### State Sued For Partner's Health Benefits

[San Francisco]- On October 12, National Gay Rights Advocates (NGRA) filed a petition in a Wisconsin Superior Court to obtain health insurance benefits for the Lesbian partner of a state

Jerri Lynn Phillips, a Wisconsin State employee, attempted to add her lifepartner, Lorri Tommerup, to her group health plan. Phillips' request was denied because the two women were not legally married.

NGRA staff attorney, Cynthia Goldstein, explained that Wisconsin has a statute barring discrimination based on an employee's marital status and sexual orientation.

"Wisconsin's anti-discrimination law is meaningless if Jerri Lynn and Lorri are denied employee benefits afforded to heterosexual couples," said Goldstein. "Equal access to family benefits is central to equal treatment."

NGRA Executive Director Jean O'Leary said, "This case reveals the limits of our rights as Lesbian and Gay Americans when we have protections on paper, only to have them ignored in practice. Lesbian and Gay families will be respected only when we demand equal treatment in every arena. This includes employee benefit programs."

## Ben-Shalom To Appeal To U.S. Supreme Court

[Milwaukee]- Miriam Ben Shalom's long and arduous legal battle of 14 years with the U.S. Army is about to reach its final chapter as she carries her case to the U.S. Supreme Court.

In a decision handed down, August 8, 1989, a three-judge panel of the Seventh U.S. Circuit Court of Appeals sitting in Chicago, determined that Ben Shalom was not entitled to re-enlist in the U.S. Army Reserve.

Following that decision, Patrick Berigan, Ben Shalom's attorney since 1985, filed a motion for rehearing "en banc" which asked for the entire circuit bench sitting as a group to rule on the case. On October 11, 1989, Berigan was notified that his en banc motion had been denied.

Ben Shalom's appeal to the High Court is a result of this decision.

Berigan told **Light** that he will first file a motion with the Seventh Circuit Court to stay their decision. This will permit Ben Shalom to remain in the military while the appeals process takes its course.

Berigan then will file a Writ of Certiorari with the Supreme Court. Such a writ is a request to the High Court to hear the case.

Most cases — approximately 90% according to Berigan — coming before the Supreme Court are discretionary.

In order for the Writ to be granted and the Court to hear the case, Berigan said, 4 out of the 9 justices must agree.

If the Writ is granted, the Court will set up a briefing schedule. Given that, the case will, according to Berigan, he will most probably be arguing the case before the Justices in the Spring of 1990.

Berigan told Light that while, in his opinion, Ben Shalom's case meets the criteria necessary to be heard by the Supreme Court, "We can't expect anything."

So now begins the final battle including waiting to see what the Supreme Court will do.

# Milwaukee School Board Asked To Adopt Curricula For Gay Teens

[Milwaukee]- Michael Lisowski, director of Gay Youth Milwaukee, testified before a committee of the Milwaukee School Board on October 11th about the problems of Gay and Lesbian teens. He urged that the Milwaukee Public Schools adopt new curricula and programs to meet the special needs of Gay and Lesbian students.

Addressing the Board's Instruction and Community Relations Committee, Lisowski questioned whether the Milwaukee Public Schools (MPS) are in compliance with Wisconsin statute 118.13 which prohibits discrimination based on sexual orientation.

"Discrimination is not always an act of commission — what we do to someone — but so much more often an act of omission — what we neglect to do for someone. Quite simply, MPS has neglected its Gay, Lesbian and bisexual students."

The hostile school environment and lack of support by school officials have been a common refrain of many young people served by the Gay Youth organization over the years. Lisowski estimated that at least 3,700 students (or 10% of the total population) in Milwaukee's middle and high schools are Gay or bisexual.

"These students suffer severe emotional and physical abuse from their families, peers and teachers when they disclose their sexual identities... Sadly, most of them suffer in silence, since there is no one or nowhere to turn to either at school, their churches, their neighborhoods or their friends."

Lisowski cited two recent studies which make the need for the schools' intervention with Gay students more urgent.

A federal report by the Department of Health and Human Services' Task Force of Youth Suicide found that "suicide is the leading cause of death among Lesbian, Gay and sexual minority youth," The study revealed that Gays and Lesbians constitute up to 30% of the suicide deaths of all young people in the United States. (The report is careful to state that this "homosexual" factor in suicides results more from anti-Gay hostility than from homosexuality itself.)

Equally disturbing, over the last two years, there has been a 40% increase in cases of AIDS among those 13 to 19 years-old.

To alleviate this crisis, Lisowski made numerous recommendations to the Committee. He asked that MPS develop curriculum "with accurate and positive information about homosexuality" for its middle and high school students.

He recommended that Gay recreation and support groups be established and TURN TO SCHOOL, PAGE 11

#### MASN Urges HIV Antibody Tests

[Madison]- The Madison AIDS Support Network (MASN) encourages individuals who are at-risk for HIV infection to be tested for HIV antibodies. Further, MASN encourages those persons who test positive to seek routine medical assessment. These recommendations are made because of medical advances in the treatment of HIV infection and opportunistic diseases. These advances can slow the progression of HIV related disease and significantly increase the quality and length of life for those infected with HIV.

These recommendations are possible because of legislation protecting the rights of those infected with HIV.

MASN recognizes its obligation to assist all people who test positive, including healthy seropositive people. MASN will help by providing emotional assistance, providing assistance in understanding rights, help with immediate living and health concerns and help people with AIDS, ARC and who are HIV positive to plan their futures.

[Milwaukee]- The Milwaukee chapter of ACT-UP (AIDS Coalition To Unleash Power) will hold a demonstration on Sunday, October 22 at MECCA's Bruce Hall beginning at Noon with a Die-In.

The action is being held to protest the "Save Our Family" rally sponsored by the Family Concerns Coalition (WVCY-FM, WVCY-TV, WKSH-AM, WYLO-AM) that will take place at MECCA at 2:00 p.m.

Dr. Lorraine Day, San Francisco's controversial "space suit" surgeon, is set to headline the WVCY backed event.

Day, who was shown on television wearing an outfit resembling that of an astronaut, believes that health care workers are poorly protected against HIV infection. She has debated traditional transmission modes for the virus and has voiced her opinion that the Federal government is involved in a cover-up about how AIDS is contracted.

Her speech to the WVCY rally is titled, "AIDS: What You Don't Know Could Kill You."

In Day's line of work as an orthopedic surgeon, flying bits of bone and blood are common. However, according to Doug Nelson, Executive Director of the Milwaukee AIDS Project (MAP), "Dr. Day is completely out of step with her own colleagues who understand that the use of universal precautions is an effective protection against HIV transmission."

"With few exceptions," Nelson said, "Milwaukee hospitals, physicians and nurses do not accept Day's extremist and misleading viewpoints on health care workers' protections.

Nelson, who watched Day on TV, continued by saying, "The bottom line for Dr. Day is that she has chosen to discriminate against HIV patients which is unacceptable in Wisconsin.

According to Tim Grair, an ACT-UP Milwaukee member and spokesperson for the organization, ACT-UP is offended by Day's up-coming speech. "Knowing the sponsors (WVCY-FM and WVCY-TV), "the facts will be in short supply," he said. "But," he continued, "that's why ACT-UP will be there; to keep the VCY rally in check."

Details of ACT-UP's Sunday demonstration are not being released.

ACT-UP last held a Die-In at MAPfest in September. A Die-In is an event at which the names of those who have died of complications due to AIDS are read while people lie on the ground to have their outlines drawn with chalk. The chalk outlines symbolize the more than 60,000 people who have died in this country since the AIDS crisis began.

This is more than the 58,000 lives claimed in the Vietnamese War and the number is growing.

On-lookers at a Die-In become participants in this solemn ceremony by writing names, messages, farewells and notes of love to accompany the chalk outlines.

ACT-UP Milwaukee's last demonstration was held in front of Milwaukee's federal building on August 25, 1989 to protest the government's dilatory handling of the AIDS crisis.

ACT-UP is a diverse, non-partisan, political action group united in anger and committed to the end of the AIDS crisis.

# A TIME TO DIE XXV Kurt Taken In Night By Rail Cattle Wagon To Auschwitz Death Camp

After seeing his mother and sister off for the south, Kurt set off to tour the city that he had not seen in almost five years. Berlin had never been beautiful, not in the way of Paris or Vienna, but now, with the allied bombings, many of the once splendid old buildings were in ruins. The house that had been his home was among them

"It was then," he said, "standing amidst the rubble of my former life, that I began to think I had been foolish and that I should have gone to Bavaria, but then a young woman approached me."

She asked him if he were General von Reichmann's son? When he replied that he was, she indicated that he should come with her. Having no other plans and being curious besides, he went.

As it turned out, his father had arranged for people to watch his family



and they had seen Kurt put his mother and sister on the train and then stay behind. After that, he had been followed.

To his surprise and dismay, he discovered that there was a plot to kill Hitler, seize the government and seek a negotiated peace with the West.

This was not the first time that there had been such a conspiracy. There had been at least six others, (the Kreisau Circle, for example) but all, for one reason or another, had come to nothing. But now, in the Summer of 1944 would come the best known of them and, if Kurt is to be believed, the Gay underground and its sympathizers had much to do with it. That, Kurt speculated, is what his father had meant when he had told his son that he was involved with people he neither liked nor respected.

In all of the plots to overthrow the Nazis, there had always been division over whether to try and negotiate with the Russians or the West. It was, as far as I could discover, the Gay position — although that may be putting too much unity to what, in fact was never a single policy — that any new German government must turn to the West. The feeling was, apparently, that if the sexual orientation of many of the conspirators were known, it would be less of a handicap with the British, for example, than with Stalin.

Kurt voiced considerable surprise at finding that there were others like himself, as well as in the fact of their militancy. It was then that he learned of the Pink Triangle and the Holocaust of the Gays that had been going on since 1933.

"It was," he said, "so sudden, so terribly sudden. My only experience, other than my fantasies, had been with Josef and now I not only discovered that we were not the only ones, but that the Nazis were trying to exterminate us all. I was terribly confused by all of this, disoriented and more than a little frightened."

They, those with whom I now came in contact, were so proud. "The Jews," they said, "revolt in their ghettos and carry on partisan attacks, but only us (the homosexuals) who they despise, will carry off the real victory — killing Hitler!

"I think now," Kurt said bitterly, "that at least the Jews got their homeland. We who were and are homosexual got nothing. Perhaps, he speculated sadly, "if we had killed Hitler, it might have been different."

Meanwhile, the plans for the assassination of Hitler and the coup d'etat were being hurried along.

Himmler's special section of the SS dealing with Gays and Lesbians had been hearing intimations of the plot and arrests were being made. If the plot were not to be irrevocably compromised, immediate action would have to be taken.

One July 20, 1944 Colonel Graf von Stauffenberg flew to East Prussia, to the Wolf's Lair, carrying a bomb that was intended to end the Fuehrer's life. Gays hoped that Himmler himself, the architect of their Holocaust, would be present and killed as well, but he was not in the building. The bomb exploded, but Hitler survived.

Hitler's revenge was immediate and in the nature of a Gotterdamurung, a fury as of the Twilight of the Gods. According to Kurt as well as others I spoke with, the underground knew that Himmler was absolutely convinced that the Lavender Network was responsible and believed that everyone who was involved with the conspiracy was Gay. This was far from true, but a dragnet was thrown out over Germany and the occupied territories that resulted in the imprisonment, torture and execution of thousands. The historian, Allan Bullock, writes that no one will ever know how many perished, the reason being that as with the hundreds of other Gays murdered in the course of the 12 year history of the Third Reich, no record was ever kept.

However many were caught, Kurt was among them.

For some reason, he was not recognized as his father's son. He was sure that had that been the case, he would have been tortured and then a meathook driven through the muscles of his back to hang, suspended until he died, such as happened to many. Even as it was, he was beaten and raped repeatedly.

Then, one day, he was dragged from his cell and forced to stand in a courtyard lined up with other men, both young and old. "We all had one thing in common," he said, "We bled from the rectum and the stains showed on the thin cotton pants we had to wear."

They were taken by truck to a railyard and there loaded into cattle wagons. "It was to be our last journey and our guards, laying about us with clubs, delighted in letting us know that.

"I now wore the Pink Triangle," he said, shaking his head, "They seemed to be so meticulous about that as if the symbol was necessary to complete out degradation."

They arrived at Auschwitz in the dead of night. Through cracks in the wooden sides of the car, Kurt could see the harsh glare of the search lights that marked the entrance and perimeter of the vast camp. "My father," he said, "who I assumed was dead, had spoken of the Germany of Gothe and Schiller, but that was only dreams, theory. The Germany that I, his son must face, was the cauldron of hell.

## Chicago's Catholic Bishop Refuses To Face Reality of AIDS Prevention

The recent statement by a committee of Roman Catholic Bishops, among whom was Joseph Cardinal Bernardin of Chicago, concerning HIV should be viewed as a disgrace by all people holding genuine religious sentiments.

The statement of policy which will be presented for approval to the National Conference of Catholic Bishops in November, recommends that schools not teach their students about the use of condoms, but only about chastity.

The reasoning is that sexual abstinence outside of marriage is the only morally correct

and medically sure way to prevent AIDS.

The thinking is terribly flawed in its refusal to acknowledge reality and come to terms with it. Whether these bishops and primates like it or not, there are young people who are going to be sexually active. To deny them the knowledge they need to protect themselves

They say they fear that if they accept teaching about condoms and other safe sex practices, they will be seen as condoning promiscuity. But what the prelates are actually saying is that ignorance will promote the value they seek to encourage.

There are human lives to be saved and ignorance will not save them.

The only mitigating factor in all this is that as with the Vatican's position on the practice of birth control by heterosexual couples, common sense and compassion will prevail and few people will pay much attention to them. But sadly, their words have only added to the burden of misery, not helped toward a solution.

Would that the bishops had the beauty of thought and love expressed by the Dalai Lama on his recent visit to Wisconsin. The world would be a better place.

## **Pastor Sharing His Secret Is Inspirational Reading At Its Best**

The Counseling Program provides a safe and peaceful environment in which to gain support, identify needs, set goals and expand choices. Short and long-term counseling is offered for individuals and for groups. There is a therapy group for adult women who are survivors of childhood incest and many, on-going, open support groups for women and

In an effort to secure safety for battered women, the Advocacy Program, located at the Milwaukee County Courthouse, assists women in obtaining a restraining order. Five clinics are held daily to assist women with paperwork and to share the restraining order process with them.

The Advocacy Program also does court advocacy, accompanying women to court for both the temporary and final hearings.

A project of the Advocacy Program is the Domestic Abuse Intervention Project/Advisor Program. This is a highly structured 18 week educational program for men who abuse their partners. The design of the curriculum places a strong emphasis on holding men accountable for their violence. The classes provide participants with

information and practical tools that are used to bring about changes in attitudes and behavior.

The goal of the Community Education Program is to work within the community to change those attitudes and values that precipitate violence against women and children. Education in awareness and treatment issues for community groups and professionals in law, medicine, mental health, education, religion and law enforcement is available.

Please come to the benefit at the Alternative on October 27 for an evening of entertainment and help support women and children who have survived abuse.


### **Alyson Announces Second Edition** Of AIDS Book

# Six Gay Couples Joined In Legal Wedlock In Copenhagen

[Copenhagen, Denmark]- In what Gay rights advocates hailed as the first unions of their kind in the world, six Gay couples went to Copenhagen's City Hall on October 1, 1989 and were legally joined in 'registered partnerships' that gave them all but a few of the rights of married heterosexual couples.

This according to the New York Times of October 2, 1989.

The ceremonies, followed by the traditional throwing of rice and confetti, were held on the day a new national law went into effect making Denmark the first country to legalize homosexual unions.

Members of the Danish Parliament passed the measure in May, 1989 by a vote of 71 to 47 after a 40-year campaign by Gay rights advocates.

In a country which has historically been sympathetic and supportive of minorities, including Gays, Lesbians and Jews, opposition came mainly from the small Christian People's Party which called the legislation "against the teachings of Jesus." who taught that "only a man and a woman can be married."

The Christian People's Party has 4 out of 179 seats in Parliament.

Some Church bishops were quoted as saying that the debate was irrelevant because the church could bless only marriages.

.Under the new law, partners - at least

one must be a resident Danish citizen—are liable for each other's maintenance. They also have the automatic right to inherit the other's property and must undertake legal divorce proceedings to dissolve the partnership. They can also be forced to pay alimony and, in some circumstances, a partner can be held responsible for the other's tax liabilities.

The couples can not be married in the state Danish People's Church (Evangelical Lutheran) and cannot adopt or obtain joint custody of a child.






# The Ordinary/Extra-Ordinary Matlovich Chronicled in New Book

Matlovich: The Good Soldier by Mike Hippler, Alyson Publications, Inc., 1989, 176 pages, \$8.95.

Matlovich: The Good Soldier chronicles the ordinary/extra-ordinary life of the decorated sergeant whose struggle with the Air Force to accept his sexual identity made his a symbol of the Gay Rights movement in the 1970's.

Leonard Matlovich, as a young man, was an unlikely candidate for Gay rights activist. His father was a career military man and Leonard was raised on a succession of bases in the U.S. and overseas. He identified as a Southerner because his mother was from the deep south and he spent six of his more stable childhood years in Charleston. His



southern identity reflected the region's militant patriotism as well as its racist

But after three tours of duty in Vietnam, a long religious quest and a lifetime of self-denial, Matlovich finally emerged as an award-winning race relations instructor and a compelling spokesman for the Gay rights cause.

This biography is enhanced by lengthy passages from interviews Matlovich recorded before his death (of AIDS complications) in June, 1988. Author Mike Hippler also interviewed friends, activists, attorneys and others who knew and worked with Matlovich. Their impressions and anecdotes offer insight and critical perspective as the story unfolds.

The legal wranglings with the Air Force and the complex appeals process are outlined (Matlovich eventually agreed to a financial settlement when constitutional arguments in his case were exhausted and denied.) And Hippler does not shy away from Matlovich's embroilment in Gay political turf wars once he became active.

The things that endeared me to Matlovich the most were his all-too-human foibles: his fumbling through relationships, his bad business decisions and choice of friends, his stubbornness, his naivete. Matlovich is portrayed, not as "hero" or "symbol", but as the multi-dimensional and very vulnerable man that he was.

He was an ordinary man thrust into the national limelight by extraordinary circumstances. The refrain from Holly Near's "It Could Have Been Me (But Instead It Was You)" kept coming to mind.

A 17-page Epilogue summarizes "Subsequent Court Cases" regarding Gays and Lesbians in the military. The book's discussion of legal challenges ends in late 1988 and so does not include the most recent developments (in the Miriam Ben Shalom case for instance). Nevertheless, it's a good re-cap of the major cases in the last 15 years.

One of Matlovich's dreams was to establish a memorial to Gay veterans. His own tombstone in Congressional Cemetery now serves as that memorial. The large black granite stone features two Pink Triangles with the legends "Never Again" and "Never Forget." The epitaph reads: "A Gay Vietnam Veteran: When I was in the military they gave me a medal for killing two men and a discharge for loving one."

CAVAFY, CON-STANTINE, [April 17, 1863-Apr. 29, 1933], Greek poet, By developing his own individualistic style of poetry, Cavafy, became

Cavafy became one of the West's most important poets. Most of his best work, however, was written after he turned forty — and was published only after his death.



Though he was Greek, Cavafy never actually lived in Greece. He was born, and died, in the Egyptian city of Alexandria. As a young man there, he often visited male houses of prostitution. He bribed his servants to ruffle up his sheets at night so his mother would not realize he had not been home.

From our community's most prolific publishing house comes The Alyson Almanac, "a treasury of information for the Gay and Lesbian community." Like all almanacs, it is indeed a treasure trove of information.

The Alyson Almanac includes highlights of our history, lists of national organizations and publications, a dictionary of Gay slang and "Best" and "Worst" lists by some of our finest critics. It outlines awards and honors bestowed on Gays and Lesbians, the voting records of members of Congress on issues that affect our community and the, by now, ubiquitous safer sex guidelines.

Being an "enquiring mind," my favorite section is the one on "People." It contains brief profiles of people known of said to be Gay, Lesbian or bisexual. I found out that Leonardo da Vinci spent two months in the Big House for sodomy, that Eleanor Roosevelt exchanged rings with Lorena Hickok and "ached" to hold her close, and that Winston Churchill confessed, "I once went to bed with a man to see what it was like."

Like most almanacs, Alyson's is light, fun and breezy. Interesting facts, from the profound to the trivial, can be found on every page. It has one major flaw however.

The entire Almanac is weighted toward Gay men to the exclusion of much relevant material about Lesbians: our organizations, newspapers, herstory and experiences.

The most egregious example of this editorial obtuseness jumped off the page of the dictionary which defines "go down on" as "to perform fellatio on." Lesbians are wincing all over America.

(Note to the totally obtuse: A lot of Lesbians have been known to "go down on" a lot of women, but definitely not "to perform fellatio.")

Alyson plans to republish its Almanac periodically with updated and expanded information. It's a fun book and I look forward to future editions. I only hope they hire a few more Lesbian consultants to provide the balance that's needed.

## **New Lesbian Alliance Welcomed** To the Political Community

Just when some of you men-folk thought you were going to keep having everything your own way, up pops, LAMM. LAMM is short for Lesbian Alliance of Metro Milwaukee, Milwaukee's first general purpose Lesbian group.

I suspect that some of you men out there are probably snickering right now saying to yourselves "Oh how cute the dykes are getting together." Others are probably thinking "Why are they doing this don't we have enough groups?" Still other men, and (I hope they are more numerous than I suspect they are) are saying "Right on sisters welcome to the party!"

Clearly the formation of a new all Lesbian group will be seen as threatening by some. To those who feel threatened, I suggest a quick crotch check. See it's still there. Now that you've re-established your manhood, let me tell you that if you feel threatened by this growing development of Lesbian power, you probably deserve to be threatened.

All too many Lesbians whether justified or not feel as though while we have a Gay Political Power structure we do not have a Gay/Lesbian political power structure and that while they have tried to work within organizations dominated by Gay men their contributions to those organizations and to our community as a whole has never been fully appreciated, recognized or utilized.

Let's do a quiz.

How many of Milwaukee's mixed organizations are headed by a woman?

How many of our organization's have made a REAL effort to cultivate a Lesbian membership?

How many of our Gay leaders have gone beyond getting some token females and accepted women as full partners in planning the operations of and running our groups?

a) Who cares?

b) Why should they? c) Not nearly enough.

d) Who needs those pushy dykes

If you answered C go to the head of class, as soon as you've explained what you've done about it.

The fact is that few of our organizations have real input from the Lesbian community. Oh yes some groups try to get a few token women to fill vacancies on their boards and then ignore them, but the fact is that this kind of operation is no longer enough.

LAMM is not contrary to the popular rumor ('Who cares those lesbos hate men and wouldn't work with us anyway.') a separatist organization. It is not that its leaders don't wish to work with men, it is only that they desire to be put on an equal

footing when they do so.

Far too often Gay leaders have complained that they can't get Lesbian involvement in their groups. That's why it is important that Lesbians come to the table with their own constituency united behind them. That's why it is essential that Lesbians have the opportunity to develop experienced leaders rather than tokens who are never given the chance to assume any real responsibility.

It is critical that a lesbian organization working on a broad range of concerns to our community develop its issues and positions and resources so that Lesbians can fully participate in discussions of how to further develop our movement and marshal the resources of the Lesbian community behind them. We need that to happen if we are be as politically potent as we wish to be.

Without the above, we will never be able to make full use of our resources as a Gay AND Lesbian community. Instead of feeling threatened, making jokes and/or ignoring LAMM, we should all be supporting and encouraging it by attending its events and encouraging our Lesbian friends to get involved.

If LAMM fulfills its promise, we will be seeing capable Lesbian leaders and a stronger Lesbian community with an increased capacity for contributing to the welfare of us all. Whether or not LAMM is able to fulfill that promise may well depend on whether or not Gay men welcome its development with more than lip service or try to ostracize it. Do the former and you are doing yourself and the Lesbian community a service. Do the latter and you will widen the gulf between us. The choice is yours Gay Milwaukee. Think carefully before you make it.

SILENCE = DEATH / ACTION = LIFE

The Milwaukee AIDS Project (MAP) and the Madison AIDS Support Network (MASN) are now encouraging individuals to be tested for HIV infection, in light of recent medical advances that make early diagnosis crucial. The following is a summary of Wisconsin's legal protections for those who choose to take the HIV test.

CAN I BE FORCED TO SUBMIT TO AN HIV TEST?

No. Wisconsin law prohibits involuntary HIV tests. Before any HIV test can be administered, the subject of the test must provide informed, written

consent for testing.

CAN MY EMPLOYER REQUIRE THAT I SUBMIT TO AN HIV TEST? CAN I BE FIRED FOR NOT SUBMITTING TO A TEST?

No. Wisconsin law prohibits an employer from asking for or requiring an HIV test as a condition of employment.

CAN MY EMPLOYER FIND OUT IF I HAVE TAKEN AN HIV TEST OR IF I HAVE TESTED HIV POSITIVE?

No. Unless the subject of the test volunteers this information, employers may not receive this medical information.

CAN I BE DISCRIMINATED AGAINST AT WORK DUE TO MY HIV STATUS? CAN I BE FIRED FROM MY JOB IF I AM POSITIVE? EVEN IF VOLUNTARILY PROVIDE INFORMATION TO MY EMPLOYER?

No. Our law prevents an employer from affecting the terms, conditions or privileges of employment, or terminating the employment of anyone who obtains an HIV test, regardless of the results of the

ANYONE REQUIRE THAT I CAN TAKE AN HIV TEST?

No. But an HIV test can be set as a condition for: applying for an individual (as opposed to group insurance policy,)

donating blood to a blood bank or plasma center,

donating a body part as an anatomical

admission to a center for the developmentally disabled or mental health institute,

burial, disposition of body or performance of autopsy.

IF I AM TESTED AT AN ANONYMOUS TEST SITE, CAN THOSE TEST RESULTS EVER BE DISCLOSED OR USED AGAINST ME?

Federal law confidentiality of tests conducted at these sites. Through the use of pseudonyms, testing at these locations is done without any information relating to the identity of the individual. Federal and state law prohibits discrimination based on HIV

IF I VOLUNTARILY SUBMIT TO AN HIV TEST BY MY DOCTOR, WHO WILL FIND OUT THE RESULTS?

Any doctor, hospital, blood bank, or other health care provider who administers a voluntary HIV test will disclose the test results to:

1) Others who provide you with patient care (such as nurses and other doctors) and those who prepare or store your medical records.

2) The State Epidemiologist, for the purpose of investigation or control of a communicable disease. This is a mandatory reporting requirement of state law. For the individual who is diagnosed with AIDS (as opposed to a positive test

for HIV), the subject may be contacted by public health officials to determine the identity of persons with whom the test subject may have had sexual contact. This 'contact tracing' requirement is designed to encourage those persons at risk to seek voluntary testing.

CAN INSURANCE COMPANIES ASK FOR AN HIV TEST AS A CONDITION OF ACCEPTANCE AS A POLICY HOLDER? CAN THEY REFUSE COVERAGE IF I TEST POSITIVE?

Yes. But only for applicants for individual life, accident and health insurance policies. For group policies, no insurer may require or request an individual to submit to an HIV test, nor can they require or request an individual to reveal the results of an HIV test already

ONCE I HAVE BEEN ACCEPTED AS AN INSURANCE POLICYHOLDER, CAN I HAVE MY POLICY TERMINATED OR BE DENIED AIDS TREATMENT

No. Once you are an established individual or group policy holder (as opposed to applicants), insurance rules prohibit termination of policy, refusal to provide AIDS treatment coverage, or providing a lower standard of coverage than that which is a normal standard of coverage in that policy for any other medical condition.

ONCE MY INSURANCE COMPANY OR DOCTOR HAS MY HIV TEST RESULT, CAN THEY DISCLOSE THE RESULTS TO MY EMPLOYER?

No. If an individual voluntarily submits to an HIV test for insurance or any other purposes, a person receiving the test results may not redisclose them to anyone who is not authorized. This includes to an

ARE THERE PENALTIES FOR ANYONE WHO RELEASES MY HIV TEST RESULTS TO SOMEONE I DON'T AUTHORIZE OR IS NOT AUTHORIZED

Yes. Whoever intentionally and illegally discloses HIV test results and causes you bodily or psychological harm can be charged with a criminal offense and receive a fine of up to \$10,000 or imprisoned up to nine months or both. You can also bring a civil suit against that person. Or, if the person is a licensed health care professional, you can file a complaint with the appropriate state licensing board.



Ballet dancer and aerobic specialist John Henry Davis, 39, died of AIDS complications Sept. 24 at Fraternity House hospice in Oceanside Calif. JOHN HENRY DAVIS

Born in Jacksonville, Davis settled in Milwaukee in 1973, where he joined the Milwaukee Ballet Company. In the next 7 years he appeared in over 20 ballets by Jean Paul Comelin; 10 ballets by Marjorie Mussman as well as numerous other performances.

At intermittent intervals during the same years, Davis taught at the University of Wisconsin-Whitewater extension program and the Metropolitan Ballet School at Wheaton, Ill.

His impressive knowledge of the development of a dancer from his own extensive professional background was remarkable according to the director of the Milwaukee Ballet.

## Robert I. McQueen

[Los Angeles]- Robert I. McQueen, former editor of The Advocate, the national Gay newsmagazine, died October 8, 1989, at his home in Los Angeles.

McQueen, who was chairman of the Board of Liberation Publications Inc., which publishes The Advocate, Advocate MEN, and other magazines for Gay men and Lesbians, died in his sleep of complications from AIDS. He was 47.

McQueen joined The Advocate in November, 1975 as editor. In 1984, McQueen was named editor-in-chief, the post he held until his retirement in July, 1988.

During his tenure as editor, The Advocate grew from a local Los Angeles paper to a magazine with an international distribution.

McQueen is survived by Rafael Llanes, his lover of five years, by his mother and father and by his three brothers.

[San Francisco]- National Gay Rights Advocates (NGRA) has won a settlement in the amount of \$62,746.38 against the Raytheon Company for AIDS discrimination. The settlement follows a landmark ruling on July 7 by the California Court of Appeals making employment discrimination against people with AIDS illegal in California.

The Raytheon Company will be required to pay all back wages, attorneys' fees and to establish an "AIDS in the Workplace" training program for its employees.

that special programs on AIDS, drug and suicide prevention be offered in the schools. He proposed that all teachers, counselors and school personnel receive,

'on a continual basis," training about issues relevant to Gay and Lesbian youth. Lisowski urged that MPS stop homophobic slurs, violence and intolerance in the schools, include Gay and Lesbian-positive materials in school

libraries, and utilize Gay and Lesbian

adults as resource people with Gay youth i.e., a mentor program.

The idea of a mentor program incorporating Gay and Lesbian adults as role models caused controversy when suggested by MPS spokesman Dave Begel earlier this year. However, no conservative opponents of the plan appeared at the October Committee hearing.

Finally, Lisowski also requested that the School Board enforce more vigorously state statute and school district policy prohibiting discrimination based on sexual orientation. He said the school system should meet its responsibility to educate students about this policy and the mechanisms available to redress any grievances.

At least one Committee member seemed supportive of the testimony. Joyce Mallory said, "We need to make sure our students know there is someone they can turn to if they feel discriminated against. As a school district, we want to send out the message that everyone should be treated fairly.

The Committee will review the recommendations of Gay Youth Milwaukee and report back to the full School Board with their findings and any proposals for action. Lisowski and members of Gay Youth Milwaukee, some of whom attended the historic hearing, will monitor the progress of their

Gay Youth Milwaukee is a support group for Gays, Lesbians and bisexuals 14-18 years-old which began on the UW-Milwaukee campus ten years ago. It


