Public to Speak On 'Light' Censoring Issue Nov. 10 In **Hales Corners**

[Milwaukee]- Members of the public will be able to speak at a Hales Corners Library committee meeting at 5:30 p.m. Nov. 10 on whether the library should continue to carry the **Wisconsin Light** newspaper and whether it should be available in a pamphlet rack.

In order to speak, members of the public must get a letter to the library by Nov. 5 listing the speaker's name, address, and a description of the speaker's intended remarks for inclusion in the meeting agenda. The address is: 5885 S. 116th Street, Hales Corners, WI 53130.

Speakers do not have to present written remarks, but the committee may decide to limit the length of remarks if many people wish to speak.

The library's Board of Trustees voted Sept. 1 to set up the five-member committee after Hales Corners resident Jeff Baas, 26, a fifth- grade teacher in Wauwatosa, complained that the advertising in the newspaper is "almost pornographic."

In his written complaint, Baas said the placement of the newspaper in a pamphlet rack in the library entrance was too accessible to children. He also wrote that the underlying theme of the newspaper is "a Gay- Lesbian agenda, which is a theme of sex." Baas will be invited to speak at the Nov. 10 meeting.

The committee will meet again at 5:30 p.m. Nov. 17 and must make its recommendation at the Dec. 1 Board of Trustees meeting. The board may hold a public hearing after it gets the recommendation.

As specified by the board, the committee's members include two library staff members appointed by Library Director Patricia A. Laughlin: Lee Alexander, adult services librarian; and Janice Couturier, circulation supervisor.

The other three members are Hales Corners residents selected by the Board President Georgiana Tamel: Brian Anderson, a guidance counselor at Pius XI High School; Shannon Richter, a junior at Whitnall High School; and Thomas D. Walker, an assistant professor at the School of Library and Information Science at the University of Wisconsin-Milwaukee.

Selection criteria included having an open mind, Laughlin said.

At the committee's first meeting Oct. 20, Richter, who was elected secretary, said she had examined photocopies of the advertisements Baas objected to and found them "almost offensive, but knowing what the majority of the paper is about, it could be almost a service to the community." Walker, who was elected chairman, suggested comparing Wisconsin Light to other alternative newspapers and examining advertisements from other publications. He also recommended reviewing American Library Association Library Bill of Rights, which the Hales

Problems Of Gay Students Brought To Attention of State Education Head

[Madison] - On Wednesday, October 20, in an historic first, State Reps, Tammy Baldwin (D-Madison) and Tim Carpenter (D-Milwaukee) met with the new State Superintendent of Public Instruction, John Benson. The meeting was held at Baldwin's request to share with Benson the many issues of concern that Lesbian/Bisexual/Gay students, faculty and staff face on a daily basis in Wisconsin's public schools.

Baldwin spoke movingly of her experience as a Lesbian in the public school in Madison, telling Benson the the heterosexism she encountered and the difficulties that she faced due to lack of role models; what it was like to be invisible.

From there, Baldwin and Carpenter went on to discuss the problems that sexual minorities face in the schools.

Among these they shared were: physical safety, harassment and name calling by other students, the lack of caring adults to talk with, the isolation LesBiGay students so often face that invisibility in the textbooks only increases.

African American man hiding in the bushes watching him. "I could see he had his hand in his pocket," Siegel said, 'massaging his genitals.''

When someone else approached, Siegel said he got up from where he was sitting and walked along the path. The Black man followed and eventually introduced himself to Siegel as "Mourice."

Siegel said that there was about "45 minutes of conversation" with "Mourice" who constantly kept his hand with in his pocket, seeming to fondle himself. Four times, Siegel said he told "Mourice" that he did not feel safe having sex in the park; "that it was illegal and dangerous." Four times, 'Mourice'' led him to a new spot and assured him it was safer.

At one point Siegel said that he noticed another man in the bushes nearby. "Mourice" said that the other man "wouldn't bother us." When Siegel asked him how he knew, Siegel said "Mourice" told him that he'd had sex with the man before. When Siegel asked him why he "didn't go after him now?" Siegel said "Mourice" replied that "he had sex with him only once and the guy didn't like having sex with the same person twice.'

Finally, Siegel said, the man rubbed up against him (Siegel), saying that he was too shy to make the first move, but "Do what you want, I'm all yours," Siegel said "Mourice" told him.

"At this time, he leaned his body up next to mine," Siegel said, "touching me with his right arm, an act of compassion, I thought, and smiled at me, hand still massaging his crotch.

"Feeling somewhat sympathetic towards his shyness, I placed my hand on his hand, which was still massaging his crotch. Immediately, he pulled out his badge and said I was under arrest.'

Informed that he could be handcuffed, Siegel said he told the officer that he would "go peacefully." The officer informed him at this time that "this was no more than an expensive parking ticket."

Siegel said that officer told him that no one needed to know, about the arrest except the two of them and that he (the officer) would "keep quiet if I would."

After being given a ticket citing him for disorderly conduct. The ticket carried a fine of \$287. No sexual misconduct by Siegel was alleged.

[Milwaukee]- In an update to the story in the last issue, the American Civil Liberties Union of Wisconsin (ACLU) has written Milwaukee Police Chief Philip Arreola to protest his Department's interference with ACT UP Milwaukee, an activist group that works to increase public awareness of the AIDS epidemic.

On October 2, as reported in Light, officers of the Milwaukee Police Department stopped members of ACT UP Milwaukee from distributing safer sex literature and condoms at Milwaukee Technical High School before a dance. And on October 9, despite a decision by the Milwaukee City Attorney's office that no illegal conduct had occurred, officers again stopped a similar distribution at Hamilton High School.

The ACLU of Wisconsin believes that the police are violating the First Amendment rights of ACT UP members. In an October 15, 1993 letter to Arreola, ACLU/WIF volunteer attorney Waring R. Fincke, called upon the police to stop interfering with protected First Amendment activities by ACT UP in the future.

Attorney Fincke wrote that "My clients... expect that your offices will not

prevent them from exercising their civil rights, including preventing students from receiving the literature... Any violations of my clients' rights will result in legal action for injunctive relief and damages.

ACLU of Wisconsin Executive Director Christopher Ahmuty said, "The Milwaukee Police Department must have better things to do than censoring a message which may just prevent one of our students from exposure to AIDS. ACT UP's message may make some officers uncomfortable, but that's no excuse to violate the First Amendment."

Dan Fons, a member of ACT UP Milwaukee said, "It was great to have one group (ACLU) to stand up and state the obvious; that the police were violating our rights.

Fons said that the next time ACT UP handed out literature and condoms at a high school, they were not bothered by the police. Fons said that homecomings are now over, but that ACT UP would continue its AIDS awareness campaign at high school dances and proms in the future. The same literature would be used.

Recommendations Made for Gay Campus Life at UW-LaCrosse

[La Crosse]- "These are very powerful recommendations and do a lot to improve the university environment... for Gay, Lesbian and Bisexual students, faculty and staff," declared Wisconsin Assemblywoman Tammy Baldwin (D-Madison) in her keynote address at the UW-La Crosse's Gay, Lesbian, Bisexual Concerns Task Force Program on Monday, October 11.

The Task Force chose National Coming Out Day to present its 39 page report to UW-La Crosse Chancellor Judith Kuipers at a campus press conference and program attended by local media and a generous crowd of faculty, students, and community observers. Task Force leader, Jay Scott, a married heterosexual ally and member of the UW-La Crosse Student Activities staff said of Chancellor Kuipers, "She stands with us as we attempt to improve the life of Gays, Lesbians and Bisexuals on campus and in the community."

Thomas Hood, Vice- Chancellor for Student Development, who received the report instead of the ill Chancellor, remarked on the report's "breadth" and "specificity," after Scott noted that it had undergone many drafts.

The 14-member Task Force included representatives from student activities, residence life, minority affairs, women's studies, psychology and philosophy departments, career services, student representatives and United Campus Ministries.

Among the recommendations are: Workshops on sexual orientation discrimination; Committees to address Gay, Lesbian and Bisexual concerns; A Student Development Liaison to the Gay, Lesbian and Bisexual community; Domestic partnership benefits for college employees; And curriculum concerns.

David Sailers, a Gay grad assistant in Student Activities, said of the report, "These are simply small requests for respect."

When asked by a reporter to comment on "these special rights," Sara Hinkle, President of the Gay, Lesbian, Bisexual Student Organization, responded pointedly saying, "Life, liberty and the pursuit of happiness are not special rights. Students, staff and faculty at this campus and around the nation, do not have the basic civil rights of life, liberty and the pursuit of happiness."

Baldwin received an enthusiastic ovation from the crowd of more than 200 after her address. "We must be outraged," she said, "vocally outraged, that a Gay teen is three times as likely to commit suicide as a straight teen."

"We want our families to love us, our neighbors to like us, and our fellow students and teachers to respect us," Baldwin said.

Noting that Gays and Lesbians have been forced to set up a separate community, she said, "We don't want to live in a separate community, but a safer, more nurturing community."



MAP Receives \$945,000 Grant From HUD for Patient Housing

[Milwaukee]- Congressman Tom Barrett (D-WI) announced on October 15 that the AIDS Resource Center of Wisconsin (ARCW), parent agency to the Milwaukee AIDS Project (MAP) has been awarded a \$945,000 grant from the Department of Housing and Urban Development. The Northwest Side Community Development Corp.

co-sponsored the grant with ARCW. "In Wisconsin we are seeing a 30% increase in AIDS cases annually. We still have a long way to go, but this grant will help address the housing needs of this growing population," Barrett explained.

The funds will be used to establish an independent living center for 14 persons with HIV disease and AIDS and provide them with rent assistance.

About half of the grant, \$541,800, will be used for rehabilitating the property at 4323 N. 27th Street in Milwaukee into six residential units. This residence will be

the first of its kind for families with HIV in Milwaukee. The remaining \$403,200 of the multi-year grant will be used for rent subsidies.

Milwaukee Brewer Makes Grant

A member of the Milwaukee Brewer's baseball team, Darryl Hamilton, and fiancee Shaun Robinson, a reporter and news anchor at TV Channel 12, will present a check for \$16,100 to Doug Nelson, MAP's Executive Director, on Friday, October 29, at the MAP offices.

In April, Hamilton pledged to contribute \$100 for every hit he got in the 1993 season. The results of his outstanding season included 161 hits.

Hamilton continues a long-standing relationship between the Milwaukee Brewers and ARCW. Paul and Linda Molitor served as honorary co-chairs of the 1992 Wisconsin AIDS Walk and Bud and Sue Selig presided over the annual Walk in 1991.

[Milwaukee]- In an update to a previous story, no citizens volunteered, so the Sussex public library's Board of Trustees will not appoint a committee to study the selection of children's books and whether children should have access to any book in the library.

The board of the Pauline Haass Public Library voted in September to create the committee after a controversy over the book Daddy's Roommate, a children's fiction book about a divorced Gay father and his roommate.

The board hosted a public hearing at which about 50 citizens spoke - half for and half against the book - then voted to keep the book on the children's nonfiction shelves. The book had been placed there by Library Director Joy Botts after a complaint was lodged against it because young children rarely use the nonfiction section without adult help.

The committee was to include five or six citizens who had not spoken either way on the issue, but no one came forward, so trustees voted 3-1 on Oct. 21 to cancel the committee.

"It was a real relief to have it settled," Botts said the next day. "It was a troublesome issue and we don't have to worry about how it will be handled now.'


In an interview after the meeting, Laughlin said the library gave away almost 200 copies of the issue of the newspaper following the Sept. 1 meeting and continues to give out dozens of every issue. For about two years, the library had been distributing only about 10 copies per issue.

She said the library had also received "quite a few" letters about the newspaper, and although she hadn't counted them, "for the most part there's been strong support for keeping the newspaper.

Committee members will review those letters before the Nov. 10 meeting.

Four women opposed to keeping Wisconsin Light attended the committee meeting and one, Violet Stajmiger, demanded that the committee hear from "taxpayers, parents and grandparents." She asked what the library defines as sodomy and whether sodomy was something to learn about at a library.

EDITORIAL

As A Community We Must Unite **To Show Strong Political Force**

The issue of the entrapment by law enforcement officials is one that, unfortunately, Milwaukee shares with other cities. Equally sadly, it is nothing new. At least as far as the Gay community is concerned, it's been going on for a long, long time.

It is a disgusting practice, totally illegal and contrary to all sense of justice outside a fascist state. And, it smacks of cops, zealots, going on some sort of moral crusade, something they have no business, no right, no warrant and no legal justification to do. There is absolutely no call, no reason, for a law enforcement official to bring their morality, no matter what it is, into the public sector. We pay these people to enforce the law. That is all they are supposed to do, not entice others to break it.

The Gay community has suffered from this for untold years. Uncounted people have been harassed, entrapped, suffered threats and fines. It is time, long since time, that we put a stop to it.

However, as the point was made by someone, this issue with the sheriff's deputies and the police is a political problem as much as it is a judicial one. Abuses of police power are resolved not only in the courts, but by the use of political clout. The sad fact is that the Gay community lacks the organization that is needed to bring the necessary pressure to bear.

In this city, where so many law enforcement officials both on the street and higher up, seem to be obsessed with sex, only political power will provide corrective measures and any relief.

We have got to get organized. That should be obvious. But obvious too, we think, is that in developing organization, we must of the LesBiGay community must not think we are alone. We must reach out to other minority communities: African Americans, Hispanics, Asians and the rest who suffer daily similar injustices at the hands of police and sheriff's officers and other public officials to our own.

In other minorities, there may be those who disapprove of us who are Gay, Lesbian and Bisexual, but so be it. There is a broader concern here, one that transcends disapproval. There is a common cause.

For LesBiGay community, for the African American community, for the Hispanic community, for the Asian community, the one hope and only hope of solving our problems is in joint action.

It should be clear that there are people in this city who much prefer to see Gays disorganized; to see the minorities riven from each other. It's called "Divide and Rule" and it must stop for the good of all.

Entrapment and harassment by law enforcement officials is not going to stop because of these few words. What is going to stop this intolerable practice and other injustices suffered by all minorities in this city, is organization and joint action. The sooner this happens, the better.

supporting her statements.

Faculty and staff too face problems, Baldwin said. Things like concern about being fired for reasons of sexual orientation and other adverse employment outcomes.

Baldwin also spoke about the urgent need for HIV/AIDS education in the schools. Though HIV education is mandatory throughout the state, many school districts ignore the law.

Baldwin said that such education is needed at all grade levels. She also advocated that condoms be distributed by the schools. None are now.

Benson, who has been in office three months, responded positively. He said that he was "proud" to break from the past; that he had no problem discussing LesBiGay concerns. "I have a number of Gay/Lesbian teacher friends," he said.

Benson said that while he realized that the Religious Right is strong, yet the staff at the Department of Public Instruction (DPI) is knowledgeable and committed to the issues Baldwin and Carpenter spoke about.

Afterwards, Baldwin voiced strong optimism about the meeting with Benson. She is encouraged by what she heard and enthusiastic for the future.

A Historic First

One of the reasons for Baldwin's strong optimism is the fact that on October 28, Benson will address the Gay and Lesbian Educational Employees (GLEE) meeting in Madison as part of the Wisconsin Education Association Council's (WIAC) state convention. Benson will be speaking on issues of

The meeting was organized by The United and was attended by representatives from Baldwin's office, by The United, the Madison AIDS Support Network, Briarpatch and the UW-Madison Dean of Students office among others. Also attending were "out" members of the Madison Police Force.

The 90 minute meeting covered the wide range of issues of concern to the LesBiGay community in order to give Williams the broad background that he needs.

Participants found the new Chief very positive and receptive. There is much optimism that Williams will continue the progressive policies of his predecessor, David Cooper.

Cast, Actors, Poets, Writer to **Appear at Store**



The 'Kindness' of Strangers: A Gay, Lesbian Youth Detention Center

The Lambda Legal Defense and Education Fund, working with the National Center for Lesbian Rights, is investigating allegations that a Southern California school district is sending Gay and Lesbian teenagers to an institution in Utah for aversion therapy or "reparative therapy" to "de-Gay" them.

The institution, known as Rivendell, is located in West Jordan (just west of Salt Lake City). It calls itself a residential treatment facility designed to treat youth with mental and emotional disorders. The Rivendell facility, which is a school as well, is reported to have a heavy Mormon influence and to teach its students that homosexuality is wrong.

One Gay youth, a former Rivendell student, told the **Los Angeles Reader** that he was sent to the institution when he was 14 years-old after his parents found him in bed with another boy.

He says that once at Rivendell, he was evaluated for homosexuality in a session where electronic sensors were attached to his wrists and testicles to measure his responses to pictures of naked men and women. He claims that therapists at the institution attempted to teach him how to become attracted to women.

Posing as a mother, a reporter says she called Rivendell inquiring about how the facility might help her son's "problem" of being Gay. She says an assessment and referral specialist from the institution told her that the facility could address the "problem" specifically and informed her that the institution employs a therapist who works with "sexual identity issues."

Editor's Note: A reporter for Light placed a call to Rivendell, identifying himself as a "outraged father" because his 13 year-old son was "Queer" and the "whole family was upset." The reporter was told much the same thing as above by a very sympathetic young woman who gave him the name of a psychologist who he should contact who would refer the boy to Rivendell after diagnosis.

A Young Lesbian

Presently, Lambda is investigating, along with the National Center for Lesbian Rights, the situation presented by one of Rivendell's former students, Lyn Duff. Duff is a young Lesbian who is now 17 years-old. In December of 1991, Duff's mother placed her in the Rivendell facility in Utah to "cure" her of her Lesbianism. placed in isolation, and subjected to hypnosis and behavior modification therapies in an attempt to give her a heterosexual orientation.

Obviously, if these reports can be proven, the Rivendell facility is abusing the young Gay men and Lesbians confined there. Clearly, such "treatment" is nothing more than homophobic quackery causing serious emotional distress.

Not With Rivendell Alone

But responsibility for this abuse does not rest with Rivendell alone. Certainly their parents are responsible. But the accountability does not end with them, either.

Duff's mother could not afford the tuition at Rivendell. Without assistance, she could never have sent her daughter there. But Duff's mother did not have to pay. The South Pasadena School District and the Los Angeles County Department of Mental Health provided funding for Duff's "treatment" at Rivendell through the state's Individualized Education Placement (IEP) program.

Placement (IEP) program. The IEP program is a means by which the state provides special education to children with special needs, such as disabilities or mental illness. Under the IEP program, if a school district does not have a facility where a special needs student can be suitably educated, then it is required to pay to send the student to a private school.

A student who is diagnosed as suffering from a "serious emotional disorder" which harms the child's education can be sent under the IEP program to a residential treatment facility.

Homosexuality: Not a Disorder

Of course, for nearly two decades, "homosexuality" has not been regarded as an emotional or mental illness by mental health professionals. Indeed, the American Psychological Association has urged its members to work toward removing the stigma of mental illness which earlier was associated with Gay or Lesbian sexual orientation.

If the above allegations are true, and if the South Pasadena School District and the Los Angeles Department of Mental Health are sending high school students to the Rivendell institution for "reparative therapy" to "treat" their Lesbian or Gay sexual orientation, then this is not merely a violation of the IEP suidelines. It is blatant child abuse.

guidelines. It is blatant child abuse. The "treatment" itself — neuroleptic drugs, isolation, deprivation, electric sensors monitoring sexual response constitutes medical malpractice. And the institutionalization of young people for the purpose of such "treatment" is a severe violation of federal and state constitutional rights.

Fortunately, for Lyn Duff, she escaped from Rivendell and from her mother; she has subsequently been adopted by a caring and compassionate Lesbian family in San Francisco. Also, fortunately, for Lyn, she has found her way to Lambda and to the National Center for Lesbian Rights, and we are investigating Rivendell.

Lambda cares about the Lyn Duffs of the world, and we are working hard to provide a safer tomorrow in which Lesbian and Gay youth can come of age. That tomorrow has no place in it for a house of horrors like Rivendell.



Academic and Theatre Worlds Explored in 'Rehearsal' Novel

In his first novel, **Rehearsal**, Michael Craft explores two worlds — the world of theatre and the academic world. In telling his story he conveys the excitement of theatrical production as well as the stuffiness of faculty receptions.

These two worlds come together when Claire Gray, a celebrated Broadway director takes a sabbatical to write and teach at her alma mater, Evans College. Here she meets George McBeth, a decorator who plays male leads in the women's college productions. He lives with Guy Baldwin who teaches at the college.

At their first meeting, Claire and George are quickly in synch and in the sack making the beast with two backs even though George is Gay and Claire, at 50, is ten years his senior. George, of course, gets the leading role of a homosexual in the play that Claire has written; he dreams of Broadway and sees Claire as his ticket to the Great White Way.

Rehearsal is a study of two individuals using each other for their own self interests. The author lets George and Claire tell their own stories in alternating sections, thus allowing the reader to know exactly what is going on in the mind of each. Claire dominates the action, and except for their first mutual seduction, she also dominates her boy toy in bed. All of the action builds to the climactic

first night production of Claire's play intended as a tryout before deciding whether to mount a professional Broadway production. The novel is just 120 pages long and at page 106, I was beginning to wonder how Craft was going to pull all the narrative threads together.

Well, the denouement is neat and it is fast though not unpredictable. It seems to me, however, that too many Gay-themed novels end in suicide, although death from AIDS is rapidly becoming the ending of choice.

The strength of **Rehearsal** lies in its characterizations and in its depictions of the two worlds where the author is completely at home.

The title of Claire's play is "Traders," and at one point she says, "Whether is affairs of the heart or of finance... Expecting to take as well as to give, we are traders." It ultimately is the worldly philosophy which gives the novel its force.

Michael Craft is the pen name of Michael Craft Johnson who has shortened his name, not to conceal his identity, but because it simply is more marketable. Johnson was an editorial art director for the **Chicago Tribune** for ten years and, since 1987, he has been communications director for the G. Leblanc Corporation based in Kenosha where he has lived since 1982. He is currently at work on his second novel.



A Weekend In The Country

When I packed my bags to go to Manitowoc October 21-23 for the State AFL-CIO Women's Conference, I thought I was getting away from it all - a weekend in the country far away from newspaper deadlines and the political struggles that beset the Queer Nation.

Oh, naive me. . "Norma Rae's Sisters: Women in Labor History." I guess I was sort of the Friday night entertainment and, I'm happy to report, the show seemed to be a hit.

On Saturday morning, I presented a report on the findings of the Women of Wisconsin Labor Oral History Project. Over the last four years, I've interviewed women prominent in their labor unions, some who were organizers as far back as the 1930's. All the tapes and memorabilia are being placed in a special collection at the State Historical Society and a book is planned.

The purpose of the project is to create greater documentation of women's contributions to the labor movement to insure that future historical accounts do not exclude women. It's been an absolute pleasure for me to conduct the interviews and get to know the women. I really can't imagine any better job than sitting around talking to older women about their lifetime experiences. In the process, I've made many new and wonderful friends.

After my speech, two other guests were scheduled. One was Sen. Herb Kohl, who I'd been trying to reach for weeks regarding his cowardly vote on Gays in the military.

Despite his generally liberal voting record, I am not a big fan of Herb Kohl. I think he's wimpy-assed, indecisive and none too bright. I worked briefly in a Kohl's Department Store warehouse in the early 1970's, where women who had worked 8 and 9 years at hard, heavy, sweated labor were making 5 cents above minimum wage with no benefits. He can brag all he wants about how his unionized food store employees loved him, but back in the warehouse it was sweatshop city.

I made a decision that as eager as I was to confront Kohl, I couldn't do that at the conference. I was a guest, after all. Yes, despite my reputation as a bull dyke in a china shop, I do have my moments of diplomacy.

A vacant- looking Kohl was led to the stage, trailing behind a woman who was holding his hand. I was seated on the stage near the podium, and I shook the Senator's clammy little hand when we were introduced. But when he began his spiel about how happy his workers always were, I quietly packed my things, left the stage and took a seat at the back of the room, all suppressed rage.

I cannot begin to tell you how elated I was then when a handful of bold, passionate dykes rose to challenge Kohl for his vote on the Pentagon ban. (See story, this issue.) And they were tenacious! I wish you all could have seen them! Mother Jones would have been proud! I don't think he knew what hit him. He was at a labor gathering and got a resounding welcome for his stand against NAFTA (which I expect him to flip-flop on before the final vote Nov. 17), but he clearly didn't expect to be called on the carpet for the Gays in the military issue.

the event was about the controntation with Sen. Kohl. The labor movement continues to be male dominated and pretty conservative, and the AFL-CIO Women's Committee has sometimes had to defend the very idea of a separate women's conference. Good god, what'll happen when the powers that be find our the women let the queers in!

There were a variety of other workshops, on family and medical leave rights, women in non-traditional trades, building women's networks and job survival skills. Mary Jean Collins, a former officer of NOW, currently with People for the American Way, talked about the religious right's threat to the labor movement. She made the connections to other right wing- targeted causes, like Gay rights.

The other "celebrity" speaker, who was a startling contrast to Sen. Kohl, was State Supreme Court Justice Janine Geske. Geske is a woman of Amazonian proportions (regular readers will recognize that as a compliment) who strode confidently up the aisle and onto the stage. She gave me a firm and warm handshake and complimented my speech. I told her I thought she was a helluva judge in Milwaukee County.

Geske was recently appointed by Gov. Thompson to fill the seat of retiring Justice Louis Ceci, a reactionary. Geske faces an election next year and that morning she was every inch the politician, touching on all the key issues an audience of working women would want to hear. She recalled working her way through school and struggling as a divorced mom, experiencing discrimination in the job market, and balancing home and work.

She spoke of representing poor and elderly clients during her years with the Legal Aid Society and of her many years on the bench. She refused to say whether she was pro-choice, but said she recognized Roe v. Wade as the law of the land which she was sworn to uphold.

I don't know whether I'll vote for Geske next year. I'm very interested in seeing her decisions in the next few months, her constitutional interpretations and, particularly, how she rules on the joint adoption case by the Lesbian couple in Green Bay. But I was very impressed with her demeanor on the bench in Milwaukee. Just one example, that I think is representative of her judgment, will suffice.

Turhan Taylor was found guilty of reckless homicide in the death of Charles Hiler, who made the fatal mistake of inviting Taylor home for sex. Hiler was repeatedly stabbed, and Taylor fled in his car. Taylor claimed a flashback to a prison rape had triggered his attack on Hiler and, in pleading for a lenient sentence, he raised the prospect of future prison abuse. I'll never forget what Geske said when she threw the book at him. She said she was very sorry for what had happened to him. "But this is not about your treatment. It is about the death of Mr. Hiler."

My reporter's instincts kicked in. I turned on my recorder and I got the scoop in which Herb told me he is not a Gay or a Lesbian! I, for one, never suspected Herb was a Lesbian!

Gay issues were pretty prominent at the conference. State Rep. Tammy Baldwin was on hand to present a workshop (along with Kris Paap of the Teaching Assistants Assn.) on "Understanding Gay and Lesbian Issues" in the workplace. They Issues'' discussed state law regarding sexual orientation and employment issues, the concept of domestic partnership and the movement to establish partners' benefits through legislation and contract negotiations.

The delegates later passed a resolution, without debate, calling for legislation on the federal, state and local levels modeled after Wisconsin's statute which prohibits discrimination based on sexual orientation. The resolution also called on local unions to utilize contract negotiations to eliminate discriminatory practices.

What Should You Do If **Police Entrap You?**

[Milwaukee]- It happens all the time, in cities and towns across the United States. Someone is enticed and then arrested by and "undercover" cop on public lewdness charges. This, according the Little Black Book by Gabriel Rotello and Evan Wolfson and published by the Lambda Legal Defense and Education Fund.

Lambda is the nation's oldest and largest non-profit legal organization advancing the rights of Lesbians and Gay men.

Such laws are, according to Rotello and Wolfson, are "almost exclusively against people perceived to be Gay. Heterosexual couples making out in "lovers' lane" or in a park, usually get off with a warning or a chuckle. Gay and Lesbian couples face arrest, prosecution, harassment and severe punishment.

Almost Always Entrapment

According to Rotello and Wolfson, people are "almost never arrested because someone else saw them having sex, was offended and called the police.'

Instead, the arrests are made by an officer who has been hanging around pretending to be interested in sexual contact. As in reported cases here, the officer follows people around, sometimes exposing themselves, often engaging in provocative and lewd behavior.

The reason, the authors say, for our treatment is that we are viewed as criminals deserving of punishment anyway, an attitude that affects us all.

Easy Victims

Because there are usually no witnesses, it is the victim's word against the cop's. And, Rotello and Wolfson say, "Courts almost never challenge police testimony, no matter how ludicrous.

A Milwaukee lawyer who has handled many such cases of victims who try and take their case to court, said that she has not won a single one.

Another lawyer noted that such a case can and will be elevated from a misdemeanor to a felony if it is contested. The wisest course of action is to pay the fine and walk away.

Rotello and Wolfson are quick to say that many people see a role for lewdness

laws. "But it is how these laws are enforced, they say, that is most troubling."

What To Do

Rotello and Wolfson advise the following steps:

Do not give in to embarrassment, shame or fear. An arrest is often made easier for the office by the target's willingness, even eagerness, to appear cooperative in hopes of getting out of trouble.

You have the right to remain silent, and in almost all cases you should. Defer all decisions about what to do until you get a lawyer.

Write down all relevant information as quickly as possible Such information should include the names and badge numbers of the arresting officers, and what they did before, during and after the arrest. Include everything that was said by them and by you. Note anything that would support a charge of entrapment or enticement.

Get a good local lawyer

Know your legal options Make sure you know exactly what you are charged with and what level of crime (felony, misdemeanor) or violation it is.

Afterward, the officer told Siegel to leave so "I wouldn't blow his cover.

Siegel said that he learned that "Mourice" was really a Milwaukee County Sheriff's Deputy named Carlton W. Moore, badge #338. Attempts to reach Moore for comment were unsuccessful. Repeated attempts to reach Sheriff Richard Artison were also unsuccessful.

At first, Siegel decided to fight the ticket, but after talking with legal counsel, decided against it.

Siegel said that an attorney experienced with such cases, told him that she had had several cases like his and none were successful. She further said that if he decided to fight and plead "not guilty," experience told her that the charge would be turned into a criminal charge that carried a \$1,000 to \$5,000 fine and/or 90 days in jail. Siegel paid the ticket.

Siegel maintains that "This officer gained my confidence, entrapped me, came on to me verbally and sexually


Christopher Ahmuty, Executive Director of the American Civil Liberties Union of Wisconsin, said that private consensual sex was not the purview of government regulation based on morality or a code of ethics. The only appropriate regulation, he said, must be based on public health and safety concerns.

In Oregon

In Portland, Oregon, there is something called the "Park Exclusion" ordinance. According to Mary Overgaard, Portland Deputy City Attorney, a person arrested in a park for "lewd conduct" receives an "exclusion ticket, by which they are excluded from the park for up to 30 days. The ticket is considered a violation, not a misdemeanor and carries no fine.

It applies to everyone, straight and Gay, she said, and is a "low key thing." She said that both female and male officers patrol the parks so that there is no suggestion of entrapment.

Numerous reports by sources who have requested anonymity say that this kind of thing is going on in Estabrook Park and in other parks. One informant said that he witnessed several men in Estabrook Park on Sunday, October 24, being arrested. There seems no let up at this time.





Kohl, spoke against and voted against both measures.

Kohl said he knew that Gays and Lesbians "did not get all that they wanted, but I think that it is significantly different and better than when this debate started." He said that people entering the service would no longer be asked about their sexual identities and, in a phrase that drew some guffaws from the audience, said that Gay service members "wouldn't be chased down very much anymore.

"That's Not Good Enough!"

Before he could complete his answer, another woman rose and shouted: 'Senator Kohl, that's not good enough!" She spoke with great emotion about how unfair it is that in the military, as in the workforce generally, straight people can be themselves and talk freely about their lives while Gays and Lesbians are denied that right and are forced to remain secretive.

Kohl replied that advances in civil rights have often proceeded a step at a time and said that the new policy codifying the ban "is a step in the right direction.

Kohl answered several other questions on Clinton's health care plan and NAFTA before exiting the hall. Outside, he spoke to the small group of women who had challenged him on the Pentagon ban. When he again referred to the new Pentagon policy as an advancement, Anne Habel gave him a piece of her mind: 'That may be, but that's no credit to you. Because there were choices you had during this whole thing. There were debates. There were amendments. The Clinton administration's position was, I think, abysmal. But then, there were even worse alternatives than that, and I think you took one of the worst alternatives, and I don't think you spoke out clearly in ways your constituency would have supported." 'This is Wisconsin," Habel reminded the Senator. "Your constituency would have supported you if you had taken a much clearer position on non-discrimination. And you didn't.'

"Why was that an unclean vote, and why were you willing to make an unclean vote on the Nunn Amendment? Jamakaya asked.

Well, I'd have to take another look at the whole amendment," said Kohl. "It had several different parts to it. I'd be happy to take a look at it and write back to you on it. Because I don't recall all the words. You know, I vote on many things

"But what I do believe you need to do is look at the sum total of everything that happened and then make a judgment on it," said Kohl. "You can take all my votes, including my vote for the final bill. And then ask yourself: is this better than it was? Not what we want, but is it better than what it was?... In my opinion, the status of Gays and Lesbians in the military is better than it was before this debate - and will be continually better."

"And I need to tell you," said Habel, "that irregardless of that particular amendment and that bill, that whatever happened there is not good enough. What I expect and what I want, and I'm telling you because you represent me, is equality. Period. And that's where I need you to go as a representative."

"I Respect What You Say"

"I understand if you think that I should have been stronger in defense of the Gay and Lesbian position on this issue." said Kohl. "I respect what you say, and I'm sensitive to what you say, and I don't stand here in opposition to you. I've had a chance to discuss it with people in the movement since I cast the vote and I've been sensitive to, if not disturbed by, the criticisms that I've received. I'm not indifferent. You know, we all go through learning experiences. But I'm not somebody who's in opposition to the things that are important to you.' Kohl said he hoped there would not be a "rift between me and people like yourself." He acknowledged the "disappointment" Gays and Lesbians feel but said "There will be other votes.'





Two for One Special

"I did not speak out in a way that would have encouraged discrimination,' Kohl responded defensively.

Voted for Nunn Amendment


"But you did vote for the Nunn Amendment which made the language stricter than President Clinton first proposed," Jamakaya noted.

Kohl's verbatim response: "Well, you know, that is sometimes in fact and then, in terms of what really is, are oftentimes in public life and politics are different* things, and the votes that you cast are

Jamakaya then interjected: "I think some of the disappointment may come from the perception, however correct or incorrect, that you may be a part of our community. Do you want to make any comment on that?"

'You mean am I Gay or Lesbian?'' asked Kohl. "No."

At least twice during the 5-10 minute discussion, Kohl's aides urged him to go on to his next appointment. Both times he waved them off, indicating he felt it was important to talk it out. While none of the women present were satisfied with his answers, they were glad for the opportunity to express their views and for the fact that Sen. Kohl stayed to listen.
