

Madison's Historic Hotel Washington, Nationally Known Gay Mecca, Burns Plans are to Rebuild

Milwaukee—The Hotel Washington complex has long been a focus of entertainment and socializing for the Madison Lesbian and Gay community. Its national reputation has attracted visitors from all over the country. On Sunday, February 18, 1996, the Hotel Washington burned to the ground.

Along with the 22-room hotel, including 10 rooms for low-income permanent residents, the building was home to the Club de Wash, the Barber's Closet, the New Bar, Rod's, Café Palms, Café Espresso, Micro Bar, Speed Print and the Barber's Closet Salon. More than 100 people worked in the building.

According to reports, the fire began a little after 6:00 a.m. Jeff Schultz, an assistant manager and resident in the building called the fire department at 6:15 a.m. Within minutes a fire crew was on the scene and discovered "it was a huge fire."

According to Bernadette Galvez, a spokeswoman for the Madison Fire Department, additional fire crews arrived at 6:28 a.m. and began searching the building for victims. The blaze, however, proved to be too great and the searchers were withdrawn.

That no one was killed in the fire was due in large part to three alert employees, Steve Richards, Michelle Dorland, building managers, and Schultz. It was they who ran through the smoke-filled halls rousting the 15 residents and getting them to safety.

For awhile, there were rumors that arson had been involved, but these have been put to rest. According to Greg and Sherry Scheel, the fire was accidental. It started in the office area in back of the Café Palms and Espresso Shop.

The Hotel Washington has a long and rich history in Madison, dating from 1885. The building was purchased by the late Rodney Scheel in 1975. Scheel, one of Madison's most prominent Gay activists and philanthropists, died in 1990 of complications due to AIDS.

While the old building went up quickly, some few artifacts were saved. These included some pictures and Rodney Scheel's desk.

Plans are now to rebuild. Greg and Sherry Scheel were almost immediately in conference with insurance adjustors and architects.

Rod's bar itself, located in the basement of the building, was somewhat less damaged. Possibly it could re-open by the first of the year, while the rest of the building is constructed over it.

Gay-Bashers Can't Stay Away

As the fire roared, one bible-thumper started preaching to the on-lookers about how they ought to get "saved" and other such religious prattle. The miscreant had a cup of coffee tossed in his face before police led him away.

Ron Greer, the Madison fire-fighter who has come under fire for passing out anti-Gay literature on duty (for which Greer is currently under investigation), came to the scene to watch with his two sons.

"I'm not sorry about some of the businesses that are gone now," Greer is quoted as saying in the Wisconsin State Journal. "But I also will add that I won't help raise money to get those businesses started again."

Madison Mayor Paul Soglin and a group of elected Gay officials dennounced Greer for his remarks.

"Ron Greer might not have ignited the match that started this fire," said Nikki Baumblatt, co-producer of WTSO-AM's Saturday Night Out. "But he has ignited the flame of anti-Gay sentiments in Madison."

Cabin Republicans. "Since 1972, Republican candidates thought they could harness the working class Democrat vote to their advantage. Buchanan's tapped into these social conservative and fiscal liberals, many who were Democrats.

"He's played the anti-Gay card, the race card, anti-Semitic card and the corporate bashing card. Ralph Reed [head of the Christian Coalition] now has the true Far Right candidate he's been demanding," Tafel said.

"And now the Republican Party looks poised to tear itself apart and hand Bill Clinton a victory. Buchanan divides the party as he divides the country," Tafel added.

Tafel urged all Gays and Lesbians to vote in Republican primaries against Buchanan.

"The front lines of the battle for the Gay community are in the Republican Presidential primaries. No matter your political persuasion or who your general election candidate will be, voting against Pat Buchanan in the GOP primaries is the most important act for Gays and Lesbians in this political year," Tafel said.

Tafel urged Gays and Lesbians to cross over in those states which allow it, as Wisconsin does, and vote against Buchanan.

"Stopping Pat Buchanan now should be the goal of every Gay and Lesbian American," Tafel said. "His appeal to the working class in a general election could be surprising. If he lenged Buchanan to debate her.

Gunderson, the only openly Gay Republican in Congress, offered to participate also.

"I join with Elizabeth Birch in calling for a dialogue or debate on these issues," Gunderson said in a statement. "The party of Lincoln, the party of freedom, the party of individuals' rights to chart their own destinies cannot be home to prejudice in any way, shape or form."

Poll Shows Voters Object to Gay-Baiting

Anti-Gay themes being sounded by GOP presidential candidates are not working with at least some of the Republican and independent voters, according a recent poll released by the Human Right Campaign.

The poll, taken in New Hampshire just before that state's primary of 443 people, found that 31% of respondents felt it is "wrong to use Gays to score points."

A total of 32% said they "strongly disapprove" of the rally held in Des Moines sponsored by the Christian Coalition to speak out against same-sex marriage and of "mixing extreme religious views and politics.

The poll also found 32% of respondents would be "somewhat less supportive" or "much less supportive" of a candidate who signed a pledge opposing same-sex marriage.

Gays Say Blood Drive Questions Discriminate

Minneapolis-AP-A University of Minnesota Gay group is urging donors at the school's annual blood drive to support changes in screening questions they say discriminate against Gays, Lesbians and Bisexuals. The group, called the University Gay Community, says bloodcollection agencies exclude potential male donors who acknowledge having had sex with an-other man even once since 1977.

Sean Wherley, president of the group, said Tuesday that such a policy does not reflect whether the participants engaged in safe sex.

It is harmful to perpetuate the myth that it is inevitable (that people who practice Gay sex) will have HIV and AIDS," he said.

He urged that blood-collection agencies use more specific questions to identify people who have used condoms or who have tested positive or negative for the AIDS virus.

Blood bank officials emphasize that their main concern is protecting the blood supply and the public's confidence in it.

The University Gay Community is not boycotting the weeklong blood drive now under way on the Minneapolis campus. The blood drive is sponsored by the university's Boynton Health Service.

Gay-Bashing on Rise in San Francisco

San Francisco-AP-City officials don't know whether an increase in hate crimes represents a greater number of attacks, or shows the public is simply more aware of the issue The city saw a 23 percent increase in hate crimes in 1995, led largely by attacks on Gays and Lesbians, according to the police Hate Crimes Unit.

'It may simply be that more people are aware of how to file a complaint,'' said Sgt. Her-i Jones. ``It's my impression that more people know now that these kinds of incidents are man Jones. crimes and that the police will take action when informed about them."

But members of hate crime watchdog groups say that while there may be normal annual violations of 10 percent or so, a jump of 23 percent is a matter of concern. "The fact remains that the numbers themselves are so high that they are simply intolerable," said Lester Olmstead-Rose of Community United Against Violence, which monitors crimes against gays and lesbians in San Francisco.

Violations range from verbal abuse to physical assaults. The number of such crimes rose to 350 last year, up from 285 in 1994. Every category except anti-Semitic and ethnic attacks rose, but the largest jump came in the Gay-related classification.

The increase comes at the same time other Northern California communities, including Oakland, Berkeley and Richmond, report drops of up to 40 percent for such crimes.

Buchanan to Gays: "NO!"; Others, "Maybe"

Washington-AP-Pat Buchanan said he wouldn't allow openly Gay people to work in his administration if he were president, although he admitted worked with closeted Gays and Lesbians as an aide to President Nixon. "I've worked with people in the Nixon White House who were Gay, not openly Gay. They're good people in a lot of ways," Buchanan told CNN. "I would have no hesitation of having folks like that. But I don't think their lifestyle should ... discredit the administration.

In other words, Roberta Achtenberg no," he added, referring to the former assistant secretary of housing, an openly Lesbian Clinton appointee who resigned to run for mayor of San Francisco.

Asked if he would ferret out Gays, Buchanan said, "Look, the FBI does those investigations. I don't do those as president.

The Human Rights Campaign said Buchanan was "exploiting the fears" of people in a segment of American society who don't agree with homosexuality.

Polls consistently show that American voters are overwhelmingly against job discrimination against Gay people," David Smith, a spokesman for the Washington-based group, said to-'Buchanan's position on whether he would accept a .Gay person in his administration is another example of Buchanan's extremism. He continues to Gay-bash with very little remorse

The GOP candidate, under scrutiny after two of his campaign aides stepped down after being linked to racist groups, said, however, that he would be "open" to having minorities join his administration

Asked whether a black person would be offered a high appointment in a Buchanan admini-stration, the Buchanan told CNN, "I would certainly not rule that out and I would probably rule that in."

As to women, Buchanan has said they "belong in the home."

Some Dutch AIDS Sufferers Choose Euthanasia

Amsterdam, Netherlands-AP-About one-fifth of deaths during a survey of Gay AIDS victims in Amsterdam were by euthanasia, a study published Friday, February 23rd, concluded. The study was sponsored by the city's Municipal Health Service, which researched the course of HIV infection and AIDS among more than 1,100 Gay men

Between 1985 and 1992, 160 participants were diagnosed with AIDS and 131 of them had died by January 1, 1995. Of those, 22 percent died as a result of euthanasia and doctor-assisted suicide, which comes under the nation's liberal euthanasia guidelines.

"They've reached a certain stage and they just want it stopped. They ask, 'let me die with dignity,'' said Henk Krol, editor-in-chief of the city's Gay Newspaper and a counselor to Gay AIDS patients.

Although euthanasia is technically illegal, it is permitted when repeatedly requested by lucid patients suffering unbearable and irremediable pain.

"They want a dignified way of saying goodbye," said Jos Holweg, a counselor to gay AIDS patients at a local AIDS prevention center. "There's a strong sense of independence among Gay men. They know that they need to take control in order to live the way they want to live ... that also includes the quality of their death.

About 3,800 AIDS cases have been diagnosed in the Netherlands since the pandemic started, and Gay men account for approximately 80 percent of them.

Although the gay euthanasia study only covered the Dutch capital, Amsterdam has the nation's largest Gay population and is usually considered a bellwether for gay communities else-where in Europe. According to Krol, homosexuals make up approximately 10 percent of the



Gay Monk Defrocked For Having Sex with Monks

Bangkok, Thailand-AP- A Buddhist monk accused of violating the monks' code by having sex with two other monks has been arrested. The case came amid increasing concern over mounting scandals in the monkhood. Buddhism, along with the monarchy and nationalism, is considered one of the three pillars of Thai society. More than 90 percent of Thais are Buddhist.

Deputy Education Minister Chaovarin Latthasaksiri led ministry officials and clergy Sunday in ousting Viroj Saengpha as a monk. He was taken to a local police station and charged with impersonating a monk, meaning not living up to expected standards. Buddhism teaches renunciation of worldly desires and possessions.

Chaovarin said his ministry was trying to locate the two other monks, one of whom allegedly took photos of the encounters and sold them.

Traditionally, almost all Thai men spend at least a few months as monks. But lack of an adequate screening process, critics say, has allowed criminals to use the clergy as a temporary refuge. In January, a Buddhist monk admitted to murdering a 23-year-old British tourist. One of the country's most respected abbots has been arrested for allegedly raping young hilltribe girls.


Anti-Gay Group Fined

Olympia, WA-AP-The state Public Disclosure Commission has fined an anti-Gay Far Right extremist group \$500 for failing to meet finance disclosure law last year.

The Committee for Equal Rights Not Special Rights backed failed Initiative 166, which would have barred government from including homosexuals under anti-discrimination laws. It was fined for failing to file reports on campaign donations and expenditures and to disclose the names and employers of all who contributed.

The maximum fine could have been \$2,500, but commission member Jocelyn Marchisio recommended the \$500 fine because the committee ultimately tried to comply with state disclosure laws.



MAP's Gay Outreach is a "Damned Good Program" Yuri Keegstra Says.

He was called Yuri after the character in Boris Pasternak's Dr. Zhivago. It's appropriate. There's the same Pasternakian intensity about him of one born into revolutionary times. There's also that look he has of caring, compassion and deep concern that is found in the "Laura Poems" and the haunting music that was composed to go with them.

Yuri Keegstra is familiar to the Milwaukee community. He and his late partner, Christo-pher Fons, were the heart and soul of ACT UP Milwaukee, (Yuri denies that, giving credit to all its members, but it's true nonetheless), helping materially to take the disease into the headlines as well as doing whatever they could to prevent its spread.

Currently, Yuri works at the Milwaukee AIDS Project (MAP) as part of the agency's Outreach Program to the Gay and Lesbian community. It is good to see him. He looks well

Yuri was born and raised in Chicago, the son of a Methodist minister. They traveled around a lot. He attended Michigan State, entering as s sophomore and majoring in history and comparative religions. It was there that he met Craig. They fell in love. Craig died of complications due to AIDS

Yuri left Michigan and returned to Chicago, there to join ACT UP in 1990. As a member of ACT UP Chicago, he met Christopher when they were both in Madison at an action, and eventually moved to Milwaukee to be with him.

As part of ACT UP Milwaukee, they were like two sparks coming together to make one fire. Perhaps they knew they would come down in flames, but Oh, what a glorious

Christopher died a year ago now, of complications due to AIDS, but as the disease took its terrible toll, Yuri stuck by his spouse.

Today, as he did then, Yuri protests that he did nothing unusual, caring for Christopher, loving Christopher as he did. But there are those who disagree. Like Zhivago at Varykino with Laura, Yuri showed that love is heroic. In tumultuous times it is steady. He showed us what love is; that love lays itself down and considers itself fortunate so to do.

Following Christopher's death, Yuri mourned and mourned deeply the way tender hearts slashed through with romance must do. Even now, his lip quivers when he speaks of Christopher, but while the hole in his soul will always be there, life must go on.

Part of the will to go on, he says, comes from the rage he feels and has felt over the disease. "The rage can't just fester inside," he says. It's got to come out constructively. "That's very important," he adds.

To channel his feelings, and knowing that Christopher would want him to move on, he has re-involved himself in ACT UP Milwaukee. But there is another route for him as well, one equally as important. That is working at MAP.

He started at MAP this past January 8th joining the agency as Gay Community Outreach Specialist, where he works with Andy Bagnall.

It was not easy, he says to make the deci-sion to come to MAP. He had always worked outside "the traditional means. It was soul-searching time for me," he said.

But finally he decided to come "on board," as they say. He talked to people working in the agency; became excited about the Gay Outreach Program, and realized that there was scope at MAP to fight the disease, ignorance and offer help, just as he has always done.

"What I learned," he said, "was that it [Gay Outreach] was a damned good program and I wanted to be a part of that.

Among the most visible things that Yuri, Andy and the volunteers do is to go from bar to bar distributing condoms and talking to those who want information.

"I enjoy doing this," Yuri says. "I enjoy being a resource person for people to talk to about issues that concern them.

He is fully aware that, while the knowledge about AIDS prevention is widely disbursed. that knowledge sometimes doesn't get changed into behavior. This is the task of MAP's Gay Outreach. This is MAP's and their participation in these revolutionary times.

The President's Award is given for "above and beyond" service to our community. This year's President's Award went to Erv







Pull in the wagons! Build a fence along the border from the Gulf to the Pacific Ocean! Hunker down! Pat Buchanan speaks to a longing in some Americans that is nearly as old as the country is itself. It is a longing, a deep desire, to stay shielded behind the oceans, to build the "city set upon a hill", and let the rest of the world go by. That kind of isolationism has never been tenable, as Washington and Adams found out, and it is even less so now.

He also speaks to another longing; a longing for a half-remembered time, when there was something called "small town America," a place of little stores and brick streets, and "everybody knew your name." There was job security then, supposedly. A kid could grow up and look forward to working in mill or farm and take the place in society that his father and grandfather had.

There was prayer in the schools and bible reading too. No real problems to speak of, right? No minorities and "uppity" women pounding at the nation's door demanding equality. It was "the best of all possible worlds," or so they'd like to think.

That's gone now, for the most part—if it ever existed at all. But if it did, any of it, it was destroyed, not by Buchanan's boogymen and alien forces—NAFTA, GAPP, the UN, the Japanese, Mexicans, Gays, and the rest. It was ended by Walmart, Target and the A&P.

Where there is no vision, they say, the people perish. Well and good. But the confusion lies in the fact that vision is an outward thing, a thing of the future, not a longing for some memory gilded past.

It is in speaking to this confusion—and encouraging it—that Buchanan and his Right Wing followers do their greatest disservice to this country. They provide no vision, only a Grimm-like tale of an Edenic myth.

It's attractive. Myths always are. They are the siren's call. But as Homer pointed out in the **Odyssey**, we must ignore it and sail on by or we shall perish indeed.

An Open Letter to the Community

After almost a year of silence (due primarily to reasons of health), I would like to lift the aura of misinformation that surrounds my departure as executive director of the United in April 1995.

I do this because there are inaccuracies that continue to surround my termination, inaccuracies were evident in the article on the United that appeared in the Valentine's Day issue of the Wisconsin Light. The inaccuracies include the following: 1.1 did not voluntarily resign. I was told by the

president of the board that unless I resigned within 24 hours I would be fired. 2.In shock at that point, I handed the president

2.11 shock at that point, I handed the president my resignation effective immediately. However, on the advice of friends—who maintained my resignation gave the appearance that I agreed with the board's decision—I verbally rescinded that resignation five hours later. And the next morning (April 19, 1995), I hand delivered a letter of rescission to the board.

3.I have never been told—to this date—why I was fired. (In fact, I never even knew that my job was in jeopardy, especially since I had been given a unanimous vote of confidence by the board at the March, 1995 board meeting).

Though I was advised by attorneys that I had a breach of contract case against the United, I have chosen not to sue the agency. I did this for three reasons.

One, I am not in good enough health to pursue litigation against the agency:

Two, I want to put a painful past behind me;

Three, I did not think it was <u>anyone's</u> best interest (my own, the United's or the community) to undertake such a divisive action.

I am delighted that according to the recent article, the United is restructuring itself. However, I am bothered that the current board president continues to speak of my "resignation" as if it had been voluntary, to infer that I left the agency of my own accord. This was—and is—not true. And I have needed to say that for a very long time.

But why, you may ask, after all these months am I finally speaking up now? I guess, to be honest, I needed to get in my "two cents." To end some of the rumors. And to break silence. Because now that there is no threat of litigation, there is no reason for continued silence. Because silence is not the way all those involved in this situation—myself included can heal.

I thank the Light for the opportunity to tell my side of the story.

His recent actions—handing out hate literature at work and the city-county building have angered many people in this community. His hatred has been especially hurtful to the Gay, Lesbian and Bisexual community in Madison who have been targeted by his visible actions. Further, his most recent performance is among the most disturbing.

On Sunday, February 18th, Greer took his three sons to witness the fire at the Hotel Washington. As he voyeuristically watched the fire, he smiled and talked to the media about the "good" side of the tragedy. In the Monday, February 19th Capital Times, Greer is quoted as saying, "It's a tragic loss of a historical building, but I'm glad to see certain establishments in the place are gone. If it means the end to certain types of businesses, I don't have a problem with that."

This action profoundly shakes the trust of Gay, Lesbian and Bisexual people in this City and specifically in the Fire Department.

Gays, Lesbians and Bisexuals should not have to fear for their protection as it relates to fire safety. Will Greer, or others he claims "asked" for his hateful literature, put the same effort into fighting a fire if a home displays the Rainbow Flag?

Will Greer work his hardest to save a business owned by a Gay or Lesbian?

While we appreciate First Amendment rights, we also recognize hate speech. Hate speech is speech which nudges someone to create a hostile work environment or which nudges someone to beat up Gays and Lesbians, set fires or perform other violent acts. Hate speech is speech which finds the "good" in a fire that leaves 16 people homeless, destroys a historic building housing eight different businesses and costs the community over \$2 million in loss.

As School Board Twists in the Wind, Gays in Salt Lake Say They'll Meet Anyway

Salt Lake City, UT -- They can ban the Gay-Straight Student Alliance--along with all other nonacademic clubs--but that won't keep the kids from meeting, said alliance founder Kelli Peterson

"This is not over by a long shot," she said. We can still meet unofficially or unsanctioned on the school campus. They cannot tell us who we can hang out with.

The 17-year-old East High School senior, who says she is a Lesbian, skipped classes Wednesday, February 21st to avoid hostility she expected following the Salt Lake City Board of Education 4-3 vote Tuesday night to ban all nonacademic clubs rather than allow the alliance to exist.

There are 49 clubs at the city's three high schools that have been banned.

They include clubs for skiers, bowlers, fencers, chess players, paintballers and frisbee tossers; "Simpsons" and "Star Wars" fans; film critics and meat eaters.

The move by the school board is similar to moves made by school boards and city governments against African-Americans in the 50s.

For example, in Pittsburgh, Pennsylvania, Kennywood Park, an amusement park, closed its pool entirely rather than admit African-Americans. Other parks, school boards and city governments in both north and south did the same thing

Included in the Salt Lake City school board ban are the Young Democrats and Young Republicans, Socialists, environmentalists and Students Against Drunk Driving. There are Hispanic, Native-American, Ethnic, Multicultural, Polynesian and Latina Pride clubs.

School officials are not sure yet whether the National Honor Society and pep clubs will fall within the ban.

Well, at least we know the Bible Club is out the door," said Mary Jo Ramussen, president of the school board and one of the three to vote against the ban.

It was Bible clubs and their supporters that brought the federal government into the picture. To ensure that schools would not ban Bible clubs, conservatives lobbied Congress to pass the federal Equal Access Act in 1984. That act allowed schools to ban all extracurricular clubs but did not allow them to discriminate among clubs on the basis of belief.

Peterson's petition to form the Gay-straight alliance last December ignited a firestorm that had some legislators threatening to give up federal education money rather that permit homosexuals to form a club.

It culminated with the school board's decision to get rid of all of the nonacademic clubs. All seven board members were angry with the federal act.

Karen Derrick, who voted for the ban, fears the action will be misunderstood.

"This has nothing to do with homosexual-ity," she complained. "It was a vote on whether nor not the federal government is going to dictate ... what is going to happen in schools in Salt Lake City.

But much of the reaction has been against the students who petitioned to create the alliance

"Everyone suffers because of the Gays," said Brett Shields, 16, a member of East High's Beef Club, which met last week to eat steaks and burgers and attend a monster-truck rally

An anti-Gay petition circulated at East.

'I am OK with what the board did,'' said Sean Rogers, 16, who signed the petition. They should not have sexual clubs in any high school.

"I'm pretty disappointed by the decision," said Charles Shackett, principal at Highland High School. He and his counterparts at East and West high schools had sent a board a letter supporting the option to keep the clubs under certain guidelines that assured compliance with the law.

In a pretty strong attempt to keep Gay and Lesbian clubs from forming, they've opened a can of worms," Shackett said. Now everyone will be defining, then adjusting to try and fit within the criteria." He cited a chess club member's contention that their area of interest was related to mathematics.

After the East High students petitioned to form a Gay, Lesbian and Bisexual club, similar requests were made by students at Salt Lake's other high schools and at Cottonwood High School in the adjacent Granite School District.

The debate became a statewide concern as GOP lawmakers in January met illegally in a closed-door caucus to grill state education officials about a perceived threat from pro-Gay "forces" in schools.

The meeting included the showing of a segment of a anti-Gay video widely disseminated in Oregon by religionists of the Far Right during their second attempt to pass anti-Gay legislation.

Since then, two bills addressing Gay clubs have been filed. One would require parental consent for participation in clubs that meet on school grounds. The other would prevent school employees and volunteers from supporting or engaging in sodomy while on school property.

Utah Office of Education attorneys say existing rules already prevent illegal activity.

Sponsors of the bills said the school board's club ban would help ensure passage of the legislation.

My bills were intended to leave most of the decision making with respect to these issues to the family and the local school district," said Republican state Sen. Craig Taylor.

Gov. Mike Leavitt has not officially endorsed the legislation but has decried the formation of Gay clubs in schools on personal religious grounds.

'As far as the activity, as far as the life-style, I'd like it not to be promoted,'' he said. The governor, roughly 85 percent of the legislators and about three-quarters of the state's population are Mormon. The church condemns homosexual acts and any sexual relationship outside marriage.

Anti-Gay Bill Passes

The Utah Senate on Friday, February 23rd, passed two measures aimed at curbing Gay clubs in public schools.

The bill, SB 262, that would require parental permission for a student to join a school club passed 22-4 without debate

Students Protest

A girl was seriously injured Friday as hundreds of students left school to march on the Capitol and to demonstrate against a ban on extracurricular clubs that was aimed at Gay and Lesbian students.

The high school students were angry with the Salt Lake City School Board's decision to ban all non-academic clubs rather than allow the Gay-Lesbian support group to form at East High.

Students at two other high schools also had hoped to form such groups before the board acted late Tuesday. The demonstrations were noisy but peaceful. A sophomore on her way to the Capitol was pinned under a car and was hospitalized with internal injuries and fractures

14-year-old West High student Jacqueline Marie Eteaki became pinned under the car that had carried her and others to the rally on the Capitol steps, a mile from the school.

The march continued in spite of the accident, and from the steps of the Capitol, junior Andrew Hunt decried the board decision.

'Over the past couple of years, the Legislature, the school district and the administration have pushed their morals on us," said Hunt

'Not everybody cares about the Gays and Lesbians," added Stacie Cottrell, 16, a West sophomore. "But they banned the Hispanic club, the theater club, all of them.

Students at East High and West High coordinated their walkouts. At East, some 400 students gathered across a busy two-lane street from the school, shouting "We will street from the school, shouting ``We will fight for our rights,'' and hoisting signs 'Separate Church and State'' And reading Honk in Support of the 1st Amendment.'

Principal Kay Peterson used a bullhorn to persuade the students to return to class. want you to know I agree with your cause," Peterson told the cheering crowd. The students shouted ``Hell no, we won't

go" to his request they return to class and not force a later makeup day. But within minutes, students began streaming back across the street and into the school.

Vanessa Palme, an East High senior and member of the Gay-Lesbian-Straight Alliance that requested a formal club, said students heeded the principal's request because they achieved what they wanted: their protest was heard.

I definitely think the point was made," They're wrong to take away all she said. the clubs.

Some 15 police officers slowed down traffic and tried to keep students from crossing back and forth across the street. There was no violence, but one youth was detained after striking an officer with a snowball.

Another 100 students watched the East High protesters, some of them denouncing the Gay-Lesbian-Straight Alliance for pressing the issue, others ambivalent about whether to join in the protest. Several boys hoisted their own sign, which read `SAFE _ Students Against Faggots at East.

Seniors Misty White and Kara Horn watched the protest, which they called ` SO dumb." But they said the school board erred. Just give them the club. If you're not Gay, don't join. What do you have to be afraid of?" said Horn.

Sophomore Joey Wilson said the school board made the wrong choice, but was bound by the federal Equal Access Act, which requires schools to treat all non-curriculum based clubs the same.

I don't think Orrin Hatch should have

ing the Utah Republican senator cosponsored the 1984 act so that Bible study clubs could form in schools. "It should be up to the school board to say no to clubs if they want to.

They don't have to ban them all," Hatch said. "I don't see a problem with just banning the sexually oriented clubs, both homosexual and heterosexual."

Principal Stuart Hott says he dropped a ban on same-sex couples at the school's prom Thursday, February 22nd after he agreed with a parent's complaint that the ban would send the wrong message.

The parent thought we should teach tolerance, and I agreed with them," Hott said.

The ban had irked some of the 358 students at Sullivan High, who said they did not know of any Gay students at the school but thought some students might want to attend the May 4th dance without dates of the opposite sex.

I think (Gays) should be able to go in as a couple, because they're a couple. I mean, this is the '90s, jeez,'' sophomore Scarlett Martin, 15, said Thursday as she chatted with a group of friends outside the school's front door.

I don't think Hott's trying to be a jerk or anything about it. I think what he's doing makes sense," countered junior Mike Jordan, 16, before he knew the ban on Gay couples was being dropped. "He's not trying to be homophobic, he just said he didn't want a lot of other people there that didn't deserve to be there.

Some students and parents also had objected to a rule requiring students to register their prom dates with Hott. Some had mistakenly thought the rule required a meeting with the principal for prom goers who were not Sullivan High students, but all that is required is attend last year's prom when he discovered a week before the event that her date was 21.

'I felt really bad for that girl, and I didn't want to have to do that again," Hott said.

The rules were a hot topic of conversation in this Moultrie County town of 4,400 after they were announced and the Decatur Herald & Review reported on them in a front-page story Thursday.

Hott said he was disappointed that parents who objected to the rules talked to a reporter before he could make changes.

'My goal is for the kids to have a good time and enjoy the prom," Hott said Thursday.

Students like Martin said they were more worried about some of the other prom rules, such as one barring girls from wearing lingerie as dresses


'I wanted to get this dress that's silver and kind of looks like a slip, but now I don't know anymore," said Martin, who added she planned to attend the prom with her boyfriend, a Sullivan High School junior.

Hott said the lingerie rule was added because one student had boasted she planned to wear a negligee to the dance, Hott said.

'I wouldn't allow lingerie in school, ei-ther,'' Hott said. 'That's inappropriate dress. It's a school function, and school rules apply.

Controversial New Magazine Launched Aimed at Young Gay Men

San Francisco—"It's exasperating. A lot of people want to pretend young Gay people don't exist. Thousands of Gay kids commit suicide every year because they think everyone is straight. These people who think nobody's Gay till they're 25 are blind to reality," said Jane Thompson, business manager for XY.

XY is a controversial new national glossy consumer magazine aimed at Gay male teens and twentysomethings that was launched on February 7th. It has sent the Right Wing religionists into a frenzy.

"I'm waiting for the Christian Coalition to burn crosses on my lawn," said Peter Ian Cummings, the magazine's editor. "But all we're saying is that young Gay people exist. I mean if you can have **Seventeen Magazine** for young women, I don't see what the problem is with having **XY** for young Gay men."

The magazine is a high-quality, perfectbound publication featuring topics found in many magazines—Gay or straight—but these are aimed squarely at Gay teens.

For example there's an article on the portrayal of teens in homoerotic ads; an article on computer software; one on snow boarding, and one on the latest in dance music.

"Young Gay men are the highest per capita users of the Internet," Cummings said. "This is why we have articles on things like personal web pages and why everyone has an Internet address."

Glenn feels old partially because he so vividly remembers when The Who released their classic concept album of the "rock opera" **Tommy.** Glenn loved it. A landmark moment in Rock & Roll History, **Tommy: The Concept Album** was truly different.

Here was an unconventional story about a truly unique hero: a deaf, dumb and blind kid who becomes a Pinball Wizard, an unlikely scenario surely but still a strikingly effective metaphor for many young people. Acid Queen, Pinball Wizard and See Me, Feel Me were songs that would help define a generation

father.

Young Tommy is tormented by his family, whether it is his loving parents dragging him mercilessly from doctor to doctor, to virtually anyone that offers them even the flimsiest prospect of hope or more vilely, his pederastic Uncle Ernie having his way with the boy while baby-sitting.

Tommy's diabolical cousin Kevin might stuff him in a garbage can but does bring about Tommy's ultimate deliverance. By cruelly putting little Tommy, at the controls of a pinball machine, Kevin inadvertently places him at the alter of his salvation. The rest, as they say, is Musical History.

Tommy: The Musical is, lively and fast-paced show, filled with dazzling visual effects, particularly some clever projections by Wendall K. Washington, a very attractive cast of young singers and dancers, loads of energetic choreography and of course, some terrific music. Still, if Tommy: The Musical emerges as little more than a glorified two-hour long music video, perhaps it is because the flimsiest plot only just barely holds together Pete Townshend's marvelously hummable score. Tommy's youthful cast generally acquit themselves quite nicely, although on occasion it is difficult to tell if some of the actors are live or memorex.



'Theda Bara and the Frontier Rabbi' Portrays '20's "Vamp"



I predict that this film will become the number one attraction in America when it opens this weekend. It has Robert Redford in the role we like him in best—the romantic lead—the type of role that has made him one of the top attractions for the past 30 years.

Current leading heart throbs like Brad Pitt and Keanu Reeves should take a page from Redford's book. In other words, if you are a romantic leading man—do romantic leads and don't continually play against your type. After all, Redford is one of the last truly Super Stars we have today. All those little Redford tricks are there that blinding smile—the little nod of the head—the glib remark with a pause on the end of it until he breaks into a smile with a twinkle in his eye.

She soon becomes the super star, but falls when she leaves him. Redford comes to her rescue and sacrifices his own career so she can become a National Network star, which is right out of **A Star Is Born**. The only thing that is missing is her closing line not being "This is Mrs. Waren Foster."

TV personalities are portrayed as vain, mindless persons only interested in themselves and their climb up the ladder to success. TV executives look like they don't know their way out of their own offices. Once again, it is Hollywood's idea of what life is like behind the TV cameras. If you are a Redford fan, go see this film on the big screen. If not, Up Close and Personal is one film to wait and see on video which will be soon out, believe me!

By Carl M. Szatmary Over the past several years, for three days in early spring, writers, readers, booksellers, publishers, librarians, critics, journalists, activists and their friends descend upon Boston for OutWrite, the National Lesbian, Gay, Bisexual and Transgendered Writers Conference.

This year was no exception. OutWrite '96, Feb. 23rd through 25th, featured nearly 2000 participants taking part in more than fifty lively and diverse panels, over 25 writing workshops in addition to various public conversations and caucuses as well as keynote addresses by Edmund White and Minnie Bruce Pratt.

OutWrite '96 is first and foremost about Gay and Lesbian writing and writers. Aspiring writers had the opportunity to take advantage of a wide variety of writing and creative imagination workshops, with topics ranging from poetry to journalism to video, instructions on the basic mechanics of getting a book published to various seminars on the next frontier: cyberspace.

A writer's Who's Who, OutWrite '96 could boast some of the biggest and most exciting queer writers including Leslie Feinberg, Mchelangelo Signorile, mystery writers Ellen Hart and Sandra Scoppettone, performance artist Kate Bornstein, novelists Stephen McCauley, Mark Merlis and Heather Lewis to name-drop just a handful.

Coming on the heels of presidential hopeful Pat Buchanan's startling win in the New Hampshire primary, it is perhaps not surprising that many of the conference programs and certainly much of the discussion took on a political scope.

This was particularly evident in "Writing Off the Right: From Rhetoric to Action" which featured media darling Urvashi Vaid and David Mendoza, Executive Director of the National Campaign for Freedom of Ex-pression as well as in "What's Happening to the Voice of the Queer Left". The politics of publishing Gay, Lesbian,

Transgendered, or simply, queer books proved to be a highly volatile topic in one of the conference's key panels, "The Future of Queer Publishing" which featured Michael Denneny, founding father of mainstream Gay men's publishing, Nancy Bereano, publisher of Firebrand, a Lesbian publisher and authors Jewelle Gomez and Sarah Schulman.

Highlights included a heated debate over the realistic viability of "Crossover books", i.e. books that will appeal to heterosexual audiences, the inability of Lesbian authors to be published with mainstream presses and the inequality of advance monies paid to Gay but not Lesbian authors.

'Before and After' is a Film With a **Predictable Plot Saved by Superb Acting**

This is a good film-not a great one-but a good film. The main focus is a great character study between its two leading stars-Meryl Streep and Liam Neeson (he of Schindler's List).

The plot concerns the "before" of an average family living on a beautiful old home-stead in a small Massachusetts town. The family is amply supported by a doctor mother (Streep) and a successful artist father (Neeson). They have the average two children-a teen-age son and a rather precocious younger daughter-who seems to do all the

cooking. The "after" comes when the son is missing after the murder of one of his schoolmates . , a girl he has been dating. He was the last one seen with her, so all suspicion falls on him. The family keeps getting postcards from him . . . all over the country . . until he turns up in a friend's home in Boston.

After that, the plot takes fairly predictable turns. The father destroys evidence, not knowing if the son is guilty or not, or if the evidence will help or hinder him.

The parents disagree as to what should or should no be done to help their son. They get a lawyer who seems more intent on getting the boy off-never mind whether he is guilty or not

Only the daughter, beautifully played by Julia Weldon, seems to have a handle on what is right and what is wrong. The trail-the confessions-the ending, all seem to fall right into line. And, you say, I could have solved that a lot sooner.

But, the film has two pluses in its two leading stars. The development and understanding of their characters makes for a fascinating study, one of the best this reviewer has seen in a long time

On thing most films today lack is good strong character development or involvement. Usually they just stand around and let the action carry the plot. Both Streep and Neeson bring their strong personalities and brilliant acting talents to their roles.

I found Streep much more believable in this role than I ever did in Bridges of Madison County. And she has far greater chemistry with Neeson than she did with Clint Eastwood (but don't forget he was directing himself).

I would like to see Streep and Neeson do another film together-for I felt their chemistry was that strong. A classic love story in which they would bring their classic training to the foreground would be a treat to see.

The weak link in the film was casting Ed-ward Furlong as Jacob, the teenage son. When you first meet him, he is sullen-even refusing to speak to his parents. His dark eyes are highlighted by and excess of makeup against his very pale skin. You feel for him. You expect him to look and act this way.

He has just been through the biggest trauma of his life-the death of his friend-running away from home, family and friends-arrest and suspicion of murder.

But he looks and reacts the same throughout the film. 

Arrogant, self-absorbed hot-shot lawyer Martin Vail (Richard Gere) is little more than an up-market, publicity-obsessed ambulance chaser. His instincts are right on target when he volunteers to represent a penniless, bewildered although not an entirely unattractive young man accused of murder.

Naive alter boy Aaron Stampler (Edward Norton) is accused of the murder and mutilation of one of Chicago most prominent and beloved dignitaries, the Archbishop of Chicago (Stanley Anderson). Blood-covered and found fleeing the murder scene, his guilt seems certain.

Realizing early on in his career that truth often just gets in the way and is invariably a far more messy business. Vail has based his career on creating and selling his own versions of truth, so much the easier to conceive of catchy sound-bites for the media. Only something goes wrong here. Openly Gay Man Sees "No Moral Problem" Working for Homophobic Pat Buchanan

Walnut Creek, CA--Justin Raimondo doesn't mind that Pat Buchanan says he will keep openly Gay people out of top White House positions if he is elected

Raimondo, who is Gay and has campaigned for Buchanan since 1992, says he feels no conflict of interest in his support for the conservative Republican.

There's no moral dilemma," Raimondo, 44, told The Contra Costa Times `'I mean, Pat is not going to outlaw homosexuality. All we're saying is that is not going to be enshrined as another victim group.

He says Buchanan, who narrowly won the Republican primary in New Hampshire, has known he's Gay for a long time.

Raimondo worked for Buchanan's 1992 White House run. Buchanan even wrote the forward to Raimondo's 1993 book, Reclaiming the American Right: The Lost Legacy of the Conservative Movement.

Raimondo has been called a ``traitor'' by the Gay press, but it doesn't faze him.

I don't feel like a victim, and they do," say Raimondo, who handles media, organizes rallies and recruits volunteers from his San Francisco home. "That's their mentality, and they have a political agenda tied to it.

Members of the Human Rights Campaign, were aghast at the news.

There's a certain amount of irony here,' Kim Mills, a spokeswoman for the group, told The Associated Press. "It's a bit ex-

ploitative (of Buchanan), if not hypocritical.'' On the February 11th airing of NBC's ''Meet the Press,'' Buchanan said he doubted that he would name to any high positions an

out-of-the-closet homosexual who declared that he believed that homosexuality was a legitimate lifestyle and was engaged in that lifestyle.'

But Raimondo--who, so far, is the only Re-publican to oppose U.S. Rep. Nancy Pelosi, D-San Francisco, this fall--says other policies inspired him to work for Buchanan. Namely, For aesthetic reasons.

he agrees with Buchanan's opposition to U.S. intervention in Bosnia, the North American Free Trade Agreement and the General Agreement on Tariffs and Trade.

On issues of sexuality, he says he agrees in the separation of sexuality and state.

Sexuality is a private matter, and it should be kept private. Period. Not hiding and being ashamed," Raimondo says. "Just because you don't announce things to the world doesn't mean you're ashamed of it. It just means it's nobody else's business, unless they really need to know.'

When he spoke on ``Meet the Press,'' Bu-chanan said he knows that openly Gay people are working for him and welcomes their support

"But I tell them this: Look, I do not believe that this is a valid, legitimate, moral " Buchanan lifestyle, period, paragraph," said.

Others in Buchanan's California campaign seemed confused Monday about Raimondo's role, including his title.

That's due, in part, to Buchanan's fledgling California campaign that has no San Francisco office.

Raimondo said he is the San Francisco coordinator

Del McLaughlin, Buchanan's Northern California campaign director, said Raimondo is a volunteer but not a county chairman.

Buchanan's California coordinator, state Sen. Richard Mountjoy, (R-Arcadia), who said he has personally appointed each county coordinator, said he never heard of Raimondo

Meanwhile, Raimondo's lover won't let him put up a huge Buchanan poster in his home

It's, uh, in the closet," Raimondo said, laughing. "But not for any political reasons.

Audrey McGee and Diane Elstrom got 'in trouble." Both were in Junior High.

Mrs. Elstrom, a friend of my mother's, bemoaned the loss of "old time values."

As a sophomore in high school, in 1956, Harold Murmulstein wrapped his car and himself around a telephone pole. He'd been drinking too much beer. He was only 16. Those of us who knew him, mourned. We'd all been there. It could easily have been any one of us.

At his funeral, I remember overhearing Edith Chisholm say that if only things had been the way they were when she was growing up, in the late 20s, how good things would be.

Edith was a pillar in the Presbyterian church, but my mother, who had known her since childhood, said she'd forgotten a few things. Like the fact that she used to be a flapper, smoke cigarettes, sneak off to dances and drink bathtub hooch in the rumble seat of her boyfriend's car.

"And you, mother?" I asked.

"I was a saint," she replied archly, adding, "As I expect you to be."

Later, I would find out that my mother's canonization was of recent vintage.

I was buying a suit (75\$, top of the line, an unheard of extravagance) at McKeesport's best clothier's, Henry B. Klein's. There I happened to run into the owner, who recog-nized me. "Tell your mom that Pinky said hello," he told me. "Ask her if she remembers the time we lost the steering wheel coming down Summit Mountain? We'd had a little of your grandfather's home brew and nearly killed ourselves.

I did as "Pinky" said.

"Pinky never could keep is mouth shut," she replied. "But I'll tell you this. Pinky is the reason you can't have that car you want." She was referring to the '57 Chevy I would have killed for. "I know what happens with boys in cars.

I nodded, thinking of Stevie Hays. Not what had happened in a car between us, but what I wished would happen. And then there was Gordon Cook. That

appened in the late Autumn of

I have to confess we were a powerhouse team. That fall, with Aunt Helen driving hard behind us, we swept the competition from the field. Get past Greensburg Central Catholic and the very formidable team commanded by Sister De Chantall, Aunt Helen said, and we'd go all the way to state finals.

But then disaster struck.

To celebrate our victory over Duquesne High, Joel Falic (a Pete Sampras look alike) threw a party one Saturday night. His parents who were away for the weekend, had a large house up on Grandview Avenue, a very elegant part of town. The party was the usual thing. The music on the Hi Fi was loud, the air was thick with the smoke of cigarettes, the beer and liquor flowed. Wally and "The Beaver," definitely would have been out of place. Just before midnight, the cops raided the place, but by that time, I was gone. I'd seen Stevie heading upstairs with Carolyn Judkins, a raven-haired beauty, who went "all the way," they said. I guess I didn't have any right to be hurt. I mean he was only doing what was natural to him. But I was hurt and I left.

I heard all about the raid on Monday when I got to school. Later, that morning, just before Miss. King's Latin IV class, I ran into Nick and asked him if he'd gotten caught up in it. But he said, no, he'd left the party by that time too

Meanwhile, the whole thing was the talk of the school. Those who weren't there, wished they had been. To ease their regrets, Jim Park, Joel's best friend, let it be known that he'd be holding a similar bash once we'd defeated Greensburg. Since our victory was a foregone conclusion, people marked their calendars. They needn't have bothered.

The following Monday, a week before the Greensburg tournament. I went into school where I found out from Stevie that Gordon was dead. He'd driven to Renziehausen Park (Renzie as it was called) and shot himself and no one knew why. There'd been no note. When I asked Nick if he knew what had happened, he gave me the strangest look, like a bird driven to ground by a storm, and turned away

Since Gordon's father was one of the most prominent doctors in town, the funeral, held at Finney's, was lavish. In addition to everyone else, all of us who knew him were there.

I remember the eulogies delivered by his family, Aunt Helen (particularly moving) and some of his friends. Gordon had been a fine athlete and a superb student, they said. Everyone who knew him, liked him, etc., etc., etc. I fully expected Nick to get up and say something. After all, he and Gordon had not only been partners in debate, they'd been good, close friends. I knew Nick was there. I'd seen him earlier, but as the eulogies went on, he was nowhere in sight.

Finally, when the priest got up, I decided I'd had enough and went out onto the side porch to think and smoke without being disturbed

To my surprise, I found Nick there. He turned to me. Never, ever, will I forget the anguished look on his face. Never had I seen such pain before.

"I know why," I remember him saying. "I know why," over and over again. "Why what?"

Why Gordon died, why he killed himself. It's my fault. It's my fault.'

I don't remember exactly what I said, but it was something to the effect that Gordon's death couldn't have been his fault and he couldn't know why. There'd been no note. No one knew why. No one would ever know why, and he had to stop blaming himself. But I was wrong, so completely wrong,

"The night of Joel's party, Gordon and I, we left early to be together." I remember how he looked at me. "We left together and went to Renzie Park. You understand? Together. We were there together, he and I.

At the bottom is a bomb with a lit fuse encircled bian Avengers, said the organization is trying to educate people about what their lawmakers are doing.

But the Free State Justice Campaign sent a statement to the committee saying it does not condone the lodging of threats against anyone, including political leaders.'

While we understand the anger, we regret the expression of it in this manner and do not view such behavior as helpful in furthering the cause of justice,'' the statement said.

DeCarlo and James E. Malone, another Baltimore County Democrat, said they had discussed the fliers with county police.

"Right now we're in the preliminary stages of an investigation into it," said Sgt. Kevin Novak, a county police spokesman.

We're not sure if it's a real threat of violence. If it leans that way, we'll take action," he said.

It is a crime to threaten bodily harm to a public official, including members of the General Assembly.

Police were looking into whether including a drawing of a bomb with a lit fuse might be considered a threat of violence.

Donahue said her organization has used the bomb as a logo since it was formed. She said it is ridiculous to consider the drawing a threat.

Not only because I'd made the team, but because my partner would be Stevie Hays (he of the smoldering eyes), with whom I was secretly very much in love.

On the other side, the negative, was Nick Sabin and Gordon Cook. As I remember them now, Nick gave new meaning to the phrase tall, dark and handsome, while Gordon was a nicely built serfer blonde.

Please understand.

And suddenly, I did understand. I understood very well indeed. And since I did understand, I embraced Nick. It took all my courage to do it, but there was no one around to see.

We lost to Greensburg and did not go to state finals. Aunt Helen was furious. "Death is something you have to live with," she ranted. I thought then, as I think now, she never had a clue.

Nick left school at the Christmas break. I never saw him or heard from him again.

There are those in this community of ours who hold those of us who are older now in some derision and contempt. You didn't have to face what we do now, the younger ones sav

Some things, no, like AIDS and some drugs, but other things, yes. Life was not a picnic. It never is. We had our problems too.

For those adults who, in the 90s, long for the 50s as the good old days when kids didn't have to face what they do now and all would be well if only we had prayer in the schools and family values and such, I say forget it.

There's no going back-and even if there were, despite Pat Buchanan, we'd find no Shangra La, but simply more of the same. As Harry Truman is supposed to have said. "The only thing new in the world is the history you don't know.



Newly Released AIDS Documents Show **Japanese Government Ignored Risks**

Tokyo-- For Japan, one week in the sum-mer of 1983 turned out to be a crucial--and tragic--turning point in the battle against AIDS.

During those days, emerging plans to ban use of unheated blood products were mysteriously scrapped. As a result, the number of HIV infections in Japan skyrocketed.

A picture of what happened and why is slowly emerging with the release of files of Health and Welfare Ministry documents pre-pared in 1983 as the ministry convened a spe-cial AIDS study group.

The first of those files, released by the ministry Wednesday, February 21st, graphically shows what the government has already admitted--that it failed to stop the use of unheated imported blood products despite knowing they posed a risk to public health. Japanese AIDS victims had long claimed

that the ministry knew in the early 1980s that transfusions involving untreated blood products were dangerous but that it failed to stop the practice.

About 2,000 people, mostly hemophiliacs--who often require blood transfusions --were infected with HIV via infected blood products in the early- to mid-1980s. Activists say that more than 400 have died as a result.

A storm of criticism over the government's actions at the time has already begun, and could grow with the release of more formerly secret documents.

The responsibility of the state is clear," the Sankei Shimbun, a major conservative national daily, editorialized Thursday, February 22nd

The documents released Wednesday, from the personal files of a former ministry section chief, show that ministry officials advocated instructing drug companies to stop handling unheated blood products and were aware of the dangers posed by such products. A document dated July 4, 1983, shows the

ministry was getting ready to propose the emergency importation of heated blood products, which had been judged effective in the United States.

Then the ministry abruptly reversed itself. In notes dated July 11, 1983, the section chief said officials concluded that special legal measures to allow emergency imports would be ``undesirable.

The government had maintained until recently that the connection between untreated blood products and AIDS wasn't clear at the

time and that side effects from heated prod-ucts could be harmful. Heat treatments weren't approved until 1985.

Japanese newspapers on Thursday, February 22nd, made much of a reference in the documents to ``the shock'' that allowing imported products would have on domestic drug manufacturers, calling it a possible reason for the reversal.

Health and Welfare Minister Naoto Kan revealed the existence of the files earlier this month. The ``discovery'' of the files caused an uproar, as it reversed the ministry's persistent claims it couldn't find any documents.

HIV carriers and their family members carried out a three-day protest in front of the ministry last week. On the third day of the protest, Kan, a former community activist in Tokyo who was appointed to the post last month, issued a dramatic public apology for the ministry's failure.

On Wednesday, he told reporters there nould be more ``transparency'' about the should be more government's handling of the matter, and said other files would be made public.

The Sankei called for the government to work for a compromise to resolve the issue of compensation for the victims.


Courts in Tokyo and Osaka are handling suits filed by victims. Their families have called on the government to admit legal responsibility and sought payments of 45 million yen (dlrs 420,000) for each victim. They also called for the government to provide permanent health care for HIV carriers.

Prime Minister Ryutaro Hashimoto told reporters Thursday he was grateful for the health minister's efforts to uncover the truth about the government's previous actions.

I hope that the documents will clear up the facts," he said.

Honolulu--State senators, continuing their politically hazardous journey through the highly emotional issue of same-sex marriages, are poised to decide on which of four roads to take.

Their House counterparts, meanwhile, decided earlier to sidestep the issue for this election year, awaiting to see what the court does this summer.

Although he had scheduled a vote for Fri-day, February 23rd, Senate Judiciary Committee Chairman Rey Graulty said some of the members were not ready to make a decision.

This is a very weighty issue on our shoulders, and I would not want members to make a decision when they don't feel they have the necessary facts," Graulty said. 'For many of us, we understand this is a vote of conscience.'

This decision will be a defining moment for many of us in terms as who we are as legislators," said Graulty, who likened it to the decision by the late Gov. John Burns not to veto Hawaii's first in the nation legalization of abortion, despite his very strong Roman Catholic faith.

While he declined to say what his recommendation would be, Graulty said it will not be to legalize same-sex marriages or to do nothing.

Although House Judiciary Committee Chairman Terrance Tom has indicated he plans no action on the same-sex issue this year, Graulty quoted Tom's own words: long as the Legislature is in session, anything is possible.

The Senate committee held a lengthy hearing on February 22nd on three bills. One legalizes same sex-marriages, one creates domestic partnerships for same-sex couples and one proposes a state constitutional amendment to ban same-sex marriages.

Graulty noted the fourth road would be to do nothing this session and leave the issue to the courts, a move he says he's confident would result in legalized same-sex marriages.

Poll Shows Opposition

A media poll indicates there is strong public opposition to the idea of same-sex marriage.

Seventy-one percent of the 807 registered voters responding to the Advertiser-Channel 2 News Hawaii Poll said they are opposed to same-sex marriage. Eighteen percent said couples of the same sex should be allowed to marry, while nine percent were undecided.

The only group that supported the idea were new residents, people who have lived in Hawaii less than a year.

The telephone survey was taken February 9-17. The poll has a margin of error of 3.4 percent

The findings are similar to those two years ago when the Hawaii Poll asked the same question.

Hawaii was pitched into one of the nation's most contentious social dilemmas on May 27. 1993, when the state Supreme Court agreed with three Gay couples that they had been unconstitutionally denied marriage licenses in 1990

The justices said the state had to show a compelling interest to ban such marriages and sent the case back for trial in a lower court.

Trying to bolster the state's court case by clarifying legislative intent, lawmakers in 1994 amended the somewhat vague Marriage Law to spell out that marriage was solely the union of a man and a woman.

They hedged their bet by also establishing the special commission that recommended the state legalize same-sex marriage, or at least establish domestic partnerships to give Gay couples some of the benefits afforded to married couples

The Circuit Court has given the Legislature

But Keith Elston of the American Civil Liberties Union said the measure follows a common pattern of discrimination in which people pass laws to take away the rights of other people they dislike.

What's happening here today, and what Governor Janklow signed, is the creation of a special right for heterosexuals to marry," El-ston said. "And also it's a vote against the creation of committed monogamous relationships among gay South Dakotans.'

In Tennessee There is no Genetics

A ban on marriage contracts between samesex couples is moving through the Tennessee Legislature despite concerns that it could violate the state constitution's right to privacy.

The bill cruised through a House subcommittee Tuesday, February 20th with a few changes, including one to protect other contracts between people of the same sex. And the Senate Judiciary Committee approved the bill 7-0, with Sen. Steve Cohen abstaining.

A person's sexual orientation is basically determined by their genetics, which they have no control over," said Cohen, (D-Memphis). 'And for us to use this particular bill or any other bill to attack them because of their genetic makeup is something I will not be a part

of. The bill's sponsor, Sen. Jim Holcomb, (R-Bluff City), said there is no proof that genetics explains anything, but that everything is made up by God.

Holcomb, a Right Wing Christian and family therapist, is part of an ex-Gay ministry.

Later he told the press that if a "child grows up with alcoholic parents, the kid will be alcoholic. The same thing is true for homosexuals.

Holcomb said he is trying to stop a problem that could occur if other states allow homosexual marriages.

Hawaii's courts are considering it, and Holcomb worries that homosexual Tennesseans will marry there and expect it to be recognized at home, so they can receive tax credits and other government benefits.

Cohen disagrees

The marriage bill, HB2262, set off the most emotional debate of the session when it cleared House committee and the full House earlier this month. Sponsors called the ban necessary because they believe the Hawaii courts will rule later this year that samegender marriages are legal.

A 20-year-old court ruling says Washington recognizes only heterosexual marriages. But the bill's prime sponsor, Rep. Bill Thompson, R-Everett, says Washington's Gays and Lesbians can be expected to flock to Hawaii, get married and return to the state expecting the same rights as heterosexual couples, such as health benefits and inheritance rights.

Thompson had wanted to send his bill to the fall ballot so voters could decide and to avoid Lowry's certain veto. Thompson was furious, but not surprised by the Senate decision. He said the bill generated more than 1,400 calls to the legislative hot line, more than any other measure this year.

"To me, this is just unconscionable," he said in an interview. "The people of Washington deserve to make the choice, rather than just letting it happen by default by some judge in Hawaii

Rep. Ed Murray, (D-Seattle), and other foes of the bill shrugged off the criticism and hailed the Senate's position.

It was very cynical, a piece of legislation that was really a political exercise on the part of the Republican caucus in the House," said Murray, the Legislature's only openly gay lawmaker. "Part of the caucus is incredibly right wing and they had to throw them a bone. They didn't do it on (abortion) choice or the worst of the anti-children's legislation.

A proposed Hawaiian state constitutional amendment to ban same-sex marriages might not end the issue for Hawaii, according to Dan Foley, the attorney representing the couples challenging Hawaii's marriage law.

Foley said he could not speculate the impact



on a Hawaii amendment should the Supreme Court strike down Colorado's anti-gay amendment.

However, adoption of a domestic partnership law would strengthen the state's case in defending its current marriage law in court, Foley said.

The bill before the committee would activate a domestic partnership system only upon the withdrawal of the legal case or a court ruling upholding the existing marriage law.

The Rev. Marc Alexander of the Hawaii Catholic Conference said there is a need to maintain the traditional marriages between a man and a woman.

This is not an issue of individual rights, it is a question of institutional definition," he 'Marriage is a unique community desaid. fined by the union of the sexually different.

Opposition to same-sex marriage generally is formed around religious organizations in the community, some more extreme than oth-

ers. "Homosexuality was one of the wickedness that caused the destruction of Sodom and Gomorrah," said the Alex Akuna family in a letter to the committee. 'Hawaii will come under fire and brimstone should it support same sex marriage."

The first speaker Thursday was Los Angeles attorney Thomas Coleman, who said Hawaii treats same-sex couples, even those who have been together for 25 years, as though they are strangers.

If the Legislature does nothing this year, the courts will legalize same-sex marriages, said Coleman, executive director of the Spectrum Institute which promotes domestic partnership laws

Lillian Hanada of Kauai sent in testimony that went to the heart of the political dilemma facing lawmakers in this election year.

She vowed to work hard against the reelection of any lawmaker who supported legalizing same-sex marriage.

In South Dakota

Same-sex marriages will not be legally recognized in South Dakota, Gov. Bill Janklow decided Thursday, February 22nd, in signing legislation that defines matrimony as a personal relationship between a man and woman.

The governor also signed bills dealing with local elections, child abuse and other issues. Janklow has signed 136 bills into law so far.

Effective July 1, marriages involving couples of the same sex will not be valid in South Dakota.

Supporters of the policy said it will prevent homosexual couples from demanding some legal benefits generally reserved for heterosexual couples. At stake are such things as adoption rights, tax advantages and benefits given to spouses of employees, they said.

John Paulton, executive director of the state Family Policy Council, praised the governor for signing the bill.

This new law upholds South Dakota's most treasured possession her families by preserving the traditional definition of mar-riage," Paulton said. "For the sake of our children and the moral stability of our society, state recognition of marriage must remain limited to the union of a man and a woman.'

Rep. Ed Fallon, (D-Des Moines), said lawmakers set the tenor for political debate, and singling out Gays and Lesbians will "fuel the fire of ignorance, intolerance and hatred.

Red-baiting is out, but pink-baiting is in," he said.

Particularly in the sharply conservative House, lawmakers have focused on controversial social issues. preme Court should decide in favor of samesex marriage. (See article in this issue.)

Immediately upon distribution of Kaufert's press release, an impressive coalition of groups, including Action Wisconsin, PFLAG, GLEEDA, and the Wisconsin Log Cabin Republican mobilized and began an impressive campaign to make it clear to Rep. Kaufert that residents of his district and activists in his Republican Party did not endorse his proposed bill.

When informed of Kaufert's intentions to introduce the legislation, Log Cabin Club of Wisconsin President, Jim McFarland, reacted.

"This kind of legislation is unnecessary," McFarland said. "Wisconsin law actually states that marriage 'creates the legal status of husband and wife.' Further, the law is pretty clear that a marriage contracted in another state that would not be valid in Wisconsin will not be recognized in this state."

McFarland added that these are the legislative hurdles that have been identified as standing in the way of Wisconsin's Lesbian and Gay couples who seek legal recognition of their unions.

Log Cabin Legislative Director, Scott Evertz, made these points and others in a meeting with Kaufert on Thursday, February 15th. Interviewed after that meeting, Evertz indicated that he began his meeting by stressing Log Cabin's support for same-sex marriage. He said that Kaufert was willing to engage in a discussion of the merits of the issue.

"Representative Kaufert seemed very concerned that the Hawaiian Supreme Court decision may force Wisconsin residents to recognize same-sex marriages without any sort of debate on the issue. When I indicated that that would be very unlikely given Wiscon-

sin's rather strict statutes on marriage, he seemed willing to consider seeking a legal opinion on the issue rather than introducing the bill."

In press appearances, Kaufert indicated that his measure was not intended to be anti-Gay, Evertz indicated that it was his experience that Kaufert was not "anti-Gay" nor "homophobic." At worst, Evertz said, "he might be characterized as uninformed on this issue."

"Representative Kaufert is a thoughtful legislator who seemed persuaded by the argument that the debate on this issue should occur around introduction of legislation to recognize same-sex marriages and not around the unnecessary 'preemptive' legislation he was planning to introduce," Evertz said.

In assessing the legislative success, Evertz stressed the work of Action Wisconsin (specifically, noting Board President Juliet Brodie and Region 3 Directors Mike Fitzpatrick and Jackie Richter) and "of course the leadership of [Rep.] Tammy Baldwin." Evertz also indicated that this success was

Evertz also indicated that this success was the clear result of years of Log Cabin activism in the state GOP. He pointed out that "a number of our Republican friends in the legislature came to our assistance. Their support ranged from quietly indicating to Rep. Kaufert their displeasure with his proposal to allowing us to access their staffs for assistance."

Evertz added, "Log Cabin has come under fire in the past for supporting the very legislators who came to our assistance when the chips were down. I'm hopeful this experience will cause our critics to think twice in the future."

Asked to comment on the possibility of another legislator introducing similar legislation, Evertz said, "Of course we must remain vigilant. That's always a possibility. But I'm pretty confident that legal counsel will indicate not only that Rep. Kaufert's fears were unfounded, but that no legislation will prevent the legal challenges to Wisconsin law that will undoubtedly occur in the event of a positive decision in Hawaii."



In the film, the Wisconsin Capitol will be standing in for the U.S. Capitol.





Tommy's diabolical consin Kevin might muff him in a gartuge can but does bring about Tommy's ultimate deliverance. By cruelly putting little Tommy, at the controls of a pitiball machine. Kevin anadvertently places him at the alter of his salvation. The rest, as they say, is Musical History.

Tommy: The Musical is, to be sure, a lively and fast-paced show, filled with dazrling visual effects, particularly some clever projections by Wendall K. Washington, a very attractive cast of young singers and dancers, loads of energetic choreography and of course, some terrific music.

Still, if Tommy: The Musical emerges as little more than a giorified two-hour long music video, perhaps it is because the flimsiest plot only just hurely holds together Pete-Fownshend's marvelously hummable score.

Tommy's youthful cast generally acquit themselves quite nicely, although on occasion it is difficult to tell if some of the actors are live or memores.

All three young actors creating Tommy through the years are effective, with Michael Seelfach particularly attractive, visually as well as vocally as Tommy: The Adult.





If you want to see this film, see it carly in its run. While it will debut as number one, it won't stay there very long. Redford is the only ming going for this film.

Pfeiffer is just Pfeiffer, and there is very little chemistry between her and Redford. She changes her hair color and styles while constantly changing her wardrobe, but she never changes her expression, vocal range or acting. Her one scene, her best in the film, is played for laughs, but for the wrong reason.

Pfeiffer, who has a nice singing voice and can sing, has to sing "The Impossible Dream" off key and try to reach the notes. She said the scene was very difficult for her to do. She does a good job of acting, but the audience is laughing, not knowing she is act-

It is a film in desperate search of a script. The plot is there, but it never finds the direction it is going in, with no help from director, Jan Avnet.

Some story lines are never explanaed. For

example, what trouble is Pfuiffer's sister in that she has to return to Las Vegas to help her-

What is it that she (and Redford) have to put money up for? Why does anchorwoman, Stockard Champing, suddenly become nice to Pleitter after she has just lost a job to her".

Photos from Pfeiffer's childhood give credit to her rise from a stage-stuck child to a teen to a woman who wants to be a TV star. She does everything wrong, but the camera loves

Redford sees what she has, and changes her image and life both in front of and in back of the camera. Does that remind you of Pygmalion? She soon becomes the super star, but falls when she haves him. Redford comes to her rescue and sacrifices his own career so she can become a National Nerwork star, which is right-out of A Star Is Born. The only thing that is moving is her closing line.

TV personalities are portrayed as vain. mindlesi persons only interested in them netves and their climb-up the ladder to success. TV executives look like they don't know their way out of their own offices. Once again, it is Hollywood's idea of what lide is like behind the TV cameras.

If you are a Redford fan, go see this film on the hig screen. If not, Up Close and Personal is one film to wan and see on videowhich will be soon out, believe me!
