#### Kevin Rotar, Popular Milwaukee Bartender, **Presumed Drowned**

Milwaukee- Kevin Rotar, one of Gay Milwaukee's most popular bartenders, is missing and presumed drowned after a boating accident which occurred on Sat-urday August 9, 1997.

The incident which occurred at around 4:00 in the afternoon took place about 50 yards from the Lake Michigan shoreline off of St. Francis, a Milwaukee suburb.

Kevin had joined a group of friends for

a fun afternoon of boating on the lake.

According to Mathew Brooks, a spokesperson for the Milwaukee Coast Guard, Rotar and a group of friends were aboard a 30 foot cabin cruiser the "Just Right." owned by Club 219 Manager Chuck Cicarello. Rotar worked at the Club.

An eyewitness on the boat who asked not to be named in this story told The Wisconsin Light that the boat was heading south in choppy waters while the people on board debated whether to cruise the Milwauke River or what is commonly called "Bare Ass Beach" when a baseball hat blew into the water.

The eyewitness said "Everyone on the boat told Kevin to forget about the hat, but he kept insisting on retrieving it." Before anyone could stop him Rotar "executed a perfect dive into the Lake.'

Rotar who was a good swimmer managed to fight strong currents and retrieve the hat. The witness said "Even as he swam, you could see the current was strong and the hat was drifting away, but he got it and turned to come back."
While swimming back to the boat, Rotar

started bobbing up and down in the water and began calling out for help. The horrified group on board began throwing life jackets and ropes but Rotar was too far away to reach them.

#### Personal Pride Can Save Lives Says Medical According to Brooks the hat was owned College of Wisconsin Study

Milwaukee-A new research study shows that personal pride and a positive outlook toward the future play an impor-tant role in preventing HIV infections among Gay and Bisexual men.

The study, conducted by researchers from the Center for AIDS Intervention Research (CAIR) at the Medical College of Wisconsin, shows that Gay and Bisexual men who engaged in unprotected anal intercourse outside of a monogamous relationship were more dissatisfied with life, expected a shorter life for themselves, and had a more fatalistic outlook than men who practiced only safer sex. By contrast, men who avoided risk behavior had a greater satisfaction in their current life. had an optimistic outlook for their futures, and wanted to live a long life.

"The areas we surveyed involve elements of pride and self-esteem," said Seth Kalichman, Ph.D., the study's lead author. "Our results strongly suggest that HIV prevention programs that encourage personal pride and affirm self worth will be more successful.

The research results also raise the possibility that some Gay men may put them-



Man Demands Jury Trial on Indecency Charge

Denver-AP- A Gay man charged with indecency is demanding a jury trial, claiming he is innocent and was charged because police were targeting homosexuals.

James Baca, 30, of Denver, was one of 11 men arrested July 13 in the city's Chees-

man Park.

Baca claimed that he was walking through the park when he became stomach sick,

and stood next to a tree after being overcome by pain.

"I had my hand between my legs to hold me up and the other holding my guts," he said. "All they (police) said was that I had my hand in front of me. They said, "You were masturbating.

Baca says the charge isn't true and that he was targeted because he is Gay. His attorney, Julie Tolleson of the Colorado Legal Initiatives Project, says police

went too far.

"We do not defend anyone's right to engage in public sex," she said. "But that still didn't give police the right to cast a net over the entire park. We are going to trial."

No Shortcuts to Beating AIDS

Great Falls-AP- Drug combinations known as "cocktails" may extend the lives of people infected with the AIDS virus, but a vaccine is the only way to slow the global spread of the disease, AIDS researcher David Baltimore said Thursday.

"A good vaccine could eradicate HIV from the face of the Earth," the Nobel laureate said in an address at the MSU-College of Technology.

More than 100 people attended a two-day seminar sponsored by the McLaughlin Research Institute, and an additional 50 to 80 attended Baltimore's talk.

A Great Falls man who has tested positive fort he virus for 11 years said he wanted to find out about new treatments.

I totally believe HIV is already curable," he said.

Baltimore said protease inhibitors have changed the landscape of AIDS research and, It may no longer be a death sentence."

Though rates of new cases have slowed in the United States, they are exploding in

countries such as India and Russia. While there are about 1.5 million cases of AIDS in the United States, there are 30

million globally, and that number is growing rapidly.

AIDS Drug Available to Certain Adults

Washington, DC-AP- Adults who are not responding to standard HIV therapy now have access to an experimental drug still awaiting government approval.

Glaxo Wellcome Inc. will give 2,400 adults with advanced AIDS its experimental

drug called 1592, the company announced Wednesday.

The drug 1592 is a member of an older class of AIDS medicines called nucleoside analogs, but it is generating interest because of preliminary evidence that it may penetrate the central nervous system.

While the Food and Drug Administration awaits proof from strict clinical trials on whether 1592 works, it allowed Glaxo to offer the drug for free to certain children desperate for new AIDS therapies.

On Wednesday, Glaxo announced a similar `compassionate use" program for adults. Physicians may obtain information for enrolling patients by calling 1-800-501-4672.

Aetna To Offer Domestic Partner Benefits

Hartford, CN-AP- Aetna Inc. will begin offering health care benefits to domestic partners of its Gay employees, making it one of the largest insurance companies in the country to offer such benefits.

About 300,00 employees will be eligible for the benefits when the package begins in January, said Patricia Seif, company spokeswoman. Details of the offer will be ready in September. The benefits do not extend to unmarried heterosexual couples.

Gay and Lesbian employees approved of the offer, but few are likely to take them, said Marybeth Shay, a member of the Actna Network of Gay and Lesbian Employees. These health care benefits will be treated as income for the employee, meaning they are subject to federal taxes, Shay said.

Also, Aetna will require applicants for the benefits to sign an affidavit swearing they are committed to their partners. Shay said some Gay workers might forego the benefits, since they will have to come out of the closet to their bosses.

Aetna joins The Hartford Financial Services Group Inc., Xerox and the city of Hartford as some of the major Connecticut employers to offer same-sex benefits.

#### Prison Denies Lesbian Couple's Bid for Wedding

York, NE-AP- Cheryl O'Dell wants to get married again.

After enduring years of abuse at the hands of her former husband, the 30-year-old woman says she has found true love. "I've found my soul mate," O'Dell said. "People tell us when they see us together it's like they can see a halo over us."

The couple wants to exchange vows in a simple religious ceremony. But it is not that

simple. Both are incarcerated in a state prison and both are women. "What is the problem? We're not trying to do anything illegal," says O'Dell's companion, Tammy Steams, 35, of Alliance. "It's not about sex at all. I've found my soul

mate and she's found hers. Larry Wayne, warden at the Nebraska Center for Women in York where O'Dell and Steams are imprisoned, has denied their request to hold a "handfasting" ceremony in

the prison chanel. Wayne, backed by legal counsel for the state Department of Correctional Services, said such a ceremony would violate Nebraska's ban on same-sex marriages.

Court Says Lesbian Adoption Can Be Considered Ledyard, CN-AP- The state Adoption Review Board can consider a Lesbian's peti-

tion to adopt the 5-year-old son of her partner, a Superior Court referee has ruled. The ruling overturns a Probate Court decision, which denied the petition on the

grounds that current law did not allow for it. The adoption is in the best interest of the child, Superior Court Referee Hadley W.

Austin ruled this week.

Austin ordered the Probate Court to send the adoption petition to the state Adoption Review Board, which will consider a waiver of the statutory parental requirements.

Book for Gay Teens to Stay in Library

Brownsville, PA-AP- Despite a parent's objections, a high school library book that advises teens about homosexuality is back on the shelf it occupied for seven years.

A committee of educators and parents at Brownsville Area High School said it will keep in circulation the 56-page book, Understanding Sexual Identity; A Book for Gay Teens and Their Friends.

After listening to students, parents and the American Civil Liberties Union, the committee allowed the book to remain in general circulation.

But parents can notify the librarian if they do not want their child to read it, school

Superintendent Dexston Reed said.

The committee reviewed the book after a parent, Gina Wellington, asked in May that

it be removed. Among passages that she and other parents found objectionable are descriptions of how to use a condom and a vignette describing a fictional 7-year-old boy's fascination

Wellington did not return phone calls to her home, but Reed said he thought she was 'satisfied."

New Insurance Company First to Aid Gay Couples

Honolulu, HI-AP- If Dr. Robert Jenkins just mentioned the words Gay and Lesbian, doors slammed shut. Few would take his pink business card. Few would return his phone calls. Claims of non-discrimination were not reality, he said.

As head of the first insurance agency to help same-sex couples obtain benefits under Hawaii's new reciprocal benefits law, he's seen discrimination firsthand.

With a colorful rainbow as its logo, Hawaii-based Pride Insurance & Financial Services Inc. opened for business this summer, just as the new law, the nation's first, came into effect, giving couples who can't legally marry a taste of the married life.

A major provision grants insurance benefits to same-gender couples.

All summer, Jenkins and his nine employees have been on the hunt for companies that will help Gays and Lesbians who want to sign up for joint life, health and home-

owners' insurance. So far, they've found 16 in the entire nation. The number is small, but it's enough of a

start, Jenkins said. About two clients a day come in to inquire about insurance or how to sign up as

beneficiaries under the new law, he said.

The law grants any adult couple who can't legally marry, Gays and Lesbians, parent and adult child, siblings and roommates, about 45 of the 400 legal benefits of marriage.

Pride Insurance also helps same-sex couples in other states and countries apply to be-

come reciprocal beneficiaries under the Hawaii law, which has no residency require-

First Open Gay in Texas History Elected

Dallas, TX- With the strong backing of Log Cabin Republicans (LCR), John Loza (R) became the first openly Gay Republican to win public office in Texas history by capturing a seat on the Dallas city council. Loza, a member of LCR Dallas, defeated his heterosexual Democratic opponent, who had the backing of the city's Democratic establishment including the Gay/Lesbian Political Coalition of Dallas. Representing a heavily Democratic area that includes a large bloc of Gay voters, Loza is the only

openly Gay person now serving on the Dallas city council.

"I am very, very grateful for the support of the Log Cabin Republicans in this race,"

Loza said. "They did a lot of good work for me. And Log Cabin stepped up to the

James Campbell, president of LCR Dallas, reported that Log Cabin was very active in support of Loza during the campaign. The group formally endorsed Loza after he addressed a club meeting.

Loza's historic election was another example of the growing momentum of success for the Gay Republican movement in Texas.

This victory is Exhibit A in our argument to the GOP that a Gay or Gayfriendly Republican can win in a heavily Democratic area," said Dale Carpenter, president of LCR Texas. "This is an historic win that has the potential to transform the political landscape in Dallas and across Texas.

Pro-Gay Initiative To Be On Ballot

Olympia, WA-AP- It's supposed to be an off-year for elections, but the November

ballot just got a little more crowded.

Secretary of State Ralph Munro announced Tuesday that initiatives dealing with marijuana and Gay civil rights contained enough valid signatures from voters to be placed on the Nov. 4 ballot, joining six other measures previously certified.

Initiative 677 would bar employment discrimination against Gays and Lesbians.

That proposal would give standing in court to sue for damages to people who believed they had been discriminated against, based on sexual orientation or perceived sexual orientation. In conformance with existing laws barring other forms of job discrimination or perceived sexual orientation or perceived sexual orientation. crimination, the measure would exempt workplaces with eight or fewer employees.

Tacoma lawyer Laurie Jenkins, president of Hands Off Washington, has estimated the campaign will cost at least \$1 million.

Gay Youth Suicide Stats Challenged

New York, NY-The Gay and Lesbian Alliance Against Defamation (GLAAD), reports that a recent widely reprinted Newhouse News Service article by Delia M. Rios dismisses the off-repeated statistics that Lesbian and Gay adolescents are 2-3 times more likely to commit suicide than their heterosexual peers, and that 30 percent of teen suicides are by Gay and Lesbian youth. "There is no scientifically valid evidence that it's true," Rios states, citing a 1994 report by representatives from the Centers for Disease Control, the National Institute of Mental Health (NIMH), the American Psychological Association the American Association of Suicidology and several Gay and logical Association, the American Association of Suicidology and several Gay and Lesbian health groups.

The statistics in question, which appeared originally in a 1989 U.S. Department of Health and Human Services (DHHS) report on youth suicide, has "propelled into public consciousness....a link between Gay teens and suicide," she writes, adding that the figure 'has shaped public perceptions of Gay teens as emotionally vulnerable and as victims of an oppressive larger culture who require society's intervention.... it has become conventional wisdom with the power to influence public policy." Rios cites Peter Mucher, chief of the Youth Mental Health program of NIMH, who asserts that "no scientific anidmos" approved the DILLIS country.

tific evidence" supports the DHHS report's figures.

While challenging statistics is a valid and important aspect of journalism, Rios fails to mention any of the more recent studies which have indicated that Lesbian, Gay, Bisexual and Transgender youth are at a higher risk to attempt suicide than heterosexual

teens.

#### Activists Seek Protection for LBGTs

Iowa City, IA-AP- Iowa City activists say they'll renew their push to change state law to prohibit discrimination based on sexual orientation. In December, leaders of the Iowa City Human Rights Commission asked the state

Civil Rights Commission to make a proposal to the Legislature to add sexual orienta-tion to the list of categories already protected under Iowa's nondiscrimination law.

The state currently prohibits discrimination based on age, race, creed, color, sex, na-

tional origin, religion or disability. At the December meeting, the state commission voted to meet with activists this fall

to fully discuss the issue and then decide whether to ask the Legislature make the Iowa City Human Rights Coordinator Heather Shank said she and other local activists

will make another presentation to the state board on June 27 and ask commissioners to follow through with their pledge for a meeting this fall.

Ames and Iowa City are the only communities in Iowa that include sexual orientation in local nondiscrimination ordinances. Iowa City added the category in 1977, Ames in

Rep. Frank To Introduce Anti-Hypocrisy Bill

Washington, DC-AP- Rep. Barney Frank (D-MA) said Monday, June 16, that he intends to introduce a bill in Congress decriminalizing sex among consenting members of the military

"I do not think that adult members of the military ought to be criminally penalized for sexual activity of a private, consenting nature," said Frank. "That doesn't mean all of it would be morally approvable," he said. "It does mean that criminal prosecution is a wholly inappropriate way of dealing with these kind of consenting acts.

Frank's bill, called the Anti-Hypocrisy Act, would end criminal prosecution for consensual sex. Fraternization or sexual misconduct that undermines agood order and discipline," however, would still be subject to disciplinary action.

Frank said the bill would help Gay members of the military. It would repeal sections of the Uniform Code of Military Justice "which specifically criminalize private, consenting sex described as sodomy, which can be both heterosexual or homosexual," he

Frank said the bill was inspired by the cases of 1st Lt. Kelly Flinn, who resigned rather than face court-martial for adultery, disobeying an order and lying to her commander, and of Air Force Gen. Joseph Ralston, who withdrew from consideration as chairman of the Joint Chiefs of Staff because of an extramarital affair a decade ago.

#### After First Seven Months, Wisconsin's Only **HIV Dental Clinic Exceeds Expectations**

Milwaukee—In its first seven months of operation, 250 clients have received dental care at the Milwaukee AIDS Project's HIV dental clinic through more than 600 encounters, 329 of which have had no insurance or needed financial assistance.

On January 6, 1997, the Milwaukee AIDS Project opened the states first-ever HIV dental clinic and the success has been overwhelming. With the dental clinic's patient load growing, the hours have expanded from 18 hours a week to 39 hours a week.

"We will not turn anyone with HIV or AIDS away," said Neil Albrecht, deputy director of programs for the Milwankee AIDS Project. "For those who don't have private health insurance or don't qualify for Medicaid, we are making the commitment that we will pay for people who might be considered indigent or very low income. Our ability to do that is because of the very extensive fund raising that we do throughout the year with individuals and through events such as AIDS Walk Wisconsin.

The dental clinic is a collaboration between the Milwaukee AIDS Project and Rainbow Community Health Centers. It

was largely furnished with about \$50,000 worth of equipment donated by Milwaukee County and Froedtert Memorial Lutheran Hospital in the aftermath of the closing of Doyne Hospital and the Doyne dental clinic last year, which had a large HIV positive clientele.

The need for an HIV dental clinic was evident when nearly 450 individuals with HIV and AIDS were unable to receive quality care after the closing of Doyne Dental Clinic. The Milwaukee AIDS Project's HIV dental clinic gives individuals access to dental services like prevenand access to dental services like preventative, restorative and cleaning, not just emergency care. Helping meet the demand, Steve Debbink, DDS, employee of Rainbow Community Health Centers, provides dental services to HIV positive adults as lead dentist at the Milwaukee AIDS Project's HIV dental clinic

AIDS Project's HIV dental clinic. Currently, the HIV dental clinic is open Monday 9:00 a.m. to 7:00 p.m., Tuesday 9:00 a.m. to 5:00 p.m., Wednesday 8:30 a.m. to 6:00 p.m. and Thursday 8:30 a.m. to 6:00 p.m. For more information or to schedule an appointment with the dental clinic, call 414-225-1571.



The cartoon features humorous incidents that happened to Dunne and his


friends and family, as told by a child.

#### In Memoriam **Kevin Rotar**

"He was a lovely, lovely man, very open. I've known him for over 20 years. It's a stunning loss. I feel deeply." Ron German's voice shook as he recalled his long friendship with Kevin Rotar. In the end, he cried softly, a prayer of tears.

Kevin was boating with friends on Lake Michigan on Saturday, August 9, 1997. About 4:00 p.m. the wind blew his hat off. Reports say he reached for it and fell into the water. Though the body has not yet been found, he is presumed drowned.

As of press time, the St. Francis police say that the search continues in which they are being aided by the Milwaukee police. The lake, however, is stormy and is

hampering the search.

Those are the bare facts of the passing of a man whose absence will leave a stark void in our community. For one thing, he was a bartender at The Triangle, the YP, the Wreck Room and, finally, at Club 219. He was more than a bartender. He was a professional. Some bartenders put your order in front of you, take your money

and go, leaving the customers to their own devices. Kevin did not do that. He was a gentleman professional, caring about his customers, treating each one with dignity and a genuinely felt concern. Kevin always had time for a friendly word, no matter how busy the bar was. We can say that from experience. We will not soon forget his shy, quiet smile and the twinkle in his eye. Neither will we forget his laughter, low, rumbling, yet soft in his throat, a laugh that drew you to him and, like a blanket, enfolded you in its warmth.

"He was a sweetheart," said Rick Formankiewicz. "He got along with everyone."

Rick, who works at the Ballgame, said he'd known Kevin for over 20 years.

None of us can know the circumstances into which we will be born. Neither do we know how we will meet our separate ends. All we do know is that every one of is a light, tiny, fragile, flickering here for awhile and then is gone. Though the lights disappear from our view, they do not go out. They join the millions that glow in the beyond and await the rest of us coming along behind.

This is how we should remember Kevin. Not for how he met his end, but for the light shown on us while he was here. Nor should we forget that his flame still

shines. It awaits us.

Wisconsin Light joins Kevin's partner, his family and many friends in remembering him with respect and with love.

While most of us know about the American Revolution, to many, at this distance, it has the appearance of a foregone conclusion—something that had to happen in the right course of things.

No way. As I used to tell my students, the Pilgrims didn't hop off the May-flower, look at their watches and shout with one voice, "Hurry up, we gotta get Plymouth built! It's only about 150 years to the American Bouchtien!" to the American Revolution!"

Nor were the Founders all that sure of themselves. From 1763 onward, as much as their own wills, events drove them on. You have to remember that aside from Sam Adams and a few of his kind, these were a very conservative bunch. They took their allegiance to the Crown very seriously indeed. The mantle of treason didn't sit well on their shoulders.

So, when the issue of independence came up, many of them shrank at the thought. After all, it was in the history of things that colonies went from being the possession of one country to that of another. Colonies didn't proceed to assume independent status.

Yet, independence took place. Whether it happened before or after the Declaration is a matter of debate, but it happened, a

truly revolutionary step.

What was even more revolutionary, however, was the ideals proclaimed in the Declaration and various other documents in which the work of the Revolution is enshrined. Prime among these was the proposition that everyone was equal before the law.

The concept of human equality, arising out of the Enlightenment, was explosive, hitting the highly structured 18th century society of deference like a bomb. The effects are still being felt.

Look at it! You may be richer than I am. You may be more intelligent, but before the law, we are equal. The laws that apply to you, apply to me and vice versa.

There's no exceptions.

There's no "some are more equal than others." There's no, "Everyone's equal, but there is a critically thinking elite. There's no exceptions. Everyone's equal. The laws apply to all.

Equality is such an obvious ideal and should have been so easy to accomplish. It has not proven to be so. Look at the barri-

ers that had to be swept away.

For example, the idea that one could hold property in another person (slavery), had to go. So did a lot of other irrationalities that made some people unequal to others: women's subordination to men; ethnic prejudices of all kinds. The list goes on. The task is not completed yet,

The ideal, as I see it, works this way. If you, as a law-abiding citizen, have rights under the law, I, having the same status must have them too, by virtue of my humanity. You cannot exclude me, not for any reason except due process of law. You may not like me because of the color of my skin, my sexual orientation, my ethnic background, or something else, but

you cannot exclude me.

You—as a male—may think I, as a woman, am inferior to you, but you cannot exclude me from equal rights. You cannot exclude me and remain faithful to what America is all about; remain faithful to one of the great ideals that has made this country what it is.

Your interpretation of religion may tell you I shouldn't be equal to you and have the civil rights you enjoy. You may believe that that's sufficient reason to deprive me of my equality, my civil rights, my dignity as a human being and an American citizen. It is not.

In the issue of marriage, what I see is that differing sex couples have legal rights that same-sex couples do not have-hundreds of legal rights, in fact. Same-sex couples are, therefore, unequal, denied the fullness of their just dignity as human beings in a country where equality is one of the founding ideals. This is wrong. It cannot be allowed to continue.

are politicians-Alderpeople, state legislators, members of Congress, who, very obviously, do not understand the concept of human equality. To my way of thinking, they are a blot of the escutcheon of America. They do not deserve to hold office since they are not willing to uphold what America means.

Once upon a time there was a woman who was fed up with being treated as a second class citizen in this country. Besides, she'd been shopping and her feet hurt. She took the first seat on the bus she could find. Her name was Rosa Parks.

Her act gave rise to a glorious page in our country's history. Led by Dr. Martin Luther King, Jr., African-Americans rose up, not to defend the idea that they should have equal rights, but to claim them. In language that stirred souls, words rarely heard, King called on America to be true to itself. The call continues.

We who are Lesbian, Gay, Bisexual or Transgendered, must do the same; must claim the rights that are ours by birth. No "go slow." No surreptitious slinking No surreptitious slinking around the dark edges hoping no one will see. No more sitting in the back of the

The rights belong to us. Human dignity belongs to us. Freedom and equality must be ours. We cannot live as second class citizens. We cannot live in bondage to prejudice. We cannot live as other than we are, free and equal citizens of a great republic, one born in the light of a most radiant ideal. We can require nothing more and nothing less.

Homophobia must be made odious. Our country's ideals demand nothing less.

We have been informed that a Transsexual woman was refused entry to a bathroom appropriate to her gender during Pridefest '97. As we understand it, she was refused entry to the women's bathrooms and when told to use the men's bathrooms was refused entry there

Pridefest is the last place we should expect gender police patrolling the imaginary bounda-ries created by society's obsession with bipolar gender categories. I thought your readers might like to know that PFLAG-Milwaukee has been involved for more than two years with the Milwaukee Public Schools Task Force on GLBT issues to Create a Safe Climate in Schools for Students and Staff. On March 4, 1997, all MPS principals-elementary, middle and high schoolreceived a resource notebook followed in April by a letter from PFLAG-Milwaukee offering a variety of opportunities (inservices, videos, panels, books, etc.), to help as needed in each

Some schools have already begun at act. On September 26th, a "Safe Climate" presentation will be made to MPS Guidance Counselors, Social Workers and Psychologists. In addition, PFLAG materials and similar offers regarding creating a "Safe Climate" have been sent to the principals of 40 suburban high schools, with follow-up to occur in the fall.

PFLAG-Milwaukee joins The Wisconsin Light in publicly acknowledging its contribution to the community and to thank the Cream City Foundation for awarding us a grant this year so that we can carry out our educational projects.

Our PFLAG brochures are excellent (but expensive) and the grant is making it possible for us to gradually expand our outreach. It is through education that we will find safety and equality.

#### Medical College's Holtgrave to Head CDC's HIV/AIDS **Prevention Division**

Milwaukee—David R. Ph.D., a faculty member at the Medical College of Wisconsin, has been named the new Director of the Division of HIV/AIDS Prevention-Intervention Research and Support at the Centers for Disease Control and Prevention (CDC).

In his new position, Holtgrave will supervise the division responsible for funding for most CDC-sponsored HIV prevention programs in the U.S. In addition, he will oversee the evaluation of HIV

prevention programs and ensure that community services receive appropriate technical assistance.

Holtgrave has spent the past two years as an associate professor of psychiatry and behavioral medicine at the Medical Col-lege's Center for AIDS Intervention Research (CAIR). He specializes in evaluating the cost-effectiveness of HIV/AIDS prevention programs.


"Dr. Holtgrave has a proven record of excellence in HIV prevention research, especially the economic evaluation of prevention programs. His expertise lends itself perfectly to his new position at the CDC, said Jeffrey A. Kelly, Ph.D., director of CAIR and a professor of psychiatry and behavioral medicine.

Holtgrave believes his experience at CAIR and in Wisconsin has helped pre-pare him for his move to the CDC. "I've had the opportunity to review data on the effectiveness of HIV prevention interven-tions, focusing on effective interventions developed at CAIR and gaining perspective on interventions nationwide. In addition, my involvement with the Wisconsin HIV Prevention Community Planning Council gave me insight into the practical issues that planning agencies face when developing prevention strategies," Holtgrave said.

Since 1996, Holtgrave has been a member of the planning group, which provides the state with community input about distribution of federal HIV prevention funds.

Holtgrave, along with Kelly, was awarded the C. Everett Koop National Health Award in 1996. In addition, Holtgrave received a U.S. Public Health Service Special Recognition Award in 1995. He has written and co-authored more than 70 journal articles and other publications. publications.

Prior to joining the faculty of the Medical College, Holtgrave worked at the CDC from 1993 to 1995 as the acting assistant director for behavioral science. He earned his Ph.D. from the University of Illinois at Urbana/Champaign with a major in quantitative psychology.



I hear of new drug combinations and positive results. I have a false sense of optimism about a disease being licked by modern science. That just is not true,

AIDS is still a pandemic afflicting 16,000 people in Wisconsin. One out of every 250 people in the US is infected with HIV. AIDS is the leading cause of death among Americans aged 25-44.

My time talents and finds are needed.

My time, talents, and funds are needed to make the lives easier for people who are infected with HIV and AIDS. 18 agencies benefit from this one day fund raiser. In a lot of agencies this gives them the largest part of their budgets.

The AIDS Resource Center of Wisconsin provides many services with the money raised from the Walk: over 13,000 men, women, and children with HIV received case management and support services in the last year. 5,612.5 bags of food were prepared and deliveries were made to 592 consumers from January to May of 1997. #### True Extent of AIDS Pandemic Begins to Be Recognized in China

Linxia, China-Coral from Taiwan, rugs from Xinjiang, knives from Inner Mongolia, the trade goods of centuries, line the tidy, brimming shops in Linxia's

Behind the far-flung traffic in exotic wares that long kept this Muslim trading town in western China prosperous now slinks a more modern commodity, heroin, and with it, AIDS.

On the back of a flourishing drug trade, AIDS has crept up an ancient caravan route linking China's Southeast Asian border to its remote frontier with Central Asia. Along the way, the virus has hit tens of thousands of China's most vulnerable, disaffected people: poor minorities on the fringes of Chinese-dominated society.

The epidemic is a silent one, officially. Its scope and the identity of its victims have shocked Chinese health policy makers and confounded communist leaders nervous about ethnic rebellion.

Little has been said in the state-run me-

Little has been said in the state-run media about the outbreak. Western AIDS experts working with the government fear little is being done, even though Chinese officials had time to prepare.

"Government leaders think it's not a thing to be proud of, people having that kind of habit or behavior are bad. Good people don't get this," said Zhang Konglai, a professor of epidemiology at Beijing Union Medical College and an AIDS education campaigner.

cation campaigner.

AIDS incubated on China's border with Burma for five years starting in 1990. The confined epidemic ravaged hill tribes in four counties in Yunnan province as members turned to the heroin pouring across the border and, out of poverty and ignorance shared needles. ignorance, shared needles.

In 1995, the virus went north with the drugs. Within a year, HIV began tearing through heroin users in Xinjiang, China's northwesternmost region 1,500 miles north of Burma.

"It's an epidemic," said Zheng Xiwen, the Chinese Academy of Preventive Medicine professor who runs the government's AIDS monitoring program.

No one in Xinjiang tested positive for HIV in 1995. By the end of last year, nearly one in four drug addicts out of a sample of 400 did, Zheng said.

He refused to estimate how many people in Xinjiang may be infected. But a Western specialist familiar with the testing data said they may number as many as 50,000. said they may number as many as 50,000, a third of all addicts in Xinjiang and the largest number in the country. Many are Uighurs, a Muslim minority grown restive under Chinese rule.

The source of the virus is not in doubt. Zheng said the strain of the virus, known as HIV-C, matches that found along the Burma border and is distinct from varieties detected in Xinjiang's Central Asian neighbors

An AIDS epidemic also has struck the Yi, another desperately poor minority living in hilly Sichuan province, according to a U.N. agency report, a draft of which was obtained by The Associated Press.

The Yi straddle the trade route that for centuries brought tea and gems up from Yunnan and Southeast Asia and horses and knives down from north China and Central Asia.

That route goes through Linxia, a legendary commercial hub in a fertile valley in Gansu province 500 miles north of the Yi and 750 miles west of Beijing. It now is a notorious drug trafficking center that AIDS experts fear will be the virus' next target.

Linxia is one of China's heroin hot spots," said Ma Weimin, a grain trader working out of one of Linxia's bustling markets. "It's in all the villages. It's everywhere."

Linxia's dominant Muslim community, from the Hui minority, is as famous for skill in trade as for the Islamic ferment that earned the town the nickname "Little

Dozens of mosques, some with the curved roofs of Chinese temples, others with the onion domes of Arabia and many newly built make the low skyline stand out against brown, arid hills. All attest to the wealth trade has brought Linxia.

Shops along the clean main bazaar burst with trade trinkets: coral beads from Taiwan, incense from India, turquoise from East China, carpets from Pakistan and fox furs from Tibetan lands. Saddles, swords and holsters give off a frontier atmosphere.

Everyone is involved in trade, according to merchants, truck drivers, restaurant owners and retired officials. Everyone knows the drugs come from Yunnan, although no one interviewed admitted to being involved. No one has heard about AIDS.

"Outsiders, people from Linxia too, are all bringing it in because they can make money," said one resident who identified himself only as "Ma," the most common Hui surname.

Migrants from Xinjiang living in Linxia were cagey about their knowledge of the drug trafficking. When pressed, one said they trade everything; they have to to make a living.

"The illegal trade follows the legal trade," said Dru Gladney, an expert on China's Muslim communities at the University of Hawaii. "It's all kinds of trade, not just drugs."

Police plastered Linxia with notices of a drug crackdown in March, part of a nationwide crusade. New posters were put up in mid-June warning drug offenders of stiffer penalties and that family members and businesses could be considered accomplices

"Police have set up checkpoints around Linxia," said one driver, also surnamed Ma. "No matter how many people they catch, there's no end."

Linxia has so far avoided an AIDS epidemic, because heroin is so cheap that users smoke rather than inject it. But if the police succeed in making supplies scarce, addicts will turn to needles, said Zhang Konglai, the Beijing Union epidemiolo-

China's AIDS epidemic so far fits the pattern of the outbreak in Thailand, said Emile Fox, director of the China office for UNAIDS, the U.N. agency coordinating AIDS eradication.

AIDS first struck Thailand's drug users and then spread to prostitutes, their clients, women and finally babies, Fox said.

Thailand has an estimated 750,000 HIV

cases. Officially, China has 5,157 people infected with HIV, 133 with full-blown AIDS, but officials guess HIV infections may be nearer to 100,000. Fox believes the real figure may be three times higher. Fox and other experts suspect a growing sex trade, not needle sharing, will cause China's worst and most widespread eni-

China's worst and most widespread epidemic, although testing has so far failed to confirm their fears.

Even though China's first AIDS case was discovered 12 years ago, the government is still reluctant to discuss its AIDS problems in detail publicly.

Ministry of Health officials refused to discuss the epidemic in Xinjiang. Likewise the Xinjiang government could not

wise the Xinjiang government could not provide specifics on the epidemic and ef-forts to fight it. Officials with Xinjiang's government and its state-run television said, on condition of anonymity, that al-


most nothing has been reported.

An outbreak among the Uighurs is an especially frightening and sensitive prospect for Chinese leaders.

The Uighurs, one of many Turkicspeaking, Muslim groups that are a ma-jority in Xinjiang, have never fully submitted to Chinese rule. They are also highly mobile, with large communities in Beijing, Shanghai, Guangzhou and other major cities.

In the absence of information about the epidemic, rumors have spread of government plots and fanned concerns about domination by the Han Chinese. Uighurs fear that Han Chinese, migrating in large numbers, are taking the best jobs and that strict government :q:: control is wrecking the practice of Islam. As a result, they feel marginal.

They have become a natural population to be involved in that (the drug trade)," said Gladney, the expert on Chinese Muslims. 'Chinese officials ... are creating an underclass that's not participating in the system."

#### AIDS Grows in Thai Sex Industry; Number of Deaths Continues to Climb

Lopburi, Thailand-These are the last minutes of Supan Banyam's life. Covered with flies and agony, she cries: "I'm already dead."

Her body, ravaged by full-blown AIDS, is motionless. Her lungs cease to function. Her skeletal fingers, tightly clasped in the healthy hand of a Peace Corps volunteer, go limp. With seeming indifference, she is pronounced dead. Lids are lowered on

These are her last rites: No one speaks. Lunch is served to other patients who will surely die soon, while Supan's orifices are packed with cotton to prevent seepage of

contaminated blood.

Just before her body is shoved into a crematory, a Buddhist monk ceremoniously pours water over her hand, where deep pink orchids rest between bony fin-

Our Buddha teaches us that we must live together with kindness and mercy, says Phra Alongkot Tikhapanyo, the monk who runs the AIDS hospice on the grounds of a Buddhist temple outside Lopburi, a city 75 miles north of Bang-

With an accepting attitude towards male promiscuity and as many as 2 million prostitutes, Thailand's huge commercial sex industry is creating a population of walking dead. It is estimated that more than 750,000 Thais are infected with the AIDS virus.

The hospice is where those in the final, ghastly stages of AIDS come to die with

Simple fiberboard coffins are stacked closely by the temple's main hall. In the first five months of 1997, 133 men and 22 women died here.

Phra Alongkot founded the hospice at Phra Baat Nam Phru temple in 1992 with

three patients.

It wasn't an easy beginning. Within the first two weeks the other eight monks at the temple left, fearing they too would be-come sick with AIDS. He was criticized by local residents.

Fear and ignorance of AIDS is why even today in Thailand most people infected with the virus are shunned by family, friends and society as a whole, says

Brooke Alison Shippee, a Peace Corps volunteer from Marlborough, Massachu-

About 135 patients live at the temple. A thousand more visit for outpatient care.

The main building, housing 40 people with full-blown AIDS, is surrounded by Thai-style bungalows where less critically ill patients stay. One full-time nurse and several volunteers tend to the patients.

Seven Buddhist monks attend to spiritual needs and perform last rites. Most of the monks are infected with the AIDS virus themselves, some who scandalously engaged in sex as monks and some who

became monks after getting infected.

The high-priced medicinal cocktails that extend the lives and lessen the symptoms of AIDS sufferers in wealthy nations aren't available at the hospice. Some solace comes from traditional medicines and hot herbal massages to ease the pain.

But when a patient comes to Phra Baat Nam Phru temple, it is usually too late anyway. It is a place for the dying.

There is prayer, meditation and the com-

fort of a sanctuary where for a brief time they are blessed with kindness and relative

Then they die, and others arrive to take

their place.



#### Nine Wisconsinites Attend Log Cabin **National Convention in Washington**

By James L. McFarland

Milwaukee-We have just returned from the annual Log Cabin Republicans (LCR) national convention, held this year in Washington, D.C. It was the largest meeting of Gay Republicans ever held. Over 300 Republican Lesbians and Gays were in attendance, and Log Cabin Republicans of Wisconsin was well represented with nine members attending.

We were treated to a number of nation-

ally known and respected speakers, in-cluding Gay author Michelangelo Signorile, former Wisconsinite and Gay acgnorite, former wisconsinte and Gay activist Jamie Nabozny, Senator Alfonse D'Amato (R-NY), and Rep. Jim Kolbe (R-AZ), the only openly Gay Republican member of Congress.

The activities began with a briefing on Control, Will held the marring after the

Capitol Hill held the morning after the House GOP's closed-door meeting focusing on the failed attempt to oust cusing on the failed attempt to oust Speaker Gingrich. We were privileged to hear all about the meeting before much reached the press from the following members of Congress: Rep. Sherwood Boehlert (R-NY), Rep. Chris Shays (R-CT), Rep. Brian Bilbray (R-CA), Rep. Connie Morella (R-MD), Rep. Rick Lazio (R-NY), Rep. Tom Campbell (R-CA), Rep. Sue Kelly (R-NY), Rep. Jim Greenwood (R-PA), and Rep. Jon Fox (R-PA).

They also discussed the budget deal, AIDS funding, the Employment Non-Discrimination Act, and FDA reform.

At the banquet that evening, Senator Alfonse D'Amato (R-NY) received the Spirit of Lincoln Award for his leadership on equal rights and AIDS funding, and gave an emotional speech about the discrimination that his Italian-American family faced a generation ago. He spoke of his uncle, who anglicized his name to find employment and his father who kent find employment, and his father who kept his name and suffered discrimination.

Drawing a parallel to Lesbians and Gays who face the choice between the closet and coming out, he reiterated his support for allowing Lesbians and Gays to serve openly in the military and for the Employment Non-Discrimination Act, of which he is an original cosponsor.

Senator D'Amato represents something that is still unusual in Washington, D.C. (though not so unusual here in Wisconsin): a conservative, pro-life Republican who opposes discrimination against Lesbians and Gays. Members of Log Cabin Republicans were pleased to raise around \$10,000 for Senator D'Amato's reelection

Noted author Michelangelo Signorile spoke to us during a luncheon about his latest book LIFE OUTSIDE: The Signorile Report on Gay Men: Sex, Drugs, Muscles and the Passages of Life-a critique of the Gay circuit party culture and its consequences for the Gay community, as well as a celebration of those who have formed monogamous re-lationships and have settled down outside the party atmosphere that pervades the community.

In his speech, Signorile warned that the

culture, and work to prevent a surge in HIV infection and drug addiction among the next generation of Gay men.

State Rep. Chuck Carpenter (R-OR), the openly Gay legislator who shut down the Oregon House to force a vote on an employment non-discrimination bill, accepted the LCR Leadership Award at the convention banquet. Carpenter spoke of the long days spent planning and execut-ing his strategy for Oregon ENDA in the state House, and the impact that the experience had on him personally.

Youth activist-and Gay Republican-Jamie Nabozny accepted the Courage of Lincoln Award for his successful fight against the Ashland, Wisconsin public school district which permitted anti-Gay harassment and abuse against him when

he was a student.

In his remarks, Nabozny commented that while touring the country speaking on his fight against intolerance for being Gay, he has faced intolerance from Lesbians and Gays over the fact that he is Re-

The keynote address was given by Congressman Jim Kolbe (R-AZ), the only openly Gay GOP Congressman, who delivered his first speech before a national Gay and Lesbian organization. He spoke movingly of the events leading to his coming out last year, telling the story of a distinguished career in public service as a leader on a wide array of issues faced with the prospect of a simplified label: "the

Gay Congressman'.
"I was simply reasserting myself as the Congressman from Arizona's Fifth District, the acknowledged Republican leader for free trade and open markets, the new advocate of Social Security reform, the proponent of less government, lower taxes and more individual responsibility," Kolbe said. "Oh yes, I happened to be a Gay person too. But being Gay was not-and is not today--my defining persona.'

Kolbe also laid out his vision for the Lesbian/Gay movement for the first time in a public forum. Bringing the crowd to its feet several times, he excoriated both the Gay Left and its control of the movement's direction, and the fundamentalist Christian movement within the Republican Party.

"We must not let the religious funda-mentalists use 'morality' as a cudgel against us," he emphasized.

But he also asked, "Why are [Gay Democrats, who are committed to expanding government control over our lives in housing and education, who would nibble at our freedom through use and abuse of the tax code and regulatory system--why, how, are they presumed to

speak for Gay rights?
"What distortion of the definition of freedom and liberty has given them unfiltered access to the megaphone to trumpet the views of Gays?" Kolbe asked. "Why are the ones committed to ex-

panding government control over our lives in housing and education-why, how, are they presumed to speak for Gay rights?

"We are a minority within the Republi-Gay and Lesbian community must con-front the problems which created this sub-Gays," Kolbe said. "But when we other

The convention ended with the adoption of resolutions calling for the GOP to re-move anti-Gay planks form the party platform and for state legislatures to repeal antiquated sodomy laws. Delegates also voted to commend the GOP leadership on AIDS funding and advancing employment non-discrimination legislation, and called on "non-partisan" national Gay and Les-bian organizations to endorse Senator Alfonse D'Amato and Senator Arlen Specter (R-PA) for re-election in 1998

One resolution on abortion rights, which engendered considerable debate, called on the GOP "to officially take a neutral stance on the issue of choice". Supporters of the resolution made it clear that its pas-sage would not alter LCR's neutral posi-tion on abortion, and that the operations tion on abortion, and that the organization would continue to be equally inclusive of pro-choice and pro-life Lesbians and

This was a fitting statement for an organization which has dedicated itself to "Building the Big Tent" within the Republican Party, and LCR activists came away from the convention re-energized and ready to continue that fight and ready to continue that fight.

#### Same-Sex Marriage Coming Sooner than Many Think, Lawyer Says

Denver-Gays and Lesbians may be able to obtain civil marriage licenses alongside heterosexual couples sooner than many think, said an expert attending the Colorado Bar Association convention.

Some state is going to go first, most likely Hawaii, in issuing same-sex licenses, and some states will respect and honor it, while others won't, starting waves of litigation," said lawyer Evan Wolfson, who successfully argued the first same-sex challenge before the Hawaii Supreme Court.

At a workshop Thursday, August 7, Wolfson said the issue would likely carve the United States into a patchwork in which a couple could get arrested after crossing certain state borders.

That's how it used to work with divorce,

Wolfson said people used to go to Nevada to get divorced, but later learned their divorce was not recognized in their

"But we're going to get to the point where everybody's citizenship and marriage is treated equally," he said.

Wolfson compared the same-sex mar-riage issue to other once-banned unions, including post-divorce remarriage and interracial marriage.

The California Supreme Court was the first to strike down prohibitions on inter-racial marriages in 1928.

"It took another 20 years for interracial marriage to get to the U.S. Supreme Court," Wolfson said.

Wolfson said same-sex couples want the

legal right to marry because of significant benefits, including tax breaks, spousal insurance coverage, child custody rights, even being counted as family when visiting a hospitalized partner.

Since 1995, Colorado lawmakers twice have killed bills to void same-sex marriages sealed in other states. Although there is not an office anywhere in the U.S. that issues marriage licenses to same-sex already laws to ban or nullify such unions.

A move to do the same thing in Wisconsin, passed the Assembly, but stalled in the Senate.

Wolfson and another attorney represent three Hawaii couples denied licenses when they tried to get married.

The couples sued, and in 1993 the state supreme court said the denial violated their constitutional guarantee of equal protection.

The Hawaii Supreme Court sent the case back to state court, saying the state must stop discriminating or show a reason why they should continue to deny same-sex marriage licenses.

At trial, the state lost, and a judge ordered the government to stop discriminating on the basis of sex when issuing marriage licenses.

The case is before the state supreme court again, and Wolfson is filing the same case on behalf of several couples in Vermont.

More than 700 attorneys are attending the Colorado Bar Association Convention, which continues through Saturday.

#### Log Cabin Republicans Praise Rep. Porter's **Leadership in AIDS Funding Fight**

Milwaukee-Log Cabin Republicans crease in funding. applauds Rep. John Porter (R-IL) for the Praising the sub White CARE Act's AIDS Drug Assistance Program.

"Chairman Porter has shown true humanitarian leadership where the Clinton Administration has only offered lofty rhetoric," observed Richard Tafel, executive director of Log Cabin Republicans (LCR).

Despite this crisis, the Clinton Admini-stration shocked the AIDS community by offering no increase for the AIDS Drug Assistance Program. It was incumbent upon Log Cabin Republicans to work with the Republican Labor/HHS appropriations subcommittee to secure the necessary in-

Praising the subcommittee's action, Jim \$132 million increase he has steered Driscoll, national AIDS policy advisor to through his subcommittee for the Ryan the Log Cabin AIDS Policy Institute, observed: "Many politicians would have used the Clinton Administration's lack of leadership on AIDS as an excuse not to increase the Ryan White CARE Act's funding. In what many have dubbed a "do-nothing" Congress, Chairman Porter has really done something important that will literally save lives.'

Tafel, Log Cabin's executive director, agreed: "Who would have believed a few years ago that Republicans would be teaching Democrats a lesson about compassion for people with AIDS. The only thing worse than the Clinton Administration's lack of leadership on this issue is the lack of criticism against the White House from AIDS and Gay organizations who have so visibly supported this Presi-

dent. Log Cabin Republicans was the only Lesbian/Gay organization to testify this year before the House Labor/HHS appropriations subcommittee in support of ap-

propriate AIDS funding. LCR has been lobbying Republicans in Congress to ensure proper access to the new breakthrough therapies for all Americans, which is the organization's number one AIDS funding priority.

The Madison media does or should know that Tammy Baldwin's sexual orientation has nothing to do with her quali-

entation has nothing to do with her quan-fications to be in Congress. But men-tioning it stirs things up so the papers go ahead and pander to the bigots. I would agree with those who say that more work should have been done in ad-vance of introducing a Domestic Partner-ship ordinance in Milwaukee, But I won't fall into the trap of blaming the victims of fall into the trap of blaming the victims of oppression for failing to properly address the situation.

The fact is that Witkowiak and others on the Common Council should support,
Domestic Partnership benefits out of a
moral certainty that it is the right thing to do, regardless of anything else that may have or may not have been done.

All the smokescreens they can come up won't change the basic fact that they are unwilling to treat us equally.

So they will cast their votes against fairness. They will deny their bigotry and moan about being called homophobes, but the reality is that it is a title they richly deserve because they brought it on them-

You may wonder what all of this has to

do with you. In Green Bay an AIDS activist was found dead in a hotel room. A couple of weeks later man putting up AIDS Walk posters was attacked. In Marshal Wisconsin, a Gay café owner was killed. In a Madison Gay bar, two men who were trying to convince patrons to come to an after hours party were overheard privately talking about the beatings that would administered to those who accepted the invite.

You never can tell for certain when you may be the victim of one of these acts of physical homophobia. It is the little acts, the moderate doses that make the extremes seem to be acceptable to the warped minds that foist them upon us.

handful of us, a preciously small handful, speak out and up against the insidious hate, but more help is needed.

We can start by calling on the members of the Milwaukee Common Council to ensure fairness but that won't be enough.

Yes we need more the letters to the

editors of various papers around the state. But even more than that action is needed at the dinner table, at family gatherings and in the workplace. We need to make our case, we need to speak to America one person at a time.

Edmund Burke was right.

#### As Many as Five Serial Killers Stalking Gay Men Believed Still At Large

San Francisco-Andrew Cunanan's suicide halted one of the nation's most lurid cases of serial murder. But from New Jersey to Virginia to Texas, the slayings of as many as 30 Gay men or transvestites, which activists believe are the work of five serial killers, remain unsolved.

In some cases, investigators have been hindered by lack of resources and, some allege, lack of interest.

"What's the difference between my son and Versace? Money and notoriety. If you've got money and fame, it's going to get solved," says Donna Smith, whose 18year-old son's strangled body was found 10 years ago in Chesapeake, Virginia. Smith, who now lives in Cocoa, Flor-

ida, does not believe her son, Charles, was Gay, although he frequented the Gay scene, as did most of the 11 victims who

followed him in death.

She watched the Cunanan chase in south Florida with fascination and with anger that the Virginia serial killer has not been sought with the same fervor as the man suspected in the murders of fashion designer Gianni Versace and four other men.

All the victims were seen as expendable," Smith says of the murders linked to her son's slaying. "They labeled them as Gays and druggies, so nobody cared." Activists who track violent crimes against Gay men and Lesbians acknowl-

edge some police departments, even the FBI, are beginning to reach out to the Gay community to build trust and understand-

#### The Cunanan **Tragedy May Teach** Us to Come Together

As with every tragic situation of such magnitude, the Andrew Cunanan murder spree and his subsequent suicide under pressure from the "better late than never" manhunt, raises many more questions than it answers. The bizarre transformation of one human being, (who went from a popular, well-liked figure in San Diego's Gay community—to a murderer of Gay people), coupled with the violent deaths of five other human beings, leaves many of us wondering about how this could have happened. Why would Cunanan do such a thing?

The Gay community was traumatized and fearful in the midst of the manhunt. Many of us in West Hollywood were looking over our shoulders before we opened our front doors. The Gay communities of Miami and San Diego were even more alert. There was a great deal of anger about the insufficient attention paid to the Cumanan case before the Versaci murder by law enforcement authorities. America got to see first hand how the priorities of law enforcement can be im-

paired by homophobia.

While the media sensationalized the story, one unreported by-product of the tragedy was that for a brief moment, Gay and straight communities came together. Unified public pressure was brought to bare to catch Cunanan, and the (unfortunately) normal rift between Gay and straight was briefly overcome.

The non-sensational question raised by this tragic situation is whether it opens up an opportunity to build more understanding between Gay and straight America? Are violence and tragedy the only circumstances that will bring people together these days? As a Gay political leader who works everyday to build bridges between Gay and straight America, I consistently ask myself and others what needs to hap-pen in this country to close the gap. Is there opportunity for greater growth and understanding between Gay and straight America? What would it entail?

Ironically, the Cunanan tragedy may have shown us a bit of the way. The Gay community-which has shaped its politic by emphasizing its differences with straight America, (and ended isolated as a result)—found itself emphasizing its commonality with the rest of America, and we became closer for it. Perhaps there is a lesson here for all Americans to learn.

Other activists, however, remain frus-trated and say it still takes pushing to get many officers to take seriously any crimes involving Gay victims, even homicides.

Gay-related cases aren't popular cases. And whether it's ignorance or homopho-bia, it's a big problem," asserts Bea Hanson, director of client services for the Anti-Violence Project in New York.

The possible serial killings include the 1994 stabbing deaths of three Gay men in Irving, Texas; the shooting deaths, from 1987 to 1992, of six Atlanta men dressed in women's clothing; and the 1992 stabbing deaths of four men who were last seen in Denver Gay bars, according to Anti-Violence Project statistics and newspaper accounts.

Hanson has also helped police link at least three murders in the New York metropolitan area, although she thinks as many as five may have been killed from

1991 through 1994

Four of the victims were last seen in Manhattan Gay bars. Their bodies, hacked to pieces, were dumped in New Jersey, Connecticut, Pennsylvania and Rockland County, just north of New York City. The killer stuffed one man's body into a trash barrel and left his hands and head in plain sight on top of the lid.

To date, police have no suspects. But investigators reject the suggestion they treat murders of Gay people differently.

"That would be a real cheap shot," says Detective Sgt. Glenn Miller of the New Jersey State Police. "That's like saying an agency wouldn't investigate the death of a Black person as much as they'd investigate the death of a state of the sta gate the death of a white person.

Miller, who has worked on the killings with police in New York, Pennsylvania and Connecticut, says he has 300 unsolved homicides in his files and all carry the same weight.

"It's a dead person," Miller says. "I don't care what their lifestyle was."

In the Virginia cases, one man was acquitted for Charles Smith's murder and another is in custody for the slaying of the 12th victim in 1994

Law enforcement officials in Virginia defend their investigation as vehemently as Miller does his.

We have thousands of hours logged on this," says Officer Dave Hughes, a spokesman for the Chesapeake Police Department. "It's been an all-out effort. It's just a difficult case.

Community Activists Wary.

When Shirley Lesser, executive director of Virginians for Justice, a Gay advocacy organization, was asked if she thought police response had improved over time, she replied, "In the incidents that we have had, whether it involves murder or harassment or property damage against Gay people, I don't know of any case that has been solved through police effort."

Some Gays think the FBI should get in-

volved in the murders, but federal law limits FBI jurisdiction. They could pursue Cunanan, for example, because he fled across state lines. They worked on the bombing of an Atlanta Lesbian bar this year because explosives were used.

In June, President Clinton devoted one of his weekly radio talks to hate crimes and specifically cited violence against Gay people. The White House has scheduled a conference on hate crimes for No-



Nineteen states and the District of Co-lumbia have sexual orientation protections: Arizona, California, Connecticut, Delaware, Florida, Illinois, Iowa, Maine, Massachusetts, Minnesota, Nebraska, Nevada, New Hampshire, New Jersey, Oregon, Utah, Vermont, Washington and Wisconsin.

"People may disagree or agree about homosexuality," says Winnie Stachelberg, legislative director for the Human Rights Campaign, a Washington-based Gay po-litical group. "But they certainly agree that there's no place for violence against

#### Free Flow of Safe Sex Thought Stopped in **Sex Education Classes**

The U.S. federal government has pre-sented its united but disquieted states with a killer idea: that they must not mention condoms or any other birth control de-vices in public school classes. The singu-lar "technology of control" in sex education is to be instead an unworkable, unrealistic methodology: abstinence

Congress has temptingly offered to distribute \$250,000 far and wide if America's state school boards will agree to teach ab-

This offer, to their great misfortune, has been seized upon by nearly every hand-out-ready state, each eager to enter into a bad bargain that spells rampant disease and death to the ignorant.

Young people who are at war with their biological urges are, hereafter, to be given no trusty weapons should their much front-line of defense-abstinence-fail them in daily experi-

ences. Not only disease but, without the technologies of protection, the undeclared war against teen pregnancy is also at stake.

For the sake of imposing fundamentalist religious control over all reproductive matters, politicians at the service of religious ideologues are willing to risk the lives of America's children. They stand ready to enforce, even with increases in terminal diseases or spates of unwanted pregnancies, their pleasure-denying sexcontrol programs,
"Would that nature" would "sign on" to

Although the proportion of adult/adolescent AIDS cases who are MSM, has declined to 50% of 54,653 men reported in 1996, MSMs continue to account for the largest proportion of reported cases

(The term MSM includes all men who have sex with men, whether or not they identify as Gay or Bisexual.)

MSM comprise an even higher propor-tion of total AIDS cases when MSM who

also inject drugs are included.

Among MSM with no other reported risk factor, 10,485 were 13 to 24 years-old at the time of their AIDS diagnosis.

Men of Color

Men of Color

MSM of color in the US are disproportionately affected by the HIV epidemic.

By the end of December, 1996, the cumulative racial/ethnic distribution of AIDS cases among MSM is as follows:

White men, 65%; African-American men, 20%; Latino men, 13%; Asian-Pacific Islander men, 1%

Pacific Islander men, 1%.

These percentages for AIDS cases among MSM of color are significantly higher than the representation of men of color in the overall population.

Trends

Overall numbers of AIDS cases among MSM also hides the risk for young MSM. By December, 1994, the total number of AIDS cases reported among young MSM was 8,527. Among Adolescents The number of AIDS cases reported each year among US adolescents (13-19 years) has increased from 1 case in 1981 to 2,754 cases in 1996. HIV/AIDS is the sixth leading cause of death among 15 to 24 year-olds in the US.

Among adolescents reported with AIDS, older teens, males, and racial and ethnic minorities are disproportionately affected.

However the proportion of females among

US adolescent AIDS cases has almost tripled—from 14% in 1987 to 37% of reported cases in 1996.

CDC studies conducted every 2 years in high schools (grades 9-12) consistently indicate that by the 12<sup>th</sup> grade, approximately % of high school students have had sexual intercourse; less than half report consistent use of latex condoms, and about 1/5 have had more than four lifetime sex partners.





#### Madison Reps "Dames At Sea" Makes A Nice Season Opening Splash!

If you want to treat yourself to an evening of fun and frolic, why not check out The Madison Reps 1997 season opening offering of Dames at Sea. This show is sure to bring a smile to your face. But brush up on your Busby Berkeley movies first.

You remember the ones where loners found each other, all problems could be solved with enthusiasm and the spunky people always succeeded. But mostly, you should remember the lavish chorus girl scenes, whether on a large stage or diving into a pool. Berkeley was best known for his overhead shots of chorus girls creating intricate patterns that marvel the eyes. But don't expect to see any of that here, because Dames at Sea is a scaled down tribute, very scaled down.

Dames At Sea has only 7 actors and a small stage but it all works together to bring to life the story of Ruby (Tonya Kay) who just stepped off the bus in New York with only a suitcase and a dream. She just happens to stumble into a theater where one of the dancers has just quit. The wise-cracking chorus girl Joan (Becky Spice) and her roommate Ginger(Kelli Clement) convince the stage manager/director Hennesy (Norman Moses) to give her a chance.

While rehearsing, the theater diva, Miss Mona Kent (Carolynne Warren) tries to make her moves on Ruby's true love, Dick (Tony Clements) a good looking, songwriter and sailor. Hennesy loses the theater right before opening night, but Dick saves the show when he and his sidekick, Lucky (John Staniunas) convince the captain of their ship (also played by Norman Moses) to let the show go on on deck

The show's musical numbers are performed with camp style which works in its favor. Only this way can one then find the humor in its tribute/spoof of Berkeley. Tony Clements sings beautifully and looks good too (wink, wink boys). Carolynne Warren gets our funny bone ticking with "That Mister Man of Mine." But while the first act played well, it pales in comparison to the second act.

Here we are treated to the most memorable numbers. 

#### Life Outside; The Signorile Report on Gay Men and the Passages of Life

By Richard Tafel

Michelangelo Signorile, the King of outing has put a new twist on a familiar word. The word is "out."

In case you're not familiar with him, Signorile is most famous for his outing of famous people (his last book was entitled Out in America). He now writes for Out, which many have told me they enjoy. His coverage of Log Cabin Republican (LCR) at the San Diego convention was actually very entertaining and insightful.

But Signorile takes the word "out" (as in outside) to actually look "in" on the Gay male community. What he finds is-and isn't-very pretty.

Signorile focuses much of his book on the international circuit party scene, and any LCR members who attend those parties will find his observations both accurate and frightening.

The Gay culture, Signorile observes, is excessively hedonistic and superficial. If someone doesn't have the right body or the right looks, they are ignored. If they don't go the certain parties, they aren't on the "A list."

Signorile, examines the underside of this world narcissism, with its rampant chemical drug abuse, and the widespread steroid use within the Gay ghettos.

Like Gabriel Rotello, Signorile asks the Gay community to take a look at itself and challenges us to change the way we look at ourselves and others.

This is not a moralizing book about how bad Gay men are. Instead, it asks the fundamental questions of the Gay rights movement: what culture or way of life are we fighting to protect?

What has been the impact of internalized homophobia on the way we establish our brave new Gay world?

I think Signorile is asking the questions that will dominate the next generation of

community debate and I strongly recommended his book.

cally consisted of around 10 teams from the core cities plus a couple of others. In that year, Cleveland hosted an expanded tournament that featured 20 teams from all over the country.

#### Women in Combat Units? 'G.I. Jane' Gives an Emphatic "Yes!"

By John A. Jahn Demi Moore appears as a young Naval officer whom everyone expects little from, somewhat looks down upon, but who they eventually come to grudgingly respect and accept. I am, of course, speaking of Moore's new picture, G.I. Jane, but I'm also speaking of her earlier vehicle, A Few Good Men.

G.I. Jane is Hollywood's answer to the military's on-going gender-related prob-lems, and, while it faithfully exhibits many a shopworn cliché of the military movie genre, it also surprises us with a few unexpected plot twists now and then. It also suffers from predictability-but again, not without unexpected turns along the way.

G.I. Jane is the story of a Naval Intelligence Officer, Lt. O'Neil (Demi Moore), who's selected by a powerful U.S. Senator (Anne Bancroft) to be the first woman to attempt to make it through the Navy's SEAL school. It's unbelievably tough training conducted by some sadistic drill instructors, in particular, Master Chief Urquay (Viggo Mortensen). O'Neil is confronted at once by the macho ol' boys network, but the harassment she undergoes initially is tempered by the Master Chief and the base C.O.

There is a definite struggle in these men between the desire to slam dunk this female invading their sanctuary and the knowledge that they have that any harassment of her will likely explode in their faces if and when she goes public with it. All of this makes G.I. Jane's plot taken right from today's often scandalous headlines.

The bulk of this film involves O'Neil's SEAL training, and her demand to be treated in every way exactly like one of the

boys...she gets her wish, alright. The many graphic scenes of harsh training really makes you feel like you're right there with 'em. I don't know if "real" SEAL training is quite so brutal, but if it is, God bless 'em!

What writer and director Ridley Scott's G.I. Jane has going for it is sharply written dialogue, a look and feel of realism, unexpected turns of plot, and it leaves you with at least a modicum of respect for the military (some patronizing officers excepted). It also is a message film: women should be able to serve with men in combat situations, but they must get to that point by being treated fairly and consistently...just like one of the guys. O'Neil doesn't ask for a helping hand because she's a girl, and she gets her wish.

Does she make it through? Well, of course, she does! But, like I said, there are a few twists along the way, and it's the unexpected which helps save this film.

To its detriment, G.I. Jane has a surprisingly weak supporting cast of one dimensional characters. Moore's character is, in fact, the only person in this 2 hour movie we ever feel we get to know in any way...and she's even somewhat of a thin, underdeveloped character. Thus, the major weakness is we remain emotionally detached from the action...a major failing, indeed, although we do feel O'Neil's triumph at the conclusion.

G.I. Jane certainly succeeds in delivering its message about expanding the role of women in the military, and in giving them the respect they deserve. Let's hope Hollywood now gives us the same for a Gay soldier ("G.I. Mary"?).

Nevertheless Glenn must admit that he found George of the Jungle refreshing and surprisingly entertaining.


For one thing, Brendan Frasier looks fabulous in a loincloth. Glenn imagines that he looks fabulous out of a loincloth but Glenn digresses...

#### 'Picture Perfect' is Actually a Picture That is Less than Perfect

By John A. Jahn Director Glenn Gordon Caron's romantic comedy Picture Perfect seems to have been aimed squarely at a particular audience: the Gen-Xers. The central characters are all in their 20s and 30s, the story revolves around the pressures of career and romance (often goals which are at odds with one another), and general Gen-X angst, and the pop tuned-laden soundtrack contains various Gen-X bands as well as a healthy dose of '70s music (currently all the rage). I guess I was supposed to find Picture Perfect all that.

The New York City-based story revolves around a young, single professional woman named Kate (Jennifer Aniston of TV's "Friends" in her first starring role). This attractive and talented ad exec is having trouble moving up the corporate ladder, and wonders why. The answer is that her boss, Mr. Mercer (Kevin Dunn) patronizingly won't even consider her for a promotion because she's unattached, supposedly without responsibilities, living as if she were "still in college," and thus, he fears, liable to leave the firm at the drop of a hat.

This scenario, therefore, puts Kate squarely in the scenario faced by many Gen-Xers. Kate, with a little unwanted help from her best friend and colleague, Darcy (Illeana Douglas), sets about to fulfill her boss's requirements, and feels she can also kill two birds with one stone by using the same scheme to get a sexy coworker named Sam (Kevin Bacon) to fall for her. The set up of this film is an interesting

one, and certainly one filled with comic

potential.

The trouble is, not only are there very few laughs in this less-than-perfect movie, but the outcome is fatally predictable. Especially for a romantic comedy, a predictable outcome is indeed a fatal flaw. It was, in fact, unpredictability which aided the vastly superior My Best Friend's Wedding earlier this summer. Within 15 or 20 minutes, you know how this movie will turn out, so the only thing that can save it is for the getting there to be very funny. Trouble is, the screenplay (by the director, plus Arleen Sorkin and Paul Slansky) is down-

You also find it hard to really like the often cold, shrewd, manipulative Kate. She treats the loveable, kindhearted guy she enlists to help her, Nick (Jay Mohr), like dirt while he's obviously falling in love with her. She predictably comes around in the last act... a point where the mistreated Nick should've taught Kate a lesson in honesty and true love and told her where to go. Instead, they embrace and (gag!) live happily ever after. The writers failed to take a big chance here and teach self-absorbed Gen-Xers a good lesson...one beginning, "Oh what a tangled web we

Picture Perfect is far removed from its title. Rather, the comedy is flat, the romance tepid and mislaid (no pun intended), the characters two dimensional, the plot predictable.

#### 'Spawn' is a Devilishly Delightful Film With Wonderful Special Effects

Though always a vociferous reader, Glenn was never much caught up in the wild and wacky world of comic books. Not that Glenn wasn't exposed to them. On his occasional sleep-over, Glenn's older, more worldly and decidedly yummy boy cousin continually sought to engage Glenn in his current favorite action heroes. Sadly, inevitably, Glenn's attentions would lay elsewhere.

Thus clueless, Glenn would wander to his usual seat, "biggie" popcorn and "biggie" Diet Pepsi in hand and patiently wait for the big screen adaptation of Todd McFarlane's cult creation, Spawn.

Bringing a comic book alive on the big screen effectively is a task beyond most filmmakers. For example, see any of the Batman flicks or even worse, far, far, worse, that perfectly dreadful Flintstone fiasco from a few summers ago.

Nor do the first fifteen or so minutes of Mark Dippe's Spawn hold much promise. Following some suitably predictable apocalypsical twaddle comes the now obligatory dare-devil explosion sequences so absolutely necessary to prime adolescent audiences for a routine, low-budget action flick

Glenn was not amused.

Then, as Glenn's mind began to wander, Michael Jai White's assassin-with-a-heartof-gold suddenly became "Spawn", tormented by the black-hearted, "Clownfrom-Hell", played to the hilt by John Leguizamo. Faithful readers of the Wisconsin Light might fondly remember Mr. Leguizamo as the saving grace of the dreadful, To Wong Foo...

Aided by the best special effects that Hollywood can buy form the great and almighty folks at Industrial Light and Magic, Spawn comes magically alive.

There are great themes at work here. In proper, comic book fashion, "ultimate evil" is dispatched with a mission to wreck havoc on the entire planet. 'Course you know (as do the makers of the comic books) that good, as embodied by the heroic action hero (here the reluctant Spawn) will, in the end, be victorious but also that evil will continue to lurk, awaiting its chance in the upcoming sequel.

What elevates Spawn is a devilishly delicious sense of humor and an attitude which defies the audience to quibble over minor implausibilities.

The real star of Spawn are some of the most fabulous special effects that Glenn has seen in some time, making it seem possible, if not actually believable, that a comic book hero such as Spawn might

While Michael Jai White's Spawn is suitably noble and inevitably colorless, John Leguizamo gleefully renders his evil Clown in true, glorious comic book fashion and just about steals the film. Similarly, Martin Sheen, too, understands that as a bad guy in a film such as Spawn, there can be no such thing as overacting.

Glenn imagines that Spawn might not everyone favorite cinematic entertainment but it is hard to imagine the heartless moviegoer charmed by the cute dog and the adorable little boy who befriend our ugly hero as he saves our planet!

Now Voyager, (1942), seems to hold a special place of affection ,for Davis aficionados, especially those fortunate enough to have seen it on the large screen. Although sometimes regarded as a grandiose soap opera, it is the most popular of the Davis films, perhaps because it is a quintessential reminder of a period of Hollywood moviemaking in which many Golden Age films supplied a valuable experiential component to our daily lives rather than a redundant digression into topical realism.

The greater of the Golden Age films often had an elusively bittersweet quality which somehow added a greater emotional focus to everyday reality capturing essence rather than specifics.

Made shortly after the more acclaimed Casablanca, Now Voyager is hardly less noteworthy than its famous predecessor. Like Casablanca, the film transcends the events of its screenplay scenario and leaves moviegoers wondering why they like it so much. Still immediate and compelling with a lingering sense of timeless angst, the film has never been relegated to that quaintly dismissive dustbin of oldfashioned memorabilia. It is a fine, beautiful film and deserves popularity and



eyes of the beholder. It couldn't have been easy for the intense Bette to play a character as shallow and vapid as Fanny Skeffington---a beautiful New York socialite concerned only with her looks and her endless parade of suitors. Eventually she marries the wealthy Job Skeffington whose proverbial "patience' allows a continuing circle of suitors to flatter his wife's vanity. "She doesn't encourage them," he states.

Bette gives the illusion of beauty by sheer willpower and the carefully structured magnetism of her performance. She uses three different vocal patterns to develop the characterization.

As young foolish Fanny, the voice is high, light and airy, with a polite superficial grace. Fanny hates unpleasantness .Learning of her brother's death as WW I pilot, she goes into hysterical shock-one of Davis's most brilliant transitional scenes after which Davis alters Fanny's persona with a sharper more cynical tone, as her charm becomes more studied and her self absorption increases She divorces her husband who leaves for Germany with their daughter.

For the final sequences, ravaged by diphtheria, her beauty and suitors gone, Bette affects an unsteady weak rasp, shoulders slightly forward with an uneven gait, and, completing the transformation with grotesque make-up emphasizing extreme hair loss, Bette creates a pleading frail character who had never developed the strength necessary for adversity.

Davis's superb performance not only captures the pathos of age and vulnerability, but she transforms the struggle between selfish vanity and loneliness into a kind of high tragedy. The sophistication and complexity of her approach still amazes.

The last few scenes with Claude stumbling over a footstool, and Bette's sudden shock of remorse are very moving. Never before had she developed a role with such exquisite care and minute detail The scope and depth of her of her emotional range is without parallel here.

It is said that Davis used her considerable authority to commandeer the production. If so her Fanny Skeffington is a testament to her intelligence and integrity and of course to her inestimable talent.

Probably the most widely remembered scene is the climactic episode in which the aged Fanny, alone and deserted, stands in her large darkening living room and tearfully watches her dilapidated image in a series of mirrors which the camera circles. The scene is doubly symbolic. It gives pause to absorb the depth of Davis's characterization and proclaims the apotheosis of BETTE DAVIS-GREAT ACTRESS. She was never quite to match this moment again.

#### Montana High Court Strikes Down State's Sodomy Law

Washington, DC-AP-Gay, Lesbian, bisexual and Transgendered activists in Montana on July 2<sup>nd</sup>, celebrated a victory when the state Supreme Court unanimously struck down the state's sodomy law by ruling that sexual activity between consenting adults of the same-gender would no longer be illegal. The victory was nearly a quarter-century in the making.

Montana Gay and Lesbian activists worked hard to show that the law was unfair and denied them their guaranteed right to privacy. It was among the most severe of all the nation's sodomy laws because it prohibited same-gender "sexual contact"-not just the customary ban on anal and oral intercourse. Violators of the law could have faced up to ten years in prison and a maximum \$50,000 in fines.

Five states and the District of Columbia

have now decriminalized sodomy. While four other states have sodomy repeal measures alive, 28 states continue to have same-gender sodomy laws which make it illegal for some Americans to love whom they choose to love.

Although the U.S. Supreme Court found no constitutional right to privacy for same-gender conduct, the 1986 Bowers v. Hardwick decision permitted each state to same-gender decriminalize

that not only teach HIV risk reduction skills, but also reinforce the message that Gay men can achieve successful relationships and long, productive, and gratifying lives," said Jeffrey A. Kelly, Ph.D., the study's co-author and director of CAIR.

Under the best circumstances, people often find it difficult to change behaviors that put them at risk for HIV/AIDS. It is even more difficult if they have many life problems and do not have a strong, positive outlook for the future. People with goals and aspirations are likely to take greater steps toward protecting themselves from HIV and AIDS, the study findings indicate.

The research also surveyed relationship status among the men. The study showed that men in exclusive relationships were more likely to be satisfied with their current life situations and had more hope for the future. However, the study could not determine whether stable partnered relationships produce greater present life satisfaction or whether men who already have these characteristics are more likely to enter and sustain exclusive relationships.

The CAIR study was based on a survey of 430 Gay and Bisexual men at an urban Gay pride celebration in 1995.

Dr. Kalichman was formerly at CAIR, and is currently an assistant professor of psychology at Georgia State University. Dr. Kelly is a professor of psychiatry and behavioral medicine at the Medical College of Wisconsin.

In addition to Dr. Kalichman and Dr. Kelly, the study was co-authored by David Rompa, a Research Coordinator at CAIR and Michael Morgan, formerly a CAIR Research Associate.

#### **LBGT Christians**

#### TO THE EDITOR:

Responding to Terry Sanderson's commentary of July 31st.

Most of us GLBT Christians don't bang our

heads on the church door asking to be let in. WE ARE THE CHURCH as are all of our sisters and brothers. In reference to "the authoritarians that constitute the Christian Church," the Pope, the Bishop, as much as I, admire and respect Archbishop Weakland, are not the church. THE CHURCH is the whole body of believers with our good points and our faults.

It is interesting that people who don't believe in the Scriptures of the work of modern Scripture scholarship, are so quick to accept the Fundamentalist interpretation of them. Most modern scholars and theologians see the Christian Scriptures as living documents, much as we see the U.S. Constitution. Therefore, our understanding and interpretation is constantly growing and evolving in light of the individual and collective experience.

We must also realize that the Bible is not a neat book of rules, bur rather a sloppy collection of 72 books (66 if you're Protestant), that explore and explain individual and/or community faith experience; books that confirm and/or contradict each other; books, though inspired by God, are written by men with prejudices from their space in history.

This does not invalidate their faith experience, but must be understood to understand their writings. Because of this, it is easy to pull out phrases or passages that would indicate that the God of Abraham and Sarah, the God of Jews, Christians and Moslems, is a judgmental, cruel, blood thirsty and homophobic God.

When one reads the whole of Scripture, especially in the light of the Gospels, which we who claim the name of Christ are called to do, a very different God, and therefore a different people emerges. These are a people of caring and concern, love and inclusion.

Yes, there is homophobia in the church and there is homophobia in the nation. Does that meant that we should throw up our hands and opt out? Or are we called to be prophets to our churches and to our world?

If one is to believe the polls, it appears that the work of the early, openly GLBT missionaries is paying off. Poll after poll shows that the Christian in the pew is much more accepting, much more pro-Gay than they were only 10 years ago. In most traditional Christian churches this is the majority; up to

Realizing that there are many in our community who have been so hurt that they, like the young child that is excluded from the game says, "I don't want to play. I don't even like that game."

Many of us are like the little girls who were told they couldn't play Little League and said, "The hell we can't," and fought until they were put on teams

put on teams.

Please don't be embarrassed by GLBT people of faith any more than we should be embarrassed by Gay Republicans or Gay or Lesbian soldiers, or any other life choices we make. Diversity is what makes us such a rich

community. Let's continue to celebrate it and stop attacking each other.

#### Gays and Christianity

#### TO THE EDITOR:

This letter is in response to Terry Sanderson's article in the July 31-August 13 issue of the **Light**. I was originally going to respond with my usual smart-ass school of sarcasm style that I frequently use when writing to the papers. But this is too important for that.

I used to share Terry's view of religions in general and the Christian denominations more specifically. That has changed in recent years. I am happy to say that I have become active in religion again. I can thank two denominations for that; the Metropolitan Community Church and the Evangelical Church of America. As the tried and true saying goes: When God closes a door, He/She/It opens a window. Well, the windows are the MCC and the EACA.

Most Christian denominations have either rejected GBLTs or have some sort of tolerance agenda going on. I agree with Terry that this is an intolerable form of Christianity and I can't imagine anyone wanting to put themselves through the ordeal-by-guilt or the back-of-the-bus experience. But there are options out there.

Both the MCC and the EACA have emerged recently. The Metropolitan Community Church, which has an active parish in Milwaukee, led by Pastor Lew Broyles, doesn't tolerate the LGBT community, it celebrates it. The MCC does not allow the LBGT community to attend services, it beseeches, begs, invites, cajoles, and otherwise encourages anyone to visit or to join whether heterosexual, homosexual, or some-other sexual. This denomination has over 300 parishes world wide and celebrates diversity as evidenced by the variety of worship experiences one can have from one parish to the next. Decidedly Protestant, it offers a variety of spiritual environments and considerable flexibility of belief.

The EACA, or the Evangelical Anglican Church in America, is a more "catholic" denomination whose priests and bishops derive their apostolic succession through the Old Catholic Church. The headquarters of this denomination is near Los Angeles and is my own denomination, by the way.

This church follows the guidelines of the Book of Common Prayer of 1979 and the liturgy is virtually identical to what one would experience at St. James or All Saints Cathedral...on a somewhat more modest scale. While there is no parish in the Milwaukee area at this time, I hope to begin one following my ordination at some future date.

These are not efforts to "play church" and do "dress up." These are legitimate denominations that have a special outreach to the LGBT community, but encourage anyone who wishes to, to participate.

Terry, people may reject us, but God never would. I understand how you feel, having shared those feelings for nearly 30 years. There's plenty of information available on both those denominations and is available for
