# Fammies Trial M. She Doll?

### Continuing Coverage By Bill Meunier

Milwaukee– The trial of Fannies owner, Sharon Dixon, is expected to conclude on Wednesday January 26. Dixon faces two felony counts, arson with intent to defraud and illegal possession of a controlled substance-morphine. Before the trial ends, the prosecution headed by Assistant DA James Griffin will have called 20 witnesses. Griffin is attempting to lay out a case that Dixon's economic circumstances and her actions before and after the fire are consistent with those of someone who would engage in an arson for profit scheme. The Defense may rest without calling anyone to the stand.

The state's star witness, Dixon's former best friend, Monica Belfour, told the Court that Dixon was with her and three other friends, who got together for dinner at Senor Frog's when the blaze broke out on October 28, 1997. Absent evidence that Dixon set the fire herself, the prosecution must use circumstantial evidence to show that she arranged to have someone do it for her. To do that Griffin has called arson experts, former Fanny employees, Dixon's accountant, and former and current friends of Dixon.

The State also tried to call two additional witnesses: Dixon's cousin, Pat Johnson and for-

mer Fannies employee Gayle Guchard. Both women testified at Dixon's preliminary hearing. Both also avoided subpoenas to testify at Dixon's trial. In an argument that took place with the jury outside of the courtroom, Defense Counsel Jim Stewart opposed a Prosecution request to read the testimony they gave before Court Commissioner Audrey Brooks to the jury.

Stewart objected because he was not Dixon's attorney at the time of the preliminary hearing and didn't have an opportunity to question the women. He contended that the State had not done enough to subpoena the women and that testimony given during a preliminary hearing was different in nature than what would be given at a trial. Stewart lost the argument when Judge Elsa A. Lamelas ruled ordered that the testimony be read for the jury.

The State contends that Dixon had plenty of economic reasons to commit arson.

The prosecution says that Dixon's owes the IRS thousands of dollars in back taxes from her failed restaurant business, Mike and Anna's. Three witness, Balfour and Murphy at the trial and Guchard at the preliminary hearing testified that Dixon said she would burn down Fannies rather than allow the IRS to seize it.

However, all three women also said that they didn't think that Dixon was serious and that her statements were not made close to the time of the fire.

A Forensic Auditor who works the Chicago office of the Bureau of Alcohol Tobacco and Firearms testified that Dixon owed over \$136,000 to the State of Wisconsin alone. But Defense counsel Stewart poked a hole in her testimony.

The auditor testified to the amounts on several sales tax notices from the State of Wisconsin. Stewart asked if she was aware that just one of those notices sent in October 1997, would mean that Fannies had sales in excess of \$600,000. The witness said that she didn't know what period the notice covered and that it may have included penalties and interest. Stewart then asked the auditor if she was aware of the state practice of estimating how much the taxes should be. The witness admitted that she didn't know what the state's practices were and what interest and penalties might be included in the amount.

When Connie Goffinet, who Dixon turned to for help in getting a loan, took the stand, the State hoped to show that Dixon was not able to obtain credit. Goffinet testified that an Illinois company turned away Dixon's loan



### First Time Gay Health Issues Pushed at Federal Level

Washington, DC —The nation's largest Gay medical association and Columbia University released a joint, comprehensive, preliminary report focusing on the health issues and concerns of Lesbian, Gay, Bisexual and Transgender (LGBT) people in the United States.

The report, funded by the U.S. Health Resources and Services Administration (HRSA), will influence federal policy as the government sets national health guidelines for the next decade. Policy decisions, as well as funding for research and services, are largely determined by what's called "Healthy People" — in this case Healthy People 2010. Some believe health issues not addressed in this 10-year plan will not receive attention at the federal level.

The Gay and Lesbian Medical Association (GLMA) and the Center for Lesbian, Bisexual and Transgender Health at Columbia University's Joseph L. Mailman School of Public Health timed the paper's release to coincide with the federal government's launch of Healthy People 2010.

"This marks the first time LGBT health concerns, other than HIV, have been addressed in any significant way," said Patricia Dunn, GLMA policy director. "This is a major step forward in national health policy. Such issues as the lack of adequate research, barriers to quality health care, and insensitivity to LGBT people within the medical community, are finally being addressed."

"This report is not just about what we know," said Darren Carter, MD, GLMA Board Policy Chair. "Because LGBT issues are rarely researched and frequently not

Launching Healthy People 2010

January 24 – 28, 2000, Omni Shoreham Hotel, Washington DC – The Gay and Lesbian Medical Association is an organization of more than 2000 lesbian, gay, bisexual, and transgender physicians, medical students, and their supporters in all 50 U.S. states and 12 countries. The Center addresses these challenges in research and evaluation, education and training, the provision of health and social services, and public health policy and advocacy.

included in the training of medical professionals, the report discusses what we don't, but absolutely should, know."The white paper outlines how "stigma and prejudice are powerful forces that adversely impact" the health of LGBT people.

"As is the case for many minorities, there are health-related challenges facing Lesbians. There are another set of challenges for Gay men, still others for Bisexuals, and even more for Transgender people," continued Carter.

"However, many mainstream health care providers have no idea what specific health concerns there might be relative to these populations. Often they do not know what questions to ask or how to ask them."

Those involved with health care often confuse issues such as the difference between gender identity and sexual orientation. According to the paper, this is among the many major problems facing researchers and is a serious barrier for LGBT patients seeking care.

"Even well-meaning physicians, for example," Carter said, "may make assumptions about Gays or Lesbians that make them reluctant to return for treatment. Or those assumptions may actually be dangerous. For example, we know that many doctors treating Lesbians believe that a pap smear test is not necessary because Lesbians are not engaged in heterosexual intercourse. The white paper provides needed evidence that this practice can be dangerous to Lesbians' health."

"What's worse," Dunn said, "is that public health policy, medical training, and planning such as the Healthy People 2010 process are research-based. This is as it should be. But research about our communities is not being done."

Both Dunn and Carter believe that the GLMA-Columbia white paper begins to address the serious deficit of public knowledge about the health care needs of LGBT people. The GLMA-Columbia white paper is a precursor to an even more comprehensive companion piece on LGBT health that will follow the final Healthy People 2010 document to be published by the Department of Health and Human Services(DHHS) later this year.

### Pro-LGBT Religious Leaders to Meet

Irvine, CA - Religious leaders from all over the United States will come together with people of faith in California on Monday, January 31, to speak with a united voice against California's Proposition 22 - The Limitation on Marriage Initiative. Orange County, CA has become ground zero for a national effort spearheaded by the National Religious Leadership Roundtable to help mobilize religious voices to speak out against Proposition 22, also known as the Knight Initiative.

A public forum entitled, "A Call to Action: People of Faith Say No to CA Proposition 22," will be held in Irvine.

"Proponents of Proposition 22 try to hide behind the thin veneer of terms like 'morality' and 'traditional family,'" said Rabbi Denise Eger, one of the speakers at the forum, and founding rabbi of Congregation Kol Ami in West Hollywood. "This initiative would cause more real harm than symbolic good to families, which is inconsistent with our understanding of morality. The fact is that millions of people of faith support equal civil rights for gays and lesbians."

### Millennium March on Washington Update

Washington, DC-- After two years of planning and the departure of some high profile leaders, Millennium March on Washington details are becoming clear. What began simply as an April 30 rally now includes a march through the streets of the nation's capitol and three big-name celebrities to headline entertainment. Ellen DeGeneres, Anne Heche and Melissa Etheridge will be among the performers who will entertain Gays and Lesbians from across the nation gathered on the National Mall.

Joining the three performers will be "Third Rock from the Sun" costar Kristen Johnson. Other performers are expected to join the list. Some entertainers also likely will appear the day before at the Human Rights Campaign's Equality Rocks, a rock concert at Robert F. Kennedy Stadium.

Participants in the March will gather at The Ellipse, located behind the White House between 15th and 17th streets. Marchers will follow Constitution Avenue and turn right onto 14th Street, then left onto the National Mall to Third Street, where the main stage will be located.

In addition to entertainment, stage presentations will be made focusing on platform issues. Several hundred thousand ballots were distributed to gays, lesbians and allies throughout the nation and online to determine the platform.

Organizers have created a "working vision" from the more than 40,000 responses they had received by the beginning of December. The eight priority issues are: hate crimes legislation and protections; ending Gay, Lesbian, Bisexual and Transgender discrimination in the workplace; racial justice; family values-including marriage and partner rights, adoption and child custody issues; health care issues; legal protection for the community's youth; overturning anti-Gay initiatives and laws at the federal and state level.

Hardy-Garcia said she hopes the march will bring out the largest Gay and Lesbian vote in history for the presidential election. "What this march is going to do is unprecedented," she said. "There's nothing like a national march to inspire people. Marches are life-transforming for people. We have a whole generation who has never marched."

"In the end, what people will remember is what it feels like to be on that mall with thousands and thousands of people like them," Hardy-Garcia said.

# Political Commentary Where Did John McCain Get His Gaydar?

Arizona Senator John McCain said recently that he can spot Gay people "by behavior and by attitudes." Ordinarily, this is the sort of comment that raises hackles on most Lesbian/Gay civil rights activists. In this case, however, I think we should cut the Republican presidential candidate some slack.

McCain was campaigning in New Hampshire when he made the statement. He was responding to reporters, who asked about his ability to spot Gay persons because he had talked about serving in the Navy with sailors whom he knew to be Gay, even though they didn't tell him.

Stereotypes are clearly a problem. In some sense, for minorities who suffer discrimination, they are THE problem. The only reason some people conclude that they should take our children away, fire us, or otherwise harass us just because we're lesbian or gay is because they believe that we all have something important in common because of our sexual orientation, that they know what that thing is, and that the thing itself is very bad.

The problem, in other words, is the logic that "All X are Y," which is the basic logic of stereotypes.

And clearly McCain relied on stereotypes

in explaining his personal gaydar system. But I think this example of stereotyping is relatively harmless, and under the circumstances, it could even be useful.

McCain's statement indicates that he is, at some level, thinking about Lesbian/Gay issues, or has thought about them. He may not have thought very carefully, and he may not have come to just the conclusion we would like, but at least he is willing to give a considered, unscripted answer to a question that has become increasingly important during this presidential race.

Unlike you know who. George II appears incapable of giving an unscripted answer to a question, and he has made the necessary obeisance to the right wing of the Republican Party by stating that he would not knowingly hire a Lesbian or Gay person for his staff.

John McCain has virtually zero chance of winning the Republican nomination for the presidency in 2000. His value to the Lesbian/Gay civil rights movement is that he may actually raise enough questions about George II during the primaries that George II will not be able to buy his way to the presidency.

And, all press releases from Log Cabin Republicans, the Gay Republican group, notwithstanding, it's still quite clear to me that Lesbians and Gay men as such will be much better off with a Democratic victory in this year's presidential race.

McCain is at least willing to take money from Log Cabin Republicans, which is an improvement. Recall in 1996 that Bob Dole created a stir by first accepting a donation from Log Cabin, then returning it in a bid to shore up his right-wing support.

The biggest problem with McCain at the moment is that he continues to support the Don't Ask, Don't Tell policy for Lesbian/Gay servicemembers. Apparently even the news that two soldiers attacked and killed their barracks mate, Barry Winchell, while he slept because they believed he was Gay is not enough to persuade John McCain that Don't Ask, Don't Tell is bankrupt.

McCain's gaydar is a reminder that progress comes slowly, and in odd ways. Never before have activists managed to insert Lesbian/Gay civil rights issues so thoroughly into a presidential campaign. Among the unpredictable results that this development has produced, John McCain's comments are at once slightly dismaying and mostly hopeful.

### On the Democratic Front: Bill Bradley Goes to LGBT Bar

Des Moines, IA -- On Thursday night, Bill Bradley met with over a 100 Gay and Lesbian activists from across the state who warmly welcomed him to the Blazing Saddle, the oldest Gay establishment in Des Moines. The Blazing Saddle is well know for its commitment to the community by providing on average \$50,000 per year in donations to various philanthropic organizations within the Des Moines area.

Bill Bradley has been outspoken on the issues affecting the Gay and Lesbian community. Bradley re-affirmed his support for amending the 1964 Civil Rights Act to include sexual orientation-realizing that ENDA does very little to address the fundamental issue of


total civil rights protection for Gays and Lesbians. Bill Bradley also renewed his support for allowing Gays and Lesbians to serve openly in our nations military.

"I was one of only two Senator's in 1993 to oppose the Clinton-Gore 'Don't Ask Don't Tell' policy. I understood then, as I do now, that 'Don't Ask Don't Tell' was a failed attempt at granting Gays and Lesbians the right to serve openly in the military. The policy has done nothing more then create a divisiveness that has spawned hatred and fear among our men and women serving in the armed forces." Bradley said.

VP Gore Renews Support to LGBT Community

Washington, DC – Vice President Al Gore recently met with the leadership of the National Stonewall Democratic Federation (NSDF) at his official residence to discuss issues of importance to the Lesbian and Gay Democrats and to the Vice President. The meeting, held at the request of the Vice President, offered frank and open discussion of issues including ENDA, hate crimes, women's healthcare, immigration and HIV/AIDS funding, among others. Gore stated his dedication to ending discrimination and spoke of a new America where we can "Expand the circle of human dignity."

NSDF Board members will be meeting with Bill Bradley at a convenient date in the near future. NSDF will decide after meeting with both candidates the timeline for an endorsement for the Democratic presidential nominee.

This is a summary and not a replacement for a careful discussion with your doctor. You and your doctor should discuss VIRACEPT when you start taking this medication and at regular checkups. You should remain under a doctor's care when taking VIRACEPT and should not change or stop treatment without first talking with your doctor.

WHAT IS VIRACEPT AND HOW DOES IT WORK?

WHAT IS VIRACEPT AND HOW DOES IT WORK?

VIRACEPT is used in the treatment of people with human immunodeficiency virus (HIV) infection. Infection with HIV leads to the destruction of CD4 T cells, which are important to the immune system. After a large number of CD4 cells have been destroyed, the infected person develops acquired immune deficiency syndrome (AIDS).

VIRACEPT works by blocking HIV protease (a protein-cutting enzyme), which is required for HIV to multiply. VIRACEPT has been shown to significantly reduce the amount of HIV in the blood. You should be aware, however, that the effect of VIRACEPT on HIV in the blood has not been correlated with long-term health benefits. Patients who took VIRACEPT also had significant increases in their CD4 cell count.

VIRACEPT is usually taken together with other antiretroviral drugs such as Retroviral (adovudine, AZT), Epivir® (lamivudine, 3TC), or Zerif® (stavudine, d4T). Taking VIRACEPT in combination with other antiretroviral drugs reduces the amount of HIV in the body (viral load) and raises CD4 counts.

VIRACEPT may be taken by adults, adolescents, and children 2 years of age or older. Studies in infants younger than 2 years of age are now taking place.

DOES VIRACEPT CURE HIV OR AIDS?

VIRACEPT is not a cure for HIV infection or AIDS. The long-term effects of VIRACEPT are not known at this time. People taking VIRACEPT may still develop opportunistic infections or other conditions associated with HIV infection. Some of these conditions are pneumonia, herpes virus infections, Mycobacterium avium complex (MAC) infections, and Kaposi's sarcoma.

It is not known whether VIRACEPT will help you live longer or reduce the number of infections or other illnesses that may occur.

There is no proof that VIRACEPT can reduce the risk of transmitting HIV to others through sexual contact or blood contamination.

WHO SHOULD OR SHOULD NOT TAKE VIRACEPT?

Together with your doctor, you need to decide whether VIRACEPT is appropriate for you. In making your decision, the following should be considered:

Altergles: If you have had a serious altergle reaction to VIRACEPT, you must not take VIRACEPT.

Allergies: If you have had a serious allergic reaction to VIRACEPT, you must not take VIRACEPT. You should also inform your doctor, nurse, or pharmacist of any known allergies to substances such as other medicines, foods, preservatives, or dyes.

If you are pregnant: The effects of VIRACEPT on pregnant women or their unborn babies are not known. If you are pregnant or plan to become pregnant, you should tell your doctor before taking VIRACEPT.

If you are breast-feeding: You should discuss with your doctor the best way to feed your baby. You should be aware that if your baby does not already have HIV, there is a chance that it can be transmitted through breast-feeding. Women should not breast-feed if they have HIV.

Children: VIRACEPT is available for the treatment of children? I through 13 years of age with HIV. There is a powder form of VIRACEPT that can be mixed with milk, baby formula, or foods like pudding. Instructions on how to take VIRACEPT powder can be found in a later section that discusses how VIRACEPT Oral Powder should be prepared.

If you have liver disease: VIRACEPT has not been studied in people with liver disease. If you have liver disease, you should tell your doctor before taking VIRACEPT.

Other medical problems: Certain medical problems may affect the use of VIRACEPT. Some people taking protease inhibitors have developed new or more serious diabetes or high blood sugar. Some people with hemophilia have had increased bleeding. It is not known whether the protease inhibitors caused these problems. Be sure to tell your doctor if you have hemophilia types A and B, diabetes mellitus, or an increase in thirst and/or frequent urination.

CAN VIRACEPT BE TAKEN WITH OTHER MEDICATIONS?

VIRACEPT may interact with other drugs, including those you take without a prescription. You must discuss with your doctor any drugs that you are taking or are planning to take before you take VIRACEPT.

### Drugs you should not take with VIRACEPT:

- Drugs you should not take with VIHACEP1:
  Seldane® (tertenadine, for allergies)
  Hismanal® (astemizole, for heartburn)
  Cordarone® (amiodarone, for irregular heartbeat)
  Ouinidine (for irregular heartbeat), also known as Quinaglute® Cardioquin® Quinidex® and others
  Ergot derivatives (Cafergot® and others, for migraine headache)
  Halcion® (triacalam)
  Versed® (midazolam)
  Taking the above drugs with VIRACEPT may cause serious and/or life-threatening adverse events.
  Rifampin (for tuberculosis), also known as Rimactane®, Rifadin®, Rifater®, or Rifamate®
  This drug reduces blood levels of VIRACEPT.

Dose reduction required if you take VIRACEPT with: Mycobutin® (rifabutin, for MAC), you will need to take a lower dose of Mycobutin.

### A change of therapy should be considered if you are taking VIRACEPT with:

Phenobarbital
 Phenytoin (Dilantin® and others)
 Carbamazepine (Tegretol® and others)
 These agents may reduce the amount of VIRACEPT in your blood and make it less effective.
 Oral contraceptives ("the pill") if you are taking the pill to prevent pregnancy, you should use a different type of contraception since VIRACEPT may reduce the effectiveness of oral contraceptives.

HOW SHOULD VIRACEPT BE TAKEN WITH OTHER ANTI-HIV DRUGS?

Taking VIRACEPT together with other anti-HIV drugs increases their ability to fight the virus. It also reduces the opportunity for resistant viruses to grow. Based on your history of taking other anti-HIV medicine, your doctor will direct you on how to take VIRACEPT and other anti-HIV medicines. These drugs should be taken in a certain order or at specific times. This will depend on how many times a day each medicine should be taken. It will also depend on whether it should be taken with or without food.

Nucleoside analogues: No drug interaction problems were seen when VIRACEPT was given with:

Retrovir (zidovudine, AZT)

- Epivir (lamivudine, 3TC)

- Zerit (stavudine, d4T)

- Videx\* (didanosine, ddl)

- It you are taking hoth Videx\* (ddl) and VIRACEPT. Videx should be taken without food, on an empty.

If you are taking both Videx (ddl) and VIRACEPT: Videx should be taken without food, on an empty stomach. Therefore, you should take VIRACEPT with food one hour after or more than two hours before you take Videx.

Nonnucleoside reverse transcriptase inhibitors (NNRTIs):

when VIRACEPT is taken together with:

Viramune\* (nevirapine)
The amount of VIRACEPT in your blood may be reduced. Studies are now taking place to learn about the safety of combining VIRACEPT with Viramune.

Other NNRTIS
VIRACEPT has not been studied with other NNRTIS.

Other protease inhibitors:
When VIRACEPT is taken together with:
Crixivan® (indinavir)
The amount of both drugs in your blood may be increased. Currently, there are no safety and efficacy data available from the use of this combination.
Norvir™ (ritonavir)
The amount of VIRACEPT in your blood may be increased. Currently, there are no safety and efficacy data available from the use of this combination.
Invirase® (saquinavir)
The amount of saquinavir in your blood may be increased. If used in combination with saquinavir hard gelatin capsules at 600 mg three times daily, no dose adjustments are needed. Currently, there are no safety and efficacy data available from the use of this combination.

WHAT ARE THE SIDE EFFECTS OF VIRACEPT?

Like all medicines, VIRACEPT can cause side effects. Most of the side effects experienced with VIRACEPT have been mild to moderate. Diarrhea is the most common side effect in people taking VIRACEPT, and most adult patients had at least mild diarrhea at some point during treatment. In clinical studies, about 20% of patients receiving VIRACEPT 750 mg (three tablets) three times daily had four or more loose stools a day. In most cases, diarrhea can be controlled using antidiarrheal medicines, such as Imodium® A-D (loperamide) and others, which are available without a prescription.

Other side effects that occurred in 2% or more of patients receiving VIRACEPT include abdominal pain, asthenia, nausea, flatulence, and rash.

There were other side effects noted in clinical studies that occurred in less than 2% of patients receiving VIRACEPT. However, these side effects may have been due to other drugs that patients were taking or to the illness itself. Except for diarrhea, there were not many differences in side effects in patients who took VIRACEPT along with other drugs compared with those who took only the other drugs. For a complete list of side effects, ask your doctor, nurse, or pharmacist.

HOW SHOULD I TAKE VIRACEPT?

VIRACEPT is available only with your doctor's prescription. The light blue VIRACEPT Tablets should be taken three times a day. VIRACEPT should always be taken with a meal or a light snack. You do not have to take VIRACEPT exactly every 8 hours. Instead, you can take it at normal times when you are eating. Take VIRACEPT exactly as directed by your doctor. Do not increase or decrease any dose or the number of doses per day. Also, take this medicine for the exact period of time that your doctor has instructed. Do not stop taking VIRACEPT without first consulting with your doctor, even if you are feeling hetter.

Dosing in adults (including children 14 years of age and older)

The recommended adult dose of VIRACEPT is 750 mg (three tablets) taken three times a day. Each dose should be taken with a meal or light snack.

Dosing in children 2 through 13 years of age
The VIRACEPT dose in children depends on their weight. The recommended dose is 20 to 30 mg/kg (or
9 to 14 mg/pound) per dose, taken three times daily with a meal or light snack. This can be administered
either in tablet form or, in children unable to take tablets, as VIRACEPT Oral Powder.
Dose instructions will be provided by the child's doctor. The dose will be given three times daily using the
measuring scoop provided, a measuring teaspoon, or one or more tablets depending on the weight and
age of the child. The amount of oral powder or tablets to be given to a child is described in the chart below.

In measuring oral powder, the scoop or teaspoon should be level.

\* 1 level scoop contains 50 mg of VIRACEPT. Use only the scoop provided with your VIRACEPT bottle.

1 level teaspoon contains 200 mg of VIRACEPT. Note: A measuring teaspoon used for dispensing medication should be used for measuring VIRACEPT Oral Powder. Ask your pharmacist to make sure you have a medication dispensing teaspoon.

How should VIRACEPT Oral Pewder be prepared?

The oral powder may be mixed with a small amount of water, milk, formula, soy formula, soy milk, dietary supplements, or dairy foods such as pudding or ice cream. Once mixed, the entire amount must be taken to obtain the full dose.

be taken to obtain the full dose.

Do not mix the powder with any acidic food or juice, such as orange or grapefruit juice, apple juice, or apple sauce, because this may create a bitter taste.

Once the powder is mixed, it may be stored at room temperature or refrigerated for up to 6 hours. Do not heat the mixed dose once it has been prepared.

Do not add water to bottles of oral powder.

VIRACEPT powder is supplied with a scoop for measuring. For help in determining the exact dose of powder for your child, please ask your doctor, nurse, or pharmacist.

VIRACEPT Oral Powder contains aspartame, a low-calorie sweetener, and therefore should not be taken by children with phenylketonuria (PKU).

HOW SHOULD VIRACEPT BE STORED?

Keep VIRACEPT and all other medicines out of the reach of children. Keep bottle closed and store at room temperature (between 59°F and 86°F) away from sources of moisture such as a sink or other damp place. Heat and moisture may reduce the effectiveness of VIRACEPT.

Do not keep medicine that is out of date or that you no longer need. Be sure that if you throw any medicine away, it is out of the reach of children.

Discuss all questions about your health with your doctor. If you have questions about VIRACEPT or any other medication you are taking, ask your doctor, nurse, or pharmacist. You can also call 1.888.VIRACEPT (1.888.847.2237) toll free.

request but that she was able to secure a \$128,000 loan from a California company. Goffinet said that Dixon rejected the package because the lender insisted on holding \$30,000 in escrow to pay the IRS taxes from Mike and Anna's

But Griffin wanted to concentrate on loans that Dixon didn't get. He also asked Goffinet if she told then Milwaukee Police Detective Mike Fenning that the California loan was for a smaller amount and would have left Dixon with only \$20,000 for remodeling Fannies. Griffin bristled as he repeatedly asked Goffinet if she remembered telling Fenning details about Dixon's credit problems. Goffinet repeatedly denied the statements attributed to her. At one point she said, "Those figures don't add up." At another Goffinet said, "I don't talk that way. I would never had said that."

Outside the courtroom, Goffinet told WI Light "He made the whole thing up. "It was a fabrication." When asked why the Detective would do that, Goffinet replied "I don't think he likes Gays." When told of Goffinet's allegation, Fenwick said, "That's not true. Did she put that in writing? I could have fun with that."

Other witnesses were asked about the economics of operating Fannies. Two former employees said the business was going downhill at the time of the fire. One said she quit because of problems with the sound system. Murphy who also worked for Dixon said she thought business was "great." She also testified that Dixon told her about tax problems

prompting Griffin to sarcastically ask, "Why when she told you about her tax problems didn't you say, 'Gee Sharon how can that be, you are making money hand over fist?"

When Griffin asked Murphy (who Police found hiding in a closet to avoid a subpoena) why she was a reluctant witness, she responded, "Sharon is my friend. I didn't want to feel responsible if she was found guilty."

Some witnesses testified that Fannies needed to remodel. A few said the dance floor was buckling, others said the roof leaked. Murphy said she saw no problems other than a sagging ceiling over the dance floor. Griffin also asked several witnesses about Dixon's reaction to the opening of Dish, a Lesbian bar, which held its grand opening the weekend after the fire. All of them stated that Dixon was concerned about losing business in the short term but felt she would be fine in the end.

Griffin is also hammering away at what the State feels is suspicious behavior on the part of Dixon. Dixon failed to set the bar's alarm the night of the fire. Every Fanny employee called to the stand testified that Dixon was strict about security and neverfailed to set the alarm. Dixon says the alarm was disconnected. Several witnesses said that Dixon's truck was not parked in its usual spot in front of the bar on the night of the fire. Balfour said Dixon gave her a magnum of Don Perigon champagne before they left the bar for dinner.

Testimony showed that Johnson rented a locker and used Monica Balfour's name as the

contact person. Balfour testified that she had no knowledge of the locker rental. Murphy, who accompanied Johnson when she rented the locker, testified that she suggested using Balfour's name.

The prosecution contends that Dixon moved things from her residence above the bar and from the bar to the locker. It also says that Dixon moved some items like the champagne fountain and a karaoke machine from the bar the night of the fire.

The Defense responded that Dixon moved the Karaoke machine because it was broken. It contends that locker items came from Mike and Anna's or were minor items such as a broken speaker. Among the items found in the locker were Nagel prints, a speaker, a CD player, a box of unused checks, family photo albums and clothes.

Fenning testified that the items found in the locker did not have any smoke damage and must have been moved there before the fire. Balfour testified that she had seen a family photo album found in the locker in Dixon's apartment.

A Milwaukee Fire Fighter testified that he found two doors at Fannies were unlocked when his engine company arrived at the scene. He also said there was no sign of forced entry. Fenning testified that he found a set of 13 keys, identified by Dixon's as hers, lying in the center of bar floor. He also testified that the front door key and the key to Dixon's upstairs apartment were missing.

Fenning testified that he found Fannies insurance certificate and alarm contract on Dixon's bed after the fire. During cross-examination, Stewart asked Fenning if he had ever read the alarm company document. He then pointed out that the document was sent to Dixon's restaurant partner, Bob Chomlinski, which the document called "Vice-President and chef." "Did you think that Fannies, a Lesbian bar, had a chef," asked Stewart. "I don't know what they had," replied Fenning.

Dixon told investigators that she left her keys on the bar. Under cross-examination, Fenning admitted that water pressure from the fire hoses might have moved them from the bar to the floor. Other witnesses viewed photos of Dixon's apartment and noted items that were misplaced. Under cross-examination, they also said that water from the fire hoses could have accounted for the condition of the apartment.

On the drug charge, Fenning testified that he found 270 morphine tablets in a safe kept inside of Dixon's apartment. He stated that Dixon told him the pills were from her late mother and a friend who died from AIDS.

A verdict is expected by the end of the week

### Justice in Milwaukee Part -2

It is this writer's opinion that the vast majority of City of Milwaukee Police treat Gays and Lesbians with respect, professionalism and courtesy. As noted in the two incidents discussed in part one of our series, however, there still are questions concerning how some Milwaukee Police officers treat the Gay citizens they are paid to serve.

Problems with Police actions or inaction are not the only challenges facing Milwaukee Gays who are seeking justice. The Police are a very important part of the criminal justice system, but they can not bring about justice on their own. The other parts of the equation are found in the offices of the City and District Attorneys and in the courts.

A Long Wait

The first of these cases involves Corey Libemann and Robert Wendorf. WI Light has been following this case since October. The case arose out of an incident that took place more than a year ago. The Police apprehended the perpetrator of a vicious unprovoked attack on Wendorf, Libemann and others. Yet, the two men are still waiting for their day in

On December 4, 1998, Libemann and Wendorf were out for an evening of fun at La Cage. At closing time, along with other customers they milled about on the sidewalk outside of the club.

Suddenly a large man entered the group of about 15 people clustered around the bar's The man, Jason Anthony Mertens,

plunged into the crowd and shoved one of Wendorf's friends into a brick wall. When Wendorf reacted asking him why he was assaulting his friend, Mertens hit him in the ear with such force that he collapsed to the ground with a punctured eardrum.

Libemann asked Mertens "Why did you do that?" Mertens answered by hitting Libemann knocking his glasses off and breaking them, while yelling "Ill kill you faggot. I'll kill you

Wendorf and Libemann say that while Libemann summoned help from the Milwaukee Police, Mertens continued his verbal and physical assaults even taking swings at some of the women in the small crowd. Finally, Mertens walked back the way he came to rejoin his brother-in-law and left the scene.

When the Police report caught up to Mertens, his brother-in-law, Christopher Nelson, told them that he tried to stop Mertens from attacking the crowd. He also stated that he didn't know why Mertens launched his

The case was referred to the City Attorney. Wendorf's cousin said that because of his injuries the police should have presented the case to the District Attorney's office. The City Attorney's office told Libemann it couldn't explain why the case was not referred to the DA unless he could provide the name of the

Libemann told WI Light that he made numerous calls to the Second Police district station office to obtain that name. None were returned until after Alderman Jim Witowiak intervened

In the end though, Libemann and Wendorf went to a February 15, 1999 charging conference in the office of Assistant City Attorney Charles Theiss. Mertens is about 6'4", and about 240 pounds, Wendorf is about 5'5" and 140 pounds. Nevertheless, Mertens told Theiss that he felt "threatened" by Wendorf.

Theiss told Mertens that nothing he was saying matched up with the facts presented in the Police report. After asking Wendorf about his injuries, Theiss said he would refer the case to the District Attorney.

Over ten months later Libemann and Wendorf were still waiting for the DA to act. In September, Libemann called the DA's office to find out it would act on the charges against Mertens.. He found that the DA had no record of the case.

When Libemann called Theiss, he found the City Attorney's office also had no record of the case. Libemann, however, did have a record. After the charging conference he asked for and received copies of the paperwork. Theiss said that the records were lost and that he would try to find out where the problem was. Libemann wrote a letter to Theiss with copies to City Attorney Grant Langley, Mayor John Norquist and his Alderman Paul Henningsen. In it, he demanded a written response that detailed what action would be taken to prosecute the case. When the City Attorney's office did not respond, he contacted the FBI and the State Attorney General's office and asked them to investigate.

In mid October, his patience exhausted, Libemann contacted local TV stations and asked for help. WTMJ aired his story. A Milwaukee Police Internal Affairs Division supervisor saw the televised report. He ordered Detective Glen Zirgibel to investigate. While Zirgibel was at Wendorf's home conducting an interview, the District Attorney's attorney office called to say that the FBI was investigating the matter.


The FBI would later determine that the problems with prosecuting the case were not

On October 21, more than 10 months after the assault, Assistant District Attorney Douglas Simpson met with Wendorf and Libemann. After reviewing the reports and interviewing the victims, Simpson issued a summons for Mertens

According to Wisconsin's hate crime law those convicted of an offense motivate "in whole or in part" by the victims race, disability, national origin or sexual orientation can received increased penalties. Libemann asked Simpson to press a hate crime charge. Simpson said that hate crimes are difficult to prove. Libemann read Simpson the law. "He wasn't too happy that I brought it up," said Libemann

Mertens has two other incidences of violence on his record. One is an unprosecuted domestic violence complaint. In 1996, Mertens was convicted of pointing a gun at two people and threatening to kill them while trying to break into a house through a window.

Despite Mertens' history of violence, Simpson declined to press a hate crime charge. However, he did leave open the possibility of a hate crime charge. During Mertens preliminary hearing on charges of misdemeanor and felony battery, Simpson told Court Commissioner Audrey Brooks that Libemann had requested "a penalty enhancer." hearing transcript reads,

Simpson...Without being circumspective, we were asked to allege that it was a hate crime and that's still an issue to be resolved."

At the end of the hearing, Simpson told the court that he reserved the right to amend the complaint alleging the same offenses. In other words, Simpson told the Court that a hate crime charge might be coming.

In the end, Simpson didn't issue that charge. Mertens pled guilty to the battery charges. At his sentencing hearing before Judge John McCormick on February 10, Wendorf and Libemann will finally be able to tell a judge how Mertens' attack affected them.

Wendorf lost some of his hearing due to the attack. Libemann and Wendorf say they seldom go out to the Walker's Point area Gay bars. "You just feel so threatened when you go down there, said Wendorf.

Libemann remains angry over the delays in prosecution and the lack of a hate crime charge. "We were victimized a second time," he said.

Richard Voss, a Defense Attorney and a former prosecutor in the District Attorney's office, is a friend of Wendorf. He believes the DA should have pressed a hate crime charge.

He said that its likely Simpson used the threat of a hate crime charge to force a guilty plea from Mertens. Voss told WI Light, "It seems to be the custom of the DA's office to undercharge in order to get a plea bargain. It's been my experience that they raise the threat of a more serious charge in order to get a plea."

Voss added, "They weren't sensitive to the value of the hate crime law. They just treated it like a run of the mill case. It's a legitimate strategy if you believe in plea bargaining but it doesn't always provide full justice.'

The case raises serious issues and leaves questions unanswered. The Internal Affairs Division of the Milwaukee Police Department deserves credit for acting after Libemann went public with his story. But the Police referral of the case to the City Attorney's office was improper. Then there is the question of why an Alderman had to call the Second District station before anyone would return Libemann's calls

The criminal justice system is complex. Paperwork will be lost, but why were Libemann's pleas for a prosecution ignored?

Then there is the question of whether or not the DA should have used the hate crime statute to get a longer sentence handed down to a repeat offender. A WI Light check of available FBI Hate Crime statistic reports failed to turn up evidence that any Milwaukee County law enforcement agency reported an anti-Gay hate

WI Light attempted to find out how many hate crime charges have been prosecuted by the District Attorney's office since Wisconsin's hate crimes law was passed in 1989. Deputy DA Bob Donahue told Light "We don't have any statistics on that. We aren't required to keep them." District Attorney E. Michael McCann and Assistant DA Simpson did not return WI Light's calls.

"The irony of this is that where they have good hate crime laws, most prosecutors I have talked to view these laws as tools they should be using," said Jeff Montgomery, a nationally known expert on anti-LGBT violence. "In this case there are witnesses and multiple victims. Apparently someone believes that the sexual orientation aspect of the law is not important."

When told of Mertens past offenses Montgomery said, "A logic reading of this case would indicate that the DA would want to use everything possible to get this guy locked up because he's a perpetual offender. I think this DA should go to school and learn what his job should be. The law is there. It should be used, and not just as a bargaining chip."

Montgomery said that using hate crime laws 'sends a message" that bias related crimes won't be tolerated.

An FBI agent contacted by WI Light said that her office has worked with the Milwaukee County District Attorney on hate crime prosecutions, but none of those prosecutions were motivated by an anti-Gay bias.

"This comes back to your DA's office and what his problem is, said Montgomery. "The community should ask him if he does not think that Gay victims mean as much.'

That's a question Jacob Weinstein is asking.

### More Witnesses?

Weinstein says that on April 2, Zurie Dantrae Baker broke his nose during a melee at La Cage. He was a bartending at the club that evening. The fight broke out when a group of about 10 mostly heterosexual patrons began beating a customer who improperly touched a woman in their party.

Weinstein, who is completing work on a criminal justice degree said he managed to eject two of those engaged in the fight. When he came back in the bar, he saw La Cage security helping owner George Prentice up to his feet. "I asked them what I should do," said Weinstein. "They said, 'We have it under control. Just keep people away."

Weinstein says that when he turned to the crowd behind him to tell them to move back, Baker hit him in the nose breaking it. Baker fled the scene shortly thereafter.

A Darryl, a bar back at La Cage, witnessed the incident. "I was five feet away," said Darryl. "Dantrae reached around a woman and belted Jacob." Baker is a regular at the bar. "I must have served him at least 10 times," said Weinstein. "I knew who he was. I saw him

The Milwaukee Police did what they could to help track down Baker. The Sunday after the fight, they accompanied Weinstein on a tour of LGBT bars in an attempt to find Baker. "Dantrae normally would come to La Cage on Sunday," said Weinstein. "We thought we might find him at another bar." Although Baker eluded them that evening, the Police eventually found him. He was ordered to appear at the District Attorney's office on May

Assistant DA Dan Jackson asked Weinstein and Darryl to tell him their version of events. Both men identified Baker as the person who broke Weinstein's nose. "He didn't ask me any questions," Darryl told WI Light. "He just lis-

After talking to Baker and an unidentified person, Jackson told Weinstein that he would not issue any charges. "He said that Dantrae brought a witness who said that someone else hit me," said Weinstein. "He told me that I had to bring in more witnesses." Weinstein and Darryl say that Jackson never told them who Baker's witness was.

Weinstein said that he knows that others saw what happened. "I asked people, but no one would come forward. They are afraid of coming out," he said.

Voss told WI Light that the DA's office he hates to second-guess the call Jackson made. "A lot of times in a bar fight, they charge

everyone with disorderly conduct," he said. That may be the case, but in this instance, Weinstein wasn't involved. He was trying to keep others from becoming involved.

"Jacob wasn't doing nothing," said Darryl. "He was just standing there and Dantrae hit him. There was no provocation at all." Darryl is angry that the DA did not issue charges against Baker. "It makes me think that I could just go up and hit someone and then bring in a friend to say that I didn't and nothing will hap-

The Police did issue a disorderly conduct citation to Baker and to one of his friends. That ticket may not have related to the Weinstein incident. The ticket is a civil not a criminal offense. Baker failed to appear in Municipal court and a bench warrant was issued for his

The Weinstein incident is a case of the Police doing everything they could to bring someone they believe attacked a Gay man to justice. They could not do it alone, however. If the system failed Weinstein so did those Gays and Lesbians who saw the incident and refused to step forward

In Conclusion this writer feels that: Justice is not something that can be put on an assembly line and manufactured by the Police, the prosecutors and the courts. It requires citizens willing to make the system work.Corey Libemann, Bob Wendorf, Jacob Weinstein and a bar back named Darryl tried to make the system work. The Police aided them but their experience with the criminal justice system has left them angry. Some would argue that the problems they encountered were systemic ones and/or caused by bad judgements. Others will see them as evidence that Gays in Milwaukee are not treated equally.

No matter which side of the argument one takes, it is clear that there are problems in Milwaukee's criminal justice system. Solving those problems whether they are motivated by a lack of understanding, homophobia or gaps in the safety net that is supposed to protect all citizens equally won't be easy. It will take an engaged Gay community working in concert with others to ensure that justice in Milwaukee is swift, fair and consistent.

# Angela's Ashes

At the beginning of Angela's Ashes, a narrator states how miserable childhoods are more interesting than good ones. He goes on to say that Catholic childhoods are often quite miserable, but that the worst is the Irish Catholic childhood. He could have added that to be a Catholic child in Ireland during the 1930s and '40s was worse still. The remaining two hours of the film certainly prove the narrator's point.

Despite the omnipresence of the Catholic Church in the lives of the characters in *Angela's Ashes*, Protestants aren't their primary enemy. Instead, they face the oldest foes of humanity: poverty and hunger. While a good portion of the film shows its characters languishing in ever more demeaning spates of pain and misery, the movie as a whole turns out to be quietly triumphant; a testimony to the fortitude of the human spirit under the worst circumstances. It also never fails to find the humor of every situation.

Director Alan Parker (Evita) recreates a section of Limerick, Ireland where it rains incessantly and muddy puddles are everywhere. If "the Sun never sets on the British Empire," it never shines on poor little Limerick at all. Parker refused to romanticize any aspect of the setting. Instead, we witness a dirty, grimy world where chamber pots have to be emptied and cleanliness isn't next to godliness, it's

next to impossible.

Angela's Ashes is based on the bestselling memoirs of Frank McCourt, and as such is told from his perspective. It follows roughly ten years in Frank's life, from ages 6 to 16. He's played by three different actors (in chronological order): Joe Breen, Ciaran Owens, and Michael Legge. They are all capable performers, and their physical appearances are similar enough that the changes do not jar.

Apart from the actors playing Frank, Angela's Ashes also contains some excellently written and acted supporting performances. His father, Malachy (Robert Carlyle), is perpetually unemployed and a drunkard. His saving grace is that he remains a loving presence in his sons' lives. The film's title character is Frank's mother, played by Emily Watson. Her performance is quiet, subdued, and powerful. Angela loves her husband and children, and will do almost anything for them, including subjecting herself to the "worst kind of shame." While Frank doesn't idolize Malachy, he loves and respects him in spite of his failings.

Viewing Frank McCourt's life story as portrayed in the film Angela's Ashes makes for a very worthwhile experience. The story is consistently involving, so as you become entwined in Frank's life, you view each new struggle with ever-growing interest. Because of his courage and perseverance, he is a hero in the truest sense of the word. Frank is a real character with genuine failings and dreams. His one goal: to return to America, "where no one has bad teeth and every man has a lavatory." That description, which concentrates on simple details rather than grand ideas, points out what kind of person Frank McCourt is.

# **Liberty Heights**

Few will argue that director Barry Levinson is at his best when making small, personal movies. One needs only to compare a sampling of cinematic magic like Avalon to a bloated and unwieldy product like *Sphere* to see the difference. *Liberty Heights* is another genial, nostalgic drama with an autobiographical flavor. It also forms the fourth installment in Levinson's overstuffed "Baltimore Trilogy" (joining *Diner, Tin Men*, and *Avalon*). And, for those who are looking for a lower-key, intimate film during a season that is ripe with big, prestigious motion pictures, *Liberty Heights* may be the answer.

One of the more pleasant aspects of Liberty Heights is that it never strains our credulity or places us in an uncomfortable position. The film doesn't shy away from difficult issues, like racial and religious prejudice, but it plays up the absurdities of such bigotry without becoming heavyhanded.

For example, there's a scene in which a black and a Jew are discussing how their races are viewed by White America, and the conversation devolves into an argument about which group has been more oppressed. The moment could have been tense and angry, but Levinson keeps things light, resulting in a sequence that is genuinely funny, but, at the same time, makes a point.

The movie is also pragmatic in the way it depicts Jewish/non-Jewish relationships. Many things have changed in the last 45 years, not the least of which is how members of different races interact.

Today, a romance between a black girl and a Jewish boy wouldn't raise an eyebrow; in the '50s, it was scandalous. In fact, there was even an element of inequality in a friendship between a Jew and a non-Jew. Witness the condescension with which Trey (Justin Chambers) treats his "buddy", Van.

Liberty Heights adopts a predominantly playful tone. There are conflicts, but no real villains. Violence is kept to a minimum - there is a fight between school boys and a scene in which someone is kidnapped at gunpoint. In the latter case, however, there's no real sense of danger or menace. In fact, aspects of the kidnapping are played for laughs. To a certain extent, the entire movie is like that. Levinson effectively treads the line between comedy and drama, never venturing too deeply into either territory. As a result, the film is neither too serious nor too fatuous.

Levnison's use of lesser-known performers enables us to become immersed in the story without being distracted by too many familiar faces. The two most recognizable members of the cast, Bebe Neuwirth and Joe Mantegna, are both capable performers, but they are not cardcarrying representatives of Hollywood's "A-list." Their work here is effective. although there are times when Mantegna's baggage as a mafioso works against him. Orlando Jones is delightful as Little Melvin, a character who's more bark than bite. Adrien Brody (Summer of Sam) and Ben Foster do solid jobs as the leads, and they are ably supported by a roster of young character actors.

Liberty Heights is smart in the way it views the adolescent years. Most movies about high school romances like to pretend that a couple who kisses at the prom will live happily ever after. Of course, the reality is that most high school boyfriends and girlfriends do not get married - and that's a truth that Levinson effectively captures. Through Ben's voiceover, the director also observes that we remember certain key moments in life with a clarity that never diminishes, while more mundane memories fade into a fuzzy blur. Levinson may not have constructed this story specifically out of events from his own life, but the quality of the remembrances depicted here have an authentic

Liberty Heights is not a perfect film. The running time is a little on the long side, and there are a few slow spots during the movie's midsection. There are also some problems with the ending. Nate's subplot is resolved a little too neatly and there's a feeling of incompleteness surrounding Van's. (There seems to be a scene missing.) Only Ben's story achieves a fully satisfying sense of closure. Overall, however, the movie is so well developed and enjoyable that these flaws aren't as noticeable or intrusive as they might be in a lesser effort. Liberty Heights functions as a pleasant and worthy addition to a strong series of films.

# The Hurricane Displays Attention to Detail

To say that *The Hurricane* is the best boxing movie since 1980's *Raging Bull* isn't necessarily very high praise. After all, how many boxing movies have there been since then? Even if boxing isn't your cup of tea, this film isn't to be missed. Certainly not by those of you looking for a gripping, true story about personal triumph and tragedy.

The Hurricane is the story of Rubin "Hurricane" Carter (Denzel Washington), directed by Norman Jewison. Carter was a championship boxer from Paterson, New Jersey, who spent 19 years in prison for murders he didn't commit. The film not only involves itself Carter's successful boxing career, but also with the crimes and subsequent miscarriage of justice, resulting in Carter's surviving long, lonely years in prison.

The Hurricane follows the current trend toward non-linear storytelling, especially in its first half. It jumps around through time freely, but the editing is clean and sharp, keeping the potential for confusion to a minimum. Essentially, there are two primary time periods in Carter's life presented in the film. The first encompasses his rising stardom, roughly from 1963 to 1966, when he is arrested, tried for murder and incarcer-

ated at Trenton State Prison for life. The second time period occurs during the 1980s, when several people inspired by Carter's autobiography, "The 16th Round," become determined to free him. Their efforts turn *The Hurricane* into a story of victory rather than defeat.

Denzel Washington is excellent in the title role, giving his most powerful and effective performance since *Malcolm X*. Playing a boxer like Carter demanded a great deal of physicality and emotional range, and Washington is entirely convincing on both grounds. Supporting performances from the likes of Vicellous Shannon, Liev Schreiber, John Hannah, Deborah Unger, Dan Hedaya and Rod Steiger (in a small but crucial role) are all solid.

The Hurricane is a well-written, wonderfully acted drama about the power of the human spirit to overcome adversity. The fact that it remains true to actual events simply adds to its appeal. Jewison rigorously researched the movie before beginning work on it. It's apparent from the opening scene (a black-and-white recreation of the 1963 bout between Griffith and Carter) that a great deal of care and attention to detail went into *The Hurricane's* composition.

# **View from** the Bi Side

### **Valuing Diversity**

By Nikki Schlaishunt Recently I was blessed with a trip back to my hometown in rural Northern California. Small, conventional, conservative, and yet it was here that my value for diversity took root, sprouted and began to grow.

I spent time during my visit tracing this value and I discovered two main roots. The first was the city park, a long swath of wild land sprawled on either side of a rocky creek, half in the city itself and half winding miles up a valley carved out of the lava rock foothills. The second was my group of girlfriends. We were an eclectic, mixed lot who came together more because none of us fit anywhere else than because we had something in common, but we learned to appreciate and care for each other, differences and all.

I learned many things about diversity and how to actively value it during my youth. I've sorted these out into three core categories, which I will present here for your examination, rumination, and active adoption, if you

1. Question Assumptions: Every winter the creek would flood, and every summer the beaches and swimming holes would be changed. You had to discover the best spots all over again-you couldn't assume. When I first met my friends, I assumed they didn't want to invite me out to meet their horses, and they assumed I wasn't interested; we found we were both wrong. When I first heard the word bisexual, I immediately thought, "That's me!" But I assumed that married people, as I was and am, couldn't identify as bisexual.

I have found that unexamined assumptions, like the examples above, often end up leading me astray. Sometimes I dredge up an assumption from my dark subconscious into the light of day, and after questioning it, I decide I like my reasons for that assumption, so I keep it. But even the questioning rewards with the rich diversity of the examination process itself.

2. Challenge Your Boundaries: The park, full of large lava boulders and cliffs of various sizes, presented a challenge to my fear of heights. But I found that if I climbed a rock or cliff that was just a little bit higher than I was comfortable with, then I was able to slowly stretch myself and expand my limits. My friends and I used to play Deep Dark Secrets, a form of truth or dare, only the dare was to tell the truth. We challenged each other to talk honestly about taboo topics like sex and drugs, and to share our deeper selves.

Bisexuals come from many different backgrounds, have different points of view, and even have different definitions of "bisexual." Working with Bi Definition, I have been exposed to many things outside of my everyday comfort level, beyond my

everyday boundaries, but I have done so in the safety of a non-judgmental, supportive group. Within this group I have felt safe to take the time to learn about and appreciate this diversity. These are just a few of the ways I have challenged myself through the years. These rich experiences have helped me grow into a stronger, fuller and more appreciative person.

3. See With Different Eyes: In the past, I would walk in the park and ask myself, how does a squirrel see the world? What about a hawk? I realized the creek experiences the world and time in a very different manner than the hills or the trees. In times of trouble, I might ask, how would Jen deal with this irate customer? Or, what would Tammie do if a friend lied to her? Today, I challenge friends and family when they make heterocentric assumptions. I point out that not everyone looks at the world through straight, monogamous, white, middle class (etc., etc.) eyes.

Different viewpoints give rise to a variety of answers. More variety leads to expanded choices, greater flexibility and increased freedom. Of course, more freedom means more responsibility and complexity, but these, too, are part of the dividends of embracing diversity, part of the potent taste and texture of the ever-increasing intricacy of our lives.

The three core lessons I have outlined here continue even now to enhance my life. I try to bring them to my day-to-day reality in concrete, active ways. Some days this is easier said than done. In December I wrote about my period of darkness, and about leaping when faith was all I had, and faint faith at that. But I found, once again, that if I reach out to life-if I open myself up to the world-life always reaches back.

I am graced with a large circle of wonderfully diverse, supportive and caring friends both in my past and in my present. In diversity I have found joy, peace, harmony, beauty, strength, and fulfilling, enriching friendships. To me, this is both proof and reward for my faith in valuing diversity.







least, is the sexual excitement exhibited by the cast. In scene after scene it is quite obvious that these guys are really are into each other (in more ways than one).






