# Treated Like Criminals!


Milwaukee - Cory Liebmann and Bob Wendorf entered Judge John McCormick's courtroom on Thursday, February 10 expecting to ask the Judge to give Jason Mertens a stiff sentence. They left feeling victimized again. The physical assault they say Mertens inflicted on them has now been joined by verbal abuse from a group of Mertens' church supporters. Liebmann and Wendorf case, which has aroused considerable interest within Milwaukee's LGBT community, remains unresolved due to Mertens' surprise "Not guilty plea."

Liebmann and Wendorf expected Mertens to plead guilty to misdemeanor and felony battery. So did Assistant District Attorney Douglas Simpson, who told WI Light that Mertens attorney led him to believe that the defendant would plead guilty.

Mertens has his own expectations. He brought a group of family members, his pastor and "prayer warriors," who sat in the gallery calling out verses of scripture just across the aisle from where Liebmann and Wendorf sat. "I felt intimidated," said Wendorf. "It was a large group of people. We were the only two who were actually there as witnesses."

"They knew who we were," added Liebmann, a former Assembly of God pastor. "I felt that they were targeting their remarks against us. It was like they were saying just because they are straight they have cornered the market on spirituality and the Bible."

Simpson was surprised to learn of the court room activities when W1 Light called to ask for his reaction. "We will not tolerate this type of behavior in the courtroom," said Simpson. "Liebmann and Wendorf have told me, our



Victim Witness person or the bailiff."

Liebmann said that there was no opportunity to inform the DA's office. Glass windows and a locked door separate the gallery from the courtroom. "Mr. Simpson was late for court. He rushed right by us, went into the court room and closed the door behind him." he said. "No one from the Victim Witness Program was there."

Liebmann and Wendorf said they did their best to ignore the Mertens supporters. Nevertheless, the message the group was trying to convey came across. "They were saying they support him and would pray him into victory," said Liebmann. "It was like they didn't care what he did."

Wendorf and Liebmann say that because of the not guilty plea they are concerned that some of those who were attacked and/or who witnessed the attacks have not stepped forward. Wendorf said Mertens attacked him after he tried to help another victim, Steve, a young Asian man, who he said Mertens pushed into a brick wall. Steve later refused to press charges.

"He is always complaining about how justice is not being done for us and then he turns around and walks away when he could help us put a stop to one person attacking us because we are Gay," said Wendorf. WI Light Editor Nadine Walther said that like anyone who is victimized or who witnesses an Anti-Gay attack those with information about the incident may confidentially contact, WI Light at (414) 226-0075.


Liebmann and Wendorf say that Mertens attacked them and several others in a group of about 15 people who were milling about on the sidewalk outside of La Cage on December 4, 1998. Witnesses, including Mertens own brother in law, told Police that the attacks were



completely unprovoked. Mertens allegedly walked across Second Street into the crowd and began pushing and punching people while making homophobic remarks. Wendorf said that when he asked Mertens to stop, Mertens yelled, "I'll kill you too, faggot" before hitting him with enough force to puncture his left eardrum. Wendorf permanently lost some of his hearing in his left ear.

Simpson raised the possibility of pressing a hate crime charge during Mertens preliminary hearing last December. Observers felt that Simpson used the threat of a hate crime charge to elicit a plea bargain from Mertens. Simpson told WI Light that despite the not guilty plea, he would not issue a hate crime charge.

Liebmann and Wendorf are angry over Simpson's refusal to press a hate crime charge



against Mertens. That law provides for increased penalties when the targets of a crime are selected in part because of their race, religion, ancestry, ethnic origin or sexual orientation.

"He should issue the charge now," said Wendorf. "He was using it to get a guilty plea and now Mertens isn't pleading guilty. Even if he doesn't get the conviction, he can still raise the issue. Let the jury decide."

Liebmann agrees. "I would think if they were seriously concerned about anti-Gay violence they would prosecute this to the full extent of the law."

"I am disappointed in the criminal justice system," said Wendorf. "I feel like the victim more and more every time I go there." A trial date has been set for April 26.


#### Hate Crime Charges Not Pressed in Milwaukee

The lack of a hate crime charge in the case of Wisconsin versus Jason Mertens has again raised the issue of whether Milwaukee law enforcement officials take anti-Gay violence seriously. If the allegations against Mertens are true, they amount to what one anti-violence expert called "a textbook case of anti-Gay violence."

A WI Light check of FBI Hate Crime statistics and Wisconsin office of Justice Assistance records as far back as 1995 shows that the City of Milwaukee reports an average of three hate crimes a year. None of them were Gay related. The attack on Liebmann and Wendorf was not reported as a hate crime. Milwaukee is four times the size of Madison and is considered to be far more conservative. Yet, Madison reports an average of three anti-Gay hate crimes a year. Even conservative Brown County has successfully prosecuted an anti-Gay hate crime case.

The Milwaukee FBI office told WI Light that it has worked with the District Attorney on hate crime prosecutions, but none of them were related to anti-Gay bias. That led Jeff Montgomery, a nationally known Gay anti-violence expert to ask whether Milwaukee District Attorney E. Michael McCann doesn't like the hate crime law in general or is only against using it against Gay bashers.

That question is one that Cory Liebmann, Robert Wendorf and many members of Wisconsin's LGBT community would like to see answered. McCann did not return W1 Light calls.



#### British Debate Anti-Gay

London - British Prime Minister Tony Blair accused the opposition Tories of homophobia for opposing his efforts to allow homosexuality to be discussed in British classrooms. At issue is repeal of Section 28, a ban on the "promotion of homosexuality" by any local government. Section 28 was passed by former Prime Minister Margaret Thatcher's government.

Blair's Labor party and Great Britain's LGBT community are against the ban. Blair has proposed an outright repeal. The Conservative party is demanding that its members in Parliament vote against the repeal.

During a debate that to some extent mirrored American discussions about classroom lessons, Blair said the Tories are exploiting homophobia for political gain. "They're quite open about that," Blair said. "Those are the oppressions I intend to take on."

Tory leader William Hague responded that the debate was about "millions of parents in this country having the right to determine what their children are taught [and] whether the mainstream majority have the right to have their views and values respected."

Blair and his party maintain that Section 28 keeps English school teachers from addressing homophobia and bullying of LGBT students. It wants to issue guidelines on sex education in the schools.

Education Secretary David Blunkett said, "The guidance will ensure that teachers are in a position to offer information and support to all young people as they develop into adults and address incidents of homophobic

In order to get the repeal through, Blair has to convince parliament to pass his local government bill. He then has to convince the House of Lords to ratify it. Last week the House of Lords voted against the proposal by a margin of 203 to 165. Blair's government is now working to overturn that vote.

Conservatives demand that Blair come up with guidelines on what can be taught in the classroom instead of moving towards an outright repeal of Section 28.

Last year, the Lords turned down his attempt to set the age of consent for Gay sex at 16, which is the age of consent for heterosexual consent. Following that vote, Blair rammed through a bill that removed 90% of the unelected members of the Upper House.

On Monday, the House of Commons approved a new bill that again set the age of consent for Gay sex at 16. The vote was 262 to 102 in favor of the change.

Canada Debates **Couples Benefits** 

Ottawa - The province of Alberta has threatened to opt out of proposed changes in Canadian law that would give unmarried LGBT couples spousal rights that are equal to those enjoyed by unmarried common law couples. The Federal government plans to make 68 changes to Canadian law to bring into agreement with a Canadian High court decision that said the government must treat

all unmarried couples, Gay or straight, the

Unlike the United States, Canadian provinces are not bound by its High Court. The "not withstanding" clause of Canadian Charter allows individual provinces to pass legislation that voids the court's rulings within their borders.

The Alberta Premier Ralph Klein is warning that if the proposal pass Canada's parliament, his province will opt out of honoring them. "We would use the not-withstanding clause if at anytime Ottawa recognized samesex marriages. We believe we reflect the feelings of Albertans on this issue," said Klein.

The governments of several other provinces indicated a reluctance to go along with the ruling, but all of them except for Alberta have now agreed to do so.

#### Trans MP Makes Impression

Auckland, New Zealand - The world's first transsexual Member of Parliament (MP) gave her maiden speech to New Zealand's national Parliament on Wednesday February 9 and initial reports are that she was a hit. In fact, The New Zealand Herald said that if timing were a measure for office, Ms. Beyer would be Prime Minister.

"I was quoted once as saying this was the stallion that became a gelding and now she's a mare," Georgina Beyer, the Labour MP for Wairarapa, began. "I suppose I do have to say that I have now found myself to be a member. So I have come full circle, so to speak.

Her fellow MP's roared with laughter.

Beyer's debut in Parliament was not without its occasional barb. While some came to her speech as a way of offering support, others were there to show their contempt and ridicule.

Ms. Beyer made a point of mentioning National MP Wyatt Creech, who she defeated in the last election."We have had an amicable relationship," she said of Creech, "and I certainly hope that I shall do my best, as I'm sure he tried to do his best — his best has assisted me to where I am today. I say that in a loving way," she said to laughter and applause from other Labour members.

Bever promised to pursue issues of concern to gay, lesbian and transgender people, which she said were not so different from those everyone in New Zealand was concerned about - health, education, training and sound employment. "There are a few other niggly ones that are just a little unusual, and we are certainly going to be trying to inform you better."

Tough Rules Over Gay Adoptions

UK - Gay couples and single mothers will find it harder to adopt under Tory plans to radically reform the adoption sys-

A commission to identify ways of finding more adoptive homes for Children in care was announced yesterday by Dr Liam Fox, the shadow health secretary.

The inquiry, to be headed by David Davis, chairman of the House of Commons public accounts committee, will draw up standards for adoption that will apply throughout the country.

The new rules will put an end to

"politically correct" adoption criteria that have led to parents being rejected on the basis of their race, religion, class or weight. Under the Tory plans, a national register of couples who want to adopt will be drawn up to speed the adoption process.

Married couples in stable relationships will be regarded as the ideal adoptive parents under the new guidelines. Gay couples or single parents are likely to find it harder to adopt under the Conservative

Mr. Davis said:"The aim is to get the best possible adoptive parents for children regardless of ethnic origin. My opening presumption is that married couples are usually the most stable. The absence of marriage means that we have to test that the relationship's stable. I am not in favor of gav adoption."

All children in care homes will be put up for adoption under the plans, which will form one of the Conservatives' first legislative acts if they are elected. The Tory commission will take evidence from leading children's charities, including the NSPCC, as well as religious groups and social service departments involved in adoption.

The commission has been charged with drawing up a scheme of making sure that all children in care have contact with outside groups, including church organizations, families or charities, so that they can have access to "values other than those of

#### **Equal Rights Bid For** Gav Couples.

Scotland - Ministers are coming under increasing pressure to introduce legislation which gives homosexual couples the same rights as married men and women. Reports in Scotland's Sunday newspapers insist MSPs are concerned about the lack of harmony in the eyes of the law between same sex relationships and those who are mar-

This marks the latest in an on-going debate about homosexuals in Scottish soci-

Controversy is still raging over whether Section 28, which forbids the promotion of gay lifestyles in schools, should be repealed or left alone.

The Scottish Executive and a majority of Ministry Officials want to see it go, but they have been facing fierce opposition from Keep the Clause Campaigners, led by Scots businessman Brian Souter, who believe in the status quo.

It is understood that giving equal rights to gay couples could be incorporated into the Incapable Adults Bill being debated by the Scottish Parliament.

The legislation is aiming for the "nearest relative" of anyone who becomes incapable of taking decisions for themselves to be allowed new rights.

And the Equal Opportunities Committee is determined that the definition of "nearest relative" should not discriminate against same sex partners.

If the move is successful then it will be the first time in Britain gay relationships have been afforded legal recognition. It is felt that would set a precedent and then spark change in the rest of the UK.

#### School District Reacts to Proposed Gay Group

Modena, CA - The Orange School District thinks it has an answer for the federal judge who ruled that it can't ban a Gay / Straight student alliance: a series of restrictive rules on student clubs. Late last week, the District banned middle and elementary school clubs that aren't directly related to class room studies. This week it is expected to require that non-curriculum related High School related clubs operate under a new set of rules. Among the rules being considered are requiring a C average, parental permission for students who participate in the clubs and a ban on discussions of sexual activity.

The ban on non-curriculum related middle and elementary school clubs was instituted so the Board would have the ability to refuse recognition to any Gay related organization in those schools. The new rules for High School clubs are intended to restrict access to the Gay/Straight alliance.

Late last year, the School Board refused to allow a Gay/Straight alliance of students and teachers from meeting on its property. That decision resulted in a federal court suit filed by the ACLU and People for the American Way. Previous Federal court rulings have prohibited schools from banning student clubs unless they can show that the clubs are disruptive or harm students.

The group held its first meeting at El Modena High School last week after Federal Judge David Carter issued a preliminary injunction ordering the School District to allow it to use school property. The meeting marred by protestors some of whom came from other states and violence.

Attorneys for the Gay group denounced the Board's actions. "The school board has never expressed any concern whether heterosexuals were discussing sex," said Attorney Judith Schaeffer, Deputy Legal Director of People for the American Way. Peter Eliasburg of the ACLU said that the Federal court may take a dim view of the Board's actions and see them as "an end around" its decision. There was no word on whether the Orange School Board's latest moves would wind up in court.

#### **Methodists Dismiss** Case Against Defiant Ministers

Sacramento - A United Methodist Church Investigative Committee dismissed a complaint against 68 ministers who defied church policy by officiating at a Lesbian couple's holy union last year. Bishop Melvin G. Talbert of the California- Nevada Conference announced the decision on Friday February 11. The ministers could have been defrocked if the matter would have reached a church trial.

Methodist conservatives denounced the decision not to move ahead against the ministers. James V. Heidiner II, a Methodist evangelical, who publishes Good News an evangelic publication called the committee ruling "an arrogant disregard for the order and discipline

Last year, Rev. Jimmy Creech was stripped of his ministerial credentials when he was convicted of officiating at a holy union for two

North Carolina men. The Methodist Church officially prohibits its ministers from officiating at same-sex weddings, a policy that was upheld by its highest court last August. However, under church rules, each district is able to decide who is fit to stand in the pulpit. That leaves the denomination with the problem of some districts allowing its ministers to participate in holy unions for Gay couples while others refuse to allow them to do

The announcement sends a message to gays and lesbians that there are people in the church who are open to accepting them as brothers and sisters," said Rev. Don Fado of St. Mark's United Methodist Church. Fado organized the ceremony. Ellie Charlton, who was one of the two women whose union Fado and the other ministers had blessed, joined him at a news conference."A lot of gay people have left the church over the years," she said. "Hopefully now some of them will come

#### **Episcopal Church Says** Maybe

New York - An Episcopal Church Commission declined to issue a ruling on whether priests can preside over same sex weddings. The commission which was convened to advise the church on the issue said it favored the current unofficial policy that leave the decision up to the individual dioceses.

We are not ready, theologically or scientifically, to say a defining word about the life of homosexuals in the church," said the Standing Commission on Liturgy and Music, whose recommendations will be discussed at the church's national convention in July. "In the context of reverence - and humility - it seems best not to take absolutist positions on a national level," the report says.

The issue of same-sex marriage is a divisive one for the Episcopal church and other denominations. Church conservatives have threatened to leave the American Episcopal Church over the issue.

Milwaukee's Episcopal Bishop RogerWhite disputed the significance of the report. He told WI Light "This is just a small committee report. It is a committee that deals with musical litugry in the church. The general convention meets in July. This recommendation may not even get on the floor of the general convention. Therefore it has no impact on the church or the diocese as of yet. The diocese does not make decisions on their own ever. They follow what the national church decides. The national church must make this

Bishop White added, "Our diocese does not talk about Gay marriages." He is neither opposed or for same sex marriage as of yet. "As a bishop I must uphold what the church teaches. The church has not made a decision on it. When the church makes a decision on it that will be my position."

White also said that he will not meet with Bishop John Shelby Spong, an ardent advocate of Gay marriage and LGBT inclusion in the church when he visits Milwaukee this weekend. Spong has performed holy unions for LGBT couples and has ordained openly Gay and Lesbian priests.

WI Light sources report that holy union blessings for same sex couples are being performed in Milwaukee area Episcopal church-

#### **HRC Endorses Gore**

Washington, DC - The Human Rights Campaign endorsed Vice-President Al Gore's bid to succeed his boss, President Bill Clinton. The endorsement, which is expected to help Gore in two key March 7 primaries in New York and California included a pointed slap at his challenger for the Democratic nomination, former New Jersey Senator, Bill Bradley.

"We feel that Senator Bradley's words of late have been very uplifting and quite inspiring. However, the vice president has toiled at our side through one issue after another over the last seven years," said HRC executive director Elizabeth Birch. "Senator Bradley didn't start speaking out on these issues until he started running for President. At the end of the day, that's late in the game."

Birch appeared with Judy Shepard, mother of Matthew Shepard and California Governor Gray Davis at a press conference called to announce the group's decision. The 40 member HRC Board voted unanimously to throw the organization's support behind the Vice-President.

The announcement seemed timed to give Gore a boost in the March 7th primaries. Analysts say that Gays and Lesbians may provide up to 10% of the vote in New York and California. Bradley has campaign hard to make inroads into the LGBT community, but his vote for the Defense of Marriage Act and Gore's equally strong public statements on behalf of LGBT civil rights have hampered his efforts.

The two Democrats are the only major Presidential candidates to state that they support federal hate crime legislation and ENDA, a proposed federal law that is aimed at ending job discrimination against Gays and Lesbians.

#### Vermont Republicans Want Court Impeachment

Montpelier VT - The House Judiciary Committee voted to draft a bill that would provide a domestic partnership system granting LGBT couples marriage like benefits. The committee vote came in response to last year's Vermont Supreme Court decision directing the legislature to either allow samesex marriages or to provide LGBT couples with the same legal standing as that enjoyed by heterosexual married couples. The court ruled that a ban on Gay marriage violates the State constitutional guarantee of equal benefits for all of its citizens.

The 7 to 3 vote came after a spirited debate over whether the legislature should allow same-sex couples to marry. Committee chairman Thomas Little said the systems would be "different than and broader than" domestic partnership plans that have been discussed. "It is clear to me that the will of the committee is to initiate and work on a civil rights bill," said Little.

Referring to the chances of getting approval for same-sex marriages Little said, "Leadership untempered by careful assessment of the world we live in is not sound leadership. What is achievable in this General Assembly and this body politic this year is a broad civil rights bill and, speaking for myself, that does not cross the threshold of marriage."

Rep. Steve Hingtgen said the issue is a moral not a political one. "Full inclusion of Gay and Lesbian Vermonters in our state marriage statutes is the courageous, moral and timely thing to do," he said Hingtgen said that by not approving Gay marriage the Committee would be giving into the radical right.

"For all those who have come before this committee preaching hate in all its poor disguises, whether with a Bible, a law degree or Ph.D. in hand, those who have filled our ears with hate, they will not be sent a message of rebuke by this committee by us choosing domestic partnership," Hingtgen said. "The hateful will have been strengthened by our decision. Pursuing the domestic partnership path validates the hate," he said. "It does more than validate it. It institutionalizes the bigotry and affirmatively creates an apartheid system of family recognition in Vermont."

Governor Howard Dean praised the Committee's decision and vowed to help sell it to the people of Vermont. In a signal that Dean and others will try to sell the idea to Gays who want nothing short of same sex marriage, Dean said, "I am going to encourage the people of this state to support a broad civil rights bill. I am going to encourage the Legislature to pass a broad civil rights bill, and I am going to ask them to pass it this year." Vermont already has a comprehensive LGBT civil rights law on the books.

Same-sex marriage advocates are vowing to challenge the legislation. They argue that a Domestic partnership system is not equal to marriage since unlike marriage the benefits it provides can't be transferred outside of the state.

Meanwhile a dozen Republican legislators signed onto a resolution to impeach the Vermont Supremes over its decision on Gay marriages. The resolution also calls on the legislature to ignore that decision.

#### Anti-Gay Preacher Gets 40 Year Sentence

Amerson, IN - Earl Kimmerling, an evangelical minister who successfully fought an attempt challenged a Gay man's attempt to adopt a child he was caring for as a foster parent, was sentenced to 40 years in prison for molesting the girl.

Kimmerling achieved statewide noteriety during his 1998 fight to keep Craig Anderson Amerson, a Gay man, from adopting the nine-year old girl. Anderson had already adopted her three brothers. As a result of the Kimmerlings fight a Republican legislator introduced an anti-Gay adoption bill. The bill, which was passed by the State Assembly died in the State Senate.

Eventually the Kimmerlings were allowed to adopt the child themselves. However, after the adoption, Kimmerling's wife Sandra learned of the molestation and went to the police.

During his sentencing hearing, Kimmerling – who pled guilty to four counts of child molestation – begged the court for mercy. The prosecution asked for the maximum 50 year sentence. Prosecutor Rodney Cummings told the court. "It's hypocrisy at its highest level. He holds himself out to be a person of God, as a representative of the Christian community, and at the same time engaging in this outrageous behavior."

The girl remains under the care of Sandra Kimmerling.



#### Milwaukee Cyclist Will Ride 3,700 Miles

Milwaukee - Jeffery Kennedy, a 23-yearold Milwaukee cyclist, recently announced his plan to bicycle across the United States and raise \$100,000 for AIDS programs and services. Kennedy, who will ride in the Cross Country Challenge 2000 with the America By Bicycle touring company, will donate the proceeds of his ride to three organizations that sponsor AIDS programs, including the AIDS Resource Center of Wisconsin.

"After losing a friend to AIDS on April 19, 1998, I decided to commit the next four years of my life to raise money for AIDS organizations," said Kennedy.

ARCW, will receive 40 percent of Kennedy's earnings. Two other Milwaukee organizations to benefit from Kennedy's quest are Camp Heartland, a summer camp for young people with HIV, and the BESTD Clinic, a community-based STD clinic.

Kennedy explains that his motivation for such an undertaking is rooted in a personal encounter he had with AIDS two years ago.

In preparation for his trip, Kennedy has begun indoor training and hopes to be outdoors on his bike in April. In addition, he will begin his fund raising efforts at his current place of employment, Robert W. Baird Co. Inc., of Milwaukee in early February.

"I hope to make history as being an individual that will change the form of fundraising by devoting this period of my life to benefit AIDS program, services and research," he said.

#### Justice in Milwaukee The Conclusion, but not the End **Analysis By Bill Meunier**

Milwaukee - We are a self-policing people. Our police, judges and prosecutors come from our general society. That is as it should be. The down side of that is that some of those charged with protecting us, prosecuting those who hurt us and judging those who are prosecuted carry with them the same anti-LGBT prejudices and stereotypes seen in society as a whole.

Most Gays believe that the problem of anti-Gay actions within the justice system is nowhere near what it once was. Nevertheless as the four incidents detailed in this series indicates to some Gays and Lesbians, there is still some distance to go.

#### Police Training

Efforts are underway to lessen that distance. Members of Milwaukee's LGBT community train Police academy recruits. The training includes a discussion of the Gay community, a question and answer session and the showing of two videos. One of the videos ( made by a Dallas LGBT organization) shows a broad cross section of the LGBT community. It is intended to attack stereotypes about Gays.

The other video is taken from TV newsmagazine. It shows an Houston, Texas undercover operation launched in response to Gay bashings in a Gay neighborhood. "It's hard even for me to watch," said Stephanie Hume, a local activist who works with the Police on LGBT issues. Hume said the video shows Police who are fearful of the bashers.

Hume says that the Police are working with an ad hoc group of activists to expand training on LGBT issues. That group, which is composed of representatives from seven organizations, is expecting to prepare an in service training component that would be part of the MPD's required in service training that all officers must

She has other ideas as well, "They need to do some awareness that targets our community," said Hume. She believes the Department should put together outreach programs that are similar to the one it uses to teach women's safe-

#### Official Silence

There are other ideas too. In some cities, police department crime reports include a space to note the possibility that a crime may have been bias related. Milwaukee is not one of those cities. Anti-hate crime activists say these boxes make law enforcement officials more aware of the problem and encourages documentation

Documentation, or the lack of it is an issue. The Liebmann - Wendorf incident seems to be a text book example of a hate crime. Yet investigating officers did not see it that way. How the Police view a crime can be an important factor in determining charges said Richard Voss a former Assistant District Attorney. Voss says that a Police statement to that a crime was motivated by hate, is much more likely to elicit a hate crimes charge.

It seems unlikely that such statements are being made. WI Light checked the FBI hate crime statistics reports back to 1995. The reports show that the City of Milwaukee reported an average of three hate crimes a year, none of them motivated by anti-Gav bias.

Over the years, this newspaper has received many reports of Gay bashings. Some were not reported to the Police but many were. The lack of anti-Gay hate crime reports is disturbing to many. As one activist put said "It's almost as if the Police think that when the bashers beat someone senseless while calling them 'faggot' they were really just angry about the guy's shoes." Madison reports around three anti-Gay hate crimes a year. Many may find it difficult to believe that Madison, a bastion of liberalism known for its tolerance has more hate crimes than Milwaukee, a city that is four times its size.

The Milwaukee County District Attorney's office does not keep records of hate crime prosecutions. That means there is no way to determine whether or not even those few non Gay related hate crimes reported by the Police are prosecuted to the full extent of the law.

The result of the official silence on anti-Gay violence is that little is known about the extent of the problem. It's hard to see how the problem can be addressed without sufficient information on its extent. Gays and Lesbians are not the only victims of hate crimes. Ethnic, racial and religious minorities are also targeted. It may be time to for the LGBT community to work in coalition with other groups and seek ways to document the seriousness of the problem and ways to lessen it.

#### The Fire and Police Commission

In some cities, the Fire and Police commission use a mix of citizens, staff and commissioners investigate complaints. In Milwaukee all citizen complaints about the Police are investigated by one of the Commission's employees, David Heard. Heard is also in charge of Police and Fire recruitment.

He told WT Light that most of the complaints are handled on an informal basis over the phone. Heard said that for every one of the approximately 100 written complaints filed with the commission there are six or seven that are handled on an informal basis. He indicated that the vast majority of these are not serious matters. They include everything from getting a parking ticket to concerns about an officer's

Heard said that he tries to resolve many of the formal complaints through a mediation meeting. Officers are given a chance to apologize to their accusers if it is appropriate. An knowledgeable source, who was associated with the Commission, said that if the accused officers fail to cooperate the Commission has little recourse other than launching a formal investigation, which can be time consuming and costly. With only one staff person to investigate Police abuse, it can also be impractical. Formal investigations are reserved for the most serious of offenses.

A Fire and Police Commission outreach effort to the LGBT community may be needed. Conversations with LGBT bar owners makes it clear that there is a perception that the Commission will do nothing to discipline officers who act in a homophobic manner. Several bar owners will speak off the record about Police actions that may warrant a formal complaint. None of them filed one. While some said they were afraid of Police retaliation, others said it wouldn't matter because "nothing would be done about it anyway" or because of the time involved in completing the process.

#### The Prosecutors

Calls to Milwaukee County District Attorney E. Michael McCann were not returned. McCann is generally considered a liberal on many issues but he is rumored to be anti- Gay. Sources within the DA's office and former prosecutors say that McCann believes Wisconsin's hate crimes law to be a bad one. That law was upheld by the US Supreme Court in 1996.

Even conservative Brown County can point to a successful anti-Gay hate crime conviction. Milwaukee with a much larger Gay population can not.

Mark Liberann and Bob Wendorf think that the system does not take anti-Gay hate crimes seriously. Libemann had to go on TV to get action on his complaint after dozens of phone calls, letters and appeals for help made to various officials went unanswered. Should the charges against the man Liebmann and Wendorf say attacked them, include a hate crime charge?

Some experts like anti-violence authority Jeff Montgomery say that prosecuting a hate crime charge sends a message that anti-Gay violence won't be tolerated. That's a message that Montgomery believes needs to be heard not only by Gay bashers but by the Gay community as well.

One of those who would like to hear it is Jacob Weinstein the bartender who suffered a broken nose. He identified his attacker and brought a witness who also identified the man who punched him. No charges were filed by Assistant DA Dan Jackson, who demanded additional witnesses.

Jackson told WI Light that he didn't think he could prove the case beyond a reasonable doubt. Perhaps he should have tried. Dantrae Baker, then man Weinstein and his witness say attacked him, has been implicated in another attack. The second attack occurred at 219. Baker is reported to be Gay himself. Nonetheless, some people feel that the DA should have prosecuted a defendant accused of causing serious harm in an incident that received a high profile within a community that feels physical violence against it is not always being taken seriously.

#### A Call for Action

Hume and others think that the LGBT community can help assure that justice is done for its members. Many anti-LGBT hate crimes go unreported. There is historical mistrust of the Police even among LGBT leaders. David Heard,

a Fire and Police Commission staff member says that when the Commission asked minority leaders for their opinion of Police services, only the Gay community failed to respond. An FBI agent told W1 Light that a similar survey conducted by its office also met with no response.

Anti-violence advocates say that many bashers count on Gay victims to keep quiet. Many of them do. Failure to report a crime not only allows the bashers to go unpunished, it also allows them to attack others. The Police can't react to crimes they do not know exist.

Cities that have anti-LGBT violence projects report dramatic increases in the number of reported Gay bashings and crimes committed against Gays. Hume says that such a project is needed here. She believes that it could perform a variety of tasks. They include making the LGBT community aware of how to use the services provided by the Police, providing advocates who can assist with reporting crimes and filing complaints when those services are not delivered properly. It could also help follow up on those complaints.

Following up on complaints can be critical. According to some of those who were associated it, the Fire and Police Commission processes are not adequate. In the case of Mark Knickelbine, his complaint about a nearly nine hour wait for a Police response to his call for help remains unresolved seven months after he filed it. Five months ago, the Commission asked Police Chief Jones to look into the matter. They are still waiting for a response.

So are others who are asking the question of whether or not Gays in Milwaukee can consistently expect justice. Knickelbine wonders why it took the Police so long to respond. Cory Liebmann and Robert Wendorf wonder why their attacker is not being charged under Wisconsin's hate crimes law. Jacob Weinstein asks why no charges were pressed against the man, who he says broke his nose. The owners and staff at 219 and La Cage ask when someone will apologize for the Police raids on their bars.

The four incidents examined in this series point to concerns over how Milwaukee's LGBT citizens are treated by the Police and the prosecutors. The concerns raised by these incidents did not begin with this series nor will they end

Just like any other newspaper, this one can raise an issue but it is up to the community as a whole to develop ways to that will lessen the problem. The question is not only whether Milwaukee's LGBT citizens can consistently expect justice, it's also whether what will they will do to make sure that they get it.

#### No Matter the Act, Unprotected Sex is Dangerous

Oral Sex Traced to HIV Infections

ver 3,500 AIDS Researchers gathered in San Francisco early this month for the 7th annual Conference on Retroviruses and Opportunistic Infections, heard both good and bad news on the AIDS front.

One of the most striking presentations is that oral sex is a higher risk activity then previously thought. That warning came from the largest study to date by the Centers for Disease Control and Prevention.

Many Gay men embraced oral sex as a low risk activity, yet at least 8% of them contracted HIV even though oral sex was their only risk behavior, according to the study. Many Gay men had made oral sex their primary or sole sexual activity because earlier studies had proven anal sex was an extremely high-risk activity.

The study has a devastating affect on prevention activities causing a restructuring of safer sex messages and education. AIDS outreach educators now must emphasize that oral sex, previously taught as low risk, does not mean no risk.

The study contains more reliable information than was previously available thanks to sophisticated DNA testing that identifies very recent HIV infections. Those tests enabled researchers to selectively interview the men and get more accurate, recent reports of sexual activity.

102 Gay or Bi men were in the study, and eight (7.8%) were determined to have been infected through oral sexual activity. Researchers cautioned that while the risk of transmission for each individual oral sex act may be low, if oral sex is the sole sexual activity that person participates in, the frequency of the act increases, along with the chance to be infected. Another words, it increases the cumulative risk.

#### AIDS Traced to 1930

At last year's AIDS conference, the genetic evidence linking chimps to HIV was established, and since then researchers developed the most sophisticated computer and data analysis capabilities to trace viral evolution. Computers analyzed DNA from more than 100 early human strains of HIV and various strains of SIV, the primate version of HIV.

Their study showed that the main HIV strain (there are about a dozen today) began to spread in humans around 1930. That date also marks the point in time where humans started to spread HIV and it started to mutate, as it continues to mutate today.

Somehow - perhaps through a bite from a subspecies of chimpanzee found in a specific area of the Congo, or by consuming its meat - the oldest known case of AIDS was confirmed in a blood sample taken from a man in the Belgian Congo, in 1959. The first American documented was a 15 year old boy in St. Louis.

#### CD4 Counts Always Drop

One study concluded that while CD4+ cell decline is delayed in patients experiencing failure of a Protease Inhibitor-based regimen and is slower compared with patients receiving only antiretroviral therapy, it will eventually occur at a median time of about 36 months.

The take-home message here is that while "tight" control of HIV at undetectable levels may not always be feasible with available anti-retroviral agents (or even necessary in the short-term), patients cannot be maintained indefinitely on failing regimens. The strategy of "loose" control (maintaining HIV RNA at a detectable level) should best be looked upon as a temporizing measure until more effective or better-tolerated agents become available.

This data makes it clear that the effectiveness of currently available anti-retrovirals remains inadequate and that novel pharmacologic and/or immune-based approaches to HIV treatment are needed.

#### Do PIs Cause Sexual Dysfunction?

A recent case series described 14 men who complained of erectile dysfunction after starting Protease Inhibitors (PI's) plus NRTIs (nukes). To investigate this further, a study at Harvard followed 274 males who started PI therapy. After a median follow-up of 1.6 years, 90 of these men (33%) had sexual dysfunction. Depression was significantly associated with impotence; however, after adjusting for age and depression, men were 3.4 times as likely to experience impotence after using the PI.

The investigaters point out that there are a number of potential confounds in this study, including the fact that overall disease severity could have increased over time. More important, Viagra was approved during the post-PI observation period, which might have prompted men to seek evaluation for erectile dysfunction in order to gain access to this drug. In light of these possible confounding variables, the possible role of PIs in sexual dysfunction in men must be considered as yet unproven.

#### Post-exposure Treatment

A San Francisco study enrolled participants who reported either sexual HIV exposure (receptive or insertive anal or vaginal intercourse, or receptive oral intercourse with exposure to semen) or exposure from injection drug use within the past 72 hours.

In addition to counseling and testing, all participants were offered 4 weeks of anti-retroviral therapy (most often AZT/3TC) and were followed for 1 year. During 16 months, 401 persons were enrolled. The vast majority (94%) reported sexual exposure, with 40% reporting unprotected anal receptive sex. The majority had not used condoms, although about one third reported that a condom was used but failed. Nearly half reported that they knew their partner was HIV-infected.

There were no seroconversions reported in this study by the end of 1 year. All except 5 took anti-retrovirals, and 80% reported they completed the 4-week course despite the typical adverse effects associated with anti-retroviral therapy. Nearly 70% remained in follow-up for the entire 12-month period.

While there were no seroconversions, because everyone received the same intervention it remains unclear to what extent this study provides a model for how care should be provided. It may, however, be reasonable to continue the practice of offering antiretrovirals to those with a high-risk exposure, given the lack

of transmission observed in those who were treated. In the absence of a control group who were untreated, however, this recommendation can only be made tentatively.

#### Attitudes About Risk-Taking

Researchers at the CDC surveyed nearly 2000 HIV-negative people to assess their attitude about maintaining safer sex or safer injection-drug-use practices, given the successes in treatment achieved in the past few years.

Participants were surveyed in 7 states in the US, with about 300 per state. Just under 700 were men who have sex with men (MSM) recruited in gay bars. (This is the group this article will highlight.) The men provided informed consent for the survey.

About 25% of Men who have Sex with MEN (MSM) reported being less concerned overall. That is lower than in Injection Drug Users IDUs (40%), or with either HETs (30%). Compared with other races, African-American IDUs or HETs were statistically significantly more likely to report less concern about HIV infection, but this relationship was not seen among African-American MSM.

A major finding of this study concerned the relationship between reported attitude to HIV and reported risk behavior. There was concordance between attitude and behavior among MSM: 71% of those who were less concerned about HIV reported receptive anal intercourse, compared with 43% of those who reported they did not feel less concerned. In contrast, there was no reported change in behavior among IDUs and HETs despite attitudes about being "less safe."

#### Immune Reconstitution

Potent antiretroviral therapy has clearly improved immunity in patients with HIV infection, although the degree and completeness to which immune reconstitution occurs varies among individuals based on the patient's age, genetic makeup, duration of HIV infection, baseline CD4+ cell count, baseline viral load, and the effectiveness and durability of the antiretroviral treatment. Results of studies presented at the conference expanded our knowledge of the process and predictors of immune reconstitution in patients with HIV infection and presented new and updated information on several approaches to immunotherapy in patients on effective antiretroviral therapy.

- Not all patients with chronic HIV infection who are treated with HAART have good immune reconstitution. That suggests that poor thymic response, as reflected in a relative depletion of naive CD4+ cells, may underlie the failure in some patients to restore CD4+ T cells after effective HAART therapy.
- · Structured Treatment Interruption (STI): One of the hottest topics in anti-retroviral therapy today among both patients and physicians is structured treatment interruption (STI), sometimes referred to as "drug holidays." With effective HAART, HIV-specific cell-mediated immunity may actually decrease due to the lack of exposure to HIV antigen. This approach may be useful in acute primary HIV infection after HAART therapy where the patient with chronic HIV may offer some degree of immune reconstitution with HAART. STI may also be useful for patients with multidrug-resistant HIV where stopping therapy may allow emergence of wild-type virus and permit use of

recycled anti-retroviral drugs to suppress virus replication.

Like everything else in HIV medicine, initially promising and even unpromising results need to be confirmed in larger, prospective, randomized controlled studies, stratified by possible important confounding factors, before the question of STI, "to stop or not to stop," can be adequately answered.

#### Clinical Implications

The clinical implications of metabolic toxicities, which include osteoporosis and bone loss in addition to lipodystrophy (abnormal fatty accumulations) include the possibilities that more therapies will be needed to counteract the effects of lipodystrophy, patient behavior may need to change (eg, exercise and diet), drug therapy may need to be changed, or medications will need to be discontinued.

Implications for the future include reassessing the goals of therapy, when to start therapy, what drugs to use initially, and when to change therapy.

The goal of therapy up until recently had been maximal suppression of viral replication. This approach reached its zenith at a previous AIDS conference, where eradication was positioned as a realistic treatment outcome. Eradication, however, is no longer a reasonable goal of therapy.

The goal of therapy in HIV infection in the 21st century may be the same as in all diseases: promotion of a long and healthy life.

It is now suggested that perhaps the only absolute indications for therapy are constitutional symptoms or CD4+ counts less than 200 cells/mm, or an opportunistic infection. Other criteria, such as those based on plasma HIV RNA contents, are arbitrary. It should be emphasized that no conclusion can be reached about this question. In fact, further studies could show that early onset of therapy is beneficial. Treatment at or near scroconversion may be important, irrespective of CD4+ lymphocyte count, as early treatment may preserve anti-HIV immunity, and could set the stage for more successful structured treatment interruptions. But "early," as such, remains to be clearly (and practicably) defined.

The idea of intermittent therapy as a strategy to prolong treatment effectiveness. Since discontinuation of suppressive therapy leads to recurrence of wild-type virus that usually retains its sensitivity to anti-retroviral agents, treatment periods designed to keep CD4+ lymphocyte counts above a safe threshold is a strategy worthy of consideration. It must be stressed that the benefits of these strategies are speculative and are not without their risk. The real-world consequences of intermittent therapy and/or discontinuation of suppressive therapy will need to be tested in appropriate trials before widespread clinical application.

It is a measure of our maturation in treating this disease that we can discuss these propositions. It also is a sign of progress to be able to take the long view and think of strategies that are in keeping with normal life spans for Persons With AIDS.

Attention PWA's Taking Indinavir: As we were going to press, the medical journal Lancet warned that the herbal supplement St. Johns Wort drastically lowers the levels of the protease inhibitor Indinavir (Crixivan) in the blood. St. Johns Wart could prompt a dramatic rebound in HIV viral levels in a drug resistant form.

After that, four different women filled in various vacancies in the trio (Birdsong came and went twice, while Wilson never left) until the group officially disbanded in 1977. In recent years, many people have used the **Supremes** moniker. There's a group in France called **The Supremes**. A woman who sang backup for Mary Wilson as a solo artist has since started her own group called **Sounds of the Supremes**.

Members of the post-Ross Supremes have been part of a trio called the "FLOS" (or "Former Ladies of the Supremes"), joined at times by a no-talent, hideous singer affectionately known as The Poodle. Mary Wilson herself has been billed as "Mary Wilson of the Supremes". Even Diane has been called "The Supreme Lady".

Fans of the original Supremes had to contend with these alternate groups because a real reunion seemed impossible - until now. After releasing a quite impressive CD that no one cared about, Ross came to the realization that her career as a solo artist pales in comparison to her former glory as one of the Supremes.

Originally, her idea was to bury the hatchet with Mary Wilson, enlist the aid of Cindy Birdsong, and do two special reunion concerts – one in New York and one in Los Angeles. If these went well, the reformed group would do a full-scale tour, release an album and a video, etc.

Then Diana received a call from one of the 70s Supremes – Scherrie Payne (sister to Frieda Band of Gold Payne). Ross was appalled to learn from Scherrie that all of the Supremes (except for herself and Wilson) are virtually penniless, having signed away what little royalties they had years ago. Payne was curious if there was any way the other living Supremes could be included in this reunion.

Ross was moved by this plea and called all of the Supremes and asked them to come to NYC for a photo session with **Albert Watson** and to plan the reunion. Problem – Ross neglected to check if Mary Wilson was available. As it turns out, Wilson is touring the UK. For now, the meeting and the photo session have been rescheduled until Mary can zip back to NYC.

However, both Mary and Cindy have concerns about a sprawling reunion of all of the living Supremes - especially since Mary and Cindy are the only ones who ever sang with Ross (their point makes particular sense when you realize that this reunion will be billed as **Diana Ross and the Supremes** – and that lineup was Diane, Mary and Cindy, period).

For her part, Diana has made it clear that without Mary and Cindy, there's no reunion. Someone close to Ross tells me that the current plan is for Mary, Cindy, and Diane to be the focus of the entire extravaganza. They will open the show with an hour revisiting some old material, doing some covers and Broadway numbers, and even performing a new original song or two.

After the intermission, the various post-Ross lineups will take to the stage and perform their hits. *Finally*, Ross will reappear on Roth).

One reunion not in the cards is the long-anticipated ABBA reunion. The defunct Swedish group turned down one BILLION dollars to launch a comeback tour (their first in over 17 years). Although Benny and Bjorn were tempted by the idea, the women (in particular Agnetha) have no interest in public performance. But it was one BILLION dollars!] Mamma mia!

# Midnight and Moll Flanders

English author Daniel Defoe's 1722 novel, *Moll Flanders*, tells the life story of a wayward woman who eventually finds redemption. It is, on its surface, strictly a morality tale written from a heavily pro-Protestant point of view and, as such, our secular society some 278 years later might find it to be an amusing anachronism. But, in the hands of a modern playwright, it can still speak to us and be more than just a lesson in Protestant ethics.

Midnight and Moll Flanders, by Marie Kohler, not only tells the fascinating life story of its title character (in a "free adaptation" from the Defoe original), but also peers into the soul of a Puritan preacher. Moll has found herself sentenced to death for trying to steal a gold necklace from a young girl. As her final hours of life on Earth tick away, she tells her story to a preacher. He takes it all as something of a confession; she assures him, much to his chagrin, she means no such thing.

Moll is, indeed, an interesting character, best summed up by Defoe himself on his work's title page. She was "...born in Newgate (a prison), and during a life of continu'd variety for threescore years, besides her childhood, was twelve year a whore, five times a wife (whereof once to her own brother), twelve year a thief, eight year a transported felon in Virginia, at last grew rich, liv'd honest, and died a penitent..."

Midnight and Moll Flanders is an ambitious new play, with no less than three different actors portraying Moll, and 25 supporting characters. It centers on the (supposedly) final hours of Moll's life awaiting the gallows, as she tells her story to the preacher. The prison cell is at stage left, while the events of Moll's life take place on the rest of the stage. The set design is quite effective, with lots of wooden staircases, a circular, central platform, and what appears to be a dockside at the back.

The best performances are, happily, in the central roles. Laurie Birmingham expertly plays the older Moll, and Emma Bates plays Moll as a young woman. The old preacher is played by Brian Robert Mani (who most recently played Teddy Roosevelt in *Teddykins*), and the same character as a younger man by Shawn Douglas. Particularly strong are the often heated, thought provoking exchanges between Douglas and Birmingham.

Midnight and Moll Flanders is still a

morality tale, but one with a modern twist. It is not just a wayward sinner who finally faces up to her past and repents, but also a sanctimonious, unbending preacher whose eyes and mind are opened to the "real world;" a world with lots of gray area, not just black and white, right and wrong. The final redemption is not Moll's, alone.

# Paragraph 175 premieres at Berlin Film Festival

Paragraph 175 a documentary depicting the persecution of homosexuals by the Nazi's premiered at the Berlin film Festival on February 13.

These Oscar winning filmmakers Jeffrey Friedman and Rob Epstein have seen Paragraph 175 win the directing award at the Sundance Film Festival

The 1871 anti-homosexual law called Paragraph 175 stayed on the books until 1969. This resulted in the fact that any survivor of the Nazi Concentration Camps who requested assistance or aid as a victim could have been arrested for the same violation that Hitler used in persecuting homosexuals.

Filmmakers Friedman and Epstein point out that the Homosexual dimension to the Holocaust is not common knowledge.

The Pink Triangle a common symbol of Gay, originates from the Holocaust. Homosexuals were required to wear it on all of their garments in a similar manner that the persecuted Jews were required to wear Stars of David.

#### Cradle Will Rock

Cradle Will Rock is Director Tim
Robbins' third movie, and although these
three films are very different in many
regards, they nevertheless share one thing:
a social conscience. Bob Roberts was a
blistering satire about how the media can
both make and break politicians; Dead
Man Walking offered a frank and uncom-

promising view of the death penalty from several perspectives; now this new film addresses both freedom of expression and what it means for an artist to "prostitute" himself.

Cradle Will Rock, mostly based on a true story, comprises five episodes that are linked thematically and, at times, narratively. The main focus tells of the efforts of Director Orson Welles (Angus MacFadyen), Producer John

Houseman (Cary Elwes), Writer Marc Blitzstein (Hank Azaria), and their cast to put on a controversial play named *The* Cradle Will Rock.

Other tales involve the struggle of Hallie Flanagan (Cherry Jones) to keep the Dies Committee from cutting government financial support for the Federal Theater Program because of alleged pro-Communist propaganda. Nelson Rockefeller (John Cusack) hiring artist Diego Rivera (Ruben Blades) to paint a mural in the lobby of Rockefeller Center (then balking when he sees the final product). Steel magnate Gray Mathers (Philip Baker Hall) flirting with Mussolini's mistress, Margherita Sarfatti (Susan Sarandon), while his flighty wife, the Countess (Vanessa Redgrave), pursues

social causes. And finally an alcoholic ventriloquist (Bill Murray) believing that Communists are infiltrating vaudeville.

Together, these tales do a good job capturing the somewhat paranoid spirit of the '30s.

Many social issues of that decade are excellently addressed in the film, including anti-Communist paranoia, flirtations with Fascism and the

rising influence of labor unions. In part, this is accomplished by careful attention to detail in terms of set design and costumes. It asks some interesting questions, such as: how far does freedom of expression go? Does the government have the right to arbitrarily determine what art it will or will not fund? When a person owns a piece of art, does the owner have the right to determine when or how it is displayed, or whether it can be changed, defaced, or destroyed? Important questions with contemporary relevance. Even though the film tackles serious issues, the tone remains light throughout this is as much of a comedy as it is a drama.

One of Cradle Will Rock's assets is also one of its detractions. With so many char-

acters involved in several different plotlines, it never loses your attention, but you also don't get to know any of the characters very well. There really isn't a weak performance in the film, but again, that also means that some of your favorites have less screen time than you might have liked them to have.

Cradle Will Rock is on the whole a satisfying combination of screwball comedy and period piece drama. Intertwining the stories of more than a dozen characters, Robbins generates a pace that is often frantic. The film isn't without flaws - but, as always, it's far more agreeable to experience a movie that occasionally stumbles because the filmmaker is over-ambitious as opposed to the opposite.





#### Sweet and Lowdown

Goody Allen has become something of a recluse in recent years, but he has nevertheless continued to put out a movie a year, most of which having semi-autobiographical content. Allen, himself appears in most of his own films, but his latest, Sweet and Lowdown, is his second consecutive movie in which he has not played the protagonist. In Celebrity, we were faced with the creepy situation of Kenneth Branagh doing a Woody Allen

In Sweet and Lowdown, Allen pays homage to his love of jazz music by honoring an obscure, fictional, '30s jazz guitarist named Emmet Ray (Sean Penn). The resulting film is

a little like a jam session: often mellow, occasionally meandering, and elevated by tremendous riffs and bursts of intensity. Presented as if it's the biography of a real person, Sweet and Lowdown freely mixes reminiscences with legends and contrived facts to present a fragmented portrait of Emmet Ray.

Penn plays Ray as a brilliant, egotistical, erratic artist whose personality traits include an inferiority complex to a French Gypsy guitarist, a mild case of kleptomania and a tendency to show up for gigs late, if at all. Ray's life is observed through a series of episodic vignettes, many of which are more in the nature of tall tales than historically believable recreations. While Sweet and Lowdown includes a good dose of drama with its comedy, Penn understands the film's tone perfectly and excels in the role, emphasizing the right aspect of his character for each scene.

Other characters in the film include Samantha Morton, a real scene-stealer as Emmet's girlfriend, Hattie. Uma Thurman plays Blanche, the socialite who coaxes Ray into an unhappy marriage. Anthony LaPaglia and Gretchen Mol have supporting parts as, respectively, a gangster and one of Ray's would be conquests. All are creditable performances, with Morton the real stand out.

Sweet and Lowdown is a pleasant surprise after the unsuccessful Celebrity. It's unambitious and lacks an obviously Woody Allenesque character. Ironically, perhaps, it's all the stronger for these reasons. It has a good look and sound about it (featuring a top-notch jazz score), and ultimately succeeds as a small, diverting film.

"You don't understand," I told them. "There will be lesbians here tomorrow."

"If you're going to protest do it outside," they said. "Now let go of the podium."

A friend of mine has had the dubious pleasure of coming out here.

Picture it: she finally figures out who she is, has all that pent-up energy, and with joy and zest bursts forth into a world...that doesn't give a hoot.

She told me about passing a clutch of Lesbians at they entered a restaurant. She wanted to tackle them by their ankles, blurt "Thank You, thank you for being here!" and grill them on whether they live locally. I certainly understood, but praised her for her restraint. Casually affixing a tracking device is the way to go.

Something for

In past issues, we've touched on some of the ways Internet surfers can use their time on the web to earn premium merchandise or even cold, hard cash. Then as now, programs such as MyPoints (online at http://www.mypoints.com) reward loyal netizens with goods and services for agreeing to receive advertising e-mail, while AllAdvantage (online at http://www.alladvantage.com) sends out checks to those who browse the web accompanied by the AllAdvantage ViewBar.

Lovely programs though they are, these and others like them can work for you only if you're already net-capable and able connect to the Internet. Suppose you just didn't feel like forking out \$20 or more a month for the privilege?

In conjunction with a variety of local and national online sites, 1stUp.Com (online at http://www.1stup.com) has begun to offer a free Internet Service Provider (ISP)

program. If you're a Windows 95, 98 or NT user - a Macintosh version is promised soon - and have Microsoft Internet Explorer version 4 or greater installed, a few minutes spent downloading (or having a friend download), a small program will get you full Internet access at no charge. Like most ISPs, service is concentrated in more heavily-populated areas. If you're fortunate enough to be a resident of Milwaukee or Racine (in the 414 area code), Beloit, La Crosse or Madison (in the 608 area code), Eau Claire or Wausau (in the 715 area code), or Appleton, Green Bay, Kaukauna, Oshkosh or Sheboygan in the 920 area code, you're in luck, as 1stUp.Com offers the free ISP service in your area.


To get started, point your browser - or have a friend point theirs - to one of 1stUp.Com's partners. Of the several they currently boast, three are national in scope, with two being the mega-search engines AltaVista (whose 1stUp link is http://www.microav.com), and Excite (which offers the 1stUp.Com software at http://freeworld.excite.com/freeworld). Most exciting perhaps for the gay, bi, lesbian and transgendered community is the third of their national affiliates: the up-andcoming gay destination site Gay.Com, whose 1stUp.Com page can be found at http://content.gay.com/freeisp.html. Others exist as well, targeting different age groups and cultural affinities, so if none of the three appeal you, take a peek at http://www.1stup.com/download.html

for the most current list.

Once you've selected an affiliate whose branded version of the software you'd most enjoy using, you'll need to register for the service itself, and this in effect is how you "pay" for the service. Depending on with which partner you register, you'll be asked a series of questions designed to ferret out enough demographic information to allow them to target to you the advertising to which you're most likely to respond. Compared to many web-based freebies, the process is relatively fast. It's worth pointing out that while you're required to provide the information, 1stUp.Com has a strong privacy policy - and there's nothing requiring you to be truthful. Inflate your income by a few hundred percent and see the adverts Bill Gates might get.

Once the small 500K program has been downloaded and installed, clicking on the desktop icon will initialize the 1stUp "NavBar," which is the key to the service. The NavBar occupies a small portion of your screen and displays to you advertisements from those 1stUp sponsors eager to reach those whose demographics match yours. You can move the NavBar around so its position matches your personal surfing preferences, but once you close it, your online session will end and you'll be logged off.

Whether interest lies in never making another ISP payment or in simply having a no-cost option in case your regular service goes down, you can't beat the price.
