#### New York Gays Win Rights Bill On 8th Try

New York — The city where the nation's homosexual rights movement started 17 years ago in the "Stonewall" riots sparked by a police raid on a gay bar has passed anti-discrimination legislation after the failure of seven previous attempts.

The City Council voted 21-to-14 and Mayor Koch signed the measure banning discrimination on the basis of sexual orientation in housing, employment or public accommodations. A violation can result in a \$500 fine and a year in jail.

"It's OK to be gay and lesbian in New York!" Joyce Hunter, a leader of the Coalition of Gay and Lesbian Rights, told about 1,000 cheering people who turned out in Greenwich Village to celebrate.

New York's first gay rights bill was introduced 15 years ago, the nation's first such measure. It failed in committee five times and was defeated on the council floor a sixth, in 1974. Since 1971, gay rights laws have been enacted by Wisconsin, a dozen counties and more than 50 cities.

"Ultimately, democracy prevailed," Koch said. "That is what is so wonderful about democracy."

The Roman Catholic Archdiocese of New York said in a statement it would try to determine what could be done to overturn the bill.

Hundreds of people gathered in Sheridan Square in the Village to celebrate the vote. People hugged, jumped up and down and applauded exuberant speakers.

#### Washington Gay Rights Measures Attacked By Bigots

Seattle (GLC Voice) — Less than two months after gaining a long-sought county ordinance in Seattle and an executive order from the governor to protect Gays in employment, Washington State Gays are gearing up for battle against referendum efforts which could overturn both of those measures.

On the statewide level, Republican State Rep. Glenn Dobbs is mounting an initiative drive to invalidate Gov. Booth Gardner's December executive order that prohibits discrimination against Gays in employment by state agencies. The iniative would make it "illegal to employ homosexuals or other sexual deviants" in areas where they could come into contact with children, people with disabilities, and the elderly.

Meanwhile, in Seattle, a conservative group has gathered over 41,000 signatures—15,000 more than necessary—to place "Referendum 7" on the county's ballot to overturn a December County Council ordinance which prohibits discrimination in county employmeny based on a number of categories, including sexual orientation.

## \$1.75 Million Lawsuit Is Filed On Alleged Affair

Port Washington (Milw. Sentinel) — A former client of the Ozaukee County Counseling Center has filed a \$1.75 million law-suit against the county in connection with an alleged lesbian affair with her counselor.

The lawsuit, filed in Federal Court, named as defendants the county, the counselor, the center and its medical director.

According to the lawsuit, the county and the center's medical director, psychiatrist Bruce E. Weffenstette, failed to properly administer the center and its employees.

The client, who now lives in Milwaukee, was being counseled in the center's alcohol assessment program. She was referred to the center for a court-ordered driver assessment and driver safety plan.

According to a notice of claim filed last October, the relationship allegedly occurred from March 1983 to April 1985. The claim has been denied by the County Board.

Morgan Butler III, the county's corporate counsel, said Tuesday that he knew "very little about the specifics of the alleged relationship between the two individuals."

"Now that the suit has been commenced, we are in a position to find out exactly what happened," Butler said.

#### NSA Agrees To Reinstate Two Employees

(Washington Blade) — The National Security Agency, the nation's most secret intelligence-gathering organization, has cancelled a 1983 "propsed action" to fire two male employees on grounds of homosexuality and has agreed to reinstate the men to their jobs with highly sensitive security clearances.

Kameny, who served as administrative counsel to the employees, said NSA officials ended two-and-a-half years of "stalling" last week when they agreed to restore clearances to a 29-year-old GS-12 computer systems analyst and a GS-14 engineer who is in his early 50s.

Both men were removed from their jobs in early 1983 after NSA officials learned through separate and unrelated investigations that the computer analyst was Gay and the engineer was bisexual, according to Kameny. NSA investigators then sent the men letters informing them NSA was taking steps to fire them on grounds that their homosexuality or bisexuality posed a risk to national security because it made the men susceptible to blackmail, Kameny said.

Butler said the counselor had "since left the employ of the county." He said the resons for her leaving were not related to the accusations filed by the client. Butler would not elaborate.

The notice of claim alleged that the client "suffered injuries as a result of the intentional or negligent seduction and infliction of emotional harm" by the counselor.

It further alleged that events included taking vacations together, spending nights together at the client's house and "otherwise maintaining a lesbian relationship."

The suit seeks \$250,000 from the county. \$250,000 from the center, \$500,000 from Weffenstette and \$750,000 from the counselor.

#### Blood Test Ordered For Gay Father

Chicago (Windy City Times) — A gay father has been ordered to take the HTLV-III antibody test in order to visit his children. However, the father has refused to comply with the order.

The ruling in John Doe v Susan Doe has been appealed by the National Gay Rights Advocates. Because the father has refused to be tested, the judge has agreed to reconsider his decision and hear further evidence from both sides.

"The judge's original decision was clearly wrong," said Benjamin Schatz, director of NGRA's AIDS Civil Rights Project. "The HTLV-III antibody test does not tell us whether a person has or will develop AIDS. Moreover, even if the father did have AIDS—which he does not—there would be no reason to keep him from visiting his children. AIDS cannot be casually transmitted, and it is time for the courts to recognize this fact."

Schatz emphasized that the antibody test was licensed for use in screening the nation's blood supply, not to screen people.

The dispute originated when the father, now living in San Francisco, filed a motion for expanded visitation privileges. This motion was opposed by his former wife, who feared the children would "catch AIDS" from him simply because he is gay. Although the father is healthy, the judge ordered him to take the test, ignoring medical evidence which was presented.

The two parents have been in litigation several times, according to Schatz. Originally, the father had liberal visitation rights. But his former wife complained because he lived with a male lover. A court then ruled the father could only visit the children at their mother's home.

After the father moved to San Francisco, he petitioned the court for expanded visitation. He was no longer living with a male lover and therefore his visitation should be expanded, according to his appeal. After this move by the father, late last year, his former wife made the claim about AIDS.

#### Volunteers Will Treat AIDS Cases In Waukesha

(Waukesha Freeman) — County Unified Services employees will not be forced to work with any clients who have Acquired Immune Deficiency Syndrome or are suspected of having the disease.

However, the department will continue to serve such clients, according to guidelines presented to the Unified Services Board

Those services will be provided by county workers who volunteer to work with those patients.

Peter Safir, Unified Services director, told the board that the guidelines for dealing with clients who have the deadly disease were drawn up because some department social workers have said they do not want to work with AIDS victims or those suspected of carrying the AIDS virus.

"A couple of our staff people are uncomfortable doing interviews or consulting" with suspected AIDS clients, Safir said last week. There have been no confirmed AIDS victims in Waukesha County.

## Oregon Rules For Gay Teacher

Salem, OR (Gay Comm. News) — The Oregon Supreme Court has reversed the firing of a Springfield, Ore. teacher, who police said was involved in homosexual activities in a Eugene adult bookstore in 1979, and has returned the case to the Oregon Fair Dismissal Appeals Board for further proceedings. This is the second decision by the Oregon Supreme Court in this case.

Frank Ross, a tenured teacher and librarian with 19 years of service in the Springfield School District, was fired following parental reaction to alleged homosexual activities in an adult bookstore. According to the amici curiae brief filed by the Gay and Lesbian Alliance of the University of Oregon and the Eugene chapter of the National Lawyers Guild, Ross was observed in the movie arcade of a bookstore having sex with another man.

The brief goes on to say, "Ross was later subpoenaed, but never actually called, to testify about the bookstore. He requested the necessary time off from his principal, and when asked, honestly stated that it was in the bookstore case. The principal spread the word. A group of parents mounted a campaign to get Ross fired and they succeeded." While acknowledging that Ross' activity was not illegal, the school district cited a state law which allows the firing of a teacher on the grounds of "immorality," "inefficiency," and "gross unfitness."

#### NGRA To Represent Gays On Insurance Commission

San Francisco (Equal Times) — Benjamin Schatz, Director of National Gay Rights Advocates' AIDS Civil Rights Project, has been appointed by the National Association of Insurance Commissioners (NAIC) to serve on a select panel of experts working to formulate national policy on AIDS and insurance.

This panel will play a vital role in determining whether gay men will be able to obtain health and life insurance across the coutry.

NGRA was selected to serve on the panel because of its leadership in the battle to defeat AIDS-related discrimination. As part of this work, NGRA recently filed two complaints with the California Department of Insurance.

"We plan to press our position strongly and clearly," declared Mr. Schatz. "The insurance industry must not be permitted to exclude gay men from coverage through life

#### Quote Brings \$1.5 Million Libel Suit

Los Angeles (Equal Tines) — Movie director William Friedkin, who directed The Boys In The Band, The Exorcist and The French Connection, has filed a \$1.5 million libel suit against the Los Angeles Times for publishing an interview with an actor who said the filmmaker "really grooves on" homosexual violence.

Friedkin named the newspaper and freelance writer Clarke Taylor in a Superior Court lawsuit last week over an interview with actor Willem Dafoe, who starred in Friedkin's last movie To Live And Die in L.A. Dafoe played a counterfeiter trying to evade the law in the film.

#### French Court Denies Benefits To Lesbian Couple

Rennes, France (Gay Comm. News) —
An appeals court here has ruled that lesbian and gay couples do not engage in "marital life," and that they are therefore not entitled to the same government benefits as straight couples. According to French law, unmarried straight couples engage in "marital life" when they have "the complete appearance of marriage in the eyes of a third party."

The Body Politic reports that the ruling upheld an earlier decision by a social security tribunal in Nantes. The tribunal ruled that Nadia Lakjda, a lesbian, could not extend her health insurance benefits to her lover, Annie Dupas, because they did not have a "marital relationship."

#### AIDS Pupils No Threat, Group Says

Madison (Milw. Journal) — Students with AIDS would pose no risk to other pupils and should be allowed to stay in school as long as possible.

The State Department of Health and Social Services has begun distributing guidelines for administrators and health specialists in Wisconsin public, private and parochial schools.

To date, no cases of acquired immune deficiency syndrome among people under 18 have been reported in Wisconsin, said Linda Reivitz, secretary of the department.

The guidelines, developed and approved by the state AIDS task force, suggest that students with the disease remain in their regular school setting.

However, youngsters who carry the AIDS virus and lack toilet training, have open sores or bite their teachers or classmates might pose a greater risk of transmitting the disease, and may be removed from regular classes, the department's 16-member Public Health Task Force on AIDS said.

"Based on current evidence, casual person-to-person contact, as would occur among schoolchildren, appears to pose no risk," the guidelines said. "The best evidence supporting this statement is that no cases of AIDS have occurred among non-sexual household contacts of the over 16,000 reported cases (nationwide) of AIDS".

The task force said that through early January, 250 of the 16,138 AIDS cases nationwide were among people under 18. Most of them got the virus from their mothers or from transfusions with infected blood.

Several localities and school districts, including Milwaukee Public Schools, have been working on AIDS guidelines. School officials said their concern was prompted by Continued on page 27 •

screening or misuse of the HTLV-III antibody test."

The appointment of NGRA represents a historic step for the NAIC, which has never before worked with members of the gay and lesbian community.

#### Conscientious Objector

Rome, Italy (Wash. Blade) — A 25-yearold chemical worker is asking Italian authorities to excuse him from mandatory military service because he's gay, reports L'Espresso, the national Italian newsmagazine.

Fabio Saini, a resident of Perugia, has requested that he be granted conscientious objector status and be allowed to serve alternative civilian service with a national gay rights group called l'Arei, according to L'Espresso.

The magazine says Saini is the first Italian ever to seek a waiver from military service on grounds of homosexuality.

Saini told the magazine he's opposed to violence as an "instrument to solve conflict" and that this conviction "derives from my experience as a homosexual."

James W. Curran, head of the AIDS branch of the federal Centers for Disease Control in Atlanta, raised these concerns at a recent conference in Tarrytown, N.Y.

"What is going to happen in 1990 is that somebody is going to say, 'Why didn't you tell us about this problem?" Currar said. "We are talking about a massive problem, one with national and international implications."

Cases of AIDS among drug addicts their sex partners and children have so far occured mainly in New York City and northern New Jersey. But cases among intravenous drug users have now been reported in 44 states, and the incidence of AIDS among drug addicts in Europe has risen sharply.

In another important development, new studies in Zaire, which has refused to allow medical reporting about the disease, affirm that heterosexual vaginal intercourse is the dominant route of transmission of the disease in central Africa.

#### AIDS Vaccine?

(Excerpted from Time Magazine) — News came from the laboratory of Dr. Myron Essex at the Harvard School of Public Health. Essex announced that he, logether with colleagues in Senegal and Tours, France, had isolated a new virus that is "closely related" to the AIDS virus but has several significant distinguishing traits. The virus, which was isolated from blood samples taken from Senegalese prostitutes, is structurally similar to the AIDS virus but even more closely connected to a virus that infects certain African monkeys. Says Essex: "We believe it is a Missing link" between the two.

The most exciting feature of the new virus

is that it appears to be harmless. In the lab. says Essex, it behaves much like the AIDS virus, infecting the same immunological cells (helper T cells) but without the "dramatic killing action" of its lethal cousin. None of more than 50 people infected with the virus have developed any symptoms of AIDS. Thirty have been followed for more than a year and have remained healthy, but, says one viralogist, "we must wait for more time to pass to be certain." It is hoped that the new virus could serve as a natural vaccine, protecting those it infects against the more harmful AIDS virus, much as people infected with cowpox virus are protected against smallpox. Studies of old blood samples indicate that the virus has been present in Senegal for at least ten years. No cases of AIDS have been reported in the country, though the disease is rampant in central Africa.

The news of an apparently harmless relative of the AIDS virus was greeted with entusiasm by other scientists. "The best thing about Max's virus," say Robert Gallo, is that we can learn why one is pathogenic and the other isn't." By identifying which component of the AIDS virus is responsible for its deadly effects, researchers may be able to develope new drugs that specifically inhibit it. They may also be able to alter the virus genetically to remove its harmful traits, leavir g a benign version that could serve as a vaccine.

There are many obstacles to a truly workable vaccine. Safety is one: even a genetically altered virus could conceivably cause disease. A successful vaccine would have to trigger the production of antibodies that protect the individual against AIDS. In light of the changeability of the AIDS virus, the vaccine would have to offer immunity against an almost infinite array of variant strains.

Q: How do I deal with my family about AIDS?

A: In the current hysteria surrounding AIDS, gay men and lesbians may have to face increasing concerns from their families about their lifestyles. Even if you have not "come out" to your family, chances are they either know or suspect and may question you about AIDS. You should give them as much accurate information as possible.

No matter how your family asks, their main concern is for both your health as well as their own. They are very likely feeling different degrees of anxiety and it will help you to be aware of this as you answer their questions.

There are generally three ways families will react to your sexual orientation, hostility, tolerence, and acceptance.


If your family is openly hostile they may use AIDS as another argument against your lifestyle. You should try to get your family to deal with the AIDS issue separately from your sexuality. You should stay calm and not be defensive. Deal with their arguments rationally, or if that isn't possible, just drop it and leave for the time being.

If your family continues to include you but doesn't want to deal with any issues concerning your lifestyle; questions may not be forthcoming. Be aware that their concerns and fears are still operating and you might want to let them know, in a subtle way, that you are doing all you can to safeguard your health.

If your family is accepting of your lifestyle it is important to know that their concerns about AIDS, again, are for your health and should be answered with accurate information and assurances that you are doing all you can to protect yourself.

You alone know how open your relationship with your family is and how well they deal with your lifestyle. This will guide you in the best way to handle their questions and fears.

It is, obviously, very important that you know the correct facts yourself, not only to dispel any myths and misconceptions your Continued on page 10.

Be informed, help overcome hysteria and fear, and PRACTICE SAFE SEX! It is your life and it is invaluable.

#### Health News AIDS Probe Opposed By Council

Madison (Milw. Sentinel) — Gov. Earl's Council on Lesbian and Gay Issues said it strongly opposes a tentative State AIDS Task Force recommendation to begin tracing sexual partners of people exposed to the AIDS virus.

The goal of "Contact tracing" is to reduce the spread of disease by identifying people who are unaware they have been infected.

Contact tracing is a technique used routinely by public health agencies to locate and inform people who have been exposed to syphillis, gonorrhea and other sexually transmitted diseases.

The council, in a vote taken March 22, said there was potential for abuse of the list of names that would result from tracing investigations.

In a written statement issued to the press, the council said it also feared contact tracing might result in a "significant drop in the numbers of people being tested" for exposure to the AIDS virus.

Earl Bricker, staff adviser to the council, said: "The majority of the people tested for exposure to the AIDS virus are gay men."

If large numbers of homosexuals who do not have AIDS but test positive for the antibody are asked to recount their sexual partners in the last five years, a huge list of names will be developed, he said.

There is concern such a list would become public, he said.

Linda Reivitz, secretary of the State Department of Health and Social Services, said the task force she set up to advise the state on AIDS issues would not take final action on the contact tracing plan until May.

Reivitz said she supports the technique as a "chief means of making sure the disease is contained as much as possible within the population."

"Reivitz said contact tracing information is considered confidential and that she did not know of any cases where confidentiality had been breached.

James Vergeront, an epidemiologist with the State Division of Health who attends task force meetings, said although contact tracing was a controversial issue, the tentative recommendation was likely to receive final endorsement.

#### **Drug-linked AIDS** Cases Spreading

New York (Milw. Journal) - A top federal official responsible for battling the AIDS epidemic has warned that cases linked to intravenous drug use, once concentrated in two states, are rapidly spreading through the nation.

He said swift action must be taken to stem further spread, and that intravenous drug use was now viewed as a far greater factor in the spread of acquired immune deficiency syndrome than previously realized.

Directly or indirectly, contaminated needles are the prime source of the fatal disease among heterosexual men and women and newborn. The concern about intravenous drug use has greatly increased for two other reasons as well.

First, new statistics show that AIDS has become the leading cause of death in New York prisons-principally because of intravenous drugs that were taken before incarceration-and there are indications similar conditions are developing in prisons elsewhere.

Second, recent research indicates that homosexual men have substantially decreased promiscuity since AIDS was discovered in 1981. Yet, reported cases continue unabated among men in this group, and a suspected key factor is the use by some of intravenous drugs.



#### "Buddies" & "Victim" Wrap-Up Film Festival

The Lavender Commitment is pleased to close the Fourth Milwaukee Gay/Lesbian Film Festival with a special two night screening of the Milwaukee premiere of Arthur Bressan's controversial AIDS feature film, BUDDIES.

Beginning with a seemingly endless computer print-out of the names of men who have died of AIDS, Bressan's BUDDIES is determined to not only educate but also to strike at the emotions of the spectator. Bressan has taken the small, individual story of last days of Robert, a 34-year-old former gardener who is now hospitalized in New York City. David is the young volunteer "buddy" to Robert. At first extremely naive of the name of AIDS, David first visits Robert in a paper gown and mask. In fact after the first visit both men are leary of the arrangement. David finds Robert arrogant and questions his own motives in becoming a 'buddy'. Yet through the course of the film, the relationship between Robert and David grows into a powerful and complex love.

Although filled with occassional lapses of



Bressan's didactic messages, in particular Robert's bitter, if infact truthful, rantings against the federal goverment's indifference to the AIDS crisis, BUDDIES remains an intensely personal story. The spectator must view the film's narrative through the two main characters, not through safe and invariably heterosexual characters that has been the rule NBC's AN EARLY FROST or ABC's ST. ELSEWHERE.

Likewise, the issue of gay male sexuality is important to Bressan, who views sexuality as crucial to survival of the individual and also the gay community. In an especially powerful and unsettling moment of BUD-DIES, David has brought Robert an old porn video tape to entertain him. As the two men watch the film, they are at first uneasy and embarrased by the situation. As a sign of their growing intimacy, Robert masturbates as David holds and nartures him.

The power of BUDDIES is the bringing to focus the AIDS crisis in terms that are personal and real to countless gay men in America. As the naive David begins to grow with an awareness and a political consciousness, it becomes clear that this has been Bressan's purpose.

Accompanying BUDDIES on Monday, April 21 and Tuesday, April 22 is the classic 1961 British thriller, VICTIM. Starring Dirk Bogarde, VICTIM was one of the first to address the subject of homosexuality in positive terms.

Tickets are \$3.50, \$2.50 for UWM students. The program begins at 7:00pm in the UWM Student Union Cinema.

#### Buddies Also At Oriental Theatre

The film "Buddies" is also scheduled at Milwaukee's **Oriental Theatre** for Wednesday, April 30 at 7:25pm, only. The cofeature that evening is Christopher Larkin's "A Very Natural Thing", one of the first sincere gay feature films. It's a sensitive story of a former priest who is torn between his dreams of domestic bliss and the temptations of the exciting New York gay subculture. This second feature is screened at 5:50pm and 9:10pm.


