



HHH Cites Bias Against AIDS Victims

Washington, D.C. (Milw. Journal) — The federal government has for the first time accused an employer of illegally discriminating against a person with AIDS.

The charge was made by the Department of Health and Human Services, which said a North Carolina hospital had violated a man's civil rights by dismissing him from his job as a registered nurse and then refusing to consider him for any other job.

The government said the Charlotte Memorial Center had violated the law "by discriminatorily denying the complainant individualized consideration for possible reemployment."

Thomas Stoddard, a lawyer for the AIDS victim, said the decision was "a hollow victory" because the man died Feb. 26. He was 27.

Stoddard is executive director of the Lambda Legal Defense and Education Fund Inc., a non-profit group that defends the rights of gays. He said the man's complaint was filed in July 1984.

The government's action is significant because it sets a precedent demonstrating that people with acquired immune deficiency syndrome may be able to protect their rights despite a restrictive interpretation of the relevant law by the Justice Department.

It is not known exactly how other hospitals have reacted to employes with AIDS. However, it is believed that most follow guidelines issued by the federal Centers for Disease Control. The guidelines say employes infected with the AIDS virus "need not be restricted from work unless they have evidence of other infection or illness." The agency recommends special precautions for people performing "invasive procedures" such as surgery.

The law in question, Section 504 of the Rehabilitation Act of 1973, prohibits discrimination on the basis of handicap in any program or activity that receives federal financial assistance.

Homosexual Act Is 82nd Most Serious Crime

Philadelphia (Gay Comm. News) — In a nationwide survey, people ranked engaging in consensual "homosexual acts" as a more serious offense than "disturbing the neighborhood with loud, noisy behavior." The survey, conducted by researchers at the University of Pennsylvania, asked people to rank the severity of 204 "illegal" events.

According to the Campridge Chronicle, "two person willingly (engaging) in a homosexual act" ranked 82 in the list.

Ranking number one was planting a bomb in a public building (resulting in the death of) 20 people. Forcible rape ranked ten; getting rid of industrial waste in a "way that pollutes the water supply of a city" ranked 23. smugding marijuana into the country for resale ranked 30; intentionally hitting a "victim with a lead pipe" ranked 31; performing an illegal abortion was number 42; knowingly passing a bad check was 69; smoking marijuana was 81; trespassing in the backyard of a private home was 87; and being a vagrant—having "No visible means of support—88.

Atlas Shrugs: San Francisco Gay Bank Closes

San Francisco (The Advocate) — Atlas Savings and Loan, the nation's first gay savings and loan association, has been sold to New York-based Empire of America Federal Savings Bank. The sale, made by the Federal Home Loan Bank Board, came one day before officials at the financially ailing gayowned bank were to meet with federal officials to discuss ways of maintaining Atlas as a gay-owned corporation.

Federal agents converged on Atlas at 4 p.m. on July 14, placing the institution into receivership; it reopened the following day as a new branch of Empire Savings.

James Bowersox, president of Atlas, said the federal officials' move came as a complete surprise to everyone associated with the bank. "They simultaneously sold all our

assets to Empire, and Atlas ceased to exist." He added that Empire immediately rehired all of Atlas' Bank employees: "We don't think there will be any layoffs," stated Bowersox. "In fact, I think there will be a need to hire more people."

Empire Savings officials have said that they intend to support the gay community to the same extent that Atlas did—though Harvey Simon, senior vice president of Empire, said that his bank intends "to serve all segments of the community. We hope to expand to serve other segments."

The road to receivership began under Jerry Flanagan, Atlas' first president, according to Bowersox. Flanagan, a nongay man who came to the bank from Camino Real Savings and Loan in San Leandro, made approximately \$25 million in bad loans with the banks' assets. Atlas had begun four years ago as a traditional mortgage home lender, but after its first year and a half, Flanagan expanded the bank's loan activities into construction and high-risk joint ventures. It became insolvent in 1985, and was seeking additional capital at the time of the

"The most painful thing the former board members feel is not the loss of money (stocks)," said Bowersox, "but the loss of Atals. It was a wonderful dream. It took a wrong turn with those bad loans. Without that, the dream would still be here."

Wisconsin Epidemiologist Approves AIDS Tests For Insurance Purposes

Madison (InStep Magazine) — The State Epidemiologist, Jeffrey P. Davis, M.D., recently completed a series of studies "investigating whether a test or series of tests was medically significant and sufficiently reliable for detecting the presence of antibody to HTLV-III."

Davis, in a July 31st recommendation, determined that the HTLV-III antibody is present when a F.D.A. licensed Enzyme Linked Immunosorbent Assay (ELISA) test is positive, NAD a Western Blot assay in reactive.

Davis' report now goes to the State Insurance Commissioner, who must determine whether the tests for antibodies is reliable for use in the underwriting of individual life, accident, and health insurance policies, and whether insurance companies should be able to require applicants to take those tests.

Present state law now says an insurer may not require or request directly any individual to reveal whether he/she has obtained a HTLV-III test, or what the results of this test were. They may also not require, as a condition of providing insurance coverage, any individual to have an HTLV-III test.

However, now that the Epidemiologist has approved the use of the two tests, and if the State Insurance Commissioner also approves their use, that may also change.

Should the Insurance Commissioner determine the series of tests for antibody in reliable, his office must then designate the test series by administrative rule, for use by insurers. During this rule-making process, there will be Public Hearings held.

If the Insurance Commissioner eventually approves the tests Wisconsin statute s.619.12 Appendix A provides that an individual determined to have the HTLV-III Antibody, and is rejected by one insurer, he is eligible to participate in the State of Wisconsin Health Insurance Risk Sharing Plan (HIRSP).

Northwestern Mutual Life Insurance Company recently began testing the blood of "every man, woman and child" seeking to buy more than \$300,000 worth of insurance. In those states (presently including Wisconsin) where insurance companies are not allowed to administer HTLV-III Antibody tests, Northwestern Mutual is side stepping that, by requiring applicants to take a test that checks the levels of disease-fighting white blood cells (T-lymphocytes) in the blood.

Tosa Arrests 11 In Sweep Of Gays

Wauwatosa (Milw. Journal) — A parochial school principal, a school psychologist and a juvenile probation officer are among 11 men arrested by Wauwatosa police in a crackdown on sexual activity in Underwood Parkway, just southwest of Hansen Golf Course.

For about three years, police have received scattered complaints about gays using the parkway as a meeting place, but the activity has increased and has become more flagrant this summer, according to Lt. Robert Hey of the Wauwatosa Police Department.

A growing number of citizen complaints resulted in police assigning plainclothes officers to the park, beginning July 10, in an effort to halt the homosexual activity, Hey said. The arrests were made from July 10 through Monday.

Hey said homosexuals generally cruised the parkway from the Zoo Freeway overpass south to Watertown Plank Rd. They also use a nature trail in that area and a second trail northeast of the first trail, he said. The golf course is southwest of the intersection of W. 92nd St. and the Menomonee River Parkway.

A special assistant city attorney will review the arrests to determine whether the cases will proceed to Municipal Court or be referred to the district attorney's office, where criminal charges could be filed.

If the cases are referred to Municipal Court, the defendants would face municipal charges of disorderly conduct for various offenses such as propositioning an officer, indecently touching an officer or exposing themselves, Hey said. The municipal ordinance violation carries fines of \$67.50 to \$585.

It is the Jouranl's general policy not to identify people until they have been formally charged.

Ald. Thomas Q. Rowe, whose district includes the park, said the gays were infringing on the ability of other citizens to comfortably use the park.

"You ride your bike through there, and guys stare at you like they're checking you out," Rowe said. "It's eerie."

Rowe said he and his wife had tried to take a walk on a nature trail one recent afternoon but were repeatedly interrupted by "guys going into the bushes together."

"It was weird," he said. "It's not a place I want to be or want my family to be."

A lavatory in a park pavilion has been vandalized with homosexual graffiti, Rowe said.

Undercover police officers have been assigned to the park as various times one or two days a week, Hey said. The officers walk the park or loiter on picnic benches and "assume the same role as many men we see in the area." he said.

Sheriff's deputies also patrol the park from time to time, Hey said.

No assaults in the area have been reported, but several people have complained about various activities there, Hey said.

"We're hoping that word of our presence there and these arrests will spread through the community and this thing will die of its own accord," Hey said.

EDITOR'S NOTE: Why don't the police realize the best way to stop the activity is by having uniform officers increase their presence?

Gays Trying The Unconventional In War On AIDS

Minneapolis (LaCrosse Tribune) — Some gay men, in their own private war against AIDS, have turned to non-traditional healing methods to fight the deadly disease.

"It is a desperate thing," said Larry Patnoe-Ellis, 45, of Minneapolis, who tested positive for AIDS-related complex a year ago.

Patnoe-Ellis has since begun a macrobiotic diet and does half an hour of "selfforgiveness, self-worth" meditation each evening.

"I would have done anything," said Patnoe-Ellis, who also regularly sees a massage therapist. "I still don't know if I'm kidding myself or not, but if this delusion makes me feel good, I'm darned happy to have it."

The self-healing methods, which include acupuncture, group meditation and positive thinking, are a sign of an emerging belief among gays that traditional medicine—which has found no cure for AIDS—is too narrowly focused in its search for an answer. The alternatives, which doctors believe are neither harmful nor helpful, are also a measure of desperation.

Other remedies include eating blue green manna, a seawater algae taken in pill form, herbs and shiitake mushrooms taken to help build the immune system.

Many alternative remedies are passed along by word of mouth. And some gays have gone to Mexico to buy ribavirin and isoprinosine, two drugs that cannot be legally sold in the United States but can be brought into the country for medicinal purposes.

Man Killed In Kenosha

22 year old Idlifonso Garza of Waukegan, Illinois, better known in Kenosha as "Angie" was killed August 5th while walking to Club 94 from his home. Angie was recently crowned Miss Gay Kenosha. He was killed on 194 just north of the state line when he apparently was struck by a hit-and-run vehicle, and then run over by at least two other cars, before the accident was reported.

One driver stopped after hitting the body, which was lying in the northbound lanes after being hit by the other cars. The driver said the car in front of him ran over the body but didn't stop. The Sheriffs department was notified of the accident at 12:17am.

Friends reported Angie often walked to and from the bar, or hitchhiked along the highway. Reports that he had been picked up while hitchhiking by a carload of "guys", beaten by them, and tossed out of the car onto the highway, could not be confirmed.





It was obvious from the beginning that the proposal to recognize lesbian mothers in the heretofore male-oriented Coalition was destined to be approved by the voting members in Chicago. The push to include women and change the name got its start at last year's conference held in Los Angeles.

"The feeling was very strong that, as gay parents, we share a commonality of concerns about the direction of the family law and justice system as it relates to custody for gay men and lesbians," said Don Harrelson. "If there is one thing we have learned in the gay community, it is the need to stand together. Our strength is in numbers and our ability to relay our influence and thoughts to the judicial system and the general public-at-large."

The conference was hosted by the Chicago Gay & Lesbian Parents Group at Mid-City Plaza downtown.

Considered a "minority within a minority," gay fathers and lesbian mothers often face prejudice from within as well as outside the homosexual community. The majority of the members have been involved in traditional heterosexual relationships, while others have adopted as single gay parents.

Re-elected to her second term as Executive Vice-President, Julie Valloni says the issues of gay parenting are complex and diverse, requiring the newly-named Coalition to set new goals and refocus on others in the coming year. "Many gay men and lesbians are exploring alternative routes to raising children, including adoption, artificial insemination, foster care and surrogate parenting." Workshops at the conference featured guest speakers and authorities on many of those subjects.

Much of the conversation between the subject of attorney Kevin Cathcart's keynote address on Saturday, had to do with how the judicial system treats gay men and lesbians in child custody cases. Complicated by the issue of AIDS, many gay parents have lost lengthy and costly court cases prejudiced by their open homosexuality, while others not out in the open, fear how the revelation will affect custody of their

Five Boston Hospitals To Take Part In AIDS Study

Boston (N.Y. Native) — The National Institute of Allergies and Infectious Diseases (NIAID) announced that \$8.6 million will go to five Boston hospitals as part of a nation-wide \$100 million, five-year program to study the use of antiviral drugs for people with AIDS. The five hospitals are Massachusetts General (MGH), New England Deconess, Beth Israel, Childrens', and Dana Farber Cancer Institute.

An estimated 1,00 people will participate nationwide and approximately 75 from the Boston area. The study will be conducted in two parts, the first testing specifically for drugs that inhibit HTLV-III, the so-called "AIDS virus", and the other testing "drugs that alleviate infections and cancers often contracted by people with AIDS."

Ribavarin, azisothymiade, alpha interferon, forscarnet, HPA-23, and dideoxcytidine, are the first drugs to be tested. A meeting will be held later this month to decide which ones will be used in the Boston study.

Dr. Martin of MGH was critical of the funds, saying that the anti-viral drugs should be more widely available, reports the Gay Community News.

State Expecting Tenfold Increase In AIDS By 1991

Madison (Milw. Journal) — Milwaukee and Dane Counties will account for one half or more of a tenfold increase in Wisconsin cases of AIDS during the next five years, a state epidemiologist predicts.

The State Division of Health said that reported cases of acquired immune deficiency syndrome increased 10% in the state in July.

As of July 25, 96 cases of AIDS were reported in the state, including 54 that resulted in death. On July 1, the state had 88 reported AIDS cases, with 53 deaths.

By 1991, the state will have about 650 AIDS cases, the agency predicted.

"There's no reason to believe that state statistics will differ dramatically from the recent national projections of cases doubling every year," said James Vergeront, a state epidemiologist.

Vergeront said Milwaukee and Dane Counties would account for one-half to three-quarters of the cases.

Vergeront said 44% of current AIDS cases reported in the state were from Milwaukee County and 18% from Dane County.

"We don't forsee a change in that pattern over the next five years," he said. "It's the same pattern as in the rest of the country, where we have the majority of cases occuring in the large urban centers, because that's where the largest concentration of persons at risk live—specifically IV (intravenous) drug users and homosexually active men."

Vergernot said, people who develop AIDS by 1991 will likely have already been infected by the time a vaccine could be marketed.

In addtion, cases of AIDS-related complex, known as ARC, continue to go "very under-reported," Vergeront said.

Early symptoms of ARC are often too subtle to be linked to the HTLV-3 virus that causes AIDS, he said.

As of June 15, the state had 85 reported cases of ARC. National experts estimate that up to 30% of ARC victims will develop AIDS within six years.

AIDS Linked To Assault Of Daughter

Wausau (Milw. Sentinel) — A 35-yearold Mosinee man, whose blood tests show he has been in contact with the virus that causes AIDS, was charges in Marathon County Circuit Court last week with the second-degree sexual assault of his 15-yearold daughter.

The man was charged with assaulting the girl several times over a three-year period.

She told police he had fondled her on a Continued on page 16 *

Last year's national tournament was held in Las Vegas, and next year, bowlers in the Gay leagues will have the opportunity to attend the national tournament in New Orleans if they so choose.

I thought those of you that already belong to Gay leagues, and those of you who might be interested in joining one of them might like the break-down on when they are all starting, and when the meetings for them are going to be held. I cannot emphasize enough the importance of attending the league's organizational meetings - this is when your rules are finalized for the coming year they decide then what dates you will bowl, how much you will pay, and where your money will go, amongst many other important things. number of occasions and had attempted sexual intercourse, and that the last assault was July 30.

The suspect is a hemophiliac and requires periodic blood transfusions. He uses crutches and a wheelchair.

The girl told police she knew her father had tested positive for antibodies to the AIDS virus. When he continued to assault her, she finally decided to go to police to protect herself, she told authorities.

Court documents said the father had known for several years of the positive test. A positive test does not necessafily mean a person will contract acquired immune deficiency syndrome.

A spokesman for the Sheriff's Department said there was concern among other inmates and jailers about housing a prisoner in the County Jail who had tested positive for exposure to AIDS.

There are only two cells isolated from the rest of the jail population. While those cells are normally used for juveniles, the suspect was kept there, officials said.

Safer Sex Guidelines For Gay Men (& Everyone)

Safer sex is great sex! It can be fun, exciting—hot, horny—and completely satisfying. It is absolutely possible to continue having great sex!

WHO IS AT RISK OF AIDS?

Guidelines for safer sex should be followed by everyone. Anyone who is sexually active is at risk of exposure to the AIDS virus. The only exception is the couple who has been in an exclusively monogamous sexual relationship since 1978. To date, gay and bisexual men, IV drug users, and their sexual partners, have been most often affected by the disease.

Because many people already carry the AIDS virus (especially in New York City and other major urban areas), reducing the number of different sexual partners does not guarantee safety from exposure. All it takes is one infectious partner for exposure. But even if one has been exposed it is thought to be important to avoid repeated exposure to the virus.

Risk reduction practices must always be followed in every sexual encounter. Have all the sex you want—just be sure to always make it safer.


AIDS IS TRANSMITTED THROUGH THE EXCHANGE OF CERTAIN BODY FLUIDS—YOU CANNOT GET AIDS FROM CASUAL CONTACT (hugging, kissing, sharing bathrooms and kitchens.)

The exchange of cum and pre-cum should be avoided:

- -In oral sex
- ... avoid putting the head of the penis into your mouth
- ... never allow anyone to ejaculate into the mouth
- ... use a condom for the greatest freedom in oral sex.
- -In anal sex
- ... always use a condom, with water soluble lubricants such as KY. Some experts encourage the use of spermicida jelly containing Nonoxynol-9
- .. withdrawing before ejaculation even with a condom is safest, since a condom can break

... under no circumstances should you ejaculate semen into the anus: This may be the highest risk activity for AIDS. Use a condom.

-In vaginal sex

... always use a condom. If you use a lubricant, it should be water soluble, such as KY ... withdrawing before ejaculation, even with a condom, is safest, since a condom can

—The exchange of blood should be avoided.

-Fisting is dangerous!

... and carries the risk of AIDS transmission through the exchange of blood. If you do it, always use a rubber glove.

-If you inject drugs, never share needles, cookers, or other drug paraphernalia.

-If you are bisexual, avoid contact with menstrual flow. Use a condom.

-What about saliva?

... The virus has been isolated in saliva, though rarely and in very low concentration. The exchange of saliva is generally thought not to be a risk for AIDS.

-What about urine and feces? Although the virus could theoretically be present in any body secretion, urine, feces, sweat and tears are not known to be modes of transmission. Oral contact with fecal material (rimming) should be avoided to reduce the risk of other sexually transmitted diseases. One should use a condom, finger cot or rubber glove if giving a rectal massage. Avoid oral contact with fingers after

-Alcohol and drugs may impair your judgment and may compromise your immune system.


-Poppers (inhalants) have been linked to Kaposi's sarcoma, a cancer associated with AIDS. DON'T USE POPPERS.

Ultimately, practicing safer sex is a personal choice. These guidelines will help to give you enough information to make repsonsible choices.

Mutual masturbation, hugging, frottage (body rubbing), cuddling, showering together and massaging do not involve the exchange of body fluids, and therefore are considered safe.



7: Does s/he not only evaluate the programs you have carefully, but offer your suggestions for advanced stages of investment planning?

8: Do you feel comfortable with the planner? If not, there are more for you to choose from.

9: Does the planner give you room to think and breathe?

10: Are you presented with objective date to support the ideas offered? The success of the firm(s) recommended, etc.?

immune deficiency syndrome during 1991, most of them people who are infected now but do not know it. By comparison, auto accidents killed 45,7000 people in 1985, according to the National Safety Council.

The health agency also predicted that 145,000 people will be sick with AIDS in 1991 and that treating them will cost \$8 to \$16 billion during the year.

"The numbers . . . are staggering," said Donald Ian Macdonald, a physician who heads the agency. "This is a major problem, probably beger than the Public Health Service . . . These numbers make it very clear that our work must be intensified."

New Gay And Lesbian Program In Pacific Northwest

Seattle (N.Y. Native) — The American Friends Service Committee (AFSC), a Quacker peace and justice organization, has announced a new regional gay and lesbian program.

The program, possible the first of its kind in the country, will begin in September 1986, in the Pacif c Northwest. A national search is now under way to select staff for the Seattle and Portland offices.

The AFS C designed the program to contribute to the empowerment of the gay and lesbian cornuunity by supporting its efforts and priorities, addressing pertinent issues, and working to overcome injustice in the Pacific Northwest.

A program goal is to establish and facilitate a network of concerned and informed people and organizations in the religious community, which can respond to needs articulated by gay and lesbian communities and challer ge conservative religious opposition to gay and lesbian rights.

ing" was held in New York City to begin planning for a march, Floyd said. Along with openly gay Minneapolis City Council member Brian Coyle, Floyd attended the New York meeting. "Idon't dispute the need for a March, but I was disappointed by the group's failure to understand the necessity of broad consultation prior to the decision." He noted that fewer than a third of those at the July meeting were from outside the greater New York area.

Floyd said that the "Forward in Unity" conference might well provide a broad base of support for the national march, "but even more importantly, it will be a start at planning for the long term follow up that will be nessary to consolidate whatever gains may result from the March on Washington."

Coyle underlined the importance of both the march and the conference. "The AIDS crisis and the recent Supreme Court decision confront us with a real challenge. It's of vital importance not only to plan action at our legislatures and in Washington, D.C., but also to develop a variety of tactics and new leadership to reinvigorate our movement."

Emma Hixson added, "We hope that this conference will be as broadly reflective of the lesbian and gay communities as it can be. We are committed to full participation by women and by people of color, and we are working to keep costs at a level that will not be a barrier."

AIDS May Surpass Traffic Toll

Washington, D.C. (Milw. Sentinel) — More people will die of AIDS five years from now than were killed in traffic accidents last year, the Public Health Service predicted, in calling for a national commission to guide America's response to the deadly illness.

The agency projected that 54,000 victims will die as a result of AIDS, or acquired

Spotlight Scores Again With 'Dreamgirls'

The Spotlight Series has definitely spoiled Milwaukee theatre audiences this summer with two stellar productions. First, they brought us 'La Cage' and now a spectacular production of 'Dreamgirls.'

If I could give Tony Awards for Best Performance in Milwaukee, I'd give the one for Best Actor to Keene Curtis for his portrayal of Albin in 'La Cage', and the Best Actress Award to the brilliant Sharon Brown, for her performance as Effie, in 'Dreamgirls.' Her renditions of the ever popular "And I Am Telling You I'm Not Going" and "I Am Changing" were marvelous! She superbly brought down the house on more than one occasion. Bravo to you, Sharon!

The show is about dreams. As Langsdon Hughes so eloquently said, "When dreams die, life is a broken-winged bird that cannot fly." So too is the message of this show. Dreamgirls and others, as they seek their

dream and the joy and sorrows that abounds for them in the process. Hughes was right.

As Michael Bennett's show notes explain, "Dreamgirls' is not just about the singing and the dancing and the performing. The play is also about the behind-the scenes reality of the entertainment industry." This sometimes seamy side of the business is not so glamorous and mixes not to well with dreams and the DREAMS.

Larry Stewart is truly capable as the manager who gets what's coming to him. Herbert L. Rawlings, Jr. as James Thunder Early is also quite good. His singing and dancing are certainly up to the challenge of recreating a 60's singing soul marvel.

All the DREAMS cast are good. Deena who replaces Effie was aptly played by Alisa Gyse. She is beautiful and talented and handles the conflict in her role extremely convincingly.

My only criticism of the show dealt with sound. From where I was seated, many of Continued on page 22 •

the lines seemed to be garbled. However as much of the show is written in almost an operatic fashion, perhaps the singers could have enunciated better.

The costumes of Theoni V. Alredge who also designed 'La Cage' are beautiful. Combined with the functional set pieces and the four revolving light columns, a truly workable environment was created for this story to develop.

The able direction of Michael Bennet and the co-choreography of Michael Peters blended with a cast of most competent performers creating the perfect complement for theatre magic.

'Little Shop of Horrors'

On a recent Chicago getaway and on the recommendation of friends, I had the opportunity to catch an extremely interesting production of 'Little Shop of Horrors' at the Candlelight Dinner Playhouse.

Candlelight's producer, William Pullinski, originated the dinner playhouse concept with the first dinner theatre in the country in Washington twenty-five years ago. The Chicago site opened in 1961.

Having had to consume less than wonderful meals at such establishments, I went there with my lover, somewhat hesitatingly. Surprisingly, we were served quite a decent meal and shared a table for four with a charming straight couple.

The show itself was just good fin! It is loosely based on a 1960 Roger Corman horror flick about a man-eating plant. (Yes, that's right) The plant named Audrey II (or should I say all four of the plants) were designed by Martin P. Robinson and the two actors who manipulated and gave it a voice persona, were a wonderful team who blended most convincingly.

The lead male, Seymour, was played by Bill Walters, the understudy for the role, in an adequate fashion.

Audrey, for whom the plant is named, was a typical dumb blonde of the period. She was played very well by Hollis Resnik. Her rendition of the period song, "Something That's Green" was performed so as to give the character an added dimension beyond that of the type she was portraying.

The trio of Black girls (Chiffon, Crystal

and Ronnettee) who created much of the 50's style sound were most entertaining.

Dale Morgan portrayed the AC-DC Dentist but didn't reach the dimensions created by his girlfriend in getting beyond his typed character. He gave us the characterization we expected and wasn't able to bring more to the role. He played many roles, including one in drag, and they afforded him ample opportunity to have fun. Hewever, quantity does not necessarily bring quality.

Lastly, with such summer fun offered, I can't think why the Melody Top production staff would have removed this show from their line-up. The film musical won't be released until Christmas and it sold and worked for a wide audience appeal the night we enjoyed it. It should have remained for Milwaukee presentation. It would have brought this wider appeal, much needed at the Top, to it. So, see it in Chicago. It's delightful!

and Recognizing and Addressing Internalized Homophobia in Our Organizations, Leadership for a New Age, and Can Activists also be Friends and Lovers?

Co-coordinator Emma Hixson described the event as "an important resource for both emerging and experienced leadership." She said, "Without discounting the importance of actions and ideas originating on the East or West Coasts, most of the gay men and lesbians in this country live somewhere between the coasts. We think this conference offers us a particular opportunity to be heard, to share ideas with one another, to interact with national leaders, and to participate in strengthening our movement. We see this meeting as a catalytic event in the development of our movement."

"When we began meeting in May," commented co-coordinator Morris Floyd, we viewed this event as a time when we could come together to build an agenda and, in the context of that agenda, decide whether another March on Washington would serve our movement well at this time."

The study found 20 percent of gay men surveyed had brothers who were "predominantly or exclusively homosexual," compared to four percent of heterosexual men, said Richard C. Pillard, professor of psychiatry at Boston University School of Medicine.

"We conclude that being a gay male is a familia trait. It isn't just randomly distributed," said Pillard, who published the study with co-author James C. Weinrich in the Archives of General Psychiatry.

Discussing the strong familia component to homosexuality, the study said a genetic influence could possibly reinforce environmentally influenced behavior.

And while the study cannot determine whether homosexuality is a genetic trait, Pillard noted "the possibility is still open."

Gay and Lesbian Leaders Call For National Grassroots Planning Conference

Minneapolis — Lesbian and gay leaders in Minneapolis-Saint Paul have called for a national conference of grassroots lesbian and gay leadership "to organize and develop leadership at the grassroots level for dramatic and sustained actions in months and years ahead." The conference is planned to "enable joint action in areas where there is broad agreement as to priority and strategy through an identified and empowered leadership network."

Men Arrested For Sodomy

Boston (Windy City Times) — Two weeks after the U.S. Supreme Court upheld the legality of state sodomy laws, two men were arrested here for "sodomy and buggery." The felony charges, although later reduced to charges of "unnatural and lascivious acts," could have resulted in maximum prison sentences of 20 years. Unnatural and lascivious behavior, also a felony, can result in a maximum prison sentence of five years and a \$1000 fine.

According to police reports, the two men were spotted July 10, "committing the act of sodomy," by Monsignor Vincent Mackay at Saint Cecilia's Church. The lawyer for one of the defendants, Kevin Delehanty, said the men were engaging in anal intercourse in the church courtyard near the vicinity of a statue of the "Madonna." Mackay called the police, who apprehended the two men and charged them with "sodomy and buggery."

Arresting officer Robert Baird said he could not comment on the case because "the timing's not great in terms of the recent federal court (sodomy) decision and

Following arraignment, one of the men, unable to come up with \$50 bail, was held in jail until the July 21 court date. The other man was released under personal recognizance after paying \$500 bail. The rationale for the discrepancy in bail amounts levied is unclear.

Both men waived their right to a trial by jury and were found guilty by Judge Charles Johnson in Boston Municipal Court. They were placed on probation until October 22.

It is hoped that this survey will eventually serve to link Wisconsin's disabled lesbians and gay men in a supportive, informational network, and that this link will improve awareness and enjoyment of life for a very significant part of our state's gay and lesbian population.
