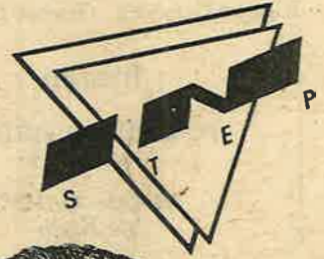

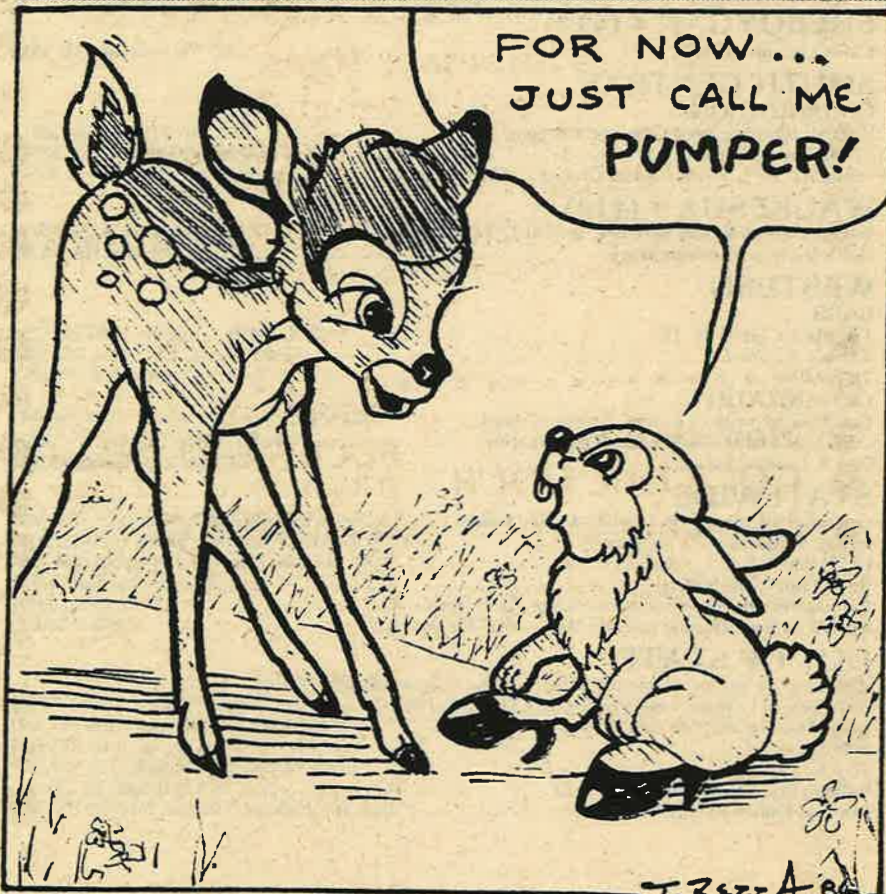

## State Outlines Plan To Fight AIDS

Madison, Wis. (Milw. Journal) — A campaign for reducing the spread of AIDS is being mapped by state health officials.

Also under discussion is an expansion of Medicaid eligibility in the state to cover more care for AIDS victims.

Part of the campaign for reducing the spread of AIDS is a voluntary program of identifying and notifying the sexual partners of AIDS victims and people who carry the AIDS virus, as recommended by a public health task force this summer.

"We are taking what they said very seriously," said Kathryn Morrison, administrator of the State Division of Health.

James Vergeront, of the health division, estimated that in five years, there would be a tenfold increase in the number of AIDS cases in Wisconsin.

Linda Reivitz, secretary of the State Department of Health and Social Services, has supported tracing the sexual contacts of AIDS carriers as the chief means available to public health officials for curbing the spread of AIDS.

But gay groups have objected to the plan, saying the names of partners of AIDS victims could become public.

A study of state AIDS cases found that 90 were thought to have been transmitted via homosexual contact, 5 through blood-transfusions or injection of blood-clotting agents, 2 through illegal drug use and 2 through heterosexual contact.

Health officials estimate that 75 to 100 people are carrying the AIDS virus for every AIDS case that is diagnosed. Not all the carriers of the virus will contract the disease.

The state would try to trace the sexual partners of people diagnosed as having AIDS and those who have tested positive for the HTLV-III virus that causes AIDS, at a cost of roughly \$100,000 a year.

If an AIDS carrier chose not to notify a partner personally, a specially trained state employee would do so and suggest precautions to avoid spreading the virus, Morrison said.

Such a procedure would be more likely to allay fears about breaches of confidentiality than would turning the task over to a public health department in a small community, for example, state officials say.

Vergeront said money for 30 testing and counseling sites where blood tests for the HTLV-III virus are given also is in the state proposal. Federal money for operating the sites is running out, and the state would have to spend \$150,000 a year to keep them going.

The health division also wants to spend \$50,000 a year to determine the prevalence of the AIDS virus in various groups of people, \$70,000 a year for the prevention and education among intravenous drug users and in the mental health community, and \$50,000 a year for AIDS support groups.

Morrison said health officials were discussing expanding Medicaid eligibility to cover more AIDS patients as part of a general broadening of Medicaid eligibility to include more women and children, more uninsured people and more of the working poor. It would cost \$1 million or more in state money over the next two years.

## Pentagon's Rejected 689 Recruits For HIV Positive Tests

Washington (Racine Journal Times) — The Pentagon said Sept. 5 that 231 potential military recruits showed evidence of exposure to a virus associated with AIDS during the second quarter of 1986.

While those results were not an increase in the percentage of men and women testing positively, they raised to 689 the number of recruits denied admission to the services since last October as a result of AIDS testing.

The results were in a Defense Department report covering the period from April 1 to June 30. The Pentagon said it screened 158,553 new recruits during that period, finding 218 men and 13 women who tested positively for exposure to the virus.

Since beginning the blood-screening program last October, the Pentagon has tested

466,629 recruits, of whom 649 men and 40 women tested positively.

The report shows the percentage rate of positive tests has remained almost constant over the last three quarters at 1.5 cases per 1,000 individuals tested. The male rate is at 1.6 cases per 1,000, while the female rate is 0.6 cases per 1,000, the Pentagon said.

The Pentagon rate of 1.5 cases per 1,000 is higher than that being reported by civilian blood agencies, but Pentagon officials stress it is impossible to meaningfully compare such figures because of such differences as average age.

Under Pentagon guidelines, recruits who test positively are automatically denied entry to the services. The Defense Department also has begun testing men and women already on active duty. Active-duty personnel who test positively are allowed to remain in the service if medically able, but face continued medical screening and limits on their duty assignments.

## Congressional Hearing On Anti-Gay Violence To Be Held

(NGLTF) — As a result of persistent efforts by the National Gay and Lesbian Task Force (NGLTF) to focus attention on the alarmingly high incidence of anti-gay violence, the Subcommittee on Criminal Justice is chaired by Rep. John Conyers (D-MI), and is part of the House Judiciary Committee.

The hearings will focus on the scope of harassment and violence against gay men and lesbians and will examine what is — and is not — being done to remedy the problem. In addition to Rep. Conyers, the Subcommittee consists of seven members: Rep. Don Edwards (D-CA), Rep. Howard Berman (D-CA), Rep. Frederick Boucher (D-VA), Rep. John Bryant (D-TX), Rep. George Gekas (R-PA), Rep. Patrick Swindall (R-GA), Rep. Howard Coble (R-NC).

"Violence against gay and lesbian people is a national epidemic," said Kevin Berill, Director of NGLTF's Violence Project. "The Subcommittee's hearings are timely and meet a glaring need. We hope they will raise public awareness about anti-gay violence and lead to concrete action by government on all levels to response to this much overlooked and underestimated problem."

In 1984, the Violence Project of the Task Force released the first national study of anti-gay violence, which was conducted in cooperation with gay and lesbian organizations in eight U.S. cities. Of the nearly 2,100 respondents, more than 90% had experienced some type of victimization because of their sexual orientation.

In order to ensure that a wide range of perspectives are addressed, NGLTF urges gay and lesbian organizations to submit written testimony to the Subcommittee. Groups that have compiled data on anti-gay violence (including police abuse) or that have documented specific incidents are encouraged to include this information in their testimony. Individuals who have been victimized because of their sexual orientation are also invited to record their experiences for the Subcommittee.

Organizations submitting testimony are asked to:

- Describe the nature and extent of anti-gay harassment and violence locally (including victimization in school and on campus, in the workplace, in jails and prisons, on the street, and in the home);
- Describe the response — or lack of response — to the problem by law enforcement, criminal justice, and social service agencies; and
- List recommendations on ways to curb the problem and ensure that gay and lesbian crime victims are treated fairly.

Testimony should be sent to Representative John Conyers, Chairman, Subcommittee on Criminal Justice, House Annex II, Washington, D.C. 20515. Testimony should be received not later than October 3, 1986. (If possible, please send testimony to the Subcommittee before September 25.) ## Nevada Supreme Court Hears Sodomy Case

(GLC Voice) — National Gay Rights Advocates presented oral arguments to the Nevada Supreme Court on Wednesday, September 10, 1986 in a case challenging the validity of the state's sodomy statute. The case is the first to be argued in a state court since the U.S. Supreme Court upheld the

Georgia sodomy law this summer.

Same gender sexual activity in Nevada is a felony punishable by 6 years in prison. NGRA filed suit in September of last year alleging that the sodomy statute is unconstitutional. However, the District Court dismissed the suit, stating it lacked jurisdiction since the plaintiffs had not been arrested. •

## 'Poppers' Appeal Planned

(Wis. State Journal) — A ruling by a Dane County judge last month that a state agency did not have the authority to ban nutyl nitrite will be appealed.

Butyl nitrite, marketed as a "room odorizer" but used as a recreational inhalant, was not sold in Wisconsin since February, when the Department of Agriculture, Trade and Consumer protection banned it as a hazardous substance. Dane County Circuit Judge Michael Nowakowski ruled on Aug. 4 that the department had no authority to ban the sale of the substance because it is a drug.

Jane Jansen, of the department's consumer-protection division, said that the

ruling will be appealed. "We don't feel that this is the last straw," she said. "... We feel the substance is one that should be banned. We did not find it to be a drug; we found it to be a hazardous substance, and, because of that, it should be banned. Even the manufacturer says it is a household substance, not a drug."

The department was backed by Wisconsin's drug-abuse agencies in seeking the ban, based on reports of the substance being used by school children and being connected with the death of at least one person, a Mount Horeb attorney.

Nowakowski's ruling was made on a lawsuit filed in February by Great Lakes Products of Indianapolis, Ind., charging that the state exceeded its authority in banning the product. The company said it had sales of \$10,000 in Wisconsin last year. •

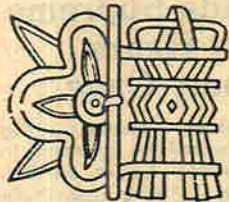

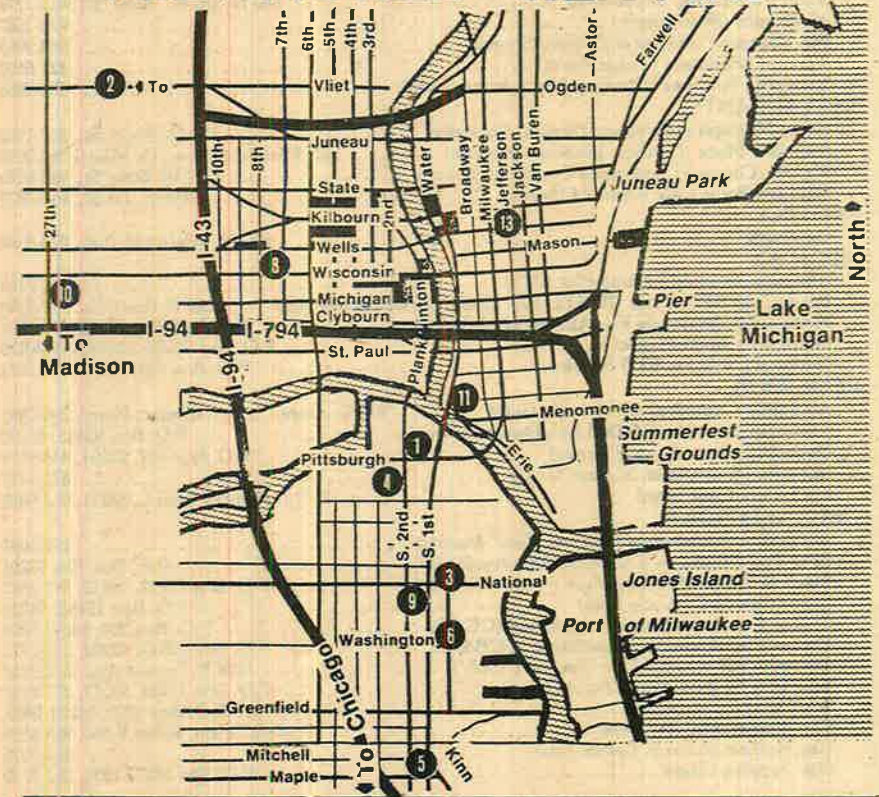

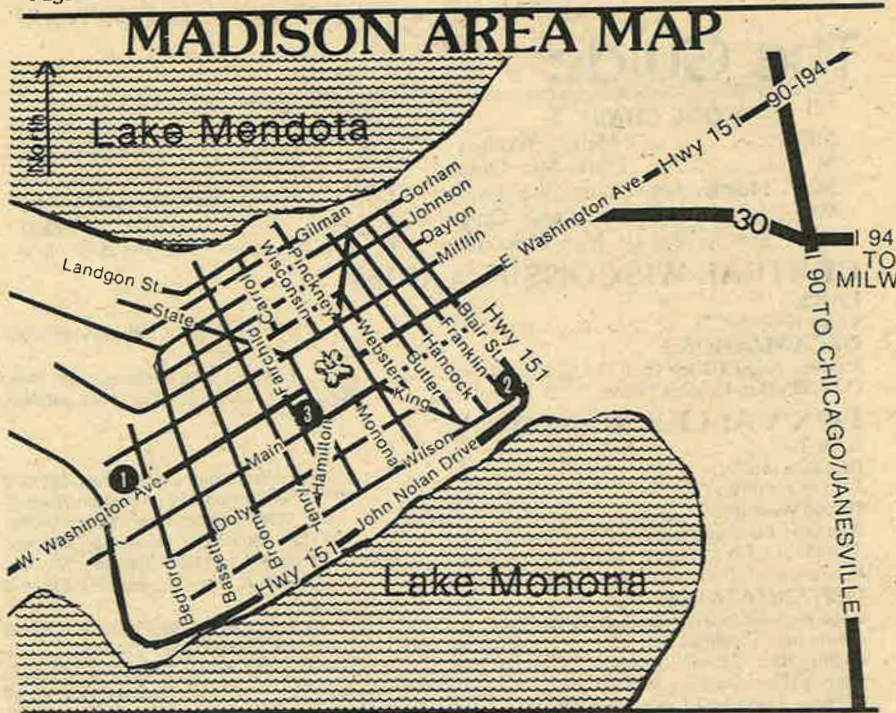

## Pushing Deukmejian On AIDS Bias

Sacramento (GCN) — This state has approved legislation barring job and housing discrimination against people with AIDS, according to the Boston Globe.

The measure was approved by the State Assembly by a vote of 42 to 30 and was sent to Gov. George Deukmejian. The bill had passed previously in the State Senate.

In July Gov. Deukmejian vetoed a similar bill, saying there was "no compelling need for the legislation." He also said that the measure incorrectly focused on AIDS and did not include other physical maladies that are officially recognized handicaps.

The new legislation however, includes a lengthy list of physical illness, including AIDS. Assemblyman Art Agnos, Democrat from San Francisco, said he hoped the change would lead Gov. Deukmejian to sign the bill.

## Judge Rules Anti-Gay Insurance Discrimination Illegal

San Francisco (GLC Voice) — For the first time in the nation's history, a judge has ruled that an insurance company is subject to laws which prohibit discrimination on the basis of sexual orientation. The ruling, in *National Gay Rights Advocate v. Great Republic Life Insurance Co.*, came in response to a motion by Great Republic to have the case dismissed as a matter of law. San Francisco Superior Court Judge Lucy Kelly McCabe rejected Great Republic's arguments that California's Unruh Civil Rights Act, a state insurance regulation, and San Francisco's gay right ordinance do not prohibit anti-gay discrimination by insurance companies. The case will now proceed to trial, where Great Republic must show that if does not, in fact, discriminate against gay men.

**Gay Progressive  
Candidate Could Win  
In Chicago**

Chicago (GCN) — For the first time here, an openly gay man running for office is considered a strong contender. Ron Sable, a progressive activist, will challenge incumbent Bernie Hansen in the February election for alderperson of this city's heavily lesbian and gay 44th ward.

Sable's campaign comes in the wake of a highly visible, but unsuccessful campaign to pass a city ordinance banning discrimination against lesbian and gay men. But while Sable can probably count on support from the newly organized lesbian and gay community, Hansen enjoys strong financial support from the ward's business interests. In addition, Sable is considered politically naive even by his most ardent supporters. As one of his campaign workers said, "Ron Sable is not a politician. This is his greatest strength and his worst weakness."

Sable, a physician, is known in the lesbian and gay community primarily for his work with people with AIDS at the Sable-Sherer clinic of Cook County Hospital. But he has also worked on a number of other issues, including organizing a Coors beer boycott contingent for the 1985 Chicago Pride Parade, serving as a member of the Mayor's Committee on Gay and Lesbian Issues, and working with Vietnam Veterans Against the War and Physicians for Social Responsibility. Sable's campaign literature describes him as an activist committed to the "political and civil rights of women, Blacks and Hispanics as well as Gays and Lesbians." In a gay community where leaders have, until recently, been most often identified by the number of bars and bookstores they owned, Sable's activist credentials are unsurpassed.

Unlike Jim Flint, gay leader with ties to the old Daly "machine" who recently ran symbolically for a minor county office as an openly gay candidate, Sable is clearly running on a reform ticket. "Independence versus machine politics will be a key issue," said Sable, who has the full support of the city's independents and Mayor Harold Washington. "I hold a philosophy of participation and empowerment, instead of the 'we'll take care of you' approach of the 'machine'. Services should be provided as matter of right and not as a favor."

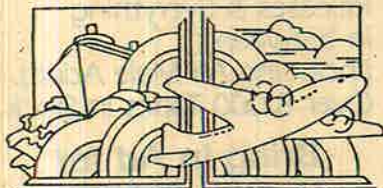

## To Your Health...AZT

by Michael McFadden

The recent announcement that AZT will be released for wider use in the treatment of AIDS is good news. AZT (azidothymidine) inhibits the reproduction of HIV (human immunodeficiency virus, formally known as HTLV III), the virus causes AIDS. The drug had been tested in a double-blind study where some patients were given AZT, while others received a placebo. From the start of the study it had been agreed that if the drug proved to be effective, it would be given to those patients receiving the placebo. Based on the results of this study, the decision was made to release the drug for wider use.

We can be happy for the persons with AIDS that AZT may help. However, we can't allow ourselves to think that AIDS is no longer a threat. AZT is not a cure. It may prolong life, but it does not eliminate the virus that causes AIDS. Also, AZT is not yet available to all persons with AIDS. Only patients who have had Pneumocystis Carinii

Pneumonia will be eligible to use AZT.

Statistics from the Division of Health show that 100 cases of AIDS have been diagnosed in Wisconsin as of September 1. 44 of those cases were reported in Milwaukee County, and 24 of those 44 are already dead. AIDS has destroyed the lives of those individuals. In addition, it has often shattered the lives of their lovers, families and friends. AIDS is a cruel disease. We must not be lulled into a false sense of security by the promising reports on AZT.

Education is still our best defense against AIDS. If you have questions about AIDS and live in the metropolitan Milwaukee area, call 273-AIDS. If you live outside this area, call 1-800-334-AIDS. If you or someone you know may be eligible for treatment with AZT call the national AZT hotline — 1-800-843-9388 for more information.

Finally, please play safe, and stay healthy.

## Parasite Linked To Occurrence Of AIDS

(GLC Voice) — A researcher at the University of Virginia has called for gay men to undergo testing and treatment for an intestinal parasite that is now suspected as a trigger that may activate the HTLV-3 virus in those infected.

In a letter appearing in the *New England Journal of Medicine*, Dr. William Petri of the university's School of Medicine wrote that gays should be tested for *entamoeba histolytica*. Petri said that gays who test positive for the HTLV-3 antibody receive routine treatment for the amoeba because, he believes, it is potentially dangerous as a stimulant to the virus.

"If you look at San Francisco several years before they had the AIDS epidemic," Petri said in his letter, according to a report by United Press International, "they had an epidemic of *entamoeba histolytica*. We're speculating that this infection, or other intestinal parasites, can stimulate the T-cells where the virus is in a latent state and cause the virus to be expressed."


In lab tests, said Petri, the amoeba stimulates T-cells in the blood, which are those the HTLV-3 virus invades.

### "Sister Mary Ignatius Explains It All For You"

Theatre Tesseract began its 1986-87 season with the revival of two satirical one act plays. Both "The Actor's Nightmare" and "Sister Mary Ignatius . . ." were written by Christopher Durang and the second play was a hit off-Broadway and both played to capacity houses for Tesseract two years ago.

"The Actor's Nightmare" is a funny happening to an accountant, ably played by Andrew Brhel, who is flung into a number of theatrical pieces for which he is totally unprepared. Though this situation for an actor is thought to be the worst experience possible, it does make for a fun-filled light piece. In fact, just the proper vehicle to prepare for the deadly serious, "Sister Mary Ignatius . . ."

"Sister Mary Ignatius . . ." is a bitter, cynically written play by the author as a commentary on his parochial school upbringing. Though much of the foolishness of the period is laughed away, (I know, I was there too), and the excesses mimicked, still there remains behind the jokes and barbs, a bitter and angry man.

The situation of the play portrays adults angered by childhood experience with the nun who returns to the "scene of the crime" to confront her. Unfortunately, she too is the product of her own twisted background which makes us pity her all the more.

However, in the American church today, the flack over the dismissal of the noted Charles Curran for his moral views including those on gays and the Seattle diocesan

upheaval which includes gay rights issues, makes one rhetorically question, "Haven't things changed at all?"

Larry Kale's direction is good but its very clear that the star of the evening is Jennifer Lerner, as Sister Mary Ignatius. She is on target and takes full control of her role, the show, the other actors, along with the audience and never gives up for a second. She is phenomenal!

Was it well done? Yes. Did I like it? Quite frankly, no. I'm very tired of those who fling accusations at a past that can't be relieved or who wallow to too great an extent in previous times and behaviors. To Durang, I wanted to say, "Grow up!" and "Get on with it!" Don't be angry if the answers were given before the questions were asked. If you don't like the cards dealt either reshuffle or change the game but don't whine and pout. That's a thinking adult's response to such a problematic situation. Only a child throws a tantrum.

## Our Story

### Another Side Of 'Lawrence Of Arabia'

Wars produce their heroes, and World War I was no exception. But of the many, none was more romantic or romanticized than Thomas Edward Lawrence, better known as Lawrence of Arabia.

Born in 1888 to a family of the English gentry, he attended Oxford and then undertook archaeological work in the mid-east. There, as Richard Aldington, one of his biographers writes, he absorbed Arab culture as if born to it. And it was there that he met an Arab youth named Dahoum. By Lawrence's own description, Dahoum was beautiful. Were they in love? Well, if not, what existed between them could certainly have passed for it. Lawrence named him "Sheik Ahmed" and never left his side. In 1913, he took the young man to England. The English, being English, professed to see absolutely nothing to be remarked over regarding the closeness of the blond, blue-eyed Lawrence and his darkly handsome Arab companion.

The bit of unpleasantness known as World War I broke out and Lawrence and Dahoum returned to the Arab lands. The area was then part of the Turkish Empire, an ally of Germany. Lawrence, because of his knowledge of the area and its people, was chosen by the British government to aid and advise the Arabs in their revolt against Turkey.

Lawrence performed brilliantly. As a close advisor to Prince Feisal, leader of the Arabs, he helped to organize them against the Turks. By this time, he had "gone native" and in his picture presents the image of a dashing robed figure, difficult to distinguish from his Arab companions.

He rode with Feisal, Dahoum at his side, out of Arabia and north into the Turkish provinces of Palestine and Syria. Everywhere the Turks were confounded. "El Orens," as they called him, had a high price on his head.

In November, 1917, T.E. Lawrence was captured by the Turks. He was taken to the house of the officer in charge where, by his own account, he was stripped, tied, beaten,

and raped. Incidentally, the tale is Lawrence's own and is told in such "interesting" detail and with all due protests over how outraged he was over the whole matter that one has to wonder.

The following morning, he was, for some reason, released, and rejoined Feisal's army.

Meanwhile, Dahoum died with the Allied victory, Lawrence returned to England. He attempted to find further military employment but failed. He then turned to writing his memoirs, *The Seven Pillars of Wisdom*. By this time, he was a hero known throughout the world. His book attempted to gild the lily. Still, it is interesting not so much as a history but for what it says about Lawrence.

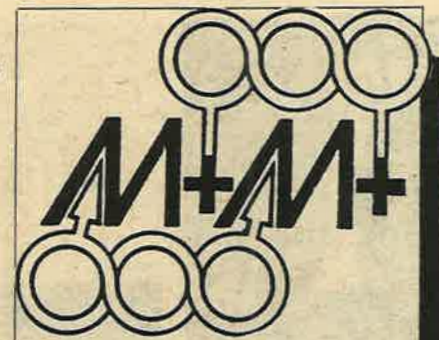
He describes lovingly the affection between two Arab youths named Daud and Farraj and glorifies such relationships. He writes of them that they are "manly loves of a depth and force beyond our flesh-steeped conceit." This may be so, but he admits that if sexuality does enter in, these relationships are "like marriage."

Daud and Farraj may or may not have existed. As with Lawrence's description of his rape, it's hard to tell. But the important thing is that the impression that is gained is of a man writing about what he has experienced and remembers fondly.

Finishing the work, he dedicated it to "S.A." The dedication was followed with a poem by Lawrence which reads in part:

"I love you, so I drew these tides of men into my hands and wrote my will across the sky in stars/Love, the way-weary, groped to your body, our brief wage ours for the moment."

As might be expected, there was much speculation at the time as to the identity of "S.A." Lawrence never said and in 1935, he was killed in a motorcycle accident near his home. Today, there is general agreement among his biographers that Lawrence dedicated his book of memoirs to the one person he had loved above all others—that "S.A." was his own Sheik Ahmed.

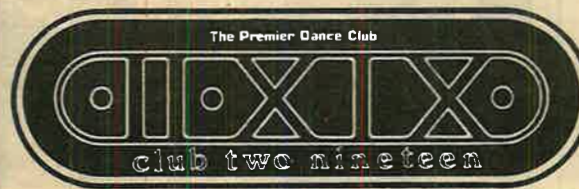


The **Ballgame** crowned Vanessa in their

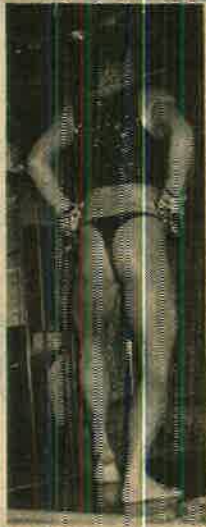
