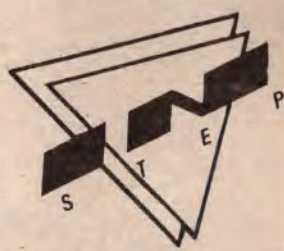

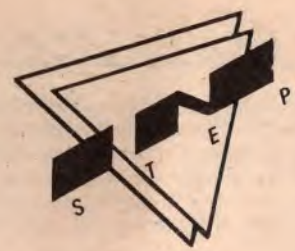

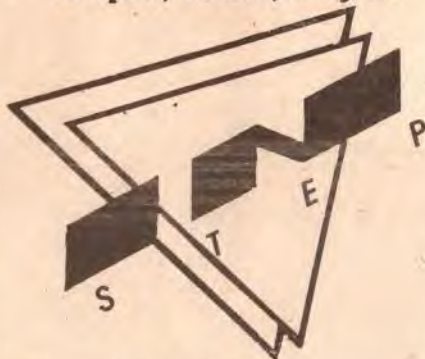
Cover Story

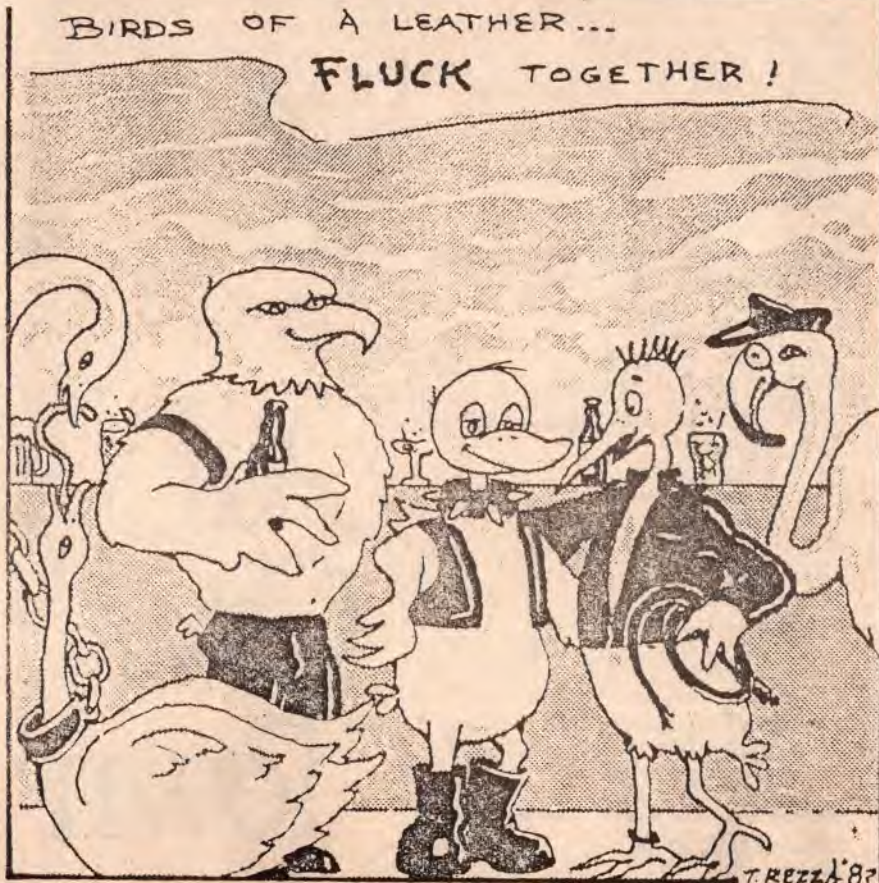

Task Force Launches Gay/Lesbian Opposition To Bork

[NGLTF]- The National Gay & Lesbian Task Force (NGLTF) is actively opposing the nomination of Robert H. Bork to the U.S. Supreme Court. NGLTF Executive Director Jeffrey Levi announced that the Task Force will strenuously fight the nomination as part of a broad-based coalition of civil rights groups.

"Judge Bork has proven himself to be a biased ideologue," said Levi. "His nomination for this position of great power and trust betrays the American tradition of fundamental fairness and equal protection under the law for diverse minorities."

Levi announced a five-part NGLTF strategy to work for the defeat of Bork's nomination. "We will lobby the Senate against the nomination in coalition with the Alliance for Justice and the Leadership Conference for Civil Rights. We plan to testify at the confirmation hearings. We will work hard to build constituent pressure against this nomination. We'll be educating the media about the homophobia of Bork's decisions. And perhaps, most importantly, we will be strengthening our community organizing efforts at the state level, where many of the legal and legislative battles will be fought."

Bork was the author of a decision upholding the discharge of a gay Naval officer, "Dronenberg v. Zech." In an opinion that anticipated the Supreme Court's reasoning in "Bowers v. Hardwick," Bork held that the right to privacy does not encompass private consensual homosexual conduct.

A subscriber to the far-right doctrine of "original intent," Bork believes that the Constitution must be interpreted strictly in accordance with what the "founders" intended.

Bork disagrees with the existing test for political speech which protects people's rights to express opinions that are hostile to the government unless there is a "clear and present danger" shown from such

speech.

Thompson Calls for Penalties

Madison [Milw. Sentinel]- Gov. Thompson last week said he wanted criminal penalties for people who knowingly spread the AIDS virus.

Thompson said he would ask the Legislature this fall to approve a law that would punish people who know they are infected with the AIDS virus if they sell blood, engage in prostitution or assault other people in a way that could transmit the virus.

"To knowingly transmit it to others clearly ought to be considered a criminal act," Thompson said.

He was reacting to recent incidents in which people with the acquired immune deficiency syndrome virus "consciously and deliberately sought to expose others to infection."

That behavior will not be tolerated in Wisconsin, Thompson said.

He suggested one reason for pushing the legislation was an incident May 30 at the Green Bay Correctional Institution. An inmate there who had tested positive for exposure to the AIDS virus was charged with battery for allegedly biting and scratching an officer.

This spring, Thompson called for mandatory testing of prison inmates for the AIDS virus, but later modified that position, calling for tests only of inmates who were assaultive.

Prison guards and other law enforcement officials have pressed for testing of inmates.

Thompson said he would defer to the Legislature to determine the penalty for deliberately spreading AIDS.

**Fairness Funds Sets Up
New Action Hotline**

Washington [Fairness Fund]- The Washington-based Fairness Fund began operating a new national Action Hotline, the beginning of July to generate thousands of mailgrams on AIDS-related issues to members of Congress, Rodger McFarlane, Fairness Fund Board Member and former executive director of Gay Men's Health Crisis (GMHC), announced this week.

The new Action Hotlines will be featured in major gay/lesbian media advertisements beginning this month, he said. In addition, the Fairness Fund will be mailing announcements to AIDS service organizations, to gay/lesbian groups/activists and to gay/lesbian business establishments.

Callers will be able to dial, toll-free, 1-800-325-6000 (day or night) and ask for an operator (9184) who will read them three, 50-word mailgram messages on AIDS issues that community lobbyists have identified as crucial for Congressional action. The messages will cost \$4.50 and will be billed to the caller's personal telephone number.

Current messages available from the mailgram service call for a "New Manhattan Project on AIDS," a reference to the all-out U.S. effort in the 1940's to create an atomic weapon. Just such a no-holds barred approach is needed now to combat the AIDS crisis, gay/lesbian activists urge.

The Project's primary goals are to accelerate research, increase drug availability and provide the best care possible for people with AIDS.

The Project also supports efforts to promote an effective national AIDS education program and enactment of laws to protect the confidentiality of and prohibiting discrimination against people infected with the HIV virus.

Additionally, a second toll-free 800 number (1-800-325-6500, Operator 9188) has been established to generate mailgrams to the U.S. Senate opposing Robert Bork's nomination to the Supreme Court.

"Our right-wing opponents successfully exploit the health crisis for political gain, mobilize massive mail campaigns and generate tremendous pressure on legisla-

tors," Endean said. "But these same legislators — even on life and death issues such as AIDS — receive little or no mail or constituent pressure from the majority of voters in their districts who support our efforts." Constituent mail in favor of gay/lesbian issues has historically been scant, said Steve Endean, Executive Director of the Fairness Fund.

"While our community's advocates are doing an excellent job in the media and in the halls of Congress, our opponents work the streets and avenues of the districts across the country. As a result, legislators too often are afraid to stand with us on controversial or emotional issues. We simply must translate the opinion poll majorities into tangible grassroots mail," said Dan Bradley, Chair of the Fairness Fund's Advisory Committee.

The public opinion mailgrams provide just such a convenient means to reach legislators, the Fairness Fund staff believes. And since the prepared mailgrams can be changed on a regular basis (and the Fairness Fund functions in close cooperation with the Human Rights Campaign Fund and the National Gay and Lesbian Task Force), the strategy ensures timely communication to address rapidly changing legislative situations.

To ensure the most effective, coordinated constituent pressure and to avoid duplicating efforts; the Fairness Fund has secured the help and cooperation of a broad range of community leaders and groups. Prominent among them are the nation's two primary gay/lesbian lobbying groups, the Human Rights Campaign Fund (HRCF) and the National Gay and Lesbian Task Force (NGLTF).

"The Fairness Fund's mailgram campaign is a creative and exciting strategy to enlist public support. It has the Campaign Fund's enthusiastic support and cooperation," said Vic Basile, Executive Director of HRCF.

Jeff Levi, NGLTF's Executive Director, said he also supports the Public Opinion Mailgram strategy. "The Fairness Fund's grassroots mobilization strategy is a welcome addition to our lobbying efforts," he said. "The ability to translate popular support into concrete pressure is important, and I look forward to working with the project."

B.W.M.T. Retains Name

The National Association of Black and White Men Together [NABWMT] voted during their annual national convention to keep the name **Black and White Men Together**. The 7th annual convention, which was held in Milwaukee from June 28th through July 4th, held vigorous debates over a potential name change to "Men of All Colors Together" [MACT].

More than 170 registrants from across the U.S. heard various speakers, attended workshops, held caucuses, attended Chicago's Gay Pride Parade, and attended many social events, as well as enjoying Milwaukee's festive atmosphere.

The name change issue, which required a two-third majority to pass was defeated 36-32. The vote came in the middle of the convention and was announced at the banquet, along with election results. Some local chapters of B.W.M.T. have already adapted Men of All Colors Together, and will continue to go by that name, but maintain membership in the national association.

The theme of this year's convention was "Celebrating Our Life, Liberty and Happiness." Many of the workshops and speeches related to the overall theme.

The week started off with members of the national association meeting in Chicago to march in that city's Gay Pride Parade. After the parade, the Chicago chapter of BWMT hosted a reception at Ann Sathers Restaurant that featured a presentation by Dr. John Bush, who spoke on "Homosexual Rights." As Milw. Co-Chair Mike Lisowski said, "John Bush sledgehammered us out of our complacency and security. I have never seen John so animated and so demonstrative."

On Monday, June 29, and Tuesday the 30th, the National Board and the House of Delegates (delegates from each member city) met at Milwaukee's Park East Hotel and held numerous meetings. Some of the topics discussed included plans for next year's convention in Boston, and formulating plans for the October March on Washington. (NABWMT is on the March on Washington Steering Committee.) Tues-

day night, they were introduced to Milwaukee via a lakefront cruise on the Iroquois. The festive trip included a shore-call just off the Summerfest grounds, a tour of the marina, and a venture out beyond the breakwater. The water was a bit choppy for dancing, and the boat quickly re-entered the clamer harbour area.

Wednesday, July 1st, was the first day for all conventioners. The first speaker was author Calvin Hernton, who spoke at length about his writings on sexism and racism, and noted his new book. It's due out in August from Doubleday and entitled "The Sexual Mountain and Black Women Writers: Adventures in Sex, Literature, and Real Life". After his speech members separated by race into separate caucuses to discuss their views on racism and their personal sexual lives. However, much of the discussion ended centering around the potential name change and arguments for and against.

Thursday was an all day presentation and series of workshops by University of Illinois professor of Communications Thomas Kochman, well known for his breakthrough book "Black and White Styles in Conflict". Kochman rarely addressed the issues of gay interracial relationships, but his discussions of race relations led to separate black and white workshops where members delved into their racial feelings. The discussions formed the heart of BWMT's overall mission and of the need to challenge and counteract racial misunderstanding, especially those brought about through cultural differences. Thursday night members held a B.W.M.T. Talent show at Milwaukee's popular Club 219. The high caliber talent exhibited rocked the bar, and was filmed by Milwaukee Gay Cable for future programming.

Friday saw various speakers urge the audience to take direct, concrete action to redress racial and social inequities. There were workshops on AIDs and other health issues. Speakers included James Credle of New York (National Co-Chair), who criticized the media and gay movement for overlooking the impact of AIDs on Africa, workshops were conducted by BWMT co-founder Mike Smith, and M.A.P.'s Brother Ben Johnson.

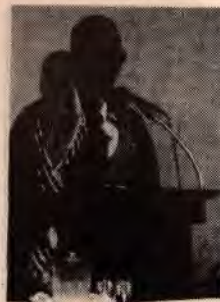

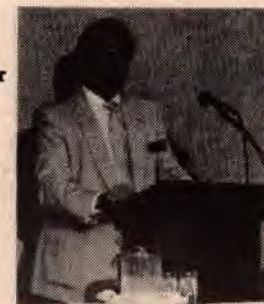

Also on Friday afternoon there was a candidates forum for elections to N.A.B.-W.M.T.'s board and for officer positions. That night, conventioners retired to Milwaukee's lakefront for volleyball, and to watch our city's dazzling fireworks.

Saturday, Wisconsin activist Leon Rouse, and former Gov. Earl's press secretary Ron McCrea, gave presentations on the passage and implementation of Wisconsin's gay rights law. In addition, David Fair, a Philadelphia activist, spoke urging the gay movement and B.W.M.T. to act on our tendency to ignore the poor in our midst as well as the homeless. He urged us to think that if Gays and Lesbians make up 10% of the population, then we also compose 10% of the poor, homeless, and uninsured. His viewpoints hit home with many in the audience. The afternoon session concluded with a memorial service dedicated to those of our community who have passed away, many from complications associated with AIDS.

The Saturday evening farewell banquet featured the very controversial Joseph Beam, editor of the black gay anthology, "In the Life". Beam stressed black on black relationships, causing some minor uproar. He riled up the audience but they gave him polite applause. Afterwords election results were announced with two non-black, non-white candidates for the first time winning seats on the board — Nelson Rivera and Gilbert Mangoang. The candidacy of Mangoang was even more unusual because he is not affiliated with a chapter, and was elected at large. Named national secretary was Ollie Lee Taylor and treasurer Bob Addison, both incumbents. Others elected to the board were Mitchell Karp, David Lott, Don Moses, John Teamer and Gavin Morrow-Hall. They will serve two year terms.

County Gives MAP/ ARCW \$36,460

[In Step]- At deadline time the full county board voted unanimously last week to give the Milwaukee AIDS Project/AIDS Resource Center of Wisconsin \$36,460. ARCW had originally asked the county for \$69,200 to match City of Milwaukee funding, however, the County provided a

little over half that amount because half of the year has already passed.

The money will be distributed in the following manner: \$14,834 will help the Milw. Co. Medical Complex to provide a full time Case manager (instead of the present half-time). It also provides \$11,626 for a full time Health Educator who will provide on-site training to fellow medical professionals. The remaining \$10,000 will provide emergency funds to the Dept. of Social Services for In-Home Services to terminally ill AIDS patients.

MISL Honored for Innovative Approach

[MISL]- The Madison Institute for Social Legislation was honored at the June 25 meeting of the City of Madison Women's Issues Committee for its work on alternative family benefits. The group was presented with an award for "investigating innovative employee benefits for alternative families," WIC Co-Chair Virginia Daley said. Linda Amsler, an independent insurance agent specializing in health insurance and a member of the Board of Directors, accepted the award for MISL.

MISL initiated work on alternative family rights and benefits for City employees as part of a larger package granting alternative families some of the same rights and benefits accorded families based on marriage. Under the proposal affecting City workers, the City as an employer would provide sick and bereavement leave for family partners and dependents, as well as family health care coverage. To establish eligibility, alternative families would take an oath signifying that they are in a relationship of "mutual support, caring and commitment."

Gay 'Olympics' Founder Dr. Waddell Dies

[Chicago Outlines]- Less than three weeks after the U.S. Supreme Court ruled that the U.S. Olympic Committee could refuse Gay Games organizers from using the title Gay Olympics, Gay Games founder, former U.S. Olympian Dr. Thomas Waddell, died of complications due to AIDS. He was 49 years old.

Waddell is survived by Sara Lewinstein, his wife, their 3-year-old daughter Jessica, and his parents, Gene and Hazel. Lewinstein, who worked on the Gay Games with Waddell, said, "We worked together. We were best friends. We loved each other."

Waddell, bedridden with AIDS, had said of the June 25 U.S. Supreme Court ruling: "The first phone call I got this morning was a reporter who was saying, why such a big deal over a word." I said, "why are gay people the only people in the world who can't use it? I think the Supreme Court has permanently sullied the meaning of the First Amendment. It seems that it protects only the powerful."

And added Waddell, "This isn't over yet. There is another arena that the U.S. Supreme Court has not considered and that's the political arena."

Dr. Waddell specialized in infectious diseases and was chief physician at San Francisco's Central Emergency facility until giving up his job when he was diagnosed with AIDS in June of last year. He also served on the board of the northern

California chapter of the American Civil Liberties Union.

Waddell had finished sixth in the decathlon competition during the 1968 Olympics.

He was among the people with AIDS who began treatment with the experimental drug AZT this past February.

A memorial service was held July 15. After cremation, Waddell's parents were to take his ashes back to their home in Greenwich, N.J.

Supreme Court to Hear Case of Fired CIA Employee

Washington [Chicago Outlines]- The U.S. Supreme Court agreed June 8 to hear the case of a gay employee, referred to as John Doe, who was fired by the Central Intelligence Agency, according to *The Advocate*. Said Nan Hunter of the American Civil Liberties Union, "The issue that's really the predominant issue before the Supreme Court is one that's not technically

limited or even necessarily related to homosexuality. That is the question of whether the CIA director has unreviewable authority to hire and fire people." Doe began his career at the CIA as a typist, and was eventually promoted to a covert position as an electronic technician. In 1982, Doe voluntarily told a CIA security officer that he was gay. The agency placed him on administrative leave, later informing him that his homosexuality posed a security threat, although CIA officials refused to explain why.

In other national agency news, the U.S. District Court of Appeals in Washington, D.C., directed the National Security Agency to hold an administrative hearing for a former NSA employee who was fired in 1983 after acknowledging homosexual conduct.

Employee Denied Medical Attention

Washington [Windy City Times]- A reference librarian at the Library of Congress was denied medical attention after he cut his foot because the local doctor feared he had AIDS, the *New York Times* reports. Rod Miller cut his foot on a stone jetty at the popular gay resort of Rehoboth Beach, Del., on June 28. He was forced to take an emergency helicopter to Washington because Dr. Robert Spicer, an orthopedic surgeon at Beebe Hospital in Lewes, Del., refused to operate on Miller unless he could prove that he didn't have AIDS. Spicer's lawyer said that the doctor's decision was based on his assessment that two friends who accompanied Miller to the hospital "looked effeminate," the Times said.

Partners Could Win Benefits

Philadelphia [Chicago Outlines]- The executive board of the Philadelphia Federation of Teachers has approved a resolution that would allow lovers of gay employees to receive life and health insurance benefits under the union's proposed 1988 contract, according to *The Advocate*. Under the proposed language, the term "domestic partners" would replace the word

"spouse" in the union contract. The executive board also approved adding sexual orientation to the categories covered by the contract's fair practices clause. Before the new provision can be implemented, two obstacles must be surmounted: The city school board must agree to the benefits extension, and the state Insurance Department must then approve the measure.

AIDS and Syphilis

New York [Windy City Times]- An editorial in the June 18, 1987 edition of the *New England Journal of Medicine* supports the hypothesis that syphilis may be a major problem in patients diagnosed with AIDS. In the editorial, Edmund C. Tramont, M.D., of the Walter Reed Army Medical Center concluded that there may be a problem both in testing and treating syphilis in AIDS patients. Tramont outlined two major problems: First, serologic tests may not detect the actual presence of the infecting *T. pallidum* organism in antibody-compromised AIDS patients. Second, as suggested by Johns et al, (in their paper "Alteration in the Natural History of Neurosyphilis by Concurrent Infection with the Human Immunodeficiency Virus," appearing in the same *Journal*), which antibiotic that readily crosses the blood-brain barrier in the absence of inflammation should be used to eliminate syphilis in AIDS patients? Two other articles in the

same issue of the *Journal* recount recent tests showing the frequent inability of benzathine penicillin therapy, normally prescribed for syphilis, to completely eradicate the virus. The consequences in terms of deterioration of the nervous system due to recurrence of neurosyphilis in PWAs with compromised immune systems is a subject requiring acute attention. According to the *New York Native*, the New York Committee of Concerned Physicians is attempting to educate patients and doctors on the need to treat syphilis in AIDS patients. The Committee's address is P.O. Box 4523, Highland Park, New Jersey 08904.

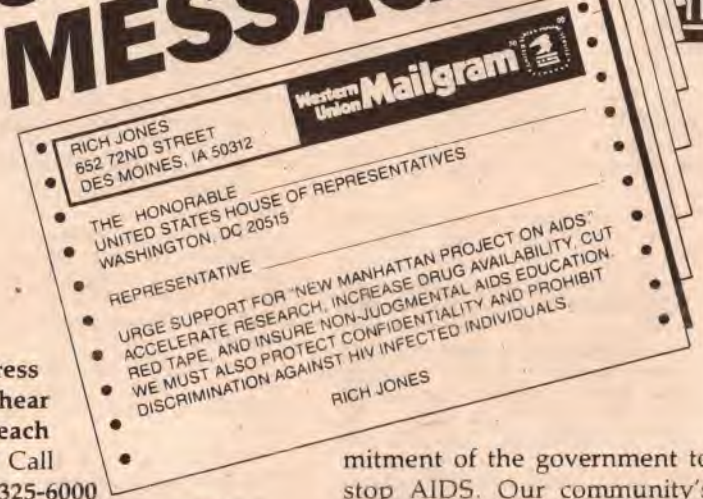

the Food and Drug Administration in May, seeking approval of a new test that measures antigens present in the AIDS virus. The antigen test provides a way to differentiate an active virus from one that is dormant.

In a related matter, a Farmingham, Mass., company called Intergrated Genetics announced a plan to commercialize a diagnostic test which could detect HIV in blood. Current tests only detect antibodies to HIV. According to the company, this test "may provide the most sensitive means to detect and monitor the level of activity of the virus." According to GCN, "For years the spector of such a test has produced intense ambivalence. Some AIDS activists have said the potential benefits to medical research must be weighed against the possibility the test would be used to gain more social control of people with AIDS." The test measures RNA, the genetic code for replication of a virus — in this case HIV. If it is effective, it will differ from other tests which measure HIV antibodies or antigens in that it would be an actual indicator of whether a person has AIDS and whether HIV infection is active. The only widely available HIV at present measures antibodies, indicating that a person has been exposed to HIV, but not whether a person will come down with AIDS.

Texas Attorney General Files Suit Over AIDS Treatment

Houston [Chicago Outlines]- Texas Attorney General Jim Mattox filed suit recently to prevent a Houston man from treating persons with AIDS and allergy victims by injecting them with their urine, according to the *Montrose Voice*. William Hitt, who operates clinics in Dallas as well as the MicroAllergy Clinic and Immunotherapy Clinic in Houston, claims the urine treatment can help persons with AIDS from contracting diseases they would otherwise catch easily. The attorney general's office began investigating Hitt in March after receiving a complaint from the state health department. The suit, filed in a Houston

state court, said the investigation showed Hitt was using a drug not approved by the Federal Food and Drug Administration or the state Health Department. Documents filed show Hitt has been treating 119 AIDS patients. The suit seeks to stop Hitt from using the treatment unless it is approved by the state, that he be ordered not to advertise that treatment will provide protection for allergy victims and people with AIDS, and that he be barred from presenting himself as a medical doctor.

AIDS Patient Flown Back From China

Manila, Philippines [Milw. Journal]- A U.S. military plane evacuated an American AIDS patient from southwestern China last week and flew him to the Philippines, a US Air Force spokeswoman said.

The plane carrying the 38-year-old patient landed at Clark Air Base at 5:50 p.m. after a flight from Kunming, Yunnan province.

Maj. Thomas Boyd, a base spokesman, said the patient would spend "a couple days in the hospital until his condition stabilizes for the long flight back" to the United States.

The patient, who works for a computer-related business in New York City, was traveling in China as a tourist when he entered the Yunnan No. 1 People's Hospital on June 18 with a high fever and respiratory illness. Tests showed he was suffering from acquired immune deficiency syndrome, a Chinese official said.

Now with the recent demise of the Melody Top, their contribution to the summer cultural life of Milwaukee is just that more important. In recent memory, we were treated to **Hello Dolly!**, **A Chorus Line**, **Dreamgirls**, and the phenomenal **La Cage** from last season. They did in fact, this summer add **Cats** to their string of hits with a near sellout!

Eliot and his "Old Possum's Book of Practical Cats" and the marriage is a rare theatrical treat. Add to it a terrific cast and the brilliance of Trevor Nunn's direction and you have a most satisfying evening of entertainment indeed.

Winter Garden Theatre, is adequate to the task of making one feel that you've been invited to the annual Jellicle Ball. The lighting effects too were effective. This is no small task for a show so dependent on the proper created atmosphere to "work". Also, remember that both had to be necessarily adapted for "the road" and touring.

A cast of actors who are constantly "working" is quite a challenge to constantly maintain. This assemblage did not hold back especially the evening on which I attended — bear in mind that they had performed a matinee that very afternoon. This is not the type of show in which the cast performs their chorus number and then disappears offstage. Rather, the cast is on stage for about 90% of the show and are almost live set pieces continuing to create the environment so that the play can continue to flow and develop. Remember that this too is extremely vital with the "road" company limitations.

A few cast standouts bear mention. Andy Spangler as Rum Tum Tugger, the Elvis-style cat, was amusing through the evening though not always consistent in character. The dancing antics of Michael O'Steen and Beth Swearingen as Mungojerrie and Rumpleteazer, were exceptionally well performed. 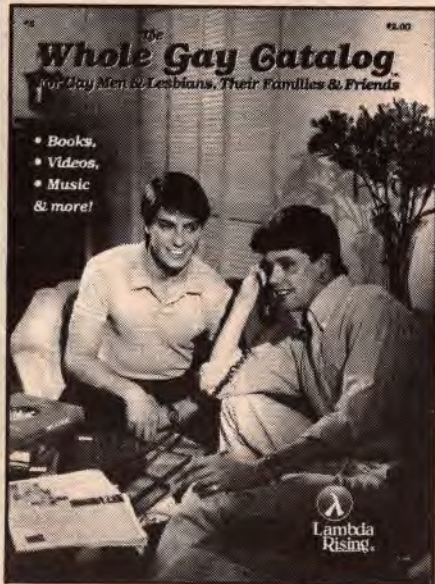
