# Feds: OK To Import AIDS Drugs

The U.S. Food and Drug Administration Commissioner Frank Young announced the agency's decision to allow AIDS patients to import treatment drugs that have not been approved for sale in this country. He made his announcement in Boston July 23rd at the annual gay and lesbian health conference. His announcement was met with cheers from the group which said it gave new hope to victims.

Young said the government officially began allowing importation of some unapproved treatments for AIDS last Wednesday, according to an Associated Press article appearing in the Milwaukee Journal.

"The decision allows AIDS patients to make some choices about their own treatment," said Ellen Ratner, president of the National Lesbian and Gay Health Foundation, sponsors of the conference. "If you're dying, you don't have a lot of choices."

Attorney Larry Gostin, a Harvard School of Public Health attorney who researches worldwide AIDS policies agreed. "From the AIDS person's point of view, they have nothing to lose and what they need is just some little optimism in their life. If there's a risk, I think that they should be able to make the decision about whether to assume that risk." He continued, "It's almost a shock because it's so contrary to the character and the tradition of the FDA."

Young and other FDA officials said such unapproved drugs as dextran sulfate and ribavirin had been allowed into the country on an informal basis. The new policy sets a formal procedure for those who certify that the drug is for their own use. Small amounts would be allowed, generally enough for three months of treatment, as an assurance that the drug is not intended for sale. Young said the FDA maintained the right to deny any shipments into the country. It changed its policy in part because some AIDS treatments were coming in as contraband.

# PWA Home Opens In Milwaukee

[Milwaukee]- Person's With AIDS (PWA's) have their first home in Wisconsin with the opening last week of a duplex in the Sherman Park neighborhood. The duplex will provide long term housing for up to six persons diagnosed with AIDS or AIDS Related Complex (ARC). The Milwaukee AIDS Project and its parent organization, the AIRS Resource Center of Wisconsin, will be the home's landlord.

The home will serve as a supportive environment for its clients who are lacking in family support or can't afford other options. This is MAP's first home under their 'Shelter Initiative' and others will be needed in the future.

The first MAP clients slated to enter the home died of AIDS related conditions before the home was ready for occupancy. Clients will be moving in the first week of August. MAP asks that anyone interested in living in the comfortably furnished domiclie contact Cheryl Vaughn, MAP's Social Worker for an application.

Local mainstream media have made things difficult for the home. To find out the home's address, media contacted the Wisconsin Housing and Economic Development Authority (WHEDA) under the open records law. They then went to the Sherman Park area and interviewed neighbors to find out their reaction to the home. Previously MAP had held discussions with neighborhood groups to allay their fears and answer their questions, so when the media questioned those concerned, most were accepting of the home. MAP was also able to stave off efforts by some of those media to publicize the address of the home. MAP would like to assure their clients have privacy and to be able to live in dignity.

The home was financed through a grant from WHEDA, and thousands of dollars in private donations. Some of that money has come from fundraisers in the gay commun-

ity, as have furnishings for the home. Several months ago when MAP first asked for donations of home furnishings, they were overwhelmed with the community's response. The result is a home any of us would be proud to live in.

Thousands of dollars of on-going funding will be needed to maintain the home and to prepare for more homes in the future. Clients' rent will be based on their ability to pay, with no one client paying more than 25% of their income in rent.

No state licenses will be needed because the home is not set up as either a nursing or group home. Because less than seven unrelated adults will be living under its roof, no city rooming house license will be needed. This type of structure will help assure outside intervention in the home's day to day operations will be kept to a minimum.

# **Ben Shalom Sues To Re-enlist**

[Milwaukee]- Army Reserve Sergeant Miraim Ben Shalom asked a federal judge in Milwaukee recently to prohibit the U.S. Army from denying her re-enlistment because she is a lesbian.

Ben Shalom has been informed by the Army that she would not be allowed to re-enlist when her tour of duty expires August 11th.

Last year Ben Shalom won an eleven year court battle with the military when the United States Court of Appeals for the Seventh Circuit ruled the Army couldn't discharge her due to her sexual preference. The Milwaukee activist, one of the founders of Milwaukee's Gay Peoples Union (GPU), was guoted in USA Today saying, "I don't want to stand up waving a banner and screaming I'm gay ... All I want is to serve my country I love and to be a good soldier."

The federal judge is expected to rule on her case before her discharge date. Her precedent setting 11 year battle has served as a landmark ruling often used in defense of other gays and lesbians against the military's exclusionary policies.

# **Teen Pleads Guilty** In Lover's Killing

Eighteen-vear-old Samuel Dasher pleaded guilty last week to charges of aggravated battery and manslaughter-heat of passion last week in the killing of his former roommate in December '87 during a quarrel, according to the Milwaukee Sentinel.

The charges were the result of a plea agreement reached as Dasher was to stand trial on a charge of second degree murder.

Michael Koudelka was found dead Dec. 1st in his East State Street apartment. An autopsy at that time showed Koudelka died from blunt force injuries to the head and chest. He also suffered crushing injuries to the neck and chemical burns to his body.

The youth, who was 17 at the time of his arrest, said that he and Koudelka had a gav relationship. He said they had guarrelled for several hours after the youth became angry about Koudelka's drinking and supposed infidelities. The youth said he got so angry he began to hit Koudelka and pour liquids - rangning from drain cleaners to soda - over him. The youth had also taken a hot iron and made an imprint on the victim's abdomen.

The criminal complaint said Dasher admited administering the beating.

Dasher is to be sentenced Sept. 8, by Circuit Judge William D. Gardner.

# **Coalition Concerned** Over Duke's VP

Washington [The Weekly News]- Gay and lesbian VOICE (Voters Organized in Coalition for the Election), a confederation of several of the nation's largest gay and lesbian political groups, have issued a joint statement expressing deep concern with Sen. Llovd Bentsen (D-Texas), Democratic presidential candidate Gov. Michael Dukakis' vice presidential running mate. "Senator Bentsen's record does not reflect the same level of commitment to AIDS and gay/lesbian civil rights as does Governor Dukakis','' reads the statement issued by

the National Gay and Lesbian Task Force, the Human Rights Campaign Fund and the Gay and Lesbian Democrats of America.

The statement points out that while serving in the U.S. Senate, Bentsen has voted for: restrictions on AIDS educational materials targeted at the gay community; mandatory HIV antibody testing of marriage license applicants, immigrants, sex offenders, and VA hospital patients; and the limitation of the District of Columbia's gay and lesbian civil rights law.

"We stand ready to work with Senator Bentsen in attaining a greater level of understanding on these and other issues," the statement adds. "We are supportive of growth in all politicians and hope that Gov. Dukakis will encourage such growth in his running mate. In the meantime, the Dukakis-Bentsen ticket has a lot of work to do in reassurng the gay/lesbian community and those concerned about AIDS that his new team will be responsive and forward thinking on the full spectrum of public health and civil rights concerns."

# GLAAD Urges Action on Several Fronts

The Gay & Lesbian Alliance Against Defamation, Inc. (GLAAD), just released their July/August bulletin containing several areas where the gay and lesbian community's input in needed to combat homophobia. Ranging from responding to a nationally syndicated columnist, to Kellogg's cereal, to MCI, and Stonewall, your action is needed to sway opinion.

#### What's the Big Deal?

"AIDS: What's the big deal?" asked nationally syndicated columnist James J. Kilpatrick in a June column. He answered by telling readers that the AIDS crisis is terribly overrated and needs to be put in perspective. And while he believes that we should extand compassion to babies, the "innocent inheritors of AIDS," he can't understand why anyone would extend themselves for the other victims of the disease.

In specific Kilpatrick wrote that "AIDS

victims deserve about the same amount of 'compassion' that society extends to those who smoke themselves to death or drink themselves to death." He concludes, "the fellow who dies of sodomy is no more special than the fellow who dies of two packs of cigarettes a day. Let us apportion our tears, and our tax dollars, with some sense of proportion."

#### Kellogg's Gay Bashing: It Ain't "Nuttin,' Honey"

Despite hundreds of written complaints, the Kellogg Company refuses to withdraw or modify its homophobic Nut & Honey Crunch commercial, in which a bunch of cowboys ask the wagon train's cook, "Hey Cookie, what's for breakfast?" When he answers "Nuttin,' Honey," the cowboys respond by scowling and pointing their guns in his face. The message: any hint of affection between two men is reason for violence.

In a just-released report on the growing wave of anti-gay violence in America, the National Gay and Lesbian Task Force declared that these Kellogg's ads "trivialize, legitimize and encourage anti-gay violence" by suggesting that violence against gay men, or men perceived to be gay, is acceptable (even comical, although certainly not to gay-bashing victims).

Network policy prohibits the broadcasting of commercials that are tasteless or offensive. GLAAD encourages you to tell the networks that ads that treat anti-gay violence as a source of humor is no joke, and Kellogg's Nut & Honey Crunch spot should be immediately pulled from the air.

MCI Telecommunications recently fired an employee because his sexual orientation was found to be "offensive."

David Gatten, an openly gay man, had worked for MCI in New York for three years. During that time he received excellent performance reviews and three management promotions. He was told, without warning, that he was being discharged because his sexual orientation offended other co-workers.

Although a New York City law porhibits discrimination based on sexual orientation, MCI is trying to circumvent the law by claiming that Mr. Gatten was not fired for being gay, but because his co-workers found his being openly gay offensive.

# Gov. HIV Infection Advisory Council: Little Progress

Madison- Almost a year after its formation, Governor Tommy Thompson's HIV Infection Advisory Council has yet to accomplish anything substantial, according to Jay Hatheway, publisher of Among Friends and openly gay council member.

Hatheway says he and other council members remain uncertain about the council's exact purpose. "What are we to do? Galvanize the public? Educate constituents? Do we have a function other than to give the impression that the governor is taking hold of the epidemic and acting?"


When appointed last fall, the 30-member council included no minorities. In response to protests from the gay community, Thompson then appointed Hatheway. Subsequently, a second openly gay man, Grid Hall of Madison, was also named.

After the counceil first met in February, three other appointments were made, in response to complaints that the council included no Blacks, Hispanics or Native Americans.

Hatheway's main concern is that "the council does not have enough gays or those who work with AIDS or ARC victims. It is generally composed of people with little background on AIDS."

(Of the six AIDS projects in Wisconsin, only the Madison AIDS Support Network has a representative – Hall – on the council. Hall was unavailable for interview at press time.)

After a first meeting devoted largely to introductions, council members spent most of their second session listening to speakers from different professions. Among those were Tim Tillotson, coordinator of **Blue Bus Clinic** in Madison, two representatives from the **Milwaukee AIDS Project** and a representative from the **Concerned Women of America**, who distribued literature advocating mandatory testing of the entire population and developing a high school curriculum for "promotion of sexual abstinence until long-term monogamy is established."

The council's membership includes many professionals, whose emphasis, according to Hatheway, has been on "protecting their professional constituencies from the (HIV) virus. Doctors have talked a lot, for example, about the proper cleaning of surgical tools. It's very technical and most of the council doesn't understand what they're saying.

"Most of the professionals' constituents aren't gay and most don't really say much about gays. I don't know if the council is homophobic, largely because gays have hardly been mentioned. The council has focused on addressing people in the mainstream, not those at high risk."

Hatheway adds that there has been very little talk about IV-drug users. The Wisconsin Division of Health statistics as of July 1st point to this cateogry as the second largest group of persons with AIDS in the the state. Of Wisconsin's caseload, 83% are gay or bisexual males, 4% of whom are also IV drug users. An additional 6% is comprised of non-gay IV-drug users.

Nancy Kaufman, Deputy Director of the Bureau of Community Health and Prevention, acts as faciliator to the council. She also served in the same capacity to Governor Tony Earl's Wisconsin Public Task Force on AIDS.

The latter's purpose, according to Kaufman, was "to develop medical guidelines for how persons with AIDS or HIV infection should be handled in various situations. The Task Force had more of a medical orientation towards infection control and policies related to it." The task force produced approximately 20 booklets of guidelines for different institutional settings.

The current council, according to Kaufman, "is much broader based and is to advise the governor and the Department of Health and Social Services on prevention, education, and services."

Hatheway says that if the council has done advising of any sort, it was brief reviews of three pieces of legislation, none of which has been yet enacted.

A proposed bill on insurance and confidentiality received little debate, says Hatheway, "since Wisconsin has strong confidentiality protections." A second proposed bill to criminalize the willful spread of AIDS was "torn apart." A third one, for mandatory testing of selected prisoners convicted of violent crimes, produced no consensus among council members because it "created a division between public health professionals and those representing prison guards."


Rep. David Clarenbach (D-Madison) expects the bills to be resurrected next year. He cites support for the cirminalization of the willful spreading of AIDS, saying that "most lawmakers are chomping at the bit to do something in response to AIDS hysteria" and that such a bill "could stand a good chance of being enacted."

Clarenbach calls the insurance questions a "major issue" for the next legislative session. Insurers are currently prohibited from requiring HIV tests for workers with group policies, a prohibition insurers are eager to eliminate.

"The council seems to think we have a handle on the disease," says Hatheway. "There's no sense of urgency, probably because many people on the council come from areas where there is a low rate of HIV infection."

# HIV-Positive Persons Have Civil Rights


Los Angeles [Windy City Times]- Federal district court here made a precedentsetting ruling July 7 that a person who tests positive for HIV antibodies is covered by the federal civil rights law that protects the handicapped from discrimination in all programs receiving federal funds, according to the Lambda Legal Defense and Education Fund, Inc. (LLDEF).

The gay- lesbian-oriented defense fund reported that a man was discharged from an inpatient alochol treatment program because he tested positive despite prior assurance that any test results would not be


#### used against him.

The man, identified only as John Doe, was admitted to Centinela Hospital Medical Center's inpatient alcohol and drug rehabilitation program in January 1987. He was asked to submit to an HIV-antibody test, and when he objected was assured the test results would not be used against him. Three days later Doe was told he had AIDS and was ordered to leave the program. Doe did not have AIDS at the time or did he manifest any symptoms of HIV and remains healthy today, according to LLDEF.

His suit against the hospital was brought by the American Civil Liberties Union and LLDEF. contd. on page 13





"This ruling represents a major victory for the estimated two million HIV-seropositive Americans because it says for the first time that discrimination based on fear of contagion will not be tolerated by federal courts," said Paul Hoffman, ACLU legal director for Southern California.

Federal courts have previously ruled that Persons With AIDS are covered by the civil rights law, but this ruling is the first by a federal court to cover an HIV-seropositive individual who has no clinical symptoms of disease as defined by the Federal Rehabilitation Act, according to LLDEF.

# **Police Close** Adult Bookstore

Kenosha, WI [Milw. Journal]- The Odyssey Book Store in the Town of Bristol was shut down July 25th by Sheriff Fred Ekornaas, enforcing an order by Kenosha County Circuit Judge Michael Fisher, who ruled that it was a public nuisance.

The store will be padlocked for up to one year as a result of Fisher's ruling, which authorities described as the first use of the law to close an adult bookstore.

Eleven patrons of the store were arrested in separate incidents last year on charges of fourth-degree sexual assault and lewd behavior. They were accused of either "sexually touching or exposing themselves" to plainclothes male deputies in and around some of the Odyssey's 34 "peep-show" booths.

The sheriff invited reporters to witness the closing, and started knocking on booths Monday afternoon to announce that the store was closing. About a half-dozen patrons who had been in that area of the store then walked out silently.

"Is all this necessary?" James Moses, the store's assistant manager, asked as deputies and reporters gathered in the building.

"It's not necessary, but it's happening," said Ekornaas, who then served the court order.

Michael Null, an attorney for the Odyssey, said he would appeal the court ruling.

Kenosha County Dist. Atty. Robert Zapf said authorities might take action against another adult book store where similar arrests have taken place.

Harrisburg [Windy City Times]- Recent amendments to the Pennsylvania Protection from Abuse Act, which became law on June 19, now provide provides protection to lesbians and gay men who are physically abused by their partners, according to The Philadelphia Gay News.

The new law expands the definition of family and household members to include "current or former sexual or intimate partners." Under the law previously, gay men and lesbians qualified under the definition of "spouses" and not all courts would allow such a construction to the term.

Under the law, a protection from abuse order would prevent an abuser from committing further abusive acts, evict an abuser from a shared residence, prohibit harassment of the victim or the victim's family, and order that the abuser pay the victim for attorney's fees and losses suffered from the abuse.



[GLAAD] New York, NY- Recognizing the power of television to affect viewer attitudes, the Gay & Lesbian Alliance Against Defamation (GLAAD) met in June and July with top programming executives at ABC, NBC and CBS. One result has been an agreement by CBS to change the name of a fall TV movie about children with AIDS, originally titled Innocent Victims.

"Basically, we wanted to explain the need for more gay characters on the networks," said GLAAD's media committee chair Stephen Miller. "Next season ABC plans to have regular gay or lesbian characters on three shows - Officer Rick Salardi on Hooperman, nurse practitioner Marilyn McGarth on Heartbeat, and a new gay male character on thirtysomething. CBS and NBC have no plans for any permanent gay characters on any shows."

Michael Standman, a member of GLAAD's board of directors, added that as important as it is to avoid offensive stereotypes, gay invisibility is not an acceptable alternative. "CBS and NBC didn't know what to say when we pointed out the absence of gay characters on their shows. George Dessart, vice president for program practices at CBS, pointed to one show that dealt with AIDS, and said that **Designing Women** had an episode with a gay man, as it that took care of things!"


CBS has, however, agreed to change the name of **Innocent Victims**, its TV movie about children with AIDS, to **The Littlest Victims**. "We made it clear that many rightwingers delight in comparing the "innocent victims" of AIDS (children and hemophiliacs) with gay men, who in their view are "guilty" of willfully infecting themselves," Standman said.

GLAAD also told ABC's Chris Hikawa, vice president for broadcast standards and practices, about its concerns over a May 6 episode of Mr. Belvedere. According to Standman, the episode dealt with a male camp counselor who attempts to caress two young boys. The counselor is handsome and single. "Child abuse is always abhor-

rent," said Standman, "but the majority of cases involve straight men molesting girls, often family members. The counselor on this show was clearly only interested in the boy campers, and not in children per se, reinforcing the myth that there is some particular connection between homosexuality and child molestation."

"We live in a homophobic culture," said Miller. "Who do you think viewers are going to blame after watching this show, gays or child abusers – or would they, without direction, even make the distinction?"

Before the show aired GLAAD had requested to view the episode or see the script. ABC had turned down the request.

At NBC, Standman said, "We pointed out that the absence of gays on their regular programming makes the anti-gay 'jokes' common on Saturday Night Live and Latenight with David Letterman all the more unacceptable." No other group is put down the way gays are on these shows," GLAAD told Ralph Daniels, NBC's vice president for broadcast standards.



# Wisconsin AIDSline

AIDS is a subject that remains in the forefront of attention. Not a day goes by without some sort of reminder. It can be a newspaper article, a story on television, or even a conversation with friends. With all the information and stories many people still have questions about AIDS. The **Wisconsin AIDSline** was set up for the purpose of giving anonymous information to those who have questions about AIDS.

The AIDSline has been in operation since March of 1986 and has grown from a part-time to full time service. It currently operates from 9 a.m. to 9 p.m. Monday through Friday, and 11 a.m. to 5 p.m. on Saturdays and Sundays, with a staff of 75 trained volunteers. The phone number in the Milwaukee area is 273-2437 or from other areas in the state 1-800-334-2437.

Volunteers at the AIDS line are trained to deal with all aspects of the AIDS issue. They are informed of medical and legal concerns, and are given updates on this information. They are also informed of counseling and testing sites throughout the state. They have information on the HIV antibody test and what will happen when a person goes in to take the test. Almost any question about AIDS can be answered by AIDS line volunteers.

#### **Gay Night**

In their continuing effort to reach all people at risk AIDSline has started a "Gay Night" on Wednesdays between 6 p.m. and 9 p.m. This service will allow a gay man to speak to another gay man regarding "safer sex" and risk reduction techniques. Trained volunteers will give facts and offer suggestions for eroticizing to make sexual encounters more exciting. AIDSline feels that sometimes these topics are more easily discussed anonymously, and urges those with questions to call.

The AIDSline is dedicated to furnishing the most current, up-to-date information about AIDS, so if you have questions please contact them.

# PWA Bracelets Now Available!

MAP has been granted the rights to become a distributor of the Public War on AIDS (PWA) Bracelets (®). The PWA Memorial Bracelet concept was originated by Mark Manning and patterned after the POW/MIA wristbands of the 1970's.

The PWA Bracelets are meant to honor

the thousands of men, women, and children who have fallen to the disease called AIDS. By wearing the national symbol of unity and commitment to help defeat this disease which threatens every American.

The bracelet bears the name, age and date of passing of people who have suffered from AIDS. This unique one-piece memorial bracelet has been custom designed to be worn by both men and women and is available in silver- or gold-plate.

The PWA Memorial Bracelet is plated because it is initially cast in brass. The reason for this is that upon finding a cure for AIDS, the PWA Bracelet Foundation organizers hope to collect all the bracelets and melt down the metal to create a national memorial and place it in a city yet to be named. San Francisco, Los Angeles, New York, and Washington, D.C. are presently under consideration.

SJG: I think you're catching a lot of flack right now about being the carriers of disease and I think that's bullshit! I hope that you know that's bullshit! I think that without the gay community, we wouldn't have the artistry that's developed in this country or any country. I know too many actors, directors, singers, dancers, too many people in the arts who've carried the stigma of being gay and despite it have risen to the very top of their profession. I have an incredible amount of admiration for those people because it's a very difficult road to hoe when you're going against society's grain. Especially when you're going against a red-neck country's grain. I think we are probably the least tolerant of gay people. The Puritan roots are too strong.

#### WIS: What of AIDS?

SJG: The Reagan administration... I know they've ear-marked money for AIDS research but you can bet your ass if it were totally succinctly only a gay problem, they wouldn't have ear-marked as much money as they have. It's only when it spread over into the heterosexual community where it started in the first place that they decided something had to be done about it.

WIS: Advice to young actors just starting out?

SJG: Go to a good school with good teachers. There are too many actors out there who don't know an ingenue from their elbow. To do justice to the profession you've got to be trained well. It's imperative that you know how to go about creating your characters and how to go about playing your actions and objectives as strongly and as passionately as you can using every part of yourself that you can.

WIS: Any final comment?

SJG: Good regional experience includes being here and working with the people that are here (the Rep). Because I think these people are top notch, I learned a lot from these guys in the last couple of years. I have a lot of affection for this place.

# Experimental **Treatment Guide**

New York [The Weekly News]- It may be a little technical for the average person to fully comprehend, but a directory published by the American Foundation for AIDS Research (AmFAR) offers a wealth of knowledge to people who have questions about the options available in experimental treatments for HIV infection.

The booklet, called the AIDS/HIV Experimental Treatment Directory, lists compounds intended to supress HIV or regulate the immune system in order to counter the effects of AIDS or HIV infection. The foundation updates the information guarterly. Copies cost \$10 an issue or \$30 for a one year subscription.

The latest release has 118 pages and features a Quick Reference Map that pinpoints treatments centers throughout the U.S., and direction on whom to contact for further information.

The booklet lists experimental treatments alphabetically, with an explanation that includes physical description; mechanism of action; trial results; toxicity/side effects, and a specifications of the criteria required in order to be considered for inclusion in each study.

A disclaimer at the beginning of the booklet explains, "This information is provided to you as a source material only. has not been verified and should not be relied upon as being accurate."

The directory is designed to provide objective information, not an evaluation or recommendation of any drug's potential side effects.

# State Releases **Behavioral Data**

The Wisconsin AIDS Update, a report issued by the Wisconsin Division of Health. released in July, reported behavior data for homosexual and bisexual men in the state. Several new questions were added to the questionnaire in the first quarter of '88, which is required at counseling and testing sites. Included were questions on frequency of anal intercourse, frequency of sexual contact with anonymous partners, uses of inhaled nitrites, uses of rimming or fisting, and use of condoms with new partners and long-term partners.


Forty-nine percent of homosexual/ bisexual males stated they never had sex with anonymous partners, and 4% stated they frequently had sex with anonymous partners.

Only 48% use condoms frequently with new partners, and 25% never use condoms with new partners. The proportion who used condoms frequently with long-term partners was 26%.

Thirty-three percent stated they never engaged in anal intercourse, and 8% stated they engaged in anal intercourse frequent-10

Seventy-two percent never use inhaled nitrates and 5% use them frequently.

Sixty-seven percent never practice rimming or fisting, whereas 3% practice them frequently.



# In Step\*August 4-17, 1988\*Page 26 Volunteers Needed for AIDS Drug Trial

[NIH]- Researchers at the National Institutes of Health (NIH) are looking for HIV-infected persons with Kaposi's sarcoma (KS) to enroll in a clinical trial of AZT and interleukin-2 (IL-2). This onging study is designed to evaluate the toxicity and obtain preliminary information on the efficacy of the drug combination; each by itself has been well-tolerated in treatment of AIDS patients with KS.

AZT has been shown to prolong life by interfering with replication of the human immunodeficiency virus (HIV), the cause of AIDS. IL-2 is a substance that occurs naturally in the body and is known for its role boosting the immune response. Investigators hope that the use of the two agents together will reverse some of the damaging effects of HIV on the immune system.

The primary aim of the study is to obtain toxicity data on the drug combination during dose escalaction of IL-2. Each patient will receive AZT as an outpatient for six weeks, and then will receive IL-2 by continuous infusion as an inpatient for three weeks. This research will be carried out at the NIH Clinical Center in Bethesda, Maryland.

The researchers are looking for 15 men or women between the ages of 18 and 60 who have KS, no history of opportunistic infections and can tolerate 200 mg of AZT every hour hours. Prospective women volunteers must not be pregnant. In addition to outpatient visits every two weeks each patient will be admitted to the inpatient service of the clinical center for three weeks during which time IL-2 will be administered.

If a volunteer responds well to the drugs and wishes to continue taking them, treatment can be continued longer than the four-month period.

Travel expenses for volunteers who live outside the Washington metropolitan area will be paid by NIH. For more information, prospective volunteers can call Dianne Lee, R.N. at (301) 496-7196.

# Dental Group OKs Infectious Guidelines

[Chicago Tribune]- Dentists have an ethical responsibility to treat patients with AIDS and other infectious diseases, according to a resolution adopted recently by the nation's second largest dental association.

The resolution also urges dentists and their assistants to use gloves, masks and other barriers that prevent transmission of diseases like AIDS and hepatitis.

Two hundred delegates, representing 30,000 dentists in the U.S. and Canada, approved the resolution during the Academy of General Dentistry's annual meeting in Chicago.

The resolution asks dentists to treat all patients "with kindness and compassion, regardless of the nature of the patient's condition."

The policy was not approved solely in response to the "politicized" issue of health care for AIDS patients, said Dr. Edward Barrett, the academy's president.

"People with AIDS are just one part of the medically compromised group," Barrett said. "In fact, hepatitis is a much more serious problem from a practical point of view."

Although the policy has no authority to regulate dentists' actions, it should reduce the number of highly publicized cases of dentists refusing treatment for patients with AIDS, said Dr. Elwood Streeter, a Los Angeles delegate.

According to an academy survey, more than 90 percent of dentists wear protective barriers at least some of the time, up from 25 percent a year ago.

The academy's resolution is similar to one passed by the larger American Dental Association about two years ago.

reference to the motion created by a gay man's hind-end when he walks or the flapping motion of a gay man's limp wrist. And while it is only a superficial reference, it does show there is some interest in exploring more realistic gay attributes for use in commercials.

The recent commercial for Isuzu's Trooper II is another ad compaign that seems to depart from anti-gay practices. This company is obviously somewhat more sensitive to the needs of it's commercial spokesman, Joe (the lying Isuzu pitchman). In this ad, Joe is allowed to appear, for this first time, in full drag. And while Joan, Joe's drag name, doesn't do a lip-synch performance, he is seen promoting the Trooper II's selling points while wearing a lovely dress. It was obvious, by Joe/Joan's difficulty with high heel walking, that cross-dressing was a relatively new experience. It is encouraging to see that Isuzu had the courage to allow Joe to explore his true inner-self while promoting their product.

Surprisingly, even the most popular commercial characters seemingly attempt


to appeal to the gay minority. The California Raisins may actually be subtley promoting a positive gay image. In fact, raisins are nothing more than dried wrinkled 'fruit' (grapes) and one of California's cities, San Francisco is considered a gay mecca. Is one of the messages of the California Raisins that, not only is it O.K., but it can actually be fun to be an old wrinked fruit or an older gay person? And the California — San Francisco — gay connection may be too obvious to ignore.

While there has been some progress toward gay rights in television commercials, there remains a large segment of advertising that is overtly or covertly anti-gay. And as long as television cowboys can murder innocent gay wagon train cooks, we can't just say the whole thing is "nuttin, honey!".

# "Nuttin', Honey!"

News Item: The Gay and Lesbian Alliance Against Defamation (GLAAD) asked executives of the major television networks to pull the plug on Kellogg's commercial for Nut & Honey Crunch breakfast cereal, claiming the ad is widely regarded as condoming anti-gay violence. The ad features a bunch of cowboys who pull their guns on a wagon train cook who they believe has called them "honey." Representatives from Kellogg's claimed that the cowboys pull their guns because there is "nuttin" for breakfast, rather than because they have been called "honey".

Madison Avenue's recent attempt to entice consumers, at the expense of an innocent and obviously closeted gay wagon train cook, is just the tip of the iceburg when it comes to the advertising industry's lack of sensitivity toward gays and lesbians featured in television commercials. At first glance, this incident may seem like "nuttin, honey" but, upon closer scrutiny a darker, more sinister pattern takes shape.

Take for example the plight of Cookie, another wagon train cook featured in a commercial for Pace Picante Sauce. When Cookie uses a plcante sauce made in New York, after he runs out of Pace Picante Sauce, the cowboys in this ad are so displeased they state, "get a rope!" Obviously, Cookie is in mortal danger, but are these two commercial death threats merely a coincidence? Was Cookie also gay? Is there some sort of dark conspiracy to do away with all gay wagon train chefs featured in food commercials?

While it is hard to ignore the similarities in these two commercials, violence against homosexual wagon train cooks remains in the minority of homophobic incidents which have taken place in television advertising. Most of these incidents seem murky and are less overt than

# those that threaten violence.

One can't help but wonder about the strange disappearance of Mr. Whipple, the grocer who's plea of "please don't squeeze the Charmin" has vanished from the airwaves. It is well-know that Mr. Whipple, in fact, was a closeted Charmin squeezer. Perhaps, he was equally closeted about his sexuality. Did he enjoy squeezing more than just an occassional role of toilet paper, like a cute bag boy's butt, maybe? What actually caused Mr. Whipple's disappearance remains a mystery. However, a gay grocer certainly wouldn't fit the wholesome image desired by Charmin to promote their "squeezably soft" toilet paper.

There are other such disappearances that are cause for some speculation. Madge the manicurist, for instance, who pitches Palmolive Dish Washing Liquid by announcing, "you're soaking in it!" to unsuspecting women having their nails done. While Madge pops up only rarely on television today, she was almost always seen holding another woman's hand and was never seen with a man. While Palmolive may state that Madge has lost her wide demographic appeal, it is easy to see how the suggestion that Madge is a lesbian would not endear her to the majority of the buying public.

Additionally, there is the case of the Tidy Bowl Man. With the advent of AIDS, a man who spends much of his time cruising around bathrooms is probably not considered a proper spokesman for a national brand of toilet bowl cleaner. Other, possibly homophobic related disappaearing acts include, the man from Glad, Mr. Clean and Josphine the plumber.

Swish Toilet Bowl Cleaner is one example in direct contrast with the Tidy Bowl situation. In this commercial, a tuneful jingle tries to persaude consumers to "bully your bowl with Swish!" The use of the word swish is a seemingly obvious contd. on page 53

On the positive side, the variety means "We might be able to predict which viruses cause rapid disease and which work more slowly or perhaps don't cause disease at all," says Dr. Lee Ratner of Washington University, St. Louis.

That might allow doctors to tailor treatment to specific viruses, says Ratner, who spoke at a symposium at the National Institutes of Health.

The down side: Some viruses may resist drugs, defy future vaccines or evade testing techniques that work on others.

So far, scientists acknowledge two human immunodeficiency viruses: HIV-1 and HIV-2. The second type is widespread in Africa, but has been found in just one USA patient – who came from Africa.

Updated research shows:

A third type may have been found in a man and his wife in Cameroon, says researcher Guido van der Groen, Institute of Tropical Medicine, Antwerp, Belgium.

"My guess is that in the future we will come up with even more HIV viruses." Blood from one AIDS patient can carry viruses with great genetic variety, several researchers said. Possible reasons: The viruses have been around long enough to evolve into many forms, or the viruses mutate rapidly while replicating in the body.

# Still No Vaccine On the Horizon

[USA Today]- Researchers from Seattle to Paris are working furiously on a potential AIDS vaccine.


But the scientific community has grown pessimistic about prospects for a vaccine anytime soon.

"It's going to be very difficult if not impossible," says Dr. Shiu-Lok Hu, of Oncogen, Inc., a Seattle company working on a vaccine now in human safety trials.

Shiu says it's too early to report results from the Onocogen trial.

Immune responses have been reported in some volunteers in safety trials of another vaccine by MicoGeneSys, Inc., West Haven, Conn.

# Steven J. Gefroh- An Accomplished Actor Articulate & Aware

Arts Columnist, Kevin Michael had the opportunity to chat with Milwaukee Repertory Theater actor, Steven J. Gefroh, at the close of the Rep.'s 1987-88 season, their first in their new theater space. You'll find an intelligent personable fellow with a keen mind and some interesting insights and observations on theater, his experience and career, and life.

WIS: How does a young man get from North Dakota to the Yale School of Drama?

SJG: I didn't know what to do when I got out of high school. So, I dabbled a little bit in acting and I decided to get a couple of years of college under my belt and see where that led. When I came out, I still didn't know what steps to take to get to where I wanted to go. So, I thought, well, let's go into the Army, I was an entertainment specialist at Fort Leavenworth. I produced, directed, and acted in talent shows. And then, I went to Kansas City to finish off my degree. I decided I needed more acting training because they didn't have a good acting program. I ended up at Wayne State in a pathetic program. So I applied at Yale and also auditioned for Temple, and Juilliard. Four weeks later, I started getting acceptance notices and would call that school and accept. Finally when I got Yale's, I called all the others back and told them I was going to Yale.

WIS: How have you found Milwaukee?

SJG: Well, I just looked West of Chicago and there it was! I love the city. The audiences are intelligent and the company is very good.

WIS: How about being part of the birth of the new Rep?

SJG: That's an honor that's unparalleled in my career. There was so much excitement about that this year, especially opening the main stage. And then opening the Stiemke Theatre with "Heathen Valley" and working with Romulus Linney (the playwright) was just incredible!

WIS: Now finishing your second season here, you'll be returning for a third. Why do you come back?

AJG: Because the company is good, the directors are good. They do good work here. It's hard to find a good ensemble of people and I think ensemble acting is the only really legitimate acting that's done. Because when you know each other so well, you can rely on each other every moment of the time that you're on stage.

WIS: As 1 look over your background, I see extensive Shakespeare. You've played Hamlet and Romeo in Philadelphia, Mercutio in Kansas City, Hotspur and Pericles at Yale, and Sebastian here. Is he of particular interest to you or is this something that's just happened?

SJG: I got started on Shakespeare when I was 17 so he's always been my first love. He's also the best playwright you can do. He gives his actor everything he needs just in words. The language is beautiful!

WIS: I know that I have to be well-behaved because I have a master fencer here. Tell me a little bit about that.

SJG: It started in Kansas City when I was doing Mercutio in 'Romeo and Juliet.' And then at Yale, it is required in your first year and you fence off at the end of the year for a class champion who takes on the class champions of the second and third year. I was our school champion my third year. It's not only good physical training but its good acting training. Good coordination. Good movement training.

WIS: Psychologically healthy do you think?

SJG: Oh I think so, because you get rid of all the aggression when you fence somebody, especially if you beat them. And if you don't, you carry it over until the next match.

WIS: Do you have all your fencing materials with you here?

Rainbow Coalition are organized under this principle, and serves as an example that we have gone beyond entirely separate issues and have learned the importance of working together.

By combining the power of the movements of people of color, women, gays and lesbians, labor and other progressive elements of our society, we create a movement whose strength is in its numbers and its diversity. The power of the Rainbow Coalition depends on the involvement of all oppressed and disadvantaged groups, and the absence of any one of the groups would weaken the coalition.

Davis recognized not only the oppression of women and people of color in her talk, but she also addressed the problems facing the lesbian/gay community. With respect to AIDS, Davis drew a strong connection between the lack of adequate health care in our society and our government's ability to restrict and limit medical research. The government has successfully promoted homophobia around the AIDS epidemic, and thus swayed public opinion against finding a cure. Davis suggests that we must "challenge homophobic manipulation of the AIDS crisis."

Davis' philosophy of community organization can be transferred to the lesbian/gay community. The pure organization of lesbian/gay groups could be recorganized to included men/women/people of color. For example, gay and lesbian groups could set aside seats for under-represented groups on their Boards of Directors. At San Francisco State, Davis made this suggestion to the student Women's Center, and the inclusion of women of color became more welcome. The end effect was that the issues of particular concern to women of color actually received representation in the organization, and thus attracted activists interested in those issues.

In addition, groups must analyze their programs and activities and closely consider how under-represented groups are addressed in these programs. For example, is a site handicap accessible? Are performers for local production companies all white? Are programs held in neighborcontd. on page 49

SJG: Yes. I have to keep in practice. I have to keep in shape.

WIS: Let's talk about the variety of roles you've played here. Peter in "Anne Frank"?

SJG: In New York, I'd never get a chance to do that role. The kid is 16 when he starts the play and 18 when its over. You draw on the innocence of grade, middle, and high school and wipe your mind clear of everything you've learned since then and just play the moment as innocently and truly as you can. So, it wasn't hard in that respect. It didn't require me to create a character out of nothingness. It required me to use a part of myself.

WIS: Harlan in "Heathen Valley"?

SJG: It's funny had anybody other than Romulus directed, I don't think I would have done Harlan. I probably would have done Billy. The tendency my first year here was to have me do the young man. Harlan let me unleash the temper and insanity I naturally have in me.

WIS: Really? Please go on.

SJG: I'm hypoglycemic. Sugar makes me crazy. I would find that it created in me extremely violent mood swings. Its been responsible for breaking up many of the relationships in my life. When I do sugar, I'm fine for the first hour but when I come down it's not wise to be around me. I get violent. So, Harlan was drawing on that part of me.

WIS: Did you enjoy it?


SJG: I loved it. To be crazy and believeable on stage is very difficult. Yet, those are some of the greatest challenges. To find the change and then to have to go back is also a good challenge for me.

WIS: Dennis in "Loot"?

SJG: It was pure fun. It was one of those times you can go on stage and not worry about warming up beforehand because you have such a good time with the character that the energy is there.

WIS: As I've shared with you, it was most interesting watching you on stage in "Loot". For me, you were almost Orton reincarnated.

And then, work my way into million dollar contracts and be able to have enough money so I can do theater wherever and whenever I want and whatever plays I want to do.

# Angela Davis At Alverno

Angela Davis, author of Women, Race & Class, and former 60's black power activist, recently spoke at Alverno College as part of the National Association of Women's Center's Conference. The conference was aimed towards non-profit women's centers who provide a variety of services, such as battered women's shelters, support groups and counseling, and employment training.

Davis has a long history of political activism, including time on the FBI's 10 most wanted list and receiving the Lenin Peace Prize. In addition, she is an active member of the Communist Party. She now teaches Philosophy of Aesthetics and Women's Studies at San Francisco State University.

Davis challenged people in the audience to become actively involved in keeping the issues of concern to women in the center. Davis draws a strong relationship between the issues of concern to different groups women, and how institutional racism can affect the response to those issues.

Abortion serves as an example of a divisive issue between women of color and white women. Davis draws attention to the proliferation of sterilization abuse since the Reagan administration. The Reagan administration has prohibited the use of federal funding to perform abortions for poor women, yet continues to allow sterilization of women, therefore preventing pregnancy ever again. According to Davis, "more women of color are surgically sterilized than white women."

Davis contends that traditional reproductive rights organizations have not made consistent efforts to become involved in these issues, and thus have had difficulty recruiting women of color as activists in the organizations. Such organizations have neglected the fact that sterilization programs infringe on the rights of poor women to control their bodies. The issue of sterilization also assumes that certain women are worthy of having children. solely based upon economic conditions.

These philosophies also assume that large families are the cause of poverty, rather than recognizing the societal foundations that cause poverty. "The Kennedy family," Davis says "was never told that having large families would cause poverty."

Society has failed to meet some basic needs that would help to eliminate some basic social problems. According to Davis, we must "focus on those women who are most oppressed and we will move everyone forward." Issues in our society that have become paramount include safe and affordable day care for all children, national health plan, and equal educational opportunities.

By operating on the idea the "an injury to one is an injury to all," Davis contends that we will truly make change. The Jesse Jackson Presidential campaign and the contd. on page 48

I'll never forget the first time that I read The Joy of Lesbian Sex.

It was a good seven or eight years ago. I saw it in a mainstream bookstore downtown. Schwartz's, on Fourth and Wisconsin, I think it was. Walked up to the counter and looked the clerk in the eye, and bought it. Wrote a check for it. With my name and address on it. Me, who (at the time) was too shy to say "boo" to a dandelion. I couldn't believe it.

I was just starting to come out to myself as a Lesbian, only just beginning to wonder, "would I like...?" "Can I...?" "Am I or aren't I?" I was totally naive about any kind of sex. "Am I or aren't I?" I figured that if I liked what the book said that Lesbians did, I was. If I didn't, I wasn't. The book would, so to speak, unstraighten me out.

Surprise! Some of it I liked, some of it I didn't.

There were lots of things in the book to which my inhibited self said: oh, I could never do **that**.

But the pictures! Ah, the pictures. Women hugging. Women kissing, women cudding. Women in each other's arms. Women with short hair, wearing jeans and sweaters. Women with short hair, wearing... nothing at all! The women of my fantasies, looking as I pictured them, not like the women of **Vogue**.

I loved all of them. And the text which accompanied the pictures satisfied the romance in my soul, and convinced me that I was in the right place (finally!), although I was so naive back then as to believe that I was supposed to want to Do It All. At first.

The Joy of Lesbian Sex even helped me come out to my family. No, they didn't read it: my sister tripped over my copy where I had forgotten it on the rug. "What's this?" (Oops.)

That was a long time ago.

Today, I have been out to myself/family/



friends/coworkers for about six years. I have shared a good friendship for all of those years, which has been a loving partnership for the last five. I do not blink or blush as easily. There are things in the book that I might do, and things that I might not, and things that we do together that aren't in the book. And I have come to see that the book need not be a litmus test, or an entrance requirement, but a matter of personal style.

We have all sought relief in Gayness from the Heterosexual view of sex, which rigidly characterized itself as one fixed, primary Act (baby-making) with fixed duties (his: hers:). Now, embracing her-her (or his-his) relationships, we are free to define ourselves and what we do however we want, as we are not limited by a biological imperative. Anything which gives pleasure to our partner, to ourselves, anything which makes sacred and special, the moment, and the act, of intimacy, we are free to claim, and to enjoy. The defining is ours.

I don't do everything depicted in **The Joy** of Lesbian Sex, nor do I agree with everything that the authors, Dr. Emily L. Sisley,and Bertha Harris, say. (Toe-fucking??) But I take it down from the shelf every so often, and re-read it, preferably in a bubble-bath. It has given to me, has awakened in me, something which I find to be fundamental to my being as a person, and I am grateful to its authors for helping me to coax my timid, shy desire for intimacy out from the deep place in me where it had been buried for so long, permitting me at last to freely choose its expression or non-expression.

Knowing that not so long ago, and even today, in this country, such an act would not be possible, I am also grateful that I can walk into a mainstream bookstore, find The Joy of Lesbian Sex on the shelf, and purchase it, no questions asked or names taken down. However, we've gained another 800 line. 800 lines are available from anywhere in the U.S. Drawback? You have to have Visa or Mastercard to use them.


