





#### Owen's Murderers Charged

[Milwaukee] - A Milwaukee Police Detective testified that Dirk E. Harris said "Let's go roll a queer to get money to go drinking," at Harris' preliminary hearing December 14th in which he was ordered to stand trial for first degree murder in the slaying death of Dennis Owens.

Owens, 31, was found dead early December 4th in a parking lot near a warehouse at 329 E. Florida St., in Milwaukee. The area is in the vicinity of several of Milwaukee's gay bars. Owens was a floor manager for WITI-TV (Channel 6), where he had worked for 10 vears.

According to a Milwaukee Sentinel article, Circuit Judge Joseph P. Callen ordered Harris, and another suspect, James G. Malone, 18, to trial after the preliminary hearing in which the detective outlined a confession allegedly made by one of the suspects, who claimed the shooting occurred after Owens made sexual advances.

Dirk Harris, 20, was charged with first degree murder and armed robbery in Owens' death. His bail was previously set at \$150,000. He had fled the Milwaukee area, but was arrested December 6th in Amarillo, Texas when he disembarked a

Eighteen-year-old James G. Malone, was also charged with first degree murder and armed robbery in Owens' death. His bail had been set at \$125,000.

According to the Milwaukee Journal, Harris told his mother that he had killed someone. She notified police, saving she had seen him with Owens' identification and credit cards. Mrs. Harris also told police that her son was going to use Owens' credit cards to leave town.

Police recovered the murder weapon, a .22 caliber automatic handgun, and Owens' car keys in a sewer near Harris' home, after Harris told police where to find them.

The police complaint indicated Harris went to Owens' home alone and took a television and a microwave after the killing. Harris admitted stealing the items and then throwing them in Lake Michigan after having second thoughts about what he had done, the detective said at the hearing.

Police said Malone admitted he was with Harris the night Owens was slain. but denied taking part in the killing. Malone told police he waited and slept in Harris' station wagon for Harris after Harris said he was going to find someone to rob. When Harris came back to the car. Malone said, Harris said he had just shot someone. The two returned to where Owens' body lay, and Harris shot the man 3 or 4 more times until his gun jammed, and robbed the body.

Police Detective Raymond Sucik said Harris gave him a different account. according to the Sentinel. Sucik testified Harris said he left Malone alone and went to a nearby tavern. When he left the tavern, he could not remember where he left the car. While he was walking, looking for the car, a car drove past, returned and stopped, according to Harris.

The driver of the car was Owens, and he asked if Harris needed a ride home. Harris said he didn't need a ride home, but needed help finding his car. Harris then got into Owens' car and the two began to look for the car. Eventually, according to Harris, Owens stopped the car and made sexual advances.

Detective Sucik testified Harris said his gun then went off. Harris then opened the car door and Owens' body fell out. Harris then drove off, unaware Owens' body was being dragged. Harris said he returned and got Malone and they returned to the body. Harris told the detective Malone shot Owens twice and Harris fired two more shots into the body.

Harris said he returned to the scene later in Owens car, but believed he had been seen and sped away.

According to several In Step sources, Harris' photo, which appeared in the major Milwaukee media, looked "very familiar." Several people said they believed they have seen Harris before in a local gay bar.

From all of this, has come an out-pouring of support from the Milwaukee Police Department for gav victims of violent attacks. Police Chief Robert Ziarnik urged gays and lesbians to report violent incidents. "Make the complaint known to us" he said on television when questioned about "gay bashing." All to often, gavs and lesbians are afraid of their family, friends, or their place of employment finding out they are gav if they report such incidents to Police. The Police and Prosecutors have learned how to be sensitive to such issues, in the same manner they've learned how to deal with rape victims. The only way violent attacks against gays can be lessened, is by the gay/lesbian community working with the police department to report, monitor and prosecute such crimes.

#### Judge: Amendment Unconstitutional

Washington D.C.- Federal Judge Royce C. Lamberth December 13th declared unconstitutional a recently passed federal law that required the District of Columbia to allow religious organizations to discriminate against gays and lesbians, according to a Milwaukee Sentinel report.

Judge Lamberth held that the so-called Armstrong Amendment, named after its' sponsor, Sen. William L. Armstrong (R. Colo.), violated the free speech rights of the district's council members.

The District of Columbia City Council filed the unprecedented lawsuit against the congressional provision which would have weakened the district's human rights law. The Armstrong Amendment called for the withholding of the entire

D.C. budget unless the Dry Council amended the district's Human Rights Act to allow religious educational institutions to discriminate against gays and lesbians. The suit filed by the District challenged the constitutionality of the amendment and asked the court to issue the injunction.

# Gay Tales From The Campaign Trail

Washington, D.C. [HRCF]- Lesbian Sheryl Harris could hardly believe her ears when Esther, a Jewish retiree from New Jersey, popped the question: "Honey, are you the 'L' word?"

Harris, operations director for the Human Rights Campaign Fund (HRCF), was "on loan" to the congressional campaign of Harry Johnston in Palm Beach, Fla., working with local volunteers — most of them white, heterosexual and retired, like Esther and her husband, Sid.

"It's not too often a black lesbian activist from the nation's capital visits the conservative Florida Gold Coast to help get out the vote," said Harris. "Before I arrived the volunteers had been briefed that gays and lesbians were coming, which created a stir among some of them. So the first thing that went through my mind when Esther asked the 'L' question was... oh, on, here it comes... Lesbian."

Harris said she took a deep breath, pushed back her shoulders and answered, "Yes, ma'am, I am."

To which Esther leaned over and surreptitiously replied, "That's okay, dear, so an I. And so's my husband, Sid."

Confusing liberals with lesbians was just one of the many tales from the political hinterlands told by HRCF staff members recently back from working on key political campaigns around the country. HRCF, the nation's largest lesbian and gay political action committee (PAC) and lobbying group, contributed more than \$400,000 in money and staff time in 1987-88 to pro-gay candidates for U.S. Congress and progressive groups

This year, in addition to direct contributions, the PAC tried a different strategy by sending its professional employees on the road to work in several congressional races.

"You could say we put our man and womanpower where our money is," said Vic Basile, HRCF executive director. "By loaning some of our top staff we took another important step in demonstrating the wide and deep range of support lesbians and gays can give candidates who support for our issues."

Basile says the Washington-based staffers not only contributed valuable professional skills to the campaigns but helped increase gay and lesbian political visibility in communities around the country.

"We picked races where we believed we could make a difference and have an impact on the election outcome," explained Eric Rosenthal, HRCF political director. "The response from the candidates has been tremendous. We gained a lot of clout on Capitol Hill by putting our people out in the field."

HRCF professionals contributed a variety of skills to the campaigns. Some assisted with computer and data input, others helped with press relations, phonebanking or fundraising. One staffer worked on getting people living with AIDS to the polls.

But perhaps the most significant benefit was the increased visibility — and educational factor — brought by the activists.

Many of the heterosexual volunteers working with the HRCF employees asked numerous questions about AIDS and were genuinely interesting in learning more about the epidemic and about civil rights issues. For some, it was the first time they had worked so closely with open gays and lesbians in the politically charged atmosphere of an election race.

#### ACT UP Zaps Trump Shoppers

New York [TWN]- Over 100 AIDS

activists disrupted holiday shopping at New York's posh Trump Tower Thanksgiving week, hoping to draw attention to the plight of homeless AIDS patients. Three members of the New York based AIDS Coalition To Unleash Power (ACT UP) were arrested for trespassing after they laid down on the marble floor in the tower's lobby and refused to get up.

Protesters also passed out paper plates bearing the message: "Thanksgiving — empty plates for homeless people." The group also littered the area with flyers that read: "5,000 homeless people with AIDS in New York City and only 44 beds."

Also targeting New York major Ed Koch for what they call his lack of response to AIDS, protesters left the building, chanting "Koch and Trump go hand in hand, the homeless die — the rich get land."

A spokesman for ACT UP said the group wants to draw public attention to the responsibility that Trump and other developers have to people in the city. Trump was unavailable for comment.


#### Gay's Bias Suit vs. Shell Oil Gets O.K.

Oakland [WCT]- An Alameda County Superior Court judge has given a "go-ahead" to a gay man in his \$5 million discrimination lawsuit against Shell Oil Company.

Lawyers for Jeffery Collins, a former director of therapeutic products for Shell Oil subsidiary Triton Biosciences in Alameda County filed suit after his dismissal from his job for printing what Shell officials claim was an "obscene" party invitation on the company's laser printer. The law firm of Paul Wotman is contending wrongful termination and discrimination on the basis of sexual orientation under the California Labor Code.

The California Supreme Court has already ruled that anti-gay discrimination by private employers in illegal under this law.



In November 1985, Collins made a copy of a gay safe-sex party invitation on the laser printer, leaving the original in the printer tray. The next day, his secretary found the original and notified the personnel director, who then notified Shell's headquarters in Texas.

As a result, Collins agreed to leave Triton in exchange for three months severance pay. A month later the company reneged, and he received no pay.

Shell officials called the invitation obscene. The invitation contained no pictures and merely asked participants to undress and refrain from oral or anal sex, and to "expose yourself, get hard, enjoy the scene." Collins' attorney claimed the party invitation was an example of the gay community's campaign for safe sex in response to the AIDS epidemic, and that Collins, therefore, should not be punished.

Ironically, Collins was working at the time on developing an AIDS treatment.

Shell filed a motion last month to have the case thrown out. Superior Court Judge Dawn Girard refused to dismiss the case on the grounds that the invitation was obscene, and ruled that Collins had enough evidence to support his charge of wrongful termination. The case will be heard next April.

#### Chicago Mayoral Candidates Gay Supportive

Paralleling the scenario of the last U.S. Presidential election, all Democratic candidates for the Feb. 28 Chicago mayoral primary have announced their support for gay rights. Mayor Eugene Sawyer, Ald. Larry Bloom, Ald. Timothy Evans, State's Attorney Richard Daley, Ald. Danny Davis, Ald. Ed Burke, and Ald. Juan Soliz all support the passage of Chicago's Human Rights Ordinance, which was scheduled for a City Council vote Dec. 21. They have also all publicly made other pro-gay statements and gestures of varying regularity and

intensity.

In addition, former Mayor Jane Byrne, who is contemplating running this time around as a Republican, is seen as a supporter of the gay community in her own way.

According to activists, this unprecedented support for gay rights can probably be traced to five separate developments in the city:


- The nearly successful 1986 candidacy of openly gay doctor Ron Sable for alderman of the heavily gay 44th ward;
- The recent highly successful and nationally noticed voter registration drive by Lesbian and Gay Voter Impact '88, in which 17,000 new voters were added to the election rosters:
- The two-year push for a gay rights ordinance in the city;
- The formation of IMPACT, Chicago's first gay and lesbian political action committee, which has so far raised more than \$40,000;
- And the emerging visibility of the ADS activism movement, including the rowdy and confrontational ACT UP/Chicago.

The only candidates not seen by activists as gay-supportive are Republican Ed Vrdolyak, and minor Democratic candidate James "Bull Jive" Taylor.

The unprecedented support for gay rights this year has lead activists to call for a refining of the criteria with whch gay men and lesbian choose their candidate. "It's no longer enough to be for our ordinance," said Rick Garcia of the Gay and Lesbian Town Meeting. "We're beyond that."

The two factors most frequently put forth now as a "litmus test" for deciding among pro-gay candidates are the firing of Lonnie Edwards, the widely criticized commissioner of the Chicago Health Department; and the appointing of openly gay and lesbian people to visible positions in campaigns and, later, city government. These issues, activists feel, should significantly help gays and lesbians narrow, in their own minds, Chicago's very crowded mayoral race.



#### HOW THE TEST CAN HELP YOU

If you or a sexual partner are at risk for HIV infection, the HIV antibody (AIDS) test can help to determine if you are currently infected. Here is some basic information about the test, and some reasons why being tested could help you:

 Counseling and HIV antibody testing is available anonymously (no names requested and at no cost from many sites around the state-see list below). Wisconsin has strict laws which protect patient confidentiality. Testing may reduce your anxiety and uncertainty about being infected. By identifying HIV infection before she becomes pregnant, an infected woman can prevent transmitting HIV infection to an unborn child. If you are not infected (test negative) you will be provided with information about how to stay unintected.

IF YOU FIND OUT THAT YOU ARE INFECTED (TEST POSITIVE):

You will be provided with immediate reterral for additional medical evaluation, counseling and support services. You can seek immediate medical care and obtain early intervention (e.g., AZT, vaccination against influenza, and pneumococcal pneumonia). 

You can inform past sexual or needle-sharing partners of their exposure risk, and prevent additional transmission to current or new partners. If you need help informing partners, confidential assistance will be provided.

#### Changes for Milwaukee Dignity

[Milwaukee]- Changes are in the works for the relationship existing between Dignity, Milwaukee, the parish of Saint Pius X and the Archdiocese of Milwaukee. In the past Dignity has operated nearly independently of both.

Several communications from the Archdiocese indicate that if Dignity remains at Saint Pius, Pius will probably be required to assume responsibility for the Dignity Mass, and incorporate certain guidelines outlined by the Archdiocese.

Archbishop Rembert Weakland said in a Milwaukee Sentinel article that he would designate St. Pius as the Milwaukee Archdiocese's official ministry to the gay community if the parish ends the Dignity Mass, and broadens some services to the humosexual community "with a stronger kind of support group of a different nature." Weakland suggested the parish introduce support groups that accept moral Catholic teaching.

Dignity is a nationwide organization for Lesbian and Gay Catholics and their friends. Dignity chairman Kevin Quader was quoted in the Sentinel saying a parish sponsored mass would have "different thrust to it. Dignity's position always has advocated responsible sexuality. Of course, a parish-run mass would espouse complete abstinence and celibacy, which we don't feel is realistic."

The Change may indeed strengthen the gay community by providing both a Dignity group and a St. Pius service,

Similar structural changes have occurred in at least 20 of the 108 Dignity chapters across the country. This trend began a year ago after Cardinal Ratzinger o. the Vatican wrote a pastoral letter critical of Dignity-type organizations. The earliest dioceses to respond generally banned Dignity from Catholic Church properties. More recently, according to The Dignity newsletter, dioceses such as Seattle, St. Louis, and Tampa are

replacing the Dignity Mass with official Church sponsored programs for the gay and lesbian community. This is similar to what Weakland is trying to do at Pius.

Decisions on what exactly will take place here will be made over the next few months. The Archbishop has given no deadline to Dignity. For the time being, Dignity services will continue to be held at Pius X, including planned Holiday activities.

Dignity also meets the third Friday of every month at the Foundation Community Center. In the future, their other services may also be moved to that location, or possibly elsewhere.

According to Dignity, interestingly and importantly, none of the 20 chapters undergoing such changes have been weakened. Indeed it is the harshest dioceses where Dignity has most flourished.

#### Goals Project: The Next Step

[LRN]- Continuing a process begun in April, 1988 and following the presentation of a report to the Mayor of Milwaukee and the Milwaukee County Executive during Lesbian/Gay Pride Activities on 20 September 1988, Lambda Rights Network [LRN] has issued the list of specific goal statements.

The "Draft Statement of Priorities," which brings focus and unity to the original 10 page report, "will provide government and community agencies with a specific focus to begin their work of self evaluation and integration of our concerns into their own goal structure," stated Ralph F. Navarro, LRN Coordinator and project spokesperson.

According to LRN, the goals and original document are the result of work begun in April, 1988, following local elections. They represent the input of over 200 people who returned their surveys and nearly 50 people who provided significant input into the process.

Six areas emerged as primary, based on the results of the survey. They included:

- 1. Provide "fact based" sexual education programs to every level of the educational system (private and public) with special outreach to adult organizations (charitable, fraternal, etc.).
- 2. Design and implement programs that stimulate inclusivity in our culture, regardless of sex, race, age, sexual orientation, religion, handicap, etc. It is the belief of the committee that only when people find positive common points with other human beings can the fear which motivates racism, sexism, homophobia, etc. be overcome.
- 3. Expand support systems to encourage homosexual people to self identify as Lesbians or Gay men to friends, family and in the work place.
- 4. Nurture Lesbian/Gay leadership which has a focus on positive growth and development in that community. We believe that work must be done to ensure the election and appointment of openly

Gay men and Lesbians.

- 5. Work with AIDS Resource Center of Wisconsin to significantly expand AIDS and sexually transmitted disease education programs.
- Expansion of Lesbian/Gay men's civil rights to include the same rights as every other citizen. This includes spousal benefits programs, advertising in the media, etc.

LRN will now coordinate meetings with officials to implement the report. Focus groups are being developed by LRN to work with government agencies, etc., to bring further depth to the report and implementation process.





Thanks for publishing the letter from DJS in your November 24th issue... it provoked a few thoughts that I would like to share with you.

First, with regards to the crass comment about typographical errors. DJS obviously hasn't popped by the In Step office when you're putting together an issue and see, first hand, the organized insanity that goes on. DJS: Take a hard look at what you see within these pages and then ask yourself if you could do all that yourself, spend hours on the phone getting advertising and other information. not to mention getting out to photograph special events - every two weeks! How about if Ron were to put a cover charge on each issue so he could afford a staff to help ease the workload so that the amount of typos would decrease? Too often there isn't enough time to scrutinize the magazine prior to going to press in a 12- to 20-hour day... Secondly, most of us within the (gasp) gay community (end gasp) try real hard to unit as a single entity. They seem to think that it's okay to totally eliminate the "other" sex from their lives. What is everybody afraid of? Sexually, I would like to think that either sex doesn't have much to worry about.

Third, I resent your remarks about "most men still slut around..." Believe it or not, there are lots of us who are in long-term monogamous relationships. Yeah, there are those geeks who cheat on their lovers, but gay people themselves seem to thrive on "that moment of bliss" even if it means involving themselves with someone who has a lover. I, for one, will not knowingly involve myself sexually with someone who has a lover. I will take

him/her out to dinner or a show, however, with the lover's full knowledge and trust.

Let me ask DJS this: How many times have you been given a phone number from someone you met that was quickly put in your wallet and subsequently thrown in the trash months later? If you took someone's number, you must have been interested in that person at the time. Try calling some of these acquaintances and go out on a (second gasp) date. one's brain housing group, I can say that bars are not exactly the best way to nurture a relationship. Try seeing someone as they are - sober or off drugs - and do something crazy like going to a concert, to the Art/Public Museum, the State Fair, Summerfest, or climbing the steps at Holy Hill, or talking about each other over a romantic dinner. And heaven forbid - you should ever be left at the doorstep without having sex with someone! Pick up a good book on the effects of alcohol and drugs like methamphetamine, cocaine or LSD on the brain and then re-read your letter ... the answers are all there.



I see many people so afraid of AIDS that we're withdrawing further from each other. Face it. AIDS is on all of our minds. To convince yourself that there are certain "things" you can do sexually and not worry about AIDS is incredibly foolish. Safe sex means no exchange of bodily fluids and no anal sex. I was one of those fool-hardy souls who believed oral sex was okay... I was diagnosed with full blown AIDS a couple of months ago. But, I've learned that there is a lot you do sexually and still be safe. It does, however, take a desire to alter your thinking towards sex. Having AIDS certainly has thrown a major obstacle into my relationship with Jay, but we both feel that it was caught early enough to where we believe I will survive... death is just not part of my consciousness.

How many of you are playing games with vourself? I hear too many people saying "I was tested recently and am negative" to put a potential suitor at ease when, in all actuality, you haven't been tested at all. Here's an idea: Go into the testing site together and when you go to get your results give each other's confidential number. If you're looking at you body in the mirror and notice that rash that doesn't seem to want to go away, or you've been waking up in the middle of the night sweating, or you notice that you're sick to your stomach more than you should - and you keep telling yourself that everything is fine - get in and get help. People who seem to be surviving generally are the ones who sought early help... wait too long and it gets very difficult to stabilize the infection(s). Retrovir (AZT) seems to work pretty good and there are newer drugs like CD-4P on the horizon that look even more promising. I'd be lying if I said I wasn't scared, but having a positive attitude, having a lover that I'd jump through flaming hoops if he'd ask me, and having a family that shocked me at their understanding and compassion, makes living with AIDS a lot easier to deal with.

Before you start to point fingers at anyone, take a good hard look into the mirror and ask yourself if you're pleased with what you see.

#### M.A.P. May Take On Nursing Homes

[Sentinel]- The Milwaukee AIDS Project is close to filing a discrimination complaint against all Milwaukee County nursing homes because the homes have refused to admit AIDS patients.

Douglas Nelson, executive director of the group, said Dec. 7 has has been in contact with the Civil Rights Office of the

A discrimination investigation would be launched within three days of filing the complaint, he said. He said a "pattern of discrimination" would not be difficult to prove.

Filing a lawsuit against the nursing homes also is being considered, he said. Such a suit was successful in Minnesota in opening up nursing homes to AIDS patients.

"Some people have recommended a lawsuit here, but we are looking at the civil rights complaint as a starting point," Nelson said.

Nelson said he would meet with county and state officials to see what could be done to force or persuade nursing homes to admit the patients. The state can withhold reimbursements to nursing homes if discrimination can be shown, he said.

A public hearing into the matter may be held soon by the County Board's Health Committee, he said.

Nelson said the filing of a complaint would be related to the fact that the AIDS Project has worked unsuccessfully since April to find a nursing home in Milwaukee County that would take AIDS patients.

He said three patients now needed the type of custodial care that nursing homes could provide. The three are patients at the Milwaukee County Medical Complex in Wauwatosa.

Nelson said the AIDS Project surveyed all 15 Milwaukee County Nursing homes on whether they would take AIDS patients, and each home said no. Several homes, he said, were "evaluating" their policies, but continued to refuse the patients.

"We have offered free in-service training on AIDS patients to the nursing homes," Nelson said, but none have accepted the training.

"It's an outrage that in our community there is not one home that will take an AIDS patient. It's an embarrassment that we must send people who need custodial care away to other counties. It is unfair to the patients, their families and their loved ones."

#### H.I.V. & TB Testing At Baths

Milwaukee's Club Baths will be the site of on-going HIV antibody testing, as well as screening for Tuberculosis. The regularly scheduled testing began at the club last week, after it was discovered that patrons may have been exposed to the highly communicable disease TB over the past few months.

The testing, to be conducted by the Brady East Sexually Transmitted Diseases Clinic (BEST), will be anonymous and on a donation basis.

Baths patrons are urged to be tested for their HIV status as well as TB. Reported cases of TB had been in steady decline in the past, but has re-emerged in recent years, and has been closely associated with HIV infection.

"Volume Two" contains a large section on treatment options. AZT, aerosol pentamidine, DHPG, TPN, AL721, and holistic approaches are discussed in first- hand accounts. "Volume Two" also attempts to remedy what Callen views as the major deficiency of Hints-that it contained little material not generated by white, gay men. The new book contains much material by and about women and AIDS and people of color with AIDS. It also includes a section about AIDS-Related Complex and HIV antibody positivity.

#### Gallo Says Activists 'Misguided' on HIV

Los Angeles [TWN]- AIDS protesters who criticize the U.S. government for sluggishness in releasing new drugs are expressing "misguided, misdirected and misinformed anger," according to Dr. Robert Gallo, co-discoverer of HIV, the alleged "AIDS virus."

Gallo was speaking at a news conference in Los Angeles before addressing the Los Angeles World Affairs Council.

Gallo, and co-discoverer Dr. Luc Montagnier of the Paris-based Pasteur Institute, were both on hand to answer questions about AIDS and their search for new treatments.

"We should not expect miracles," said Montagnier. "We should expect continuous progress in the therapeutic field."

Both men criticized those who demand access to untested drugs based on test-tube studies or anecdotal, unscientific reports that they helped

individual patients.

"You can make claims for a lot of things having effects," Gallo said. "You can make claims for eating spinach. You can make cases for eating hamburger, because people with AIDS go up and down in the severity of their symptoms, regardless of what medicines they use."

"Without careful studies, we learn nothing, and we encourage fraud," he added.

Both men said they believed the gradual development of drugs to treat AIDS would eventually make it a manageable disease like diabetes. Both praised the drug AZT, a highly toxic drug which appears effective in slowing the progression of AIDS in HIV infected people. Both also expressed high hopes for the development of recombinant CD4, a drug that shows promise as the next breakthrough in anti-viral therapy.

#### Sweden AIDS Drug Better Than AZT

Stockholm [Sun Times]- Swedish researchers said December 12 they have developed a drug found to be five times more effective against AIDS than AZT, the only medicine approved so far by the U.S. Food and Drug Administration to prolong the lives of PWA's.

Virologist Bo Oberg of Medivir Invent AB, a new research company, told a press conference that the drug fluorinethymidine (FLT) drastically weakened the acquired immune deficiency syndrome virus in test trials on monkeys and on human cells.

"FLT is at least five times more effective than AZT (azidothymidine)... These results are a major breakthrough," said Oberg, a professor at Karolinska Institute here.

"We chose AZT as a reference since it is the only medication on the market today against AIDS," he said of his group's research.

Neither AZT nor FLT is a cure for AIDS, but each slows the reproduction of HIV, which causes the deadly disease, and thus may extend the lives of patients by months or even years.





# "Driving Miss Daisy"

On a recent excursion to Chicago, I had the opportunity to view "Driving Miss Daisy" by Alfred Uhry at the Brian Street Theater. This work has just been awarded the Pulitzer Prize for Drama for 1988.

Uhry's work consists of small vignettes helping us understand the inter-relationships between Miss Daisy, her son, Boolie, and her chauffeur, Hoke in a time period from 1948-1973. You should note that the play is set in Atlanta during these years of more fully developed understanding in terms of race relations. The Wethan's, Miss Daisy and her son are of Jewish extraction and Hoke is black.

Cast as Miss Daisy was the truly exceptional actress Dorothy Loudon. Miss Loudon is probably best remembered as the original Miss Hannigan in her Tony Award winning role in the Broadway musical "Annie." For that performance she also won the Drama Desk and Outer Critics Circle Award. Her abilities as the marvelous actress she is were clearly in evidence especially in her physical expressions as an aging woman. Also a mark of an exceptional performer is the communication established between the characters and shown to the audience in terms of non-verbals. Miss Loudon's performance said almost more in this communication than the lines she spoke. She is a consummate professional and has worked her craft to an art form.

Closely matched to her will Bill Cobbs as Hoke. He also have had Broadway experience in both "Ma Rainey's Black Bottom" and "Master Harold.. and the Boys." He was a wonderful compliment to Miss Loudon and as professionals their chemistry on stage is exciting.

It is here that the third character in the

piece, Matt De Caro needs to be further seasoned through further experience and depth. His abilities though acceptable for the role were clearly not on a par with the other two performers. Perhaps it is just with more breadth of experience that he will in fact grow into an actor of greater stature. As it was, he was clearly out of his element in this production and could not measure up. Unfortunately, this did weaken his credibility and the piece somewhat.

The simplistic set served the play very well. The play was also performed in toto without an intermission.

I would encourage you to keep abreast of theatre offerings in the Chicago area. Pieces of this caliber are definitely available and well worth seeing. Such excellence should not be missed!

# Clark Named New Columnist



go for their dreams because you did."
Harvey Fierstein's dream, the long-awaited film adaptation of "Torch Song Trilogy" has finally been realized in classic "labor of love" tradition. "Torch Song Trilogy" is the funny and poignant story of a gay New Yorker's search for love and respect in a heterosexual world which focuses on the lovers in his life, as well as his strong-willed mother.

From its birth off-Broadway to its more than two year successful run on Broadway and two coveted Tony Awards - Best Play and Best Actor, Fierstein was finally able to bring all of the right elements together to produce the screen version. This combination included the assembly of a dynamo cast - Harvey Fierstein, Anne Bancroft, Matthew Broderick and Brian Kerwin, the producing talents of Howard Gottfried, responsible for such award-winning, thought-provoking films as "The Hospital," "Network," and "Altered States," and finally, a studio that was committed to bankrolling the project, New Line Cinema.

Before securing a commitment from New Line Cinema, numerous producers and studios had expressed interest in the project, however, each had screen visions of "Torch Song" that called for major revisions and cuts, siphoning out what Fierstein considered to be the heart and soul of the work. Based on the critical and boxoffice success of the Broadway stage production, the seasoned production team of Director, Paul Bogart, and Producer, Howard Gottfried, and the magnificent ensemble cast, New Line Cinema realized the project's potential to reach a larger audience and offered financing to "Torch Song" without imposing any major changes on the screen adaptation. A happy union for all parties involved, Fierstein, who adapted the work himself to screenplay, stars in "Torch Song Trilogy" as Arnold Beckoff along with the exceptional talents of Anne Bancroft, Matthew Broderick, Brian Kerwin and Karen Young.

"Anne Bancroft saw the show about six years ago," Fierstein recalls, "and afterwards she and her husband Mel



Brooks and I went out. Mel sort of teasingly said he never thought a film version would get made, and I said fine — believe what you believe — and I'll call you when it's ready. And Anne said sure, call me when it's ready, and so I called her when it was ready. Anne was always my fantasy of playing the mother, and it just goes to show that dreams do come true."

Anne Bancroft, quickly accepted the offer to play the mother in "Torch Song Trilogy." "Harvey opened up the mother's role in the screenplay, bringing in scenes from her earlier life and, remembering the richness of the stage production, I felt drawn into this enormous magnetic force."

"Sure, it's both a romantic comedy and a drama about nine years of one man's struggle in the '70s and '80s," says Broderick. "But more than about being gay, it's about having a family and understanding what a family is..., in that sense, it really is an old-fashioned story."

Matthew Broderick received his breakthrough role as David, Arnold Beckoff's teenage, adopted son, in the off-Broadway New York stage production of "Torch Song Trilogy," which earned him an Outer Critics Circle Award and The Villager Award. Broderick was cast in the film version of "Torch Song Trilogy" as Arnold's lover Alan — a role that serves as another turning point for the actor, being his first portrayal of a grown man. Broderick enjoyed the challenge of rejoining Fierstein in the film version of "Torch Song" as the older character,

Alan. "It's so nice go get a phone call after five years to say... we're going to do it again, to work with people you've worked with before, people you like and you know are good," remarked Broderick. "It's nice to have another chance at it."

Anne Bancroft, who plays Harvey Fierstein's mother, feels strongly about the tendency in film and television to steer away from the controversy of gay people and the world they live in ... "the world is full of people afraid of what they don't understand or don't know. There is nothing you can do except to try and educate them away from their fears. The role epitomizes the parent who wants to control their children into becoming what they dream them to be, rather than what they want and who they are. I can only hope that some people will see the film and notice themselves in this person, and learn to love and support and not to control."

Harvey Fierstein describes "Torch Song Trilogy" as "a story of a man trying to find his place in the world, a world that isn't necessarily built for him, and he continues because he is brave of spirit and true of heart. He builds a world within the world for himself to exist."





#### **Christmas Presence**





#### Gossip

I was having a bad day: The article I was working on wasn't going well, my dinner date for the evening still hadn't called, and on top of it all, I was feeling fat. So when the phone rang, I thought it could only be more depressing news. But I was wrong. It was my friend Steve who breathlessly spoke the three little words I so love to hear. What he said was, "Have you heard?"

Other people may thrill to other words"I love you," "I understand," is popular; so is "The check is in the mail", and those things have been known to cheer me on some occasions. But nothing brightens my mood like the promise contained in Steve's question. What would it be? I wondered. Some dirt about a mutual friend or rival? Some hearsay about an acquaintance's sex life? Maybe some gem about some goody-two-shoes we both despise.

I can't tell you what Steve told me that day — after all, it was supposed to be a secret in the first place — but I can say that the second half of my day was a lot more fun than the first; somehow just knowing what I knew was enough. It was great gossip and I appreciated it.

The way some people talk, you'd think that gossip was the eighth deadly sin, right up there with gluttony and greed. You'd believe that it was a bad waste of time and at worst, calculating and mean. It can be. When I think about gossip, I think of it as a form of emotional speculation, a way to figure out what is going on in the world around me. I try to avoid bad gossip, anything that embarrasses, insults or destroys self-esteem. I could not live without the other kind, that which amuses, moves or instructs. Let's consider gossip, and the three E's of good gossip.

1. Gossip is Educational. Okay, so I did learn a few things in school, like who wrote Moby Dick and that the hypotenuse of a right triangle is equal to the sum of the squares of the other two sides — but everything I ever learned about people, I learned through gossip. Nobody taught me, for example, that, standing in a certain part of a bar meant you were cruising or the god-like hunk so many lusted after kissed like a dead carp. I learned these things by talking to friends. And this was useful information. Without it I may have gotten a few too many propositions, or worse yet, found myself married to a carp.

2. Gossip is Entertaining. The ugly truth about life is that a lot of times it's pretty boring. Think about what you did today: got up, went to work, came home, went to bed. Maybe you also talked to some friends, did some shopping and watched a little T.V. Which part was really the most exciting? Talking to your friends. And what did you talk about? Not the issues of the world, you talked about each other, who is going out with whom, who's looking good and who isn't.

The reason you had that conversation, or at least the reason I had it, was not necessarily that I care who's seeing who or what someone did. I had the conversation because it was fun. It's fun to watch peoples lives unfold, it's like having your own personal soap opera, and the suspense is great. Will Rob break up with Brad because he went out with Mike? Will anybody show up at Tad's party? Tune in tomorrow.

3. Gossip is Exercise. Some people swear by running, others think aerobics is the answer. But for my part, I say nothing relieves tension, exercises important muscles, and gives physical release like picking up the phone and saying, "Have I got something to tell you!" It may not do much for the thighs, but it sure gives the heart and mouth a workout.

But of course, you have to remember that something that educates, entertains, and exercises will sooner or later do the same for somebody else. That's one of the

So why am I so confused?

Simply put: Sam Kinison and the 2 Live Crew.

On his new record, Kinison shouts that AIDS started when some "queer stuck his dick up an African monkey's ass"; he urges his audience to admit that AIDS is the "homos" problem, not theirs; and he bellows that "real men" don't use condoms

A co- worker responded simply. "Well, gee. Let's hope he's a real man then."

And then there's the 2 Live Crew. The great minds that brought you "We Want Some Pussy" (a stupid, sophomoric record which I still steadfastly defend in the name of the First Amendment now bring you their version of "Do Wah Diddy."

The 12 inch, X-rated extended remix contains the following:

"I saw this fag/ Tricking at the bus stop/ Singing do wah diddy/ Diddy dum diddy do/ I said you sissy mother fucker/ You know you ought to stop/ Singing do wah diddy/ Diddy dum diddy do/ Spreading AIDS/ (Spreading AIDS)/ Park bench/ (Park Bench)/ Watching dicks/ (Watching dicks)/ You know a real

nigger/ Ain't about all that shit."

And on a lower, but just as offensive, note, there's DJ Jazzy Jeff and the Fresh Prince on their "He's the DJ, I'm the Rapper" album. Here, the teen rap idols shout for all the "homeboys with AIDS" to be quiet, and for all the "girls who don't like guys (ew, gag)" to be quiet.

Now I would like to ask the music industry a simple question.

Where the hell are your brains?

Somewhere in the last twenty years it has become unfashionable to tell "nigger" and "kike" jokes.

These days, you tell those kind of jokes an no one buys your work.

But not so with homophobia. Gay and lesbian Americans are still the "niggers" of the world, the one minority group it is still socially acceptable to fire, expel, evict, defame and even beat up in this age of "social enlightenment."

Which makes me so irate that the music industry could condone or even promote such rabidly hateful attitudes under the very noble guise of artistic freedom.

I am no expert on music contracts, but-I am aware that, except in cases where an exceptionally talented artist is given full artistic control, record companies will on occasion throw crap back at an artist if they don't like it (read: if it won't sell).

Ah, but homophobia sells. An increase in anti-gay violence of 42 percent nationwide as per the National Gay and Lesbian Task Force's 1987 Anti-Gay Violence, Victimization and Defamation Report shows nicely. A 1987 Justice Department study which found that gay and lesbian people are "the most frequent victims of hate-motivated violence" shows that.

But the recording industry must always take the "higher road" in protecting an artist's creative integrity.

Bullshit.

feel safe walking the streets at bar time. Leave with a friend, or ask someone to walk you to your car.

Some bars have offered foot patrol outside the bars on busy evenings. The Beer Garden, in particular, has a commendable team of women who patrol the area surrounding the bar. As a result, women have reported less crime in the area.

We need to become responsible for our own safety. Perhaps groups like Lambda Rights Network could become involved in a safety campaign directed at bar owners, patrons and members of the gay/lesbian community.

While I was a student at Marquette University, a fellow student was murdered on her way home. The result to this tradegy was a mobilization of Public Safety, parents and students to organize a Escort Service and Foot Patrol to provide additional support to local police efforts. The response was incredible and the result is a safer campus. contd. on page 63



#### darla's view...

Violence is a topic rarely discussed in our community, but a recent tragedy has opened discussion of the issue of gay/lesbian bashing and violence in Milwaukee, and throughout the country. The recent murder of Dennis Owens, a WITI-TV (Channel 6) employee has drawn attention to the issue of gay/lesbian bashing and its impact on the gay and lesbian community.

The news coverage of Owens' death has had homophobic overtones that are common in the media. It has been somewhat assumed that Owens was in a gay bar because he was in the neighborhood of many gay establishments. There are many "straight" bars in the neighborhood of Florida St, but the media failed to mention that Mr. Owens might have been in one of those bars.

The fact that the media mentioned the neighborhood as a gay area is a homophobic reaction to the story. Rarely, probably never, has the media said, "George Smith was murdered outside a heterosexual bar." The mere mention of Owens' suspected, but not confirmed, sexual orientation is a homophobic statement.

Some years ago, crime suspects were described by the media with reference to race. The argument was successfully made that reporters frequently described black suspects with regard to race, but made no mention of race when the suspect was white.

This is no longer a common practice in journalism. The attention that the Owens murder has caused could backfire on the gay/lesbian community. Attention has again been drawn to our "gay ghetto." Other maniacs, who until recently may not have been familiar with the gay bar scene, now know where we entertain ourselves. The attention could result in more gay/lesbian violence.

Reporting violence to the police has

always been a problem in the gay community, and the Owens incident will not help the situation. When we see the treatment that such incidents receive in the media, fear becomes the primary motivator for leaving the police out of violent problems. Property crime is also neglected because gays and lesbians do not want to be identified as customers of certain gay bars.

The fear creates a vicious cycle with regard to our own police protection. Even though incidences of attacks, property crime, rape and even murder may be significant in the areas housing the gay bars, the police are rarely called, so the problem is not documented. As a result, we can not demand increased police protection because we haven't documented the problem.

Of course, those of us who have been active in the gay and lesbian community for any length of time know that gay bashing is not a recent occurrence. In 1982, members of the Wisconsin Governor's Council on Lesbian and Gay Issues conducted a state-wide survey on lesbian and gay violence. The results concluded that violence is a major problem in the gay/lesbian community.

The National Gay/Lesbian Task Force (NGLTF) has been conducting a violence survey, modeled after the Wisconsin survey, since about 1983. A recent issue of College Woman, a magazine published by Working Woman Magazine, discussed the problem of gay/lesbian bashing on college campus throughout the country, and their data was derived from the NGLTF survey. My colleague, Morgan Summer at Wisconsin Light, can speak first hand about gay bashing on college campuses.

What's the answer? As women, we've learned that there is safety in numbers. We learn from childhood on that it isn't safe to walk alone, and men may need to learn this lesson. For some reason, men

Would they let an artist do twenty minutes on why Hitler was right to throw the Jews in ovens? Would they shout "artistic integrity" if a comedian cracked jokes about how funny it was that the Klan lynched Black people for so much as looking at their wives?

No. But then, that wouldn't sell.

But what about the first Amendment, Cliff? What about artistic freedom? Couldn't pro- gay and pro-lesbian speech and music be censored under the same controls that you are professing? Couldn't the Parents Music Resource Center come down and take away your Prince records using your same arguments?

Don't think that argument hasn't nagged me in my sleep for months now.

I finally came up with two positions which, in my humble estimation, reconcile my fight-to- the-death attitude about the first Amendment and my desire not to see and hear "artistic" work that promotes hatred, violence and bigotry against an American minority.

First, I feel that it is indeed the responsibility of a record company, publisher, editor, etc. to edit and review product that will bear their banner for their own standards of taste. If a company's position is to not tamper with an artist's product, then fine, that's their stance. They certainly are entitled to that. Last time I looked, this was still America.

All I ask is that all these companies exercise the same control on an artist who comes up with such anti-gay garbage that they would place on someone who came out with the same tripe aimed at any other minority.

Just because homophobia sells, doesn't make it right. Twenty-five years ago ''nigger''jokes sold, too. That didn't make it right. And it doesn't make it right now.

And secondly — and this is the most important point here — the right to freedom of speech is not, and has never been, an absolute. You cannot get up in front of a crowd of 10,000 angry people and urge them to get their guns out and shoot the mayor; and you cannot yell

"fire" in a crowded theatre.

And you should not be able to shout such lies that AIDS is "the homos" problem" and that "real men don't use condoms" either.

In instances such as these, the question is not one of, "Is it offensive to my delicate sensibilities?" but "Is it endangering the public health and safety?"

With 77,000 Americans diagnosed with AIDS or HIV infection since 1981, 43,177 which have died, and 24,400 people who have been exposed to the disease by non-homosexual sexual means since 1981, isn't allowing such garbage to be sold to the masses tantamount to shouting "fire" in a crowded theater?

It not only crosses the boundaries of bad taste (something which every American has an inalienable right to do), but it endangers the public health and safety, hence making it not only wise in the interest of what is fair and just for Warner Brothers to edit out the AIDS gags from Kinison's diatribe, but it is their duty to do so in the interest of the public health and safety.

As for other homophobic, repulsive, AIDS-phobic recordings (The 2 Live Crew, DJ Jazzy Jeff, et al.), I urge all concerned Americans to exercise their First Amendment rights to write letters, make phone calls, picket and boycott. By doing so, maybe we can bring about a day when bigotry against gay men and lesbians is treated the same way bigotry against America's Black, Jewish, Arab, Hispanic communities is treated by the modern-day recording industry.

Maybe then, this will really be the kinder and gentler nation we keep hearing about.
