





## WI to appeal hate crime law to U.S. Supreme Court

In Step — Wisconsin Attorney General James E. Doyle announced July 31 the state would appeal the Wisconsin Hate Crimes law to the U.S. Supreme Court.

The Wisconsin Supreme Court struck down Wisconsin's law on June 23, the day after the U.S. Supreme Court ruled a St. Paul. Minnesota hate crime ordinance "an unconstitutional abridgment of freedom of speech." The unanimous U.S. court vote decried the "selectivity" of the St. Paul ordinance and declared it an infringement of First Amendment free speech rights, saying "It has proscribed fighting words of whatever manner that communicate messages of racial, gender or religious intolerence. Selectivity of this sort creates the possibility that the city is seeking to handicap the expression of particular ideas."

The now invalid St. Paul ordinance was more broadly phrased than most such measures, including Wisconsin's.

Wisconsin's state-wide law enhances penalties for crimes against people and property which were motivated by bigotry based on race, religion, disability, sexual orientation, national origin or ancestry. The Wisconsin law was recently altered to provide clearer standards for judges & juries to use in deliberating over hate crimes cases.

The state court's June 23 decision was split 5-2. Chief Justice Nathan Heffernan expressed some "regret" in rendering the decision: "Because we wholeheartedly agree with the motivation of the Legislature in its desires to suppress hate crimes, it is with great regret that we hold the hate crime statute unconstitutional — and only because we believe that the greater evil is the suppression of freedom of speech for all of

State Justices Shirley Abrahamson and William Bablitch dissented. Abrahamson wrote: "I believe the Wisconsin statute ties discriminatory selection of a victim to conduct already punishable by state law in a manner sufficient to prevent erosion of First Amendment protection of bigoted speech and ideas."

Doyle, who will appeal with the support of several other states, thinks the Wisconsin court erred, because the state law does not punish thoughts, but increases the penalties for people who select their victims because of bias. The appeal to the U.S. court should come by mid-August.

# Gay community responds to stepped-up vice arrests

Milwaukee [In Step] — Concerned members of the Gay and Lesbian community are working on a number of fronts to respond constructively to the massive increase in vice squad activity taking place throughout the metropolitan Milwaukee area.

The Vice Squad of the Milwaukee Police Department, the campus police at UW-Milwaukee and suburban police departments in Wauwatosa and Cudahy as well as the Village of Shorewood have intensified their crackdown on sexual activity in parks and restrooms in the last four months, raising concerns about possible entrapment and allegations of inconsistent enforcement of the law.

Ralph Navarro of the city's Gay Information Service, criticized police sting operations, saying they were "creating crime, not solving crime." He said: "I have heard too many stories over too many years that indicate it is the police who are initiating the activity."



Attorney Thomas E. Martin, who is representing several men who have been arrested, told In Step that the controversial use of undercover police decoys in parks and public washrooms was "awful but lawful" in most cases.

#### INCONSISTENT ENFORCEMENT?

Martin is particularly concerned about the disparity of treatment different authorities dole out to the men arrested. Some men are charged with municipal citations, which simply carry a fine. Others have been charged with criminal misdemeanors, which carry more serious penalties. He called this inconsistent enforcement of the law "arbitrary and capricious."

Martin also noted that in most cases, at the charging stage, no distinctions are being made between first offenders and repeat offenders. In the case of repeat offenders, no referrals are currently being made to the mental health system.

This concerns Gary Hollander, a psychologist who also worked on the Blue Ribbon Commission on police reforms. Hollander feels the underlying behavioral issues cannot be addressed solely through criminal prosecutions. He is also concerned about the "high risk behavior" involved in such anonymous sexual encounters and cites the need for greater education.

Terry Boughner, editor of Wisconsin Light, believes internalized homophobia may be one of the factors leading some men to seek anonymous sex in public places. He thinks that the Gay community as a whole needs to do some soul searching and stategizing regarding the increase in promiscuity among some of its members. "We have to encourage people to be more responsible," he said.

Kitty Barber of the Lesbian Alliance of Metro Milwaukee joined in the consensus of opinion. She told In Step: "Criminal prosecution is using an atomic weapon for killing flies. With all of the serious crime in Milwaukee County this summer, this seems to be a very poor use of limited police resources, when there are constructive alternatives that we are proposing that would reduce this problem."

#### PROPOSING SOLUTIONS

Attorney Martin has helped organize an ad hoc committee to address current law enforcement practices as they relate to vice arrests and their effect on the Gay community. Navarro, Hollander, Barber and other concerned people have proposed several avenues to tackle the problem.

First of all, Martin has written to First Assistant District Attorney Robert Donohoo requesting that the D.A.'s charging policies be clarified, made consistent and be implemented in a uniform manner. Donohoo is expected to respond to Martin's request sometime in August. In Stepwill inform readers of the result.

Other committee members have contacted security personnel and merchants at the Grand Avenue Mall (where a number of arrests have been made) to suggest a more visible uniformed presence of security rather than the use of plainclothes decoys. The posting of signs indicating that the restrooms are heavily patrolled and the redesign of restrooms to reduce the liklihood of sexual contacts were also suggested.

The idea that more publicity about the prosecutions appear in the mainstream press and Gay newspapers in an effort to deter the sexual activity met with a negative response. Merchants and police indicate that whenever publicity about the location of public sexual activity appears in the press, it actually leads to increased activity.

Martin said that one of the toughest challenges to get across to law enforcement authorities was that aggressively ridding one particular location of sexual activity would not end the problem. Often the activity is merely transferred to another place, in what one activist described as "precinct roullette."

#### UPDATE ON UWM

On August 5, Shane Reister, co-president of the Gay and Lesbian Community (GLC) at UWM, met with UWM Chancellor John Schroeder, Campus Police Chief Phillip Clark and

other university officials about the vice arrests at UWM. At least 83 men have been arrested in the last three months for sexual activity in the school's restrooms.

Reister expressed concern about the alleged methods of entrapment being use by campus police. Unfortunately, none of those arrested has been willing to file a complaint, so Reister came away with the Impression that the police there will continue using undercover decoy methods until their methods are formally challenged or proved illegal. Chief Clark reportedly said that the tactics employed were legal and effective.

Reister submitted to Chief Clark a list of hypothetical situations (compiled by GLC members) that might occur in restrooms. Clark promised to read them and then clarify how the police would respond.

Chief Clark said he would provide the GLC with "incident reports" of the arrests and demographics about the people arrested. Reister said these could help his group to evaluate police behavior. The administrators also told Reister they would consider remodeling the restrooms in ways to deter such behavior, but gave him no timeline for doing so.

Reister told In Step: "I'm disappointed they don't seem to want to deal with the underlying issues. They just want to clean up the problem at UWM, and they're not very sensitive to the issue of entrapment." He said that the Chancellor and Police Chief promised to continue communicating with the GLC, however.

Most of those activists interviewed by In Step said that the merchants, police and prosecutors they have spoken to show little understanding of why men engage in public sex and seem convinced the only way it can be stamped out is through criminal prosecution. While members of the ad hoc group pledge to work diligently through the proper channels to see that some procedural reforms are instituted, they believe the process of changing attitudes may be much more difficult.

Editor's Note: In our next issue, Attorney Martin will describe, in detail, an arrest under the circumstances above and offer his advice.

#### Local suit against Eliason ejected; federal suit pending

Milwaukee [In Step] — Circuit Court Judge John McCormick has dismissed a lawsuit filed by Julie Brienza who claims that the Rev. Vic Eliason and United Press International conspired to unlawfully fire her from her job because she is a Lesbian.


Judge McCormick dismissed the local case because a similar lawsuit has been filed by Brienza in federal court in the District of Columbia. The federal case, seeking \$12.5 million in damages, will proceed.

Brienza was fired from her job as a reporter for UPI in April, 1990. At the time, she also did freelance work for the Washington Blade, a Gay newspaper. Her suit alleges that after Rev. Eliason discovered that she worked for both news organizations, he orchestrated a campaign to have her fired from UPI. He allegedly used his TV and radio stations (WVCY) and his contacts with other fundamentalist ministers to publicly denounce Brienza's Lesbianism and to pressure UPI to fire her.

Eliason counters that he was only exercising his freedom of speech and that UPI rightfully fired Brienza for using their facilities for non-UPI work.

Brienza's federal suit charges Eliason with malicious interference with her UPI contract, unlawful invasion of privacy and defamation for exposing her as a Lesbian, and violation of Wisconsin's hate crimes law (recently ruled unconstitutional). It also claims that UPI violated the District of Columbia's Human Rights Act by dismissing her because of her sexual orientation. Brienza resides and works in the District.

Brienza is represented by a D.C. law firm and the Lambda Legal Defense and Education Fund. Said Lambda Legal Director Paula Ettelbrick: "Eliason's witch hunt tactics against this one reporter are a tragic reminder of the power of homophobia.

#### Gay man bashed near Astor Hotel

Milwaukee [In Step] — Robert Keirsey, 43, was robbed and assaulted in a violent Gay bashing incident outside the Astor Hotel on Milwaukee's east side just before midnight on Friday, July 31.

As Keirsey was walking home from the This Is It bar, he was stopped by two black men just outside the Nantucket Shores restaurant, which was closed. The assailants demanded Keirsey's money, which he gave them. They then began to taunt him verbally and smashed his face through a window of the restaurant.

Bleeding profusely, Keirsey staggered to his home about three blocks away, where he knocked on the window to alert his roommate. His roommate let him in and immediately called 911.

Keirsey told In Step that before they smashed his face into the window the assailants taunted him in a rap-like rhythm, saying: "Hey, pretty boy, faggot, rich boy, white boy...We're gonna fix your face and make sure no one — man or woman — ever wants you again."

Keirsey said he does not dress or act stereotypically Gay, so he speculated that the attackers may have been following him home from the bar.

Keirsey was treated at St. Mary's Hospital for facial lacerations and bruises. He received seven stitches above his right cheek bone and, nearly a week after the attack, was still sore from the cuts and bruises.

Keirsey's roommate said the response to the 911 call was pretty slow. It took almost a half hour for the police to arrive. But Keirsey told In Step that once police arrived they were "extremely helpful and thoughtful." He told them what the assailants had said to him and asked the police to record it as a hate crime. A detective called Keirsey the following day to let him know that his wallet and brief case had been recovered. No suspects are in custody.

Keirsey has a new sense of how vulnerable everyone is on the street. He urged people to be careful when leaving bars and suggested that carrying a whistle also might help. He said that Gays in San Francisco carried whistles and that they were sometimes effective in frightening potential muggers away and/or in calling for help.

Victims of Gay bashings in Milwaukee, whether verbal or physical or both, are encouraged to call the Gay Bash Hotline at (414) 444-7331, as well as reporting it to the police, making sure they document it as a hate crime.

## Ahmuty to head state ACLU

Milwaukee [In Step] — Christopher Ahmuty, well known as a supporter and volunteer in Milwaukee's Gay and Lesbian community for many years, has been appointed the new Executive Director of the American Civil Liberties Union of Wisconsin.

The choice of Ahmuty caps an extensive national search conducted to find a replacement for retiring Director Eunice Edgar. Ahmuty has been employed by the Wisconsin ACLU for ten years, most recently as Associate Director. His appointment was a popular choice among local Gays and Lesbians.

"Chris is a person who has dedicated his life to the principles of the ACLU, and that includes full civil rights for Lesbian, Gay and Bisexual people," said Ralph Navarro, former chairman of the Lambda Rights Network (LRN). Ahmuty was a founding member of LRN and holds a seat on its Board of Directors.

Scott Gunkel of LRN said of Ahmuty's appointment: "It's the best choice they could have made." He noted Ahmuty's work in the "No Retreat on Civil Rights" campaign, in the effort to defeat the anti-Gay Rawhide Amendment and his diligent work to establish police reforms in the wake of the Jeffrey Dahmer case.

"The ACLU has always been a great ally of the Gay community," said Gunkel. "With Chris at the helm, I'm sure that cooperation will continue."

#### Senate moves to kill D.C. partners law

Washington - The U.S. Senate on July 30 approved an amendment which would effectively rescind the District of Colombia's recently enacted domestic partnership ordinance.

The move came when a procedural motion to table an amendment from Sen. Trent Lott (R-Miss.) failed on a 51-41 vote. The Lott amendment was then approved on a voice vote.

The rider, attached to the District's annual budget, would bar the local government from using any of its federal or locally generated tax dollars to implement its domestic partners law.

The D.C. law, formally the Health Care Benefits Expansion Act of 1992, was passed by the District Council and signed by Mayor Sharon Pratt Kelly in April. The measure allows unmarried same and opposite-sex couples to register with the city as domestic partners. Partners of District employees are offered coverage under the city's health insurance program. Private companies are also offered tax incentives to offer similar benefits to their employees.

Saving that he has "not only a right but a responsibility" to overturn the local law, Lott argued that, if allowed to stand, the measure would undermine the family by encouraging homosexual unions and heterosexual partnerships outside of marriage.

"We must begin to take a stand for the family," said Lott. "We must make the difficult decisions of right and wrong, and we must reach the conclusion, based on evidence and moral precepts that all lifestyles are not equal. We must decide that the institution of traditional marriage is preferable and superior, and our policies should reflect that conclusion and its moral imperative."

Lott argued that domestic partners law was passed by the council "under pressure" from "special interests" and insisted that it was "fundamentally unfair" in its treatment of traditional married couples.

He also charged that the measure would exacerbate the nation's declining 'family values' which he argued have been responsible from everything from the number of single parent households to the District's record murder rate.

"My name is Lott," said the Mississippi conservative. "And there was a Lot in history whose wife looked back and became a pillar of salt. Do you wonder, or do you recall that she looked back to see? She looked back to see a situation like this law would not only allow, but promote," he concluded, making reference to the biblical story of the condemned cities Sodom and Gomorrah.

Backers of the local law countered that the measure was not an effort to legalize same-sex marriage, but rather a good faith effort to extend health benefits to many uninsured Washington-lans.

"I would hope that before people rush to a conclusion that this (law) is Lot's wife and Sodom and Gomorrah, that they look at what the real facts are here." Said Sen. Brook Adams (D-Wash.). This is not that kind of legislation. This (citizens without adequate health care coverage) is the kind of thing that exists throughout the United States."

District supporters also insisted that Lott's amendment was an intrusion on the city's limited right to govern itself.

The Senate's District appropriations bill now moves to a conference committee where it will be reconciled with the House's version of the bill. Historically, the committee has killed anti-Gay amendments attached in the House and Senate.

Whether attempts are made later in the House or Senate to revive the amendment. lobbyists note, will be a better gauge of support for D.C. home rule and Lesbian and Gay rights in Congress.

#### Appointment of Lesbian minister upheld

New York [In Step] — On July 31, the Synod of the Northeast of the Presbyterian Church (U.S.A.) voted 9-1 to uphold the appointment of an openly Lesbian minister, the Rev. Jane Adams Spahr, to a Rochester congregation.

Members of Rochester's Downtown United Presbyterian Church had voted overwhelmingly to appoint Spahr their co-pastor. But members of more conservative congregations petitioned the regional synod to block the appointment.

In 1978, the governing body of the church declared that homosexuality was "incompatible with Christian faith and life," and that Gays and Lesbians could not become ministers. But it exempted from that prohibition homosexual ministers and deacons who had already been ordained. Rev. Spahr was ordained in 1974 and did not come out as a Lesbian until 1979.

In its decision in support of Rev. Spahr, the synod refused to counter the wishes of the Rochester church which had twice voted their approval of her. Blocking her installation would "have the effect of denying to an ordained minister an opportunity to fulfill his or her ministry."

Those who oppose Rev. Spahr will appeal the synod decision to the highest authority in the church, the Permanent Judicial Commission of the General Assembly. A final decision is expected in late October.

Rev. Spahr expressed confidence about the appeal. Referring to the 9-1 synod ruling, she said: "We're going in there with a really strong vote."

More than 300 people packed Milwaukee's Westminster Presbyterian Church in June for a sermon by Rev. Spahr. She vowed that Gays and Lesbians and their supporters would be a positive force in changing the church.

#### Murders in Mexico, ILGA protests in Paris

A leader of Mexico City's AIDS movement and two other Gay men were murdered in a Mexico City apartment July 12. The killings follow at least four other anti- Gay murders in the city in recent weeks, Gay groups said.

According to Mexican newspapers, Francisco Estrada Valle, founder and president of the AIDS organization Ave de Mexico, and two friends were tied up, tortured, stabbed and strangled.

"The crime was perpetuated with distinct hatred against homosexuals," according to a letter written to Mexican President Carlos Salinas de Gortari by 30 Mexican Gay, Lesbian and AIDS groups.

There are no suspects and Gay groups charge that police "are... more interested in the particulars of the victims" sexual lifestyles than in clarifying the facts of the crime," as one activist put it.

#### PARIS POLICE ATTACK PROTESTERS

The murders happened as the 14th annual conference of the International Lesbian and Gay Association opened in paris.

Two hundred ILGA delegates quickly protested at the Mexican embassy and reported they were "brutally" attacked by 1,200 officers of the French riot police, CRS. Nine demonstrators were injured, according to an ILGA press bulletin.

Police reportedly barricaded the street with squad cars and began beating protesters without asking them to disperse or leaving an opening through which they could depart.

ILGA lodged a protest with the Minister of the Interior, who is responsible for the police. Paris police have attacked Gay protesters two other times this year, during ACT UP demonstrations, according to reports in Gai Pied.

#### L.A. baths to remain open

Los Angeles [LLDEF] - Under a comprehensive settlement approved July 30 by the Los Angeles Superior Court, Los Angeles bathhouses will be allowed to remain open under a set of guidelines developed by a joint consortium of community educators and public health officials. The agreement was reached in settlement of a lawsuit filed by Los Angeles County District Attorney Ira Reiner and the Los Angeles County Department of Health that sought to close two bathhouses as a threat to the public health. Lambda Legal Defense and Education Fund, with Cooperating Attorney Mickey Wheatley represented the two bathhouses targeted by the county - Hollywood Spa and the Compound.

Wheatley hailed the decision as a breakthrough in public health policy: "The County of Los Angeles has consistently tried to shut down Gay bathhouses without recognizing the very important role bathhouses play in Gay culture and in HIV prevention and education. This settlement will promote the public health, not hurt it, and the county has finally agreed to cooperate with the bathhouses rather than impede their efforts. We are very pleased with this settlement because it ensures the involvement of the HIV infected community in bathhouse regulation. Most importantly, it vigorously promotes condom usage among Gay and Bisexual men."

Lambda Staff Attorney Mary Newcombe, who litigated the case with Wheatley, agreed: "The community participation in negotiating this settlement has been crucial. We are able to demonstrate that the community consensus about the role of the bathhouses is absolutely consistent with good public health policy. Needless to say, of course, we want to stop the transmission of HIV - but HIV and AIDS won't be stopped by closing bathhouses and forcing an entire population that does not identify as Gay or is isolated from peer education out into the parks or other locales where individuals cannot be reached. This settlement is a giant step forward in understanding and preventing spread of HIV throughout the Gay, Bisexual, and heterosexual communities."

Newcombe and Wheatley praised management of the targeted bathhouses for promotion of safer sex practices in the bathhouses. Hollywood Spa manager John Ferry stated: "We are very excited to have a group of health care advisors to assist us in developing an effective educational program in our clubs. We have consistently tried to work with the county, and this settlement ensures that our efforts to promote safer sex are consistent with county guidelines."

#### New bill would repeal DoD Gay ban

Washington — Sen. Howard Metzenbaum (D-Ohio) on July 28 introduced to the Senate a bill which would rescind by act of Congress the Pentagon's long-standing ban on Lesbians and Gays in the uniformed service.

The measure, sponsored by Metzenbaum and seven of his Senate colleagues, mirrors a pending House proposal sponsored by Rep. Patricia Schroeder (D-Colo.). The House bill presently has 70 co-sponsors.

"The Pentagon's prohibition of Gay men and Lesbians serving in the military is as senseless and cruel today as it was when it was first conceived 50 years ago," said Metzenbaum at a Capitol Hill press conference called to announce the measure's introduction.

Flanked by Gay and Lesbian veterans and activists, the veteran lawmaker denounced the Department of Defense policy as a waste of good members of the service and, additionally, a waste of tax dollars.

Pointing to the cases of Navy Lt. Col. Tracy Thorne and Army Col. Margarethe Cammermeyer, two highly commended officers who were recently separated from



the service based on their acknowledgment that they are Gay and Lesbian, Metzenbaum insisted that the government was throwing away perfectly good people without just cause.

Since the 1940s, the Pentagon has maintained the contested policy which states that homosexuality is "incompatible with military service." While in the past, the Department of Defense has suggested that homosexuals make poor soldiers and that they present unusual security risks, now their defense of the policy is solely grounded on the contention that the presence of openly Gay individuals in the service is detrimental to "good morale and discipline."

Metzenbaum seized on that defense and insisted that the government's justification of the policy is not based on evidence.

"Defense officials freely admit that the policy is not based on scientific or empirical data," he said. "They say that it is based on, quote, considered, professional military judgment based on years of experience,' end of quote. I call it baseless prejudice founded on fears and ignorance."

A recent study conducted by the General Accounting Office concluded that training and recruiting costs average \$28,226 for each enlisted person and \$28,226 for each officer. Calculating that

the service dismisses an average of 1,000 members of the service a year under the policy, the study reported that the government spent approximately \$491 million over the past to ears to recruit and train service members it would eventually dismiss on grounds of homosexuality.

Those figures did not include the legal and administrative costs involved in investigating and expelling those Lesbians and Gay men.

Related but separate proposals, sponsored by Rep. Barbara Boxer (D-Calif.) in the House and Adams in the Senate, would ask that the White House and the Pentagon act to repeal the ban.



Washington D.C. — based AIDS Action Council, called Nelson "a bright, dedicated AIDS activist with impressive skills and experience who will help enhance the power of the national AIDS lobby."

Founded in 1983, the AAC represents more than 500 community- based AIDS service organizations from all over the country.

"My election is an acknowledgment by national AIDS leaders that the HIV epidemic is ravaging America's heartland. I will work to assure that our issues are included on the national AIDS agenda," Nelson said. Top priorities for Nelson will be increased federal funding for AIDS care, an aggressive national prevention campaign that boldly addresses risk behaviors, and a strong federal investment in community- based research.

Since 1988, Nelson has directed the ARCW. His long history of health care management and advocacy experience includes work at a Madison health care consulting firm, the Wisconsin Hospital

Rate Review Program, where he served as executive director: and the State Medical Society of Wisconsin, where he held the positions of Legislative Coordinator and Director of Health Services.

Nelson attributed his election to the unique support that state government has given to the AIDS epidemic in Wisconsin and to the strength and success of the AIDS service agencies that he directs.

Because of increasing state support, Nelson said that the ARCW has become the largest private, non-profit AIDS service organization in the midwest. "There is no other single AIDS service agency in the midwest that delivers the comprehensive support and HIV prevention services that we do," Nelson explained.

The AIDS Resource Center of Wisconsin, Inc. operates on a \$3.1 million annual budget and delivers services through three AIDS service organizations: the Milwaukee AIDS Project (MAP), Southeast Wisconsin AIDS Project (SEWAP) in Kenosha, and Northwest Wisconsin AIDS Project (NOWAP), in Eau Claire.

#### Scouts sued for expulsion of Gay Eagle Scout

New York [LLDEF] — Lambda Legal Defense & Education Fund brought suit July 29 against the Boy Scouts of America (BSA) and the Monmouth, New Jersey Boy Scout Council for discrimination against a young Gay Eagle Scout. The lawsuit, the first to be filed under New Jersey's recently adopted Gay civil rights law, is the latest of several cases across the country challenging the Boy Scouts' anti-Gay discriminatory policy.

Lambda represents 21 year-old James Dale who, while spending more than half his life in the Boy Scouts, achieved its highest rank (Eagle Scout), earned thirty merit badges, and was invited to become an Assistant Scoutmaster in Matawan, New Jersey. Dale's twelve-year involvement with the Scouts came to an abrupt end in 1990, when a local newspaper ran an article picturing him at a seminar on the psychological and health needs of Lesbian and Gay teen-agers. Without any warning, Dale received a letter from the Boy Scouts revoking his membership. The letter gave no reason and did not comply with BSA's own internal procedures for a fair hearing. Under pressure, the BSA admitted that it was expelling Dale, despite his exemplary performance as a Scout, simply because he is Gay.

The case complaint charges the Boy Scouts with illegal discrimination as a public accommodation, as an employer, and as an organization conducting business. Other legal claims challenge the BSA's unfair practices in denying Dale a right to be heard as required by BSA rules, and in misrepresenting itself as a non-discriminatory group open to "all boys."

Boy Scouts of America continues to face growing national pressure to change its discriminatory policy. In addition to other lawsuits around the country, several organizations, including Levi-Strauss, the Bay Area United Way of San Francisco, Wells Fargo Bank, and the Bank of America have pulled their funding of the BSA to protest ban on Gay Scouts. Organizations sponsoring BSA troops, including the Union of American Hebrew

Congregations, a leader in the national Reform Jewish Movement, and the Unitarian Universalist Church have urged the BSA to reverse its policy. Several school boards have begun closing their facilities to the Scouts. The Girl Scouts and many other youth service organizations have no such policy of discriminating against Lesbian and Gay participants.

#### Judge upholds PWAs insurance

[ACLU] — Issuing a stern rebuke and warning, a New York state judge dismissed an attempt by a life insurance company to rescind the \$50,000 policy of a man who died of AIDS. The judge also forced the company to pay \$127,000 in attorneys' fees to the policy holder's estate.

The judge, Ira Gammerman of the state Supreme Court in New York County, said that New England Mutual Life Insurance Company engaged in improper and discriminatory conduct when it searched its files to invent a reason to rescind a \$50,000 life insurance policy after the policy holder, Jeffrey Duke, began making AIDS related claims under a separate disability insurance policy.

In asking the court to rescind the policy, New England Life argued that Duke had misrepresented himself in applying for the policy by describing his lover and business advisor as his "business partner." In finding that Duke did nothing wrong, Judge Gammerman rebuked New England Life for starting an investigation to find any 'bogus basis' for revoking the policy and for treating Duke unfairly because of his disability, his sexual orientation and his marital status.

The American Civil Liberties Union's National AIDS Project filed a friend-of-the court brief on behalf the ACLU and Gay Men's Health Crisis, asking for a "clear signal from the judiciary" that such unfounded, costly misrepresentation claims against policy holders with AIDS are barred by existing legal rules.

Each month, approximately 50 individuals in Metropolitan Milwaukee benefit from the agency's rent assistance and roommate referral services.

"As a delegate to the convention, I had the opportunity to talk about Gay Games with delegates from all over the country and learn that they share my enthusiasm for the Games. From now until November, we will be working hard to ensure that President Bill Clinton will preside over the opening ceremonies of Gay Games IV in June of 1994." she said.

On May 13, 1992, the Board of Directors of New York in '94, the organizing body of Gay Games IV, voted to adopt new dates for Gay Games IV. The Games will begin on Friday, June 17, 1994 and will end with closing ceremonies on Saturday, June 25, 1994. The Games were originally scheduled to take place from June 25 through july 4, 1994.



games, and to hear bids for the location of the 1994 World Series. The 1993 event will be in Philadelphia, PA.

The LA Series will begin with opening ceremonies on Tuesday, August 18, and the games will start immediately thereafter. Games will be played on Saturday, August 22. A closing banquet will follow for all participants at which trophies will be presented.

In the Women's Division, the format adopted in 1991 will be used again. The games begin with round robin play leading to a double elimination tournament to determine the Division champion. Women's Division teams use an 11 inch softball in their games.

The Open Division (primarily men's teams but can also include women's teams or mixed teams) will have a new format this year made up of three subdivisions. The first sub-group will consist of the championship team from each league; the second sub-group, any league team (other than the champion) with a .500 or better record; and the third sub-group, any league team with a record under .500. This group is a special effort to recognize and include purely recreational teams in the World Series. Open division teams use a 12 inch softball in their games.

On Thursday evening, August 20, a variety show will be held featuring skits performed by those participating in the World Series. The proceeds of this event will go to NAGAAA for the design and creation of a special promotional book. This will be used by NAGAAA officials in their efforts to secure a long-term national corporate sponsor.

"Securing a corporate sponsor of such stature will provide sustaining funds not only to NAGAAA itself, but also for each team in the Alliance, Pribich said. This is extremely important for the long-term future of NAGAAA."

which the majority in this country all at once defines biologic truth, social necessity, and personal essence, our work will be difficult and frustrating. Because we are asserting our own worth and our special perspective, the work can be joyful." Duberman had come a long way over a long and difficult road, but he had found himself at last!

I met Mr. Duberman, briefly, the following November at the second annual conference of GAU. As editor of GPU News, a monthly Gay publication emanating from Milwaukee at that time, I was looking for good writers on liberation

topics. I spotted Duberman across a crowded room as being the 'hunkiest' man in the room. I asked who he was and wangled an introduction, giving him a sample copy of the publication together with my card and asked him to submit an article on any topic he chose. He thanked me and gave me a smile that melted my heart, but he never sent an article for publication.

I urge you to read this book. It is an inspiring trip through some of the difficulties of being Gay in pre-movement years.

#### Cures

Cures: A Gay Man's Odyssey by Martin Duberman, Dutton, Plume, New York, 305 pages, paperback, \$11.

#### Reviewed by Eldon E. Murray

Martin Duberman has led and still leads a very productive life. He has been a noted historian, teaching at Princeton, and later a Distinguished Professor of History at Lehman College, CUNY and he has written more than a dozen books that have received critical acclaim, as well as several plays.

However, one wonders just how prolific he would have been had he not had the dubious benefit of a long period of psychoanalysis in the hands of some downright cruel and unfeeling psychotherapists.

Duberman had bought and internalized the negative psychoanalytic model of homosexuality as a 'sickness' that did not allow a full and happy life. His doctors encouraged him to work for change with a goal of 'curing' himself of his homosexual orientation and becoming heterosexual in fantasy and in fact.

He struggled, desperately, for more than twenty years, reviling himself (at the urging of his doctors) as intrinsically evil and doomed to live the life of an abnormal freak, incapable of anything other than brief, lustful same sex sexual encounters that were degrading in nature.

Of course, he was deep in the closet during that time and his self image — because of the abuse heaped upon him by his doctors and fellow group therapy patients — was one of confused agony as he tried to prove his self worth. he even tried celibacy and his attempts to relate to women sexually were all dismal failures, leaving him with a sense of profound frustration. In an effort to prove himself he threw himself into his work. So, it is actually possible that he would not have produced so much highly praised work if he had not been so driven to find self

affirmation.

Duberman has never lacked courage, and in this book he courageously and candidly admits that he had a penchant for casual sex with pick ups from bath houses and hustler bars. He had one difficult and rocky love affair with a basically straight hustler-type, who was almost as confused as he was at the time.

Finally in the late sixties, the first stirrings of the Gay liberation movement began and after the uprising at Stonewall in 1969, the movement quickly grew in strength and numbers. At first Duberman remained on the sidelines, participating in all sorts of left- wing actions, except the Gay movement, the one actually closest to his personality. Then in late 1970 when he had just about decided not to return to therapy sessions, his doctor abruptly announced his retirement. Duberman, wisely, did not seek another therapist. having decided that even if he did control his sexual contact with members of the same sex, he could not control his fantasies so he would, therefore, still be a 'non-practicing' homosexual.

He attended a few meetings of the relatively new Gay Liberation Front and the even newer Gay Activists Alliance, but he still was not ready to make the plunge into activism. At last, in 1972, he publicly announced his homosexuality in the pages of his book Black Mountain: An Exploration in Community. Such an announcement from such a distinguished writer created a whirlwind of reactions, both good and bad, but the deed was done and there was no turning back.

Much to his surprise, now that he was no longer fighting himself, his psyche began to heal and his self-image began to improve. Even as a publicly known 'Gay man' he had not formed any relationships with Gay organizations. Then, in April of 1973, he was invited to help in the formation of a new group of Gav academics. He jumped at the chance, becoming one of the founders of Gav Academic Union. The book ends shortly after the first national conference of this group in New York in November of 1973. with Duberman giving the keynote address, saying, "Because we challenge the exclusive heterosexual lifestyle by





## Northwestern U. seeks AZT users for GLQ223 study

Chicago [In Step] — Northwestern University and Genelabs Inc. is seeking to fill vacancies in its Phase II study of GLQ223 alone and in combination with AZT in symptomatic HIV infected patients.

This study involves GLQ223 administration to patients who have not previously been exposed to it, but who have received at least 9 months of AZT therapy. The study will evaluate the efficacy of GLQ223 on survival, opportunistic infections, T4 cell count and assessments of viral load.

The study will involve the randomization of patients who have 200-500 T4 cells and AIDS or ARC to one of three treatment arms: AZT alone; GLQ223 alone; or GLQ223 plus AZT. Patients who will receive GLQ223 will be given an infusion every three weeks for 45 weeks.

To be considered for the study, patients must be:

- · Diagnosed with ARC or AIDS;
- Have a history of AZT therapy at a dose equal to or over 300 mg daily for at least nine consecutive months immediately prior to entry into study;
- A CD 4 count of at least 200 but less than 500;
- · Between the ages of 18-65;
- Women can NOT be pregnant or breast feeding. Women must agree to abstinence or to the use of barrier methods of birth control during the study;
- Patients with the following are NOT eligible: an active AIDS-defining opportunistic infection; evidence of AIDS dementia complex or active neurological disease; participation in other clinical studies.

#### WHAT IS GLQ223?

GLQ223 is a protein-based compound — alpha-trichosanthin — a highly purified derivative of Trichosanthes kirilowii —

also known as the "Chinese Cucumber Plant" or Compound Q — which raised much interest several years ago in underground buyers clubs.

It is important to distinguish between GLQ223 and Compound Q. GLQ223 is the only one currently in FDA approved Phase II Trials. Compound Q is a street drug imported from China. While both are based on a naturally occurring compound known as trichosanthin, they are very different.

GLQ223 is highly purified and has been shown in previous trials to be safe and well-tolerated.

Compound Q is of uncertain quality and available through guerrilla buyers clubs. Reports indicate it is of uncertain quality, highly toxic, and sometimes had lethal side effects in underground studies.

Genelabs' development of the synthetic version — GLQ223 — provided the unique opportunity for the government and AIDS activists to cooperate in this vital AIDS research.

Just as the toxicity of Compound Q has no correlation with the reported safety findings of GLQ223 — final results from Phase II trials of GLQ223 will have no predictive power for the efficacy of Compound Q. (In other words, comparing GLQ223 to Compound Q is like comparing apples to oranges.)

In pre-clinical studies, GLQ223 demonstrated the ability to selectively block HIV expression in infected T-lymphocytes and macrophanges without harming un-infected cells.

Subsequent Phase 1B trials of GLQ223 demonstrated that the drug was safe and well-tolerated. In addition, administration of the drug in patients with AIDS or ARC was associated with measurable increases in markers of immunologic activity. Positive responses included increase in white blood cells (known as T3 cells), as

apologized and offered them rebuttal space in an upcoming issue of the paper. Boy, I thought, do we so-called grown-ups have a lot to learn from them about integrity and activism and coalition work! Later, though, I realized that while I would never have had the courage to be anywhere near as 'out there' as those folks during my own undergraduate days, much of what they did was made possible, at least in part, by people of my generation and those who came before.

It's a continuum. We are all building on the efforts of someone else; nothing we do is in isolation, whether we realize it or not. I find that really comforting somehow. Because it means, I think, that even when we feel as though we are making no progress, it's a pretty safe bet that we have not actually struggled in vain. And that's what I mean by the thread that connects us: we are all interdependent. At the risk of getting too zen on you (or is it too late for that?), it's that Buddhist thing; even the tiniest pebble causes a ripple effect - 10,000 waves. And it means that even when we feel most alone, we really aren't: our lives are crowded with tiny ripples of other lives, forward and backward. From students at Miami of Ohio to Ann Bannon to some essentially unknown Russian woman in the 1800s to someone from a distant time and place whose life has gone totally unrecorded all of these people have in some small way affected our lives. And just as a for instance, take my Russian woman. I can't imagine that she ever gave a thought to the impact of her life on the lives of people thousands of miles and a century away, or probably that she even thought of herself as particularly special in any way - odd, perhaps, or unusual in some respects, but no one extraordinary. And yet, she has had an impact on my life, enough so that I have been willing to spend my spare time learning about her culture and hoping to re-create, to some degree, her story in a way that will make it accessible and meaningful to many others: the ripple

What it boils down to is that we're all in this together. And I think that is, in a nutshell, in large part what Gay and lesbian Pride Parades illustrate — that and the fact that we like a good party! The whole rest of the year, we may be arguing among ourselves about what is politically correct and what is the most effective way to accomplish our goals and even what our goals are. But at least for this one day, we are able to embrace our diversity, to celebrate it along with what is unique and important to each of us personally. Then I find myself thinking. Why can't every day be like that! But it's like Christmas: it only comes once a year, or maybe - if there's some crisis that draws us together or a March on Washington - two or three days a year. And who could sustain that level of intensity on a daily basis anyway?! What Pride Day does do for us, though, is recharge our batteries. It gives us a chance to remember who we are, where we came from, what we're about, and that we are all (to borrow from the evil Ma Bell) connected - from the drag queens to the leather boys and gals to the jocks to the political activists and community workers to the regular nothing-out- of-the- ordinary folks. As Holly Near sings, "We may have come here on different ships, but we're all in the same boat now."

## We're all in this together

Off and on for the last year or so. I have been doing research for a historical novel set in late nineteenth-century Russia. The story is based on the actual case history of a Lesbian of that time. She was no one famous, just a woman from a reasonably well-off family, but otherwise unremarkable. In fact, even that she was a member of the land- owning gentry is unremarkable: outside of the peasant classes, that description could apply to most Russians then. What was remarkable was that, in the incredibly patriarchal structure of that society, where men literally controlled just about every aspect of life, she was able to live her life as a Lesbian. And perhaps even more remarkable is the fact her story was ever recorded at all. We have all heard stories and read biographies of famous people throughout history who were purportedly homosexuals, but rarely do we know much about the lives of essentially 'ordinary' people.

But what I have been thinking about in regard to that is, even though she and I have virtually nothing in common - her world is as alien to me as I'm sure mine would be to her - there is still a thread that links us: I am in awe of her life as a Lesbian, and I suspect she would feel similarly about mine. And in so thinking, I realize that I have had this experience before, in a way, except that the other person in question and I were not so far removed from one another in either time or space; there was certainly no more than 20 or 30 years between us and we are both from these here United States. And yet the feelings of awe and unfamiliarity were as decidedly present as if I and my late nineteenth-century Russian were chatting.

The incident I am recalling is when I first met Ann Bannon, author of all of those wonderfully trashy (no offense intended) Beebo Brinker stories from the

late fifties and early sixties. I remember going up to her and thanking her for all she had done, for recording a slice of our history so that I could in some way experience it. I commented on how incredibly courageous I thought she was and had been - I could hardly imagine being a Lesbian in such incredibly repressed times. "No." she said, "it's you young people who are the brave ones." She was amazed at how out many of us are, and how outspoken, and the strides we had taken toward securing some measure of equality and acceptance for Lesbians and Gays. But all her protesting aside, it was clear to me that we would never be where we are today if it hadn't been for her perseverance and that of all those others of her generation, both the famous and those we have never heard of and perhaps never will.

And then again recently, I had that same sort of experience, only from the other side. That is, I got to see things from Ann Bannon's vantage point. This past spring, I went to a couple of college campuses to read from my work. At Miami University of Ohio, I spent several hours with eight or ten undergraduates there, eating dinner, touring the campus and town, schmoozing. And I was impressed. They were so sure of their sexuality, comfortable in it, and they were outspoken on campus, demanding respect and equal treatment, responding to homophobic letters to the editor in the university newspaper, politically articulate and sensitive to issues of race and gender, working together as men and women, Bisexuals and Gays and Lesbians, people of different colors. One minute they would be all giggly and gossipy and campy, and the next they would be relating the story of how, going out for a keg of beer for a party, they realized they were near the editorial offices of a local paper that had recently run an editorial they found offensive and decided to stop in and talk to the man who had written it. Apparently, they made their case so well that the journalist

#### WI AIDS summary

According to the Wisconsin AIDS/HIV Update July issue, as of June 30 there were 1,241 cases of AIDS in Wisconsin, an increase of 16 in a one-month period. In a years time, 291 new cases have been reported to the state Division of Health.

In Wisconsin, Gay men now make up 71 percent of the cases in the state. Gay men who also were IV drug users make up an additional 5 percent.

Other Wisconsin exposure categories show 9 percent of cases are heterosexual IV drug users; Heterosexual contact 5 percent; undetermined exposure 5 percent; Hemophiliacs and transfusion cases each make up 2 percent; and 1 percent were transmitted by mothers.

Wisconsin's numbers are quite different than USA figures. (The last available figures are from March 31.) In the USA, Gay men make up 57 percent of cases, and Gay IV drug users make up an additional 6 percent. Non-Gay IV drug users make up 22 percent; and 6 percent are from heterosexual contact

In Wisconsin, males make up 93 percent, and women 7 percent. (In USA figures, males are 89 percent, women 11

percent.) Racial/ethnic divisions in Wisconsin show whites make up 77 percent, Blacks 17 percent, and Hispanics 6 percent. (USA figures are radically different: 50 percent white; 29 percent Black; 16 percent Hispanic.)

The reported number of AIDS cases per 100,000 population shows Wisconsin has a rate of 4.5 cases per 100,000. The Centers for Disease Control places Wisconsin in the lowest bracket (states with a figure of less than 4.9 per 100,000). In comparison, New York has a rate of 42.9, Florida 42.4, and California is at 28.2 per 100,000.

#### **Condom Reliability**

"The individual user, not the condom, is more likely to be responsible for any failure." That is what the Wisconsin AIDS/HIV Update quotes from a well-researched article distributed by the Centers for Disease Control.

"When condoms are used consistently and correctly, they are extremely effective," according to the article. The efficacy of condoms as prevention for sexually transmitted diseases and/or as birth control, have been documented in many laboratory and clinical studies.

Multiple lab studies have clearly demonstrated that an intact latex condom is a "continuous, effective barrier to HIV." Pores in natural membrane ('skins') condoms, however, allow passage of HIV and smaller viruses such as hepatitis B.

Several studies show 100 per cent effectiveness, but others show that some individuals become infected despite self-reported condom use. Those people may have been infected because of inconsistent condom use. Condom failure is due to non-use, inconsistent use, incorrect use, breakage or leakage. Condom effectiveness increases with



experience.

Incorrect use accounts for some condom failures and breakage. Researchers found some men put on the condom after sexual activity had already begun; others have breakage occur from fingernail tears or use of oil-based lubricants, which weakens the latex. Latex condoms should be used only with water-based lubes, preferably those containing nonoxynol 9.

Manufacturing defects are quite uncommon, since national standards are used, and samples are tested to assure high quality. Each condom is electronically tested for pinholes or areas of thinning as part of the manufacturing quality control in the USA. Also, all domestic and imported batches of condoms are subject to sampling testing by the Food and Drug Administration. Batches which fail are not allowed to be sold in the US.

In one study, more than half of the condom breakage occurred while the condom was being put on or taken off. In another study, all breaks occurred prior to ejaculation.

The article continues, "we regard condom use as 'highly effective' for the following reasons: intact latex condoms are an effective barrier against bacteria and viruses; multiple studies have demonstrated that condom use protects against STD's; several studies have shown than a person exposed to HIV who used condoms, remained free of infection over many months; condoms are manufactured with high standards of quality."



#### **Condom Using Hints**

- Put on the condom before you enter your partner.
- Make sure there is no air in the condom, including the tip.
- Use plenty of water based lubricant.
   (For example K-Y jelly, For-Play, PrePair and Probe.) Never use saliva!
- Hold onto the base of the condom when you're pulling out after intercourse to prevent the condom from coming off inside your partner.
- Use a fresh condom every time you have sex.

(See the diagram near this article showing the proper way to put on a condom.)

#### THE A-B-C-'s OF PUTTING ON A CONDOM



Gently squeeze the tip of the condom with one hand, making sure there is no air in the tip. (This leaves room for the semen when you ejaculate (cum), and forces out any air bubbles, which are a major reason condoms break.)

While you continue to squeeze the tip of the condom, forcing out any air, begin to unroll the condom down the length of your penis...





... carefully unrolling it all the way down to the base of your penis to the hair.




