



Momentum Surges After Stonewall 25 Meeting in Milwaukee

National Delegates Elect Leaders and Adopt Plans for New York Celebration

Milwaukee - Organizing efforts for Stonewall 25, the "Global Celebration of Lesbian and Gay Pride and Protest" scheduled for New York City next June 26, gained greater momentum after national delegates held an intense two-day strategy session at the University of Wisconsin-Milwaukee July 31 and August 1.

A permanent Executive Board was elected and detailed plans were unveiled for the march and rally, which Stonewall 25 co-chair Pat Norman described as "the greatest event in the history of our movement and the greatest human rights march the world has ever seen."

More than a million people are expected to attend Stonewall 25, an anniversary celebration of the 1969 Stonewall Rebellion, the pivotal event which helped launch the Gay liberation movement.

But Stonewall 25 also has a global emphasis, with the "International March on the United Nations to Affirm the Human Rights of Lesbian and Gay People" a centerpiece of the event. The march on the U.N. will be followed by a rally in Central Some delegates joked that the Park. recent March on Washington was merely a "dress rehearsal" for the massive turnout expected in New York next year. In addition to hundreds of thousands of New Yorkers and LesBiGay and Transgender people from across the U.S., Stonewall 25 will draw thousands of people from around the globe, including those who will be attending the Gay Games IV and Cultural Festival and the annual conference of the International Lesbian and Gay Association (ILGA).

elements of the LesBiGay community.

"I stand before you in my best red six inch 'come fuck me' pumps to remind you that our 'Homosexual Boston Tea Party' was made up of drag queen prostitutes, street hustlers, welfare recipients and some very bad-ass bull dykes," said Ramirez Murray.

"Yes, those people that in many people's minds then and today are considered the low side of our community. But I stand here today to remind you that these people were our movement's true revolutionary heroes and they *must*, they will be remembered!"

Co-Chair Pat Norman stressed that Ramirez Murray's remarks represented the views of the entire Executive Committee. It was later agreed by all that Transgender/Drag people would have a visible presence throughout the celebration, with the march led by veterans of the Stonewall Rebellion.

Julie Dorf, Executive Director of the International Gay and Lesbian Human Rights Commission, a branch of ILGA, then offered some sobering perspective on Gay life around the globe.

"If we were in Istanbul, Turkey or Quito, Ecuador or Beijing, we would not be

allowed to assemble here today," she said. "Transvestites are the target of paramilitary death squads in in Colombia, in Ecuador, in Brazil. Lesbians are forced into psychiatric treatment in Russia and China. We're put to death in Iran and Saudi Arabia. We're Gay-bashed and the victims of other hate violence here in the U.S. and elsewhere."

"Stonewall 25 is an unprecedented chance to pull off the most global of Gay Prides, the most international mobilization on the international body with the authority to require countries to protect our rights and we need that."

INTERNATIONAL FOCUS

The idea for an international celebration of Stonewall's 25th anniversary was first presented by Gay pioneer Morris Kight at a 1985 meeting of the International Association of Gay and Lesbian Pride Coordinators. It has been endorsed since then by a growing number of national and international LesBiGay groups.

At its annual meeting in 1992, the International Lesbian and Gay Association adopted the official title of the march and formulated its demands. At its conference in July in Barcelona, ILGA decided that two speakers representing each continent will address the rally in Central Park.

Some delegates present at the Milwaukee meeting objected to the absence of "Bisexual" and "Transgender" in the march title. But Steve Ault, an Executive Coordinator of Stonewall 25, explained that as a truly global event, some decision-making has to be shared with international bodies, and that ILGA's decision, apparently made in deference to certain cultural differences between nations, must stand.

Among the demands of the march are: that the freedoms guaranteed in the U.N.'s Universal Declaration of Human Rights be extended to Gay, Lesbian and Bisexual people worldwide as well as to people with HIV/AIDS; that agencies of the U.N. regularly monitor human rights violations against LesBiGay people; that member nations of the U.N. recognize and protect LesBiGay family relationships; and that the U.N. proclaim an International Year of Lesbian and Gay People.

A major concern was raised regarding potential visa and immigration problems for visitors coming to the U.S. Representatives of Stonewall 25, the Gay Games and ILGA,

along with legal experts, will work in advance to ensure that such problems are minimized, but placing monitors at J.F.K. and other major entry points may be necessary as well.

"STRONG" EXEC COMMITTEE

The three co-chairs of Stonewall 25, all interviewed by In Step, agreed that the most significant achievement of the meeting was the election of a permanent Executive Board. "We can finally make decisions that are binding," said Norman, a longtime dyke activist from San Francisco. "Now, we're really ready to hit the ground running."

"The quality of people chosen, the diversity they represent and the mix of professional and organizing skills make this a really strong committee," said Ramirez Murray, "I'm more confident than ever we can pull this off."

Franklin Fry, a stage manager by trade, was elected to fill the third co-chair position. He has been involved for the last eight years with Heritage of Pride, the group that oversees most of New York City's annual Pride events. In 1990 and '91 he served as chair of HOP.

Fry was praised by his co-chairs as a dynamic organizer and as someone with the knowledge and experience to handle all the complicated logistics in New York City. "A very wise choice," Ramirez Murray commented.

Seven other people comprise the Executive Committee. Two seats are reserved for representatives of ILGA and the Int'I. Assn. of Gay and Lesbian Pride Coordinators (filled by Julie Dorf of San Francisco and Janice Thom of New York at the Milwaukee meeting).

Carolyn White, an attorney from Atlanta, Mandy Carter, a longtime activist from North Carolina, and Steve Oxendine of New York, who works in the theatre and did much of the groundwork for the Central Park rally, were newly elected.

Two new seats were approved. Flora Piterak of New Hampshire won the slot for a rural activist, and Hubert Alexander, an organizer of Atlanta's Pride events, won the slot reserved for a person with HIV/AIDS.

The Executive Committee conforms to a commitment made by Stonewall 25 that requires 50% gender parity and 25% representation by people of color. Norman, Alexander, Oxendine and Carter are African American. Ramirez Murray is Latino.

GREATER DIVERSITY NEEDED

The diversity of the Executive Committee was not as evident in the regional delegations that fill out the entire National Steering Committee. In fact, only the Northeast region fulfilled its requirements for women and people of color. (Each region is assigned delegates according to population. For instance, the Northeast has 8, the South, 12, the Rockies, 4.)

While it was generally agreed that regions short of women and people of color should continue to do outreach in their areas to ensure better representation at future meetings, some white men complained bitterly about the so-called "quota" system, especially when it was decided that to balance voting at the meeting, women present could cast three votes, people of color two.

Protests of "Reverse discrimination!" could be heard around the room, and one delegate rose to complain that "Unfortunately, I'm a white man and I don't count. If I was a Hispanic female I could



vote. I could do whatever I want. But because I'm a white male. ...my vote doesn't count."

Brenda Howard, a delegate from New York, tried to calm the controversy: "The point of this is not to punish anybody. The point of this is to make a statement — each one of us and collectively — that we really mean this [greater inclusion of women and people of color]."

When someone said improving the percentages was just a matter of "dragging people's asses to meetings," Derrick Livingston, a co- chair of the March on Washington, was livid.

"I don't think it's a matter of dragging people of color's asses here, it's a matter of doing the outreach. It's very much the message," he stressed. "It's not 'We need you so we can vote' — that's fucked! We need people involved because they are part of this community. People of color made Stonewall happen!"

The controversial voting formula, which is mandated in Stonewall's statement of structure, was finally agreed upon, and voting throughout the conference, though sometimes chaotic, was not the subject of further debate.

The Midwest delegation made perhaps the poorest showing in terms of gender and racial representation, with no women or people of color for its 8 slots.

Kitty Barber and Lori Coleman of the Lesbian Alliance of Metro Milwaukee (LAMM), who helped host a reception for the national delegates Saturday night at the M&M Club, were told of the shortfall, volunteered as interim delegates and participated in the Sunday session. Coleman is African American. She told In Step: "I have the full intention of becoming a permanent delegate."

The Midwest region will hold two meetings, one in Chicago for Illinois and Wisconsin, and one in Indiana for Indiana, Michigan and Ohio, so that eight permanent delegates can be chosen to the steering committee. A meeting for all Wisconsin volunteers interested in helping with Stonewall will be held August 21. Call Gary Wells at (414) 264-2740 for the time and place.

AN AWE-INSPIRING EVENT

The atmosphere was lively and sometimes contentious throughout the weekend, but the delegates lapsed into a hushed, seemingly awe-stricken state, when detailed plans for the march and rally were presented.

"Suddenly, everything became much more concrete. Like, 'Wow, it's really going to happen," one delegate commented.

The minimal budget for all the events involved in Stonewall 25 is at least \$4-5 million. Plans call for the hiring of a development coordinator who will seek corporate sponsorship, conduct grant writing and organize special event fundraisers. One of these will be a dinner to present the Stonewall 25 Awards. Aggressive fundraising must be conducted by local Stonewall committees as well, and the group agreed that Proud Enterprises of New York, a Lesbian-owned business, would be the official merchandiser for Stonewall 25.

Franklin Fry presented a detailed proposal on march logistics, which was adopted with only minor changes.

The march on the United Nations could draw as many as 1.5 million people, so contingency plans call for several alternate routes which will ultimately converge in Central Park for the rally. The "official" route will be focused on the U.N. with people massing in the blocks just west of it and stepping off at noon.

Line-up times will be staggered to reduce the wait for those in the second half of the march and ease congestion in the formation areas. An "Order of March" will be distributed in advance so contingents will know exactly when and where to gather. (This should be welcome news to Wisconsin, the 87th contingent in the March on Washington, whose marchers waited more than six hours to "step off" and reached the Mall as the rally ended!)

The streets of New York will be festooned with rainbow flags and balloon arches. A "Morning Stage" with pre-march speeches will not be held, but "performance pockets" at intersections will supply marchers with entertainment, and speakers all along the route will provide a live feed from the rally site as well as any vital information for marchers.

The rally will begin at 3 p.m. and include speakers and entertainers of diverse

cultural backgrounds. Medalists from the Gay Games may be featured. The massive stage at the south end of the Great Lawn will be bordered with banners and covered by huge arches of rainbow colors. Three large Sony screens will project the action on stage and other pre-programmed video images to the surrounding throng.

At 4 p.m., a Moment of Silence will be observed at the rally and along the march route for those lost to AIDS. Skywriters will spell "We Remember" above the crowd, and doves will be released.

The rally is set to end at 8:30 p.m., when an internationally known star (like Elton John, perhaps) will perform. Joined by an orchestra and massed choir, the concert will end with a spectacular fireworks and laser finale.

GOODBYE MILWAUKEE! HELLO BOISE! Exhausted by the intense meeting but

fortified by the progress that was made, delegates to the National Steering Committee of Stonewall 25 agreed to meet next in Boise, Idaho on October 22-23. An enormous amount of planning is still required, and the committee will continue holding regional meetings until next June.

Delegates thanked Gary Wells for organizing such a smooth conference and praised the hospitality they received in Milwaukee. The YP hosted a barbeque dinner for them Saturday night, followed by LAMM's reception at the M&M Club and a fundraiser at Club 219. Other bars and Gay businesses held drink specials, donated services and generally contributed to the success of the weekend.

In Step will continue to report on Stonewall 25 developments, and this reporter has just made her reservations for New York!

Top Level AIDS Summit Held In Madison

ACT UP Protests Outside, Confers Inside

Madison — A summit meeting of the country's leading AIDS researchers and administrators, entitled "Future Directions in AIDS Research," was held at the University of Wisconsin July 30 and 31, and members of ACT UP were ever-present, participating inside and protesting outside the conference.

The private symposium was attended by Dr. Anthony Fauci, Director of the National Institute of Allergy and Infectious Diseases, who oversees much of the government's research on HIV/AIDS; Kristine Gebbie, President Clinton's new AIDS Policy Coordinator; Dr. Robert Gallo, a scientist who helped identify HIV; Dr. June Osborn, former chair of the National Commission on AIDS; Martin Delaney, head of San Francisco's Project Inform, a clearinghouse for information on AIDS treatments; Larry Kramer, the writer and outspoken AIDS activist; scientists from Harvard, the UW and other institutions; and two members of ACT UP.

The brainstorming session was meant to be private, but ACT UP insisted on representation on the inside and planned a protest outside to ensure publicity.

About 25 members of the Madison, Milwaukee and New York chapters of ACT UP demonstrated outside Van Hise Hall on July 31. They were there to protest the symposium's "exclusive 'gentleman scientist' back-room proceedings," and to demand a massive new government effort, similar to the Manhattan Project, to find a cure for AIDS.

ACT UP's model for such an effort is dubbed "The McClintock Project to Cure AIDS" after the Nobel-winning biogeneticist Barbara McClintock, who was once scorned by the scientific establishment.

The McClintock Project would constitute a "second front" against AIDS and operate separately from the National Institutes of Health. The publicly funded project would incorporate different theories and approaches to HIV/AIDS and promote research that focuses on the actual development of the disease in affected individuals rather than test tube models.

Research within the McClintock Project would be conducted free from conflicts of interest with pharmaceutical firms and In Step + August 12-25, 1993 + Page 87

universities, and the Project would be governed by a board made up of scientists and people with HIV/AIDS. Massive funding and intense research, similar to that which fueled the Manhattan Project in World War II, would hopefully bring speedier treatment options and, ultimately, a cure.

RESULTS OF THE MEETING

The symposium was called to explore future courses in AIDS research and to develop public policy recommendations to facilitate that research. The idea of the McClintock Project was raised by Mark Melano of ACT UP/New York, who was allowed to attend the meeting on the condition that he not speak the first day. The group discussed it only briefly, and it was not mentioned in the official statement released after the symposium.

The first day was devoted to identifying critical research questions necessary to advance AIDS research. Intensified research was recommended in the areas of gene therapy, immune reconstitution and pathogenesis (the origin and development of HIV). Special programs to target emerging and innovative areas of research were also endorsed.

The group agreed that a rational strategy must be found to overcome the barriers facing complex drug trials which often involve multiple compounds from both public and private sources. The development and standardization of tests to measure viral load was also recommended.

The second day of the think tank was devoted to discussing public policy and administrative changes necessary to facilitate progress in research. The need for greater collaboration and information sharing between all institutions. administrators and scientists involved in AIDS research was seen as the major imperative here, along with a greater infusion of funds from the private sector to "accelerate the pace of progress."

The conferees proposed that the government offer incentives to pharmaceutical companies to assist more actively in research, a concept that ACT UP is opposed to. They also called on the President and Congress to educate the American public to the urgency of the epidemic and the need for greater research.

"No amount of structural review or proposals for change will work without defining the structures for implementation

and without the will and courage to carry out these changes," the group concluded. A second meeting in Boston this September will work on methods of implementing the proposals.

Members of ACT UP remain skeptical.

They are suspicious of the pharmaceutical industry's involvement in research, noting the exorbitant prices of drugs for HIV/AIDS and the limited number of high profit drugs being developed and marketed to the exclusion of less profitable treatment options. In addition, ACT UP is adamant about expanding AIDS research beyond the confines of the bureaucracy of the National Institutes of Health. But the summit's conclusion was to urge a greater infusion of funds and scientific know-how from outside the N.I.H. into the N.I.H. As for the other recommendations, Yuri Keegstra of ACT UP/Milwaukee told In Step: "ACT UP has been making most of these same proposals since 1987."

"It's good that they have finally met and started this process," said Keegstra. "It's taken them twelve years. If they were really committed, they would be meeting literally every day, like in the Manhattan Project."

"We accomplished our goal," said Drew Boileau of ACT UP/Madison. "They weren't going to go public with their little conference, but we forced them into the public spotlight. They've gone on record with their goals. We'll have to see if anything comes out of it."

Clinton's New Pentagon Policy Challenged In Court

Protests Continue, Rand Report Suppressed

Washington, D.C. — Amid continuing protests and arrests over President Clinton's new guidelines on homosexuals in the military, the American Civil Liberties Union along with the Lambda Legal Defense and Education Fund have filed a challenge to the policy in federal court.

Twenty-eight activists, including Clinton campaign fundraiser David Mixner and National Organization for Women President Patricia Ireland, were arrested outside the White House July 30. On August 6, Hiroshima Remembrance Day, vigils were held throughout the country to "mourn" the continuing denial of liberty to Gay and Lesbian Americans who want to serve their country.

Meanwhile, Gay and Lesbian leaders have become even more incensed by the administration's decision to defend the old policy in court by fighting Petty Officer Keith Meinhold's attempt to be reinstated.

In addition, the New York Times obtained the executive summary of the independent report by the Rand Corporation commissioned by the Defense Department. The study supports the integration of Gays and Lesbians into the military and offers practical steps to successfully achieve that goal. But like previous studies which have

supported Gays in the military, the Pentagon has suppressed the report.

THE FEDERAL SUIT

The federal lawsuit was filed in the District of Columbia on behalf of seven active-duty and reserve service members. It alleges that the new policy violates First Amendment rights of free speech and the constitutional right to equal protection of the laws.

In their petition, the A.C.L.U. and Lambda say that the military's policy recognizes that Lesbians and Gay men have long served with distinction in the armed forces and that "homosexual orientation is not a bar to service entry or continued service."

But, the papers argue, the new policy creates a system under which all Lesbian and Gay service members "are not judged solely on their fitness and ability to serve their country but, rather are subject to discharge because of the perceived prejudices of others."

The new policy "proscribes and chills" any public speech that would identify service members as homosexuals, in addition to hindering a "vast array" of private and/or intimate speech and expressive conduct.

The A.C.L.U. and Lambda also argue that the new policy imposes "a restrictive, confused and self-contradictory set of rules"

on Lesbian and Gay service members unrelated to fitness or ability to serve and that heterosexual service members are not subject to the same rules — a violation of the Constitution's equal protection clause.

"Once labeled as a Lesbian or a Gay man, a service member loses the right to be judged solely on her or his ability and fitness to serve and becomes subject to punitive treatment, to which no heterosexual service member would be subject," says the joint petition.

Attorneys for Lambda and the A.C.L.U. recognize they face a daunting challenge in the courts. With just a few exceptions, federal judges and appeals courts have deferred to the military, allowing the Pentagon to enact restrictive regulations that might not pass constitutional muster in the civilian sector. These infringements have been justified on the basis of ensuring "morale, discipline and the effectiveness of our fighting forces."

The Seventh Circuit Court of Appeals, in denying re-enlistment to former Army Staff Sergeant Miriam Ben-Shalom, said it this way: "We, as judges, should not undertake to second guess those with the direct responsibility for our armed forces. We, as judges, although opponents of prejudice of any kind, should not undertake to order such a risky change with possible consequences we cannot safely evaluate."

CLINTON v. MEINHOLD

One of the exceptions to that judicial deference to the military came in the case of Keith Meinhold. In January, Federal Judge Terry Hatter Jr. ordered that sonar operator Meinhold be reinstated in the Navy. Hatter said he could not "merely defer to the 'military judgment' as the rationale for the policy — the court must consider the factual basis underlying the military judgment."

"Gays and Lesbians have served, and continue to serve, the U.S. military with honor, pride, dignity and loyalty," said the strongly worded decision. "The Department of Defense's justifications for its policy. are based on cultural myths and false stereotypes. These justifications are baseless and very similar to the reason offered to keep the military racially segregated in the 1940's."

Hatter "permanently enjoined" the Pentagon from "discharging or denying

enlistment to any person based on sexual orientation in the absence of sexual conduct which interferes with the military mission of the armed forces of the U.S."

It is that favorable decision which the Clinton administration has appealed in an attempt to block Meinhold's reinstatement. Gay advocates are appalled that a President at one time committed to lifting the ban altogether has now actually gone to court to defend the old ban and to prevent a Gay sailor from serving.

"At least the Bush administration was honest about the fact that they were trying to kick Gays out of the military," said Meinhold's attorney. "Here the Clinton administration is claiming before the courts that they are not kicking Gays out, but then they defend the old rule."

THE RAND STUDY

Gay leaders and veterans are also disgusted with the Pentagon's suppression of the Rand report, entitled Homosexuals and U.S. Military Personnel Policy: Policy Options and Assessment.


Unlike the Pentagon panel which issued the new guidelines and was heavily influenced by the oft-stated resistance of the Joint Chiefs of Staff, the independent Rand report began with the premise Clinton first enunciated in calling for the study: to establish procedures for the integration of homosexuals into the armed forces once the ban was lifted.

Starting with the premise that the ban would indeed be lifted, the Rand report came up with these proposals; no extensive revisions of military regulations are necessary for the change; emphasis should be placed on conduct, and a list of inappropriate behaviors regarding public displays of affection, harassment and abuse of authority should be used as a guide; compliance with these guidelines by all service members, hetero- and homosexual, would not imply any endorsement of a "homosexual lifestyle"; and finally, the leadership of military commanders at all levels is essential to implementing the policy.

Rand gathered more than two dozen lawyers, doctors, social scientists and military leaders to conduct their study. They visited Britain, France, The Netherlands, Germany, Canada and Israel as well as police and fire departments in the U.S. which have hired Gays and Lesbians.

Madison Rallies Against the New Policy

Madison — A rally was held on the steps of the Capitol August 6th to protest President Clinton's new policy on Gays in the military. State Rep. Tammy Baldwin, Maria Hanson, a Lesbian veteran with the campaign for Military Service, and an aide to U.S. Senator Russ Feingold addressed the small but spirited crowd of about 40 people.

"The so-called 'Don't Ask, Don't Tell, Don't Pursue' policy is an inadequate approach for achieving the goal of lifting the ban on service in the military by Gays and Lesbians," said Feingold's Regional Coordinator Billy Feitlinger.

"It fully ignores the principles that discharges should not be based on sexual orientation or status, that all prohibitions against sexual misconduct should be equally enforced and that there should be only narrowly limited restrictions placed on private speech and conduct."

Sen. Feingold has co-authored a letter with seven other senators calling for release of the independent Rand study on Gays in the military (see main story). Referring to press leaks about the report, the letter states: "We know the Rand Corporation experts could find no substantive basis for maintaining the existing ban. The Rand findings also cast serious doubts on the wisdom of adopting a revised policy."

have been maintained, and recruitment and retention rates appear to be unaffected by the presence of known homosexuals."

Regarding concerns over a potential breakdown of "unit cohesion," the report states: "Military leaders have many tools available to prevent this from occurring, including the existence of regulations and norms regulating conduct."

"Over time, the individual characteristics of a homosexual may become more salient to the group that his or her sexual orientation per se, breaking down stereotypes and helping to preserve the functionality of military units."

A Freedom of Information requests has been filed to force the Defense Department to release the full report. Similar requests in the past few years helped to unveil several Pentagon funded studies which concluded that homosexuals were eminently suitable for military service. Unfortunately, none of these studies were ever cited by President Clinton in his many statements against the Pentagon ban.

As In Step went to press, the House and Senate were voting to approve the Pentagon's 1994 budget, which includes an amendment codifying Clinton's new policy on Gays in the military. The Congressional measure also allows any future Secretary of Defense the option of reversing the one advance for Gays that Clinton's plan carried: the practice of not asking recruits about their sexual orientation.

In fact, Judge Ginsburg declined to discuss Gay rights in any detail when she was questioned during her Senate Judiciary Committee hearings, noting that opposites, apparently developed a mutual discrimination based on sexual orientation was a "burning question" likely to come before the high court.

She did make several strong, though generic statements against discrimination when prodded by Sens. Edward Kennedy (D-MA) and William Cohen (R-ME).

Kennedy reminded her of a speech she delivered in 1979 in which she said: "I orientation should be deplored."

discrimination against anyone is against the tradition of the United States and is to be the Appeals Court (excluding Ginsburg), deplored. Rank discrimination is not part of declared there was no constitutionally our nation's culture. Tolerance is. This country is great because of its accommodation of diversity ... The richness of the diversity of this country is a treasure, and it's a constant challenge, too, to remain tolerant and respectful of one another."

Cohen asked her about "rank" discrimination and whether it was unconstitutional. Ginsburg gave an eloquent response, but sidestepped the crucial question of constitutionality:

for reasons that are irrelevant to that person's talent or ability, that is what I meant when I said rank discrimination: arbitrary discrimination that's unrelated to a homosexuality was not protected by the person's ability or worth, unrelated to a right to privacy - a decision bolstered by person's talent; discrimination because simply because of who that person is and not what that person can do."

CLUES IN HER RECORD

Research into Ginsburg's background and previous court decisions reveal mixed signals regarding her stance on Gay rights.

Ginsburg suffered considerable discrimination herself as a Jew and a woman trying to break into the legal profession in the late 1950's. In the 1970's she served as general counsel for the American Civil Liberties Union and successfully argued several landmark cases on women's rights before the Supreme Court. During her tenure at the A.C.L.U., the group began its Sexual Privacy Project and published as part of its series of legal quidebooks, The Rights of Gay People.

Ginsburg then served for 13 years on

the Court of Appeals for the District of Columbia, part of that time with Antonin Scalia, widely regarded as the most conservative member of the current Supreme Court. One case Ginsburg ruled on in 1984, Dronenberg v. Zech, has caused concern among Gay rights advocates. The case involved the appeal of a sailor, James Dronenberg, drummed out of the service think that discrimination based on sexual after admitting to homosexual conduct. He claimed his rights to privacy and equal Ginsburg responded: "I think rank protection had been violated.

The decision of a three-judge panel of protected right to engage in homosexual conduct and that such conduct within the armed services would be "harmful to morale and discipline. The Navy is not required to produce social science data. . . to prove what common sense and common experience demonstrate."

Dronenburg's request for a rehearing of the case before the full Appeals Court was denied. Ginsburg joined in this denial. While distancing herself from the prejudiced "If I discriminated against some person comments of her colleagues, she noted the court was "controlled" by the precedent of a 1975 Supreme Court decision (Doe v. Commonwealth's Attorney) which said the 1986 Bowers v. Hardwick ruling upholding Georgia's sodomy law.

Friends and colleagues who know Ginsburg well say that she knows many Gay people and, indeed, "deplores" anti-Gay discrimination. But she also made clear during her confirmation hearing (when asked about capital punishment): "I will be scrupulous in applying the law on the basis of legislation and precedent. My own views. , are not relevant to the job for which you are considering me, which is the job of a judge."

CHAMPION OF EQUAL PROTECTION

One issue that Ginsburg discussed enthusiastically and without reservation at the hearings was her overriding commitment to the concept of equal protection of the laws. And herein lies some hope for Gay and Lesbian America.

Because of previous rulings denying privacy protections for homosexual conduct, Gay rights advocates are looking more toward the equal protection clause and other legal formulas to seek redress.

At her hearings, Ginsburg spoke at length about the Roe v. Wade decision which legalized abortion. Unlike previous nominees who did their best to avoid the issue, she spoke forcefully in favor of a woman's right to control her body, including the right to choose abortion. And she argued that the Roe decision could have been even stronger if the justices had invoked the equal protection clause in addition to the right to privacy.

Ginsburg's reasoning was complex, but came down to this: imposing government restrictions on a woman's body and her reproductive choices, without imposing similar restrictions on a man's, was a form of sex discrimination and denied women the equal protection of the laws.

Her argument strengthens the constitutional underpinnings of abortion rights (relieving those who doubted her commitment) and breaks new ground by extending the equal protection clause to reproductive issues. It leads one to hope that Ginsburg might also be a strong advocate for extending equal protection coverage to cases involving Gay rights.

It's hard to imagine Ginsburg's judgments not being governed to some extent by her commitment to equality. She will be only one voice on a nine member court, so even if she should try to break new ground, she may remain in the minority for some time. But her thoughtfulness and the intellectual skills which impressed virtually everyone at the hearings might make her a key figure in building a new, more liberal consensus.

The unapologetic way she advocated abortion rights and the Equal Rights Amendment during her confirmation hearing was inspiring too. She did more for women's rights in those few hours before the committee and the TV cameras than a dozen militant protests.

Finally, consider this: Ginsburg is replacing Justice Byron White, the author of the infamous Bowers v. Hardwick decision. By any measure, Ginsburg is likely to be an improvement!



NATIONAL NEWS BRIEFS

Oregon Law Will Block Anti-Gay Efforts

Portland, OR — The Oregon legislature has passed a bill which prohibits localities from enacting anti-Gay initiatives, dealing a serious blow to the ongoing anti-Gay campaign led by Lon Mabon and the Oregon Citizen's Alliance. "This is definitely a thorn in our side," conceded Mabon.

Oregon has been torn apart by the OCA's anti-Gay crusade for several years. Last November, a statewide anti-Gay referendum was defeated, but since then, the OCA has won anti-Gay initiatives carefully targeted to four rural counties and two small towns. The OCA had planned to build momentum toward another statewide referendum next year.

The State Senate's Majority Leader, Dick Springer, said the law would "stop them in their tracks," while State Rep. Gail Shibley, a Lesbian, told the New York Times: "The message is clear. The issue of discrimination based on sexual orientation is a statewide concern, and the OCA's divide and conquer mentality will not be tolerated."

The success of the Oregon measure may be due to its compromise formula. While nullifying anti-Gay laws, it also prevents localities from adopting any "special rights" based on sexual orientation. Because they have contended all along they do not seek "special rights," Gays and Lesbians had no objection to the second provision.

Clinton Appoints More Openly Gay Officials

Washington, D.C. — While disappointing many with his decision on Gays in the military, President Clinton is following through on his promise to appoint qualified Gays and Lesbians to his administration. In the past month, he appointed four Gay men to important positions.

David Cruise, a former Rhode Island State Senator, was named to be Director of Intergovernmental Relations at the

Department of Commerce. David Tseng, a Los Angeles labor attorney, was appointed Special Assistant to the Assistant Secretary of Labor for the Pension and Benefits Administration.

Patrick Nolen of New Hampshire was named Special Assistant to the Under Secretary of Commerce for the International Trade Administration, and David Martin was appointed Confidential Assistant to the Assistant Secretary of Commerce for Legislative and Intergovernmental Affairs.

"Our community has suffered some recent defeats this year, but the political appointment process continues to be our shining star," said Andrew Barrer of Coalition '93, a panel recommending Gay and Lesbian candidates for government service.

Atlanta Mayor Vetoes Partners Provision

Atlanta, GA — In a move that took Gay and Lesbian activists by surprise, Mayor Maynard Jackson, who had previously expressed support for a domestic partnership law, vetoed the provision that would have provided benefits to the partners of city workers.

As reported in the last issue of In Step, the Atlanta City Council approved two bills, one establishing a domestic partners registry for unmarried Gay and straight couples, the other extending benefits to the partners of city employees. Mayor Jackson vetoed the second bill, citing concern over costs. The Council fell short of the votes needed to override his veto.

Within hours of the veto, 200 angry Gays and Lesbians demonstrated outside City Hall chanting "Civil Rights or Civil War!" But within days, evidence of a greater anti-Gay backlash was developing. Several Atlanta area legislators announced plans to pass an anti-partnership bill at the state level, and Mayor Jackson's liaison to the Gay community, who was critical of the veto, was transferred to a department outside the Mayor's office.

as part of a benefit for Gay Games IV and Cultural Festival.

"Because she's comfortable in her own skin, she helps us all be more comfortable in ours. She's out there for all of us," said Billie Jean King in tribute.

Navratilova called the Gay Games "a powerful vehicle for attacking homophobia and for displaying our power and pride. Gay Games IV will change the way the world thinks about us."

The star-studded benefit raised almost \$250,000 of the \$5.5 million budget needed to produce the Games. Someone paid \$18,000 for one of Martina's racquets. Another person paid \$30,000 for a chance to play a match with her. The Games are set for next June 16-25 in New York City, and will coincide with the Stonewall 25 celebration.

L.A. Republican Mayor Appoints Openly Gay Officials

Los Angeles, CA — Richard Riordan, the newly elected Republican Mayor of Los Angeles, has surprised the Gay community with recent high level appointments of openly Gay men and a high profile appearance in the city's Gay Pride Parade.

Shortly after taking office, Riordan appointed Michael Keeley, his former law partner, as the city's Deputy Mayor. Two weeks later, he appointed Art Mattox, a business executive who has participated in sensitivity training with the L.A. Police, to the city's Police Commission. He appointed the two Gay men, said Riordan, because they "happen to be two of the most competent people I've ever come across."

"What I'm saying to the city of L.A.," said Riordan, "is that I'm going to pick the best, most capable people I can to help me run the city. If they happen to be Gay, Christian, Irish, or any other, so be it."

Riordan also rode in the annual Gay Pride Parade. That same week, Jackie Goldberg, an open Lesbian, took her seat on the Los Angeles City Council.

Judge Grants U.S. Asylum to Gay Brazillian

Fear of anti-Gay Persecution "Well Founded"

San Francisco, CA — In the first ruling of its kind in the U.S., an immigration judge has granted a request for asylum to a Brazilian who had been persecuted in his homeland because he is Gay.

In a July 26 decision, Judge Philip Leadbetter ruled that 30- year-old Marcelo Tenorio was eligible for asylum based on a "well-founded fear of persecution" because of his membership in a particular social group. Testimony at the trial revealed the existence of twelve paramilitary death squads who routinely target homosexuals and transvestites. At least one Gay man is killed in Brazil every five days because of his sexual orientation.

In granting Tenorio asylum, Judge Leadbetter noted that "anti- Gay groups appear to be prevalent in Brazilian society and continue to commit violence against homosexuals, with little official investigation and few criminal charges being brought against the perpetrators."

In 1989, Tenorio was beaten and stabbed in a homophobic attack outside a Gay disco in Rio de Janeiro. Fearing for his life, he fled to Mexico and then entered the U.S. illegally in 1990. He found work as a lab assistant in San Francisco but was discovered by the Immigration and Naturalization Service last year and threatened with deportation.

Judge Leadbetter's decision will allow Tenorio to remain in the U.S. "I am thrilled not only for myself, but also for other Gay people who are seeking asylum in this country," Tenorio said.

The U.S. is obligated to adhere to the United Nations' requirement that member nations grant asylum to individuals who have "a well-founded fear of being persecuted for reasons of race, religion, nationality, membership in a particular social group, or political opinion."

interpreting "social group" to include sexual minorities.

Tenorio's attorney, Tania Alvarez, sees the ruling as a landmark: "Now that Lesbians and Gay men have been recognized as a bona fide social group, persecuted members of our communities worldwide who meet the criteria for asylum should receive the same protection as other persecuted groups."

There are about two dozen similar asylum cases pending in U.S. courts, according to Julie Dorf, Executive Director of the International Gay and Lesbian

"By ruling to grant asylum," said Dorf, "Judge Leadbetter has asserted that the U.S. must become a place of refuge for persecuted Gay men and Lesbians, just as it can be to other persecuted people. We hope that this ruling is the first of many to grant sexual minorities equal protection under U.S. immigration law."

Scheduled For August 19th and 20th in Minneapolis



Pittsburgh — The North American Gay Amateur Athletic Association (NAGAAA) 1993 Softball World Series will be held in Philadelphia from August 17 to August 21. The principal national sponsor is Miller Lite Beer. Quibell Water is a national co-sponsor.

All games will start on Tuesday morning, August 17 with the championship finals set for Saturday, August 21. The entire Series will be played at Fairmount Park in the Mount Pleasant Dairy Field Complex.

More than 3,000 people are expected to attend including players, coaches, officials, and fans. According to Nancy Pribich, NAGAAA Publicity Chair, Philadelphia officials estimate a net positive impact on the city's economy of at least 2.5 million dollars from the games and related activities. 

Guess I Don't Get The Last Word On The Ban After All!

When we last left our hero, I sent out my column certain the Gay military ban would have been lifted. I had said "Hopefully as you read this, it will be a history lesson that we can all look back at in victory." WRONG!!!!!!!! Sorry about that. Now I want to make it crystal clear that Sister is in no way pro-military, but I am in every way Antianti-Gay.

If they declared it illegal for homosexuals to have intimate relations with parakeets, I'd probably protest just on the grounds that it was discriminatory against queers. So naturally I attended the huge rally/civil disobedience actions in San Francisco and Los Angeles protesting the Great Compromise. I would have come to your town to protest if I'd had the air fare.

As usual, The Sisters of Perpetual Indulgence, Inc. and the Queer Army dressed in pink camouflage, toted signs saying, "Lift the Ban and then Ban Militarism" and quoted Harvey Milk, "Together We Are An Army." This time, the mood of the protest was not the least hopeful and light-hearted as demos have been lately.

The familiar Clinton-Gore campaign signs were plastered with memos indicating the honeymoon is over between slick Willy and the Gays: "Clinton panders to bigots." One woman carried a huge poster summing it all up: "They sell us out EVERY TIME!" A Gay male protestor wore his "Clinton-Gore in '92: Let Freedom Ring" campaign shirt, painting a large "NOT !!!" onto the slogan. An outstretched banner announced, "Civil Rights Are Not Negotiable!" A poster read "Clinton Gags Fags," while several protestors circulated wearing "Don't Tell" strips of tape over their mouths. The rally began with chanting, "Don't Ask, Don't Tell; Powell and Nunn, Go to Hell!"

Torie Osborn, executive director of NGLTF, said, "Today I am one angry Lesbian. President Clinton has caved to the politics of the far right and proved to be the bubba that betrayed us." She chided the

upper echelon of the military system as nothing but a few straight men with irrational fears.

By the way, as recently-out Lieut. Zoe Dunning says, "Why is it that all the brass is concerned about is men in the showers?

Whatta they think, we Lesbians get dry cleaned??" Supervisor Carole Migden asked rhetorically, "Do straight men get kicked out of the military if they're caught off-base in a sexual encounter?"

Chris Bowman of the Republican Log Cabin Club pointed out that the witch-hunts and discharges will still persist at an annual cost of \$50 million, "No other calling in the world requires that one segment of its workforce remain celibate. The Catholic church requires celibacy of all its priests and nuns, not just the Gay ones." Thank gawd MY order doesn't require celibacy, or even monogamy!!!

Lisa Detmer of the Lesbian Avengers, wearing a t-shirt with a big bomb logo, said, "We won't settle for anything less than a complete lifting of the ban, and our fuse is short." She made it clear that in no way was her group endorsing the militarism of any kind, but nonetheless demanded full civil rights for queers. Kate Raphael of Lesbians and Gays Against Intervention added, "It may be a civil right to get into the military, and it is and we demand it, but it is a human right to stay out of it." Taking off on the Army slogan, she said, "It's not just a job, it's a lousy job."

Ken McPherson of Life/AIDS lobby spoke of a planned national action at the 1996 Democratic convention, bigger than the million-member '93 March on Washington. "It will be up to you, Bill Clinton, as to whether this will be a friendly meeting or otherwise."

Last time I reported on a ban-lifting rally, the Gay musical band ended the event playing "Happy Days Are Here Again" as the crowd clapped and danced for joy, which I had hoped all of us would be doing as you read my former column. This time, needless to say, there was no celebratory spirit.

And that, my friends, is the gawd's honest truth. We are not going away, we are not going to stop marching and civilly disobeying, and we are not going to miss the June 26 Stonewall 25 March at the UN for queer rights, or the march against the Democratic convention in '96

Special Elections Set for State Senate, Assembly

Madison — A primary election will be held August 24 to narrow the field of candidates vying for the State Senate seat vacated by Republican Donald Stitt of Port Washington. And on August 31, voters in Kenosha will choose a replacement for former Assemblyman, now U.S. Representative, Peter Barca.

The Senate race is significant because it will determine which party will control the State Senate. The current tally is 16 Democrats and 16 Republicans. The 20th District is heavily Republican.

The Republican candidates are: State Rep. Mary Panzer of West Bend (considered the front runner); Michael Riley, a Cedarburg businessman; Craig G. Heatwole, a Port Washington businessman; David A. Schwengel, a public utility worker from West Bend; and Kelly Green of Cedarburg.

The Democrats in the race are: Kimberly A. Dumas, a teacher; and Sara Lee Johann, an attorney in Cedarburg.

The general election is scheduled for September 21. A Libertarian candidate, James S. Rustad, is also on the ballot.

The August 31 election for the 64th District Assembly seat in Kenosha will be between Democrat James E. Kreuser, who has won the support of labor unions and women's groups, and Republican William F. Cantwell.

Geske Appointed to State Supreme Court

Madison — Gov. Tommy Thompson has appointed Milwaukee Circuit Court Judge Janine Geske to replace retiring Justice Louis Ceci on the State Supreme Court.

The appointment came as something of a surprise because conservative elements in the Republican Party had been lobbying in favor of two other candidates, Milwaukee County Judge Dominic Amato and Brown County Judge Patrick Crooks.

Geske's exact ideological bent is unclear and she has refused to be labeled. She is perceived as tough on defendants found guilty of violent acts, but compassionate toward victims and critical of the social conditions which foster crime. Fellow judges and both prosecutors and defense attorneys all agree that Geske is a hard- working and intelligent jurist.

The State Supreme Court has been dominated by a conservative majority for many years. Decisions are often rendered with a 4-3 conservative/liberal split. Geske is replacing the conservative Ceci, so everyone is anxious to see where she will fit in and whether there will be a realignment of the court.

Among the cases of interest to the Gay community that Geske will rule on is an appeal by a Lesbian in Brown County who wants to adopt her partner's daughter. The father is willing to sever his parental rights. The lower court found that the adoption would be in the best interests of the child, but denied the petition for adoption on the basis that the two women were not legally married, a requirement of Wisconsin statutes.

In her appeal, the Lesbian partner argues that her rights to due process and equal protection of the laws have been violated. Oral arguments are scheduled for this fall.

Obviously," a stay at the festival is not your getaway weekend at the Ritz Carlton. So why do we go?

We all have our own takes on the Michigan thing to one degree or another, but basically I think everyone who attends is there for one mega, undiluted, unadulterated dose of Lesbian culture, in all its many guises. Being at Michigan is like being plugged into a giant battery recharger, with most of us leaving the festival feeling physically exhausted but spiritually refreshed. So often in our own communities we experience only a fraction of the Lesbian thing. At Michigan, one's senses are bombarded with a much fuller view of the richness of Lesbian culture, so that no matter what kind of Lesbian you are, you are bound to feel much less alone when you

leave than you did when you came. Then too, the sense of safety one feels at Michigan is like a soothing balm to the mind and spirit. In the end, I guess it's almost like some convent thing, where the deprivations of the flesh are ultimately good for the soul.

So what it comes down to is this: you might be able to recreate the physical sensations of the Michigan festival experience, but it's tough to capture the rest of it. For one thing, where the hell would you find that many naked women willing to come over to your house?

Your Own Private Michigan

It's that time of year again, when the softball fields are suddenly — for no reason discernible from the hetero calendar of holidays — emptied of female ballplayers; when there's a run on RV rentals and rain ponchos; when the local women's bookstore is a lonely place to be. Yes, it's the time of year when Lesbians across the globe don their No-One-Knows-I'm-a-Lesbian t-shirts and their labryses — like pilgrims returning to the holy land — and journey to the piney woods, trekking with joy in their hearts to that Mecca of pure gyneuphoria, the Michigan Womyn's Music Festival.

but every year, a number of the faithful are left behind — some because they could not finance the journey, some because their bosses are of another faith and do not honor this holiday, and yet some one or two more to deep the bookstore open as a consolation for those remaining. If you are one of the ones who are facing the plight of being one of the eight Lesbians in your town not going or if you're a Gay man and you've always wondered what the festival experience was like, cheer up: there's something you can do. Just follow these simple steps to create your own Michigan festival experience.

1. Find a road with a LOT of potholes (almost any street in Chicago), and drive over and over it, imagining that the phone poles along the sidewalks are really trees and that the blue cloud of smoke is the dust of a dirt road instead of the environmental disaster of a car choking along in front of you. While you drive, have on a tape of the Parachute Club or Holly Near and an idiotic grin of happiness and say things like, "We're almost there!" and, "Won't be long now!"

2. When you return home from this drive, put together a complicated piece of equipment in the dark with nothing but a flashlight to illuminate the tricky parts. Maybe, for good measure, have a little argument with your lover about which thingamabob gets inserted where.

3. Give the different rooms in your house names, like Lunatic Fringe, Neptune Nerds, and Spinster Acres. Assign different rules of behavior to each room and sleep in the one that best suits your mood.

 Spend the next 3 or 4 days walking around your house with nothing on but Birkenstocks.

5. Sleep on the floor. Or, for a more authentic effect, tryscattering several pretzel sticks and garbanzo beans (uncooked) under your sleeping bag or blanket. Release a few mosquitoes into the room, and cuddle up to your honey.

6. The next morning, scatter gravel on the floor of your shower and turn on the spigot for cold full blast, seasoning it with just a hint of warm. Invite several women from the community, whether you know them or not, to come watch.

 Sit out in the sun way too long and crisp up those tender parts. Don't drink any water until you feel as if you could pass out.

8. Walk twice around the perimeter of your house, very slowly, before getting food, then sit down on your lawn, with the sprinkler on, to eat. (If you are the sort of person who is always prepared, it's OK to hold a rain poncho, tentlike, over your head and plate while you attempt to dine.)

9. Go into your house, turn out all of the lights, crank up the air conditioning to "freeze," take off most or all of your clothes, and put a damp blanket ont he floor. Then, put on a tape of Chris Williamson and relax. For an even more realistic effect, you could also turn on a sitcom so that all the talking and laughing makes it hard to really hear the music.

 Don't look at a newspaper or listen to any news for several days running so you have no idea what's going on in the world outside.

11. Start a rumor. And then tell yourself it's not true.

12. You could try not flushing the toilet for 3 or 4 days, but the neighbors would probably complain. When they do, and the Board of Health comes to investigate, holler, "Men on the Land!" as you open the door unless, of course, the bureaucrat in question is a woman. In which case, by all means: invite her in.

 Invite all of your ex-lovers over and glare at them as you pass from room to room.

14. Argue with yourself about the political correctness of every possible issue.

Dear Editor:

Senator Sam Nunn, Chairman of the Senate Armed Services Committee, while claiming to be clarifying President Clinton's new policy on Gays in the military, has deleted on significant section. According to the Associated Press.

"Missing from the committee's policy is the administration's requirement of equal enforcement for heterosexuals and homosexuals of the Uniform Code of Military Justice, which outlaws sodomy."

That omission by Senator Nunn's committee clearly shows the hypocrisy in the military's current policy: it does not want to enforce its own Uniform Code of Military Justice against heterosexuals.

During Desert Storm, a male army officer forced a female into an act of sodomy. The Army at first dismissed it as "consensual," but after the woman fought the decision the army pursued it and the male officer confessed. According to the UCMJ, even a "consensual" act should have

been grounds for discipline, but the Army ignored its own rules of conduct. We only heard about this incident because it was, in fact, a rape, and because the woman had the courage to demand justice. One wonders how many other, unpublicized instances of non-enforcement there were, and, indeed are, every day.

Allowing Gays into the military is not just about Gays, but about equality and decency.

We have seen Senator Nunn's military code of "honor" at work in the Tailhook affair: in both the difficulty in getting the military to investigate, and in difficulty in getting testimony to prosecute those accused. We see the same code at work now in Senator Nunn's legislation, which in effect says heterosexuals are free to ignore the UCMJ and carry on as before.

I'm afraid women in the armed services are in for a rough time. Maybe they can somehow learn to stay in some "closet."



New case definition reflected in 461% seasonal increase

(In Step) — On January 1, 1993, the definition of what conditions verify an actual AIDS case was expanded. The new guidelines include all HIV infected people with severe suppression of their immune systems (less than 200 CD4+T helper cells), pulmonary TB, recurrent pneumonia or invasive cervical cancer. The impact of that change is now being reflected on local, state and national AIDS surveillance summaries.

In Wisconsin, for the first quarter of 1993, a total of 427 AIDS cases were reported to the Wisconsin AIDS/HIV program, representing a stunning 461% increase over the number reported for a similar period in '92. Those 427 new cases are 23% of the cumulative total of 1,818 Wisconsin AIDS cases reported since 1982.

Of the 427 cases of AIDS reported in Wisconsin during the quarter, 357 (84%) were based on the new definition that went into effect on January 1st. Only 70 (16%) were based on the old definitions. Of the 357 persons reported with only 1993-added conditions, 353 of those (99%) had severe HIV-related immune system suppression only. Only 4 (less than 1%) had pulmonary TB, and none had recurrent pneumonia or invasive cervical cancer.

In Wisconsin, it is expected that 75-100% more cases will be reported in all of 1993 than would have been reported using the previous case definition. Most of the 1993 reported cases will result from reclassification of persons previously reported with HIV infection, according to the Wisconsin AIDS/HIV Update, a publication from the Wisconsin Department of Health.

As the process of reclassification is completed, the monthly number of new AIDS case reports will decrease towards previous levels, and has already dropped significantly since the "boom month" of January when the new definition went into effect. The publications AIDS Surveillance Summary also shows that in Wisconsin, Gay males make up 67% of AIDS cases (nationally, the figure is 55%); IV Drug Users make up 11% of Wisconsin cases (nationally, 23%). In the state, another 6% are from heterosexual contact, with 6% more of undetermined exposure.

92% of Wisconsin AIDS cases are male; 74% are white, 19% Black, and 6% Hispanic.

The format of the program is to provide information on HIV, HIV transmission, AIDS and Safer Sex practices to viewers of the program and to answer the specific questions of callers on the live call-in program.

"It is tradic that most people do not understand how this virus is transmitted," says Ambelang. "Many people feel because they occasionally use a condom they are safe. There is no such thing as SAFE! Our program tries to get the point across. We don't moralize or pass judgements. Sex is happening, it is happening in and outside of heterosexual of marriages, it is happening among the Yuppies and it is happening among Teens. Many individuals, even those within the supposedly knowledgeable Gay population are putting themselves and their partners at risk due to a misunderstanding of the basic fundamentals of transmission. We want an end to this as soon as possible!"

Berlin--Nein!

A few weeks ago, Caremark[™] the homecare company, sponsored a local update on the International AIDS Conference in Berlin. The speaker was Brian Buggy, M.D., a local doctor who attended the Conference. I don't know if it means anything, but Dr. Buggy and one Medical Fellow were the only doctors from Wisconsin to attend. If the U.S. cannot hold an international meeting, maybe we need a few more regional or national conferences to get the doctors together. But I digress. The most immediate conclusion one could come to, following Berlin, was: no news is not good news.

I'll leave the technical stuff for others. There are plenty of publications with the scientific information from Berlin available. This is a simplistic overview as I see it.

First and foremost anti-virals appear to provide some help in quality of life, and a slowdown in progression to the disease, but do nothing toward prolonging life. The study that received the most attention from the media, the British/French Concorde (no relation to the airplane of the same name), left as many questions as answers regarding early intervention with AZT. While attempting to come up with some standardization on when to begin early intervention, they couldn't. Again, early drug intervention seems to have little effect on patient longevity. Actually it appears that avoiding opportunistic infections along with a positive mental attitude is what really prolongs life. This is an area that needs more study. People are living longer, and to some extent better, but we still don't know why.

There are indications that combination therapy, particularly AZT along with ddC or ddl does promote a better quality of life and



might extend longevity by 6 to 18 months. It even appears that combination therapy begun at anytime in persons with CD4 counts of 50 or greater will have some benefit. Unfortunately this continues to be true in some patients, but not in others.

As I mentioned previously, avoiding opportunistic infections seems to greatly contribute to one's quality and quantity of

life. Prophylaxis preventive treatment for PCP and MAC have shown they work. The disease (AIDS) itself will continue its progression, but we will be healthier if we avoid other stuff.

While the evidence of value of the Salk vaccine seems to be basically elusive at this time, there are indications that he is on the right track. In its early stages, the vaccine may actually turn out to be of some benefit for people who have already progressed to AIDS.

The information that came out of Berlin was what I expected, little or no progress on almost all fronts. Personally I've never been optimistic about a cure, but I sure would like to see more effort put into quality of life issues for people with AIDS. Sometimes it seems that researchers are on a different wavelength than patients. There is great scientific value in basic research, but there is more to life. I would never dream of interfering with independent research, but really wish more researchers would spend time with patients to see what issues they would like to see explored.

Stephen R. Endean, 44, IS Dead

Visionary Gay Pioneer Dies of AIDS

Washington, DC - Steve Endean, the first executive director of the Gay Rights National Lobby and founder of the Human Rights Campaign Fund, the country's largest Lesbian and Gay organization, died at 7:30pm August 4, in his home in Washington, DC, of AIDS. He would have turned 45 on August 6th. He was the Lesbian and Gay community's first professional lobbyist and a visionary leader in the community for more than twenty years. As an activist and organizer, Endean had a passionate belief in the power of mainstream politics to achieve the goal of Lesbian and Gay civil rights. He was personally responsible for the creation of some of the Lesbian and Gay community's most important lobbying, grassroots and political programs.

Congressman Barney Frank (D-MA), one of two openly Gay members of the U.S. House of Representatives, in a statement called Endean "one of the bravest, toughest and most skilled fighters for human rights in our nation's history. People who know how hard it can be to fight for Gay and Lesbian rights today should appreciate how many times harder it was to do that 20 years ago when Steve was a pioneer in the effort. I grieve at our loss."

Endean's energy and persuasiveness were legendary. Those qualities were largely responsible for his ability to maintain a dominant role in the country's Lesbian and Gay community for more than two decades. Endean also credited his belief in God and his work with the Metropolitan Community Church as a source of personal strength. An article published at the time of his retirement from the Human Rights Campaign Fund noted that "critics and friends agree that Minnesota native Endean - through his skills as a political tactician and the sheer force of his personality - helped change the national Gay political movement from a marginalized group of outsiders in the eyes of Congress into a well-oiled operation that today has earned the respect of powerful politicians."

In the years following the New York Stonewall Riots of 1969, Endean sought to mobilize the emerging Lesbian and Gay

community as a political force. As a young man in Minneapolis, Minnesota, and later nationally, he sought to transform the energy of street demonstrations into mainstream political activity, encouraging Lesbians and Gay men to work within the political system to pass anti-discrimination laws and elect supportive candidates to office.

Endean would later use the techniques he developed in Minnesota to mobilize the Lesbian and Gay community nationally as a potent force in politics. He believed in creating coalitions with other progressive organizations, including labor, civil rights, women and religious groups, and in building on small advances in an effort to achieve larger goals.

In 1978, Endean moved to Washington, DC. to become the first executive director and lobbyist for the Gay Rights National Lobby. "The Lobby was housed in another organization's offices," he later wrote, "we had a single desk, and the day I arrived I discovered the phone had been disconnected. GRNL had \$9 in the bank and thousands in debt." Within two years, however, the organization had moved into a Capitol Hill townhouse, had staff of 10 professionals and an annual budget of more than \$300,000, A Washington Post feature story on him written at the time noted: "His dress is classic and conservative, the lobbyist's requisite navy blazer and tie. His style is professional. When he talks tactics, it's as a seasoned lobbyist."

In 1982, while continuing to work as Executive Director of the Gay Rights National Lobby, Endean created the Human Rights Campaign Fund as a national Gay political action committee (PAC). In 1985, after Endean had retired from both organizations, the two groups merged. The Campaign Fund has grown from a small political action committee into a 75,000 member organization that raised more than \$5 million last year for its lobbying, campaign and grassroots activities throughout the United States.

In 1986, Endean created a national grassroots organization called The Fairness Fund which generated mailgrams and letters to Congress from supporters of Lesbian and Gay rights. In 1987, The Fairness Fund merged with the Human Rights Campaign Fund and Endean rejoined the staff as Field Director. He renamed the grassroots program "Speak Out," and developed it into

the most successful grassroots program in the history of the Lesbian and Gay movement, sending over a million letters to Capitol Hill in its seven year existence.

In ill health, he retired from the Human Rights Campaign Fund in May of 1991. Despite his illness, Endean continued to work part-time with the Campaign Fund, creating a new program, "The National Endorsement Campaign," to gander written support for a Federal Lesbian and Gay Civil Rights Bill from prominent non-Gay Americans in all fields of interest.

"Steve Endean's legacy will endure," said Tim McFeeley, Executive Director of the Human Rights Campaign Fund. "The institutions he developed will continue to bring our issues to the forefront of American politics. Few individuals have made as great a contribution toward ending discrimination than Steve Endean. He will be greatly missed."

Endean was working on an autobiography, "Into the Mainstream," at the

time of his death. He was an active member of Black and White Men Together, a social group, and a parishioner of the Metropolitan Community Church in Washington, DC. He attended St. Thomas College in St. Paul for one year, and the University of Minnesota for four years. He was active in Phi Gamma Delta social fraternity.

Endean was born in Davenport, Iowa, but lived most of his life in Minnesota and Washington, DC. He is survived by his parents Robert Endean and Marilyn Endean Lowe of Minneapolis, MN; his sister Mary Ellen Barna of Minneapolis and many friends at the Human Rights Campaign Fund, the Metropolitan Community Church and across the country. A memorial service was held August 28, in Washington, DC at the Metropolitan Community Church. A later memorial service will be held in Minneapolis at a date to be announced. Cultural Festival Part of Gay Games & Stonewall 25

Major Art Shows Scheduled for June 1994 in New York

Thanks to the help of two members of the Gay Games Board of Directors, Howard Buford and Robby Browne, the Gay Games Cultural Festival will be able to highlight the works of two major Gay artists in June 1994.

Buford has arranged with the largest private collector of the works of Keith Haring to exhibit a large part of his collection during the Cultural Festival. Howard has also been in contact with other private collectors and the Keith Haring Foundation to see if it is possible to obtain other pieces. "We would like to make it the largest exhibit of Haring's works ever presented," says Buford.

Haring was a New York painter who started his career as a graffiti artist before becoming world famous for his simple, colorful representations or our common humanity. He died of AIDS-related causes in January 1991. He gave generously to both AIDS and Gay and Lesbian causes. As probably the most widely known Gay artist of the period since Stonewall, it is very appropriate that his work should receive a major exhibition during the Cultural Festival.

Buford has been actively involved in the Gay Games' Marketing Committee, and he sees the Haring show as one event in which several large corporations may be vying for sponsorship to support the costs of mounting the exhibition. "Our aim is to use events with widespread appeal such as the Haring show as a way for corporate America to reach out to the Lesbian and Gay community. If we succeed in doing so, it will be a major breakthrough for Gay Games IV & Cultural Festival."

As yet, no venue for the Haring show has been found, but negotiations are underway for the use of several possible downtown Manhattan locations.

Board member Robby Browne has been talking to the Guggenheim Museum about the possibility of mounting another major exhibit during the period of the Cultural Festival. Gail Harrity, Deputy Director of the Guggenheim, says that the Museum is very excited about the possibility of doing a blockbuster show featuring a controversial Gay artist in June 1994. "I

can't tell you the name until it's officially announced in our calendar," she says, "but it's sure to spark a great deal of enthusiasm, as well as some criticism!"

Artist & Performers Urged To Participate In Cultural Festival

The Cultural Festival Committee has devised a project proposal form for artists and performers who want to participate in the Festival. The proposal form is available now to anyone who calls or writes the Games.

"It is our responsibility to see that people learn about the Cultural Festival and the possibility of participating. With the form, our next task is to publicize widely and to actively solicit applications. Otherwise, we can't possibly have the kind of inclusiveness essential to the success of the Festival," said Dan Baker, Chair of the Cultural Committee.

In the area of music and dance performances, the Committee is talking to several major venues in both Manhattan and Brooklyn.

"The number of performances that we are able to present depends on the space available to us," explains Baker. "Some really ideal locations, such as the Joyce Theatre, are already booked for June 1994, so we can't hesitate to lock in some of these spaces. Fortunately, many other great locations are still available, and they all seem to be very receptive to participating in the Cultural Festival in one way or another. People see June 1994 as a crucial moment in the cultural life of Lesbians and Gay men worldwide."

If the scale of the musical events comes close to being what is now envisioned, it will be possible to produce at least one and maybe more albums based on the performances. Jay Hill, executive director, has already started discussions with music producers about these possibilities, and he reports there is a great deal of enthusiasm.

"The 1994 Cultural Festival will be a watershed event in the lives of Gay and Lesbian performers, and we expect to enjoy the performances of many well-known artists," he says. "We also want to be able to say that many of the greatest 'out' performers of the future got their start at Gay Games IV & Cultural Festival."



Arlyn J. Kampen died July 21, from complications due to AIDS. He was 46 years old. In recent years, Arlyn's life-sized snow sculptures were a popular attraction at Milwaukee's WinterFest and delighted thousands of people who attended annual event.

In January, Arlyn captained a three man snow sculpting team which went on to win The 1993 United States National Snow Sculpting Competition in Anchorage, Alaska. He designed the winning sculpture "Equine Spirit" which qualified the team to represent the United States at The Olympic Arts Festival to be held in conjunction with The 1994 Winter Olympic Games in Lilihammer, Norway.

In addition his success in Alaska, Arlyn won numerous snow and ice sculpting





competitions, including victories at The 1992 International Snow Sculpting Competition held in Ontario; and The 1991 United States National Snow Sculpting Competition held in Milwaukee. In 1988, he designed and decorated the "World's Largest Wedding Cake" made from snow. Arlyn worked as a professional ice carver with Home Town Ice, Inc.

Born near Melrose, WI, Aryln graduated from Black River Falls High School and honorably served in the U.S. Navy from 1965 to 1969. He later studied art at the Milwaukee Institute of Art and Design.

Arlyn was very active through-out the community, with strong connections to Milwaukee's Gay and Lesbian recovering fellowships, serving a term on the Galano Club Board of Directors. Arlyn enjoyed theater and was a cast member for several years with The Fest City Singers, including service on that groups Board of Directors as well.

Arlyn is survived by his mother, Dolores; siblings Michael and Vicky; team members, Bill Hackbarth and Paul Hess; and countless friends and "family" whose lives he brightened.

A "Celebration of Life" honoring Arlyn will be held at 7pm, Tuesday, August 31st at The Villa Terrace, 2220 N. Terrace Avenue on Milwaukee's east side.
