


# NEWS Kitty Barber Shot After Highway Chase, Stand-Off with Police in Dane County

# "Dynamic" Activist Reportedly Despondent Over Law School, Relationships

Madison — As In Step went to press, Kitty Barber, a longtime activist in Milwaukee's Lesbian community, was recuperating at University Hospital in Madison from gunshot wounds sustained after a high speed chase and stand-off with police and sheriff's deputies.

The incident began at about 2am Friday, December 1 on Madison's east side when police began their pursuit of Barber, who was reportedly exceeding the speed limit in her minivan.

Barber fled the police, who were joined by sheriff's deputies and the State Patrol as she sped north out of the city. The chase ended at the Super America at the junction of highways 19 and CV, when Barber stopped, got out of her vehicle and, according to police, put a gun to her head.

Barber was ordered to drop the gun, but instead, the police say, aimed it at an officer. At this point, other officers opened fire, wounding Barber in the chest, abdomen and legs. Madison Police Lieutenant Steve Gilmore defended the action, saying "Deadly force was going to be used against the officer."

Numerous sources indicate that Barber was despondent over falling behind in her school work — she was a second year law student at the University of Wisconsin —and several recent break-ups of relationships.

Barber has spoken openly about her struggles with alcoholism and depression in the past, including in songs she wrote and performed. The song "Doktor, Doktor" on her album *Over the Line* contained a bitter indictment of psychiatric abuse.

Close friends from Milwaukee, including her former partner, Karen Gotzler, rushed to Madison to be with Barber who underwent many hours of surgery.

#### **"A HORRIBLE TRAGEDY"**

Meanwhile, friends and colleagues in Milwaukee expressed shock and sadness at the news about Barber, who has been a high profile and much-admired activist in the feminist and Gay and Lesbian communities since the 1970's.

They recalled Barber's work, from helping to revitalize the Women's Coalition in the 1970's, through her performing as an openly Lesbian artist, to the founding of the Lesbian Alliance of Metro Milwaukee (LAMM) and her leadership as a spokeswoman for Milwaukee's Gay and Lesbian community during the crisis brought on by Jeffrey Dahmer's murders in 1991.

"I'm shocked, devastated, sad," said Lesbian activist Stephanie Hume. "Kitty was one of my mentors. She inspired me to take my commitment to my community more seriously and make it a lifetime thing."

"Her leadership when our community was going through times of great crisis — like the Dahmer case — served us well and helped us to grow and move on. Her articulate voice enhanced our image in the straight community. She taught so many of us how we could work effectively for political change, at the local *and* the national level."

"Kitty's a real pioneer," Hume concluded. "She's like our Mother Jones." "This is a horrible tragedy," said Julie Kleppin, who worked with Barber to help found LAMM in 1989. "Kitty is a terrific person and I hate to see this happen to her."

"Kitty's one of those brilliant people who's very driven, and I don't think she always heard her inner voice or friends' voices telling her she was OK, she was wonderful. Sometimes a person working as hard as she did can feel isolated and alone. It's so sad."

Another political colleague and friend in the Gay community, Scott Gunkel, said of Barber: "She's one of the strongest women I've ever met in my life. She's been a dynamic spokeswoman and organizer for us. I personally owe her a lot for my own political education and growth. I've missed her around Milwaukee in the past few years."

# **STATE Briefs Opponents Lambast Pro**posal to Gut Housing Protections

Madison - Assembly Bill 662, which would gut civil rights protections in the area of housing, got a hostile reception from the majority of people who testified at a hearing before the Assembly's Committee on Housing November 30. Among those speaking against the measure were representatives of the Madison AIDS Support Network, the AIDS Resource Center of Wisconsin (ARCW) and Action Wisconsin, the LesBiGay advocacy group.

An analysis by the Legislative Reference Bureau describes AB 662 in this way: "Under current law, a person may not discriminate in housing based on the age, ancestry, color, disability, family status, lawful source of income, marital status, national origin, race, religion, sex or sexual orientation of another person.

"This bill adds an exemption to this prohibition, permitting owner-occupiers of a dwelling that contains independent living units of 4 or less to discriminate in the provision of housing in that dwelling. The bill requires local ordinances to be consistent with this exemption."

Proponents say the bill is needed to protect the rights of property owners to free association. But critics say the bill would punch a huge loophole in current housing protections, allowing many land-

lords to openly discriminate against people they do not like.

The bill would be a setback to all the protected groups, including Gays and Lesbians and people with HIV/AIDS, who in recent years fought hard to win such protections.

Openly Lesbian State Rep. Tammy Baldwin, who serves on the Housing Committee, expressed her strong opposition to the proposal on a variety of grounds. And Mike Gifford of ARCW told In Step: "Sixty-five percent of our clients are in jeopardy of becoming homeless each year. This bill will make a bad situation much worse."

Because of the negative feedback from the public, the Housing Committee has not scheduled the bill for committee vote. Although AB 662 is not in imminent danger of being passed, people are encouraged to call their state representative to express opposition to the measure. #### Gotzler, Rose Seek Position on Milwaukee's **Common Council**

Milwaukee - In a historical "first" for Milwaukee politics and the city's LesBiGay community, two openly Gay candidates are seeking to represent the Third Aldermanic District on the Milwaukee Common Council. The candidates are Karen Gotzler and Steve Rose. They may face as many as 8-10 other candidates in the non-partisan primary election scheduled for February 6.

The third district runs along Milwaukee's lakefront, roughly from the downtown area north to Shorewood. This area of Milwaukee's fabled east side is home to many of the city's LesBiGay activists and businesses.

While some worry that having two openly queer candidates will split the LesBiGay vote, Rose saw some benefits to the race: "What better way to combat apathy in the Gay community than by having two qualified openly Gay candidates run? Two committees working on get-out-the vote campaigns in our community can only help in the long run."

Gotzler, 41, was born and raised in the Third District and has been involved in many community groups, including the Task Force on Battered Women, the Lesbian Alliance of Metro Milwaukee, the No Retreat on Civil Rights Network and Milwaukee's Overall Economic Development Program Committee. works for the Wisconsin Department of Development, and feels that her background as a business owner and economic development consultant makes her well qualified to tackle the many economic development issues facing Milwaukee.

Rose, 25, was born in Texas but has made Milwaukee and the Third District his home for the past two and a half years. He works as a residential property manager and has been actively involved in many LesBiGay groups including PrideFest, the Metropolitan Community Church, People of All Colors Together and AIDS Walk Wisconsin. His campaign is focussing on "quality of life" issues at the neighborhood level.

A fundraiser and variety show, A Rose by Any Other Name, will be held for Rose at the 3B's, 1579 S. 2nd Street, at 10:30pm on Saturday, December 9. Entertainers include Jessica Mills, Brittany Morgan and Mary Richards. The \$2 cover will benefit the BESTD Clinic, although the BESTD Clinic has indicated very clearly it has not endorsed Rose. (ED. NOTE: Please see Letters section in this issue.)

On December 12, Gotzler is holding an "Economic Development" fundraising reception at the City Grille at the corner of Brady and Van Buren from 5:30-7:30pm. On the 16th, she'll hold a fundraising reception for the LesBiGay community at the Yankee Hill Apartment Complex from 4-7pm.

#### Medical College AIDS **Researchers Granted \$3** Million

Milwaukee - Jeffrey Kelly, Professor of Psychiatry and Behavioral Medicine and Director of the Center for AIDS Intervention Research (CAIR) at the Medical College of Wisconsin, has been awarded a four-year, \$2.6 million grant from the National Institute of Mental Health.

The grant will be used to study ways to transfer successful AIDS prevention approaches from the research arena to community-based AIDS prevention organizations in 75 cities nationwide, making their prevention measures more effective.



"CAIR has developed a number of HIV prevention interventions that meet with considerable success in helping people reduce high-risk behavior," says Dr. Kelly. "However, we are concerned that information on how to conduct and implement these approaches does not always reach the front line AIDS prevention staff of community-based organizations. They often don't have access to scientific journals and detailed 'how-to' information for conducting state-of-the-art HIV prevention strategies in their own communities,"

The new grant project will enable CAIR staff to provide inventive, on-site training in state-of-the-science HIV prevention programs to the staffs of 75 of the country's community-based AIDS prevention programs.

Meanwhile, Dr. David Holtgrave, Director of AIDS Policy Research at CAIR, has been awarded a two-year, \$424,817 grant from the National Institute of Mental Health to conduct studies to evaluate the cost-effectiveness and cost-utility of HIV/AIDS prevention interventions. A nationally recognized expert in cost-effectiveness research, Holtgrave's objective will be to identify how many HIV infections are averted by AIDS prevention and what types of AIDS prevention approaches provide the greatest benefit in relation to their cost.

## HIV Infections in Wisconsin Now Over 5,100

Madison — The AIDS/HIV Program of the Wisconsin Division of Health reports that as of September 30, 1995, 5,111 state residents have contracted HIV, the virus that causes AIDS and there have been 3,051 cases of AIDS itself. Sixty-five more people died of AIDS complications in the third quarter of this year, bringing the total of AIDS deaths in Wisconsin to 1,765.

Of the 5,111 people who contracted HIV since statistics were compiled in 1982, 13% are female, a number that has been slowly but gradually rising. Of all those with HIV infection, 61.9% are white, 29.3% are black, and 6.9% are Hispanic. Of the total number of AIDS cases, 64.5% were contracted through male to male unprotected sex with an infected partner. Injection drug use contributed to 12.7% of cases. The combination of unprotected male to male sex and injection drug use accounts for 5.9% of cases, and 6.5% are due to unprotected heterosexual relations with an infected partner.

The national statistics issued by the Centers for Disease Control and Prevention are increasingly grim. As of September 30, 1995, 477,000 Americans had been diagnosed as HIV-positive, and more than 295,000 have died from AIDS complications.

## "Public Sex" Ordinance Referred Back to Madison City Attorney

Madison — In November, the Madison City Council in a unanimous voice vote referred the controversial "public sex" ordinance proposal back to the City Attorney for reconsideration and re-drafting.

Alderman Mike Verveer told **In Step** that Council members recognized the ordinance contains potential violations of due process rights and therefore declined to act on the measure until it is significantly revised.

The ordinance was drafted in reaction to neighborhood complaints and inflammatory reports in the media about male-to-male sex taking place in Olin Turville Park. It was initiated by Police Captain Ellen Schwartz and was unanimously endorsed by the city's Parks Commission.

The measure would give police the power to banish a person from all city parks for up to six months for violating certain ordinances, including public exposure, the use of "profane" language, and "boisterous behavior."

The proposal was sent to the City Attorney for a 60-day review, so the first time it could possibly come up for consideration by the Council is in early January.

# NATIONAL News Briefs Congress Needs to Hear About Medicaid Cuts, Ryan White CARE Act

Washington, DC — AIDS activists and service groups are alerting the nation to the terrible impact that proposed cuts in Medicaid, the government's program of health assistance for low income people, will have on people with HIV/ AIDS.

Medicaid is the federal effort that makes health care available to 36 million low-income Americans. Nearly half of all Americans living with HIV and AIDS rely on Medicaid — including more than 90% of children with the disease.

Congress is expected to vote on a budget bill for 1996 by mid-December. A face-off between the Republican majorities in both houses of Congress and President Clinton resulted in the federal government closing down in mid-November. A revised bill must be debated and adopted this month. AIDS advocates say that it is *critical* for people to contact their members of Congress and oppose the current proposal which aims to cut \$182 billion from Medicaid in the next seven years. Instead of a minimum guarantee of medical support for indigent Americans from the federal government, medical assistance would be left up to the states, which will receive federal block grants and decide the criteria on which that aid will be distributed.

"People with AIDS are not politically popular to defend," Mark Barnes of the AIDS Action Council told the **New York Times.** "As a person who grew up in Alabama, I fear, I tremble for the fate of people with AIDS under a purely stateadministered Medicaid program."

Doug Nelson of the Milwaukee AIDS Project said that with the demise of General Assistance payments in Milwaukee County and the closing of Doyne Hospital, people with HIV/AIDS in the Milwaukee area will be even more dependent on federal assistance.

Also held hostage in the tug-of-war between Congress and the President has been the Ryan White CARE Act Re-Authorization. Although the CARE Act was passed by both the House and the Senate, a conference committee has only recently met to negotiate a compromise on the slightly different versions of the bill. It has not yet been sent to the President for his signature.

#### Appeal in Cammermeyer Case Heard by 9th Circuit

San Francisco, CA — As In Step went to press, the Ninth Circuit Court of Appeals was to hear the government's appeal of a lower court ruling which allowed the reinstatement of Col. Margarethe Cammermeyer, the highest ranking Gay or Lesbian service member to have been (initially) discharged from the military service.

The entire case is based on the government's pre-Clinton policy against Gays in the military. The government is not actually contesting Cammermeyer's reinstatement —partly because the case deals with the old policy but also, many believe, because of the massive publicity and support Cammermeyer has received. The appeal is limited to the issue of whether it was proper for the district court to go beyond ordering Cammermeyer reinstated to rule that the former policy, as applied to her and on its face, is constitutional.

"It's a real shock to see this happen," Gunkel said. "If it can happen to her, it can happen to any of us. All of us are very vulnerable at times. None of us are exempt from that type of crisis."

Cindy Van Vreede reports that in recent communications with Barber via an online Lesbian bulletin board, "Kitty's latest postings were very witty and upbeat. This seems very out of character for the woman I've been communicating with the last few months."

Van Vreede says Barber expressed excitement about her former partner Karen Gotzler's race for the Third District Aldermanic seat in Milwaukee. "She was very enthusiastic about Karen's campaign and the good she could do at City Hall."

"I hope Kitty makes it. We're all pulling for her." Based solely on her statement that she is a Lesbian, the military discharged Col. Cammermeyer from her position as Chief Nurse of the Washington National Guard on June 11, 1992. Cammermeyer, a Bronze Star recipient with 28 years of service in the Army, Army Reserve and National Guard, filed suit that very day.

On June 1, 1994, US District Court Judge Thomas Zilly, granting Cammermeyer's motion for summary judgment, found that the military ban on Lesbians and Gay men has no rational basis and is rooted only in prejudice. Judge Zilly ordered the military to reinstate Cammermeyer to her former position, prohibited the government from taking any adverse action against her based on statements concerning her sexual orientation, and declared the military's discharge of her and the military's former regulation unconstitutional.

Because the government admits the reinstatement is proper, Cammermeyer will continue to serve regardless of the resolution of the appeal.

#### Judge Upholds Ban on Gays in Boy Scouts

Trenton, NJ — In the latest court decision challenging the Boy Scouts of America's exclusion of Gays from the ranks of Scout leaders, a state judge in New Jersey cited the Biblical tale of Sodom and Gomorrah in his ruling that the ban does not violate New Jersey's law prohibiting sexual orientation discrimination.

In the November ruling, Judge Patrick McGann wrote that it is "unthinkable that in a society where there was universal governmental condemnation of the act of sodomy as a crime, that the BSA could or would tolerate active homosexuality if discovered in any of its members."

McGann found himself in a contradiction, however, because New Jersey itself does not prohibit sodomy. He rationalized in this way: "The criminal law has changed. The moral — as to the act of sodomy — has not."

"Sodom is derived from the name of the Biblical city, Sodom, which, with the nearby city of Gomorrah, was destroyed by fire and brimstone rained down by the Lord because of the sexual depravity of their male inhabitants," the judge said.

Many Biblical scholars disagree with this interpretation of the story of Sodom and Gomorrah, and legal experts expressed outrage that Judge McGann would use it as justification for a legal decision about a discrimination case. The New Jersey case was brought by James Dale, an Assistant Scout Master and former Eagle Scout, who was fired from his position with the Monmouth County Boy Scout unit in 1990. He is being represented by the Lambda Legal Defense and Education Fund. Lambda plans to appeal McGann's ruling.


#### P-FLAG Under Attack for Hard-Hitting Ads

Washington, DC — Hard-hitting public service ads about the horrors of Gay bashing and Gay teen suicide, sponsored by Parents, Families and Friends of Lesbians and Gays (P-FLAG), have elicited outrage by fundamentalist leaders and threats of legal action against any broadcast stations which run the ads. The two 30-second spots were created by P-FLAG for its "Project Open Mind" campaign. Controversy has raged because the ads intersperse images of a Gay bashing and (simulated) suicide attempt with the image and words of fundamentalist ministers Pat Robertson and Jerry Falwell.

In one of the ads, Robertson is heard saying, "Homosexuality is an abomination...The practices of these people is [sic] appalling...Many of those people involved with Adolf Hitler were satanists; many of them were homosexuals. The two things seem to go together. It is a pathology, it is a sickness." Falwell says: "God hates homosexuality."

Immediately after the ads first appeared, attorneys for the Christian Broadcasting Network, owned by Pat Robertson, sent a letter to the general managers of TV stations across the country, telling them that the P-FLAG spots contain potentially defamatory material against Robertson and threatening legal action if they are run. As a result, P-FLAG reports, numerous stations have since rejected the ads. In addition, Nancy Rodriguez, the mother of a murdered Gay man who speaks in one of the ads, was apparently fired from her job because of her involvement. She has filed a complaint with the Georgia State labor Board.

Sandra Gillis, the Executive Director of P-FLAG in Washington, DC told the **New York Times** the purpose of the hardhitting ads: "Mainstream Americans are not an intolerant lot. They don't realize the level of abuse and violence against Gay and Lesbian people. [The message is] Watch your words. They can create a climate in which violent people think their violent action is OK."



## More Gay Leaders Are Lost to AIDS

Beverly Hills, CA — Two more leaders of the Gay community succumbed to AIDS complications in November. Gay philanthropist Bruce Decker, 45, died at his home in Beverly Hills November 11, and New York activist Steven Powsner, 40, died in his Manhattan home November 20.

Decker was very active as an openly Gay man in Republican Party circles throughout the 1980's. He served as President of the GAY GOP group Concerned Americans for Individual Rights.

Decker was also deeply involved in AIDS issues. He helped found a number of AIDS research organizations, including the American Foundation for AIDS Research and the Health Policy and Research Foundation of Los Angeles. He also served as a consultant to a number of pharmaceutical firms working to develop anti-AIDS therapies. In 1986, he was financial coordinator of the champaign which defeated Proposition 64, an initiative that would have required the quarantine of all people with HIV in California.

Powsner was a founder and former President of the New York City Lesbian and Gay Community Services Center. An attorney, Powsner successfully negotiated with the city to obtain the old Food and Maritime Trades High School on West 13th Street where the Center has its headquarters today. Powsner is also responsible for initiating the two and a half mile lavender line that stretches along Fifth Avenue, marking the route of the annual Gay Pride Parade.

#### Gay Church Banned From Key West Parade

Key West, FL — Organizers of the annual Christmas parade in Key West have stirred controversy with their decision to ban a predominantly Gay church, the Metropolitan Community Church, from participating in the event. The Christmas parade is organized each year by the Lower Keys Ministerial Association. The 120-member MCC has not joined the parade in years past, but its spokesman, the Rev. Steven Torrence, told the New York Times: "I thought it was time for us to be in this community parade. We had a wonderful float."

The parade chairman, the Rev. Gary Redwine of the Big Coppitt Baptist Church, had other ideas, however. In rejecting the MCC's application, he sounded a call that has become almost cliche among fundamentalist Christians: "If's not that we hate homosexuals or anything. We just don't agree with homosexuality and we can't condone the homosexual lifestyle." Key West has a large and vocal Gay and Lesbian population, and the decision has been greeted with anger by them and their many allies. The Grand Marshal, the mayor of Monroe County, withdrew from the event as did several other churches and numerous politicians and local celebrities.

"I think it is hypocritical on the part of the association," said Key West Mayor Dennis Wardlow. "Key West is a very tolerant town. We've always had a live-andlet-live feel. We're all God's children; we're all created equally."

#### Sharon Bottoms Re-Files for Custody of Her Son

**Richmond, VA**—Sharon Bottoms, the Lesbian mother who was denied custody of her own son by the Virginia Supreme Court because her Lesbianism allegedly made her an "unfit" mother has filed a new petition for custody.

Attorneys for Bottoms say the new attempt to regain custody of 4-year-old Tyler Doustou is based on conditions that have changed in Bottoms' home life and that of her mother, who won custody of the boy.

The new petition says that while Bottoms is still a Lesbian, she has now lived in a stable relationship for several years, has a steady job and has maintained a stable residence. This is in contrast to her mother, Kay Bottoms, who has moved into a mobile trailer and has sometimes been without running water. The rationale of the courts had been that Kay Bottoms could provide Tyler with a more secure home.

The petition also charges that Kay Bottoms, in violation of the previous court agreement, has denied visitation to her daughter on 23 occasions. The petition seeks a contempt order. An attorney for Kay Bottoms has countered that Sharon has violated the agreement by allowing Tyler to see her lover, April Wade, at their home.

A spokeswoman for the Lambda Legal Defense and Education Fund said the outcome of the new petition would be a good barometer of how the court feels about all the non-Lesbian-specific issues around this custody case.

#### House Members Protest Invocation by Lou Sheldon

Washington, DC — Twenty-two members of the US House of Representatives have sent a letter to Speaker of the House Newt Gingrich protesting his decision to allow the Rev. Lou Sheldon, leader of the anti-Gay Traditional Values Coalition, to deliver an invocation on the floor of the House in November.

In his prayer, Sheldon said: "Loving and living God, we greet you in the name of Jesus Christ...Please convert out hearts to believe and obey your ways as taught in the Holy Scriptures. May we learn from your Holy Word what is morally right and morally wrong. May we come to fully understand that the nation whose God is the Lord is the Nation that shall be blessed."

The letter to Gingrich referred to Sheldon as "a man who has made a career out of vilifying Gays, Lesbians and persons with AIDS" and accused him of "promoting fear and intolerance."

"We are concerned," the members of the House write, that "in a Congress in which members of the leadership have used anti-Gay slurs and others have called Gays and Lesbians "disgusting and revolting," Rev. Sheldon's presence only legitimizes such attacks and encourages further displays of hate."

"At a time when this country is in deep need of leadership that will heal divisions, we object to you providing a national pulpit to an individual who embraces a divisive, homophobic and sexist agenda aimed at tearing this country further apart. We strongly urge you not to provide bigots like Rev. Sheldon with an official platform in the House of Representatives in the future."

The letter's signatories included: Reps. Barney Frank (D-MA), Patricia Schroeder (D-CO), Richard Durbin (D-IL), Patsy Mink (D-HI), John Lewis (D-GA) and Tom Foglietta (D-PA). All were Democrats.

#### Disney Stands Firm on Partners Benefits

**Orlando, FL** — The Walt Disney Company is standing firm on its recent decision to extend health benefits to the partners of Gay and Lesbian Disney employees in the face of mounting criticism from the Religious Right.

One of the first volleys came from Rev. Lou Sheldon of the Traditional Values Coalition. "With the understanding that the homosexual agenda has penetrated Hollywood, it should come as no surprise that Disney now supports antifamily values," Sheldon opined. "Disney is no longer Walt Disney; it is a secular, anti-family corporation."

A group of Florida lawmakers then jumped on the bandwagon, calling the partners policy "a big mistake both morally and financially" and asking, "We wonder what Walt Disney himself would think of your decision if he were alive today?"

Most recently, the Florida Baptist Convention passed a resolution at its annual meeting condemning Disney and saying the company's "moral leadership has been eroded." The American Family Association, also based in Florida, is also threatening a boycott of Disney movies and products.

"We made this decision because it brings our health benefits in line with our corporate non-discrimination policy," Disney spokesman John Dreyer said. "We regret that people are offended by a decision to provide health care to our employees."







# Letters MAP: "A Bitter Disappointment"

#### To the Editor:

RE: Article in the 11/9/95 issue, "MAP promises action..."

Because of other responsibilities, I was not aware of the November forums regarding dissatisfaction with Milwaukee AIDS Project but I would like to add my voice to those expressing a need for reform.

My partner died from complications of AIDS, November 18. By August, it was becoming apparent that we would need assistance if he was to remain at home during his final months. Confident that an agency which we had supported consistently over the years and one geared to the needs of persons with AIDS would be there when we needed their services, we called MAP. Repeated calls to my partner's case manager resulted in responses of "I'll look into it" to "We don't have any volunteers available." No information about other sources of assistance was provided. In most instances our calls were not returned, but we kept trying. In August, now confined to a wheelchair, we began asking about facilities for care and were told to look into Wisconsin House which was, we were told, wheelchair accessible. We drove there and discovered a flight of concrete steps with no elevator in sight and it was obvious the facility and staff were not geared for taking care of non-ambulatory patients. The case worker either didn't know what the facilities were or didn't care.

By October 15th, I had come home from work more than once to find him lying on the floor, unable to reach the telephone. Still no assistance from MAP. Desperate for any help, I called his case manager to find out how we could get him admitted to a nursing home, which one, and who to talk with regarding paying for it. I was given the name of one home, which didn't have an opening, was given no information about hospice facilities (to this date I don't know if MAP supports one or even knows of others friendly towards people with AIDS), was told to call the national Social Security hotline for information – which was not correct since Milwaukee County Social Services handles nursing home matters under the Medicaid program – and that "You can always take him out to County Hospital and leave him there. They have people trained to expedite that sort of thing."

A totally insensitive, uncaring and uninformative response.

A friend recommended contacting St. Camillus. I explained the situation to them. Within a week, their nursing director and social worker made an in-home evaluation; explained the Medicaid program and its application to us; and had organized a team of volunteers from their staff to come in during the day while I was at work, until a bed opened in their facility.

The first of this month, I canceled my monthly payroll deduction assigned to MAP and I will no longer support or recommend their services. It appears to me that they are not serving the needs of the community in the most basic of ways. Their inability to provide ANY useful information or assistance in our time of greatest need was a bitter disappointment.



# Beware of the Gay Marketeers! Some Studies Offer Bogus Facts on LesBiGay Community

If voters continue to defeat statewide anti-Gay initiatives, as they have in elections since 1992, it will be no thanks to Gay marketeers who promote a jet-setting image of the Gay community. Consider a recent mailing that solicited advertising for a Gay event in St. Louis. Enclosed with the solicitation was a rainbow-colored insert that called our community "The Dream Market." It declared that, compared to the average American household, Gay households have over \$23,000 more income, travel abroad almost five times as often, and are frequent flyers almost 14 times as often.

The problem is that these claims are based on mail-in responses to an unscientific non-random survey inserted in eight select Gay newspapers by the Simmons Market Research Bureau in 1988, not on an academic analysis of the income and spending habits of Gay and Lesbian households. As Lee Badgett, Assistant Professor of Public Policy at the University of Maryland, points out in an article published in the July, 1995 issue of the Industrial and Labor Relations Review, the respondents to the survey were disproportionately white, urban, and well-educated. Moreover, 86% of the respondents were men.

A July 18, 1991 Wall Street Journal article on corporate advertising in the Gay community quoted the figures collected by the 1988 Simmons survey as scientifically accurate "facts" about Gay households. The 1991 **Journal** article has, in turn, become the "authority" for the type of nonsense included in the St. Louis advertising solicitation.

#### **CONFLICTING EVIDENCE**

Dr. Badgett's own scientific study of the economic status of Gay men and Lesbians arrived at conclusions that were directly contrary to the Simmons survey. Dr. Badgett analyzed data contained in the 1989-1991 General Social Survey, which was a national random sample conducted by the National Opinion Research Center. She compared data for persons who said they had had one or more samesex partners since age 18, with data for those who denied having had any such relationships. Her statistical analysis found that Gay and Bisexual men in similar occupations and with similar educational levels as heterosexual men earn, on the average, considerably \*less\* than heterosexual men, between 11% and 27% less. The data for Lesbian and Bisexual women indicate that they also may, on the average, earn less than heterosexual women with comparable occupations and education, but those findings were not statistically significant.



As Dr. Badgett notes, no survey of Gay men, Lesbians, and Bisexuals will be completely accurate. Not all persons interviewed will disclose honestly their sexual behavior, even when researchers assure confidentiality. Although analysis of data in the National Social Survey therefore cannot result in an absolutely accurate picture, it is far more reliable than reporting the results from surveys of readers of Gay newspapers! The most that such marketing surveys show is the demographic characteristics of a certain subset of the Gay community - those who happen to read the newspapers surveyed and who choose to respond to survey inserts.

The scientific soundness of conclusions about the Gay community derived from such marketing surveys is as valid as it would be to draw conclusions about all Christians in this country by surveying only those Christians who respond to questionnaires contained in publications of Christian right-wing groups such as Focus on the Family.

Gay marketing hype may sell the Gay community to corporate America, but it does so at a heavy price. As Amy Gluckman and Betsy Reed pointed out in the November/December, 1993 issue of Dollars and Sense, an economic affairs magazine, solicitations based on the marketing surveys whitewash the Gay community, covering up its diversity. The selling of the Gay community to corporate America also implies that Gay men and Lesbians are valuable only as consumers, insinuating that those without purchasing power are unworthy of concern. Most importantly, the radical right, in its campaigns against civil rights protections for Gay men and Lesbians, has seized gleefully on the bogus data promoted by Gay marketeers.



# FDA Approves Three New AIDS Drug Therapies

Washington, DC — Last month the Food and Drug Administration (FDA) approved the use of three new drug therapies against AIDS: **3TC** or Epivir, produced by Glaxo Wellcome; **d4T** or stavudine/Zerit, created by Bristol-Meyers-Squibb; and **Saquinavir** or Invirase, manufactured by Hoffman-La Roche.

The three drug makers received accelerated approval for the marketing of their anti-AIDS medications after their applications were given the green light by the FDA's Anti-Infective Drugs Advisory Committee in November.

The approval allows drugs to be marketed when studies have shown promising signs of usefulness, but when definitive information on safety and efficacy is not yet available. The manufacturers are required to proceed with more definitive studies and to reapply for full approval.

The FDA approved 3TC for use in combination with the already-approved drug AZT. In clinical trials among individuals with advanced HIV disease, 3TC in combination with AZT helped to increase the patients' CD4 "helper" cells cells needed to fight HIV infection — and reduced, in some cases significantly, levels of HIV in the blood. 3TC with AZT seemed to be even more efective in patients who had never taken AZT before.

"The real significance of this combination," said a key researcher of the 3TC/ AZT approach, "lies in its potent and sustained anti-viral effect."

Glaxo-Wellcome has no plans, however, to evaluate the effectiveness of 3TC in people at early stages of HIV infection.

The second drug to receive accelerated approval, d4T, is intended for patients after they have concluded AZT therapy, either because of severe side effects or its ineffectiveness. The drugs d4T and 3TC are known as *nucleoside analogues*, drugs that aim to inhibit an enzyme in HIV called reverse transcriptase, which aids in viral reproduction.

Saquinavir, which will go by the brand name Invirase, is one of a new group of *protease inhibitors* which, in studies, have been shown to block another enzyme that is critical to the successful replication of HIV. At this time, Invirase can only be used in combination with other anti-AIDS drugs, not alone as a sole therapy.

FDA Director David Kessler said the most promising area of AIDS drug re-







search was such combination therapies which can hopefully provide a "one-two punch" against HIV.

The Treatment Action Group (TAG), an AIDS advocacy organization, praised the FDA for giving accelerated approval to the drugs, but appealed to the drug companies to keep the cost of the new drugs within reason.

Glaxo's wholesale price for the amount of 3TC needed over one year by a patient is about \$5,000. The retail cost is expected to be much higher still.

TAG's Peter Staley commented: "In a time of unprecedented cutbacks to the reimbursement programs upon which most people with HIV depend, it is critical that manufacturers price their new drugs at affordable levels."

Each of these three new drugs should be available before the end of the year. Consult your physician for further information and advice.

#### Thalidomide Effective for AIDS-Related Mouth Ulcers

Washington, DC — Thalidomide safely and effectively heals severe mouth ulcers in persons with HIV infection, according to an interim analysis of data from a study supported by the National Institute of Allergy and Infectious Diseases (NIAID).

The study, sponsored through NIAID's AIDS Clinical Trials Group, compares the safety and effectiveness of thalidomide with placebo for treating patients with severe oral and esophageal ulcers. In the second or maintenance phase of the study, doctors are evaluating thalidomide's ability to prevent recurrences of ulcers in the mouth or the esophagus.

As a result of the findings, current and newly-enrolled study participants with oral ulcers will all receive open-label thalidomide rather than being randomized to receive either placebo or drug. Patients with esophageal ulcers will continue to be randomized. The maintenance phase of the study will continue as planned.

"Many patients with HIV infection suffer from these extremely painful mouth ulcers, making eating difficult and contributing to weight loss and debilitation," said Dr. Anthony Fauci, Director of NIAID.

"Thalidomide is the first treatment shown in a rigorous scientific study to heal these ulcers. As the study continues, we anticipate additional valuable information about the drug's effectiveness and long-term toxicity." (Thalidomide is known to cause malformations in infants born to women taking the drug.)


#### A BOOMERANG EFFECT

For example, the October 27 Washington Blade reported that Carolyn Cosby, the founder of Concerned Maine Families, and lead organizer of Maine's anti-Gay initiative, Question One, made the supposed wealth of the Gay community one of her four key arguments in support of Question One in an October 10 debate. She deftly combined the stereotype of the rich Gay person with "no special rights" rhetoric, arguing that highincome Gays are demanding "special protections." Likewise, the Gay Rights, Special Rights video, which the radical right circulates nationally, argues that Gays are not disadvantaged, because they have no need for civil rights protections. Granted, the economic status of Gay men and Lesbians as a group is not relevant as to whether or not civil rights laws should prohibit sexual orientation discrimination. Thus, even if the average Gay man and Lesbian were as well-off as Gay marketeers and the right wing pretend, that still would not justify discrimination based on sexual orientation.

But in the battle over civil rights protections based on sexual orientation, it will be hard to get heterosexuals riled up about discrimination against a group marketed as having all the economic advantages. It will be especially difficult to get the sympathy or votes of those in the uncommitted middle, when many American households are worse off than they were a generation ago.

As economic stress increases in the country, so will scapegoating. Demagogues are playing on the stereotype of wealthy Gay men and Lesbians flying around the world, whipping up powerful resentment against the Gay community. It is disheartening to know that myths promoted by some segments of the Gay community are among the arsenal that the scapegoaters are using in their attacks on the Gay and Lesbian community.

# Books Top Gay/Lesbian Nonfiction Titles of 1995

Perhaps even more so than has been the case with fiction, Gay and Lesbian themed nonfiction has especially flourished over the past twelve months. Virtually stealing all of the spotlight this fall were two "virtual" titles: Andrew Sullivan's Virtually Normal (Knopf, \$22) and Virtual Equality (Anchor Books, \$24,95) by Urvashi Vaid. By Carl M. These dueling "virtual" books both focus on the future of the Gay rights movement but from decidedly different points on the political spectrum. Andrew Sullivan's position as editor of **The New Republic** virtually guaranteed widespread mainstream media coverage of **Virtually Normal**.

Far more controversial, particularly



within various areas of the Gay and Lesbian community was Vaid's, Virtual Equality. As a former Executive Director of the National Gay and Lesbian Task Force, Vaid has written a book that is a virtual call to arms to the Lesbian and Gay community to begin the work necessary to achieve not "virtual" but genuine equality with the rest of America.

Sadly not televised by Milwaukee's Public television outlets is the widely acclaimed The Question of Equality, a wonderful, thoroughly researched four-part series chronicled Lesbian and Gay politics in America since Stonewall. Still, a companion volume to the series, likewise titled, **The Question Of Equality** (Scribner, \$35) is available featuring many rare photographs and essays by lewelle Gomez, Mab Segrest, David Deitcher (who also serves as the book's editor) and Dale Peck.

The season's most controversial title is not specifically a Gay or Lesbian title: **The Gravest Show On Earth** (HoughtonMifflin, \$24.95) by Elinor Burkett. In this behind-the-scenes portrait of America in the age of AIDS, Burkett has shown a bright, often harsh and occasionally very critical light on those individuals and organizations fighting the war against AIDS.

At 635 pages, Out In All Directions: The Almanac of Gay and Lesbian America (Warner, \$24.95) is chock-full of fascinating facts and figures in any and every aspect of Gay and Lesbian life. The book's trio of editors' fabulous finds include the complete list of Lambda Literary Award-winners, 10 Lesbian and Gay Military heroes, and a Gay Psychokiller Hall of Fame, to name just a few. A perfect gift idea.

The biography/autobiography shelves in Gay and Lesbian bookstores overflowed this year with a surprising roster of subjects including the usual celebrity suspects.

The Gay bestseller honors from any category during the year certainly must go to Olympic Diving Champion Greg Louganis with his remarkable story in



RuPaul told all in her book Lettin' It All Hang Out.

Breaking The Surface (Random House, \$23), with Eric Marcus.

In Lettin' It All Hang Out (Hyperion, \$19.95), a kiss & tell (with appropriate make-up tips, naturally) biography from "Supermodel of the World" RuPaul, highlighted summer-reading doldrums. Interspersed throughout the text are rare and previously unseen photographs. A must for all RuPaul fans!

Boy George's Take It Like A Man (HarperCollins, \$22.50) might also be categorized as a "celebrity bio," but unlike Lettin' It All Hang Out, Boy tells his story of the price of fame with surprising, often shocking candor. A remarkable life told in an equally remarkable book. Highly recommended.

Equally candid is a memoir from Gore Vidal, **Palimpsest** (Random House, \$27.50). With the likes of the Kennedys, Eleanor Roosevelt, Tennessee Williams and the Duke and Duchess of Windsor amongst many others crossing his path, Vidal portrays his fascinating life intermixed with mediations on writing, history and politics.

In Favored Strangers: Gertrude Stein and her Family (Rutgers University Press, \$34.95), Linda Wagner-Martin looked beneath the usual Stein legend to create a fresh new look at Gertrude Stein as a part of her family growing up and also of her and Alice B. Toklas's survival during the second World War.


Of the many other dazzling biographical works that emerged in 1995, a handful of others also merit special mention. Writer, activist and artist Kate Millett has written an engaging memoir, **A.D.** (Norton, \$25), a book about education and art and politics – and about being Gay in the 1950's.

In a book that is part memoir and part performance, Dancer/AIDS activist Bill T. Jones chronicles his incredible life in Last Night On Earth (Pantheon, \$35). In John Preston's last book, Winter's Light (New England University Press, \$19.95), he reflects, with great eloquence, on his search for home, in the small town of Portland Maine. Perhaps the most unique biography of the year is the amazing I Am My Own Woman (Cleis Press, 10.95), a look at the life Charlotte von Mahlsdorf, a transvestite who lived openly in Berlin during World War II.

These are just a small selection of wonderful Gay and Lesbian reading to pass many a cold winter's night!

# Film Writer Finds "Entrenched Homophobia" Surrounding "Total Eclipse"

#### **Interviews Denied to the Gay Press**

#### By Dale Reynolds

(ED.NOTE: Dale Reynolds has provided In Step with many excellent film features over the last few years. Here he comments on an experience he had trying to pursue an interview with Leonardo DiCaprio, who plays the French Gay writer Rimbaud in the Fine Line release Total Eclipse. In the movie, DiCaprio plays opposite David Thewliss as Paul Verlaine.)

This journalist became involved in the marketing of the film *"Total Eclipse"* in a most unfortunate manner. I became aware of the film when it wrapped in late Spring of 1995 and the first information on it went out to the Hollywood trade papers. I had a friend connected to the shoot and he gave me some background on the director and DiCaprio. At that time, all the Gay press, including myself, began the usual search for stories by calling FineLine, which was releasing the film in America, the producers in Paris before that, and DiCaprio's public relations firm in Beverly Hills, Baker/Wynokour/Ryder.

My initial phone call to B/W/R was met with a curt, "Call in late June." When contact was made at the beginning of the summer, this journalist was told – as were all the others – that DiCaprio would not be granting interviews with any of the Gay press. No explanations were given, other than since it wasn't a "Gay film" there was no need for him to talk to us.

I countered that with the sexual situations involving two men on screen, in the buff, this was indeed a Gay film, pressing the public relations woman as to what, in her opinion, would constitute a "Gay film?" She had no answer. I explained that as the reputations of Rimbaud and Verlaine as a Gay couple made them something of an icon to the community, that made the film a big one for us.

She countered that it wasn't a big film, it was a little arthouse movie which wouln't make any money. After a long pause, I realized that she was not working for "Total Eclipse", but rather for Leonardo DiCaprio, and that she was prepared to let the film sink.

In some anger and frustration, I called the American distributors, Fine Line, in New York and repeated our phone call conversation. Then she sent me a letter threatening a slander lawsuit from B/W/R if I continued to repeat my story to outsiders, a story she fully denied having had a part in, accusing me of manufacturing the conversation as an "unethical" way to retaliate for not getting an interview with their young client.

Fine Line then refused to cooperate with me, refusing a picture of DiCaprio, even, as my story (at that time for my Australian outlet, **Outrage**) wasn't authorized. Both the subsequent public relations firms handling the film and the director have expressed bewilderment to me as to the tactics of the PR flack at B/W/R.

I repeat all this to put the experience into some kind of perspective. No journalist should knowingly put him- or her-self into a story; there is a demand for objectivity on our part. Fortunately for me, I found the film superb in its execution and, as is usual with the work of Agnieszka Holland, sensitive to the material. She has elicited excellent performances from her cast and a period-right feel in the cinematography.

But the fact remains that as a result of B/W/R's perceived homophobia in dealing with the national Gay press, no interviews with DiCaprio have been granted, except for a short telephone conversation with **OUT** Magazine, limited expressly to questions about co-star Thewliss and director Holland, and not about Gays. The national **Advocate** has refused to do a story as a result and Los Angeles' **Frontiers** took it off the cover. potentially hurts the chances for this \$8 million dark and sensuous film to do the business it could otherwise have done in America.

While no one has been willing to talk for the record on the rebuffs, it was always my feeling as a critic that the film itself is too strong, too artistic, and too damn good to be jettisoned simply because of the entrenched homophobia of either the actor himself, his manager/parents, or a stultified system which doesn't choose to recognize that we Gay folk are a potent force in the Entertainment Industry today.

The last scene had them cuddling on the bed, watching the church service on TV.



# HIV DRUG TRIALS OPEN FOR ENROLLMENT

#### WISCONSIN COMMUNITY-BASED Research consortium (WCRC)

The WCRC is currently enrolling individuals with HIV disease for participation in two trials of experimental drug therapies. These trials may advance scientific knowledge and future treatment for other individuals with HIV disease.

#### TRIAL NO. 1 - DELAVIRDINE

This is a double-blind, randomized study. The study compares the responses of individuals taking a combination of Delavirdine (DLV) and Didanosine (ddI), or placebo and ddI.

#### ELIGIBILITY:

If your are fourteen years of age or older, are HIV positive, have a CD4 count of 50 to 300, have previously been on AZT and have not been on ddI therapy for more than four months, you may be eligible for this study.

#### TRIAL NO. 2 - DELAVIRDINE

This is a double-blind, randomized study. The study compares the responses of individuals taking varied doses of Delavirdine (DLV) and Zidovudine (AZT), or placebo and AZT.


#### ELIGIBILITY:

If your are fourteen years of age or older, are HIV positive, have a CD4 count greater than 200 but less than 500, and have not been on AZT therapy for more than six months, you may be eligible for this study.


I remember when I first came out back in 1982. Having graduated as a straight girl from the Sheriff's Academy in May, by my 21st birthday in June I was celebrating as a baby dyke at the nowdefunct Sugar Shack. That was followed in August by my parents' very ugly divorce, and then came the Holidays. I dreaded them.

#### NO "HOME" TO GO BACK TO

We had always been a very familyoriented group, celebrating all together and at home, even during the previous few years when my father had been living in his own apartment and I had recently moved to my own. Now, my mother and little sister had moved out of state, and my brother, my dad and I were in our own apartments. The house had been sold as part of the divorce settlement, and there was no "home" to go back to. On top of that, my mother was no longer speaking to me, one of the main reasons being my newly discovered sexuality.

My dad, brother and I managed that year to have some kind of lame get-together. It must have been bad, because I don't even remember it. Later, my sister moved back to Milwaukee and my dad got remarried, so there were more of us to celebrate with combined families. Then I got involved with someone and had my own stable place, and my mother began speaking to me again. But in between, I suffered miserably for years through the "Het Holidays."

I would spend them alternately feeling awkward and uncomfortable as I made the requisite appearances with my blood family, then feeling desperately giddy as I later sat relievedly on a barstool, sharing family horror stories with my Lesbian and Gay family. We truly were family then, bound by mutual feelings of sadness over lost innocence intertwined with the frightening yet power-



ful realizations we had made about ourselves. We missed the comfort of the old days, but their ignorant bliss had enslaved us to false lives of deceit and selfdelusion.

Secretly, I was devastated. My family has always been unfashionably important to me, and I knew things could never be the same. My mom was rather a fundamentalist (albeit a hypocritical) Christian, and while my dad was with her, he remained quite conservative. But now Mom was far away and Dad was beginning a new life of his own, so he became more open to new possibilities.

#### A NEW FAMILY

His second wife is an open and accepting human being, and (unlike my mom), a truly enlightened feminist. Before I began, I suggested that it be offered to Whomever or Whatever the collection of pagans, orthodox Christians, and unorthodox spiritualists deemed appropriate in their own hearts:

"We offer thanks for the blessings before us. We are grateful for the families we were born with and the ones we have made; for the friends we were given and those we have chosen. May all our blessings help us to be more loving, caring and productive human beings, and to reach out to those whose blessings are few."

May you all be truly Home for the Holidays, whomever or wherever that may be.


## Jock Shorts John Cowles Volleyball League Begins Season
