

## Hawaii OKs Benefits for Gay Couples

Honolulu, HI — A six-year battle that began with gay and lesbian couples demanding the right to marry is coming down to a governor's signature that will make Hawaii the first state to offer benefits to couples who aren't allowed to wed.

Gay and lesbian couples still can't marry — indeed, part of a legislative compromise would firmly bars this option. But reciprocal benefits that also apply to cohabiting couples such as a widow and an adult son to siblings or to roommates have been won.

With Gov. Ben Cayetano saying he will sign the measure, dozens of couples have already mailed in applications seeking spousal benefits such as medical insurance and state pensions, inheritance rights, and the right to sue for wrongful death.

Among them were Joseph Melillo and his partner of 20 years, Pat Lagon, one of the three couples who filed the lawsuit that started the issue on its contentious path.

"Something good did happen out of this (lawsuit)," Melillo said. "Albeit, not the outcome we would have liked to have, but for some people this will benefit them in the interim until we get our marriage legalized."

That legalization, however, could be even more out of reach.

Their lawsuit led to a Hawaii Supreme Court ruling in 1993 that it is unconstitutional to deny marriage licenses to same-sex couples.

The state Legislature answered that with a compromise: it passed the benefits law, along with a proposal that would negate the Supreme Court ruling by putting a specific ban on gay marriages right in the state constitution.

The constitutional amendment will be put to the state's voters; public opinion polls have shown that more than 70 percent of the voters oppose legalizing same-sex marriages.

The first to put in their application for benefits under the new law were Robie Lovinger and her partner Louise Esselstyn, who recently celebrated their fourth anniversary. They put a framed copy of their application among photos of their commitment or "wedding" ceremony.

"When we get our certificate, we'll certainly frame that, too," said Lovinger.

Coverage under the benefits measure isn't universal.

"People are calling us wanting to sign up their grandchildren and boyfriends and are questioning why they can't," said Patrick Johnston, spokesman for the state Department of Health. "They want the benefits, but don't necessarily want to get married."

A business group, the 30-member Hawaii Business Health Council, had urged the governor to veto the bill, saying not enough is known yet about how it will affect the economy, especially medical insurance costs for businesses.

The group complains that the measure could be used to give any two adults easy access to insurance, particularly for people with terminal diseases such as cancer, and they say it could force some businesses to reduce their individual insurance coverage to pay for an increased client load.

The state expects 20,000 to 40,000 homosexual couples to apply for benefits over the next three months. But as of last Thursday, only 100 applications had been picked up, and it was not known if all of those were for homosexual couples, Johnston said.

Some gay and lesbian couples say they won't apply for reciprocal benefits until they can get all the same benefits offered to married couples, such as divorce, child custody, and joint income tax filings.

"After this (reciprocal benefits) law, people will see the world didn't come to end or stop; their world hasn't changed. They'll wonder why we are denying them the rest of their rights?" Melillo said.

## Court Overturns 'Don't Ask, Don't Tell'

Brooklyn, NY — U.S. District Judge Eugene Nickerson said the Pentagon's socalled "don't ask, don't tell" policy doesn't simply discriminate against homosexuals in the nation's armed forces, it also violates their First and Fifth Amendment rights of free speech and equal protection under the law.

The decision, the first federal court ruling to reject the anti-gay policy as unconstitutional, was a resounding rejection of unequal treatment of gays and lesbians in the armed forces.

In the 48-page ruling (Able vs. USA), Judge Nickerson said, "The plaintiffs are American citizens. They wish to serve their country in positions of responsibility

and potential danger." Armed forces that are "called on to fight for the principles of equality and free speech ... should embrace those principles in its own ranks," the decision declared.

The court decision doesn't, however, strike down the Defense Department policy, said Matt Coles of the ACLU's Lesbian and Gay Rights Project, which brought the suit jointly with the Lambda Legal Defense and Education Fund.

But Coles says the ruling does keep the armed forces from kicking out six soldiers who challenged the policy's constitutionality.

"It also opens the door for striking down the whole policy," said Peg Byron of Lambda.

It is the second time Judge Nickerson has declared the anti-gay policy unconstitutional. In 1995 he ruled that it violated free speech provisions of the constitution, but a federal appeal court later vacated that ruling and returned the case to his court for reconsideration on more narrowly defined legal grounds.

Judge Nickerson's latest ruling contends that the policy is still unconstitutional on more specific considerations, arguing that it violates the due process provisions of the Fifth Amendment by subjecting only gay and lesbians service members to a unique and separate set of behavioral regulations.

The ruling also rejected military prejudices in the case, saying that the Defense Department had made "an outright confession that 'unit cohesion' is a euphemism catering to the prejudices to the heterosexuals."

Judge Nickerson said such historic intolerance of homosexuals was unacceptable


"It is not within our constitutional tradition for our government to designate members of one societal group as pariahs," he wrote.

The Pentagon is expected to appeal Nickerson's ruling.

## Community Grieves Loss of Attorney Thomas Martin

Milwaukee — Thomas E. Martin, a respected Milwaukee attorney and prominent figure in Milwaukee's gay and lesbian community died in late June in what has been officially ruled a suicide. Martin was 47 years old. He is survived by his life and business partner of over 15 years, Gary Swartz, his mother Anna, and brothers Albert and Robert.



Martin died on the early afternoon of Wednesday, June 25th. A single eyewitness, positioned underneath the Hoan Bridge, indicated he saw Martin falling from the bridge at approximately 12:26 p.m. At 12:33 p.m., a Milwaukee County Sherrif discovered Martin's car in the southbound emergency lane of the Hoan Bridge. The right directional flasher was on, the key was engaged, and the engine was running. Martin's driver's license, business card and his therapist's business card were found in the car's ashtray. No suicide note was found, either in the car or at Martin's residence or business office.

According to the Medical Examiner's report obtained by In Step, Martin was recently diagnosed with Bi-Polar Disorder and, according to the report, became "depressed" after the death of his father in March of this year. He was admitted to Columbia Hospital shortly thereafter, and received inpatient treatment for two weeks. Upon release from the hospital, Martin was treated with medication. He resumed work, and continued to consult with a therapist until his death.

Sources close to Martin told *In Step* that after his father's death, he expressed difficulty dealing with work-related stress, and felt frustrated that he wasn't fully utilizing his skills and creativity.

The Medical Examiner's report states that Martin had been "acting strange" in the week preceding his death, and had contacted his therapist during the weekend prior, expressing anxiety and depression. As a result, according to the report, Martin's medications were modified.

On Monday, June 23rd Martin sounded "despondent" but made no mention of suicide when contacted by his therapist.

A family member who spoke with Martin in the days preceding his death indicated that he didn't "sound depressed or confused," and made no mention of suicide. Close friends also stated that Martin made no mention of suicide to them.

Martin, a longtime Milwaukee resident, began his law career after graduating from UW-Madison Law School. He previously graduated Phi Beta Kappa from Brown University. He was named head of the Milwaukee field office of the Organized Crime Strike Force in February of 1980. Prior to that he had worked as an assistant US attorney and, prior to that, had worked for a private law firm.

In a highpoint of his early career, Martin culminated three years of secret investigations with indictments against Milwaukee Mafia figure Frank Balistrieri and his

sons, Joseph and John Balistrieri along with 13 other people.

A highly publicized case in October of 1981, signaled a dramatic shift in Martin's career, when he was arrested for having sexual relations with a boy who Martin subsequently learned was a minor. Press reports from the time indicate that Martin picked up a "male hitchhiker" on September 12, 1981, and the two then had sex at Martin's home. Sources close to Martin stated that he met the youth, after bar closing near the old Factory night club in the Third Ward, in an area well-known for after-hours cruising, and that [Martin] had previously seen the youth frequenting gay bars and clubs.

Subsequent to his arrest, Martin immediately resigned his Strike Force post. After several months of legal wrangling, Martin pleaded no contest to a misdemeanor charge, and his license to practice law was suspended for six months.

"Actually everyone who knew Tom, maintained respect for him after he left the US Attorney's office," Judge Charles Kahn, a longtime friend of Martin's told *In Step*, "No one I know condoned the conduct he was convicted of in a court of law, however ... people always respected Tom, even though he had this awful situation."

Martin resumed his career after the suspension was lifted, and opened a private practice. He shifted his focus to include the general practice of law, specializing in criminal defense, family law, real estate, and estate planning. Early on, he served a large number of clients referred to him by the Public Defender's office and by judges. He maintained a diverse client base with many gay and non-gay clients, and worked with his partner Gary Swartz, a certified public accountant.

"He was a true and a masterful lawyer in general practice," stated Kahn who first met Martin while both attended law school, "Tom was very highly skilled in court, and was an excellent trial lawyer. So, whether it was a traffic ticket or a complicated business transaction, Tom was able to handle himself very well and fight zeal-

ously for his client."

"Like many solo practitioners, he didn't have the luxury to handle big publicity garnering test cases," recalled friend and fellow attorney Tom Zander. "Tom really made a name for himself representing ... ordinary people with ordinary cases. In many, many cases, he represented clients who didn't have representation or money,"

Martin worked on issues of police entrapment and harassment, and was recognized as an expert in that area. He felt that Milwaukee maintained one of the worst records in the country of treating persons arrested for illegal sexual activity, likening local prosecutors' stance on the issue to "killing a fly with a baseball bat."

In recent months, he had worked with The Milwaukee LGBT Police Relations

Task Force, which had begun a dialog between Milwaukee Police Chief Arthur Jones, local law enforcement and community groups.

Jamakaya, longtime journalist covering Milwaukee's gay and lesbian community and *In Step* staffer said of Martin, "My sense is that he was one of the few attorneys in town who went to bat for guys who got entrapped by the police. He went so far as to hold meetings with the D.A. and police officials to try to stop such busts or see that charges were reduced."

Martin had been active in a wide range of community groups for many years. He played a substantial role in the Cream City Business Association (CCBA), the forerunner of the Cream City Foundation (CCF). He was active in the formation of the Human Rights League (HRL) and volunteered services to the Brady East STD Clinic (BESTD). He was supportive of the Milwaukee AIDS Project (MAP), Saturday Softball League (SSBL) and assited other community groups and organizations in obtaining 501(c)3 status. He had recently joined the National Gay Lawyer's Association and was elected to a leadership position with-in that group.

"Tom also spoke at many workshops on gay and lesbian legal issues over the years. I'll never forget one forum on domestic partnership and gay marriage held at the M&M Club back in 1990," Jamakaya recalled, "I think everyone expected a straightforward presentation on legal protections for gay relationships. Tom did that, but he began with a very long and thoughtful lecture asking provocative questions like: Do we really want to emulate the structure of the traditional family, which is currently in a state of cultural collapse and whose heterosexist ideology has been used to oppress us? Why shouldn't the gay community be as innovative in the area of family relationships as we have been in other areas? He took the time to illuminate the complexities of the issue. He struck me on that occasion and many others as a deeply sensitive and intellectual man. His thoughtfulness and hard work on behalf of our community will be sorely missed."

Zander expressed similar thoughts stating, "He felt a real empathy to help the community, and he didn't just do that for people in the gay community, but for people outside the gay community as well. Tom always tried to put a positive slant on things, and felt that was the healthier approach for our community. That there was

no reason for us to be shooting at each other."

Throughout his career, Martin was active policitally as well. He volunteered to help the election of Alderman Paul Henningson and Congressman Jim Moody among others. Recently he had talked of writing a book about what's wrong with the political system in America, and how to fix the democratic process.

"Tom was one of the most thoughtful men I ever had the pleasure of meeting. I think it is important to note the wonderful example he and Gary set for the last 15-1/2 years. They were a wonderful role model for what a [gay] couple should be. Their lives were completely intertwined. It is a tribute to both Tom and Gary."

An estimated 350 persons attended a memorial service on July 1 at Lake Park Lutheran Church on Milwaukee's eastside. Notable attendees included Former Governor John Reynolds, State Attorney General John Doyle, Milwaukee Alderman Paul Henningson, Judge Charles Schudson, Judge William Callahan, US Attorney Tom Schneider, Chief Federal Judge Joeseph Stadmueller, State Senator Lynn Adelman, former Alderman and current Assistant Chancellor at UW-Milwaukee Sandra Hoe-Lyon among many other friends and family members.

## Homophobic Madison Firefighter Gains National Spotlight

Madison (AP) — A black firefighter-clergyman who opposes gays, forced integration and affirmative action wears a T-shirt that proclaims: "Intolerance is a beautiful thing."

Ronnie Greer, 41, has been reprimanded by the

city for his outspoken beliefs on gays.

Greer's lawyer Michael Dean of Waukesha said he plans to take his client's case to Circuit Court or U.S. District Court in a few days, calling the dispute with the city a free-speech issue. The case involves Greer's inability to get along with his Fire Department superiors, assistant city attorney Rick Petri said.

"He's a malcontent," Petri said.

The case "is mainly about the freedom of one's speech in the workplace and the freedom to hold and voice one's beliefs," Greer said during a Wisconsin State Journal interview at his home in Fitchburg.

"This whole story is nationwide news except in Madison," he said, referring to the attention it has attracted from Christian conservatives.

The Virginia-based Rutherford Institute has helped pay his legal bills. World, a Christian magazine, recently featured him on the cover, wearing a Fire Department shirt and a gag in his mouth.

Greer, an ex-Marine who was born in Tennessee, is a preacher for the 30-member Trinity Evangelical Fellowship that meets in an elementary school.

He was suspended from work in June for two months without pay after distributing an anti-homosexual pamphlet at a Madison fire station.

The literature calls homosexuality a "filthy scourge" and recommends employment discrimination against gays and lesbians, blaming them for diseases and child molestation.

"All homosexuals will spend eternity in the lake of fire if they refuse to repent their abominable acts,"

it say

The Madison Police and Fire Commission decided June 25 that Greer's distribution of the pamphlet violated department policy against workplace harassment.

He gave the pamphlet "only to individuals who had asked for it or who were involved in conversation with me. It was never given knowingly to anyone who is homosexual," Greer said.

Dean accuses the city of a double standard by allowing magazines and calendar pictures in fire stations that would offend Christians.

"There have been for years and years and years what are called smut lockers," Dean said. "Ron is not asking that those be removed. He understands that you have to have tolerance in the firehouse.

"Nor is he asking that firefighters stop their profanity or blasphemy or filthy language. He is merely asking that the rules be applied fairly."

Greer said: "Over the years, I've known a number of people on the job who thought black people were dumb or they don't like 'niggers.' My feeling is that's your business so long as you don't get in the way of my doing my job."

The commission calls Greer's "record of discipline to be uniquely abysmal and disheartening."

Greer, who has been with the department for 17 years, has had encounters elsewhere. After attending Custer High School in Milwaukee and joining the Marines, he spent 18 months in federal prison for attempting to kill a white officer.

The "angry, racist young man" met an evangelist in prison and decided to "dedicate myself and the rest of my life to the Lord," he said.

Married with three sons, he left Madison's Mount Zion Baptist Church as an associate pastor two years ago because of disagreement over his anti-homosexual views.

When his new congregation sponsored a speaker last year who declares much of Nazi Germany's leader-ship was gay, about 20 people came to listen and about 200 showed up to protest.

The activist group, Lesbian Avengers took credit for putting about 60 pink triangles on the Greers' lawn.

DeEtte Tomlinson, executive director of The United, a privately and publicly funded group that

serves Madison's gay community, says Greer provides a benefit.

"He's made a difficult and controversial issue very public and that's a good thing," Tomlinson said. "That's when debate happens; that's when people learn and that's when bridges are built."

### Madison Gay Judge Says Honesty Helped Him Excel

Madison (AP) — A Madiosn judge stricken with cancer says he went through much of his education and a four-year Navy tour before coming to terms with his own homosexuality.

"I grew up in a small town in Canada with traditional values," 53-year-old Judge George Northrup told The Capital Times. "My concept of a gay person was the stereotype, someone who was very effeminate, who cross-dressed.

"So although I knew I felt an attraction to men, I didn't identify myself as homosexual," he said.

Over 24 years, Northrup has been a Dane County prosecutor, court commissioner and finally a judge. Now he is dying of mesothelioma — a rare and nearly always fatal cancer of the chest lining and abdominal cavity.

He no longer presides in the courtroom but stays employed, handling court paperwork. Witnessing his partner of 21 years die of AIDS has helped him prepare for his own death, the judge said.

Northrup said his cancer is not AIDs-related. He has been tested several times for HIV, the virus that causes AIDS, and all the tests have been negative, the judge said.

As a teen-ager, Northrup ran track and played soccer and rugby. After attending the University of British Columbia for a year, he signed on with the U.S. Navy and served for four years as a radar technician on aircraft carriers in the Atlantic and Pacific. Then he came to the University of Wisconsin-Madison to finish his education.

"During all of that time, I never came out," he says, speaking for the first time publicly on the subject.

As an undergraduate in the late 1960s, he began to explore coming out.

"I finally came to the conclusion that it wasn't a question of choice, it was who I was, and that the first thing you have to do in life is be honest with yourself and make the best of it.

"I also decided that most limitations are self-imposed. This was going to dramatically limit my life if I let it. But if I didn't let it limit my life, it wouldn't. I've been very fortunate that that's been pretty much the case."

Northrup and his partner, Larry Small, appeared together occasionally at social functions for the law enforcement community.

"It wasn't long before everyone in the D.A.'s Office, the Police Department and the Sheriff's Office knew about me," he said. "Anyone with any common sense knew what was going on. I've tried to be honest, but also, when it came to my personal life, my sexual orientation, to be discreet.

"I think anyone, straight or gay, should be discreet in the workplace about

their sexual life."

One detective tried to bait him when Northrup was a junior prosecutor, he said. "Snide little comments were made one day, and I just confronted him,"

Northrup said. "I asked him what his problem was and gave him a piece of my mind on the issue. It was a very frank conversation. I think it totally surprised him, and in the long run he ended up respecting me and we became friends."

Northrup said that is a good example of his firm belief that anyone can avoid being victimized by refusing to behave like a victim.

"Whether you're gay or straight, the issue is how you handle yourself, not your sexual orientation," he said.

When Northrup was installed as a judge in 1985, Small had a place of honor in the jury box and was introduced along with the rest of Northrup's family.

When Small died in April, 1994, Northrup was prominently listed in the obituary as his "partner of 21 years."

At Small's memorial service, nearly the entire judiciary turned out. "I was overwhelmed," Northrup said.

## Far-Right Group Asks Texas to Dump Disney Stock

Austin, TX — The American Family Association of Texas has asked the state public school system's trust fund to dump all its stock in Walt Disney Co. because of what the group considers the entertainment giant's "violent, obscene music" produced by recording companies owned by Disney.

The move comes, however, just weeks after the Southern Baptist Convention called for a boycott of Disney and its subsidiary companies because of the company's domestic partnership health coverage and non-discrimination policies. Wyatt Roberts, the head of the Texas branch of the AFA, led an unsuccessful 1996 boycott of the Texas Triangle, a gay paper based in Austin.

An appropriations bill rider that takes effect in 1998 would prohibit state agencies from investing in companies that produce or distribute music that is demeaning to women or that advocates criminal behavior. Several state legal experts have questioned the legality of the rider itself, and the head of the state board of education says the rider is no basis for changing its stock investments.

Ironically, before the AFA asked Texas officials to dump the stock, Disney had already recalled an album by the group Insane Clown Posse because the company considered the lyrics objectionable.

## **Texas Lesbian Wins Visitation Trial**

Austin, TX (AP) — A lesbian is entitled to sue for visitation rights to her ex-lover's child, a Texas appeals court ruled on July 3, providing gay partners a legal standing denied in some other states.

The ruling by the 3rd Court of Appeals didn't turn on the question of Lisa Ann Fowler's sexual orientation nor decide whether she actually should be allowed to visit the child, who was conceived with the help of a sperm donor.

Rather, the decision was based on a provision in state law that says such a lawsuit may be brought by a person "who has had actual care, control, and possession of the child for not less than six months preceding the filing of the petition."

Under that standard, Ms. Fowler's lawsuit should go to trial, a three-judge panel said. It overruled a lower-court judge who had dismissed the lawsuit on the grounds that Ms. Fowler didn't have legal standing.

This is the first such ruling by a Texas appeals court.

The woman who gave birth to the child while the two lived together, Tonia Jones, will appeal, said her lawyer, Mary Kay Sicola.

The San Francisco-based National Center for Lesbian Rights assisted Ms. Fowler.

"From our perspective, it's significant nationally that a Texas appellate court would not get caught up in the issue of sexual orientation but in fact would look at the reality of the relationship between Lisa Fowler and her son," said Kate Kendell, the group's executive director. "The most important fact is that she, with her partner, raised a child. The child viewed both of them equally as parents."

In similar cases in several other states' appellate courts, the results have been mixed, said Beatrice Dohrn, legal director of the Lambda Legal Defense and Education Fund, which fights for gay rights.

Lesbians were allowed legal standing to seek visitation rights in Wisconsin and Pennsylvania and denied it in California and New York.

The U.S. Supreme Court in 1995 let stand the Wisconsin ruling. Ms. Kendell said in that case, the exlover won visitation rights. In Pennsylvania, visitation rights were denied, and the woman is appealing that decision, Ms. Dohrn said.

Ms. Sicola, Ms. Jones' lawyer, said the biological mother was trying to do what she thought best for her child, with the support of the father and her current lesbian partner.

"It's very unfortunate this thing is being trumpeted as a gay rights issue. I think that's a disservice to the facts of the case," Ms. Sicola said.

Ms. Jones has described Ms. Fowler as physically, emotionally and verbally abusive, according to court papers. Ms. Fowler's lawyer, James Arth, said she has received counseling for "some anger issues in the past" but is neither violent nor abusive.

## 'Who's The Boss?' Star Comes Out

Los Angeles, CA — Danny Pintauro, formerly Jonathan Bower of television's hit sitcom "Who's the Boss?" came out of the closet in the July 7th issue of *The National Enquirer*.

The Enquirer article relates the 21-year-old actor's "coming out" experience, including how he told his parents and his "Who's the Boss?" co-stars Judith Light and Tony Danza that he was gay.

"I couldn't deny it anymore. It was just the right time to come out," he tells the Enquirer.

"The lesbian, gay, bisexual and transgender community is indebted to people like Danny Pintauro who demonstrate the courage to 'come out'," said Joan M. Garry, The Gay & Lesbian Alliance Against Defamation's (GLAAD) Executive Director. "He should be proud in the knowledge that by telling his story he is a role model for gay youth who may be struggling with their own sexual orientation," Garry added.

A GLAAD statement indicated the group is heartened by the *Enquirer's* decision to approach GLAAD with regard to Pintauro's story, which demonstrates [the *Enquirer's*] new effort to reflect the realities of lesbian, gay, bisexual and transgender people.

"We hope that this is indicative of future stories that will deal completely and fairly with the lives of our community," read the statement.

"This article is the most sensitive, accurate story dealing with sexual orientation GLAAD has ever seen in the *Enquirer*," said Chastity Bono. "We applaud Danny for his decision, and encourage the Enquirer to continue to work with the community and GLAAD to build on this important first step."

## FDA Warnings Preceded Withdrawal of Home HIV Test Kit

New York, NY — In the months before a Johnson & Johnson unit removed a controversial home HIV test from the market, federal regulators issued stern directives to the company to clean up its quality control procedures, government records show.

According to a *The New York Times* report, the company's Direct Access Diagnostics unit said that it was withdrawing the test, called Confide, as a result of weak sales. But the formal warnings from the Food and Drug Administration may have been the last straw for a product that Johnson & Johnson fought 10 years with the agency for the right to sell and spent millions of dollars to develop.

"Consumers simply have not shown a high level of interest in using the Confide service," Robert Miller, president of Direct Access, told the *New York Times*. The unit had processed 90,000 Confide test results since it was introduced in June 1996, he said.

The withdrawal of Confide leaves the home HIV testing business to Johnson & Johnson's sole competitor, Home Access Health Corp., which makes the Home Access test kit. Home Access says it has sold 150,000 tests so far this year.

Johnson & Johnson said that the FDA's concerns were not factors in discontinuing the test.

"The technical issues raised in those letters had either been resolved or were on the way to being resolved,"

Jeffrey Leebaw, a spokesman for Johnson & Johnson, said. The FDA's first directive to Direct Access centered on how some of the company's tests, which required users to place blood droplets on a card, were sent in for processing. Direct Access provided preaddressed envelopes for drugstores to give to customers for shipping the test cards to the company. But the agency notified the company in March that envelopes for Confide were being inadvertently provided to Home Access buyers in some stores where both test kits were sold.

"This resulted in users of the mislabeled competitor's kits being unable to obtain test results," the FDA said in its warning letter.

In a second letter to Direct Access, sent in May, the agency took issue with the unit's method of validating test results because it was using blood that had been frozen and thawed rather than fresh blood, a process the company said was effective but that it agreed to change at the agency's request. The agency also said Direct Access had failed to submit required reports to the agency after the company received complaints that it may have given false test results to some customers.

## Aussies Find 'Shocking' Level of Anti-Gay Attacks

Melbourne, Australia — A national survey of more than 3,000 gay men in Australia found that some 41 percent said they had been physically or verbally abused in the past year and that 6 percent said they had been the object of a physical assault during the period because of their sexual orientation. Some 13 percent of those under age 20 said they had been physically assaulted in the past year because of their sexual orientation.

The survey, conducted by researchers at Macquarie University, also found that more than two-thirds of those responding said they had been physically or verbally attacked because of the orientation at some point during their lives:

Dr. Paul Van de Ven, one of the researchers who conducted the study, also reported that 16 percent of the gay men who were HIV-positive reported that they had been refused public services of some type because of their infection.

## Lesbian Relationships Cited as Cause Of Canadian Prison Disturbance

Halifax, Canada — According to a report in Canadian newspapers, prison officials concluded that a September 1996 near-riot at a women's prison in Truro, Nova Scotia, was sparked by tensions over lesbian relationships among the inmates.

"Some inmates ... were claiming they were being discriminated against because they were gay," the internal prison report says. "Other inmates claimed the entire matter was making them uncomfortable, particularly the outward display of affection in inappropriate settings.

During the Sept. 5, 1996, incident, women flooded their cells, set bedding on fire, and smashed toilets and windows at the institution.

The report said it found no evidence of homophobia among staff at the prison, but said both inmates and prison employees were confused about how lesbian relationships in institutions should be dealt with because the nation's prison authority, Corrections Canada, has no policy on same-sex relationships.

#### U.S. Businesses Increasingly Offering Partner Benefits

San Francisco, CA — A large-scale survey of U.S. businesses by the accounting firm of KPMG Peat Marwick indicates that overall, 13 percent of the businesses with more than 200 employees in this country offer some form of domestic partner health benefits.

The survey found that 23 percent of the larger firms with 5,000 or more workers offer such benefits; 13 percent of the firms with 1,000 to 4,999 workers offer the benefits; and 12 businesses with 200 to 999 workers have partner benefits programs in place.

The survey also found that high-tech firms were the leaders in offering the benefits, with 20 percent of the industry having such benefits. Government was next at 17 percent and retail firms were third with 16 percent offering the benefit packages.

#### All-Female College Debates Transsexual Physicist on Faculty

London — Faculty and students at Cambridge University's only all-female college, Newnhman College, support the appointment of Rachel Padman, a male-to-female transsexual as a physics instructor at the school.

Dr. Onora O'Neill, who heads Newnham College, said Padman "has been accepted as a woman as a member of the scientific community for many years" and had "marked out a distinguished career for herself."

The school's charter requires that all faculty at the college must be women, but under British law, transsexuals cannot alter their birth certificates and despite Padman's sex-change operation, her birth records still indicate that she is "male." The British regulations blocking the change in birth records is currently being challenged legally before the European Commission.

### **Montana Top Court Overturns** Sodomy Law

Helena, MT — It was the toughest anti-sodomy statute in the country, carrying a maximum prison sentence of 10 years and fines up to \$50,000. No one has ever been prosecuted under Montana's felony sodomy law, and following a July 2 decision by the state Supreme Court, no one now ever will be.

Although there haven't been any prosecutions under the state statute, the lesbian and gay rights activists who brought the 1994 lawsuit challenging the Montana sodomy law said its mere presence on the lawbooks nevertheless presented homosexuals in the state with enormous legal problems indirectly.

Stacey Haughland, a Bozeman, Mont., lesbian who was one of the six activists who sued to overturn the 1973 sodomy statute, said, "The law's existence has been used to deny people a lot of rights. For example, in custody cases, the fact that someone is a gay man or lesbian has been used against them because it was a felony in the state."

The state Supreme Court ruled, in upholding a lower court decision that declared the law unconstitutional, that the "right of consenting adults, regardless of gender, to engage in private, non-commercial sexual conduct strikes at the very core of Montana's constitutional right of privacy."

The court went on to declare that "absent an interest more compelling than a legislative distaste of what is perceived to be offensive and immoral sexual practices on the part of homosexuals, state regulation, much less criminalization, of this most intimate social relationship will not withstand constitutional scruti-

The state's top court also agreed with the six plaintiffs that "there is enough evidence to show that there is a correlation between homosexual sodomy laws and homophobic violence."

All seven of the court's justices agreed that the law was unconstitutional, and six of the court's seven justices joined in the majority opinion that it violated the state's privacy rights provisions.

Justice Jean Turnage in a dissenting opinion said the law should have been stricken because it violates the state's equal protection guarantees, not privacy rights.

## **Condom Distribution Proposal Gets Cool** Reception in St. Louis

St. Louis, MO - Despite reports that the rate of infection of sexually transmitted diseases (STDs) among St. Louis area teenagers is some 38 times higher than the national average, school board officials said they wouldn't talk about a call by trustee Bill Haas to distribute condoms to public school students.

Haas told the St. Louis Post-Dispatch that he wants the schools to begin distributing condoms to sexually active students because "kids are dying" and said opponents of condom programs in public schools were "anti-sex people." He said he would present his proposal at a school board meeting in early July.

But Hattie R. Jackson, the board's president, told the paper the school board probably wouldn't take up the issue at all.

"The board has no intention of handing out condoms," Jackson told the paper. "We've never discussed it. We don't know where the community, parents or

students stand."

None of the regional schools hand out condoms to students, the paper reports, and only a few schools can even show students who ask how condoms should be used. Some school in the area even prohibit the use of the word "condom" in sex education classes.

### **Gay-Teen Group in** Dispute With IRS

Charlotte, NC - Can the Internal Revenue Service force a support group for homosexual youth to prove that it does not encourage homosexual activity or attitudes among young people? That's the question at the center of a dispute between the federal agency and a Greensboro organization.


The Gay and Lesbian Adolescent Support System applied to the IRS for tax-exempt status. The IRS wrote back in September 1996 with a letter the organization now claims is prejudiced and improper. The group has requested a new review of its application.

The IRS letter said the organization could not receive tax-exempt status unless it outlined, among other things, the procedures it had to make sure counselors did not encourage homosexual practices or attitudes among minors.

According to its own literature, GLASS is "a supportive community for self-identified lesbian, gay and bisexual youth and for those youth who still may be coming to terms with their sexual identities."

It offers weekly support group meetings that seek to raise teen-agers' self-esteem and help them deal with anti-gay prejudice.

IRS spokeswoman Jodi Patterson said the agency won't comment on individual cases because of privacy laws. But she said a gay or lesbian group would not automatically be barred from receiving tax-exempt

## Pride Parades Roll Around the World

San Francisco, CA — Lesbian and Gay Pride roared around the world at the end of June with celebrations and parades from Honolulu to Paris to Houston to San Francisco.

More than 200,000 gays and lesbians from all over Europe joined for the first time in marking the celebration in Paris to make the French parade the largest in the country's history.

Similar parades were also held in Mexico City, Toronto, Berlin and in other major cities around the world.

In Houston, parade organizers for the first time held the city's Gay and Lesbian Pride event at night with illuminated floats — and hundreds of equally lighted, glowing and twinkling parade watchers. Organizers said the cooler evening weather encouraged a more festive celebration than usual and drew some 50,000 people to the city's predominately gay Montrose district, about 20,000 more than attended any previous daytime parades in the city.

In Hawaii, with the state poised in early July to become the first in the nation to have a statewide domestic partnership law, gays and lesbians celebrated their 8th annual pride parade - although with decidedly mixed reactions about the state's new law.

Governor Ben Cayetano has said he will probably allow a state domestic partners benefits bill that includes about 60 specific benefits programs to become law on July 8. The legislation is part of a complex political effort to circumvent an expected state supreme court ruling that would legalize same-sex marriages in Hawaii by offering the partners program while banning gay and lesbian marriage.

Although many of the Hawaii pride event celebrants said the statewide partnership program is a landmark in gay rights in the U.S., many say "the legislature has made us second class citizens" by trying to prevent state courts from legalize marriage for gay couples.

With a 60-foot pink triangle overlooking the side of city's tallest hill, an estimated half-million people - and one elephant — joined in San Francisco's 27th annual pride parade, one of the most festive and upbeat seen in the city in several years.

Scores of contingents from virtually every major country in the world carried their national flags, enormous floats with dozens of dancing men and women, and contingents of every kind - from lesbian moms to church congregations to crack rifle drill-teams - strut-

ted, strolled and twirled their way along the jammed parade route. The elephant was part of a contingent sponsored by Anheuser-Busch to promote its new "Elephant Red" beer.

As usual, the parade was led off by several hundred members of the Women's Motorcycle Contingent, better known at "Dykes on Bikes." Among the groups following behind were two others: "Mikes on Bikes," a group of male bicycle riders, as well as a group called "Dykes on Spikes" made up of lesbians in spiked golf shoes.

The four hour-plus parade was also broadcast live for the third year on KOFY-TV, the local Westinghouse network affiliate.

## Cunanan Update: Still No Fingerprints — Strange Cash Flow

Chicago, IL — Investigators said a bloody screwdriver found in the car belonging to murdered Chicago realtor Lee Miglin doesn't match one owned by the main suspect in the case, Andrew Cunanan, a gay man from San Diego who remains the object of a nationwide manhunt. Police also said their investigation wasn't helped when they found no fingerprints at all on the screwdriver, although a state crime lab will try to use sophisticated DNA testing to see if it can positively match any genetic material.

In addition to being the prime suspect in Miglin's death, Cunanan is also wanted in connection with two other killings in Minnesota, and a fourth in New Jersey in late April and early May of this year.

Deepening the mysteries surrounding the case already, the *Chicago Tribune* reports that Cunanan withdrew as much as \$75,000 from San Diego bank accounts just before the killing spree began, although authorities say they have no idea how Cunanan got the cash.

Cunanan's credit cards were already at their limits and his last known job was as a drugstore clerk.

But the newspaper reported that earlier this year Cunanan's checking account suddenly began to show large cash flow changes, with single deposits ranging up to \$15,000 and large checks being written the next day to nightclubs that Cunanan visited.

Authorities quoted by the paper said they are pursuing the possibility that Cunanan may have been involved either in some sort of pyramid scheme or a drug smuggling operation, but said so far there is no evidence one way or the other.

Investigators told the paper that in the four months before Cunanan disappeared, Cunanan moved some \$75,000 in and out of accounts at two San Diego banks.

#### 5% Increase in Minnesota Hate Crimes Reported

Minneapolis, MN — The Gay and Lesbian Community Action Council reports that hate crimes against gays and lesbians in Minnesota rose 4 percent in 1996 compared with the previous year's figures.

The anti-violence group also reported that while the number of anti-gay attacks in the state grew, the severity of the attacks also increased.

"The reports continue to be more violent with each passing year and the number of victims affected by these incidents continues to dramatically rise," said Constance Potter, a spokeswoman for the group.

Some 70 percent of the anti-gay incidents the agency collected took place in with cities of Minneapolis and St. Paul.

#### New British Labor Parliament to Tackle Age of Consent Laws Again

London — Bolstered by the recent popular support in electing a new Labor Party government, British Members of Parliament say they're sure they can win an overwhelming vote in the House of Commons to lower to age of consent for gays from 18 to 16 - the same age of consent that applies to heterosexuals in the UK.

In 1994 when Parliament lowered the nation's age of consent laws, lawmakers narrowly defeated an effort to equalize the laws that determine, among other things, when people can legally have sex. Instead, although Parliament lowered all the ages at least a few years, the age of consent for homosexual sex was kept at 18 years instead of 16 years that now applies to heterosexual sex.

The recent overwhelming election of a new Labor Party government, however, has led MPs to feel confident they can lower the age for gay sex by a wide majority.

The strong Labor Party majority may also lead, many observers say, to Parliament finally lifting the ban on homosexuals in the British armed forces.

### Zimbabwe Ex-President Denies Rape Charges

Harare, Zimbabwe — Canaan Banana, the former president of Zimbabwe, has finally broken his silence about the charges he raped several men while he was the country's head of state, denying he is homosexual.

Banana told BBC television and South African reporters that his enemies had mounted a "malicious vendetta" of "pathological lies" against him because they feared he intended to go back into politics. He has charged that political opponents had offered some of the men who have made the accusations money and other bribes for bringing criminal complaints against him.

"I am not a homosexual," Banana told reporters.

#### Despite Alum Complaints, Princeton Chapel Remains Open to Gays

Princeton, NJ — Some Princeton University alumni are upset with the use of the school's chapel for an April 26 commitment ceremony by two gay men, but Princeton officials say the facility is open to use on a non-discrimination basis.

Although the chapel has been used for other same-sex commitments before, the ceremony for Jason Rudy and Mike Beer, both Princeton graduates, rankled some alumni both because it was so publicized and because the couple signed the chapel's register of marriages.

The Rev. Joseph Williamson, dean of the chapel, agreed with complaints in the school's alumni newspaper that the couple should not have been allowed to sign the registry and said their signatures will be "amended" and that the registry itself will in future only be available to "record sanctioned marriages."

Williamson insisted, however, that the chapel will continue to be available to same-sex couples for commitment ceremonies like any other couple.

#### HIV+ Boaters in Yacht Race

Los Angeles, CA — One of the 41 yachting sailboats participating in this year's 14-day Transpacific Yacht Race from Los Angeles to Hawaii, a 2,200-mile event, is a crew of 9 HIV-positive sailors.

The ship is being sponsored by a nonprofit group named Get Challenged based in Ojai, Calif., which helps provide leadership support for people infected with the virus in their daily lives.

Milwaukee - Thanks to \$35,000 in funding from Kenosha County, the Southeast Wisconsin AIDS Project is expanding its Peer Mentor Education Program with another comprehensive program targeted at youth at risk of HIV infection due to the abuse of alcohol and other drugs.

The Southeast Wisconsin AIDS Project's prevention educators have formed a working coalition with area agencies and three area community centers to recruit high-risk youth to participate in a comprehensive eight week program to be

offered in each of the community centers.

"Participating youth will be trained in HIV and AIDS instruction as well as participating in a number of sessions dealing with the development of life skills and self-esteem in order to give them the foundation necessary to make healthy choices in their lives," said Michael Obinger, Southeast Wisconsin AIDS Project director.

In addition, each program will include a mentor component. Mentors are community volunteers who have been significantly affected by the use of alcohol and/or drugs and who have made positive changes in their lives as a result.

The Southeast Wisconsin AIDS Project's goal is to train 45 youth, representing a diversity of culture, class, gender and sexual orientation, who will take information learned back to their neighborhoods and social structures and share with their peers medically accurate information about AIDS and HIV prevention.

Rockford, IL - The AIDS Care Network will hold it's tenth annual Candlelight Vigil on Sunday, July 13th at 8 p.m. This event is held each year to celebrate the lives of all persons with HIV/AIDS.

The ceremony will be held at Symbol in Sinnissippi Park near the recreational path. Testimonials will be given by several community members affect by HIV. Following the testimonials a candlelight procession to the River will be held. Candles will be provided.

A roll call of names and a sunset memorial in memory of those who have died will be held at the River's edge. Individuals who wish to have a loved one remembered are invited to call the AIDS Care Network Office at (815) 968-AIDS or (815) 968-5181. Loved ones who have died through complications associated with HIV will be mentioned by first name only unless otherwise requested. Those attending the Ceremony will be offered a white rose in remembrance of their loved one(s) and if desired may lay the flower in the Rock River as a gesture

The AIDS Care Network has provided services for people affected by the HIV pandemic since 1988. A community based, not-for-profit organization, ACN serves Rockford and a nine county area in Northwestern Illinois. 1997 is also the 50th year since the founding of the St. Camillus Healthcare Campus in Wauwatosa. "The early Camillians settled here from Germany and established a small hospital for men on the city's south side," said Bro. Stephen Braddock, "They later acquired the land in Tosa and built what was then known as St. Camillus Hospital for Incurable Men." Many of the patients were afflicted with polio, TB, and sexually transmitted diseases, explained Braddock.

Though relatively few in numbers, the Camillians have made a significant impact on the Milwaukee healthcare community. Known world wide for their dedicated care of the sick, dying and aged, Camillian priests and brothers are engaged in health care work in over thirty countries. The Order owns or operates over 550 hospitals, nursing homes, AIDS centers, hospices, and senior living facilities.

In recent years, the Order has focused much of its efforts and resources on the AIDS pandemic. St. Camillus HIV/AIDS Ministry provides the Milwaukee Community with a full continuum of HIV related services. Services include: skilled nursing care, home care, support groups, supportive housing, volunteer services,

education, and counseling.

According to Braddock, who is a Chairman of the Board which governs the Milwaukee based operations of the Order and heads the HIV program for the North American Province, "We are deeply committed to those affected by HIV disease. At the same time, our commitment is just aS strong to our many other established ministries... Camillians vow to care for the sick and dying, period! No one group or population is more important than another, people are people," he said, "I don't care what their affliction or life circumstance may be, we are here for every one."

## MAP Hosts CDC Funded Prevention Workshop

Milwaukee — The Milwaukee AIDS Project recently held a two-day HIV prevention workshop funded through a Center for Disease Control (CDC) grant as part of an ongoing Opinion Leader Program.

Richard Elovich, director of HIV prevention at Gay Men's Health Crisis in New York, New York, led the workshop which focused on HIV prevention for gay men based on the philosophy of harm reduction in HIV prevention programs.

"The most striking piece of information from Richard's workshop dealt with the empowerment of gay and bisexual men," said Andy Bagnall, gay outreach manager at the Milwaukee AIDS Project. "As AIDS prevention educators and advocates, we need to provide gay and bi men with opportunities to engage one another in life-saving discussions about sex, self-esteem, loving other men, HIV and protecting our lives and the lives of those we love."

The 20 workshop participants included collaborators from AIDS Network in Madison, Northern AIDS Network in Superior, LaCrosse County Health Department, Milwaukee AIDS Project staff members, Center Project staff members, Northwest Wisconsin AIDS Project staff members and Southeast Wisconsin AIDS Project staff members and individuals throughout the state of Wisconsin who do HIV prevention with gay and bisexual men.

"It is so important for us to hear from other agencies and individuals in major epicenters like New York to learn and share collective knowledge," said Bagnall. "Richard brought us new insight from his experiences in New York, other workshops he has led and the research he has done for articles he has published."

Several points of Elovich's presentation reiterated the strategy behind the AIDS Resource Center of Wisconsin's (supporting administrative agency of the Milwaukee



AIDS Project) current "man2man" advertising campaign which focuses on building the self-esteem of young gay men through positive, affirming messages about living and staying HIV negative. The prevention campaign which has already featured the "Our Dreams" and "Our Community" posters, bar napkins and advertisements, will unveil a third message, "Our Values" statewide in July.

## June Flood Causes Major Losses at The Milwaukee AIDS Project

Milwaukee — The June flood devastated the Milwaukee AIDS Project, 820 N. Plankinton Ave, which provides services to thousands of individuals affected by HIV and AIDS. The Milwaukee AIDS Project's basement is its main storage area

and houses the agency's food pantry. While there is no way to calculate the total damage as of yet, early estimates are over \$55,000 and MAP is calling for immediate help.

MAP's Food Patry receives 450 requests per month for food and supplies from the food pantry. These requests feed nearly 1,500 individuals - consumers and their family members. The June floods destroyed nearly all of the food stocked in the food pantry as well as personal care items. Some of the most critically needed items are: diapers, fresh produce, bottled water, paper items, cereal, dry food items and health care items. Items lost to flood damage include; Nearly everything other than canned goods;two freezers; three refrigerators; one computer; office furniture; and children's gifts collected so far this year.

Health Services at MAP also lost items to flood damage including medical supplies such as gauze, rubber gloves, cotton swabs, etc.; agency washer & dryer; and wheel chairs and walkers.

The Preventions Services lost cases of condoms and cases of syringes for the agency's needle exchange program were destroyed.AIDS Walk Wisconsin is Wisconsin's largest AIDS fund raising event scheduled for September 21 lost nearly all of its printed pieces: envelopes, registration material, stationary, etc. This is a critical time for AIDS Walk as walker registration is key to this event.

Other items that need to be replaced in the building include: fluorescent tube

lighting, ceiling tiles, desks, chairs, tables and computer equipment.

Cash donations are also critically and immediately needed to purchase items destroyed by the floods so that the Milwaukee AIDS Project may continue providing services to the many consumers who rely on the agency. Hotlines have been set up for those who can help - 414-225-1570 or 414-225-1572.

### St. Camillus Expands Housing **Options for PWA's**

Milwaukee - St. Camillus HIV/AIDS Ministry recently opened its second supportive residence for people living with HIV disease.

Emmaus House welcomed its first resident on July 3rd. The facility offers a home-like, supportive environment for persons transitioning from the St. Camillus Health Center back into the community.

"We're seeing a significant number of people come into our skilled care unit very, very ill," said Eric Gravenkamp, a social worker with the AIDS Ministry. "However, for the first time since this disease surfaced, many people are rehabilitating and going home," he said. Gravenkamp points to new developments in drug treatments as the cause of what is becoming known as the "Lazarus Phenomenon."

Residents of Emmaus House are supported by nurse case managers from Camillus Home Health Agency, as well as by staff and volunteers of the Ministry.

The opening of Emmaus House was delayed due to severe damage suffered by last months heavy flooding. Raphael House also had significant damages and loss


"We are deeply grateful for the incredible outpouring of support from the community to help us recover from this tragedy," said Brother Stephen Braddock, Executive Director of the AIDS Ministry. "There was deep concern expressed by our city's Gay community and Religious Communities alike... that reality speaks volumes to me."

The Ministry plans to open a third residence on or before October 1st, 1997. To be known as Magdalene House, the residence will be dedicated to caring for HIV+ women. A fourth home, Camillus Cottage, will open soon after.

Covers are usually anywhere from \$20-\$100, plus your air fare, hotel, car rental, etc. etc., for weekend events? *Come on!* Doesn't anybody have to work?

Most of these parties are held in the bigger gay cities... New York, Fire Island, Palm Beach(California), LA, San Francisco, South Beach, Ft. La-di-da (excuse me, Lauderdale), and Atlanta. For once I'm glad Milwaukee isn't on such a list!

Perhaps it just jealousy on my part, but the pictures you see in the coverage of these big events are of beautiful, buffed men, dancing their designer asses off. There is also the perception that these sometimes all-night-long parties are primed with lots of mood and energy enhancing drugs... crystal, coke, ecstasy, and Lord knows what else.

Hah! Guess Again... I've just been switched to my third Inhibitor, the first one worked for 6 months, and the second almost a year. The Big "A" is still out there my friends and tribal members. Recreational drugs including alcohol DO lower your inhibitions (admit it!) so please, continue having safer sex. Have Fun and Play Safe may sound passe, but we must all be responsible as well as reasonable.

Is that happening here, in "small town" Milwaukee? I hope not, but people have always said that we're behind the coast cities by a good year to year and a half as far as trends go, and that scares me. Sure, there are drugs in our bars, and have been, for years, but the scene is much less intense here.

## Angels

The Milwaukee Repertory Theater and the Milwaukee Chamber Theater is circulating an apology for their upcoming productions of Tony Kushner's Pulitzer Prize-winning "Gay Fantasia" plays "Angels in America." A number of straight people I asked couldn't understand why anyone would be offended by this. An equal number of gay people were puzzled why straights couldn't see what the problem is.

Among the questions it posed in its Q and A format were "Why do a play about homosexuals?" and "Haven't we seen enough about AIDS?"

Let's imagine that a similar "explanation" had been sent out about a production of Eugene O'Neill's 1956 Pulitzer prize-winning Irish family play "Long Day's Journey Into Night."

#### "Why do a play about those Irish Maniacs?"

While "Long Day's Journey Into Night" deals with those Irish maniacs, it does so in a way that universalizes its subject, becoming about each of us as we face the question of what we want to be as Americans. This Pulitzer Prize-winning play is about much more than Irish maniacs. It's about family, religion, morality, politics, and the need for connection.

#### "Haven't we seen enough about those Irish maniacs?"

In the 100th year since those Irish maniacs started staggering into our country, more than 14 million Americans have been diagnosed as being at least part Irish maniac. Originally thought of as a red-haired, sirloined faced phenomenon, the blight of Irish mania is now spreading. While Irish mania surges into the headlines each time a celebrity like Merv Griffith, Mickey

Rooney, or Tatum O'Neill is diagnosed with Irish mania, attention, no matter how unpleasant, must be paid.

### "Why is this play so degenerate, corrupt, and depressing?"

Eugene O'Neill's play "Long Day's Journey Into Night" is celebrated for its honesty. With this honesty



comes an explicit portray of America in a belly-crawling, grass-grabbing drunken Irish crisis. Although there are some very degenerate scenes, they are not superfluous, nor are they meant to titillate-they are an integral part of the play's story.

#### "Are you sure they don't titillate?"

Well, maybe just a little.

#### "How much?"

Pretty much, actually, now that you mention it.

#### "I hear the mother is a morphine junkie."

Yes, but only in contrast to the bigger, more wholesome, more Milwaukeean part of the play.

#### "Can you tell me a little something about the wholesome, Milwaukeean parts?"

The setting is near the ocean, which is a lot like the lake. That's wholesome, isn't it?

#### "I suppose."

And foghorns! There's lots of foghorns! How dirty can that be? And the father goes around turning off the lights to conserve electricity. In that, there's a lesson for us all, wouldn't you say?

#### "Definitely."

Why, sure. And hey! We never actually see the mother shooting up. She does that behind locked doors, in the privacy of her own bedroom, where it belongs. And...and...they talk to each other! The mother and father and two kids talk to each other! Sometimes it gets kinda snotty, sure, sure, no doubt about it, but the important thing is that here we have a family taking thing over as a family unit!

#### "Anything else?"

Yes, and I want to make this point perfectly clear. The mother, father, and two kids may be Irish maniacs, but they are strictly normal heterosexual Irish maniacs. This you can prove because the mother and father procreated tow normal, heterosexual Irish maniacs in the official, normal, God-given way!

#### "How do you know the two sons are straight?" What?

"Well, they are bachelors at a rather advanced age for

## The Mainstreaming of Gay Pride

rom Manhattan to Chicago to Seattle to San Francisco, gay pride events this year were marked by something a bit new and unusual: normalcy. Bare-breasted Amazons revved by on Harley-Davidsons as usual; scantily-clad gymbodies solo-flexed to throbbing dance tunes as they have for more than two decades of pride parades; and pink-wigged gender-benders dribbled basketballs in stiletto heels or cavorted as perpetually indulgent nuns in the tried and true tradition. But pride celebrations from coast to coast also reflected, more than they ever have in the past, a main-streaming of the gay and lesbian community itself.

Amid the more flamboyant parts of parades almost everywhere were scores of contingents of such non-dramatic types as: lesbian historians, gay Republicans, choruses, beer companies, computer firms, drugstore chains, and radio stations; there were troops of lesbian moms with their kids in strollers, gay dads trying to keep up with their precocious toddlers, gay and lesbian senior citizens, and parents marching shoulder-to-shoulder with their gay sons and lesbian daughters; there were groups of gay Catholics, Episcopalians, Baptists, Jews, Lutherans, Methodists, Unitarians, Presbyterians - even in such paragons of godlessness as San Francisco.

Where there had once been a smattering of local straight politicians, there were now troops of mayors and members of Congress, bevies of judges and county supervisors, and pods of state legislators. Perhaps more mind-boggling, many of them now were openly lesbian and gay. Even the White House sent out greetings to gay pride celebrants across America from President Clinton.

While earlier parades had been dominated by bar floats with semi-dressed (if that) dancers gyrating to thunderous disco tunes, menacing studded-leather road warriors, and more drag queens than you could shake a mascara brush at, this year's events were almost downright all-American with groups focused on issues involving work, family, religion, and community service. Where once militant gay and lesbian student groups marched, we're now seeing more and more button-down gay fraternities and lipstick lesbian sororities parading down Main Street. And anti-war activists in parades are likely to find themselves outnumbered these days by gay veterans groups.

It's not that the more sensational aspects of the pride parades have disappeared (don't worry, Dan Rather will be sure to let you know the day drag queens and dykes on bikes vanish from the streets of San Francisco and New York). Our swishy brothers and butch sisters were as flamboyantly present at pride parades everywhere as they have been from the beginning.

But gay rights has very much gone mainstream in the past few years and fairly ordinary gays and lesbians with fairly ordinary concerns were in evidence this year in unprecedented numbers. In fact, from Houston to Seattle to Manhattan to Chicago to Minneapolis, pride parades all reported record numbers this year. In San Francisco, as many as 700,000 people may have turned out for the city's massive four-hour-plus televised parade — that's almost as many people as the city's total population of 735,315 and makes it the third largest parade in America — behind the Rose Bowl Parade and the Macy's Thanksgiving Day Parade in

New York.

Just south of San Francisco, the gay pride committee in San Jose this year went so mainstream that it's headed up by a heterosexual man. And the Christopher Street-West parade in Los Angeles was available anywhere on the planet from a live satellite feed.

Perhaps not too surprising, this mainstreaming of the usually outrageous and audacious pride celebrations causes some gays and lesbians a bit of concern. Are we becoming "too mainstream"? Do our pride celebrations still reflect the sometimes staggering diversity of who we are? And - maybe the most terrifying question of all - are our parades becoming boring? After all, who can get excited about watching troops of bank executives, TV cameramen, pediatric nurses, computer programmers, statistical analysts, printing press operators, and telephone installers proclaiming their Gay Pride?

Well, most of us aren't going to get too excited by a contingent of gay and lesbian chiropractors marching in a Pride Parade, it's true. Yet in a very real sense, that's what the concept of the diversity of our communities does ultimately mean. We are everywhere — and that includes the offices of certified public accountants and the corner gas station and the shoe department at Sears. It may not be as provocative or exciting or titillating as drag queens from outer space or muscletwinks flexing in jockstraps or a whip-wielding Ledermeister. But no one ever said the real world was either La Cage aux Folles or a Colt Studios porn movie.

In the years after the 1969 Stonewall Riots in New York sparked the modern gay rights movement, a common slogan was "Out of the closet and into the streets." But the rainbow banners at this year's PrideFest in Denver proclaimed a more current movement motto: "Out of the closet and into the courthouse." And as the rights movement shifts from the streets to the courts and legislatures, perhaps it's not too unexpected that the costume of choice might also change from leather and drag to suits and ties.

While in Florida, Tampa's gay pride festivities featured a "Family Values Picnic," complete with canoe rides and volleyball, perhaps expressing a new kind of "mainstream activism" that refuses to concede that the family is the exclusive domain of far-right conservatives and religious fundamentalists.

As legal battles from Hawaii to Massachusetts increasingly illustrate for today's activists, the phrase "We are family" is not just a vague post-hippie slogan, but a matter of imminently practical issues that concern untold numbers of gays and lesbians in areas ranging from health insurance coverage and inheritance rights to income taxes and child custody.

At Seattle's pride parade, one marcher there with a substantial portion of her church congregation, told reporters, "Three years ago, there was a lot of flamboyance, guys dressed in elaborate drag - that sort of thing. That's not a big deal anymore. We're beyond sensational now. We just want the same as everyone else."

According to the parade's organizers, as with many other activists around the country, that means things like: the right to employment and housing without discrimination, the right to marry and establish families, and the right to pass on their values to their children.

Laurie Jinkins, who heads up the state activist organization Hands Off Washington, said, "We've moved on. The challenges now are in everyday life issues: kids, school, work, things like that."

In Toronto, where Canada's largest gay pride celebration took place with more than half-a-million people attending, the message was the same. One parade-goer said, "I think the message now is, 'Surprise! We're just people." And while drag queens and leather-clad companions took part in Toronto's parade as they always have, they were also flanked by businesspeople like those from The Fraternity, who showed up in dress-shirts and ties.

Ironically, despite the often decidedly button-down, more-traditional-than-thou nature of the Toronto event, the parade's theme was the fairly provocative "Queer by Nature"

And therein lies the rub — or at least one of them. When reality outstrips rhetoric, how do we accommodate the changes?

We say we're a diverse community, that we're everywhere, that we're just like everyone else, and that we want everyone to come out. Yet the emergence a couple years ago of a gay and lesbian anti-abortion group sent — and still sends — shockwaves through the gay body politic. And at New York's parade this year, the only marchers jeered by spectators were Log Cabin Republicans who walked down Fifth Avenue with the city's Republican Mayor Rudy Giuliani.

How does a socially progressive movement, which the gay rights movement by definition must be, incorporate, embody and embrace conservative segments like these without either compromising their beliefs or the movement's

At a less profound but just as important a level, how do gay pride celebrations - which by nature are somewhere between political street theater and a carnival - include contingents of certified public accountants and marching gay Republicans and lesbian French horn players without also boring the spectators into staying away in droves.



Shorewood — Acclaimed author Aimee Liu's third book and second novel is based on the actual experience of her grandparents and their romantic but doomed relationship. 
## UWM's Final "Summer Evenings of Music Concert" is a Viola Lover's Dream

### **Brave Hearts Theatre Will** Present "Osiris or Isis"

Madison — Brave Hearts Theatre welcomes performance artist Peter Conover in "Osiris or Isis," an erotic experimental theatre piece with words, music, and movement. Based around the song "Isis" by Bob Dylan, with additional music and lyrics by Conover, "Osiris or Isis" draws from the ancient legends of Egyptian mythology and presents the archetypal relationships of the masculine and the feminine in a challenging and probably startling way. Conover will perform both roles, that of the god Osiris and the goddess Isis.

The former duet, which consisted of Dylan's "Isis" rearranged as a Celtic-style folk-rock mini-opera with new lyrics by Conover doubling Dylan's lyrics, became two separate songs, distinctly different in style but structurally identical, allowing Conover to sing the story of "Isis" in a masculine voice, with a hard-rocking minor key attack on the guitar, and then to tell the same story from her point of view, "Osiris," at a feminine pitch, in a major key, with a softer, flowing guitar style.

Further expansion of the piece resulted in exploring the dynamics between the masculine and the feminine attributes of the god and goddess within. Working either nude or with simple costume elements, Conover, does not attempt to completely transform his appearance using cosmetics or by completely cross-dressing, but rather through a total, psychophysical identification with the hermaphroditic qualities inherent in the human form, whether male or female. Conover's androgynous approach questions our most basic cultural assumptions about gender roles and sexuality.


## "Milwaukee Summers Can Be Deadly" So Says Author Kathleen Anne Barrett



Shoppers are curious when they first enter, but then they start realizing all we have to offer at very reasonable prices and by the time they are ready to pay for their purchases they're hooked," said Fortier. "Most people do come back. We have several individuals who have been visiting Survival/Revival every week since we opened in 1994."

For some of the shops customers, finding out the resale shop proceeds benefit the Milwaukee AIDS Project has made them want to do more than just shop. Many now bring in their own items for a tax-deductible donation as well as volunteering in the resale shop which rewards them with a 25 percent discount on purchases.



#### Bayard Rustin: Troubles I've Seen, A Biography

Then asked by a youth why more people had not been "out" before Stonewall, an elder replied, "Most of those who were either in jails or mental institutions." Jervis Anderson's biography of Bayard Rustin reveals that the restricted opportunities for gays did not always result in constricted lives. Individuals like Rustin overcame those barriers to lead productive lives while contributing to the enhancement of the entire nation. Rustin is best known as the organizer of the 1963 March on Washington, at which a quarter of a million assembled, black and white, male and female, and heard Rev. Martin Luther King enunciate his "dream" of a time when his children would be judged by their character and not by the color of their skin. That March had major political consequences, pressuring Congress to pass the Civil Rights Act of 1964.

Born in 1912 in Pennsylvania, Rustin, excelled at track, academics, public speaking, and music, and received a scholarship to a black religious college and sang (well enough to be a professional) in a quartette to help raise funds for the school.

He was expelled his second year, however. Anderson reports the rumored reason for his dismissal was that Rustin had fallen in love with the son of the college's president. Shortly thereafter, Rustin ended his studies at Cheney State Teachers College,

again because of "something naughty."

Bayard's family had ties both to the African Methodist Episcopal and the Quaker churches. In the 1930s, with war looming in Europe, Rustin veered toward his Quaker pacifism. Also in 1939, the American Communist Party strongly opposed American involvement in WWII. Rustin was then a member of the Young Communist League and enrolled at New York's CCNY, a center of intellectual political debate. For the YCL Rustin was asked to lead a campaign against segregation in the US armed services, then vastly expiring this campaign when Hitler attacked the Soviet Union. Immediately, the American Communists reversed themselves, and urged American participation in the war against fascism.

Rustin was ordered to halt his campaign against the US services. Rustin then

quit the Communist Party.

Rustin's pacifism now led him to the Fellowship of Reconciliation, a small, slightly religious pacifist group headed by Rev. A.J. Muste. Also in FOR was the youthful James Farmer, who induced For to subsidize a new, pacifist organization to combat racism, the Congress of Racial Equality (CORE). Farmer and Rustin were the most prominent black spokesmen for pacifism in For, and both sought to create new, non-violent methods to overturn racist practices.

In 1944 Rustin was sentenced to three years in prison for rejecting the draft.

Released in 1946 Rustin resumed work for For. In 1947, following a Supreme Court decision invalidating segregation in interstate travel, For organized the first "freedom ride," the Journey of Reconciliation of 1947. Rustin was among the integrated teams on the buses, and among those arrested for integrating facilities. When the North Carolina NAACP refused to appeal their cases, Rustin had to spend thirty days on a chain gang for that crime.

Rustin, a skillful orator and a stirring singer, was arrested in Pasadena, California on a "morals charge." He had been caught by police in a parked car having sex with two men. Rustin now had to endure a prison sentence, not for the cause of peace, or the cause of ending racism, but for what was then a shameful crime. When released FOR essentially fired him and gave him almost no severance pay after eight years' employment. Other job offers evaporated. Rustin wondered if Muste now wanted him to become a shoe shine man. Rustin endured low-status jobs, humiliation, unemployment, and therapy sessions, not an easy "sentence" for a proud man in his 40's who had been groomed to become an American Gandhi. Happily, there was another small, but less religious, pacifist organization, the War Resisters League (WRL), and after some months, it hired Rustin. But for Rustin, those were terribly

In December, 1955 in Montgomery, Alabama, the bus boycott began, and WRL sought to keep it on track as a non-violent protest. In February 1956 Rustin was dispatched to aid Rev. King advising him on matters of symbol and substance. For example, segregationists had a rifle in the living room, and he urged King to remove it. If his followers were to remain non-violent in the face of hatred and provocation, so must King. Indeed, King could not afford to have a weapon, for his enemies would contend that he started the violence. Acceding to Rustin's reasoning, King

King found Rustin's advice profound and essential, and Rustin headed the Harlem office of the SCLC. In May 1957 Rustin organized the SCLC's Prayer Pilgrimage to Washington in which 30,000 partook, and he also organized other marchers and boycotts in the late 1950's.

In 1960 Rustin was planning SCLC protests for both the Democratic and Republican conventions of 1960, but Harlem Congressman Adam Clayton Powell objected to the protests aimed at the Democrats. Powell threatened King privately, saying he would start a rumor that Rustin and King were lovers if Rustin were not fired. For the good of the movement, King asked Rustin to resign. Because of the threatened gay charge, Rustin was effectively exiled from the civil right movement at a time when non-violent direct action was being most widely applied throughout

Rustin had demonstrated too many talents to be crushed by Powell's blackmail. The WRL assigned him to new projects in Britain and Africa, where he remained a prominent spokesman of peaceful protest. In 1963, when Randolph began to propose his old dream of a March on Washington, he sought Rustin to coordinate it. This time, the other civil rights leaders agreed, and Rustin did coordinate that massive project. Anderson describes the in-fighting, the disputed speech of SNCC leader John Lewis, the criticism of Rustin's past; as well as the carping from outside by southern segregationists and Malcolm X. But Rustin arranged to have a quarter of a million come to Washington and leave on the same day in a demonstration of determination, topped by the rhetoric of Rev. King. And despite the fears and warnings, the demonstration was peaceful.

Rustin then renewed his contacts with King and helped plan the itinerary and accompanied the SCLC leader on his trip to Europe to accept the Nobel Peace Prize in 1964.

But in the mid-60s new issues rose that were to divide the civil rights movement, and alienate Rustin from both it and the peace movement. Black Power, a slogan used by Stokeley Carmichael during a March in Mississippi, was opposed by King, Rustin, and the more established civil rights leaders.

Similarly, on the ever-increasing numbers of Americans being sent to Vietnam, the peace movement became ever more strident in its demands that America pullout. Rustin, long-time spokesman for pacifism, argued that a pull-out would result in a Communist victory. He, Vice-President Humphrey, and other liberals, demanded peace talks instead. To the growing, militant peace movement, Rustin's defense of the Democrats seemed like a sell-out, and a betrayal of peace.


To some, the reason for Rustin's change was clear, he had sold out. But ever since 1941 Rustin had been suspicious of communism. Thus, he was much more likely to criticize the American anti-war movement of the 60's whose pull-out position he believed would result in a Communist Vietnam.

By the 1970s his gayness was no longer an issue. In 1972 he was arrested for carrying a concealed weapon, an antique cane that sheathed a sword. But in an era of rising crime, Anderson makes no report that Rustin was mugged. After a ruptured appendix was misdiagnosed and mistreated, Rustin died in 1987.

A fuller discussion of Rustin's critique of Black Studies and quota hiring (what we now call affirmative action), may have given the reader more appreciation of Rustin's intellect and dissent. Anderson notes in a few sentences that Rustin had a steady companion for a decade, William Naegle, but says nothing more about the relationship or even who Naegles was. On a similar theme, he quotes Rustin that Langston Hughes was "not gay," but asexual. But the older Harlem Renaissance figure Glen Carrington may have known Hughes at an earlier time. Carrington was certain that Hughes was gay.

Despite my quibbles, Anderson has written a fine biography of the courageous gay man, Bayard Rustin.





#### Resident Alien: The New York Diaries

I spent an afternoon in the sun on one of our recent nice days and read this book straight through. It read like a letter from a very dishy friend one hadn't heard from in years. "Based on his diaries in *The New York Native*, this latest effort is vintage Crisp: at once witty and profound, tough-minded and compassionate, outrageous and wise."

The time flew by and I was laughing to myself at some of the antics (his and other people's) when I noticed I was becoming quite as rosy as the sunset.

This review is liberally laced with quotes about Quentin Crisp, and quips from the book; there just seemed no other way to do it.

"Quentin Crisp, long famous as 'one of the great stately homos of England,' exiled himself to America in 1982 after he discovered that in New York 'happiness rains down from the sky.' "He says, "Everyone is so polite. That's the wonderful thing about Manhattan, you are never without friends."

Crisp gives a definition of himself: "I am concerned with the high gloss on society, not with its inner machinery. I am a free-loader, a dilettante, a butterfly on a wheel. And that's putting it nicely." Crisp lives on East 3rd Street near the Bowery next to a house full of Hell's Angels in a rented room . . . and has a "listed" telephone.

When asked why he didn't have an "unlisted" telephone number, he replied, "What, I ask the world, is the use of a telephone if my number is unlisted? It means that no one will ever be able to call me; I will have to call him. Think of the expense. In fact, I hardly ever initiate a telephone conversation. I wait for the world to communicate with me. At least this ensures that I am unlikely to be a nuisance to anybody."

And call, they do; at all hours of the day and night from all over the world. (If any of you are so inclined, look up his number in the Manhattan directory and give him a call and invite him to lunch. Bring your tape recorder—and by the way, be prepared to pick up the tab.) By his own admission he will talk to anyone and is unfailingly polite; he is in the "smiling and nodding racket," as he so bluntly puts it.

At 85, Quentin Crisp makes his living by "talking" and "appearing" at various functions . . . anywhere!. Crisp says he "never refuses an invitation if he is paid . . . and fed." He told Jay Leno he has found that he could live very well on "peanuts and champagne." Jay brought out the peanuts and opened the champagne.; Crisp loved it.

During the time that he actually stays in his room

for a few days, he is "content to dine on baked beans on toast." He will answer correspondence, which he types on a portable typewriter placed on his lap—in the only chair. He reads books that publishers have sent to him to review. His reply for books he hasn't read for some reason or other is, "Please feel free to quote me as saying anything which will promote the sales of this excellent book." A few publishers have been witty enough to print his response verbatim.

He also likes to file his nails and snooze—a lot. He likes TV, but he doesn't like music or art and professes to know absolutely nothing about politics. He has been interviewed about some of the movies he has appeared in. Notably "Resident Alien" and "The Bride" (with Mr. Sting—always using a proper title when referring to people he has met). He has also appeared as Queen Elizabeth I of England in the movie "Orlando."

There's lots more. Read and laugh!

Gay men: "Gay men are like the children of the damned: if you tell one of them anything, spontaneously the whole bunch knows it."

Fag-hags: "Fag-hags are all plump, sophisticated middle-aged ladies who use a lot of outmoded *gay* gestures and utter all the traditional *gay* catchphrases at parties where they are the only females present."

Los Angeles: " . . it was fun. Los Angeles is New York lying down."

Art and Art galleries: "I rarely visit art galleries, for two reasons: The first is that there is never anywhere to sit, and the second is that I do not understand the pictures. When people ask me what I've got against pictures, I can only reply 'What have you got against the wall?' "

Alcohol: "When I was first here [in New York] I used to drink before I went to the theater. In my dressing room I drank; in the interval I drank; and when the show was over I drank, but I can't do that now." As for being an alcoholic, he says, "I'd rather be alcoholic than anonymous."



### **Gay Money**

re gays and lesbians an economically privileged group, much sought after for our purchasing power and our trend-setting buying habits? Or are we an economically oppressed minority, forced to accept substandard wages or jobs that do not match up to our abilities? And are gay men better off than lesbians? The answers to these questions, like so many questions about us, depend on who you believe.

Of course, we know that our community is very diverse economically, as in most other respects. We are wealthy Hollywood executives, we are mired in rural poverty, and we are everything between. So, to get a true picture of the average income of gay and lesbians, we need to do some kind of statistical survey, and that's where the trouble begins. Because identifying gays and lesbians in the population is not easy.

One approach has been to survey gays and lesbians contacted through gay newspapers and magazines. According to several surveys of this kind, gay people in the U.S. earn significantly more than the national average. In addition, they tend to live in two-income households. Thus, one study conducted in the late 1980s reported that gays and lesbians have an average household income of \$63,100, compared with \$36,500 for the general population. When one throws another factor into the equation - the presence of fewer children in gay households - one is left with an image of gay people as having unusually high disposable incomes.

But these conclusions are suspect for two reasons. First, gay people who read gay magazines and respond to the surveys may be a privileged minority within the entire gay community. Second, one has to be concerned about potential bias on the part of the people who organize such surveys - perhaps a desire to help gay people feel good about themselves or to prove that gay people are a worthwhile target for

advertising dollars.

Another approach has been to use data derived from national random-sample surveys. One such survey, conducted in 1993 by the market-research firm Yankelovich Partners, reported that self-identified gays and lesbians have personal incomes about the same as those of heterosexual people of the same sex. In accordance with the generally higher incomes of men than women, gay men in the survey had an average personal income about 60 percent higher than that of lesbians. But this difference disappeared when the data were corrected for household structure: both gay men and lesbians live in households where the average income per household member is about \$12,500. Thus, if gay people's households function as economic units, the disposable income of lesbians and gay men may be about the same.

The finding that gay and straight people have similar personal incomes is a little puzzling, because several surveys have reported that gay people are more educated than straight people, and also are more likely to live in large cities. Both these factors are usually associated with higher income. So is something else operating to

keep gay people's income down?

To address this question, another study was conducted by economist and lesbian activist Lee Badgett of the University of Maryland. Badgett re-analyzed data collected by the National Opinion Research Center in 1989-91. The raw data indicated that, on average, lesbian or bisexual women earn an average of 18 percent less than heterosexual women, and gay or bisexual men earn 7 percent less than heterosexual men. The gay or bisexual men earned 75 percent more than the lesbian or bisexual women. Badgett then used detailed statistical tests to remove the effects of other variables, such as occupation, race, educational level, and area of residence. After correction for these variables, the gay or bisexual men earned about 24 percent less than heterosexual men, while there was no significant difference between the incomes of lesbian or bisexual women compared with heterosexual women. In other words, gay men take a significant hit in income simply because they are gay. Lesbians may not take a big hit in income for being lesbian, but they do take a significant hit for being women.

Badgett believes that these income differences demonstrate the effects of discrimination against gays and women in the workplace. In fact, she uses her results to argue in favor of legislation such as the Employment Non-Discrimination Act,

that came close to passage in the U.S. Senate last year.

I'm not sure that Badgett has made a watertight case with respect to anti-gay discrimination. For one thing, it's possible that gay men aren't as focused on salary when they choose their positions. Maybe they lay more emphasis on the intangible rewards of work such as the opportunity for service, creativity, and the like. Such preferences might lead to fine differences between the positions held by gay and straight men, differences that are not captured by Badgett's broad occupational categories. Or maybe, having fewer dependents, gay men are less motivated to work overtime or to seek promotion.

But still, based on the more scientifically sampled studies, it seems pretty clear that gay people earn either the same as or somewhat less than heterosexuals. It's time to retire those "statistics" about the supposed affluence of our community. They may make us feel good, but they're probably wrong, and they also feed into a belief

that we don't need gay-rights legislation.
