Court Says Boy Scouts Can't Ban Gays

Trenton, NJ — The Boy Scouts of America's ban on admitting gays violates New Jersey's laws against discrimination, a state appeals court has ruled.

The court said the Scouts' decision to kick James Dale out of the Boy-Scouts because he is gay should be overturned.

the Boy Scouts of America and its local councils are "places of accommodation" that "emphasize open membership" and therefore must adhere to New Jersey's anti-discrimination law.

New Jersey's anti-discrimination law was expanded in 1992 to prohibit most organizations from discriminating on the basis of sexual orientation.

An attorney for Dale said this is the first time any appeals court has ruled against the Boy Scouts in challenges to their exclusion of gays. A spokesman for the Boy Scouts' national headquarters said the decision will be appealed to the state Supreme Court.

Dale earned 30 merit badges, seven achievement honors and other awards, and was an Eagle Scout during his 12 years in the organization. He last served as an assistant scoutmaster.

He was expelled by the Monmouth Council of the Boy Scouts in 1990 after the group learned from a newspaper article that he was gay. He sued and a lower court judge ruled in the Scouts' favor in 1995, calling homosexuality "a serious moral wrong" and agreeing with the Boy Scouts of America that the group is a private organization and has a constitutional right to decide who can belong.

The Appellate Division of State Superior Court overruled that decision, saying

"There is absolutely no evidence before us, empirical or otherwise, supporting a conclusion that a gay scoutmaster, solely because he is a homosexual, does not possess the strength of character necessary to properly care for, or to impart BSA humanitarian ideals to the young boys in his charge," the decision read.

All three members of the appellate panel agreed that Dale should be restored as a member of the Boy Scouts. One judge, however, disagreed that the Boy Scouts should be forced to reinstate Dale to a leadership position. The dissent means the decision can be automatically appealed for a hearing before the state Supreme Court.

Gregg Shields, spokesman for the Boy Scouts of America, said an appeal will be filed. Shields said the scouts "have long taught traditional family values, and a homosexual is simply not a role model for those values." Dale, now 27 and working in New York for a publishing company, said he was elated by the decision.

"This is everything that I was taught in the Boy Scouts, that justice will prevail," Dale said. "It's a wonderful victory for scouting. I was taught in Boy Scouts that you stand up for your rights, that when you know something was right, deep down, you go for it."

In a related decision, the national executive board of the Boy Scouts has voted to create a new division of Explorer scouting that will allow posts to choose their religious standards, spokesman

Gregg Shields said.

The Explorer program — which involves scouts from the ages of 14 to 20 - will be split into a newly created Venturing division as well as Career Exploring, Shields said from Scout headquarters in Irving, Texas.

Venturing programs will retain "traditional standards for duty to God," Shields said, while Career Exploring posts will be

allowed an option.

The change could avert some court challenges to the scouts' requirement of a belief in God and also its ban on gay youths and gay adult leaders,

Two such discrimination suits now before the California Supreme Court were filed by a man who was expelled because he is gay and twin boys who were thrown out because they do not believe in God.

Scout lawyer George Davidson argued before the court in January that homosexuals and atheists do not belong in an organization that teaches conservative sexual morality and promotes a duty to God. The court's decision was expected this month.

Last month, Chicago settled a lawsuit by agreeing to sever its ties to scouting programs until the group accepts gays and stops requiring a religious oath.

The American Civil Liberties Union had sued alleging the city's involvement violated the separation of church and state and that the Scouts' ban on admitting gays is discriminatory.

Action Urged in Response to AB759

Madison — A bill which would limit the use of state funds to pay for health insurance coverage for state or local government employees; their spouses; and their dependent children would also deny health insurance benefits to domestic partners of state and local government employees; it is in, according to its sponsors, response to the Madison school district's decision to offer "DP benefits".

The bill was introduced on February 3, 1998, by Reps. Stephen Nass (R-Whitewater), F. Lasee, Grothman, Ladwig, Owens, Schafer, Ainsworth, Hahn, Urban, Albers and Kreibich; cosponsored by Senators Fitzgerald (R-Juneau) and Zien.

A committee hearing was held Thursday, February 19, 1998. One person testified for the bill (the bill's author), and thirteen people (some representing themselves; some representing organizations and public employee unions) testified against the bill.

Action Wisconsin, a statewide gay rights lobbying group issued a statement and believes the bill is "bad public policy," and is "a reaction to the Madison school district's recent decision to offer health insurance coverage to domestic partners of teachers, it is apparently an attempt by a few legislators to control local governments outside their own districts. This is both undemocratic and insulting to local taxpayers."

Action Wisconsin is encouraging interested persons to contact their legislators to express their opposition to the bill.

Alaska Court Rules Ban on Same-Sex Marriages Unconstitutional

Anchorage — An Alaska state superior court judge has given the move to legalize same-sex marriages a healthy boost after several years of setbacks in state legislatures around the country.

Superior Court Judge Peter Michalski ruled, in a 13-page decision, that gays and lesbians can choose their life partners as a "fundamental right" that the state of Alaska cannot deny without showing a compelling interest in refusing to grant them marriage licenses.

The case, which had gotten little news coverage, arose when Jay Brause and Gene Dugan sued the state last year after being denied a marriage license in 1995. The Alaska attorney general's office had asked Judge Michalski to dismiss the Brause-Dugan suit, but instead he ruled that tradition isn't an adequate guide for legal decisions, and that even the state legislature cannot circumvent constitutional rights by enacting measures, as the state lawmakers have done, barring such marriages.

"It is the duty of the court to do more than merely assume that marriage is only, and must only be, what most are familiar with," Judge Michalski said in his ruling. "In some parts of our nation mere acceptance of the familiar would have left segregation in place."

In addition to deciding that the suit should go forward, the judge also ruled that to justify violating the rights of gay and lesbian citizens to legally marry the attorney general's office will have to establish a "compelling state interest" in refusing marriage licenses to

The legal phrase — "compelling state interest" — is the most difficult test a court can set and means Alaska officials could have a difficult time arguing their case.

John Gaguine, an Alaska assistant attorney general who unsuccessfully argued the case, immediately said the state would appeal Judge Michalski's ruling to the state supreme court.

"We argued that it's not sex discrimination because no person can marry a person of the same sex," Gaguine said. "It's the same for a man and as it is for a woman. We're not really prohibiting anyone from doing anything."

If the state's high court refuses to hear the appeal for any reason, it would put the lawsuit back in Judge Michalski's court to prove a compelling interest, which Gagnine acknowledged would be "an extremely high standard to beat."

On the other hand, if the state supreme court does hear the appeal, it would not actually be ruling on the merits of the lawsuit itself but instead would be reviewing Judge Michalski's requirement for the state to prove a compelling interest for refusing marriage licenses to same-sex couples. While state high courts usually don't like overturning such lower court decisions, it could in fact nullify Judge Michalski's ruling and return the original suit to his court for a rehearing - without a "compelling state interest" requirement.

Whatever course the case takes, both sides agree that although this current ruling is a big-boost for advo-

cates of same-sex marriage, the suit is far from over and will doubtless take several years to resolve.

Brause and Dugan, who have been a couple for 18 years, told reporters they were "encouraged" by Judge Michalski's ruling, but said the suit still has "a long way to go" before they get a marriage license in Alaska.

"It's fundamentally about being treated as an equal," Brause told reporters.

Robert Wagstaff, the lawyer representing the two gay men, said the state's refusal to give same-sex couples marriage licenses is "clearly discriminatory" and that he doesn't think the state can prove a compelling interest in refusing such licenses.

"It's denying people of the same sex the rights that are granted to people of the opposite sex," Wagstaff said. "There really isn't any compelling reason. The state really has offered no reason other than 'That's politics' and 'That's what the Bible says."

In 1993, the Hawaii supreme court issued a ruling that made gay rights advocates think same-sex marriages were just around the corner. The court said denying marriage licenses to same-sex couples constituted sex discrimination, and it directed the state to demonstrate a "compelling state interest" for that discrimination. Arguments were heard two years ago, and the court's ruling was expected late last year, but so far no decision has yet been handed down in that case.

Alaska state Senator Loren Leman, who sponsored the legislature bill banning same-sex marriage in the state, said he had little confidence in the state supreme court's ruling, and adding that a constitutional amendment may be needed to reverse the decision if the courts rule in favor of gay and lesbian marriages.



UN Links Human Rights and AIDS Pandemic

ACT UP and similar groups were right that "silence does equal death" in the epidemic

Geneva — In its growing efforts to tackle the AIDS epidemic that's raging around the world, United Nations AIDS officials are increasingly sounding like radical AIDS activists of the 1980s in the U.S. and other countries, and is having to face some realities that not only does "Silence = Death" but also that discrimination — against homosexuals, prostitutes, drug users — is ultimately unhealthy.

The UN says efforts to bring the global AIDS pandemic under control will continue to elude health officials unless discrimination against people infected with the virus is ended. To that end, the UN Human Rights Agency has joined with the UN AIDS Program in proposing some general steps they say would help protect the human rights -

and health — of people with AIDS.

UN officials say the epidemic continues to spread at an alarming rate around the world, even though new infections in many Western, industrialized countries have now leveled off. Last year, for example, nearly six million people globally were infected with HIV, and the UN now estimates that by the end of this century — less than two years from now - there will be some 40 million people infected with the virus.

UN officials are now saying — as AIDS activists in the U.S., Great Britain, France and other Western nations argued more than a decade ago — that discrimination, intolerance and prejudice against people with AIDS is growing as quickly as the disease itself

Miriam Maluwa, a human rights advisor with the UN AIDS Program, says discrimination and the fear of it discourages people at risk for infection from seeking medical help and those who are already infected from even acknowledging they are HIV positive. Both, Maluwa says, have serious consequences for their communities.

People never know who is infected," Maluwa said. "And that increases the community within which they live to be vulnerable to further infection. If discrimination was tackled, if people didn't feel stigmatized, there would be perhaps more people who would come out in the open about the infection, and in so doing would reduce the prospect of them infecting other people.

Maluwa said that indeed the 1980s activists in ACT UP and similar groups were right that "silence does equal death"

in the epidemic.

In its new human rights handbook for people with -HIV/AIDS, the UN calls on governments around the world to deal with the problem of discrimination many AIDS patients face. The handbook also urges governments to provide health care for people stricken with the disease and to candidly and

aggressively educate their citizens about how the disease is spread and what precautions can be taken to minimize the risks of infection.

David Patterson, another UN human rights adviser, says the new proposals also call for the elimination of what he calls "punitive laws."

Patterson says UN health officials would like governments to repeal "criminal laws which make it very difficult to access particular communities that are vulnerable to the epidemic - including prostitutes, IV drug users, homosexuals and others.'

A second type of legislation the UN would like member nations to enact, Patterson says, would be anti-discrimination laws "to protect people affected and infected" with HIV. A third area of legal reform that should be addressed, Patterson says, would include "enabling laws ... to address this issue of vulnera-bility." Child protection laws, literacy and minimum education guarantees and similar legislation, Patterson says, would be important changes of this third type to help improve the basic conditions under which groups of citizens function in the nation.

Zimbabwe might be a classic illustration of the links between law and health, some human rights activists say.

The repressive government there, headed by President Robert Mugabe who has no qualms about calling homo-sexuals "pigs" and "dogs," turns a blind eye to the status of women in the country and offers little in the form of health care or AIDS education. When prostitutes are killed, police do little or nothing to solve the murders.

Gays and lesbians are regularly detained without formal charges being filed against them, and are beaten by police in an effort to identify other

Speaking in the U.S. recently, Tina Chipo Machida of Gays and Lesbians of Zimbabwe, said lesbians in the country were frequently raped with impunity because their attackers knew the women were very unlikely to go to police to report the assault because authorities were more likely to arrest the victim than to investigate the rape itself. "Coming out of the closet is like climbing into a coffin," she said of being openly gay in Zimbabwe.

International human rights activists increasingly believe there is a connection between Zimbabwe's enormously high HIV infection rate and the fear the exists among many of the country's citizens most vulnerable to being stricken by the

Health officials estimate that there will be more than 600,000 children orphaned by the AIDS epidemic by the year 2000, and currently one million Zimbabweans are believed to be HIV positive - nearly a 10 percent infection rate in the country of

10.5 million people.

And the UN now agrees with international human rights activists who say that repressive and discriminatory laws in countries like Zimbabwe and others are significant contributors to the epidemic continuing rapid progression throughout much of the world.

Simplified Las Vegas School **Policy Raises** Concerns

Las Vegas - The Clark County (Nev.) school board, which runs the school system in Las Vegas, has adopted a simple anti-harassment policy comprised of just 45 words.

But while the new anti-bias policy has drawn praise from some because of its simplicity, civil rights activists have objected to the new, strippeddown wording because it doesn't actually identify

"Harassment will not be tolerated, regardless of its basis," the new policy states, without naming any of the groups that traditionally are included in such bans.

School board members had initially considered a policy reading, "Harassment is prohibited regardless of whether it is based on race, color, age, creed, religion, national origin, sexual orientation, handicap, or marital or parental status, or any other basis." But they abandoned that for the simplified version that doesn't identify any groups, arguing that it was "more direct."

But Carol Keck, head of the local Parents, Families and Friends of Lesbians and Gays, said that stripping out the names of specific groups weakens the policy because members of those groups are most often the targets of harassment and mistreatment.

"In theory it may be fine to say the policy is 'no harassment of anyone,' but in reality blacks and Hispanics and gays and others are the ones who are harassed," she said. "So naming those groups specifically reinforces that harassment of them won't be tolerated and not naming them weakens the policy."

Cops & Cruisers **Using the Same** Internet Resources

San Diego — On opposite coasts of the U.S. in late February, anonymous public sex was making news - and taking a new high-tech direction in a double-edged cautionary tale.

In San Diego, the local ABC-TV affiliate launched an investigative report exposing anonymous sex at a bathroom at San Diego State University. Three-thousand miles away, police in Dorchester County, South Carolina, began a crackdown at a rest stop along Interstate 95 just south of St. George, S.C., arresting 11 men in a one-day sweep.

found via the Internet where sites on the World-Wide Web and in news groups list information often in great detail and with up-to-the-minute reports - on where men can go to find casual, anonymous sex. Among the hundreds of spots listed were both the San Diego State University bathroom and the I-95 highway rest spot in South Carolina. Finding the listings was a simple matter of searching the WorldWide Web, and then looking up the locations.

And that is exactly what the reporters in San Diego and the Dorchester County, S.C., sheriff's

According to police reports, the men arrested in South Carolina ranged in from 30 to 66 years in age and were booked on a variety of charges ranging from indecent exposure to public lewdness to prostitution. Police said most of the men were from South Carolina, but others came from six other states. While most of the men were released on per-

sonal recognizance, police said one man was bailed out of jail by his wife.

In San Diego, there were no arrests because the television station was busy so its cameras would "catch a sex act involving several men" in the university men's room where the station's roving reporter was acting as a decoy in order to get the video footage for the newscast.

Even so, the TV station showed its clandestine videotape to police, who apparently took a much more sanguine view of the bathroom sex than the shocked reporters. A San Diego police officer quoted in the report said simply that the men in the restroom were "looking for basically a cheap thrill" and that many of them are "in fact married men."

What police do say, however, is that even if the Internet makes it easier for such public sexual hot spots to be publicized for the men who use them, the giant computer network system also makes it equally easy for law enforcement officers to find

One gay police officer, who asked not to be identified, said the police department where he works has "far too much serious crime to deal with to bother surfing the Web looking for relatively minor criminal offenses.

But even so, he added that in law enforcement agencies or for individual officers looking to increase their arrests, Internet resources like the ones already online that detail information about such anonymous sex locations "just make their jobs easier."

He also predicted police use of such web sites was more likely to increase as more and more individuals --- including police officers -- turn to the Internet's massive collections of resources, whether that was the intention or not.

Brazil's High Court Rules Gays Have Right to Inherit

BRASILIA - Brazil's supreme court has unanimously ruled that a surviving partner of his gay lover does have the right to inherit the deceased man's property in a ruling that gives same-sex couples in the country broad legal rights.

The high court made its ruling in the case of Milton Alves Pedrosa, whose partner, Jair Praero, died of an AIDS-related illness in 1989.

The two men had purchased an apartment together and Praero's father had claimed ownership of the dwelling after

In handing down the ruling, the court said, "Their sexual behavior may go against moral standards, but the civil union between them is legitimate."

Ross Perot May Yank Benefits Package at His Computer Firm

NEW YORK - Ross Perot, the Texas billionaire who has twice made bids for the presidency, says his Houston-based computer firm, Perot Systems Corp., might drop its domestic partnership benefits program.

Perot questioned the fairness of such partnership benefits packages because they don't apply to non-gay relationships, such as unmarried heterosexuals living together or to people who are just roommates.

Extending benefits for such couples or roommates, however, would "start getting expensive" the Texas tycoon said. The partnership benefits program at Perot Systems was put into place in 1997 by James Cannavino, the former CEO of the firm.

During his 1992 presidential campaign, Perot irked rights activists when he said during a national TV interview that he wouldn't consider appointing any openly gay or lesbian person to his cabinet if elected because, "I don't want anybody there that will be a point of controversy with the American people."

Non-Gays Want Partner Benefits in Oakland

OAKLAND - Allen Edwards, an Oakland, Calif., city employee, has joined in an earlier complaint to state labor officials charging that the city's domestic partnership measure is illegal because it extends health care and other benefits only to same-sex couples but not to opposite couples.

The year-old benefits program for city workers extends medical coverage to the partners of city employees on the same terms as existing benefits for spouses of married workers.

Last year, Mickey Ayyoub, another Oakland employee, filed a similar complaint with state labor officials because the city refused to allow him to get health insurance coverage for his female partner through the program.

State Labor Commissioner Jose Millan ruled in October that the Oakland partner benefit program does in fact discriminate and ordered city officials to extend the program to include unmarried opposite-sex couples as well, but the city has refused to do so even though an appeal of Millan's ruling was upheld.

Ayyoub told reporters he and his female partner didn't want to get married, which would have allowed her to enroll in the benefits programs as his spouse, and that "our com mitment should have the same value as (the commitment of) gay and lesbian people."

Millan has said that if Oakland officials don't change the benefits program soon the state may be forced to sue to force compliance with the earlier ruling.

Anti-Gay Candidate in Miss. **Congressional Race**

LONG BEACH, Miss. — One of the contenders for the Republican nomination to run in Mississippi's 5th congressional seat race may be familiar to rights advocates.

In 1994, Karl Mertz, then an equal employment opportunity officer with the U.S. Department of Agriculture, created a controversy when he objected to efforts by the department to hire gay and lesbian employees. He was later removed from his post because department officials said he couldn't carry out anti-bias policies if he objected to them.

In his congressional bid, Mertz is espousing some traditional conservative positions (banning partial-birth abortions, abolishing the IRS, reducing the size of the federal



Barney Frank Makes Milwaukee Appearances

Milwaukee — U.S.Rep. Barney Frank, in his recent visit to Wisconsin, urged a renewed effort to put a human and humane face on capitalism when he addressed Congegation Shalom after a Friday night service.

"Sixty-five years ago FDR (President Franklin Delano Roosevelt) began to put a human and humane face on capitalism. The basic principle of the New Deal was that government should help people in

trouble," Frank said.

The prevailing view until then had favored trickle down economics, which holds that when the free market has its way it will take care of everybody, and the rising tide of the market will lift all our boats with it. But, Frank cautioned, it does not help people who have no boats, and are standing on tiptoe. Capitalism and the free market increase the tide without regard to individuals, and that is where the role of government should come in, he maintained.

Some people can get hurt through no fault of their own, Frank said. Some workers, for example, make bad choices.

"Forty years ago, in the garment trade, some people became cutters and pressers, and then, after 30 years in the business, found they could no longer make a living.

"Their only fault was not to have a vision of how international trade would develop in 30 years," Frank said.

develop in 30 years," Frank said.

To make some adjustments in the economy does not hurt the economy, he pointed out. For example, in 1995 the minimum wage was raised. And before that change was accomplished, there were predictions of disaster. Businesses would suffer and jobs would be lost., some said.

"That didn't happen. More people were employed, making more money," he said.

Also, when taxes were raised on the wealthiest group, with incomes of \$150,000 and over, in 1993, that reduced the deficit more than anything in recent years., Frank said.

One problem, he saw, and a major one, is contending with a global economy.

"Today, if you own capital, you can invest that money anywhere in the world.

"Countries are told that the key to economic development is to attract capital. So to persuade people to invest, the countries offer low wages, reduced workers rights, and weak environmental laws, to show them that they can make more money investing in their country than elsewhere.

There is a competition for capital, with no restrictions on capital.

In his view, what is needed is international cooperation, so that certain minimum standards can be set, to get rid of child labor by nine year olds.

"This is the challenge of the technological age, and the international mobility of capital. We are for increased legal mobility of capital internationally, but (should) require some conditions.

His conclusion was that many countries desire access to the American market, and that the United States could grant this access with certain conditions, minimum standards protecting children, the environment and workers' rights.

On Saturday, February 28, Frank was the guest of honor at a fund raising event for Madison Congressional hopeful,

Tammy Baldwin.

Colorado School District Settles With Gay Rights Student Club

Denver (AP) — A settlement was reached last week between the Cherry Creek School District and a high school gay rights club that sued, demanding it be treated like any other club.

District officials agreed to treat the Homosexual Heterosexual Alliance Reaching for Tolerance as an official club at Smoky Hill High School, "with all the rights and responsibilities of other student-initiated clubs," the students' attorneys said.

"This is a great bunch of kids and they should be very proud," said attorney Dwight Pringle. "They got virtually everything they wanted."

Pringle and Colorado Legal Initiatives Project, a gay legal defense fund based in Denver, represented the students.

The student group filed a civil rights lawsuit in January alleging the district had censored its publicity, refused to recognize it as an official club and ordered a counselor to oversee its activities.

Pringle said following a court hearing before U.S. District Judge Zita Weinshenk, the district agreed to enter a consent decree granting the student club all the relief it was seeking.

Under the agreement, the district also rescinded a directive the student group be converted to a support group run by a

In addition, the district agreed not to censor the group's materials, attorneys said.

The students' lawsuit claimed school officials had censored words such as "homosexual," "lesbian" and "gay" from the club's posters.

The high school club's 25 members, both gay and heterosexual, meet to discuss personal and social issues.

Military Ignoring "Don't Ask, Don't Tell," Group Charges

Washington, D.C. — Harassment of gays and lesbians in the U.S. armed forces has risen for the fourth straight year despite the Clinton administration's pledge to combat discrimination against homosexuals in the armed services, according to the Servicemembers Legal Defense Network (SLDN).

In its annual report, the Washington-based rights group said it had received reports of 563 "command violations" from service members, including instances where commanders harassed service members in direct violation of President Clinton's "don't ask, don't tell" policy, investigations that were begun with no credible evidence, and violence against service personnel believed to be gay or lesbian.

The report charges that military commanders aggressively investigated the private lives of military personnel they believe are gay or lesbian and failed to protect-them from harassment by other

service members.

The report describes what it calls "heavy handed and increasingly intrusive investigative tactics against suspected gays, including coercion and fishing expeditions." In addition, it charges that there is "no recourse or redress for service members asked, pursued or harassed" and that those who violate the policy are not held accountable for their actions.

The report says such reported violations have increased each year since the so-called "don't ask, don't tell, don't pursue" policy was adopted in 1993, rising from 340 in 1994 (the first year the policy was in force). According to the report, there were 443 reported incidents in 1996 and 563 in 1997 - a 27 percent increase in just one year.

"The violations we are seeing are very basic," said Michele Benecke, a director of the organization. "They should not be occurring five years into the policy. Don't ask means don't ask. The rule could not be more clear, but time and time again,

investigating officers ask.'

Among the reported incidents, of course, was the highly publicized case of 17-year veteran submarine Senior Chief Petty Officer Timothy R. McVeigh whom the Navy began investigating because of an anonymous profile on McVeigh's personal America OnLine account. Despite possible violations of federal laws in obtaining the information from AOL about McVeigh's account, a federal judge in January ordered his discharge halted saying it "violated the very essence of 'don't ask, don't pursue.'

Among the incidents cited by the Servicemembers Legal Defense Network's annual report were 124 cases in which commanders broke the simplest part of the "don't ask, don't tell, don't pursue" policy by bluntly demanding that military personnel

tell them if they were homosexual.

According to the report, in 235 other cases commanders launched investigations into the sexual orientation of service personnel without any "credible evidence" - meaning more than one person saying that someone was gay or lesbian.

And in another 182 cases, the group cited 182 incidents of anti-gay harassment, including reports of beatings and death threats against service members who were believed to be homosexual. This figure alone, SLDN says, reflects a disturbing increase of 38 percent over similar harassment reported in

the year before.

In one instance, the report described what it called a "most harrowing set of cases" on the aircraft carrier Eisenhower during a two-month period last year. One sailor was knocked unconscious by an assailant who called him "a faggot" in an off-base assault, just days after his car tires had been slashed on base. Another sailor in the same command unit found a note tacked to his bunk on the carrier which read, "Leave or Die" along with an anti-gay slur. Another had a similar threat written in ketchup on his bunk.

But "the ship's command did little to attempt to track down the perpetrators, and instead investigated the private lives of the threatened sailors and questioned their veracity." All of the sailors who complained of the harassment were discharged.

The response was, the report charges, in direct violation of a memo sent out by the Pentagon last year stating that "servicemembers should be able to report crimes free from fear of harm, reprisal or inappropriate or inadequate governmental response."

In another case included in the report, Kevin Smith, a Marine Corps lance corporal was hospitalized after being attacked outside a gay bar in San Angelo, Texas, last September by other Marines.

Smith's sergeant was more interested in determining whether the victim was gay than in tracking down his attackers, the SLDN reports says. The sergeant pressed Smith about his sexuality and, fearing an investigation, Smith left the military.

The group also noted the case of an Air Force woman from Louisiana accused of being a lesbian by a former roommate, who later retracted her statements and said they were false. But the woman was discharged anyway, "despite the lack of evidence," the report said.

Defense Department officials said they had not seen the report and could not comment on it.

Wisconsin AIDS Hotline Established For Teens

Milwaukee — Carrie Staller, 18, a student at Nicolet High School, has been answering phones on the AIDS Resource Center of Wisconsin's (ARCW) Wisconsin AIDSline during its teen hours since this new initiative began in July.

She and other teens working on the Wisconsin AIDSline want their peers to ask any questions about AIDS that they may have and encourage teens not to put themselves at risk of contracting HIV. All calls are anonymous.

"I think that it's important that teens volunteer, give something back to the community and prepare to take our positions in society," said Staller. "We are the new generation."

When working on the Wisconsin AIDSline, she finds that there is one question most commonly asked:

Caller: "Where can I get tested?"

Staller: "There are anonymous testing sites, where names are not kept on file and confidential testing sites, where medical records are kept but not revealed, in all Wisconsin counties. Would you like to hear about the ones in your area?"

She knows the answer to questions about AIDS because she and other teens who serve on the three-hour shifts, 3 to 6 p.m. or 6 to 9 p.m., Monday through Thursday, have taken extensive training at ARCW.

"The teen hours appear to be the practical way to supply correct information in an easily -moreaccessible form," said Neil Albrecht, ARCW regional director.

He explained that it began in response to suggestions from focus groups. "We wanted to learn-what kind of prevention efforts would be effective with teens and the focus groups came back with peer education as the best tool," said Albrecht.

"Teens need to be able to talk to other teens. Peer education is a highly effective prevention strategy," said Albrecht. "In recent months, teen calls to the Wisconsin AIDSline have nearly doubled."

Estimates are that 50 percent of all new incidences of HIV infection are in people under the age of 24. One recent study co-sponsored by Yale University and MTV Cable indicated that many teens seem to be uninformed about the risks of contracting the disease through the exchange of bodily fluids, namely sexual intercourse.

Ten teen volunteers have completed a minimum 25 hours of training plus three, 3-hour shifts of observing other Wisconsin AIDSline operators. Teens staffing the Wisconsin AIDSline will be supported by an adult at all times and generally work two shifts a month.

Posters and informational flyers have been sent to principals at public middle schools and high schools across the state, and to some private schools. Posters and flyers have also been sent to coffee houses and other teen gathering places.

Teens in the Milwaukee area may call the Wisconsin AIDSline at 414-273-AIDS, and those across the state may call 800-334-AIDS.

Prostitute with AIDS Under Investigation in Italy

ROME — Vittorio Vicini, the prosecutor in the Italian city of Ravenne, has stirred the anger of many AIDS activists in the country after he issued information and photos of Giuseppina Barbieri that appeared in newspapers and television stations throughout the country identifying her as a prostitute who is continuing to have unprotected sex with customers even though she has AIDS.

Vicini said the information released to the media "isn't a violation of her privacy, but a warning to the public." AIDS activists, however, said officials had violated the woman's privacy without any evidence she was posing any threat to the public health.

Barbieri is reportedly being investigated by officials for possible criminal charges that she has continued to have unprotected sex with clients even though she has known for two years that she was infected.

N.Z. Prime Minister to Attend 'Hero Parade'

AUCKLAND — The Auckland city council earlier this year refused to recognize the country's largest gay pride event, the Hero Parade, with a proclamation, but New Zealand's Prime Minister Jenny Shipley has announced that she will attend the event.

Rights activists had high praise for the prime minister's decision as "a very visible gesture of support for what the Hero Parade stands for."

A spokesperson for the prime minister's office said her attendance was "no big deal" because Shipley, once the country's health minister, supports efforts like the parade's campaign to educate homosexuals about HIV and AIDS.

Teenager Kills Lover Claiming 'Embarrassment'

MIAMI — Police have charged Kervaris Pollack, 17, with 1st degree murder in the shooting death of Larry Sheppard, 24.

According to police, Pollack told them he shot Sheppard because the man showed up at his high school with presents and other students had learned the two were having a relationship.

Pollack reported told police he was embarrassed about his sexual relationship with Sheppard after his classmates learned of it because of the man's visits to his high school with gifts for him.

Sheppard's family, however, says Pollack was motivated by greed, not shame, noting that the teenager had taken the dead man's car and credit cards after killing him.

'Millennium March' Plans Temporarily Suspended

WASHINGTON, D.C. — Just ten days after announcing it, the Human Rights Campaign and the Metropolitan Community Church have said they were at least temporarily suspending plans for a "Millennium March" on the nation's capital in the year 2000 because a number of organizations that were expected to support the march had instead criticized announcements of plans without enough discussion.

An HRC press release had indicated the proposed march had the support of a number of national groups, including the National Gay & Lesbian Task Force, the National Black Lesbian & Gay Leadership Forum, the National Gay & Lesbian Alliance Against Defamation, the National Center for Lesbian Rights, the Gay & Lesbian Victory Fund, Parents, Families & Friends of Lesbians & Gays (PFLAG), and the National Latino/Latina Lesbian and Gay Organization.

The event, if it takes place, would be the fourth march gay rights advocates have organized, but ironically, it will be the first that doesn't actually include the words "gay" or "lesbian" in its title — a decision organizers said was made to try to avoid controversy over naming more and more specific sub-groups in the march's title.



"We are happy to receive the 501(c)(3) designation. Members and donors have given generously to the Center knowing that their contributions would be tax deductible. With this official designation from the IRS, past and future donations are tax deductible to the full extent of the law," said Julie Ellsworth, Chair of the Development Committee.

The Advance Ruling will be effective until a final and permanent determination of tax exempt status is be made by the IRS after four full years of operation, in the year 2002.

"The designation continues the process of establishing the Center as a viable project. It validates our mission statement, vision and programs," said Center spokesperson, Joshua Feven.

Transgendered Author To Make Milwaukee Visit

Milwaukee — Riki Wilchins, author of Read my Lips, Sexual Subversion and the End of Gender is being hosted in Milwaukee for a book-reading and booksigning by Gender Gemini Group and AfterWords Bookstore.

Riki, considered by many, the brightest and most articulate transgender spokeswoman of her activist generation is famous for her rapier wit, razor tongue and street-smart activism.

Read My Lips, currently number four on the Lambda list, changes current thinking about bodies, sex and gender. Riki's voice is outraged, outrageous, sad, and hilarious as she weaves theory and personal experience into her account of what it means to be "gendered" in the postmodern world. Her story of self-discovery is compelling both by the way she lives it and thinks it through in the highly accessible, personal and theoretical narrative she constructs. Her book is a unique mix of theory and application, anecdote and affront.

Riki Wilchins is the co-founder of the Transsexual Menace, a direct action group, calling attention to the discrimination and violence facing transgendered people. She is also Executive Director of GenderPAC, a public advocacy coalition dedicated to pursuing gender, affectional and racial equity. For the past two years, Riki has been one of the main organizers of National Transgender Lobby Days, which brought these issues directly to Washington. She is currently working on two more books.

Chicago Black Lesbians and Gays Announce Unity IV Conference

Chicago — Dr. Marjorie Hill, psychologist, and Phill Wilson, co-founder of the National Black Lesbian and Gay Leadership Forum will be the keynote speakers for Chicago Black Lesbians and Gays' (CBLG) fourth annual Unity conference scheduled for April 3 and 4, 1998. For the last five years CBLG has supported Black lesbigay/trans community development through activities in both the African American and the gay communities.

This year's Unity IV theme is "Renaissance and Renewal: Celebrating Ourselves". The conference will acknowledge the work that has been accomplished by the groups within Chicago's Black lesbigay/trans community. The conference will take place at Chicago Holiday Inn City Centre, 300 E. Ohio. The location is fully wheelchair accessible and sign language interpreters will be available.

Dr. Hill, a nationally recognized lesbian activist, and the former director of the New York City Mayor's Office for Lesbian and Gay issues during the David

Dinkins' administration, will speak. During her tenure Dr. Hill successfully negotiated the inclusion of a lesbian and gay contingent in N.Y.C.'s St. Patrick's Day Parade. Dr. Hill is currently a commissioner for the New York State Workers' Compensation Board. Dr. Hill is the assistant vice president for special populations at the New York City Health and Hospital Corporation, the nation's largest public health network. Dr. Hill was the first open lesbian to serve as president of the Association of Black Psychologists. Dr. Hill also was prominently featured in the video All God's Children, which examined issues of homophobia in the Black Christian Church community.

Chicago born Phill Wilson's work as the co-founder of the National Black Lesbian and Gay Leadership Forum helped shape the Forum into a respected voice representing Black lesbigay/trans people nationally. Wilson was among the group of leaders participating in the first ever meeting of lesbians and gays with a sitting President during President Bill Clinton's first term. Wilson is an HIV activist and is the director of public policy for the AIDS Project Los Angeles.

For the very first time this year's UNITY IV is a two day event. Unity IV features dialogue on community issues, workshops, cultural displays, a film and video forum, institute tracks and networking. Unity IV concludes with a Banquet and Gala Celebration which will be acknowledge CBLG's fifth anniversary.



TRIBAL TALK

Ti's been a while since I've updated you, my dear readers, on my health status. I never wanted this column to be just about "living with AIDS" even though it can be an overwhelming fact of one's existence. I don't want to turn off those of you who really could give a damn about my latest drug protocol, t-cell count, or viral load. But, I've heard from enough of you who DO want to know, and I like to be as open as possible with those people. So, for the rest of you, just skip over this next segment, and pick up reading, after my "Health Update".

My current HAART (Highly Active AntiRetroviral Treatment) regimen includes the 'nukes' 3tc and d4t since September of '96. In September of '97 my protease inhibitor was switched to Nelfinavir, and Nivarapine, a non-nuke, was added to my regimen one month later (in October) after Nelfinavir (my fourth PI) didn't have much of an effect for the first five weeks. By Nov. 12, my viral load went undetectable and my CD4 (t-cells) went from 82 to 87.

My virus stayed undetectable for a whole month and is now steadily, but slowly rising, until it reached a little over 16,000 on Feb. 24th, with a CD 4 count of 78. The first week of December, I began doing daily subcue injections of Interleukein 2, at the urging of my oncologist who wants to build up my NK killer cells, to fight off any future leukemia return. I've been on IL2 in the past, and it is a double edged sword.

It gives you flu like symptoms, and I get lumps at all my injection sites, which seem to take forever to completely go away. IL2 has also been used for HIV, to boost the immune (CD4 Cells) system. There is currently an ongoing controversy about the effect of IL2. Some researchers say it "flushes" the "resting" (sleeping) cells awake.

Flushing wakes up the killer cells my oncologist likes to see, and it also wakes up my CD4 cells, which can *seemingly* increase my counts. During the time I took the IL2, my CD4 (helper t-cells) went from 87 on Nov. 12, to 74 on Dec. 30, to 141 on Jan. 27, to 43 on Feb. 10, to 84 on Feb. 24, when I took my last injection. Talk about a roller coaster!

On top of that, IL2 also can awaken dormant cells that contain latent HIV, flooding my blood stream with more, active virus. IF, and that's a big if, my viral load had been suppressed by my drugs, the new HIV released by the dormant cells awakened by the IL2, should have been killed off by my meds. However, my drugs probably had stopped working about the time I began the IL2.

In retrospect, and after new research I've done, thanks to the web, I wouldn't have agreed to the IL2, until my viral load was suppressed at undetectable levels for at least two months. Then, and only then, would I have done the IL2 for it's potential positive effect. My research also indicated that IL2 is mostly beneficial to people who have more than 200 t-cells to start off with. Research has shown some stunning CD4 count increases using IL2 for those whose immune systems are still working at that 200 t-cells level and above. But even their increases can be transitory.

As things stand today, my infectious disease specialist is awaiting approval and the paperwork for two new "expanded access" drugs, because I've used up all the currently FDA approved HIV regimens. Hopefully, by the end of March, I'll be

adding Abacavir (1592) a new 'nuke', and Adefovir (Preveon) a whole new class of drugs called nuceloTide (not nucleoSide) analogs (nukes), and staying with the Nivarapine. I'll be dropping the Nelfinavir, 3tc and d4t. This will be the first time since Feb. '96 that I won't be on a protease inhibitor, but there isn't one currently available even on expanded access.

I also had another bone marrow biopsy on Feb. 24 to check for any signs of leukemia. Test results weren't back as of Monday, but I'm hopeful I'm still in remission. For those of you who have to have a bone marrow biopsy done, IF you have a good doctor, who has done many of these invasive procedures before, and you get your doc to give you something like Ativan prior to the test (and for God's sake, don't look at the equipment they'll be using) they aren't as nasty as you've heard. Trust me, that was my ninth one!


Oral Sex Can Transmit HIV. Yes, another new report in the journal Sexually Transmitted Infections concludes that contrary to myths oral sex is not safe sex. Other reports indicate that even when a person with HIV has an undetectable viral load in their blood, HIV can still be found in semen. Another words, oral sex is not a no risk solution, and you should use protection, not only because of HIV, but because of Herpes and warts. The risk for HIV infection, however, is still substantially lower than for other forms of sexual intercourse.

An appeal was made recently at the annual meeting of the American Association for the Advancement of Science in Philadelphia for more help from across the scientific community in finding a vaccine against HIV. A leading researcher commented that with more than 40 vaccines in trials none has been shown to work safely in people, and pleaded for an influx of a broad range of expertise in studying the immune system all the way down to the molecular structure of cells.

Activist Alert! Save Domestic Partnership... The State House of Representatives is considering AB759 that would limit domestic partner benefits by prohibiting the use of state funds for insurance to cover the cost a local government entity may incur for such benefits. This would include school districts, cities, or counties. Please call your state Representative and tell them that 1) Domestic Partnership is an important tool to ensure that ALL Wisconsin families can access comprehensive health care services and 2) if local governments want to offer such benefits to their employees, then they should be allowed to do so without state interference. I know many of my 'sisters' and many of you readers made the trip to New Orleans for the annual Mardi Gras bacchanal. The dazzling celebration draws hundreds of thousands, many of whom are members of our tribes from across the country, to the bayou for this annual festival. The stories my friends have told me, and the videos I have seen lend an authenticity to media coverage that slammed the event for becoming a public "orgy". The general media really came down hard on all the nudity and



more of less declared the French Quarter off limits to "families". It seems local sentiment is growing to limit parade permits, crack down on underage drinking and public nudity, and get away from the anything goes image.

You can only assume, because of the way gays and lesbians are treated in general, that our part of the French Quarter will probably be the first area authorities will lower the boom on. Although, with the crowds, it's hard to imagine them being able to do too much, too quickly. Perhaps it would be best next year, to keep the lasciviousness in the bars, and tamper it a bit out on the streets. As one friend related, "God, I haven't had that much sex since the late 70's in the baths!"

Late last month, the European Union shattered the hopes of gay activists by ruling against a British lesbian railroad clerk who sought travel benefits for her girlfriend. The case had been considered a test of workplace equality for gays across Europe because travel benefits are available to the partners of heterosexual employees.

It seems the US. military's "Don't Ask, Don't Tell" gay policy is actually being treated as "Ask, Pursue, Harass" by many commanders according to the Service members Legal Defense Network. The group reported an increase of harassment of gays in the military in 1997 with 563 violations of the policy which is supposed to limit the way such cases are investigated.

Reminds me of the joke I heard about President Clinton needing a similar policy in the White House with for interns because of the Lewinski debacle. (Poor Monica, she left with a bad taste in her mouth...)

Clinton, did however, come to the defense of openly gay James Hormel (of Spam family fame) who he nominated as ambassador to Luxembourg. Hormel would be the first openly gay ambassador. Clinton was quoted as saying "Will he or will he not be a good ambassador... is all we should ever ask" when some Senate Republicans are trying to prevent a vote on the nomination because it would "promote a homosexual agenda".

That brings to mind the witty and often twisted Bruce Vilanch in his regular column, *Notes From a Blond* in the Feb. 17 *Advocate*. Vilanch complains about "the legion of people lately who whine, 'Must everything be so gay?' as if millions of gay people just showed up last week on some alien craft." Those who complain because we are not so invisible anymore and don't want us to be so pushy about it.

The Blond continues, "Your straight friends — and some of your gay ones — who want you to pipe down and be a little less gay are wring-

ing out the last vestiges of homophobia injected into them so many years ago. Many of them don't even know they have it... What we must realize is that homophobia is the status quo, so insidious and ingrained that it will sneak up on us in the most unexpected and casual places."

The changes for the newest edition of Wisconsin's PrideFest in late August including expansion into the Harley area to the south for a second main stage plus an expansion of food and activities, have me excited for our community and proud of the efforts of the Pride Council and all the volunteers. I can't wait!

Praise the Lord! And be in awe of the talent of Robert Duval in The Apostle. His fire and brimstone preacher is truly 'all that'. A more qualified Best Actor Oscar winner is hard to imagine, but I haven't seen all the actors nominated for this year's films.






According to Geo, his tavern down the street, Zipper's, was near a final sale agreement with an undisclosed purchaser.

"Hope Against Hope" World Premiere Set for March 13

Milwaukee — On Friday, March 13, at 8 p.m. Amethyst Productions will present the world premiere of *Hope Against Hope*, an original play by Peter Reeves based on the Mandelstam Memoirs at the Studio Theater of the Broadway Theater Center, 158 N. Broadway.

Hope Against Hope is a drama of intrigue, personal freedom, and the power of faith. In November of 1933, the Russian poet Osip Mandelstam wrote a satiric poem about Josef Stalin. Shortly thereafter, he recited it to a group of friends at a small, private gathering. One of the eleven people who were there that evening memorized it on the first hearing, and subsequently repeated it to Stalin, himself. The following May, 1934, Mandelstam became one of the first writers (certainly the most famous) to be singled out for "treatment". What followed for Mandelstam was a four-year odessy of exile, torture and eventual death.

Woven into this fateful tale, is a beautiful love story between Mandelstam and his wife, Nadezhda. Nadezhda, which means "hope" in Russian, survived this horrendous ordeal, and not only saved her husband's manuscripts, but wrote a wonderful detailed memoir "Hope Against Hope". Published in 1970, it is surely one of the most illuminating accounts we have today (or are likely to have) of life in the Soviet Union during the Stalinist purges of the 1930s. Sadly, "Hope Against Hope" has never been published in Russia, and the work of Osip Mandelstam remains almost completely unknown both there and in this country.

The cast, under the direction of Maureen Kilmurry includes: Pamela Brown as Nadezhda, and Tom Schimmles as Mandelstam. Other cast members are William Crawford, Terry Tuttle, Janet Petersen, Herschel Kruger, Howard Goldstein and Robert W.C. Kennedy as Boris Pasternak. The technical staff includes set designer Paul Gegenhuber, lighting designer Eric Appleton, stage manager Stacey Meyer, and costume designer Meghan Powell. An original music and sound score was composed by Ben Davis and recorded at Walls Have Ears Studios.

Madison Rep Tackles O'Neill's Autobiographical Masterpiece

Madison — A Long Day's Journey into Night, the autobiographical masterpiece of American playwright Eugene O'Neill, will open at Madison Rep on Friday, March 13 at 8 p.m. in the Isthmus Playhouse of the Madison Civic Center, and runs through Sunday, April 5.

O'Neill considered the play so truthful that he had a sealed copy of the script deposited in a safe with instructions that it neither be published nor performed until 25 years after his death. It was produced first in Sweden, and then the United State only three years after he died and, in that same year won a Pulitzer Prize for Literature.

For O'Neill, the work exorcised the demons of his immediate family that had haunted his life. The "Tyrone" family of the play is a thinly disguised portrait of his own. The character of James Tyrone (Paul Boesing), is his actor father, James O'Neill, a matinee idol who forever regretted abandoning the classics to keep poverty at bay. Mary Tyrone (Mary Ann Thebus), is the playwright's delicate and sensitive mother, Ella. Her addiction to morphine after Eugene's difficult birth was a well-kept secret that took an enormous toll on the entire family. James Jr. (Jamie) played by Mark Ulrich, is the elder brother--an alcoholic and failed actor. The character of Edmond (Tom Lee) is the young Eugene.

With some poetic license, O'Neill distills his family's tragedy into a single summer's day in 1912. The quartet of characters advances from a morning's surface jocularity to the evening's soul-shaking revelations of self-truth. Although the play is about specific people, it has universal relevance. What household does not put up with some unreasonable behavior from its dominant figure? What brothers or sisters don't experience a pinch of jealousy for one another? What family isn't faced with a member's compulsive behavior which it must ignore or excuse to avoid rupture?

UWM'S INOVA Chosen To Organize U.S. Pavilion at Cairo Biennial

Milwaukee - The United States will be represented at the seventh International Cairo Biennial by an exhibition proposed by the Institute of Visual Arts (inova) at the University of Wisconsin-Milwaukee. The project, organized by inova's Senior Curator Marilu Knode, will display the work of New York artist Nancy Spero at the event which runs from December 1998 through mid-February 1999.

The event is the largest international exhibition of contemporary art in the Arab and Islamic worlds, and is housed in several facilities around Cairo including the Museum of Modern Egyptian Art, the Aknaton Gallery and the Opera House Galleries. The Spero project was chosen to represent the U.S. at the international event by the Federal Advisory Committee for International Exhibitions, a standing committee of the National Endowment for the Arts, from more than 400 U.S. curators who were invited to submit proposals.

The Principles: The Gay Man's Guide To Getting (And Keeping) Mr. Right

We've all heard about the book called: "The Rules". It was written for straight women and told them how to get and marry a man. The author of this little book takes a different tack and tells us what gay men need to do to get and keep a man. He says, "There's a big difference between you and a 'Rules Girl.'"



Outland says that "while no book can turn you into a silvertongued devil who always says and does the right thing, a book can tell you what not to do and when not to do it." He sets out to do just that and has divided the book into three sections: "Finding Him"; "Getting Him"; and 'Keeping Him".

You'll discover what to

The Auntie Mame Principle: "If you do happen to meet somebody and find he has a fanatical interest in, say, boxing, don't pretend that you do, too, when you don't. You're a gay man. You've seen Auntie Mame. You remember what happened to Roz Russell when she pretended she was an

accomplished horsewoman. Behave accordingly."

The Bookworm Principle: "If you read ... why not put this accomplishment to work by cruising your local bookstore? Readings are a wonderful way to meet people. If you read, and he reads, well, there's a rare interest you

have in common right there.

The Eliza Doolittle Principle: "Six months of concentrated effort at the gym will give you some results and don't think nobody is noticing. If they see you three times a week for six months, and one day they realize you have biceps ... believe me, they're all noticing.'

Getting Him

The Wallet Principle: "If you were walking down the street and saw a wallet bulging with cash sitting there on the sidewalk, would you bend down to tie your shoe and scoop it up, or would you jump up and down and shout . ? Why wouldn't you behave the same way when you find a desirable man?"


Keeping Him

The Joan Rivers Principle: "Most of your little conflicts can be solved by applying [this] principle. At a certain part of [her] routine, Joan would be just about ready to say something really, really wild, maybe even shocking, and she'd ask her audience, 'Can we talk?' Communication is the heart of relationships. ...

The Joint-Checking Principle: "Moving in with someone is a big deal, but its reversible if things don't work out. 



MOVIE REVIEW

Dark City

ark City works the same way cinema itself does. A legion of bald Hellraisers called The Strangers try to propagate their dying species by mix-and-matching human memories in order to discover that holiest of sci-fi/fantasy grails, the soul. The Strangers have found that this is best achieved by stopping time and the population's waking consciousness every midnight, transforming the city's landscape (in a series of breathtaking morphs) and planting the memory cocktails in their subjects with a so-futuristic-it-looks-antique hypodermic needle through the brain. When time starts up again, the humans are unleashed onto a city that knows no sun, a dreamscape concocted entirely from the Strangers' Gothic underworld dwelling. But quicker than you can say Rod Serling, something goes wrong when John Murdoch (Rufus Sewell) wakes up during one of these transformations with the same evil morphing powers.

Now isn't that how movie going works? Every time we plop down (ugh, I don't even wanna say) dollars for a movie ticket, we are consenting to sitting in the dark and watching a legion of strangers transform reality while the time and space outside stops. These strangers depend on our ability to remember (in this case, organizing memory for us out of narrative information) in order for their experiments to be successful. Yet the entire project can become dismantled if too much information is leaked so at times they seat us in the dark figuratively as well. One can even make the somewhat far-fetched argument that movies, given their strong anthropological nature, can propagate if not the human species then certainly their traditions and history.

Some of the very greatest films of all-time, from Sherlock Jr. and Singing in the Rain to Hiroshima Mon Amour and Hold Me While I'm Naked, function in a similar way — as a critique of the unique way cinema orchestrates the push and pull between narrative and memory, fantasy and reality. Dark City definitely had the potential to rank amongst such classics. But there is no push and pull here. We are given way too much information on The Strangers right at the beginning. Because their supernatural powers are thrust upon us full force in all their computer-animated glory, nothing they can ever do afterwards shocks or abrades. Anti-social and inhuman though they may be, they aren't all that strange to us. It's as if we were told at the start of The Game that every character was in on the prank. The reason why that film worked was because we nervously wracked our brains trying to figure out how each terrible thing that happened to Michael Douglas logically fit together. Here we know logic has no play so we just hazily surrender to the surface splendor of the production.

Dark City was originally supposed to be a sci-fi film noir from the perspective of Detective Burnstead (William Hurt) but as director Alex Proyas guileslessly admits: "I thought Murdoch was a more emotional viewpoint for the story, whereas centering it on the detective made it more cerebral and less visceral." Less visceral?!? Hard to imagine but actually it would have worked better from the detective's viewpoint. We would have been discovering the Strangers' plot and Murdoch's obsessions right along with him making them all the more strange and exciting. Instead we let Murdoch chase his past and allow ourselves to drift off waiting for something real to happen. Even the characters themselves seem dreamily uninvolved as when NO ONE registers a reaction after Murdoch's mind bursts the glass the separates him from (but is it really) his wife (Jennifer Connelly) in prison.

Yet Dark City is recommended for the way it's placed a remarkable calm over you by film's end. For stress reduction, it's better than new age music but for drama, I'll take Deep Rising.

Millenia X @ Circuit performed for the Saturday night celebration, wish I would have made it down there for that!


