

WHAT ARE THEY SCARED OF?

Homophobia seems to be sweeping the nation like a plague of Biblical proportions--an apt analogy since the basis for most of the antigay sentiments is the Bible. The outbreak has been building for years now. I think it all started when Bush took office in 2000 and it's gotten steadily worse ever since. The latest wave of "moral values" that ensured four more years of fundamentalist conservatism brought the threat level to epidemic proportions. Don't believe me? Just check out the latest news. Antigay sentiments abound.

On Wednesday, December 1, Michigan governor Jennifer Granholm announced that the state would be removing domestic-partner benefits from contracts negotiated with state workers, citing a voterapproved amendment to the state constitution that bans same-sex marriage "and similar unions." Michigan voters approved the amendment November 2.

Alabama state representative Gerald Allen recently proposed a law that would ban all books in public libraries and schools with any gay content, no matter how small. The proposed law would prohibit all books with gay characters and any school textbooks that suggest homosexuality is normal. In the past, Allen was an outspoken advocate for the ban on same-sex marriage. He suggests destroying the books that contain positive gay material. This would include works by authors such as Herman Melville, Tennessee Williams, Willa Cather, Carson McCullers, John Cheever, Alice Walker, James Baldwin, Truman Capote, and Gore Vidal, to name just a few.

In Webb City, Missouri, Brad Mathewson, a 16-year-old openly gay high school student, was sent home for wearing a T-shirt bearing the insignia of the gay/straight alliance from his old school. In support of their friend, a group of fellow students made homemade T-shirts reading "If this shirt offends you, look the other way." The back, among other messages, stated, "We have the right to be who we want to be" and "We support gay rights." Other students donned shirts with messages such as "I'm gay and I'm proud" and "I have a gay friend and I'm proud of him." The group was given the choice of either changing their shirts or going home. Seven chose to go home.

A Methodist minister was defrocked on Friday, December 3, after being convicted of violating church laws against actively gay clergy. It is the first such decision in over 17 years. The Reverend Irene Elizabeth Stroud, 34, an associate pastor at Philadelphia's First United Methodist Church of Germantown, set the case in motion last year when she announced to her bishop and congregation that she was living in a committed relationship with her partner, Chris Paige.

CBS and NBC rejected an ad from the United Church of Christ. The 30-second ad highlights the Cleveland-based UCC's welcoming stance toward gays and anyone else who might feel shunned elsewhere. The ad shows a muscular bouncer working a rope line outside a handsome but nameless church, deciding who is eligible to enter and worship. "No, step aside, please," he says to two men holding hands. Across the screen comes the message, "Jesus didn't turn people away. Neither do we." The final

scene shows a woman with her arm around another woman. The networks said the ad was too controversial to broadcast because it implied exclusion of gay and lesbian couples by other groups. ABC Family, AMC, BET, Discovery, and TBS, among others, accepted the ad the UCC said.

ABC's 20/20 recently aired a deeply flawed segment about the murder of Matthew Shepard. The news magazine claimed to have found previously unexamined layers in the story. Instead, they presented rumors and unproven claims by the murderers who now assert the killing had nothing to do with Matthew's sexuality—contrary to their court testimony. In a shameful bid for ratings during November sweeps, the network gave up journalistic integrity in order to play off the nation's homophobic mania.'

These are only just a few highlights of the stories that have surfaced in the last week. Taken as a whole, they paint a stunningly depressing picture of the state of the US. If anyone had any hope that things might possibly improve during Bush's second term, it's not looking good. If anything, we seem to be slipping back into a hysterical state of McCarthyism--book burnings, open discrimination, and panicked finger-pointing.

It's not all bad news though. The chances of Allen's proposed book ban passing are extremely slim. In the Webb City, Missouri case, the ACLU has filed a lawsuit on behalf of Mathewson. Rev. Stroud has said that while she is disappointed, she never expected to win the case, and hopes to use it as a learning opportunity. Her supportive congregation has said it wants her to remain with them, serving in many of the same positions she did as assistant pastor, but now as a lay minister.

How do we counteract the rising tide of homophobia? Since the elections many people have written me asking that question. They all want to know: What do we do now? The answer? The same things you were doing before, only take it up a notch.







U.S. Circuit Court Rules Employer Can Require Female Employees to Wear Makeup

The Gender Public Advocacy Coalition (GenderPAC) this week denounced a decision by the 9th U.S. Circuit Court of Appeals holding that a female employee fired for refusing to wear makeup cannot sue her employer for sex discrimination.

Said GenderPAC Executive Director, Riki Wilchins, "This ruling would be right at home in the 19th century. Women long ago won the right to be judged on the quality of their work, not whether they conform to some outdated standard of feminine attractiveness. These judges need to wake up and smell the coffee."

The employer, Harrah's Resorts, had implemented a new "Personal Best" policy that required it's female employees to wear their hair "teased, curled or styled," and wear "foundation/concealer and/or face powder, as well as blush and mascara," nail polish, and lipstick.

Darlene Jespersen - an exemplary employee for two decades - was fired

when she objected that the new standards "forced her to be feminine" and made her feel "dolled up" like a sex object.

The 2-1 decision rejected Jespersen's suit, countering that she had not shown that feminine standards were significantly more burdensome than those imposed on men. The Court held that sex stereotyping rulings - such as the landmark Supreme Court case decision Hopkins v. Price Waterhouse - did not specifically address the issue of sex-differentiated grooming standards.

Male bartenders at Harrahs' were only required to wear their hair above the collar and keep their nails clean and neatly trimmed.

Said the lone dissenting judge, "Sex-differentiated appearance standards stemming from stereotypes that women fulfill a different role in the workplace systematically impose a burden on women, converting such stereotypes into stubborn reality."

LEAGUE Foundation to Award College Scholarships

(Bedminster, NJ) - For the 9th year in a row the LEAGUE Foundation will award its annual academic scholarships later this year. Applications are currently being accepted through April 22, 2005.

Originally, the Foundation began as a grass-roots organization in 1996 with the generous support of LEAGUE Members (Lesbian, Bisexual, Gay and Transgender United Employees at AT&T). Through the years, however, the organization has grown into a national scholarship fund reaching all 50 states with support from corporations, individuals, and other GLBT organizations. To date the LEAGUE Foundation has awarded 44 scholarships.

Applicants should graduate high school in 2005; identify themselves as lesbian, gay, bisexual, or transgender; have achieved a cumulative grade point average of at least 3.0 on a 4.0 scale; are actively and substantially involved in community service; live in the United States; and have been accepted to attend an accredited college or university in the United States.

Scholarships currently open for application are the Matthew Shepard Memorial Scholarship (name used with permission of the Shepard family), named for the Wyoming college student murdered in 1998 for his sexual orientation, and the LEAGUE Foundation Scholarship.

Gay Press Questions Media Handling of Susan Sontag Passing

When noted novelist, essayist, critic and political commentator Susan Sontag died in late December of complications from leukemia, the press acted quickly, citing her works as "influential" and her legacy as "essential."

What the press frequently failed to make note of, however, were Sontag's many relationships with women over the years.

The author, who spent many years partnered to photographer Annie Liebovitz, among others, made it a point to be very private about her social life over the years. Her intense desire for privacy and lifelong rejection of the labels "lesbian" and "bisexual" caused many critics to blast her for not coming out in early years.

Today, it seems the press is all but ignoring any of Sontag's relationships but her short-lived marriage to Phillip Reiff, with whom she had a son. The two married ten days after they met and divorced shortly after in 1959.

Q Syndicate editor and Lambda Literary Award winning author Paula Martinac blames the limited way in which the United States defines the word "lesbian" as one of the key reasons for this notable omission.

Martinac also suggests the media might simply use the excuse that they are respecting Sontag's privacy as a reason for not mentioning her same-sex relationships.

The Los Angeles Times referred to the omission as a "curious silence."

Sontag was born Susan Rosenblatt in 1933, but took the name Sontag after her stepfather. She graduated from high-school at age 15 and earned her Bachelor of Arts in philosophy in just two years from the University of Chicago.

The author was a dominant force in New York's literary scene in the late '50s and early '60s. Her book The Volcano Lover was a bestseller and in 2000, she won the National Book Award for In America.

In addition to her relationship with Liebovitz, for whom she wrote the introduction to Women, a collection of portraits of women, Sontag enjoyed a long relationship with dancer Lucinda Childs.

Most recently, Sontag used her influence to question US politicians' "characterization of the September 11 attacks. She wrote: "Where is the acknowledgment that this was not a 'cowardly' attack on 'civilization' or 'liberty' or 'humanity' or 'the free world' but an attack on the world's self-proclaimed superpower, undertaken as a consequence of specific American alliances and action

PFLAG Says Nation's Schools Ignoring Gay Students

(Washington, D.C.) - Members of PFLAG announced this week that the results of their 2004 National Schools Assessment has found "critical deficiencies" in support for LGBT youth.

While the assessment found a growing awareness of LGBT issues in school, representatives of PFLAG announced that at 95-percent of the nation's schools, little to no gay, lesbian or bisexual resources existed. Transgendered resources were non-existent at all but 1-percent.

"Our findings help explain why so many people still hold on to damaging old fictions and profound misunderstandings about our GLBT family members and friends," PFLAG's Executive Director Ron Schlittler said in a statement to the press. "Misinformation goes unchallenged because accurate information is virtually banned in our schools."

Schlitter did make a point to commend students for promoting safety in their schools

"There are some encouraging signs," he said. "Nearly 39 percent of respondents reported the existence of support groups

for gay and straight students that address the needs of GLBT students."

While the assessment's findings were not up to PFLAG's standards, chapters are springing up all over the place in smaller communities.

In Lake Oswego, Oregon, 63-year-old retiree Marion Hammer just received a grant from her former employer Prudential Financial for her volunteer work with the organization. For years, she said, the area had no outlet for kids coming out or their parents.

After finding out her high-school son was gay in the mid '80s, Hammer said she was appalled by the lack of support and amount of misinformation available in schools. Her anger drew her to work with PFLAG to start Spokane's first-ever gay pride celebration in 1990.

"All parents love their children, regardless of their sexual orientation,' Hammer said she believes. "Sometimes, they just need a little outside help to figure that out."

PFLAG's National Schools Assessment was developed by PFLAG's safe schools staff and researchers at the University of Maryland. The respondents came from 39 states

Gay Teen Activist Honored for Inspiring Peers

(Little Gables, FL) - Miami based student honor program "Do the Right Thing" has named 17-year-old Steven Alicea as one of October's top 10 Miami-Dade County students.

The award is the latest in a string of accolades for the one time F-student, who came out to his pastor foster parents at 15 - who in turn told him he would go to hell.

"I thought of suicide, of just taking my life," Steven said. "Thank God I didn't."

Today, in addition to being honored, Steven is in a stable foster home with two loving mothers. He plans to study dance at Florida International University.

After bouncing through 17 foster homes, group homes and shelters in his 17 years - some of them mentally and physically abusive, he says - Steven found comfort at gay-oriented Pridelines Youth Services near downtown Miami, where he became close to the group's executive director, Denise Hueso.

At the time, Steven was failing many of his classes, skipping school and contemplating suicide. Meeting Hueso and finding Pridelines was a turning point.

"She was very cool and down to earth," Steven said. "I started spending a lot of time at Pridelines, doing a lot of community service."

Hueso and her partner, Sandra Newsom, wanted children and they decided to become Steven's foster parents.

Florida prohibits gays and lesbians from adopting children but not from becoming foster parents.

"We talked about it for months,' Hueso said. "We talked to a lot of people and

then said, 'What the hell, we're going to do it."

Steven has lived with the couple at their home in Little Gables since February, 2003

"Now, he's got two people who care a lot about him. He calls them his moms," said Michael Guthrie, program director at the School for Applied Technology in Miami, a dropout prevention academy where Steven is a senior with a B grade average.

Steven works 24 hours a week at Care Resource, Florida's largest AIDS service agency, where he is a peer-education promoting HIV testing to young people. He also counsels other gay teens at Pridelines.

"With a little effort on our part, we've had so much impact on his life," Newsom told the Miami Herald. "Having Steven at home has put so much structure in our lives. It has taught me about how I communicated, how I see things."

The "Do the Right Thing" communityservice award is sponsored by the Miami Police Department, British Airways, The Miami Herald and WTVJ-NBC 6 and carries with it a prize trip to London. They cited him for raising his grades, his AIDS activism and achieving "success despite adversity."

In addition, the national Colin Higgins Foundation honored Steven with its annual Courage Award after Newsom nominated him.

"He impressed me ever since I met him," said Candy Hertsch, Steven's high-school guidance counselor who nominated him for 'Do the Right Thing.' "He has drive, ambition, he's respectful and kind."

(Costa Mesa, CA) - The Orange County diocese of the Roman Catholic Church is under attack by a group of parents and parishioners upset with the church's decision to allow a gay couple to enroll their children in a church school.

The group has demanded that St. John the Baptist School in Costa Mesa accept only families that pledge to abide by Catholic teachings, The Los Angeles Times reported Sunday.

Church doctrine opposes gay relationships and adoption by same-sex couples. The demand would likely keep the men's two adopted boys from attending the school's kindergarten.

"This is not a radical or mean-spirited approach to Catholic education," the group told the church in a letter reviewed by the Times. "It is a straightforward assurance to any prospective parent that their child will be taught the fullness of the Roman Catholic doctrine."

But school officials have rejected the demand and issued a new policy stating that a family's background "does not constitute an absolute obstacle to enrollment in the school.

"I firmly believe that this policy is in line with the teaching of the Catholic Church," Rev. Martin Benzoni, who oversees the 550-student elementary and middle school, told the Times.

Rev. Gerald M. Horan, superintendent of diocese schools, said he was wary of adhering to Catholic beliefs too closely. He said doing so would mean banning children whose parents were divorced, used birth control or married outside the church.

The decision outraged some parents, several of whom threatened to seek involvement from the Vatican - many parents are threatening to switch schools.

"The boys are being used by these men as pawns to further their agenda," said Monica Sii, who has four children at St. John

Some parents backed the school's posi-

"Let he who is without sin cast the first stone," said Katie Flores, whose daughter is a classmate of the boys.

A handful of similar disputes have popped up around the country, according to Rev. Jim Schexnayder of the National Association of Catholic Diocesan Lesbian and Gay Ministries. In Oregon, a lesbian couple has sued a Catholic school that rejected their daughter. The boys' fathers, who enrolled their children at the beginning of the school year, declined to comment to the Times.

Despite arguments in support of the boys' continued enrollment, the group of parents continue to make waves.

"We're taking a stand for faith," said parent Ken Stashik. "This is much larger than what's going on in a small Catholic school in a small town."

conduct further studies in patients with other complications of cancer.

ADVR's AVR118 is a biopolymer that possesses novel immunomodulator activity. This peptide-nucleic acid complex, which, to date, has demonstrated a very favorable safety profile, appears to stimulate the pro-inflammatory responses required to combat viral infections such as HIV and human pap-

illomavirus and to dampen aberrant autoimmune-type inflammatory responses, such as occur in patients with rheumatoid arthritis.

Data presented at the American Society of Clinical Oncology's annual meeting in June, 2004, showed that AVR118 appears to have activity against fatigue, loss of appetite, and weight loss in patients with HIV

University Of Wisconsin Faces Isolation Over Gay Benefits

(Madison, Wisconsin) In January, the University of Wisconsin will become the only school in the Big Ten that does not offer health insurance for the partners of gay and lesbian employees. Under state law it would be illegal to offer the benefits, and university officials are expressing concern that the school will be unable to attract the best faculty and researchers.

The only other Big Ten school currently not offering benefits is Penn State, but faculty have been receiving them under a plan where private donations fund them, and on January 1, the university's own plan will commence.

"The absence of domestic partner benefits is really a serious recruiting issue for us," UW-Madison Provost Peter Spear told the Wisconsin State Journal. "We know of instances where we have lost outstanding candidates because of it."

The university is also concerned about a proposed amendment to the state consti-

tution that would ban same-sex marriage and civil unions. Wisconsin already has a Defense of Marriage Act outlawing gay marriage.

The proposed amendment passed in the last session of the legislature. If it wins final legislative approval in January, it would go before voters as a referendum next April.

"It's an issue that's becoming more and more painful for people," Mariamne Whatley told the Journal.

Whatley, a lesbian and associate dean in UW- Madison's School of Education said: "With this marriage amendment, suddenly Wisconsin is looking a lot more hostile, and a state that was a leader (in non-discrimination matters) is really falling behind the whole Big Ten."

Wisconsin became the first state in the union in 1982 to specifically ban discrimination based on sexual orientation.

New Treatment 'Enables Recovery Of Immune System' In HIV Patients

(Jerusalem) Israeli researchers say they have made a major breakthrough in helping the bodies of people with HIV/AIDS "recover" their immune systems.

Researchers from Hadassah University Medical Center in Jerusalem have developed a new medication to significantly strengthen the body's immune system against the autoimmune aftereffects of HIV infection according the researchers' report.

Even with widespread use of antiretrovirals which kills the virus, the immune system continues to kill healthy cells

But, the Hadassah researchers have discovered that there is an autoimmune process that continues unabated despite the fact that the patient is taking the cocktail, the university said in a statement late Tuesday.

The vaccine that the Hadassah scientists developed stops the continuation of the autoimmune process.

It was based on the hypothesis that in addition to HIV causing AIDS by invading and killing CD4 blood cells, HIV causes the body's central immune system to start killing these cells independently of the virus as a consequence of an autoimmune process, the university said

For most AIDS patients, the central immune system does not recover even if the HIV virus is almost eliminated through treatment with the cocktail of medications. The Hadassah vaccine was designed to stop the continuation of the autoimmune process.

Seven patients participated in the study. Each received between three and four injections in a six-month period. Five of the seven patients responded positively to the vaccine developed by the research team.

"Our aim was not to prevent infection by the virus but to strengthen the immune system and use our vaccination treatment as a complement to the antiviral medication (HAART)", said Dr. Rivka Abulafia-Lapid, the lead researcher on the team.

The researchers are continuing to develop the vaccine. The next phase is extended clinical trials.


New AIDS Drug To Undergo Clinical Trials

(Yonkers, New York) Advanced Viral Research Corp. announced Monday that it has received approval from the Food and Drug Administration for clinical trials on a new generation of drugs known as AVR118.

After review of the drug which was submitted at the end of November, the FDA notified the Company that it may pro-

ceed with its Phase II, multi-center clinical trial in the U.S.

The study will examine the safety, tolerability and efficacy of AVR118 in patients with advanced cancer who are suffering from symptoms of progressive disease. Successful completion of this trial will then provide the platform to



The last best (and worst of) 2004 list

The old year may be over and done with, but the lists of the best and the worst from 2004 still keep on coming. From books to movies, television to music - there was just so much to see and hear last year that we couldn't resist just one more review!

Books

There were some great books in 2004, but I'd say the best would have to be Boy Meets Boy by David Levithan. Some may view it as a simple teen romance, but it's really so much more. It's a beautiful fairy tale that took on a genre overwhelmed by clichés and gave it a new and original twist. High school sophomore Paul lives in a world where being gay is considered as normal as having red hair or being left handed. The problems and angst he experiences aren't because he's gay; they're simply because he's a teenager. What a concept! In turns surrealistic and all-too realistic, Boy Meets Boy was a work of art. It does what all great works of art should do: inspire, challenge, and make you think.

The worst book I read in 2004 would have to be Troll by Johanna Sinisalo. Despite the fact that the book has appeared on quite a few best-of lists, was a finalist in the Gaylactic Spectrum Awards, and many of my friends highly recommended the book to me, I loathed it. I usually don't like to bash books since, as an author myself, I try to support fellow writers, but since this book has received so much positive attention, I felt compelled to speak up.

Movies

The only movie I saw in 2004 that ranked five starts on my rating system was Saved! starring Jena Malone, Mandy Moore, and Macaulay Culkin. Produced by Michael Stipe and directed by Brian Dannelly, Saved! tells the story of a young Christian girl who experiences a crisis of faith when her boyfriend comes out to her and she sets out to turn him straight—and in the process gets pregnant. In the end, with the help of the school misfits, she discovers the true meaning of Christian love. The script is wickedly funny without ever being mean, and the acting is top-notch.

Even counting that abomination Van Helsing I was unfortunate enough to pay to see in the theatre, the worst movie I saw in 2004 is hands down Nine Dead Gay Guys. A truly awful movie.

TV Shows

2004 was not a stellar year for gays on TV. Few new shows premiered with gay characters and most of the existing shows continued their decline. I stopped watching Will & Grace several seasons ago when they inflicted Harry Connick, Jr. upon the viewing public. I have nothing against the man personally--in fact, I think he's a great singer--but he had about as much chemistry with Grace as Liza and David. The show has simply lost it's edge and I don't find it funny any more. I stopped watching Queer As Folk last season when the storylines became too unbelievable even for a soap opera. One of my pet peeves is when writers force their creations to act out of character simply to manipulate the plot. It's a sign of sloppy writing.

So my pick for best show of 2004 with featuring gay people is a tie between three reality shows: America's Next Top Model on UPN, What Not To Wear on TLC, and Project Runway on Bravo. No, season three was not America's Next Top Model's best cycle (that would have to be Season 2), but it continues to be one of the only shows on the mainstream networks to have so many openly gay cast members and not make an issue of it. Regulars stylist Jay Manuel, runway expert J. Alexander (aka Miss J.), and judge and fashion stylist Nolé Marin all add a touch of fabulousness to every episode in which they appear.

TLC's What Not To Wear is one of those rarest of rare things: an American adaptation of a British show that actually surpasses the original--thanks in large part to co-host Clinton Kelly. Every Friday night, he and Stacy London change the lives of fashion impaired individuals with their brand of tough love and spot-on advice. I'm not ashamed to admit this show has actually made me cry on occasion.

And last but not least, one of my newest obsessions is Bravo's Project Runway. Featuring several openly gay cast members, the show, pitting wannabe fashion designers against one another in various challenges, has proven to be surprisingly smart and original.

The worst gay-themed show of 2004 would have to go to Comedy Central's Straight Plan for the Gay Man. I think the title says it all.

An honorable mention goes to TBS' He's a Lady. The premise of the show was to take eleven macho straight men and have them compete against each other to see who could make the most convincing woman. I couldn't quite decide if it was a positive or negative show. On the one hand, it taught its contestants a lot about gender bias and accepting others for who they are, but judge NBA star John Salley couldn't have been more homophobic or offensive. The producers should have fired Salley after the first episode and replaced him with someone more openminded.

Music I think one of the most innovative and exciting new groups to emerge in 2004 was the Scissor Sisters, and they just happen to be unabashedly gay. Well, three of them are anyway. Led by his-fabulousness Jake Shears, the band smashes through musical barriers blending an eclectic mix of gay disco, Elton John, and Led Zeppelin--and somehow it works. Their songs range from beautifully melancholy ("Mary" and "Return to Oz") to giddily fun ("Take Your Mama Out" and "Filthy/Gorgeous), and cover all the ground in-between.


I don't have a worst of 2004 in queer music. While Rufus Wainwright and Catie Curtis both released albums that were arguably not their best, they were both still immensely listenable.

News Story

My best and worst news story of 2004 is one and the same: Gay Marriage. The story burst onto the scene in February when San Francisco Mayor Gavin Newsom declared California's ban on samesex marriage to be unconstitutional. The movement quickly spread to other states such as Oregon and New York, and culminated with Massachusetts legally marrying same-sex couples in May. For many LGBT people who thought they'd never live to see the day when gay marriage was legal in any of the United States, hope flickered to life.

The Religious Right wasn't about to sit by quietly while gays achieved equality, however, and a virulent counter-strike was soon launched on every front. Lies and fear tactics abounded, and by the time the November elections rolled around, gay marriage received a huge setback in the form of bans enacted in many states and the reelection of George W. Bush. While the true impact of the gay marriage debate on the presidential election is unclear, it is a certainty that it played a part.

Did we gain ground in 2004? Undoubtedly. But we also lost ground. The question is: Did we gain more than we lost or lose more than we gained? Or maybe it was all just a draw. Whichever, we still have a lot left to do. Let's make 2005 a year of unmitigated gains.





Making the Most of Your Web Site

Your website can be much more than a place to post a resume or merely list your services. Today your website can and should be a gathering place where your clients, subscribers and customers can not only check on what you're up to but also reach for their wallets and buy your goods and services as well.

In this article I want to address ways that you can put more into your website by turning it into a powerful profit center. What do I mean by profit center you ask? Well according to Barbara Winter author of Making a

Living Without a Job a profit center is an individual source of income.

These sources are often related to each other under 'an umbrella' of services that you may already offer. For example, an auto mechanic may earn a portion of his income from repairing cars, but he may also write a series of tip booklets on everything from 'how to keep your auto running smoothly' to 'how to protect your paint job'.

If our mechanic teaches a workshop on how to handle minor repairs on your own, those same students may become customers when they need major work done on their automobiles and will most definitely be customers for his booklet series. What I've just illustrated here is three profit centers for our mechanic:

- 1. Auto repair work (perhaps his main source of income
- 2. Booklet writing and publishing
- 3. Automotive repair classes

All of these can be sold through his website. Can our mechanic come up with even more profit centers? You bet! He can develop as many as his time allows. And the best part his website can be the 'gathering place' for all of his products and services. Think of it this way, you're probably working hard to get eyes on your web site anyway why not make the visit an experience. Make your website a destination and not just something for your potential customers to click through on the way to some other site.

You can make your website a destination by offering your visitors an opportunity to get to know you and what you have to offer. Address their needs and concerns, offer them solutions via your products and services and you will find yourself easily creating a series of profit centers that make your customers happy as well as your bottom line.

Ways to implement this today

Think of what you offer, perhaps you're a coach or author. Maybe you're a travel agent or you create art. Brainstorm for ideas for potential profit centers. Start by asking your customers what they need and then fill that need. If you sell travel packages, ask your client base what they would like to see in a tour,



then develop a tour or series of tours based on their interest. Profit center number #1. Offer these tours for sale on your website; announce them through your newsletter.

f you've been to a place where your tour members would like to visit and you have any writing ability perhaps you could develop an article or series of articles on the destination. (You could sell these articles to other websites -or- print publications) Profit center number #2. Perhaps those articles can become a small guidebook or series of guide books. Profit center number #3. If you don't want to deal with hassle of trying to find a publisher then consider publishing the book yourself.

Hold a brainstorming session with a supportive family member or friend. Try to develop at least three potential profit center ideas per week. Then investigate these ideas to see if they have any merit.

I'll give you an extra tip, go for the ones that feel really good to you, that excite you the most and pursue those ideas first

Now, not all of your ideas will pan out, but that's okay all you need is few good ones to get you started and you're more than half way there.

Still need some profit center ideas to jump-start your imagination?

- 1. Write a tips e-booklet, (see the resources section to learn more about this) if that sells well offer a print version (two profit centers)
- 2. Teach a Tele-seminar, have the seminar recorded and then sell the recording as an audio CD or video tape or DVD (another profit center).
- 3. Take a series of your articles and combine them into chapters for an e-book that you could sell.
- 4. Contact another company that offers products that compliment your services and offer to become a distributor for them. For example our travel agent could easily sell travel accessories everything from luggage tags to carry on bags and travel alarm clocks.

Gay TV Gives Birth to Slew of New Gay Programming

On cable TV's here!, a gay parenting series, a holiday drama about a teenager's two gay dads and numerous gay themed films acquisitioned from film studios across the world round out the roster of programming.

And on the Palm Springs based Q Television, a daily gay talk show and the gay soap opera Paradise Falls play mostly to audiences in Southern California and Manhattan.

For years, mainstream cable networks like HBO and Showtime have enticed gay viewers with shows like Six Feet Under, Oz, The L Word and Queer as Folk - programs featuring gay characters without succumbing to the standards and occasional censorship of network TV

Now, channels geared toward gay and lesbian audiences specifically are making a play for financial success. Gay TV has officially arrived.

Cablevision Systems Corp. announced yesterday that it is offering digital customers monthly subscriptions to 30 hours of on-demand programming from here! for \$6.95.

Time Warner Cable in New York City, Los Angeles, Boston, Milwaukee and San Antonio began carrying here! late last year as non-subscription video-ondemand for \$3.95 per three-hour viewing. DirecTV recently began offering here! as a monthly add-on for \$9.99. And EchoStar's Dish Network offers three-hour pay-per-view blocks of the channel for \$3.99.

Regent Entertainment co-founders Paul Colichman and Stephen Jarchow founded here! in August of 2003 and the service is now available in one form or another in more than 30 million cable and satellite TV homes nationwide. It got a nearly two year head start on Logo, which Viacom Inc. plans to launch sometime this year as a digital channel with wider distribution.

"They all want to serve the gay and lesbian community and they want to do it in a way that makes money," Colichman told Newsday on Tuesday. "And because it is a premium service, anyone who doesn't want gay and lesbian programming doesn't have to get it."

Colichman said here! claimed \$15 million in revenue for the first year and has plans to spend \$50 million this year on original programming and acquiring syndication rights to series and films.

Cablevision's nationwide satellite service called Voom carries its own gayoriented movie channel - DivineHD. A company spokeswoman declined to say whether Cablevision will carry Logo, which Viacom had planned to launch next month but has not said whether that is still the plan.

Team ratings are a total of the 10 best individual rating on the team. NAGAAA Divisions, such as B, C and D in the Gasparilla Classic, are then based on these ratings.

B-Division: Team rating of 131-170 and no individual over 20.

C-Division: Team rating of 101-130 and no individual over 14

D-Division: Team rating of 100 or less and no individual over 11

This way a "D" team can go to a tournament and not get slaughtered by a higher-ranked team. At the same time, a higher-ranked team can't "sandbag" or play in a lower division just to win a trophy to take home.

Jerry Springer Opera Featuring 'Gay' Jesus Incites Record **Number of Complaints**

(London, England) - This isn't your typical PBS Opera.

In a style true to Jerry Springer's popular US talk show format, a London musical based on his show, featuring a nappy-wearing Jesus who admits he is more than "a bit gay," has received a record 5,500 complaints, a representative of the BBC said.

Nevertheless, the BBC said it will go forward with its planned airing of "Jerry Springer: The Opera," which is still playing to packed houses in London's West End.

The show contains a total of 3,168 uses of the "f" word and 297 of the "c" word. The profanity-packed songs include titles like "Pregnant by a Transsexual" and "Here come the Hookers."

British media regulator Ofcom said it had received 5,500 complaints about plans to broadcast the music. That is more than three times the previous record holder, Martin Scorsese's The Last Temptation of Christ, which received 1,554 complaints when they aired the film in 1995.

"This organized attack is the latest of a series of attempts by religious interests to control what we can see or say in this country," National Secular Society vicepresident Terry Sanderson told London's Telegraph.

The organization urged the BBC to stand firm "reliagainst gious bullies.'

"Viewers have a right to see it,"

Sanderson said. "Those who are likely to be offended have a similar right to

The BBC was forced to pull the \$2.5 million satirical cartoon Popetown after a campaign spearheaded by the Catholic Church.

The BBC has vowed to go ahead with the broadcast despite complaints.

How to Survive in 2005

America's LGBT leadership, whether they like it or not, before attempting to the move the marriage agenda forward again, had better bring people of color to the table from day one. We cannot and will not be the after thought when organizations need to publicly display diversity. From the messaging to the strategic mobilization of the LGBT community, we need to be there.

> I don't ever want to see a white gay man stand before camera again equate and his struggle to the Black civil rights movement. It

doesn't help the thousands of Black gays who are also trying to message to African-American around this issue and only further divides our community with Blacks seeing gay as a white issue. When you talk about messaging to communities of color, in particular the Black community, that message would be better received coming from an African-American same-gender loving person to the Black community.

The executive leaders of our LGBT organizations need to take a closer look at the diversity within their own organizations for 2005. It's not enough to have programs headed by people of color for people of color. People of color need to be on the communications team and the development team as well. The reason that most gay organizations can't penetrate the Black press is because you don't have a Black person on your communications team pitching the Black press. Why don't African-Americans donate to your organization? Well, part of the reason is that you don't have African-Americans on your development team. The other reason is that Blacks don't typically feel that these national gay organizations have their community's best interest at heart. This all goes to say that there is work that needs to be

Now I know this is going to be hard for some to swallow. Why? Because the gay leadership seems to think that what works for the white community will work for all communities. Not so. These organizations are going to have to invest in people of color to have a winning strategy. This includes the same salary, benefits and support that you give your other team members.

Having worked for one of the largest and well funded gay organizations in the country I can tell you first hand the feeling of isolation within an organization when you are the token Black hired only to work with the Black community. Aside from my position, my views, opinions and ideas in other areas of the organization were not needed. Conse-

quently, this organization does not have any credibility in the Black gay community today and is till scratching their heads trying to figure out why.

At the end of the day, Blacks played the most powerful role in the 2005 election and most of the gay organizations were unable to message to the African-American community around the issue of gay marriage. Thank God for the National Black Justice Coalition, an ad hoc coalition of Black LGBT leaders who came together this year to message directly to the African-American community on

America's gay leadership is going to have to develop a whole new approach to addressing marriage equality. What I learned as well as many other Black same-gender loving persons is that we cannot even begin to address marriage equality until we first address Black sexuality and homophobia. I think a lot of Black gays jumped aboard the marriage train because our voices were excluded from the conversation in the beginning, Black pastors were being used by right wing conservatives to message to the Black community and because we do want the right to marry. In the end, a couple of things happened in 2004. First, Black gays were represented more in the media this year, including Black media than ever before in history. What that means is that we were visible in our own community which is a huge accomplishment. Next, more Black LGBT persons mobilized around this issue than ever before. Again, I feel this is because our community was being used to win votes for the GOP and it was so blatant that even those of us that are not active, had to get out there.

Diversity means more than just having people of color on your website and over people of color programs. It means having the influence and perspectives of people of color at every level in your organization and movement. That way we can tell you what works and doesn't work in our communities both gay and at large. The LGBT community cannot push forward without gays of color and together we need to develop a strategy that works towards addressing LGBT issues in all communities.

Cream City Foundation Searches for New Executive Director
