Manufacture/Sale Of Poppers Banned in U.S.

Poppers (nitrite inhalants) are now a "banned hazardous product" in the United States. As of February 15, 1989, it is illegal to manufacture, distribute, import or sell any isobutyl nitrite substance or any consumer product "used for inhaling or otherwise introduced into the body for euphoric or physical effects."

The ban is part of the Drug Omnibus Act of 1988, which was signed into law last November by President Reagan. The main sponsors of the nitrite inhalants provision were Representatives Mel Levine and Henry Waxman (D's- Calif.). Both are strong supporters of Gay rights.

The ban was hailed by Hank Wilson of San Francisco, a Gay activist who, in 1981, founded the Committee to Monitor Poppers.

"It is long overdue", said Wilson.
"Up to the point of the ban we still had businesses in the Gay community that were promoting and selling poppers. There were Gay publications, like **Update** in San Diego, carrying large popper ads, as though there were no hazards to using the drug."

Wilson continued: "New people are continually coming into the Gay community. Young people are coming out. The last thing we ought to do is to introduce these newcomers to products that will be harmful to their immune systems, while we're in the midst of this enidemic."

With regard to the hazards of poppers and their effects on the immune system, a great many studies have been done by top-notch independent researchers. Wilson emphasized that these studies all point out that poppers are bad for the health and bad for the immune system.

The initiative for regulating poppers has come from the Gay community itself. West Hollywood, the Gayest city in the world, took the lead in banning poppers.

The medical case against poppers is impressive. Poppers are immunosuppressive. They can cause anemia, lung damage, serious skin burns and death or brain damage from cardiovascular collapse or stroke. Poppers cause genes to mutate and have the potential to cause cancer by producing dealy N-nitroso compounds. Poppers have been used successfully to commit suicide (by drinking) and murder (victim gagged with sock soaked with poppers). There are strong epidemiological links between the use of poppers and the development of AIDS, and especially Kaposi's sarcoma (KS). A six- fold decrease in the incidence of KS over the past five years parallels a sharp decline in the use of poppers.

For nearly two decades the poppers industry eluded regulation by labeling their commodity a "room odorizer." The FDA and various other health agencies all looked the other way. The Centers for

Milwaukee Nursing Homes Begin Accepting AIDS Patients

[Milwaukee]- It was clearly a victory for the Milwaukee AIDS Project (MAP). It was a victory that is a beginning, but a victory nonetheless.

At a press conference held March 13, 1989 at MAP offices, representatives from the health care industry and from two Milwaukee area nursing homes announced the opening of two nursing homes to AIDS patients.

The two nursing homes are the Mt. Carmel Health Care facility and the Greentree nursing home.

Tom Moore, Executive Director of the Wisconsin Nursing Homes Association said that he was "proud of the role" he and the Association played in getting AIDS patient placement. "A comprehensive educational effort is currently underway," he said for staff, patients and families. Moore added that he hoped that other nursing homes would soon follow suit. He noted that within "2-3 weeks" two more nursing homes should be "ready to open their doors" to AIDS patients. He did not specify which two these would be.

The Nursing Homes Association represents 258 nursing homes throughout Wisconsin.

Joe Higdon of the Greentree facility confirmed Moore's commitment to caring for AIDS sufferers and said that the first AIDS patient would be admitted by March

Doug Lesjak of the Mt. Carmel facility announced that in-service education was already underway although he would give no definite date as to when the first AIDS patient would be admitted to Mt. Carmel.

The opening of the two nursing homes is the culmination of a long process of delicate negotiations by MAP and the organizations Executive Director, Doug Nelson. Nelson thanked Moore "profoundly" for his efforts and extended gratitude to both Greentree and Mt. Carmel. Nelson said that MAP social workers and case managers would be prepared to render all possible help in giving care to AIDS patients in the homes. The Buddy System will be at the nursing homes, he said, and MAP will do in-service education as well.

However, Nelson said that the opening of these two homes was only "the first step toward high quality care." The numbers of AIDS cases in Milwaukee is, Nelson said, expected to increase.

Currently, Nelson said, there are 131 persons living with AIDS. By what he called "a very conservative projection" that number is expected to increase to 200

by 1990 and 300 plus by 1991. These numbers are for Milwaukee alone. Nelson was optimistic that as nursing home experience caring for AIDS patients grows, the numbers of facilities needed will be available. However Nelson again stressed the need for a long-term AIDS care facility.

Asked about staff response to the admissions of AIDS patients, Higdon said that at Greentree there had been "no overwhelming reaction; no negative comments. We expect it to be a positive experience," he said. Lesjak agreed that the same was true for Mt. Carmel.

Nelson said that the greatest obstacle to overcome was fear on the part of those unfamiliar with AIDS patient care. It was fear that caused the delay in the opening of the nursing homes to AIDS patients. But, he emphasized, this reaction was greatest from people who are not close to persons with AIDS. However, he stressed, there was no need for fear and that with on-going education, this would be over come as discrimination was increasingly dismantled.

"Milwaukee," Nelson said, "is a progressive, caring community." He voiced strong optimism that with education and continuing effort and good will on the part of all concerned, AIDS sufferers would receive the care that they deserve.

Federal Law Prohibits AIDS Discrimination

[New York, NY]- The American Civil Liberties Union (ACLU) has urged AIDS advocacy groups to take advantage of a new federal law which, effective Sunday, March 12, prohibits discrimination in housing based on that disease.

The Fair Housing Amendments Act of 1988 bars discrimination against persons with disabilities including persons with AIDS and HIV infection. It applies to virtually all housing in the United States.

Under the law, it will now be illegal for landlords to discriminate against persons with AIDS- related conditions in the sale or rental of housing. It will also be illegal for landlords to ask questions of prospective tenants about whether they have AIDS or a related condition. If a person were evicted or turned down for an apartment because he/she had an AIDS-related condition, that person could file suit in federal court.

[Washington, D.C.]- Senator Jesse Helms (R-NC) on March 17 killed legislation that would have extended by six months the federal government's funding program of AZT (Retrovir) for low-income individuals. The move comes as two states — Georgia and Kansas — have exhausted their AZT grants, with funding in several more states expected to expire in the upcoming weeks.

Wisconsin with 26 persons under the federal program, is one of 13 states who will run out of money in June, 1989.

Approximately 7000 people in the U.S. are receiving government assistance under the AZT subsidy program. AZT — which costs about \$8,000 a year at full dose — is the only government-approved drug for directly fighting AIDS.

Human Rights Campaign Fund (HRCF) lobbyists said the bill would not have allocated additional funds for AZT, but would have given the government time to reprogram already existing funds into federal AZT subsidies. For example, funds from states with surplus money could be moved into states whose funds have expired, or additional moneys could be located within the Public Health Service to subsidize AZT.

Majority Leader George Mitchell (D-Maine), who schedules legislation in the Senate, had stipulated that the bill would be brought onto the floor only if Senators could agree not to add amendments or to set a time limit for debate on amendments.

Legislative insiders on Capitol Hill said Helms, along with Senators William Armstrong (R-Colo.) and Don Nickles (R-Okla.), refused to agree to the stipulations, thus preventing the bill from being considered by the Senate.

"When we say Jesse Helms is 'King of Killer Amendments,' we really mean killer," said Robert Bray, HRCF communications director. "More people are going to get sick and die faster because they cannot afford life-prolonging drug treatments. It was not a good day in TURN TO AZT, PAGE 11

[Stevens Point, WI]- A new support group for HIV-positive persons has been formed for individuals in the central Wisconsin counties of Portage, Wood and Marathon by the Central Wisconsin AIDS Support Group, Inc. (CWASG) and the Central Wisconsin AIDS Network (CWAN).

Membership in this group will be limited to HIV-positive individuals only. To insure confidentiality, interested parties will be screened and will have to submit medical proof of HIV positivity (copy of test results or physician's letter). The first meeting will take place in late

The first meeting will take place in late March and subsequent meetings will be held bi- monthly thereafter. Agenda and issues to be discussed will be determined by the group members.

Although both CWASG and CWAN currently limit their activities to the above mentioned counties, interested individuals in surrounding counties (Shawno, Lincoln, Price and Waupaca) are invited to take part in this program.

A TIME TO DIE XIII

Nazi's Set Up 30 Work and Death Camps in Europe by 1942

We come now to the main part of our

In the Winter of 1938-39, the time of Rudolf's imprisonment, there were 9 concentration camps in the Reich. By 1942 there were 30 scattered throughout Germany and across Nazi-occupied Europe. The camps were divided into two types. One was the work camps, the Arbeitlager, where prisoners were routinely tortured, starved and worked to death. It was mainly in the work camps that the medical experiments took place. All the survivors I spoke with over ten years agreed that Gays were primarily the subjects of such experiments and they will be discussed later. Such camps included Dachau, Flossenberg and

The others, set up after the war began, were death camps, "Totenlager." Their



express and only purpose was the extermination of great masses of people by as efficient means as were possible. These included Auschwitz, Chelmno, Treblinka and others. Rudolf Hoess, Commandant of Auschwitz, writes that "at least two and a half million victims were exterminated at Auschwitz by gassing" in gas chambers "built to accommodate 2000 people at one time.' In addition, he says, "another half million died of starvation and disease."

All of the camps were under the jurisdiction of Reichsfuehrer SS Heinrich Himmler and that part of the SS known as the "Totenkopfverbande" or Death's Head Units named such for the white death's head insignia that they wore on their black uniforms

In a speech delivered at Metz in 1941 to officers of the SS, Himmler precisely described their duties. They were to "fight the Untermenschentium" the subhumanity. While this speech was given in 1941, there was nothing in it that had not been said again and again since 1933 and before.

It should be remembered because it has been ignored or forgotten, that Gays were considered among the "subhumans" and, as such, we were unfit to live. It should be kept in mind as well that in this effort at total extermination of those of us who are Gay and Lesbian, Hitler, Himmler et al, were doing nothing new: The only thing different was the use of the technology available to the modern totalitarian state to accomplish what had been started over 1500 years before.

In the 7th Century A.D. the Eastern Roman Emperor Justinian incorporated in the Roman Law, edicts ordering death for all Gays as the carriers of disease and sin. Attempts at our extermination have been on-going and unceasing ever since.

I have visited both Dachau and Auschwitz kept now as memorials to the millions who died there.

There is no way I can adequately convey what I felt by going there, anymore than I can describe the hurt and depression that comes over me as I resurrect for this series old memories from my notes. In most cases, I believe, these Gay men, Gay survivors who I talked with, are now dead. All that is left of them, of their experiences in Hell, are what I have on shards of paper and in my memory. But even that is something. For countless ten's of thousands of Gays, nothing remains of their lives. It is as if they never existed at all.

The vast majority of those who have written about the Holocaust from one

angle or another, have ignored us, sloughed over our sufferings as if it all never happened. By them denying us our history, they are saying we are subhuman and not fit to be remembered. Damn them! The Nazis annihilated us, the chroniclers erase our memories and so kill us again.

These people are kindred spirits with the so-called "revisionist" historians who write that the Holocaust never happened at all! If it never happened, it can all happen again just the way Gays are being slaughtered in Iran. In the name of what? I don't know. Some new Hitler who calls himself an ayatolah instead of a fuehrer. Different language, same

As I write, there returns the horror, the hurt, pain and finally, anger and rage that came as I heard the stories. These emotions even now, are all mixed up in me and they surface in full force when I think about the SS officer who sent Rudolf to hell. He was a closet case, willing to sell anyone to save himself. I know people

Still, as I sit here, I think too of the unknown Gay who, coming to Rudolf's cell, offered him the means of survival, a cup of water, a little food - and at what possible price?

Dachau takes its name from the little town that is just on the outskirts of the camp. It is a charming place, really, founded in the 13th Century. There are quaint shops, well-kept lawns, and a church whose bells rang out as I was standing in front to the camp's gas chamber. Those same bells only added to the horror of the place because they must have been heard by every Gay and other prisoner as they trudged hopelessly to their deaths.

The camps were vast and could easily cover all downtown Milwaukee. Today, at Dachau you can yet see the great parade ground which, in any camp, was the scene of beatings and tortures of all kinds. Beyond it are the reconstructed barracks, stark, gray wooden, row upon row of them, sitting low like slugs, separated by wide, unpaved roads. And beyond that sits the great white gas chamber, the ovens, the blood trenches. These all at Dachau, Auschwitz and elsewhere were the killing fields of Germany. These were the logical end of Justinian's law, of St. Peter Damian's curses, of St. Thomas Aquinas' maledictions, the terrors of the Inquisition and on and on and on.

In the next and future articles in this series, I will continue with Rudolf's story. It is the most complete that I have. But please understand my venom and my

David L. Neitzel, 1970-Feb. 22, 1989 Only a few issues ago, I was overjoyed at one of our Gay Youth members receiving a Black Excellence award. Now, on a profoundly sadder note, I must write about another Gay Youth member.

He died, February 22. A friend called to tell me. They had seen the article in The Milwaukee Journal. I don't think I ever knew his last name. At our Gay Youth meetings those are not revealed; a form of secrecy, protection or privacy.

I met David 3, maybe 4 years ago when

he was just starting to deal with his sexual orientation. We talked over the phone a couple of times and then he attended his first meeting.

Eventually his parents found out and there were the all too often usual reactions; anger, hurt, guilt and the customary "get-thee-to-a-shrink." He did not attend any meetings for some time, but he did call me and we talked. His parents came gradually to tolerate his orientation, but I think his father continued to have trouble with it and there developed a distance between them.

For the past year and a half, I would see David more frequently. He had been through a lot, but he seemed to be at peace with himself. He was not just coping with life, he was planning it.

I won't repeat what The Journal has reported, but suffice it to say that David was a top student, a worker in his church and the YMCA.

He wanted to be a beautician and he was good. His teachers said he had the potential to succeed on the international

Last Christmas he came to his last Gay Youth meeting. He told me he had two offers from top beauty salons in the country; one in Boston, one in New York and he had decided to accept the one in Boston to study under Giacomo. I wished him all the luck in the world, sure he

His death seemed so senseless. I know all his past trials were preparing him to

endure what was ahead. And now, he is written consent. gone in an instant. But he has left a legacy First National Lesbian Conference To Be Held March 3-6 in Durham NC

After an exhausting four days of discussion, some 160 Lesbians from across the country agreed upon a location and date for the First National Lesbian Conference. Convening at Duke University in Durham, NC March 3-6, 1989, the women chose Atlanta, GA as the host city for the event slated to occur between mid-March and mid-April, 1991. The exact date will be determined at a later meeting.

Deemed a historical decision, it marks the first time that a national Gay or Lesbian conference will be held in the South. As Lesbian visibility remains a key issue on the agenda, it was felt that as part of the overall process of social change, the Lesbian presence in a southern city such as Atlanta would carry greater impact than holding the event in someplace like Washington, D.C. Support for Atlanta was further expressed due to the large number of Lesbian organizations

based there. Finally, it was thought that as Georgia has a sodomy law, holding the conference there would favorably affect the host community.

From 4,000 to 5,000 Lesbians are expected to be in attendance at the National Conference.

Before Atlanta in 1991, two more National Planning Meetings will be held, the first in Portland, OR in July, 1989 and the second in either Columbus, OH or Chicago at dates to be determined.

[Washington, D.C.]- According to a press release from the Human Rights Campaign Fund Sen. Edward M. Kennedy's efforts to extend a program that provides the drug AZT to victims of AIDS who cannot afford the expensive treatment has failed, thus assuring that the program will expire March 31, 1989. We, the Executive Board of (Morgan's College) Gay/Lesbian Student Union (G/LSU), are very distressed at the content of the "Boy of Summer" column entitled "Silent Treatment" (Vol 2: no.5). The allegations raised against us are very serious, and we would like to take this opportunity to respond to them and present our side of the story.

When Mr. Summer left our group, we were sorry to see him leave; however, he resigned without notifying us and while we were investigating allegations that he had violated office policy. As our investigation continued, we found that Mr. Summer had indeed violated policy by taking confidential information for personal use. His actions included contacting a prospective member to make a date by taking his number from confidential office records.

Mr. Summer has told us that he has heard from a few members that they felt like the meetings were conducted in a very cold manner. Somehow they also got the impression that they were on display for us to "check out." We attempt to help everyone who comes to our group, and perhaps some of our intentions have been misinterpreted. Members will occasionally offer a new member their phone number with an offer to call if he would ever like to talk. This is done in the spirit of trying to help that new member feel that he is included as a member, not an outsider. We realize that we can not be all things to all people, but we attempt to make all who attend our meetings feel at

Galileo Galilei was excommunicated by the Roman Church about 1600 because he defied the Church and publicly stated his ideas that it was the earth that moved around the sun. Only in the last few months has the Roman Church finally said that they were wrong and he was right. Almost 4 Centuries late! How long will it take them to recognize that many of their popes were Gay or that we can use Church property? What is so terrible for a Gay person to act with Dignity?

Jamakaya's column, as your editorial points out, hits a critical issue. Having worked in Gay People's Union (GPU) with its library and newspaper, I know there are a lot of problems carrying out those good intentions. It takes money to do it well enough to be used and a track record of stability, plus a trained staff. Your editorial says that "Cream City Foundation is uniquely qualified." What are those unique qualifications? Have they ever run a library or archive? No, but GPU has and does. Have they been around long enough to show that they will endure at least as long as the papers you propose to save? No, GPU is the oldest Gay organization in this city in continuous existence.

Obviously both groups have had their financial problems over the years. Jim Kepner out in Los Angeles has great trouble keeping together his wonderful treasure trove of Gay/Lesbian items.

The best choice, in my opinion, would be the Wisconsin Historical Society (WHS) in Madison. Four years ago The National Association of Black and White Men Together asked me to find a place for their archive. We were accepted for inclusion by the WHS. That way our records are kept in a humidity controlled area, in fire-proof shelving, and organized by professional staff.

The second choice would be Northwestern University. The third might be the Milwaukee Public Library. But they are not really an archive. I worked there for five and a half years, setting up the Wisconsin Architectural Archive which was totally funded from outside sources. They have space limits.

Taking Off The Blinders! Part 2- Is the Resurrection a Myth?

The doctrine of the resurrection of Jesus is not just **one** of the doctrines of Christianity. It is **the** doctrine of the gospels and the Christian religion.

We have (what is alleged to be) the epistles of Peter, James, John and Jude — all of whom are said by the evangelists to have seen Jesus after he rose from the dead — but in none of these epistles is the incident of the resurrection even stated, much less that Jesus was seen by the writers after his resurrection.

The facts just recited should bring great discouragement to the hearts of those Christians who build high hopes of Immortality almost entirely upon the alleged resurrection of Jesus. For Paul says: "If in this life only we have hope in Christ, we are of all men most miserable. But now is Christ risen from the dead, and become the first fruits of them that slept. For since by man came death, by man came also the resurrection of the dead. For as in Adam all die, even so in Christ shall all be made alive (1 Cor. 15:19-22).

As a leading Christian theologian pointed out, the resurrection must have ben a physical event. "If the resurrection be merely a spiritual idea, or a mythicized hallucination, then our religion has been founded upon error." And Paul declares that, "If Christ be not risen, then is our preaching vain; ye are yet in your sins" (1 Cor. 15:14, 17).

Peter and John were the close friends of Jesus' James and Jude being his brothers. If the epistles that appear in the New Testament under their names are really their writings, as claimed by Christianity, it should strike any reader as strange indeed, that the resurrection of Jesus was an occurrence of such slight importance, that those who are alleged to have seem him after he rose from the dead, say nothing about it. Their silence comes with the force of absolute denial of the physical resurrection story.

The modern Christian doctrine of a general resurrection did not take its form from the biblical story of the resurrection of Jesus. The doctrine was a prevailing idea of the Jews long ages before the days of Jesus, making it very logical to assume that the story of the resurrection of Jesus was founded upon or grew out of this popular belief of the times.

One Hebrew writer maintains that the resurrection is reserved for the faithful alone — "So when he was ready to die he said thus: It is a good thing to be put to death by men to look for hope from God, to be raised up again by him; as for thee, thou shalt have no resurrection to life" (2 Maccabees 7:14).

Before the time of Jesus, the Pharisees — the dominant Jewish sect — were strong believes in a resurrection: "For the Sadducess say that there is no resurrection, neither angels, nor spirits; but the Pharisees confess both (Acts 23:8).

Paul appears to speak of the resurrection strictly as a belief: "But if there be no resurrection of the dead, then is Christ not risen" (1 Cor. 15:13). "Now if Christ be preached that he rose from the dead, how say some among you that there is no resurrection of the dead?" (1 Cor. 15:12). "For it we believe that Jesus died and rose again" (1 Thes. 4:14).

We do not know that Jesus died and rose again; we did not see him after the resurrection, but "we believe that jesus died and rose again." Why did they not settle the question once and for all by calling in as witness some of the "five hundred," who Paul says saw Jesus after the resurrection?

These statements by Paul evince the influence of the belief in the resurrection upon his mind. The questioning language is not such as would be used by one who had seen Jesus in the flesh after his resurrection. In fact, several Christian sects that flourished near those times, as the Corinthians, Carpocratians, etc., rejected in total the story of the physical resurrection (1 Cor. 15:12; 2 Tim. 2:18), furnishing further evidence for discrediting the physical resurrection of

Paul makes a laborious effort in the 15th chapter of 1st Corinthians to establish the resurrection belief into a doctrine, but his efforts hang upon such frail arguments, in place of facts, as is

exhibited in the phrases: "If there be no resurrection of the dead"; "if the dead rise not"; "if we believe that Jesus died and rose again."

These statements clearly show that, in Paul's mind the resurrection is at most only a belief which has not yet fully crystallized into a doctrine. As it evolved from a belief into a more definite and fixed form under such preaching, it became a doctrine that gradually adjusted to itself the two previous forms of belief — (1) the one of a last day resurrection, and (2) the other of a resurrection immediately at



death, in the dogma of the resurrection of Jesus on the third day after his death, and his coming again at the last day to raise and judge the dead.

The idea of a general resurrection at the last day seems to be the most common, and the one which the church adopted, although there seems to have also a belief in an immediate resurrection after death, especially for beggars and malefactors — "And it came to pass, that the beggar died, and was carried by the angels into Abraham's bosom: the rich man also died, and was buried; and in hell he lifted up his eyes, being in torments, and seeth Abraham afar off, and Lazarus in his bosom" (Luke 16:22, 23).

And to the malefactor, Jesus said: "Verily I say unto thee, Today shoult thou be with me in paradise" (Luke 23:43).

How soon the doctrine of the resurrection of the physical body, under such high-pressure preaching, became popular, we have no means of knowing. But it was not until some time after the writing of Paul were given to the church; for he, as we have seen, speaks of it as a spiritual resurrection. So also does Peter (1 Peter 3:18) speak of Jesus "being put to death in the flesh, but quickened (reanimated) by (in) the Spirit."

The legend became more and more popular as it spread abroad. Enthusiasm inflamed the credulous minds of the ignorant and superstitious, until the subjective visions of Paul, in order to satisfy the masses, at last became crystallized into objective reality.

In order to gain power over the people, Paul's visions and revelations and messages of the angels and others, were reduced from popular belief by the priesthood to historical facts.

Paul makes clear that the foundation of the religion of Christianity rests upon the belief in the resurrection, but why actually should it be of such significance? Is their Jesus Christ the first one to rise from the dead? Is he the last one? No!

Elijah raised a child from the dead (1 Kings 17:17, 21-22); Samuel said to Saul, "Why hast thou disquieted me, to bring me up" (1 Samuel 28: 7, 11, 15); Elisha raised the dead son of a Shunammite (2 Kings 4:32, 34-35); a dead man being lowered into a grave revived when he touched the bones of Elisha (2 Kings 13:1); Moses and Elijah revived at the time of the Transfiguration (Luke 9:28, 30); the saints arose en masse at the time of Jesus' death (Matt. 27:52-53); Jairus' daughter rose from the dead (Matt. 9:18, TURN TO RESURRECTION, PAGE 5

Celibacy in Catholic Church Is Merely a Discipline

This is the second in a series of three articles which are addressing the question of clerical celibacy in the Roman Catholic tradition. "Where did it come from and why is it still around?"

In the last column, we looked at how the idea of a celibate clergy slowly and rather erratically developed in the first 11 centuries of the Church's existence. The Gnostics, who felt that all sexuality was below spiritual dignity of the "reborn Christian" and, who also believed that any type of sexual activity or sexual pleasure defiled a person, had a strong influence upon the developing Church. They were not in the majority, but they made their "minority opinion" felt through their prolific writings and strong political position.

For the most part, the married clergy were in the small towns and villages doing what pastors were supposed to do; taking care of the spiritual needs of the people. They didn't have a lot of time to do much writing and politicking. At any rate, it was the so-called "intelligentsia" in the big cities, schools and monasteries who had the day and celibacy for the clergy became the rule, at least on paper.

Despite the fact that Church authority began to demand celibacy on the part of its clergy, the authoritarian pressure didn't automatically make it a fact in reality. St. Aelred's father was a priest and his grandfather, a bishop. (Both lived during a period when the Roman Church was pushing very hard for celibacy.) The fact that the Council of Trent (1545-1563) was forced to call for the suppression of concubinage among the clergy, clearly demonstrates to us that it was never a settled question.

Gradually, however, from the time of the Council of Trent to our present age, celibacy became the rule and not the exception and it became the fundamental operating principle of the Roman Catholic priesthood. By the time the Second Vatican Council came around (1962-1965), no one even raised the question — at least, not among the Council Fathers.

Celibacy was never proposed nor offered as a strictly dogmatic principle or matter of faith. It is merely a discipline and could easily be changed by a stroke of the Pope's pen. However, we cannot easily dismiss the Gnostic influence that is still around in our community.

Most of us grew up in a church where human sexuality was "merely tolerated" as the lesser of two evils! "It is better to marry than to burn in hell" was the "credo" of our Catholic grade school education. The early Church writers to whom we looked for spiritual formation were saturated by Gnostic thought and certainly weren't of much assistance in helping us to get our heads screwed on straight.

Those writers are still being read today. St. Augustine, for instance, viewed sexual desire or lust as an evil resulting from original sin and passed on from one generation to the other by means of sexual intercourse. With authors of this caliber promoting celibacy and the virtues of virginity, and other dissenting voices being ignored or suppressed, it is no wonder that celibacy is something that we have learned to live with.

Celibacy and sound spirituality are one and the same thing in the minds of most people. (My own parents refused to go to communion on Sunday if they had had sexual relations the night before. As my father was a salesman and only got home on the weekends, it doesn't surprise me that every Sunday afternoon, we got 30 cents to keep us at the movies as long as

possible.)

Over the past 400 years, writers in the Catholic Church have tried to "sell" the idea of celibacy by using every conceivable argument they could find. Obviously, Sacred Scripture says very little about the matter. (St. Paul gives us his own personal opinion about celibacy in 1 Corinthians and there is a passage in Matthew 19:12 which speaks of the "eunuchs who make themselves so for the sake of the Kingdom" — translated by some to mean "people who renounce sexual activity for the sake of proclaiming the Gospel." But that is pretty much the extent of the "witness from Sacred Scripture!")

Scriptural evidence lacking, the writers went to other sources to find the evidence they needed to prove that the Catholic Church was right in insisting on this celibate discipline for their ordained ministers

Now, Martin Luther is not what you'd call a "good source" from which the Roman Catholic Church would like to draw her wisdom, but when it came to celibacy, and when you're grabbing for straws, you'll go even to a "hateful source" in search of validation.

Martin Luther was one such source. It was pointed out that even though Luther broke away from the Church in 1517, he did not denounce clerical celibacy and, as a matter of fact, he supported that celibacy until 1522, a full 7 years after his break with Rome. He, himself, did not get married until 1525.

Along with other rather weak "pro-celibacy witnesses" such as Luther who only supported it for 8 years, the Church writers tried to appeal to logic and reason for their arguments. These "arguments for celibacy" were often ridiculous, crude and sexist.

An example of two of them: "The secrecy of the confessional is not compatible with the mutual confidences of conjugal love. The vicar's wife will gossip about what you confess to her husband!"Or, "You can't be a good preacher if you have to come home to a noisy and demanding household. A priest needs quiet contemplation and a peaceful setting in order to preach well." (This guy obviously didn't hear many priests' homilies nor has he visited a modern parish house where "busyness" is the rule.)

Another argument equally unfounded: "Only a celibate can have the undivided and liberated heart that is needed for a dedicated ministry." (That writer obviously didn't meet any of the many very dedicated and hard working non-Catholic Pastors who, quite literally, give the whole of their lives to their work and still live very fruitful married lives. I find the proportion of dedicated to non-dedicated ministers to be exactly the same whether those ministers are Catholics or not, married or celibate.)

There are other such arguments that are presented that came to my ear: "How can we Catholics afford to support a priest if he has a family?" — This, from a lady who belongs to a parish of 4,000 people and who has a lady friend from a Lutheran parish that has 350 people and who pay their minister \$35,000 a year! Well, it's nice to know that the Church hierarchy is not the only one who clutches for straw arguments when they don't want to do something!

I'll continue this discussion in my next column. Keep the letters and comments coming. It keeps me thinking and God bless

23-25); the widow of Nain's son rose from the dead (Luke 7:11-15); and Lazarus rose from the dead (John 11:43-44). All of these people rose from the dead and all did so before Jesus. So why give such importance to the event? By the time Jesus rose from the dead this was a rather common occurrence. Moreover, people not only rose before Jesus, but after him as well. Peter raised Tahitha and Paul raised Eutychus.

If this is raised to a Christian, the answer might be that all of the above-mentioned people died once again, but Jesus never died again. However, the Bible says no such thing. Paul said its the "resurrection" per se, that matters. The allegation that Jesus did not die again has no significance in the matter. If the Christian was asked to cite a passage that would justify his contention he would not be able to do so for there is no such passage.

Finally, this would be contradicted by the Old Testament. Enoch and Elijah never died. See Gen. 5:22-24 and 2 Kings 2:11. Elijah went directly to heaven - he did not die first.

Thus, there is virtually nothing that Jesus did that had not been done before. Assertions alone prove nothing. A good look at the Bible will show that Jesus did nothing that substantiates his credentials as the Savior, that others did not do before him.

In some of our future columns we'll discuss the fallacies of other Christian contentions concerning the credentials of Jesus as Messiah and Savior. We'll also demonstrate clearly the danger in relying upon the words of Paul as compared to those of Jesus himself.

Folk Singer Heather Bishop Performs March 24th in Milwaukee

Heather Bishop is a Canadian folk artist and she is coming to Milwaukee on March 24 to perform at the War Memorial Center. This concert is the second in a series featuring Canadian musicians sponsored by Full Moon Productions.

Heather's music reflects her high political consciousness. She was a strong protester against the Vietnamese War and that awareness, sensitivity and idealism is reflected in her music. She is, in fact, one of the few musicians whose lyrics deal with incest, abuse and racism. She is an open Lesbian which is, I think, refreshing, especially in a time when the shift of artists in "women's music" seems to be toward genderless songs — an attempt, perhaps, to gain wider market acceptance.

Heather's newest album, "Walk That Edge," should be available at the concert. I have been told by Joan Miller her long-time manager, that is a "folk album with a bluesy, country western flavor. It is on Mother of Pearl Records, Heather's own label.

I've had a chance to see Heather, both in Bloomington and here in Milwaukee in 1987. She is a vibrant performer with a dynamic energy that gathers her audience to her and holds them in her spell. A part of that is, I think, that she plays to the little kid in you which comes out, for example, when she leads the concert hall in a rousing ode to bellybuttons.

She leaves no questions unanswered. There is no room for speculation as she sings, "I wanna be seduced...I want a woman to take me out to dinner for two...

One of my favorites concerns the risks of a personal relationship. It's called "Yukon Rain" and sings about making a fool of myself and "counting on our friendship to see us through this one."

Heather Bishop is a seasoned performer with a rich voice singing brand new material. What better combination for predicting a great concert? Hope to see you there.

All that is over now. No doubt some Gay men will be unable to break the habit and will continue to consume black market poppers. But no longer can poppers be presented as harmless "room odorizers" or as an accepted part of the Gay male lifestyle.

British Humour Invades Repertory and Skylight Theatre Stages

[Milwaukee]- We talk of British humor, but just what is it? Well, currently there are two shows in town which are prime examples of this genre, yet they are totally different. "Good Evening" with Montgomery Davis and William Leach at the Stackner Cabaret of the Milwaukee Repertory Theater (MRT) presents the antic side of British humor, much of it dependent upon putting a reverse spin on reality.

These two pros, Davis and Leach, exploit British eccentricity, the off-center situations, characters and language that the late Kenneth Williams did so outrageously in "Pieces of Eight" (e.g. "Eunuchs are the ones with no humps, aren't they?"). It's the dithery, dotty side of the British character that comes out on "Red Nose Day" when millions of Britons, including the royal family, put on shiny plastic noses.

"Oh Coward" at the Skylight Comic Opera, on the other hand, typifies the other side of British humor. Designed to showcase stylish drams, sophisticated songs and witty repartee of Noel Coward, it offers a worldly-wise, smart comedic style with a subtext of sexuality, much of it with a clever Gay appeal.

Peter Cook and Dudley Moore wrote "Good Evening," and several sketches in the MRT program have been added from "Beyond the Fringe", the '60's revue in which Cook and Moore also had a hand. Monty Davis who directed the Cabaret production plays the chubby, brash member of the duo; he is very good at British lower class dialects, sings a bawdy Elizabethan madrigal with much winking and smirking and plays an unimpressed shepherd who was present at the Nativity. "The stable was all mucky."

Leach, in contrast, plays the proper upper class toff, stiff upper lip and all, with consummate poise. Both actors, without missing a beat, slyly ring the changes on humor which is characterized by irrelevance, inane repetitions and non sequiturs. Fast paced throughout, it's a fun show.

The drawing room comedy of "Oh Coward" is presented with sheer energy by a youthful foursome. They sing, dance, recite poetry and enact scenes from Coward plays and musicals, even play the maracas for "Nina from Argentina." Steven Hauck is urbane and debonair and at times has the whimsical air of a P.G. Wodehouse anti-hero; his rendition of "Don't Put Your Daughter on Stage, Mrs. Worthington" is echt Coward.

Hauck and Traci Lyn Thomas capture the requisite air of leisure class ennui and deliver the brittle dialogue oh so convincingly. Court Whisman's suave manner and tenor voice are engaging, and his rendition of "Alice is at it Again!" is hilarious though he has a tendency to lost the British accent. Melinda MacDonald tends to belt songs a la Broadway and this simply is not the Noel Coward touch. Her true metier comes out in Coward's satiric portrait of a mid-western matron in Paris talking on the phone with a minimum knowledge of French.

Some highlights include the singing of "I've Been to a Marvelous Party", "Mad About the Boy", and an updated version of "Let's Do It." The scenes from "Private Lives," "Blithe Spirit" and "Design for Living" are welcome reminders of Coward's brilliance as a playwright. "Design for Living" wherein Leo and Otto love Gilda and Gilda loves both Otto and Leo and Leo and Otto love one another was very daring for the '30's, but it still rings true today.

Faith and Reason Confronted With "Agnes of God" at Clavis Theatre

It is a struggle between faith and reason brought to confrontation on the stage in John Pielmeier's play, "Agnes of God" to be performed by Milwaukee's Clavis Theatre Ensemble under the direction of Ted Altschuler.

It's a battle that is as old as history and as new as tomorrow. It goes on in each of us as we try and interpret our world in terms of the never dying hope of a nexus with things unseen.

"That's the way it should be," Altschuler says leaning forward in his chair. He is an intense young man, a New Yorker come to Milwaukee four years past where, he says, "I can be an artist."

"What happens on stage," he continues, "is what happens in the newspaper. You don't enter the theatre and leave the world behind. "Agnes of God" deals with the questions of reason and faith and that's as contemporary as anything."

He sits back, turning his head to look out the windows set high in the wall of the rehearsal room. Beyond, a late Winter storm howls in cold, white fury as if it would deny with all of the force at its command, the coming wonder of Spring and resurrection. It is a fitting setting to be discussing "Agnes of God." Isn't that what the play is all about; the chill of the intellect confronting the regenerative

possibility of miracles?

Key to the drama, of course, is the young nun, Agnes, played by Amy Zeh. It is Sr. Agnes who gives birth to the doomed child. As Zeh sees Agnes, "it is a miracle, an angel come down" from God. Zeh explains this with a gentle calm and soft expression that bespeak a fine actress involved deeply in her role. He demeanor is in sharp contrast to the storm beating against the windows.

That meeting of the human and the divine, as has happened with others in myth and history, is the nun's downfall, Zeh explains. Her experience with God, with the searing Love that is God, is both her apotheosis and her destruction.

Outside the storm continues to rage and seems to pick up strength.

The Mother Superior of Agnes's convent must marshal her faith to assimilate this. Kay Knudsen who plays Mother Superior, sees her as far removed from the simplistic, almost virginal innocence of Agnes. She has come to terms with her faith, but it is not an unquestioning, unthinking acceptance. Unlike the great mystics of the Church, she possesses a broad worldliness.

Knudsen's large eyes are warm with intensity as she discusses her role. Mother Superior has about her, says Knudsen, "the elements of the mother earth." Her "instincts are very natural, very female." It is with these that she confronts the birth and death of the child and from these reserves she draws, as from a well, her hard-gathered faith and determination to protect Agnes.

It is the psychiatrist to whose lot it falls to investigate the child's death, who provides what Altschuler sees as the central conflict in the play. She is not simply an ex-Catholic. She is, as Altschuler sees her, a person who has remained a Catholic while dropping that faith in favor of the religion of reason. It is she, Altschuler says, who, in the conflict presented by the playwright, changes.

"Agnes of God" is not simply a play about science vs. religion. Altschuler, Zeh, Knudsen and the other artists who are creating it, see it as a disturbing drama that offers a mix of humanism and religion that raises questions about the acceptability of faith in this day and age. It is a work that leads us to see that the storm in every soul rages there because of the weaknesses in both faith and reason.

"Agnes of God" will be presented at the Clavis Theatre, 2239 N. Prospect Ave. It will run from March 24-April 30. Believe me, having met with some of the people involved, having discussed their work with them, this is a must see play.

Downtown Milwaukee offers some attractive and interesting late Sunday morning brunches. With the coming of Spring, you might want to take advantage of some. Here are a few that a friend and I have checked out recently.

We avoided the Hyatt, Wyndham and the Pfister since those are the first places folks think about. Instead, we concentrated on some you might overlook.

Lake Park Pavilion

Great setting overlooking Lake Michigan. There's a porch and a cascade of stone steps leading down from the tall bluff on which the Pavilion stands. Or you might try the main room and overlook the golf course.

Couples come with Sunday morning papers to have breakfast, sit on the porch, drink coffee, and watch the sailboats and freighters move across the glass-like lake. No one hurries you. Breakfasts are inexpensive and it's most relaxing.

If you're not partial to paper plates and plastic forks, you'll not like it here, but that aside, the simple atmosphere and relaxation are worth the short trip. It is located at 3133 E. Newberry Blvd.

The second alcove has all you can eat crablegs, smoked salmon, as well as every kind of salad. The seafood is heaped high on long counters and they never run out. The third alcove is a room with hot pastas and wonderful sauces, tiny meatballs and roast beef sliced to your desire.

Breads, coissants, rolls and Danish, hot, fresh and aromatic, are arranged on side tables that form the center area between the three main food locations. Champagne is served at your table as well as a variety of Sunday morning drinks.

Pieces of Eight is very busy. The brunch runs about \$14.95 per person, but what a surprising delight from this restaurant that usually gets grudging reviews. They are located at 550 N. Harbor Dr.

I've never thought of this restaurant for breakfast, but we tried it one morning and found a delightful reception and menu.

I had the Super Hopple-Popple and my friend tried the potato pie. Great! We had a choice of exotic omelets and belgian waffles with strawberries and cream along with a wide variety of other entrees. All these sounded wonderful, but where else can you get Hopple-Popple? The regular luncheon menu is available, of course, if that suits your fancy better. Try it. The costs are moderate as always. 
Park East

"Gays Against Drugged Sex" -**Group Proposed**

In this column I would like to expand on the concept of a kinder, gentler society. I do not believe that government or politics can do anything much to bring this about. It is something that each and everyone of us must work on. Just what is this kinder, gentler society?

It is a society of individuals who have a deep and committed sense of compassion and caring for themselves and for others. It is a society which is moved, not by fear, judgment, prejudice, division, control or violence. It is a society which is moved by seeing what is, doing what is right, understanding others and being involved and moving beyond the small self-centered world we all tend to create around ourselves.

How does this translate into practical terms? There are some very interesting reports that are being published now which point to the fact that those individuals who test positive for HIV or who have been diagnosed with AIDS, are surviving longer when they can arrive at self-love and fill their lives with loving, supportive relationships. USA Today had a small article in it on February 23 which I would like to quote.

"For Christmas 1986, Bob Mehl got a leather jacket. A friend said it would be a shame he wouldn't get much wear out of it. Mehl—diagnosed with AIDS almost three years ago-happily told an audience this week, 'I'm still wearing the jacket and it's been several Christmases since.' Mehl attributes his long survival to self-love, volunteer work, a sense of humor and several drugs, including AZT which he has taken two years without side effects that plague many users."

There was a recent report in JAMA [Journal of the American Medical Association) which reported a very similar phenomenon which love and supportive relationships and an other-directed concern can contribute to a longer, fuller life. But isn't this something that everyone would want - those infected with HIV as well as those who are not.

Thus, each and everyone of us can contribute to bringing about this radical change in society. But the hard thing is to actually do it because there are so many forces within society and within ourselves that block us from doing this and we all have to watch and observe what it is that stops this from happening.

An inner sense of conflict is one of the biggest stumbling blocks. We all, at times, have a sense of being not loved, abandoned, judged as bad individuals, wanting to be accepted, wanting to be judged as good. But we can never change this by making that all-out effort because society will never allow this to be. We get stuck in ourselves. A conflict which I suspect is very common is the attraction to other individuals, but the fear that if one had sexual contact with this person, one could contract HIV. Thus, there is the strong dichotomy between the pursuit of pleasure and the avoidance of pain.

But is there a way of living that goes beyond this pleasure/pain conflict? Pleasure and pain are both involved the memory and thought. I had this experience in the past which was very hurtful, sad and uncomfortable and I don't want it to happen again. Can we live life without these overpowering memories? Can we participate in life fully with just what is going on right now between me and others, between me and my environment - the sun, the wind, the birds and trees, the lake, etc. It is a challenge; it is definitely a challenge.

So let's apply this to the bar situation. Many people go out to bars to be with people, to find someone to talk and visit with, to forget our sorrows, to deaden the pain. There is a sense of being unloved possibly or wanting some physical contact with another human being. But the reality is that alcohol and cocaine suppress the immune system and make a person more susceptible to becoming infected.

Secondly, under the influence of either, a person looses control of their inhibitions and gets careless in the indulgence of sex another way a person can get infected.

Thirdly, especially with cocaine, if the person has a heavy habit, there is the constant threat that if it is available only through needle sharing, at some point in time, the strong craving will lead the

person to share even dirty needles. This, of course, is another way to get infected. This whole situation spells trouble and, in fact, in Chicago as many as one third of the substance abusing population is already infected with HIV. We don't know for sure what is happening in Milwaukee yet, but we have to be very careful.

I propose for a kinder, gentler society that we start a group called "Gays Against Drugged Sex" - GADS. The group would not be opposed to going to bars and meeting people. The group would not be opposed to physical contact. The group would not be opposed to friendship and loving relationships. But the group would only be opposed to having sex with a person who is high on cocaine or drunk or compromised by any drug. The person who is under the influence of some drug is still worthy of love and affection, but cannot be a partner in a sexual encounter. The risks are simply too great.

If this type of approach becomes the custom and expected norm of those who go out to the bars, perhaps many infections with HIV can be avoided. I especially would hope that the youth who are just coming to grips with their sexuality could hold strongly to such a

What will this take? We all have friends who have trouble with drug problems. We all have friends who are not yet in a settled sexual relationship. We all share in the very real and gripping conflicts of good and bad dichotomies. So, can we all get involved and educate the youth, lend a helping hand to those with drug problems, show others that someone in this world truly cares? Can we give a loving hug to the person infected with HIV or diagnosed with AIDS? Can we reach out to the person who has withdrawn and isolated him/herself because of pain, depression and fear? The answer rests with each and every one of us. Can society become a kinder, gentler place to live?

I wish everyone well. So, eh, GADS, let's get on with life. Love, Roger.



Violence Against Gays Continues On Milwaukee Streets

[Milwaukee]- It happened again, but this was neither the first time nor terribly enough, will it be the last.

Randy had left C'est La Vie, a Milwaukee bar on South Second Street. It was about 1:30 am. Suddenly, he saw a van pull up and men leap out. Before he could do anything, or even think what to do, the men had grabbed someone and begun to beat him.

The victim finally escaped his assailants and stumbled into the nearby Phoenix bar. Randy followed him and found the young man in the bathroom.

It happened only recently. The memory is still engraved on Randy's mind. He can still see him, a young man, only 24, his head gashed, a gaping hole in one cheek, his lower lip severed and hanging down, blood all over his face.

Randy took the guy to St. Luke's hospital. The doctor, Randy said, was very sympathetic. "He asked me if I would hold his (the victim's) hand to calm him." Randy did as the medico stitched his face back together again.

Afterward, since the young man did not want to return home, Randy took him to his home where he and his roommate took turns taking care of him.

Paul is standing nearby as Randy tells his story. He's a big man, someone who few would want to fool with but, as he said, he's seen plenty.

In February he was driving past La Cage, late, when he saw a "kid" who had come from the bar, getting beat up. Paul didn't stop.

"It's a regular thing," he said. "There are guys cruising up and down Second Street to National, always the same old cars, always around closing time." If they see someone walking alone, "they stop and try to entice the person into their car."

Other reports reaching us substantiate what Paul said. According to these reports, several similar looking cars and vans have been seen prowling the area from Water Street to National always around bar closing time. Sometimes the assaults are verbal, shouting epithets, etc. But there are also the cases such as Randy experienced.

According to several reports, some of the attackers may be involved with gangs who require that a prospective member "beat up a queer" before they can join.

As we have said before, take all possible precautions. Do not walk alone and watch out for your friends. Don't be the next victim.

If you know of an incident of either verbal or physical abuse, report it to the police and to Wisconsin Light. The one thing these thugs who prey on us don't want is publicity. By using the media, you can help put a stop to these crimes.

AIDS Parallels Nazi Holocaust

With the fiftieth anniversary of the outbreak of World War II approaching in September of this year, there has been renewed interest in the events and causes of that great conflagration. In the fall of last year, for example, there were solemn observances of the official beginning of the Jewish Holocaust.

As a Gay and Lesbian community, we have much to learn from the Jewish experience as we attempt to come to grips with our own Gay Holocaust, not only in the 1930's and 40's at the hands of the Nazis, but in the 1980's at the hands of our own American government.

I know that that last sentence probably has turned off a good number of people who read this paper. That is most unfortunate, especially since one of the most important lessons we can learn from the Jewish experience in Germany is not to ignore the reality of what is happening to us.

There were many Jews in Germany who chose not to believe what was happening to them until it was too late. They thought that only the so-called "troublemakers" - those who chose not to grovel, but to organize against the Nazis and/or openly continue the practice of their faith - would be harmed. They couldn't or wouldn't believe that the country they loved would be so cruel to them.

In much the same way, we have many American Gays and Lesbians who as good, productive citizens, can't bring themselves to accept the truth of what is happening to their community.

Our government has not opened up camps nor built gas chambers for us, but just as the Nazis set out to deliberately destroy the Jews of Europe, our government has set out to deliberately destroy us by letting AIDS do the work.

Anyone who believes otherwise should get a copy of Randy Shilts' book, And the Band Played On. and read, among other things, the memos sent between Reagan Administration officials ordering the denial of the existence of AIDS.

Just as many German Jews were convinced by the Nazi's soothing statements that they were in no danger until it was too late to escape, many Gays believed our government's statements that they were in no danger.

The Jews in Germany were a despised part of the population, being called, "subhumans" who were pushing their values off on "decent people."

Today, we see the unadulterated hatred many hold towards us. At a Right Wing conference in Chicago, it was said from the podium that thanks to AIDS, most, if not all, of us would be dead in five years. Hundreds of "decent" people stood and cheered. Even the organizers were shocked. Many Americans see us as child molesters, people interested only in sex, people that no "self- respecting" person would have anything to do with.

There were Jews in Germany who, with pride and self-respect, fought back. But far too many bought the Nazi line. Why? Out of hopelessness, fear or the belief that there really was nothing to be afraid of. Then too, any Jew who stood up was likely to be criticized from within his/her own community. "Don't make trouble and they'll leave us alone.'

Today, there are similar attitudes in the Lesbian/Gay community. Recently, Miriam Ben-Shalom appeared on the Sally Jesse Raphael Show. Speaking about this, a man I know told me that a friend of his was disgusted by Miriam's appearance. Miriam, said the friend, had no business telling the Army she was a Lesbian and that in so doing, she had brought her problems on herself.

If the friend reads this, I want him to know the contempt in which I hold him. I know the agony and suffering Miriam has experienced. Her fight is an act of greatest courage and only through such acts will we ever achieve equality.

Unfortunately, far too many of us agree with "the friend." If you march, demonstrate, propose legislation or even walk down the street holding your lover's hand, you're a "troublemaker" bringing the wrath of society down upon us.

It is ironic that many of those who call themselves Gay or Lesbian condemn the actions of those of us who attempt to fight when courage and the willingness to fight

back are our only hope.

The parallels between ourselves and the Jews in Germany are close, far too close. Daily we experience random acts of violence as did they prior to Kristalnacht, the beginning of the Holocaust. Where is the popular outcry? Where are our public officials and community leaders when we need them to denounce these attacks?

Even when non-Gays have been victimized because of AIDS, our leaders have been silent. When the home in Florida was burned because of two hemophiliac children who had contracted AIDS, did Ronald Reagan condemn that act of violence? He did not. Christians in Germany and throughout Europe could have helped the Jews, could have prevented the Holocaust had they chosen to do so. Some did, in fact, help, but there were far too few of them. For the many there was only fear and even a sharing of Nazi hatred of Jews that led them to turn their backs.

Today we see much the same thing. There are the "fag jokes" at work, politicians who "sympathize" with us but fear the political consequences of open support. Like many of the Jews of Germany, we sit today with our heads in the sand.

What the Nazis did was fueled by pure hatred bred into its perpetrators by years of well-taught myths and stereotypes. These same types of things are being taught about us today.

In Nazi Germany, untold thousands of us joined the Party, the SA and the SS for the prestige or because they thought they would be safe from the doom Hitler had pronounced on them. In the same fashion today, there are Gays and Lesbians concerned about the latest styles, the hottest bar, the newest hit single than they are about the fate of their own people.

Even worse are Lesbians and Gays who support our enemies in the hope that they will be protected. This, among other reasons, is how they justify their support of Reagan, Bush and others even though there can never be any justification for supporting those who want us to die.

Many of the Jews of Germany believed that an accommodation could be reached with their oppressors who, in turn, denied what they were doing. Reagan-Bush have told us they are doing everything possible to help us. But even the Federal Government's own figures tell us that for every PWA there are 10 who are suffering with ARC. In the meantime, the Centers for Disease Control has restricted the definition of AIDS to keep the public from knowing how widespread the disease

The AIDS epidemic is a holocaust for us just as certainly as what was done in the Nazi Death Camps. Both are the result of government policy. But there are differences. We have access to the media. We can organize freely. We can use the political process to vote our enemies out

We all must realize that spreading myths about us directly feeds anti-Gay/Lesbian violence and makes it more difficult for us to get the resource to fight AIDS. Let the media know that we are tired of letting those who hate us spread their vile doctrines. The mainstream press wouldn't print letters containing slurs about other minority groups. Yet they run syndicated columns by people like George Will who once wrote that government funds should not be used for AIDS research because it only benefits Gays and Drug Abusers who brought their plight on themselves.

You can have an impact. In Milwaukee, when Perry Stone, a "shock jock" on WQFM viciously attacked us, we fought back and he was fired. (He has just been booted off a station in San Francisco for

verbally assaulting two little girls.) Organize behind candidates who will support us. RISE UP! Contribute to their campaigns, volunteer and vote for them. When someone who thinks they are Gay or Lesbian talks about how AIDS sufferers brought it on themselves, RISE UP. Let them know they are not part of our community. When you hear someone talking about how the government is doing all that it can to fight AIDS, RISE UP. Tell them the facts. When you see an

In An Attempt to Become "Straight" Lands Him in Jail

Writing my feelings down on paper has never been easy for me. I was never one to be able to keep a diary. I was always terrified that someone would run across those private feelings which I had transposed onto paper. Although I'm nowhere near being a private person, I don't like just anyone being able to see into my head and heart.

But now is the time, I believe, to share some of these experiences. You see, I like to talk to people I meet in the bars. I even eavesdrop at times and what I hear gets me to thinking.

Too often, a topic I hear discussed is chasing "chicken." Many Gays are obsessed with youth as if getting it on with a much younger man could somehow make them feel younger, more virile. Unfortunately, this attitude is reflected and reinforced in Gay videos and literature.

Two years ago, I had moved back to my hometown in an attempt to make myself straight. I got a job in a small restaurant and a girlfriend as well.

There was this guy - a boy - who worked there. He was 16. I was 20. His name makes no difference, but from the day I started working, I caught him looking at me. I dismissed it as a subconscious fantasy. I had a girlfriend and that was that. Uh-huh. Yeah. Right.

After a couple of months, the kid began to suggest that we go party together. Finally, we made plans. He was going to get some buddies - make it more of a party that way - and there'd be no girls. This way, you see, we could really cut loose. Yeah, sure.

The big night came. I bought the booze and then picked him up from work. On the way to his place, he informed me that he hadn't invited anyone else. I knew what was going to happen and I know now that he did as well.

We went to a secluded spot he knew about and set out a blanket and the beer. We drank a lot in a short time and started talking. "Of course" our bantering led us to wrestling. That's when I discovered he was aroused.

I stopped suddenly and looked into his eyes. His lust mirrored my own. I let my hand roam and it went from there. I was feeling somewhat guilty, so I asked him if he was sure if he wanted this to really happen. He did, so we did.

It was a week later that the sheriff showed up at the door. I wasn't home so my parents had the honor of being informed that I was going to be charged with sexual assault, rape, in other words.

My best friend talked his parents into letting me stay with them after I was kicked out of the house. They stood by me throughout the trail. Eventually, the felony sexual assault charge was dismissed because I proved I hadn't assaulted the kid. But I was found guilty of a misdemeanor of sexual misconduct with a minor. I spent 30 days in jail.

Gary, I don't know if you'll see this, but thank you. You were a great help and, yeah, a great friend too.

It's all finally behind me. The shame and guilt I felt took longer to deal with, but now I have. I hope my sharing this will help someone think thrice before giving into temptation. Even if the act is consensual, the kid may decide he's "not really that way" and was, therefore, seduced and can anytime afterwards

I might add that the younger he is, the nastier it's going to be for you. Wisconsin does not recognize anyone under the age of 15 as being able to decide that they are ready for sex. Believe me, you do the crime, you will do the time! Eighteen is the law and even that is pushing it. Most kids that age can't handle sex, let alone anyone under that age.

If there is anyone who would like to write, whether because of having gone through a similar experience or young people who want someone they can write to, feel free to do so through The Light. Don't give in, be healthy and most of all,



Washington for affordable health care."

Last September, Congress authorized \$15 million to continue the program until March 31, 1989. The new bill would have extended the subsidy program through September 30, 1989. The program was originally created in Spring of 1987 when AZT was first licensed. Congress has adjourned for two weeks and will not reconvene until April 4, after the program has ended.

The legislation was introduced into the Senate by Ted Kennedy (D-Mass.), who rallied wide-spread, bi-partisan support for the bill. 14 Senators from 13 states were co- sponsors. Wisconsin's two Senators were not among the 14.

HRCF furiously lobbied for passage of the bill before the current program expired. Among other actions, HRCF sent 3,300 mailgrams to Capitol Hill, urging

When Should Partners Be Told Of AIDS Virus Infection?

Should HIV sero-positive individuals assume the full responsibility for informing their sexual partners that they are infected with the AIDS virus?

My views regarding disclosure have changed considerably since the early stages of my diagnosis. In those days, since I was ashamed of being HIV positive, my primary concern was preventing others of being aware of that fact. I was afraid of the consequences; discrimination by insurance companies, housing authorities, landlords, some hospitals and doctors, neighbors and, most cruel of all, rejection by friends and family. I determined to try and protect my confidentiality at all costs.

Eventually, I decided to abstain from sexual encounters. But, after several months passed, I found it more and more difficult to refrain entirely from sex. I also felt that I shouldn't be expected to abstain as long as I took every precaution I could so as not to transmit my virus to my partners.

Returning to the social environment was a slow and difficult process. I still wasn't sure I was doing the responsible and ethical thing in not telling my partners I was a PWAV even though taking all precautions and practicing safe

Then I started compromising, figuring that if I only participated in mutual masturbation, kissing, cuddling, etc., I shouldn't need to be concerned with disclosure, for I wasn't putting my partners in any dangerous situations and they weren't putting me in any. But, as time passed, not even this decision eased

I then decided to drop all of my excuses, inhibitions and fears, concluding that the only way I was going to feel comfortable and responsible about my sex life was to let my sex partners know right up front that I was HIV positive.

I backed out of my decision several times, but finally carried through. The results were disappointing, but I felt good about me and I continued to do it. The results were the same. Guys would be diplomatic and considerate, but not willing to take the risk.

Then someone told me that I was approaching the situation negatively. I

was disclosing the information with such a tone of shame and disgust that a potential partner could only take the news in a negative manner and be turned away.

In time, with much support from groups, family and friends, I came slowly to accept my body and me. I discovered I was still somebody! This didn't make disclosure all that much easier, but at least I was able to do so in a more positive way and not feel the deep-seated shame, fear and humiliation I had felt. If a guy decided not to get involved, I just accepted that as his right and respected

Sure, rejection does get to me at times. But then I say to myself, "It may be hard, but look at the quality people I am getting to know and I am feeling a lot better about me! I'm no longer ashamed of my body and that's the important thing.

I am no longer concerned with the disclosure dilemma. But what about you? In the initial stages of a relationship, not knowing whether it will develop into a sexual one, is it better to wait? We all know that, unexpectedly, intimate moments can and do pop up.

I would like to hear from you, for, as I have said in this column, I would like to put together a book containing the experiences, thoughts and feelings of HIV positives and those of your friends and loved ones. The BASIS Project is a national program screening individuals who may have hidden syphilis. Participants enter a two to three month process of evaluation and testing - resulting in recommendations to them and to their physician.
