Madison Safer Sex Awareness Day September 22

[Madison]- The Third Annual Safer Sex Awareness Day will be held in Madison on Saturday, September 22, 1990 in Library Mall from 12:00-4:00 p.m. The event is a kickoff for the Madison AIDS Support Network's (MASN) University Outreach Education Program at the University of Wisconsin-Madison.

The day is designed to be a non- sexual, non-threatening way for students to become aware of and involved in HIV prevention techniques. Features of the day's events include: the band, Switchtrack Alley, The Condom Games, Pat the Prophylactic, information, comedy, prizes and speakers, including persons infected with HIV and a dance at night, "The Rubber Ball."

Condoms and the spermicide nonoxynol-9 have been found to be extremely effective in preventing the transmission of HIV, the virus which causes AIDS. MASN hopes to enable students to learn about and feel comfortable with using condoms correctly as well as providing individuals with risk reduction information to encourage informed choices about safer behaviors.

Another purpose of Safer Sex Awareness Day is to offer an opportunity to approach the issue creatively-- allowing students to use humor to address their own vulnerability. The Day will open the door to further discussion, and will allow students to be receptive to more serious programs that will follow later in the year.

Winners in each of the events will be awarded prizes donated by local businesses. First Degree **Murder Charge** Dropped

[Milwaukee]- Circuit Judge William D. degree murder against James G. Malone for the slaying, in 1988, of Dennis Owens, a Gay man employed by WITI-TV 6.

At a hearing September 5, Judge Gardner let stand a charge of armed robbery connected to the murder and set the trial date for October 19.

Prosecutors asked for dismissal of the murder charge after admitting that they could not prove beyond reasonable doubt Malone's responsibility for that crime. Malone's accomplice, Dirk Harris, has already been convicted in the first degree murder and armed robbery of Owens. He was sentenced to life in prison with no parole until the year 2035.

Owens, 31, was shot five times and run over by a car after being robbed. His body was found in a lot on E. Florida Street in the Gay bar district. At his trial, witnesses testified that Harris planned to

"roll a queer." Owens is fondly remembered as a quiet and friendly man by patrons of the Gay bars he occasionally visited. He was respected by his colleagues at Channel 6 where he worked as a floor manager and cameraman in the news department. Coworkers noted that Owens often donated his time, money and technical skills to charitable causes.

"The Wisconsin AIDS Walk is fast becoming a high profile event around which people are rallying to demonstrate solidarity and support for all people affected by the AIDS epidemic," said Doug Nelson, Executive Director of the Milwaukee AIDS Project (MAP).

Nelson continued, "For the first time we will truly witness the community coming together on the issue of AIDS" and, he added that the response to the Walk has been far more extensive than expected.

Originally, Nelson said, MAP had projected an estimated 2,500 walkers, but now it is believed that that number will be exceeded.

'Enthusiasm is building rapidly. We expect a large turn-out for the Walk. Already there are more than 20 teams registered," Nelson said. They include Schwartz Bookshops, the Visiting Nurse Association, Bank One, La Cage and Breezin 100.7 FM to name a few.

ACLU Files Suit For Man Denied National Guard Employment

[Milwaukee]- In a novel approach to fighting military discrimination against Gay men and Lesbians, the American Civil Liberties Union (ACLU) of Wisconsin Foundation has filed a state employment discrimination complaint on behalf of a Gay soldier who was denied employment by the Wisconsin National Guard.

The soldier, Richard Aries of Madison, was honorably discharged by the US Army at the end of his enlistment after he was denied the option to re-enlist because of his sexual orientation.

Aries then decided to apply for a position with the Wisconsin State National Guard and was told by telephone that there was a slot open, that he would have the same rank as he had in the Army and that he would be eligible for student

When he later attempted to enlist in person, Aries was asked if he was Gay. When he told the recruiter he was, Aries said he was told that the state guard follows the federal regulations regarding homosexuality.

Although federal regulations forbid the

enlistment of Lesbians and Gay men in national guard units, Wisconsin law specifically prohibits the state's national guard from discriminating on the basis of sexual orientation.

fighting the military's discrimination on a state level, the ACLU has opened a new avenue to legal and public challenge, said William B. Rubenstein, the Director of the ACLU's national Lesbian and Gay Rights Project.

The case against the Wisconsin State Guard is being handled for the ACLU by cooperating attorney Patrick Berrigan of the Milwaukee firm of Angermeier & Rogers. Berrigan also represented Miriam Ben- Shalom.

In contrast to Ben-Shalom's federal constitutional challenge to the U.S. Army policy, the Aries case will challenge the state guard's discrimination before the Wisconsin Personnel Commission on the ground that it violates Wisconsin's statewide Gay rights law.

If unsuccessful before that panel, court

Nelson indicated that walkers are making an extraordinary effort to bring in pledge money. "The average pledge per walker," he said, "is approximately \$100. And," he added proudly, "there are several people who already have collected over \$1,000 in pledges and one of the teams has currently secured

\$8,000.

Vince Lombardo, a long-time MAP volunteer and one of the walkers who has gathered more than \$1,000 in pledges, said, "I am overwhelmed with the generosity of people and their willingness to help fight the AIDS epidemic. My pledges range from \$2.00 to \$100 and I am amazed at the variety of people who have pledged their financial support.'

Lombardo speaking from his hospital bed went on to say that, "My original goal was to raise \$1,000 for the Walk and I fully expect to raise more than \$2,500. It has just blown me away at how easy it is to get support from my friends and my

colleagues at work.

Broad community support for the AIDS Walk will be immediately evident at the Opening Ceremonies. Speakers will include the honorary Co-chairs of the Walk, Susan Mudd and her spouse Milwaukee Mayor John O. Norquist; Speaker Pro Temp of the Wisconsin Assembly, Rep. David Clarenbach and Frederick Cullen, President of Bank One. Emcees will be Melody Wilson and Tim Blotz, news anchors at WTMJ-TV.

Wide-spread community backing is seen also in the more than 25 corporate sponsors that are underwriting the cost of the Walk. This permits all pledge dollars from Walkers to be used for AIDS prevention and direct services to people

with HIV disease.

"The Wisconsin AIDS Walk will be more than just a stroll along the lakefront," Nelson said. "It will be a spirited celebration of life with good food and great entertainment.'

Prior to the Walk, the popular Milwaukee band "John Kruth and the Atomic Croutons" will perform to be followed by warm-up exercises led by a "suitably enticing" team from Vic

Milwaukee ACT-UP Demonstrates Against Wisconsin Dental Comm s Discriminatory

[Milwaukee]- The Milwaukee chapter of the AIDS Coalition To Unleash Power (ACT-UP) held an informational action on Wednesday, September 19, 1990, in front of the Lincoln Avenue Dental Group offices at 2700 W. Lincoln Ave. The action began at approximately 9:00 a.m. with members of ACT-UP handing out leaflets and encouraging patients to ask their dentists appropriate questions to ensure quality dental care.

The informational action received widespread coverage by most of the major media. The exception, as of press time, is The Milwaukee Journal which did not carry a story in its September 19 issue, the day of the action.

There were six questions printed on the leaflet that ACT-UP wants dental patients to ask their dentist. 1) What are the Universal Blood Precautions? 2) Do you use these Precautions with every patient? 3) Do you know that most HIV + people aren't aware of their infection and can't tell you they're infected? 4) Do you know you are already treating HIV + people? 5) What's the most recent training you've had in infection control? and 6) Why aren't there any mandatory continuing education requirements to keep your

Channel 4 which gave the story lead coverage on their 5:00 p.m. news, reported the action as a "quiet demonstration." According to J.J. Newmann who was there, most people accepted the leaflets and were eager for the information.

This action, according to ACT-UP, constitutes the first in a series of actions designed to focus public awareness on the dental community's Wisconsin inadequate and risky response to the AIDS crisis. Until Wisconsin's dental community stops its discriminatory and ignorant practices and engages in real educational and disease preventing techniques, ACT-UP-Milwaukee will continue to use whatever non-violent means are necessary to inform the public about these issues. Until Wisconsin dentists begin to protect themselves and the general public, they are leaving us all

ACT-UP's informal survey of dentists revealed that one third of area dentists were engaging in discriminatory practices with regard to treating HIV infected people. Also, it was discovered that many dentists were woefully ignorant of or

refused to implement properly the disease prevention techniques proscribed by the Centers for Disease Control and the American Dental Association.

Members of ACT-UP-Milwaukee met with Dennis McGuire, Executive Director of the Wisconsin Dental Association (WDA) and other representatives of the dental community to express concern and inform them of ACT-UP's expectations. Their response, according to ACT-UP, was to do little if anything to help ease the effects of the AIDS crisis or to ensure an end to discrimination and ignorance.

Therefore, ACT-UP Milwaukee determined to pursue its own agenda, addressing the dental needs of the people of Wisconsin.

ACT-UP requests that the WDA send its members a letter that addresses the full scope of this problem. Among other points, the letter should include:

An acknowledgment of the problem; A copy of AB 400 prohibiting discrimination against HIV +; An explanation of every caregiver's moral and ethical obligation to treat persons with HIV; An explanation of the recommended precautions for preventing the transmission of any

NY Mayor Appoints Lesbian Judges

[New York, NY]- In late August, Mayor David Dinkins appointed two open Lesbian attorneys to municipal judgeships as part of the first four judicial appointments of his administration, according to the Washington Blade. But it came as a surprise to almost everyone when, at the swearing-in ceremony at City Hall, a third appointee introduced her female "life partner" to the Mayor and assembled dignitaries!

The new judges are: Rosalyn H. Richter, former director of the Lambda Legal Defense and Education Fund, a Gay rights group; Paula J. Hepner, supervising attorney for New York City's Human Resources Administration; and Karen Burstein, a former New York state senator who has also directed the state's Civil Service Commission and Consumer Protection Board

It was Burstein's "coming out" that surprised everyone at the swearing-in. She and Hepner were appointed to Family Court, Richter to Criminal Court. The fourth appointee was Eugene Oliver, an African-American who had been assistant district attorney in the Bronx. He will preside over Criminal Court.

Kowalski Guardianship Denied

[Duluth, MN]- In the latest chapter of a five year struggle, Judge Robert Campbell has denied Karen Thompson's petition to be recognized as Sharon Kowalski's guardian. The case is not closed however, and Thompson can press her claim at an October hearing the judge has scheduled to hear new testimony.

Kowalski, 34, suffered severe brain damage and became a quadriplegic after a car accident in 1983. Thompson, 42, Kowalski's lover and a professor at St. Cloud University, has fought a lengthy legal battle with Kowalski's parents over her guardianship. Last year, Donald and Della Kowalski relinquished guardianship, but the courts have yet to decide who will be responsible for Sharon.

The story has become a cause celebre among advocates for Gay rights and the disabled who argue that Kowalski has been mistreated and subject to discrimination because of her handicap and sexual orientation.

Rutgers Cuts ROTC Scholarships

[New Brunswick, NJ]- Rutgers has become the first university in the US to protest the Pentagon's ban on homosexuals by cutting four merit scholarships which have been given annually to Reserve Officer Training Corps (ROTC) students.

A spokesman for Rutgers stated that the military's policy violated Rutgers' commitment not of discriminate on the basis of race, religion, color, sex, age, national origin, ancestry, handicap, marital or veteran status and sexual orientation.

Rutgers officials have also played a key role in the efforts of national college and academic groups to formally lobby the Pentagon to change its restrictive policy. Rutgers is home to the oldest and one of the best organized Gay and Lesbian student organizations in the country.

Domestic Partners On S.F. Ballots

[San Francisco, CA]- A scaled down version of a domestic partners law similar to one defeated in last year's elections will be on the San Francisco ballot this November, according to the San Francisco Sentinel.

Whereas last year's initiative would have allowed unmarried couples to register their relationships to receive health care and other spousal benefits extended to city workers, the new measure limits itself to the registration of domestic partners. It leaves the question of benefits for future action.

Last year's referendum, coming two weeks after the major earthquake and opposed by Fundamentalist groups, lost by just 1,700 votes. Sponsors of this year's resolution still face religious opposition but cite several positive factors: 1) a hotly contested gubernatorial race between Sen. Pete Wilson (R) and former Mayor Dianne Feinstein (D) is expected to bring out many more voters and 2) the deletion of specific benefits should blunt the criticism of those who questioned the economic effects of the earlier plan.

Meanwhile, in August, Ithaca, New York became the latest city to adopt a domestic partners law. It provides for registration, but leaves the question of benefits for later legiclation

Feminist Health Clinic Destroyed

[Redding, CA]- Arson is suspected in a fire that did \$40,000 in damage to the Feminist Women's Health Center in Redding this Summer. Staff members believe it was the culmination of a long campaign by anti-choice zealots to close the clinic.

Last September, a fire was set in a crawlspace at the health center. Members of the anti-abortion group Operation Rescue have repeatedly picketed, blockaded and occupied the clinic. In March of this year, more than 100 people were arrested for trespassing and violating an injunction against such protests.

Two days before the latest fire, a judge had agreed that Operation Rescue could use the "defense of necessity" to argue for acquittal. This defense allows the accused to argue that since (in their opinion) abortion is wrong and endangers life, any actions to stop it are justified.

Until rebuilding is completed, staff members are continuing to see patients in a trailer that has been placed in front of the clinic. Volunteers are also driving patients to the Chico Women's Clinic, 80 miles south of Redding.

Florida Voters Reject Gay Rights

[Fort Lauderdale, FL]- Voters in Broward County, Florida have rejected an amendment to their county's human rights ordinance which would have added sexual orientation to the list of categories protected from discrimination. The measure was defeated by 59% to 41%.

Putting a positive face on the results, Brad Buchman of United Citizens for Human Rights told **Gay Community News:** "It thrills us that 71,000 people came out and voted for Gay rights in Broward County. I don't think that's a major defeat."

Buchman said the campaign, which was opposed by Protestant Fundamentalist and Catholic groups, had organized the local Gay and Lesbian community better than ever before and that the Gay community had learned valuable political lessons which can be applied in the future.

Sponsors Pull Plug On "Diceman"

[Dallas, TX]- The Dallas Voice reports that five major businesses cancelled their sponsorship of comedian Andrew Dice Clay just days before his scheduled appearance at the Starplex Ampitheatre here in August. Clay is known for his racist, sexist and homophobic routines.

Radio station KTXQ-FM joined the "Dallas Morning News," WFAA-TV, Miller Lite Beer and Coca Cola in withdrawing support from Clay's performance. The Dallas chapter of the Gay and Lesbian Alliance Against Defamation (GLAAD) was instrumental in forming a broad community coalition to protest Clay's appearance.

Clay's movie, The Adventures of Ford Fairlane, was one of the biggest flops of the Summer season and his studio has announced that an upcoming film of Clay live in concert has been put on the shelf with no plans for release.

30 Participants Still Needed For AIDS Research Study

[Milwaukee]- A very important study is underway. Your help is needed.

In the past three months, 70 Gay men in Milwaukee have participated in research intended to determine more accurately the emotional consequences of AIDS. The research project, being conducted by Gary Hollander, M.S., still needs 5 HIV-Negative and 25 AIDS-diagnosed participants to reach statistically significant levels.

"Although many men have come forth to volunteer in the past three months, the need for these remaining 30 men is critical," explained Hollander.

Hollander went on to say that to be significant, the research must have a minimum number of participants. When completed, the study will offer planners at the Milwaukee AIDS Project (MAP) and other AIDS service organizations, including hospitals and mental health clinics, a more accurate picture of what emotional supports and services may be needed for people with HIV disease.

Participants are assured confidentiality in the study and can arrange to complete the three written surveys involved in a group or in individual sessions. The surveys require only moderate reading ability. To qualify, participants must be men who identify themselves as Gay. Twenty-five men who are AIDS-diagnosed and 5 men who are HIV- negative are needed.

Hollander enumerated several interesting challenges in completing this research. "Despite my years of work in AIDS service here and around the country, and my fairly high profile in the Gay and Lesbian community, I still encounter some wariness on the part of potential research participants. They may fear disclosure of their HIV status or their sexual preference, despite the numerous safeguards employed to assure confidentiality."

Hollander also explained that reaching people who are AIDS-diagnosed is problematic because he must generally rely on MAP case managers or area physicians to refer participants to him.

"This can be a real bottle neck if this research isn't a high priority for these other professionals," Hollander noted.

"I have also observed an interesting response to the acronym HIV. A few participants read a leaflet I distributed," said Hollander, "several times before they saw HIV negative subjects are being sought. When they read 'HIV' they automatically substituted positive. This is a curious response."

Once this initial study is completed, Hollander plans to expand his research to include women, heterosexual and bisexual men, and other people with a broader spectrum of HIV disease.

Hollander is a psychotherapist at Sinai Samaritan Outpatient Psychiatry Clinic, an instructor at UW-M and a member of the Board of Directors at MAP.

The need for participants remains critical. Prospective participants for the study are urged to call for an appointment or more information by September 28. Sessions can be scheduled by calling Brian at MAP (273-1991) or Gary Hollander (289-0779).



Elections, Seeks Women For Board

Milwaukee Pride Committee Holds

Nine persons were elected to be on the Milwaukee Lesbian/Gay (MLGPC)Steering Committee for 1990-91 at the MLGPC Annual Meeting on September 10.

The Steering Committee has 15 positions; 7 men, 7 women and 1 at-large position. The approximately 25 people who attended the meeting filled positions from a field of 15 candidates.

Those chosen were Tim Hansen, Gary Wells and Scott Gunkel, this past year's vice-president, secretary and treasurer, respectively.

Newly elected members were Don Clabots, Kelly Cauffman, Larry Taylor and Don Buzanowski to complete the seven positions alloted for men. Peter Thomas was chosen to the at-large post. Terri Coughlin, who worked as a volunteer this past year on the budget and financing, was the only woman who ran for and was elected to one of the seven positions on the Committee reserved for women. She was elected by acclamation.

Out-going Committee members Jim English, Michael S. Lisowski and Miriam Ben-Shalom did not run for re-election.

Since no other women ran for any of the other six positions reserved for women, these vacancies on the Committee will be held open for 30 days. Any woman wishing to run for a Committee position should submit a letter of intent to the Steering Committee. The Committee will then vote to fill the remaining positions. However, after the 30 day period, the vacant positions will be open to anyone wishing to serve on the Committee. This is being done so that the Committee can begin work as soon as possible to prepare events and fundraisers for the coming year.

The Annual Meeting began at 7:30 p.m. at the M&M Club banquet room. Jim

English, out-going MLGPC president, praised and thanked everyone for their

Gary Wells, out-going secretary and volunteer coordinator, listed the numerous fundraising events over the past year. Wells explained how this past year, innovative fundraising helped meet the expected increase in expenses. (See MLGPC's financial statement next issue.)

Wells pointed out that if 500 people pledged \$5.00 a month in a "Pride Pledge Program", the Committee could raise \$30,000.

Apologies were tendered to the Cream City Foundation (CCF) whose \$1,500 grant to MLGPC had not been mentioned in the Pride Guide.

It was noted that CCF was mentioned as one of the several corporate sponsors, both at the Rally and during promotional stories in the Gay press. It was also noted that the grant was reported in the Gay press at the time.

Wells stressed that for the up-coming year, fundraising will focus more directly on corporate donors, foundations grants and the Gay/Lesbian community than on the bars as has been done in the past. This last year, there were 5-6 bar fundraisers which accounted for 5% of the gross total raised. The other 95% came from the CCF grant, corporate sponsorships and other sources.

A discussion took place on whether MLGPC should be a year-long celebration with periodic events - or should it focus its energies on the Pride Week in June. The new Steering Committee will take this question under advisement.

The first scheduled MLGPC meeting will be held on Friday, September 28 at 7:00 p.m. Anyone interested in running for an available Committee position or wishing to attend the meeting, please call the Pride Line at 32- PRIDE.

Guest Editorial Community Deserves Apology From Alderman McGee

Milwaukee Alderman Michael McGee's threats to inflict violence on the community if it does not respond adequately to his demands have put him in the center of a storm of controversy which unfortunately has obscured any rational discussion of potential solutions to the very real problems he seeks to address.

The problems of Milwaukee's Black community are real and urgent and we should all be working together to help address them, but the problems of one minority group are not resolved by using derogatory slurs designed to put down other minority groups

According to uncontradicted press accounts, on Wednesday September 12th, McGee placed a phone call to Community Development Block Grant Administrator Leo Reis to complain about Reis investigating a group in McGee's district. The alderman reportedly called Reis (who is not Gay) a "wimp" and "a faggot." and then allegedly threatened to

This type of conduct is inexcusable under any circumstances but especially when it comes from a public official whose salary is paid for with tax dollars provided by Gays, Lesbians and straights. Reis said he was "shocked" by McGee's statements. The Gay and Lesbian community should be shocked too. No one should have any illusions about what McGee's reaction would be if any alderman directed a racial slur at a citizen. He would probably call a press conference and demand the alderman's resignation, while calling the alderman a bigot.

And he would be right. There is no place in public office for anyone who utilizes the language of oppression. We don't expect nor do we call for McGee to resign, but at the very least McGee owes an apology not only to Reis but to the entire Gay and Lesbian community as well.

WVCY Christian Patriotic Rally Turns To Gay Bashing

[Milwaukee] On September 8, 1990, WVCY, Milwaukee's Christian radio station held what was being promoted as a pro-flag and pro-America rally at Bruce Hall in MECCA. The event, organized by Rev. Vic Eliason, featured the Life Action Ministries with their act entitled "America, you're too young to die." The event gathered more than 3,000 spectators.

Shortly after 6:00 p.m., anticipating that the "save the flag" rally could, in fact, become a "kill a fag" rally, a group of eleven people from ACT-UP-Milwaukee gathered in front of the Hall to pass out flyers featuring two nude young men wrapped in an American flag and holding a condom. Other than a few minor incidents, ACT-UP was met with minimal

The program began as a flag-waving presentation using multiple slide projectors and singing from the Life Action Ministries performers. The event was reminiscent of something that one would expect to find at one of America's theme parks, with the performers doing renditions of practically every popular patriotic song since the conception of the

After a small break, which included fundraising, the event took a drastic turn. Praises of America gave way to verbal disgust. The program, which was promoting America's liberties and freedoms, became what we now know as a pro-family rally, similar to the one held this past June. Using anti-Gay slurs, the speakers brought cheers from the crowd to levels high enough to drown out anything being said.

The speakers stated that Humanism and homosexuals were responsible for

AIDS and the only way to rid ourselves of AIDS would be abstinence. They implied both that presently infected people would quietly die away, and that safer sex was not effective. They stated that Gays and Lesbians presently have too many rights and that these rights are aiding the downfall of our society. As many members of ACT-UP-Milwaukee had suspected, this was indeed a fag-bashing event in the disguise of being a pro-flag

The speakers adopted anti-feminist and anti- abortion stances. They came out against New Age religion, the game, Dungeons and Dragons, cartoons like "He-man", pornography and sexual freedom.

The event ended with prayer and a call for all those who had not accepted Christ as savior to meet with counselors after the rally ended. These people were quietly taken to a back room in MECCA.

Before our eyes, the Fundamentalists took a pro-America rally and by using shock tactics, led the audience to believe that Gays, Lesbians and pro-choice backers, rock musicians and a few other select groups are fully responsible for the now "imminent" demise of our country. Then, when they had fully convinced the audience of our "impending doom", they soothed them with the promise that converting to their Fundamental views would save our nation.

ACT-UP-Milwaukee has begun monitoring WVCY's broadcasts and actions after last year's Pride Parade when they brought Dr. Lorraine Day, a doctor who advocates quarantine camps for HIV+ people.



Last year, Scotland Yard told me that I couldn't perform because I promoted buggery. I told them that I was proud to promote buggery. They kicked me out of England.'

Lesbian performer Holly Huges. another de-funded artist, told the Advocate: "When applying for an NEA grant, I wrote this letter...to the NEA and President George Bush and I talked about my work being homoerotic with a capital

How did she feel about being denied

the grant?

'Depressed. It always plays into my internalized censorship. I left this incestuous and abusive family in 1973 where there was this rule of silence: if you spoke out, you were told you were imagining things. Now, I walk outside and discover that the world is my family. Helms is just my father with a mask on.'

Responding to a letter from a Gay man who felt threatened by abortion rights, Lynn Menefee wrote to the Washington Blade: "As women, we have our holocaust. As Gay men, you have yours. You would do well to give us the same non-judgmental respect and support you would like to receive." Hear, hear!

Anti-abortionist Deborah Grumbine, serving jail time for blocking a clinic, told the Los Angeles Times of her Big House bunkmate: "This last time, the woman below me was a really promiscuous homosexual. The first thing she asked was 'Do you like women?' I said 'I like Jesus.' That sort of took care of all the angles for me.

TV Guide recently admonished comic Robin Williams for his Gay impersonations. They gave him an official "Jeers" rating (in their "Cheers and Jeers" column) for "lapsing too frequently into cliched impressions of effeminate Gav men.'

"In recent years, Williams' TV appearances have been marked by an over-reliance on easy imitations of Gay stereotypes, especially his hosting of the last two "Comic Relief" specials on HBO...Williams' ability to make people laugh is a talent he should be proud of, but it shouldn't be wasted on such cheap shots. There's no pride in prejudice.' Alright, TV Guide!

The Star with another celebrity tidbit: "...when a car nearly hit Andrew Dice Clay in a Hollywood restaurant parking lot, guess who pulled the Gay-bashing comedian to safety just in the nick of time? Boy George was the rescuing hero! Grateful Dice wanted to high-five the singer, but Georgey just batted his mascaraed eyelashes and co-quettishly disappeared.'

Speaking of boys and the Diceman, Nora Dunn of "Saturday Night Live" (who refused to appear with Clay and was cut from the "SNL" line-up this year) had this to say about her work environment there: "It's definitely a boy's perspective. 

Schwartz Bookshops Plan Banned Books Week Display

[Milwaukee]- Banned Books Week, September 22-29, celebrates the freedom to read and to choose for ourselves as individuals the content and quality of our reading materials. It is sponsored by among others, the American Booksellers Assoc., The Assoc. of American Publishers and is endorsed by the Center for the Book of the Library of Congress.

Milwaukee Mayor John O. Norquist will sign a proclamation in honor of Banned Books Week, original copies of which will hang in all five Harry W. Schwartz Bookshops.

As Harry W. Schwartz experienced in the Twenties and Thirties with the censorship of such now-classic books as Well of Loneliness by Radclyffe Hall among others, there exist once again individuals who are attempting to dictate what Americans should be allowed to read and what we should not, people seeking to impose their personal views of government, religion and morality on all of us. The Harry W. Schwartz Bookshops regard attacks on our country's First

Amendment as not only hypocritical, but unconstitutional and dangerous.

Among the books challenged in the recent past are Huckleberry Finn, The Grapes of Wrath, The Giving Tree, Hamlet, Raisin in the Sun, Dairy of Anne Frank and The American Heritage Dictionary. The sponsoring organizations believe that most would-be book banners act with what they consider to be the highest motives — protecting themselves, their families and communities from perceived injustices and evils and preserving the values and ideals they would have the entire society embrace. The result, however, is always and ever the denial of another's right to read.

In addition to displaying Mayor Norquist's proclamation, Schwartz Bookshops will build large book displays in all five shops calling attention to the nature and magnitude of the threat that censorship poses to our First Amendment rights to freedom of speech and press.

Cincinnati Museum Director To Face Jury Trial

[Cincinnati, OH]- In a decision that boggled the minds of legal and artistic scholars, a Municipal Court judge in Cincinnati refused to dismiss the first obscenity charges ever against a museum and its director.

Judge F. David J. Albanese ruled September 6 that jurors could convict the Contemporary Arts Center (CAC) and Dennis Barrie if they think only one of five "homoerotic, S&M" photographs by the late Robert Mapplethorpe violates obscenity standards.

"It's so intellectually wrong, it's incredible," said defense attorney H. Louis Sirkin.

Gay, Lesbian and arts activists also criticized the decision, announcing plans for an expanded demonstration outside the courthouse on the trial's opening session September 24.

The judge has a concept of the Constitution thoroughly alien to the American experience," said veteran political activist Ted Good, who has launched an investigation into Albanese's background and possible links with influential conservatives who pressed for prosecution.

First Amendment specialists expressed surprise at Albanese's ruling. "I cannot find a justification for (it) in existing law," said Fred Schauer, a

professor at Harvard University's Kennedy School of Government. "I am confident that this ruling could not stand in the Supreme Court."

America's highest tribunal has held that an allegedly obscene work must be considered "as a whole," saying that excerpts from a book, or a scene from a film, may not be separated from the work's overall context.

Albanese found that "each photograph has a separate identity...a visual and unique image permanently recorded...

The focus will be each picture 'taken as a whole.'

The Republican jurist worked as an assistant to renowned "smut" fighter Simon Leis Jr. when he was a Hamilton (Ohio) County prosecutor. Leis, a former U.S. Marine and now sheriff, helped instigate the indictments against CAC and Barrie-the latest example of conservative Republican officials "blatant homophobia" said Good, vice chair of the Hamilton County Democratic Party's executive committee.

The Gay/Lesbian March Activists (GLMA) courthouse protest will be by outraged artists, art students, AIDS activists and others and will begin at 9:30 a.m. on September 24 just before the trial's opening. Civil disobedience is expected.



Wisconsin To Lose \$250,000 In 1991 Federal AIDS Funding

[Milwaukee]- A 20% cut in federal funding in Wisconsin for 1991 will mean the Milwaukee AIDS Project (MAP) and other AIDS service organizations statewide will lose more than \$250,000 for AIDS prevention programs.

"The funding cut comes at the worst possible time when we need to implement targeted and costly efforts to prevent an explosion in the AIDS epidemic among injection drug users in Wisconsin," said Doug Nelson, MAP's Executive Director. "There is also disturbing evidence that there is significant relapse into unsafe behaviors that put people at risk for HIV infection.'

The cut is the result of a reallocation of AIDS prevention funds for states by the Centers for Disease Control (CDC) in Atlanta.

This cutback is a trend in federal funding for AIDS. Wisconsin also lost 20 percent of its allocation for AIDS prevention programs in 1989. According to Nelson, these cutbacks threaten the expansion and intensification of AIDS prevention programming to meet the increasing challenges of the AIDS epidemic in Milwaukee and Wisconsin.

"This means that we must turn to the community to ask for its financial support," said Nelson. "The Wisconsin AIDS Walk is a perfect opportunity for the community to come forward to make the financial investment that the federal government is unwilling to make."

To date, more than 20 corporations, including Miller Brewing Company, Aurora Health Care, Time Insurance and Bank One have made an investment to



A Vote for Tommy Thompson Is A Vote For Our Enemy

The Gay Basher is at it again. Once again Tommy Thompson asks for your vote. You are supposed to forget that his opponent, Tom Loftus, was defending your rights while the Gov. was kicking you. You are supposed to ignore Tommy's opposition to every piece of Gay/Lesbian rights legislation introduced while he was in the legislature. You're supposed to forgive him his ignorance and reward him for all the kicks in the teeth he has meted out to you during his career.

You are supposed to be seduced by his slick commercials paid for with the largest campaign treasury in Wisconsin history, so large in fact that it would do a Chicago politician more than proud.

When our Gay Rights Law was introduced, Thompson not only voted against it, he helped lead the charge that nearly succeeded in defeating it. (BAM! Punch to the mouth)

In 1988 when Tommy won the Governor's office defeating a supportive Tony Earl, he ran commercials denouncing Earl for spending tax dollars on a Gay Liaison and on the Governor's Council On Gay and Lesbian Issues. (POW! Kick to the ribs)

As Governor he refused to issue a proclamation expressing sympathy for the family and friends of those who died from AIDS. (CRUNCH! Blow to the head)

As Governor he vetoed legislation that would have paid for the health insurance premiums of HIV infected persons who could no longer work thereby forcing them into underfunded public health programs which often don't provide the uninsured with the kind of care that should be given. (ZONK! Knee to the groin)

As Governor he used his line item veto to gut an AIDS education bill so badly that its outraged sponsor, State Representative Barbara Nottestein, said it was a waste of time getting it passed. (CRUNCH! Kick to the shins)

Now he wants your vote. There are

those who say that while they abhor the Thompson record on Gay/Lesbian issues he has done well in other areas. To some that's a little like someone who beats you up outside of a Gay/Lesbian bar who then, when they run for office, asks you to vote for them because they don't beat their wife and kids and are kind to animals.

Thompson has made it clear that he is our enemy and that he doesn't deserve our support as a community or as individuals. How can we expect to maintain the support of our friends (Thompson's opponent, Tom Loftus, is a big friend of ours) if we support our enemies instead of them?

Tom Loftus has spoken out on issues of concern to us, he has voted correctly on legislation of concern to us. He is a decent honest man in an uphill fight who needs our help and support.

Loftus, has little charisma, he is not exciting, he is not a good speaker. What he does have is a burning desire to see to it that all of Wisconsin's residents have a shot at being treated equally.

And for a growing number of Gays and Lesbians disturbed by the Thompson record on our issues that is enough.

Metropolitan Community Church Celebrates 23 Years of Service

[Milwaukee]- On October 7, 1990, the Universal Fellowship of Metropolitan Community Churches (UFMCC) will be celebrating its 23rd year of ministry. UFMCC was started in Huntington Beach, CA by the Rev. Troy Perry as an affirming and positive ministry predominantly to the Lesbian and Gay Christian community.

Rev. Perry felt the call of God to begin a "Church for all people" after a friend became the victim of homophobia and was assaulted and victimized because of his homosexual orientation. During his hospitalization, this friend expressed the belief that "Nobody cares about Gay people, not even God!" Rev. Perry was moved to the conviction of faith articulated in John 3:16 which states that "God so loved the world that God gave God's child that whosoever believes in this child shall not perish, but shall have

The whosoever in this scripture includes Lesbians and Gays and all those who are marginalized for whatever

everlasting life.'

communicable diseases between patient and doctor. (These precautions should have been in place for years in response to Hepatitis B.); A WDA commitment to expel any member who discriminates against HIV÷ people; A WDA commitment to report any member who discriminates against HIV + people to the Attorney General and the State Division of Regulation and Licensing and a WDA commitment to cooperate with all relevant parties to bring a quick end to this problem.

In a letter dated Sept. 13, 1990 from McGuire sent to Daniel Fons of ACT-UP-Milwaukee, Cheryl Vaughn of the Milwaukee AIDS Project, Neil Rosenberg of the Journal and Joe Manning of the Milwaukee Sentinel, questioned ACT-UP's McGuire information concerning dentists and announced that the WDA would not work with ACT-UP. "In the future," Mcguire wrote, "we will be directing our efforts to and working with the caseworkers of the Milwaukee AIDS Project in helping them obtain treatment for their clients.

In a letter to McGuire, Fons, writing for ACT-UP-Milwaukee, said among other things, "For all the good that MAP does, it can only touch upon the lives of a fraction of those affected by this disease. Part of the problem faced by Wisconsin's HIV+ population is that the systems

currently in place to deal with this crisis are groesly inadequate. Your response ignores this reality altogether."

Fons went on to write that "if you (WDA) will not actively engage in desperately needed educational efforts, then we (ACT-UP) will pursue this agenda without you.'

Appearing on Channel 10's "Smith and Co." on Wednesday evening, Sept. 19, Doug Nelson, MAP's executive director said while the number of dentists who now will treat people with HIV infection or those with AIDS numbers 25--up from 3 of several months ago, MAP supports ACT-UP's action as the "Logical tool" to get the WDA to respond to the serious and on- going problem. Protests (such as ACT-UP's action) are, said Nelson, "as American as apple pie" and indicated that he was strongly supportive of ACT-UP's survey of dentists which the WDA had called in question.

Nelson said that he viewed the state Medicaid program as "the big culprit" in the problem. Many of MAP's clients seeking dental care are on some form of state-funded Medicaid which "two-thirds" of dentists do not take. The reason for this is what Randy Johnson called "the absurdly low" payments Medicaid makes for dental care.

Johnson appeared with Nelson and Daniel Fons on the program.

Nelson said earlier on the phone that the Medicaid program reimburses dentists for only 40 percent of charges incurred for care.

Nelson said that as a member of the Governor's Council on AIDS, he would do everything in his power to see that Medicaid payments were increased.

Nelson also said that "polarization must be avoided." That all parties concerned must now come together to seek a solution to this problem.

Johnson admitted that there "probably




