#### **All-Gay Military** Regiment May Be Formed And **Placed In Service**

[Milwaukee]- In a move calling to mind the Theban Sacred Band of ancient Greece, the Gay, Lesbian and Bisexual Veterans of America (GLBVA) is seeking to form an "all-Gay" military regiment that would be "placed into service in the Persian Gulf or wherever trained personnel would be needed.'

To achieve this "dream", GLBVA, headed by Miriam Ben-Shalom has sent an open letter to President Bush, the Secretary of Defense, all Representatives and Senators "and to the American People" "expressing the desire of many Gay, Lesbian and Bisexual veterans to return to service in this time of crisis.'

GLBVA has further issued a "Call To Arms" to all Gay, Lesbian and Bisexual veterans who would be interested in serving in a reactivated regiment: The 54th Massachusetts Volunteer Regiment (MVR). GLBVA is working with Ms. Kate Dyer, Executive Aide to Gerry Studds (D-MA) to research the reactivation process. MVR is the regiment of choice because it "was a segregated regiment of African-American men, freed slaves who were told that they were unfit to serve, a threat to morale, good order and security.

According to GLBVA, the Call To Arms "represents not only an effort to show through action that Gay men and Lesbians want to be part of Mainstream America,' but also challenges "all discriminatory legislation and administrative policies towards Lesbians and Gay men" by the U.S. government and particularly the Department of Defense.

According to GLBVA, any veteran, regardless of sexual orientation, who would like to reenlist, and who has an Honorable or upgradeable discharge, and who is interested in serving in a reactivated but segregated, active duty regiment, contact GLBVA at (414) 342-6543, Fax: c/o Havlicek and Associates (414) 271-8884 attn: Annabelle Havlicek. #### **Denver Mayor** To Sign New Gay Rights Bill

[Denver, CO] [GLINN]- Denver's sweeping anti-discrimination bill dubbed "Denver's Gay Rights Bill" was approved by city council on October

The bill, which Mayor Federico Pena has pledged to sign into law, will prohibit discrimination on the basis of race, color, religion, national origin, marital status, military status and physical or mental disability as well as sexual orientation in the areas of employment, housing and commercial space, public accomodations, private educational institutions and health and welfare services.

Council members voted 8-4 to approve the measure after a spirited, three hour council debate at a jam- packed public hearing, according to The Denver Post. The Post described the debate as "largely... a referendum on homosex-

The bill received strong support from a number of organizations including the Denver Women's Bar, ACLU and the Council of Churches. However, the Catholic Archbishop voiced strong opposition.

# Dr. Krim Says AIDS May Be Fully Treatable Within Five Years

Editor's Note: The following interview with Dr. Krim took place in Milwaukee's Pfister Hotel on October 16, 1990.

Dr. Krim, one of America's leading researchers on AIDS, was in Milwaukee to give AMFAR's check for \$25,000 to the Wisconsin Community-based Research Consortium. The check is the first matching grant to the state challenge grant of \$150,000.

In 1986, Dr. Krim said that she believed that AIDS would cause a revolution in the American health care industry. She has not changed her mind.

"I'm still convinced of that," she said. "The numbers of AIDS will be increasing in the '90s. Because this is a disease of young people, it's also a disease of people who are not insured or underinsured and this puts an enormous pressure on our health care system. We're going to see municipal hospitals make demands on public funds unknown in the past and we're going to see private hospitals either having to refuse patients which is contrary to the principles of their profession or assume the care of many patients who cannot pay for their care. In New York now, there are hospitals who are in a deficit situation by hundreds of millions of dollars."

She went on to say that, "AIDS is not the only health care problem we have in this country. Better access (to health care), more just access, exists across the board and the public is starting to complain."

She noted that "Health care is not a right in this country. It's something someone has to buy. I think we're going to have to face the need this country has to develop a system of universal health coverage. Basic medical care is a right and we're going have to come up with a

Asked about the chances for a vaccine, Krim said, "Research has made tremendous progress. There are several other drugs besides AZT that are going to be approved very soon. (DDc and DDi). There is a whole list of other drugs that are being developed. There will be a progressive improvement in our ability to suppress HIV. We also have accepted the

need for treating people earlier.
"I am convinced," she said, "that in the future, we're going to want to treat people as soon as infection becomes demonstratable. We're going to see people survive with the infection, without disease, for a very long time. This is the goal we have now; to turn it into a controllable infection that is chronic that won't make people sick.

**ACT UP Contacts WISN Radio Advertisers In Protest Over Station** 

[Milwaukee]- According to a press release, the Milwaukee chapter of the AIDS Coalition To Unleash Power (ACT-UP) has begun a campaign to inform the public of the "irresponsible decisions being made by Steve Downes. Downes is the Vice President and General Manager of WISN- AM in Milwaukee.

ACT-UP states that the decisions referred to regard the broadcast of "AIDS misinformation" by WISN. During the past two weeks, ACT-UP states, "Mr. Downes has repeatedly allowed Mark Belling, an on-air personality, to spread dangerous misinformation about HIV infection and AIDS to the public.'

ACT-UP states that "after numerous attempts to get an official response from Mr. Downes," it has "begun to contact WISN-AM's sponsors about this issue.'

As of October 17, 1990, ACT-UP stated that it had sent letters to the following sponsors: Steinhafels Furniture; Colders Furniture; Factory Outlet Carpets and Waukesha Memorial.

ACT-UP stated that it intends to "continue and expand this campaign until Mr. Downes decides to make an on-air apology and correction regarding this misinformation." ACT-UP stated that it will be "encouraging anyone interested in slowing the devastating effects of AIDS in Milwaukee to contact Mr. Downes and urge him to act responsibly regarding this matter." WISN's number is 342-1111.

Downes said that "no apology was necessary" and indicated that if there was misinformation, he would be "happy to correct it." However, he said, "to my knowledge, the information on the air was substantially correct." He said he had not received ACT-UP's press release.

ACT-UP has said in a letter to Steinhafels Furniture that "despite Mr. Belling's claims to the contrary, we are not attempting to 'silence,' 'harrass' or 'intimidate' him. We defend Mr. Belling's basic right to voice his opinions. However, the facts about AIDS are not a matter of opinion. Mr. Belling does not have the right to create his own 'facts',' said the letter.

### Medical College Recruits Nationally -**Recognized AIDS Researcher**

[Milwaukee]- A nationally-recognized psychologist specializing in AIDS high-risk behavior intervention has been recruited by the Medical College of Wisconsin. T. Michael Bolger, President and CEO, announced that Jeffrey A. Kelly, Ph.D., joined the faculty Sept. 1, 1990, as Professor of Psychiatry and mental health.

Bolger said that Dr. Kelly brings with him \$3.5 million in grants from the National Institute of Mental Health. One significant purpose of the grants is to evaluate the impact of community behavior intervention programs in reducing those activities which pose a risk of acquiring the HIV infection.

"Dr. Kelly and the Medical College plan to invite key community organizations in Milwaukee to help introduce and evaluate new models to assist people at high risk for contracting said Richard A. Cooper, M.D.,

Executive Vice President and Dean.

"I'm sure that Milwaukee has many on-going programs dedicated to AIDS prevention," Dr. Kelly said. "It is my hope that we can develop cooperative programs with their agencies in response to community needs. I would also like to support and assist existing urban AIDS prevention and urban health programs.

"Our whole approach to the problem is to look at the behavior and not so- called 'risk groups.' We want to help people learn the skills that will prevent them from being exposed to the HIV virus," Kelly

Through extensive surveys around the country. Dr. Kelly and other researchers have found that, in the last several years, groups at high risk have increased their knowledge immeasurably. The next step, however, is applying the science of behavior change to help people more fully translate knowledge to action.

If we start treating people very early, when they have a functioning immune system, it is conceivable that early effective treatment will allow the immune system to get rid of the infected cells.

So," she said, "talking about a cure is not crazy anymore, but it will require very early treatment." She predicted that in "five years we may have a specific inhibitor of the virus.'

Krim spoke proudly of AMFAR's work and that of community-based centers in doing vital AIDS research. "A few years ago AMFAR picked up on the idea that doctors' experience should be utilized; experimental drugs made available to people who need them. And we (AMFAR) started to fund community-based trail centers (such as the Wisconsin Research Consortium). As soon as tolerable doses are determined, the drugs should go to community-based centers. (There are 45 such centers now.)

The highest priority is to treat opportunistic diseases rather than HIV. You can live with HIV as long as you don't get sick. The community priorities are reflected in the centers. We at AMFAR consider this very important.

Asked about the work of Dr. Jonas Salk, Krim said that Salk had two experimental drugs he was testing now. But, she noted, we don't have any results yet in terms of effective protection. The trial has not lasted long enough.

She went on to say that there are 7 accine preparations in this country now under study and "with all of them we know they stimulate the production of antibody. We don't know if they are protective against infection."

In regards to minorities, Krim noted sadly that disease is a function of poverty, not race. Cultural differences also play a role in hindering education and prevention. She cited the Mormons who have such a stigma attached to homosexuality that men have to lie to women and kids.

Asked her opinion of the current Bush Administration on AIDS, she replied, 'An improvement in rhetoric."

constantly Throughout, Krim emphasized the need and efficacy of sex education in the prevention of AIDS. In San Francisco, she said, the incidence of infection among Gay men is now less than 1%. This is because of sex education and "shows that education works."

To show how imperative education is, Krim pointed out that AIDS is the leading killer of Black women today and is increasing in women generally and babies faster than in men.

#### NATIONAL NEWS BRIEFS

### Lesbians Plead Guilty To Conspiracy

[Washington, D.C.]- The Washington Blade reports that three women — two of them Lesbians - have entered guilty pleas to charges of conspiracy and aiding and abetting the 1983 bombing of the US Capitol. No one was injured in the explosion, which occurred in the wake of the US invasion of Grenada.

Linda Evans and Laura Whitehorn, who are Lesbians, along with Marilyn Buck pleaded guilty to conspiring to "influence, change and protest policies and practices of the US government... through the use of violence and illegal means." A dozen other charges against the women related to other bombings, as well as conspiracy charges against three

other co-defendants, were dropped as part of the plea agreement.

Supporters of the defendants organized an Emergency Committee for Political Prisoners Rights. They held that as five of the six accused were already serving prison time for previous offenses related to the bombing, the government's charge of conspiracy was superfluous and vindictive and intended to intimidate other political activists into silence. Each of the defendants are veterans of the anti-war, Puerto Rican independence and Central American solidarity movements.

#### Seattle Partners Law On Ballot

[Seattle, WA]- On November 6, residents of Seattle will vote on Initiative 35 which seeks to repeal the city's new Family Leave Ordinance. The ordinance offers sick and bereavement leave to unmarried municipal employees - straight or Gay - when their partners are sick or die.

The Gay and Lesbian community of Seattle has mounted a strong "No on 35" campaign to counter the efforts of the fundamentalist-led Citizens for Family, which

opposes any recognition of domestic partnerships and supports the repeal.

In 1978, Gays in Seattle withstood a similar effort when fundamentalists attempted to repeal the city's Gay rights law, which prohibits discrimination based on sexual orientation. That referendum was defeated by a vote of approximately two to one. The greatest worry of the "No on 35" organizers is that that earlier success has made the Gay community over-confident about the current challenge, according to Seattle Gay

### **Boston Hosts Gay Officials Confab**

[Boston, MA]- Plans for the Sixth International Lesbian and Gay Officials Conference in November are under attack by conservative members of Boston's City Council, who are angry that the Council Chamber and other rooms in City Hall will be used for the event.

The conference, set for November 16-18, will be hosted by Boston's Gay Councilman David Scondras, who reserved the City Hall rooms for meetings and workshops. He cited previous use of City Hall facilities for political meetings, memorial services and social events. No public funds will be spent on the conference.

An assistant to Scondras told Philadelphia Gay News that the Council members opposing the conference "are homophobes, and they're trying to make this a homophobic issue." The Lesbian and Gay Official Conference has previously been held in West Hollywood, Washington, D.C., San Diego, Minneapolis and Madison - all

#### Ryan White's Mom Slams Senate

[Washington, D.C.]- In an appearance before the Senate Appropriations Committee. Jeanne White, mother of the late AIDS patient and activist Ryan White, chastised senators for cutting hundreds of millions of dollars from an AIDS bill that was meant to provide urgently needed funds to localities hardest hit by the epidemic.

The bill, dubbed the Ryan White Comprehensive AIDS Resource Emergency Bill, was to provide \$875 million over a five year period, but a Senate subcommittee decided to postpone funding the bill for at least a year, effectively leaving localities with little or no federal AIDS funding for fiscal year 1991. Another proposal seeks to cut funding by 80%.

Mrs. White said that Ryan would never have wanted his name attached to the bill had

he known it would be so ineffective.

While Mrs. White was testifying in Washington, Ryan's grave in Cicero, Indiana was vandalized. Shrubbery around the headstone was destroyed and statures were broken. Authorities have offered a reward to anyone who will identify the culprits.

#### **NYC Schools To Provide Condoms**

[New York, NY]- Five members of the seven member New York City Board of Education have endorsed a proposal to distribute condoms to public school students through school based health clinics. The plan could be operational by Spring of 1991.

Board members cited concern over the fact that New York City has the nation's highest incidence of AIDS among people aged 13 to 21. Figures suggest that up to 80% of the

city's half million teen-agers may be sexually active.
"Our children are sick, our children are dying," said Board member Dr. Westina L. Matthews in declaring her support for the proposal. Another Board member, Dr. Gwendolyn C. Baker, said that "the question for us is not should we distribute condoms,

# General Motors Cuts Anti-Gay Slur

[Detroit, MI]- An executive for the General Motors Corporation has announced that is company will delete an insulting reference to homosexuals from a video presentation aimed at Chevrolet truck dealers.

The promotional video contains short commentaries by "real" people who own Chevrolet trucks. In the video, a farmer states: "There isn't no foreign company that makes any decent working pickup. It's either going to be big, or some little faggot

The Chevrolet spokesman said the segment would be edited out of the tape before it is played for dealers or at auto shows in the future. News of the slur spread after the clip was shown to thousands of Chevrolet salespeople at a recent exhibit in Nashville.

### **Activists Mock Obscenity Issue**

[Washington, D.C.]- Nude and suggestive statues in the nation's capital were raided in late September by the Reactionary Art Police (RAP), a Gay protest group. The raids, in which "Warning" and "Caution" signs as well as large bolts of material were draped over statues, were carried out to mock the current Congressional debate over allegedly

RAP covered the statue of a nude woman in Dupont Circle, claiming, tongue-in-cheek, "that it may have been attracting Lesbians to the area." The group then moved to the Ellipse where they covered the Boy Scout Memorial. It features a naked man and woman following a uniformed Scout. The activists, who donned Jesse Helms masks, warned that the monument may promote child abuse and pedophilia.

Washington, D.C. Park Police detained the demonstrators briefly until they removed the coverings from the statues. No one was arrested.

#### Milwaukee Ballet Holds World **Premiere of AIDS Themed Ballet**

Company's November 8-11 series will include a world premiere work, "Of Rage and Remembrance," that addresses the AIDS epidemic and its effect on humanity. "John Corigliano is one of America's most popular composers and, while in residence with the Chicago Symphony last March, premiered his 'Symphony No. 1.' It is a powerful and moving work that deals with the AIDS crisis with affecting dignity. Whether or not one knows the theme of the piece, it leaves us, as the Chicago Tribune says, 'with a renewed awareness of our shared humanity," said Posin.

Inspired by the AIDS quilt which pays loving remembrance to those lost to the disease. Corigliano's score was described by the New York Times as being "by turns anguished, hysterical and deeply moving."



#### Court Ruling Places A Leak In State Anti-Discrimination Law

There's a leak in the dyke of Wisconsin's anti-discrimination law. It was put there by a recent Wisconsin Court of Appeals decision when it ruled that the Green Bay Press Gazette's classified section was not a "public accommodation as defined by Wisconsin statutes." The dangerous aspect of the ruling is that it defined "public accommodation" only in terms of those businesses that are "comparable to or consistent with the (thirteen) businesses enumerated in the statute." The Wisconsin Supreme Court has declined to review this ruling; therefore, it now stands as Wisconsin law.

Without boring the reader with further quotations from the Court's ruling or the Wisconsin statute, the following businesses (in addition to newspapers) might now claim exemption from the bias law: movies and theatres; drug stores and hardware stores; gas stations and banks; department stores and clothing stores — just to name those "non-covered" businesses I patronized the day I wrote this article. We must confront every member of the Wisconsin legislature and ask him/her to help broaden the Wisconsin statute on non-discrimination. Our allies in this cause should be any group that has been denied full and equal enjoyment because of its sex, race, color, creed, physical condition, developmental disability, national origin or ancestry.

Members of the Wisconsin House are all up for election this fall; now is the time to get their ear about broadening the bias law. Now is the time for organizations such as the American Civil Liberties Union and the Lambda Rights Network to recruit their natural allies from women's groups, racial groups and religious groups. Exactly 200 years (to the day) before the Appeal Court's decision, John Curran said that eternal vigilance is the price of liberty. We Wisconsin residents who have a sexual orientation that differs from that of the majority have rested somewhat comfortably behind Wisconsin's "consenting adult" and "non-discrimination" laws. The recent Court of Appeals decision calls for vigilance — and action now to preserve our legislated liberty. To arms, to arms... the red necks are coming!

#### **AIDS Funding**

TO THE EDITOR:

Editor's Note: The following letter was sent also to Rep. David Obey.

Congressional funding of the Ryan White Comprehensive AIDS Resources Emergency (CARE) Act of 1990 is a matter of greatest urgency for Wisconsin and the thousands of people throughout the State who are affected by the AIDS epidemic.

I am writing to ask for your support and leadership at the Congressional Conference Committee meeting this week to increase the \$297 million House appropriation for the CARE Act by at least \$500 million. This increase is absolutely essential if Wisconsin is to receive any financial benefit from the Act.

The Ryan White CARE Act is the most comprehensive federal funding of AIDS services ever authorized by Congress. For Wisconsin, it is funding urgently needed to meet the increasingly difficult demands of the growing AIDS epidemic in our state. Congressional failure to appropriate sufficient funds for the CARE Act will severely harm Wisconsin and seriously undercut our ability to deliver essential AIDS services and successfully manage the epidemic.

I was shocked to learn that the House Appropriations Sub-Committee on Health appropriated only \$207 million of the \$875 million authorized for fiscal year 1991. This appropriation completely eliminates any financial gain for Wisconsin at the very time that, in parts of Wisconsin, the AIDS caseload is doubling each year.

The nine community-based AIDS service organizations located in every region of Wisconsin will be significantly harmed by the failure to fund the CARE Act as will public health care institutions in Milwaukee, Madison and several other cities that are caring for the vast majority of people with HIV disease. Extremely important early intervention, treatment and financial assistance programs that are desperately needed by Wisconsin citizens who are HIV infected will be jeopardized.

If Wisconsin is to gain any benefit from the Ryan White CARE Act, the Congress must increase the appropriation by at least \$500 million. Anything less than the \$500 million increase will fail to help the State because the 16 metropolitan areas hardest hit by the AIDS epidemic will be the recipients of most of that funding.

The House Appropriation Sub-Committee's action has essentially gutted the CARE Act and brings the federal government's response to AIDS to the brink of complete failure. I ask you to do all in your power as a member of the Conference Committee to appropriate at least \$500 million more for the Ryan White CARE Act and thereby restore the credibility of the federal government to the critically important struggle against the AIDS epidemic.

Without this increased appropriation, Wisconsin's ability to successfully manage the AIDS epidemic is seriously jeopardized.

### Political Naivete

I am deeply disturbed by the political naivete and misguided indignation present in Brian Kipp's article "Gays Can And Do Serve Well and Proudly in U.S. Military." The gist of Kipp's article is to protest, not against Mr. Bush's war, but against the discrimination faced by those Gays who "love their country" and want to join the military.

Mr. Kipp, it seems, has bought into Bush's propaganda program that Saddam Hussein is a madman — a demonic Middle-Eastern "thug", about to impose chemical warfare

upon the entire Middle East and can **only** be stopped by sending 30,000 plus troops to Saudi Arabia. Mr. Kipp thus states: "Hussein isn't the first madman to attempt to seize more of the world pie, but he stands out as being a much more serious threat..."

When you mention, Mr. Kipp, that Hussein is not the first to "attempt to seize more of the world pie," you should immediately think of the US of A as a country that seizes and destroys far more of the "world pie" than is ours to seize and destroy.

Which brings me to the major premise of your article that I disagree with: that there can be any pride in joining a military institution as corrupt and oppressive as this one. Don't get me wrong. I agree that discrimination is wrong in any way, shape or form. But if you are going to fight this battle of discrimination in the military, you must make some broader connections than you are making. You should acknowledge that many people who join the military are not doing so because they love and therefore want to fight for our country; many do so because they are economically forced to. It is no great pride to sell your soul to the military in order to receive financial aid, or in order to go to school at all. In essence, nobody should have to enlist in order to receive what in our society is a privilege, rather than a right.

We are fully aware that this decision will cause some of us to be alienated from one another. For that, we are sorry. However, we are also aware that we will not and cannot possibly please 800 or more Lesbians... because we are still so diverse. All we ask is that you trust the fact that we have been very thoughtful in our decision-making process. We hope that whether or not you completely agree with our decision... you will still give us your support. There is still a great deal of latitude for diversity, creativity and humor. It's generally worked for four years. We remain hopeful for the fifth. Please know that we try; we try hard; we do this for ourselves and we do it for you.



Many communities — most suburbs, for example — have community theatre companies. Stephen Dean wants Milwaukee's Lesbians and Gays to have one "for our citizens."

"We want to do plays for our community, about our community, about our lives, our struggles, what we are living," he said. Some other cities have Lesbian and Gay theatre companies, Dean said.

Dean and three other men have been working for the past three months and have created a name and a plan. Different Drummer Theatre Alliance is being incorporated to act as an umbrella organization for theatre groups, Dean said.

One such group is the Special Folk Action Company.

It gets its name from an act by Whoopi Goldberg, in which she describes names used about and against Gays and Lesbians and says, "I think of them as just special folk," Dean explained.

The group needs two things: people and a place. To recruit people for acting, stage managing, set construction, public relations work and other jobs, Different Drummer took out a series of ads in In Step magazine and had a booth at MAPfest.

The ad produced about 30 responses. The booth produced a stack of filled-out forms from interested people.

But Dean is concerned because only 3 of the responses from the ad were from women and most of the forms were filled out by men.

"We want to have women respond," he said. "We want women to form a group or be part of a group." Lesbians could form their own acting troupe and perform under the umbrella organization, he said.

For example, he said, Different Drummer plans to produce a show of one-act plays soon, and a group of women would be welcome to do a one-act of their choice.

Dean is also concerned about a lack of women because the group hopes to do "Execution of Justice," by Emily Mann, the story of the assassination of Harvey Milk, and will need women actors.

"Anybody interested in doing something a little different" in theatre is welcome to join the group, including heterosexuals, he said. Many plays about Gay life include heterosexual characters, he said.

For starters, Different Drummer members hope to put on a show of one-acts in December or February. If they can get the rights, they want to do "A Poster from the Cosmos," about a man being interrogated by police about the suicide of his lover who had AIDS, and "Laughing Wild," a comedy in which a positive attitude speech-maker reveals his negative character.

Auditions will be announced. The date of the plays depends on how fast the group can work.

"We decided to go with one-acts to get our feet wet," Dean said. "They don't require a lot of set construction." A show should also get more interest in the group, he said.

Different Drummer needs a place to rehearse, Dean said, "All we need is like a classroom. We could pay something. It wouldn't be a lot." The group raised almost \$70 at MAPfest, he said.

The group also needs a performance space, and members will talk to other small theatre companies to see about renting space. Different Drummer will need funds to pay the rent.

Dean holds a Master's degree in Fine Arts for directing, producing and stage management. He has directed community theatre groups in the Milwaukee area. Other members of Different Drummer have theatre experience, but that is not necessary, he said.

"I would like as many people that want to do something like this to join," he said. "I think there are a lot of good plays to choose from, a lot of authors."

#### Harriet Tubman's Story On Skylight Stage Oct. 24

[Milwaukee]- Skylight Opera Theatre will present Thea Musgrave's "Harriet, The Woman Called Moses," an opera based freely on the life of Harriet Tubman, Oct.24- Nov.11, 1990 at the Skylight Theatre, 813 N. Jefferson St.

"Harriet, The Woman Called Moses," written in 1985 is inspired by the life of Harriet Tubman, leading up to and including her experiences as an escaped slave and as the most famous "conductor" of the Underground Railroad. In two acts, the 90-minute work conveys the fears and anxieties of those who made the dangerous trip from slavery to freedom and recounts and celebrates the sacrifices, courage and strength of an exceptional and admirable American heroine.

#### Working Against Our Friends Will Not Defeat Homophobic Politicians

We all owe our thanks to ACT UP San Francisco. Most of us have been laboring under the misunderstanding that if we wanted to defeat homophobic politicians we had to work for their opponents. But now thanks to these paragons of wisdom, we now know the truth. If we want to defeat folks like Jesse Helms, we have to boycott products made by companies that are friendly to us.

Specially, we are all being asked to boycott Miller Beer because, some corporate executives of Miller's parent company, Phillip Morris, gave money to Jesse Helms and because the Morris Corporation gave a grant to a UNIVERSITY library named after Helms. Phillip Morris owns a lot of companies including Kraft Foods and Oscar Mayer, but the boycott has centered on Miller Beer and Marlboro cigarettes. After all the queens in San Francisco can hardly be expected to do without their Cheesewhiz, Velveeta and Hot Dogs and apparently the other cigarette brands made by Morris are above reproach.

There are those who have objected to the Miller boycott. They point out that Miller has pro Gay hiring policies, has donated to Gay causes and supported the fight against AIDS. They suggest that if each of the boycott supporters had a semi load of suppositories they would still be full of it. They have even gone so far as to claim that the energy being spent on the boycott would be better used raising funds for Former Mayor Harvey Gannt who is running neck and neck with Helms, or at least in support of a boycott against a company that is actually working against us.

Fortunately not everyone agrees with this line of reasoning. Take ACT UP Dallas for example. They convinced some Dallas bar owners to join in the boycott. One of the arguments used was that Miller doesn't donate lots of money to Gay and Lesbian groups in Dallas, even though the Dallas Gay and Lesbian

community drink lots of Miller. You can hardly blame them for feeling that way. After all, just because the Midwest is sending billions down to Dallas (and the rest of Texas, too) to bail out their Savings and Loan Associations doesn't mean that they aren't entitled to lots more from Midwestern companies. I am sure that Milwaukee's Gay and Lesbian groups are eagerly awaiting those big checks they will undoubtedly be getting from all of those Dallas oil companies. Milwaukee's Gay and Lesbian community uses Dallas oil just as certainly as Dallas Gays and Lesbians drink Milwaukee's Miller Beer.

Rumor has it that Dallas ACT UP is going to help State Senator Chet Edwards win an open seat in Congress by boycotting a cola product. Edwards is in trouble, because on behalf of another Texas Legislator, he accepted an award from the Texas Gay and Lesbian Task Force. Now that ACT UP Dallas has seen the light, they know they don't have to work for Mr. Edwards' campaign, they only have to pick an innocent company to boycott and Edwards will win by a landslide.

Sure there are those who think that boycotting a supportive company like Miller is like shooting yourself in the foot because you have trouble walking. And, yes, some say that with Gannt having a real chance to beat Helms we should be using every bit of our strength to send money and volunteers to his campaign. They compare this boycott to beating up a friend because his parents don't like you.

All of that may sound reasonable on the surface, but these folks are forgetting one simple fact: ACT UP San Francisco has decreed the Miller Boycott and being from San Francisco they know more than the rest of us. You can tell that by all the State wide Gay rights laws they have in California. Okay maybe they don't have any while Wisconsin, where Miller is located, does but that doesn't mean that San Francisco's Gay and Lesbian community isn't infinitely smarter and

#### State Supreme Court Refuses To Hear Ad Discrimination Case

[Madison]- On September 14, 1990, the Wisconsin State Supreme Court refused to hear the appeal of two Lesbians and a Gay man who filed a discrimination suit against the Green Bay Press Gazette for refusing to publish their ads for Gay and Lesbian products and services.

The Press Gazette was clear that the ads were rejected because of the words "Lesbian" and "Gay." "We just don't print those kinds of ads," said a spokesman.

The State Supreme Court's inaction lets stand the lower court ruling that the newspaper has the First Amendment right to print — or not to print — whatever it chooses. It also lets stand the lower court ruling that a newspaper's classified ad section does not constitute a place of public accommodation as defined by Wisconsin statute.

The plaintiffs, Peggy and Tracey Vandeveer and Jay Hatheway, argued that the state's civil rights law, which prohibits discrimination on the basis of sexual orientation in public accommodations (as well as housing and employment) was being violated by the newspaper's refusal to print the Gay-oriented ads. Hatheway's ad was for the publication Among Friends, which offers support to rural Gays. The Vandeveer's ad was for sweatshirts that carry Gay and Lesbian slogans.

The Wisconsin statute specifies 15 businesses such as theatres, hotels and restaurants that cannot discriminate. Lambda Legal Defense and Education more politically astute than Milwaukee's. If you don't believe that just ask anyone from San Francisco and they'll be happy to set you straight (in a manner of speaking of course). In fact many of us who are forced by circumstance to live in other areas of the country have been told in no uncertain terms by many Gays and Lesbians who live there that San Francisco is superior to wherever we live. That's why they call it "THE City."

The rest of us just don't understand the high minded strategy and logic concocted by those geniuses of the Golden Gate. Sure no corporate profits from Miller went to Helms, so what if Miller has sponsored

Fund, which assisted the plaintiffs in their appeal, argued that the law was intended to be interpreted broadly to all places of business, but the court disagreed.

Paula Ettelbrick, Lambda's legal director, declared: "It is an outrage that the Wisconsin Supreme Court would implicitly approve an interpretation of the state's major civil rights law which would now allow discrimination not only by newspapers but by department stores, travel agents, banks and thousands of other businesses not explicitly noted in the statute:"

The only solution, in Ettlebrick's opinion, is to amend the state law to ensure that all businesses that provide goods and services to the public are subject to the anti- discrimination provision.

An entirely different aspect of the case has concerned Gay, Lesbian and feminist editors. They have pointed out that if the plaintiffs won their case, alternative newspapers could be compelled to accept advertisements from groups that are hostile to the newspaper's focus and readership. For instance, the Wisconsin Light could be forced to run ads from fundamentalists offering a "cure" for homosexuality, or Feminist Voices could be compelled to advertise anti-abortion counseling services.

As there are no grounds to appeal the case to a federal court, the rights of the newspaper have been upheld and the plaintiff's case has been dismissed.



## **Counseling Center Celebrates** 10 Years Of Community Help

[Milwaukee]- The Counseling Center of Milwaukee, located at 2038 N. Bartlett Ave. in Milwaukee, has been offering programs directed to the well being of the Gay and Lesbian community for more than ten years.

Tim Baack, the Coordinator of the Men's Support Group Program at the Counseling Center, recently announced the establishment of The Gay Men's Discussion Group (GMDG). Meeting every fourth Sunday of the month between 6:00 and 8:00 p.m. at the Counseling Center, the GMDG is intended to provide a safe and supportive environment for men to share information and ideas on issues that are of interest and concern to the Gay community.

The GMDG is a drop-in group modeled after the Counseling Center's successful Our Space discussion group currently servicing the Lesbian community. Each GMDG program will have either a guest speaker or a panel of speakers. Those attending will be encouraged to actively participate in the discussion. At all times, the Counseling Center will do its best to insure confidentiality of all participants.

Within six months, Baack hopes to establish a GMDG committee comprised of GMDG participants. The committee would help choose discussion group topics and coordinate the program.

The first GMDG will be held on Sunday, October 28. The topic of the discussion is "Coming Out." Future topics will include: Dealing with Your Own Homophobia; Developing and Maintaining Healthy Relationships and Having Sex vs. Making Love. A recommended donation of \$2 per meeting is requested.

In addition to GMDG, the Counseling Center is currently offering facilitator training for HIV+ individuals. Those who complete the program will then facilitate a support group for HIV÷ men. The Counseling Center's HIV + support groups are meant to complement those currently offered by the Milwaukee AIDS Project (MAP). The Counseling Center support groups will differ from MAP's in that they will be a closed group consistent

in membership instead of a drop-in type group where members may change from meeting to meeting. The HIV+ groups are targeted to meet once a week for 14 to 16 weeks.

Other men's support groups dealing with Gay men's issues are in the process of formation. These groups will meet once a week for 10 to 12 weeks. Membership normally consists of a combination of men in different stages of establishing their own Gay life experience. In order to reduce the necessity for a waiting list, the Counseling Center is offering three separate Gay men's support groups this Fall. A donation of \$5 is requested per session, but the fee is negotiable for men with financial difficulties.

Specialized topic support groups are created as the need arises. Baack encourages Gay men to forward any recommendations for a specialized support group directly to him.

Any man interested in either GMDG, HIV + facilitator training or one of the Gay men's support groups should call Baack at 271-2565. If he is not available, leave a first name and number where you can be reached. The Counseling Center mailing list is confidential and all mailings are done in a manner to insure
