#### State Official **Cancels Meeting** With ACT-UP

[Madison]- According to a press release issued by ACT UP/Madison and ACT UP/Milwaukee, Patrick Fiedler, Secretary of the Wisconsin Department of Corrections (DOC), canceled a meeting he had requested with ACT UP on July 22, 1991. The meeting was to be held to discuss ACT UP's continuing protests regarding the refusal of the DOC to implement the recommendations of Governor Tommy Thompson's HIV/AIDS Technical Advisory Committee. (see article, this issue)

Five members of ACT UP arrived at the DOC building and were shown to a conference room. A video documenter, who has been present at previous meetings between ACT UP and the DOC, accompanied the activists.

ACT UP has not released the tapes of previous meetings at DOC to the press, and had no intention, the group said, of making this one available.

The purpose of taping the meeting was to provide both sides with an indisputable reference document. ACT UP said they viewed the tape as a tool to facilitate open, good faith negotiations.

Upon seeing the video equipment, Patrick Fiedler refused to proceed with the meeting he had requested. Fiedler said the presence of the video camera would "inhibit his ability to negotiate." He also accused ACT UP of wishing to turn the meeting into a "media event," despite the fact that ACT UP had invited no representatives of the press to attend and had not issued a press release regarding the DOC's request for a top-level meeting. ACT UP offered to make available to the DOC a copy of the tape should the meeting proceed. This was unacceptable to Fiedler.

Unable to accept the presence of the camera, Fiedler broke off the meeting.

ACT UP has stated that is it willing and anxious to meet with Fiedler, but that ACT UP's commitment to openness and verifiability cannot be suspended to accommodate Fiedler.

In a letter sent to Fiedler and signed by ACT UP/Madison and ACT UP/Mil-waukee, the groups reaffirmed their belief in "an indisputable audio/video reference" and pointed out that "Similar documentation has taken place in our previous meetings with DOC."

The two groups also reaffirmed their desire to meet with him. "We recommend meeting in a neutral space where your penchant to patronize will not hamper good faith dialogue."

## Community Stunned by Murders, **Angered By Press Coverage**

[Milwaukee] - Allegations "homosexual overkill," which f "homosexual overkill," which first emerged at a murder trial in Racine County on July 19, have been reiterated by authorities and the media in reference to the separate and more recent mass murder discovered in Milwaukee on July 22. The multiple murders uncovered that night are the worst such crimes ever recorded in the history of Milwaukee.

Jeffrey L. Dahmer, 31, is being held by Milwaukee police as the primary suspect in at least eleven grisly homicides. The skulls and severed heads of eleven people, along with numerous organs and limbs in varying states of decomposition, were discovered in Dahmer's apartment at 924 N. 25th Street late in the evening of

Police were alerted to the murders by a man who had apparently fled Dahmer's apartment that night. The man, who had a handcuff locked around one of his hands, hailed a police car and led officers back to the scene of the alleged crimes.

After a July 24 hearing before Judge Frank T. Crivello determined that there was probable cause to hold and charge Dahmer, bail was set at \$1 million. Formal charges were expected to be filed on Thursday, July 25. (The Light's press deadline for this issue was 6 p.m. on July 24.) Gerald Boyle, Dahmer's attorney stated that his client was cooperating with police and helping to identify the victims.

Police and medical authorities believe that all of the victims were men and it is

likely that all were African- American or men of color. Dahmer is white. The first victim to be identified was Oliver Lacey, 23, of Chicago.

According to an affidavit filed in Milwaukee County Circuit Court, Dahmer met individuals at taverns and shopping malls and induced them to return to his home by offering them money so he could take photos of them. Patrons in several of Milwaukee's Gay bars claim to have seen Dahmer in those establishments.

The relatives of Tony Hughes, 21, who disappeared in Milwaukee on May 24, fear that he may be one of the victims. Hughes was last seen leaving Club 219, a Gay dance bar on Milwaukee's south

Police reported that along with the human remains confiscated at Dahmer's apartment were photos of mutilated bodies, body parts and homosexual acts. Police were quick to label the murders "homosexual overkill," and that phrase was again reported throughout the local print and broadcast media.

The term "homosexual overkill" was first employed only days before at the Racine County trial of another alleged murderer. The phrase was repeatedly used by Milwaukee County Medical Examiner Jeffrey M. Jentzen and Racine County District Attorney Lennie Weber in the murder trial of Joachim Dressler, 43.

Dressler is accused of murdering and dismembering the body of James Madden, 24, on June 27, 1990. TURN TO MURDERS, PAGE 5

[Milwaukee]- Members of Milwaukee's Gay and Lesbian community, both political leaders and average bar patrons interviewed by the Light, have reacted with wide-spread shock, sorrow and dismay at the news of the grisly murders/dismemberments discovered on Monday, July 22, 1991. The mass killings are believed to be the worst such crimes ever perpetrated in the city of Milwaukee.

Anger was also expressed over the fact that the media was seen by most as labeling the crime as being brought about, in part, by homosexuality.

the 'homosexual' angle," said Stan Straka. "They were so quick to take off with it. There's been over 90 murders in our city this year and none of them was labeled 'heterosexual.' This type of reporting just brings more hatred towards our community.'

Tim Grair, a member of Queer Nation/Milwaukee commented that to him it was "a horrifying and frightening experience." Grair went on to add: "To me this whole situation makes grotesquely clear that it is imperative that we recognize the importance of self-awareness training and I hope this spurs more people into action with the

Scott Gunkel, President of the Lambda Rights Network, expressed stunned shock over news reports and added that "there can be no excuse for blaming the whole Gay community for this deranged act."

Gunkel said that Lesbian/Gay organizations would be holding a strategy session on Thursday, July 25, 1991 at 7:00 p.m. at the Milwaukee Enterprise Center, 2821 N. 4th Street, to voice the community's concern and position.

Olson condemned "accusations that the murders are examples of 'homosexual overkill,' which seems to imply that all Gay men are culpable. As a community," Olson said, 'we need to rise up in pride and counter the insinuations that underlie this act."

Olson urged Gays to "affirm the power of coming out" so that Lesbians and Gay men can free themselves as well as teach others that Gays and Lesbians are "not the monsters some fear us to be.'

Olson went on to say he believed that if "this man Jeffrey Dahmer, the suspect in the crimes had been a self-affirming. openly Gay man who loved himself and others, Milwaukee would very likely have been spared this tragedy.'

Olson concluded saying, "We the Gay community — with the rest of the community — mourn the senseless loss of life and deplore the manner of their

By Jamakaya [La Crosse, WI] - In his first public response to allegations that he is a closeted Gay, Rep. Steve Gunderson (R-WI, 3rd District) accused those "outing" him of being "crazy people" and "pathological liars." His comments were reported in the July 21 La Crosse Tribune.

On June 30, Gunderson was accosted in a suburban Washington, D.C. Gay bar by Michael Petrelis, a Queer Nation activist, who reportedly threw a drink at the Congressman and challenged him to 'come out of the closet."

Witnesses say Gunderson replied: "I am out. I'm in this bar, aren't I?" Gunderson's spokeswoman, Jennifer Koberstein later denied the Congressman made that remark.

During an Independence Day parade in La Crosse, Gunderson was again confronted with the issue. Tim Campbell, editor of the GLC Voice of Minneapolis and a proponent of outing, distributed hundreds of flyers that mentioned the bar incident and urged Gunderson to "come out for Gay rights" and to "join the sponsors of the Gay and Lesbian rights bill in Congress."

Both Petrelis and Campbell cited Gunderson's failure to co-sponsor the federal Gay rights bill and his failure to publicly advocate in favor of Gay issues as motivation for their outing campaign. In revealing his alleged homosexuality, the activists hoped to expose the "hypocrisy" and "double standards" they perceive in his public and private

Petrelis, in particular, objected to Gunderson's presence in the Gay bar. In his confrontation with the Congressman on June 30, he reportedly yelled out that because Gunderson did nothing to help the Gay rights movement, he "should not be allowed to enjoy the fruits of Gay liberation.'

In his interview with the Tribune, Gunderson said he was busy with dairy and education issues and had not studied Gay rights measures. He also accused Petrelis, Campbell and the group Queer Nation of ''despicable tactics'' and ''pathological lies.'' ''We're dealing with crazy people," he said.

Campbell told the Wisconsin Light in a telephone interview that Gunderson's defamatory statements were "the

UP/Madison. Savage went on to say that "Mr. Thomas was extremely ill in the days leading up to his death. Why wasn't he transferred sooner? The HSU at Waupun is not equipped for caring for terminally ill inmates, yet Mr. Thomas was held there until he was too sick to live, and only then transferred to the hospital.'

An issue paper submitted by the overnor's HIV/AIDS Technical Governor's Advisory Committee to Governor Tommy Thompson and the Department of Corrections (DOC) in May, 1990, states that the prison HSUs "...are ill equipped to provide care to persons with terminal illness...' They provide "routine ambulatory care services, including health assessments, management of minor injuries, routine monitoring of chronic diseases, and referral for specialty care."

Regarding the HSU at Waupun, the report goes on to state: "The physical facility... is over one hundred years old and is inadequate to provide skilled nursing care." The report describes the staff at prison HSUs as lacking the skills specific to caring for seriously and terminally ill inmates.'

ACT UP/Madison has been protesting the treatment of PWAs in Wisconsin prisons since April 17, 1991. ACT UP states that it would like to see the DOC enact all of the recommendations of the HIV/AIDS Governor's Committee. Advisory recommendations concern issues of treatment; access to health care; education for guards, staff and inmates; compassionate early release; distribution of condoms and communication between prison HSUs and outside care providers.

ACT UP/Madison has called for an investigation to resolve what it regard as questions surrounding circumstances of Mr. Thomas' death.

Steve Kronzer, administrator of program services for the DOC, said that 'inmates receive the best care available.

[Pensacola, FL]- Three teenagers have een arrested and charged with murder for the beating death of a married father of four who they believed was Gay, according to police

The youths were arrested in June for the slaying of John L. Braun, 43, a Southern Bell Telephone technician. Braun suffered multiple blows to the head with a blunt instrument. He was killed in a wooded area near the shore of Escambia Bay.

"The original motive was to beat up a homosexual, and it escalated into murder," said Sergeant Perry Knowles. The men also stole Braun's wallet, which contained \$13.

Jason Gueder and Christopher Reynolds, both 18, and a 17 year old minor have been charged with murder and armed robbery. Gueder and Reynolds are being held without

#### Award to Hudson's Lover Upheld

[Los Angeles, CA] - A California Appeals court has upheld the \$5 million award a jury had ordered Rock Hudson's estate to pay the actor's lover Marc Christian because of the fear that Christian might still develop AIDS.

The court said Christian was living with "the ultimate in personal horror — the fear of slow, agonizing certain death." In 1989, the jury had ruled that Hudson engaged in "outrageous conduct" by concealing his AIDS diagnosis from Christian during the time the men engaged in sexual relations.

Christian, 38, has tested negative for HIV. He plans to donate some of the money to

#### Gay Ministers Appointed, Ousted

[Washington, D.C.] - Despite objections voiced during her ordination ceremony, Elizabeth Carl, 40, was ordained into the Episcopal priesthood in Washington, D.C. on June 5. Carl became the first open Lesbian to serve as an Episcopal priest. Her investiture brought this comment from the nation's most famous Episcopalian, President George Bush: "Perhaps I'm a little old-fashioned, but I'm not quite ready for that.

On June 13, the Western Pennsylvania Congress of the United Methodist Church, by an almost unanimous vote, defrocked the Rev. James Hawk, 27, because he is Gay. The United Methodist Church has banned Gays from the ministry for six years.

Hawk said: "It's very sad to have grown up in the United Methodist Church and to have known these people all of my life and loved them and cared for them,,, and, today, to realize that they really don't love me."

Meanwhile, the Rev. Scott Alexander, a Gay man, has been installed as senior minister of the largest congregation of the Unitarian Universalist Association in Boston. Unlike other denominations, Unitarian Universalists have always welcomed Gays as both members and ministers. Said Alexander: "We're saying that God loves everyone while the others are saying God loves some of us."

#### Frat Suspended for Homophobia

[Syracuse, NY] - A fraternity at Syracuse University has been suspended by its national office after selling t-shirts with anti-Gay slogans, including one that advocated Gay

All 54 members of the Alpha Chi Rho fraternity were permanently suspended. There is an appeal process that may allow those exonerated to re-group at a later time.

The University's Gay, Lesbian' and Bisexual Student Association complained to officials about the t-shirts. On the front, the shirts said: "Homophobic and Proud of It!" The back read: "Club Faggots, Not Seals," with the picture of a muscled crow, the fraternity's symbol, holding a club and standing over a prone faceless figure. Next to them is a seal raising a mug of beer.

#### Cemetery Vandals Charged in Ind.

[Cicero, IN] - Charges of criminal mischief and criminal trespass have been filed against two youths for the most recent desecration of the grave of AIDS activist Ryan White. Jeanne White, Ryan's mother, had offered a \$500 reward for information about the vandals and phone tips led to the teenagers.

The youths gave no explanation for toppling the huge gravestone. Hamilton County Sheriff's Detective Thomas Anderson said: "It was not premeditated. It was just

spur-of-the-moment.'

It was the third time White's grave has been vandalized. In previous incidents, the stone was also toppled, flowers were uprooted and slurs were spray-painted on the stone

"I'm trying to go on and complete Ryan's battle to teach those who don't understand," said Mrs. White. "I'm just sick about it. My daughter Andrea and I have had enough of this... It's a quiet cemetery and I don't know why they can't leave him to

#### **Sperm Donor Seeks Child Custody**

[Davis, CA] - Superior Court Judge Donna Petre is expected to rule soon on whether a Gay man who donated sperm to a Lesbian couple to conceive a child may claim paternity and joint custody of the boy who is now one year old.

California law states that donors who provide semen to a licensed physician for use in artificial insemination cannot claim paternity. But the law may not apply in this case since the donor gave his semen directly to the women who then performed the insemination themselves.

Last year, the U.S. Supreme Court ruled that an Oregon law, similar to California's could not prevent an Oregon sperm donor from suing for custody. That case was settled

Andra and Mary Northup, who share their last name, said they did not utilize a licensed sperm bank because their doctor advised them that fresh sperm increased Andra's chance of pregnancy. They also performed the insemination on their own because they preferred being able to tell the child where he came from. Andra Northup conceded: "We tried to provide a more humane approach and maybe that was real stupid.'

#### Police, FBI Confer on Murders

[Indianapolis, IN] - Agents from the Federal Bureau of Investigation (FBI) met with Indiana and Ohio police recently to share information and develop a strategy to solve a rash of slayings that has claimed the lives of ten Gay men.

The investigators reviewed all of the clues and similarities in the crimes. Larry Swihart of the Preble County, Ohio Sheriff's Department, said: "New things come in weekly and it's been quite a while since we put our heads together."

The bodies of four men were dumped in Preble County between 1985 and 1990. The bodies of six other Indianapolis men have been found in central Indiana and west central Ohio. All of the victims were known to be Gay or had ties to the Gay community. Eight of the ten victims had been strangled.

#### S.F. Cop Guilty of Brutality

[San Francisco, CA] - The San Francisco Police Commission has found Captain Richard Cairns guilty of brutality and misconduct stemming from a violent police "sweep" through Castro Street during an ACT UP protest in 1989.

Cairns was convicted of the unprovoked clubbing of two women and the false arrest of one of the women for allegedly assaulting an officer. The 22-year veteran of the department led the tactical unit that charged into the demonstrators to break up the

Cairns could be suspended or terminated, but sentencing will be delayed until related charges against four other officers are resolved. Witnesses at the incident likened the cops' behavior to a "police riot."

#### **Teen Charged In** Sex Assault Of Fellow Youth

[Beloit, WI]- According to the Eau Claire Leader-Telegram, a 16-year-old Beloit boy may be tried as an adult on a charge of sexually assaulting a younger boy whose hands were tied with telephone

The Rock County District Attorney's office is seeking a waiver to adult court because the boy is mature, and his potential for responding to treatment within the juvenile justice system is "minimal or non-existent."

Police said the youth admitted the assault, telling authorities he was bored, lonely and "wanted to, like, hurt him any way I could."

The teen was charged on July 12 with first-degree sexual assault and false imprisonment for tying and gagging the 14-year-old boy and forcibly having sex with him, police said.

Center for Public Representation and the Legal Assistance to Institutionalized Persons Program.

Prisoners were warned that "you are told by the staff that testing is confidential," but "This does not mean that no one learns the results of your. test." The letter went on to say that "Currently, the administration does not allow anonymous testing in Wisconsin jails or prisons. The results of your test are available to the prison staff.

Under these circumstances, the letter advised prisoners "Do not get tested while in jail" because "harassment and discrimination" take place.

Instead, people were advised to be tested for HIV once they have been released and were given a list of several places in Madison where anonymous HIV testing is available.



#### **OBITUARIES** Richard T. Mitch: Gay Activist, ADVOCATE Co-Founder, Dies at 65

[Los Angeles, CA]- Richard T. Mitch, co- founder, former publisher and managing editor of The Advocate died of cancer at the home of his sister in North Syracuse, NY on May 17, 1991. Mitch was

After being arrested in a random Los Angeles Police Dept. raid of the Yukon Bar in 1966, Mitch joined the newly formed militant Gay organization, Personal Rights in Defense and Education (PRIDE), and became the editor of the group's newsletter.

In 1967, the newsletter became The Los Angeles Advocate and, in early 1968, was taken over by Mitch, his partner, Bill Rau and Sam Winston, after PRIDE sank beneath a debt load brought on by police

Mitch and Rau adopted the pseudonyms "Dick Michaels" and "Bill Rand" so they could continue to publish the new publication while holding their regular jobs under their given names. Rau was working at ABC radio network in the typing and mimeo department and it was there that the early editions of The Advocate were printed clandestinely at

By May, 1969, the "Los Angeles" was dropped from the name and Mitch and Rau had quit their jobs to devote full time to it. By 1970, the magazine was being distributed nationwide and in foreign countries.

In the early July, 1969 edition, The Advocate gave extensive front page coverage to the Stonewall Riot when it rated no more than a paragraph in local newspapers.

The Advocate steadily expanded, going from a three-room suite in Hollywood to a two-story house. Mitch and Rau regularly

put in 15-hour days. Finally, in 1975, they sold the magazine to San Francisco millionaire David Goodstein. By that time, it was circulating a 56 page bi-weekly edition to 48,000 readers nationwide.

Following his retirement, Mitch wrote a column by-lined "Dick Michaels" for Update and the Philadelphia Gay News during 1984-85, offering a conservative viewpoint on what he considered out-of-control Gay activism.

#### **EDITORIAL**

#### Mass Murder: Human Phenomenon, Transcends Cultures, Sexualities

The hysteria surrounding the recent revelations of grisly murders and mutilations in the city of Milwaukee (see front page stories) is all the more reason to try and keep things in some sort of perspective.

For example, the use of the term "homosexual overkill" by the Milwaukee County Medical Examiner, Jeffrey M. Jentzen, in relation to the Dressler case in Racine is, at best, an unfortunate choice of words. At worst, it is grossly unfair, escaping definition for meaninglessness. We have to ask, is there "heterosexual overkill?" The point is, that if sexual orientation is a necessary descriptive term in cases such as these, then heterosexual and homosexual must, of necessity, be used equally.

We should also keep in mind, that there is absolutely nothing to indicate that violence is in any way a characteristic of Lesbians and Gays more than of any other groups. Nothing.

Violence and other brutalities, unfortunately, are human phenomena, present throughout history in all societies at all times. We sometimes seem to think that such gruesome acts are due to instability in society; a breakdown in values - however they are interpreted. Yet historically that just doesn't work out. Some of the most hideous crimes in history have been committed in the most stable and self-assured of cultures — Jack the Ripper, for example in Victorian England.

The fact seems to be that mass murderers are a phenomenon unto themselves. They can be kings or paupers, nobles or churls, heterosexual or homosexual.

Thus, our community must, I think, in no way set about blaming itself or thinking less of itself. Regardless of the hysteria, of scurrilous radio talkshow hosts who, in a snarling pursuit of ratings, don't care who they hurt, we as a community should ignore that and other inconsequential ravings.

We must abhor the crime, feel sorrow that it happened and offer compassion to the families of its victims.

We must also, I think, strive ever harder to break the bonds of ignorance and discrimination that bind us.

We must increase our efforts at education, letting the public at large know the enormous contributions we have made to society and culture throughout history. We must let them know that those who were Lesbians and Gays — many quite open — created much of what is defined as Western Civilization.

We must also increase our self-awareness for our own protection. We must gird ourselves as Lesbians and Gay men to fight even harder, with the consciousness that violence, prejudice, hatred and ignorance are the true sources of evils in this world and that we, as a community, are at the forefront of the battle against them.

These horrible crimes are not a homosexual issue. They are not a heterosexual issue. They are a human issue, an issue of someone demented, and on that level we can feel sorrow. There but for the grace of the divine go any of us, Gay, Lesbian, Bisexual or

#### **Straight Society Creates The Climate** Encouraging "Homophobic Overkill"

Mass murder has as much to do with sexual orientation as rape does with love, or child molestation does with affection.

If either suspect in these gruesome murders had sex with their victims has not been established. And if one or both did, what does that prove? Does it prove they were homosexual? Evidence in the current trial portrays the suspect as a loving family man, a good husband and father. In other words, a straight man. The attempt by the press to label him a homosexual in order to shift blame from their own violence consumed reality is not only an insult but a sham.

Regardless, these two suspects certainly were not and are not Gay. Being Gay is being proud. It is the ability to love a person of the same sex, to share love, affection and life. If sex was involved, it was not a matter of making love. It was a matter of violation, like rape, and child molestation, an assault bred of anger, of hate, of corrupt power, of humiliation, and of intense homophobia. It was not "homosexual overkill," it was

homophobic overkill. Violence, murder and dismemberment — the ultimate violation of the human body — is not the product of love, of being an 'out' and proud Gay person. It is the product of hate. It is the product of a society that fears two men loving each other, but accepts the widespread depiction of murder and complete barbarity on the small and silver screen. It is the product of self hatred engendered through the oppression of Gays by a society and church that wants sexual conformity at any cost. It is the product of violence on the streets and dysfunction in the home. It is, quite simply, the product of a society that

heterosexuals have forced upon us. Gay people have not created the society in which we all live. We have not created a society that drives thousands of Gay and Lesbian teen-agers to commit suicide. We have not created the society that causes gangs of heterosexuals to go out to find Gays to brutally attack and murder. We have not created the society that looks away when heterosexuals rape Lesbians to "make them straight." We have not created the society that forces people to hide in the closet or face rejection by their families, loss of their jobs or assault in the streets. And most certainly, we have not created the society that turns out mass murderers. We have been the victims of it. The facts in these two cases, when they fully emerge, will prove we are the victims of it still.

LRN commends your stations' efforts to present programming on Lesbian and Gay topics. We have not failed to recognize your successes; for instance, LRN presented its media award to Smith & Company

But your efforts make your refusal to broadcast "Tongues Untied" even more of a mystery to us. Just what was it about this film that makes it unsuitable for broadcast? Can Lesbians and Gays appear on Smith & Company only if they are uncontroversial? Can Lesbians and Gays appear only if they are white and look

middle class? Do you have any guidelines?
Since there are many individual Lesbian and Gay lifestyles, it is prejudicial to ignore the existence of some when an outstanding record of that culture is presented to you. Black Gay

experiences, as portrayed in "Tongues Untied," may make some of your viewers uncomfortable, but contentment has never been a good reason to shun serious work. Cows should be contented; sentient viewers should be challenged on occasion.

Perhaps your viewers have only grown to accept Gay ballet—dancers on "Great Performances" or the characters of effeminate British aristocrats on "Masterpiece Theater." We are not engaging in "political We are not engaging in "political correctness", but giving you some sound demographic information, when we write that African American Lesbians and Gays exist in Milwaukee in roughly the same proportion as in any other American city. We doubt that you'll find a genuine British aristocrat anywhere in Milwaukee.

Vivid language and explicit sexuality are part of many Lesbians' and Gays' lifestyles. "Tongues Untied" is not sensational; it is speaking the truth as many see it. And as John Keats wrote, "Beauty is truth, truth beauty." "Tongues Untied", like the images of Robert Mapplethorpe, may shock some, but we cannot allow the squeamish or prudish among us to determine what your adult audience will view.

Why not reverse your position and take a stand for freedom of expression and diversity. Your station may find that it attracts new viewers and supporters and that its current viewers and supporters are not as puritanical as someone at 10/36 apparently seems to

#### 'Tongues Untied'

THE FOLLOWING IS A REPLY TO LRN'S LETTER TO CHANNELS 10/36

Thank you for your letter concerning "Tongues Untied." You are correct, we do serve all of the communities in southeast Wisconsin and we do have the record for not avoiding controversial programming. We are proud to broadcast many programs that serve a diverse audience and we will continue to do so. As you mentioned, your organization's As you mentioned, your organization's honoring award to "Smith & Company" confirms our pledge to broadcast diversity to

many audiences.

One point of clarification, we do not broadcast "British" programming for an aristocratic audience nor do we broadcast "Gay" issues only for a Gay audience. Our audience research shows we have a broad based audience watching "Masterpiece Theater" and "Smith & Company."

Our community research also contends that

Our community research also contends that vivid language including most of the explicit language in "Tongues Untied" is appropriate—if noted and flagged at the beginning of the program — for broadcast to our community. But, the explicit language in "Tongues Untied" illustrating a sexual act is not within our community standard — whether the illustration is homosexual or heterosexual. In our opinion, this short scene is presented for shock value, not for any true understanding of the Black, Gay culture. That is the reason "Tongues Untied" was not broadcast on 10/36. The producer was asked to change this

short scent, but he refused.

Broadcast is the key to our reasoning. Unlike theatrical releases, who control their audience by age limitations, broadcast TV has children watching at all hours. Yet, we are able to provide a diverse and sometimes controversial programming service to many peoples of many age groups. We cannot broadcast all things because of this measured community standard that we are required to follow. Our signal is voiced in most all of the homes in our service area and the Federal Communications Commission states we must know our community standard and be this steward to our broadcast audience.

It would be unfortunate and unjustified to consider our reluctance to broadcast one program as the end of our long record of diversity of programming. Please continue to look to 10/36 for continued commitment to presentation of diverse and thought provoking

Madden was canvassing for an environmental group and was last seen in the area of Dressler's home in the town of Raymond in Racine County. Portions of Madden's dismembered body were discovered two days later in plastic bags in nearby farm fields.

Jentzen, the medical examiner, testified on July 19 that Madden was killed by a gunshot to the back of the head. His body had been cut in half at the waist. Madden's arms and hands had been severed. Internal organs and genitalia had been removed with what Jentzen described as "surgical Jentzen described as precision."

"This is what we call 'homosexual overkill," said Jentzen. "There was more here that was done than is necessary to stop a person from breathing." Jentzen called such frenzied violence typical of "homosexual overkill" murders.

"limited" his admittedly experience, Jentzen claimed to have seen five cases of "homosexual overkill." He theorized that the perpetrators reacted angrily out of deeply repressed homosexual feelings and attacked their lovers in a frenzied rage.

The only apparent evidence linking Dressler to homosexuality were pornographic photos and videos confiscated at his home and the admission, by his wife, that Dressler communicated over a computer bulletin

board used by Gay men.

Jentzen's "homosexual overkill" theory was widely reported in the print and broadcast media. The theory was reinforced by District Attorney Weber who is prosecuting the case. Weber has used the phrase many times, according to sources monitoring the case for the Light, sometimes using it almost interchangeably with the actual criminal charge of first degree intentional homicide.

Repeated attempts by the Light to reach Dr. Jentzen, in the hope of clarifying his definition of "homosexual overkill" understanding what credentials entitle him to proclaim such motives, were

unsuccessful.

Less than a day after completing his testimony at the Dressler trial in Racine, Jentzen was called to the scene of the mass murder in Milwaukee.

Gay activists in Milwaukee have criticized the casual use of the term 'homosexual overkill'' in both cases and throughout the media. (See accompanying article.) They have questioned the validity of such a concept and warned that it could inflame the public and lead to further violence against Gays and Lesbians. Some believe the very idea is based in homophobia - the irrational fear and hatred of Gay people.

Gay and Lesbian community leaders were scheduled to meet on July 25 to plan a strategy for responding to the recent events and, specifically, to the allegations of "homosexual overkill,"

Lesbian Alliance of Metro Milwaukee, was concerned about the racial implications of the crimes. She commented: "How can so many African-American men disappear, and no one knows about it? If these disappearances had occurred in a white suburb, the headlines would have screamed about it all along."

Barber noted that the victims of serial murderers are most often women, children, people of color and Gay men. "We are the despised and the disposable."

This is an issue of race, class, gender and sexual orientation. Where were the police? Where were they? That's what I want to know," said Barber.



Several people voiced the opinion that "something had to be done" to counter what Tom L. called "insensitive reporting" by the major press and its effect on the community at large. Others denounced the reporting as verging on "the hysterical."

A number of people throughout the bars thought that the community as a whole should take some action to counter what they thought would be the rise in homophobia and violence as as result of "using us as a scapegoat," as Jim T. remarked. However, no one seemed to know what it was that could be done.

At C'est La Vie, early in the evening, around 9:00 p.m., a mug shot of Dahmer was shown. No one present seemed to be familiar with him. Since others in the other bars had not seen the a picture of Dahmer, bar patrons were unable to say if they knew him or not, although at least one opined that he did and, in fact, had been approached by Dahmer. Several people at the Triangle, who asked not to be named, said that they had seen Dahmer in the Phoenix and Club 219 and that he "looked suspicious," but they could be no more definite than that.

There was speculation about people who were missing or believed to be missing. John Clayton, owner of C'est La Vie. said that he knew of two young men who had been missing for "6 months to a year," and he feared that they might be among the victims.

One, Clayton identified as "Steve," was white, short in stature and small-boned, and "The Sheik," a Black man, tall, very thin who wore a turban.

In what has to be an entirely subjective impression, people in the Gay bars seemed as horrified and confused about the case as everyone else. There were all kinds of rumors and speculations. But the overriding fear or concern seemed to be with the way the case was being reported in the media and its repercussions on the community.

#### "Warshawski:" Star Vehicle For Sexy, Funny Kathleen Turner

"I think my women are consistently intelligent, consistently not victims, women who try to do something about whatever situation they're in, be it Matty Walker or Peggy Sue." Kathleen Turner in Premiere

Paretsky's fictional Add Sara detective, V.I. Warshawski, to Turner's growing list of intelligent and independent movie heroines. Turner has struck another blow for strong women in Hollywood as the title character in the new film Warshawski.

Paretsky's private investigator, featured in several volumes of detective fiction (Blood Shot, Killing Orders, Burn Marks), is smart, tough, witty and sexy. So, who else but Kathleen Turner to play

her? The film Warshawski is something of a composite, drawing elements from a number of Paretsky's books. Happily, Warshawski's wit and grit remain intact. The plot has Warshawski taking charge of Kat, the 13 year old daughter of a murdered client. The "female dick," as her detractors call her, has to uncover why the girl's father was slain and why the killers are now after the girl.

Along the way, Warshawski encounters a number of brutal and buffoonish goons most of whom she handily dispatches with her quick wits and skill in the martial arts. It turns out Kat's own sleazoid family members are the bad guys/gals, trying to off the kid who, because of daddy's demise, controls the assets to a multi-million dollar development on Chicago's waterfront.

The plot is fairly routine, similar to your average TV mystery, but the delivery the quick pacing, the cartoon-like characters and the smart, witty dialogue make the movie quite enjoyable. The movie has a hip, catchy musical theme, and the visual images of Chicago - its skyline, skyscrapers, streets and lakefront — do the Windy City proud.

Warshawski is unquestionably a star vehicle for Kathleen Turner and I'm thrilled to report that she delivers the goods with great panache. Turner exudes a confidence and sexuality that is almost

palpable. She is in top comedic form and much of her character's sparkling dialogue is strongly feminist in tone. At one point, Warshawski surmises: "Never underestimate a man's ability to underestimate a woman."

After getting seriously beat up, a frustrated Warshawski asks her assailant: "Do you know how hard it is to get blood out of cashmere?" To a guy who brags he has slept with 500 women, she offers this delicious put-down:
"Can't get the hang of it, huh?" To
another creep: "You're about as deep as formica." And her sage advice to Kat: 'When in doubt, hesitate.

Running gags about Warshawski's shoe fetish and what her initials " V.I." stand for elicit a variety of equally witty responses. The dialogue is true to

Paretsky's original writing.

Thank you, Kathleen Turner, for not playing victims. Thank you also for being intelligent and witty and gorgeous and a hell of a lot of fun in this movie.

According to a QN press release, O'Meara did not press charges because of "his belief in first amendment rights." QN also said that O'Meara expressed "great concern" over the recent rise in violence against the Gay

knee-jerk response of a politician who has been exposed as a fraud. It doesn't change the factuality of our story.'

Asked directly if he is a homosexual, Gunderson told the **Tribune**: "I can't answer that because I can't prove it to you.... It is not anybody's business. Being single, I have been accused of being a womanizer by some, abstinent by others. I can't prove any of them."

Gunderson insisted on his right to privacy: "Nothing in my personal life is legitimate discussion unless I am breaking the law or using my position for

Gunderson was defensive about his presence in the Gay bar. "Yes, I was in a Gay-owned restaurant to get dinner. There are lots of Gay-owned businesses in Washington. I would take my parents there; there was nothing wrong with being there.

"Yes, I was in a Gay bar. I have Gay friends, Black friends, women friends, Jews; anyone who knows me knows I am a strong advocate of civil rights for everybody," said the Congressman.

In early June, however, Gunderson cast a "no" vote against the 1991 Civil Rights bill. The bill passed but was vetoed by President Bush. Gunderson is not listed as a sponsor of the federal Gay rights bill.

Despite these apparently contradictory positions, the National Gay and Lesbian Force (NGLTF) reports that Gunderson has voted favorably on 94% of Gay and AIDS-related legislation in the

current Congress.

But Campbell criticized NGLTF's score-carding on the issues as "narrow," ignoring abortion rights, affirmative action, Supreme Court (Gunderson supported nominees conservative Robert Bork) and even the federal Gay rights bill.

According to Campbell, Gunderson has voted against National Endowment for the Arts funding for Robert Mapplethorpe's work and opposed de-criminalization of the District of Columbia's sodomy

Rep. Gunderson's interview with the La Crosse Tribune is apparently the first step in a campaign of damage control in his home district where constituent reaction to all the media coverage of his outing is still unclear. Campbell noted that while passing out his flyers at the July 4 parade, people reading them did not seem surprised at the allegation that Gunderson is Gay.

While distributing his flyers on July 4, Campbell was arrested by La Crosse police and charged with two counts of littering. He believes the arrest was an attempt to prevent him from passing out the flyers. Campbell called it an example of police harassment and an infringement of his freedom of speech. Police confiscated 300 copies of the leaflets.

Campbell will contest the charges (which carry \$61 fines) in La Crosse municipal court on August 29. He has asked the Wisconsin Civil Liberties Union to assist in his defense.

The Governor's office staff, upon seeing 35 activists coming down the hall carrying a casket and being led by "Death," quickly shut the door. In the vestibule outside the office, the activists chanted "Shame" and "Prisoners With AIDS Under Attack, What Do We Do? ACT UP! Fight Back!"

The chanting attracted people from all over the building, coming to see what the uproar was all about. Observers said the on-lookers seemed taken aback to see the figure of "Death" knocking on the Governor's door.

Unable to take the sandwich and towel into the Governor's office, one activist shoved them in under the door.

ACT UP/Madison wants Governor Thompson to issue an executive order compelling the DOC to enact the recommendations of his own committee.

repeats 'best care available' like some sort of mantra. Steve Kronzer thinks that if he says it enough, it must be so. Being allowed to waste away in insolation in a prison infirmary that is not staffed or equipped to handle terminally ill patients is not the best care available by any

stretch of the imagination."

To protest Mr. Thomas' death, ACT UP/Madison staged a demonstration at the DOC building in Madison on July 1, 1991. Activists set a casket on the sidewalk in front of the building and a "die-in" was presided over by one activist dressed as Death. The 35 'dead' activists lay on the ground in front of the building observing 5 minutes of silence. At the end of that time, the activists, from their prone positions, began chanting "DOC You Can't Hide. We Charge You With Homicide" and "Enact The Recommendations."

"Enact The Recommendations" is not a catchy chant, but it's what we are here said Joe Policarpio, a member of ACT UP/Madison.

During the demonstration, press releases were distributed by Mr. Kronzer detailing Mr. Thomas' criminal record. "The message would seem to be,"

Savage said, "that if you have done something that lands you in prison, the DOC has every right to murder you." Savage charged that "They're trying to say that we shouldn't be here protesting

today because Ricardo Thomas was a criminal and deserved to die. The DOC does not understand that an attack on one PWA is an attack on all PWAs or people suspected of being at risk for AIDS, and we won't let them get away with it.

After the demonstration at the DOC, the activists walked over to the Capitol building to deliver the daily peanut butter and jelly sandwich to the Governor.

#### **MAP Director Expresses Concern Over Dangerous AIDS Fears**

[Milwaukee]- "The recent hysteria that Milwaukee has experienced on HIV testing for health care workers and for patients is a major setback in the long struggle to achieve enlightened management of the AIDS epidemic," said Doug Nelson, Executive Director of the Milwaukee AIDS Project (MAP).

We only make progress against AIDS with very small steps over long periods of Nelson added. disheartening to be pushed back by several steps as a result of the gross over-reaction of health care leaders, politicians, and the news media to the singular case of a physician with AIDS in

our community."

In an exclusive interview with Wisconsin Light, Nelson referred to the recent announcement that Dr. Robert Marek, a dermatologist practicing at he Medical Associates Clinic at Menomonee Falls, a Milwaukee suburban community, has AIDS and has ceased medical practice. The announcement included information that the Clinic informed 6,000 of Dr. Marek's patients via a special letter that Dr. Marek was diagnosed with AIDS, but that his patients were not at risk for transmission of HIV.

"The news of Dr. Marek was the lead story in the media for two days running and calls to the Wisconsin AIDS Line at MAP increased ten-fold as a result of very concerned patients," Nelson Nelson reported. "The community response bordered on the hysterical and the result has been decreased public confidence in the health care system and heightened public fear about AIDS."

"Our health care leaders failed to lead and permitted business considerations political judgments to cloud fundamental scientific facts about HIV transmission that the public needs and has a right to know," Nelson said.
"The disastrous result of this failure of

health care leadership is the politicalization of the HIV testing issue. When confusion is communicated from the health care establishment, politicians will react with alarm and policies are promoted that are reactionary and without a basis in scientific fact," Nelson continued.

Nelson said that the initiative by Sen. Jesse Helms (R-NC) calling for prison terms for HIV infected dentists and surgeons is an outrageous throwback to long-gone eras of quarantine and is demagoguery in its worst form on the health issues of AIDS.

Nelson said that he was "immensely disappointed" that both Wisconsin Senators Kasten and Kohl voted for the Helms bill.

"AIDS policy is Wisconsin is among the most enlightened in the country and we have worked hard to achieve that reputation," Nelson emphasized."All of us who care deeply about the AIDS epidemic are entitled to be outraged that both our senators from this progressive state have identified themselves with the most reactionary and destructive national forces that are thwarting the nation's effective response to the AIDS epidemic," Nelson said.

Nelson said that the failure of health leadership and political care demagoguery have created a public hysteria on the crucial of HIV testing.

'The reality is that there is virtually no risk that a patient can be infected with HIV from a health care provider delivering health care services. The hallmark of the American health care system is the use of the highest standards of infection control that guarantees to the public that in any health care setting patients are protected from infectious disease including HIV,'

Nelson said. These infection control procedures were upgraded and universally implemented 10 years ago when the AIDS epidemic began. Since that time there has not been one documented case of a

surgeon transmitting HIV to a patient during the course of a health care procedure. In New York and California where well over half of all AIDS cases originate and where the epidemic has raged the longest, health care professionals have relied exclusively on the highest standard infection control to protect the public. There has not been any need for either routine or mandatory testing of health care workers and patients.

Nelson said that there is far greater risk to patients from physicians or dentists who are alcohol or drug- impaired, who are sleep deprived due to absurd requirements, who are psychologically distressed, and who are fundamentally incompetent.

'To require a health care provider to have an HIV test in order to deliver health services is a gross and unwarranted over-reaction to the risk of HIV infection. If such a policy is established, there is even greater need to require breathalyzer tests, drug tests, psycho-analysis, and annual competency testing for all health care workers because the risk of harm to patients from these failings are far, far greater than the risk from HIV infection," Nelson said.

Nelson harshly criticized the concept of routine testing of patients as equally inappropriate and counter- productive. "There is no medical necessity to test all patients for HIV who undergo elective surgery as Waukesha Memorial Hospital is now doing," Nelson said.

"Every hospital must treat every patient as if the patient were HIV infected, and that is the fundamental premise of infection control and universal precaution procedures. Consequently, there is no justification for obtaining an HIV test of a patient when all patients are presumed to be infected," Nelson emphasized.

Nelson said that such testing is an enormous waste of resources that are better spent on delivering care and support for people with AIDS. He estimated that Waukesha Memorial does at least 20,000 elective surgeries each year and that an HIV test at an average cost of \$25 for all surgeries would result in \$500,000 of unnecessary cost to health care consumers.

"In Waukesha one half million dollars will go a long way toward delivering outstanding support services to people with AIDS in that community and in preventing the spread of the epidemic," Nelson emphasized.

'We cannot afford to waste these resources on unnecessary unproductive HIV testing when we don't have enough money to manage the increased pace of the AIDS epidemic in Wisconsin. It is important for the public to know that no one is obligated to consent to an HIV test in order to receive health care services. Wisconsin is fortunate to have its unique law which prohibits all health care providers from discriminating against patients based on their HIV

The hysteria that has surrounded the HIV testing issue in Milwaukee and in other metropolitan areas around the country has been a tragic political diversion from the enormously difficult work of sensitively managing the AIDS epidemic, Nelson explained.

"We have much, too much, work to do in the years ahead to be sidetracked by political issues that divert us from our mission," Nelson emphasized.

Nelson said there were five steps that need to be taken immediately to eliminate the hysteria of recent weeks:

1) Remove the issue of HIV testing from the political arena; 2) Seek the counsel of health care professionals who are highly knowledgeable about HIV disease; 3) Establish HIV testing policies based on scientific fact rather than public fear; 4) Guarantee that the highest standards of infection control are implemented in all health care settings through audit teams if necessary; 5) Reassure the public that the health care setting is safe and offers no risk of HIV

"We can both protect public health and protect the rights of people with HIV and neither interest needs to be sacrificed,' Nelson said.
