Amnesty Int'l. **Adopts Gays As** 'Prisoners of Conscience'

[Washington, DC]- In a historic decision for Gay men and Lesbians worldwide, the human rights group Amnesty International (AI), at its biennial conference in Yokohama, Japan on September 7, voted to adopt people imprisoned for their homosexuality as prisoners of conscience.'

International Gay and Lesbian groups were ecstatic that the 12 year campaign to gain support for homosexuals from the prestigious human rights group had finally reached a successful conclusion.

The Gay and Lesbian Task Force to Change Amnesty International, a worldwide coalition formed this year to pressure the organization, issued the following statement:


"We, as representatives of thousands of Gay men and Lesbians around the world, would like to thank Amnesty International for taking this long-needed step. We offer our deepest thanks to Amnesty sections [chapters] that worked so hard to achieve this victory, especially the USA, Canada, Ireland and Norway. The Task Force has faith that Amnesty will implement this important decision immediately.'

Until now, AI has assisted some imprisoned Gay activists but not those arrested for simply being themselves or those arrested on the basis of sexual conduct. The Yokohama decision represents a radical change in AI policy.

The Yokohama resolution states, in part, that AI "decides to consider for adoption as prisoners of conscience persons who are imprisoned solely because of their homosexuality, including the practice of homosexual acts in private between consenting adults;...instructs the International Executive Committee, in consultation with sections, to draft guidelines regarding AI action on behalf of imprisoned homosexuals, taking into consideration the cultural background of various areas where we have sections and

Eleven ACT UP Members Arrested Protesting Treatment of Inmates

[Madison]- Eleven members of ACT UP chapters from Madison, Milwaukee, Chicago, St. Louis and Minnesota were arrested at the State Department of Corrections on September 9 while protesting the mistreatment of inmates with AIDS and HIV infection in Wisconsin's prisons.

The rally, march and sit-in were called by ACT UP to demand a new investigation into the death of Donald Woods, an HIV-positive inmate who died of asphyxiation while being restrained and gagged with a towel by prison guards at the Waupun Correctional facility one year

"AIDS did not kill Donald Woods," declared Dan Savage of ACT UP/Madison. "The State of Wisconsin killed Donald Woods."

After rallying on the Capitol steps, almost 200 angry activists, shouting "Tommy Thompson, you can't hide/We charge you with homicide!" converged on Republican Governor Tommy Thompson's office. Dozens of towels were thrown at the locked and guarded doors in symbolic protest while some activists, as they have on a daily basis since April, delivered peanut butter and jelly sandwiches to the governor's door.

Wisconsin inmates with HIV/AIDS, like Roger Hillman at Waupun, who are supposed to receive high caloric diets and frequent meals, are currently given just one extra peanut butter and jelly sandwich per day by prison authorities.

After occupying the Capitol rotunda and conducting a die-in, protesters re-enacted the death of Woods and marched to the Department of Corrections building where phalanx of Madison police officers guarded the entrance.

A brief shoving match occurred and, ultimately, eleven activists were arrested on disorderly conduct charges for sitting in front of the doors. Two were charged with resisting arrest.

In January, Royce A Finne, a Special Prosecutor appointed to investigate the death of Donald Woods, exonerated the guards involved, claiming their gagging of Woods "was not an unreasonable precaution against biting or spitting, which the staff reasonably feared would risk their exposure to the HIV virus."

Outraged by the finding, ACT UP has joined the State Public Defender's Office and the American Civil Liberties Union in demanding a new investigation into Woods' death.

Mary E. Waitrovich, First Assistant State Public Defender and former counsel to Woods, demanded a John Doe probe. She called the state's investigation a "whitewash," citing the Special Prosecutor's failure to interview the prison guards who had restrained Woods.

In a strongly worded rebuttal to Finne's report, Waitrovich noted that the guards involved donned full riot gear while subduing Woods - face masks, rubber gloves, heavy boots. They also carried a 6. x 4 foot plastic shield.

Contrary to Finne's findings, Waitrovich concluded: "I believe that the officers placed a towel around Mr. Woods' mouth and thereby caused his death because of an unreasonable, irrational and unwarranted fear of AIDS exposure."

[Madison]- Up to ten thousand people are expected to converge on Madison, Wisconsin, Saturday, October 5 for the city's second major March for Lesbian and Gay Rights and Pride. The March will be the centerpiece of an extended weekend of concerts, workshops and events, most notably, the largest Midwest display of the NAMES Project AIDS Memorial Quilt. (See the many related stories in this issue.)

Madison's Pride Rally begins at 1 p.m. Saturday at the State Street corner of the State Capitol.

Madison City Alderperson Ricardo Gonzales will welcome patricpants to Madison and introduce two distinguished keynote speakers: Urvashi Executive Director of the National Gay and Lesbian Task Force; and Joe Eider, a University of Wisconsin Professor active in Parents and Friends of Lesbians and Gays and in efforts to end discrimination against Lesbians and Gay men in the Reserve Officer Training Corps.

The March will step off at 1:30 p.m.,

proceed down State Street to Lake Street, then up Langdon to James Madison Park. Participants are encouraged to bring signs, banners and boom boxes tuned to 89.9FM. Madison's listener-sponsored community radio will

be playing march music.

Following the March, there will be a Celebration in James Madison Park from 2:30 p.m. to 5:00 p.m. The Celebration will include food booths, information tables, speakers and entertainment. Featured performers are: On the Verge, the popular Madison women's folk/rock band; and Jan Wheaton, jazz vocalist with the Harris Lemberg Trio. MC for the afternoon Celebration will be popular Madison comic Linda Finn. It is also expected that some "surprise guests" (including a certain Gay male quintet and a nationally-known comedienne) might just show up for cameo appearances.

Jan Wheaton is one of Madison's long-time favorite song stylists, although she performs infrequently since her job as Associate Athletic Director of Academic and Student Support at the UW-Madison keeps her busy. She has sung at jazz clubs in Kansas City and New York, as well as in most of Madison's clubs over the past 25 years. (She will be performing at the Lake Monona Pub on September 27 with the Stan Godfrieaux Trio.) Jan has a recent album Small World. Isn't It.

Candidates for elective office, David Clarenbach and Tammy Baldwin, will speak at the Celebration. Rep. Clarenbach, who is celebrating his 20th year in politics, is a long-time sponsor of legislation protecting the rights of Lesbians and Gays. Clarenbach is preparing a campaign for the U.S. Congress. Tammy Baldwin is an openly-Lesbian County Supervisor who is planning a run for the State Assembly. If elected, she would be the highest openly-Lesbian/Gay elected official in Wisconsin.

The Rally and Celebration will be interpreted for the deaf.

In addition to justice in the Woods case, protesters called for the compassionate release of prisoners with AIDS and full implementation of recommendations by the National AIDS Commission and Gov. Thompson's Advisory Committee on the

treatment of HIV/AIDS in the prison

In May, 1990, Thompson's Committee issued 34 recommendations for the treatment of inmates with HIV/AIDS. They include: distribution of condoms, bleach and clean needles; ongoing education programs for both inmates and staff; strict confidentiality of HIV status; medical personnel trained in HIV caregiving; and an end to segregation and work restrictions for inmates with

Compelling Tales of Police Abuse Dominate Commission Hearing

[Milwaukee]- "If a society's police do not adhere to the rules, we can easily and quickly move from a free society, a democratic society, to a police state. And I submit to you that today, right here in Milwaukee, for some people in certain parts of the city, a police state exists.' That was the stark conclusion of Kitty

Barber, of the Lesbian Alliance of Metro Milwaukee, as she gave test Mayor John Norquist's Blue Ribbon Commission on police- community relations at the United Community Center September 17.

The Commission was established in the wake of allegations of police negligence in the Jeffrey Dahmer serial murder case.

Litany of Abuse

Speaker after speaker presented compelling testimony about police harassment and abuse of Gays and Lesbians and of arbitrary and inconsistent enforcement of the law by the Milwaukee Police Department (MPD). Some of these charges came from police officers

Mary Thoreson was pulled over by Milwaukee police officers on Locust Street

"I was yanked out of my car and slammed up against the side of it. I was thoroughly searched by two male officers. They both roughly handled my breasts and one grabbed my crotch and told me, while laughing, that I wasn't a boy but a

'fucking dyke.' The police, who were looking for a boy in a stolen vehicle, let her go.

In January of this year, Thoreson was the victim of a Gay bashing. Though she reported it to police, she never heard

anything afterward.
Said Thoreson: "The police are paid to protect and serve all of us no matter who or what we are. As a resident of Milwaukee, I demand equal protection and service now.'

Scott Gunkel reported that after leaving Club 219 on S. Second Street one night in 1989, he and his friends heard officers in a squad car, using their vehicle microphone, yell out: "Hickory-dickory dock, some young blond is sucking my cock" and "You're all sick fucking faggots!" The slurs were made while the police held their high- powered spotlight on the victims.

Gunkel filed a formal complaint and was given the run-around for 13 months. When he inquired about the status of the complaint at the Second District, he says police there tried to "intimidate him, making him repeat the epithets out loud. Ultimately, the officer involved received a

Evidence by many who testified suggests that shining police spotlights is a common tactic of harassment. One woman reported that while leaving a Gay bar one night, she was greeted by a "blinding light" as she emerged from the door. Ironically, she had been attending a seminar on crime prevention led by a Milwaukee police sergeant who remained in the bar. She wondered what his reaction might have been had he emerged to find himself in the spotlight.

Dennis Bunch was arrested in 1989 and, shortly after being placed in a holding cell, was asked by the inmate across the hall whether he had AIDS. Bunch asked why, and the other man told him an officer had placed a card on his cell

'Great American' To Be Discharged [Seattle, WA]- A National Guard Colonel, a Vietnam veteran and Bronze Star recipient

[Seattle, WA]- A National Guard Colonel, a Vietnam veteran and Bronze Star recipient with 26 years of military service, who was called "one of the great Americans" by her superiors, is about to be drummed out of the Army because she is a Lesbian.

Col. Margarethe Cammermeyer, 49, honestly revealed her sexual preference during a top secret military clearance investigation in 1989. The officer, who has a doctorate in nursing, was a candidate for chief nurse of all US National Guard units.

In July, Col. Patsy R. Thompson, President of a four member board of Army and National Guard officials, told Cammermeyer: "I truly believe that you are one of the great Americans Margarethe, and I've admired you for a long time and the work you've done and all that you've done for the Army National Guard."

Thompson then announced that because of Cammermeyer's homosexuality, which is contrary to Pentagon regulations, the board recommended that she be given an honarable discharge. Cammermeyer intends to challenge her discharge in federal court.

Virginia Liquor Law Challenged

[Alexandria, VA]- The Washington Blade reports that a Gay bar called the French Quarter Cafe, the Gay alumni association of William and Mary College and a Lesbian activist filed a joint lawsuit challenging a part of Virginia's liquor law that prohibits the selling of drinks to homosexuals. The plaintiffs say the law violates their constitutional rights to free association, due process and equal protection under the law.

The statute calls for the state's Alcohol Beverage Control (ABC) Board to revoke the license of any establishment that serves as a "meeting place or rendezvous" for homosexuals, pimps, prostitutes, drunks, panderers, etc. It also prevents liquor sellers from hiring anyone with the "general reputation" of belonging to any of those categories

A recent visit by officials of the ABC Board to the French Quarter Cafe, frequented by Gays, alerted its owner to a potential crackdown. In 1990, a Ramada Hotel had denied the alumni group's request for banquet facilities, fearing its liquor license could be revoked. And Dale Barnhard was forced to leave an Alexandria bar after she began dancing with her woman companion.

The suit does not seek monetary damages but a resolution of the constitutional issues involved.

Juan Palomo Re-Hired By POST

[Houston, TX]- Following a barrage of protests by Gay activists, Hispanic leaders and the newspaper's own reporters, the Houston Post has re-hired popular columnist Juan R. Palomo as an editorial page columnist and a member of the paper's editorial board.

Palomo was fired in August after talking with other newspapers about how his admission that he is Gay was edited out of one of his columns for the Post. The column focussed on the homophobic backlash surrounding the murder of a local Gay man, and Palomo felt his revelation was appropriate within that context.

A protest scheduled for September 7 turned into a victory party when Palomo revealed he had been offered — and had accepted — the position on the **Post**'s editorial board. Palomo is now one of the few Hispanics and one of the only openly Gay people to serve on the editorial board of a major daily newspaper.

Condom Placed On Helms' Home

[Arlington, VA]- A massive nylon condom, inflated by portable generators, was placed over the two story South Arlington residence of Sen. Jesse Helms (R-NC) by members of ACT UP/New York September 5. A slogan on the giant condom said: "A condom to stop unsafe politics. Helms is deadlier than a virus."

The Washington Blade reports that as Arlington County police officers arrived at the scene, they all broke into laughter. Neighbors soon gathered, and reporters and cameras captured the comical scene.

After about an hour, police ordered the ACT UPers, who were accompanied by legal counsel, to remove the condom. They complied and no arrests were made. The protest called attention to Helms' continuing opposition to AIDS education, funding and research.

Polls Removed From Gay Center

[Dallas, TX]- Dallas County Commissioners recently voted 4-1 to discontinue the use of the Dallas Gay and Lesbian Community Center as an official polling place. They took the action after a Republican official complained that some people might be uncomfortable about voting there.

John Thomas, the Center's executive director, told the **Advocate**: "We are a good neighbor. We have a good location and access to parking. There are other polling places in Dallas in Jewish and Hispanic community centers. Ours should be treated no differently."

The Gay and Lesbian Community Center was chosen as a polling place in 1990 because it is in the center of the precinct. Voter turnout had increased from 41% in the 1986 election at the previous location to more than 60% in the 1990 election.

"The Community Center has everything going for it as a polling place," precinct judge Brian Drummond told the **Advocate**. "If rational minds were working here, there would be no question that it is where the county's polling place would stay."

The City of Dallas will continue to utilize the Center as a municipal polling place.

Dannemeyer: 'Gay Conspiracy'

[Los Angeles, CA]- In a recent interview with the Los Angeles Times, Rep. William Dannemeyer (R-CA) claimed that there is a conspiracy in both the government and the media to "advance homosexuality as a civil right."

Dannemeyer defended his opposition to a proposed teen sex survey to be conducted by the Department of Health and Human Services. He charged that a small "cell" within that department was working to advance a "homosexual agenda."

"I believe there is a clear agenda on the part of the homosexual community to develop statistical data they can then twist to their own conclusions to justify perversion in American sexual practices."

He attacked television for incorporating themes of "homosexuality tolerance and promotion" and said that because Gays have no children, they spend their extra money on political activism, giving them disproportionate power.

Dannemeyer is seeking the Republican nomination for the US Senate seat in California which is currently held by moderate Republican John Seymour.

Quickies...

[Trenton, NJ]- The Washington Blade reports that New Jersey Gov. Jim Florio (D) signed an executive order in August which prohibits discrimination based on sexual orientation in all state employment, services and benefits. Florio succeeded Republican Gov. Thomas Kean, who was perceived by many as anti- Gay.

[Cambridge, MA]- After two years of discussions with its workers, the Lotus Development Corporation has adopted a policy granting the same benefits to the unmarried and same sex partners of its employees that it offers to the spouses of its married employees. "Fundamentally, we believe it's fair and equitable," said Lotus executive Russ Campanello.

[New York, NY]- Saying that "not a shred of hard evidence" supports the ban, the New York Times, in a September 1 editorial, called for the Department of Defense to end its prohibition on Gay and Lesbian soldiers.

Ten Percent Society Plays Games With UW Board of Regents

[Madison]- True to its much publicized threat, the Ten Percent Society on September 6 disrupted a meeting of the University of Wisconsin Board of Regents over the regents' failure to take action against the discriminatory Reserve Officers Training Corps (ROTC) on campus

"We are tired of being ignored. You're playing games with us, now we're playing games with you. Let the games begin!" shouted Andrew Miller as 25-30 protesters played Twister, threw streamers and silly string and generally partied in the room in Van Hise Hall set aside for the regents' meeting.

The regents recessed for half an hour before resuming their meeting.

The protest was called to demand more aggressive action by the regents against the ROTC program which, in accordance with Pentagon policy, does not commission openly Gay or Lesbian officers. The UW student association, the Faculty Senate and the Board of Regents have all condemned ROTC, and the UW system has a clear non-discrimination

policy in regard to sexual orientation. But ROTC remains on campus.

Ten Percent Society Co-Presidents Michael Dixon and Tracy Prouty said that in a meeting with UW Chancellor Donna Shalala and other administrators the day before the protest, Shalala urged the protesters to focus their attention on the national level, toward Congress and the Department of Defense.

Prouty told the Badger Herald it was an ironic suggestions in that "Shalala has been known to say that the UW is a bottom up university" but we are told that they will only work from the top down."

Shalala has cited the loss of \$1.6 million in federal funding and the UW's status as a land grant institution as reasons for not terminating the ROTC program immediately.

Dixon declared that the Ten Percent Society planned to keep up the pressure on the regents. He suggested that disrupting ROTC classes or "outing" prominent UW officials could be tactics used in the future.

Hepatitis A Infections On Rise In Gay Community Nationwide

[Madison]- The Madison Department of Public Health in a recent press release, reports that Hepatitis A infections are on the rise nationwide and that the Gay community has been hit particularly hard.

Hepatitis A is a virus that causes illness lasting one to two weeks, with often an even longer recovery period. Adults may develop some or all of the following symptoms:

Fatigue, nausea, fever, vomiting, diarrhea, jaundice (yellowed skin and eyes), dark urine and abdominal pain.

The Hepatitis A virus (HAV) is spread in the stool (bowel movement, scat) of the infected person, usually before he or she knows they are sick. (Do not confuse HAV with Hepatitis B, which is spread by blood and body fluids.) Any contact with infected stool will spread the virus.

Usually handwashing is good protection against HAV. However, people who are members of the household or sex partners of an infected person are at greater risk of becoming infected with HAV. People who have become infected with HAV are able to spread it to others unknowingly during the week or two before they themselves become sick.

Gay men, the Department says, may be more vulnerable or at risk for this infection, if they practice anal sex without the use of condoms and handwashing, or if other safer sex practices involve anal contact.

Anal sex is risky, even with handwashing, as there may be enough stool on the outside of the condom to spread HAV. The amount of stool present is not necessarily visible.

Sex toys can spread the disease as well. They should be washed thoroughly, preferably with a 1:10 bleach solution, and dried after use.

Rimming is a very risky activity that is almost certain to spread HAV from an infected person to others, the Department said.

The Department noted in its press release that people who are immunocompromised (HIV infected) can be at risk for a much more serious illness when infected with HAV. People whose liver is damaged already, due to excessive use or abuse of alcohol or drugs, will likely become more ill, and can develop liver failure and death.

If you have been exposed, contact your local health department. The department can provide you with Immune Globulin (IG), an injection which provides temporary protection against HAV if given within two weeks of exposure. In Milwaukee the number to call is: 278-3180. In Madison: 266-4821.

OR check with your doctor if you suspect you have symptoms of the disease. In any case, **stop** handling food (or bartending), or providing child care or health care.

Something rotten on Capitol Hill

Why are HRCF and NGLTF fighting Queer Nation, not the opposition?

In February of 1987, at one of the largest gatherings of committed Gay rights activists in American history, the "war conference" which famous preceded the last mammoth March on Washington for Lesbian and Gay rights, delegates endorsed sticking pink triangles on the doors of legislative offices whose occupants opposed Gay and Lesbian rights during the day while enjoying by night time benefits of the Gay community. That's when "outing" got a national mandate.

Subsequently, both the Human Rights Campaign Fund (HRCF) the the National Gay and Lesbian Task Force (NGLTF), our stodgiest rights groups, took stands opposing outing as if the war conference had never happened.

That's sad. Particularly now that Queer Nation groups throughout the country and abroad have commenced outing legislators and government officials with impressive successes.

During the recent outing of Congressman Steve Gunderson (R) from Wisconsin, HRCF put itself in a particularly dishonorable position. While Queer Nation types were using data about Gunderson's record supplied by HRCF itself to attack his record, HRCF officials Eric Rosenthal and Greg King vigorously denied knowledge of their own data and custom designed a report card for Gunderson on which they gave him a 100% rating.

In order to construct this report card, Rosenthal and King had to overlook the fact that Gunderson is not a sponsor of the Lesbian and Gay rights bill; overlook ten consecutive votes against abortion rights in the last Congress; overlook 24 bad votes out of 25 on feminist issues in the last Congress; overlook bad votes on some of its own issues in the last Congress and only calculate 10 selected votes; overlook bad votes on every civil rights bill yet to be presented to Congress during his tenure; overlook support for Supereme Court nominees Bork and Souter and, finally, overlook his June vote against the 1991 Civil Rights Act. This week they are probably overlooking Gunderson's vote against a motion to conduct a national survey of teenagers and sex as a tool for fighting AIDS.

HRCF justifies its defense of Gunderson, characterizing him as "a moderate Republican." He does not look at all moderate on the battery of issues most likely to concern the Lesbian and Gay communities as I see them. For HRCF to score him 100% when the National Women's Political Caucus scores him 4% insults one of our closest allies. To protect a politician who consistently votes against civil rights is sheer folly.

It seems abundantly clear that HRCF and NGLTF need to come up with more complete report cards for Congressmembers. Queer Nation types are on the right track.

HRCF and NGLTF also need to take a stand of neutrality rather than opposition to outing. They should take the same neutrality on all battles undertaken by hard-hitting activists. There's plenty of room in queer activism for both tough guys and nice guys, as long as we stop fighting each other. It's the so-called nice guys who err most frequently on this

When one looks at the infighting among Gay activists on Capitol Hill, one senses quickly that there's something rotten in Denmark. I think the rot is on the side of HRCF, not Queer Nation and not ACT UP.

Once again, protests by the students aimed at disrupting some arm or another of [UW-Madison] Administration proceedings, have brought up the controversy concerning the way that UW should address ROTC discrimination against bi and homosexual people. Again it has proven to be a disagreement on how to agree and no one side of it is proceeding, I would submit, in an entirely rational or efficient way. I think a much more productive situation could exist if each side would give a little understanding and some redirected efforts

toward a common effort to solve the problem.

More specifically, I think that the 10%
Society's share of the fault comes from refusing to contemplate the possibility that Donna Shalala and her administration are sincerely working on a potentially effective way to end ROTC discrimination based on sexual orientation. If the 10% Society has any good reason to believe that Shalala is not working on an effective plan, they have never made these

reasons clear to the public.

It has been taken as an axiom that because she does not accept their approach, that any approach by her is a cover-up, or at least a very bad plan doomed to failure.

In the spirit of honest inquiry, I challenge the 10% Society to make clear to the general

population of this campus why they feel that their approach is better. I challenge them to cease being as dogmatic as they have portrayed the administration to be. With even Dick Cheney questioning the Pentagon's policy towards alternative sexualities, the idea of Federal level changes seems to be, all else equal, a likely goal to work for.

This does not make Donna Shalala or the

administration by any means free of fault. One reason that a person could come to share the 10% Society's suspicions is the lack of communication about two important questions concerning the administration's efforts to

Why we should believe that effective actions are being taken, and what the general student body and public could do to assist in those

I challenge Donna Shalala and the administration to make much clearer to the general population what they are doing and how we could participate. These question have all along been as vague as the 10% Society's

specific reasons for preferring to expel ROTC.

If the administration sees fit to respond to this challenge, I would be very interested in the 10% Society making clear what faults they might see in the administration's plans — when, at last, everyone is informed.

Parents will no longer be able to blame their LesGay children for their lifestyle. The parents, in turn, will be freed of guilt for "causing" their children's homosexuality and free them to love their children the way they were created.

Yet we should not and cannot put too much hope in scientific discoveries that point to the etiology of homosexuality being biological. People of good will may more readily accept us,

but all the scientific evidence in the world will not change the attitudes of the bigots.

Mainline churches will — with shameful hypocrisy that parades as compassion — continue to teach that it is okay to be LesGay; after all, it is genetically determined. But it will still be a sin to express those feelings in even the most committed and loving of relationships.

This, lest we endanger our chances of spending eternity with the God who created us LesGay people. Curiously this God has chosen only our community to live under enforced celibacy so that our eternal souls be not tainted and the joys of heaven (albeit in Christian teaching a celibate one) be denied us. Naturally, the Fundamentalists and other

flagrant homophobes will continue their

prejudices. No, while the newest scientific information may be helpful to some, it really will not make a difference in our world. The hatred will

In our life times, at least, we will still need to have LESGAY PRIDE parades and rallies. We will still need to defend our rights to love and live. We will still need to insist to some churches that our most sacred commitments of love and faithfulness to a partner of our sex receives God's blessing on equal footing with heterosexual relationships.

But for most of us, nothing has really

changed, because we knew long ago that as surely as God made Adam and Eve, God did make Adam and Steve and Eve and Amy too!

Milwaukee School Board To Hear Resolution on Gay/Lesbian Teens

[Milwaukee]- Lesbian/Gay teens in the Milwaukee Public Schools have a right to a quality education in a safe and nurturing environment.

This is only one of the conclusions reached by a Committee formed four months ago to study issues concerning Gay and Lesbian teens in the Milwaukee Public School (MPS) system. The recommendations, in the form of a resolution, will be presented to the Community Relations Committee of the MPS School Board on Wednesday, October 9, 1991 at its 7:00 p.m. meeting.

The Committee's other resolutions are:

* That all young persons have an equal opportunity for quality education regardless of sexual orientation;

That curriculum materials, teaching strategies and school policies which include non-judgmental information on sexual orientation be implemented in the

* That school personnel prohibit any sexually oriented deprecating, harassing and prejudicial statements;

That all administrative personnel, faculty and staff receive training to increase their knowledge of and sensitivity to Lesbian and Gay culture and

* That drop-out prevention strategies targeted towards Gay and Lesbian youth be developed and implemented;

* That community and school-based services and resources be made available to Gay/Lesbian youth.

The 14-member Committee, chaired by Sheryl Gotts, Curriculum Specialist, wascomposed of representatives from the various MPS branches: supportive staff, guidance services, administrative supervisory council and the Milwaukee Teachers' Education Association. Also included were Kathy Herbst, facilitator for a support group of young Lesbians, Michael S. Lisowski, Director of Gay

Youth Milwaukee, and Bernell Howard, a member of Gay Youth Milwaukee.

The Committee was formed after a meeting in April of Herbst, Lisowski, former MPS Superintendent Robert S. and then Peterkin Associate Superintendent Robert C. Jasna (now Deputy Superintendent).

Enactment of the resolutions is considered imperative. According to the report, "Because of isolation and discrimination, Lesbian and Gay students are at greater risk for suicide (two to three times higher than for heterosexual teens), homelessness, rejection by family and peers, sexually transmitted diseases, including HIV disease, and substance

The report goes on to state that, "Given the increased levels of anti-Gay and anti-Lesbian prejudice and the rising tide of verbal and physical abuse against Gay and Lesbian youth and adults," it is critical that MPS act now.

If the resolutions are enacted by the MPS Board, Milwaukee will become the fourth U.S. city to have policies dealing with Lesbian/Gay youth. The others include San Francisco, Los Angeles and New York City.

Friends and supporters are encouraged to attend the School Board's Community Relations Committee meeting on Wednesday, October 9 to speak on behalf of the resolution. The meeting will be held at the MPS Administration Building, 5225 W. Vliet Street beginning at 7:00 p.m. This meeting will be the only time that the public will be allowed to speak on this issue.

If approved, the resolution will then be placed on the agenda before the entire nine-member School Board for discussion and vote on October 30, 1991.

Controversy Rages In Beloit Over Firing At Women's Bookstore

[Beloit, WI]- A controversy has stirred this small south central Wisconsin community over the dismissal of Kathy Moretz, an other-abled woman, from her part- time job as a salesperson with Different World Bookstore, a feminist

bookshop. As a result of her firing, Moretz, on September 18, 1991, filed suit with the state's Equal Rights Division against the bookstore's owner, Judy Post-Woodman, charging discrimination on the basis of

sexual orientation. In August, 1991, Moretz met Laura, a woman who is now her lover. According to Moretz, on August 31, 1991, Laura came to the bookstore wearing black jeans, a leather belt and a T-shirt. Moretz said that after Laura left, Post-Woodman confronted her, telling her she would not get a store car which she was slated to receive, if Laura appeared in the store again. According to Moretz, Post-Woodman also said "If you want the car, you have to leave Laura."

After a number of other confrontations, on September 9, 1991, Moretz said that Post- Woodman called the relationship between Moretz and Laura "a sick relationship" and ordered her, on pain of losing her job, to cease the relationship. Moretz refused, she said, and walked out. Post-Woodman, speaking to the

Wisconsin Light by phone, denied that this happened and further denied allegations of being anti-Lesbian. "It's all a smoke screen," she said. "It's all politics.

The bookstore owner went on to say that from the beginning, she has had an 'extensive' Lesbian book section in Different World and that she was attacked and picketed by religious fundamentalists because of it. She resisted the attacks and kept the section.

Post-Woodman called the whole incident involving Moretz "real sad," and said that this is "not the first time I have been attacked by Lesbians" despite having a Lesbian book section and hosting a Lesbian support group in the store. Referring to the support group, Post-Woodman said that Moretz had 'pulled it out' of the store.

Post-Woodman went on to say that Moretz "doesn't have a leg to stand

The affair has received a great deal of attention by the local media. Rockford, Illinois TV Channel 23 as well as the print media have devoted time to the story.



NGLTF Director Urvashi Vaid: Dynamic Speaker and Organizer

[Madison]- Urvashi Vaid, the Executive Director of the National Gay and Lesbian Task Force (NGLTF) and the first woman of color to run a major national Lesbian and Gay organization, will provide the keynote address at GALVAnize's pre-March rally at the state capitol, 1:00 p.m. on October 5, 1991.

"She's an incredibly dynamic and inspiring speaker," said a Madison man who heard her keynote at last June's Chicago Pride March. A Madison woman, who heard her speech at the National Lesbian Conference in Atlanta, said, "I'd

follow her anywhere.

Vaid was born in New Delhi, India and grew up in upstate New York. She has a law degree from Northwestern University. She is a long-time feminist activist and community organizer whose involvement in the feminist and Gay/Lesbian movements spans more than a decade. She has worked for prisoner's rights around the issue of AIDS. In the women's community, she has worked with a variety of grassroots organizations dealing with violence against women.



Vaid was also involved with Roadwork, multi-racial women's cultural foundation based in Washington, D.C. Roadwork produced the Sisterfire urban festival of women's music and culture and serves as booking agent for Sweet Honey in the Rock.

NGLTF, with headquarters in Washington, D.C., is the oldest national Gay and Lesbian civil rights advocacy organization. Its political work is divided into three primary areas: lobbying, education and grassroots organizing. NGLTF has been extending its lobbying and membership development efforts in the Midwest. Vaid and other members of the organization will be at an information table in James Madison Park at the Celebration following the March on October 5th.

In an interview in Democratic Left earlier this year, Vaid described NGLTF as a unique institution in the Gay and Lesbian political movement because it's the one with the broadest vision.

"We exist to do two things," said Vaid, "to eliminate prejudice and discrimination based on sexual orientation, and to build a movement for social change. As part of our mission statement, we have a commitment to ending racism, sexism and other systems of oppression.'

the Lesbian/Gay Noting community itself is not immune from sexism and racism, Vaid described the problems faced by women and people of color in their fight for Lesbian and Gay

"The Gay community is in fact not a community, but a series of communities united by the experience of oppression because of our sexual orientation. We are African-American people, Latino/Latina people, Asian Americans, Pacific Islanders, Native Americans, white, men, women; we are sexual minorities within our own community, the leather community, the S&M community, the transvestite community.'

'Sometimes it's a miracle that we actually coalesce as a movement," said Vaid, "but we are engaged in developing a diverse politics, a politics that respects difference and allows us to work together. The institutions of our community are changing because women and people of color are rising to positions of power in those institutions.

'It's a part of a process of broadening the mission of NGLTF...We are becoming a movement for liberation--for broad

progressive change.'

2. During Saturday morning workshops from 10:00 a.m. to noon, plans are to offer childcare at the UW Memorial Union. Let us know if you need this service.

3.Free childcare will be available during all Sunday events. We hope that you will be able to bring your children along to the Rally, March and Celebration in James Madison Park on Saturday. Childcare or reimbursement will NOT be provided for events sponsored by other organizations such as the Saturday night

Sunday's childcare will begin at 10:00 a.m. and end at 4:30 p.m. It will be located in the "3 Wishes" Child Care Center facilities in the University United Methodist Church at 1127 University Avenue, which is convenient to both the CHAS/Brooks Street Y Brunch location, the UW Memorial Union where the workshops and videos will be held, and probably the Ecumenical Service site.

It will be directed by professional childcare providers, two women who formerly operated the Magic Penny and now do in-home child care, along with enough staff for approximately 40 children. 
P1 The McCormick ramp is midway between the two Saturday afternoon events. It does NOT have an elevator or DIS/VET spots.



Politician, Comedian Ammiano To Speak, Entertain for Pride

[Madison]- Tom Ammiano, an openly Gay teacher, member of the San Francisco School Board and stand-up comedian, will perform at "A GAYLA Affair," Friday night, October 4, 1991, at 8:00 p.m. in the Great Hall of the UW Memorial Union.

Educator Ammiano will also lead a workshop entitled, "Gay and Lesbian Issues in the Public School Arena," on Saturday, October 5th at 10:00 a.m. in the

UW Memorial Union.

It goes without saying that Ammiano is a man of many interests. One minute he can engage in a serious discussion about the need to open up the educational process to people of color and kids with special needs, and the next, he'll have you on the floor with a comedy routine that brings together two of his favorite subjects: growing up in Catholic schools and the unique Gay culture of the city by

'Not everyone knows this, but San Francisco has a patron saint--Saint Francis A Sissy," Ammiano explains. "His miracle was changing breakfast into

Ammiano, 48, grew up in New Jersey and first came to San Francisco in the late '60's. As he began his career as a special education teacher in 1969, he faced his first confrontation with the system when he realized that many of his students were monolingual Spanish speakers who didn't belong in a class for developmentally disabled kids.

After coming out in 1975, he joined the Bay Area Gay Liberation Movement and picketed the School Board to get information about sexual orientation added to the curriculum. About this time, he became close to Gay Supervisor

Harvey Milk. (Ammiano's recollections of that time figure prominently in the award-winning documentary, The Life and Times of Harvey Milk.

In the early 1980's, Ammiano's career as an openly Gay stand-up comedian began to take off. He worked the open mike circuit both for Lesbian/Gay crowds and for the tougher mixed audiences. As a Hawai'ian reviewer noted, "He's a quick-witted performer. His rapid-fire delivery and irreverence in everything from religion and politics to ethnic background to straight and Gay lifestyles have earned him wild praise.'

He's not someone known for holding back with a deserving target. As a San Francisco Examiner critic quipped, 'Ammiano's very fair. He tears

everybody to shreds.

In the late 1980's, Ammiano's fame became national as he began appearing throughout the country, including at numerous benefits for AIDS-related organizations. And, he became "immortalized" thanks to the popular 1987 PBS documentary, "The History of English," which featured an Ammiano monologue about the expressions that are unique to the Gay dialect.

After he was blown out of the water in his first try at the school board, Ammiano's stand-up act had included a routine about how it feels to be rejected by tens of thousands of people at the same time. Those jokes ended in November, 1990, when Ammiano won election to the San Francisco school board with the largest majority of any candidate.



Milwaukee Pride Committee To Reorganize and Move Forward

"The Pride Committee lives!" declared Gary Wells, President of the Milwankee Lesbian/Gay Committee (MLGPC), after an emergency meeting September 18 to decide the future course of the troubled organization.

Burdened by a \$9,000 debt and a continuing lack of representation by women as mandated in its by-laws, Committee members defeated a proposal to dissolve the MLGPC and declare

Members voted instead to suspend the by-laws, which were viewed by some as impediments to progress, and, essentially, start from scratch.

Wells told the Light that the Committee's immediate and primary concerns were finances and structure. "We need to raise money, and we need to develop a credible budget for 1992. We need to formulate an organization less cumbersome to manage, streamline it, and make it more business like and effective.

"People are still committed to the ideals of the organization," said Wells, "and since we have wiped the slate clean, this is the perfect time for input and ideas from the community to make the Committee a more representative and responsive group.'

To that end, the Pride Committee has scheduled a special meeting for Tuesday, October 15 at 7 p.m. to hear both complaints and suggestions from the community about how the Committee should proceed. For the location of that meeting, call (414)32-PRIDE. Everyone is invited and encouraged to become involved.

The emergency meeting of MLGPC had been called in the wake of its annual meeting on September 10, which drew only five people beside the Committee's officers. Elections scheduled to be held that night were postponed because of the lack of women present. Heated debate about the future of the Pride Committee at that time led to the September 18 meeting.

(Editor's Note: Full coverage of all sides in the controversy was impossible as the Light was in production the evening of the 18th. We will follow up with additional coverage.)

In a related story, at a meeting September 8, the Pride Committee voted to cancel the Flirtations Concert that had been scheduled for September 19.

According to Dennis Bunch, MLGPC Vice President, there were two reasons for the cancellation. One was the low ticket sales. Bunch cited the "lack of community desire for the event." He added that MLGPC did not get its promotional material out on time, and apologized to those people who had looked forward to the event.

Inaction of Police, Mayor, Media **Focus of Queer Nation Protest**

[Milwaukee]- Queer Nation (QN) Milwaukee is calling for a national demonstration to take place in Milwaukee on Monday, October 7, 1991. According to QN- Milwaukee spokespeople, the demonstration is motivated by "the action and inaction of the Milwaukee Police Department, Milwaukee Mayor John Norquist and the media" regarding the "horrific" crimes of Jeffery Dahmer.

The demonstration will begin at 11:00 a.m. at Milwaukee's City Hall (Water and Wells Streets). Speakers from various communities have been planned. According to Tim Grair, a QN-Milwaukee spokesperson, one of the speakers is anti-violence activist, Queen Hyler. Others have yet to be announced.

The demonstration will conclude at the Police Administration Building at 7th and State Streets.

In a press release, QN-Milwaukee said that they found it "unacceptable" for the Milwaukee Police Department to be "more concerned about the suspension of officers under investigation" than for the "safety of People of Color, Womyn and Gays." It is unacceptable for Womyn and minorities to be "given less police protection than straight white males."

QN-Milwaukee also object strongly to the establishment of "a Blue Ribbon panel without community input. It is unacceptable for the Mayor to ignore the Lesbian & Gay community both at our functions and his own," the release said.

QN-Milwaukee went on to say that they objected strongly to the "blind use" by the media of phrases like "homosexual overkill" in what QN called "a blatant disregard of journalistic responsibility.

QN- Milwaukee added that they found it "unacceptable that uninformed ravers are allowed to spread hatred and homophobia through the press and over the public's airwaves.

Dahmer Pleads 'Not Guilty' And **Arreola Fires Two Officers**

[Milwaukee]- Accused serial murderer Jeffrey L. Dahmer entered pleas of not guilty and not guilty by reason of mental disease or defect to fifteen charges of first degree murder and intentional homicide September 10 in the courtroom of Judge Laurence Gram.

The dual plea means that the trial will take place in two stages: the first to ascertain whether Dahmer committed the crimes, the second to determine whether he was insane at the time of the murders.

The first day of the trial was set for late January, 1991. Dahmer is expected to undergo extensive mental examinations in the next few weeks. His attorney, Gerald Boyle, has time to change or modify the plea, and he implied he might seek a change of venue because of the massive publicity about the case in the Milwaukee area.

On September 7, Milwaukee Police Chief Philip Arreola fired two officers involved in the May 27 incident in which they returned the naked and bleeding Konerak Sinthasomphone back into the custody of Dahmer. Dahmer has admitted to killing the 14-year old shortly after police left. A third officer, a rookie, had his firing suspended pending good behavior over the next year.

'I have concluded that the three officers did not follow basic investigative procedures by failing to obtain the names of any witnesses," said Chief Arreola. "Their memo books contained almost no information pertaining to the investigation.

Arreola said the officers "failed to take an obviously incapacitated child into protective custody as required by department procedure and state law" and ignored the "impassioned pleas" of a citizen, Glenda Cleveland, who called to offer further information about the boy.

The State Attorney General's Office investigated the incident, but found no basis on which to press criminal charges against the officers.


Just days before Chief Arreola fired the officers, the Community for Justice Committee, which includes several aldermen and state representatives, threatened "massive civil disobedience" if such action was not taken. They have now canceled those plans. A demonstration by Nation/Milwaukee to protest both the police negligence and the media coverage of the Dahmer case remains scheduled for October 7

Brad Davis

Brad Davis, who acted on stage, screen and television and who was best known for the film **Midnight Express**, died of complications from AIDS in California on September 8. He was 41.

Davis won a Golden Globe Award for his portrayal of Billy, the hashish smuggler imprisoned in Turkey, in Midnight Express. He also appeared in Chariots of Fire, Querelle and the TV miniseries Robert Kennedy and His Times. On stage, he played Ned Weeks in Larry Kramer's drama about AIDS, The Normal Heart.

In a statement published after his death, Davis attacked the film industry's hypocrisy in dealing with AIDS: "I make my money in an industry that professes to care very much about the fight against AIDS...But in actual fact, if an actor is even rumored to have HIV, he gets no support on an individual basis. He does not work."

Davis said he had lived in fear that "somehow the gossip mill would get hold of me and that would be that: I'd be one more pariah in Hollywood who would never get a job."

Davis is survived by his wife, Susan Bluestein and a daughter.

Dwight E. Jordan

Dwight E. Jordan died September 6, 1991 while inner tubing on a river in Phoenix, Arizona.

Dwight, an amazingly talented and giving man, touched the hearts and minds of many people. While doing what he loved best, entertaining across the United States and Canada, he uplifted and inspired people to reach for and fulfill

groups and countries in which Amnesty International is proposing development."

To implement its decision, the Gay and Lesbian Task Force to Change AI is calling on the group to: devote money and resources to researching and pursuing cases of Gay and Lesbian oppression; initiate a major study documenting Gay and Lesbian oppression throughout the world; organize major publicity campaigns around the issue; and work with existing Gay and Lesbian organizations, like the International Gay and Lesbian Human Rights Commission and the International Lesbian and Gay Association (ILGA).

ILGA said it was "very pleased with the changed position AI has taken with regard to the persecution of Lesbians and Gays... This concludes a worldwide discussion of many years. ILGA hopes that Amnesty will tackle its new task effectively and is prepared to cooperate toward this end."

AI-USA Executive Director Jack Healey hailed the decision and noted that "If it hadn't gone well, a lot of us [in AI-USA] would have resigned."

Activists are eagerly awaiting the new guidelines being developed by Amnesty's Executive Committee. Marj Byler of Al-USA, said the guidelines would teach sections assigned cases of Gay and Lesbian prisoners how to handle local homophobia and how to develop strategies for successful campaigns. (All cases are researched and assigned to different countries by Amnesty's central




Gay and Lesbian activists, in the Task Force coalition and abroad, waged an intensive campaign to change the AI policy. The Task Force launched letter writing campaigns and provided extensive information to AI. Julie Dorf, founder of the International Gay and Lesbian Human Rights Commission, was credited by AI with providing many examples of anti-Gay imprisonments, thus bolstering the case for Gays as prisoners of conscience.

The National Gay and Lesbian Task Force (NGLTF) organized a massive lobbying campaign at Al's annual meeting held in Washington, DC last June, where Urvashi Vaid, NGLTF Executive Director, keynoted the meeting's welcoming event.

"Perhaps one of the most important things we did as Gay and Lesbian activists," said Charlotte Innes of the Task Force coalition, "was sensitize AI and raise its consciousness to a point where it would take a principled position from which it would not budge."











door indicating that he was. Several individuals testified that, as either victims of or witnesses to Gay bashings in the south side Gay bar district, when they sought assistance from the police they were dismissed and even threatened with arrest.

A man named Richard, desperately seeking assistance for a friend in trouble, was told: "Get the hell out of here or we're going to arrest you." Another witness trying to supply information was told: "Shut the fuck up and get out of here or I'll arrest you."

In a chilling episode similar to that of Konerak Sinthasomphone, one woman spoke about her 15 year old brother out biking late one night, who found himself being stalked by a stranger. He was able to flag down a squad car, told the officers of his plight and asked for a ride home. The police not only did not help the boy, but issued \$100 worth of citations to the boy for having no light or license for his

Scott Gunkel, who is a bartender at Club 219, related the story of the now infamous March 28 police raid there in which 35-40 officers in fifteen squad cars and one paddy wagon rousted a total of 40 customers and seven contestants who were participating in a "Hot Buns" contest — an example, he said, of 'excessive force and manpower.'

One contestant's arm was broken by police and officers taped the wrists of a female impersonator to her ankles and left her that way for 20 minutes. She was later thrown into the police holding tank where she was made the subject of ridicule.

Stephanie Hume talked about a friend who was severely injured in a Gay bashing. Hume tried to follow up with police but was stymied when she found that they had written "almost nothing in their books" about it.

The litany of traumatic stories went on for more than two hours. Some of the most damning evidence was submitted by police officers themselves.

Cops Speak Out

One ten year veteran of the MPD wrote an anonymous letter to Wisconsin In Step last year in which he reviewed some of the tactics of harassment apparently used by Milwaukee police.

'Why are officers still allowed to flash floodlights into Gay bars, yet do not subject straight businesses to the same harassment?" he asked.

"I suggest you have someone statistically examine the amount of parking tickets issued with several blocks

of the Gay bars and businesses as opposed to all the other bars in Walker's Point and the Third Ward to see if the parking meters in front of those addresses are enforced more regularly. "I suggest Chief Arreola ask why

officers carrying paperwork with gloved hands are allowed to tell other workers and prisoners that a prisoner is Gay or that he has AIDS...Or why District 2 officers are allowed to park in front of 219 S. Second or in the block of 100 E. National Avenue for the legendary pedestrian violation activity, while not subjecting patrons of the straight bars and restaurants to the same...

"Why do officers write down all the license plates numbers in parking lots of such establishments, obtaining listings and filing them in various illegal files that are still kept, from the Internal Affairs

Division on down?'

harassment is "rampant within the MPD. "At least ten different desks within the Department have signs on them reading: 'Sexual harassment will not be tolerated - it will be graded."

Another officer, a Lesbian, who has since left the Department, wrote: "My eyes were opened my first day of training. My training officer's opening comments were strewn with sexist and anti-Gay remarks. Men who had difficulty with the physical regimen were called 'faggots' or 'fairies.' I was sure that racist remarks weren't far behind. I was right. Even though racist jokes and remarks weren't made in front of cadets of color, they were prevalent in private conversations.

"On the street," she commented, the stereotypical behavior continued. Officers did not hesitate displaying their disgust towards homosexuals. And their prejudice affected their enforcement of the law.

Knowing "I would never be able to reveal my sexual orientation to anyone in the Department for fear of discrimination and harassment," she left the MPD.

The Madison Story

Detective Alix Olson, an openly Lesbian officer with the Madison Police Department, testified that she was "really appalled" at the "horror stories" that were unfolding at the hearing. "It just seems unreal to me that this is going on.'

Olson joined the Madison force ten years ago as an open Lesbian and could recall only one "mild" incident of harassment by fellow officers. She said that of Madison's sworn force of 300 officers, about one sixth of those were openly Gay.

Olson said that she and several other Madison officers had taken upon themselves the task of establishing a police liaison to the Gay and Lesbian community and that the results have been very "beneficial." She recommended that the Milwaukee Department establish

"It shows the Police Department is ready and willing to work with the Gay community. I've heard people say here tonight 'We'll work with you, just don't bash us. We want to work with you. We want to cooperate.' If you're having people in the Gay and Lesbian community saying that to you - that's terrific! Don't lose that! It's really important. Because, as an officer, I know I can't be everywhere. I can't see everything. I need to have people out there helping me out in my investigations. And if they're willing to do that, even after all the crap they've taken, I think you ought to help them get to that point."

Detective Olson urged ongoing sensitivity training. "You need some sort of ongoing training, not only in the academy, but also for people who are already in the Department, because a lot of times they're the ones who are major problems. They've been there forever.

They're like dinosaurs.'

"You may not change all of them, but you're going to get through to some of them. And if you can do that, hopefully, they're going to have an influence on their peers. Among police officers, peer pressure is really strong. Even if one person can say to another officer, 'Hey, you really shouldn't do that,' or 'Hey, don't call them queers,' then you've made a start.

Olson also made a strong pitch for the establishment of a special hate crimes unit to focus specifically on bias motivated crimes. Madison has one detective specializing in that area, but Olson suggested that a city the size of Milwaukee should have an entire unit.

Ron Geiman of Wisconsin In Step, said that "never" in the seven years he had published the magazine had police ever sought him out as a source of information about hate crimes or missing persons in the Gay community. He reinforced the request for a police liaison to the Gay community and said: "The community is here to work with them if they [the police] ever bother to approach us.'

Geiman suggested that police launch sting operations like the one in Houston, in which undercover cops posing as Gay couples were able to arrest many Gay

In reference to the harassment of Gay in particular, Geiman said: "Officers have to be informed that there is a difference between cruising and hustling...there is a distinct difference money does not always change hands.


Geiman, echoing many other speakers, also strongly encouraged the MPD to begin actively recruiting Gay and Lesbian officers: "Gay and Lesbian officers working in the Gay and Lesbian areas are going to get more cooperation from our community. Our people would feel more open with Gay and Lesbian officers."


Margaret Snow of the Police Proposal Task Force of the Milwaukee Lavender Network, a coalition of Gay and Lesbian groups, presented preliminary findings of survey about police performance distributed in the Gay community.

Ninety-five percent of those surveyed said they did not believe the MPD provided the same services to Gay, Lesbian and bisexual people as they did to heterosexuals. Six out of seven people who actually reported a hate crime to the MPD characterized the Department's response to their victimization 'homophobic.'

The Lavender Network Task Force is in the process of drafting a proposal for reforms in the MPD which encompasses many of the suggestions made at the hearing: comprehensive sensitivity training at all levels of police personnel; a liaison to the Gay and Lesbian community; the immediate cessation of racist and homophobic slurs by police officers; and the recruitment of openly Gay and Lesbian officers.

At the end of the lengthy hearing, Blue Ribbon Commission Chair Father Albert DiUlio told the audience that the Commission would be sending its final report and recommendations to the Mayor's Office and the Police and Fire Commission by October 15. It is then up to those institutions to take action on the

ACT UP/Madison and ACT UP/Milwaukee have charged that the Department of Corrections (DOC) has dragged its feet in implementing these recommendations. Since the death of Donald Woods last year and the death of Ricardo Thomas, another prisoner with AIDS, in June, ACT UP has intensified its protests.

During the protest outside the DOC's building, DOC officials released to the press a statement itemizing a list of seventeen of the Governor's recommendations which it claimed have been implemented. Those recommendations deal primarily with counseling and education of inmates on HIV/AIDS and special training and protocols adopted by the prison system's medical staff in dealing with HIV-infected inmates.

The DOC asserted that it would maintain the segregation of HIV/AIDS infected inmates "for medical reasons as well as for the protection of the infected

inmate and others." Records of blood and diseases transmitted through bodily fluids will continue to be collected by staff. In addition, citing unspecified "legitimate medical and security reasons," the DOC opposes the elimination of work restrictions for inmates with HIV/AIDS. The DOC is also on record in opposition to the distribution of condoms and needles.

ACT UP's Dan Savage remained adamant: "We're not going to settle for enactment of 'just about' all of the recommendations or 'almost' all of the recommendations. We want every single one of those recommendations implemented and we want it now!" He promised further agitation on the part of ACT UP to see that the DOC complies with all the recommendations.

Doug Nelson, Executive Director of the Milwaukee AIDS Project, has been appointed to a DOC Committee charged with implementing the Governor's recommendations. He said he felt that the DOC was more flexible today than a year ago, in part, due to the concerted agitation of ACT UP. As to whether the DOC will move on all the recommendations, Nelson said: "The jury is still out."

Judy Greenspan of the A.C.L.U.'s National Prison Project spoke at the September 9 rally and offered a stark assessment of the AIDS epidemic in America's prisons.

"Today, AIDS in prison is a death sentence," said Greenspan. "There is no doubt about it. Everything from substandard medical care to astronomically long sentences to indifference to discrimination to harassment to violence to the criminalization of the epidemic, which has led to attempted murder charges being lodged against persons with AIDS."
"We have an epidemic of fear in the

prisons," said Greenspan, "and the corrections staff and administrators are fostering that fear."

Greenspan noted that the universal demand voiced in similar protests throughout the country was that prison authorities "Treat and educate, not test and segregate."

Many exciting prizes, including a trip to Hawai'i, will be given out to those who bring in the most money at the Walk.


