On September 9, United Way's Executive Committee recommended that funding of the Boy Scouts be continued. However, the final decision is in the hands of the full board.

Spokespeople for Queer Scouts have announced that will be present to greet board members before the meeting. The meeting will be held at 7:30 a.m. at 225 W. Vine Street in the Brewers Hill section of Milwaukee. Queer Scouts invites anyone interested to join them at United Way's parking lot gate at 7:00 a.m.

Queer Scouts say that the gathering will be a peaceful attempt to persuade United Way board members to vote against funding the Boy Scouts.

Prior to the meeting, Queer Scouts will be contacting all of the board members. Board members will receive an informational packet. This will be followed up with a phone call.

Among other things, the packet will include a full explanation of the issues surrounding the current boycott of United Way and statistics on Gay teen suicide.

"We intend to make sure that before the vote, each board member is well-informed," said Dan Fons, a Queer Scouts spokesperson. "We want them all to understand the very real human consequences of a decision to continue funding the Boy Scouts," Fons said. The chair of the United Way board is



Primary Opponents Endorse Baldwin in State Assembly Race

[Madison]- Tammy Baldwin who swept to victory in the Democratic Primary on September 8 has been enthusiastically endorsed by her three Democratic opponents in the race. Billy Feitlinger, Dave Cieslewicz and Ken Strasma, on

September 25, signed a letter endorsing her in the race for the 78th Assembly District.

Feitlinger, Ceislewicz and Strasma cited Baldwin for her "personal and leadership qualities" that she brings to

After praising Baldwin for her stands on reproductive freedom, universal health care and civil rights, they went on to laud her for running as an open Lesbian.

"She would make history," the letter said, "as the first openly Gay or Lesbian member of the Legislature in Wisconsin. The courage she has shown in running honestly on this issue is notable in a time when Gays and Lesbians are being physically, verbally and politically assaulted around this issue."

The three former candidates went on to say that now Baldwin has a tough race before her. They asked that supporters show the "same generosity" toward her now as had been done before.

Milwaukee's Contribution

Milwaukee's Lesbian and Gay community came strongly to Baldwin's aid in the primary. In a fundraiser held in Milwaukee this Summer hosted by the Lesbian Alliance of Metro Milwaukee and many other supporters, donors gave nearly \$4,500 according to Baldwin campaign headquarters.

Baldwin supporters in Madison say that, with the race heating up, your support for Tammy Baldwin must not slacken and is needed now. Feitlinger, Cieslewicz and Strasma noted that the November 3 general election is less than 40 days away. "Please join us in supporting Tammy now!" they wrote.

[San Francisco]- In what many viewed as a surprise move, California Governor Pete Wilson signed a bill into law on September 25 that protects Lesbians and Gays against job discrimination. The measure, AB 2601, bans job- related discrimination based on sexual orientation for virtually all state and private workers.

Wilson's action makes California the seventh state to protect Gays and Lesbians against job discrimination. The others are Wisconsin, Massachusetts, Hawai'i, Connecticut, Vermont and New Jersey.

Like the original bill, AB 2601 exempts businesses with fewer than five employees, churches and other not-for-profit religious organizations. There is some confusion whether teachers and other educational employees are covered or whether the state educational code already protects them.

Wilson, under pressure for Right-wing Christian and political groups, had vetoed a similar bill last year. In addition, Gay-bashing at the recent GOP national convention along with right-wing drives against Lesbian/Gay rights in Oregon, Colorado and Portland, Maine, seemed to have created a poisoned atmosphere. Also, on September 24, the House of Representatives in Washington had gutted a law that would have allowed city workers to obtain health benefits for their partners of whatever sex.

Bill Geiger, Managing Editor of Frontiers magazine in Los Angeles, told Wisconsin Light that people were "completely surprised" by the Governor's action. "We're shocked," he said.

There had been no indication, Geiger said, that Wilson would sign the bill and, in fact, sources had informed Lesbian/Gay leaders that it would be vetoed

As a result, Geiger said, there had been state-wide planning for demonstrations as had happened last year over the Governor's veto.

Asked why Wilson had signed the bill, Geiger said he thought it was an attempt on Wilson's part to "become more moderate." Other observers agreed that the signing was part of a balancing act between the moderate and Right-wing elements in the GOP.

Adverse Reaction

As might be expected, Lou Sheldon of the Traditional Values Coalition blasted the Governor's action. Sheldon was quoted in the New York Times as saying that the bill would "protect sex with animals and the rape of children as forms of political expression."

J. Craig Fong, Director of the West Coast Regional Office of the Lamda Legal Defense and Education Fund, said that Lambda was pleased with Wilson's action, but expressed displeasure at the Governor's veto on September 26 of the Civil Rights Restoration Act of 1992 (AB 3825) which Fong called "a more comprehensive" act.

AB 3825 would have banned job and housing discrimination against not only Gays and Lesbians, but to most, if not all, other victims of discrimination as well.

Fong called AB 3825 "a far more sensible approach to rectifying the civil rights laws of this state."

The signing of one law for Gays and the veto of the broader measure, would, Fong said, "force us to establish an inefficient two-tiered system; one for the majority of California workers and a second for Gays and Lesbians." He went on to call the veto of the Restoration Act "just an example of Republican politics of division, hoping to set group against group by granting protections to some but not to others."

Fong said the passage of the Gay antidiscrimination law on September 25 and the veto of the wider AB 3825 the following day "would have California believe that our communities are claiming so-called special rights."

NATIONAL NEWS BRIEFS

Sodomy Law Held Unconstitutional

[Frankfort, KY]- On September 25, 1992, the Kentucky Supreme Court struck down the state's anti-sodomy law, ruling that privacy rights should apply to homosexuals.

In a 4-3 ruling, the court said the law violated the state's constitutional right to privacy and the right to equal treatment under the law.

"We need not sympathize, agree with or even understand the sexual preference of homosexuals in order to recognize their right to equal treatment before the bar of criminal justice," the court said in an opinion written by Justice Charles Leibson.

Kentucky was one of eight states that had sodomy laws prohibiting sexual acts between persons of the same sex. Sixteen states and the District of Columbia have sodomy laws applying to people of different sexes.

Thompson/Kowalski Need Our Help

[Clearwater, MN]- For Karen Thompson and Sharon Kowalski, the completion of their legal battle means the start of a more private campaign. Legal fees to bring Kowalski home have totaled more than \$220,000, while therapeutic and disability equipment cost another \$41,000. In addition, there is the attendant care that Kowalski will take even more money.

Domestic Partners Benefit Passed

[Cambridge, MA]- Cambridge, Massachusetts became the first municipality in the Commonwealth to extend benefits to the partners of its Gay and Lesbian employees. By a narrow vote, the City Council approved the plan which will be implemented by the end of 1992.

Cambridge, home of Harvard University, joins 18 other municipalities nationwide in supporting domestic partnership benefits for city employees.

Lesbian Billboards Campaign Set

[San Francisco]- In an effort to increase public awareness of Lesbian relationships, the Gay and Lesbian Alliance Against Defamation (GLAAD) will launch an unprecedented billboard campaign challenging the traditional definition of family. The campaign, due to blanket the state of California beginning in late October, highlights a Lesbian couple, one pregnant, with the tag line "Another Traditional Family."

While debate on family values rages, recent research by Overlooked Opinions of Chicago, shows that over 70 percent of Lesbians are in relationships and 52 percent of

Lesbians live with their partners.

By comparison, recent studies in American Demographics show that only 26 percent of Americans actually fit into the standard nuclear family. This reflects a decline from the 44 percent measured in 1960.

More Gay Protections Adopted

[Washington, D.C.]- The Washington Blade reports that Cincinnati, Ohio and Stamford, Connecticut have joined the growing list of US cities that outlaw discrimination based on sexual orientation.

The Cincinnati law, passed by an 8 to 1 vote, covers city employees and services but also prohibits discrimination based on HIV infection, marital status and Appalachian regional origin.

The Stamford law, passed by a 27 to 9 vote, also covers municipal employees and ervices.

Military Ban on Lesbians Challenged

A decorated Minnesota Army National Guard captain has told guard officials that she is a Lesbian, saying she wants to challenge the policy that prohibits homosexuals from serving in the U.S. military.

Capt. Pamela Mindt, 33, a 15-year veteran of the reserves, has received 11 commendation medals during her career. Mindt, who serves with the 204th Medical Battalion headquartered in Cottage Grove, said she decided to challenge the military policy after Col. Margarethe Cammermeyer, the decorated chief nurse of the National Guard, was dismissed in June because she is a Lesbian.

"Something broke inside, and I said, 'I've had it," Mindt said. She decided to become the first such test case in Minnesota.

White House Protesters Arrested

[Washington, D.C.]- Two staff members of the Human Rights Campaign Fund were among the women arrested at the White House during a non-violent civil disobedience on August 26th protesting the Bush Administration and the Republican Party's assault on women's reproductive rights.

The demonstration, highlighting the support of women of color for abortion rights, came on the 72nd anniversary of the Constitutional amendment giving women the right to

The activists were arrested for demonstrating without a permit and were detained for several hours

Among those arrested were Ginny Montes, National Secretary for the National Organization for Women; Jeannette Foret, Young Feminist Activist; and Christine Rice, a Native American Activist. The demonstration was organized by the National Organization for Women, with assistance from the Human Rights Campaign Fund.

A Letter from Pat Robertson

[Virginia Beach, VA]- In a letter written to about 5,000 Iowa members of the Christian Coalition, religious broadcaster Pat Robertson urged them to oppose adopting an equal rights amendment to the Iowa constitution.

Robertson blamed the amendment on "Radical feminists" who, he said, intend to use the amendment to further their "secret agenda" which is "pro-abortion, anti-family, and pro-homosexual rights.

"The feminist agenda," wrote Robertson, "is about a socialist, anti-family political movement that encourages women to leave their husbands, kill their children, practice witchcraft, destroy capitalism, and become Lesbians."

The letter ended with a plea for money.

Advocate Launches New Magazine

[Los Angeles]- The Advocate, the nation's largest and oldest Gay and Lesbian news magazine, has announced that it will begin publishing The Advocate Classifieds, a sexually-oriented editorial and advertising magazine on September 22, 1992.


The Advocate Classifieds will be a noticeably larger and more colorful publication. It will include porn-star gossip, full-frontal nudes, fiction and horoscopes, said J.B. Morris, the magazine's editor.

Senate Candidate Feingold Strongly Supports Rights for Gays

Editor's Note: The following is the transcript of a phone interview with State Senator Russ Feingold who is running for the Senate on the Democratic ticket.


Special to Wisconsin Light

[Milwaukee]- Wisconsin Light: Senator Feingold, congratulations on your victory. Would you, if elected, hire a person for your staff who, all things considered, is openly Lesbian or Gay?

Russ Feingold: I would have no hesitation about that. I already have people on my campaign staff who are openly Gay. That would not be something that would concern me. That would be

WL: If elected, would you consider co-sponsoring the federal Gay rights bill in the Senate?

RF: I suspect that I would co-sponsor

WL: Recently, Massachusetts state employees were granted benefits for same-sex partners. What would be your stand on Domestic Partnership?

RF: Very positive. I think we should adopt that kind of progressive legislation

in the national and state level.

WL: In regards to AIDS funding, would you work for greater AIDS funding?

RF: We've issued a position paper stating our support for additional AIDS funding.

WL: What is your opinion of Magic Johnson's recent resignation from the AIDS Commission?

RF: I think it's good. I think it sends a message to the Commission that popular sports figures and others cannot really do something about the AIDS problem seriously decreasing funding. It's good that he had the courage to do that.

WL: Would you support rescinding the ban against open Lesbians, open Gays serving in the military?

RF: I would support rescinding the ban. I think it's wrong.

WL: Would you also support, again all things being equal, someone who was nominated to the U.S. Supreme Court who

was openly Lesbian or Gay? RF: That would not be in any way a negative factor or factor in my decision. A person's sexual preference has nothing to do with a Supreme Court position. It should be based on their qualifications for

the job. WL: What would your stand be on for Public funding maintaining Broadcasting System considering those who would like to cut or abolish such

RF: I vigorously oppose that (cutting funding). I think PBS is a very important means of communication for the country and that's (opposition to PBS) fueled by the right-wing Senators who I oppose one hundred percent.

WL: I assume your position would be the same on the National Endowment for the Arts (NEA)?

RF: Absolutely. I don't think that any interference or any loyalty oath or any intrusion of government in the arts is

WL: What is your stand on the North Ame ican Free Trade Agreement?

RF: I cannot support the agreement in its present form. It threatens taking Midwestern jobs to Mexico. It also threatens the environment. It would have to be re-negotiated.

WL: What is your stand on Universal

Health Care?

RF: I strongly favor universal health care. In the State Senate, I was the author of a universal health care proposal for Wisconsin which David Clarenbach started in the Assembly. I do believe it should be comprehensive, cover all

Americans, cover the wide scope of concerns, cover long-term care for the elderly and the disabled and of course, people living with AIDS.

WL: Would you support increased federal support for Amtrak, particularly for the Milwaukee-Green Bay and Milwaukee-Madison corridors?

RF: I would love to see greater access to rail transport in Wisconsin. It's really as shame that the country does not have an adequate rail system. I would be willing to see that as part of our efforts to rebuild the country.

WL: What ambitions may you have beyond the Senate?

RF: This is enough hard work and enough intrusion on a person's personal life that if I am able to become a senator, I have no idea whether I would want to run a second time. My top priority is to do a good job for six years. That'll be enough to think about.

WL: What will be your top priorities in the Senate?

RF: A serious plan to eliminate the federal deficit and the enactment of a national health care system.

WL: Could you be specific about elimination of the deficit?

RF: We have an 82 point plan which would eliminate the deficit in five years. It includes about 200 billion of defense cuts, weapons and personnel; about a 100 billion dollars in domestic programs that are wasteful or unnecessary but does not touch social security, 300 billion dollars of higher taxes on very high income people.

We have a very clear plan that does not rely on a balanced budget amendment that would take years to pass or may never get through.

WL: If you are elected and were invited to speak at either the Milwaukee or Madison Gay Pride rallies, would you

accept? RF: Of course.

WL: As Senator, you would accept?

RF: I don't know, why not? Every group in society should have access to their senator.

WL: Is there anything that you would like to say to the Lesbian/Gay community?

RF: I admire the courage of the community in fighting discrimination that is constantly heaped upon it. In particular, I admire the strength and the efforts in the fight against AIDS, fighting the attitude about AIDS. I encourage the community to have even greater enthusiasm for its efforts because it's the only way to defeat discrimination.

[Milwaukee]- Almost 4,500 people raised more than \$404,000 at the 3rd Annual Wisconsin AIDS Walk held Sunday, September 20th, along Milwaukee's lakefront. The goal for the benefit to assist vital AIDS care and education service agencies throughout the state was \$300,000.

Of the contributions pledged, 96 percent had been turned in by the Walk's conclusion. The 'Scream Team' led by Linda Molitor was the Walk's top money raiser. For the second consecutive year, Molitor raised the most money of any walker with over \$5,000 pledged. R. Parrish was also honored for \$3,500 in pledges raised.

Leadership Breakfast

Festivities began at 9:00 a.m. with the Wisconsin AIDS Walk Leadership Breakfast at Professional Marketing Services on the East Side. Paul and Judy Joseph from Walk sponsor WTMJ-TV acted as Masters of Ceremony.



National Coming Out Day Is Celebrated October 11

Editor's Note: October 11 is National Coming Out Day, a time set aside across the country to urge all who are closeted to "come out." We run this article by Demian in celebration of that day.

You have found the person with whom you want to spend the rest of your life. This person is your best friend, your partner in life, your lover, your spouse. A small voice inside tells you, "For pity's sake, now just shut up and don't let anybody know about it." So you stay shut up in the closet.

But, by staying there, what really gets shut up is your honesty and what you lose is your self-respect. Hiding your sexual orientation guarantees a life of lying. That destroys relationships as easily as it undermines individual lives.

Easing Into Outness

Sometimes the act of coming out is so small and natural you hardly think about it, such as the number of times you shop for groceries together. Eventually, the clerks see you as a couple. But you can come out more strongly as well.

For example, you can come out when you jointly apply for memberships, particularly "family" memberships. You can come out when you buy a home together. Note this: unless you say you're a couple, real estate people may show you places that don't suit your needs.

Coming out is critical at times of emergencies. Should your partner be incapacitated by illness or accident, only next of kin would be allowed near. You would have no voice in your partner's medical treatment unless you have

assigned powers of attorney and are willing to be out to medical workers.

If your relationship is made clear to relatives long before your death, they are less likely to tell a court, "Our child must have been demented to will the house to a

financial. Over 20 municipalities and some private businesses now offer domestic partnership benefits. If you're out, your partner could be eligible for medical insurance or other benefits. Such employment benefits can amount to more than \$50,000 during the course of a career.

Legalized marriage for same-sex partners would offer yet more. Out, vocal partners make it impossible for lawmakers to claim their district has no Lesbians or Gay men. We can't expect

Coming Out Voluntarily and Otherwise

National Coming Out Day is October 11 and I hope you're all planning an appropriate celebration.

I've decided to spare you yet another of my own coming out stories (I've got a million). Instead, I'll review the recent forced of Republicans by the Gay press and, more importantly, share the inspiring words of more courageous people who have voluntarily come out.

Surely, all of you have had your yuks by now over the revelation that Phyllis Schlafly's oldest son, John, is Gay. Mother Schlafly, an anti-Red McCarthyite in the 1950s, has since led campaigns against the Equal Rights Amendment, day care, abortion rights, Gay rights, and sex and AIDS education - all in the name of family values, of course. And now the whole world knows she has a homo in her family! My, my.

Phyllis Junior, a 40 year old tax attorney who lives with his mom in her Alton, Illinois mansion, has been financial advisor to mom's anti-everything group, Eagle Forum. In the QW article that outed him, he denied involvement in the group's policies but then defended his mother's homophobia with the spurious excuse that "it's possible to distinguish between the way one feels about individuals and the way one feels about a group." Hmmm. Here's hoping both Schlaflys stew in their traditional family

Other recent "outees" have been Ray Price, 62, the Republican speechwriter who penned George Bush's acceptance speech in Houston, and Congressman Jim McCrery, 42, of Louisiana.

The Advocate titled its September 22 expose on McCrery "The Outing of a Family Values Congressman." It contrasted evidence of McCrery's past Gay relationships with his shameful record of opposition to AIDS education and research and his support of the military's ban on homosexuals. Publisher Niles Merton called McCrery: "A liar. A hypocrite. An opportunistic exponent of what the Republican Party dares to call family values." That pretty much says

Meanwhile, prominent celebrities who have voluntarily come out in the last few years express satisfaction with their new, more truthful identities and encourage others to come out as well.

Singer k.d. lang told Arsenio Hall: "I felt that it was time, in terms of just the public consciousness, to talk about it openly, and I feel a responsibility to the Gay community as well as to myself. But ultimately, it was to relieve all the pressure that's been on me. You know, as a public image, there's always been this undercurrent of speculation.'

lang told USA Today that reaction to her coming out has been "Wonderful. It's a non-issue. I feel emancipated and a real intimacy with the audiences now.

Actor Dick Sargent, who played the second Darrin Stevens on Bewitched, came out last year on Coming Out Day. 'It's changed my life in so many ways, Sargent told Gay reporter Brent Hartinger. "I'm relieved for one thing. For the first time in my life I feel like I'm being honest with everyone. I'm not afraid to take my lover to parties. And I've become a full time activist, I guess. Since I went public about my sexuality, I've decided to do everything I can. The

more awareness we can get about how Gays and Lesbians are just people, the better. It can change people's thinking.

Sargent, who was joined by former co-star Elizabeth Montgomery as Grand Marshalls at this year's Gay/Lesbian Pride Parade in Los Angeles, also said: "One of the happiest things about coming out was that I've had no negative comments. Not one person has said anything negative. I was on a call-in show a couple of months ago and they wanted the controversy. But the people who called in were supportive, talking about their own coming out or whatever. There have been no negatives.'

Sir Ian McKellen, the actor/director knighted last year for his contributions to the theatre, has become increasingly vocal about Gay rights since he came out himself a few years back. In a recent issue of Christopher Street, McKellen offered this advice to those thinking about coming out:

"Do it. But do it knowing that your life will change, and it might initially change in ways that you wouldn't want it to change. You might find you lose friends... But I can only be certain that they will be replaced by relationships which have much more meaning because they are more honest. And in the end you will get what you deserve. If you stay in the closet, you don't get what you deserve. You get the raw deal."


Marvin Leibman, conservative activist and longtime friend of William F. Buckley, Jr., came out on October 11, 1990. Today, at 69, he's just published his autobiography, Coming Out Conservative. He has told the press: "The main thing I want to do within the Gay community is to help people come out — to not go through all I did for 60 years. And I just want them to know that it's not that bad, it's good. It takes such a load off you; you just feel really released.

'Show it to the world and enjoy it," says Leibman,"There's nothing to be ashamed of. Make the Gay and Lesbian movement your family... Come out and be public. It's a great feeling!'

A final thought. National Coming Out Day has special significance this year because October 11 is also the birthday of Eleanor Roosevelt (1884).

Blanche Weisen Cook's new biography about the great humanitarian has caused controversy because the author discusses the significant impact several Lesbian couples had on Eleanor. The second volume is expected to carry more information on Eleanor's 30 year love affair with Lorena Hickok.

So on October 11, I'll be sure to sing a few stanzas of the dyke classic "Gimme That Ol' Lesbianism" (to the tune of "Old Time Religion"), singing happily, as I have for years, but with more confidence than ever: "If it was good enough for Eleanor - it's good enough for me...



Acting is Superb in Woody Allen's 'Husband and Wives' Masterpiece

Woody Allen's new film, Husbands and Wives is yet another masterpiece in the tradition of his last work. I had hoped to keep this review separate from the much publicized Woody and Mia Farrow break-up, but that's impossible since indeed it's the subject of the film.

Woody plays a novelist and professor married to Mia who works for a publisher. Their best friends, another upscale Manhattan couple, brilliantly played by Sydney Pollack and Judy Davis, announce

they are getting a divorce.

Allen and Farrow are shocked and are forced to question their own commitment. Mia becomes attracted to an editor at work, Irish actor Liam Neeson, while Woody falls for one of his own students, Juliette Lewis, who writes a paper "Oral Sex in the Age of Deconstruction." To tell much more would ruin an elaborate and

brilliantly constructed plot. Brilliant Acting

The acting is superb. Sydney Pollack, probably best remembered as Dustin Hoffman's agent in Tootsie, and Australian actress Judy Davis both deserve Oscars.

Davis, who may well be the world's best cinematic actress, plays a beautiful, strong, intelligent, sophisticated woman with such vitality and sensitivity that she matches any of Katherine Hepburn's great performances.

Since this will almost certainly be Mia Farrow's last Woody film, I had hoped this would be her chance for a long-denied Oscar. Although she is excellent, she is overshadowed by Davis who has the more dynamic role.

A Doctoral Dissertation

There is so much going on in this film, it no doubt will be the subject of more than one doctoral dissertation. This picture is just as confessional as Annie Hall. At one point Mia says, "Your manuscript is so autobiographical." Woody replies, "What else am I going to write about?"

Woody's wider task is to examine the

state of long-term romantic partnership in contemporary society. Although his subjects are, as usual, white, middle-class, Manhattan heterosexuals, the issue covered are so universal almost anyone under 50 can enjoy this film.

Keep Your Expectations Low in the '90's

Woody comes to many conclusions about romantic partnership. He believes one should keep expectations low and remember that joining is based on companionship rather than physical attraction which will ultimately fade. Much more daringly, he proposes that masochism, emotional rather than physical, is a common element in relationships. Placed in context, that isn't necessarily fatal since, for many, a certain amount of abuse seems to be as genuine a need as a certain amount of love. The older half of the audience I saw the picture with was repelled by this notion.

A Pseudo- Documentary Style

The film is done in a pseudo-documentary style with hand held cameras, clumsy editing and character interviews. At first, this is somewhat annoying, but it suits Woody's purposes well. In the last scene, Woody looks into the camera and tries to explain how he could become involved with a college student and break up with Mia. He comes to the conclusion that he has a deeply rooted self-destruct impulse that will never allow him to be happy in any relationship and it prevails over any amount of therapy.

The dialogue is so funny and realistic in this picture one often wonders if Woody lifted lines directly from his own romantic involvements.

Even if after reading the tabloids, one thinks Woody is a monster — I for one do not believe some of the accusations — he is nonetheless one of the most important artists of our time. Like Charlie Chaplin and Buster Keaton before him, the revelation that he is a troubled soul should come as no surprise.

"Our non-singing members are truly the unsung heroes of this organization," said Schumacher. "They grab the reins on many duties and tasks that the singing membership cannot due to time constraints. 

what and who they are. For them, voting against Bush would be a measure of acceptance of their homosexuality. Rather than vote against a President who has utterly rejected them, they will vote against themselves.

They want to believe that they are better than the rest of us. They smugly assure themselves that there are other issues more important than the Gay and

Lesbian agenda.

We are Lesbians and Gays. No matter how much we may try to deny it, being Gay or Lesbian is deeply woven in the fabric of our being. Refusing to vote, or voting for our oppressors is more than an act of stupidity, it is an act of self-hatred.

Some say they won't vote because they don't trust Bill Clinton. That's like saying that if you were being bashed, you wouldn't ask a passer-by for help because they might hit you even harder.

Bush's record on Gay and Lesbian issues is clear. It is a sorry record. He has continued the policies of discrimination against Gays and Lesbians in the military, publicly denounced Lesbian and Gay parents, openly admitted that he hasn't done enough in the fight against AIDS, and repeatedly stated his opposition to Gay and Lesbian rights legislation.

Worst of all are the Bush attempts to stir up hatred against us so that he can get re-elected. During the Republican convention, Pat Buchanan took the podium and told a national television audience that "there is no room in the Republican Party for Gays and Lesbians.'

Don't operate under the illusion that Buchanan didn't speak for the Republicans. The GOP convention was so tightly controlled that even the home made signs carried into the hall had to be approved. Every word of every speech was gone over and okayed. When Buchanan called for a "war" against us, he spoke for George Bush.

Its time to give Mr. Bush his war. We've never had a better chance to make significant gains. We can't afford to blow

Would Clinton make a difference? Yes, he would. Clinton's election would mean things to many people. But undeniably it would mean that the days of building an election victory on a platform of homophobia are over. That alone would make a difference.

Furthermore Clinton has publicly promised an immediate end to discrimination against Gays and Lesbians in the military. He has publicly promised to implement the recommendations of the President's Commission on AIDS. He is on the record in favor of Gay and Lesbian rights legislation. At the Democratic convention Clinton became the first Presidential nominee of either major party to call for an end to discrimination against us.

Clinton's election won't eliminate homophobic attitudes, but it would help the institutionalized homophobia that make those attitudes seem acceptable.

Contrast that with four years of excuses, inaction and outright hostility from the White House. We have endured four years of stonewalling on AIDS, four years of witch hunts in the military, four years of official policies that discriminate against us.


In three states, Colorado, Alabama and Oregon, the electorate will vote on referendums which would mandate discrimination against Gays and Lesbians. Passage of the referendum in Alabama is a forgone conclusion. In Oregon the polls show those in favor and those opposed are in a dead heat.

That makes federal protection of our right to live without fear even more important. Its one thing to refuse to pass

All work is expected to be completed by the end of this December.





Colorado Gays Continue Battle To Protect Their Basic Rights

[Denver, CO]- In an election year when words like "family" and "values" are losing their luster to words like "economy," the people of Colorado are having to consider whether or not they want to exclude people with differing sexual orientation from the list of persons in need of recognition as victims of discrimination.

Proponents of this effort, known as "Amendment #2, argue that Lesbians and Gays should not be allowed "special rights" because "they don't need it." They point to a host of questionable data on Gay wealth to make their point.

Amendment #2 will appear on the November ballot for a state-wide referendum.

The Stakes Are High

Should the amendment pass, Colorado will be the first state, pending the vote in Oregon, to have an amendment to its constitution that would, according to many legal scholars, plainly deny rights to people based on their sexual

Should the amendment fail, Colorado would be poised to enact a statewide effort to ensure that Lesbians and Gays are not discriminated against.

Colorado For Family Values and Wisconsin

Taking up the crusade for the amendment is Colorado For Family Values (CFV), whose members take their name directly from what the Republican Party hoped would be the winning theme of the 1992 election.

CFV is part of the Christian Coalition, a California-based, nation-wide, right wing Christian organization which is orchestrating campaigns against Gay and Lesbian rights in Oregon and Portland, Maine. If successful, sources in Portland, Oregon say, they intend to make a nation-wide effort, concentrating on 17 states. Wisconsin is among those targeted.

Will Perkins, one of CFV's leaders wrote in a letter to Colorado clergy that "half of all child molestations are committed by homosexuals." In the same letter intended as material for sermons, Perkins says that Lesbians and Gays are "sick, dangerous people who do not deserve equal rights." Perkins goes on to say that "a large percentage of male and female homosexuals use gerbils in sexual activity.

CFV: The Dark Side

Judy Harrington, a lead organizer for Equal Protection Of Colorado (EPOC) which is campaigning against #2, sees CFV as a money making venture for the Christian right wing.

"I think at the core of this (CFV)," Harrington said, "are shrewd right-wing businessmen in California figuring out a way to make a bunch of money for themselves. Verbal Gay- basing working politically against Gays — is a perfect fund raiser for the right wing."

Harrington continued, "In the past, it

has been anti-abortion and anti-choice, and now in every national poll you see, the pro-choice attitude is the majority. The Right is losing ground - direct mail doesn't get them as much money - and it is very emotional and very appealing to raise money to stop the 'homosexuals.

EPOC has its strong supporters such as Denver Mayor Wellington Webb, Colorado Governor Roy Romer, tennis star Martina Navratilova along with Apple Computer and the Denver Housing Authority. Still, as of the end of September, polling results are unclear.

Amendment #2 will either lose by 18 percentage points or pass by two. The mixed results could be because voters throughout the state are less predictable than voters in Denver, who regularly vote favorably on issues that are Lesbian and Gay related, as evidenced by the probable re-election of U.S. Congresswoman Pat Schroeder for her 11th term.

A Scary Campaign

CFV boasts former U.S. Senator Bill Armstrong and University of Colorado football coach Bill McCartney as honorary chairs of their campaign. Recently, Denver Bronco linebacker, Karl Mecklenberg, donated \$500 to the cause.

"It's very scary to be attacked like this," notes EPOC Assistant Campaign Manager Joseph Marchione. Marchione says he is "painfully" aware that the campaign faces pressure from both "people who would like to see Lesbians and Gays dead" and critics who are themselves Lesbian or Gay. Crucial to the success of the campaign, Marchione says, is to keep Lesbians and Gays both interested and involved.

Down To The Wire

To some, EPOC may be pushing the odds by hoping that the last ten days of the campaign will prove to be what makes or breaks them. But, already, a 30-second TV spot is running, showing a mother and father talking about family values and their Gay son.

EPOC's Bobbie McCallum admits the print and electronic media have not covered the issue well. "They (the media) seem to get it," she said, "but they have no sense of urgency." While acknowledging that the media is friendly and generally supportive, she gets the sense that they don't see how much of a threat amendment backers pose.

Adding to the disinterest, McCallum said, is the crowded November ballot. Colorado voters will face ballot measures on gambling, schools and other issues as well as the one on Gay/Lesbian rights.

Part of EPOC's strategy, McCallum said, "is to point out specific examples that illustrate CFV's extremism." She cites, CFV's Perkins' charge that if #2 is not passed, employers will have to hire homosexuals "regardless of their shortened life expectancy due to AIDS."

"A lot of politics is luck and timing," notes McCallum. No doubt, opponents of Amendment #2 hope the time for Lesbian/Gay rights is now.
