Court Grants Preliminary Injunction Preventing Military from Ousting Gays

(Brooklyn, NY)- On April 4, 1994, Federal District Judge Eugene Nickerson granted a preliminary injunction preventing the government from discharging the six servicemembers who filed suit challenging the recently enacted federal law and final Department of Defense regulations excluding Lesbians and Gay men from serving in the U.S. Armed Forces. The Court's action prevents the government from taking any discriminatory continuation.

action until a full hearing or trail and final decision in the case. No Trial date has yet been set.

The lawsuit, brought by the Lambda Legal Defense and Education Fund and the American Civil Liberties Union on March 7, 1994, charges that the "Don't Ask. Don't Tell" policy violates constitutional rights to free speech and free

'The hardship to the six plaintiffs is evident and immediate," Nickerson said in granting the injunction that blocked the dismissal of the six. "Their free speech rights to pursue this case will be chilled. They will be subjected to adverse action, including likely discharge from their chosen profession, on the basis of what substantial judicial deemed unconstitutional discrimination.'

The injunction was sought in an emergency hearing after one of the six, Petty Officer Robert Heigl, was served with a notice of imminent discharge. He is on active duty with the Coast Guard and is stationed at Governor's Island in New

Straight: The Latest Hate Journal of the Christian Right Wing

(San Francisco)- The San Francisco chapter of the Gay and Lesbian Alliance Against Defamation (GLAAD), has uncovered a homophobic newsletter and E-mail transmission, Straight (Society To Remove All Immoral Godless Homosexual Trash), available from Denver, Colorado for computer BBS

The masthead reads, "Straight is published 6 times a year by Christians under the authority and direction of Christ and his Law-Word," and the publication appears to be run by Rick Savage. Straight offers ad display slicks for use in

Christian publications, the header stating "Death Penalty for Homosexuals is Prescribed in the Bible; Wanted: All Criminals Protecting, Promoting or Practicing Homosexual Perversion.

"As kooky, outrageous and stupid as this may look, it is really not that far removed from what Pat Robertson, Lou Sheldon and Pat Buchanan are

saying," said Al Kielwasser, SF/GLAAD co-chair.
In fact, in one issue, Straight quotes Buchanan,
"In a healthy society, homosexuality will be

In a segment entitled "Reclaiming Our Language," Straight calls "homophobia" a smear term and suggests using "heterophobia" as an expression against Gays, except Straight does not like the term "Gay," but prefers "SAD" (Sodomites Against Decency)

In this new information superhighway we are seeing more and more messages advocating rounding up and killing Gay men and Lesbians," said Bonnie Haley, GLAAD co-chair, who recently discovered Straight during her computer media watch duties. "This is very similar to the racist hate

On an upnote, I have talked with monitors of electronic bulletin boards and there is now a pact among all BBS operators on the West Coast to delete any of this information advocating death for any individuals," said Haley.
"On the other hand," Kielwasser added,

Milwaukee Moving June 11-12 PrideFest Down the Hill to a New Location on Lake Michigan

(Milwaukee)- After five years of celebrating Pride at Juneau Park, Wisconsin's Pride celebration, PrideFest, is moving. The new site is just north of Milwaukee's War Memorial Center. The two-day event will be held on Saturday, June 11 and Sunday, June 12, 1994.

This year's festival will stretch from the Vietnam War Memorial all the way to the War Memorial Center itself. This means the festival will be located right on Lake Michigan.

The new site offers several advantages over the old one. Chief among these is the absence of trees The festival had used up all of the clear ground space at Juneau Park and had no room to accommodate this year's planned expansion with more tents, activities and stages.

The new site offers a glorious view of Lake Michigan. Furthermore, O'Donnell Park Parking Pavilion is just two blocks south of the new PrideFest grounds. The Pavilion holds around 1,200

Christian Right Group Organizing in State to Fight Civil Rights for Gays and Lesbians

(Milwaukee)- Wisconsin Christians United (WCU) announced on April 4, 1994 the opening of its new political campaign, "Project Resist and Restore." The project was made public on WVCY, the Milwaukee TV station operated by Wisconsin Voice of Christian Youth. Ralph Ovadal, a resident of Monroe, Wisconsin, and head of WCU, was interviewed by Rev. Vic Eliason on his nationally broadcast call-in show, "Crosstalk."
Wisconsin Christians United is centered at

Ovadal's address, W6908, Highway 81, Monroe, WI 53566, but has organizational presence in about 12 Wisconsin localities, according to him.

Ovadal said the new project aims to "Resist the homosexual agenda and Restore decency and sanity to our public policy here in Wisconsin and to our governing institutions

Ovadal appealed for funds to carry on an effort centered on the pastors of Wisconsin churches. "The key, of course, is always the pastors. . We want to ultimately hold a press conference on the

steps of the capitol with all the pastors we can get and take a stand for righteousness.

Project Resist and Restore plans a number of steps in its newly declared war on Lesbians and Gay

1) Collect enough money to buy and distribute a video exposing the homosexual agenda to several

 Develop a newspaper-type publication exposing homosexuality and use it in a literature drop campaign across the state;

Introduce legislation which would remove all sexual orientation language from the state statutes.

Ovadal says his group feels very strongly that Gays are not entitled to full civil rights. "I'm here today to say I am against certain civil rights for homosexuals. I say that unabashedly.

Eliason strongly endorses the group and its opinions. "Folks," he said, "it's exciting to know people heading in a direction: they know where they're headed, they know what they want to do, and they need people to help them do it."

PrideFest will be making good use of the

Madison's Club 3054 and Instep Magazine will be sponsoring a dance tent.

The PrideFest History tent will include the largest display of Gay and Lesbian history anywhere in the country.

None of these things would have been possible at the old site," said PrideFest Co-Chair, Bill Meunier. "We had run out of room to put up more tents and exhibits. Trying to cram everything into the space we were using would have caused severe crowd congestion. Furthermore, we would have had problems with sound systems on the various stages drowning each other out.'

The new PrideFest will be fenced off and have one gate located at the north end of the grounds. Visitors will be asked to voluntarily donate \$1 to help keep attendance and defray costs. Carry-ins of food and drink will be prohibited except for those accompanied by children.

Organizers admit that they are somewhat nervous about the move. After five years in one location, they want to make sure that people know about the move. They are asking that as people become aware of the move, they spread the news to

A controversy is brewing over the marketing of Zima malt liquor to Gay and Lesbian bars around the country. Zima is being promoted in Gay publications and in TV commercials which depict it as an upscale liberal, yuppie beverage. The clear malt liquor is a hot item in many locations.

The problem that many Gays and Lesbians have with Zima is that it is brewed by the Coors Brewing Corporation. In a move that appears to many to be deceptive, the Coors Brewery is marketing the liquor under the name "Zima Beverage Company, Memphis, TN."

Critics say that Coors has good reason to hide its ownership of the brand. They charge that some of the Coors Brewery profits, including money garnered from the Gay community, have been funneled into homophobic, radical Right Wing organizations

Coors is a privately held corporation, wholly owned by members of the Coors family.

David Smith, Public Information Officer for the

National Gay and Lesbian Task Force (NGLTF) told Light that "Coors has been trying for to get into the Gay and Lesbian market for some time. You can find no use of the Coors name in the marketing of Zima. It's clear that this was a deliberate marketing decision. In effect, a percentage of every dollar spent on a Coors product goes directly to radical organizations that are attacking this country's Gay population." Richard Levy, Director of Political Research

Associates in Boston, agrees. Levy says that while the Coors family funds homophobic radical groups, their company is making an open bid to increase its share of the Gay market.

"Their strategy seems to be 'We'd like you to drink our beer, before you die", said Levy. He added that "The foundations they have set up with Coors profits took the lead in creating the whole new radical right.

"These people aren't just engaged in passive Republican or Democratic politics. They are actively engaged in aggressive attacks on the Gay

and Lesbian community," said Smith.

That engagement includes donating money as well as providing political guidance to the Right

Wing.

Tim Kingston, author of a series of articles on Coors for the San Francisco Bay Times, a Gay Adalah Coors publication, estimates that the Adolph Coors Foundation sent approximately \$1.1 million to Right Wing groups in 1988 alone. In its 1992-93 fiscal year, Kingston believes the Coors Foundation sent \$900,000.

One major beneficiary of Coors funds is The Free Congress Foundation (FCF), identified by People For the American Way and others as the organization that created the Radical Right. It was this group that came up with the strategy of labeling civil rights for Gay people as "special rights," a strategy that is widely credited with convincing Colorado voters to pass Amendment 2.

FCF also helped to organize the effort that derailed President Clinton's plan to lift the ban on Gays in the military.

Gays in the military

Joseph Coors is the Chairman of the Board of both FCF and the Coors Brewing Company. By 1988, he and the Adolph Coors foundation had donated a total of \$485,000 to FCF.

Another group funded in part by Coors beer money is The Heritage Foundation (HF). HF was established by Joseph Coors and ultra-right activist Paul Weyrich



According to The Village Voice, HF provided a needed legal review for Oregon's anti-Gay Amendment 9. Amendment 9 failed, but backers are currently trying to get a new version on the

NGLTF calls HF "one of the most influential, ultra-right wings think tanks in the world."

Many critics believe that the Coors family is so great, that they have labeled them "key players" in the creation and expansion of the Right Wing. Among the most vocal of these critics is Russ

Bellant is the author of The Coors Connection, a 1991 book about the Coors family

Anti-Gay Initiatives Attract Radical Bedfellows

(Seattle, WA)- Anti-Gay initiatives in Washington State have received support from individuals and organizations connected to the KKK and the neo-Nazi movement. "I'm not surprised," said Luma Nicol of the United Front Against Fascism. "People should understand that the anti-Gay initiatives are just part of a whole Right Wing agenda that is anti-Semitic, racist, anti-woman. I suspect that Klan members and neo-Nazis are not only giving money, but are doing many other things in support of the anti-Gay

Anti-Gay Advocate Blasted by Vegas Mayor

(Los Vegas)- Mayor Jan Jones on April 6, confronted an anti-Gay activist who accused her and other Nevada politicians of promoting child molestation by supporting civil rights for Lesbians and Gay men. "Take your hate and fear and take it somewhere else," Jones told Lon Mabon, head of the Oregonbased Citizen's Alliance, parent organization for anti-Gay initiatives in Nevada, Oregon, Washington and Idaho. "The statements you made are not only inappropriate, they're wrong, they're cruel, and they're hate and fear-mongering against both the governor and myself," Jones said.

Nevada Governor Bob Miller said that Mabon's claims are "so ridiculous that they make my case for the property of the property of the particular of the p

me. This group has an underlying motivation, that they don't even attempt to conceal, of instilling hatred

Mabon was in Nevada pushing an initiative that would allow employers and landlords to discriminate against Gays and Lesbians.

Striesand Tour to Raise Millions for Charity

(Beverly Hills, CA)- Barbra Steisand's first tour in two decades will raise \$6.3 million for 20 U.S. charities, it was announced. Charities in Washington, D.C., Detroit, Los Angeles, San Jose and New York will receive 9,700 tickets to sell and will keep the proceeds, according to a statement from Guttman Associates, Steisand's publicist.

The charities deal with AIDS, children's and women's rights, the environment, homelessness and poverty, inner city education, earthquake relief and constitutional liberties, the press statement said. They range from People for the American Way to the San Francisco AIDS Foundation.

Demand for the original 12 shows was so great that the superstar decided to add six shows. All 18 sold out in less than an hour on March 27, with the tickets prices from \$50 to \$350.

(New York, NY)- In what may be the first-ever promotion between a major U.S. airline and a Gay business, **Detour Publications**, a publisher of Gay and Lesbian travel guides, announced a coupon offer in conjunction with USAir. The promotion features a coupon good for up to \$50 per person off a USAir flight through the end of 1994. Consumers are eligible for the coupon when they purchase any **Detour** Guide between now and June 30, 1994. **Detour's** guide to New York City has been officially endorsed by Gay Games IV. People With HIV/AIDS Welcome In Japan

(Tokyo, Japan)- Officials of the Japanese Ministry of Health and Welfare emphasized on April 1, 1994, that people with HIV or AIDS are welcome in Japan, and that no visitor to Japan, regardless of length of stay, will be denied entry to the country because of HIV status. Yokohama, Japan is the host

city of the Tenth International Conference on AIDS, to be held August 7-12, 1994.

Dr. Naoko Yamamoto, Deputy Director of the Infectious Diseases Control Division, Health Services Bureau, added that Japanese officials do not ask visa applicants about their HIV status or sexual orientation, and do not require them to take an HIV antibody test. "The policy applies regardless of length of stay, and it applies not only during the Yokohama conference, but at all times," Dr. Yamamoto

Dr. Yamamoto also said that discrimination against people with HIV or AIDS in hotel accommodations is illegal in Japan.

The Secret's Out About Lesbianville, USA

(Northampton, MA)- The secret is out about Northampton, Massachusetts, a little New England town with a large Lesbian community. Dubbed a "town like no other" by Newsweek and "Lesbianville, USA" by the National Enquirer, Northampton has been deluged with phone calls and letters from Lesbians and Gay men from across the country and around the world, requesting information about visiting or

In response to this demand, several business leaders have formed the Northampton Area Lesbian and Gay Business Guild (NALGBG). The group has published a brochure about the area that is specifically geared to the interests of Lesbians and Gay men. Lacking Legal Marriages, Gays Must Take Out Powers of Attorney Papers to Protect Their Interests

When his lover of 18 years had a heart attack and was taken to the local hospital, a Gay man was told by the hospital staff that because he was "not family" they would not give him any information about his spouse's condition. They wouldn't even tell him if his spouse was dead or alive.

Only after he went home and got their power of attorney papers, which were carefully examined by the hospital administrators, was he told that his spouse was going to survive.

If the ceremony that they had had years before had been recognized by the civil authorities as a legal marriage, then the pain and fear they suffered would not have been compounded by having to prove their status as family to an uncaring hospital bureaucracy

A Lesbian couple in Honolulu who have three children worry that if one of them were to die, the children would be taken away from the remaining parent and lose the only family they have ever known. This couple married seven years ago, before having children, so that their kids would be born "in wedlock." But the state refuses to

recognize their marriage.

We can gain vital civil rights through the legalization of same-gender marriage, rights that we currently hold only through piecemeal, and often ineffectual, legal protections. Domestic partnership, in the few places that recognize it, often carries more symbolic than legal value. The struggle for marriage rights is principally a struggle for civil

Yet some Gays and Lesbians continue to think that this issue is not important to our community. Some charge that the movement for same-gender marriage is merely copying heterosexual values and is a goal inconsistent with the pursuit of civil rights for Gay people. The movement for same-gender marriage fundamentally seeks to ensure that all people have equal access to the rights granted in our society.

I believe that ours is a radical movement that will strike a significant blow to the forces of our oppression by breaking down the bastion of heterosexual privilege: marriage.

Society rewards people for entering into heterosexual marriage, by granting legally sanctioned rights and benefits. Granting these rights to other models of family removes the advantage currently enjoyed only by heterosexuals and their

The question of whether states ought to grant couples benefits not given to singles is a different question than whether same-gender couples should

be treated as equal to opposite-gender couples.

By not pursuing the right to marry, we are saying in effect that it is acceptable to treat Gay and Lesbian couples differently from heterosexual

couples. That is not acceptable to me. Same-gender couples deserve better than second-class citizenship. All people are entitled to equal second-class treatment, and that is why we are pursuing the legal

right to marry here in Hawai'i.

Legalized marriages would give Gay and Lesbian relationships full legal and social legitimacy for the first time in history. Gay and Lesbian couples would be entitled to all legal benefits that automatically accrue to married couples, including child custody, employment, inheritance and survivor benefits.

Gay and Lesbian couples would also receive all economic benefits of marriage, including tax exemption, fee waivers, death benefits and commercial discounts. Even those who have no interest in marriage will benefit from a victory in this case because it will represent the end of second class status and the beginning of full equal citizenship for Lesbians and Gay men.

Same-gender marriage also is a grave threat to the conservative, religious, anti-Gay movement. In their opposition to civil rights for Gays and Lesbians, they rely heavily on falsehoods and stereotypes of promiscuous, leering men who prey on young boys and have hundreds of sex partners each year; of Lesbians who parade naked down Main Street.

We are portrayed as the bearers of disease and threats to morality and the "traditional family." Yet,

our very desire for marriage shatters these images.

We have found in Hawai'i that those who oppose same-gender marriage argue against homosexuality itself, rather than against Gay marriage because it does not fit into their stereotypes. After all, marriage conveys the ideas of love, of commitment, of monogamy, the opposites of what they portray us to be.

Some have argued that we will never have marriage rights because they are too controversial. The Hawai'i Supreme Court has proven that assumption wrong. Because of Hawai'i's long tradition of civil rights and tolerance of cultural diversity, we have a unique opportunity to expand the civil rights of Gay and Lesbian Americans. can turn back the tide of anti-Gay sentiment and broaden the scope of the Gay and Lesbian civil

On the eve of the 25th anniversary of the Stonewall riots, I believe that we stand at an equally critical moment. When we are granted the right to marry and our intimate and loving relationships are treated equally to all others, the barriers which stand between us and our full and equal participation in society will fall. We invite you to join us in making this happen.

Mixed Results in Madison Elections: Diversity Gains, But Conservatives Do, Too

Elections in Madison and Dane County brought mixed bag of results for progressives and supporters of civil rights for Lesbians, Bisexuals and Gay men on April 5.

On the positive side, local government is beginning to more accurately reflect the face of the community with the election of Hispanic and African-American candidates in races for circuit court judge, school board and county board. Veteran board member Mark Pocan and newcomer Scott McCormick, running as openly Gay candidates, both won handily in their races for county board. The Madison school board is now firmly in the hands of progressives and moderates, although the Radical Right is gaining in its effort to thwart diversity initiatives at the committee level.

However, despite a first class effort, openly Lesbian candidate Cathreen Godre lost in her bid to become a Dane County supervisor. And hopes for a return to a progressive county board evaporated when conservatives won 22 of 39 seats (a net loss of one progressive seat).

Progressives and moderates reinforced their control of the Madison School Board with the April 5 election of two allies of the Gay and Lesbian community. However, Gay and Lesbian education advocates caution that the forces of the Radical Right have not gone away; they've merely gone underground, advancing their agenda in less visible

Lopez Makes History

Community activist Juan Lopez made history as the first Hispanic-American to win election to the Madison School Board. Lopez's victory is also notable in that he is the first single person without children to serve on the school board in recent memory--a reminder to the community-at-large that many of us without children also care about the schools and see them as the key to the future of our community. Lopez is the coordinator of Project Opportunity, an organization that works with students at risk of dropping out of school.

He defeated conservative incumbent Greg Samp,

who lashed out at Lopez following the election in a bitter display of sour grapes. Samp told the Wisconsin Journal that he wasn't able to compete with Lopez because "my primary responsibility is to be a father." He discounted the long list of people from all across the city who supported Lopez, saying that Lopez's victory was proof that "school board elections can be bought."

The reality, of course, was that Lopez won

because he waged a solid, broad-based campaign. Even in and ostensibly "liberal" city, as a minority candidate, Lopez had to work harder than Samp to overcome prejudice and preconceptions. Samp's not so veiled reference to Lopez's status as a single person without children was an especially cheap shot. However, surrounded by his family who had flown in from Texas to be with him at his victory party, Lopez rose above such comments to speak eloquently about the value of diversity and the need to bring people together. He will be an outstanding leader on the board.

In the other school board contest, community activist and real estate agent Deborah Lawson defeated perennial "family values" candidate Michael Langer by a margin of almost four to one. Lawson will replace outgoing progressive Nan Brien, who is stepping down after three terms. Lawson has a long history of progressive activism. and both she and Lopez were enthusiastically endorsed by members of Lesbian and Gay parenting organizations and Gay and Lesbian teachers.

The election leaves school board member Nancy Mistele as the lone conservative voice on the nine member board. On the surface, it represents a coming full circle from several years ago when it appeared likely that conservatives would eventually dominate the board, due to the successes of candidates backed by archeonservative Citizens Advocating Responsible Education (CARE).

However, despite the good news contained in this election, advocates for Gay and Lesbian families and children warn that this is no time for complacency. They say that CARE has only gone underground, and that a "stealth" campaign to advance its conservative agenda is well under way. (More on this story in upcoming issues of Light.

Progressives Fail to Take

Back County Board

The disappointment of a 22-17 conservative win was only slightly mitigated by the fact that seven of the races were extremely close. That means victory could be within reach next time, but progressives have to work harder to get there.

Diversity gained some significant victories with the election of three African Americans, newcomers Regina Rhyne and Kevin Bonds, and second term incumbent Steve Braunginn. Rhyne is a longtime south side activist who speaks eloquently of her journey from being on welfare to receiving a Master's degree in urban and regional planning. Though she's mellowed over the years, Regina doesn't hesitate to say what she thinks. She should make things very interesting and provide an important voice to people who have often gone

Kevin Bonds will represent the town of Madison and north Fitchburg, bringing an extraordinary array of skills and experiences to the board. He has a solid background as a fiscal analyst that compliments his extensive work as a community activist and coalition builder. He is not afraid to challenge the system, yet clearly knows how to work within the system as well. Many on the board have clearly identified him as one of the most promising rising stars in local politics. Stay tuned. Godre Loses to Hendrick

By a margin of about 60 to 40 percent, neighborhood activist John Hendrick defeated openly Lesbian Cathreen Godre in the race to succeed retiring Gay and Lesbian community leader Dick Wagner on the county board. Because both candidates had similar stances on most of the issues, it was a race that most progressives had labeled a "win-win" situation. Hendrick's name recognition and a 20-year history of neighborhood

Hendrick is an attorney with the King St. Alternative Law Office and a leader in the Labor-Farm Party. He has long been an ally of the Gay and Lesbian community. Several years ago, as president of the Marquette Neighborhood Association Hendrick had traveled to other

neighborhood associations, lobbying for their

activism seemed to account for his margin of

support for the Alternative Families ordinance.

Godre ran a broadly-based, well-organized campaign. Spending countless hours going door-todoor, she was extremely well received by those who met her. Volunteers spent hundreds of hours compiling a sophisticated database that identified likely voters and supporters. Godre and campaign workers were able to distribute several professionally produced pieces of campaign literature to virtually everyone in the district. Experienced politicos close to the campaign agree that virtually experience that could be done was that virtually everything that could be done was done to get out her message.

Godre raised the second largest amount of

money of any candidate for the board--more than \$10,000. Godre's endorsements included former Gov. Tony Earl, and most of the east Madison representatives in the state legislature, including Sen. Fred Risser and Rep. Tammy Baldwin. Former Dane County Board Chair Dick Wagner also worked hard on her behalf, as did a wide variety of community activists.

Now that the election is over, many in the community are searching for lessons to be learned. Openly Gay candidate Tim O'Brien, who lost his chance at the general election by a margin of only nine votes, backed away from his promise to endorse Godre after the primary, and immediately endorsed Hendrick instead.

The election was also difficult because many in the community have felt torn by the choice between a third party candidate and an openly Gay or Lesbian candidate. While many in the community are already coming together, some bad feelings persist. The weeks following the election will be a time for introspection, and community leaders hope to bring about a dialogue between longtime friends who found themselves in different camps.

After a string of recent successes by openly Lesbian and Gay candidates, this loss struck many as totally unexpected and, therefore, especially painful. However, important work was done that will serve as a foundation for future candidacies by members of our community. Important lessons were learned, and with time, those lessons will become

better known. (Look for more analysis and reflection on the

UW-Stout Student Recants Story that She was Assaulted Twice

(Menomonie, WI)- A 19-year-old Lesbian student, Amber Withrow, has recanted stories of being assaulted twice on the University of Wisconsin-Stout campus, including on incident when she had said the attackers used slurs against

"I'm very pleased we could free the name of the university," Chancellor Charles Sorensen said on Monday, April 4. "I felt we'd taken a real black eye with this thing.'

Withrow, who has voluntarily left the university and returned to Minnesota, signed a statement on Thursday, March 31, retracting her allegations.
That was after campus investigators confronted

her with evidence that attacks, reported in October, 1993 and February, 1994, hadn't occurred, said John Enger, university relations director. "We have closed the case," he said.

Investigators suspected the woman wasn't being truthful about the October 18 attack when Myrtle Werth Medical Center emergency room reports indicated she didn't have a separated shoulder, a fractured cheek or a concussion as she had stated, said Dennis Shaw, coordinator of campus police.

The medical report showed she had a few abrasions and a bruise on her arm. That's why they immobilized her arm. They didn't even take Xrays," he said. Shaw said authorities didn't immediately request

medical records because they were working on other leads and did not suspect Withrow was not telling the truth.

Withrow told campus police she was walking

from her dormitory to a parking lot when she was grabbed from behind and beaten by three or four people who used gender epithets and slurs about her being a Lesbian.

On February 3, Withrow reported that she was attacked in her dorm room and struck in the face by

Her allegations couldn't be supported by evidence, based on the time she said the attack occurred and interviews with other people, Enger

Campus investigators don't know why the student made the false reports or how she got the abrasions and bruise that the doctor found on her, Enger said.


She does not want to pursue this so we have no way of getting to the truth," Enger said.

Withrow could be charged with a misdemeanor of obstructing an officer, but no charges will be filed, Dunn County District Attorney James Peterson said.

Withrow has agreed to receive counseling, Peterson said. "Sometimes it's best to get people help than to try and prosecute them.'

Americans Believe that Gay Domestic Partnership Policies for Gays are Fair

Commentary By Nalani Askov A recent survey by Newsweek magazine shows that an overwhelming number of Americans believe that domestic partnership is a simple matter of workplace fairness. Sixty-seven percent of Americans surveyed support giving Gay and Lesbian employees access to the same employment benefits that are available to married employees.

What is Domestic Partnership?

Domestic partnership is not Lesbian and Gay

marriage. Domestic partnership is a policy that fairly and reasonably provides Gay and Lesbian employees with access to the same employer-provided benefits that are available to married

Domestic partnership policies may take a variety of forms. Cities, states and other government employers and private employers may allow their employees' domestic partners the same access to employment related benefits that they offer to the

As a Community It Is Imperative That We Buy the Products and Services of Corporations Which Support Us

As recent articles in The Wall Street Journal and other publications point out, there are companies that are supporting the community. They are including sexual orientation in their non-discrimination policies. They are offering domestic partner benefit that include us.

Just as importantly, they are putting money into our community. They are advertising in our publications. They are helping to sponsor our events like Gay Games IV and Stonewall 25 to mention only two of the largest and best known.

They do this in large part, because there are people within their organizations who believe that this is good for business as well as being the right thing to do. But whatever the motivation, the value of their actions is immense.

actions is immense.

Think for a moment of the value if major corporate sponsors decided to "go with" a prime time TV program showing Gay people living as normal, everyday families just as most of us do.

Think what would happen if the Kellogg company put an openly Gay person on their cereal boxes, one of the many Gay athletes, for example.

That time may be closer than we think. Even now, several major corporations are underwriting ad campaigns showing Gay people in normal situations. We may not like to admit it, but ads and TV shows have a great educational value.

But each time something like this happens each time a company supports us, the Far Right rises up.

But each time something like this happens, each time a company supports us, the Far Right rises up in all their venom and spits back in furious hatred. Our own self-interest cannot let this go unopposed. Companies like Miller Beer, like Levi-Strauss, like several of the airlines, should not be left hanging

We should know their names. We should buy their products and services. And we should communicate our appreciation to them for what they are doing. As we do, we show other companies that it's "just good business sense" to support our community.

Otherwise, what we're going to be left with is Coors and Kelloggs, to mention only two, whose money and power do us damage and no good to anyone at all.

spouses of their married employees. These benefits may include access to health care, dental or vision plans, the ability of an employee to use accrued sick leave to care for their domestic partner or that partner's child in the same circumstances as married partners, and the ability to take bereavement leave upon the death of the domestic partner or a member of the partner's immediate

Who can be a Domestic Partner?

There is no uniform definition of a "domestic partner." The criteria varies among employers. However, some elements of the definition are more common than others. Employers generally define domestic partners as persons who share a close personal relationship with each other and who:

1) are unmarried;

2) are each other's only domestic partner;

share the common necessities of life and are responsible for one another's welfare;

4) are not related by blood closer than would bar

5) are of consenting age; and live together.
Some employers limit their partnership policies only to Gay and Lesbian employees. They reason that heterosexual couples could choose to marry in order to qualify for benefits, while Gay/Lesbian partners cannot

How Widespread are Domestic Partnership

Policies?

At least 30 public employers across the U.S. have adopted domestic partnership policies. These include Seattle, Madison, Wisconsin, New York City, Washington, D.C., Los Angeles, Minneapolis, and San Francisco among others.

Domestic partnership policies are good business More than 100 private employers have voluntarily

adopted domestic partnership policies.
These include: Microsoft, Viacom International, Lotus Development Corp., Levi Strauss among

By adopting such policies, employers increasingly are recognizing the changing demographics of the American family. Only a small percentage of families now consist of a full-time

employed husband, homemaker wife, and children.
A significant percentage of families include unmarried heterosexual or Lesbian/Gay couples with and without children. Employers understand that providing benefits to these employees makes the same economic sense as it does to provide benefits to their married employees.

Myths and Realities

Insuring domestic partners is terribly expensive and they will bankrupt an employer's health care program because of the large number of claims.

Domestic partners are no more likely to use medical services than anyone else insured under an employer-provided plan. When they do use medical services, the cost of their care is statistically no different than of others insured under employerprovided health care plans. Myth

Domestic partnerships are mostly for Gays and Lesbians. Fact

Employers that provide coverage both for heterosexual and Gay/Lesbian couples, experience indicates that most of the couples signing up for benefits are heterosexual couples.

One AIDS death is so costly it would ruin an employer financially.

The average cost of treatment for a person with AIDS is about the same as for treatment of an heart attack (\$45,000 to \$50,000). Treatment for some common cancers is much more expensive and the cost of care for a premature infant can average from \$50,000 to \$250,000.

Health care reform will eliminate the need for domestic partnership policies because everyone will have access to medical benefits.

Health care reform may ease the need for domestic partnership policies by providing health care coverage for everyone, but it won't eliminate the

All employees need to be able to use their sick leave to care for their partner, or their partner's child, and to take bereavement leave upon the death of their partner or their partner's close family members

These and other "non-economic" domestic partner benefits will continue to be an important part of domestic partner policies.

ACT UP Protests Milwaukee's "Inadequate Response" to Last Year's Crypto Outbreak

(Milwaukee)- On April 7, 1994, more than 30 AIDS activists descended on Milwaukee's City Hall protesting what ACT UP says in the city's "inadequate response" to last year's Cryptosporidium outbreak that infected great numbers of people in the Milwaukee area.

The demonstrators, held signs condemning Milwaukee's inaction and yelled chants such as

"Stop Lying, People Are Dying."
Included in the group was an activist dressed up as Death and carrying a coffin. The coffin was later left in the office of Mayor John Norquist as a reminder of the 104 people who have died from Cryptosporidiosis.

One person, Christopher Fons, who has not yet succumbed, spoke at the demonstration while holding the IV pole from which his intravenous

nutrition was hanging.

Fons is a person living with AIDS and a member of ACT UP Milwaukee.

"One year ago today, I was a basically healthy, highly active person," Fons said. "That was before I was infected with Crypto. Since then, I've had constant diarrhea, lost 40 pounds and the energy that goes with it, and failed at absorbing most of what I ingest-including my oral medications that infections. I frequently don't have the energy to

leave the house--or get off the couch. Since December, I've been on IV nutrition because I can

no longer properly digest food."

ACT UP says that it is demanding justice for the 104 people who have died. They say that the City did not respond in an appropriate manner; that the City must admit that negligence occurred and make

ACT UP further demands that a boil advisory be issued for people with compromised immune systems. Since water standards were devised for healthy people, they say, these same standards do not necessarily guarantee the safety of water for people with compromised or damaged immune

Paul Nannis, Commissioner of Health for the City of Milwaukee, has refused ACT UP's demand to issue a boil advisory for people with compromised immune systems. "What about restaurants; what would they do?" Nannis asked.

ACT UP has denounced Nannis' refusal to admit that standards of water safely designed for healthy

people do not necessarily hold true for immune compromised individuals.

This just reinforces our belief that the City of Milwaukee doesn't care about people living with AIDS and other immunodeficiencies," said ACT UP's Yuri Keegstra.

Senator Rude is "Approachable" on Gay Marriages and Domestic Partner Issues

By Bill Steffenhagen

(La Crosse, WI)- "I am approachable on this ue," said Wisconsin State Senate President Brian Rude (R-Coon Valley) in a March 17 Light telephone interview.

The issue is the domestic partnership and Gay marriage legislation that will be presented to the Wisconsin Assembly by Rep. Tammy Baldwin (D-Madison), to which Rude expressed "serious reservations" in a previous Light report.

In that report, Rude stated flatly that he did not support such legislation, characterizing it as "special rights" and "extraordinary protection" for Lesbians and Gay men.

Baldwin responded by suggesting that such "total resistance... makes it harder for constituents

to approach him ."

While acknowledging that "Our society may be evolving and it may be that my opinion may be different in 10 years," Rude, in the March 17 interview, reiterated that he is "not prepared to cupport" the legislation, calling it "special whether support" the legislation, calling it "special treatment" and saying, "I question whether marriage is a fundamental civil right."

He went on to say, "I don't feel, reflecting the mores and values of a community I represent and the State of Wisconsin, comfortable with expanding

When Light pressed Rude as to whether marriage may be considered a public accommodation, Rude said that, "The judiciary must deal with that. I deal with the political situation rather than the legal."

Although Rude makes frequent use of the term "special rights" when discussing the issue of civil rights for Gay people, when questioned about Lou Sheldon's "special rights" attack on Baldwin's

planned legislation during the minister's recent

Wisconsin visit, Rude stated that the did not even know who Sheldon was and does not support "the far right's concept of 'special rights'."

As reported in a previous Light story, Sheldon has advocated the repeal of the Wisconsin law that bans discrimination based on sexual orientation.

"I do not support such a Rude told Light, repeal. It would represent open season on Gays." He added that he is "comfortable with the status

Man Claiming to Have AIDS Sentenced to **Prison for Biting Officer**

(Beloit, WI) AP- A man who bit a Beloit, Wisconsin police officer after claiming to have AIDS has been sentenced to six years in prison.

Charles Rucker, 32, also was sentenced on Monday, April 4, in Rock County Circuit Court to five years probation after he serves his sentence. Rucker pleaded guilty in February to first-

degree reckless injury and battery to a police officer. In exchange for the plea, a charge of attempted first-degree intentional homicide was

He initially pleaded innocent by reason of insanity after his June 6, 1993 arrest, but he was found competent to stand trial after a mental evaluation.

Police said Rucker bit an officer on the arm when officers responded to a domestic disturbance

Rucker yelled, "I have AIDS and you're all going to die" during the incident," police said.

Attempts Made in Hawai'i to Derail Court **Decision on Same-Sex Marriages**

(Honolulu, HI)- Hawai'i may be the last state to have entered the Union, but as it moves ever closer to being the first state to recognize same-gender marriage, a miracle of significant proportions is marriage, a miracle of significant proportions is unfolding. A Hawai'i State Supreme Court decision in May, 1993, set this miracle in motion.

In December, 1990, three same-sex couples applied for and were denied marriage licenses.

They then sued the State of Hawai'i for the right to marry. In July, 1991, the District Court dismissed the case, but the decision was appealed on the basis that the state's refusal to allow the couples to marry, "deprived them of access to a multiplicity of rights and benefits.

Hawai'i's miracle occurred two years later when the Hawai'i State Supreme Court ruled in favor of the same-gender couples. Writing for the majority, Justice Levinson agreed with the couples, reasoning that the state's refusal to issue marriage licenses to them unfairly deprived them of access to these rights and privileges. The Court ruled that the current ban violated the equal protection clause of the State Constitution that prohibits discrimination based on gender. In order to continue to deny marriage licenses to same-sex couples, the state must prove a compelling interest to the court.

State Attorney General Robert Marks is working to prove that compelling interest. The case is scheduled to be heard in April, 1995, but in the meantime, several legislators are trying to derail it through legislation to limit marriage to oppositesex couples. Final resolution of the case could take

If the Supreme Court ultimately decides in favor of same-sex marriage, Gay and Lesbian couples will be able to marry immediately. Couples from the mainland who marry in Hawai'i can seek recognition of their unions in their home states. Such efforts would set into motion a national same-sex marriage movement that could ultimately end up in the U.S. Supreme Court.

The Hawai'i Equal Rights Marriage Project
As the case began to take shape in the Supreme
Court, the couples formed the Hawai'i Equal Rights Marriage Project, now under the auspices of the Gay and Lesbian Community Center in Honolulu. Initially charged with securing victory in the

courts and raising funds to pay for the rapidly increasing legal costs, the project blossomed into a volunteer-run organization that educates the public, the media and the legislators about the case. The Marriage Project has worked diligently to counteract the work of the Religious Right Wing which has mobilized to block the movement for equal marriage rights.
Same-Sex Marriage in the Legislature

Some members of the State Legislature are determined to interfere with the judicial process. During the months following the Supreme Court's decision, State Rep. Terrance Tom held a series of hearings state-wide to sample public sentiment on the issue of same-sex marriage. Many in the Lesbian and Gay community felt that these hearings were an attempt to stir up anti-Gay sentiment to influence the case. Thousands of people throughout the state testified both for and against same-sex marriage.

When the Legislature convened in January, 1994, Rep. Tom quickly introduced a bill that proposed to limit marriage to couples who appeared to have the ability to procreate. Despite an outpouring of eloquent opposition testimonies at public hearings from such diverse groups as Native Hawai'ians, clergy from a number of denominations, civil rights and ethnic organizations, straights and Gays, the bill sailed through the House in a vote of 34-17.

At the hearings, religious fanatics railed against same-sex marriage and told legislators that Hurricane Iniki, which devastated the island of Kauai last year, was god's punishment. Following the rapid passage of the bill by the

Third Annual Bisexual Conference in April

(Minneapolis)- The Third Annual Bisexual Empowerment Conference, A United, Supportive Experience (BECAUSE), will take place in Minneapolis on Friday, April 22 and Saturday,

Begun in 1992 by a handful of Bisexual activists and sponsored by a coalition of Bisexual and Bi-inclusive organizations, initial outreach in the Minneapolis metro area has expanded to cover the Midwest region.

House, the Gay community quickly geared up for what seemed likely to be an equally speedy treatment of the bill in the Senate. Just ten days later, further public hearings were conducted.

Another bill was introduced that proposed a constitutional amendment to ban same-gender

This bill was especially threatening because it would change the state constitution's bill of rights to legalize discrimination. Dan Foley, attorney for the couples said that it "would be divisive to the community and a threat to all minority groups."

Through the intensive lobbying efforts of those

favoring same-gender marriage, many legislators who still opposed full marriage rights came to recognize the inequalities faced by same-sex couples, and urged the consideration of a domestic partnership bill.

A week later, yet <u>another</u> all-day hearing was held on a new Senate bill proposing domestic partnerships.

The domestic partnership bill, a virtual replica of Denmark's model and the most sweeping introduced to date in this country, sparked strong debate among advocates of same-gender marriage.

The bill would grant Gays and Lesbians most of the rights of marriage immediately until a victory in the court case would grant remaining benefits.

However, domestic partnership still falls short of the community's goal for full and equal marriage rights. "We see domestic partnership as an incremental step towards our final goal of equality in marriage," said Maggie Tanis, spokesperson for the Marriage Project, "but it's still a case of separate but unequal. We will not end our struggle

until we have achieved full equality."
With a majority of Senate Judiciary Committee members unwilling to support the domestic partnership proposal and the constitutional amendment, both bills were killed in early March. Still alive is the bill that would clarify state law to

allow only heterosexual couples to marry.

In an update, on Friday, April 8, is the deadline to move on the measure in time to have it acted upon this year. At this time, the legislators have been reduced to name-calling. Observers agree that if the legislature fails to act, it will be too late to have an impact on the court proceedings.

In the meantime, the Honolulu Roman Catholic

Diocese is frantically urging state lawmakers to get some sort of a bill enacted that would ban same-sex marriages. The bill that would make clear that marriage is between a man and a women would be the state's compelling interest, said Bishop Francis Dil.orenzo.

Given the controversial nature of the issue, will same-sex marriage actually become law? Foley is optimistic. "I feel good about the case," he said, but added, "We hope to prevail, but we can't assume

Marlon Riggs, **Award Winning** Filmmaker, Dies

(Oakland, CA)- The career of an acclaimed professor and filmmaker, who won Emmy and Peabody awards for his documentaries on Gays and

African Americans, has been cut short by AIDS.

Marlon Riggs died of the disease at his Oakland. California home on Monday, April 4, 1994. He was

Riggs began making documentaries in 1982 after receiving his Master's degree from the University of California-Berkeley's School of Journalism, where he later became one of the university's youngest tenured professors. He quickly earned national recognition, with the Public Broadcasting System airing several of his works.

His best-known documentaries -- the Emmy-

Louis W. Stimac, **Local Civil Rights** Fighter for Gays Dies

(Milwaukee)- On April 8, 1994, Louis W. Stimac died after a seven-year battle with throat cancer. He was 53 years-old.

Louis was a true pioneer in the battle for civil rights for Gay people in Wisconsin during the 1970's and early '80's. While he spent his first 8 years after high school in the St. Francis Seminary, he left there to live and work among his own Gay people. He was shortly drawn into the battle for

civil rights for Gays.

Perhaps Louis' greatest contribution to our community was the incorporation of the first Gay group in Milwaukee, the Gay People's Union (GPU) in 1971. He wrote the GPU's Articles of Incorporation, which forced the state to legally recognize the group. He was one of the four individuals who signed the required documents at a time when being publicly known as a Gay man usually meant losing your job and being arrested and beaten by the police. During his 10 years with GPU, Louis lectured

extensively across the state at schools and churches, using his vast religious and behavioral knowledge to refute the misconceptions of his audiences.

He was responsible for starting numerous support groups, the first Gay hotline in Milwaukee and the first Gay Alcoholics Anonymous meetings.

Louis was one of two openly Gay speakers at the first Gay Symposium on Sexuality and spoke twice a week on the city's first radio program for Gays. He was particularly proud of his work in educating ministers and priests about Gay people with funding secured from the Priest Synod.

Ethnic Notions and Color award-wining Adjustment, which won a Peabody-traced the media portrayal of Blacks through U.S. history.

A public television documentary he produced, Tongues Untied, about African American Gays, was used by the Religious Right in 1992 as an example of the type of art the government should

Ultra-conservative presidential candidate Pat Buchanan used a snippet from the film in a campaign ad showing Gay men dancing in leather

Riggs was one of the youngest people ever tenured at UC Berkeley in arts and humanities, said Tom Leonard, acting dean of the Graduate School of Journalism.

His mother, Jean Riggs, and partner, Jack Vincent, were with him when he died at his home, Leonard said.

Riggs also is survived by his father, Alvin Riggs, and sister, Sascha. The family members live in Arlington, Virginia.

After leaving GPU, Louis continued to foster After leaving GPO, Louis continued to toster positive alternatives for Gays, but in a smaller, more personal way. He allowed his home to become a safe haven for Gays who faced abusive families or who were simply in need of a place to feel comfortable with who they were.

Louis loved to cook for people. Every year he prepared and hosted a Christmas feast for friends and those who were not welcome in their own homes. During these years, Louis acted as a mentor to a number of up and coming activists who learned the importance of research, inclusiveness and visibility in activism. These people carry on his legacy today.

During the past ten years, one of Louis's greatest joys was his well-known video tape collection. At the time of his death, he had over 6,500 titles catalogued and available in his home.

Louis's family and friends will remember him as a generous and truly honest man who enriched the lives of all who knew him. He will be greatly

June 26 Stonewall 25 March in New York will be the Nation's Largest Human Rights

Demonstration Ever

By Stanley E. Ely ...recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world"

Though he does not choose not to name a figure, Franklin Fry believes that those gathered in New York City for the Stonewall 25 March and Rally on June 26th, will constitute the nation's largest demonstration ever in support of human rights.
"The March and other activities planned in June

are going to be far more than local or even national," said Fry, one of the three national co-chairs of Stonewall 25. "We've heard from people in 64 countries who are interested in coming—from every continent but Antarctica!"

Conceived nine years ago and officially called The International March on the United Nations to Affirm the Human Rights of Lesbian and Gay People, the March will commemorate 25 years since the Stonewall Rebellion, set off early in the morning of June 28, 1969 when Lesbians and African American and Hispanic drag queens spontaneously resisted arrest as police raided the Stonewall Inn, a Gay bar in Greenwich Village in New York City.

It was dramatic and unexpected, an uprising that continued for three days and is generally acknowledged to have given birth to the modern movement for Lesbian and Gay civil rights in the

Once this June's events were announced, a trickle of individual inquiries began to arrive at the Stonewall 25 office--from Chile and Zimbabwe and Kazakhstan. Before long, those turned into communiques like the one advising that a group of 100 plans to come from Argentina.

"The latest count expected from Australia is 700-800," said Fry, beaming. "One person even is coming from Croatia to march as an openly Gay man. Imagine--amid all that he's going through in

his country."
"We're creating the word 'Stonewall' for the first time in other languages," Fry declared.

The relationship between Stonewall 25 and the United Nations emanates from the Declaration of Human Rights, which was adopted by the UN General Assembly in 1948. (Eleanor Roosevelt. who authored the document, was then the US representative to the UN's Human Rights Commission.)

This year's March officially calls on the UN to take all necessary action to assure (among other things) that "the promises of the Declaration not be denied to Lesbian, Gay, Bisexual, Drag and Transgender people.

Although Stonewall 25 counts eight executive committee members across the country, organizing the event has been the effort of many grass-roots local organizations. Groups around the United States are sponsoring activists wishing to come from developing countries.

Activities are planned from Los Angeles to Tel Aviv, and large Gay Pride parades in such places as San Francisco, Milwaukee, Chicago, St. Louis and Houston, normally scheduled for the same time as

sometimes.

Stonewall 25, have been moved forward this year so that residents of those cities can attend their own

and the New York event.
The New York City Heritage of Pride Parade, which last year drew some half a million people, will be replaced this year by the Stonewall March.

To underscore both the local and global nature of the event, and to accommodate a potentially immense crowd, the noon June 26th March will start from two locations, one from the United Nations on the East Side of Manhattan, the other from the site of the original Stonewall Inn in the Village, with the two converging for an afternoon rally on the Great Lawn in Central Park.

The Rally itself will feature eleven international

speakers chosen from their respective continents.

Thus, according to Fry, "The Asian message will be given by Asians selected in Asia."

The Rally will also project a number of video clips of highlights of the Lesbian and Gay civil rights movement over the past quarter century. International human rights activists and peace prize winners have been invited either to come or to send

their messages.

June will truly be bustin' out all over New York with other activities surrounding the June 26th March.

Gay Games IV will receive an expected 15,000 athletes during the week of June 18-25.

The night of June 25th, will see a candlelight march in the Village around the site of the original

New York City will also host at least 20 national and international events including, among others, a conference of the Gay and Lesbian Association of Choruses; the National Lesbian and Gay Health Conference, a combined concert of 500 musicians from the Lesbian and Gay Bands of America; an International Lesbian and Gay Association convention, a National Gay Pilots Association convention, and a Legacy of Stonewall exhibit at

the New York Public Library.

"Our biggest challenge now is to raise money," said Fry, who was named to his committee post after having managed several New York City Heritage of Pride marches and rallies. "The entire package is estimated to cost \$2 million."

Stepping back to reflect on the event, Fry said, "No one had any idea what the ripple effect would be of some courageous drag queens who refused to be intimidated by a police raid in 1969. Yet look what that rebellion sparked.

"At this point we can't know what long-range effect Stonewall 25 will produce either. But through it, thousands of people will take forward the message of human rights abuses that Gay men and Lesbians suffer around the globe as oppressed

"When that man from Croatia goes back to his country, he'll have experienced something that will prompt him to try to change things.

The subways are intimidating, but they're the cheapest, fastest and best way to get around the city. And they go everywhere. I kid you not. No matter where you are or where you want to go, there's a subway station within a block or two.

turnstile. Don't dilly-dally. You'll get shoved from behind. (Comments may be made about your parentage as well).

The trains are noisy and not the cleanest things in the world, although I'm told that's changed. But they are safe. Honestly, I've ridden on them uncounted numbers of times and never had any trouble at all.

One thing though. I do avoid them in the wee hours. Just a precaution, that's all.

New York taxies are famous--or infamous-depending on who you talk to. They go with the speed of the wind and ignore all the rules. Believe

To hail one, get out into the street, stick your arm out and shout TAXI for all you're worth. It's the only way. And don't be polite. I've elbowed more than one competitor (female or male),out of my way, got in, slammed the door shut and forgotten about them.

Generally, New Yorkers are a friendly bunch but not when it comes to getting a taxi. Be nice and you'll end up walking or stand, dripping in the rain. Make sure you pick a medallion cab. They're

yellow and have an alpha-numeric four digit medallion number on the roof.

If the medallion is lit up, the cab is available. The only exception to that is if the little "off duty" signs on either side of the medallion are lit too. Then, the cab is just like it says, "off duty

A New York cabby talks-and talks, if they know English and sometimes even if they don't. They know their city backwards, forwards, up and down. Don't be afraid to ask.

For some reason, I've found that a lot of the cabbies are Gay. Young and gorgeous types, Asians, Africans, Hispanics, men from the Middle

God, those were good times!

Buses? Forget them! They're just too unbearably

But above all, walk! There's really no other way to really see the city.

New York is wonderfully easy to get around.

Just remember that the streets go east-west. The lower the number, the further downtown you are.

The avenues go north-south.

The island is split into east and west by 5th Avenue. Officially it's known as The Avenue of the Americas, but don't you call it that. If you want people to think you've been to Manhattan before, call it "5th Avenue" call it "5th Avenue.

Things to Remember
As I said, New Yorkers are a friendly bunch, but

take some precautions. Always walk determinedly and look like you know where you're going. Keep your head up, don't make eye contact. It's a wise rule to follow.

If someone stops you to ask for the time or a hand-out, just ignore them and go on your way.

Honestly, some of the street people can be pathetic. They use animals or even little kids to get your sympathy, but ignore them.

3) On nearly every street corner in the city, there's one version or another of the old shell game. Stop and take a look if you will, but don't get involved. It's fixed. You can't win--and you may lose a lot more than you bargained for.
4) As a general rule of thumb that's good in

situations, just remember, "This isn't Wisconsin anymore.

5) Don't walk around gawking up at the skyscrapers. Manhattan's canyons are fascinating, but try and be discreet. You've seen tall buildings before, haven't you?

6) Don't run around wearing a lot of jewelry That means earrings (the long dangling kind), necklaces or things of that sort. Anything that

glitters is considered to be gold.

7) Don't ever pull out a wad of money when making a purchase. A few small bills are always

I wouldn't even begin to recommend places to eat. But I would, if I were you, try and find some time to take a walk through Little Italy and Chinatown, both downtown.

Those places, both of them, are a wonder of

sights and delightful places to get something to eat. The prices are "relatively" inexpensive and you'll have a good time.

A Few Sights One of the best "buys" in town, is the Staten Island Ferry (or as someone said to me once, "We even have our own navy!") It's 50 cents one-way and worth every penny.

From up on Christopher Street, why not walk downtown and take in Wall Street and the World Trade Center on the way. Shortly you'll reach Battery Park. You get the Ferry there

The view from on deck, no matter the weather, is incomparable. To your rear is the New York skyline. To your right is the East River and Brooklyn. To your left is the Statue of Liberty and beyond that, the Jersey shore.

Staten Island is worth a peek, but if you're in a hurry, get off, pay your 50 cents for the return trip and get back on again.

There are other things too that I would not miss. By all means, go to Macy's on 34th Street. Oh, I know, Bloomies and the rest are great, very Yuppie. But Macy's should not be missed. It's the largest

department store in the world.

Of course, take in the Empire State Building.
That's tradition. But you'll get a better view from the top of the World Trade Center.

Take a tour of UN headquarters. It's worth a

look-see and the gift shop is delightful. Want good clothing (all styles) and the absolute best possible price? Go downtown, to the east, to Orchard. You'll find discount clothing and shoe

stores for days, not to mention shops selling just about everything else that's ever been made on Have tea and little cakes (all I could ever afford) at the Palm Court of the Plaza Hotel. My dear, it is

just tooo traditional and so elegant you'll die.

I haven't even begun to scratch the surface with this little account. You'll have to see for yourself. Would I want to live there? Not on your life! Do I like to visit New York? You bet!

If, like me, I was last there, I checked to see that what I'm about to say still holds good--very good, you like it black, you have to say that's what you The Village
All Greenwich Village, or "the Village" as it is commonly known, is divided into two parts: the East Village and the West Village.

At the end of Christopher Street, at the Hudson River, is the Pier. It's a great, long expanse stretching out toward Hoboken. On sunny days, it is loaded with people sunning themselves and

cruising up a storm. Time was when you could pick someone up and adjourn beneath the pier and . . . Or just head into one of the bars. There was always a back room. But

I hear that's all gone now--or mostly, anyhow But God, underneath those piers was busy!, especially late at night.

Now that I'm on the subject, there was a time when I didn't know you played pool on a bar pool table. You couldn't if you wanted to. They were always too busy, too occupied.

Time was too, when I would highly recommend a visit to the Mineshaft, not too far away. But that's

Still, I remember the first time I went there, maybe two, three in the A.M. It was my first time. There was only one way to prove to the doorman I was Gay, so I did it and got in

There are hustlers all over the place. Be careful. But if you must cruise them, one of the places to do it is the Port Authority Transit Building (the bus station) up on 42nd Street. The second floor is very active. You'll see them standing, trying to look casual, along the railing overlooking the first floor.

The men's room on the second floor used to be "wide open." But I'm told that's changed now. I'm also told that the Port Authority is well

patrolled now, so again, be careful.

If you're interested in outdoor action, go to the "Rambles" in Central Park during the day. wooded area set up on a low hill, cris-crossed with dirt paths secluded by big rocks.

Somebody said that it's sleazy. Yeah, I guess it is. I thought it was exciting, but I was a lot younger

Some Tips About New York New York City can seem as intimidating as hell-and in some ways, it is. But don't be afraid of it.

New Yorkers walk fast, very fast. I am not kidding about that. In Chicago, going along State Street is a leisurely stroll. In New York, along Broadway, and everywhere else, you either keep up or get out of the way.

Yes, I know. New York City is dirty-or so it will seem. As one person said, here in Milwaukee you could eat off the streets. In New York you're afraid to eat off the plates. So, accept it, ignore it and don't complain.

Everyplace you look is Gay.
As always in New York, the people here are half the show. On a nice warm day-or night (New York never really does sleep), you'll see every kind of gorgeous hunk (both sexes) that has haunted your fevered dreams. And most of them won't be wearing too much. What you don't see, they point to kind of thing.

One thing that I think is worth remembering

He was expelled from the seminary, but not for being Gay. He put on the seminary talent show in mother.

The stories themselves are not the only things

McGivern's animated face, expressive voice, and wicked comic timing illuminate his tales. Perhaps best of all, he avoids the temptation to turn this into a confessional.

You never get the sense that McGivern, who calls himself a "Recovering Person," felt peculiaror persecuted-for being Gay. He doesn't blame or complain. He is who he is and these are his stories.

Ultimately, they are our stories too-the child who believes she'll never please her parents, no matter how hard she tries; the son struggling to understand why his father was so rigid, so controlling; the adult who reclaims his life with the

intervention of those who love him.

Connections pop through the audience like flashbulbs and laughter abounds.





I hate to say it, but I remember the customs then, and the <u>prices</u> of things.


I can't say I recall how patriotic everyone wasor was supposed to be--but I guess they were, the adults, I mean.

John Waters New Film, 'Serial Mom', More Likely to Amuse than to Offend

(New York, NY)- They could have formed the world's most fashionable rock 'n roll band.

On vocals: the 300 pound bodacious beauty, Divine Lead guitar: leering David Lochary, his hair dyed silver. On bass would have been strung-out Danny Mills, and snaggle-toothed Edith Massey would have played the drums. Producing and writing the songs: John Waters, the "Pope of Trach"

But instead, Waters and friends made movies, starting with 8mm films in the '60's and culminating in such low-budget orgies as Pink Flamingos and Female Trouble. From the streets and trailer parks of Baltimore, they brought a way of life to the screen that included incest, bestiality necrophilia and the conspicuous consumption of

dog do-do.
"I'm proud of those movies," Waters said during a recent interview. "Somebody told me their first date was at Pink Flamingos. They got married and named their baby Divine

"I had no idea, technically, how to make a movie. I was just learning how to do it . . . It's like looking at home movies, like looking through our parents' photograph album. Our movies was how we caused trouble. Looking back on it, I thank God we had that outlet. What would have happened to

Much of the old gang is gone now. Divine died shortly after Waters' mainstream breakthrough, the 1988 release Hairspray. Massey and Lochary already had died. Waters himself is in his mid-40's, and admittedly not the same man who used to spend his free time at murder trials.

His latest film, Serial Mom, stars Kathleen Turner as a sweet Baltimore housewife who makes obscene phone calls and finds increasingly lethal ways to dispose of those who threaten her happy home. The subject matter-murder, families, a dog sucking on a woman's toes-is vintage Waters: the atmosphere is relatively new.

What helped make Pink Flamingos and other early features so unsettling was a raw, grainy quality that made you wonder if the makers really disapproved of what they were portraying. With Serial Mom, the distance is clear. "Straight" people rather than "freaks" speak most of the lines. The tone is ironic rather than subversive, more

likely to amuse than to offend.
"My attack is a little less hostile now, and a little more playful," Waters said. "I'll buy the true crime books and I'll see the true crime movies. I go to murder trials. But I have changed because in the old days, I went more for sensationalism and it ended up with me teaching in jail, which I took fairly seriously.

So now, some of the outrageous things I've said about murder trials, I don't feel anymore. It's exploitive of some of the people I have talked to in jails. I never told the stories of my students in jail-some of them are fairly notorious--where in the old days I would have. I got into it more.'

Waters was born in 1946, grew up in an upper-middle class family in suburban Baltimore and attended a Catholic high school. By college, a brief enrollment at New York University, he was dropping acid and was hooked on low-grade horror

Suspended from NYU for smoking pot, he returned to Baltimore in 1964 and shot his first 8mm short, A Hag in a Black Jacket, and followed it with Roman Candles and his first 16mm feature,

Eat Your Makeup.
The casts for his recent movies have combined holdovers from the old days--notably red-headed

Stole--with campy "legitimate" actors. Sonny Bono and Pia Zadora appeared in Hairspray and Patty Hearst and David Nelson were in Cry Baby. Serial Mom stars two genuine Academy Award nominees, Turner and Sam Waterston.

"I have no problem with movie stars. I can get along with them. I want 'em. I had to create my own because I couldn't afford them. Just my friends

were movie stars," Waters said.

He will not, however, work with just anybody.

Fame is the highest of callings and his tastes are suitably discriminating. Included on his good list are Hearst, Zadora and Joey Heatherton. On the bad list: Tony Harding ("I don't really

respect her"), Zsa Zsa Gabor ("I think she' déclassé") and Katherine Heburn. (She takes herself too seriously.")

"There's only one real movie star left, living in America, and that's Lana Turner. She's the best of all. She had the on-screen life, the off-screen life. She's my favorite of all."

Editor's Note: Wisconsin Light was fortunate enough to be granted an interview with Divine when she was in Milwaukee in 1988 to appear at Club 219. This was the last known interview that she granted to the press.

The Oscar is a "little shot in the arm for the ailing Spanish film industry," Culture Minister Carmen Alborch said.

Belle Epoque, which is directed by 39-year-old Fernando Trueba, is the sweet story of sexual encounters between a young army deserter and four sisters in pre-Franco Spain. The soldier is played by Jorge Sanz and the sisters by Penelope Cruz, Maribel Verdu, Ariadna Gil and Miriam

Spanish director, Antonio Gimenez Rico said the Oscar is "a prize for Spanish cinema and, given the difficult times we're experiencing, benefits all of us."

Spanish films account for only about 9 percent of the receipts at Spanish movie houses, according to Culture Ministry figures. American films bring

in more than three quarters of the revenues.

The situation led the government to take steps in December-to promote Spanish movies, including the requirement that theaters show a greater percentage of films made in the European Union-a move that drew loud protests from theater owners.

In December, Spain and France led the fight to exclude the film and TV industries from the General Agreement on Tariffs and Trade, the accord designed to guarantee the free flow of goods among member nations. France and Spain argued that without subsidies and other protection, their moviemakers would be swamped by

Hollywood productions.

"This recognition from the Academy in Hollywood should serve to confirm our enthusiasm for adopting measures—not only legal measures, but also steps by the movie industry itself—to continue the fight," Alborch said.

"When there's a good, well-told story, with imagination, genius, good acting and good directing-and tied to our culture and our historythe final result can be this kind of splendid recognition," she said.

Not everyone was convinced the Oscar would send positive ripples through the Spanish industry,

Rafael Azcona, one of the writers of Belle **Epoque**, was happy the film won the Oscar, but couldn't hide his pessimism. "Spain has won it before and nothing happened," he said.

In 1972, the French production, The Discrete Charm of the Bourgeoisie, directed by Spaniard Luis Bunuel, won the Oscar. Hollywood was always hesitant to give honors directly to the Spanish industry while the country was ruled by dictator Francisco Franco, who died in 1975.

The only other Spanish Oscar was for Jose Luis Garci's 1983 film Volver a Empezar.

Hundreds of Attacks on Artistic Expression Proliferating Across the Country

(Washington, D.C.)- Hundreds of attacks on artistic expression are proliferating in communities across the country, from campuses to shopping malls to public buildings. These are the findings of Artistic Freedom Under Attack, Volume 2, a new report released late last month by People for the American Way

Controversies over art are proliferating on the state and local level. The report identifies challenges to artistic expression in 43 states, including Wisconsin, and the District of Columbia.

The report's numerical breakdown of complaints about art reflect extremes of public sentiment on social issues. The leading complaints given in mounting challenges to art were as follows

Nudity or sexual material, 50% Alleged anti-religious content, 16% Art about or associated with Gays and

Lesbians, 13% Art alleged to be sexually harassing, 6 % One example of an attempt at censorship that

failed occurred in Oshkosh, Wisconsin. Community members and students in Oshkosh condemned the use of a Michelangelo fresco as a high school yearbook cover because it included

male nudity The scene, from the "Creation of Adam" on the Sistine Chapel was termed "degraded" and "disgusting" because it showed frontal male nudity.

The figure of God was shown without having The local newspaper received letters condemning the artwork, considered as one of the finest works of art in the world, as "pornographic." One writer said that serial killer Ted Bundy had been inspired to commit his crimes after looking at

"pictures of nude people." School Board member Fred Boss agreed, saying,
"It surprises me what passes in the name of culture" and called for the removal of the yearbook advisor,

Jack Talbot. Talbot responded, saying, "If this is good enough for the Sistine Chapel, it should be good enough for the Oshkosh West yearbook."

No changes were made in the yearbook and neither Talbot nor his staff were disciplined.

While the censors failed in Oshkosh, they succeed most of the time elsewhere. According to the report, challengers succeeded at a rate of 63% of incidents reported.



Hispanic communities, to broaden their customer base in order to get more money to fund organizations that repress those communities."

Bellant says that the Coors family has done more than donate a portion of its fortune to the Far Right. It has also assumed a personal leadership role, he said.

Some of the Coors family members sit on Boards of radical right organizations in addition to holding seats on the Coors Board of Directors. According to Bellant, they help these groups by

raising funds, planning strategy and networking.

Among the Coors-supported groups, the Council for National Policy (CNP) seems especially ominous. Bellant says the CNP has tried to be very secretive about its agenda, membership, activities

Bellant said the CNP Board includes several Coors family members, in addition to employees of the Adolph Coors Foundation and the Coors

Brewing Corporation.

Bellant charges "The CNP is composed of the most extreme ultra-right wingers in the country. One of its members is a former leader of the Indiana KKK. We know they meet at least four times a year. This is where the leaders of the Religious Right all meet with members of the Coors family there."

Levy, Bellant and others say that the Coors family is not content with funding today's Right They and their foundations have also provided money to organizations geared towards

authored Spiritual Warfare: The Politics of the Christian Right, has uncovered a large group of Right Wing college-based organizations funded in part with money provided by the Coors family. Diamond says that in 1990-91 alone, \$160,000 in Coors money was given to these groups

The Institute For Educational Affairs (IEA), now led "Madison Center for Educational Affairs (MCEA)," is one of the organizations supported, in part, by Coors money. Among its major projects has been the establishment and expansion of a "Collegiate Network" of Right Wing college

campus papers.

The Network was started in 1981 and now includes 70 such papers.

Bellant charges that this organization works to Network papers. The group sold ads in all the Network's papers for Coors Brewing.

Bellant and others say that MCEA also helps to place Right Wing college journalists in positions where they can be of influence. It specifically

targets newspaper editorial boards, government agencies and other positions where they can help the Radical Right get its message across.

According to The Bay Times, the list of far right groups benefiting from the Coors family fortune includes: Reed Irving's Accuracy in the Media, the John Birch Society, the National Christian Educators, University (founded and run by Pat Robertson), and

others, including HF and FCF.
On the same day that the Bay Times published the first in a series of articles entitled "Rocky Mountain Venom, Coors and Queers," the company issued a press release that claimed it was "among the most progressive Fortune 500 companies regarding the rights of Gays and Lesbians, following the criteria developed NGLTF."

Coors said it has instituted a non-discrimination

a diversity training program and policies forbidding discrimination against employees who are HIV+. In addition, the company said it has donated \$275,000 to AIDS groups over the last six

spokesman as saying that he believes the company spokesman as saying that he believes the company "has been more progressive on this front than either of our major competitors or any other company in the beverage industry

NGLTF's response was a strongly worded press release of its own. NGLTF called the Coors employment policies "a smoke screen designed to divert attention from the company's long history of funding extreme right wing activity targeted against people of color, labor and Gay Americans.

NGLTF's Smith who wrote the release, said, "While we are supportive of the Gay and Lesbian employee group working for change within the company, it is important to note that the Coors press release failed to mention the anti-union, anti-Gay, anti-civil rights agenda of the Coors family that profits from each sale of a Coors product. Smith called Coors' claim of a progressive record "outright deceit."

Coors claim to be "more progressive" than either of its two major competitors is a matter of opinion. Activists familiar with the record of the Milwaukee-based Miller Brewing would hotly dispute the Coors claim. According to Miller sources, Miller's programs

have contributed over \$1.8 million to the fight against AIDS over the fast two years, and hundreds of thousands more to Gay and Lesbian sporting

events, pride celebrations and arts groups.

Miller has the same non-discrimination policies that Coors claims and has had them longer.

Miller's diversity shows in its management. It has a number of high level management positions filled by openly Lesbian and Gay individuals.

There are two other major differences between

Miller and Coors.

Miller doesn't have a formal Gay and Lesbian employees group, but Milwaukee activists familiar with the company say that it doesn't need one. Being Gay or Lesbian has never been an issue with the company

Furthermore, Miller has always had a supportive stance on Gay and Lesbian issues.

Kingston says that after representatives of Coors approached The California Association for the Coors approached The California Association for the Coors approached The Coors app Pride, Inc., a group of Lesbian/Gay Pride organizers, the organization voted to reject any Coors donations.

Even some newspapers in the cash-starved Gay and Lesbian press hold Coors at arm's length.

According to Kingston, in early 1994, when Coors representatives tried to talk with San Francisco's three Gay papers, only one, The Bay Area Reporter, was willing to meet with them.

Coors company representatives insist that their company is being unfairly treated. They say that while the Adolph Coors Foundation makes contributions to radical right wing groups, the company itself does not. They contend that the Gay community should be open minded about their

There is no evidence that the Coors company makes direct cash contributions to the Far Right,

They charge that the Coors family does that for Coors by funneling part of the Brewery profits into the radical right wing groups.

Says NGLTF's Smith, "In effect, a percentage

of every dollar spent on a Coors product goes directly to radical organizations that attack this

country's Gay population.' Bellant agrees. "The family's wealth depends on the profitability of the brewery and without that wealth, they wouldn't be able to provide leadership for the Radical Right. The Coors family is the foremost Right Wing family in America and it's their businesses that allow them to be so."

Chip Berlet, an analyst with Political Research Associates, points out that members of the Coors family control both the company and the Coors

Berlet, who tracks Right Wing money, told The Bay Times, "If you know the route of the money and how influential that money has been in building the Right, I don't see how you can find that argument (that the company and the Foundation are different) palatable."

Coors was heavily damaged by a 1975 boycott led by Gays, Lesbians, African American groups, Hispanic organizations and labor unions. The boycott cause Coors' profits to plunge from \$67.7 million to \$44.7 million.

Coors decided to make peace. It signed

agreements with Hispanic and African American

According to The Bay Times, the cost of the peace was high for Coors. The company promised to make an annual donation of \$500,000 to Hispanic groups and another \$500,000 to African American organizations. The company also agreed to invest in minority communities and to deposit \$3 million in African American-owned banks.

In response to Gay and Lesbian complaints, Coors did agree to stop asking prospective employees about their sexual orientation and giving polygraph tests. It would also add a nondiscrimination statement to its personnel policies. It

even formed a Gay and Lesbian Employees group.

Bob Burgess, a former Coors Marketing
Executive and author of Silver Bullets: How
Coors Bombed in the Beer Wars, told the Bay
Times that Coors has an excellent PR staff that can be credited with its improved reputation. "Whatever Bill Coors says, they have 100 people to say that he didn't mean that Coors has learned that lesson very well," Burgess said.

Kingston says, "If you want your money to go to a company whose profits benefit owners who donate to the Far Right and whose politics are less than Gay-sensitive, then go ahead and drink the beer. But just think where your money's going. Everybody has a responsibility in this, the bar owners do, the customers do, we all do." Conservative activist Bob Moore, thinks that

people should have the option to choose, but he also believes they should choose products for positive rather than negative reasons.
"I prefer Miller over Coors," Moore said, "not

because I don't like Coors beer, but because of all the support Miller has given to our community."
Miriam Ben-Shalom, nationally known activist,

says she has tried Zima and likes it. Now that she knows the product is brewed by Coors, she is resolved not to purchase it.

"I am angry that even one penny of my money has gone to Coors," Ben-Shalom said. "I think they are trying to deliberately hide their connection with Zima."





(San Francisco)- Scientists already know that infection with HIV can lead to cancer by weakening the immune system. But a new study suggests the virus causes cancer directly, by switching on cancer genes in the cells it invades. The finding could lead to better treatment for both AIDS and cancer. But it also raises doubts

both AIDS and cancer. But it also raises doubts about the safety of some forms of gene therapy and casts a cloud over scientists' goal of creating an AIDS vaccine.

AIDS has been associated with certain types of cancer, including lymphoma and Kaposi's sarcoma, that most researchers believe take advantage of the

weakening of the immune system. But in a study released on April 8, 1994, researchers at the University of California at San Francisco found that when HIV inserts its genetic material into a cell's DNA, it can apparently activate a nearby cancer-causing gene.

That gene then starts up a less common variety of lymphoma, non-B-cell lymphoma, though the exact mechanism remains a mystery, Drs Michael McGrath and Bruce Shiramizu said. "This is the first direct evidence that we have a

human virus causing cancer through some mechanism-not just indirectly by immunosuppression," McGrath said.

Dr. William A. Blattner, chief of the viral epidemiology branch of the National Cancer

Institute, called the finding an important step in understanding how a retrovirus--the class of virus that includes HIV--can cause cancer.

Dr. Dawn Willis, a virologist and scientific program director for the American Cancer Society, said the link between HIV and cancer was always considered indirect because no one had ever found HIV in a cancer cell before. The discovery could suggest research in tracing the role of viruses in

But the study also casts a cloud over the goal of creating a live virus AIDS vaccine. The study's authors and other scientists fear such a vaccine could trigger cancer genes while halting AIDS. More broadly, the study raises questions about

the use of any retrovirus in a vaccine, as well as their increasing role in the new field of gene therapy. Retroviruses can be used to carry a gene into an organ to correct its functioning.

"This causes a lot of concern over the use of retroviruses for anything--for vaccines or even gene therapy," McGrath said. "Hooking up a gene to a retrovirus and then infecting human cells might risk

on active duty. The others are reservists.

Lambda and the ACLU say that the statute and regulations create an elaborate system under which all Lesbian and Gay male service members are not judged on their fitness and ability to serve, but are

instead subject to discriminatory treatment because of the perceived prejudice of others.

"The American public has been hoodwinked into believing that these rules are somehow more 'relaxed' and fair than the old policy," said Ruth E. Harlow, Associate Director of the ACLU's national

Lesbian and Gay Rights Project.
"The truth," added Kevin Cathcart, Lambda's Executive Director, "is that the law and regulations are more clearly than ever based entirely on prejudice and therefore unconstitutional."

Gay Leaders Throughout the Country **Condemn Promotion of Pedophilia**

The current controversy over the membership of the North American Man/Boy Love Association (NAMBLA) in the International Lesbian and Gay Association (ILGA) raises in sharp relief the question of what boundaries, if any, should be drawn around the Gay and Lesbian rights movement. predicament is prompted by the Clinton Administration's threat to seek the revocation of ILGA's consultative status in the United Nations Economic and Social Council (ECOSOC) if ILGA does not oust NAMBLA at ILGA's 16th World Conference in New York this coming June. ILGA's leadership has stated its intention to seek NAMBLA's ouster which under ILGA voting rules requires an 80 percent majority.

NAMBLA's Position

Fairness obliges us first to consider NAMBLA's own words. The October, 1993 issue of NAMBLA Bulletin, which I bought from D.C's Lambda Rising bookstore, is a 16-page, professionally laid-out publication containing news articles; letters, including one from an imprisoned pederast; an interview; a first-person essay about a man meeting an abused boy of about 12 on a bus trip; an ad for two photography books; and several photos of boys (mostly shirtless) who appear to be between the ages of eight and thirteen. The masthead displays the emblems of both ILGA and the Gay and Lesbian Press Association. The following is the opening of an article titled "Where We Stand":

"The North American Man/Boy Love Association is both political and educational. We work to organize support for boys and men who have or desire consensual sexual and emotional relationships and to educate society on their positive nature. We speak out against the oppression endured by men and boys who love one another ...

The author of the first-person essay says lamentingly of society, "They would rather (the boy) go to an abusive mother than to a man who loves boys.'

A common thread running through this material is an inability to recognize a conflict of interest. These men really seem to believe that they have the boys' best interests at heart, despite clear evidence from their own accounts that they are taking grotesque advantage of troubled boys' need for love, attention, support and freedom from abuse. Their subtler form of abuse directs an adult's arsenal against the innocence of children and the nascent sexuality of young adolescents and, when it succeeds, calls the result consensual love. That people so selfish should presume to lecture others about love, much less portray themselves as victims, is a supreme achievement in self-delusion and gall.

Consenting Adults: A Foundation of Our Movement

The NAMBLA activists and their supporters assert that those who oppose them have simply caved in to our society's anti-sexual attitudes and "homophobic pressure orchestrated by the American Right wing." This begs the question of what responsibilities we are prepared to assume along with our sexual freedom.

For a long time, the idea of "consenting adults" has been one of the foundation stones of our movement. For ILGA to refuse to defend this principle against an assault from within its own ranks would be not only political suicide, but an abdication of leadership at the very moment when its consultative status in ECOSOC has enhanced its opportunity to lead. ILGA has a right, in fact a responsibility, to defend itself and its mission. This is not to say that all efforts to reform age of consent laws should be opposed; but NAMBLA opposes setting any age of consent.

At any rate, as Rep. Barney Frank (D-MA) has observed, "It's not a Gay issue — as long as the age of consent applies equally regardless of sexual orientation.

Youth to be Protected, not Exploited

Recent years have seen an increase in organized efforts to protect Gay and Lesbian youth rather than exploit them. These include strongly youth-oriented Gay and Lesbian community centers in many cities. These organizations nurture the future of our movement; by supporting their work, not only do we help to protect sexual minority youth, we serve as role models.

seldom character Tests accommodate themselves schedule. In the case of NAMBLA, not to decide is to decide. By canceling the membership of NAMBLA and other pedophile organizations, ILGA would not denying anyone's right of self-expression, but exercising its own. It is time to tell NAMBLA and its kin to express their views elsewhere, without the benefit of ILGA's assistance or its

ILGA's Those who consider breakthrough toward visibility and participation in the U.N. "a meaningless symbol of their own self-importance" clearly do not comprehend the magnitude oflga's opportunity to advance the cause of Gay and Lesbian civil rights in the world. Anyone who would throw that away deserves the company of the self-serving denizens of NAMBLA.

British Seek Additional "Tales of the City" Sequel Funding As PBS Backs Out

(San Francisco)- AP PBS has pulled the plug on a miniseries sequel to Armistead Maupin's Tales of the City, which met with high ratings and sporadic controversy when PBS aired it in January.

The sequel was to have been partially financed by Britain's Channel 4, which paid virtually the entire cost of the original miniseries. American financing, chiefly from PBS, was to account for about half of the More Tales production costs. Scripts for the six installments were recently

On Thursday, April 7, Maupin accused PBS of knuckling under to conservative pressures, especially because the sequel was to deal directly

with civil rights for Gay people and Christian Right
Wing opposition to equality.

Donald Wildmon, a Right Wing minister from
Tupelo, Mississippi, a long-time opponent of
anything having to do with Lesbians and Gays, last
month urged members of his American Family
Association to contact their congressional Association to contact their congressional representatives to protest the use of tax dollars for Tales of the City.

Citing Tales of the City and other programs with Lesbian and/or Gay themes, Wildmon said PBS should be called "The homosexual pride taxfunded TV network."

Maupin said that although he discounted on's individual influence on PBS, Wildmon's "apparently in their eyes the controversy it (Tales of the City) generated somehow outweighed the critical praise and overwhelming public response it

Wide Acclaim
Tales of the City was widely acclaimed by critics and was PBS's highest rated dramatic

miniseries in at least a decade

PBS spokeswoman, Karen Doyne, confirmed that PBS has decided not to pursue production of More Tales of the City, but said Maupin's comments "couldn't be farther from the truth."

Doyne said that "provocative programming is nothing new to PBS." She said the decision not to finance a sequel was made for budgetary reasons, and added, "Doing a popular program doesn't mean we're going to do it again and again." "For them (PBS) to deny that they're running

scared at this point is preposterous," Maupin said, "because I think that's exactly what they're doing."

In the Works

Although Doyne said PBS had never committed to More Tales of the City, Maupin and other

sources said PBS was strongly supporting preparatory steps for the sequel in recent months.

Maupin said More Tales of the City, which was originally serialized in the San Francisco Chronicle, deals, in part, with the Michael Tolliver character coming out of the closet to acknowledge. character coming out of the closet to acknowledge that he is Gay to his parents, who, in turn, have joined Anita Bryant's "Save Our Children"

campaign against Gays.

The issues addressed in the book and prospective miniseries are "very much alive today,"

Maupin noted that PBS has experienced a change in leadership since its initial interest in More Tales. Ervin Dugan, a former Federal Communications Commission member from South Carolina, became president on February

In his brief tenure at PBS, Dugan has emphasized public television's mission to broadcast educational programming, especially for children, and public affairs programs. Doyne said however, "He's also talked about our on-going commitment to drama."

Nevertheless, PBS has slashed the budget of the American Playhouse series, under whose banner Tales of the City was broadcast. Lindsey Law, executive producer of American Playhouse, said the budget was cut from \$6.6 million this year to \$2.2 million for 1995 and nothing at all in 1996.

American Playhouse recently formed a forprofit partnership with Samuel Goldwyn Pictures to produce films for theatrical release and later for broadcast on PBS, apparently as a means of keeping the series alive on television. Law said of the More Tales decision, "The

money side is easy to figure out. I'm not going to

have any money, so how can I do it?"

Law said PBS was enthusiastic about a Tales sequel as recently as January, but added that PBS's new president "may indeed want to ruffle fewer feathers." But he said he had heard nothing to indicate any particular fear of More Tales of the

Doyne said the decision not to finance More Tales of the City was made independently of the

decision to slash the American Playhouse budget.

Alan Poul, who produced Tales of the City when it was filmed in Los Angeles and San Francisco, said he expects Britain's Channel 4 to seek a new American financial partner for the sequel.
