National Civil Rights Movement Finally Turning Its Attention to Gay Americans

Decades after its birth, the civil rights movement is finally turning its attention to Gay Americans.

For 30 years the movement has piled up countless victories for minorities and women, the elderly and the disabled and the ill. All the while, it's remained legal in most of the country to discriminate against Lesbians and Gay

But a landmark debate is about to begin.

A bill banning job discrimination against Gay people is the first Gay cause to be embraced by the larger civil rights community. And a Senate hearing on the measure scheduled to begin July 19 will mark the first time an issue involving civil rights for all Gay people is to be aired on Capitol Hill.

The Labor and Human Resources Committee will hear from people whose sexual orientation cost them their jobs. A disabled Republican will testify, along with the chairman of the U.S. Civil Rights Commission, supportive union and corporate witnesses and possibly the assistant attorney general for civil rights.

National Battle Over Inequitable AIDS **Funding Heats Up as Negotiations Begin**

(Milwaukee)- In a major break-through for Wisconsin's on-going national struggle for equitable AIDS funding, final negotiations on the shape of a new Ryan White CARE Act are set to begin as Wisconsin Light goes to press, July 21, 1994.

Representatives of the historically power-ful Title I CAEAR Coalition and the Wisconsin-led Campaign for Fairness are scheduled to begin the talks in Washington, D.C. on funding formulas that will direct national AIDS funding over the next five years and potentially change the national AIDS constituency.

We have worked hard to gain national recognition of the massive inequities in Ryan White funding," said Doug Nelson, Executive Director of the AIDS Resource Center of Wisconsin (ARCW), who originated and continues to lead the Campaign for Fairness.

"It has been a struggle to get to the table, but these negotiations are a victory of sorts in that they represent an acknowledgment that Ryan White inequities must be corrected,"

Henry W. Maier Dies at Age 76; Was Milwaukee's Mayor for 28 years

Signed Gay Anti-Discrimination Ordinance

Known as the "mayor's mayor" for his leadership on urban issues, Henry W. Maier died at age 76 on July 17, 1994, reportedly of complications due to pneumonia. He served as mayor of Milwaukee from 1960 to 1988, setting a City Hall record for longevity in that

Maier graduated from the University of Wisconsin-Madison in 1948, served in the Navy, and then embarked on a career in politics. In 1950, he was elected to the Wisconsin State Senate, where he became Democratic floor leader. He left the Senate to become Milwaukee's mayor.

Maier entered that office with a plan focusing on urban renewal, economic development, improved city finances and greater government efficiency. Despite weaker powers, he strengthened the office of mayor through careful appointments of department heads.

Maier earned a Master's degree in political science while in office and became one of the country's leading urban spokesmen. In the 1960's and 1970's, he called for a reordering of national priorities and increased funding to save America's cities from disaster. He served as president of the National League of Cities, the U.S. Conference of Mayors, and the National Conference of Democratic Mayors; and chairman of the National Coalition of Urban

During the open housing marches of the 1960's, Maier argued for a metropolitan-wide fair housing ordinance instead of one covering just the city, saying that fair housing limited to the city would only speed up the migration of whites to the suburbs. He called suburban zoning ordinances, which essentially ruled out low-income housing "fundamental declarations of intent that Negro citizens are condemned to ghetto imprisonment."

Milwaukee's ghetto rose up in a riot on July 30, 1967. Maier ordered a drastic citywide curfew, which limited the violence to a

Maier also maintained an on-going battle

with Milwaukee's two daily newspapers. Today, Maier might be most fondly re-

membered for starting Summerfest. He first proposed the idea in 1961. The first fest was held in 1968. In 1969, in keeping with Milwaukee's tradition of singing mayors, Maier wrote and performed the "Milwaukee Summerfest Polka.

In 1980, Maier signed a controversial oron sexual orientation for City of Milwaukee jobs and for firms that contract for city busi-

After 28 years as mayor, Maier declined to run again and left office in 1988. He continued to teach and write on urban issues.

He is survived by his second wife, Karen Lamb, Ph.D. by his two daughters by a previous marriage and his grandchildren.

Wisconsin Light: Tell me a little about yourself. For example, are you from Wis-

Scott Evertz: Washington, D.C. Born and bred there. My father was an Eisenhower appointee which is what brought the family there. I've lived in Milwaukee since 1980, a significant chunk of my life. I came here to go to Marquette [University], majored in political science and theology, and basically never left. I got involved in politics right about the time that I left Marquette. I like being involved in politics on the grass roots level.

WL: Are you running as an openly Gay

SE: Yes, yes. I'm running as an openly Gay Republican man. I will be openly Repubdinance prohibiting job discrimination based lican in the Gay community and openly Gay in the Republican community.

WL: What made you decide to run for the legislature?

SE: First, is my interest in serving the people of my district. But also, a key reason is that it is true that the State Assembly is probably going to go Republican in this next


I think what is real important is for there to be a voice representing the concerns of the Gay and Lesbian community in that new majority. The present State Representative in our district is the Assistant Majority Leader and that status will disappear when the Republicans gain control of the Assembly, which it would appear that they're going to do.

So, I've worked with a number of the Republican legislators who are in Madison right now. I work well with them and I feel there would be at least an open door and an open ear to my concerns as they relate to Gay and Les-

The Gay and Lesbian Victory Fund has said that not until we have seats at the table are our rights truly protected. And while we have friends who 99% of the time vote our way, it is only Gay and Lesbian elected officials who we can count on to vote our way 100% of the time. And that's another key reason I'm run-

WL: What do you see as the leading is-sues that you'll be addressing in your cam-

SE: Well, it would appear that the key concerns of district residents outside of the Gay and Lesbian issues (which are significant because of the significant population of Gay and Lesbian people in the district). But beyond that, the issues that concern most state residents are property taxes, welfare reform, and

They think property taxes are too high. They think something needs to be done with the welfare system. I feel it (welfare) is enslaving the population. It's not doing what it was intended to do.

When it comes to crime, our district encompasses some of the worst wards, if you will, in the entire state.

Judge Says Boy Scouts Discriminated

San Diego-AP- A judge awarded \$5,000 to a Boy Scouts leader who was expelled after revealing he is Gay. California's civil rights law prohibits the Scouts from discriminating against Gays, Superior Court Judge Anthony Joseph ruled on July 7. "Public acknowledgment of homosexuality does not translate into 'teaching' that homosexuality is proper or improper," the judge wrote. He declined, however, to order the reinstatement of Chuck Merino, a 38-year-old police officer, until the Boy Scouts held administrative hearings. The Boy Scouts plan to appeal

Colorado Gay Pride Parade Attracts Thousands

Denver-AP- Gays, Lesbians and their friends and allies, including actress Carol Channing, turned out on July 10 for a parade, rally and festival in Denver in numbers the police estimated at 30,000. Channing said she was proud of her "Gay and Lesbian friends and their hard work in fighting against Amendment 2"

The event started with a parade in Denver that featured nearly 1,000 participants and at its conclusion at the state Capitol, a crowd listened to speeches by Gov. Roy Romer, Denver Mayor Wellington Webb and Channing. Channing gave her personal "Diamond Award" to Webb for his work as a "statesman." "We are all one people," Webb told the Gay crowd. "We have a right to be treated equally."

Cammermeyer Warmly Welcomed Back

Camp Murray, WA-AP- Col. Margarethe Cammermeyer, who returned to her post two years after she was discharged for being a Lesbian, says she will adhere reluctantly to the military's new "Don't Ask, Don't Tell" policy. Cammermeyer, 52, said her first weekend back as chief of nursing services for the Washington National Guard's 164th Mobile Army Surgical Hospital went smoothly. Cammermeyer said her colleagues weren't uneasy or awkward. In fact, she was greeted with cheers and smiles from all ranks of command, she said at a news conference. "Over the last few days, I have experienced a tremendous openness and willingness for me to return to work."

Studds Challenges CDC Officials on HIV

Washington, D.C.-AP- Rep. Gerry Studds (D-MA) challenged statements made on July 12 by the government's top health officials that progress has been made in preventing HIV infection. Studds sharply questioned the officials at a hearing of the House Energy and Commerce subcommittee on health. They estimated that between 800,000 and 1 million Americans are infected with HIV. "I believe that the numbers are not going up suggests that we probably are making some progress with our community prevention efforts," said Dr. David Satcher, the new director of the federal Centers for Disease Control in Atlanta.


Studds retorted, "Do you really believe that? Every number I've seen, every community that we're concerned about, has increased." While there has been a dip in HIV infection among adult Gay men, it is increasing among young people, Studds said. "I would briefly conclude that we don't have a clue basically," he said. "It clearly...is increasing among people of color in the inner city; it appears to be increasing among young Gay people again... Where the hell is it decreasing?"

AIDS Spreading Quickly In India

New Delhi-AP- AIDS is racing through India just eight years after the first case was detected. More than half of the male and female prostitutes are estimated to be infected. In northern India, 70% of the estimated 30,000 intravenous drug users have become HIV positive. The National AIDS Control Organization estimates that there are 1.62 million cases in the population of 880 million, up 60% from 1993. In five years, the numbers of people infected with HIV will be, it is estimated at 10 million and growing. Most AIDS experts dismiss the official estimates as absurdly low.

Madison's Club 3054 Owner Reportedly Agrees to a 90 Day License Suspension

Madison-AP- Sheri Becker, the owner of Madison's Club 3054 and Wings, has agreed to a 90-day suspension of the liquor license for her East Side establishment, the chairman of Madison's Alcohol License Review Committee

Michael Lawton said that the Committee would meet on July 27 to vote on the suspen-

Club 3054 was cited as a "disorderly house" after undercover police officers said several men had unprotected sex with each other in the bar's basement during "underwear night" promotions February 24 and April 7.

The Committee has already voted 4-2 to reject a stipulation calling for a 60-day suspension of the license and ordered the city attorney's office to try and negotiate a 90-day suspension. The alternative would be a public hearing likely leading to revocation of the bar's license, Assistant City Attorney Rick Petri said.

Petri and Becker's attorney, Richard B.

Jacobson, initially reached agreement on a stipulation calling for a 60-day suspension of the bar's license and 12 other concessions. But a majority of the Committee thought the actions of the bar warranted a 90-day suspension, the maximum penalty short of revoking a liquor license.

Alderman Tim Bruer, who made the motion to increase Club 3054's suspension to 90 days, said the other concessions of the original stipulation will be enforced.

Among other things, they call upon Becker to start the suspension on the day after Labor Day; close the basement area of the bar indefinitely; submit herself for an alcohol and drug abuse assessment; and complete any treatment that is recommended and keep the bar open to outreach workers presenting safer sex information and AIDS testing.

Bruer said any violation of the stipulation would lead to a swift revocation of the bar's

liquor license.

Madison's Magic Picnic Weekend Was a Mixture of Queer Politics and Party Spirit

(Madison)- Queer politics and a party spirit hit Madison last weekend (July 15-17) with a series of events culminating in a march down State Street on Sunday afternoon.

The weekend kicked off with the 10% Dance at the Great Hall of the Memorial Union at the University of Wisconsin-Madison. The Great Hall was at capacity by midnight after people attending the sold-out Indigo Girls concert arrived.

Saturday, July 16, was the Magic Picnic. This annual event was held at Brittingham Park from noon to 6:00 p.m. Hundreds of people were in attendance, standing in line for food and beer and dancing in the shelter to even the rain.

Sunday morning, July 17, the UW Lesbian, Gay, Bisexual Alumni Council held its 3rd brunch for LesBiGay alums.

The event was attended by 250 people including State Representative Tammy Baldwin (D-Madison), Congressman Barney Frank (D-MA), author, Evelyn Torten Beck (Nice Jewish Girls), and Clinton appointee Bruce Lehman. Beck and Lehman were honored with the "Alumnae of the Year" awards.

Sunday afternoon was the GALVAnize March on Madison. Approximately 1,000 people attended the pre-rally where Tammy Baldwin delivered an important message.

"We must take strength in the fact that our fight is about one of the most fundamental freedoms that exist. The freedom to love," Baldwin told the enthusiastic crowd.

"It is about our right to love the people we love," Baldwin continued, "without having it called illegal; our right to love who we love without having it called immoral; our right to love who we love without having it called illegitimate.

"Because there is nothing about the love that we feel that is immoral, illegal or illegitimate. The love we have is a gift to this community, this state, and this nation and it is something for which we must fight without apology," Baldwin said.

The march down State Street was celebratory, marked by a single protester. The United, the Madison AIDS Support Network, the University United Methodist Church and Bi? Shy? Why?, all boasted large contingents. The post-march rally at the Library Mall culminated a celebratory weekend with music and comedy.

Attendance at most of the events was less than expected. The smaller numbers are at-

tributed to a number of factors including poor publicity, questionable weather and weary activists, tired from a Summer of marching and rallying. Despite these concerns, however, many enjoyed the weekend.

"I think the 'Magic Weekend' was a great success," said march participant Tracy Prouty. "It is always important that our community come together, to support one another and be visible in the city of Madison."

Barry Goldwater and Oregon Gov. Roberts Join Others to Fight the Radical Right

(Washington, D.C.)- Retired Senator Barry Goldwater (R-AZ), Oregon Democratic Governor Barbara Roberts and a team of leading political strategists have joined a campaign launched by the Human Rights Campaign Fund (HRCF) to fight the Religious Right in states where anti-Gay ballot initiatives are being used on the state and local levels to institutionalize discrimination.

The Radical Right's takeover of state and local Republican Parties is just the tip of the iceberg," said Stacie Spector, director of the campaign, Americans Against Discrimination. "They seek to institutionalize discrimination and produce a narrow agenda of intolerance.

Anti-Gay ballot initiatives are being used by Radical Right groups to raise money and turn out the extreme Right Wing vote."

Goldwater and Roberts have accepted the position of honorary co-chairs of the campaign. They will provide advice on strategy and political support.

"I support equality for all Americans and an end to discrimination based on sexual orientation," Goldwater said. "I also oppose the misuse of the initiative process by extremist groups to institutionalize discrimination.'

While their rhetoric focuses on Gay people, the Radical Right's agenda is much broader," said Tim McFeeley, HRCF's executive director. "Radical Right groups seek to roll back progress on civil rights, freedom of choice, freedom of speech and other freedoms," he said.

McFeeley noted that the Religious Right's agenda is sponsored by a network of political groups working to elect extremist candidates. They want to carry their divisive agenda all the way to the White House," he said.

'Don't Ask, Don't Tell, Don't Pursue' One Year Later Gets a Failing Grade

(Washington, D.C.)- With the arrival of the first anniversary of the Clinton Administration's new policy on Gays in the military, a national legal aid organization is giving a failing grade to the way it is being imple-

Under the "Don't ask, Don't tell, Don't pursue" policy announced last July, military officials are not allowed to ask troops about sexual status or launch investigations without credible evidence of homosexual acts. But military commanders and investigators continue to question recruits and servicemembers about their sexual orientation, launch investigations without evidence, and seize personal possessions. And suspected Gays face severe harassment, physical violence, and the end to their careers.

"A year into the new policy, witch hunts and rampant harassment continues," said Michelle Benecke of the Servicemembers Legal Defense Network (SLDN), which provides legal services to men and women in the military. "For many service members, the situation is even worse than before. The consequences of illegal and intrusive investigations has been harsh. In reality, the new policy should be called 'ask, force to tell, and pursue.

One of the few positive things we can say about the last year is that it has clearly demonstrated that Gay people can serve openly in the military without causing any problems, said Benecke. "Largely due to court orders, nearly 20 Gay men and women are serving openly with distinction and contributing to the mission of the armed forces.

Their stories prove that the true threat to morale and unit cohesion are the disruptive witch hunts--not the presence of Gay people in

Vietnam War veteran and Army Colonel Margarethe Cammermeyer, whose unit telephoned her to welcome her back to duty after a judge ordered her reinstated.

Air Force Captain Richard Richenberg, who currently faces discharge even though he is ranked at the top of all Air Force officers. Richenberg's co-workers, in sworn affidavits, have flatly denied that his sexual orientation would have any negative effect on their mission accomplishment.

Navy Lieutenant Zoe Dunning, another top officer, who has served openly since January, 1993. A former commander and her colleagues have testified that the disclosure of her sexual orientation has "had absolutely no detrimental effect on the unit." Dunning faces a discharge board under the new policy on July

Cook said Thorne's "statements that he is a homosexual raised the presumption of homosexual conduct." He said the statements "clearly create a rebuttable presumption that the officer engages in homosexual acts or has a propensity to do so.

In Bangor, Washington, another board of

inquiry recommended the honorable discharge of Machinist's Mate 2nd Class Mark A. Philips even though a Navy officer had closely

questioned the sailor about his homosexuality. And in Norfolk, Virginia, a third board of inquiry recommended the honorable discharge of Lt. j.g. R. Dirk Selland.

The board of inquiry's recommendation to discharge Thorne will be submitted to a review board and then will be reviewed by Dalton, who is not bound by the recommendation. Dalton is not required to act on it within a specific amount of time, but "the idea here is to do this as expediently as possible," said Navy spokesman Lt. Bill Spann.

Georgia's Cobb County Becoming a **Battleground in the Fight Against Bigotry**

(Marietta, GA)- With two framed copies of the Ten Commandments draped sandwich board-style over his shoulders, an old man strolled one recent morning across the town square of Marietta, Georgia.

"I could be at home in my easy chair, watching TV. But they took the Ten Commandments out of there," W.B. Musselman said, pointing to the Cobb County courthouse. 'I'm putting some life back into it.

The retired Baptist preacher from nearby Woodstock is not alone in picking Cobb County to make such a statement. With its resolution condemning Gays and a court fight over a Ten Commandments display, Cobb is now marked as an epicenter in the battle over 'family values.'

The county's very name has become in some quarters synonymous with its anti-Gay resolution, approved by the County Commissioners last August.. The resolution officially declared homosexuality to be incompatible with community standards.

The resolution was written originally in opposition to the Atlanta City Council's approval of legislation allowing Gays to add their partners to their city insurance program.

This has garnered the county national and international attention because of the 1996 Olympic Games. Marietta is due to be the site of the volleyball competition.

On July 8, Greg Louganis, an Olympic gold medal winner, and who is openly Gay, told an audience that included U.S. Olympic officials that the volleyball competition should be taken out of Cobb County.

'I'm concerned about some of the athletes who are scheduled to participate in the volleyball preliminaries," Louganis said. "In addi-

tion to the normal pressures of competition, Gay athletes who are participating in the preliminaries will have the added pressure of knowing that they are not welcome in Cobb

Louganis made his remarks after receiving the Robert J. Kane Award in St. Louis which honors athletes who had success at the U.S. Olympic Festival and continue to give back to their sports.

Observers generally understood that the U.S. Olympic Committee was sending a strong message to all Olympic athletes and to Cobb County by giving the Kane Award to an openly Gay athlete.

On Wednesday, June 13, Billy Payne, chief executive of the Atlanta Committee for the Olympic Games, announced that the committee was "very close" to moving the preliminary volleyball competition out of Cobb. He told a news conference that a decision would come by the end of the year.

In the meantime, recent weeks have witnessed competing rallies by clergy opposing and supporting the resolution, a mock volleyball competition by the Lesbian Avengers in the Marietta Square and a news conference by Cobb County Commission Chairman Bill Byrne's daughter to announce she's a Lesbian.

Alan Tucker, who owns a shoe repair shop in downtown Marietta, said the commissioners are meddling in areas they don't belong.

If they put the energy they put into this resolution into a good cause--say, the homeless, battered wives--just imagine what they could do," Tucker said.

But Tucker's response may not be typical. The County Commissioners say phone calls are running "30-1" in favor of the resolution.

Submarine Commander Describes Day Gay Officer Came Out

(Norfolk, VA)- The day after President Clinton took office, Lt. j.g. R. Dirk Selland went to his commanding officer on the submarine USS Hammerhead

Selland started talking about his "lifestyle," Commander Carl Hesslinger re-

"He appeared uncomfortable" and said he hated to bring bad news to his commander, Hesslinger said.

Finally, a chaplain sitting in told Hesslinger what Selland couldn't quite get out--Selland is Gay.

Hesslinger ordered Selland off the craft that night in January, 1993. And on Tuesday, July 12, 1994, Hesslinger was the opening witness at a board of inquiry that will recommend whether the 25-year-old Selland should be discharged from the Navy

Hesslinger said Selland didn't expect the Navy to take action against him because of the new President's pledge to lift the ban on Gays

Selland's case under the "Don't ask, Don't

tell, Don't pursue" policy.

Selland's admission to his commanding officer "raises a presumption that he will engage in homosexual acts in the future," said Lt. J.D. Secor, the government's attorney in the case.

Toni Ianniellu, one of Selland's lawyers, said the government can't assume that a person will engage in homosexual conduct from a simple admission of being Gay.

Selland said he expects the board will recommend his dismissal. His lawyers plan to go to court to challenge the constitutionality of the policy. Selland is assigned to the Atlantic Fleet supply center until the case is resolved.

Selland had excellent performance evaluations from the submarine's previous commander, but Hesslinger described Selland's performance as the "Hammerhead's" supply officer as "abysmal."

However, under cross examination, Hesslinger acknowledged talking Selland out of a transfer and into staying on the "Hammerhead." "He was in trouble professionally, but that was not the way to deal with it," Hesslinger said.

Navy Lieutenant Tracy Thorne Suffers

Setback in Navy Discharge Decision

(Washington, D.C.)- A lieutenant who declared that he is Gay on national TV, said on July 15 that he hopes Navy Secretary John Dalton will let him stay in the Navy, but if that doesn't happen, that the courts will side

A Navy board of inquiry recommended on July 14 that Lt. Tracy Thorne be discharged. He and his attorneys said they will challenge the Clinton Administration's "Don't ask, Don't tell" policy in federal court.

"I certainly hope that Secretary Dalton exercises his judgment to retain me in the service, because if not, I will simply be discharged because of the fact that I told the truth,' Thorne said on July 15 on ABC.

Asked if he would take the matter to court

if that doesn't work, Thorne said, "I certainly hope I don't have to, but the courts have shown that they're not going to let this prejudice stand and they're going to allow people to serve their country honestly

Thorne, 27, a former member of the

Navy's "Flying Tigers" bomber squadron, became on the first military Gays in recent times to publicly disclose his orientation when he appeared on ABC's "Nightline" in May, 1992. His case has become a major test of the "Don't ask, Don't tell" policy which took effect March 1, 1994.

He was followed by a flood of other Gay servicepeople.

Thorne acknowledged on July 15 that he has never stated whether he has made love to another man, but denied that he was splitting legal hairs as he accused the Navy of doing.

I just feel that my private life is my private life, and when I come to work, I leave my private life at home," Thorne said.

After the board's courtroom announcement at the Washington Navy Yard on July 14, Thorne told reporters, "I am confident that this policy will eventually be overturned when it's reviewed on its face.

"Is this Terry Boughner?" the voice asked on the phone. I said that it was. "Will you hold for Mayor Maier?"

It was a cold and snowy January day in 1987. I looked in questioning wonder at Jerry sitting across the room and at our two guests.

There was a click and then a gruff voice came over the wire. "This is Henry Maier."

He had called to thank me for a letter I'd written him offering a suggestion about a symbol for the city that he wanted Milwaukee to

was Gay and who was probably not. As it turned out, he knew as much about the subject, if not more, than I did, sobering indeed to a writer's ego.

There were other occasions, after he left office, when he had a little more time to talk. I sat, fascinated, as he spoke of having lunch with THE Mayor Daily of Chicago; of his having met President John F. Kennedy, of his marching in the civil rights marches of the '60's and his knowing Dr. Martin Luther King Jr and so much, much more.

You've got to understand, I'd only read

We talked for awhile--or rather he carried most of the conversation. I was too dumb-struck. After all, I'd lived in Pittsburgh for over 40 years and in all that time, I'd never even laid eyes on the Mayor, must less spoken with him. But here, when I'd been in Milwaukee less than six months, the Mayor was calling me.

Jerry told me I'd been honored. I thought so too, as did our amazed guests.

Incidentally, my suggestion (for some kind of triumphal arch a-la Paris) was not followed, but Mayor Maier had won a friend for life.

about these people. He'd met and worked with them--and so many, many others. He was living history, a wonderful reservoir of lore from one of the country's most turbulent times.

He could and did make these people and events come alive, speaking in technicolor as a good teacher would. My only wish now is that I'd had the presence of mind to take notes.

But you see, always, always, I thought there would be plenty of time for that. No more do I regret my lost opportunities than now when I write.

It was a year or so later, just before Mayor Maier left office. Jerry and I went out to his house. We were going someplace (I forget now where) with his wife, Dr. Karen Lamb.

Mayor Maier met us at the door. "She's not ready yet," he said, "but come on in."

I remember thinking, "My god! This is the Mayor and we're two Gay men. Now what?

He shushed the dog and took us into the kitchen, a warm and inviting place. "Hear you're publishing a book," he said to me. I nodded, indicating that I was. He asked what it

"Gay history," I answered, feeling a catch in my throat. Intimidated? You bet I was. I'd come out to a lot of people, but never to someone like him, not in close quarters, any-

But then, we started to talk-or rather, he did. Had I looked up this person or that? Did I know President Buchanan was Gay? "He's from your state, wasn't he?"

Before I could answer, he dashed upstairs to get some books, while I looked at Jerry

open-eyed. But he could only shrug.

Mayor Maier shortly returned, arms laden with a variety of volumes and soon we were busily discussing who in the world's history

Once Jerry asked me what I thought of Mayor Maier. I told him that to me, he was the Grand Old Man of Wisconsin politics, a character, a Milwaukee original in the best sense of those terms. As such, in my mind, he was a combination of Boston's fictional Frank Skefington and Bay City's very real Mayor Honey Fitz.

The Mayor Maier I knew was not just a maker and participant of history. He was also a man of high and searching intellect. He couldn't have cared less whether I was Gay or straight, but only what was in my head.

I remember him too as a kind man, a man full of good humor, a person of considerable understanding of what it was like to be a member of an oppressed minority.

He signed the Milwaukee ordinance making job discrimination against Gays and Lesbians illegal. The Sentinel's Ken Lamke in his analysis of Mayor Maier's career, conveniently forgot about that. Typical, I suppose, but Moior Maier would have understood.

"You Gays," he told me once, "have your battles to fight. I've fought mine too. You'll win I did"

It seems that the question of "Outing" is one that just will not go away.

For example, a recent article in Newsweek on Rep. Steve Gunderson's re-election bid

93QFM; Blame the Callers, Not the Hosts

TO THE EDITOR:

In your last issue, you published an open letter to the community from Mr. Jeff Lynch. As you explained, this letter was actually mailed to the Advertising Director at WQFM radio, with a copy to the Light.

The subject of the letter was a segment of the 93QFM morning drive-time show which aired on June 27, 1994. This show is hosted by a zany crew of three people known as "MC and Those Sports Guys." The three announcers are MC (Mary Christine), Rob and Mitch. The premise of this show is discussion about various topics among themselves and with people that call in to the show plus and occasional rock and roll tune here and there for color.

Many of the topics discussed involve sports, thus the name of the show.

As you can imagine, when there is live discussion on the radio by as many as five people at one time, anything can happen. Generally, a subject is brought up and discussed for about forty-five minutes to an hour with several breaks for commercials, music and news during that time.

It appears that Mr. Lynch did not listen to the entire discussion that morning.

It started at approximately 7:35 a.m. and ended at 8:30 a.m. The announcers asked heterosexual men to call in to the show and describe experiences in which another man had approached them for a sexual encounter. A very provocative and touchy subject isn't it?

I listened to the entire segment of this show and I feel that the hosts handled the callers and the subject very well. The words "harass" and "harassment" were never used by the announcers (or any of the callers for that matter).

The word "recruitment" was used by one of the callers, not the hosts, and all three of the announcers were quick to beat the caller up on the recruitment thing when he brought it up. That particular call ended when the announcers hung up on him and then dished him royally along with his obviously contrived story.

The talk flies thick and fast on this radio show. The three hosts are well-versed in sarcasm, irony, tone of voice and the art of conversation. You really have to listen closely to this show to catch everything.

I have been a regular listener for about one year and I really enjoy it. Telephone calls to the show are screened, of course, but the announcers really don't have much control over what the caller might say once he or she is actually on the air. Don't get me wrong, the hosts were asking for trouble by getting into that particular subject and they got some too. Perhaps if he had heard the entire broadcast, he would have had a more balanced platform from which to draw his conclusions.

I feel that the broadcast was insightful and hilarious. If my opinions differ from Mr. Lynch's and are not "politically correct", then so be it.

I urge the members of our community to listen to the show and form their own opinions.

93QFM professes to be a radio station that is for the <u>whole</u> community and they do a fairly good job of it. Some people are going to like it and some will not, no matter what.

I also urge the members of our community to listen and react to the other radio stations in town, such as WVCY and WISN, among others. Some of the hosts and announcers on these other stations trash us regularly.

The Time Is Now For Gays and Lesbians to Support the National Non-Discrimination Act

By Senator Edward M. Kennedy

At all critical stages in the history of a free people, forces of oppression must be confronted in order for the frontiers of justice to be extended. For America, the time has come again. For Gay men and Lesbians, the time is now.

Just recently, a million Americans gathered to commemorate the 25th anniversary of Stonewall, the first milestone in this long journey on freedom's road. The civil rights movement is on the march again, moving closer to the American ideal of liberty and justice for all.

A great deal of progress has been made in the past quarter century. Although many miles have been traveled, there are many promises yet to keep. They are promises to a cook in Georgia fired for being a Lesbian; to a postal worker in Michigan beaten unconscious by coworkers for being Gay; and to a truck driver in New Hampshire, a stock broker in Maryland, a social worker in Mississippi, and countless other Americans—all fired because of prejudice despite their productivity and performance. Such flagrant discrimination is wrong, and it is time to fight back.

That is why, along with 30 of my Senate colleagues and 115 House members, I have sponsored the Employment Non Discrimination Act of 1994. Our bipartisan legislation will extend existing federal protections against job discrimination to Gay men and Lesbians, and give relief to those living in fear of losing their livelihoods. Our bill will send a strong message to employers and all Americans that homophobia will not be tolerated as employment policy anywhere in the nation.

This is not about granting special rights--it is about righting senseless wrongs. Our case is strong--our cause is just--and we intend to prevail.

"Injustice anywhere is a threat to justice everywhere." Dr. Martin Luther King, Jr.

Polls show that the vast majority of Americans agree with us that Lesbians and Gay men should not have to face discrimination in the workplace. Many Fortune 500 corporations have already included sexual orientation in their non-discrimination policies. Eight states and more than 100 municipalities have acted to ban discrimination against Gay men and Lesbians.

By joining Congressmen Barney Frank and Gerry Studds and myself at the press conference introducing this legislation, Coretta Scott King affirmed this action as the next chapter in America's civil rights history. She said, "I support the Employment Non-Discrimination Act of 1994 because I believe that freedom and justice cannot be parceled out in pieces to suit political convenience. As my husband, Martin Luther King, Jr said, 'Injustice anywhere is a threat to justice everywhere'."

But the fact remains that in 42 states, qualified Lesbians and Gay men with excellent records can be fired--with no warning--just for being Gay. It happens every day, and it is up to us to stop it.

Let's be clear--the Radical Right will leave no stone unturned to block the enactment of this essential legislation. Our own commitment must be even stronger. To ensure success, we need your active support and assistance.

Being right is good, but it is not enough. We need to mount a major effort in order to prevail. We must inspire the complacent and convert the skeptical. To make this bill a reality, we need you to take the following action steps now:

Goldwater Speaks Out Against Anti-Gay Job Discrimination

(Washington, D.C.)- Former Republican Sen. Barry Goldwater, who last year proposed lifting the ban against Gays in the military, is urging Congress to approve legislation protecting Gays against job discrimination.

"Job discrimination excludes qualified individuals, lowers work-force productivity and eventually hurts us all," the former Arizona senator said in a column first published in the Washington Post on July 13.

"Topping the new world order means attracting the best and creating a workplace environment where everyone can excel," Gold-

Goldwater, one of the country's most conspicuous conservatives, surprised some when he urged the government to life the ban against Gays in the military in a June, 1993 Post opinion piece.

18 Wisconsin AIDS Deaths in June

(Madison)- Eighteen Wisconsin residents died of AIDS and 23 new cases were reported in June, a state agency reported on Friday, July 8.

The total number of confirmed AIDS cases is 2,414 and the total number of deaths is 1,334 since state reporting of the disease started in 1982, said Gerald Whitburn, Wisconsin's health and social services secretary.

That compares to 1,925 confirmed cases and 997 deaths due to AIDS a year ago at this time, Whitburn said.

"You don't need to be 'straight' to fight and die for your country," he said then. "You just need to shoot straight."

In the July 13th article, Goldwater, the 1964 Republican presidential candidate against Lyndon Johnson, argues in support of a bipartisan coalition in Congress that has proposed legislation outlawing job discrimination against Lesbians and Gay men.

"Congress is waking up to a reality already recognized by a host of Fortune 500 companies, including AT&T, Mariott and General Motors," he said. "These businesses have adopted policies prohibiting discrimination based on sexual orientation because they realize that their employees are their most important asset."

Discrimination hinders America's struggle to reduce the deficit and compete in a global economy, he said.

"It's not just bad--it's bad business,"
Goldwater wrote. "In urban and rural communities, hatred and fear force good people
from productive employment to the public
dole--wasting their talents and the taxpayers'

In the essay, Goldwater speaks out against the Radical Right, but assures the public he's still a conservative Republican who believes in democracy and the separation of church and state.

"The conservative movement is founded on the simple tenet that people have a right to live life as they please, as long as they don't hurt anyone else in the process," he said.

"No one has ever shown me how being Gay or Lesbian harms anyone else," Goldwater added

Kristine Gebbie Resigns as President Clinton's AIDS Coordinator

(Washington, D.C.)- Her clout and competence under attack, Kristine Gebbie is resigning as President Clinton's AIDS coordinator, saying she faced "conflicting expectations of what an AIDS czar could do."

Gebbie said on July 8 that her successor in one of the hottest spots in national health policy "must have the tools necessary" to win the confidence of people suffering from the deadly disease.

Many AIDS activists contended she clearly had not accomplished her goal and said they were delighted with her "mutual agreement" with Clinton to leave the job on August 2, 1994.

In her resignation letter, Gebbie told Clinton, "In assessing the contributions I have been privileged to make, the issues being raised about how the office could be more effective, and the changes which are necessary to keep your agenda moving, I have decided to leave this position at the end of this first year."

AIDS activists, led by ACT UP have long contended she did not have the requisite authority for the job. Her office was condemned for falling far short of Clinton's campaign promise to appoint what amounted to an AIDS czar with immediate access to the White House.

Gebbie maintained that she did have access to the White House. As to being an AIDS czar, she told Light that that wasn't her concept of what her office should be. Her duties were more to educate people, she said.

Gebbie was criticized for not having immediate access to members of Congress and the Cabinet. She maintained that she could "talk to anyone, any time."

When Light reported that she had her office over a McDonalds' and that attempts to find out her office number from the White House were fruitless because no one knew what it was, Gebbie's office responded in an-

Milwaukee AIDS Project (MAP) Executive Director who is a member of the National AIDS Council Board and who participated in the growing national movement calling for Gebbie's resignation, was both ecstatic and relieved upon learning that Gebbie was gone.

"She never built the power base of her

"She never built the power base of her new office and failed to develop the political clout that's necessary to wield influence in Washington," Nelson explained.

"As time went by, she became weaker and untenable in a position with such high demands and expectations.

"I don't believe that a public health administrator can be the powerful AIDS czar that we need and I strongly support the selection of an individual who has a deep commitment to the AIDS community and a solid record of political success," Nelson said.

"The greater issue is who will be the next AIDS czar. The Administration cannot afford to make another mistake," Nelson warned.

Gebbie was viewed as having little, if any power. As one member of ACT UP/D.C. told Light, "You know as well as I do that anyone like Gebbie whose office is 'out of the loop,' has no power at all. She's nothing but a cipher, a zero, a zilch."

When this reporter finally met Gebbie at the offices of the Milwaukee AIDS Project, she said, "So you're the man who couldn't find me." The response was, "I hope the White House lists you now."

On June 22, 1994, the prestigious and powerful Washington, D.C.-based AIDS Action Council issued a press statement titled "White House AIDS Policy Office Falls Short."

The statement criticized Gebbie for failing

 effectively advocate within the administration and on Capitol Hill for increased federal funding for HIV/AIDS programs;

 collaborate with federal departments and agencies to develop a comprehensive federal AIDS plan;

This had been one of ACT UP's chief criticisms of her. They wanted a Manhattanstyle Project for the conquest of AIDS. She told Light that wasn't necessary.

tional AIDS Policy function simultaneously as a SWAT team and as a shuttle diplomacy group-responding swiftly to AIDS policy crises as well as building wider consensus within the federal bureaucracy on steps to be taken. Serious evaluation and reorganization of this office is badly needed," said the AIDS Action Council.

Nelson said that he had participated in the Council's discussions on Gebbie and urged the Council to take the strong stand that it ultimately did.

When Gebbie began work in August, 1993, over 20 federal agencies and departments maintained AIDS programs with little coordination among them. But in a year since, according to the AIDS Action Council, the situation has not changed much.

"The AIDS Action Council welcomed the

"The AIDS Action Council welcomed the appointment of an experienced public official with expertise in HIV/AIDS prevention. But the Council's "disappointment and disaffection with the office" grew.

The Council's statement said that Gebbie's

The Council's statement said that Gebbie's office had been "plagued by miscues and an ill-defined sense of mission." The office, the Council said, had actually become a "stumbling block." To the development and implementation of better policies.

In accepting the resignation, Clinton admitted that more needs to be done and "more will be done" to fight AIDS.

ACT UP spokespeople said she had accomplished little and her departure was long overdue.

Currently, ACT UP is urging the White House Chief of Staff, Leon Panetta, to consider Connecticut Gov. Lowell P. Weicker, Jr as the new AIDS czar.

"We need a cabinet level AIDS czar and it's got to be Lowell Weicker," Steven Michael, an ACT UP spokesman told Panetta. "I got you," Panetta replied.

Michael said that Weicker is the only person ACT UP will support as Gebbie's replacement.

"Lowell Weicker is the only person that we are going to give a grace period to because we know he can get the job done," Michael said.

The White House has not announced if Weicker is being considered for the post or, for that matter, who else is being considered.

Shalala Battles the White House in Support of a Gay Appointee for AIDS Czar Position

(Milwaukee)- A source in Washington, speaking for background, said that as the AIDS Action Council and others such as ACT UP, put pressure on the Clinton Administration to get Kristine Gebbie to resign, the question arose as to who would replace her.

The White House let it be known that whoever the new appointee would be, it would not, under any circumstances, be a Gay woman or man.

The reason, the source said, had nothing to do with avoiding the association of the disease with being Gay. Rather, it had to do with the Administration's fear of appointing another Gay person so close to the 1994 elections. Because of this, no person who was known to be Gay would even be considered.

The source said that when Donna Shalala, Secretary of Health and Human Services, heard that, she was outraged and protested strongly. "She really went to the mat on this one with those boys down there," the source said.

She thought it was outrageous that when the Gay community had suffered so much from the disease and been for so long on the front lines, a Gay person would be automatically excluded from consideration for the post.

The result was that the Administration caved in, agreeing that sexual orientation would not be a barrier to being considered for the post.

'The Client': A Compelling and Endearing Movie With a Quirky Charm

At the heart of Joel Schumacher's The Client is an endearing relationship between a troubled boy and the tough, sharp and compassionate lawyer he hires to protect him from the mob and police.

The strength of the movie rests on that relationship which, at times, will bring you close

Schumacher draws strong, compelling performances from those involved: the always reliable and talented Susan Sarandon and newcomer, Brad Renfro. Tommy Lee Jones adds his quirky charm as their foil.

Based on John Grisham's best-selling novel, The Client, the movie involves an 11year-old named Mark Sway (Renfro) who is told by the lawyer of a Mafia hit man where the body of a missing senator is buried. The senator was killed by the hit man, and the lawyer commits suicide knowing he's the next contract.

Mark and his younger brother, Ricky (David Speck), are in the woods smoking cigarettes when lawyer Romey Clifford (Walter Olkewicz) drives up to kill himself by attaching a hose to the car exhaust. Mark keeps pulling out the hose to save the guy and gets snatched in the process.

Romey decides to kill Mark as well as himself and while they're locked in the car, he babbles about the mob and the senator. Mark escapes, but he and Ricky see Romey put a gun to his mouth and pull the trigger.

The suicide leaves Ricky hospitalized.

Meanwhile, Mark, who called the police to report the suicide, falls under suspicion.

The Bristol Renaissance Faire, a Taste of Olde England In Wisconsin

If you want a taste of Olde England then there is no better place to sample it than the Bristol Renaissance Faire. Located almost precisely on the Wisconsin-Illinois line, the Faire resembles a quaint English village right out of the 16th Century. As you wander down well-trodden paths beneath towering oaks, you can get an idea of what an Elizabethan market town must have been like.

All along the way, on either side, there are little shops with peaked roofs open to the "street." Tables are set up within and without to display all variety of wares; everything from objects d'art to hand-crafted shoes and fabrics.

In this regard, one especially I would recommend. That is Fantasy Art. Here P.D. Breeding-Black displays her paintings of firmthighed, beautiful women and muscular, handsome men riding fire-breathing dragons and taming nature's storms. Along the way, all manner of whimsical

Along the way, all manner of whimsical sights regale the eye. There are wandering minstrels. There are places to rest and be charmed by harp and lyre. There are jousting matches to behold and all sorts of games. There is even a theater from which you can get a pretty good idea of what the Globe must have been like when the Bard and his troupe trod the boards.

I would earnestly recommend the demonstration of falconry. These majestic, beautiful raptors and the lessons the falconer teaches are well worth a stop.

The entire staff is in full Elizabethan costume and speak with a Shakespearean style. They are never out of character, which adds an antique atmosphere to the place.


One sight not to be missed is the Queen's Procession. Her Britannic Majesty, Queen Elizabeth I, is escorted in high honor by the Lord and Ladies of her court. (The young yeomen of the guard, each looking suitably formidable, are enough to take your breath away.)

There is food aplenty to be had. While Jerry liked the turkey legs, I favored the more spicy jalapano peppers stuffed with pork. But whatever tempts your tongue, you will find it good, I think. And find it good too, as you stroll along, to smell the aromas of roasting meat twirling slowly on the spits.

The Bristol Renaissance Fair is conveniently located. Take I-94 south and get off at Exit 347 to Highway Q, then follow the signs.

There is a great deal of convenient parking at \$2 a car, but go early. The day we were there (a Sunday), the handling of the traffic flow was somewhat disorganized, so there was a long, long line.



She is recognized as a leader and innovator in the fields of women's studies/Jewish women's studies and Lesbian studies. When she was a professor at UW-Madison (1972-1984), she pioneered the first course on Lesbian culture which remains an integral part of the women's studies curriculum.

Congressional Hearing Investigates Harassment at Camp Sister Spirit

(Jackson, MS)- A U.S. House of Repre- how the lack of federal protection based on sentatives subcommittee held an oversight sexual orientation actually hinders the federal hearing in Jackson, Mississippi July 6 focusing on the events surrounding the conflict in Ovett, Mississippi, the location of the feminist retreat Camp Sister Spirit run by the Lesbian couple Brenda and Wanda Henson.

The Subcommittee on Civil and Constitutional Rights of the House Judiciary Committee heard testimony from the Hensons, leaders of Mississippi for Family Values, several local officials, representatives of the U.S. Department of Justice and experts in the area of hate crimes. The hearing was chaired by Rep. Barney Frank (D-MA) and also led by Rep. Jerrold Nadler (D-NY). Robin Kane, Public Information Manager of the National Gay and Lesbian Task Force (NGLTF) attended the hearing and submitted a written statement to the subcommittee.

In their testimony, Brenda and Wanda Henson summarized the harassment, threats and violent incidents that have been committed against them since November, 1993, including death threats by mail and phone, a dead dog hung from their mailbox, gun fire along the property line, gunshots aimed at a woman from a moving vehicle, and a high speed vehicle chase involving Brenda Henson and an unknown perpetrator.

These incidents have followed a highly publicized campaign against Camp Sister Spirit headed by James Hendry and his group, Mississippi for Family Values. Hendry has organized two town meetings and two rallies targeting the Hensons and Camp Sister Spirit.

The Hensons implored federal officials to protect them and ensure their basic rights.

"We do not seek tolerance and acceptance," said Wanda Henson. "We seek equality under the law and freedom from oppression, intimidation, and harassment. We seek justice and a legal system that is capable and willing to defend our rights."

Both Hendry and Rev. John Allen stated during their testimony that the harassment and incidents against the Hensons are unsubstantiated and they implied or overtly stated that the Hensons created the campaign against them for

Contrary to previous statements, both Hendry and Allen said they do not want the Hensons to leave Ovett. Instead, they merely oppose the "commercial" aspect of Camp Sis-

Allen's testimony focused on his moral opposition to the Hensons Lesbianism and the any specific goals except that the Hensons "experience the life-changing redemption found in a genuine faith surrender in Jesus

Two representatives of the U.S. Department of Justice testified at the hearing: William Yeomans, Counsel to the Assistant Attorney General, Civil Rights Division and Ozell Sutton, Southeast Regional Director of the Community Relations Service.

Yeomans testified that "at present, none of the nation's civil rights laws provide explicit protection on the basis of sexual orientation...The Department of Justice is limited to enforcement of the laws as written. Our jurisdiction reaches only so far as Congress chooses to extend it.'

'The situation in Ovett has demonstrated

government from intervening on behalf of its own citizens," said Robin Kane, NGLTF Public Information Manager.

Without specific inclusion in legislation, Gay, Lesbian and Bisexual people across the country lack basic civil rights that are taken for granted by most citizens," Kane said.

Baldwin said.

Baldwin's accomplishments during her first term have received recognition from a wide array of political observers. She was named Legislator of the year in 1994, but the United Council of UW Student Governments for her leadership role in advocating for UW

State's Unitarian Congregations Openly Welcome Gays and Lesbians

Straight members of the congregation came and brought their kids when the Rev. Roger Bertschausen performed a union ceremony for a same-sex couple at the Fox Valley Unitarian Universalist Fellowship in Appleton

"I think it was really significant," Bertschausen said. "For our children, it really gave them a different model." They could see, as a later Mother's Day sermon would repeat, that Unitarian Universalists (UUs) have "a different vision of family values.'

A few years back, Bertschausen said, the Fox Valley congregation was comprised of "liberals who would say they were open but they really weren't, and they weren't all that willing to go out on a limb and be welcoming and make that public.

But as more Gay and Lesbian people joined, individual reservations vanished and the congregation was transformed, he said. A Lesbian now chairs the Sunday Services Committee. Others, active in the Sunday school program, "really are wonderful Gay and Lesbian role models for our youth and children," he said. "It would have been a shame not to be welcoming and not let them

Members of the church also lobbied the Oshkosh YMCA to change its definition of "family" to include any two adults living to-

Many religious denominations are struggling with the issue of homosexuality. A very few have accepted Gay, Lesbian and Bisexual people in every aspect of religious life, including the ministry.

UUs faced the issue early on. The first Gay UU minister came out in 1969. By 1990, it had 45 openly Lesbian and Gay ministers.

The UU denomination was born two centuries ago when a few Christian congregations doubted such beliefs as the trinity and damnation. About 210,000 people, mostly in the United States and Canada, are UUs today.

Without a required creed, its small membership has grown wildly diverse. Atheists have been welcome for 100 years. More recently, pagans have found a home in what sometimes look like very traditional churches. Congregations are encouraged to be open to people of all sexual orientations.

But affirming all people - not just tolerating them -- has been easier in some congregations than others, said Keith Kron, a ministerial student and head of Interweave, UU's organization for Gay, Lesbian, Bisexual and Transgender people

Some congregations get nervous when they welcoming Gay men means they might hold hands or dance together at social events. Others will hire a Gay minister, but not twice in a row, he said.

"It's just a matter of getting to the point where we kind of become ordinary folks in the congregation," Kron said.

The denomination sponsors a 15-step program called "Welcoming Congregations" to help members reach that point. However, Interweave works better, said Jane Bredendick of Marshfield, the Central Midwest District Interweave chair. Interweave can deal with the unique nature of each congregation, she said.

You start with everyone within your congregation, not just the Gay community or the people you think need it or that sort of presumption. The whole idea is to integrate everyone," she said.

Barb Seegert, who has recently started an Interweave group at the First Universalist Unitarian Church of Wausau, believes Interweave can include all people.

"We want to be sure the church doesn't see us as something they have to support but something that actually supports them," she said. "That's what Interweave is all about, making us interdependent, not dependent."

At the Bradford Community Church in Kenosha, the Rev. Annie Holmes, a Lesbian, started an Interweave group in 1992, one month after she began her ministry there. Twenty-two people came to the first meeting at her home.

"There was real power in the sharing be-tween Gays and straights," she said.

Sometimes Interweave hosts social events, like a showing of the movie "Desert Hearts." Often straights with Gay relatives or children come for support and advice.

Sometimes we just laugh and laugh and laugh and laugh," Holmes said. "People have funny stories. There's just some crazy things that go on in their workplaces."

"It's also been a real forum for political action and we've taken some stands here in Kenosha," she said. Church members wrote to school board members because the family life curriculum had no information on homosexuality and bisexuality. They've also worked on other issues and make sure a monthly letter to the editor gets submitted to a local newspaper.

Some members, Gay and straight, still have reservations, Holmes said. Some think that Interweave accentuates differences rather than similarities among people or that its is-

sues should be taken up by another committee.

"Some think that I push Gay-Lesbian issues too far," she said. "The perception is anything's too much. So we all have a long way to go.'

Other congregations have been active. Milwaukee-area UU churches formed an Interweave group this spring and recruited two dozen Gay and straight members to march in this year's PrideFest parade.

The three congregations in Madison -First Unitarian Society, James Reeb Unitarian-Universalist Church, and Prairie Unitarian Universalist Church -- have united with other Madison religious organizations to deal with homophobia and to welcome and Gay men, Lesbians and Bisexuals in their communities.

Racine's Olympia Brown Unitarian Universalist Church called a Gay man to its ministry more than 15 years ago. In addition to other work, the Rev. Tony Larsen has brought a touch of Gay sensibility to the pulpit by turning "The Wizard of Oz" into a humorous musical Sunday service.

The United Unitarian Universalist Society of Mukwonago started an Interweave group about three years ago made up of about half heterosexuals and half Lesbians and Gay men. That made a difference when the church recently called a Gay minister, said Jo Lindoo, a member of Interweave.

"We already had educated a lot of people in a lot of issues," she said. "We convinced them that we weren't going to become a Gay church. And all the other fears we put to rest for most people and so the vote (to hire the minister) passed," she said.

The Interweave group meets monthly. It has studied an anti-Gay video, watched "And the Band Played On" and has addressed individual concerns about coming out.

"And we have one Bisexual, too," Lindoo added proudly, then laughed at how naive that remark sounded. "That was a big thing," she explained, still laughing. "As a Lesbian, I'm pretty ignorant about that, so it's been real

Few Anti-Gay Measures Will Appear on State Ballots this Fall

(Washington, D.C.)- Right Wing Religious groups hoping to pass anti-Gay initiatives in Arizona and nine other states this year have fallen short of their goals, gathering enough signatures to get measures on ballots in only

The other states where anti-Gay initiatives failed to make the ballot are: Washington, Michigan, Ohio, Missouri, Maine, Florida,

Several weeks of reckoning came the first week in July in what has become a battle between Gays and the Religious Right who are backing discrimination initiatives.

Supporters of such measures failed to file signed petitions in Missouri and Washington State, but did submit enough signatures to qualify for the ballots in Idaho and Oregon.

David Smith of the National Gay and Lesbian Task Force (NGLTF), expressed relief that few of the measures had garnered enough support.

'We started out in January with 10 of these initiatives and we're down to a handful," Smith said. Smith said, however, that he expects efforts on other fronts.

Arthur Kropp, president of People for the American Way, a liberal group that, among other things, monitors the Religious Right, noted that similar anti-Gay measures are showing up in state legislatures and before town councils and library boards.

"We're not going to see any lessening of attacks on Gays and Lesbians because it works," Kropp said.

Others have noted that anti-Gay rhetoric by the Right garners religious leaders and organizations great sums of money.

Idaho

On July 6, a day before petition signatures were due in Idaho, the Idaho Citizens Alliance (ICA) submitted 38,510 verified signatures of registered voters, 6,000 more than required to put the initiative on the ballot in November.

However, opponents of the measure noted that ICA had forecast that it would be able to get over a 100,000 signatures.

People are starting to see these measures mean discrimination and censorship and they are rejecting it," said Nicole LeFavour of the Idaho Campaign for Human Dignity. "We've seen people standing up for their neighbors and say they won't stand for discrimination.

Oregon

The Oregon Citizens Alliance (OCA), led by Lon Mabon, submitted 120,000 signatures, about 30,000 more than needed to get its measure on the ballot.

Suzanne Goldberg, a lawyer with the Lambda Legal Defense and Education Fund, said her group would fight the ballot measures, first by challenging petition signatures.

In Ohio, the Pro-Family Forum (PFF) gave up its plan for an anti-Gay ballot initiative in favor of targeting individual politicians who are Gay or sympathetic to Gay causes. Insiders say the plan is either to intimidate them into silence or drive them from office.

Though this year's petition drives have failed in the great majority of the states where they were being pushed, numerous anti-Gay initiatives will be on local ballots throughout the country. And more are expected in the fu-

In response, the Human Rights Campaign Fund has launched a campaign "to fight the radical right" in states where local anti-Gay initiatives will appear.

Oregon Democratic Governor Barbara Roberts and retired Republican Sen. Barry Goldwater of Arizona are the co-leaders of the "Americans Against Discrimina-

As in Colorado, Lamida is leading the fight against the Oregon anti-Gay initiative.

recently published Th Religious Right: The Assault on Tolerance and Pluralism in America, a publication of the Anti-Defamation League, Mabon is closely connected with Pat Robertson's Christian Coalition.

An appeal of a trial court ruling that the Oregon anti-Gay initiative cannot go on the ballot in November because it embraces more than one subject, will be considered by the Oregon Supreme Court.

Secretary of State Phil Keisling, the top state election official, has asked the court for a



ruling by September 8.

Washington

In Washington State, Governor Mike Lowry and five top state officials hailed the rejection of the two anti-Gay initiatives, saying "the people of this state will not permit intolerance and discrimination.

The two initiatives were I-608 and I-610 which would have forbidden state or local civil rights ordinances for Gays and Lesbians and would have barred public schools from presenting homosexuality as positive or normal.

We are pleased that Washington citizens saw in these initiatives the threat to all of our basic constitutional rights and kept the constitution alive and well in Washington State, Lowly said.

I-610 forces threw in the towel on July 2 after collecting only 50,000 signatures of the 210,000 needed. But I-608 went down to the wire, with organizers flying to Spokane to pick up last minute petitions from Eastern Washington and some backers hitting the streets to look for last minute signers.

"We just missed," said Cathy Mickels, a spokeswomen for initiative backers. She blamed the "Bigot Busters" for the loss.

The Bigot Busters were groups of Gay and Lesbian activists who went around the state passing out information on the initiatives.

"We're not throwing in the towel," Mickels said. "We're not going to go away."


Nevada In Nevada, a ballot initiative fizzled when Religious Right organizers there failed to get the necessary 51,339 signatures needed.

A recent poll in Nevada conducted by the Las Vegas Review-Journal and KLAS-TV, Channel 8, found that 52% of those surveyed approved of a law protecting Gay people from being denied fair access to jobs, education and

79% said Lesbians and Gay men should have equal rights in job opportunities.

Maine, Florida and Ohio Proponents of an anti-Gay initiative in Maine failed to gain enough signatures by a wide margin. They said they would try again

In Florida, the state Supreme Court effectively kept a proposed initiative off the ballot, ruling in March that the language used would confuse voters.



Olympic Gold Medal Diver, Greg Louganis, Is a Study in Platforms and Courage

As a diver, Greg Louganis took the platform with one goal in mind; Do not make waves. A clean entry into the pool at the conclusion of a dive would leave nary a ripple on the water, but would leave a lasting impression on the judges.

As this, the greatest diver in history, winner of medals and maker of records, found that his success was a contradiction. He made a splash by not making a splash.

As a retired diver, Louganis took the platform again at the U.S. Olympic Festival in St. Louis, a different platform this time, with one goal in mind: Make waves--and try to still the waters.

And thus the greatest diver in history, winner of the U.S. Olympic Committee's Robert J. Kane Award as an athlete who continues to give back to his sport, again went in search of success by contradiction.

Louganis stood up before a hotel ballroom full of USOC officials, business people, and athletes, received his award and spoke out as an openly Gay man. This was not news as something new because Louganis had revealed his sexual orientation in a public speech at the Gay Games in New York. This was news as something unusual because of the setting and the audience.

Standing up and speaking out as an openly Gay man at the Gay Games is the equivalent of diving into a pool. Standing up and speaking out as an openly Gay man at the U.S. Olympic Festival, in front of the top brass of the USOC, is the equivalent of diving into a block of cement.

The crowd sat in silence as Louganis read his prepared speech, as he dedicated the award to Dr. Tom Waddell, a U.S. Olympic athlete who happened to be Gay, who also happened to die of AIDS; as he praised Xerox, the company that sponsored the award, for the fair

and equal treatment he said it gives Gay employees; and as he called on the USOC to help resolve a continuing crisis that surrounds the volleyball competition at the 1996 Summer Games in Atlanta.

The volleyball preliminaries in 1996 are scheduled for Cobb County, which is in contention for the gold medal as the most closed-minded county in the country. Cobb County's elected officials have condemned a number of things, homosexuals and art that doesn't lend itself to a black-velvet background among them.

Louganis joined a number of voices that have called for the volleyball prelims to be moved out of Cobb County, given the contradiction between the Olympic ideal of bringing people together and the Cobb County ideal of bringing the right kind of people together and banishing the rest. (Encouraging historical note for Cobb County residents and sympathizers: Hitler wasn't fond of Jews or Blacks, and still he played host to the 1936 Summer Games.)

Louganis spoke of the Gay athletes who might compete in Cobb County with "the added pressure of knowing they aren't wanted. No athlete should have extra barriers like that"

Athlete or not, no person should live with his race or creed or sex or sexual orientation as a barrier, but that is an ideal as far from reality as the amateur Olympics. The barriers don't come down, brick by brick, unless people like Louganis speak up.

So up is down. Another contradiction, perhaps, but the world is full of contradictions. For years we made the same mistake with the world's greatest diver that we make with so many athletes who win and earn gold. We knew enough of Louganis the athlete to imagine we knew Louganis the man. We admired the courage it took to climb upon a platform and the talent it took to jump off and land just so

As usual, we, the world, didn't know the whole story. Turns out we had no idea about Louganis and platforms and courage.

Study Finds Heterosexual Men Overwhelmingly Involved in Child Abuse Cases While Gay Men Are Rarely Implicated

(Chicago)- Openly Gay and Lesbian adults are no more likely than heterosexual adults to sexually abuse children, a new study says.

The study was done in Colorado, after Right Wing religious group claimed that people living "a homosexual lifestyle" are responsible for 50% of all child molestation's.

"No evidence is available from this data that children are at greater risk to be molested by identifiable homosexuals than by heterosexuals," wrote the authors of the study published in the July, 1994 issue of **Pediatrics**.

The authors reviewed all child abuse cases at one hospital over a one-year period and found 269 cases in which an adult was suspected. In only two cases, or 0.7%, was the offender identified by the child's caregiver as a possible Lesbian or Gay man, the researchers said.

In 222 of the 269 cases, or 82%, the suspected abuser was a heterosexual partner of a relative of the child, said the researchers, led by Dr. Carole Jenny, director of the child protection team at Children's Hospital in Denver.

Typically suspected abusers were fathers, stepfathers or boyfriends of mothers. The vast majority of offenders were men in both girls' and boys' cases.


Dr. Jonathan Kelly, medical director of the Isaac Ray Center in Chicago which evaluates sexual offenders, said he could not recall ever evaluating a child sex abuser who was openly Gay.

"The group that did the study were all people who worked with abused kids full-time," Jenny said. "We had a hard time thinking of a case where homosexuality was an

Dykes To Watch Out For



\$53 Million Spent Annually on Advertising In the Gay Press

(New York)- A nationwide study of 76 Gay magazines and newspapers, among them, Wisconsin Light, found a growing market for advertising spending in the Gay press, currently estimated at over \$53 million annually. The study was performed by Mulryan/Nash, an advertising agency that specializes inreaching Gay consumers.

Mulryan/Nash found that several advertising categories not targeting Gay and Lesbian consumers nationally, such as automobiles, are in fact advertising in Gay newspapers and magazines through local dealers who value Gay business.

"Dealers representing all imported and domestic auto makers are advertising in large and small Gay newspapers nationwide," said Paul D. Poux, Mulryan/Nash's media director. "For example, an Atlanta newspaper, Southern Voice, has over ten dealer ads in each issue, because dealers have seen a very positive effect on sales. Advertisers are realizing that Gay magazines and newspapers are legitimate media vehicles and a way to reach almost 10 million brand-loyal consumers in communities across the country."

The largest advertising categories in the Gay press are bars and clubs, at 19.5%; 800 and 900 number phone services, 12.6%; and legal, medical, and other professional services.

10.8%. Auto advertising accounted for about 2% of all spending.

Although market research on Gay and Lesbian consumers has concluded that they earn more and have more disposable income than average Americans, many advertising categories are absent in the Gay press, creating opportunities for those who target Gays and Lesbians.

Home furnishings accounts for only 1% of advertising, even though Ikea has targeted Gays with a TV ad. Ads for investment companies total only 0.2%, and banks, just 0.1%. And although Gays are early adopters of most consumer electronics, ads from electronics companies represent only 0.1% of all spending.

Other notable categories: candidates for local and state office who run ads in newspapers from Washington, D.C. to Milwaukee; and local churches, whose advertising totals 0.6% of all spending.

Mulryan/Nash was formed in 1991 to help mainstream businesses target the Gay market. They engineered groundbreaking campaigns in the Gay press for the Netherlands Board of Tourism and Broadway's Angels in America, and perform research and marketing for several Fortune 500 companies.

Unprecedented Gay Pride Events Keep Gay Issues High on Israel's Social Agenda

(Jerusalem)- Since the controversy around the commemoration two weeks ago of Gays at Yad Vashem Holocaust Memorial (reported in Light, last issue), unprecedented Gay Pride Month events are keeping Gay issues on top of the social agenda in Israel, according to the World Congress of Gay and Lesbian Jewish Organizations.

The World Congress is an umbrella organization with 60 member groups and over 15,000 members.

But what is even more unusual is the growing involvement and commitment of Government officials in the cause of Gay civil rights.

Almost every Pride Month event, be it a movie, Lesbian poetry reading or a play, is sponsored by a member of the Knesset, the Israeli Parliament.

Involved are members from an array of left and right wing parties--Labor, Meretz, Likud, Zomet and Hadash.

Culminating Pride Month, an official reception at the Knesset in Jerusalem for Gays and Lesbians is scheduled for the last week in June, hosted by Knesset member Yael Dayan, Chair of the Knesset Committee for Gay and Lesbian Rights. This will be followed by an outdoor reception in Tel Aviv opened by city Mayor Ronni Milo (Likud).

Gay Tourists Welcome in Zion

At the same time, the Israeli Tourism Ministry has reaffirmed its commitment to support Gay tourism to Israel, disregarding calls from some American Orthodox Jews to boycott tourism to Israel as a response.

The Minister of Tourism, Uzi Bara'm, has said, "We will continue to assist Gay travel to Israel the same way we assist any other type of tourism."

Other Advances

Similarly, the Israeli Education Ministry has announced plans to introduce a "very progressive" Gay awareness and sensitivity program into the Israeli public high school curriculum beginning next year. This, despite right-wing religious objections.

And in the Israeli Supreme Court, a case now pending is expected by legal observers to leave Israel with a comprehensive national policy guaranteeing partners of Gay and Lesbian employees all benefits now offered spouses of heterosexual employees.

A Friend's Day in Court

TO THE EDITOR:

Today I escorted a friend to court. It was a case which had gone on for a year and a half. My friend--let's call him James--had been accused of lewd and lascivious conduct. For laymen, that means that he had been accused of exposing himself in a public toilet at the Grand Avenue Mall.

Now, although I am Gay myself, I feel the same outrage that most would feel in a situation like this. There really is no excuse for a man to conduct himself so. I have relatively little compassion for people caught in "public sex." Public conveniences simply are no place to solicit encounters, not to mention the risk of disease or possible assault. However, I was glad to escort James to court and act, if necessary, as a character reference for him. Why? Simple. He did not do what the police said he

I have known James for more than six years. He is a moral, Christian man, an honorable man, and yes, a Gay man. He is "out" at all of his jobs and has done a fine job as a volunteer with a variety of organizations in the Gay community. He has no arrest record or history of scofflaw behavior. None, whatsoever.

He wears symbols of his pride: freedom rings, T-shirts from various Gay events, and the like. He is not effeminate, does not speak with a lisp, and does not carry himself in a "campy" manner. [He drives a pick-up truck.]

I have seen him in many situations where others were attracted to him and watched him stick to his belief in monogamy; I have seen him turn down men with absolute gentleness and firmness because he feels that he would like to know a person before...Well, before. He is, nicely, "a bit old-

I remember his anger when he called me and told me he had been arrested. He had simply walked in to the Men's WC, and when he exited, he was arrested. He was wearing freedom rings that day and a Gay-themed shirt from a pride celebration-nothing obscene or offensive, beyond the fact that it was a "Gay shirt."

I encouraged him to fight back, and so he did for a year and a half. He worked three jobs to pay for his lawyers, asked for help only in terms of references [all of his employers supplied sterling references], and steadfastly maintained his innocence.

But the burden of fighting for so long in taxing in so many ways. A person becomes tired, not only in the body, but in the soul as well.

Today, James tossed in his towel and pled no contest to a bargained down charge. He has no record, still has all his jobs, but it doesn't matter. Today, because his attorney, an experienced trial lawyer, was afraid that a fair and impartial jury could not be raised, because the issue was a "Gay issue" and subject to the whims and prejudices of society, an innocent man was found "guilty" of something he did not do.

I don't blame the lawyers. James' lawyer and the prosecutor, as well, both said to me in different conversations, that they knew James was innocent. The prosecutor even alluded to the fact that he understood that mistakes are sometimes made in arrests like those of James' type. The prosecutor even made statements on behalf of James as he asked for he charges to be changed

Yet, as I watched James walk out of that court room, an angered man, a hurt man, I must say I find fault with "the system." I watched his courage shrivel and become dust. I have to ask myself who will restore my friend's dignity, his sense of selfworth? How must I deal with my own anger at the injustice I witnessed today in the halls of the Law?

I know, I know. It was a Gay man accused of soliciting public sex. No one likes to think about these things. And it was a "small case," no celebrity

Justice, however, should be blind. It is dangerous, indeed, when the "small things" one takes for granted, such as fairness and the integrity of our court system, are no longer there because of a general lack of rectitude, both morally and intellectu-

And while Gays may not be the most "popular" of minorities, nevertheless, it was an innocent man this time, who was forced to accept a finding of guilt. It makes me wonder who will be next? You? Or you?

It becomes extremely important when a simple matter of justice in 1994, is so obviously still beyond the members of the Gay community because of fear, hatred, bias, and bigotry. It impacts on all of us, homosexual, heterosexual, in ways we might never begin to imagine.

claiming for some time that Lesbians and Gay men are seeking special rights, special protection, special status. The argument is the cornerstone of their appeals for money and campaigns supporting discrimination.

The July 19th hearing is "an important opportunity to dispel the myth," says David Smith, spokesman for the National Gay and Lesbian Task Force. "Gay people are discriminated against, do not have recourse, and are looking for equal protection under the law--nothing more.'

The bill recently introduced in the House and Senate is narrowly drawn for maximum potential appeal. It says an employee's partner is not entitled to benefits; quotas and preferential treatment are verboten; religious employ-ers are exempt except for their for-profit enterprises; the act doesn't apply to the military; and it's not necessarily violated if a policy affects Gay people more than heterosexuals.

The exceptions are expected to assure eventual Clinton Administration support of the bill. So far the White House has endorsed its principles; that's the line Justice Department civil rights chief Deval Patrick is expected to take in his testimony.

The bill has nearly 150 House and Senate sponsors, only nine of them Republicans. Justin Dart, a Republican who will testify before the Commission, said he hoped more Republican lawmakers "of vision and conscience" would sign on.

According to the Human Rights Campaign Fund, Sen. Russ Feingold has signed on as a co-sponsor of the bill. Sen. Herb Kohl has not signed on. Calls to Kohl's office got no response.

In the House, the National Gay and Lesbian Task Force says that Rep. Thomas Barrett (D-5) has become a co-sponsor. None of Wisconsin's other House delegation

Congressional Republicans can expect considerable pressure from the Religious Right and "pro-family" groups already mobilizing for battle.

"Our view is that this is entirely different from race or sex," said Gary Bauer, president of the Family Research Council. "Inevitably you're going to force employers who have deep moral objections to that way of life to bring people into their business who are openly promoting that way of life."

Bauer, whose group has asked to testify before the Commission, contends that American society condones and accepts discrimination of Gays and Lesbians.

But Gay activists say their polls show more than three-quarters of Americans agree that Gay people shouldn't lose their jobs because of their sexual orientation. Their research also shows, however, that most people wrongly believe Gays already are protected by federal civil rights laws.








The CAEAR Coalition is an organization of high incidence AIDS cities which have received AIDS funding at significantly higher levels than the rest of the country. Coalition cities include San Francisco, New York, Los Angeles, Washington, D.C., Miami and Chicago.

The Campaign for Fairness is supported by more than 130 AIDS service organizations like ARCW in 47 states throughout the country which are based in areas that do not gain the financial benefit of high incidence formulas.

"Our entire campaign is based on the premise that a person with AIDS in Milwaukee or in any small town in Wisconsin is as important as the person with AIDS in San Francisco or New York and is entitled to a base line level of primary care and support services that are comparable," Nelson explained.

Nelson said that the old formulas of the CARE Act do not provide for comparable, base-line services throughout the country. These formulas, he said, were written by a "handful of well-intended people" almost five years ago and fail to address the rapid pace of the national AIDS epidemic.

"There is no logic to formulas that disperse six times more funding per AIDS case in San Francisco than in Milwaukee, Madison, Pittsburgh, or Cleveland," Nelson said firmly.

"We cannot afford to live with this inequity over the next five years and that is why we have pressed this campaign throughout the country and on Capitol Hill," Nelson added.

As reported in the June 23-July 6 issue of Light, San Francisco receives \$5,441 per AIDS case, while Milwaukee receives \$963 per AIDS case.

Nelson said that key issues to be decided in the up-coming negotiations include the use of recent AIDS case counts in the formulas instead of cumulative cases which do not reflect the demographics of those who are living with HIV and AIDS and the best assessment of service needs.

Another critical issue according to Nelson is the establishment of a minimum base-line amount of funding per AIDS case for both Title I and Title II of the CARE Act.

Battle Heats Up

Wisconsin Light has learned that professional lobbyists for the Title I CAEAR Coalition launched an intensive telephone lobbying campaign with Wisconsin AIDS leaders last week

All nine of Wisconsin's AIDS service organization directors were phoned several times in a concerted effort to scuttle the Wisconsinled campaign for equity.

Reliable sources confirm that the lobby effort used scare tactics and all sorts of personal attacks to urge the directors to abandon the campaign. The lobbyists asserted that if the campaign continued, Wisconsin would be blamed for the death of the CARE Act and that all federal AIDS funding would cease.

Sources say that Nelson was characterized as being naive and of leading "a crazy and irrational" movement by the lobbyists who are reportedly paid \$800,000 for their work on behalf of Title I.

Numerous threats were also made by these same lobbyists who are trying to hold on to their money.

Asked to respond, Nelson said, "It's hard-ball national politics which I'm prepared for, but it saddens me that these crude tactics are being used. They are not very flattering. They misdirect attention from the real issue of inequity and ultimately, they just didn't work in Wisconsin and I don't believe they'll work elsewhere either."

"The AIDS directors in Wisconsin are very astute leaders and they thoroughly understand the harm that has come from inequitable Ryan White funding and continue to stand united in support of our campaign," Nelson stressed.

"They also know me well, so the personal attacks only undercut the substantive arguments of the Title I lobby," Nelson said.

"I expected a higher level of debate than what we are getting, which is why I am very pleased that negotiations are beginning and will be facilitated by a professional mediator appointed by the AIDS Action Council," Nelson said.

Reports reaching Light say that the same kinds of scare tactics were also used against Sen. Russ Feingold (D-WI) who has made a commitment to provide Senate leadership for greater equity in a re-authorized CARE Act.

Political Support Builds In D.C.
According to Nelson, the support among
U.S. Senators for equitable funding continues
to grow. Both Wisconsin Senators Russ Feingold and Herb Kohl are committed to the campaign and are seeking support from their col-

"We have good support on the Kennedy Committee which is where re-authorization will begin and I believe we will demonstrate surprising support throughout the Senate," Nelson said.

The Kennedy Committee is the Senate

Committee on Labor and Human Resources chaired by Sen. Edward Kennedy (D-MA).

"Equitable AIDS funding is both a rational and understandable political issue and the vast majority of the states fall victim to the current inequities. I believe the political support will be there to make the critical changes that are necessary to correct the failures of the CARE Act," Nelson said.

Nelson informed the Light that a Senate support statement known as a "dear colleague" letter had garnered strong endorsements but is being held in deference to the up-coming negotiations.

A "dear colleague" letter is a common strategy on Capitol Hill to demonstrate political support for important issues and can be highly influential during committee deliberations on various bills.

Nelson praised both Senators Feingold and Kohl for their steadfast support of the "dear colleague" letter and the principles of equity.

"We hope that we can gain an agreement in the negotiations that will make the "dear colleague" letter unnecessary and will allow for expedited re-authorization. If we can't get agreement through these negotiations, then the Senate letter will be a powerful statement of political support for equitable AIDS funding,". Nelson said.

Nelson left Wednesday, July 20, 1994, for Washington and the critical and what promised to be very difficult negotiations.

While his mission is to bring equity to the CARE Act, he also characterized this battle as one that will "redefine the national AIDS community to include big cities, small cities, and rural areas because the AIDS epidemic is an urgent public health crisis in every part of the country."

When you talk to people who don't necessarily identify themselves as Republicans, and you ask their opinions on those issues (property taxes, welfare, crime), they articulate the Republican response. I think the district is more Republican than the numbers would indicate.

WL: State Rep. Tammy Baldwin is planning to introduce domestic partner legislation. How would you stand on that?

SE: I am definitely in favor of anything that promotes the concept of Gay and Lesbian families.

One concern that I have with domestic partnership legislation is that it does allow unmarried heterosexual couples to get the same benefits that Gay and Lesbian couples would get.

Some of my more conservative friends in the Republican Party have indicated that they would be more in favor same-sex marriage legislation instead of domestic partner legislation. Straight people can get married. Domestic partnership is a kind of in-between status for them and I do think that conservative legislators would have more of a problem with that than marriage.

Would I support domestic partnership legislation? If that is the legislation that seems to stand the greatest chance of passing at the time it's introduced, I would support it, but I still favor same-sex marriage.

WL: Do you favor maintaining current funding for AIDS prevention, education and care, or increasing it?

SE: Certainly, I would be in favor of increased funding as the client load of an organization like the Milwaukee AIDS Project increases. This is one area where the money would not be wasted.

WL: You're a Gay man. You're running as a Republican There seems to be a contradiction in that. Is there?

SE: No, there isn't. The Republican Party has always stood for individual freedom. It was founded in Wisconsin as an anti-slavery party. Some in the Party have veered off in the

wrong, but "right" direction when it comes to Gay issues. But when I talk to my friends, other Gays and Lesbians, their basic values are Republican values, when you talk to them about crime or taxes or the dozens of other issues.

I don't know that I was comfortable following the 1992 Convention in Houston, but I would maintain that the Pat Robertson part of the Party is a very small proportion of the Party and in Wisconsin, it's a very, very small proportion.

I have the support in this campaign of some very conservative Republican legislators who may be characterized as ultraconservative, but who are supportive of Gay/Lesbian rights.

WL: So, you're saying that you believe you can win this race?

SE: Yes, I am, but I'm not saying it will be easy. While this is a traditionally Democrat held seat, there are a number of factors that don't make this a traditional Republican/Democrat match.


A large part of the District is relatively new for the incumbent--a much less liberal part--and Gay/Lesbian issues are among the reasons that we will win in November.

WL: Any candidate is, I think, looking for "eager hands." Are you?"

SE: Yes, absolutely. We need money. We need volunteers who can get out on the streets and help us to do door-to-door campaigning, and people who can stuff envelopes.

Catching the Errors--Well, At Least Trying to Find Them!

The first letter came innocently enough. "Dear Editor: In reviewing this article in last week's magazine, I found a number of errors. I have noted them on the enclosed copy..." Indeed he had. Seven, maybe 8 corrections had been made in red pen. Most of the corrections were the addition or removal of commas, but not all. A few misspellings, one was grammar.

The letter was a jolt to me. You see, I'm the proofreader. If there was an error, it means I've missed something. Maybe I'd

just had a bad day.

Next week the second letter came. More errors and this time more dialogue. The letter was caustic, even snotty. "Don't you people have a proofreader?" The fact that the article had gone to press without being proofread didn't make me feel any better. I was the proofreader, and therefore I was accountable.

Letter #3 turned the heat up a notch, but was basically similar to the first two. But letter #4 wasn't. My phantom critic was by now livid. In addition to a copy of the article with the corrections made, I got a stinging letter. Obviously, I had "no personal esteem." Why else would I allow a magazine that reflected a "5th grade education level" to be printed? My spectral expert offered to come to our offices and do the proofreading himself in order to spare us the embarrassment.

Actually, there are lots of reasons why all mistakes aren't caught. Some are missed by me. Some I catch but the typesetter fails to correct. Sometimes in the rush to meet a deadline, an article circumvents the proofreading sequence altogether and is printed with only a cursory review by the writer. And some 'errors' may be technically wrong, but reflect the style of the writer. These I don't change. Several of the mistakes that prompted my phantom's most recent letter were indeed glaring; I have no explanation for how they got through.

But what was becoming apparent was the rising level of vitriol in my phantom's letters. The letters had started innocuously enough, but had quickly moved to mean- spirited. Now they were downright nasty. This man was spending a lot of time trying to make me look bad. He was certainly getting under my skin, for which I was sure he would have been pleased.

I reread my critic's letters and finally it dawned on me why he was so angry. It wasn't really the errors he was working so hard to find. It was the fact that we never acknowledged him in any way.

Generally, I think a Letter to the Editor deserves a response. Someone has taken the time to express an opinion. At a minimum, they deserve a reply. Mind you, I think there is a level of nastiness that, once surpassed, removes the obligation of a response. My phantom critic had probably passed that level in his last letter. But what about the first 3 letters? Perhaps the reason #4 was so angry was that #1, 2 and 3 had seemingly gone unnoticed.

So I composed a letter. I explained the proofreading process. I explained how hard I tried, but still occasionally failed, to find all the mistakes. I closed by asking him what was the point in his letters. I was doing my best; what were his letters supposed to achieve?

My answer came swiftly. First of all, my letter. I'd used "myself" when proper grammar called for using "me." Nothing major, but to my phantom critic, an error was an error. And all errors were basically the work of dim-witted buffoons.

But once he passed that, his letter turned rather mild. Not apologetic - no, he'd found errors and that was that - but the mean-spirited tone was gone. He meant to have his day in court and now he'd had it. His letter closed on a friendly

There is a lesson to this. People who write letters need to be listened to. They need to be told that someone has heard their opinion.

I'm still proofreading. And I know my phantom critic is still out there looking for errors. And that's okay. We understand each other a little better now. There's something reassuring about that.

Religious Right Promotes 'Fear-Based' **Curricula to Censor Sexuality Education**

(Washington, D.C.)-Religious Right political groups have seized the offensive in their ongoing challenge to sex education, according to a new report released in June by People For the American Way.

Teaching Fear: The Religious Right's Campaign Against Sexuality Education finds that in communities across America, groups are trying to supplant comprehensive sexuality education curricula with their own programs, which contain no information about contraception or AIDS prevention, and which primarily seek to instill fear of sexual activity. The People For report comes on the heels of a major new study from the Alan Guttmacher Institute documenting the crucial role of contraceptive use in teen pregnancy prevention.

After years of getting nowhere, these Right Wing political groups are trying a new tactic in their campaign against sex educasaid People For the American Way President Arthur J. Kropp. "They are peddling their own programs that are notoriously short on facts and big on fear. At a time when America's teens are besieged by threats to their health, these distorted programs do nothing to provide life-saving information. ideologically-driven programs are nothing but another vehicle for the Right's political and social agenda.

The People For report identified four key trends in the Right's campaign against sex education in the public schools:

1. Promoting curricula that censor spe-

cific information on prevention of AIDS and teen pregnancy, and that teach

The advent of the AIDS epidemic, and Surgeon General Koop's call for early and comprehensive AIDS and sexuality education, forced a change in tactics in the Right's political battle against sexuality education.

As a substitute for comprehensive curricula, they developed and promoted several 'abstinence-only" curricula--notable Sex Respect and Teen Aid programs. These programs are being billed as substitutes for existing sexuality education. But they omit the most fundamental information on contraception and disease prevention, and perpetuate medical misinformation.

Winning control of local school boards as a first step to eliminating compre hensive sexuality education.

In many communities where there is strong Religious Right influence on the school board, comprehensive sexuality education curricula have been abandoned in favor of the more expensive, less educationally sound abstinenceonly programs.

In California, the Religious Right domi-nated school board in Vista has adopted Sex Respect after a long and bitter controversy.

'Capturing the school boards is crucial to the Right's overall political agenda for education," said Kropp. "When these groups do gain control of school boards, they quickly pursue a range of goals like gutting sex educa-

tion, imposing the teaching of Creationism as a science, and attacking multicultural educa-

3. Defending abstinence-only curricula against court challenges.

The Religious Right-supported programs have increasingly been challenged on legal grounds, since many states now have statutes designed to ensure that sexuality education covers essential information such as contraception and AIDS prevention.

While many cases are pending, an appeals court in Louisiana ruled in March that Sex Respect violates state statutes prohibiting the teaching of religious doctrine in sexuality education programs.

4. Rallying grassroots support against comprehensive sexuality education.

Virtually all national Religious Right political groups have included their efforts to undermine sexuality education in their broader campaign against the public schools.

Eagle Forum, Concerned Women for

America, Focus on the Family, and Citizens for Excellence in Education have led the way in devoting major resources to promoting these abstinence-only curricula.

To rally their membership to this cause, they have developed a range of promotional materials, including paid advertisements and video tapes, that perpetuate gross distortions of fact and play on the anxieties of parents about their children's sexuality.

As a corollary to this effort, they have made a frequent target of the Surgeon General. Dr. Joycelyn Elders, for her high profile efforts to promote comprehensive sexuality education and prevent teen pregnancy.



hen lesbian Christine Kehoe ran for San Diego City Council in 1993, her opponent, a "longtime friend" of the gay and lesbian community, mailed a flyer comparing their candidacies. The flyer implied that Chris Kehoe had no family because she had no children and did not list Kehoe's partner, parents or anyone as a family member.

H owever, Chris had many family members on election day. Family members much to my horror, he found a mistake in that made her the first out lesbian elected to office in San Diego history -- elected by a 10% margin of victory. Victory Fund members knew that Chris Kehoe was candidate and a family member that our community could count on.
