#### **Numbers of AIDS Cases Continues** to Rise; Containment May Be in Sight

Washington, D.C.-On her 19th birthday, Jecenia de Jesus lost her mother to AIDS. Months later, she felt she had lost her own future as well.

"I was 19 years-old, HIV-positive and all alone," said de Jesus, remembering the day she was told that she, too, carried the virus, although she wasn't a drug-taker like her

"I hadn't even begun living and I was waiting to die.

The 22-year-old de Jesus, who helps run a Harlem HIV-AIDS project that emphasizes "living with AIDS," told her story Monday, August 14, at the opening of a three-day international conference on the disease.

She is among more than 1 million Americans and among more than 19 million men, women and children worldwide who carry the AIDScausing HIV--a legacy of rampant infection rates in the 1980s.

A recent report says that there are now 5,000 people living with AIDS in Wisconsin.

The 1990s will see increasing AIDS deaths, but perhaps also containment of the disease through global prevention programs, said J. Brian Atwood, administrator of the U.S. Agency for International Development.

Some 300,000 to 600,000 people are expected to die from AIDS this year. AIDS deaths are projected to hit 1.5 million to 3 million by 2000, when 10 million children could be orphaned by the disease.

AIDS is the No. 1 cause of death for Americans aged 25 through 44.

"These statistics are not someone else's problems," Atwood told the more than 700 AIDS experts at a meeting sponsored by his "If communities wither and nations die, all of us will pay.

Atwood said the United States and other countries must make a stronger commitment to pay for AIDS prevention and education programs. The U.S. aid agency provides more than half of the money spent on such programs worldwide, with a budget of \$121 million this

"Our rhetoric at international meetings still surpass the tangible actions of our govern-ments," Atwood said. "Fear and ignorance still play too large a role in our national de-

Patricia Fleming, director of AIDS policy for the White House, said U.S. AIDS funding has increased 40 percent since President Clinton took office. And the House recently agreed to boost funding for the National Institutes of Health office that deals with the disease.

Additionally, scientists are making progress in preventing AIDS infection of unborn babies

#### Clinton Ends 40 Years of Government Policy that Said Gays were Security Risks

Washington, D.C.-President Clinton has ended more than 40 years of government policy that assumed Gay people to be security risks who could not be trusted with official se-

The language and tone of the 13-page Order, developed at the President's direction by the National Security Council at the White House, together with input from the Department of Justice and the Office of Management and Budget, is definite, precise and binding government-wide.

The Order says in part, "The United States government does not discriminate on the basis of race, color, religion, sex, national origin, disability, or sexual orientation in granting access to classified information.

... No inference concerning the standardes in this section may be raised solely on th4e basis of the sexual orientation of the em-

Gay activist groups praised Clinton's order ending discrimination based on sexual orientation in granting security clearances.

Elizabeth Birch, executive director of the Human Rights Campaign Fund, called it "an important step toward ending governmentally

sanctioned job discrimination against Gay and

But Republican Congressman Bob Dornan, a long-shot candidate for the GOP presidential nomination, called Clinton's action "something else he didn't have to do that's gotten in our

"I wouldn't trust them with a \$5 loan, let alone the nation's secrets," Dornan said of Gay people, whom he also labeled "promiscuous by definition."

The order establishes the first uniform standards for U.S. agencies in granting security clearances and it requires federal agencies to recognize each other's security clearances.

An executive order has the force of law, but it can be overturned by Congress

A requirement for federal employees who handle classified information to be trustworthy grew out of a loyalty program established by President Truman in 1947, a time of growing concern over communism. Executive Order 10450 modified the loyalty program in 1953 and, for the first time, included "sexual perversion" as a basis for removal from the federal service.

Federal agencies used the sexual perversion standard to label Gay people as security risks. It was not until 1975 that the Civil Service Commission issued guidelines prohibiting the the basis of sexual orientation. But policies regarding security clearances for homosexuals remained vague or restrictive until the early

#### Federal Judge Says Gay Category is Not Rational and Blocks Discharge of Gay Sailor

Seattle, WA--A Navy lieutenant who acknowledged that he is Gay was not discharged on Friday, August 11 as scheduled but will get his day in court.

U.S. District Judge Thomas Zilly issued an injunction Tuesday, August 8, blocking the Friday discharge of Lt. Richard Watson, stationed at the Bangor submarine base on Puget

Zilly said the law requiring him to leave the military may well be unconstitutional and issued a preliminary order barring the discharge until the merits of the case can be argued in court--probably within 90 days.

The law, enacted by Congress in 1993, requires members of the military who acknowledge their sexual orientation to either rebut the presumption that they engage in Gay sexual behavior or face discharge.

"The classification of homosexual is not based on any rational basis, but rather solely on prejudice," Zilly said.

Watson has consistently received glowing evaluations characterizing him as "one of the most capable officers in the submarine force.

In October, he advised his commanding officer: "I have a homosexual orientation. I do not intend to rebut the presumption" that he engages in homosexual acts.

The Navy responded by scheduling his dis-

The issue has come up twice previously in federal court, in New York and Virginia. One ruling supported the law and the other found it in violation of equal-protection and free-speech rights guaranteed by the Constitution.

In his presentation to Zilly, attorney Christopher Bakes, a member of Watson's legal team, asked the judge to imagine the commander of a sexually mixed unit declaring his heterosexuality and being ordered to rebut the presumption he would engage in sexual activity with senior members of his unit.

Justice Department lawyer Mark Quinlivan argued that "Congress reasonably assumed that any member...is likely to act in a manner consistent with his or her stated sexuality, unless the member demonstrates otherwise.

The Senate committee that considered the law concluded that sexual behavior "is one of the most intimate and powerful forces in society" and said "experience demonstrates that few remain celibate.

"The difference between the treatment of declared homosexuals and heterosexuals in the military, in part, is that the military can deal with the sexual attraction between heterosexuals by separately quartering men and women."

The "Recognizing Our Own" tour will begin on Thursday, September 21, in Madison.

The tour will continue through October and November and include such cities as San Francisco, Los Angeles, Dallas, Chicago, New York and Atlanta. The tour concludes on November 21, in New Orleans.

In each of the stops along the way, Clarenbach will not only be honoring those openly Lesbian or Gay public officials, he will be urging on the community the vital importance of Lesbians and Gay men seeking public office, he said.

The tour has another purpose as well, Clarenbach said. He wants Washington to realize that the "rest of the country is way ahead" in acknowledging the contributions of Lesbians and Gav men.

"One of my top goals in this new position," Clarenbach said, "is to bring an outside-thebeltway wake-up call to the nation's capitol.'

Clarenbach was making reference to the often heard complaint that D.C.-based Gay activist organizations may seem out of touch with what is going on in the rest of the coun-

#### NATIONAL NEWS BRIEFS

#### Fred Phelps Convicted on Two Counts

Emporia, KS-AP- Convictions on two misdemeanor counts of disorderly conduct apparently don't bother the rabidly homophobic Rev. Fred Phelps. "If you guys knew how little this bothers me, you wouldn't even be asking me questions," Phelps told reporters after the verdict was read on August 11. A Lyon County jury deliberated about 50 minutes before returning the guilty verdict.

While Phelps denied all wrong-doing, prosecution witnesses testified that Phelps had stood outside a Topeka restaurant and shouted "queer" and "faggot" and "whores" at six people who he believed to be Gay. One of the six was Margarite Hanlon, who is 86 years-old. Phelps and members of his family were at the restaurant picketing because he said the restaurant hired and

Phelps said he plans to challenge the constitutionality of the state's disorderly conduct charge "all the way to the Supreme Court."

#### Zimbabwean President Likens Gays to "Beasts"

Harare, Zimbabwe-AP- President Robert Mugabe renewed his attack on Gay people on August 11, likening Gay people to "beasts" and calling on his people to "hound them.

If you see people in your areas behaving like homosexuals, arrest them and take them to the police," Mugabe said at a ceremony honoring guerrillas who had died fighting for Zimbabwe's independence. Departing from his prepared speech, Mugabe said Gays were "reduced to the status of beasts. If dogs and pigs don't do it, why must human beings?'

The attacks follow intense world-wide criticism from human rights groups over Mugabe's scathing attack on Gays while opening a book fair his government had pressured to withdraw a Gay literature exhibit. In protest, the South African publishers discontinued their cooperation with the fair, according to Reuters news service. The South Africans said the exclusion of Gays from the fair was "indefensible," considering the fact that the fair's theme was human rights

Human rights groups in Zimbabwe and elsewhere have said that Mugabe has chosen to scapegoat Gays to distract attention from worsening economic hardships, official graft and controversy over his own relationship with his female secretary

#### Thailand Bars Editor of a Gay Guide

Bangkok, Thailand-AP- The British editor of a Gay magazine that tells readers where to find Gay and Gay-friendly spots in Thailand and around the world, has been barred from entering Thailand, the government said on August 11. Put on the blacklist for defaming Thailand was John D. Stamford, editor of Spartacus Gay Guide, the Thai Foreign Ministry said. The publication has been sold in Thailand and 149 other countries for the last 24 years. The ministry accused Stamford of publishing pictures in the guide that had "pedophilic tendencies.

#### Speaker's Sister Coming Out into Spotlight

Rochester, NY-AP- Candice Gingrich called for Gays and Lesbians to be open and honest about their sexual orientation in order to combat discrimination. The out-spoken half-sister of Newt Gingrich, the Speaker of the House, told an audience at Rochester's Lake View Baptist Church that she has a simple message: "We all have opportunities to make a difference by educating people around us." She said she believes one way to counteract homophobia is for Gay people to be seen as people--not issues.

"Joan or John Q. Public out there, when they hear about discrimination against Gay people, they think, 'Oh, discrimination against Gay people.' But if John or Joan know Bob, who is a Gay male who lives next door or Jill, who they work with who's a Lesbian, it's no longer Gays who are discriminated against, but Jill or Bob. It really makes a difference, when they realize it affects people," Ms. Gingrich said.

Ms. Gingrich was in Rochester as part of a 51-city tour as spokeswoman for the Human Rights Campaign Fund's (HRCF) National Coming Out Project. Both Madison and Milwaukee are scheduled in the tour, according to HRCF

#### David Geffen Gives \$4 million for AIDS Services

Los Angeles-AP- Record mogul and openly Gay David Geffen is giving \$4 million to New York's Gay Men's Health Crisis (GMHC) and a related organization-the largest single gift for AIDS services GMHC said.

AIDS must be everyone's fight," said Geffen, one of the founders of the new DreamWorks studio. "I hope my contribution will encourage more people to come forward and give generously. In the face of so much death, it's essential we do all we can to support life.

#### The previous largest single gift was also given by Geffen, a \$1 million donation. Arsonists Target Two Gay Establishments

Phoenix, AZ-AP- Arsonists have targeted two Gay establishments within the last two weeks in Phoenix, but fire officials say they aren't sure whether the blazes were a threat or an incredible coincidence.

An amateur arsonist, on August 7, splashed gasoline along the back walls of the Metro Dance Factory and lit a match to it. The small fire caused about \$500 in damage to the building.

Another arson victim wasn't so lucky. On July 26, arsonists destroyed the offices of Echo magazine, Phoenix's largest Lesbian and Gay publication.

No anti-Gay graffiti or markings were found at either fire and neither fire was followed by anonymous phone calls by the arsonist, police said.

#### PLAGAL Salutes Roe V. Wade's McCorvey

Boston, MA-- Philip Arcidi, President of the Pro-Life Alliance of Gays and Lesbians (PLAGAL) on August 13 praised Norma Leah McCorvey, the plaintiff Jane Roe in "Roe v. Wade," for becoming a volunteer in the pro-life movement. "McCorvey's intellectual and spiritual journey on the question of abortion echoes the sentiments of many Americans and evidences continued hope for recognition of the rights of the unborn in our country," Arcidi said.

Arcidi sees her change of mind as an example to all with misgivings about abortion, particularly to Lesbians and Gay men. "McCorvey's pro-life advocacy shows that her life as a Lesbian is consistent with her new work on behalf of the unborn. We believe others will be inspired to bring their pro-life sentiments out of the closet," Arcidi said. Arcidi added, "Many will find, as did McCorvey, that 'I think I have always been pro-life, I just didn't know it.

PLAGAL was founded in 1990 and currently reports to have over 450 members in chapters in Boston, Cleveland, Minneapolis, Philadelphia and Washington, D.C.

#### **New Hampshire Activists Hold Rally in** Support of Gay and Lesbian Youth

Merrimack, NH--A proposal to bar schools from presenting homosexuality as an alternative orientation and lifestyle would create a discouraging and violent atmosphere for Gay youth in the community, a critic said.

Randy Kottwitz organized and staged a candlelight vigil in Merrimack, New Hampshire on Monday, August 14, as the five-member school board debated whether to approve the proposal by board Chairman Chris Ager.

The proposal is to add a clause to district policy prohibiting "any program or activity that has either the purpose or effect of encouraging or supporting homosexuality as a positive lifestyle alternative.'

Kottwitz said the proposal "is rooted in hatred and bigotry. Although the immediate targets are Gay and Lesbian children, it does reach outside of the school system in terms of expressing this hatred and bigotry toward the

The "Vigil for the Victims of Gay Teen Suicide and Gay Teen Violence'' was held from 9 p.m. to midnight in the Merrimack High School parking lot and was a peaceful protest.

"I knew that a lot of people shouting and carrying signs was not going to be productive to our cause," Kottwitz said.

The vigil was an attempt to offer Gay youth in the community support, he said.

Gay youth are two to three times more likely to attempt suicide than other young people and may account for up to 30 percent of youth suicides, according to a 1989 report by the U.S. Department of Health and Human Serv-

Board members Ginny Twardosky and Shelly Uscinski support Ager's measure. All three have said the policy was necessary to ensure the district does not do anything to "promote' Gay sex or trample on parents' rights.

"It's just not our business to be promoting or encouraging or supporting alternative life-styles," Ager said. "People should be allowed to live their lives the way they see fit when they're outside of the school system.

Among the speakers at the vigil were Betsy Janeway, president of the state chapter of Parents, Families and Friends of Lesbians and Gays; Kevin Jennings, executive director of the national Gay, Lesbian and Straight Teachers Network; House Democratic Leader Rick Trombly, (D-Boscawen); Michael McSheehan, a leader of Seacoast Outright; and Jim Bretz of the Citizens Alliance for Gay and Lesbian

Jennings, a former teacher in Rhode Island and Massachusetts, helped win approval of a bill in Massachusetts in 1993 aimed at guaranteeing a safe school atmosphere for Gay stu-

Jennings said the Merrimack measure amounts to "thought control" that would have a chilling effect on local teachers.

'It creates a climate of fear for teachers," he said. "If they tell me I have to do this, what's the next thing they'll tell me I have to do?' The teachers are going to be afraid of not just this but a lot of other things, and more concerned with keeping the school board off their back than being effective at their jobs and giving students the best education they can.'

Board members indicated fast month they did not plan to vote on the measure until September 5, though Ager said Tuesday the board could vote earlier if he could find a majority.


#### **GLAAD Needs You**

I have been actively involved in National



#### **Guest Editorial**

No one applauded more loudly than this paper when former Wisconsin state legislator David Clarenbach was appointed to a position of national leadership as head of the Victory Fund last June. We have made no secret of the high regard in which we hold David. He is a man of unquestionable integrity, experience, and conviction who accomplished more for the Gay and Lesbian rights movement over the years than any other legislator in this country. And he is a

David's appointment to the job at the Victory Fund marked a turning point in what has been several years of difficult transition for David--a period marked by his retirement from the state legislature after more than 20 years in elected office, his 1992 defeat in a bid for Congress, the death of his beloved mother, and the dissolution of his marriage to a woman he loved deeply. While these last several years have also been a time of accomplishment and moving forward, those of us who care about David have longed for the time when he might be able to return to the realm that is his passion and his calling--the arena of electoral politics where he made his home for more than 20 years.

There's no question that the Victory Fund has hired the right person for the job. David has what it takes: an almost unparalleled background as someone who has run for elected office at all levels of government, incredible success as a fundraiser, a deeply-rooted grassroots consciousness, an exemplary record as a coalition builder, and an intimate understanding of the

Consistent with his family's long history of social activism, David's personal idealism and compassion have always driven him to put unwavering principle above political expediency. He knows and speaks eloquently of the principles that drive the movement for Gay, Lesbian, and

What concerns us today, however, is that upon taking the Victory Fund job, David has been publicly sending some mixed signals that may come back to haunt him. He must begin to focus and refine his message in regards to his personal story, especially when he starts interacting with the national Gay and Lesbian press.

For in taking this position, David "came out" for the first time in his long political career as an openly Gay man. For more than 20 years, he had remained silent on the subject of his own orientation, instead holding up the precept that the right to sexual privacy on behalf of all individuals is the foundation upon which the fight for Gay and Lesbian rights must be based. And in articulating the principle of sexual privacy now and over the years, David speaks an important truth.

However, the truth that transcends all others in our movement is the power inherent in our coming out and telling our stories. However inadvertantly, in sending a mixed message in recent days, David has sometimes been sending a contradictory message--with the implication woven throughout that ultimately, the decision to come out is not all that important.

In announcing his appointment in mid-June, the Victory Fund issued a statement in which David was quoted as saying, "One of the biggest regrets of my life is that I didn't run for Congress as an openly Gay candidate. As Executive Director of the Victory Fund, I will do everything in my power to keep other qualified candidates from making the same mistake.

It was a statement that sounded perfectly straightforward and unequivocal, and it reportedly assuaged the fears of Victory Fund board members who were concerned that someone who had never run for office as an openly Gay candidate would be able to speak authoritatively at an organization with the mission of promoting openly Lesbian and Gay candidacies.

However, within a couple of weeks, David was distancing himself from that statement, and with good reason--it denied the integrity of his relationship with Heidi Nass, his companion of more than 10 years who had become his wife during the year in which he announced his run for Congress. In an interview in early July with Jeff Gillan of WKOW-TV, he questioned whether it had been appropriate to express regrets about not having run as openly Gay at that time. "Well, I don't know if it was a mistake, because at the time I was married to a woman, a wonderful person with whom I had a deep and loving relationship," he told Gillan.

"And it would have been a bit unusual to have identified oneself as being Gay and being married at the same time, which isn't much of a contradiction--people fall all sorts of places on the spectrum of sexuality. And I also felt that it was important to establish the principle of sexual privacy, that it really was an irrelevant issue when it came to running for Congress. While it is extremely important to me that candidates adhere to a principle of supporting civil rights for all people and to oppose bigotry at every turn, I don't know that it is a prerequisite in being a candidate for Congress to identify with whom you sleep and with whom you love.

In a follow-up interview with John Quinlan, Clarenbach again tried to clarify his own selfdefinition, when asked to clarify what he meant when he told Gillan that he was "probably bio-

The theater filled rapidly. There were hundreds of people there, all ages, but a lot of

Yet across the aisle from me and one row down, quietly enjoying each other, being together in a way that filled me with so many memories.

When I was their age, there was no rainbow flag. And while I may have dreamed about going on a date with Tommy Marchase, it was impossible for it ever to have been.

But, just as the lights started to go down, I saw one slip his arm about the shoulders of the other. It was such a casual gesture, done so easily, as if it had been done countless times before. I hoped that it had,

The movie was good. It starred Keanu Reeves after all. But I honestly couldn't concentrate much on it.

When it was over, I got up, making sure to

get right behind them. Outside, I smoked a cigarette and watched

#### **David Clarenbach Talks About His Victory** Fund Appointment, Coming Out and Outing

Wisconsin Light: What is the significance of your coming out publicly for the first time as an openly gay man in accepting the appointment at the Gay and Lesbian Victory

David Clarenbach: I guess my thought process is that I'm being hired not to be a Gay and Lesbian poster child, but to be an advocate, and a spokesperson and an organ-izer for openly Lesbian and Gay candidates seeking public office.

It is not particularly relevant to the job description that I am Gay and it is important to me to maintain the dignity and respect of my private life. Yet it is clear to me that it is an important part of the job to have courage, by example.... Candidates for public office who are Gay or who are Lesbian who are contemplating the level to which they should make that information public. An ability to present, to make the case to them, a case that I have learned through personal trial is not only the most honest and the righteous, in all true meanings of that word, path to follow, but also the one that make the most political

Who I am and who I love has never been a particularly big secret. I've never made much of a secret of my loving and committed relationship with a woman. I've never made much of secret of a loving and committed relationship that I had with a man. And those features of my private life which I intend to remain private.... I guess I'm not being very articulate on this....

To hide, or to cover-up, or to lie about one's personal life is very different from being respectfully private. I think that it is important as I do my job with the Victory Fund, since the mission and goal of the Victory Fund is to advance openly Gay and Lesbian candidates to be honest and direct about who I am, and where I've been and where I'm go-

I guess I'm not sure where I'm going with Ask me again, even if it's just rephrasing the question, I want to get to the crux of what you're getting at, and if I'm not being very articulate, just ask me again in a different way.

WL: Let me try to come at it this way, first. What is your response to the observation that you confused many in the Madison Gay and Lesbian community who had believed that you were Gay when you announced your marriage to a woman in January 1992, eight months prior to the primary election in your run for Congress?

DC: The logical conclusion of that argument would be to suggest that I deny the existence of a loving, supportive relationship that I have had with a woman for 10 years. Sort of the mirror opposite of homophobia.... Does a person who has a relationship with someone of the opposite gender need to hide and deny in order for the Gay community to

support one's candidacy?

And I would no more deny a relationship with a person of the opposite gender than I would deny a relationship with a person of my own gender. And that is and will always be a basic underlying principle that I will not

And if who I love and who I live with undermines political support that I might enjoy from whatever community in my constituency, I'm damn willing to pay that price to defend my personal existence and my per-

sonal right to privacy. I do not think--I'm going to put it in the affirmative-I enjoyed the overwhelming support from Gays and Lesbians throughout the Congressional Second District and from within my constituency in the state legislature (in my race for Congress in 1992). The overwhelming majority knew exactly who I was, where I was coming from, and were comfortable with my being David Clarenbach. There were admittedly some individuals--and will continue to be until my dying day--who are suspicious of anyone who attains or seeks public office-their motives and their level of honesty. That kind of suspicion is probably very, very healthy. You need to be suspicious of political office hold-

But the consistency and uniformity with which certain standards are applied need to be considered and reflected on very seriously because in some ways those same critics that somehow were attributing contrary motives to a personal relationship that had been developed over a period of ten years...

WL: For the record, the timing of the marriage, just before the election.... Was the decision devoid of consideration in terms of

the election coming up?

DC: Yes. (Pause) I think that people are al-ways looking for easy labels. I wasn't comfortable with labels. It wasn't a qualification for Congress who I was sleeping with. I think that my position on public issues was abundantly clear. I will compare my track record and list of accomplishments against any elected official in the country. Period. Congress, state legislature, city council. I can look with pride on an unprecedented list

of legal protections and funding programs, based on sexual orientation and HIV and AIDS status and hate crimes, and you can go down the list. That is the basis upon which I wish to be judged, and not who I sleep with and what I do with them once I do. And that's, I think, the basis on which I was hired to lead the Victory Fund.

WL: Would you do things differently if you had it to do over again?

DC: I think that having been elected to public office first in 1972, the year that Barney Frank first got elected to public office....

generation practically where there were no openly Gay elected officials anywhere in the country--none--in 1972.

Now you've got fourteen from Wisconsin. You've got five members of the Oregon state legislature who are openly Gay or Lesbian. (In a tongue-in cheek, mocking tone) It's becoming almost an epidemic.

It's a very encouraging sign. If I were to be a candidate for public office, there's no question but that that's one of the issues that would arise, you deal with it honestly, it becomes a non-issue, and you move on. Just as I believe my private life to be a non-issue with respect to my job with the Victory Fund, deal with it honestly, move on. It's but a blip on the radar screen. And I'm eager and enthusiastic to meet this new challenge with the Victory Fund. There's no question in my mind but that I will do my job and do it well. There is an almost limitless potential for the impact that the Victory Fund can and will have on the body politic of America today. And it's not a question of shifting gears. It's a question of continuing the momentum that the Victory Fund has built up for its first four years. Four years from now I fully expect that we will be fielding candidates in every state of the union for elective office. It will no longer be a unique or a newsworthy event that...(for example) 'an openly Gay member of the Arizona state legislature was elected this fall, my isn't that unusual?' No, it's not unusual-it happens every election. That's where we intend to be in four years.

WL:To follow-up on an earlier comment you made-using language similar to what I often hear from Gay and Lesbian elected officials who have decided not to be identified as openly Lesbian or Gay.... You said, "It wasn't a qualification for Congress who I was sleeping with." Isn't the significance of being an openly Gay or Lesbian candidate something that's more than just a matter of who that person sleeps with ...?

DC: It's about brotherhood and sisterhood. It's about respecting diversity. As we say lo-cally, at least, "celebrating difference." (slogan of a local civil rights awareness campaign) That that shouldn't be cause for division, it should be cause for a commonality of interest in a community of interest.

So there is more to the self-identification of one's sexual orientation than just declaring with whom they have sex. And that is the important part of an individual's growth and maturity and the decision that they make as to that self-declaration. Every one of us walks down this path at a different pace, taking different side trips. And it is not anyone's right to judge that path and the speed at which an individual makes that journey.
I am who I am. I am comfortable with

that. I choose not to judge anyone else's process in coming to that point. I think the bottom line is that people need to be allowed to make mistakes and make decisions them-

WL: Does your own process in deciding now to come out-declare yourself publicly for the first time to be a gay man-put you in a position to advocate the power inherent in making that decision? Because that's what the Victory Fund is all about.

DC: Yes. And it's not just righteous. It is in the candidate's best self-interest. And what we collectively need to do is to create a sufficiently secure political environment so that more and more people will feel comfortable in making that political and personal decision. And that's not just changing or moving the political process, it's societal changeattitudes, educating and sensitizing the public, and that is what builds that secure and supportive political environment.

WL: Kathleen DeBold's (asst. director of the Victory Fund) read on your appointment is that your own struggle with the issue of whether and how to be out will help you in counseling others who are weighing the pros and cons of running openly gay candidacies. Does that make sense to you?

DC: You know--"been there, done that"--as

And it is a unique personal journey just to run for public office. I've campaigned for hundreds of people. There is nothing that comes close to putting your heart on the line when you're the candidate. Because when it's rejected, it's you that they're rejecting, not a third party. And, to have been there and to have served in public office for twenty-some years does provide me with some insight as to the process that some other candidates will and have gone through.

WL: What about your own personal coming out process; how did your parents react?

DC: We didn't discuss relationships or anything of that sort very overtly in my family, but there was always a quiet support for my partner, whoever it might have been at the moment. That person was included in family events and holidays and things of that It was never even a question in our household, and that's what helped make it a very natural part of my life.

WL:Did you discuss Gay and Lesbian rights in your family-a family that was very deeply involved in feminist issues and other

civil rights issues?

DC: Yeah, not early on, but certainly as I developed my own political repertoire and started becoming more publicly identified with advocacy on Gay and Lesbian civil rights, that certainly became part of it... And in some ways, I think I helped to move my mother (Kathryn Clarenbach, co-founder of the National Organization for Women) along in terms of her public advocacy as well. know that early on she took the position that a more radical feminist perspective ought not be advanced quite so stridently... By the end of her public service career, she incorporated Gay and Lesbian civil rights into her stated program of social change, and so, I think it

WL:Did being Gay translate itself into

empathy for other people facing oppression?

DC: Yeah, I think so. That was one of the things that my mother always emphasized, that none of these movements are isolated or peculiar or unique at all. They each have unique ingredients to them. But they were really part of a... What do right wingers accuse liberals of--being secular humanists--and my mother was an unapologetic secular humanist, or feminist humanist. She really believed it as do I.

WL: How did the struggle growing up Gay

affect your belief system?

DC: I don't even know if I had 'that struggle,' so I'm not even sure if I can answer that question. I just don't know.

WL: For some people "coming out" is a process that is very dramatic-one moment it isn't there and the next moment it is, one moment there is a great deal of self-loathing and shame, and the next moment you cast that aside... Was it that way for you?

DC: You know, I haven't ... maybe I'm being really naive or just tuned out to that level of analysis, but I've never really studied that internal equation. I'm not trying to dodge the question, because obviously we've talked about a lot of things, but I just really haven't considered that-the role that those is-

sues have played in my life and whether I had that kind of--I mean I am what I am and I've never questioned who I was.

WL:My own experience is of having an awareness of being Gay going back to about age 5, but having a specific date that marks my coming out to my parents and friends at age 26...

DC: Hmmm, Wow. Well, that is dramatic. Well, I can believe that. I can't chart a date or even a landmark. It's like Popeye. 'I y'am what I y'am.' I'm Popeye.

WL:Could you respond to the notion that your being Gay may have been well-known within the Gay/Lesbian community during your years in the legislature, but not in the community-at-large, and that some of the power in being out there as a Gay man is in the larger community knowing that a respected community leader is Gay?

DC: I don't know that it was relevant.... I'm probably not the one to ask a question like that. You could ask Tammy, but we didn't serve together in the legislature.... You could ask Tim Carpenter.... My suspicion is that a lot of members of the legislature, a lot of the press, and a lot of the general public has assumed that I was Gay, as a result of my political and legislative association and prioritization of Gay and Lesbian civil rights bills, but I don't know that to be the case. It's just a guess on my part.

And there's I think some advantage to that, too. Would that not help undercut any stigmatization or --what's the word I'm looking for...

WL: If somebody "assumes" that you're Gay, then it has the same effect, is that what you're saying?

DC: Yeah.

WL: Your judgement about the choices others make in deciding to be openly Gay or Lesbian elected officials?

DC:I think that that has to be a choice that is entirely respected by our community and is up to the individual to decide.

I don't believe in forced coming out or public disclosures of individual's sexual orientations. Under any circumstances.

WL:What about the case of a Gay politician who's doing destructive things in the process of trying to deny their Gayness?

DC: I disrespect that person. I'm ashamed

DC: I disrespect that person. I'm ashamed and embarrassed of that person. But to me it's kind of like the issue of the death penalty (which he opposes). Are there issues in which the crime is so heinous that someone deserves the death penalty? On an emotional level, there is probably some button that could be pushed, that says yes, goddamit, that person deserves to die. But I cannot bring myself to pull the trigger. And I cannot defend homophobia or bigotry of any sort whether it is being conducted by a Gay or Lesbian person or someone who is straight.

But I would not apply any more stringent standard to someone who is in the closet than I would to someone who is straight and advancing a homophobic or bigoted cause. If you had a Jesse Helms who is straight and proud of it, because he's Darth Vader--he represents the worst of American instincts--do you set him up in some compromising position and take photographs, do you do that because he's an evil man. No, I don't think so. Do you threaten someone who's a right-winger by bringing him out of the closet? No, I just can't understand, defend the circumstances.

WL: Are there any circumstances, though, where the impact of a closeted Gay or Lesbian elected official's hypocrisy constitutes grounds for calling them on their hypocrisy?

DC: I'm opposed to outing. But I know that there are those in the community whose roles I respect deeply as part of a diverse movement that would contend, would even go so far as to say anyone who is closeted, whether they're an advocate or a successful advocate or not should be yanked out of the closet and the integrity of their decision-making process be violated.

WL:Are you saying, in part, that if you out someone, it takes the meaning out of

coming out?

DC: Yeah, I guess it does. And it certainly shouldn't be used as a punishment.... There is something a little twisted about that.

WL: What kind of reaction do you think there will be to your "coming out" for the first time in print as an openly Gay man?

DC: I've been able to survive and prosper in a public and political arena by recognizing that there are certain things that are outside of one's control. You don't write the headlines, you don't write the newspaper articles. People will say, will read, will think whatever they want. And if there are suspicions or questions about motives, all I can do is be true to myself. And I can't control what people say behind my back. I hope that I'm not so self-absorbed to think that it's on the tip of everyone's tongue-that everyone's sitting around the dinner table talking about whether I got appointed to some position or not. It's not in the big picture, particularly significant whether it's me or William Waybourn or somebody else who's doing the job as long as the job's getting done. And I'm not doing this for the headlines or the glory. This is going to be a tough job. It means uprooting myself from my childhood home.

I've lived in Madison my entire life. This is a very comfortable and known commodity. And I'm having to leave my friends and a support network, and a very important job (as Acting E.D. of the Madison AIDS Support Network) that I've been doing for eight months or so. It's a challenge, and it's important. And I don't know what the Wisconsin Light, or Washington Blade, or New York Times will say about me, what conclusions are drawn, ultimately it isn't something really care about. I'd rather they'd say that I'm a really nice guy, rather than that he's a jerk, of course, that's human nature, but I don't lie awake thumbing my fingers and wondering what somebody is saying about me at that very minute. I don't think that most people really care.

WL:I think that that this aspect of your taking the job-your coming out-is something that people will talk about, will react to, something that's significant, something that hadn't been explicit or out there before. Given all of the speculation that's been out there before, it is something that will make a difference...

DC:I just don't agree with that premise. I just don't--except for people with a National Enquirer mentality, (people will say) 'oh that's kind of interesting,' and then people will go on with their lives. I don't think that who I am particularly matters to anyone outside of a small circle of friends, and that a board of directors has selected me to direct an important political program is the headline-that's the news, that the important factor.

WL:In terms of the Lesbian and Gay community, though, I guess the difference that I would see among some people is that this marks the transition from your being an "ally" of the community to your being a "member" of the community. (Note: Clarenbach accepted a Lesbian and Gay community service award in 1993 as "Ally of the Year.")

DC:That's an interesting perspective. And I suppose that some will share that.

WL: Is that divergent from how you feel?
DC:Yes, I've been a part of the community
my entire life. As you well know, I have not
exactly hidden who I am. As I have said,
I've never lied. If someone out on the campaign trail came up to me at the Iowa County
Fair and asked, "are you Gay?" I'd have responded, "yeah, and what of it?" There was
never an effort to have some phoney-baloney
front

WL: The notion was during your Congressional campaign in 1992 that when you campaigned on the coasts that you were presenting yourself as an openly Gay man in order to raise money in the Gay and Lesbian community, but when you came back to Wisconsin, you represented yourself locally as a married man. In other words, dependent on political expediency, one representation with

the Gay and Lesbian community on the coasts, which were far away, and a different representation as a married man back in Wisconsin.

DC: I had a fundraiser in Washington with Barney Frank and Studds, it was at Bruce Lehmann's house—my female partner was with me at the event. I don't hide my relationships and I would not do that to someone who I loved and that I cared for. And certainly would not play that kind of insidious

gamesmanship.

WL: Any final points?

DC: I feel that I am a deeply personal person. I don't.... I just think that that's who I am.

WL: It's not what you represent of yourself, but it's what you do?

DC:I think that that's the basis upon which most people--Gay or straight--want to be judged



#### 'Kids' Is a Spare, Brutal, **Cautionary Tale of Adolescent Sexuality** that Offers Little

Occasionally there are films that cannot be judged merely upon the sum of their cinematic parts. These films instead, exist on a fundamentally more profound level, resulting from intense media hype. Recently, the traveling medicine show has turned its blinding spotlight on Larry Clark's Kids, a spare, brutal, cautionary tale of adolescent sexuality.

Months prior to Kids actually finding a home at a cinema near you, the film has been alternately praised and vilified, more often than not on the basis of the same arguments. So, at what point does "Kids: The Movie" emerge from "Kids: The Movie Hype?"

Perhaps it doesn't. Maybe it can't.

The screenplay by 19 year-old Harmony Korine tells a simple story: 24 hours in the lives of modern teenagers.

First, there's Telly (Leo Fitzpatrick), a tall, scrawny white kid obsessed with fucking virgins. Sex, Telly will reflect to the audience, is what gives life meaning. Doing it with virgins empowers him. He also thinks that only screwing virgins is a pretty cool way around safe sex.

Telly's best friend is Casper (Justin Pierce). A couple years older than most of the other kids, Casper is a couple of cans short of a six-pack, the result of too many drugs, too much liquor and way too many skateboard crashes without a

Violent, stupid and dishonest, the few thoughts that Casper is actually capable of putting together, invariably revolve around sex, but he is usually too fucked up to do much about it.

Finally, there is Jennie (Chloe Sevigny), one of Telly's many conquests. Jennie accompanies her far more promiscuous friend Ruby to the clinic for an AIDS test. "Bad girl" Ruby, despite a lengthy, varied and pretty advanced menu of sexual activities, gets a clean bill of

Prototypical "good girl" Jennie, on the other hand, has managed to get herself HIV+ on the basis of her one and only time between the sheets. Needless to say, she is devastated. Presumably the audience is meant to be as well. Don't think so.

Director Clark and screenwriter Korine have managed a collection of exploitive, baldly manipulative scenes of underage and unprotected sex, excessive drug use and brutally graphic violence in creating this typical "day' in the life of today's adolescents. Clicheridden, rabidly anti-Gay, anti-woman and racist to boot, Kids does indeed prove that such typical American family values as misogyny, white supremacy and prejudice all start at an

What cannot be debated is that Clark has

produced a disturbing, almost mind-numbing cinematic experience. Deliberately blurring the distinction between documentary and narrative filmmaking, Clark has succeeded in creating images so realistic that it becomes impossible not to think that this young cast was being badly exploited and abused.

After nearly two hours of Clark's shrill indictment of '90's America, no solutions are offered. Idle and aimless, the kids from Kids not only lack any hope for the future, but suffer a present compulsively concerned only with immediate gratification.

Telly and company have absolutely no qualms about screwing or abusing supposed friends in their single-minded pursuit of this goal. Despite knowing Telly will, in all probability, infect Darcy, Jennie does nothing to stop them.,

Casper can rape Jennie the morning after the party while she is passed out from drugs despite insisting he is her friend.

So, how are we in the audience supposed to care about Casper and Jennie when they have so little regard for each other or for them-

The answer is simple. We don't.

tor (Stephen Gilborn) dismisses Carol's complaints as "all in her head." Her patronizingly patient husband is likewise patronizing.

After she begins to experience nose bleeds, vomiting and a variety of seizures, even Carol begins to recognize that platitudes like "Reduce stress" just aren't going to continue

From a flyer posted at her health club, Carol finds herself on a journey which will lead to the diagnosis of her condition as "Twentieth Century Illness" and which will ultimately result in Carol left alone, isolated in a sterile igloo located at a new age treatment center in the deserts of New Mexico.

Parallels with the AIDS epidemic are inevitable. Yet what makes Safe so frightening is its depiction of the very ordinary material objects that surround each and every one of us as the cause of "Twentieth Century Illness.

Clearly Haynes is asking the question, where do you go when there is no place to run, nowhere to hide? The complete and thorough bleakness of Haynes' vision makes his answer quite clear.

Safe is not without flaws. The very coldness

of the film, its obsession with facades and superficial materialistic appearances, immediately distances itself from the audience.

Similarly, Carol's very ordinariness makes her a rather spiritless hero. Deliberately, methodically paced, Safe lacks the spark to engage our passion as well as our reason. Rating: \$\$\$\$ (scale \$ to \$\$\$\$\$\$)



#### 'Safe' Presents a Bleak and Frightening Picture of Rampant Disease

Superstar: The Karen Carpenter Story hailed the emergence of a unique new cinematic voice. Blending adult subject matter, unconventional narrative structure and a frighteningly bleak vision, in his first feature, Poison, Todd Haynes raised a storm of controversy, particularly when the media exploited the fact that Poison was funded, in part, by the National Endowment for the Arts.

Safe is Haynes' eagerly awaited follow-up feature. In its horrific depiction of a sinister, mysterious, environmentally caused immune system disorder, Safe is unlikely to disappoint any of his fans.

Haynes' story is simple. Carol White (Julianne Moore) is a numbingly ordinary wife and homemaker living a complacently affluent lifestyle in California's San Fernando Valley. Step-mother to her career-drive husband's young son Rory, Carol's day-to-day routine seems, well...pretty darn routine.

She picks up dry-cleaning. Then Carol is off to complain about the wrong color sofa set that was just delivered. They certainly didn't order it in black. Black doesn't go with the color scheme in the room. She and hubby ordered teal. No, she doesn't understand how the original order could have been marked that they wanted it in black.

Then, it's off to lunch with her best friend. Wait, let's not forget about her weekly aerobics class. Then again, there are those occasional wifely duties (you know, um...SEX).

Well, that should just about do it. All in all, a

#### 'A Walk in the Clouds' is a Warm Summer's Dream of Love and Goodness

In a world where romance only seems to pop up in television commercials hawking international flavored coffees or brand name color film. Alfonso Aran's lush, lyrically romantic A Walk in the Clouds is a bit of a culture shock.

Then again, A Walk in the Clouds does have those zany Zucker brothers, Jerry and David as producers. While perhaps more famous for bringing such classics (?!) as Airplane and Naked Gun to a cinema near you, they were also responsible for that supernaturally romantic hit from a few Summers

Like Ghost, A Walk in the Clouds is similarly light as air in the story department. Handsome soldier (Keanu Reeves) returns home from World War II (Pacific theater), emotionally battle-scared, to his unlikely young bride (Debra Messing), so self-absorbed that she couldn't find time to read Paul's almost daily battle-front correspondence.

Presumably prompted by their disastrously awkward reunion, in skimming a few of these heart-felt missives, Betty Sutton realizes the magnitude of her mistake in marrying Paul.

Regardless of how disappointed Paul is in returning to Betty, crack of dawn the first day finds him on a train to Sacramento, box of chocolates under his arm. A seller of chocolates before the war, Paul will disregard all of his dreams and goals upon Betty's urging and return to the land of soft and chewy centers.

Improbable and coincidental circumstances bring Paul and Victoria (Aitana Sanchez-Gijon) together where Paul so finds himself playing the newly-wed husband to an unmarried and pregnant Victoria.

Plans for a quick getaway are foiled by kindly, slightly befuddled Don Pedro Aragon, Victoria's grandfather played with nearly

complete saintliness by Anthony Quinn. Boy has met girl. Soon he almost loses girl. Eventually, everyone lives happily ever after. Who, after all, could ask for anything more?

Those looking for any topical, issue-drive themes, hip or satirical comedy or the slightest elements of hard-edged realism in this neverneverland of a film are going to be sorely disappointed. Instead, A Walk in the Clouds is a radiant film filled with delightful moments of warm, often earthy humor, glorious sunrises and a simple, yet effective story


As the young couple gradually falling in love, Reeves and Sanchez-Gijon are both gorgeous and believable. Sanchez-Gijon provides Victoria with a fiery emotional center barely disguised beneath the facade of her required role as a docile, dutiful daughter.

Reeves is not, perhaps, one of this generation's brighter acting lights, but here he is pretty gosh-darn likable, with a slightly goofy, decidedly off-center charm.

Helping Reeves considerably is the fact that Arau has presented his "gringo" character immediately as an outsider, his lack of family and his very blandness at odds with the charismatic, tradition-driven Aragon family.

Adding to A Walk in the Clouds' dreamy, atmospheric quality are some excellent production values. Special mention must be given to Maurice Jarre's lush score and David Gropman's picturesque production design.

What is refreshing is that the film is an unabashedly old-fashioned romance. If following one of Hollywood's classic romances, the kind that are only shown on the American Movie Classics channel, you bemoan the fact that "They just don'[t make 'em like they used to," here's the movie for you! Just be sure to take a tissue or two and enjoy.

#### 'Something to Talk About' Has Everything Going For it. So Why is it So Dull?

New York, NY--How is it that a movie that seems to have so much going for it-- picture postcard settings, A-list actors, an appealing soundtrack, a script from the author of Thelma and Louise and all the best intentions--can leave you feeling so flat?


That's the mystery of Something To Talk About, an intelligent but slow-moving comedy-drama starring Julia Roberts as a young wife forced to examine her life when she discovers her husband has been cheating.

If you've seen the ad in which Roberts scandalizes a gathering of well-heeled Southern ladies at the local Charity League by demanding to know "if this is a regular service to all my friends," you've seen the best moment in

Roberts plays Grace King Bichon, a contemporary wife of the moneyed South who works on her father's huge thoroughbred farm. From the outside, she seems to have it all--a sweet daughter (Haley Aull) who's already proving to be a talented horsewoman, and a wellappointed house.

Grace's placid existence falls apart when when she sees her good-looking husband, Eddie (Dennis Quaid), in a clinch with another

Equally hard to deal with is the unsympa-

Her autocratic father, Wyly King (Robert Duvall), is mainly worried the scandal will be bad for business. 'And her gracious mother, Georgia (Gena Rowlands), also tells her to forgive Eddie. "It happens in the best of marriages," she murmurs in her velvety southern drawl. "He slipped. It's up to you to

But that's not good enough for Grace and her feisty, outspoken sister Emma Rae (Kyra Sedgwick). Emma responds by kicking Eddie in the groin, inviting Grace to move in with her and eventually encouraging her to date another man.

The performances from the major female leads are convincing, particularly Roberts as the vulnerable nice-girl and Rowlands as the long-suffering wife used to smoothing the wa-

With his patented devilish grin, Quaid also is believable as a charmer known as "Hound Dog" in college. And Quaid and Roberts work well together as concerned parents.

But there's little chemistry between them as a romantic couple. It's easy to see how the marriage foundered because of boredom and apathy. With no glimpses of real passion, it's hard to work up an interest in whether they'll get back together.

Screenwriter Callie Khouri won an Academy Award for her 1991 debut Thelma and Louise and, though she's echoing some of the same themes here, nobody can accuse her of

stereotyping.

The characters have real depth. Quaid isn't just the bad guy, he's a great dad who genuinely regrets the things that have gone wrong

In her role as the salty-mouthed sister, Sedgwick is given some of Khouri's better lines, but she can't escape the limp tempo ei-

And Duvall, typecast as Big Daddy, looks like he's just walking through the movie.


Director Lasse Hallstrom (My Life as a Dog, What's Eating Gilbert Grape,) captures the dignity and serenity of his subjects and settings, but he does it a little too well, making the film slow and dreary.

The lackadaisical staging, combined with rather somber lighting from cinematographer Sven Nykvist (Fanny and Alexander), is like a black hole that sucks everybody in.


Hallstrom includes some excellently shot steeplechase scenes that make you feel like a rider going over the jumps. But the subplot-whether the charming little girl will be allowed to ride her favorite horse, and whether she'll win the Grand Prix-is too predictable.

With so many shoot-'em-ups monopolizing theaters this summer, it's a real pity this wellmeaning movie doesn't come together. But by the last 15 minutes, you're less interested in whether Grace and Eddie's marriage will work out than when the movie will finally end.

Ultimately, Something to Talk About does not provide a lot to talk about.


girls and boys for sale.

#### Robert H. Eichberg, Co-Founder of National Coming Out Day Succumbs to AIDS

WISCONSIN

Tesuque, NM-- Robert H. Eichberg, a psy-chologist who co-founded National Coming Out Day and wrote a popular book on how people reveal their homosexuality, has died of complications of AIDS. He was 50.

Eichberg died Friday, August 11, at his home in Tesuque, just north of Santa Fe.
Eichberg's book, Coming Out: an Act of

Love, has become required reading for friends and family of Gays and Lesbians, said Lynn Shepodd of Santa Fe, president of the Santa Fe Lesbian, Gay and Bi Pride Committee.

"If you care to have any relationship with Gay people, his book is essential," Shepodd said. "It accurately describes the process that Gay and Lesbian people go through in their

"His whole life's work was about bridging the gap between Gay and non-Gay communi-

ties, allowing people to discover who they are, and really encouraging them to go out and do something with that knowledge," she said.

Honey Ward of Santa Fe, a friend and colleague, said Eichberg helped "thousands of people--people who had literally lived lives of quiet desperation, people who thought their lives were not going to get any better, people who thought they would always be secondclass citizens.'

In an interview with The Associated Press in 1993, Eichberg said "Most people think they don't know anyone Gay or Lesbian, and in fact everybody does. It is imperative that we come out and let people know who we are and disabuse them of their fears and stereotypes.

Eichberg was born in Brooklyn in 1945 and lived most of his life in Los Angeles.

His activism began more than two decades

ago with the founding of a political action committee for Gay, Lesbian and women's civil rights in Los Angeles.

In 1978, he founded The Experience, a community-based workshop that inspired people to reveal their sexual orientation to family and friends, Ward said.

Eichberg moved to Santa Fe in 1988-- the same year he co-founded National Coming Out Day with Jean O'Leary of Los Angeles, Ward said. National Coming Out Day is observed annually on Oct. 11.

A gathering to celebrate his life was held at 1 p.m. Saturday, August 12 at the Santa Fe Ski Basin lodge. A celebration also is to be scheduled in Los Angeles at a later date, Ward

Eichberg is survived by his partner, Jon Landstrom of Santa Fe; his mother, Shirley Greenes; his father, Norman Eichberg; and brothers Peter Eichberg and Steven Eichberg, all of the Los Angeles area.

#### **Lesbian Custody Case** Over 6 Year-Old Boy Goes to Federal Court

Madison- The mother of a 6-year-old boy believes her constitutional rights will be violated if a former Lesbian lover gets court permission to visit her child, a civil suit says.

The lawsuit filed in U.S. District Court on behalf of Elsbeth Knott requests an injunction preventing Sandra Holtzman from winning a state-court ruling in the dispute.

The Wisconsin Supreme Court sent the case, June 13, to Circuit Judge George Northrup to consider Holtzman's claim to visitation rights.

The two Madison women have disputed the visitation issue since their breakup in January,



Court records say they met in 1983 in Boston and bought a house together, exchanging rings in a ceremony in September, 1984.

Holtzman attended childbirth classes with Knott and was present when the boy was born. The pair moved to Madison in June, 1992, where Holtzman attended law school.


After the breakup, Holtzman filed for custody and visitation rights, saying she had acted

in the role of a parent. Northrup ruled in 1993 he could grant neither custody or visitation because there was no court action such as a divorce petition.

However, the Supreme Court ruled Holtzman could pursue her argument in Northrup's

The claim is "denying her the rights generally given an intact marital family to be free from government intrusion.'









logically Bisexual," but that the public wouldn't understand that. "I think most people view that particular label, especially when it is self-imposed, as being a cop-out. And I guess that's what I meant to say on Channel 27. That even if someone is Bisexual, that is they are attracted to and respond physically to both women and men, the public would not accept that kind of label. You know, it's got to be black or white, yes or no, Gay or Straight."

Given the fact that David has not chosen to be publicly open about his sexual orientation in the past, Tim O'Brien, who ran last year as an openly Gay candidate for county board, offers the criticism that David has a long history of defining himself in terms of what he thinks people want to hear rather than in terms of who he is. "I thank him for the work that he's done. But I he think he also needs to recognize that taking on this position could harm some of the work that he's done, and could hurt the Gay and Lesbian rights movement, which is all about being out and open about who we are as a means of achieving non-discrimination--and I think that he should withdraw his name from the Gay and Lesbian Victory Fund directorship.'

We respectfully disagree with Tim O'Brien's conclusion, but commend him for showing the courage to raise legitimate concerns about mixed messages that have swirled around David for years. There were many factors that contributed to David's 1992 Congressional loss, but not nearly enough attention has been devoted to the political consequences of the mixed signals that were being sent to members of the Gay and Lesbian community, and by extension to the progressive community, that year. There was a widespread belief in the community, based on his past relationships, that David was a Gay man. And so there was ample speculation that David's marriage (which remained a secret for many months until it was revealed by a reporter in January of 1992) was timed for political expediency, or as some put it less kindly, that it was a sham. And that just wasn't the reality--the reality was in fact, much more complicated.

It was, at base, a misperception, given his long and loving committed relationship with the woman he'd married, but it was a misperception that needed to be addressed publicly given the damage that it was doing to the public's trust. Instead, David responded by invoking the principle of sexual privacy and refused to confront the issue directly. Given other concerns raised publicly that year that David was selling out in order to get elected to Congress, including allegations arising from substantial contributions from long-time foes like the health insurance and cable industries, the fact that these perceptions went largely unaddressed hurt him significantly.

These allegations may have been largely insubstantial, but they did enormous damage to his credibility with the public, and the Clarenbach campaign's response to them was lackluster at

As David knows as well as anyone, in politics, perceptions are everything. And however erroneous the public's conclusions may have been, the public needed to have those questions addressed. It's clear that these allegations hurt him deeply, given his long record of achievement on the cutting edge of social change. But it wasn't just his record that people were concerned about, in a year when establishment politicians were particularly suspect. Given the politics of a Congressional district much less progressive than the assembly district he once represented, the question was whether he could be trusted to continue to stand for the things he had once stood for once he reached Washington.

Given his past record, members of the Gay and Lesbian community wanted very much to support him. However, in a year in which he was being challenged in the primary by an opponent whose candidacy as a highly-qualified Native American woman held enormous promise, and in which another highly-qualified openly Lesbian candidate was running for the first time for the state legislature, many chose not to put their energy into his campaign.

As David has pointed out in recent interviews, the public trust is a fragile thing. One of the most powerful aspects of a person's decision to run as openly Lesbian or Gay, he's noted, is that the public respects a person's willingness to be completely candid about who and what they are. In a community in which more than a dozen people have been elected to office as openly Lesbian and Gay candidates, that expectation of candor was extremely high.

When interviewed, David continues to show the anger and ambivalence he feels toward the members of the community who have raised questions about how he has responded to the question of his own self-definition. He has alternated between acknowledging and accepting the breach of trust that many in our community felt as legitimate, to lashing out at the "National Enquirer-like mentality" of those who found themselves frustrated or confused by his statements and actions that year. Those close to him confirm that concerns about a Gay and Lesbian community noted for its ability to criticize and condemn its leaders almost prevented him from tak-

"It has hurt me that there has been such a focus, not on what the Victory Fund does, or the skills and the abilities and experiences that I would bring to the job, but the personal nature of my relationships.... "he told the Light's John Quinlan. "It has surprised me frankly that some people, including yourself... have focused on that as much as you have, and I just need you to know that if this is as big as a point as you seem to be making it--I hope, at some point, that I'll understand that a little better."

These are inherently difficult issues to raise. As a bottom line, a person's path in coming out must be one they choose themselves. Too often, as a community, we become self-righteous about the journey's others take, despite the fact that each of us makes difficult and often contradictory coming-out decisions every day of our lives.

The very personal choices that David has made in his own journey is not the question. The paramount issue here is that as the leader of one of the nation's most influential Gay and Lesbian groups the messages that he sends to the nation are clear. Sexual privacy is an important principle, as is the right of individuals to transcend labels that fail to indicate the complexity of human relationships. However, those messages must not drown out the more overwhelming personal and political truths inherent in what it means to come out.

As would any of us in his position, David is clearly struggling with how to explain himself as he "comes out" very publicly about who he is for the first time. Some mixed messages are to be expected. However, after years of stating over and over again that he longs for the day when a person's sexual orientation is simply irrelevant, it's important that he focus instead on a message that recognizes the reality of the current day. The power inherent in our "coming out" is the single most powerful factor that will advance the cause of Gay, Lesbian, and Bisexual

As Mark Pocan and Tammy Baldwin observed on the August 13 edition of Sunday Night Out, David's struggle will ultimately serve him well in advising and counseling candidates contemplating what it means to run for office as an openly Lesbian or Gay politician. And, as they also pointed out in no uncertain terms, David has what it takes to take the Gay and Lesbian Victory Fund to new and impressive heights.

We know David, and we know the powerful things he has achieved here in Wisconsin. We have every reason to believe that he will continue that extraordinary record of success at the Victory Fund in Washington. We also know that he will be under an enormous amount of scrutiny from the national Gay and Lesbian press, and from countless individuals in the weeks and months to come, particularly as he begins a three month long national tour in September.

Beyond a doubt, David is right when he says that he is ultimately not the issue here, that the issue is the important work of the Gay and Lesbian Victory Fund itself. But we encourage him to be patient and thoughtful when asked to tell of his own journey, because in a community that

so highly values what it means to come out, these are extremely important questions.

And what a powerful journey it has been. We are so proud that Wisconsin's own David Clarenbach will be leading such an important national organization. In the weeks to come, we'll be featuring a series of stories that more fully tell his story. And, also in the weeks and months to come, we look forward to covering the remarkable achievements of a man for whom

that he now opposes affirmative action.

The latter Governor has always opposed government programs which use race as a basis for selection, even if they favor people of color and are designed to remedy past discrimination.

The former Governor has taken his position in opposition to affirmative action only because he sees that it is politically popular, and as another means of scapegoating a segment of the population for the economic problems of his state which he himself has exacerbated by increasing taxes.

The latter Governor has taken his position because of firmly held moral principles, principles which should not be susceptible to sudden change.

The former Governor has proven himself to be a fiscal liberal and a social conservative, while the latter Governor has proven himself to be a fiscal conservative and a social moderate, as he claimed.

There is one other significant difference between these two Governors: one of them is running for President, and the other is not.

Unfortunately, it is the former Governor, Governor Pete Wilson of California, who is running for President, and the latter Governor, Governor William Weld of Massachusetts, is not.


The former Governor, having proven himself to be a fiscal liberal, then resorted to becoming a social conservative in order to win re-election.

First, he vetoed a bill which would have banned discrimination on the basis of sexual orientation even though he had told Log Cabin members that he would sign such a bill, claiming that the law already banned such discrimination (which was not true).

He later signed into law a weaker bill banning discrimination on the basis of sexual orientation (apparently such discrimination was not illegal after all). The former Governor more recently vetoed legislation allowing domestic partners to register with the state, even though the legislation had no fiscal impact and did not confer benefits upon domestic partners, in order to placate the fundamentalist Christians.

The latter Governor not only supported banning discrimination on the basis of sexual orientation, but also appointed many openly Lesbian and Gay persons to positions in his administration, adopted domestic partnership benefits for state employees by executive order, created a commission to study the problems of Lesbian and Gay teenagers, and pushed through legislation requiring public schools to provide counseling for lesbian and Gay teenagers.

Finally, the former Governor decided to make immigrants the scapegoat for the economic problems of his state, and argued for cutting off all education and welfare benefits for illegal aliens.



#### **Speaking From The Right**

#### Federal AIDS Research Funding

It is unfortunate that many AIDS activists have resorted to distortion regarding a recent U.S. House Subcommittee vote on AIDS research funding, but there is no other way to describe what they have done.

It has been widely reported, including in this newspaper and in In Step, that the House Appropriations Subcommittee on Labor/HHS/Education voted on a party line vote to eliminate the federal Office of AIDS Research, and some have reported that the Subcommittee voted to cut AIDS research funds.

This is patently untrue, as the language of the Subcommittee report demonstrates.

The Subcommittee vote merely ended the practice of separately allocating funds for AIDS research to the National Institutes of Health (NIH) (the Federal government's main arm for conducting medical research)

arm for conducting medical research).
Funds for AIDS research were lumped in with all funding for NIH, which was actually increased by \$642 million.

The Subcommittee language not only contemplated the continued existence of the Office of AIDS Research as an advisor to the head of the NIH, but also contemplated an allocation from the \$642 million increase to AIDS research commensurate with the need.

The Subcommittee specifically stated: "The Committee wants to make clear that it continues to support the Office of AIDS Research (OAR), its leadership, and its coordinated

budget planning process and that it expects the individual institutes, centers and divisions to fully cooperate with OAR's work.


"The Committee assumes that the NIH Director's decisions on allocating AIDS funding will be fully consistent with the plan developed by the OAR and that he will ensure that the institutes allocate their budgets accordingly."

It appears that many AIDS activists are so intent on making Republicans look bad that they are willing to misstate the facts in order to accomplish their goal. It is unfortunate that reporters in the Gay press are too willing to take what the AIDS activists say at face value rather than investigate the accuracy of their statements with contacts on Capitol Hill or the Log Cabin Republicans.

I, for one, am proud of the conservative Republican Subcommittee for allocating an increase to NIH research funding, which should lead to a significant increase in AIDS research funding if President Clinton's Director of the NIH acts as he should, at a time when most programs are being cut.

The latter Governor instead advocated forcing all welfare recipients to work and limiting the eligibility of all welfare recipients for receiving welfare benefits to a specific amount of time.

Most recently, the former Governor has suddenly reversed his long-held position in favor of affirmative action and announced
