Maine's Anti-Gay **Ballot Measure Set to** Go to Voters in Less **Than Thirty Days**

Portland, ME—While writing to the Justices of the U.S. Supreme Court while Colorado's Amendment 2 case is being heard probably would do little good, there is one situation where the Lesbian and Gay community nationwide is being asked to help.

In less than 30 days, Maine voters will decide the outcome of a statewide anti-Gay ballot measure, Ballot Measure One, that threatens Lesbian, Gay and Bisexual Americans everywhere.

Well-funded national anti-Gay groups of the Far Right are funneling resources into Maine to support the discriminatory measure. The initiative was specially designed by anti-Gay Right Wing extremists to resist the kind of court chal-lenges currently facing Colorado's Amendment 2. If it passes, those of the Religious Right and their kind plan to clone it and bring it to states throughout the country.

The Gay community is being asked by Maine and national leaders to act to help defeat the anti-Gay initiative, which will appear on the state's ballot on November 7

The initiative would single out Lesbian and Gay people for discrimination and exclude us from equal participation in the democratic proc-

Portland is currently the only place in Maine that includes Gay people in its non-discrimination laws. Federal and Maine state civil rights laws do not protect people from being fired or otherwise being discriminated against merely for being Lesbian or Gay.

If passed, Measure One would overturn the law in Portland and prohibit Maine from ever including sexual orientation in its nondiscrimination laws.

What happens this year in Maine will affect all Lesbian and Gay Americans.

Maine Won't Discriminate is the statewide coalition working to defeat the anti-Gay ballot measure, and it needs your help. Current polls show that the vote could go either way, so your support can make a difference.

Republican Party Gets \$5,000 from Human Rights Fund—And Keeps it Washington, D.C.-Gay activists and House

Republican campaign strategists managed to find common ground at their first meeting, on AIDS programs and corporate America's efforts to treat Gay and Lesbian employees fairly.

The activists from the Human Rights Fund (HRF) ended up contributing \$5,000 and, to the dismay of the religious right, the Republicans ended up keeping it.

When Republicans seized control of Congress, 'the conventional wisdom was that Gay and Lesbian Americans were doomed," said Elizabeth Birch, HRF's executive director.

Yet, she said, an AIDS care program vital to the Gay community is likely to be reauthorized with full funding and no anti-Gay amendments, and an employment non-discrimination act has more co-sponsors in this GOP Congress than the last Democratic one.

Sen. Bob Dole, (R-KS), made headlines when his presidential campaign solicited and then returned a contribution from Log Cabin Republi-

It was a sobering setback for a fledgling group striving to prove it's feasible--in an age of Religious Right prominence in party affairs-to be both Gay and Republican. But there have been signs of encouragement as well.

When the group held a conference for major donors in June, speakers and Republican minglers included Massachusetts Gov. William Weld, Wyoming Sen. Alan Simpson and eight House members. Among them was Rep. Steve Gunderson, (R-WI), who is openly Gay, close to the House leadership, and increasingly outspoken as he approaches retirement next year.

Gunderson and the Log Cabin group embody what spokesman David Greer calls the winning combination in American politics today," fiscally conservative and socially moderate.

There are three Gay PACs active at the federal level. The largest, the Gay and Lesbian Victory Fund, gives money to openly Gay candidates for local, state and federal office. The fund raised about \$900,000 in the past election cycle and has helped some 400 candidates since its founding in

Spokeswoman Kathleen DeBold said the fund has helped at least two Republican congressional candidates in each cycle. The Human Rights Fund, which raised about \$760,000 in the past election cycle, contributed to two Republican senators and six Republican House members in the first six months of this year. Four GOP House members have so far accepted money from the Log Cabin group, which was organized in March.

Rejections of money these days are rare. House candidates usually hold consistent positions, and Gay groups are careful about their

"When HRF began in the early '80s, there were many candidates who refused money, said spokesman David Smith. "But attitudes have clearly changed since then."

No one has rejected money since 1988, he said, when Rep. Peter Hoagland, (D-NE), refused a contribution. Under attack as a liberal, Hoagland scraped to victory by 2,981 votes. Last fall he lost by 1,766 votes to Jon Christensen, a traditional-values GOP candidate.

Republican lawmakers receptive to Gay concerns are mostly moderates from the Northeast. There are some libertarians and some with relatives or good friends who are Gay. Some are from districts where Gays have clout.

Transgender Activists Lobby Congress

Washington, D.C.—On October 2nd and 3rd, 75 Transsexual, Transgender and Genderqueer activist from across the country gathered on Capitol Hill to participate in the first National Gender Lobbying Day. This historic occasion marked the first time the gender community had raised its political voice in national politics. Concerned citizens from more than 20 states met over the two days with their Senators and Congresspeople, lobbying on issues critical to the gender community such as employment discrimination, civil rights, access to medical care and soaring levels of bias-related violence against the Transgendered.

Said organizer Riki Anne Wilchins of the direct action group, The Transsexual Menace, "It's high time 'Genderqueers' came out of the closets, out of the shadows and out of the margins. Too many of us have lost our jobs, our homes, and even our lives simply because of who and what we are. We work. We vote. We pay taxes. And we will no longer be silenced or shamed into political immobility. With Lobbying Day, we announce to the world that we are out for good.'

Gay/Lesbian Alums at Northwestern University

Chicago-An all-university reception at this month's homecoming celebration will mark the first recognition by Northwestern University of its Gay and Lesbian alumni. "This recognition has been a long time coming," said Charles Katzenmeyer, who chairs the event and appealed to Northwestern's Department of Alumni Relations for official recognition as part of the 1995 Homecoming celebration.

Many observers believe that next month's vote on domestic partnership benefits will signal whether the university is sincere about fair treatment for its Gay and Lesbian population.

Alumni from around the country have expressed interest in attending the event, Katzenmeyer said. Students, faculty and staff also are participating, through the Gay and Lesbian University Union and the Bisexual, Gay and Lesbian Alliance.

The reception will be held on October 20 at 9:30 p.m. at Ann Sather Restaurant, 929 W. Belmont in Chicago. For more information, call Samantha Westcott at (708) 491-4693.

ACT UP San Francisco Wins Round One in Court

San Francisco—Felony charges against four AIDS activists who participated in an "office seizure" of San Francisco Republican Party headquarters, were reduced to misdemeanors on Friday, October 6th at the conclusion of a two-day preliminary hearing. Judge James McBride who presided over the hearing found no basis in the claims by the GOP that the ACT UP demonstrators allegedly caused over \$10,000 in damage to the Republican headquarters. In addition, McBride, concerned over evidence and testimony provided by ACT UP members that points to prosecutorial misconduct and collusion with the GOP by District Attorney Arlo Smith, ordered that all correspondence between the DA and the Republican Central Committee of San Francisco be turned

ACT UP San Francisco has mounted a media campaign against the GOP and is planning to subpoena top-level Republican officials during their up-coming jury trial.

Lesbians and Gays Demand Action from the U.N.

San Francisco-The first ever International Tribunal on Human Rights Violations Against Sexual Minorities will occur on Tuesday, October 17, 1995, 9:30 a.m. to 1:30 p.m. at the United Engineering Center, 345 E. 47th Street in New York City. The Tribunal will provide an international forum for individuals who have suffered persecution and abuse based on their sexual orientation. The testifiers, who represent a range of issues and regions, will present their cases to a distinguished panel of international human rights experts. At the conclusion of the testimony, the judges will issue recommendations calling for the U.N. and other human rights organizations to take their rightful and necessary roles as protectors and defenders of the human rights of sexual minorities world wide.

Co-chairs of the Tribunal are Urvashi Vaid, activist and author, and James C. Hormel, Gay philanthropist. "The U.N. must recognize that Lesbian, Gay, Bisexual and Transgender people are entitled to all existing human rights guarantees," Vaid said.

Disney to Extend Domestic Partner Coverage

Burbank, CA-AP—The Walt Disney Company will offer health insurance to the partners of its Gay and Lesbian employees, as well as the partners' dependent children. "We made this decision because it brings our health benefits in line with our corporate non-discrimination policy, Disney spokesman John Dreyer said on October 6th. The new policy goes into effect on January 1, 1996. Disney joins several entertainment giants, including Universal, Paramount Pictures, Sony and Warner Brothers, that have extended domestic partner benefits in the last three years. Though most of corporate America has been reluctant to extend health benefits to Gay and Lesbian partners, Disney's decision could change that.

"I think other people will say, 'If it's good enough for Disney, maybe it's something we should consider," said Gary Schmidt, marketing director of PacifiCare Health Systems, a health maintenance organization.

Capital Cities/ABC, which Disney plans to acquire, already offers benefits to domestic partners

of Lesbians and Gay men.

Nine Year-Old Born with HIV is Virus-Free

London, England-AP-A nine year-old boy who had tested positive for HIV has been cleared of the virus without medical treatment, Italian scientists say. The breakthrough case was described in a letter in the October 7th issue of the weekly medical journal, The Lancet. Reports of apparently natural recoveries from HIV have sparked both excitement and controversy among experts. "This child showed that it is possible to clear the virus naturally," said Dr. Carlo Giaquinto, a pediatrician at the University of Padova and co-author of the letter. Some doctors, like Giaquinto, say these cases may provide crucial clues for designing more effective anti-AIDS

But skeptics-and there are many-wonder whether these people were ever HIV+ to begin with, or whether the virus is still lurking in the blood and cannot be detected by conventional means. Though symptom-free and virus-free, the boy has a still unidentified immune deficiency.

Christians in the Arena with Coors

Golden, CO-AP- The "Taste of the Rockies" is leaving a bitter aftertaste these days with Right Wing Christians (who don't drink much beer, anyway, so they say)who feel betrayed by Coors Brewing Company's decision to extend health benefits to the domestic partners of Lesbian and Gay employees. The brewing company finds itself caught between Gay activists reluctant to for-give Coors its long-time support for Right Wing causes, and the newly alienated Right Wing

"We did a lot of research and of course people said 'You're going to have this backlash and that backlash," said Coors spokesman Joe Fuentes of the policy adopted in May. "But it's pretty consistent with Coors' philosophy of treating its employees well.

Coors family members still are involved in Right Wing groups. The Coors Foundation has do-nated to the Heritage Foundation and Mountain States Legal Foundation, both Right Wing

But Coors is changing, said Earl Nissen, president of Coors Lesbian and Gay Employee Resource. The domestic partners policy is just an extension of Coors' support of a variety of Lesbian and Gay efforts and donations to AIDS research over the past few years.

Lesbians and Gays Organize in South Dakota

Rapid City, SD-AP- Organizers have announced the creation of a statewide organization to fight for the civil rights of Lesbians and Gay men. Free Americans Creating Equal Status (FACES), was introduced Saturday, October 7, to coincide with National Coming Out Day. Barry Wick, FACES founder, said that Lesbians and Gay men face job, housing and job discrimination. "That's why FACES of South Dakota is important," he said.





Editorial

'Tis Time to Wait

By the time this paper is printed, one of the most crucial civil rights cases in many years will be before the U.S. Supreme Court. The nine Justices will have in their hands the question of Colorado's Amendment 2. The case begins to be heard on October 10.

It is hard to imagine a more important case. Essentially, it is this: can a majority of a society acting out of malice and bigotry, exclude one group of people from the just exercise of their rights because of who they are, who they were born to be?

Being Lesbian or Gay is not a lifestyle. The mainstream media have been del8uded by this and

use the term frivolously.

Being Lesbian or Gay is not a lifestyle. It's a state of being, involving the whole person, both physically and psychologically. It is not chosen, but established well before any choice can be made. The only choice involved, like heterosexuality, is what someone does with it, but that doesn't seem to be at issue here. What is in question is whether we have the right to live our lives in equality and peace, or whether we shall suffer discrimination caused by a misuse of religion so malicious as to be difficult to imagine.

Should the decision go against us, we shall, of course, fight on. No proud and noble people such as we are, can hold their heads up and live in chains. But the fight will be more fierce. No matter how an adverse decision is written, it will be interpreted by the vicious as a cachet to commit all manner of violence against us. The rhetoric will be searing. Our young people, among whom the suicide and run away rate is already great, will suffer most of all.

One of the sadly ironic things about this is that in pushing for Amendment 2 and others like it, the members of the Religious Right are condemning many of their own children. Many of their children will be born Lesbian or Gay. There is absolutely nothing that they can do to stop it and they cannot change them if they are.

But then there is an old saying that evil always redounds back on those who foster it. Sad that this can and, in many cases will, haunt those unaccepting, misguided parents for the rest of their

If the decision is in our favor, our battle will still not be won. We still must fight for the legal rights associated with marriage. We still must struggle to be able to adopt, and a great deal more. A favorable decision will be one battle won, not a victorious war when we can lay down our banners and rest.

Those we have talked to in Washington who are in a position to know, say the outcome is anybody's guess. "No one's calling this one," someone said. Another added, "It'll be close, 5-4 ei-

Unlike some publications, we are not advising people to write to the Justices or call the Supreme Court. We do not think that would do much good. Traditionally, the High Court has not been susceptible of lobbying and it probably isn't now.

Calling or writing your Representative or Senator isn't going to do much good either. They have no influence there.

The National Gay and Lesbian Task Force has called for vigils on October 10th. Such things are happening around the country, but, like letters, we do not think they will do much good-

other than for the people participating in them. In future weeks, there will be much speculation about how this Justice will rule or that. It's all a guessing game. As difficult as it may be, the thing is out of our hands now, and we must wait.

But we can say this. There is no minority, African Americans, Hispanics, Asians, Native Americans or women in general who do not have a stake in this. One or all of them may not think so, but they do.

As we've said so many times before, as long as women are not free and equal, Gay men will be in chains.

Bigotry and prejudice are all of a piece and Mark Furman isn't the exception in this country. Unfortunately, among far too many, he's the rule.

What we hope and pray is that the Justices will understand that unless there is freedom and equality for everyone, no one has it.

When the history of this country is finally written, it may be said that equality, genuine equality was the most difficult of all the lessons that this country had to learn.

Speaking from the Right

The Truth About Ryan White

It is an unfortunate fact that I am once again forced to use this column to "set the record straight" instead of using it to opine on an important issue of the day.

You may have noticed that I have reluctantly become a truth squad of sorts, and I will discuss my theories as to why misinformation seems to abound in the Gay press. But first, the real scoop on the Ryan White bill's passage in the House:

If there is any one person who deserves the lion's share of the credit for the House of Representative's adoption of the Ryan White bill without amendments from the floor, it is openly Gay Republican Congressman Steve Gunder-

It was Congressman Gunderson who interceded with his friends Speaker Newt Gingrich Majority Leader Dick Armey and persuaded them to bring the bill to the floor under a suspension calendar so that no amendments could be introduced

(Perhaps Gunderson was correct to refuse to condemn Armey's slip of the tongue in referring to Barney Frank as Barney "Fag").

As AIDS Resource Center of Wisconsin lobbyist Mike Gifford said, Congressman Gunderson "carried this bill on his back" and ensured its adoption.

Congressman Gunderson deserves great praise and recognition for his courageous efforts to head off the "no promo homo" amendments which Congressman Dornan and other Right Wingers intended to offer in the House.

It is curious then that the report in the last issue of The Wisconsin Light regarding this issue listed Congressman Gunderson as merely one of several members of a bipartisan group of lawmakers who cooperated to advance the legislation, and made no mention of Congressman Gunderson's important role in the process.

It is also curious that the article implies that the Human Rights Campaign Fund (HRCF) had a great deal to do with obtaining the House leadership's support for blocking any amendments. This implication is laughable, as any honest observer on Capitol Hill would attest.

The House Republican leadership is well aware of the fact that HRCF has given more money to state Democrat party organizations, let alone Democrat candidates, than it has to

Republican candidates.

In fact, HRCF was high on the Republican leadership's blacklist of PAC's which have always contributed money to Democrats but rarely if ever contributed to Republicans

The House leadership knows that HRCF has done everything in its power to keep the Republicans from taking power, and they have no interest in helping HRCF as a result.

That is why Log Cabin Republicans (LCR) is so important. The House leadership is willing to listen to Congressman Gunderson and LCR because they know that Congressman Gunderson and LCR have worked to make the Republican majority a reality.

So why do the reports in the gay press mis-represent reality so frequently? Perhaps because most of the articles are written from information provided by the established national Gay organizations like HRCF.

These organizations have two overriding goals at this time: to do everything possible to return the Democrats to power in the next elecand to maintain their brokers in the Lesbian and Gay community.

To accomplish these goals, two strategies have become apparent: the distortion, whenever possible, of the Republican record on AIDS issues, and, when distortion of that record is impossible (as with the recent Ryan White victory in the House), the propagation of the notion that it was their work which was responsible for the victories and the suppression of the notion that LCR had any influence on the outcome.

I have discussed before the evidence of the distortion of the Republican record on AIDS issues (such as the false reports that a House subcommittee had cut AIDS research funding and eliminated the Office for AIDS Research which were "confirmed" to an In Step reporter by

HRCF's attempts to take credit for all good legislation emanating from Congress is evidenced not only by the reports in the last issue of this newspaper, but also by HRCF's own

HRCF has recently created a "magazine" to report its activity to its contributors, and I was mailed a copy of this magazine even though I have not contributed to HRCF in years.

Throughout the magazine, HRCF trumpeted its success in obtaining the adoption of Ryan White in the Senate, but made not one mention of Log Cabin Republican's critical efforts in persuading Senator Kassebaum to take a leadership role on the bill and in persuading Senator

Dole (with, among other things, the \$1000 which was returned to us) to override Senator Helms's hold on the bill and bring it to the floor for a vote

In fact, HRCF consistently lists other organizations which have been instrumental in lobbying Congress on these issues, but never men-

One would think from reading the HRCF magazine that nothing changed last November and that HRCF continues to hold power in the halls of Congress through its influence with the Democrats.

The reality is otherwise, of course, but HRCF cannot afford to allow LCR to gain credibility within the Lesbian/Gay community. The reason for this is that HRCF is concerned, and rightfully so, that LCR might erode HRCF's donor base.

HRCF itself used to pitch the fact that 40% of its donors were Republicans before LCR came on the scene (now they deny that this was ever

If these Lesbian and Gay Republicans see that there is an alternative to HRCF, and an alternative that supports Republican principles and Republican candidates, many of them would likely end their contributions to HRCF, since it rarely ever supports Republican candidates and definitely does not espouse Republican principles, and send their money to LCR instead.

It is no wonder that HRCF's former executive

director so shrilly attacked Log Cabin during last year's election, implying that we were traitors to the Lesbian/Gay community

I suspect that LCR had already begun to erode HRCF's donor base, striking a nerve in the process (and by eroding the donor base I mean peeling away Republican donors, although HRCF has no doubt increased its contributions overall with alarmist appeals to the Gay community to stop the heinous Republican

This is not to say that there is no place for HRCF and other similar organizations at this time. There is no question that they continue to hold much influence on the Democrat side of the aisle in Congress, and victories on Gay issues will continue to require significant votes from the Democrats since much work remains to be done with the Republicans.

But it would be nice if these organizations would have the intellectual honesty to admit that they have very little credibility with most Republican members of Congress, and it would be even nicer if they refrained from distorting the record of the Republicans just so they can return their beloved Democrats to power by mobilizing the Lesbian/Gay vote in support of Democrats in the next election.

This is too much to hope for, of course, because it would mean acknowledging that LCR is needed and, therefore, that money should go to LCR (and presumably not as much would then go to these organizations).

Moreover, it strikes me that many of the socalled leaders of the Lesbian/Gay movement would rather see the Democrats return to power than achieve legislative victories in a Republican Congress, which is why they are willing to do everything possible to distort this Congress's record.

And that is why I will never again give money to any of the establishment, national Lesbian/Gay organizations, and why I will send that money to LCR instead. I urge other moderate and conservative Lesbians and Gays to do

On January 30, 1933, Hitler attained power.

Von Schroeder was not the only foolish Jew in Germany. Others joined Gentile industrialists in bankrolling Hitler's party, despite its anti-Semitism, because they saw it as the best means of protecting their wealth from the threat of Communism.

History is well enough known that I don't have to recount what happened to Germany's Jews. Sadly, the rich ones like von Schroeder were most likely to escape Hitler's camps with much of their wealth intact. at MAP, is On Board and Running Fast

Andy Bagnall is the new Manager of Gay Outreach at the Milwaukee AIDS Project (MAP). Though he has worked at MAP since January, 1993, he has held this position for about a month. So, you can say he is freshly on boardand he has hit the deck running.

It is a bleary day, with the overflow of some hurricane or other pouring over the city in torrents. But as I sit, talking with Andy at the AIDS Resource Center of Wisconsin (ARCW), he is fresh and bright as a golden October day, brimming with energy as a waterfall.

According to his job description, he says, he is to coordinate AIDS prevention outreach to the Lesbian and Gay community; he's to develop programs and expand them; and he's to supervise new staff and volunteers.

But all that's rather formal. What that means, he says earnestly, is that he's going to promote AIDS prevention strategies for the Gay community that will help save lives.

ARCW Executive Director Doug Nelson called Bagnall "an outstanding choice to lead a resurgent AIDS prevention movement in Milwaukee.

"Andy is as tenacious and as hard working a person as I have ever met," Nelson continued. "He's a natural leader, he's deeply committed to the Gay community, and he's determined to bring aggressive and explicit prevention programs to the community.

While Nelson was enthusiastic about Bagnall's leadership ability for AIDS prevention, there is no question that both Bagnall and Nelson understand that Bagnall's new role will also involve strengthening 'MAP's relationships with the Lesbian and Gay community, relationships that in some cases have deteriorated.

"I need the community," Bagnall says. "I need them to help me." He leans forward on the table, reaching out a hand as if to gather people in. "I want to involve the whole community." His dark eye flash.





Also, observers say, the changes came because of a feelings within the Lesbian and Gav community that HRCF (now HRC) that was bound within the beltway, out of touch with the community at large, and predisposed to "cozy up to the Democrats," as one critic said.

As the 1996 election approaches, the Action Center will also include information about presidential, House and Senate races. Users will be able to enter their zip codes to display races in their area, with background research on candidates' positions on Gay and Lesbian issues.

New Statement of Goals

A cornerstone of the new organizational identity is HRC's new "vision statement."

'The Human Rights Campaign envisions an America where Lesbian and Gay people are ensured of their basic equal rights-and can be open, honest and safe at home, at work, and in the community.

HRC has also unveiled its new logo: a simple equal sign that symbolizes the fight for basic equal rights for all Gay and Lesbian people.

To further its attempts at broad community outreach, HRC has added more than 100 community events to the more than 35 HRC galas around the country.

It is also seeking to become an effective partner in state and local efforts to defeat anti-Gay legislation.

As one critic of the organization said, "It's about time. HRCF had become narrow, isolated, provincial and out of touch. They've long needed to broaden themselves, see there's life out there, get in some new people, see that a lot's happening in the grass roots.

The five-member Family Research Institute, headed by psychologist Paul Cameron, produces writings against Gay people that have been widely used in campaigns against Lesbians and Gays like the one waged in Idaho last year over an anti-Gay initiative. It has moved to the Colorado Springs area.

Openly Gay Officer Struggles to Remain in the Navy

Norfolk, VA-Richard Selland has sued Defense Secretary William Perry and Navy Secretary John E. Dalton, claiming he was denied a promotion because he is Gay.

promotion because he is Gay.

Selland, a native of Salisbury, Maryland, said he was one of three officers in a group of 203 who were turned down for a promotion.

"My pay is being held stagnant and I'm being held back regardless of performance," Selland said. "I was not surprised, but I was disappointed."

Selland, who was seeking promotion from lieutenant junior grade to full lieutenant, told a Navy chaplain he was Gay in 1993, and was transferred from the nuclear submarine where he was stationed. He is now serving as a supply officer in Norfolk.

The Navy tried to discharge him in April but he has received an injunction allowing him to stay in the Navy while his suit is pending, Selland said.

Selland's suit claims the military's Don't ask, Don't tell policy is unconstitutional. A hearing is scheduled for later this month.

His promotion was turned down despite supportive letters from three U.S. senators: Barbara Mikulski, (D-MD).; Charles Robb, (D-VA); and Paul Sarbanes, D-MD)--and five House members: Barney Frank, (D-MA); Wayne Gilchrest, (R-MD; Constance Morella, (R-MD); Patricia Schroeder, (D-CO); and Gerry Studds, (D-MA).

In her letter to the board, dated August 1, 1995. Mikulski said. 'The only criteria for military service should be the ability to servenot one's race, gender or sexual orientation. I urge you to base your decision on Lt. Selland's promotion on the quality of his work.'

Navy spokesman Denny Moynihan said promotion boards deliberations are confidential, but members only consider performance records.

Lesbian Editor Takes Aim at the Hypocrisy of the Religious Right

New York, NY—"Before I came out in print, I had never had someone tell me that I was going to hell. Now people say it to me regularly." So begins Linda Villarosa's biographical essay in the September, 1995 issue of Essence magazine. The essay is one in which—as the magazine's cover indicates—"A Lesbian Takes on the Bible."

Villarosa, who is also the executive director of the magazine, utilizes a mixture of personal experience and social critique a she strikes at the hypocritical heart of the "Religious Right."

"Those so-called righteous people take the Bible literally when it suits them," she explains, "ignoring anything that doesn't easily support their narrow condemnations."

Villarosa undermines the Right's obsession with homosexuality, revealing the Religious Right's inconsistent and irrational use of biblical texts. The hecklers who regularly quote the Bible when condemning her Lesbianism, Villarosa observes, have precious little to say about other scriptural taboos.

"It didn't take a biblical scholar to figure out that people who shout me down in lecture halls and write me letters are not sending hate mail to people who are divorced," Villarosa writes. "The man who lashed out at me in Oregon is not

"The man who lashed out at me in Oregon is not condemning people who eat pork (Leviticus 11:7-8). Neither is he carrying on about cattle breeders, farmers who grow two different crops, or anyone who wears a poly-cotton blend of clothing (Leviticus 19:19).

As an African-American, Villarosa notes the particular pain she has experienced within the community, when "Black people are using the Bible against their Lesbian and Gay sisters and brothers just as whites used the Scriptures against our ancestors when they interpreted passages to mean that our people should remain en-

Villarosa concludes her essay with a plea for some scriptural—and common—sense. The essential message of compassion can be rescued, Villarosa suggests, once people "stop taking the Bible literally and begin to read it critically and intelligently."

waukee sponsored by the Far Right group, Christians United, and whose work has been denounced by various civil rights groups, has said his scientific research concludes homosexuality is an `addiction' that has caused an `octobus of infection stretching across the

His writings imply a connection between homosexuality, child molestation and mass murder.

"A wise society tries to be very clear that this is wrong, condemns it, punishes those that it catches engaging in it and goes out of its way not to promote it," Cameron said.

His work is frequently referred to in the literature of Colorado Springs-based Focus on the Family and by Colorado for Family Values, the Colorado Springs group behind that state's 1992 anti-gay initiative.

'Cameron is well-known for inaccurately gathering information and twisting statistics in order to attach the extreme behavior of a few Gays and Lesbians to all,' said Richard Skorman of Citizens Project, which was formed to fight that initiative.

Cameron was dropped from the American Psychological Association and the American Sociological Association, which charged him with misrepresenting sociological research.

'His institute's move will further the mistaken impression that Colorado Springs is the center of Religious Right extremists,' Skorman said

The Idaho Citizens Alliance initiative prohibiting state or local laws protecting Gays from discrimination was rejected by less than 3,100 votes last year. But the alliance has launched a revised version that it is currently trying to qualify for the 1996 ballot.

Gunderson Warns Against Apathy in Face of the Rising Threat of AIDS

St. Louis, MO-The heavy dose of attention in recent years has made people tired of thinking and talking about AIDS, says U.S. Rep. Steve Gunderson.

"We don't have the luxury to be tired," warned Gunderson, (R-WI). "This is not just a big-city issue; people with AIDS are coming home, to rural Iowa and rural Wisconsin and rural Missouri."

Gunderson, the only publicly Gay Republican congressman, spoke on September 30, at the third annual fundraiser for the Human Rights Campaign Fund at the Hyatt-Regency Hotel at Union Station.

The Washington-based political action group claims 150,000 members and schedules black-tie fund-raisers in 27 cities throughout the United States each year.

Gunderson said he agreed with AIDS activist Mary Fisher that this country was in the midst of an 'AIDS fatigue' that was endangering the lives of thousands of Americans.

A congressman for 15 years, Gunderson said he was committed to `building bridges' between Gay Americans and people who feared or distrusted Gays.

He criticized both the Religious Right for its intolerance of Gays and many Gays themselves for their involvement in activities such as Gay parades

"Sometimes, it comes off as an in-your-face kind of thing that seems totally committed to destroying your values," he said. "I have as much difficulty with radical Gay groups as I do with the Republican right."

He acknowledged that he broke political stereotypes. 'I'm a rural, religious Republican and, oh, by the way, I happen to be Gay," he said. 'I don't see myself as a weirdo; I see myself as myself as a weirdo; I see myself as a weirdo; I see myself as a weirdo; I see myself as myself as a we

He agrees that abstinence is the first line of defense against AIDS. But Gunderson added, `I don't think we should pretend we're in some beautiful Disneyland.' He said work in AIDS education and research must be accelerated.

'The Stars Fell on Henrietta' is a Movie for Those Who Want to Dream Again

In The Stars Fell on Henrietta,, director James Keach and screenwriter Philip Railsback transport the audience to another America. The time is 1935. The country is in the throes of the Great Depression. The place is no place really, just a small town lost in the Texas dust bowl.

Enter one Mr. Cox (Robert Duvall). Just a down-on-his-lucker with his cat, Matilda. An oil man, just a speculator really, Mr. Cox is still in search of that first real strike.

Sure, he's been in the business for years. He's even helped other oilmen make their for-tune. Not Mr. Cox. though. Still, Mr. Cox is marvelously magical, feel-good movie experiland by the smell, the taste, the very feel of it.

Fate finds Mr. Cox rescued from a dust storm by Don Day (Aiden Quinn), a farmer clinging to a meager existence on a farm whose land is all used up. Kind souls, Day, his wife and family open their home to the tired and injured man.

the dust storm, is drawn to the fields outside the farmhouse and under a canopy of stars Mr. Cox

Finding oil would seem to be the easy part. First there is trying to convince the beleaguered Day family that beneath their barren fields is enough oil to make them indescribably rich. Oh, then there is also the small matter money,

enough money to set up the oil rig.

The Stars Fell on Henrietta is about dreams. And about hope. In Mr. Cox we have a very determined hero/dreamer. Never doubting for a moment is his dream, Mr. Cox will find oil, or die trying. The oil in the Day's field becomes his goal, his sole goal, in fact the entire purpose in his life. And nothing, absolutely nothing will stand in his way.

The Day family, Don, Cora and their three

children, are the impossibly perfect prototypical American family. They are the Waltons without the saccharine. Honest and hard-working, the Days cannot possibly fathom that there might actually be oil under their farm. Only their little girl Pauline (the adorable Kaytlyn Knowles), who like Mr. Cox has heard the oil, actually believes.

And then, so does Don Day. Maybe he begins to believe because he actually hears the oil, or maybe because he just desperately wants to believe, wants to dream again.

absolutely convinced that he can detect oil on the ence. Technically, director Keach and his director of photography Bruce Surtees have vividly recreated the despair of the Texas dust bowl during the bleak 1930's. David Benoit's lyrical score beautifully sustains the actions.

Keach's cast never hits a wrong note in the film. In the central role of Mr. Cox, Robert In a magical scene, Mr. Cox awakening after Duvall is a wonder, sustaining the right balance of mule-headed determination and eccentricity.

Aiden Quinn likewise invests Don Day with the right combination of despair and blind hope. In the small role of Big Dave, the usual capable Brian Dennehy is aptly menacing.

The Stars Fell on Henrietta is a small film, a story well told. It's just the kind of movie to sneak into to town and then suddenly disappear. And that's too bad. Pam Keesey, Author of 'Lesbian Vampire Stories', to Read at AfterWords

Milwaukee-Sexual and seductive, violently jealous, the Lesbian vampire enthralls every Lesbian she meets. She is so terrifying and so deliciously wicked, so powerfully ancient and alluring, that even vampire buffs have tried to keep her under wraps.

By the time I saw The Hunger, I knew my interest in vampires was more than a passing phase. What I didn't know, sitting there in the dark with my boyfriend by my side was that he was a passing phase.'

'How to Make An American Quilt' is a Rare, Enchanted Film, Warm as an Autumn Day

In years past Jocelyn Moorhouse's How to Make an American Quilt would most probably have been condescendingly dismissed as a "Women's Picture."

All the characteristic elements are here: a focus on emotions rather than action, a predominance of strong female characters, and especially only a few male characters in brief, secondary

Nevertheless, this beguiling filming of Whitney Otto's best-selling novel offers a wealth of pleasures for all manner of audiences.

Quilt's story is deftly and deceptively simple. Graduate student Finn (Winona Ryder) escapes relationship and thesis conflicts by spending the summer at the home of her grandmother Hy (Ellen Burstyn) and her great aunt Glady Joe (Anne Bancroft).

Here Finn intends to (finally) finish her latest thesis, this time focusing on the rituals of women's handiwork in tribal cultures. Meanwhile, Hy and Glady Joe host the Grasse Quilting Bee who are currently engaged in creating a wedding quilt for Finn.

Moorhouse has structured her film in much the same fashion that the Grasse Quilting Bee allows Anna (Maya Angelou) to direct the making of Finn's wedding quilt. Quilt becomes the sum of its parts, each part or segment focusing on a different member of this remarkable group of quil-

house's How to Make an Amerian Quilt, yet serves an almost secondary, passive role: that of Mark Zubro, to

The Grasse Quilting Bee is composed of a remarkable group of women. First there is Hy, Finn's grandmother, who as her husband lay dying sought comfort in the arms of her sister's

Then there is Sophia (Lois Smith), a woman grown bitter with life's disappointments, yet shown as a lively, high-spirited young girl who loved to dive.

Em (Jean Simmons), grown weary of her husband's affairs, is (again) on the brink of leaving him. Yet as a sultry and very beautiful young woman, Em was enchanted as her husband's

As the quilting bee's "outsider", Constance (Kate Nelligan), mourning the loss of her beloved husband, has found comfort in the arms of Em's husband. Anna originally served as a servant to Hy and Glady Joe but now reigns supreme within the quilting bee.

Anna's daughter Marianna (Alfre Woodward) has returned to Grasse from Paris. The lover of many men, she found, if only just briefly, and then lost, her destined true soulmate.

Much as the Grasse Quilting Bee seeks to create a quilt, filled with love but also with wisdom for Finn's wedding, each member seeks to impart some essence of her life to Finn, to offer advice that will guide Finn to the happiness that may have, in fact, escaped their own lives. In Finn, they have found a very apt and receptive

Highlighting Quilt is its large and impressive

cast. Definitely an ensemble effort, Quilt nevertheless features a few, truly standout perform-

With her marvelously fluid voice, Maya Angelou is impressive as Anna, storyteller, former servant and now the quilting bee's inspiration and leader.

Jean Simmons is radiant as Em, and Lois Smith invests in Sophia a poignant vulnerability only just barely masked by her facade of bitter-

Holding the group (and the film) together is the always wonderful Ellen Burstyn. Only the usually fine Alfre Woodward seems a bit out of place as Anna's free-spirited daughter, just returned home.

How to Make an American Quilt is a decidedly old-fashioned film, lushly filmed and beautifully scored. Central to the film are family relationships. Family values, true family values, here reign supreme. If there isn't anything especially new here, that's OK.

One of those rare and special films, How to Make an American Quilt is filled with joy and love and a host of characters that we come to care about deeply. Isn't that enough? It is for



I never realized that I could be a part of that because I had always felt that problem was too immense. I always just let my personal life and sexuality walk over me and I never was concerned with the fact that I was hurting myself.

I always believed with the most deep-rooted sincerity that "Oh well, I will be helping my family, whatever, if I keep silent" philosophy.

Being raised correctly, I always had believed in the old Christian philosophy of making a concerted effort to be selfless. However, what I did not realize was that I wasn't helping anyone.

I hadn't realized that there are others in my situation and I was creating a disservice for them beyond my grasp by making myself someone else's sacrificial lamb.

I did not understand how I could firstly help myself, and secondly, attempt to help others who are in my situation.

Also, MATC now has a group for its students which is brand new. It was started by a member of my family and, I assure you, that you will feel comfortable.


If you are older and have a Gay loved one or friend, there is PFLAG.

Mormon Leaders Begin to Open Discussion on Origin of Sexual Orientation

Salt Lake City, UT-The leaders of the Church of Jesus Christ of Latter Day Saints (LDS)(Mormons), are bringing discussion of homosexuality out of the closet, seeking to explain to distraught parents of Gays and Lesbians and to the general membership why same-sex unions are anathema to the church.

In an unprecedented airing of the issue in the October edition of the faith's Ensign magazine, a church apostle writes that gender is a premortal characteristic and that Satan is out to confuse what it means to be male or female.'

The struggles of those who are troubled by same-sex attraction are not unique. There are many kinds of temptations, sexual and otherwise. The duty to resist sin applies to all of them," Elder Dallin H. Oaks says in the eightpage article.

Until recently, LDS leaders have publicly discussed homosexuality mostly in general condemnations of immorality. But in 1994 the church began a vigorous campaign against efforts in Hawaii and elsewhere to legalize samesex marriages.

In the past month, they have thrice proclaimed their opposition in high-profile forums. And Oaks' article, while disappointing to many Mormon Lesbians, Gays and their parents, is significant for its acknowledgment of scientific research that is increasingly showing that sexual orientation has biological underpinnings.

Oaks stressed that the subject of sexual orientation is 'highly complex' and scientific knowledge about it in its infancy. Firm conclusions to "nature" versus "nurture" arguments over sexuality "must await many additional scientific studies."

Nevertheless, he wrote, Mormons should refrain from using the words Homosexual, Lesbian August 27th, 40 such parents asked, "How long and Gay as nouns because to do so would run counter to church doctrine.

It is wrong to use these words to denote a condition, because this implies that a person is consigned by birth to a circumstance in which he or she has no choice in respect to the critically important matter of sexual behavior," Oaks

He also condemned those who engage in 'Gay-bashing' and urged church members to our own experience and our own children tell us now compassion toward those infected with the otherwise," the parents wrote. show compassion toward those infected with the HIV virus or afflicted with AIDS, "who may or may not have acquired their condition from sexual relations.

On other points, the article by the former Utah Supreme Court justice elaborated on statements made in a September 23 "proclamation" by the church's governing First Presidency and Council of the Twelve Apostles: That only heterosexual relations within marriage are acceptable to God and that men and women since Adam and Eve have been commanded to "multiply and replenish the earth.'

Mormons who engage in homosexual behavior can expect to be excommunicated, Oaks said, And discipline can be given for encouraging sin by others.

While many Christian faiths condemn homosexuality, Mormons have unique reasons for doing so. It is a basic tenet of the faith that only men and women married for eternity in a Mormon temple can dwell with God, and their families, after death, and eventually attain godhood

Oaks' address appears in partial response to a growing number of Mormon Lesbians, Gays and their parents wounded by their treatment within a church that continues to insist homosexuality is treatable and even preventable.

state. "There are powerful legal reasons why a lawful marriage in one state must be recognized by all other states," said Wolfson, co-counsel in the Hawaii case.

Money and Polls

A recent article in the New York Times discussed the Hawaiian move to legalize samegender marriages and pointed to the "vast eco-nomic benefits" that "will come to the first state to recognize" same-gender marriage.

The millions of dollars, if nothing else, the article said, "will make states begin to rethink Gay marriages."

In July, a new poll was released by the Lambda Legal Defense and Education Fund showing that fully a third of the nation's voters are in favor of allowing marriages between same-gender couples.

The poll found that 33% of voters believed that two people of the same gender should be able to get married if they love each other, while 63% disagreed.

Young voters with higher incomes, and those with more education, were more likely to be in favor of equal marriage rights.

The telephone survey of 1000 voters nationwide was conducted June 21-26 by EPIC-MRA-Mitchell Research, a polling firm based in Michigan.

Those who oppose same-gender couples having the freedom to marry the one they love and support, however, are aggressively working to prohibit other states from recognizing marriages that would take place when and if Hawaii legalizes them.

"By promoting misinformation and fear regarding same-gender marriage, the Radical Right has raised significant funds to increase their influence on state governments," said Laurie McBride, Executive Director of LIFE: California's Lesbian, Gay and AIDS Lobby.

'Having successfully engineered legislation prohibiting recognition of marriages for samegender couples in Utah, they are actively targeting other states. Unless we mobilize nationally, we are at risk of losing the freedom to marry in many states before it is even won," McBride said.

Suggs, Associate Director of the Gay and Lesbian Alliance Against Defamation (GLAAD), "that religious and civil/legal marriages are two

sepaate institutions.
"We believe the state should not dictate which marriages any religion performs or recognizes, just as religions should not dictate who gets a * civil marriage license from the state.

'The Radical Right is confusing religious and civil marriage in an attempt to mislead people,' Suggs said.

Other arguments used by the Radical Right to oppose same-gender marriage are strikingly

similar to those used 30 years ago when civil rights groups fought government interference in the rights of others to marry.

'It was only 30 years ago that interracial couples were prohibited from legally marrying," McBride said. "Today, very similar arguments are being used to deny same-gender couples the freedom to marry.

NGLTF Marriage Organizing Manual

On October 2, 1995, the National Gay and Lesbian Task Force (NGLTF) announced its publication of To Have and To Hole: Organizing for Our Right to Marry. NGLTF is working in conjunction with the National Freedom to Marry Coalition.

"Marriage is coming at us like a 3,000 ton locomotive," said Robert Bray, NGLTF Field Organizer and author of the manual. "We must educate ourselves, foster a discussion in our own community, organize and drive the issue from the grassroots up.

The manual includes: the latest background information on marriage cases; how to fight Radical Right attacks and hostile legislation; questions and answers; and almost everything a person could need to organize for the freedom to

Rep. Rick Lazio, for example, represents a southern Long Island, N.Y. district that includes the Gay beach enclave of Fire Island. He led a drive to maintain money for a housing program that serves AIDS victims; his efforts earned him a Log Cabin contribution.

Political imperatives also animated the National Republican Party's decision to accept money from the Human Rights Fund. From House Speaker Newt Gingrich on down, GOP leaders have stressed their mission to elect more Republicans and the diversity of those already in office.

The move unleashed predictable fury on the right. One manifestation was a two-page broadside from Robert Knight, the Right Wing Family Research Council's cultural affairs director. He bitterly accused the GOP of elevating Gay concerns above those of traditional Republicans.

That the campaign committee stood firm reflects shifting political geography.

The rise of congressional Republicans forced Gay activists to reconsider their traditional focus on Democrats. The very existence of Gunderson, the Log Cabin Republicans and their allies is forcing the GOP to break out of its stereotype

Lesbian Book-Banning Trial Ends as Right Wing Screams 'Foul'

Kansas City, KS--A federal judge is expected to decide within a month whether a school district's ban on a novel about Lesbians violates students' free speech rights.

U.S. District Judge Thomas Van Bebber heard the final witnesses Wednesday, October 4, in the case brought by several students, their parents and a biology teacher against the Olathe School

At issue is the removal of the novel Annie on My Mind from the Olathe South High School library after it was donated in 1993 by a Gayadvocacy group. A copy had already been in the library for years.

Richard Marriott, a Right Wing Christian, one of four school board members who voted for the ban, testified Wednesday he was "offended by the nature of the book.'

Marriott testified that he found the novel to be predictable and that it "glorified the homosexual lifestyle.'

The critically acclaimed book, about two girls who fall in love with each other, was written in the late 1970s by Massachusetts writer Nancy Garden. She testified earlier in the trial, which began September 20.

School board president Bob Drummond, a psychologist, testified last month he considered homosexuality a mental disorder similar to schizophrenia or depression.

Olathe school superintendent Ron Wimmer, who made the initial decision to pull Annie, testified Wednesday that he did not object to the novel's content but was merely dealing with a touchy community issue.

Wimmer said he received hundreds of letters when the book was donated to the district and that he wanted to quell the reaction from the community and the media.

The plaintiffs contend that the board violated their First Amendment right of free speech and that due process was violated when the book was

School officials replied that they were exercising their right to choose material for students and their right not to succumb to the agenda of a special-interest group.

And therein, say the straight spouses, lies much of the problem. If being Gay were more socially acceptable, Gays wouldn't try so hard to fit into a conventional marriage.
