Germans Said to be Destroying Files Pertaining to Nazi Persecution of Gays

Milwaukee—Recently, a highly disturbing message went out over the Internet from a professor at the University of Hamburg in Germany

Professor Norbert Finzsch said that the Hamburg State Archives has decided to destroy up to 90 percent of a large collection of documents pertaining to criminal prosecutions undertaken during the Nazi period.

According to Finzsch, these documents include references to the persecution of Gays and other so-called "forgotten" minorities.

In one of his messages, Finzsch said, "The Hamburg files were one of the very few collections of data on the administration of justice under Hitler that had remained intact.

Finzsch said that the decision to destroy the documents came after a 10 year review of their contents by a special commission. He said also that a large body of the collection has already been destroyed and that there has been no record kept of what was in them.

Gay people were the first minority to be persecuted after Hitler and the Nazis came to power in 1933. Dachau, the first of the concentration camps, built outside Munich, was constructed for Gay people.

Gay men were required to wear the Pink Triangle which was 2-3 centimeters larger than any other such symbol.

Lesbians were required to wear the Black Triangle.

Gay bars in Berlin and elsewhere were burned down around the patrons' heads.

There was Gay resistance to the Nazi persecution. It is known that a cell of the Gay resistance to Hitler existed in Hamburg as it did in many other German cities of the time. The Nazis made every effort to seek out and extinguish these groups. There were members put on trail in Hamburg. How many is not known and never may be known now.

Finzsch said that the destruction of the Hamburg documents means "that a scholarly categorization in terms of degrees of punishment, gender, and class of indicted/convicted persons is impossible."

Finzsch urged Gay activists throughout the world and the U.S. to write to the Mayor of Hamburg calling on him to stop the destruction of the remaining documents

New Study Indicates that 7% of Gay and Bisexual Youth are Infected with HIV

Baltimore, MD-AIDS is spreading fast among U.S. Gay males in their teens and early 20s even though they grew up amid widespread awareness in the Gay community of ways to avoid the lethal virus, a study found.

Preliminary results presented Saturday, February 10th from the first national survey of young Gay men showed that 7 percent are infected with HIV, the virus that causes AIDS.

"HIV prevalence is very high among young men who have sex with men, compared with the general population of youths in the U.S.," said Dr. Linda Valleroy of the U.S. Centers for Disease Control and Prevention.

Her survey found that more than a third of

these young men have had anal sex without condoms in the past six months. This is the primary way HIV spreads among Gay men.

"The prevalence of unprotected anal sex is alarming, given that these young men grew up in an era of HIV awareness," she said.

The study was based on interviews and tests of young men who gather at spots where they can meet and socialize with other Gay men. In the absence of community centers in the Gay community in most places, they are forced to congregate at bars—if they can get in—and street corners. Sex can come easily and it can be dangerous.

Why these young men fail to protect themselves against AIDS is unclear. However, Dr. John M. Karon of the CDC said they may think their chances of getting the virus are low.

"They know the risks, but they assume that only older Gay men are infected," he speculated. "So if they only have sex with young men, they think they're safe."

Dr. Jeffrey Kelly, head of the CAIR Center of the Medical College of Wisconsin, said that what we're seeing is that while the incidences of HIV infection is indeed on the rise among young Gay males, particularly young Gay men of ethnic minorities, new infections for Gay men overall has remained steady over the past

"We've done a pretty good job of HIV prevention among older Gay men, especially white men," Kelly said. "However, we badly need to reach out to younger Gay men and Gay men of color."

So far, the researchers have interviewed 1,781 men aged 15 to 22 in six urban counties: Miami's Dade County, Dallas County and four California counties--Los Angeles, San Francisco, Santa Clara and Alameda.

Valleroy presented the findings at a meeting of the American Association for the Advancement of Science. They include: HIV infections were found in 5 percent of

the young men aged 15 to 19 and 9 percent in those 20 to 22.

Four percent of whites were infected. 7 per-

Four percent of whites were infected, 7 percent of Hispanics and 11 percent of Blacks. 38 percent reported unprotected anal sex

within the previous six months.

The study began after researchers in the San Francisco Bay area surveyed 425 Gay and Bisexual youths in the early 1990s and found that 9 percent were infected.

Dr. Kelly said that in San Francisco, "50%

By John Quinlan Madison—The political landscape in Wisconsin for Lesbians, Gay men and Bisexuals underwent a drastic

transformation on February 12th when State Rep. Dean Kaufert (R-Neenah) announced his intention to introduce legislation prohibiting same-sex marriage in Wisconsin.

While the bill has not yet been drafted, if introduced, Wisconsin would join 19 other states that have legislation pending to prohibit same-sex marriage in anticipation of an impending ruling by the Hawaiian Supreme Court that would legalize same-sex marriages

Thus far, Utah has passed such a law and similar bills have made it through at least one house of the legislature in two other states (See article, this issue).

If the Hawaiian court up-

holds the right of same-sex couples as it is expected to do, the 49 other states will be faced with recognizing see issued in the Aloha State

marriage licenses issued in the Aloha State. This is because of the "full faith and credit" clause of the U.S. Constitution which requires states to recognize each other's licenses.

Far Right forces have moved to forestall this by trying to get state legislatures to ban samesex marriages.

On Saturday, February 10th, at a rally in Des Moines, the Christian Coalition announced its intent of seeing such preemptive laws passed in all 50 states (see article this issue).

Here in Wisconsin, the prospect of such a divisive debate strikes many as ironic, given the state's long tradition of leadership in the area of civil rights—which includes being the first "Gay Rights" state in the nation which was passed with bipartisan support in the legislature and signed into law by Republican Governor Lee Dreyfus.

In Wisconsin, under the worst-case scenario, Kaufert's bill would be quickly passed by the Republican controlled legislature and sharply divide the people of the state.

"We must take this bill very seriously, despite its introduction relatively late in the legislative session, said State Rep. Tammy Baldwin (D-Madison).

In the hours following Kaufert's press release, Baldwin and others acted swiftly to call an emergency community meeting in Madison. Despite the short notice, over 40 activists attended

At the meeting, Baldwin and others expressed some measure of surprise that the bill's introduction had apparently originated with Kaufert, who is one of the Assembly Republicans who is generally recognized as a moderate. By way of example, Baldwin cited his support of a rehabilitative approach in the area of corrections.

In stark contrast to many of his colleagues on both sides of the aisle, Kaufert has shunned politically expedient "lock 'em up and throw away the key" rhetoric, for a more balanced approach.

Kaufert's press release was harsh. "If people in another state decide to support Gay marriages, that's their prerogative. However, those people don't have a right to tell us here in Wisconsin that we have to live by their rules."

Baldwin: Don't Get Swept Up, Let the People Decide

Kaufert's argument that his bill is an attempt to "let the people of Wisconsin decide for themselves," is off-base Baldwin maintains. "In fact, we'd be preempting Wisconsin's chance to debate this issue," she said. "We'd be letting events in Hawaii drive what happens here."

Recent Study Gives First Evidence that New Class of AIDS Drugs Prolongs Life

Washington, D.C.—For the first time, researchers have compelling evidence that a powerful new class of AIDS drugs prolongs life and reduces complications for people at advanced stages of the disease.

These drugs, called protease inhibitors, attack the AIDS virus in a different way from the medicines that have been on the market for several years.

Until now, scientists' enthusiasm for these medicines has been based on test tube signs that they work, such as a 100- to 1,000-fold reduction in levels of AIDS virus in patients' blood.

Finally, they have reason to think the drugs truly may accomplish what they are intended to do: Help AIDS patients live longer and better

Encouraging evidence on two of these drugs-Abbott Laboratories' ritonavir and Merck & Co.'s indinavir-were released to researchers at the February Conference on Retroviruses and Opportunistic Infections.

The news produced a sense of optimism that is rare at AIDS gatherings, where the results of drug experiments are so often disappointing.

Patients need to know this is promising," said Dr. William Paul, head of the federal Office of AIDS Research. "Scientifically, it is the best we have seen. It's an unfinished story but a very good beginning."

Dr. Jeffrey Kelly, head of the CAIR Center of the Medical College of Wisconsin expressed optimism about the new drug therapies.

"It is another step-a small one-on the road to making AIDS a chronic disease,"

Kelly said. He added quickly that this step is "one of the most significant steps to come along in the last couple of years."

Kelly cautioned strongly against anyone thinking that this new class of drugs should make anyone feel complacent about the disease

or their own safety.
"These new drugs," he said, "does not mean that AIDS is anywhere near a cure. If

Update on Baboon Bone Marrow Transplant

San Francisco-AP- Baboon bone marrow implanted in an AIDS patient to boost his failing

immune system has apparently failed to work, doctors said Wednesday, February 7th.

But the AIDS patient, 38-year-old Jeff Getty, is doing `surprisingly well,' perhaps due to chemotherapy, said Dr. Steven Deeks, who performed the transplant at San Francisco General Hospital on December 14th

Getty, a former University of California policy analyst who turned into an AIDS activist when he discovered he had the disease, said from his Oakland home that he had always known the chances of success were not good.

"When I came into this, I rolled the dice," he said. "I didn't even know if I was going to live through thing. Now I'm looking forward to a long summer of sailing.

Bone marrow produces the body's immune system, and the baboon cells were transplanted into Getty because the animals do not become infected with AIDS for reasons biologists still don't understand.

Previous experiments with baboon bone marrow transplants had failed because the bodies of the human patients rejected the foreign cells.

Deeks said Getty's surprising improvement may be as important as the experiment itself. There are some hints as to why Jeff is doing better, and this will open up new areas of research," he said, but refused to be more specific

Paper to Print Same-Sex Engagement Notices

Wilkes-Barre, PA-AP- The Times Leader published its first same-sex engagement announcement, for Philip Mercadante Jr. and Roderick Bliss Jr. of Blakely, on December 31st Vice President and Editor Allison Walzer says publishing the notice was an example of making The Times Leader accessible to its readers.

If it does no harm to other people, I bend over backward to make this paper available to the community," Walzer says. "I do realize that reasonable people can disagree about this issue."

The Harrisburg-based Pennsylvania Newspaper Publishers Association says each newspaper can decide to run or refuse such announcements. Feature editors at two of the state's largest papers, The Morning Call in Allentown and the Pittsburgh Post-Gazette, say they have never received a request for a same-sex announcement, so no policy about publishing them exists.

Philadelphia Newspapers Inc., which runs The Philadelphia Inquirer and the Daily News. publishes paid wedding and engagement announcements through its advertising department. The papers do accept same-sex notices, according to department policy.

Colorado Senate Approves Hate Crimes Law 02/07/96

Denver, CO-AP- Sending a message that crimes based on sexual orientation, age and physical disability are unacceptable, a Colorado Senate committee on February 7th approved a bill expanding the state's ethnic intimidation law.

The bill simply expands the state's ethnic intimidation law to apply to crimes against a person based on physical or mental disability, age or sexual orientation. Charges range from a Class 1 misdemeanor--which carries a sentence of 16-18 months in prison--to a Class 5 felony--which carries a sentence of 1-3 years in prison and a \$1,000-\$100,000 fine, depending on the crime.

Supporters of the bill cited statistics that showed hate crimes against homosexuals are on the

rise, and said a law addressing the issue would help stop the trend.

Will Perkins, chairman of Right Wing Colorado for Family Values--the group that backed anti-Gay Amendment 2, was the only witness to testify against the bill. Nearly a dozen showed

Perkins said current law already protects people from harassment and expanding the law only asks the government to be "the thought police."

Poland's New Constitution Includes Gays

Warsaw, Poland- The Parliament of Poland will soon be considering a new permanent constitution drafted by its Constitutional Committee. On April 11, 1995, the Committee proposed the human rights clause of the draft, outlining groups who should not be discriminated against. The proposed clause (Paragraph 2-Article 2) includes the words "sexual orientation." The words have raised the expected furor from the Catholic Church. Former President Lech Walesa

Lambda, a national Gay and Lesbian rights organization in Poland, has been lobbying the government for over two years to get sexual orientation into the new constitution and keep it there. Lambda's documentation of cases of discrimination against Gay people was instrumental

in getting the phrase included.

Poland's new President, Aleksander Kwasnieski, seems more accepting and ready to bring Poland into line with the Council of Europe and the Parliament of the European Community, both of which have urged member states to entirely equate Gays with straights in all fields of


Anti-Gay Rhetoric Escalates in Zimbabwe

Harare, Zimbabwe- Official harassment of Gay men and Lesbians in Zimbabwe has widened to include virulent attacks on the floor of Parliament, according to the International Gay and Lesbian Human Rights Commission. A series of debates in the last few months on "the evil and iniquitous practice of homosexualism and lesbianism" have provided a forum for anti-Gay speeches by a number of legislators from the ruling ZANU PF Party, which follows the lead of State President Robert Mugabe.

Being Gay or Lesbian in Zimbabwe is currently illegal and punishable by a fine. Members of Parliament are calling for the punishment to be increased to caning and flogging and death for both women and men

St. Camillus AIDS Center Bombed

Bangkok, Thailand- According to the International Gay and Lesbian Human Rights Commission, the St. Camillus Foundation Relief Center, an 18-bed facility in Thailand's Nonthaburi Province was bombed. The Center, founded in 1993, provides counseling and temporary shelter to people living with HIV in a country which has one of the highest incidences of HIV infection in Asia. The Center has been forced to relocate following the bombing and continues to provide badly needed services. The police did no investigation and have offered no protection and, in fact, encouraged the Center to move.



Bipartisan Effort in Congress Seeks to Repeal Dornan Measure in Defense Bill

Washington, D.C.- Despite the urging of the AIDS Action Council, the Human Rights Campaign, , the National Association of People with AIDS and numerous other groups, Clinton signed a defense funding bill into law on February 10th a provision of which would expel all service personnel from the military who have tested positive for HIV

The measure was championed by Rep. Bob Dornan (R-CA), a notorious homophobe.

Clinton said that he opposes that provision but supports the overall bill.

At the time of signature, the White House stated that they believe the provision to be unconstitutional and that the Department of Justice will not seek to defend it in court.

The President also issued an Executive Order designed to prevent the HIV exclusion measure from taking full effect.

A White House aide said the executive order is designed as a stopgap, in case the legislative repeal effort fails. The order would establish full medical benefits for the discharged service members and their family, partial or full disability pay, education benefits, and job train-

Bipartisan Effort
On Capitol Hill, meanwhile, Republicans and Democrats are beginning a bipartisan repeal effort aimed at striking out the HIV discharge requirement.

They have six months to act before the military discharges more than 1,000 uniformed enlistees and officers who carry HIV.

Even before the Presidential ink was dry on the bill, Rep. Peter Torkildsen, (R-Mass.), had filed legislation to repeal the HIV expulsion provision in the Defense Authorization

Among Wisconsin's House delegation, Congressmen Scott Klug (R-WI) and Gerald Kleczka (D-WI) are among the co-sponsors, according to the Human Rights Campaign.

Congressman Tom Barrett (D-WI) is in Europe and could not be reached, according to his office

In the Senate, the repeal measure is sponsored by Sens. Edward Kennedy (D-MA) and William Cohen (R-ME) and co-sponsored by Sens. Russ Feingold and Herb Kohl (D-WI), among others, including Sen. Sam Nunn (D-GA), who was one of the leading opponents of lifting the ban on Gays in the military

Nunn recently recounted a letter from a sergeant with 16 years of service who contracted HIV from a blood transfusion and whose wife and two children would lose dependent health benefits with his discharge.

"The service is my life," the sergeant wrote. "I've given everything I have to it. When this bill passes, I'll be out of the service and out of a job. How am I supposed to support my fam-

"We need to put a human face on these statistics," Nunn said.

The bill currently has 74 co-sponsors in the House and 35 in the Senate.

"If Magic Johnson can play professional basketball after five years with HIV, then a dedicated American should be able to serve his or her country in a noncombat role," Torkildsen said.

Torkildsen was alluding to a letter sent to House Speaker Newt Gingrich and to Senate Majority leader Robert Dole by Earvin "Magic" Johnson.

"I am writing to you on behalf of a group of people that I have never met, but for whom I have the greatest respect and empathy: the 1,049 members of the U.S. military who, like me, just want to do their jobs and provide for their families," the basketball superstar wrote.

Current rules forbid those with the virus from being deployed overseas or sent into combat, and Dornan argued that places an undue burden on others in uniform.

Dornan said that Gay advocates are leading opposition to his provision, and as many as half the service members with HIV are former drug addicts who got the infection from dirty needles,

"Nobody gets the special treatment that these people get," even as the military is discharging healthy service members to reduce its ranks, Dornan said.

Opponents argued that thousands of service members with other serious ailments also are not allowed to be sent to foreign duty but are not covered by the Dornan amendment



No, she never used those words. She used other words that meant the same thing, but were more easily understood by her young

Then there is what Beth has done for us. Several years ago, Beth arranged for us to use the War Memorial Center for a memorial service commemorating Gay and Lesbian war dead.

Ignoring any potential political consequences, Beth came to the service herself and she brought her husband and children with her. They all stood proudly in front of the TV cameras.

She worked hard to pass a County Board resolution proclaiming Pride Week. She would even get the homophobes to leave to increase our chances, but we always lost. friendly supervisor, Roger Quindel, didn't show up and we lost by one vote.

When we spoke about Quindel's absence, Beth wasn't angry or bitter over Quindel's screw up. "Everybody makes mistakes," she said, "The important thing is that the heart is in the right place.

The last two years, when it was obvious we didn't have the votes, Beth got supportive supervisors to sign a fancy proclaimation. She got it framed and read it from the PrideFest stage. It wasn't a small gesture.

As a Black female Supervisor, Beth Coggs-Jones knows how frustrating it is to feel alone. She doesn't want us to feel that frustration.

Right now, Beth Coggs-Jones must feel terribly alone and that is really tragic. If more of our elected officials had her honesty, her dedication and her heart we would all be much better off. As she said "Everybody makes mistakes.

The important thing is that the heart is in the right place.

It's too bad some people can't or won't judge her the same way she has judged them.



Pressure Mounting on Rep. Gunderson to **Back Away From his Pledge to Retire**

Milwaukee—There is growing speculation that Rep. Steve Gunderson (R-WI), Congressman from the 3rd Wisconsin Congressional District, might run for re-election after all, according to the Milwaukee Journal Sen-

In February, 1994, at the beginning of his last campaign, Gunderson announced that this would be his last term in office. If he stays with his pledge and retires, he will become one of 34 congressional incumbents who are not running again, and one of two openly Gay members of Congress to leave. The other is Congressman Gerry Studds (D-MA). This would leave Barney Frank (D-MA) as the only openly Gay member of Congress.

In the Thursday, February 8th issue of the Eau Claire Leader-Telegram, Gunderson, who has served since 1980, is quoted as saying about running again, "You never say never. Draft movements are seldom serious, substantial or successful . . . If something developed that I had to respond to, I'd respond to it.'

Many observers believe Gunderson has every reason to run again. His Party is in the majority in Congress; his being openly Gay has not affected his popularity in his district;

he is in line to become the chair of the powerful House Agricultural Committee; and he has worked hard to forge new dairy policy and should want to see it to completion.

Doug Knight, chair of the 3rd District's GOP, is quoted as saying that he has received "many calls" from people who want Gunder-

Knight said he is not leading a draft Gunderson movement, but he is not discouraging one

Gunderson's office maintains that nothing has changed. The Congressman will not run

David Clarenbach

David Clarenbach, executive director of the Gay and Lesbian Victory Fund, admits that "Losing two out of three openly Gay" members of Congress is not good; that the Lesbian and Gay community "have some ground to

Clarenbach sees that ground being made up in the 1996 Congressional races.

'We have our best shot ever," he said, "at electing our first non-incumbent Gay and Lesbian members of Congress.'

Clarenbach was referring to the five openly Lesbian or Gay candidates-four Democrats and one Republican-who are running. Two in particular, both Democrats, Rick Zbur of Long Beach, California, and Dale McCormick

In his late March primary, Zbur's chief opponents are Peter Mathews and Republican incumbent Steve Horn, who is supported by the national Log Cabin Republicans.

Rich Tafel, Log Cabin's director, cites Horn's support of Ryan White, among other things, as reason for Log Cabin's support.

Zbur is supported by the Victory Fund. "This is a classic example of the difference between electing one of our own and relying on well-intentioned friends," Clarenbach said. McCormick, who has a June primary, has

also received support from the Victory Fund. McCormick cut her political teeth on last year's battle against the anti-Gay referendum. Clarenbach said that he is "very optimistic"

about her chances to the first openly Lesbian member of Congress in history.

On-Line Chat Room Murder Triggers Internet Debate on Privacy

Milwaukee--News accounts of the killing of an America Online (AOL) subscriber, allegedly by another he met in a Gay chat room, have been posted in various places within AOL and on the Internet since the January 4th slay-

AOL complied with a search warrant demanding the e-mail files of those involved, sparking on-line debate about privacy in electronic communication.

Some of the debate has devolved into Gaybashing and that has drawn nasty retorts.

But many postings are serious, thoughtprovoking comments on computer privacy. Many are listed under the Internet Newsgroup heading, "Real Life Murder via AOL!"

Several messages include stern warnings to avoid writing anything incriminating or embarrassing.

Some samples follow.

From `GrevCloak7'':

'Don't say anything on the Internet that you wouldn't tell to your worst enemy.

'Stop whining about privacy, there is none. .. The last bastion of privacy is to keep your

Lesbian Drags Tennessee Kicking and Screaming into the 20th Century

Nashville, TN-The Tennessee Court of Appeals said Friday, January 26th, a state law making sex between persons of the same sex a crime violates the right to privacy

The three-judge panel of the court unani-mously ruled the law is unconstitutional but said it cannot stop pending or threatened criminal prosecutions for violations of state criminal laws. The panel denied a request for an injunction against enforcement of the law.

The state had appealed a ruling by Davidson County Circuit Judge Walter E. Kurtz in a lawsuit filed by Penny Campbell and others who said they had violated the law in the past and feared prosecution.

The attorney for the plaintiffs said the ruling leaves the issue muddy.

Technically it means that people can still be arrested and prosecuted, but people who are arrested will have a darn good defense because this opinion says the law is unconstitutional," said Abby Rubenfeld, attorney for Campbell

and the other plaintiffs.

She said she hopes the state attorney general

will appeal to the state Supreme Court so the issue can be clarified. A spokeswoman for Attorney General Charles Burson said he had just gotten the opinion and had not made a decision yet.

In practice, Rubenfeld said her guess is that police and prosecutors won't make arrests under the law. She said most of the people charged under the law are actually arrested for sort of quasi-public sexual activity.

Most of the people charged under this law could be arrested for disorderly conduct or something else," she said.

She said she wasn't aware of anyone who had been arrested in their home and charged under

The appeals court upheld Kurtz's ruling that private sexual activity between consenting adults of the same sex was protected by the state constitutional right to privacy and that the state had failed to show a compelling reason to prohibit such behavior.

We conclude that our citizens' fundamental right to privacy ("the right to be let alone") encompasses the right of the plaintiffs to engage in consensual, private, non-commercial, sexual conduct, because that activity 'involv(es) intimate questions of personal and family concern," Presiding Judge W. Frank Crawford wrote for the majority

The right to privacy should not be diminished or given less constitutional protection when the adults engaging in a private activity are of the

same gender, the panel said.

This court has previously observed: 'This Court does not sit as moral arbiters making judgments on what is acceptable social behav-' Crawford wrote.

In a partial dissent, Judge Ben E. Cantrell argued that since the plaintiffs who originally challenged the law had never been prosecuted, the court should have upheld the state's motion to dismiss the lawsuit.

However, he agreed with the majority on the

issue of privacy.

Friend of the court briefs were filed by the American Civil Liberties Union, The American Psychological Association, The National Association of Social Workers and LAMBDA Legal Defense Fund, among others.



Speaking From the Right

Why do We Need the Log Cabin Republicans?

Log Cabin Condemns Right Wing Involvement in Iowa Caucuses

Des Moines, IA-More than 1,000 Right Wing religionists gathered in Des Moines to launch what has been described as the first of a nation-wide series of assaults against Gay people Saturday, February 10th.

The rally, which one observer characterized as a "feeding frenzy of hate" demanded that GOP presidential candidates oppose same-sex marriages.

"Tonight we begin to raise our voices and we raise them with the might of our numbers," said Bill Horn, an anti-Gay, Right Wing extremist.

According to the Human Rights Campaign (HRC) and other sources, Horn is in the pay of the Christian Coalition which, in turn is part of Pat Robertson's religious empire.

Log Cabin Republicans, the nation's largest Gay Republican organization, heartily condemned the rally.

"The extreme Right has cleverly picked a non-issue to rally around," said Richard Tafel, executive director of Log Cabin Republicans. "The real goal here is to bash Gays and Lesbians like they did in 1992 in Houston, which damaged the Republican Party. Any candidate who wants to win in November will be making a disastrous mistake" in supporting Right Wing aims.

The Right Wing religionists are an important force in Republican politics in Iowa, and they demonstrated that clout with support from some of the major GOP presidential contenders.

Commentator Pat Buchanan, who has made strong showings in key early tests, warned the crowd against ``the false god of Gay rights'' and said conservatives in Des Moines already have made their point by ousting an openly Gay member of the city's school board.

Buchanan was referring to the electoral defeat of an openly Gay member of the school board. As reported in **Light**, the defeat was organized by Horn and backed by Christian Coalition money, according to AP reports.

Drawing rousing cheers, Buchanan saluted "the cultural warriors of Fort Des Moines."

Candidate Alan Keyes denounced contenders who focus on economic issues, saying the Republican Party can build on its gains only by paying more attention to social and family issues.

Senate Majority leader Bob Dole, considered the front-runner for Monday's precinct caucuses did not attend but sent organizers a letter of support saying that cutting the out-of-wedlock birth rate must be a priority.

"To achieve this goal, government at all levels must work to support and promote the institution of marriage that unites husband and wife," Dole said in his letter.

The event, supported by Colorado for Family Values (CFV), was billed as the opening round of an effort to block legalization of same-sex marriages. Organizers of the Religious Right have said that an effort will be made in all 50 states to push laws banning same-sex marriages.

In a press release, Log Cabin reported that CFV has unveiled a new video entitled "The Ultimate Target of the Gay Agenda."

In addition to Buchanan, Phil Gramm and Alan Keyes addressed the anti-Gay rally. All three publicly signed a "Marriage Protection Resolution" which pledges them to work against same-sex marriage.

According to HRC, Lamar Alexander, Bob Dornan and Steve Forbes also signed the

"You would have thought that candidates like Bob Dole would have learned by now that pandering to the most extreme Right groups and bashing Gays will only come back to hurt you," Tafel said. "Steve Forbes knows that bashing Gays is totally contrary to a message of hope, growth and opportunity and he's missing an opportunity. The only way for any candidate to benefit is to be the one candidate that refuses to pander to this vicious, anti-Gay group."

About 250 protesters lined the streets outside the fundamentalist church where the rally was held, accusing participants of Gay-bashing.

'White Squall' is a Film full of Male Pulchritude, But Old Hat Nonetheless

When Glenn is sent on assignment by Wisconsin Light to review yet another of today's most fabulous motion pictures, Glenn usually seeks to avoid any exposure to pre-release studio hype. In the case of White Squall, many of Glenn's friends thought it quite amusing that Glenn was unaware that this is a picture with a virtual all-male cast who spent the majority of the film in shorts and sneakers and very little else.

Not watching much television also meant that Glenn thought that little Scott Wolf was merely a Tom Cruise knock-off and not the wet-dream star of one of television's hottest teenage angst drama's, "Party of Five"

tually seems to want to be aboard.

No three-hour tour, the Ocean Academy is a year long sea-faring adventure with plenty of stops along the way to get drunk and pick up prostitutes.

Glenn imagines that the prostitutes were a necessity since there was absolutely no privacy for any of the boys to ... well, you know

Enigmatic skipper Christopher Sheldon (Jeff Bridges) runs a tight ship, where discipline is all. If this means publicly humiliating a teen with acrophobia into mast-climbing (with rather wet consequences), so be it.

So too when angry, self-destructive Frank Beaumont (Jeremy Sisto) recklessly shoots a dolphin, Sheldon immediately boots the boy

No, White Squall is not the sort of film in which Jeff Stryker might make an unannounced cameo appearance, but rather an ocean-bound rites of passage opus. True, there is certainly more than enough beefcake (calfcake?!) in White Squall to please even the most jaded Gav male viewer.

Despite some extraordinarily striking homoerotic glances between crew and Captain, at least in Glenn's opinion, homosexuality gets nary a mention.

First, Glenn does want to state right from the start that White Squall is a highly entertaining and often a most exciting film. That acclaimed Alien-director Ridley Scott has based White Squall on a true story has made many of the film's scenes even more riveting for Glenn.

Still, it would take a reviewer with far more integrity and perhaps a bit more discretion than Glenn not to suggest that White Squall could quite appropriately be sub-titled, "Dead Boater's Society". With hunky Jeff (Oh Captain, my Captain!) Bridges in the Robin Williams' part, White Squall shares many

similar plot devices with Dead Poet's Society. White Squall begins with Chuck Gieg (Scott Wolf), along with twelve other high school youths joining the crew of the "Albatross", a floating prep school. The Ocean Academy is a highly selective educational institution for unruly youth of the rich and dysfunctional. Actually, of all of the boys only young Gieg ac-

With Chuck Gieg as the glue, this disparate group of boys soon quite predictably melds into a winning team. In a joyous scene reminiscent of Golding's classic Lord of the Flies, the boys land on a deserted island and race up to the summit of a volcano crater. (Glenn has to wonder who conveniently thought to remember to bring face paint.)


Then when homeward bound, a freak of nature, an exceedingly rare weather condition known as a "white squall" strikes the The crew must face the most difficult challenge of their young lives.

As in any Ridley Scott film, White Squall is always visually compelling. The landscape and seascapes are magical, the underwater shots striking and the boys, happily, uniformly

Without any doubt White Squall is Chuck Gieg's own, intensely personal story. Using Gieg's own journals, Todd Robinson and director Scott have quite apparently most faithfully brought Gieg's adventure to the screen. Yet Glenn must ask: Is there really anything

Pamela Brown, arguably one of the finest actresses on the Milwaukee stage, is making her directorial debut at the Boulevard Theatre with Edward Albee's Pulitzer Prize-winning play Seascape. Recently, she took time out from a rehearsal to sit down and chat about the

She is a native Wisconsinite, she says, born and raised in Racine. She left there to go to school in Boston. She had always wanted to do theatre work, to act, and it was in Bean Town that she got her chance, taking some classes

and doing some shows. But, she says, it was only when she came back to Wisconsin, to Milwaukee, in 1986, that she really "trod the boards.

"I did a little community theatre," she says, 'and then I met Mark.'

She is referring to Mark Bucher, who founded and heads up the Boulevard Theatre.

She is attracted to Albee, she says, because of her love of his play Virginia Wolff—"which I would love to be in someday," she hastens to add. What she finds in him is a fascination for his interest in couples, plus his dedication to life and those who choose to live it to the max, instead of just existing.

"I'm really enticed by Albee's complexity," she says, adding that he is Gay, which, perhaps, explains part of his focus on the twistings and turnings of life.

For those not familiar with it, Seascape involves the interaction between two couple; one human-male-female-and one, a lizard couple. In the end, they come to terms with each

In the process, she notes, Albee explores the intricacies of relationships: how you can love

someone and want to kill them sometimes too. It is this kind of thing that is play after play that Albee has written.

Does she see any comparison to "real life", to the meeting of a Gay couple and a straight one-given that Albee is Gay?

'Yes! The thing," she answers with enthusiasm, "is that there are so many meanings, so many levels of meaning in the play, which is what makes the work the fascinating thing that

"Its about being different, it's about evolution, about having different tastes, about having different lifestyles-and learning that each has something to give to the other.

"It's also about the fact that you can't really maintain the status quo forever. Things change, they're in flux. You have to learn to live with that.


In Seascape, both the human couple and the lizard couple change and adjust to each other, but neither gives up being who and what they

In that way, she says, Seascape is a very positive play, full of hope. The adjustments are made and life goes on.

Pam Brown is a brilliant actress, who brings to the stage a rare presence. There is no doubt that she will be equally successful as a director. This is a must-see play.

"Richard III' is a Film of Fabulous Settings and Superb Acting, Truly a Film to See

1995 shaped up as the year Hollywood rediscovered Jane Austen. With Othello and Ian McKellen's Richard III already vying for the anglophile audience across America, perhaps 1996 will prove to be the Bard's.

Although Glenn did not actually meet deadline with an Othello review, Glenn found Kenneth Branagh & Co. mesmerizing in this robust and passionate period love story, complete with Shakespeare's delightfully tragic ending.

Richard III is another Shakespeare, historical, bloody to be sure but containing a dizzying array of characters and enough political intrigue to make Richard Nixon and Watergate look like an inept episode of Romper Room.

McKellen and director Richard Loncraine have the unenviable task of bringing to the screen Shakespeare's greatest villain, the man who would be King.

With typical stage production often over three and a half hours, **Richard III** is a sort of one-night mini-series. So many characters, so many sub-plots.

To make Richard III assessable for those who have never discovered the PBS station in town, McKellen has brought the action into the 1930's. A long and bloody civil war has divided the nation, ending with the death of reigning King Henry as well as son and heir, Prince Edward. A new royal family emerges as Edward, Richard's eldest brother claims the crown. The gala coronation of King Edward (John Wood) and his American-bride Elizabeth (Annette Bening) opens the film.

Big band music, the haze of cigarette smoke and neo-Nazi imagery dominate McKellen's tale of the deformed younger brother who is all false flattery, deceptive loyalty and murderous treachery. With grotesquely honest asides to the audience every rung of the ladder, Richard climbs his way to the top, killing his enemies and claiming their lives and their wives.

McKellen here reprises his much-acclaimed portrayal of Richard and is nothing short of sensational. His Richard is no parody of villainy but evil incarnate. An early scene in the morgue immediately sets the tone for the film.

Richard woos and wins the heart of Lady Anne (Kristin Scott Thomas), the widow of the man Richard killed to place Edward on the throne. The scene is so frightening precisely because those in the audience are as likely to be susceptible to Richard's charms as lady Anne, even if we, like Lady Anne really ought to know better.

McKellen's star-turn is not diminished by the stellar cast that surrounds him. Nigel Hawthorne is eloquent and doomed as Richard's sweetly duped, tragically manipulated brother Clarence. As the oh-so bitter mother of a monster, two-time Academy Award winner Maggie Smith chews up and spits out her curses to Richard with a delightful, venomous glee. Poor John Wood has little to do as King Edward except to look like Thomas Mann's pathetic hero Aschenbach at the end of Death in Venice.

Hunky Dominic West adds a much needed decorative element as Richard's adversary Richmond.

Superb acting, fabulous settings and a truly spectacular ending makes Richard III a Shakespeare work likely to charm even the mallrats.

So what's wrong? Maybe nothing really. Perhaps only an odd feeling Glenn had upon leaving the cinema of having just witnessed the Cliff's Notes version of the play.

'Les Ballets Trockadero De Monte Carlo' Returns to Milwaukee March 28 All-Male Ensemble to Perform at Pabst Theatre

Founded in 1974 by a group of Ballet enthusiasts for the purpose of presenting a playful, entertaining view of traditional, classical ballet in parody form and en travesti LES BALLETS TROCKADERO DE MONTE CARLO first performed in the late-late shows in Off-Off Broadway lofts. The TROCKS, as they are affectionately known, quickly garnered a major critical essay by Arlene Croce in The New Yorker and combined with reviews in The New York Times and The Village Voice established the Company as an artistic and popular success. By mid-1975, the TROCKS' inspired blend of their loving knowledge of dance, their comic approach, and the astounding fact that men can, indeed, dance en pointe without falling flat on their faces, was being noted beyond New York. Articles and notices in publications such as Variety, Oui, The London Daily Telegraph, as well as a Richard Avedon photo essay in Vogue, made the Company nationally and internationally known.

The 1975-76 season was a year of growth and full professionalization. The Company found management, qualified for the National Endowment for the Arts Touring Program, and hired a full-time teacher and ballet mistress to oversee daily classes and rehearsals; also, in this season, they made their first extended tours of the United States and Canada--packing, unpacking, and repacking tutus and drops, and stocking giant sized toe shoes by the case. Running for planes and chartered buses all became routine parts of life.

Since those beginnings, the TROCKS have established themselves as a major dance phenomenon throughout the world. They have participated in dance festivals in New York, Spoleto (Italy), Holland, Vienna, and Paris. There have been television appearances as varied as a Shirley MacLaine special, the "Dick Cavett Show," "What's My Line?," "Real People," "On-Stage America," and with Kermit and Miss Piggy on their show "Muppet Babies." A television special was filmed at the famous Olympia Theatre in Paris and has been shown throughout Europe and North America. Other foreign appearances have included their own solo specials on national networks in Japan and Germany, as well as a French television special with Julia Migenes. The TROCKs' active touring schedule has included four tours of South America and Mexico, including six weeks at the Metropolitan Theater in Buenos Aires, a tour of Australia, eleven tours of Europe, including Russia in 1994, ten across Canada, and eleven of Japan, with a stop in Hong Kong in 1992. These tours have been popular and critical successes. In the United States, the Company has become a regular part of the college and university circuit as well as being part of the dance presentations in cities throughout 48 of the 50 states and the District of Columbia. These appearances have included the Palace and City Center in New York City, and engagements with the symphony orchestras of Atlanta, Baltimore, Buffalo, Denver, Kansas City, Rochester and Utah.

The 1995-96 season promises to be an exciting 21st anniversary. After a week long run at the *Danny Kaye Playhouse* in New York City, performances are scheduled in the USA (San Francisco, Los Angeles, Escondido (CA), Boise (ID), Milwaukee (WI), Stony Brook, Purchase (NY), West Long Branch (NJ), and Reading (PA), and Canada (Montreal, Ottawa). The Company will be returning to London for a week long engagement at *Saddler's Wells Theater*, will tour Taiwan, and for the twelfth time will travel to Japan for what has become their annual extended summer tour of that country. The Company continues to appear in benefits across the country for local Aids organizations and has given, or participated in, special benefit performances for Rochester City Ballet, and Connecticut Ballet Theater, *DRA (Dancer's Responding to Aids; part of Broadway Cares/Equity Fights Aids*) as well as the Gay & Lesbian Community Center in New York City. Plans for continued tours across the United States and Canada, an extensive European tour, and summertime in Japan are in the works for the 1996/97 season.

The original concept of LES BALLETS TROCKADERO DE MONTE CARLO has not changed since its inception. It is a Company of professional male dancers performing the full range of the ballet and modern dance repertoire, including classical and original works in faithful renditions of the manners and conceits of those dance styles. The comedy is achieved by incorporating and exaggerating the foibles, accidents, and underlying incongruities of serious dance. The fact that men dance all the parts--heavy bodies delicately balancing on toes as swans, sylphs, water sprites, romantic princesses, angst-ridden Victorian ladies--enhances rather than mocks the spirit of dance as an art form, delighting and amusing the most knowledgeable, as well as novices, in the audiences. For the future, there are plans for new works in the repertoire; new cities, states, and countries to perform in; and for the continuation of the Trocks' original purpose: to bring the pleasure of dance to the widest possible audience. They will, as they have done for twenty years, "Keep on Trockin'."

Greg Louganis, Olympic Champion to Sign Books at AfterWords in March

Milwaukee--On Monday, March 25th at 7:00 p.m., Olympic champion and AIDS-activist Greg Louganis will be making his only Milwaukee appearance at AfterWords Bookstore & Espresso Bar.

Louganis's Milwaukee appearance at After-Words is one stop on a nationwide 10-city book tour promoting the paperback release of his New York Times best-selling autobiography, **Breaking the Surface** (Plume \$12.95).

When Breaking the Surface was released in hardcover a year ago March, it became an instant success and somewhat of a publishing phenomenon. No one was prepared for the tremendous outpouring of love and support which greeted it.

Louganis's revelation that he has AIDS stunned an America which had adored him as a shining light of the U.S. Olympic diving team, the consummate athlete who overcame tremendous adversity to win a 1988 Olympic gold medal.

His powerful, unflinchingly honest memoir, Breaking the Surface (which Louganis wrote with Eric Marcus) is now available in a trade paperback edition enhanced by a new epilogue by Louganis detailing his experiences following the publication of the book.

Breaking the Surface is the moving story of a man whose athletic success also involved the challenge of breaking free of a lifetime of silence and isolation.

Same-Sex Marriage Expected to Generate \$4 Billion in Revenue for Hawaii

Milwaukee-With all the other issues of the day to talk about, presidential hopefuls Pat Buchanan and Sen. Phil Gramm take time from their schedules stampeding through Iowa to publicly sign a pledge against same-sex marriage. In a speech, Buchanan says that what someone does in their bedroom doesn't entitle them to "special rights," among which he includes same-sex marriage.

At the same time, in Hawaii, where samesex marriage is expected to become legal, the Religious Right is described in XY Magazine (a new publication for Lesbian and Gay youth) to be in a frenzy trying to stop it. They probably won't succeed. Even Robert Knight, cultural director of the ultra-Right Family Research Council, thinks same-sex marriage is

"I think the Hawaii Supreme Court will probably trash the definition of marriage and say homosexuals can marry, thus creating a constitutional crisis.'

Knight was referring to the "full faith and credit" clause of the U.S. constitution which says states have to recognize each others li-

University of Hawaii constitutional law professor Jon Van Dyke told the Senate committee that the chances of the state prevailing in the case as it stands are almost nil.

Outside the Religious Right, many in Hawaii see the coming of same-sex marriage as a financial windfall.

According to Professor Jennifer Gerada Brown of the Quinnipiac College of Law in Hawaii, same-sex marriage is expected to generate up to \$4 billion in state revenues from couples getting married and honeymooning in the Aloha State. That would mean an end to Hawaii's budget deficit and lower taxes, two things not to be despised.

The \$4 billion gain includes an offset loss from Right Wing Christian tourists who would no longer want to visit.

Financial rewards aside, there are those in Hawaii who are still trying to avoid biting the bullet.

The Senate is going ahead with legislation to create domestic partnerships for both Gay and heterosexual couples who live together, Senate Judiciary Committee Chairman Rey Graulty

It's the only realistic way to avoid same-sex marriages from being imposed on Hawaii by the courts, he said. I'm convinced that if we do nothing, same-sex marriages will be the law in our state.'

A comprehensive domestic partnership bill now being drafted will be heard by the Judiciary Committee on Feb. 22, Graulty said.

A domestic partnership system will give gay and unmarried couples living together equal treatment in the financial and legal benefits that are afforded to married couples, he said.

Graulty's House counterpart, Judiciary Committee Chairman Terrance Tom, has bottled up all same-sex marriage and domestic partnership legislation.

House Speaker Joseph Souki said on February 5th that the House is willing to await the results of the court case on the same-sex is-

The House might reconsider that position when it understands the poor chances the state has in prevailing in the same-sex marriage court case that goes to trial in July, Graulty

However, he said a comprehensive domestic partnership law would have a 95 percent chance of being sufficient to show the court that the state was providing equal treatment to

Graulty said one feature of the Senate's domestic partnership bill will be a one-year residency requirement.

For the bill to be acceptable to Hawaii's conservative religious community, it would have to have a residential requirement to keep Hawaii from being flooded by out-of-state residents seeking domestic partnerships, he

Even domestic partnership is too much for the Roman Church.

The executive director of the Hawaii Catholic Conference, the Rev. Marc Alexander considers the bill just another way of allowing same-sex marriage, which the church also op-

In Other States

While other states such as Utah, are rushing to pass laws forbidding the recognition of same sex marriages done in other states, Washington State is taking a different tack if one man has his way.

The state would legally recognize same-sex marriages under a proposed ballot initiative filed in response to a bill in the Legislature that would ban such unions.

Zakmichael Tazmon of Seattle outlined his proposed initiative in documents filed with the state February 5th. He must gather the signatures of 181,667 registered voters by July 5 to get his proposal on the November ballot.

The initiative reads: "A marriage shall be recognized as a legal marriage when the parties are persons of a different or of the same gender. Any marriage that is valid in another jurisdiction shall be recognized as a valid

Rep. Bill Thompson, (R-Everett), filed the bill out of concern that Hawaii courts may legalize such marriages as early as this summer.

If that happens, Thompson said last week, Gay couples in Washington could get married in Hawaii and return home expecting the same privileges afforded heterosexual married couples, such as health benefits and inheritance

The Republican-led House is expected to pass the bill, following its approval last week by the Law and Justice Committee. Senate approval is unlikely and Gov. Mike Lowry has promised to veto such a bill if it reaches his

"It's like a freight train coming at us from Hawaii," said Bob Larimer Jr. of Vancouver, director of the ultra conservative Washington for Traditional Values

Rhode Island

A bill to limit the state's recognition of outof-state marriages is not aimed at Gay couples, but at those who would dictate Rhode Island's social policy, according to its spon-

"What it really is, is a states rights bill," said Rep. Robert Flaherty, (D-Warwick). 'This state and every state should have a right to set its own social policy.

Polygamy used to be legal in Utah, Flaherty said, and some states still have differing rules about relatives marrying one another.

'We shouldn't be jockeyed into accepting someone else's social philosophy until we have a debate," he said.

The bill would allow Rhode Island to recognize a marriage from another state only if the marriage "comports with and meets all conditions and requirements" of state law.

Marriages between partners of the same sex are not legal in Rhode Island.

Sen. Will Fitzpatrick, who is Gay, was prepared to testify against the measure, which he said would prevent official recognition of Rhode Island gay couples who go to Hawaii to get married.

Considering that the state of Hawaii is expected to legalize same-sex unions in the next year, this is quite clearly an anti-gay bill,' said Fitzpatrick, (D-Cranston).

In Iowa

Conservatives in the Iowa House want to keep the state from having to recognize samesex marriages, but Democrats who control the state Senate say they probably wouldn't approve any such proposal.

"I think just from a consensus feeling around here, that wouldn't be a top priority. And also, we wouldn't have the votes to do Senate Majority Leader Wally Horn, (D-Cedar Rapids), said Thursday, February 8th

Two Republicans, Reps. Steve Grubbs and Charles Hurley, are pushing a bill that would deny recognition in Iowa of same-sex marriages that take place in other states.

House leaders say a same-sex marriage proposal is not one of their priorities, but that doesn't mean it won't be debated.

Horn said the legislation would have little chance in the Senate.

"I have to assume that that's something we would not do at this time," he said.

In California

California's Republican-controlled Assembly voted 41-31 on Wednesday, February 7th to block the state from recognizing same-sex marriages. The bill goes next to the Senate. The debate left the Legislature's only openly Gay member teary-eyed.

"Whenever a society wants to demonize a particular group it prohibits them from marrying," said Assemblywoman Sheila Kuehl, referring to laws that once barred slaves and interracial couples from marrying. Kuehl is a Lesbian and former actress who played Zelda on TV's "Dobie Gillis."

And on Thursday, a committee in Idaho's legislature introduced a bill that would make same-sex marriages performed in another state invalid in Idaho.

Lawmakers said they introduced the bills when it became apparent that Hawaii's courts or Legislature might make same-sex marriages legal, and thereby grant gay couples the social, legal and financial benefits afforded married heterosexuals.

In Colorado

A bill introduced in the Colorado House that would ban same-sex marriages was condemned by the American Civil Liberties Un-



ion, which said it could be found unconstitu-

The measure was proposed by Rep. Marilyn Musgrave, (R-Fort Collins), and 15 Republican co-sponsors. It is similar to legislation introduced in at least 14 other states.

"I do not feel that Colorado should be forced to recognize same-sex marriages," Musgrave said. "I feel that we're being proactive if we address this issue now instead of later on after some state, perhaps Hawaii, would recognize (same-sex marriages).

Jim Joy, state ACLU director, and Sue Anderson, director of Equality Colorado, condemned the measure Thursday

This bill would leave people legally married in another state in limbo and would lead to endless litigation," Joy warned. "Thirtyfive years ago, interracial couples were fighting for their right to marry. Couples would get married in one state and then be arrested when they passed into another.'

Joy said the U.S. Supreme Court struck down such prohibitions among the states in

Musgrave, said "'tremendous implications" attend recognition of such marriages.

'There's a huge economic impact when you're talking about inheritance, insurance and all sorts of issues," she said.

you're not infected, you must continue to do everything possible to stay that way.

In a presentation Thursday, February 1st, Dr. John Leonard of Abbot showed that ritonavir cuts the death rate in half--at least temporarily--when given in late stages of AIDS.

Ritonavir or dummy pills were randomly given to 1,090 AIDS patients at 67 hospitals in the United States, Canada, Europe and Australia. All of them had ominously low levels of helper T cells, the main target of the AIDS virus in the bloodstream.

The patients continued to receive whatever AIDS drugs they had already been taking and were followed for seven months. By that time, 13 percent of the patients getting ritonavir had died or gone on to develop new AIDS-related illnesses, compared with 27 percent in the comparison group.

The death rate was 4.8 percent in the ritonavir patients and 8.4 percent in the compari-

About 15 percent of patients on ritonavir dropped out of the study, and the most common side effect was vomiting and nausea.

However, Leonard said some of the patients said they felt better, gained weight and even cleared up AIDS-associated skin cancer.

"There is no question this is an important step forward," said Dr. Anthony Fauci, head of the National Institute of Allergy and Infectious Diseases.

"This does not mean that AIDS is anywhere near a cure. If you're uninfected, you must do everything you can to stay that way." Dr. Jeffrey Kelly

Showing that any AIDS medicine prolongs life has been extremely difficult. Studies a decade ago with AZT, the first AIDS drug, suggested improved survival, but this was disputed by later research.

Abbott applied to the U.S. Food and Drug Administration in December for permission to sell ritonavir, and the company hopes to have the medicine on the market in March.

Earlier in the week, researchers showed that both the Abbott and Merck drugs dramatically reduced levels of virus in the blood when combined with other standard AIDS medicines, such as AZT and 3TC.

Merck's indinavir cut virus levels so low they could not be detected in 90 percent of patients using the most sensitive tests for viral genes. Abbott went a step further and tried to grow virus in cultures using blood taken from treated patients. They concluded the virus was completely gone in 25 percent of them.


"This is a new milestone for determining progress in AIDS," said Dr. Andre Pernet, Abbott's research director. "It's very important for the first time to be able to say patients are blood negative."

As impressive as this sounds, researchers cautioned that the virus may still be lurking elsewhere in the patients' bodies, such as their lymph nodes or brains.

Some researchers believe it may make sense to start patients on a combination of protease inhibitors and other drugs as soon as they know they are infected, rather than holding therapy until the virus has caused considerable damage

'The dream is to start patients early when they have very low viral loads," said Pernet. If you can suppress it without mutation long enough to let the infected cells be replaced by healthy cells, then you could cure it, although that has not been proved yet.'

Kelly cautioned that this is only "speculation" at this point. "There is no cure in sight," he said again.

Symbolic Same-Sex Weddings Expected to Raise Big Bucks for San Francisco

San Francisco—As Valentine's Day 1996, approaches an expected 3,000 same-sex couples will soon be able to say "I do" in a symbolic civil wedding performed by the county clerk.

Under the plan, which takes effect March 21st, same-sex couples who register as domestic partners will pay \$30 to have the ceremony, though the union will carry no legal weight.

The proposal creates a "civil ceremony to solemnize the existence of a domestic partner-ship," Supervisor Carole Migden said Tuesday, January 23rd. "It's a very San Francisco sort of thing."

The San Francisco Board of Supervisors voted 8-0 Monday, January 29th for an ordinance that allows same-sex couples who register for domestic partnerships to then 'solemnize' their relationship with a civil ceremony performed by a county clerk.

Migden, who introduced the ordinance, said many same-sex couples will have the civil ceremonies performed quickly after they are authorized on March 21.

According to Migden, the measure will create an equal opportunity for committed couples who choose to pledge their faith and devotion to one another at a time in which society can only benefit from the expansion of the definition of family."

The observance would serve only to solemnize a series of rights the city has granted gay couples since its domestic partnership law took effect on Valentine's Day in 1991. Under that ordinance, San Francisco allows same-sex couples who register to have visitation rights in hospitals, shared health plans for city employees and bereavement leave for city employees when a domestic partner dies.

Private employers are not required to grant the same benefits.

Only couples registered as domestic partners in San Francisco will be eligible. At least 3,000 unmarried couples, most of them gay, already have filed for that designation.

One of those couples is Lori Guidos and Cheryl Deaner, who registered together two years ago then had an elaborate wedding ceremony of their own. While they do not intend to have another wedding, they applauded the board's vote.

"I think it's a wonderful, symbolic gesture," Deaner said.

"It shows the way mores are changing in this country. And when society changes in general, eventually the law changes, too," she added. "And that's what's needed _ family civil rights."

Lou Sheldon, a Right Wing extremist, of the Washington, D.C.-based Traditional Values Coalition, on the other hand, said the effort to recognize same-sex marriages is just a "fad." He said the fact that only 3,000 couples have registered for domestic partnerships shows that type of commitment does not have a large backing.

"It's not unusual that San Francisco does the freak thing," Sheldon said. "I think basically what you have here is a dysfunctional behavior being recognized by the Board of Supervisors in a ceremonial manner."

The only two other cities that offer civil ceremonies to domestic partners are Madison, Wisconsin., and New York City.

Laws that would ban same-gender marriage are either pending or active in South Dakota, Alaska, Washington state and Colorado. Maine was considering one, but its sponsor withdrew the proposal because it became so controversial, he said.

Utah does not recognize same-sex marriages.

San Francisco has a large Lesbian and Gay population, sometimes estimated at 10 percent or more of the 730,000 residents, attracted by

the city and its liberal political bent.

San Francisco's effort to recognize longterm same-sex partnerships is at odds with a state effort to prohibit their recognition in California. The state Assembly is scheduled to look at a bill on January 30th that would prohibit California from recognizing same-sex marriages, whether performed inside the state or outside for example in Hawaii, where same-sex marriages could be legalized next

Adding the symbolic marriage ceremony is expected to double or triple the number of couples registering as domestic partners, according to a memo by Assistant County Clerk Nancy Alfaro. The county clerk traditionally performs civil marriages.

If half the couples already registered have a ceremony, that would generate \$45,960, according to Alfaro. And she estimates new couples registering could add another \$41,500 this year.

Volunteers would perform the ceremonies, and processing would cost an estimated \$3,000, according to the county clerk's office.

"A large number of taxpayers have asked for this service from our department," said Alfaro. "Implementing ceremonies would resolve any access and fairness issues."

In 1994, the California Legislature passed a bill that would have set up a statewide registry of unmarried domestic partners, but Gov. Pete Wilson vetoed it.

Cheryl Deaner at the Alternative Family Project in San Francisco said the proposal seemed like an idea whose time has come.

"Although this won't really remedy any legal discrimination, it is a step forward," she said.

A Chicago Neighborhood of Diversity **Welcomes Women Entrepreneurs**

Chicago--The Swedes say valkommen; the Persians, khosh amadeed; the Spanish, bienvenidos; the Japanese, yo okaso irashai mase.

And they're saying it to women entrepreneurs in Andersonville's North Clark Street, a street of dreams for women in a potpourri of Chicago's ethnic neighborhoods.

The North Side community, a mecca for cultural and ethnic diversity, has opened its arms to sexual diversity--businesses owned and operated by women, some Lesbians, some

Go on a shopping spree at women-owned stores, and you'll find pet supplies, imported dolls, jewelry, pottery, an American Indian skin painting, lesbian erotica, Swedish pastries, Christmas decorations.

You can take your pet to the vet, see a play or sip cappuccino while planning an overseas trip. You can take home a rented moviemaybe Thelma and Louise.

Women have set up shop amid an eclectic serving of ethnic restaurants, grocery stores and 'Valkommen' banners that line about a mile-long stretch of North Clark.

"Women are making incredible strides in this neighborhood," said Angela Turley, coowner of Studio 90, a boutique offering artists' handmade creations, including clothing designed by Turley and co-owner Jill Hilgen-

Andersonville has about 200 businesses and Alderwoman Mary Ann Smith, the neighborhood's fourth female City Council member since 1971, says about 70 percent of them are owned or managed by women.

One popular spot is the feminist bookstore Women & Children First--not far from the Spanish Speaking Bookstore.

Co-owners Linda Bubon and Ann Christophersen, lured by the tolerant atmosphere and low rents, moved the bookstore here in 1990 from pricey Lincoln Park.

Women & Children regularly brings in authors like Amy Tan and Gloria Steinem for autograph signings, and offers story hours for young children. Its books appeal to women of

all sexual orientations, from novels by Tan, Sarah Paretsky and Anne Rice to books on cooking, motherhood and homosexuality. It has a sizeable collection of books by and about Lesbians.

'A lot of different people live with each other, not only in terms of tolerating each other but also liking the mix," said Christo-

But customers also include people like grandmother Rita Roth, who attends a monthly women's book discussion group at the store. "I try to support women entrepreneurs," she said.

A few doors away at WomanWild, owners Nancy Perrone and Janet Soule offers gifts made solely by women artists--pottery, stained glass, jewelry, candles and more.

There are a lot of Lesbian and Gay businesses here," said Perrone. "We are part of that diversity."

The upscale gallery's name comes from Lesbian feminist writer Sonia Johnson's Wildfire-a reference. Perrone said, to "the creative energy in women.'

Named after farmer John Anderson, the four-square-mile neighborhood about five miles from downtown was settled by Swedes moving north after the Chicago fire in 1871. About 25 years ago, several Middle Eastern businesses began locating there. Today, both ethnic groups are prominent, along with Japanese, Italian and Filipino eateries.

The Landmark, a cooperative of 18 shops-all but one owned by women-- helped pave the way for women entrepreneurs when it opened in 1987. That same night two other womenowned business opened nearby.

The history of the artsy Kopi--A Traveler's Cafe, is a story in itself. It opened in 1991 after two women on a backpacking trip in Southeast Asia met a third woman from Andersonville.

The trio decided to open a coffeehouse with a travel theme where people could buy maps and travel books, find destination points on globes, and check the time in faraway places like Timbuktu by glancing at wall clocks.

They took out a \$12,000 loan, named the business Kopi--coffee in Indonesia-- and paid off the loan in six months.

The whole idea behind Kopi is we don't see sexual preference, race, culture or relig-' said Rhonda Welbel, one of the two remaining owners. "We look at this neighborhood as open to everyone

Says Landmark building owner Jan Baxter: There is something in the water that grows

Others say Andersonville is so welcoming to women because of its Scandinavian roots and multi-ethnic history.

troduced in 9 other states in the past 20 days, Baldwin is well-aware that there is a wellorchestrated national drive on by the Radical Right to get such laws on the books, as confirmed by the Christian Coalition.
"We shouldn't let Wisconsin become swept

up in this effort to advance the Radical Right's larger agenda," Baldwin said: "Wisconsin deserves better. The bill's introduction this late in the session when there's little time to thoughtfully consider its implications, means allowing external political event to undermine our legislative process.'

Baldwin continued. "We've seen this rhetoric before, in other state legislatures, and in the Republican presidential primary. And let's call it what it is-this is not about Gay marriage. It's about stirring up hatred and fear for the sake of political expediency.
"It's not at all about giving Wisconsinites a

voice. If this measure advances, it means polluting Wisconsin with the Radical Right's national hate agenda. And by any measure, that's not what's best for the state or its people.

State-Wide Organizing Efforts Action Wisconsin will be leading efforts to turn back the proposed legislation, embarking on a broad-based strategy grounded in the alliances formed over the past 15 years.

Action Wisconsin's president, Juliet Brodie, said that the organization's five regional divisions will each play an important role in responding to the Far Right's assault.

The Madison regional chapter of Action Wisconsin was well-represented at the February 12th meeting.

In addition to Madison, the Milwaukee and Fox Valley (Kaufert's home district), will play crucial roles.

Madison Fire Chief Faces Campaign of Harassment From Fire Fighter

Madison--In recent weeks, Madison's first female fire chief. Debra Amesqua, has been no stranger to controversy. Ever since the announcement of her hiring, she has been the subject of a campaign of anonymous innuendo and unfounded assertions implying that she was hired for reasons that have nothing to do with her qualifications.

In recent days, that smear campaign has taken on blatantly homophobic undertones. And now Madison fire fighter Ronnie Greer has been caught distributing anti-Gay leaflets while on the job, and is facing disciplinary ac-

While Greer claims that distributing the pamphlets is something he's entitled to do under his First Amendment rights, fire department officials point out that this just isn't so when he does it while on city time in a manner that creates a hostile work environment for other fire fighters. As of press time, city officials were contemplating what action to take against Greer.

A well-established "good old boys network" within the Madison fire department seems to be making a loud and long last stand in an ongoing battle to discredit the new chief.

In the current climate of backlash against affirmative action, both homophobia and sexism have been invoked as weapons. speak for only a minority of their colleagues, a handful of male fire fighters have been outspoken in their criticisms of Amesqua in ways that have bordered on insubordination.

For example, an anonymous caller to an early morning talk radio program identified himself as a fire fighter, and proceeded to Gaybait Amesqua, just days after her hiring.
"It's pretty obvious why they hired her," he

"She's a woman, she's a Native American, she's a Well, heh, heh, heh, I won't say it. You know what I mean.

Fifteen years ago, Madison fire department officials fought tooth and nail to keep women out of the department. That fight resulted in a history-making lawsuit that was won by women who became Madison's first female fire fighters.

Not surprisingly, a significant number of Lesbians have joined the force over the years. This was an echo of a process that had begun at the Madison Police Department several years before. The result has been that Madison has, arguably, one of the largest contingents of openly Lesbian fire fighters and police officers of any city in the country.

Despite this, recent events have made it clear that many in the department view the advent of women in real positions of power as a significant threat. And homophobia-based harassment has often been invoked as a weapon against these women, regardless of their actual sexual orientation. Greer, a former school board candidate and elder at the predominantly African-American Mount Zion Baptist Church, is merely the most visible of those critics.

The local media have been less than sophisticated in their reporting of the entire affair. For the most part, they have taken a so-called even handed "he says, she says" approach when it comes to reporting the story, ignoring the questionable veracity of the statements being made by Amesqua's critics, and showing no initiative in attempting to show the not-sosubtly hidden motivations underlying those

The problem has exacerbated existing tensions between the Gay and Lesbian community and the leadership of Madison's predominantly African-American churches.

Maryland Governor Backs Gay Civil Rights Bill

Annapolis, MD-AP-Governor Parris Glendening's office said on January 26th that the nor has thrown his support behind legislation prohibiting the discrimination of Gays and Lesbians in Maryland. This is the first time such a bill has had the governor's support. Under the proposed bill, discrimination in employment, housing or access to public accommodations such as hotels and restaurants based on a person's sexual orientation would be prohibited. The legislation would designate Gays and Lesbians as a group protected from discrimination under state law. The bill will have the benefit of the governor's staff and resources to lobby for its passage.

the Lesbian and Gay community And yet I still hear the often naively expressed sentiment that this simply can't be sothat it's impossible to understand how a person who faces one oppression can be judgmental

toward someone else who faces another oppression. If only it were true.

However, all such cynicism aside, for every example of situations I can recall when members of the African-American and Lesbian/Gay/Bisexual communities have been at odds, there is another less visible, but equally significant, example of a situation when people from those communities have pulled together.

I remember well a day ten years ago, for example, when Tammy Baldwin and I were sitting around the table at a meeting of the local Rainbow Coalition. The subject was member-ship recruitment. Several of us had just finished speaking about the need to continue our efforts at outreach into several underrepresented cultural and ethnic minority communi-

As we were about to move on to other subjects, an African-American community leader by the name of Charlestine Daniels raised her hand. "We mustn't forget our Lesbian and Gay brothers and sisters," she said, and proceeded to go into an eloquent and moving ten minute monologue about all of the reasons why our participation under the Rainbow was so vitally important.

Over the years since then, that experience has been repeated many times for me. African-American friends have been there for me in a big way, and I'd like to think that I've been there in a big way for them, too.

The same has been true of so many of my female friends, who have to overcome harassment and blatant discrimination in so many realms of their lives. It doesn't happen with everybody, but in my own life, I've been blessed by a diversity of friends who do see the interconnectedness of the fight for the rights of

Newly installed fire chief Debra Amesqua faces an especially daunting challenge right now. Everything I have heard about her qualifications and her philosophy of life says to me that Madison is extremely fortunate to have a person of her caliber at the helm.


She deserves to be able to step out from under the shadow of this manufactured controversy--and she deserves to have the media begin reporting on her work without always attaching the stigmatizing label of "contro-versial" in front of her name. And she will only get that chance if all of us speak out against the backlash that has manifested itself in the kinds of blatant displays of prejudice that people assumed couldn't exist in the so-called utopia known as Madison.

Some good things have come as a result of the Greer hate literature incidents. Community leaders of all races are beginning to speak out against Greer's message. Links are being made with this incident, and the distribution of KKK literature that had occurred a few weeks earlier. Yes, people are beginning to speak

But each of us must ask--what have I done? And can I do more? For, unless we confront those questions, and work hard to be there for each other in significant ways, Madison will be a place that none of us will want to live in.
