Federal Court to Review Suit Brought By Wisconsin Youth on Anti-Gay Bashing

Milwaukee--A civil suit waiting review by a federal court accuses public school administrators in Ashland of failing to protect a Gay student against taunts and physical abuse by classmates.

If Jamie Nabozny, now 20, wins the argument, the ruling will alert school administrators nationwide to provide a protective environment for students, attorney David Buckel said.

Buckel works for the Lambda Legal Defense and Education Fund of New York City, which is assisting Nabozny in his suit against the Ashland school district.

"Violence against Lesbian and Gay teens is a serious problem that school officials cannot ignore," added Patricia M. Logue, Managing Attorney of Lambda's Regional Office in Chicago. "With the federal government reporting that one-third of teen suicides are by Lesbian and Gay youth, schools must show zero tolerance for anti-Gay attacks."

The 7th U.S. Circuit Court of Appeals in Chicago is scheduled to hear the case March 28th.

If Buckel's argument is upheld, it ``would be an endlessly expensive burden to place on school districts'' that could be named in similar suits, Timothy Yanacheck, the district's lawyer, said.

'The school district didn't do anything to cause these punks, Jamie's classmates, to harass him,'' Yanacheck said. 'This legal case focuses on a narrow point, and that is (whether) the U.S. Constitution creates a responsibility on the part of school officials to protect kids.''

"If we prevail in this case, it will send a message to school principals across the country that they need to abide by the principle that all students need a safe environment to get their education," Buckel said.

What Jamie's case does is make it clear that we're simply not going to take this anymore," said Kevin Jennings, executive director of the Gay, Lesbian and Straight Teachers Network, based in New York City.

Jennings' group gave Nabozny an award earlier this month for fighting homophobia in schools.

Another case involves the Salt Lake City school board, which decided recently to eliminate extracurricular clubs rather than allow a gay-student support group, Jennings said.

In New Hampshire, parents sued the Merrimack school district over a policy that forbids support of homosexuality as a positive lifestyle, he said.

Nabozny and Buckel said they are willing to take their case to the U.S. Supreme Court. "The big reason is so that it doesn't happen

to other people," Nabozny said.

He was kicked, spit on and taunted in corridors, restrooms and locker rooms after enrolling in middle school in 1988 in the Lake Superior community, he said.

He dropped out of high school as a junior in 1993. His parents said they conferred with school administrators and counselors after their depressed son considered suicide.

"Every time we left any of the meetings, we felt something was going to be resolved and it never went any farther," Nabozny's father, Robert, said in court documents.

Nabozny moved to Minneapolis where he earned a high school-equivalent degree. He filed suit in 1995.

"The thing that I remember most is that my stomach was always in knots," he said in an interview. "I would always tell my parents that I was sick."

He and Buckel argue the district failed to afford Nabozny the same protection that was given girls against sexual harassment.

Yanacheck, denying the district should be held accountable, cites a decision in October of Judge John Shabaz of U.S. District Court in Madison.

Shabaz ruled Nabozny failed to present sufficient evidence to send the case to trial.

`The facts in the plaintiff's case are also wrenching because he was verbally harassed and beaten by other students because of his sexual orientation,' Shabaz wrote.

'There is nothing in the record, however, to indicate that the defendants created or ex-

Midler, or "The Divine Miss M," is no stranger to Gay
audiences, for it is among us that she first began her
career that has hit the heights of both screen and music.

According to Midler, she wsas born and raised in Honolulu, Hawaii, and made up her mind to become an actress while still in high school in the Aloha State. After a year of studying drama at the University of Hawaii,

she was cast as an extra in George Roy Hill's film Hawaii. It was, Midler says, a small taste of what might be, but "I was hooked.

She relocated to New York City, where she made her stage debut in Tom Eyen's Cinderella Revisited, followed by her portrayal of Tzeitel in the Broadway musical Fiddler On The Roof.

In the wake of singing engagements at a host of popular New York cabarets, Midler opened a record-breaking run at the city's Continental Baths.

As those of us know from "the good old days," the Continental Baths was one of the most popular Gay men's spas in New York City. Midler wowed them and she has, as she said, "never forgotten my roots. I owe a lot to the Gay community and I always will."

She created such a sensation with her Gay audiences, that it wasn't long before she had signed a contract with Atlantic Records.

In 1973, Bette took Grammy Award honors for Best New Artist in recognition of her "Divine Miss M" debut album (now certified RIAA platinum). That same year, she received a Tony Award for her appearance at Broadway's Palace Theatre. Medical College Study Indicates that HIV is Necessary, But Cannot Itself Cause AIDS

Milwaukee—Scientists at the Medical College of Wisconsin have shown that a second virus, human herpsesvirus six (HHV-6), plays a critical role in the progression of HIV infection to AIDS. A description of this work will appear in the Journal of Immune Deficiency Syndromes and Human Retrovirology in April and is an extension of earlier work by the same investigators.

Medical College researchers Konstance

Kehl Knox, Ph.D., senior research scientist, and Donald R. Carrigan, Ph.D., associate professor of pathology, evaluated lymph node samples from ten HIV-infected patients for active HHV-6 infection.

Drs. Knox And Carrigan used a sophisticated staining technique to detect cells actively infected with HHV-6 in the tissue samples. Large numbers of cells actively infected

Oregon's Arch-Homophobe Runs For Senate

Salem, Or-AP-Oregon's leading campaigner against Gay rights says his last-minute entry into the U.S. Senate race means he's going strong. Opponents and one-time allies say

he's just desperate to rescue a dying crusade.

Lon Mabon, chairman of the Far Right Wing group Oregon Citizens Alliance (OCA), surprised friend and foe alike when he went to the Oregon House chamber and filed his GOP primary candidacy papers minutes before the filing deadline. Statehouse observers saw it as political payback to Republican front-runner Gordon Smith, who accepted Mabon's endorsement during his failed bid for Bob Packwood's vacant Senate seat, but recently ditched Mabon, calling his group "divisive." Smith, narrowly beaten in January's special election for Packwood's seat, wants to make good on his second chance as he, Mabon and others compete in the May primary for the opportunity to replace retiring Sen.

Mabon himself cited Smith's about-face as his main reason for jumping into the Senate race. Social conservatives need a GOP candidate who actively opposes "special rights" for

But others say Mabon is just trying to pump up a group that has lost more than onefourth of its members over the past six years and is experiencing financial difficulties.

Mabon has sponsored two state ballot anti-Gay initiatives. Both were defeated by voters. The first would have declared homosexuality abnormal behavior and outlawed specific civil rights protections. The second lacked the strident language, but still would have forbidden government from affording special civil rights protections to homosexuals.

Currently he's pursuing another measure to restrict homosexual civil rights legislation and one to ban late-term abortions. Both require more petition signatures to qualify for the November ballot.

Tampa Captures Gay Group's Convention

Tampa, FL-AP- Four years after a controversy over Tampa's sexual orientation ordinances, the city is preparing for a Hay group's lucrative convention. Gay groups threat-ened to boycott the city in 1992 when Tampa voters repealed an amendment to the city's human rights ordinance banning discrimination on the basis of sexual orientation. But the city put the law back on the books in 1993 after courts declared the vote invalid on a technicality.

And now a Gay group's convention could prove to be the largest meeting to use the city's convention facilities. The Gay and Lesbian Association of Choruses Festival V, has already booked one-fifth of the city's entire supply of hotel rooms for its convention July 6-14, tourism officials said Tuesday.

The quadrennial festival will feature 90 choral groups--up to 6,000 singers-- from North America, Europe and Australia.

All musical performances will be at the Tampa Bay Performing Arts Center. But Tampa Convention Center officials are preparing for a crowd of 7,000 at an opening ceremony July 7 featuring poet laureate and novelist Maya Angelou.

The Tampa City Council is expected to vote Thursday on requests to close streets downtown for a gay pride parade on July 7, which organizers say could draw 10,000 people or more. And the festival has also rented Busch Gardens theme park for functions.

In addition to hotel business, the festival is expected to attract more than 30,000 people who will watch performances but not stay overnight, said Mark Puig, executive director of the Tampa Bay Gay Men's Chorus and a festival organizer.

Protests Mark New York's St. Patrick's Parade

New York, NY-AP-Sidelined from the main event, members of the Irish Lesbian and Gay Organization (ILGO) protested on street corners as the St. Patrick's Day Parade marched past them. Police arrested 45 ILGO members, most of them in front of the New York Public Library at Fifth Avenue and 42nd Street.

ILGO has tried to gain admittance to the St. Pat's parade for years, but is always turned down. The group has also asked for a permit to hold a counter-parade, but also is denied

The first demonstration, in front of the library at 9 a.m., was orderly until about 9:45 a.m. Then 38 people broke off from the main crowd of about 250, ran into the middle of Fifth Avenue and sat down in the street. Police gave them two warnings to leave or be arrested, but they refused to go. They were taken into custody as a Gay Irish band played When Irish Eyes Are Smiling.

Watching his colleagues being arrested at the library, ILGO member Paul Warren said he thinks the action is essential. "I think it's important to make the point it's wrong to exclude people. We are Irish and we happen to be Lesbian or Gay," Warren said. "It's

nothing more than institutionalized bigotry."

Although there were a lot of ``boos'' from marchers in the parade directed at the demonstrators, there were also peace signs and thumbs up thrown out to them. And several officers from the Emerald Society were cheered by the demonstrators when they ran to the curb to get hugs from ILGO members as they passed by. A kilt-clad bystander shook his head as he watched the library protest. William Armet, a member of the Celtic Pipe Band, who would march in the parade later that day, said ILGO should be allowed to take part.

'This is 1996. C'mon, these people are just like us." Armet said. 'And they are Irish. That's what counts."

Plurality Opposes Gay Club Ban in Utah

Salt Lake City, UT-AP-Utah residents are split on whether local school boards should ban all student clubs rather than allow Gay-Lesbian organizations in public schools, a new public opinion survey shows. The recent Deseret News-KSL poll, showed 35 percent of the 607 people interviewed said they would allow support groups for Gay students rather than ban all student clubs. Pollster Dan Jones & Associates found that 28 percent wanted school boards to specifically ban Gay-Lesbian clubs, even if it mean a court fight over civil

Gay Physicians Say Oral Sex is "Low Risk"

San Francisco—On March 19th, the Gay and Lesbian Medical Association (GLMA), an organization of 1,800 physicians and medical students, declared that unprotected male/male oral sex should now be classified as low-risk activity for HIV. It's position statement, supported by 36 scientific references acknowledges that a few documented cases of HIV transmission through oral sex have been reported. Nonetheless, notes the statement,. "most studies have not found a statistically identifiable risk," and thus prevention efforts should focus explicitly on unprotected anal intercourse.

Failure to focus on anal intercourse is dangerous, warns the group: "Education that equivocates about the type of sex being discussed is confusing and potentially harmful because it implies that oral sex is equivalent in risk to anal sex," it counsels.

"Prevention education must consistently acknowledge the essential importance of sexual intimacy for Gay men," notes GLMA Policy Committee Chair Alvin Novick M.D., a biology professor at Yale. "Rather than attempting to impose an unrealistic zero-risk standard on all people, our prevention efforts should focus on reducing risk overall by helping each individual learn how to maximize fulfillment and minimize risk.

Lawsuits Over Freedom of Speech and Information on the Internet Go To Court

Philadelphia, PA-One side sees cyberspace becoming a world ruled by conservatives who bristle at the word "breast." The other wants the Internet to be a friendly neighborhood for the world's children--free of pictures promoting bestiality and words glorifying in-

Plaintiffs who have filed two lawsuits challenging the Communications Decency Act (CDA) began presenting their arguments Thursday, March 21st, taking three federal court judges on a tour of the worldwide computer network.

What this case is about is determining what the rules are going to be in the brandnew medium of cyberspace," said Chris Hansen, attorney for the American Civil Liberties Union.

The law in dispute, enacted February 8th with President Clinton's signature, as part of the nation's new telecommunications law, makes displaying "indecent" or "patently offensive" words or images on the Internet punishable by harsh fines and prison time if they are accessible to minors.

It was designed to keep nude pictures of adults off screens available to children. But, according to a coalition of civil libertarians and online industry groups, it also bans a broad class of speech protected under the U.S. Constitution's First Amendment.

The legal challenges were filed last month in Philadelphia, the birthplace of the Constitution. The results could determine whether the act is an unconstitutional attack on free speech or a vital protection of America's vulnerable youth.

We're pretty confident that the courts will have the savvy to recognize the problems in the law and the smarts to change it," said Jerry Berman, the executive director of the Center for Democracy and Technology, a plaintiff in the second lawsuit.

The most pervasive criticism of the law is that its language is unclear.

Plaintiffs such as the online services America Online, CompuServe and Prodigy say they aren't sure whether the law covers materials that have serious literary, artistic or intellectual value and are constitutionally protected for adults.

This case is not about obscenity or kiddy porn. Those will continue to be illegal even if we win outright," Hansen said. "It's about suppression of sexually oriented speech that does have social value.

Examples include medical information about such topics as childbirth, abortion,

Lesbian and Gay groups, breast cancer and sexually transmitted diseases; works of art and literature; and samples of popular culture such as music lyrics and movie clips

Excluded by the new law would be works such as Michelangelo's statue of David.

Michelangelo's statues are appropriate in the halls of the Vatican but not the streets of the information superhighway," said Prodigy attorney Marc Jacobson.

Randy Bennett of the Newspaper Association of America fears the vagueness will lead people to err on the side of caution.

This self-censorship will halt the distribution of protected expression and information of value," Bennett said.

Online newspaper content from the mainstream press and alternative publications such as The Seattle Gay News or Wisconsin Light that may be subject to the CDA includes articles reporting sex crimes or medical coverage; reviews of books or movies that may be "patently offensive"; and editorials or opinions about sexuality, abortion or vio-

One other potential problem with compliance is adhering to ``contemporary community standards.'' Which community is providing the baseline to determine what is 'indecent' or 'patently offensive"-New York, Amsterdam or Peoria?

The plaintiffs plan to give the courts an online demonstration of exactly how the Internet works. By doing so, they are confident they can persuade the judges the law is unenforce-


Technology exists to allow parents to block access to thousands of sites containing sexually explicit material. Several software programs are password-protected, inexpensive and tamper-resistant.

'That's part of the solution, but what if a child goes to the neighbor's home or the library and logs on? They need to be protected, too," said Bruce Taylor of the National Law Center for Children and Families.

Donna Rice Hughes, who came into the public's consciousness as Gary Hart's companion and now works for the antipornography advocacy group Enough is Enough!, said parental empowerment is just the latest ACLU battle cry.

They started out with the issue that Anything goes in cyberspace-that is what makes the Internet so beautiful,"" she said.

That would be fine if there was no criminal element and everyone lived by the Golden Rule.



Goodness Has Nothing to do With it

As we reported a couple of issues ago, when the Hawaiian State Tourist Bureau looked into the matter, they got a pleasant surprise. If same-sex marriage is made legal in the Aloha State, tourist income will increase by some \$4 billion plus change-and that's after subtracting what the state would lose from Right Wingers who stayed away.

In Tampa, Florida, the same thing happened pretty much. 4,000 to 6,000 Lesbian and Gay singers can spend one whopping amount of dough. Can't you just hear the city's solons? "We don't approve of them!" protests one.

"Ah, yes," replies a wiser head. "But isn't their money such a lovely shade of green?" "Repeal that awful ordinance against them!" cries the first speaker. "Repeal it at once, I say!"

The vote for repeal is unanimous.

As the late Senator Dirkson once put is, "Here a billion, there a billion, and pretty soon you're talking real money." Or to put it another way, "My God, how the money rolls in!" The point to all this cynicism is simply this: Money may not eliminate prejudice, but the de-

sire for it can sure make people act like it's gone.

Take the Sybaris Club for example. We noted with interest that at the recent Make A Promise silent auction, "formerly" homophobic Sybaris had two "get-away" items up for bid. But wait! There, lo and behold, was a disclaimer saying they didn't discriminate against anybody; same-sex couples welcome. Prejudice gone? Yeah, right. But underground is okay for now.

The same thing held true for another business we know about. A little mention to the owner of money the paper wished to spend-and could easily spend elsewhere-and bingo! Prejudice.

My God, I'm sorry, etc., etc., etc.

Somebody once said that when you pray for peace on earth, the most you're ever going to get is absence of conflict. Purists and idealists among us may not like that, but it's the way it is. On the road to our freedom, we should, perhaps, ignore motivation and not despise nonprejudicial actions, thinking, in the end, that actions can sometimes lead to a change of heart.

In the Absence of Sources, the Truth About the Nazi Persecution of Gays is Being Lost

On January 27th, as reported world-wide in the press, Nazi concentration camp survivors gathered at sites throughout German to mark the anniversary of the Russian liberation of Auschwitz. But for many Lesbians and Gay men, in Germany and elsewhere, such gestures are hollow.

After the liberation of the camps, Dachau and the rest, Gays wearing the Pink Triangle who had survived the horrors best associated with Hell, knew no freedom. They were forced to complete their sentences imposed on them by Hitler's courts.

Just as bad, if not worse, there was no apology forthcoming from the German government, no financial or other recompense for their agonies, and, for a long time no memorial to what they had endured.

Lesbians and Gay men, were outcasts in Nazi Germany and remained so in "free" Europe. Homosexuality remained illegal in Germany until 1969.

Sadly, though understandably, few, very few Gay survivors wanted to tell their stories afterward. As Richard Plant in his book, The Pink Triangle: The Nazi War Against Homosexuals says, "The pink triangle was still their scarlet letter.

(Incidentally, Plant's book, published in 1986, remains one of the best works on the subject. It is "must" reading for every Gay man, Lesbian, Bisexual and Transgendered person.

And for those of you who think that "It can't happen here," remember, Hitler and company weren't only a German phenomenon, they were also, unfortunately, a human phenomenon.)

One of these, however, who has come forward, is Teofil Kosinski. As reported in the April 2nd issue of The Advocate, Kosinski recently petitioned the German government for compensation. What did he want? One deutsch mark (about 50 cents, the last time I looked), one symbolic coin. The government refused even that.

ws have received indemnification Kosinski is reported to have said. "So did some Gypsies. For homosexuals-nothing.

If you're interested in reading more about Kosinski, he has a book out, titled Damned Strong Love, written under the pseudonym of

The point to be made here is that Kosinski is story is rare, so very rare. The chance of more of those stories from Gay men and Lesbians is getting rarer with each passing day.

Not only are the survivors dying off, the

documents are being lost.
As reported in Light, Professor Norbert Finzsch in January, raised an alert via the Internet about the destruction of files held by the justice department in Hamburg. These files, Finzsch has reason to believe; contain record relating to the Nazi persecution of

In an update, the Hamburg justice department issued a statement saying that the destruction of the files had been halted

But we should not take comfort in this, Finzsch says. He believes that once public attention has shifted away, the destruction will begin again.

What makes this absence of sources all the more devastating is that, as usual, in the absence of knowledge, pseudo-scholars with evil intent, proliferate.

One such example is The Pink Swastika: Homosexuality in Nazi Germany co-

authored by Scott Lively. Lively is the former communications director of the Oregon Citizens Alliance, a Right Wing extremist group that was responsible for the push to get an anti-Gay law passed in Oregon a la Colorado.

As The Advocate reports, no serious scholar of the period takes the book seriously. For example, Klaus Muller, the Western European project director for the Holocaust Museum in Washington, D.C., calls the book "clever propaganda," which is another point. It is "clever," but doesn't really have to be when there is so little to refute it.

For example, Lively perpetuates the myth that Hitler had an affair with Rudolf Hess. According to Plant, "That is about as likely as saying Eisenhower had an affair with

To put it another way and more firmly, there is absolutely no credible evidence that Hitler was Gay. None.

Yes, of course, there were Gays in Nazi organizations. Ernst Rohm is a classic example. But, as The Advocate reports Muller as saying, "It was very dangerous to be in a Nazi organization and be a homosexual.

Lively's book is much on the level of The Protocols of the Learned Elders of Zion, a book fabricated by the Czarist secret police, which said the Jews were taking (or had taken) over the world etc., etc., etc.

In the same vein, Lively uses "sources" drawn chiefly from Soviet propaganda used against the Nazis in the 1930s-before the Russo-German pact of 1939.

"I spent the best part of my youth in prison," Kisinski is quoted as saying. "Who would punish a 17-year-old boy for love?"

It might be well for a few of our state legislators, some radio talk jockeys, some "Christian" ministers and some in Congress to remember that question.

New Study Helps Explain Transmission of HIV Among Straight Women

Washington, D.C .-- Researchers have discovered how a strain of the AIDS virus penetrates a woman's vagina, possibly helping explain why the disease spreads faster in certain women abroad than it has yet here.

The discovery, published Friday, March 1st in the journal Science, doesn't mean U.S. women have any less to fear from HIV, emphasized Dr. Anthony Fauci of the National Institutes of Health. Government figures show HIV infection already is growing fastest among women.

But the study helps researchers understand yet another mechanism the fatal virus uses to get inside the body, Fauci said.

There are different subtypes of HIV. One version, HIV-1e, is most common in parts of Asia and Africa, where 90 percent of HIV cases are attributed to heterosexual contact, Harvard University's Dr. Max Essex re-

Here, HIV first spread through homosexual contact and drug use, and heterosexually transmitted cases now account for some 10 percent of infections, he said. The most common U.S. subtype is HIV-1b.

HIV typically penetrates blood immune

cells, but Essex decided to see if the two subtypes penetrate to equal degree the cells that line the vagina, known as Langerhans'

The HIV-1e, from heterosexual patients in Thailand, grew much faster and to much higher levels in Langerhans' cells than the U.S. strain did, he found.

HIV-1e has been detected in only a few Americans, but Essex said if it spreads here, heterosexual women might be at even greater

Fauci, the government's top AIDS expert, said that's probably an extreme scenario, noting there are many differences between Thai and U.S. women that also influence HIV's heterosexual spread, everything from availability of condoms to high levels of Thai prostitution.

But the finding "brings us one step closer to understanding the mechanism whereby HIV may initially infect individuals," he

Illinois Religious Far Right Courted by Those More Eager for Office than Heaven

Chicago-State Rep. Barb Giolitto was warned to expect a rough re-election campaign after voting for a bill intended to guarantee equal rights for Gay people.

Just the same, she was shocked by the leaflet that turned up in mailboxes across her Rockford-based district the Saturday before Election Day 1994.

The leaflet criticized Giolitto not only as a supporter of the Gay rights bill, but also of same-sex marriages--something not covered by the bill. The leaflet said she would allow Gay people to adopt children and teach in public schools--things not covered by the bill but already done openly by Gay people.

I just thought it was a lowdown, dirty trick," says Giolotto, a Democrat who lost the election. "They (Right Wing Religionists) waited until the last minute so I couldn't

It was an example of how what ultra Right conservatives call family values have become an important--and sometimes questionable-part of political campaigns in Illinois as in the rest of the nation.

Much of the family-values campaign material that circulated before the March 19th primary, came from groups loosely called the religious right—"Christian" conservatives who oppose abortion and any rights at all for Gay people and passionately support such causes as prayer in schools. But those issues have been eagerly seized upon by Republican groups and individual candidates as well.

Partisan groups and office-seekers have sometimes dramatized the issues with far more zeal and flamboyance than accuracy

Democrat John Sheehy lost his south suburban Illinois House seat in 1994 following a last-minute mailing that attacked his support of the human rights bill. It came complete with a cartoon showing a reptilian-looking ogre pulling Sheehy's strings. Like the mailing to Giolotto's district, it's not known where the anti-Sheehy mailing originated.

Those hurt the most by such mailings are most critical of the religious right.

"They have little interest in the truth in the mailings they send out," says Rick Garcia, executive director of the Federation for Human Rights, a group that lobbies on behalf They're interested in of Gay people. spreading fear.

But there has been no general outcry among Illinois Democrats. No one wants to take on religion in a political fight. And thus far, the influence of Christian conservatives has been limited in Illinois.

Unlike such states as Iowa and Minnesota, Illinois remains a bastion for moderate Republicans led by Gov. Jim Edgar.

Fundamentalist Christians are just not as numerous here as they are in the Bible Belt,' says Paul Caprio, executive director of Family Political Action Committee.

Family PAC, whose chairman is conservative commentator Tom Roeser, spends up to \$100,000 supporting conservative candidates in Illinois each election.

We are people who are deeply committed to the Judeo-Christian rubric of public pol-Roeser says.

Still, most politicians believe U.S. Rep. Jerry Weller, R-Ill., got a considerable lift from Christian conservatives in his 1994 race against Democrat Frank Giglio in Chicago's south suburbs and downstate counties.

Caprio estimates that up to 30 percent of Republican primary voters in Illinois are "born-again" Christians.

This year, his group targeted three incumbent Republican state representatives that it says vote in Springfield `like people from the Chicago lakefront" and defended two incumbent conservatives who were under challenge in Republican primary races.

But the spotlight among grass-roots conservatives was on the Republican race for the

U.S. Senate nomination in which conservative state Rep. Al Salvi, (R-Mundelein), ran against Lt. Gov. Bob Kustra, who had Edgar's endorsement.

Salvi found volunteers among members of perhaps the best-known religious right group in America, the Christian Coalition.

They're very excited about the possibility that we can put into office a real, pro-family conservative," says David Curtin, executive director of Illinois Christian Coalition and a former aide to Illinois Senate President James

The Christian Coalition maintains that it doesn't endorse candidates but "merely distributes" voter guides at churches and elsewhere on Sunday before the voting. The guides are heavily slanted and biased in the

They can be powerful because distribution is concentrated in areas where conservative Christians are most numerous

National leaders of the Christian Coalition, Pat Robertson and Ralph Reed, have been eagerly courted by presidential candidates. But state leaders are on the political fringes.

The Illinois chairman is John Parrott, a Bloomington-based clothing manufacturer's representative and longtime Robertson admirer. The only board member with a familiar Statehouse name is John Nimrod of Glenview, who was bumped out of his Senate seat more than a decade ago -- by Bob Kustra.

The power of family issues has kindled an interest among Republicans more eager to get into the House than into heaven.

I don't think anyone who knows me would call me a member of the religious right," says Michael Tristano, now an official of the University of Illinois-Chicago. But two years ago, as a member of the House Republican leadership staff in Springfield, he helped to produce leaflets that attacked three Democrats who voted for the human rights

The leaflets were headlined "Dark Days

Green Bay, WI-The 10% Society at UW-Green Bay will be hosting Pride Week, April to 12th. The theme of the week is "Reclaiming Our History."





Perry Watkins, Openly Gay Soldier Who Won Battle With the Army, Dies of AIDS

Tacoma, WA-Perry J. Watkins, an openly Gay soldier who won a federal court ruling that allowed him to retire with full honors, has died from complications of AIDS. He was 47. A statement issued by the Gay, Lesbian and Bisexual Veterans of America (GLBVA), Col. Nancy Russell (Ret.), GLBVA's president, called him "a true American Patriot who never got the respect or attention so justly due him.'

Watkins died Sunday, March 17th, at his home in Tacoma, the Gay and Lesbian Alliance Against Defamation (GLAAD) said Wednesday, March 20th.

An African-American, a native of Missouri, Watkins was drafted into the Army in 1968 during the Vietnam War.

He was admitted into military service despite having told his superiors that he was Gay. At the time, the Army discharged soldiers for Gay sex and other specific acts but not for homosexuality itself.

It wasn't until 1981 that the Department of Defense formally declared homosexuality incompatible with military service, contending it undermined discipline, order and morale.

"I didn't lie to the Army. I told the truth all these years that I'm homosexual," Watkins said in an interview in 1983.

I always made a point of informing the units where I'm assigned that I'm homosexual. My commanding officer always knew

In 1980, the Army notified Watkins that it was revoking his security clearance. The Army later told him it was also commencing discharge proceedings.

Watkins, represented by the ACLU of Washington, sued in U.S. District Court 1981 to obtain reinstatement of his security clearance and to prevent his discharge.

After a series of court rulings, the Army succeeded in discharging Watkins in 1984. At the time, he had served 16 years, four years short of being eligible for a full pension.

In May 1989, the 9th U.S. Circuit Court of Appeals ruled that it was unjust for the Army to enforce its anti-homosexual policy because Watkins acknowledged being Gay when he was drafted and was allowed to reenlist three

The court's ruling was narrowly focused and did not address the larger issue of bias.

'It is not a sweeping constitutional decision, but it is a first step that recognizes the value of the services of openly gay soldiers, Nan Hunter, a spokeswoman for the American Civil Liberties Union, said at the time.

In its press statement, GLBVA said that "While national Gay organizations passed off Watkins' victory as a fluke and ignored it, the decision continues to impact current cases against the U.S. military establishment.'

After the U.S. Supreme Court refused to hear the Army's appeal, the Army settled Watkins' lawsuit in 1991 by allowing him to retire from the military with honorable discharge and \$135,000 in back pay

Watkins was an example of how honesty and perseverance can make a difference, GLAAD spokesman Mark F. Johnson said.

Watkins was prominently featured in the late Randy Shilts' book Conduct Unbecoming, a work on the military's treatment of

A 1994 documentary called "Sis: The Perry Watkins Story" was made about his military career. The title referred to Watkins' performances as a female impersonator at various military bases.

Watkins Faces Gay Racism

In 1991, Watkins came to Milwaukee for PrideFest. His smile was infectious. He seemed to be enjoying himself. However, during the last two years of his life, he withdrew, granting few interviews because, as he himself said, of the racism and discrimination that he experienced at the hands of national Gay organizations and in the so-called Gay communities around the nation.

Some might think it was due to his failing health," said long-time friend Miriam Ben-Shalom. "Those who think that would be wrong. Perry stopped speaking because he was hurt at the treatment he received as an openly Gay Black man by his own commu-

"He was angry with the racist attitudes he encountered," Ben-Shalom said, "and decided to take care of himself. His passing is such a loss. We are missing a great hero and an honest man, now. I grieve the loss of one of my closest friends.

Burial plans were for a small private ceremony near Watkins' home.

Milwaukee-The Estate of Earl Koch has given a grant of \$55,000 to the Wisconsin AIDS Research Consortium (WARC), a research program for clinical drug trials in Wisconsin.

WARC is a subsidiary of the AIDS Resource Center of Wisconsin (ARCW), and an affiliate of the Milwaukee AIDS Project

According to Tom Landers, the personal representative of the Estate, Koch died at the age of 83 on October 14, 1995, after a brief fight with pancreatic cancer. His final month was spent receiving wonderful care at the Milwaukee Hospice Residence.

Born in central Wisconsin in 1912, Koch was educated at what was then the Wisconsin State Teacher's College at Stevens Point. He taught high school for 10 years at Manowa, Wisconsin, before serving with the Army in the Pacific during World War II.


After the war, Koch returned to Milwaukee and married Harriet, who died in 1970. He taught in the Milwaukee Public Schools from 1946 until he retired in 1977. Most of those years were spent teaching English and later, serving as Guidance Director at Bay View High School.

Koch's interest in the work at MAP and its affiliated research program, WARC, came from many sources, particularly friends who had died of AIDS, and through his awareness of the pain and suffering this disease brings to families, friends and those afflicted with the disease, Landers said.

Thomas E. Martin, the attorney for Koch's Estate, said that Koch's bequest of \$55,000 will be applied exclusively to the research done by WARC.

Doug Nelson, ARCW's executive director, explained that WARC's clinical drug trials enable Wisconsin residents with HIV disease to obtain some of the most advanced experimental HIV therapies.

Until 1991, people in Wisconsin living with HIV disease, traveled to Minneapolis or Chicago to participate in the latest clinical drug trials. Now, they can participate in these trials in academic, community clinic and private practice settings close to their homes, while

remaining under the care of their primary health care provider.

Presently, the Scientific Committee of WARC is evaluating several studies to increase clinical drug trials offered in Wisconsin, Nelson said. Several new studies may be added over the next months, potentially in-

cluding a clinical trial involving an HIV vac-

Priority studies are continuing, including drug trials that evaluate immunomodulators and therapeutic vaccines, treatments for opportunistic infections, prophylaxis agents, and combination therapies

Eight committed physicians specializing in infectious disease and HIV/AIDS participate in WARC studies. Koch's gift will help to fund the cost associated with this research.

According to Landers, Koch would be pleased to see his gift contribute to scientific progress in this needed area. Koch felt that MAP and WARC were the best organizations in Wisconsin to make this contribution.

"I'm delighted to receive this gift on behalf of Earl Koch and his Estate," Nelson said. "We hope that this gift will lessen the tragic continuing toll of AIDS, and advance scientific research for effective therapy and treat-

Warns Dole Aga

Gay and Lesbian Couples Tie the Knot Symbolically, But the Real Thing Isn't Far

San Francisco-Dozens of Gay couples, dressed in everything from traditional white dresses and tuxedos to full drag, were united on March 25th in city-sponsored weddings uniting same-sex couples in symbolic union.

Among the couples were nurse Margaret Johnson, 38, in a white dress, and her partner of three years, Liliana Diaz, 44, a social worker in a red jacket and skirt.

"It's a commitment and it's also a political statement," said Johnson, who said she was so nervous her hands were "freezing."

"It's a spiritual and emotional bond," she added. "That's very important at this time, to show the world that we're about love, we're about lust, we're about passion, and we create families together."

They planned a honeymoon starting Saturday in Argentina.

Before the ceremonies, each couple turned in a card with their names and a personal sentence to be read when they are joined. The ceremonies then began, one after the other.

In the auditorium at Herbst Theater, across the street from City Hall and acting as a substitute while the real thing undergoes extensive earthquake retrofitting, hundreds of friends and relatives vied for seats to watch the proceedings.

The wedding ceremonies are symbolic in the legal sense, since marriage between people of the same sex is not legal in California.

City supervisors approved such civic ceremonies January 29th to solemnize a series of rights the city has granted Gay couples since a domestic partnership law took effect five years ago.

Under that ordinance, San Francisco, as do several other cities in the country, allows Gay couples who register to have visitation rights in hospitals, shared health plans for city employees and bereavement leave for city employees when a domestic partner dies.

Sponsoring the measure was city Supervisor Carole Migden, who says the ceremony doesn't create special rights but instead creates equal opportunity for committed couples.

"It makes real to Lesbians and Gay people a way to concretize their relationships," Migden said.

Wedding participants must pay a \$30 fee above and beyond the \$35 now charged to register a domestic partnership.

And afterward, there likely will be less hoopla surrounding the event. Future ceremonies will be conducted at the city clerk's office, just as marriages are.

Denise Ratliff, who took part in the ceremony with her partner, said the mass ceremony at Herbst Theater will be a showcase for the nation. "Straight America and Gay America need to look to us for models of what Gay culture is," she said. "It really is about love."

Danny Wo took part in the ceremony with his partner, Mark Chabalus, Both were dressed in smart black tuxedos. They have been together five years.

"The only thing stopping same-sex marriages," Chabalus said, "is the religion thing. If the Christians and Jews want to marry only men and women, okay. Let them do it, but in their churches. Their religion gives them no right to step on Danny's and my rights."

"This may be only symbolic now," Wo added. "But the real thing isn't far away. Count on it."

It was that which seemed to be the general tenor of the ceremony. This is our right, they seemed to say. We will have it come what may.

Log Cabin Head Warns Dole Against Right Turn to Woo Buchanan Supporters

Columbus, OH--The leader of a national group of Gay Republicans has warned Bob Dole against moving to the right to woo supporters of Pat Buchanan during the presidential campaign.

Rich Tafel, executive director of the Log Cabin Republicans, said Friday, March 15th, that the Kansas senator cannot count on the organization's support if he backs Buchanan's views on homosexuality and other social issues.

Buchanan has consistently opposed Gay civil rights and once referred to AIDS as nature's "awful retribution" against Gay people.

The erstwhile radio and TV commentator was trailed Dole badly in recent polls in Ohio and other Midwestern states that held primaries on Tuesday, March 19th. But despite his losing record, and despite the fact that the vast majority of Americans have rejected his message, Buchanan has said he will stay in the race and carry his message to the GOP's national convention in August and try to influence the party's platform.

Observers generally agree that Buchanan's return home is a sign that his campaign is in trouble financially.

trouble financially.

Tafel said the Republicans--including Dole--should leave Buchanan's ideas out.

`If he goes to the right to appease Pat Buchanan, he'll probably lose our support,' Tafel said.

Spokeswoman Christina Martin did not return a telephone message left Saturday at Dole's campaign headquarters.

Dole has run afoul of the Log Cabin Republicans before. In August, his campaign returned a \$1,000 contribution from the group, saying the group's agenda did not fit Dole's views.

Dole later said returning the contribution was a mistake and blamed the action on campaign aides.

Tafel's group has about 10,000 members in 30 states, including Wisconsin. He was in Columbus to meet with members and GOP officials

He said carrying Log Cabin's endorsement can be a drawback for some Republicans. Candidates who acknowledge the support tend to do well in big cities, but not as well in rural areas or the bible-belt South.

"If you're running in Columbus, the Log Cabin endorsement is valuable," Tafel said.

The group will decide whether to make an endorsement for president during its convention in San Diego this summer, he said.

Controversial Salk Therapy for AIDS Began **Testing on Humans in March**

Washington, D.C .-- An AIDS therapy designed to boost the immune systems of infected patients--the last work of vaccine pioneer Jonas Salk--began testing in some 3,000 Americans in the third week in March.

Remune is the first immune system-based AIDS treatment to make it to such advanced

But scientists caution that patients should not expect a miracle. While the rationale behind immune-boosters is intriguing, earlier testing of such agents has been disappointing, said AIDS expert Dr. Pat Fast of the National Institutes of Health.

Developed by Salk, the inventor of the first polio vaccine who died last year, Remune is a form of immunotherapy. Sometimes called a "therapeutic vaccine," it is designed to rev up the immune systems of people with HIV,

the virus that causes AIDS. Salk took a strain of HIV, stripped it of its outer coating and killed it. He then added a chemical that helps immune cells recognize an invader and remember how it looks.

HIV usually hides in the body until it is strong enough to kill immune cells. Salk's theory was that Remune would prompt those cells to recognize all of HIV's proteins, usually hidden under its outer coating, earlier and fight back.

Two other immunotherapies are in earlier testing, but they use only portions of HIV, not the whole, killed virus.

Salk's therapy has been highly controversial. Immune Response, maker of Remune, told the Food and Drug Administration last year that, in small studies, it helped some patients retain vital immune cells.

The government's panel of AIDS experts said the studies probably were exaggerated but told the FDA to allow larger testing anyway to settle the issue.

Dr. James Kahn at the University of California, San Francisco, on Monday began enrolling some 3,000 patients with HIV, but not AIDS. Half will get Remune shots every 12 weeks for three years-in addition to whatever anti-AIDS drugs their doctor regularly pre-scribes--to see if Remune slows their progression to AIDS.

Clearly there's a lot of controversy," acknowledged Immune Response spokesman Steven Basta. This study should give us a definite answer."

One worry is that repeated injections of traditional vaccines, like flu shots, cause a small, temporary boost in patients' HIV levels. While there's no proof these small boosts cause harm, Kahn said he will watch Remune patients closely during their repeat injections.

Milwaukee-You expect him to be handsome, of course, and perhaps just a little taken with himself. He is, after all, an renowned athlete, best-selling author, TV per-sonality, and all the rest. Thus, you are not prepared for the man Greg Louganis is.

March 25th was a bitterly cold night. A

large crowd of people, bundled up against the chill, waited outside AfterWords Bookstore drinking hot coffee provided by the store. He was due at 6:30 p.m. for a short meeting with the press before beginning the all to boring task of signing books.

He came in, entering the store not in a rush, but in a small gust, smiling shyly, with a certain unexpected diffidence, and took his seat at the counter.

He is remarkably good-looking. At six feet plus, he is obviously an athlete, filling out his T-shirt and denims to perfection. His complexion is golden, a perpetual tan, with a soft dusting of moss roses in his cheeks. A patina of gray glazes his thick, black hair.

With him is his publicist, who is accompanying him on his 10-city book signing tour. He is of medium height, small boned and handsome, with a deep olive complexion and wide, gentle eyes. He will not give his name. Greg is the center of things, he says. "I'm not important." Remarkable.

The photographers move in. They take their pictures. Louganis smiles brightly. This is a gentle man, one who hopes to please.

In answer to a reporter's question, Louganis says his book, Breaking the Surface, has been in the nature of a cathartic. He has enjoyed writing it, he says, but disclaims the title of author. Instead, he would rather be known as a diver and actor.

This summer, he will be attending the Olympics in Atlanta, doing "chalk-talks" for

NBC, other divers and their families.

Has he been in Milwaukee before? Yes, once, on a diving meet. His publicist and he arrived in the city the previous day, wandering about a little, getting some exercise in at a gym. That evening they had a "good" dinner at the M&M Club.

Is he dating? No, he replies and pauses. "It's difficult," he admits. "I'm busy all the time." He leans forward a little in his seat, looking hard at the reporter. "I haven't had good luck with partners. I'm learning what I want in a partnership now.

But there is something else there. You can hear it when he settles back and adds, "I'm sticking to my dogs right now, five of them. Dogs are loyal and," he says with a knowing smile, "you always know where they sleep at night." He pauses. "One week more, and I'll be home."

There are several hundred people waiting for him to sign his book. AfterWords opens its doors and the line files in, entering according to the ticket number that each has.

Those still outside-and waiting in the Laundromat next door, want things to hurry up. The staff at AfterWords tries. Louganis' publicist tries gently. but Louganis obviously likes people and wants to be liked. He wants to say a few words to each one so that this signing process will sort of an interaction between friends and not be the impersonal thing such occasions can be.

When he meets them outside, this reporter will tell Rick and Sheldon that Louganis is indeed impressive, not as a celebrity, but as a genuinely decent, down-to-earth human being, the kind you'd like to invite into your


From Milwaukee, Louganis will go on to Minneapolis. Soon he will be home.


Make A Statement Walk for AIDS Awareness at UW-Oshkosh



Like most books or plays, the plot is simply put. There is a Jewish father (Marvin) who, as he sings, "wants it all." What he means by 'all" is the love of his wife, his son and his Gay lover. Right.

But in the end, he does get it all. It's a struggle of first-class dimensions, but he does get it. I don't know how many men and women I've talked with who would envy him.

Falsettos has been called "briskly paced," and so it is-at least, in part. I have to say that there were spots when the music dragged somewhat. But that is quickly obscured by some tear-jerking numbers that go right to the core-if you know what I mean.

I found the costumes and scenery to be very attractive, not overpowering, not dazzling, I don't think, but certainly well done

The cast is generally strong. Led by Tony Clements as the Gay man, David Pevsner as the older man and Wendy Baila as his wife, Trina, they are in command of their production and cross the footlights in a way that is both effective and subtle.

I must admit not being "overwhelmed" by Neal Mayers' portrayal of the psychiatristwho becomes Trina's second husband. He's too stiff, too mannered, disappointing to say the least.

In the end, as Marvin's lover dies of AIDS and Marvin and his ex are there, finally, for one another, my date and I cried then, and cried in each other's arms later.

The Skylight Opera's production of Falsettos, though it has some weak spots, is a show every Lesbian and Gay man should see. You will be moved by it, touched by it, and, perhaps, made to see yourself in it. I would recommend it on an existential level-or any





'Antonia's Line' is a Fascinating Little Film **About the Strangest People on the Planet**

Glenn often finds himself taken to many films that he has never heard of simply on the basis of a vague (and inevitably oh-so fleeting) promise like "There'll be an endless parade of

Well, never let it be said that Glenn Bishop looked down on any major motion picture that features an endless parade of naked men.

Such was the situation with Antonia's Line. a film that is one of the five nominees for the Best Foreign Film Oscar but one which, quite sadly, cannot boast an endless parade of naked

But, as Glenn's friend was heard to remark, "It's not the quantity of butt, it's the quality of butt." Glenn is sure that these are words to live

Nevertheless Glenn was most pleasantly surprised when as Antonia's Line began to unfold, there developed a strong and positively depicted Lesbian element.

The basic story line of Antonia's Line is deceptively simple. Antonia, the film's title character is an elderly woman who upon waking senses that she will not see another morning. This being so, she is determined to bring her large, extended family together, one last time.

Cinematically, writer/director Marleen Gorris has strung together a series of flashback episodes, tracing Antonia's life, beginning with the time just as the Second World War has ended and Antonia has returned to her small village to bring up her adolescent daughter.

Although a native of the small, close-knit rustic community, Antonia ruffles feathers galore with her strong-minded, independent thinking ways. She is absolutely adamant to live her life as she sees fit.

When the neighbor Bas (Jan Decleir), a widower who lives nearby offers to marry Antonia, she can hardly suppress a giggle as she inquires why she would want to do such a foolish thing. She offers him friendship and Farmer Bas is wise enough a man to accept.

Years pass. Antonia's daughter Danielle, an independent chip off the old block decides that she would like a child (a daughter, go figure) but nothing so unnecessary as a husband. Like mother, like daughter.

With Antonia's blessing and aid, Danielle scours the big city looking not for Mr. Right but Mr. Right-away. In a veritable heart-beat

GALA Choruses to Hold International Convention in Tampa in July

Tampa, FL-After years of planning pocked with protests, Gay and Lesbian organizers got the go-ahead for a parade in downtown Tampa to kick off a weeklong international Lesbian and Gay choral festival.

Approval drew complaints from Right Wing opponents who warned it was a dangerous precedent for the city and could bring vulgar public displays.

Several hundred callers jammed the city switchboard to protest the City Council's unanimous vote Thursday, approving a July 7 parade permit for the International Gay and Lesbian Association of Choruses Festival V.

A City Hall spokesman said that the "vast majority" of the calls were from people best identified as "religious extremists" who did not live in the Tampa area.

A spokesman said the event could draw 10,000 marchers.

They did the legal thing and approved it," Mark Puig, head of the Tampa Bay Gay Men's Chorus and a festival organizer, said Friday, March 22nd. "We've been working on this festival since 1991 and at every turning point we were holding our breath that the festival would not be moved.'

The quadrennial music festival, scheduled July 6-14, will feature 90 choral groups-about 5,000 to 6,000 singers-- from North

From hotel bookings, tourism officials said it could be one of the largest conventions in Tampa--especially during summer which is not peak season. One-fifth of Tampa's 12,000

local convention and visitor's bureau.

Sixteen speakers opposed the request to close streets downtown for a Gay pride parade. Two spoke in favor at the council

'I think this is a dangerous precedent to set for the city," said David Caton, state director of the American Family Association, a Far Right Wing group. 'This is not an im-

This is not an issue of Gay versus straight," Caton insisted. Instead, he said, the parade permit amounts to licensing or promoting a particular lifestyle and sexual

Gay-Themed Movies Now Among Filmdom's

Caton's wife, Rachel, said Gay parades elsewhere have involved nudity, extravagant costumes and questionable behavior. "It's a parade to promote a lifestyle of destruction that God doesn't like.

Asked what kind of entertainment the deity did like, Caton did not respond.

Council members said they had no legal basis to deny the request.

Councilman Scott Paine said people have a

right to assemble and speak, even if what they say is unpopular.

Supporters called the fears baseless and said they speak to ignorance.

Marchers will start and end at the Tampa Convention Center, where poet Maya Angelou is to keynote the event.

Tampa has hosted other concerts by Gay choruses, but not on this scale. Since starting in New York in 1983, GALA's festival has grown from 12 choruses with 1,000 members to more than 100 choruses with some 4,500

I am looking at very rough numbers, (but) at any one time we'll have about 10,000 people in town," said Jim Clark, executive director of the convention and visitors bureau.

The festival nearly snubbed Tampa because of controversies over a sexual orientation

GALA initially considered other locations when Tampa voters in 1992 repealed the city's amendment to its human rights ordinance banning discrimination based on sexual orientation

The city reinstated the law in October 1993 after the courts determined 462 signatures that forced the vote were invalid because the signatories did not live in Tampa.

Hillsborough County Commissioners repealed a similar county ordinance in May 1995. It caused festival officials to cancel contracts with hotels outside the city.

Puig said a project called "Buycott," helped keep the music festival. It's a booklet of businesses that ban discrimination based on sexual orientation. Conference-goers will be given copies of the booklet.

Delegates will only buy where they are wanted," Puig said.

Gay producer Howard Rosenman, who participated in a panel discussion at the Palm Springs festival about Gay filmmakers, said the real triumph will be when a major studio film about a detective tracking a murderer portrays the detective as being Gay. "And that is around the corner," he says, predicting the studio will have Gay divisions "in four

One Lesbian manager says a New York bank wants to invest in Gay-themed movies: The bank's research shows they are the safest

Several producers, agents and managers say the growing number of Gay films is the logical outgrowth of one of Hollywood's closest-knit

Frustrated by government inaction against AIDS, Hollywood in the 1980s formed a powerful fund raising and lobbying effort. The largely Gay activists didn't sever relationships when the topic wasn't AIDS: They banded together socially and professionally. That network is now the fulcrum of the lever of Gay and lesbian films.

The audience for Gay and Lesbian films, while not huge, is reliable. Whether it's The Incredibly True Adventures of Two Girls in Love or Jeffrey, Gay people show up. A few films--Longtime Companion among them-can cross over to a larger segment of movie-

The Adventures of Priscilla, Queen of the Desert in 1994 and last year's To Wong Foo, Thanks For Everything! Julie Newmar did reasonable business, although several critics say they were little more than fun excuses to put straight actors in drag.

Clearly, for all the progress there is still much ground to cover.

"You don't see it like this very often," laments director Gorris of her film's depiction of a Gay couple. "In the whole, mainstream

films are about heterosexual relationships.' It's still much easier for a straight actor to play a Gay role than for a Gay actor to play a straight part-let alone come out of the closet.

Actor Michael Kearns, a former leading

man on television, scarcely worked since he said he was HIV-positive. Ian McKellen (Richard III) is one of the few openly Gay actors working steadily.

The new Sandra Bullock film Two if by Sea is sprinkled with anti-Gay jokes, the Father of the Bride films (produced, astonishingly, by Rosenman) hold a swishing wedding coordinator up to comic ridicule and a new television movie version of the novel Bastard Out of Carolina' has been rewritten to expunge the underlying Lesbian themes.

There were the nervous laughter and comments at Antonia's Line, too. But the audience showed up-and cheered at the end.

If such a movie can play in Palm Springs, it can play anywhere.



Palm Springs, CA-The two young women on the movie screen in this retiree-laden desert resort weren't simply close friends. The Antonia's Line couple were Lesbians, and there

they were 40 feet tall-naked and making love. "Enough already!" came the audible groan from one elderly woman in the theater as the frank but hardly explicit scene unfolded. And yet when the Dutch film concluded, the capacity audience at the Palm Springs International Film Festival applauded vigorously.

Antonia's Line, opening in New York and Los Angeles theaters on February 2nd is a fascinating preview of a new wave of movies featuring matter-of-fact Gay and Lesbian story lines. Off-putting for some, these movies are nonetheless proving very popular, and, as reported in Light in the last issue, quickly have become one of the safest financial bets in

Holland's official submission for Academy Award foreign film consideration, Antonia's Line is a movie about one woman's multigenerational family. The Lesbian couple-Antonia's daughter and a schoolteacher--is one of many special relationships the movie show-

In both spirit and execution, Antonia's Line echoes literally dozens of upcoming movies.

"What this movie is saying is, 'This is what these people do--it's no big deal,' '' says the film's Lesbian director, Marleen Gorris. 'It's a fairy tale: Wouldn't it be nice if we all left each other in peace?'

The two-week Palm Springs festival, among the world's fastest-growing with more than 140 movies, is the springboard for several films with prominent Gay and Lesbian characters. The prestigious Sundance Film Festival, starting Friday in Park City, Utah, has an even higher concentration of Gay- and Les-

bian-oriented works. Most of the Gay-themed movies at both festivals are either foreign films or independent movies made outside the Hollywood studio system. But the major studios are actively developing an array of film projects with strong Gay and Lesbian elements, and more prominent straight actors are playing Gay parts.

One top producer even predicts the major studios will have separate Gay movie divisions

by the end of the decade.

This new surge of films departs dramatically from many recent movies in two distinct ways: They are honest and candid, and Gayness is simply part of the characters' lives rather than the underlying plot device.

Besides colored eggs, chocolate bunnies and lilies, you know what Easter means. The TV stations will haul out The Ten Commandments—again! Just like the Easter bonnets, that same film makes it's appearance every Easter Sunday. Why? It's a great film for Passover, but why Easter? It has nothing to do with the New Testament, much less the life or teaching of Christ. There are so many other, and better, Biblical epics to choose from.

My first choice would be the silent (1927) version of The King of Kings, which is one of the most beautiful films ever made. It has been restored so that the Christmas, Easter and Resurrection sequences are now shown in their original two-color technicolor beauty.

I think that part of the beauty of the film is that you never hear the Christus speak. Therefore, you can imagine his speaking voice as you would think Our Lord speaks—and not that of some famous actor.

(I remember sitting through the entire film of The Big Fisherman thinking, "I never knew God sounded just like Walter Pidgeon!")

It has been said that the silent version of King of Kings has been seen by more people than any other film in motion picture history. After its initial run and success, Cecil B. DeMille gave the rights to the Churches of America organization. Under their banner, any church, any denomination in America, could use the film for exhibition or study.

Therefore, for years almost every congregation saw the film in some form or other. Because the film was in the Public Domain, so to speak, it was shown almost ever Easter on TV stations around the country.

If you have seen it, I know you'll enjoy it again after all these years. If you have not seen it, I highly recommend it.

Of the more contemporary epics, The Robe (1954) is by far the best. After some 40 years, it still remains one of the best epics Hollywood ever made.

Based on the celebrated book by Lloyd C. Douglas, it has a spectacular screenplay by Philip Dunne. Most epics rely on superior sets and effects—and casts of thousands. The Robe is the one exception. A wonderful original score by Alfred Newman adds an emotional impact to the film.

The cast is headed by Richard Burton, Jean Simmons, Victor Mature (in an outstanding and best performance of his career), Michael Rennie, Richard Boone with Jay Robinson as the Emperor Caligula.

Forget about the film's sequel, Demetrius and the Gladiators. It is not worth the \$3 rental fee, this in spite of the presence of the ever talented Susan Hayward.

The Robe also brings us to the monthly trivia question. Which major star was the movie rights to The Robe purchased for and was to be the star in, this, the first film released in Cinemascope?

In the 1950s, when attendance at the movies dropped off drastically, Hollywood thought it could reclaim many of its viewers with Biblical epics. After all, they were something television could not compete with at the time.

Soon Hollywood was turning out an epic in what seemed like once a month. Each one had more stars, more spectacles, more hordes of extras and all in Cinemascope and stereophonic sound.

Quo Vadis? (1951) still remains one of the best. It is the film that made Robert Taylor a

God Doesn't Like Naked People, Especially in Plays, Preacher Says

Charlotte, NC--The Charlotte production of a play chronicling AIDS and homosexuality in New York featured bells, whistles, protesters, police, TV cameras and a drag queen--and that was outside the auditorium.

Inside, local actor Alan Poindexter stood fully nude on stage for seven seconds—and he wasn't arrested.

A judge signed a temporary restraining order Wednesday, March 20th, that allowed the production of the Pulitzer Prize-winning Angels in America to be staged as scheduled, despite the nude scene.

Still, supporters and opponents of the play marched outside the North Carolina Blumenthal Performing Arts Center on opening night.

The play had been performed in Greensboro and Durham without incident. But critics in Charlotte had threatened to invoke an indecent-exposure statute because of the nudity during a hospital examination scene.

Attorneys for the Charlotte Repertory Theater were able to blunt the threat at the last minute by obtaining a restraining order from Mecklenburg County Superior Court Judge Marvin Gray.

"The play is an artistic presentation," Gray wrote, citing U.S. Supreme Court rulings that nudity in an artistic setting is protected by the First Amendment. "Nudity ... in the play appears to constitute artistic expression."

The restraining order expires in 10 days.

The order prevents interference from Charlotte-Mecklenburg police, the district

attorney, the sheriff, state alcohol commissioners and others, including the Performing Arts Center itself, which is Charlotte Repertory's landlord and whose threats triggered Wednesday's lawsuit.

The Performing Arts Center said it would not allow the play to go on unless the theater promised not to violate the state's indecentexposure law or unless it obtained a court order banning authorities from enforcing the law.

"I cannot tell you what a miracle those guys have pulled off in a day," Keith Martin, the theater's managing director, said of its lawyers. "We didn't think it was possible."

Attorneys for the theater plan to ask Gray for a preliminary injunction that would protect further performances of the play, which runs through April 26.

An agent for the play's New York author, Tony Kushner, had said removing the nude scene could have violated federal copyright laws.

Kushner plans to be in Charlotte on Friday and Saturday for an AIDS benefit and a speech.

The Rev. Joe Chambers, who sparked the controversy earlier in the week with a news conference condemning the play, said the fight was not over.

"There's been an incredible community debate on moral issues," he said. "We're Christian people here and Christians don't go around naked. God isn't naked and He doesn't like to see naked people."

major star again. The burning of Rome is superbly done, but does not take over the story.

Filmed entirely in Rome, the sets are some of the most beautifully done and the cinematography is of constant high caliber.

Besides Taylor, the cast includes Deborah Kerr, Leo Genn, Finlay Currie and Peter Ustinov—whose outstanding performance as Nero made him a star and gave him a place in Hollywood history.

For some reason, 20th Century Fox seemed to make the most realistic epics. Their films depended more on the story and stars' performance than glitz. One of their truly superior epics was **David and Bathsheba** with a performance to match her beauty. Her costumes were about as authentic as Hollywood can get for Biblical epics, unlike the costumes that Lana Turner wore in MGM's ridiculous **The Prodigal**.

Again, Alfred Newman's score is a big plus, especially in the moving sequence when Peck recites David's most famous psalm, "The Lord is My Shepherd."

A stunning flashback tells the story of David and Goliath. Again, character actor, Raymond Massey almost steals the show as Nathan, the prophet of doom.

Surely one of the most popular and successful epics of all time is **Ben Hur**—or should I say, "Ben-Person" to be politically correct?

Again I think I must recommend the silent version filmed in 1926. It is the most beautiful and probably the best silent film ever made. It is so superior to the "talkie" remake made in 1959.

Messala (Francis X. Bushman in the silent and Stephen Boyd in the talkie) does not get killed in the chariot race in the silent version. He becomes a cripple and lives to continue to dog Ben Hur.

The religious aspect of the novel and Hur's

devotion to Christ is far more believable and moving in the 1926 version.

One of the most touching scenes you'll ever see is when Hur's mother and sister return from the colony of lepers. They find Ben-Hur asleep on a bench outside their old home. His sister crawls to him and kisses the sole of his boot so as not to infect him with her disease and then she walks away without ever awakening him to talking to him.

The famous chariot race is film making at its best. And, believe it or not, the silent version holds its own against the famous remake. Ramon Novarro makes a far more believable—and sensitive—Ben Hur than Charlton Heston even attempts.

I have always thought that Heston's Oscar for **Ben Hur** was one of the Academy's biggest mistakes. He is so wooden and gives very little compassion to the role. Novarro is far superior in every way.

The 1926 version cost an unprecidented \$4 million, while the 1959 version came in at \$15 million. In this case, you get more for less.

A new restored version of the silent film has become available on tape. It has many two color technicolor sequences within the film. Included are Hur's triumphant march into Rome, the opening Christmas story, and a moving crucifixion sequence.

So, this Easter pick out a title from one of the above selections, sit back and watch one of Hollywood's best epics unfold. All titles are available on video tape.

For many it was their first real campaign. They had stuffed and licked the envelopes, gone door to door on days when the wind chill dipped down to obscene levels.

They badgered their friends into helping. They contributed money they couldn't afford to give. Few could have given any more time or any additional financial help. How could we have lost?

for Best Actress and Newcomer Of The Year. 'The Rose" soundtrack album hit RIAA platinum and brought Midler a Grammy Award, her second, for the RIAA gold title track smash. That same night, she took home another Grammy Award \tilde{N} for "Blueberry Pie" from the children's compilation album, In Harmony: A Sesame Street Record.

Later that year, Midler opened on Broadway in Divine Madness (whose soundtrack album was released by Atlantic in 1980) and starred in the show's feature film adaptation, directed by Michael Ritchie.

In addition, she starred in the motion pic-ture Jinxed. While the film itself got a "thumbs down" by Roger Ebert, Midler's performance was acclaimed.

By this time, Midler's reputation as a multi-talented performer on stage, screen, television, and record was unrivaled.

With the publication of 1979's A View From A Broad, (pun intended) a European tour memoir, you could also add author to Midler's list of achievements, a talent which she furthered explored in her "children's" book, The Saga Of Baby Divine.

As Barbara Hershey said of her, "There's a train called Bette Midler. You either get on it or you get left behind." For Midler, it has been "full steam ahead."

After the release of her 1985 comedy album, "Mud Will be Flung Tonight!," Midler focused her energies on her movie career. The result was a string of films, including: Down And Out In Beverly Hills, Ruthless People, Outrageous Fortune, and Big Busi-

In 1988, Bette starred in Beaches, the first film to be released through her own All Girl Productions. The film's original soundtrack her first music release in six years-put Midler's recording career back on the fast

After Beaches, Bette began a virtually nonstop work schedule. Over the next two-and-ahalf years, she starred in the Touchstone films Stella and the Paul Mazursky-directed Scenes From A Mall. Other projects during this time included the HBO special, The Mondo Beyondo Show, plus voice work as the character Georgette in Disney's Dickensinspired animated feature, Gliver And Com-

In 1991, Midler reunited with director Mark Rydell for her starring role in For The Boys, the story of a USO entertainer. The role won Bette an Academy Award nomination and a Golden Globe Award, while Atlantic released the companion soundtrack re-

cording.
In 1993, Atlantic released Bette's RIAA gold greatest hits collection, "Experience the Divine," which included a previously unreleased live version of the Johnny Mercer & Harold Arlen classic "One For My Baby (And One More For The Road)."

Her moving performance of the standard as the final guest on Johnny Carson's NBC-TV

Tonight show farewell won her an Emmy Award.

On screen again, she starred in the Disney film Hocus Pocus. In December of that year, In more unexpected arenas, Midler recently made a guest voice-over appearance on Fox-TV's The Simpsons, guest-starred on this year's much-touted Seinfeld NBC-TV season finale, and even had her name posted as a litter removal sponsor on adopted stretches of the Long Island Expressway and Bronx River

As Battle Rages Over Internet Censorship, a Teen Speaks Out on Gay Issues On-Line

America Online (AOL) took some heavy media hits over the widely reported story involving a 14-year-old boy and an adult male he met through the online service. As a result, AOL's TOS (Terms Of Service) dept .-- also known as TOSAdvisor--began a crackdown on certain Member Rooms.

As a clarification, chat rooms on AOL consist of three types: Public, Member and Private. Public Rooms are as described, and explicit language of a sexual, "vulgar" or "bashing" nature is now allowed under TOS guidelines. AOL has volunteers called Guides who help keep order.

Member Rooms are created by AOL users who want to meet others, generally for "dating" and sexual reasons. More explicit language is tolerated in such rooms, since users specifically go looking for these rooms. Examples of Member Rooms are "Married

"Yng Men 4 Older Women," "Men 4 Men," "Bi F 4 Bi F," "Men's Locker Room," "Fantasies and Dreams" and so forth.

Guides can enter Member Rooms, but don't do so as much as they do Public Rooms. When AOL users want total privacy, they can create a Private Room where even Guides and TOS representatives cannot enter.

Because AOL came under pressure, TOS started removing rooms from the Member Rooms list with names such as "Yng M 4 Yng Such rooms are frequented by Gay, Lesbian and Bisexual teens and young adults, although older adults may also access the rooms too.

After complaints against TOS by a number of users--and a petition campaign launched by a teen AOL subscriber, and a request from me to TOS for an explanation, I received the following e-mail:

"To avoid giving the impression that we allow solicitation of minors online, we are very cautious in allowing room names

referencing youth. Anything that could possibly be construed as sexual is usually made 'Yng M 4 Yng M falls under this category. It is ambiguous in that 'M' could mean 'male', hence underage male.

You may create the room 'Yng Men 4 Yng Men', which specifically states that the occupants seek to meet adults. I hope this clears up our position on this." The letter was signed by Pete, Terms of Service Advisor, America Online.

NOTE: Following is an excerpt of e-mail from the person who circulated the petition on AOL. It speaks for itself. He wishes to remain anonymous, for obvious reasons.

In making any statement of position, I strongly believe that I echo the views of teenagers, both Gay, Bi, and straight.

I am soon to be a 17 year old male. I'm from down-state New York. I am a president of a prominent nationwide youth group and a former vice-president of an honor student's organization. I have a number of years experience in dealing with peer counseling and in active leadership roles.

I have never been a Gay rights activist. I am a teen activist and am involved currently with 3 organizations. I don't have time for a typical social life, because I am dedicated to my interests. While this has a number of low points (I can only be on AOL at midnight, and sometimes fall asleep while typing), it has many very lofty rewards that I enjoy. I have received certificates, awards, and many thank you cards in the last 3 years.

I am an honors student, and have a particular interest in education techniques, cognitive and behavioral psychology, and human sexuality. I have audited college classes on those topics for 2 years (at night!).

As a high school student, I am well aware of the discrimination that affects my generation. I have many Gay friends online as a result of my own exploration of sexual identity and have not settled on any singularity of at-

traction yet.
While I don't limit my online friends to any particular group, I identify with the struggle that fellow teens have in keeping a room open for discussion and FUN of relevant issues. If an issue so immediate as sexuality can be considered a relevant issue, then rooms should be available for it.

To state it simply: If it can be available for adults, why should there be a limit in what is available for teens? Don't even bother with the law, as it cannot be enforced in a domain where people won't give out more than their screen names to strangers.

What about the dumb kids who give out personal information? Well, don't worry about them; they are just as likely to drown in

A petition will demonstrate to AOL that there is an interest in it, by teens FOR TEENS. We are not stockholders. We are customers. AOL provides a computer and networking system....we use it. AOL gives ground rules for using it....we follow them. AOL requires payment We pay. Customers want something done and business doesn't re-

There are many admirable aspects of the system. What we want is the huge corporate entity to respond to its customers, as any other company must. All of us who use AOL have money at our disposal, and we use it

It seems highly hypocritical for an organization, for-profit especially, to discriminate against Gay teenage males simply for their age. Notice, we are not discussing the issue of homosexuality, per se, because it is obvious that AOL is a Gay-friendly employer and

It is hypocritical for a few reasons:

1) There already exists "teen chat" rooms. If the policy of AOL was to protect minors from untoward sexual advances from perverts/adults in those rooms, they would not

2) There already exists "Gay adult" rooms. There are "adult chat" areas. Now that we've established that there are teen rooms, adult rooms, and adult Gay rooms, the question we should think about is, "Why aren't there Gay teen rooms?"

3) Screen names make it impossible for adults and teens to tell each other apart. One method we use is discussion of relevant issues (including sex); those who are unable to relate to the discussion are "Pervs" who we know to

4) There are procedures for dealing with perverts, which most teens (in contrast with most of the adults we've encountered) are familiar with. Flooding e-mail boxes of annoying perverts, IGNORE'ing them in chat rooms, and shutting off our Instant Message'ing are all very effective methods. In addition, there already exist many corporate techniques of handling jerks, such as GuidePager" and TOS.

5) We are not defenseless, nor innocent. Most, though not all, of the teenage users of AOL have extensive "moderning/BBSing" experience. We are neither ignorant of the protection that AOL provides through screen names, or of how to handle an annoying per-

In essence, the issue is one of age discrimination for teenagers who do not need protection. Another user on AOL wrote: "a request has already been made to the GLCF (Gay Lesbian Community Forum) on AOL to have an adult-monitored teen room for outreach, networking and discussion.'

I don't wish to sound arrogant or resentful, but that is an adult-centered approach. It doesn't recognize the fact that most teenagers, sexually explorative or not, are uncomfortable by any adult presence.

with HHV-6 were identified in all ten of the lymph node biopsies. Lymph node biopsies from seven non-HIV infected individuals were also studied and were found to be free of HHV-6 infected cells.

Of central importance in the study by Drs. Knox and Carrigan was the fact that at the time the tissue samples obtained from the HIV infected patients, three-fourths of the patients had relatively intact immune systems.

Their helper T (CD4+) lymphocyte counts were greater than 200, the point at which the immune system is generally considered to be severely damaged.

Further, the detection of active HHV-6 infection in the lymph node of one of these patients was of special significance since the infection was present when her helper T lymphocyte count was still within normal range.

These observations make HHV-6 unique in that it is the only other infectious agent besides HIV that is present in active form in all patients throughout the entire course of HIV

infection and AIDS. All other non-HIV infections in these patients occur later in the course of HIV infection, usually after CD4+ lymphocyte counts

drop below 200. Also, no other proposed "cofactor" has been found in all HIV infected patients, and no other infectious agent has been demonstrated to be present when the CD4+ counts are still in normal range, making HHV-6 absolutely unique.

We believe this is an important advance in understanding how infection with HIV causes AIDS. It appears that HIV uses HHV-6 as an

instrument of destruction," Dr. Knox said.

Interestingly, the predominant form of HHV-6 present in the lymph node tissues was the rare A variant of the virus (HHV-6A). HHV-6A differs from its more common relative, HHV-6B, in that it is far more destructive of the cells that it infects. HHV-6A is rarely identified in normal individuals and in non-HIV infected populations of immunocompromised patients such as bone marrow transplant victims.

According to Dr. Knox, HHV-6A has numerous properties that may allow it to play a central role in AIDS. It cause the infected cells to produce chemicals that enhance the growth of HIV and it allows HIV to infect other forms of white blood cells that are ordinarily resistant to HIV. Also, HHV-6A and HIV synergistically destroy CD4+ and other forms of white blood cells.

The research of Drs. Knox and Carrigan also reveals an important new characteristic of HHV-6A that may greatly accelerate the progression of HIV infection to AIDS.

The researchers demonstrated that cells infected with HHV-6A produce a factor that can pull HIV out of its latent, silent state into full and active growth. While this "HIV activating component" (HAC) has only been partially characterized, it appears to be composed of fragments of cells destroyed by HHV-6A infection.

These findings, combined with earlier work from the laboratory of Drs. Knox and Carrigan showing that HIV enhances the growth of HHV-6, suggest that infection with HIV is necessary, but not sufficient for the development of AIDS and that the development of AIDS requires concurrent active infection with HHV-6A.

"If this hypothesis is true, then it is possible, and even likely, that the simultaneous administration of drugs capable of blocking HHV-6A and HIV replication early in the course of HIV infection may slow or even stop the progression of HIV infection to AIDS," Dr. Knox said.

The researchers would like to see followup with large scale studies to confirm these findings.

Honolulu--Efforts by the state Senate leadership to shelve a proposed constitutional amendment to ban same-sex marriages are meeting resistance from some members.

If that resistance rallies at least nine of the 25 Senate members who would be prepared to buck Senate President Norman Mizuguchi, they could force the issue to a vote by the full Senate. According to one dissident on the issue, that move is not yet a priority.

Although Mizuguchi referred the bill to the Senate Judiciary Committee as a matter of process, committee Chairman Rey Graulty says he has no plans to hold a hearing on it, despite an intensifying lobbying effort from religious groups supporting the bill.

The leadership of the Senate has spoken and indicated that as far as they are concerned the issue is dead, and I as the chair of Judiciary Committee abide by the decision of the Senate leadership on this issue," Graulty

"I think it is time to call it a day on samesex marriage and let the court decide what might be best and then to act accordingly after they have made their decision," he said.

Sen. Randall Iwase, who supports the constitutional amendment bill, called Graulty's decision "unfortunate.

Iwase said he's hoping there will be a full hearing on the House bill, a vote by the Judiciary Committee and then a vote in the full Senate in which each member can express their view. Any proposed constitutional amendment would be on November's general election ballot for voter ratification.

The constitutional amendment would be a means of letting Hawaii's people tell the state Supreme Court that it was wrong and misread the constitution in its 1993 ruling on same-sex marriages, Iwase said.

A trial on the issue of the state's compelling interest in denying same-sex marriages is scheduled to begin Aug. 1.

The Senate's position was a bill to establish domestic partnerships for Gay couples, giving

them the same rights and benefits of married couples. That bill remains dormant in the House which opted to let the voters decide.

Iwase complained that the Senate's Democratic leadership has abandoned the policy decision made in 1994 that the issue of samesex marriage involved a question of separation of powers and was something to be decided by the Legislature or a constitutional convention, not the courts.

In Kansas

The state does not recognize same-sex marriages as legal, and a majority of House members passed a bill on March 21st designed to make sure it never happens.

The bill, approved 87-38, would add to state law a declaration that same sex-marriages are ``contrary to the public policy of this state and void.

Kansas does not recognize same-sex marriages because its criminal code outlaws same-sex sex. However, some legislators, especially religious conservatives, are worried about a 1993 court decision in Hawaii.

Rep. Jan Pauls, (D-Hutchinson), sponsor of the ban on same-sex marriages, said she is concerned that same-sex couples could fly to Hawaii, get married, then return to Kansas and sue for the same legal standing as heterosexual married couples.

Pauls offered the ban as an amendment to a bill that would end the requirement that judges approve all underage marriages. Her amendment passed, 81-24.

The only legislator to speak against Pauls' amendment was liberal Rep. Sabrina Standifer, D-Wichita.

"I don't think this is an area where government needs to be involved," she said.

Conservatives gleefully called for a roll-call vote on the amendment. Many House members did not take the debate seriously. Some chuckled when a few of their colleagues pretended initially to abstain from voting, as if they had a conflict of interest.

In Colorado

Gov. Roy Romer indicated Tuesday, March 19th, he may veto a bill passed by the Legislature banning same-sex marriages in Colorado and said he favors recognizing same-sex unions, but not as traditional marriages.

If I choose to veto it, it will be because we need to take it in a more comprehensive way, and we need to do it and do it right,'

Romer said on the Mike Rosen Show on KOA radio.

Romer did not say when he would reach a decision. He has 10 days to sign it or veto it. If he does not act, it will take effect without his signature.

On Monday, March 25th, Romer vetoed the bill, saying it would bring discrimination against same-sex couples.

Romer said he strongly believes there should be statutory recognition of the different type of union" between same-sex couples that would distinguish it from traditional marriages between men and women.

He said this would give long-term same-sex partners access to one another on their deathbeds, for example. Since their relationships are unrecognized by current law, they now can be denied deathbed access by blood rela-

"Gay people ought to be treated like human beings,' Romer said.

The governor acknowledged that Colorado needs to take a position on same-sex marriages because otherwise a ruling by the Hawaii Supreme Court could take the issue out of Colorado's hands.

Supporters of the Colorado ban said that without it, Colorado would be forced to recognize marriages performed in Hawaii. They say the Constitution's Full Faith and Credit

Clause requires states to recognize marriages performed in other states.

Romer said Colorado needs to be able to protect itself in court from any litigation arising from the Hawaii decision, but that issue and recognition of same-sex unions should be addressed at the same time.

Romer said he would like to bring together legislators and citizens to discuss whether a 'partnering' category should be created in the statutes that would recognize long-term same-sex relationships.

We have three Gay couples in our church and what would you want us to do-ignore them as human beings and deny them human rights?" he asked.

In Idaho

Without comment, Gov. Phil Batt has signed a law forbidding legal recognition in Idaho of same-sex marriages that might be valid in another state.

The legislation skimmed through the 105member Legislature with just 10 dissenting votes and was among bills signed into law by the governor on Monday, March 18th

Sponsors argued that without action by the Legislature, if another state validates samesex marriages, Idaho would have to recognize them because of a state law granting approval to contracts and agreements which are legal in other states.

The new law, which went into effect as soon as the governor signed it, also bars legal recognition of any marriage entered into with intent of circumventing Idaho laws.

In Alaska

Same-sex marriages would be prohibited under proposed state legislation, with supporters saying it would preserve traditional families and opponents calling the measure discriminatory.

The bill was debated Monday, March 18th, in the Senate Health, Education and Social Services Committee, which introduced the measure last week. Most testimony at the hearing came from Gay men and Lesbians who said the measure would deprive them of the same rights granted to heterosexuals.

In practice, Alaska law already prohibits same-sex marriages. Supporters said the bill was introduced to make the law clearer and to preempt a pending court decision on same-sex marriages in Hawaii.

Susan Hargis, board chairman for the Southeast Alaska Gay and Lesbian Alliance, said she has made a lifetime commitment with

a woman she would like to legally wed.

I certainly don't want one, but if I went out and had a sex-change operation, I could get married," Hargis told the committee. That's bizarre.'

Sen. Loren Leman, a committee member, said he believes same-sex marriages undermine traditional families and social values.

The Rev. Howard Bess, a Baptist minister at the Church of the Covenant in Wasilla, supported the bill, saying he knows many Gay couples.

They are every bit as committed, every bit as monogamous, every bit as stable, every bit as wholesome as a heterosexual mar-Bess said.

State law does not specify that marriages must be only between a man and a woman, though the Alaska attorney general's office has said that courts probably would uphold only opposite-sex marriages the way the rules are now written.

Alaska is being sued by two men who were denied a marriage license in Anchorage last year, said assistant attorney general John Gaguine. Their claim is that prohibiting a same-sex marriage is unconstitutional, Gaguine said.

The bill would spell out that marriages could take place only between a man and woman. Leman said that would clarify state law and protect Alaska from a court ruling that might allow same-sex marriages in Ha-

That case has prompted efforts by Far Right Religionists to enact same-sex marriage bans in about 25 states to preempt the chance that Hawaii courts might allow two men or two women to wed. States typically recognize each other's statutes, meaning other states might have to acknowledge same-sex marriages that take place in Hawaii.

Hargis said she and her partner "would be on a plane tomorrow to Hawaii" if same-sex marriages were legal there.

Leman said the proposed legislation would prevent gay and lesbian couples in Alaska from wedding in Hawaii then returning home and seeking to have the marriage legally recognized here.

The measure also would help uphold legislation passed by the state House last month that would allow employers to deny health and retirement benefits to workers' unmarried domestic partners, Leman said. That bill was prompted by a lawsuit last year by two University of Alaska employees with same-sex partners.

With the Legislature's Republican majority at odds with Democrats and Gov. Tony Knowles on balancing the state budget, Democrats said the same-sex marriage bill was wasting time.



It is "that party". "The party". You see yourself among dozens of drunken young people, many of whom you call to this day your "friends".

There you are, all done up for the occasion in torn jeans and grungy clothing. You see yourself in those "clothes", dispensing an endless amount of energy on that dance floor. You are an angry young person, and you will do anything for hours that will vent this



Wisconsin Teens Reflect National Experience in Their High School Lives

Milwaukee-When Victoria P. was 15, she fell in love with her best friend.

But the friendship Victoria felt was something deeper--and scarier--than she expected,

she said.
Victoria realized she was a Lesbian.

Since then, the Milwaukee teen has spent the past two years trying to come to grips with her sexuality, in part through educating her family, teachers and peers about her experience.

Victoria and hundreds of other Lesbian and Gay teens in Wisconsin and throughout the nation endure not only inner turmoil, but harassment, ridicule and verbal and physical abuse from peers, teachers, administrators and family as well.

'I've been a Lesbian since I was conceived. I just kind of realized it when I was 15,'' Victoria said. 'I've finally started to be able to be comfortable with my life.''

The best estimates are that between 5 percent and 10 percent of the total teen population in the United States is Gay, Lesbian or Bisexual, although many hide their sexual orientation out of fear or confusion, experts say.

Government studies show that teens confused by their sexuality are more likely to abuse drugs or alcohol, try suicide, get bad grades or drop out of school.

Many leave home to take to the streets, living as best they can. Any of the larger cities in the U.S., has unnumbered Gay teens who have turned to prostitution, social scientists say.

But, at least for some, things may be becoming a little easier.

Because of strong support networks being developed, more teens today are `coming out' about their about their sexual orienta-

Many schools now have support groups for Lesbian and Gay students, and some schools, few in number, have even allowed students to take their same-sex partner to dances and other school-sponsored affairs.

Coming out is healthier for homosexuals,

teens said, but along with this freedom comes a lot of backlash.

Keith S.a Catholic high school student in

Wisconsin, says he fought through rejection from his family, his church and his school.

When Keith was in seventh grade, he learned through a Bible study class about Sodom and Gomorrah to associate the word `homosexual' with the way he'd been feeling.

ing.
'I thought, 'Great--I have a name for who I am now,''' Keith said. 'I thought, 'I don't want to be disgusting. I don't want to be a faggot.'''

Through a school counselor, he started attending support group meetings and read a lot about homosexuality. He said that his mother found out a few months ago when she discovered some Gay reading material in Keith's room.

Keith said his mother took him to see Catholic nuns and priests, all of whom accepted him despite his homosexuality except one who declared, "If he had gone to a Catholic school, this never would have hap-

School officials also did not know how to react to the news that their starring oboist and student council chairman was Gay, Keith recalled. He has been taunted and pushed around by some students.

Milwaukee teen Alissa came out to her parents when she was 14, after suicide attempts and bouts with depression because she felt so isolated and confused.

Alissa's mother at first reacted angrily, saying Lesbianism was "disgusting" and that these feelings were just a phase Alissa was going through.

Three years later, Alissa says, her mother

"You have to realize your parents don't hate you, they don't think you're evil. It's just that they're afraid you're not going to have a normal life," she said. "That's what parents want for their kids--to have a normal life."
