WARC to Initiate Salk AIDS Vaccine Trials in Wisconsin

Milwaukee-The Wisconsin AIDS Research Consortium (WARC) is the only test site in Wisconsin for the RemuneTM

vaccine trial.

Remune™, developed by the late Dr.

Jonas Salk, pioneer of the polio vaccine, is a cutting-edge therapy designed to slow the progression of HIV. The goal of this new therapy is to delay or prevent the progression of HIV infection to AIDS by stimulating CD4 activity to attack HIV

and thus keep the virus under control.

Out of the 150 selected testing sites in the nation, WARC is the only one with multiple satellites. Satellite sites are lo-cated in Eau Claire, Green Bay, Kenosha/Racine, Madison and several in Milwaukee.

These satellites have helped WARC obtain its original goal of 50 people participating in the RemuneTM trial. However, since the goal was obtained faster than expected, WARC expanded its contract to include 50 more individuals. The new goal is to have all 100 positions filled by March 31, 1997.

The Remune trial is a three year intended study through the Immune Response Corporation, a biopharmaceutical company engaged in the development of an advanced HIV therapy.

Two other drug trials occurring WARC is also screening HIV+ individuals for participation in two expanded access open label compassionate use studies using the Remune vaccine.

To participate in these, individuals must have CD4 counts below 300 or above



The forum in this case is the system for subsidizing student-sponsored organizations that engage in First Amendment activity at the university.

UW's system of fostering diverse groups and expression at the school is replicated at the vast majority of public universities across the country, making the case, Southworth v. Grebe, significant for students' First Amendment rights nationwide.

Catholics Ask Church to Change

New York, NY-AP-As Cardinal John O'Connor delivered his sermon inside St. Patrick's Cathedral Sunday, February 16th dissident Catholics gathered outside and called on the church to relax its stance on the ordination of women, celibacy for clergy and

Liberal Roman Catholics in New York and nationwide called on the church's leader-ship to catch up with its members and change the way the church is run.

"Jesus was open to dialogue with anyone, including people with whom he vehemently disagreed," said Sister Maureen Fiedler, national coordinator of the Fairfax, Virginia.-based We Are Church.

At Philadelphia's Cathedral Basilica of St. Peter and Paul, one older man hurried past

the activists, telling them to "shut up with all your crap here.

Members of We Are Church want the Vatican to approve the ordination of women, drop its requirement that priests remain celibate and recognize the human rights of Gays and Lesbians.

I don't see one thing about it that's radical," said Margaret Dubbins, of Los Angeles,

who signed the petition on her way into Mass at St. Patrick's. "The majority of American Catholics are moving ahead regardless of what the Pope says. ... There's a silent majority within the church that is doing this anyway."

Presbyterians Debate Homosexuality

Raleigh, NC-AP-Presbyterian church leaders across eastern North Carolina rejected a policy Saturday, February 15th, that would have barred ministers and church officers from having sex outside of marriage

Church leaders voted 172-140 against an amendment to the denomination's constitution that would require ministers, elders and deacons to be faithful in marriage or chaste

Although the amendment does not mention the word "homosexual," many attending the meeting saw the proposal as an attempt to deny ordination to Gays and Lesbians

who are sexually active but cannot legally marry.

The vote, taken by leaders of 136 Presbyterian congregations stretching from Orange County to the coast, will be tallied with those of other regions this June when the Presbyterian Church (U.S.A.) has its annual meeting.

Jewish Views on Homosexuality

Seattle, WA-AP- The four main Jewish movements differ significantly in their perspective on homosexuality

The nation's 400,000 Orthodox Jews consider homosexual behavior an abomination

forbidden by the Torah.

The Conservative movement, followed by about 2 million U.S. Jews, holds that people are entitled to their own sexuality. There are no openly Gay or Lesbian conservative

Reform Judaism, representing about 1.4 million U.S. Jews, has accepted Gay and Lesbian rabbis since 1990. Last year, its Central Conference of American Rabbis voted to support same-sex civil marriages and to oppose state government efforts to ban such unions. Many reform rabbis perform commitment ceremonies.

The most liberal group, known as Reconstructionists, is also one of the smallest at 40,000. Reconstructionists don't consider homosexuality an issue, saying equality, in every aspect, is part of its main philosophy.

Court Upholds "Don't Ask, Don't Tell" Policy

San Francisco, CA-AP-A federal appeals court has upheld the military's don't ask, don't tell" policy on Gays in the military, rejecting a discharged sailor's claim that the policy is unconstitutional.

In upholding the discharge of Navy Petty Officer Mark Philips, the 9th U.S. Circuit Court of Appeals became the first appellate court to rule on the portion of the policy

that requires dismissal for homosexual conduct.

The 2-1 ruling came Friday, February 15th.

Judge Pamela Rymer ruled that those reasons are not irrational or based merely on prejudice. She also cited the courts' traditional deference to military judgment.

In a dissent, Judge Betty Fletcher said the policy of discharging homosexuals, but not heterosexuals, for private off-duty sexual conduct is discrimination based entirely on prejudice against homosexuals.

Gay men and Lesbians are no less able and no more prone to misconduct than their heterosexual counterparts," Fletcher said. `Even in the military context, an entire class may not be singled out for disfavored treatment because of animosities towards that

Pro-Life Gays Call for Parade Consistency

New York, NY—Phillip Arcidi, President of the Pro-Life Alliance of Gays and Lesbians (PLAGAL), on February 20th, urged the Ancient Order of Hibernians (AOH) to be consistent in their exclusionary policy and bar pro-choice leaders from their parade. Since Gays and Lesbians are excluded from the New York St. Patrick's Day Parade because their lives do not conform to Roman Catholic Church teachings, PLAGAL called for the exclusion of pro-choice politicians because they do not conform to those same

In a letter addressed to Edward J. Wallace, President of AOH, Arcidi said, "It is disappointing to see the Ancient Order of Hibernians abandon its self-proclaimed consistency with Roman Catholic teachings only when those who cannot speak for them-selves—the unborn—suffer the consequences."

Church Agency Names Specialist for Gay Concerns Cleveland, OH-The Rev. Dr. William R. Johnson is the United Church of Christ's (UCC), first national staff minister for Lesbian and Gay concerns. The church has added "Lesbian, Gay, Bisexual and genderal minority concerns" to Johnson's portfolio. Based in Cleveland, he has been the Homeland Board's HIV/AIDS ministries specialist since 1990 and will continue in that capacity. The Homeland Board is the U.S. mission arm of the 1.5 million member church. The UCC's General Synod and the church's national agencies have long supported equal rights for Gays and Lesbians, both in society

Johnson, ordained in 1972 by the UCC's Golden Gate Association in the San Francisco Bay area, is believed to be the first openly Gay man ever ordained to the Christian

Bishop to Celebrate Mass for Gays

Rochester, NY-AP- The spiritual leader of Rochester's Roman Catholics says he can uphold the church's teachings on homosexuality while offering Gays and Lesbians a

chance to participate in a special service.

Bishop Matthew Clark, head of the 400,000-member Diocese of Rochester, plans to offer a Mass for Gay and Lesbian Catholics on March 1 at Sacred Heart Cathedral, the Rochester Democrat and Chronicle reported February 19

Clark told the newspaper that he hopes to make Gays and Lesbians feel welcome in the church, and said Catholics should not equate offering Mass for homosexuals with endorsing homosexuality.

The Mass for Gays and Lesbians will be a relatively rare one. Only a handful of the 150 dioceses in the United States have held such liturgies, and only about 30 have any form of outreach ministry for Gays and Lesbians, church officials said.

While the church recognizes homosexuality as an orientation, it describes homosexual activity as a sin.

Gay Marine Gets Honorable Discharge
Washington, DC-AP-A Marine who remained in active service for four years after declaring on national television that he is Gay said he was relieved to finally be retiring but he hoped the military learned from his experience.

Elzie filed a lawsuit against the military after the Marines withdrew approval for his early retirement and moved to discharge him in September 1993 after he announced he is Gay on ABC's "World News Tonight."

Elzie's Jan. 29, 1993, announcement came the same day President Clinton agreed to the 'don't ask, don't tell" policy, which bars inquiry into sexual orientation but allows the discharge of those who declare their homosexuality or engage in homosexual acts.

Elzie, 34, was temporarily put on standby reserve, but a federal judge ordered that he be put back on active duty in November 1993.

The lawsuit, filed in September 1993 in U.S. District Court in Washington, D.C., requested a declaration that Elzie's discharge and deprivations of retirement were unconstitutional and that the Marines restore him to the retirement program, his attorney, Christopher Sipes, said.

The honorable discharge ends the litigation, Sipes said.

Gingrich Discusses Life as an Accidental Activist

Morgantown, WVA-AP-Growing up as the only liberal in the Gingrich clan, Candace Gingrich used to bite her tongue when the talk turned to politics at holiday dinners, she said.

Those days ended for the Lesbian half-sister of House Speaker Newt Gingrich after a

reporter posed the question: Are you Gay?
Gingrich, author of The Accidental Activist, said she likely would have been involved in issues important to homosexuals even if she was not the House speaker's sis-

Gingrich said she does not want anything for homosexuals that other Americans do not already enjoy

As for her brother, Gingrich, 30, said they have never been close because he is 23 years older. Although she disagrees with her conservative brother on many issues, she said that

conservatives can be understanding. University Studies Domestic Partner Plan

Colorado Springs, CO-AP-University of Colorado regents said they need more information before drafting a proposal on extending health insurance to the partners of

Several regents, though, voiced support for the idea Wednesday, February 19th, during a meeting of their Academic Planning Committee.

CU's faculty council has urged the regents to consider offering health insurance to the live-in partners of Gay and Lesbian employees. The council, which represents nearly 3,500 professors among CU's four campuses, says the university is losing valuable employees to schools and organizations that provide the benefits.

The university is the first state agency to study giving health benefits to same-sex

Administrators estimate that less than 1 percent of the 20,000 faculty and staff members, or fewer than 200 people, would take advantage of the offer.

Anti-Gay Group Denied Recognition

State College, PA-AP-A Penn State University student group says it denied an anti-Gay rights group official recognition because doing so would have nurtured a climate of hate against Gays and Lesbians.

The student Supreme Court also denied it had violated the First Amendment rights of the group, known as STRAIGHT, saying the organization still could promote its views on campus, as it did Tuesday during an afternoon rally against the decision.

In the written decision, the court said: "Homosexuality is a lifestyle that is accepted by a great number of people in the Penn State community, and the fact that STRAIGHT says its purpose is to 'provide students with an official and formal organization in which they can express their view regarding the refusal to accept or support homosexuality. 'is year troubling." ality...' is very troubling.

Darin Loccarini, president of STRAIGHT, said he would appeal the decision, calling it a double standard. STRAIGHT--Students Reinforcing Adherence in General Heterosexual Tradition--is a political organization that wants to prevent Gays and Lesbians from winning university-sanctioned privileges, Loccarini said.

ample of a group meriting de-funding, Shabaz singled out the Lesbian, Gay and Bisexual Campus Center, describing its function in politically charged terms by saying it is 'primarily concerned with ad-vancing the homosexual agenda and pro-moting pro-homosexual political activ-

Noting the judge's choice of words, Logue said, "The term "homosexual agenda" is a rhetorical device that is often used by Gay civil rights opponents to denigrate claims to equal treatment and respect. It is unfortunate that the judge would characterize the Center's fine work in these terms.

Just prior to issuing this ruling, Judge Shabaz presided over Lambda's trial for Jamie Nabozny, the Wisconsin Gay man who received nearly \$1 million settlement after a jury found school officials liable for the anti-Gay abuse he suffered while a student. 

TO THE EDITOR,

It is said that those who don't learn history are doomed to repeat it. So it seems today, when Gays are persecuted as if nothing had been learned from the Nazi persecution of the Jews.

Comparing modern extremist groups with Hitler's Nazis is frowned on because it evokes images of gas chambers and ovens at death camps. But the early Nazis didn't fit that terrible picture. The average Nazi of pre-war Germany was an honest, lawabiding citizen struggling to support a wife and children. He saw his country threatened internally by moral decay and externally by Soviet Commu-

Jews provided convenient scapegoats for Germany's problems. Some were Communist leaders, and some were involved in financial scandals which propagandists exploited to blame Germany's economic woes on Jews as a group. The average German wasn't rabidly anti-Semitic, but incessant demonizing propaganda gradually turned public opinion against the Jews. Tell a lie often enough and people tend to believe it.

Nazi anti-Semitic propaganda is echoed in what today's Christian Fundamentalists circulate against Gays. A Nazi film, "The Eternal Jew," showed footage of actual Jews edited to present hateful images. A Fundamentalist church in California produces videos like "The Gay Agenda" that uses selective editing to give a false picture of the GLBT commu-

The Nazis pictured Jews as a threat to health, claiming ghettoes were needed to control typhus epidemics. Uprooted by war and living in crowded conditions, some Jews did have high rates of dis-

One genre of Nazi anti-Semitic propaganda was the Jewish sex maniac. Today, Gay men are painted as child molesters. Even the mainstream press uses the frightening term "pedophile" in cases where it doesn't apply.

The Nazis classified Gays with Jews as menaces to society, and the groups were often mentioned together in propaganda. German Gays suffered less than Jews because they were harder to find, and because homosexuality was thought to be a choice that could be changed, even if by medical experiments or torture. Being Jewish was considered genetic and 'correctable" only by death.

Today, Fundamentalists advocating death for homosexuals are a small minority, but a larger group admits it wants to force Gays "back into the closet," effectively ghettoizing them.

One would hope Fundamentalists could learn from the Nazi campaign against the Jews, so that history doesn't repeat itself, but there seems to be no end in sight to the stream of scurrilous anti-Gay propaganda emanating from Right Wing religious

Decent Fundamentalists will object to comparison with the Nazis, but they should reflect on the damage they do in circulating hate propaganda. Even respectable churches have been duped into distributing hate literature cloaked in scientific-sounding jargon and filled with dubious statistics.

William Bell Riley founded the modern Fundamentalist movement and educated many Midwest Protestant ministers. He also distributed anti-Semitic literature and wrote editorials against Jews in the publications of his Bible school. He was an ardent supporter of Hitler right up to the start of World War II.

Since the great founder of the Fundamentalist movement didn't realize the menace of the anti-Semitic propaganda he circulated, it's not surprising

Man Who Coined the Word, Says Homophobia is the Worst Phobia of all

Milwaukee-George Weinberg, Ph.D., author of thirteen books, is the heterosexually-inclined psychotherapist who coined the word "homophobia." A pioneer, he openly critiqued his profession's anti-Gay stance when it was unthinkable to do so. In 1972 Dr. Weinberg's groundbreaking book, Society and the Healthy Homosexual, began: "I would never consider a patient healthy unless he had overcome his prejudice against homosexual-

Dr. Weinberg lives in Manhattan. His latest book, co-authored, is titled Will Power (St. Martin's Press, 1996) and he has just finished another-not yet outabout practical principles in the Bible.

In a recent interview, Dr. Weinberg was asked how he came to coin the word "homophobia?" His instructive response is printed here.

After seeing in the 1950's and 1960's the enormous brutality against Gays and seeing that I myself couldn't introduce known, professed homosexuals even to my friends who were supposedly liberal or psychoanalysts -that they always had reasons for avoiding these people. They weren't at all distressed by the worst kinds of brutalities toward Gays.

I realized that something else was going

on-- more than simple mis-education. This was some deep emotional misgiving these people had, some phobic dread. It seemed to me the problem was theirs, not the homosexual's

I knew a landlord who had two Lesbians living on the 5th floor of his brownstone and he couldn't sleep at night at the thought they were up there making love, and obviously the problem was his, not

After trying to introduce Gay friends of mine to heterosexuals in those days I just almost couldn't make the bridge. They always found reasons not to invite them to their homes and I realized that this is a classical phobic revulsion. They exhibited the same trait as your claustrophobic, your agoraphobic except that they were traits toward Gays.

I realized when I went to Washington D.C., a woman I met there was terrified about being alone in a room with me. As soon as her male friends left the room she began to tremble and almost couldn't speak and I realized she thought I was a homosexual and she was extremely phobic about me.

I recalled a comment by Oscar Wilde's brother: "I don't know why they say Oscar's immoral. Any woman is safe with him." and it turned out-- I realized this was something that had a very deep root, a classical phobia, but of all the phobias, the most destructive being homophobia.

Claustrophobia or agoraphobia---if you can't go to the theater or outside---or you have almost any kind of dread but it doesn't ordinarily get converted into the

These were recognized as phobias, but this---homophobia-- was not recognized

I'd felt such sensitivity in Gay people, whether it was Tchaikovsky, or Michelangelo, or Shakespeare or my Gay friends who discussed literature, art and music with me... Since states could put two consenting adults in jail for 10 years for nothing more than a homosexual act, the culture was haywire. That's homopho-bia's destructiveness. That makes it the worst of all.

In November of last year, represen-tatives of The Wisconsin Light were told that a member of one labor union board in-formed the Wagner campaign that despite Wagner's support of organized labor, the union would not endorse him because the it 'couldn't ask its members to vote for someone who is Gay." That union did in fact endorse Falk

Wagner's Record
Wagner was a County Board veteran. He served on the Dane County Board for 14 years from 1980 to 1994 when he decided not to seek re-election. Wagner had what even those supporting his opponents characterized as a "distinguished record" of service to Dane County

Wagner's tenure as County Board Chairman was marked by his achieving consensus on a variety of issues. Included in his accomplishments were instituting a county wide 911 system, developing plans to preserve the environment and developing plans for future growth.

He was the first openly Gay officeholder in Wisconsin history. During the cam-



In the Fight Against AIDS, Researchers See Reason for Hope, but There is No Cure Yet

Boston, MA-The 4th Annual Conference on Retroviruses and Opportunistic Infections presented data and trial results showing that the new combination of

therapies are working.

In New York City, the death rate for people with AIDS has fallen by half, from 20 deaths a day in November, 1995, to about 10 a day by November, 1996. Other data released during the conference showed that hospitalization rates are falling, and that the cost of caring for people with HIV is decreasing when people used strong antiviral therapies.

With two new antivirals (one a protease inhibitor) expected to receive approval in the next few months, and optimistic reports on several others, the best news is that a number of new combinations may help those whose previous combinations

have failed.

The conference announced many successes, but not all the news was good. Dr. Peter Piot, of the Joint UN program on HIV/AIDS, sounded a sobering note when he reminded the conference that the therapies that are doing so much in North America and Europe are unavailable and unaffordable in most of the world. For this reason and more, there is increased interest in finding a preventive vaccine for AIDS.

The Test of Time

Dr. David Ho of the Aaron Diamond AIDS Reserch Center, Time Magazine's Man of the Year for 1996, was the Keynote Speaker. Can HIV be cleared from

an infected person's body?
"We don't know," Dr. Ho said, as he recapped his findings that the virus does

not lie dormant in the body.

From the day of infection, the virus and the immune system are constantly battling. A billion or more viruses are created each day with a similar number being eliminated (cleared). With the new antiviral combinations available during the past year, we have learned a lot about what happens during a period when the immune system gets the upper hand over

Pop a Few Pills and AIDS Will Be a Thing of the Past? Think Again, Think Hard

In spite of good news from a major AIDS Conference held in January in the nation's capital, experts say it would be foolish-because of myths and rumors circulating-to believe AIDS must no longer claim our constant attention.

And yet, with each hype-fest about the new protease inhibitors, many who as-sume a cure is around the corner have already begun to behave as though there's nothing more to worry about.

Safer sex still remains the primary responsibility we have to ourselves, say the experts. Where once utter hopelessness resulted in AIDS denials, now, conversely, the renewal of hope is causing another kind of denial, a denial just as

Young people in their twenties haven't yet faced AIDS as a reality. Along with a false sense of immortality usually common to that age group, the hopes that recent press stories have inflamed makes twenty-somethings all the more likely to fool themselves, saying "Its nearly curable now, so I can do what I want without worrying," or "I'm young, I-can't get the

Youthful Gay men and some Lesbians may follow many of these thought-paths.
"There are cures now," they say without
knowing, "and even if they aren't here yet, it won't be long. I don't have to wear a condom. That's something for the old folks, those from yesterday's generation. Besides, I have a friend who has been doing just great since he started taking the protease inhibitors."

What those who look only on the sunny side of AIDS ignore, is that protease inhibitors, while no doubt highly beneficial to many, are not so to all. In fact, the side effects of these inhibitors can be more devastating than AIDS itself.

Users must stay with a demanding schedule-hour by hour, and it is preached that if they miss a few doses, the virus may once again revive and become uncontrollable in their systems.

Also, and not least, the cost of protease inhibitors is frightening, well beyond the

reach of the uninsured.

Some patients tell of the onset of sideeffects after dramatic increases in their T-cell counts, One such side-effect is what drug companies call "kidney sludge," a condition which is akim, according to one patient, to "carrying a bowling ball

If a person's HIV status is somewhat advanced the wonder drug, Crixivan, can trigger herpes zoster, creating ugly sores over the entire body. In other cases of side effects, patients feel extremely unpleasant reactions in their digestive

Skin can become so sensitive that the new drug users imagine they're suffering from extreme sunburns. It can hurt, they

say, even to comb one's hair. Others find themselves, of necessity, mapping out the public bathrooms in their neighborhoods, enduring embarrassments that have bypassed any other conditionlike facial lesions- for the humiliation

HIV Home Testing Kits Criticized by Some, Accepted by Most

Omaha, NE- With a quiver in her voice, a nervous telephone counselor told Tom Spring that he had the deadly virus that causes AIDS.

She then referred him to a pediatrician whose telephone had been disconnected for three years. She also asked how he planned to tell his wife.

Spring is Gay.

His story has fueled criticism in Ne-braska against the AIDS home test kits that went on the market in May with promises of telephone sensitivity and helpful referrals.

It's inbound telemarketing masquerading as counseling," said Joseph Hall, di-rector of the Nebraska AIDS Project and coordinator of the review that Spring participated in a few months ago.

A bill has been introduced in the Legislature to encourage pharmacists, grocers and other retailers to put labels with the state's AIDS hotline number on the kits. The Health Committee heard testimony Thursday in Lincoln on the bill (LB619), which would provide the labels free to retailers from the Nebraska AIDS Project.

Hall wants to make sure that those who have the virus are referred to the state's largest AIDS advocacy group. "We want to give them (retailers) an opportunity to do this voluntarily and then come back next year, if we find out people are not

complying," he said.

Spring took the test at the group's suggestion and to examine for himself the tests. Spring has been HIV positive for 10 It's not to be Mr. Mean, but to correct the problem," he said.

Several AIDS groups contacted across the nation reported few if any complaints.

The companies stood by their counsel-

Ellen Scofield, spokeswoman for Confide in Bridgewater, N.J., said each person counsels differently and the company continually updates its referral base.

She said 75 percent of Confide's counselors have master's degrees in counseling,

social work and education and the average length of a call with an infected person is 20 minutes

A spokesman for Home Access said that in response to the Nebraska test, the company's referral base has been updated, the pediatrician's phone number has been removed and counselors are told not to assume everyone is heterosexual.

Don't make assumptions," said Kevin Johnson with Home Access in Hoffman Estates, IL.

In fact, the once-controversial kits have generated little interest, said Mike Shriver, a spokesman for the National Association of People with AIDS in Washington, D.C.

People aren't stampeding to the store to buy the kits, nor are they not buying the "Shriver said. "It doesn't seem to be kits, a big deal."

Most of the people taking the test are the worried well" or repeat testers. People at high risk, including those in the nation's poorer communities, cannot afford to take the \$50 tests, Shriver said.

The kits are sold under the brand names Home Access Express and Confide. Spring took both tests on the market and was not happy with either company's counselors.

"It was very cold, callus and calculating," he said. "I just didn't think they cared."

Needle Exchange Programs Effective in Stopping Spread Of HIV, Study Shows

Washington, DC-A federal report concluding that needle exchange pro-grams are effective in slowing the spread of HIV and AIDS represents a critical step toward taking the politics out of public health, the Human Rights Cam-

paign (HRC) said.
"The Department of Health and Human Services (HHS) reached the only scientifically honest conclusion possible," said Winnie Stachelberg, HRC's legislative director. "All the evidence to date shows that access to clean needles decreases the spread of HIV and AIDS.

"In light of this report, we call on the administration, the public health community and Congress to work together to lift ban on spending federal money on needle exchange programs."

The report found that the scientific evidence is not strong enough to indicate that such programs do not promote intrave-nous drug use. For that reason, it stopped short of recommending an end to the prohibition on spending federal money on needle exchange programs.

HHS issued the report on February 18, 1997, in response to a request from the Senate Appropriations subcommittee for the Departments of Labor, HHS, Education and related agencies.

The report's principal conclusion is that "needle exchange programs can be an effective component of a comprehensive strategy to prevent HIV and other bloodborne infectious diseases in communities

that choose to include them.

This is the first time in the history of the AIDS epidemic that the federal govemment has publicly stated this conclusion," Stachelberg added. "We believe that this will have a positive impact in those communities that are considering but have yet to institute needle exchange

programs."

The National Association of People With AIDS (NAPWA) called the report "a significant first step," but added that it "was not enough."

"For the thousands of people who de-serve and need a well-funded and accessible needle exchange program right now, this shallow report does not lift the prohibition of federal funding for these programs," said Cornelius Baker, NAPWA's executive director.

AIDS Action Council, the nation's leading AIDS advocacy organization, called on President Clinton and Congress to heed the results of the report, which a spokesperson called "an important first

Approximately one-third of reported AIDS cases are related to intravenous

According to the AIDS Action Council, over a third of reported adult AIDS cases and over half of all AIDS cases among children, are related to injection drug use.

In the second week in February, a panel of public health experts at the National Institutes of Health concluded that needle exchange programs are a powerful and proven weapon in the war against AIDS. They also charged that misguided politics continue to block institution of such pro-

And many respected public health organizations have reviewed the research on needle exchange programs and agree that they work. These organizations include the National Academy of Sciences, the National Commission on AIDS, the American Medical Association, the National Alliance of State and Territorial AIDS Directors, the American Foundation for AIDS Research and the American Public Health Association.

AIDS Briefs

Bill Seeks to Prevent AIDS Education

Olympia, WA-AP- Washington lawmakers are studying a "parents' rights" bill that would ban counseling students or teaching them about AIDS prevention or sex without written consent from their parents.

The Senate Education Committee held a hearing Thursday, February 20th, and the House Education Committee heard testimony the following day on legislation that is

gaining popularity nationally with religious conservatives and "pro-family" groups.

The legislation is favored to pass the Republican-controlled Legislature, but Democratic Gov. Gary Locke is expected to veto it. Lawmakers then could choose to send an identical bill to the November ballot, bypassing the governor.

Senate Bill 5555 would reverse the procedure for classes about AIDS prevention, human sexuality, alcohol and drugs, and course units on suicide and health-related topics. Currently, parents have to inform schools when they don't want their children to take such classes. Under the bill, they would have to sign a permission form for their children to receive the education. Counselors could not work with students without express permission from home.

Currently, only about 1 percent students are withdrawn from such classes, the committee was told.

Marijuana May Have Medicinal Uses

Bethesda, MD-AP- Sparse but promising evidence indicates smoking marijuana may ease the suffering of some seriously ill patients, but more study is needed before the drug's medical value is understood, a panel of experts said Thursday, February 20

"For at least some indications (medical uses), it looks promising enough that there should be some new controlled studies," said Dr. William T. Beaver, a professor of pharmacology at Georgetown University School of Medicine and the panel's chairman. Although a final committee report is not complete, "the general mood was that for some indications, there is a rationale for looking further into the therapeutic effects of

marijuana," Beaver said. But smoking marijuana presents serious technical problems in medical research, said Beaver. Most drug trials are blinded, with one group of patients taking the real drug and another taking a placebo.

Smoked marijuana, he said, is impossible to disguise.

Another problem is that smoking marijuana includes the same risk to the lungs as cigarette smoking, Beaver said. Both tobacco and marijuana smoke contain chemicals that can cause cancer and other diseases.

AIDS Group Pulls National Ad

Dallas, TX-AP- An AIDS charity yanked a nationwide ad campaign after receiving complaints that messages such as "Prayer won't cure AIDS. Research will" insulted

people who believe in the power of prayer.

The American Foundation for AIDS Research said objections to the campaign focused on two of three ads that ran on public buses: "Prayer won't cure AIDS. Research

will" and "Sexual abstinence won't cure AIDS. Research will."

"AmFAR seeks to educate, not offend the public," said Dr. Mathilde Krim, chairwoman of the board of directors of New York-based AmFAR, a pet charity of actress Elizabeth Taylor.

KCBI-FM news director L.B. Lyon said a caller to the Dallas Christian radio station complained about the ads, and he followed with a news story. That generated more protests, he said.

V Drug Use Spreads to Rural Areas

Denver, CO-AP-Most of Colorado's injection drug users live in the Denver metropolitan area, but health authorities say they are seeing evidence of the problem in rural counties as well.

A state health report published in September showed Coloradans contracting AIDS increasingly are women who inject drugs or have sex with men who do, and unborn babies of those women

The state alcohol and drug abuse division estimated in 1995 that there were 540 IV drug users in Weld County. As of last year, there was a total of 68 reported AIDS

In comparison, the six-county Denver metro area with a combined population of more than 2 million, had an estimated 10,900 IV drug users and a total of 4,732 total reported AIDS cases.

Needle exchange programs are being considered by state legislators and the state board of health to help prevent the spread of AIDS and other blood-borne diseases among intravenous drug-users.







the virus with the help of the drugs.

It is important to remember that antivi-rals don't directly eliminate the virus; they stop it from reproducing. It is the job of the immune system to get rid of the vi-

Free floating virus in the blood is eliminated very quickly, and thus is the easiest to clear. Active infected T-cells take a little longer, but it is the other cells that take longer to clear.
In addition, there are parts of the body,

such as the central nervous system (CNS), including the brain, where protease in-hibitors don't get to very well.

Dr. Ho is continuing to experiment to see if people can eventually stop combination therapy without the virus return-ing, but it will be some time before they believe it will be safe enough to allow volunteers to discontinue treatment.

If the virus can be cleared, the strongest combination should be started as early as possible.

However, until clearance is a viable option, antivirals need to be chosen with an eye toward keeping them working as long as possible, and leaving other options open when they no longer work.

If, in the end, viral clearance is not possible, keeping antivirals working will be the course to follow.

In the Meantime

Some of the most important announcements at the conference concerned new antivirals soon to be available, and the data showing which of the increasing number of potential combinations are working best

Agouron Pharmaceuticals is applying to the FDA for approval of their new prote-ase inhibitor "nelfinavir" (trade name Vircept). Trials who nelfinavir may be as potent as Merck's indinavir (Crixivan) or Abbott's ritonavir (Norvir), and when taken in combination with either AZT plus 3TC or ddl plus D4T, many people can lower their viral load by over 999

Nelfinavir is also being tried out in combination with Roche's protease inhibitor saquinavir (Invirase). The early results, while not as good as for ritonavir plus saquinavir, may be good enough to be a choice for people who have used up

other options.

Besides nelfinavir, many expect the FDA to approve the drug delavirdine (Resciptor). Delavirdine, like the previously approved nevirapine (Viramune), is a Non-Nucleoside Reverse Transcriptase Inhibitor. The data on delayirdine is not as strong as other antivirals, but for peo-ple who are already resistant to some antivirals, there are some new combinations that include a non-nuke to consider.

And Beyond

With the dizzying number of new combinations, the consensus of the conference was that it is more important than ever that people use a doctor who follows HIV

treatments closely, preferably a specialist.

This year's conference didn't change the rules, but they did help to refine them. The message remains, if you have a high viral load, talk with your physician about a powerful antiviral combination, one that can get your viral load to below detect-

able levels to avoid resistance.

The choice of the best therapy depends on your medical history, including what antivirals you have used in the past.

Gays and Lesbians Should Accept the Bishop's Apology at Face Value

A Roman Catholic olive branch such as
that offered last week (second week in
February) by Orlando Bishop Norbert

Dorsey, isn't something at which we can just sneeze. Open-minded clerics within the Catholic hierarchy are expressing, with the establishment of such Gay and Lesbian ministries as that which Bishop Dorsey has just opened, brave and honest regrets about the harmful effects of the centuries-long sexual persecutions that are seemingly implicit in most current Roman Catholic policies.

"We may have hurt or wounded our Gay and Lesbian brothers and sisters through ignorance or misunderstanding," said Bishop Dorsey, and "In the name of our church, if that has happened to any one of you, I ask your pardon and the pardon of God."

A letter from the Vatican, intercepted in 1992 and published in The Washington Post, ordered American bishops to oppose legislation that promotes civil rights for Gay men and Lesbians. It labeled homosexuality—in spite of the contrary view of the American Psychiatric Association—

"an objective disorder."

The Post said the Roman Catholic Church declared its support "for discrimination against Gay people in such areas as public housing, family health benefits, and the hiring of teachers, coaches, and military personnel." The Vatican, it reported insignated that homosexuals are ported, insinuated that homosexuals are mentally ill and insists that any denial of

rights to Gays will promote family values.

The Vatican letter read: "The church has the responsibility to promote public morality of the entire civil society on the basis of fundamental moral values." The rights to housing and employment, continues the extraordinary church directive, are not absolute, and employment, it says

are not absolute, and employment, it says curiously, is "a privilege."

Fortunately, two American Catholic bishops reacted swiftly to this Vatican skullduggery, and, in The Washington Post took out an ad, a public statement deploring the Vatican's backward stance.

Now, with the addition of such clear voices as Bishop Dorsey's, a campaign among American Catholic clerics, at least, gathers steam during the closing years of this decade. How long it may take before truly meaningful changes in

church policy occur is anybody's guess. Currently, Gay-sympathetic American bishops remain a minority within their

church, risking the displeasure of a dis-gruntled Pope who seems not afraid, as he showed recently in the case of a Sri Lankan priest, to excommunicate any Catholic clergy he regards as renegades or "heretics.

It is in the light of such dire threats to their positions that the recent apology to American Gay men and Lesbians, spoken on behalf of the church by Bishop Dorsey, deserves the heartfelt thanks and appreciation of all same-sex lovers, no matter their religious orientations

In an institution which, through its emissaries, once lit fires under the bodies of its doctrinal opponents, civilized progress comes all too slowly. It takes courage, since the present pope is hostile to same-sex affection, to oppose him from within

On February 8, 1994, as reported in the pages of this paper, the European Parliament presented its nation-members with a

ment presented its nation-members with a non-binding resolution recommending that Gay and Lesbian couples be granted marriage and adoption rights.

The resolution passed 159-96, and on its heels Pope John Paul II reacted with uncharacteristic fury. He attacked the European Parliament in a statement accusing it of conferring "institutional value on deviant behavior."

cusing it of conferring "institutional value on deviant behavior."

Though Vatican attacks on political bodies remain rare, the pontiff departed from his prepared text and—according to newspaper reports—his voice-pitch rose in evident alarm as he pontificated thusly:

There are some who would say, "Who cares about what the Pope thinks about anything?

There are those who would summarily dismiss Bishop Norbert Dorsey's olive branch to Gay and Lesbian believers as a shameful church supported money making-scam, one he hopes will turn "fallen away" Catholics into regular Massattending tithe-makers. But because the good bishop is bucking those top dogs at the bureaucratic Vatican center on his hierarchical totem pole, such a hurried dis-

missal would be manifestly unfair.

He appears instead to be a religious man who has looked carefully into real-life issues and is attempting to introduce longneeded changes for millions of Gay men and Lesbians who feel, as a result of oldfashioned papal ravings, a deep-seated spiritual depravation.

Hanged, Stoned, Dropped or Halved; The Fate of Gays in Today's Iran

Gay men and Lesbians live in frighten-ing closets in this ancient land once known as Persia. A theocracy, ever since fundamentalist religionists seized gov-emment control following a 1979 upris-ing against the autocratic Shah, primitive "religious" death penalties for same-sex love are now used to strike terror into Iran's fragmented Gay communities.

Those charged with love-making are given a choice of four deathstyles: being hanged, stoned, halved by a sword, or dropped from the highest perch.

During the past decade, however, Iranian men and women, primarily exiles, have bravely confronted the rampant homophobia loosed in their country, pub.

mophobia loosed in their country, publishing an impressive magazine, Homan, and courageously establishing worldwide outposts of their organization, also called Homan.

Hit-squads sanctioned by the Iranian government operate brashly in locales outside the nation, murdering nationals who oppose the current "religious" regime. The bravery, therefore, of Iranians who publish and agitate against the anti-Gay policies of the regime cannot be underestimated.

A perusal of the anti-Gay penal code passed by the fundamentalist Iranian par-liament in 1982 gives evidence of the in-sanity that motivates homophobic nit-

'One may become aware of the complexities and intricacies of Iranian sex laws and appreciate the extraordinary flatulence of their creators," writes one

Gay teens (Article 144) are also punished at a judge's discretion. Rubbing one's penis between the thighs without penetration (tafheed) shall be punished by

100 lashes for each offender.

This act, known to the English- speaking world as "frottage" is punishable by death if the "offender" is a non-Moslem.

If frottage is thrice repeated and penalty-lashes have failed to stop such repetitions, upon the fourth "offense" both men will be put to death.

Even heterosexually-inclined Iranians must now be exceedingly careful. Should they introduce two men who are likely to be found nude under the covers or to rub their penises between thighs or buttocks, they too are liable for 70 lashes (if they are men) or 75 lashes (if they are women.)

According to Article 156, a person who repents and confesses his Gay behavior prior to his identification by four wit-

nesses, may be pardoned.
Even kissing "with lust" (Article 155) is forbidden. This bizarre law works to re-route old Persian male-bonding customs, including common kissing and holding hands in public.

Who can determine what constitutes lust? Some Gay liberationists joke about the "boner police.

In fact, morality police do thrive in modern Iran, seeking out not only Gays and Lesbians, but opposite sex couples too, those who picnic together without being related by blood.

Obituary

Pioneering journalist and scholar, Don-ald R. Slater, who, in the 1950's-dawn of Gay American activism, established an undeniable place for himself, is dead at 78. He died Valentines Day at the Veterans Hospital in Westwood, a Los Angeles-area locale.

Slater, the editor of ONE magazine in 1954, pushed forward victoriously with ONE's landmark Supreme Court case when the staid little magazine fought for its right to publish against post office cen-sors attempting to hamstring bold published examinations of same-sex affec-

Suing on behalf of ONE, and proud winner of this major legal battle, Slater actually helped establish the right of same-sex love to speak its name. Rodger Streitmatter, Ph.D. a professor of journalism at the American University and author of the definitive study Gay/Lesbian journalism, Unspeakable, says the FBI sent investigators to harass ONE's editor and writers, making FBI investigations known to non-Gay employers and to the Los Angeles police, among the most homophobic in the na-

In his well-researched Gay journalism history, Dr. Streitmatter quotes strong arguments by Slater, making clear the importance of ONE as it figured in the earliest struggles by American liberationism.

"These early publications," said Slater, "were not a forerunner of anything. They were the start of the homosexual movement in America."

In the 1960's Slater was editor of Tangents, a magazine that was similar in size and content to ONE.

Slater preferred to use the term "homo-sexual," to either "Gay" or "Lesbian." He was a sexual integrationist who saw no reason to make pointed distinctions befor free expression and free assembly."
In another definitive journalism history,

Edward Alwood's Straight News, (about the mainstream's treatment of Gays) Slater is quoted as saying that he and other founders of ONE "certainly didn't want to institutionalize homosexuality, a la heterosexuality, or make ourselves into a special class or culture group."


After the opening of Slater's Homosexual Information Center in Los Angeles, the feisty scholar and collector of avant garde homosexually-inclined manuscripts said he saw room in his worldview for every different kind of individual, but as individuals, not as members of a class.

"Is there room in your movement for all types of homosexuals, from the very straight to the drag queen?" asked Ken Gaul, a reporter for the Manhattan-based

weekly, GAY.
"Sure," replied Slater, "let them all come. I like to treat everybody as an individual, from drag queen to hustler."

GAY's reporter asked if Slater opposed male prostitution and he replied, "I'm not against hustlers. If a man wants to pay that's his business....Frankly I'm domesticated. I don't pay. I don't like the idea of going to bed with somebody for money, but some people, that's all they have." Don Slater is survived by his long-time companion, Tony Reyes.

These days, Eric Beeman, the man the FBI once dubbed the "pee wee bandit," is spending less time clearing Boston banks, and more time clearing the shelves of Gay bookstores around the country, bookstores like Milwaukee's AfterWords.

The first printing of his book, Tales For The Obsessive Gay Romantic has sold out, and suddenly, the con, (who lives nowin Chicago) has become the artist to watch out for.

When I spoke to him, he had just finished speaking on the phone to his agent in New York. I asked him how this transformation, this metamorphosis, as it were, came about?

"Well, it was less of a transformation," Beeman replied, "and more of an undoing. An undoing of the layers that were never really me. The Eighties, the materialism...the values that were never mine."

He is generous to himself in this assessment because, with a bit more probing, one can find a Beeman who relishes his past. With a raised eyebrow and a crooked smile, he will tell you of the day he robbed one bank on his lunch hour. The bank was down the street from another bank where he worked as a teller and right across the street from police headquarters.

"Yeah, without prison, there would be no me," he said. "I had no identity before prison. I don't recommend it as a way to find yourself, there must be an easier way, but I have to say, without prison, there'd be no Eric Beeman the author, there'd be no book."

It is with this same raised eyebrow and cooked smile that you will read his stories, not for the traces of the author's own dubious past that rise to the surface here and there in the stories, but for the obsessive reflections of Gay love you see (in your friends, not yourself!...of course...).

For instance, in the story "Get a Job, Find a Boy," the protagonist goes to the theater to see the man he

has a date with, a "miscellaneous pirate" performing in the play the Pirates of Penzance, only to fall in love with a musician in the pit.


By the time he gets to the cast party, he's putting the moves on the lead of the play, "the King of the Pirates," instead. And at the end of the night, he goes to the home of the man he's "just been sleeping with" for a year, while speaking of a crush he has on a cartographer who has just joined his running club. Sound like anyone you know?


Perhaps it is his prison experience that turns up the tension between freedom and confinement in Beeman's "I" characters. Love seems to liberate and imprison them simultaneously.

"Yeah, it's autobiographical," Beeman readily admits, "But a lot of those guys in the book are really just one guy. So don't think I'm a total trash heap."

Each tale psychologically illuminates the workings of a Gay man in love in a new

Tough Guy Clint Eastwood plays a master thief in and directs "Absolute Power"

Eastwood's 'Absolute Power' is More Likely "Absolutely Preposterous"

I've been a big Clint Eastwood fan for, oh, as long as I can remember; back to all those wonderful westerns he made in the late '60s and his legendary "Dirty Harry" films of the '70s. To be sure, his output has been uneven, but on the whole, he's been on of my favorite movie actors.

After his greatly successful revisionist, bleak western Unforgiven, I went into Absolute Power expecting another excellent film from Eastwood; after all, like Unforgiven, he produced and directed this film. Unfortunately, I was quite disappointed.

In Absolute Power (Rated R), East-wood play a master thief on the run from the law. The film opens with Luther (Eastwood) plying his trade at the luxury itemfilled home of a powerful Washington power broker (veteran actor E.G. Marshall). He's about to make his stealthy exit when a couple arrives in an adjacent room, and Luther witnesses their sexual playfulness rapidly deteriorate into a vi-cious murder. Very soon, secret service agents and a presidential secretary arrive to clean up the mess. Why, you might ask? Because the murderer is none other than the President of the United States.

It's precisely at this moment that what

started out as an intriguing film descends into little more than an average, trivial, tasteless, totally preposterous "thriller." Which isn't to say Absolute Power doesn't have its moments. For one thing, it certainly has star quality, with not only Eastwood's extremely well-written and acted performance as the master sleuth, but also stars Gene Hackman (another of my favorites) as the President, Ed Harris. Scott Glenn, Judy Davis, and Laura Linney a Luther's estranged daughter. Truly, the father-daughter relationship is actually the best aspect of the film. Hackman is one of our 2 or 3 finest actors today, but this was a role a dozen lesser people could have done.

I won't go into all the plot inconsistencies and silliness. Suffice it to say that I found the whole premise of the story to be incredible, and that broke the film for me. Still, there are some fine performances-I just wish these characters could've found themselves in another venue. Some reviews have called Absolute Power a comedy because they found it so ludicrous; others are calling it one of Eastwood's best works. Such a wide variety tells you something: this is a mediocre film at best.

On a scale of 1-10, I rate this one a 4.

With all the magic of a cheap pomo (so Glenn understands), Alex meets Isabel (Salma Hayek) his one true love and soulmate while standing in line for a public toilet in a sleazy bar. Who cannot be daz-

zled by all of this romance.

Bing, bing, bing and it's three months later and Isabel pays Alex a little visit. Seems that during that one magical night, a baby was conceived. Alex dutifully blubbers and throwing caution (plus an extremely important meeting) to the wind, journeys with Isabel to meet her parents.

Wait, this sounds a bit like last year's A Walk in the Clouds, except that in that film, Keanu Reeves was being gallant without having knocked up the pretty girl.

Enchanted by Isabel's family, alternatively charming and threatening, Alex declares his love for her. Another night between the sheets? No, a cheap and sleazy wedding chapel marriage ceremony witnessed by an Elvis impersonator. Didn't Glenn recently see such a ceremony highlighted in New Bride magazine?

Coming from radically different backgrounds and perhaps a bit hindered by not knowing a whit about each other, the newlyweds experience the predictable foibles faced by newlyweds on sit-coms since the dawn of television. So predictable are their subsequent foibles that homage seems to have particularly paid to that most classic of all sit-coms, "I Love Lucy."

Is Fools Rush In a total bust? Those looking for a pleasant, mindless little hetero date flick aren't likely to be unduly disappointed. Matthew Perry and Salma Hayek prove to be an engaging pair and exhibit surprising romantic chemistry.

Unable to rise above the mediocre writing is the equally uninspired supporting cast who seems to be content with phoning in their performances, particularly an especially disappointing Jill Clayburgh. Fools Rush In producers seem to have wasted an awful lot of money to have Clayburgh playing such a throw-away part as Alex's tipsy mother.

'Rosewood' is a Film that Should be Seen Because We Must Not Forget

By Dolores Barclay In January 1923, a violent gang of white thugs ravaged the prosperous African-American community of Rosewood, Florida, burning it to the ground and slaughtering many of its residents. The mob had been incited by a white woman's false ac-cusation that a African-American stranger raped and beat her.

The residents who survived the attack fled to the swamps and never again returned to their homes or their land. And for more than 70 years, their story remained a dark and tragic secret.

Now, John Singleton (Boyz N the Hood) retells that brutal slice of American history

in Rosewood.

What richly deserved to be a powerful story, however, is greatly diluted in Singleton's Hollywood distillation. His use of a mysterious stranger who rides into town and helps save Rosewood's women and children turns the movie into a formula, and he weakens things even further by adding a lame romantic subplot.

Worse still is his reliance on stereotypes, right down to the obligatory "mammy," in this case, Esther Rolle as family matriarch Sarah Carrier, and cartoon white bigots. These guys were crazed and frightening terrorists, but Singleton's whites are straight out of central casting.

The movie opens with a sweeping shot of the pristine village of Rosewood, with its neat, wooden houses and vegetable gardens made up of tidy, straight rows. The streets are clean and uncluttered, the houses well-maintained. Inside the Carrier house, a china closet holds blue china and fine crystal, and an upright piano stands in the living room.

Rosewood is a prosperous, proud community, very unlike the poor white trash enclave of nearby Sumner.

The white residents of Sumner hate, and are jealous of, thriving Rosewood, and any excuse to obliterate the town will do. They find their answer when Fanny Taylor, a white married resident who sleeps around, is beaten by her white lover. She claims a African-American man did it. And though everyone knows this is not the case, her allegation provides a reason to destroy

Much of the two-hour and 22-minute movie is devoted to the burning and de-

struction of the town and the slaughter of its residents.

Also near the forefront are the romance between Mr. Man (Ving Rhames) and Scrappie (Elise Neal), a young schoolteacher, and the story of John Wright (Jon Voight), a white shopkeeper who lives in Rosewood.

Wright recently has remarried after his first wife's death and is struggling to deal with his new relationship, as are his sons. He absorbs the collective guilt of his white neighbors and becomes a buffer between their rage and the defense of the Rosewood African-Americans. In the end, he teams with Mr. Man.

As the mysterious stranger, Rhames is a strong, attractive presence. But is he a romantic leading man? More compelling is Don Cheadle (Devil in a Blue Dress) as Sylvester Carrier, a gentle piano teacher who stands up for his rights and those of his family.

But by putting the focus almost entirely on the destruction of the community and a few, mostly superficial, characters, Singleton misses a big opportunity for a more dramatic presentation: the story of the sur-

Why did they remain silent for so many years and how did they cope with the terror that haunted them? Why didn't they seek outside help and get back their land from the whites who stole it from them? And what was the journey to some small form of justice such as for Arnett Doctor, the son of a survivor who finally got the state of Florida to make reparations?

Still, Rosewood is a movie that deserves to be seen, because the story it tells must stav alive

Gays, Bisexuals and Lesbians should see this movie precisely because racism and homophobia both have the same root. The virulent prejudice and ignorance that caused the burning of the town and its citizens to be scattered, should be, unfortunately familiar to the LesBiGay community.

Rosewood was produced by Jon Peters with Penelope L. Foster as co-producer and Tracy Barone as executive producer. The script by Gregory Poirier is weak, but Johnny E. Jensen's excellent cinematography deserves a mention. The movie is rated R for violence.

'Dante's Peak' is Visually Compelling, **But Otherwise is Disappointing**

Dante's Peak is the latest in a once thought extinct, but apparently only dormant, Hollywood movie genre: the Disaster Movie.

The genre got its start in that great Decade of Disaster (in more ways than one), the Seventies. 1972's The Poseidon Adventure kicked things off, not only because it was a huge commercial success, but also because it's actually a decent movie. One of the most compelling disaster films was 1974's The Towering Inferno which was even nominated for an Oscar for Best Picture.

There are all kinds of theories as to why disaster films became trendy during their "golden era" of the '70s. The main theory goes something like this: Americans were feeling mighty low about themselves and their country for a number of reasons—the continuing morale-destroyer which was the Vietnam War, Watergate, rampant inflation, the Arab oil embargo, and Jimmy Carter. So-called disaster films played right into the nation's confusion and malaise; having a cathartic effect, as it were.

Fast forward two decades and we have films like Twister and now, Dante's Peak,

which play on our nation's current emotional issues (AIDS, crime, drugs, general "moral decline"), in much the same way. Our sense of unease in the nervous '90s is likely the culprit in the new wave of dis-

Okay, now let's dispense with the psychobabble and commence with a brief review. Is Dante's Peak worth seeing? Yes, if (and only if) you like dazzling, computergenerated special effects.

No, if movies with predictable plots, cardboard characters, and totally unrealistic "action" sequences aren't your game.

Incidentally, Pierce Brosnan, who plays a vulcanologist on a crusade against all the world's "evil" volcanoes, is in this one purely for the money, and it shows. For all his many fans out there-and I trust many a Light readers is a Brosnan fan-you'll be disappointed in this sense; he doesn't shed a stitch of clothing (though they do get dirty and singed), and his only kiss comes in the last minute of the film (and it's a grimy-looking one at that).

"Dante's Peak" is probably worth a movie rental in a few months, but otherwise, forget it. On a 1-10 scale, this film rates a 4.

Oscar May Ignore Them, But the Great Films Make the Nominees Parodies

Kenneth Branagh's Hamlet might be viewed as a form of public service: a testament, not only to the source material, but to the awesome power of the big screen in opening up classic works in their entirety without the sec dry tidiness of PBS TV. The effect is breathtaking. But four hours of poetry? You've got to be

What we have here is a reputed cornerstone of Western culture-enough to scare anyone away. Those who stuck it out for two hundred and forty minutes with a single intermission (there should have been two), may have found themselves rewarded with the revelatory experience of Shakespeare's eloquent language as drama rather than ritual.

Branagh brings the play into the light with sets that look like something out of Student Prince. This takes a bit of getting used to, but he never slackens the pace.

Sex with Ophelia makes her mad scene more moving; Polonious is almost a dirty old man making his famously sanctimonious "advice" something hypocritical and his murder less appalling. The ghost, complete with earthshaking effects, seems more threatening than pathetic. The famous "To be or not to be..." is delivered into mirrors behind which Claudious and Polonious hide and eavesdrop, and the camera circles suspiciously, those characters Hamlet doesn't like.

The mystery of Hamlet himself, (played by Branagh with fast-fire determination), has no solution nor should it have. Shakespeare's intention was always to illustrate the fact that man's greatest mystery is himself. Here, the mystery is not diluted, but expanded onto a greater scale since there's no getting away from the verse which flows seamlessly without relent.

But what else can you expect from a master writer who supercedes Milton, Plato, Sophocles, Aeschylus and Tom Clancy.

Given the proper time and attention, the fluency of Shakespeare's language is mesmerizing-besides, you've got the big screen to fall back on here, put to good use for a change, and, if you're more accustomed to Luke Skywalker's kind of force than the force of language, you might be pleasantly surprised at what great poetry can do.

Not to pick on Star Wars, which loses and gains with the passage of time. If Lucas's added effects seem too much like technocratic obsession, and if advanced computerized technology diminishes its startle, the miniaturized conflict between Good and Evil, evidently inspired by the old Flash Gordon serials, enhances the

movie's nostalgic effect.

Star Wars is no four star masterpiece. The characters still seem a bit twodimensional and the film doesn't quite have the universal tenderness of Snow White, or the melancholic elegance of the Thief of Baghdad, or even the mystic metaphysics of 2001. Still, it's a very likable film. Even the robots are loveable.

The current Oscar nominations are here to remind us that action and sci-fi films are not all that's rotten with the state of film

Can't do much for an industry that nominates, but was most likely stuck, with the populist vulgarisms of Jerry McGuire, Shine and Fargo as top notch films. Not that these films are bad, but they appeal only to the most common denominator of audience involvement—the ground-entry level of drama and comedy.

They have neither the distinction, nor the emotional charisma to deserve the "best" of anything.

I can't honestly include English Patient in this negative grouping. It made a stab at classiness, but unfortunately based itself on overrated source material and ended up being dryer than its own sand.

Shine, a cold, clumsy film, in two parts badly welded together, also illustrates that good intention do not a good film make.

I haven't seen Secrets and Lies, but the subject matter sounds dangerously trendy.

I also have trouble with what passes for acting these days. Watching Cruise, Harrilson, Rush, and Gooding, I'm seeing more caricature than characterization, like watching grotesque vulgarizations of na-

I can accept Francis McDermont who kept mugging at a minimum and used as much restraint as the script would allow. Only Lauren Bacall eschewed all this tomfoolery and gave a straight, distinguished performance. Kristin Scott-Thomas gazed into the camera. That's all.

The cruelest rub of all was the Academy's ignoring the lovely Evita and the

virulent Hamlet in all major categories. Granted Eva and the Prince of Denmark would make strange bedfellows, but their films share a common quality.

Both engage the audience in moving, cinematic translations of material not usually thought to be entirely suitable for the

Both demonstrated that the added dimensionality of the screen can sometimes break the static boundaries of the stage and give new emotional focus to the overly familiar.

The motion picture industry always tries a balancing act between "artistic" films and populist fodder for the common herd. Even if the artistic films are never nominated, everyone knows they're there mocking the nominees that make the audience the fall guy.

But as long as filmmakers have forgotten that movies were once made largely for mature thinking individuals, and that not everyone under 25 operates in a hillbilly vernacular upgraded to street-wise jargon, things won't change much. Perhaps the final rationalization for making those dead-ended serious films that no one enjoys is that last frame we see so often on the screen-"This film is based on a true story."

Who cares?

Like 'Star Wars,' 'The Empire Strikes Back' is Not to be Missed

Where were you in the summer of 1980? Well, I was enjoying a few months of freedom before entering my Senior year of high school, and, like millions the world over, anticipating the release of the second "Star Wars" film that year, The Empire Strikes Back. Even after seeing The Return of the Jedi three years after that, The Empire Strikes Back has always remained my personal favorite of the trilogy. It's by far the darkest, most serious of the three films, and, to me, the best written, acted, and scored.

Lucasfilm, Ltd.'s re-release (started Feb. 21st everywhere) retained all the original glory, and, in fact, only made computerized additions to a couple of scenes, sufficing mostly to "clean up" the existing film. Star Wars creator George Lucas, wanted almost no changes to Empire because it's his personal favorite of the three films, too

(great minds think alike).

As the film opens, we find that the Rebels have been forced to relocate to the desolate ice planet of Hoth, while Darth Vader, in search of young Luke Skywalker (his, shall we say, "estranged" son), has ordered the dispatching of imperial probes all over the galaxy. When one such probe alerts the Empire to the Rebel base on Hoth, all hell breaks loose.

The Empire Strikes Back adds severa! new places, people, and creatures to the

saga. The Hoth scenes give us Tauntauns (domesticated snow creatures), the fierce wampa (a huge abominable snowmantype), and finally, the great land battle between Rebel ground troops and fight-ers, and the massive, armored, lumbering Imperial Walkers (At-Ats, by name).

There's the treacherous ride through an asteroid field (for which Dramamine is recommended), Luke's abortive training with Jedi master Joda on the swamp planet of Dagobah, and finally, the climactic scenes taking place on the planet Bespin at the beautiful floating metropolis known as Cloud City, administered by Han Solo's old smuggling buddy, Lando Calrissian.

It is, in fact, at the magnificent "City in the Clouds" where most of the computer updating was done for this re-release, making it even more glorious and gorgeous than originally was the case.

Need I say it? A 10 on any scale.

City Promises More Security Atlanta Police promised beefed up protection for that city's Les/Bi/Gay community, but according to Chris Cash, Editor in Chief of Southern Voice, Atlanta's Les/Bi/Gay newspaper, "We are still trying to pin them down on exactly what protection they will provide."

Cash described The Otherside as a bar

that attracts a few Gay men and many Lesbians. She said the choice of that bar as a target was a curious one. "It's not the most popular bar, but it has been around for a long time. It's the kind of bar that people go to early in the evening. Then the older Lesbians go home and the younger ones go on to another place."

Cash said the Atlanta community was

shaken, but that the bombing hadn't caused people to stay home. "Saturday caused people to stay home. evening was a busy night for our bars. People aren't going to let this dissuade them from enjoying themselves.

As word of the bombing spread, Atlanta bars instituted a policy of denying admission to anyone carrying a package or knapsack.

Atlanta's Third Bombing Atlanta Mayor Bill Campbell issued a statement condemning the bombing. was the third pipe bomb incident suffered by the City in the last six months.

The first incident occurred during the 1996 Olympics. Two people died at Centennial Park, the location of that explosion. An Abortion Clinic, the North-side Family Planning Clinic was the scene of another bombing last month.

Seven people were injured in the clinic bombing during which two pipe bombs exploded.

Mayor Campbell has publicly said that the City believes it is dealing with "a serial bomber." Pipe bombs were used in all three incidents. All three bombs contained dynamite and nails. Pipe bombs

were used in all three incidents.

Similar Methods Used in Bombings In two of the bombings, the Clinic and the Otherside, there was a second bomb designed to hurt rescuers.

Federal officials were called to the scene

and launched an investigation. They remained on the scene through Sunday combing the area for clues that might lead them to a suspect.

Officials were denying an ABC report that they had concluded the same person committed all three bombings. The network reported that the bombs used in the three incidents all contained the same trigger mechanism, the same explosives and the same type of nails.

Jay Spadafore, an FBI spokesman, said that the agency has not concluded anything about the identity of the bomber. Two weeks from now, we might have a much better idea if these bombs are made by the same person. More clues are left behind each time a device is discovered or

detonated. Bobby Browning of the Bureau of Al-cohol, Tobacco and Firearms told the press that while there are similarities be-

tween the bombs used at The Otherside

and the other Atlanta bombings there are differences too.

We are certainly exploring the possibility that they were made by the same person or group, but we are not ignoring the possibility that they were not" said Browning.

Feds Called In Spadafore announced that the Federal Task force investigating the Clinic bombing will also investigate the bombing of The Otherside Lounge. Additional federal and local law enforcement personnel will be added to that group. The Olympic Centennial Park bombing will continue to be investigated by a separate task force.

National reaction to the bombing was swift, major National organizations such as the Human Rights League (HRL), the National Gay and Lesbian Task Force (NGLTF), Lambda Legal Defense and Education Fund, and others condemned the bombing and called for federal action.

But according to Cash and others, many members of Atlanta's Les/Bi/Gay community are upset that President Clinton did not condemn the bombing. As one person contacted by The Wisconsin person contacted by The Wisconsin Light put it, "Clinton weighs in quickly enough when it's an abortion clinic, he should have issued a public statement

immediately."
Gingrich, Clinton Condemn Bombing Candace Gingrich who was in Atlanta for a conference, called upon the President and her brother House Speaker Newt Gingrich to condemn the bombing with same vigor they used in condemning the

Abortion Clinic bombing.
"If you recall when the (clinic) bombing happened in Sandy Springs, within minutes ... the president and my brother were denouncing what happened," she said of the abortion clinic blast.

Following her comments, the Speaker's office issued a statement quoting Newt Gingrich as calling the incidents "inexcusable acts of terrorism.

President Clinton finally spoke up on the Monday evening after the bombing. The President called the bombing terror-

ism and called upon all Americans to stand together against hate crimes of this nature Georgia Militia Involvement?

Speculation on who might have committed these acts runs rampant. It is worth noting that the day before the bombing, three members of the Georgia Militia, a radical right wing group were sentenced from 6 1/2 to 8 years on pipe bomb conspiracy charges.

When asked if the sentencing had anything to do with the bombing, Mayor Campbell said that the possibility was

Last Spring members of an Arizona Militia group were arrested on bombing conspiracy charges. In that case, the group had been planning to bomb, abortion clinics and Gay bars among other targets.

Lambda Defense Fund Speaks Out
Calling the bombing "a cowardly, despicable act of hatred," a Lambda attorney
met on Monday, February 24th, with local Lesbian and Gay lawyers to discuss civil rights issues, including anti-Gay violence.
"We will not be bombed back into the closet," Lambda Staff Attorney David

Buckel said.

Lambda Executive Director Kevin Cathcart said, "Martin Luther King, Jr., warned that the fight for justice is often met by violence. No terrorist will deter our work toward achieving full recognition of civil rights for Lesbians, Gay men, and people with AIDS and HIV.

Cathcart, who is to meet soon with Atlanta supporters, added, "There is much civil rights work to do in the Southern Region. We have no doubt that, just like the Lesbian and Gay community in Atlanta, Lambda will thrive in this region."

Cathcart was referring to the fact that Lambda is planning to open a Southern

Regional Office very soon.

treatments and effective prevention strate-gies, that both of these budgets remained mostly on the sidelines of AIDS instead of committing aggressively to the front-lines in the fight against AIDS," said Doug Nel-son, executive director of the AIDS Resource Center of Wisconsin (ARCW)

President Clinton's Budget The proposed 1998 Federal Budget includes only some modest increases in funding for HIV and AIDS services that do not meet the challenges of the worsening AIDS epidemic in Wisconsin or

throughout the country. The spending plan fails to increase funding for AIDS medications and recommends the smallest increases in CARE Act funding during the Clinton administration. The budget did include increased funding for HIV prevention, AIDS research and housing for people with HIV and AIDS.

"Typically, the President's budget has been the high-water mark in terms of AIDS funding from Washington. This year, the AIDS community needs to exceed the President's mark to even begin to address the needs of people with HIV and AIDS," said Mike Gifford, director of Public Policy at ARCW.

The President's proposed budget also includes a \$22 billion cut in Medicaid funding over five years achieved through a per capita cap on expenditures. Nearly 53 percent of adults and 90 percent of children with HIV and AIDS rely heavily upon Medicaid for access to health care including the new AIDS treatments. A federal per capita cap may result in greater financial pressure on all states to provide comprehensive care, which may result in states initiating cost-saving plans that could include eliminating non-mandatory services such as coverage for medications.

The good news is that the president is asking for increases for care, prevention, housing and research at a time when other discretionary spending is static," said Winnie Stachelberg, HRC's legislative di-rector. "Unfortunately, these increases are not enough considering that we could be on the threshold of beating back this epidemic. To achieve the goals articulated in the White House strategy, President Clinton must commit the money now, for treatment of those already infected and for research aimed at finding a cure,


Stachelberg went on to say that "Imposing such restrictions on Medicare could be devastating to thousands of people living with HIV and AIDS and might limit their access to the new class of drugs that have improved and prolonged so many lives," she said.

A bipartisan National Governors Association and a bipartisan roster of senators have joined a chorus of groups opposed to

Stachelberg said. "We also continue to believe that the administration should encourage states to implement needle exchange programs because such programs have been shown to slow the spread of HIV in one of the most vulnerable communities.'

The Need has Never Been Greater

"AIDS remains a top public health threat in Wisconsin. Government leaders need to acknowledge it as a crisis and need to enact policies that provide leadership in the fight against AIDS," said Gifford.

State of Wisconsin statistics report that 799 new AIDS cases have been diagnosed in just the last two years. This total represents about 25 percent of all AIDS cases reported in the state during the 15 year history of the AIDS epidemic.

More than ever, Wisconsin is struggling to deal with the AIDS crisis. The astronomical cost of AIDS care which is quickly surpassing \$200,000 per person identifies the strong need for increased HIV prevention services so that AIDS does not overwhelm the limited available

The stringent protocols to ensure the highest level of effectiveness of new AIDS treatments requires a greater reliance on community-based services and medical management of HIV. A patient on these medications must adhere to strict diets and can barely miss a doctor visit without potentially harming their health status. Both transportation and nutritional services are key to successfully following drug protocols and therefore critical to successfully treating AIDS.

Because any significant gap in taking the medications can lead to drug resistance, continuous medical coverage for access to Inc. is dedicated to the fight against the the medications also requires strong benefits planning.
