#### Compromise Reached on Changing Wisconsin HIV Confidentiality Law

Milwaukee-A group representing AIDS victims reports a compromise with legislators for changing a Wisconsin confidentiality law under which people with the disease need not inform their sex part-

Existing law forbids physicians whose patients have the AIDS-causing HIV virus from notifying the patients' sex and intra-venous drug partners about the risk, unless the patient has died.

Legislation introduced earlier this month would allow physicians to alert partners of patients who test positive for HIV

The move was occasioned by the report of a Milwaukee man who is HIV+. He reportedly told doctors at Froedtert Memorial Lutheran Hospital that he was still having sex with his wife, who doesn't know he has the virus. According to the report, doctors urged him to tell his wife, but he has refused.

The above case is only one of several reported. Physicians can do nothing because of the state's confidentiality laws. The law forbids physicians to tell patients' sex or IV needle sharing partners that

they're at risk unless the patient has died.

To correct situations like the one above, a bill was sponsored by State Rep. Sheldon Wasserman (D-Milwaukee) and State Sen. Peggy Rosenzweig (R-Waynesteen) the treatment of the state of the sta Wauwatosa) that would allow doctors to intervene in cases where there is a substantial risk of HIV transmission.

The issue is of such sensitivity, both in Wisconsin and nationwide, that legislators, the Milwaukee AIDS Project, the Medical College of Wisconsin, the State Medical Society and others have been meeting behind the scenes for weeks to develop a position on which all may

#### Hawaii Legislature Agrees to Constitutional **Amendment Banning Gay Marriage**

Honolulu-The Honolulu Advertiser reports the Hawaii House and Senate have reached agreement on a proposed constitutional amendment they believe would ban same sex marriage. Agreement has also reportedly been reached on the package of benefits and rights for couples who, under the amended state constitution, would be denied the right to marry.

In an effort to steer the decision away from the purview of Hawaii's courts, House and Senate leaders have been struggling for months over the wording of constitutional amendment. The Advertiser reports lawmakers on April 16th, agreed to: "The Legislature shall have the power to reserve marriage to opposite sex

If the proposed amendment clears the full legislature, as expected, voters will be asked to ratify the amendment in the 1988 General Election. Polls taken over the past several years show a sixty to seventy percent majority of Hawaii residents have stated their opposition to same-sex mar-

House and Senate negotiations repeatedly broke down over the scope of bene-

fits that would be granted Gay couples and other non-traditional families in the event the Gay marriage ban was adopted. The House was offering a limited package of five enumerated benefits and the Senate was pressing for a package containing more than two hundred.

The compromise reached late in the night of April 16<sup>th</sup>, provides some sixty rights and benefits guaranteed by the state to couples forbidden by law to marry.

Senate negotiators say a substantial benefits package which included joint health care coverage was absolutely essential if lawmakers were to prove to the courts that banning Gay marriage did not necessarily entail discriminatory practices against Gay couples.

Dan Foley, the lawyer representing the three Gay and Lesbian couples who originally sued the state for marriage licenses, says the case is far from over. If the proposed amendment is adopted by voters in 1998, the 1999 legislature would still have to draft a law banning Gay marriage. Foley says the Hawaii Supreme Court will not wait that long to make a decision on the Gav marriage issue.

Madison-As the vote on AB 104, Wisconsin's Anti-Gay Marriage bill nears, efforts to defeat it are intensifying. The bill is expected to pass the State Assembly but faces an uncertain future in the State Senate.

AB 104 sponsored by State Representative Lorraine Ser-ratti, (R- Spread Eagle) would forbid Same Sex marriages from being performed in Wis-

Openly Lesbian State Representative Tammy Baldwin told the Wisconsin Light that the defeat of AB 104 is im-

Baldwin says that the radical religious right is using AB 104 as an organizing tool. "If they are successful with AB 104, we can be assured that other bills will soon follow."

Indeed, in addition to Anti-Gay marriage bills, other states are also considering or have passed legislation that would ban guidance counselors from referring suicidal Gay teens to Gay operated

groups, bans on Gay organizations on college campuses and in High Schools and even bills that would allow them to confine anyone who is HIV+

Dan Ross, At Large Board Member for Action Wisconsin, agrees with Baldwin. "If we don't act now, we will be facing even worse legislation in the future."
In Wisconsin religious extremists have

made it clear that they want to repeal AB 70, Wisconsin's landmark Gay Civil Rights law, and reinstate Wisconsin's Sodomy laws among other measures.

AB 104 has raised many questions. Some clergy from churches that perform Gay marriages have called it an infringement on their religious freedom. Legal scholars have said that since Wisconsin already defines marriage as a union between a husband and wife, AB 104 is not needed. Furthermore there are an estimated two dozen Wisconsin married couples where one of the partners has undergone a sex change operation. If passed in its present form, AB 104 would in effect annul these unions.

Nevertheless on May 13, the State Assembly is expected to pass the bill. AB 104 has 30 sponsors in the lower chamber of the Legislature. That expectation hasn't stopped or even slowed down efforts to convince

The network rejected Olivia Cruise Lines request to buy air time with the explanation that their ad was unfit for younger viewers. Though shooting of the ad has not yet begun, plans called for the commercial to show two women kissing aboard a cruise ship. The company considered the ad to be a compliment to the theme of the April 30 epi-

Some have called ABC's decision to dock the ad "a double standard" considering that the network is willing to broadcast a show about a Lesbian discovering herself. "As more Gay and Lesbian-themed programming begins to air, network executives will have to take another look at their advertising policies," said Kerry Lobel, Task Force executive director. "They don't seem to have a problem running an ad for other cruise lines with happy straight couples kissing and being romantic," she stated. "Aren't there children watching those programs too?," she asked.

#### GOP Solons Sign Non-Discrimination Policy

Washington, DC-- Several GOP Members of Congress have confirmed to Log Cabin Republicans (LCR) that, as a matter of policy, they do not permit discrimination on the basis of sexual orientation in the hiring, firing or promoting of personnel in their

As one of its top priorities in the 105th Congress, LCR requested written clarification of the non-discrimination policies in each Republican Member's office, specifically addressing sexual orientation. Responses to LCR's March 3 request have begun arriving at LCR's Washington office, including from some Republicans who had not pub-

Rep. Mark Neumann (R-WI) was one of several new confirmations received by Lo Cabin Republicans, including Rep. Charlie Bass (R-NH), Rep. Joe Knollenberg (R-MI), Senator Mike DeWine (R-OH), and newly-elected Senator Gordon Smith (R-OR) and Rep. Jim Gibbons (R-NV). #### Panel Finds Probable Cause in Lesbian Case

Pittsburgh-AP- The University of Pittsburgh discriminated by refusing to extend health coverage to the Lesbian partner of a former writing instructor, a civil rights panel has decided.

Deborah Henson, a lawyer who taught legal analysis and writing, filed a complaint against the university in January 1996, saying the policy violated a city ordinance banning discrimination based on sexual orientation.

The city Human Relations Commission concluded that the policy "has resulted in disparate treatment (for homosexual employees) in comparison to heterosexual em-

The case now proceeds to a private settlement conference. If both sides fail to agree on a resolution, the commission will schedule a public hearing on the complaint.

#### Largest Ever Gay Religious Conference to be Held

Los Angeles—The largest international Gay and Lesbian religious gathering ever held in the Pacific Rim will take place in Sydney, Australia, July 20-25. 1997, according to the Rev. Troy Perry, founder and moderator of the Universal Fellowship of Metropolitan Community Churches (UFMCC).
"This is the first of UFMCC's biennial General Conferences to be held outside of

North America, and reflects our growing commitment as a truly international community of faith," Perry said.

This year's General Conference will feature a public rally at Sydney's town hall, keynote addresses by internationally recognized human rights activists and theologians, an international AIDS luncheon, and much else. Actual selection of the host city for 2002 will take place in November, '97, in Denver, at the annual Board meeting of The Federation of Gay Games. The Federation's site selection committee will be visiting all five cities this spring and assisting the prospective hosts prepare for their presentations in Denver.

#### Nabozny Gets High School Diploma

San Francisco—Lambda Legal Defense and Education Fund and its plaintiff, Jamie Nabozny, came to San Francisco to pick up an honorary diploma. The diploma was presented to Nabozny on April 10<sup>th</sup> from the San Francisco Unified School District. San Francisco Schools Superintendent Waldemar Rojas and Board of Education member Juanita Owens awarded the diploma at Lambda's Seventh Annual San Francisco Spring Reception and Dinner.

"This honor means more to me and my family than anyone will ever know," Nabozny said. "I would like to thank the San Francisco School District for offering this diploma, something that, along with a safe education, I was denied in my home

town [of Ashland, Wisconsin],"
On April 2<sup>nd</sup>, Lambda and Nabozny were also honored when the San Francisco Board of Supervisors issued Certificates of Honor for their anti-discrimination work.

#### Lesbian Activist Says Military Still Discriminates

Fort Collins, CO-AP- A career Army officer drummed out of the military for being a Lesbian said homosexuals in the military are still the subject of witch hunts, in spite of the so-called "don't ask, don't tell" policy.

Margarethe Cammermeyer received several rounds of applause and a standing ovation Thursday, April 17, from more than 600 people who saw her speak as part of Bisexual, Gay and Lesbian Awareness Days at Colorado State University.

#### Company Offers Life Insurance to HIV+

Chicago-AP-AIDS advocates are cheering the decision of an insurance company to offer life insurance to people with HIV, a move seen by many as a recognition of the significant advances made in treating the illness.

I'm certainly amazed that the insurance industry is starting to recognize that there is some real hope out there for people living with this disease," said Javier Salazar, a lob-byist for Washington-based AIDS Action.

Guarantee Trust Life Insurance has become the first in the United States to offer life insurance, albeit expensively, to people infected with HIV. The Glenview-based company specializes in insuring high-risk individuals and is test-marketing the coverage in

"From a life insurance risk perspective, we believe many otherwise healthy HIV-positive individuals are more appropriately viewed as having a treatable chronic illness rather than a terminal disease," President Richard Holson said.

The treatment that has helped prolong the lives of people infected with the AIDS virus involves an expensive combination of drugs that includes a new kind called a proteone inhibitor.

tease inhibitor.

#### Same-Sex Marriage Ban Apparently Dead

Olympia, WA-AP- In a prime example of how "up" can sometimes be "down" at the Capitol, Washington senators have managed to strongly approve a ban on same-sex marriages, while simultaneously giving it the kiss of death.

And adding to the slightly surreal quality of the vote, neither side is quite ready to declare that dead means dead.

The short explanation: The ban passed handily, but not before lawmakers removed a requirement for a public vote in September, a killing move, given Democratic Gov. Gary Locke's strong opposition to the measure.

The bill, one of the top priorities of social conservatives this session, is on its second trip through the Legislature. Previously, the measure cleared both houses, but was ve-

toed by Locke, who called it unnecessary, mean-spirited and divisive.

The House struck back a month ago with a bill, HB1130, that would place the issue on the ballot, bypassing the governor's desk. The vote was 50-48, the bare minimum

needed for passage, with eight Republicans joining minority Democrats in opposition.

After days of futile searching for the necessary 25 Senate votes for the referendum, backers on Wednesday agreed to allow three moderate Republicans to sponsor an amendment removing the reference to a public vote. The amendment was approved on an unrecorded voice vote, and the bill then passed 30-18.

#### Committee Tentatively Approves Marijuana Bill

Augusta, ME-AP- A plan to legalize marijuana for medical use has won preliminary approval from Maine legislators.

The Joint Standing Committee on Health and Human Services voted 9-3 in favor of a measure that would essentially protect people with cancer, AIDS or glaucoma from

measure that would essentially protect people with cancer, AIDS or glaucoma from being prosecuted for possessing up to an ounce-and-a-quarter of marijuana. The bill will go on to the full House and Senate after the committee's formal vote next month. According to the proposal, people who use marijuana to treat glaucoma, AIDS, or cancer would be provided an 'affirmative defense" for possessing the drug.

Under an affirmative defense, people still can be charged with possession of marijuana, which is a civil, rather than criminal, offense in this state. But judges would be obliged to dismire the charges and research likely would be a state. obliged to dismiss the charges, and prosecutors likely would not pursue them. Use of marijuana in public would remain prohibited.

Washington, DC—On April 16<sup>th</sup>, The National Gay and Lesbian Task Force (NGLTF) released its bi-weekly update of Gay and HIV-related legislation in US state capitals. In the update, NGLTF tracks measures ranging from making schools safe for Lesbian Gay, Bisexual and Transgender (LGBT) youth to banning Gay and Lesbian couples from becoming adoptive or foster parents.

Of great concern is a North Dakota bill recently signed into law making it the first state to legalize the confinement of people suspected of having HIV. According to the law, emergency personnel, including police officers, firefighters, patients, health care workers and others may secure a court order confining individuals to whose blood they have been "significantly" exposed. Persons may be confined for up to five days and no criminal charges need be filed to be imprisoned.

"This is one of the most chilling and dangerous laws enacted this year," said Kerry Lobel, NGLTF executive director.
"It flies in the face of accepted medical and public health policy regarding HIV. This law will do more harm than good for the people of North Dakota.'

Critics of the new law say the fact that HIV tests of others does not determine one's own HIV status seems to have been lost on North Dakota law makers and the governor. The law goes into effect July 1. **Hate Crimes** 

Hate crimes legislation continues to move forward in a few states, buoying hopes that the number of states with hate crime laws inclusive of Gays and Lesbians will increase by year's end.

"Hate crime laws are of great importance in deterring violence against Gay, Lesbian, Bisexual and Transgender people," stated Lobel. Four of the states with such bills currently have hate crime laws excluding crimes based on sexual orien-

Lobel underscored the importance of having sexual orientation included in these laws, "hate crime laws excluding sexual orientation send a dangerous message that while hate crimes are wrong,

anti-Gay bashing is acceptable."
As of April 16, 1997, the National Gay and Lesbian Task Force tracked 227 Gay or HIV/AIDS-related state legislative measures. Over half, 116 are considered unfavorable or hostile. The remaining 111 are considered favorable to the Lesbian, Gay, Bisexual, and Transgender (LGBT) community.

Marriage Approximately 61 bills banning same gender marriage have been introduced in 32 states. In Rhode Island and West Virginia, the defeat of anti-marriage bills last week was celebrated. This brings to six the number of states (MD, NH, NM, RI, WV, WY) where marriage bans were defeated this year.

Anti-marriage bills remain pending in 20 states (AL, CA, CO, CT, FL, HI, IN, IA, LA, MN, MT, NE, NJ, NY, OH, OR, TX, VT, WA, WI). In five states (IL, MD, NE, RI, WA), pro-marriage bills were introduced. Only those in Illinois and Washington remain alive.

This year, marriage bans have been signed into law in five states (AR, ME MS, ND, VA). Marriage bans have become law in 21 states since 1995. (AK, AZ, AR, DE, GA, ID, IL, KS, ME, MS, MI, MO, NC, ND, OK, PA, SC, SD, TN, UT, VA)

In Nebraska, anti-marriage foes were marriage bill to a vote. During debate, an amendment was introduced to prohibit people three times convicted of assault on a spouse from obtaining a marriage license. The amendment failed, 17 to 15. It is possible the bill will not be rescheduled for another vote.

In Indiana the LGBT community is battling its fourth anti-Gay marriage bill of the year. Three House bills were killed earlier in the session. The newest bill is a House amendment to a welfare-to-work bill. The full House will be voting on the bill in the near future.

In Washington state, a bill remains alive that, if passed, provides for a ballot measure on the issue by as early as June of this

Civil Rights
Approximately 24 bills favoring basic civil rights for Lesbians and Gay men, including making discrimination in areas such as the workplace, housing and public accommodation illegal, have been intro-duced in at least 18 states. These measures remain alive in 11 states (AZ, CA, IL, LA, ME, NE, NH, NY, OR, TX,

West Virginia's died in committee last week. Including West Virginia, civil rights measures re now dead in seven states (AR, CO, MD, MT, NM, VA,

WV). In Washington, the group Hands Off Washington continues its signature gathering to put a pro-Gay employment nondiscrimination measure on the ballot in November.

Domestic Partnership

At least 15 measures have been introduced in seven states and five remain alive (CA, HI, IL, MA, and MN). These measures range from providing a mechanism for Lesbian and Gay couples to register as domestic partners, providing at hospital and prison visitation rights, to extending benefits such as health insurance to same-gender partners.

Domestic partner measures were killed in Colorado and Virginia. An antidomestic partnership bill is moving in Colorado. The bill, which would prevent state colleges and universities from offering domestic partner benefits to its employees, passed a Senate committee. In Illinois a bill was introduced man-

dating municipalities to extend domestic partner benefits to same-gender couples and to extend them to unmarried heterosexual couples as well. While the intent of this law is to undermine the provision of domestic partner benefits to same-gender couples recently approved by the Chicago City Council, NGLTF classifies this measure as favorable.

Historically, domestic partner measures included same and opposite sex partners, reflecting a progressive approach to the reality of families in the United States. NGLTF continues to support broad defi-nitions of domestic partners in these measures.

**Hate Crimes** 

Twenty nine hate crime bills including crimes based on sexual orientation were introduced in at least 19 states (AZ, CO, DE, GA, IN, LA, MA, MN, MT, NE, NM, NY, PA, RI, SC, TX, VA, WV, WY).

The Indiana, Montana, New Mexico, Virginia, West Virginia, and Wyoming bills are dead. Bills in Colorado and Nebraska moved out of committee last week and the Texas bill made it out of committee April 15<sup>th</sup> and now goes to the full Senate. A measure in Georgia missed the deadline to be heard this year but can still be considered next year. Georgia has a two year legislative session.

Of the bills still being considered, four states (CO, NY, PA, RI) would add sexual orientation to existing hate crime laws, while six of the states (AZ, DE, GA, LA, NE, SC) have no enhanced penalty hate crime laws on the books. In Texas, while there is a hate crimes law on the books that includes sexual orientation, the law is crafted such that prosecutions

under it are nearly impossible.

In Arizona, a major showdown over the hate crimes bill unfolded last week. Govemor Fife Symington, who vetoed similar legislation last session, attempted to attach an amendment eliminating specific categories of hate crimes. Such an amendment would have made the bill meaningless. House members rejected th language and passed the measure in its original form. Symington says he will veto the measure. The bill is now in the

In Kentucky, bill sponsors are waiving the ever popular and ever false banner of special rights. A bill was pre-filed that would prevent judges from issuing protective orders to victims of same-gender domestic violence

According to press reports, one Senator stated, "If violence among homosexuals is so profound that they need special protection, the Gay community needs to come forth and explain what its problem

Schools/Campus

Last week, California's Dignity for All Students Bill passed in the Assembly Education Committee. Speaking for the bill were numerous Gay and Lesbian youth and a mother who's son took his own life because of severe harassment and abuse from his classmates at school for being Gay The bill would prohibit bias based on sexual orientation in school employment, curriculum and the treatment of students on campus. A measure

that would prohibit discrimination based on sexual orientation in schools is pending in Connecticut, and in Rhode Island there is a measure that would repeal a law passed last year that lets parents take their children out of AIDS education and sex education classes.

In four states (MO, FL, NH, WA) anti-Gay bills concerning curriculum were introduced, and in three states (CA, CT, NC) anti-Gay bills concerning military recruitment on campuses are being conSodomy

Five sodomy repeal measures were introduced in four states (AZ, MA, RI, VA). The Rhode Island and Virginia bills are dead. In California, efforts are underway to remove those prosecuted under a now extinct sodomy law from a bill requiring sex offenders to register.

Transgender Missouri is considering a measure hostile to Transgendered people. It would make Transgender status of a parent an issue in determining child custody.
HIV/AIDS

At least 26 bills favorably addressing HIV/AIDS issues have been introduced in at least nine states (AR, CO, FL, GA, IN, MN, NM, RI, VA). At least 20 measures deemed unfavorable have been introduced in fourteen states (DE, FL, GA, ID, MA, MI, MN, MS, MO, MT, ND, OK, VA, WA).

In New York State there is a bill in the General Assembly that would eliminate what's left of confidentiality protections for persons with HIV.

"There was a nine percent increase in net income from the 1996 event, which would not have been possible without the generous donations and strong support from the community," said Marge Beil, special events director at ARCW. "We also had 75 volunteers who helped make the 1997 Make a Promise Dinner & Auction the success it was."

Twenty years ago, a group of friends sat down together and began a new organization, a Softball League for Milwaukee's Gay and Lesbian community, the Saturday Soft Ball League. Twenty years and tens of thousands of runs, outs, hits, and yes errors later their dream is still going strong.

The SSBL is one of Wisconsin's oldest Gay and Lesbian organizations. The League

The SSBL is one of Wisconsin's oldest Gay and Lesbian organizations. The League has changed over the years, but the idea of friendly competition and providing an opportunity for Gays and Lesbians to learn how to play and to compete against each

other has not changed.

For over two decades, the SSBL has been building a rich tradition. That tradition includes the first ever Gay Softball tournament, the Wreck Room Classic, now called the Milwaukee Classic, hosting two Gay World series and the first Lesbian World

Series. It also includes great fun, thrilling games, and friendships.

The SSBL has contributed more to our community than softball. Dozens perhaps even hundreds of people have used it as a vehicle to come out of the closet. More than a few players have found lifetime partners on the ball diamonds. Inter city friendships have formed at tournaments held here and elsewhere. The League was also instrumental in helping PrideFest in some years contributing up to a third of its

All of those who worked on the League Board, who sponsored teams, who played, who umped and who cheered should be proud of what they have done together. They

deserve the thanks of the entire community.

Like so many others we are excited about the upcoming anniversary season. If haven't been to the games, there is no better time to stop by Sijan field than this year. With two new teams, dozens of new players, and for the second year in a row, a team from Madison, 1997 promises to be one of the best seasons yet.

So if the up and down Wisconsin weather gets you blue, use a little SSBL magic. If you try you can smell the freshly cut outfield grass and feel the spring air. And in the distance you can hear the crack of the bat, the cheers of crowd and the umpire's cry, "Play Ball." We can hardly wait.

Ellen DeGeneres and Tiger Woods

Maybe you've watched "Ellen" and maybe not. Maybe as some commentators say, the show was a dud, going nowhere; that Ellen's coming out is a last-ditch stand for viewers in the sweeps period. Maybe. One thing, however, is certain. Ellen DeGeneres and her character "Ellen," have gotten Americans talking about LGBT issues—or, more particularly, our community itself.

Whether by design or default, DeGeneres and her character have become one of this month's cultural icons—and whether by design or default, DeGeneres is a pioneer. She is the first leading TV actress to come out as Gay, and the first to portray a lead Gay

There is no denying that role models like Ellen DeGeneres and Tiger Woods can and do make a difference. There have been many of them over the years. Arthur Ashe, Margarethe Cammermeyer and Marvin Liebman and Martina Navratilova come immediately to mind. Like Woods and DeGeneres, these people are role models, but then, in a small way, so are we all who are out. In our own spheres, large and small, it is up to all of us to "make a difference." In that way only one day will we all be free.





#### Being Openly Gay or Lesbian on TV Sure Isn't What it Used to Be

so deftly played by smooth Johnnie Cochran in that Los Angeles trial most of us would rather forget. Less obvious, though just as entrenched and sometimes at least as insidious, is what might by called the Gay card.

Gay and Lesbian history is rooted in decades when the mere whisper that one was not staunchly heterosexual could

wreck careers and lives.

Keepers of public morals kept so-called transgressors firmly in their place, preferably in ominous shadows. Then in 1969 came the Stonewall uprising, in which Gay customers at a Greenwich Village bar fought back against the police, who were often raiding such places. The sea change began. It would accelerate with the advent of AIDS and years of harrowing headlines.

Today the Gay card is no longer an automatic trump for bigots. When still another celebrity is found to be Gay, the prevailing reaction borders on ho-hum. In fact, ABC has been using the once-feared card to drum up publicity for the episode of "Ellen," on April 30, in which the title character played by Ellen DeGeneres, who herself recently came out officially in Time magazine, will announce that she is a Lesbian. "Ellen" is produced by Disney. The times, they really are a-changin'.

On television, back in 1985, the movie "An Early Frost" was justifiably praised as an all-too-rare attempt to deal with the subject of AIDS. It would remain rare for years. But pay cable, not subject to advertiser pressures, was instrumental in altering the content landscape.

Home Box Office, for instance, won numerous awards with the documentary productions "And the Band Played On' and "Celluloid Closet." Now HBO has produced "In the Gloaming," the story of a young man reconciling with his family as he dies of AIDS, and nobody, apart from the usual naysayers, bats an eye as the rave reviews pour in.

Something new is happening, not just in American society but in Gay and Lesbian circles. The Gay image is edging away from the old urban cliches of kinky bars and unbridled promiscuity. Obviously, AIDS hovers over these changes. But the vibrations are unmistakable.

In his new book, Sexual Ecology: AIDS and the Destiny of Gay Men, Gabriel Rotello, urging a new life style of limiting partners and restricting sexual acts, offers what will no doubt be a con-

troversial suggestion that Gay men "re-We've heard enough about the race card ward self-restraint and end the pervasive belief that those who are living at the most extreme fringes of Gay sexual life are somehow the most liberated and the

most Gay."

In fact, as with any other group, Gay and Lesbian images cannot be reduced to one stereotype. This is one of the messages being hammered home by "In the Life," the magazine program examining Gay and Lesbian issues and culture every other month on national public television.

The latest installment takes an "as American as apple pie" approach to Gay and Lesbian lives. Viewers, even many Gay viewers, may be surprised.

With Katherine Linton as host, the program first goes to Detroit, where Gay and Lesbian workers press the big auto makers for gains. "They're going to live with me just as I have to live with them," says one man, who ends up a delegate to the United Auto Workers convention.

Chrysler reluctantly agrees to include a 'sexual orientation" clause in its contract. One significant development is the mu-tual support of Gay and straight co-workers. As someone observes, manage-ment has "an attitude of contempt toward hourly workers, people who work with

Meanwhile, television prime time has been playing the Gay card with startling frequency. On "Friends," speculation continues that Joey and Chandler are Gay, with bemused interest, not indignation.

If Niles on "Frasier," constantly fussing in the absence of the invisible Maris, isn't Gay, he should be.

Once again, Americans seem more so-phisticated and tolerant than hatemongering fringe groups would dare admit.







#### Free Hepatitis B Vaccine Now Being Offered at BestD Clinic

Her full name was Corrine Butters Duke, but everyone called her simply "Miss. Duke." No one was strong enough to dare further familiarity. Miss. Duke taught 5th grade in Third Street School where she ruled with gimlet eye, no more fierce than at test time.

Well, Miss. Duke's gone now, but we all still have to take tests, important ones when lives are at stake—especially yours. However, before our "little" test, there's some information you ought to know.

Hepatitis B

There's a disease running around, a nasty thing, that infects some 200,000 people in this country every year, 75% of them between the ages of 15 and 29. It's called hepatitis B.

The disease is a viral infection that gets spread primarily through contact with blood and semen that comes in contact with those warm, wet places on your body (mucous membranes of the anus, vagina, tip of the penis or the mouth) via a scratch or scrape.

What results, at the very least, are chronic infections that increase the risk of cirrhosis (scaring) of the liver, liver cancer and other problems.

At its worst, hepatitis B can result in death. About 5,000 people die of hepatitis

You may not have heard much about it. In this age of AIDS, its been shoved into the background. However, to put it mildly, like Miss. Duke, hepatitis B is nothing to fool around with.

Symptoms? How do you know if you've got it?

That's one of the problems with it. You may not know if you have it at all. Most infected people experience no symptoms. If there are symptoms, they may not appear for 6 weeks to 6 months after the first exposure.

Even if you do have symptoms, you may think nothing of them. You may have a fever, headache, loss of appetite, feel sick to your stomach and vomit. You may feel "washed out" and have muscle and joint pain. In other words, it'll feel a lot like you have the flu.

In addition, there may be a yellow dis-

coloration of the skin or whites of the eyes (a sure sign of liver disease), along with dark, tea-colored urine and claycolored stools. All or any of these may appear during the infection.

The thing to remember is that no matter how you look or feel, you're contagious. You can spread it around.

The Test

Okay, so how do you know if you're at risk. Here's a few simple questions.

- Have you ever had sex with one or more persons? That includes vaginal, anal or oral sex with or without
- Have you ever shared a razor blade with a friend?
- Have you ever shared a needle to inject drugs?
- Have you ever given first aid to any-one who was bleeding or needed mouth to mouth resuscitation?
- Do you have any medical condition that requires you to receive blood transfusions or dialysis?
- Are you originally from or have you ever traveled to: Asia, the Pacific Islands, Africa, the Middle East or the Amazon Basin?

If you answered "Yes" to any one of these questions, you are at risk for hepatitis B.

There's a Vaccine and It's Free

State Representatives to stand up against it. Strategists say that it the more commotion they can make in fighting the bill in the Assembly the less likely the State Senate will be to pass it. Sources in the State Capitol say that if the State Senate views the issue as too contentious it is likely to keep the bill in Committee rather than bring it to the floor for a debate and vote.

Rallies

With the stakes high, resources from throughout Gay and Lesbian Wisconsin are being thrown into the fight. Rallies have been scheduled for Milwaukee on Monday May 5 at noon in front of the State office building at 7<sup>th</sup> and Wells and in Madison on Monday May 12 from 7:00 PM to 9:00 PM at the State Capitol. **Lobby Days** 

Action Wisconsin, Baldwin and others have also set May 5 to May 9, as lobby days. Everyone is being encouraged to contact their State Representatives and State Senators during that time period.

Activists are also hoping to pack the Assembly gallery during the six hour debate on AB 104 which will begin at 10 AM on Tuesday May 13. It is hoped that by re-peating their success at the bill's hearing in Wausau where Gays, Lesbians and their supporters outnumbered those fovaring the bill, Gays and Lesbians will send a strong message to the State Senate.

In addition to these events, The Wisconsin Light is hosting two parties to help Action Wisconsin raise funds to fight AB 104. Both will be held on Wednesday April 30 during the broadcast of "Ellen's Coming Out Episode." One will be at Scandals, 121 W. Main Street, Madison, and the other will be held at La Cage, 2<sup>nd</sup> and National in Milwaukee.

State Representative Barb Nottestein, will speak at the rally in Milwaukee. Tammy Baldwin will head up the list of speakers in Madison.



Music Therapy involves both listening for relaxation and participation in creating music. Bartyczak has several rhythmic instruments from different cultures to develop the interaction in groups or on an individual level.

#### Marvin Liebman: A Man Out of Sync With His Party and His Times

Marvin Liebman was a Gay man, an inti-Communist and a devout Reaganite. He died March 31" of heart disease—or a self-inflicted broken heart—at George Washington University Hospital.

As a closeted Gay man in the 1950s and 60s, Liebman, a Jew turned Christian, was one of the most prolific organizers and innovators of fundraising in the conservative movement. A top lieutenant to publisher William F. Buckley (who knew Marvin was Gay), Liebman created such groups as the Young Americans For Freedom and the American Conservative Union. He helped launch the Goldwater and Reagan candidacies. No doubt, his work also helped internationalize prodemocracy groups and uprisings in Europe, Asia and Latin America.

But in 1990, he announced that he was not just conservative, but also Gay. In doing so, he felt compelled to denounce both his adopted Christianity and years of heroic work with the American Right. He said in his 1992 autobiography, Coming Out Conservative, that he felt "like a Jew in Germany in 1934 who had chosen to remain silent, hoping to be able to stay invisible as he watched the beginnings of the Holocaust."
He joined ACT UP styled groups and

used their leftish, emotionally violent thetoric to summon the fears of over 50 years ago when fascism and Communism conspired to bring down the United States. Only this time, the fascists were homophobic Republicans and the anti-Semite conservatives of AmeriKKKa

Coming out as a Gay and a conservative, Marvin had an obligation to tell the other side of the story to Gay people-not just join the other side. Instead, he promulgated inflated images of rampant Nazism and skinheads dominating the American mainstream and Gay life.

How sad for Marvin; he was so out of sync with what was really happening in the late 1980s and early 1990s before he died. Despite clumsy and awkward moments, the Republicans and Gay people within the Party had learned to peacefully coexist. When Marvin died last month, more Gay people worked for and contributed generously to his anti-big govern-ment, libertarian, free market Party than

Marvin was well aware of this but he ever effectively said much in his public statements to the Gay press. He knew that former Presidential candidate Barry Goldwater had staunchly defended Gay's rights to be in the Party and the military. He knew that New York's Republican US Senator Alphonse D'Mato, an Italian-American, had done the same in his autobiography Politics, Pasta and Power. Marvin knew Gay Republicans had organized to elect inclusive GOP mayors of the two largest US cities: New York and Los Angeles, and two GOP Governors in Massachusetts and New Jersey.

And there is more that Marvin knew. In 1993, Senate Minority Leader Robert Dole had a majority of his 44 Republican colleagues sign a pledge not to discriminate against Gay staff members, and the National Republican Congressional Committee released a statement pledging to do

A district in Wisconsin reelected a Gay Republican Congressman during the 1994 Republican blowout that captured the US Senate, House and the majority of Gover-norships with nearly 500 new GOP state legislators; meanwhile, Speaker Newt Gingrich told the Washington Blade that Bob Doman did not represent the future of the Party.

Marvin knew all this but chose instead to let his personal angst over his homosexuality rule his better judgement, and he became just another unoriginal neu-rotic voice of fear, an identity-crisis driven refugee marching in the ranks of the dominant and fascist Gay Left

Marvin was also far off base in decrying anti-Semitism in the conservative movement. Had he not noticed that the academic base of the conservative movement is increasingly populated by Jewish writ-ers whose leadership provides invaluable depth and intellectual force to its journals, think tanks, and talk shows?

In renouncing his Christianity as intolerant, had he not noticed the new Hispanic and Asian complexion of American Christianity; or that America was big enough to make room for non-Western religions brought over by the Asian boat people and immigrants he helped create?

Marvin had done so much to create hundreds of activist groups that would propel Ronald Reagan into the Presidency, and in so doing, had provided the world an eloquent spokesman and inter-national force that would liberate every

And when Polish ship yard workers and Chinese students at Tiananamen Square boldly shouted the writings of Madison, Jefferson, Hamilton, Patrick Henry and Reagan at their armed oppressors, Marvin should have been a happy and triumphant man as he saw his life's work evolve, not the morose, angry, screeching alien he had become for the journals of ACT UP and rallies in Lafayette Square.

Poor Marvin Liebman. A diverse world owes this great and Gay man eternal gratitude for developing the forces of freedom that would defeat Communism and totalitarianism. It is a tragic paradox that Marvin would spend his final years propping up the totalitarianism of the Gay Left who believe that all Gays must come out of the closet to defend and promote diversity, and the only way to do this is for all Gays to become angry, anti-social

When Marvin Liebman came out as a Gay conservative, he no longer sang his own song of freedom (fortunately, others picked up his music); instead he sang along with groups that many in the Gay community believe do more harm than good. He did not offer Gay people a choice, merely an echo of despair and demagoguery. He was no longer a triumphant conservative; just another angry and miserable Gay clone.

Rep. Shays and ENDA

For starters, Shays has been a co-sponsor of every national Gay rights bill from his start in Congress, when he took over mid-term from his very popular predecessor (Stewart McKinney), a Gay man who died of AIDS. Back in mid-1987, Shays was anxious to continue his predecessor's progressive agenda, which was in line with his own policies as State Senator and in line with the socially progressive, economically conservative District.

The real reason for Shays' interest in showing leadership on this issue has more to do with his vote on DOMA last summer. He sincerely wants to do the right thing (and usually does), and was quite taken aback by the vehemence of the reaction by the local Lesbian and Gay community to his Yes vote.

Shays showed a lot of guts (or naivete) by showing up at a fund-raiser for Lambda Legal Defense and Education Fund soon after the vote. He actually was invited by someone who lives in the 3rd District, but he certainly got an earful from some hurt and angry constituents while he was there.

As for Shays' influence with the current Speaker-I'm not holding my breath. Shays' admiration for Gingrich approaches hero worship, but that is due in great part to Shays' overweening passion, reducing the budget deficit.

Shays saw the Republican revolution very narrowly as a way to finally break the hold of the ossified committee chairs who, he felt, were in some part responsible for the ever increasing federal budget deficit.

Gingrich has demonstrated that he does not return the loyalty of his subordinates, however much they have stood by him. There is much confusion about what happens inside the bodies of people with HIV before they develop AIDS. In the early 1980's when AIDS was first encountered, it was seen as a collection of diseases that were occurring in people whose immune system was seriously damaged. It was several years before it was discovered that a virus, now known as HIV (Human Immunodeficiency Virus),

caused this damage.

Had researchers understood in the beginning what they know now, there would be no 'syndrome' known as AIDS; instead it would be referred to as the late stages of HIV disease. As tests showed that people with HIV appeared healthy for years before the diseases now known as 'oppor-tunistic infections' began, it was believed

**Pros and Cons** After this, it would be logical to ask why people don't just take an antiviral combi-

nation right away, as soon as they know that they are infected with HIV.

One of the reasons to wait is the side effects of the drugs, some of which can be severe. There are those who are early in the disease and want to wait for better drugs, afraid that using the ones we have now might preclude them from using better ones later.

And there are people who are simply not ready to take medicines every day on time for the rest of their life. The best argument for waiting is that it is not yet known if taking these powerful drugs for long periods will have serious implications.

But even taking this into account, many researchers now believe that the earlier one starts, the better for the health of the body in the long run.

The message is simple: There is no latent stage. From the beginning HIV is running rampant and, if it remains untreated, will cause damage which can't be felt or seen. There are now ways to

control that damage.

#### It is the Duty of Congress to End Workplace **Discrimination Based on Sexual Orientation**

Commentary by Rep. Tom Barrett In Georgia, a woman was dismissed from her job at The Cracker Barrel Old Country Store in 1991, because she failed to demonstrate normal heterosexual values.

In Michigan, a Gay employee of the US Postal Service, complained to his supervisors about the daily harassment he received from his coworkers in the bathroom. When he tried to file suit under the Civil Rights Act, the court ruled that federal law required them to dismiss the

men and women are denied job opportunities, simply because they are Gay, Lesbian or Bisexual. With absolutely no recourse under current federal law or the Constitution, Gays and Lesbians have no means to seek justice against those who discriminate against them purely on the basis of sexual orientation.

That is wrong.

Just as our government worked so hard to deliver justice and full equality in the courts for all Americans regardless of race, religion, gender, national origin, age, or disability, we must fulfill our mission of achieving full civil rights by ending injustice on the basis of sexual orien-

It's not a matter of "special rights" as some have argued in Wisconsin, it's simple justice.

I have joined once again with my colleague Barney Frank in originally cosponsoring legislation about this change. The "Employee Non-Discrimination Act" (ENDA), which prohibits employers from making decisions about hiring, firing, promoting, or compensating an employee based on sexual orientation.


The bill makes clear that preferential treatment and quotas are strictly prohibited and that no claims will be based on statistics about Gays and Lesbians in the

The legislation enjoys bipartisan support in both the House and Senate and came within one vote of passage in the Senate last year. It reflects nondiscrimination policies already in place at major corporations such as AT&T and Xerox. Nine states and 166 cities and counties already have legislation prohibiting employment discrimination. A recent national poll found that 85% of Americans believe employers should not discriminate based on sexual orientation.

While we need to make similar advances to end discrimination in housing, education, medical treatment, and in the armed forces, this bill will lay critical groundwork, and will serve to highlight the clear-cut issues at hand.

Until all Americans cannot be fired simply because of who they are, we will never truly achieve full civil rights in the United States.



Doug Nelson, executive director of the Milwaukee AIDS Project (MAP), said his group wants to assure the patients' pri-

vacy.
"It is a bill that our agency worked on very carefully and came to some common ground," Nelson said. "We were able to protect HIV confidentiality and also were able to address the ethical issues the phy-

The bill would allow physicians to report the names of sex and drug partners of HIV+ patients to the Wisconsin Division of Health's partner notification program. Workers from the program then would contact the people and tell them they're at risk, without revealing the name of the patient.

Nelson expressed confidence that the AIDS Resource Center of Wisconsin, MAP's parent agency, would support the move as long as the final wording of the law is what had been discussed earlier.

Nelson added that while ARCW supports "carefully crafted" expansion of the HIV disclosure laws, "no legislation will ever take the place of every individual taking personal responsibility to protect themselves from contracting HIV.

Ross Walker of Milwaukee's BestD Clinic said that he concurred with Nelson that the compromise proposed "is both ethically prudent and appears to keep intact Wisconsin's excellent record of cli-

ent/patient confidentiality.

Walker did, however, express several concerns. One was that since many health care clinicians either do not recognize or are "blind" to same-sex relationships, "this will primarily address heterosexual relationships.

"I am not sure that legislation is the answer to this nagging concern of many of us working as HIV/AIDS service providers," Walker said. "Those of us involved with anonymous HIV counseling and testing are periodically faced with this same public health dilemma. We often know, but we can't tell," he emphasized.

Walker said that the existing Wisconsin HIV/AIDS reporting statute and automatic referral to the Division of Health Partner Referral Programs "accomplishes about as much as what is proposed.

"I am not sure that persons with HIV/AIDS who now refuse to access Partner Referral will change their postures

under what is proposed."

Under existing statutes, state guidelines and protocols, any person known to be infected with HIV, must be reported to the Wisconsin Division of Health. The person's name is then automatically passed on to the appropriate County Partner Referral Program for follow up. The HIV client has the option to cooperate with Partner Referral or not.

"The problem is real and there is no easy solution," Walker said. "As a matter of fact, I am almost reluctant to address the issue lest it plant new seeds in the minds of those who would publicly stigmatize and scom those with HÎV/AIDS.

"My biggest concern," Walker added, "is that the current debate, pending legis-lation and publicity will be a stepping stone to reduce or eliminate anonymous HIV counseling and testing in Wiscon-

Walker warned that "It would be very easy for those opposing anonymous testing to tack on amendments to what is being proposed in the legislative process. It was better after all. I no longer cared who

knew I was Queer. I could talk to people about being Gay, at last. Maybe I could dispel some of the stereotypes I had grown up with. I was so high on life. Of course, I was naïve.

My friends in my former church sud-denly disappeared. After their departure, my excommunication from the Wisconsin Evangelical Lutheran Synod was announced to me in a letter from my pastor. People stopped talking to me when they found out who I was, and I was targeted by Wisconsin Christians United for a mail box full of hate. I must say I was not equipped to handle this, but I had been warned that it would happen.

The one thing I was not warned about was the sudden abandonment by the Gay community. The already dysfunctional LGB Alliance, which only met to tell jokes once a week, suddenly decided it was too much for them to deal with. I was shunned when I wrote my next column about Gay rights. And I was even more isolated when I urged people to join me in Madison for National Coming Out Day.

The final straw for me was when a member of the LGB Alliance and a friend who had accompanied me on my rounds of three of Madison's Gay bars, decided he didn't like my article criticizing the Alliance for its total lack of visibility on campus. In a spectacle worthy of ACT he suddenly started shouting. He made quite a scene.

I later found out that he was so scared that I would "out" him that he was willing to resort to violence in order to prevent this imagined action.

What about friendship? What about the bond we shared because of the fact that we were both Queer? All of a sudden, none of that mattered.

Can you see why I wonder where the Gay community is? Rather than welcoming someone who finally stood up for himself, refusing to be forced into a public closet, my Gay and Lesbian brothers and sisters decided to run for cover as fast as they could.

As if they weren't enough of a betrayal, one of my former WELS church mates tried to blackmail me into stopping my writing. Overnight, at least for him, blackmail became a Christian value. I was almost suicidal. I had been betrayed on all' sides. Where could I go for understand-

As it turned out, I had to move to Madi-

Is it any wonder why rural LGBT folk are so invisible? Not only do they have to bear the burden of their ignorant classmates, but they also have to bear the fickleness of their "family."

Why must we feed on ourselves? From the closeted politician who em-braces "family values" and then votes against ENDA to the closeted "Christians" who are more concerned about

what their own "community" might think if they acknowledge they go to church. Steve Gunderson, the last rural Gay

man to go public, forced or not, was ve-hemently criticized by his own "community." We Queer people have too many communities and not enough activists to go around.

As long as this internalized homophobia continues, we will continue to feed on ourselves. As long as we sit back and accept this kind of treatment by anybody, even our own "community," there can be no hope for us.

As far as this Gay man is concerned, the people of rural UW Platteville don't de serve a community. Why fight for people who will stab you in the back at the first available opportunity? It's enough to

#### Ashley MacIsaac: An Unconventional, Controversy

The 22-year old openly gay musician is becoming as well known for his music as he is for his controversial viewpoints and antics. From his frank opinions about his sexual orientation to his appearance on the Conan O' Brien show where he kicked up his legs, while wearing a kilt with nothing underneath, and exposed his

genitals to millions of Americans,

MacIsaac is quite unapologetic for his unconventional points of view. "I don t know if I think being gay is normal. How can I say that it's normal? As much as I know that there are some animals and there are groups of sheep in Tasmania or over in Australia that particularly just have gay sex, that's not for me to go into the idea that they don't have a conscience and learned process as well, and that they've learned to do that because they don't have any girls around them or whatever "he

"But I don't see that it's not normal either because a lot of people are doing it,"MacIsaac adds. "It's normal for a lot of people It's normal for me. It's not particularly normal for let's say my father, who married my mother and had me. He would think that it was very strange. He assumes that we're here for only one reason and that's reproduction. I grew up in a very heterosexual family where typically conversation about homosexuals would be on that would be a joking matter, or along the lines of 'if you ever were or if I ever knew, you'd be cut off,' the whole American way." The outspoken MacIsaac is currently touring to promote his stellar debut opus, "Hi! How Are You Today?, "on A&M records. (He previously opened for Melissa Etheridge and the Crash Test Dummies.) Fusing Celtic folk sounds into contemporary pop confections, with swirls of house and industrial dance rhythms mixed in, the flamboyant musician creates folk grunge with a pop sensibility on the electric fiddle.

The album recently earned platinum status in Canada and it's first U.S. single release, "Sleepy Maggie, "a quirky, hienergy ditty, featuring the Gaelic vocal power of Mary Jane Leonard, is currently climbing the Billboard dance charts.

# The Wheel House's "Lend Me a Tenor" : A Charming Comedy Worth Seeing

"Lend Me A Tenor" is Melanec Wheel ouse's second foray into comedy. It

House's second foray into comedy. It follows the very successful run of "Nunsense" which had five month run at the Milwaukee East Side Dinner Theater.

While not quite as entertaining as "Nunsense", "Lend Me A Tenor" is certainly worth a look.

The production successfully captures the look and feel of the 1930's era during which the story takes place. It has the look and feel of a well done 1930's film farce.

Tito Merelli, a world famous tenor know to his fans as "Il Stupendo" is booked for a one night only performance by the Cleveland Grand Opera company. Merilli arrives with his justifiably jealous wife, Maria.

When Maria discovers a fan, Maggie, hiding in a closet hoping to get an autograph she leaves in a huff. Tito threatens to kill himself, but is talked out of it by Max, who is an assistant to Opera Director, Mr. Saunders ( who is also Maggie's father).

When Tito takes one too many sleeping pills, Max thinks he has in fact killed himself and calls on Saunders to figure a way out of the situation.

Saunders convinces Max to sing Merrili's part in Otello which Max does to great acclaim. The problem is that Merilli isn't dead. He awakes, rushes to the Opera House and is nearly arrested when he tries to gain entrance through the stage door. He escapes only after hitting a policeman.

The second act is a riot of confusion as both the imposter and the real Merrilli narrowly miss each other going through doors of the Hotel suite while entertaining two admiring female fans, Maggie and Diana, who sang Soprano in the production, as well as Julia, the Chairwoman of the Opera Guild.

Throw in a Gay bellhop, and an exasperated Saunders trying desperately to keep everyone from discovering his scheme and you have the makings of a first rate farce.

In the end everything is resolved to nearly everyone's satisfaction, when Merilli is reunited with his wife and Max gets his girl, Maggie.

For the most part the cast was fairly effective in their roles. This was especially true of Robert Fuchs who played Merilli, Karla Sherman who portrayed his wife Maria and Dick Thomas who played Saunders.

Fuch's facial gestures, accent and body language were perfect for the part. Sherman was totally believable as the irate wife of the tenor. Thomas was very good as the scheming Saunders.

Also quite good were John Cullinan as Max and Nancy Hucke who was delicious as the blonde bombshell soprano trying to get into Merrilli's pants and career.

On the negative side of the ledger, was Karen Zimmerman playing Julia. Zimmerman who shined in Nunsense is less than adequate here. The problem wasn't with her acting which was fine, it was with her volume which was not. She was so loud that I was uncomfortable listening to her deliver her lines.

Given her part, some increase in volume may have been justified, but far too often one got the impression that Zimmerman

was shouting instead of giving her lines.

One other problem was that the first act seemed to lag a bit, and the timing for

some of the gags seemed somewhat off. But on the whole this was a charming production with many comedic moments. It is well worth seeing.

Now, years later, I see that phrase pop-ping up all over the place. And you know,



#### 'Chasing Amy' is a Refreshingly Honest, Funny, Sensitive Film

Glenn is puzzled by many things, too many really to mention here but of late, Glenn has been particularly puzzled by the notion of transgender. creasingly included in the names of alternative organizations, what exactly does it mean to be a transgendered person? Is Glenn, as a Gay man transgendered, for

No, Chasing Amy isn't a "transgendered film", nor does director Kevin Smith include any "transgender characters". Yet faithful readers of the Wisconsin Light are likely to be surprised and captivated at this small, curiously disarming film's frank discussion of relationships and the fluidity of sexual attraction.

Warm and winning, Smith's Chasing Amy cannot help but defy easy categorizing. Say romantic comedy and the resulting image is some silly bit of fluff most likely starring a cast member from the hit TV series Friends. Yet Chasing Amy is

both romantic and a comedy.

Holden McNeil (Ben Affleck) and his boyhood pal Banky (Jason Lee) are the successful creators of the "Bluntman and Chronic" comic book characters. At a comic convention Holden becomes dazzled by fellow comic artist Alyssa Jones (Joey Lauren Adams). She is friendly yet seems somewhat distant, perhaps a little less impressed.

Still, their coupling seems assured and imminent. But wait, there's only one minor problem: Alyssa is a notorious lesbian (Glenn wonders if there is any other kind). Banky questions the logic of Holden's fixation on Alyssa thinking, as Glenn did, how unlikely this delightful couple's prospects seemed to be.

But a couple they nevertheless become and as Banky becomes increasingly jeal-ous and resentful of Alyssa's intrusion into their idyllic, dare one say, comic book-like existence, there develops an romantic triangle unusual in big screen cinematic ventures and which forms the essence of Smith's film.

Silly, sophomoric films such a Threesome and Three of Hearts sought to incorporated a gay angle into their pedestrian scripts to tease and tantalize their mainly heterosexual audience.

Not so with Chasing Amy. Just when Smith seems destined to resort to tired old stereotypes, such as exposing Holden's smugness at wooing and win-

ning a Lesbian, the tables turned on him. So wonderfully developed are Holden, Alyssa and Banky as believable and engaging characters that we cannot help but be caught up in their lives and hearts.

Both Alyssa and Hooper (Dwight Ewell) emerge as two of the strongest and most interesting gay characters to have seen in a big screen cinematic motion picture in recent memory. A particularly memorable occurs when Hooper, whose outward militancy masks his Gay soul offers a marvelous comic convention speech about the racism at the very core of that most sacred of sacred films, Star Wars.

Equally fascinating is Jason Lee's Banky, a complex, deeply conflicted character whose latent homoerotic feelings towards his best friend are wonderfully explored without ever resorting to simplistic psycho-babble or any pat solu-

#### Unfortunately, 'Volcano' Lives Up to Its Billing as a Disaster Movie

As if Los Angeles weren't in the news enough today over its pollution, traffic snarles, crime, racism, moral depravity, you-name-it; how about we put an active volcano right smack dab in downtown L.A.? In "real life," L.A. is threatened by all those human disasters mentioned, plus several natural ones: earthquakes, mudslides, firestorms. What the hell, let's throw in a lava-spewing volcano for good measure. And, while we're at it, let's make a no brainer film about it all!

Something's going very wrong at the city's famed La Brea Tar Pits. Temperatures are rising, warning bells are going off. Enter Mike Roark (Tommy Lee Jones) as the city's emergency chief and Dr. Amy Barnes (Anne Heche), the pretty, young geologist he's bound to fall for. Of course, no one heed their warnings, especially not the city's political and economic leaders. Before you know it, a minor earthquake opens up a gaping wound just below L.A.'s concrete surface. A few more unexplained rumblings and you soon have geysers of molten lava, thousands of degrees in temperature, and burning boulders soaring through the air. Hell seems to be literally engulfing central L.A.

Volcano fails as a movie for many rea-sons. As a stock "disaster film," it trots out

all the cliches we've come to expect ever since the genre was born in the early '70s: the scientists no one believes until it's too late; the rebellious teenager put in harm's way who learns a few lessons about the meaning of life; the somewhat nerdy, single scientist who finds true love amidst the rubble and ash; and, finally, Man's inability to confront and win out over the forces of

In Volcano's case, rampaging vulcanism from fire trucks, and a few helicopters evidently capable of carrying more water than they weigh themselves. Secondly, simply, expertly, dynamite a skyscraper in less than half an hour so that it collapses right smack in front of the flowing lava.

End of story? No, not quite. Like any disaster film, it's always good to leave the story somewhat open-ended (sequel, anyone?). Volcano ends with a shot of a rising volcanic cone where the tar pits used to be.

Volcano does offer some neat special effects as one might expect in today's digital domain—the exception being the pocket lint that passes for volcanic ash. Like last winter's Dante's Peak, Volcano comprises silly and incredible events wonderfully presented through popping special effects technology.

Volcano rates a 3 out of 10.

#### '8 Heads in a Duffel Bag' is Mindless, Clueless, Not Funny, Dumb

The first problem with this film is that writer/director Tom Schulman just doesn't seem to have a grasp of story-telling. In Mr. Schulman's inept hands, even this film's routine, sit-comish plot is mangled and confusing.

Seems that Tommy Spinelli (Joe Pesci) is playing the role of courier. His job is to transport heads of eight recently bumped off East Coast hoods to a West Coast mob boss, as proof of their demise.

After a spectacularly unfunny bit, where the self-important Tommy tries to kick a package containing donor organs in transport, the duffel bag of the title is taken from him and placed in cargo. Tommy is assured that it will be the first bag off the plane. Approaching the luggage carousel, Tommy hastily and quite inadvertently grabs the wrong bag, one belonging to Charlie (Andy Comeau). Charlie similarly grabs the wrong bag, likewise never noticing that it isn't his bag.

Glenn must wonder if only sit-com characters are clueless enough to grab someone else's baggage at the airport? And why does neither bag actually look like a duffel bag?

Desperate for the heads, Tommy sets off

looking for Charlie, a journey that leads him to Charlie's college dorm room and where he proceeds to question Charlie's roommates Emie (David Spade) and Steve (Todd Louiso) at length. Thinking that they aren't cooperating, Tommy proceeds to torture them. A scene that has Tommy snapping the underwear-clad Emie and Steve with a wet towel proves to be a happy if unexpected pleasure.

But Charlie is on holiday in Mexico with his fiancée, Laurie(Kristy Swanson) and her parents Dick and Annette (the per-petually tanned George Hamilton and Dyan "Can we say cosmetic surgery" Cannon). It turns out that Laurie is afraid that if her parents find out that Charlie has a whole bunch of heads in his luggage, they won't want her to marry him. Silly girl.

There's more to this pointless film but you just won't care by this point. Sadly, no one is bumped off in the course of this la-

The film's few amusing moments are feeble compensation for this numbingly unfunny macabre farce. See 8 Heads in a Duffel Bag if you dare but remember, Glenn warned you!

#### 'Anaconda' is a Good Film if You Haven't Got the Time to Go to the Zoo

Some people have a natural phobia about snakes. Not Glenn. Now, cockroaches are a different matter. Remember that scene in Looking For Mr. Goodbar, when Diane Keaton is handed a dirty dishrag covered with cockroaches? Glenn still suffers nightmares.

But what can all of this possibly have to do with Anaconda, you might well ask?

Moviegoers who experience a healthy fear of snakes are much more likely to find chills and thrills in Anaconda than Glenn expects that most others are likely to.

Director Luis Llosa wastes very little time or effort with setting up much of a story. Glenn hazards a guess that it all has something to do with anthropologist Steven Cale (Eric Stoltz) leading a documentary film crew on an expedition down the Amazon to find the legendary and previous undocumented Shirishmam Indi-

The misfit crew includes Cale's very pretty gal pal, Terri Flores (Jennifer Lopez), the director of the documentary. Then there is Danny (Ice Cube), her cameraman, the sound mixer Gary (Owen Wilson), a blond surfer-dude and the rather irritating, hopelessly helpless production manager, Denise Kalberg (Kari Wuhrer). Except for Danny Rich (Ice Cube) toting around a camera, nobody else seems to have much purpose on board. The only ones missing from this "three-hour tour" seem to be Gilligan and The Skipper.

Their journey has barely begun before our intrepid heroes come across Paul Sarone (Jon Voigt), inexplicably left stranded on a deserted boat. They invite him aboard but it is impossible not to sense something amiss. He's downright creepy and you just gotta know he ain't gonna bring them no good luck.

Immediately Sarone bangs heads with Cale but after a freak incident with a poisonous Amazon wasp, Cale is left unconscious and the uneasy crew are forced to place their faith in Sarone. Big mistake.

Sarone is obsessed with finding and capturing alive the fabled, lethal 40-foot Anaconda snake and quickly their peaceful little search for some mythical natives turns into a nightmare confrontation with the ultimate evil.

At a mere 90 minutes, Anaconda's frighteningly predictable plot sails along faster than one might expect. In proper action-flick formula, cast and crew manager to be eliminated neatly in reverse order of billing, which still doesn't explain how Ice Cube manages to nab top-billing even in this second-rate snake-fest.

Still, Anaconda isn't exactly a total wasted admission. Surrounded by an attractive. if decidedly lightweight cast, Jon Voigt steals the show with a deliciously over-the-top, scene-stealing outing as the sinister villain Sarone.

Plus, Anaconda boasts some pretty nifty special snake effects. Production notes reveal that 30 real Anacondas were used in filming, but Glenn imagines that the spectacular giant Anacondas that lunch on several characters during the film's climax, were provided by special effect folks Walt Conti and John Nelson. While these effects aren't exactly the most believable or even remotely realistic, they prove to be mighty entertaining, nonetheless and they did have Glenn cheering for the complete annihilation of the sad little

Anaconda isn't terrific but will make for a decent matinee outing while moviegoers wait for the summer's highly touted block-

## The Human Spirit Triumphs in Bruce Beresford's 'Paradise Road'

It's early 1942, and Imperial Japanese forces are sweeping through European controlled Southeast Asia. The so-called fortress of Singapore, a British possession, is about to fall. This is the time and place where this true story begins. We follow a diverse group of women and small children as they climb aboard a small gunboat and are evacuated. The women come from all stations in life—from maids and common laborers to high society types—and from every race in the region, especially Europeans, who dominated this part of the globe prior to World War II.

However, they don't get far, the gunboat is attacked by Japanese warplanes and sunk within swimming distance of the island of Sumatra. Upon reaching shore, the women and children find themselves prisoners of the Japanese Army, which they will remain for the duration of the war.

Paradise Road, written and directed by Bruce Beresford (Driving Miss. Daisy, Tender Mercies, Breaker Morant), is the story of these unfortunate women. They are starved, beaten, humiliated, tortured, and even executed for the tiniest transgression. Their attrition rate is staggering. Yet, in this horrifying environment, the women bond with one another in ways they never would have outside the confines of their jungle camp. They do so despite everything largely because of two women in particular, who, through music, forge a sense of humanity in this utterly inhumane place and time—a sense of humanity that even manifests itself in

some of the brutal guards.

Adrienne Pargiter (Glenn Close) is a classically trained musician who, along with another musically fluent prisonel (Pauline Collins), advances the idea of forming a vocal chorus from amongst the prisoners in an attempt to keep their spirits up and, in a way, show their captors they have not been totally broken and dehumanized. They practice in small groups, always wary of the guards. Finally, they gather together and sing, expecting the worst from the Japanese. What happens next is truly moving.

Paradise Road is a successful film for several reasons. The central characters are convincingly portrayed and interesting. Frances McDormand, best actress Oscar winner for Fargo, appears as a German-Jewish refugee who's the camp doctor, yeat another fine performance by this talented actress.

It's well written and shot on location in Southeast Asia, thus giving the film credibility and presence (living survivors of the actual camp participated in the making of the film).

Finally, there's music—beautifully sung and moving, especially given the circumstances under which it came about.

Paradise Road is far more than just The Bridge on the River Kwai with women in place of men. It's the true story of courageous women, the triumph of humanity over hatred, bigotry and adversity, and the power of music.

I rate this film an 8 out of 10.

# Digital Sound, Character Development Bring Reality of War to Life in 'Das Boot'

There's always been something oddly compelling about war movies involving submarines. Every since the end of World War II, there have been excellent films in this genre, including The Enemy Below, Run Silent, Run Deep, The Hunt for Red October and Crimson Tide. Those last two involved modern nuclear submarines the size of WW II battleships, however, and the claustrophobic effects of being aboard a submarine below hundreds of feet of water with an unseen enemy lurking somewhere above gets somewhat lost on you.

Not so with the gritty anti-war movie Das Boot (German for The Boat, as in U-Boat, "Unterseeboot," the German word for submaring)

The year is 1941. The Nazis are still marching triumphantly all over Europe, but Winston Churchill's England remains unbowed. Hitler is depending largely upon his proud U-Boat fleet to bring Britain to its knees by sinking supply ships crossing the Atlantic. Since the island nation cannot be invaded, starving them into submission will do just fine. There's only one problem: the Royal Navy.

Das Boot follows a youthful, enthusiastic submarine crew aboard U-96 as they cruise the ocean in search of prey, always wary of British destroyers and their terrible depth charges. As U-96 prowls the Atlantic, the crew will taste the very extremes of human experience—blood pumping excitement and stultifying boredom, fierce camaraderie and dehumanization, intense terror and great pride.

Director Wolfgang Petersen (In the Line of Fire, Outbreak) takes you along for this harrowing trip in a masterful way indeed.

Das Boot was an enormous success when first released in 1982 in its 2 ½ hour theatrical release. Now, some 15 years later, a 3 ½ hour Director's Cut is making its way across the country. The re-

released version contains many new scenes of crew life and dialog which serve to make the central characters more interesting—we come to care about them more this way, you feel like you know them, like you're a crew member yourself, almost. Of course, the excellent movement of the camera through the dank and dark submarine aids in this regard, too.

For myself, the most startling and notable difference between the original version and restored director's cut isn't visual, but audible. Indeed, some of the most extensive new work on Das Boot occurred, not on the fading film, but on the soundtrack, which, in a movie about war aboard a submarine, is essential to the viewer's

overall experience with it.

The men in the U-boat live, survive, or die by sound—trapped in a confined space, it's all they have. It's vital, therefore, that when they are terrified by the sound of whirring propellers of fast-approaching enemy ships, shocked by popping of rivets off the hull, or nearly deafened by exploding depth charges, that we in the audience feel such sounds in our own stomachs, throats and hearts—

and we do!

The original sound design and musical score received Academy Awards. Now, with today's digital domain, the film has an 8-track, split-surround sound allowing for a much broader spectrum of frequencies than ever before. The results are amazingly real sounding effects. Even the dead

silences are absolutely quiet.

A new generation of moviegoers now has a unique opportunity to experience Petersen's ideal cut of **Das Boot** in theaters. Complete with newly added footage bringing the characters into sharper focus, restored color and clarity, and a redesigned digital sound system, **Das Boot** is not to be missed. The gritty and terrible reality of war comes to life in no better way than in this film.

Das Boot rates a 9 on a 1-10 scale.







away for a while, but decides he made a mistake coming to America. Out of panic and fear of having to make conversation with total strangers, Charlie begs Froggy to let him go home but Froggy won't hear of it and fixes it so that the lodge owner. Betty Meeks, thinks Charlie is a foreigner who can't speak or understand English.

Betty is fascinated by foreigners, having led a sheltered and backwoods life and looks forward to servicing Froggy's friend. Froggy leaves the lodge for military maneuvers and Charlie decides he can't go through with the lie, but before Charlie can tell the truth the Reverend David Marshall Lee, his fiancée Catherine Simms, her brother Ellard and the local villain, Owen Musser, all think Charlie can't understand them. Before long, Charlie is privy to all sorts of secrets that give him the trump card in all kinds of hilarious situations.

The Foreigner is touted as a sidesplitting comedy, I'd have to agree. I laughed so hard I found myself drenched in tears. The narrative set-up was a little long but necessary for the remainder of

the play.

While some of the subject matter may be 10 years dated and slightly off color by today's standards, one has to remember that most scripts date themselves so Madisonians should chill and not frown on some of the show's political incorrectness. The delivery was a bit pushed (we were, after all, watching the show in the intimate Isthmus Playhouse, not a field house) and watching Charlie play dumb at the beginning got a little tedious, but once Charlie decided to reinvent himself as a real foreigner, things really got fun.

Charlie's mirror image pantomime of the not so smart Ellard at breakfast touched a funny bone I didn't know I had. And Betty thinks she's got an "extra circular" connection with Charlie when he uses hand signals from football, disco and airplane ground traffic controllers to try to communicate. And with a climax reminiscent of The Wizard of Oz, I found

this to be one of my new favorite plays.

Directed by J.R. Sullivan, Foreigner was written by a former Milwaukee Rep performer, Larry Shue. It debuted in Milwaukee in 1983 and then went on to become an Off-Broadway smash. Tragically, Shue died in 1985 in a commuter plane crash. Shue fills the narrative with many comic moments that not only entertain but also make some lovely observations on the importance of friendship and trust.

Michael Herold brings the role of Charlie to life with his facial juxtapositions and made-up language. Margaret Ingraham as Betty gives a fair performance as an old widow with a desperate plea for some

new life in her old one.

Mark Lazar as the filthy, rotten Owen is mean spirited and funny as the "butt" of numerous jokes, literally. Real charm comes from Royden Mills as Ellard who has been taught to believe he's a real dummy but finds new life and talent as Charlie's English teacher.

Add Jeff Knupp as Froggy, Jeff Christian as the preacher who's not so holy and Valeri Lantz-Gefroh as Catherine, the debutante turned preachers wife turned debutante wanna-be and you've got a great show. (If you want Gay sub text, I could throw in the Klu Klux Klan angle of the show and say its about the underdog

fighting bigotry and hatred, but here the good guys win while in real life, while we are still waging the battle).

As Froggy states to Ch finds out how far Charlie has taken the charade, "Enjoy it while you can" The Foreigner is playing Wednesday

people going up and down the hill.

Think of the SSBL and you think of the Wreck Room Classic, now the Milwaukee Classic. Who can forget some of the thrilling games between the Milwaukee Wreck Room Chaps and Side Tracks of Chicago as they vied for the title.

And who can forget Wayne Bernhagen suffering from AIDS trudging up the hill after cheering his team onto to victory.

Think of the SSBL and you think of great -competition between teams like the Finale, the Factory, Your Place, Paradise Books and the Wreck Room Spurs. Teams that seemed so evenly matched that nearly every Saturday schedule had three or four important games on its slate.

The SSBL is said to have fallen in national stature. With the advent of other tournaments, the Milwaukee Classic is not the draw it once was and with the addition of two dozen cities playing in the Gay World Series, Milwaukee has not finished in the top three in quite some time.

But none of that detracts from what the league has accomplished over the years and the visionary spirit that not only created the SSBL, but that helped pave the way for Gay and Lesbian sports on the national scene

Regardless of how Milwaukee may finish in the World Series, the SSBL is highly regarded by other leagues around the country. In fact Ron Burbee, former SSBL Commissioner was elected to several terms as commissioner of NAAGAA, the North American Amateur Gay Athletic Alliance.

Other SSBL officers have also been elected to positions on the NAAGAA Board.

A cursory review of the league's history shows just how much it has contributed.

In it's inaugural season in 1978, the SSBL's original teams were the Ball Game, the Beer Garden, Claire's Belles, the Factory, the Finale, M & M, the Wreck Room and Your Place.

That same year, the League co-hosted the Wreck Room Classic, America's first National Gay Softball Tournament.

Also in 1978, that same year, Milwaukee sent a team to the Second Annual Gay World Series in New York. The Milwaukee Suds finished third out of five teams competing that year.

In 1979, Milwaukee, along with New York, Los Angeles, San Francisco and Toronto, established the North American Gay Amateur Athletic Alliance (NAGAA).

That same year, the SSBL hosted the third annual Gay World Series. The five original NAGAA members were joined by Boston, Chicago and the Twin Cities. The series title was taken by Los Angele's Rusty Nail. Milwaukee again finished

In 1980, the Wreck Room Chaps finished 2<sup>nd</sup> in the World Series held in Los Angeles.

The year 1983 was a banner year for the SSBL and it really started to come into its own. The League grew to 12 teams with nearly 200 players.

In 1985, the SSBL hosted the 9th Annual World Series. The team title was won by Houston's Briar Patch, the Milwaukee Chaps finish second.

In addition to hosting the Gay World Series, Milwaukee also hosted the first ever Lesbian World Series. San Diego's Spoilers won the title.

In 1986, Wreck Room owner Wayne Bernhagen (due to ill health) asked the SSBL to take over his Wreck Room Classic tournament. The First Milwaukee Classic is held.

In 1994, the SSBL began three years of helping Milwaukee's PrideFest. Dozens of league players did grounds maintenance, security duties and tended bar.

In 1994, the SSBL moved from Mitchell Park where it had played from its inception to Sijan Field in Bay View. The move was made necessary when the County converted one of Mitchell's two softball diamonds into a soccer field.

In 1996, the SSBL became an inter city league as Madison's Manoeuvres joined.

This proud tradition of 20 years of fun, sports and friendship renews itself on Saturday May 3, at Milwaukee's Sijan Field, 2128 S. Kinnickinnic as the 20<sup>th</sup> Anniversary season of the Saturday Soft Ball League gets underway.

This year's schedule includes nine teams one more than last year. This year's line up is The Ball Game, Balistreri's Pizza, Club 219, In Between, M & M Club, Mama Roux, Manoeuvres, River West and The Triangle. The players on these teams will battle it out for top honors not only in the league but in two tournaments being hosted in Milwaukee.

is what my whole gig is about - to get a radio song and get people to play "Sleepy Maggie.' Hopefully people will get the whole dance vibe off it. I could become like the Gypsy Kings and people would say he's a great live act and it's wonderful music and it's traditionally based and they'll get into it. But I want to be a pop star and if can get a hit record that would be great, "he says.

"My music keeps the integrity and tradition of the original fiddle sound, but adding this new sort of hook to it, "he adds. "It's that dance, dance, dance, sex, sex, sex, now that I got your attention, I've got a car for sale idea. It's like, here s a drummer and here's an electric guitar player and now that I've gotten your attention, here's that 300-year old fiddle tune from Cape Breton that s in the middle of it.

MacIsaac's stage show is equally as electrifying as his recorded music and earning critical raves. Whether kicking up his heels while wearing a kilt, strumming it out a la Green Day or churning out a cover of the Bee Gee's "Staying Alive,"(a concert favorite), MacIsaac turns in an over-the-

top performance.

The whole gig is about image in one sense, and there has been a whole pile of different images coming out about me, but I only have three labels that I put on myself, and that's that I play the fiddle, that I'm from Cape Breton and that I'm Canadian, "he says. "I have about 300 years of enjoyment behind the music. I stand by my music; it's something that works and that it's good. So whether you're RuPaul doing disco in New York or you're a kid up in Harlem, I don't think you couldn't get into it if you actually listen to it in the right frame of mind.,"he says.

"Modernizing this music is a way of making it relevant to people today. If it takes showing my cock on Conan to make it relevant for someone to want to talk to me or listen to my album, well hey that's what I'll do. I'm still going to go out and play the fiddle tune."

Born and raised in Creignish, on Cape Breton Island of Nova Scotia, Canada, population 280, MacIsaac grew up listening to traditional fiddle music.

His father bought him his first fiddle at age 8 and taught the young lad how to play; from there he began a love affair with the centuries old instrument. For the next nine years, MacIsaac honed his craft by playing anywhere he could, from square dances to local festivals in his homeland.

But life changed for him when he turned 17 and took off for New York City to fiddle in an off- Broadway production of the existentialist play "Woyzeck." Suddenly this smalltown boy found himself amongst the big city slickers and discovered the underbelly of the nightlife.

From drag bars and sex clubs to the dance floors of gay discos, MacIsaac was like a kid in a candy store.

"I went to New York and lived there for about six months. I hung out at the Limelight every night in the 'lick-it' lounge, and then I'd go to the Roxy or the Pyramid and listen to dance music for the first time,"he recalls. "I was going out and buying plat-

> MacIsaac back to Cape Breton after that and realized that he could do transfer his fiddle playing into a pop setting."It suddenly occurred to me that I could play fiddle tunes over this tape of dance music, "he says. "Essentially all my music is about is keeping a beat and keeping a rhythm and that's what the basic element of dance music is about too. I suppose my time in New York had a lot of relevance on my music. Otherwise I wouldn't have gone home and said I want to play the fiddle in a pop setting and that I want to go out and be able to go back to New York and have the opportunity to continue."

> Ultimately, what matters most to Maclsaac is getting people to listen to his music. Taking a 200-year old song, like" McDougal's Pride" and contemporizing it, or at least putting in a setting that it comes

off as being contemporary.

"The whole musical idea of the record was to try and put it in forms that people could somewhat relate to. A song like 'McDougal's Pride', is as PBS as any song think will ever get. And the song before it, 'Devil in the Kitchen,' has that sense of grunge or more hard playing. But if you take away the arrangements of it, it's basically the same structure that I've always been playing," he says.

"I once called myself a fiddle slut. The whole thing I meant by that was just that I will play in whatever sort of situation or wherever I can be put to play in front of new people. And if it is a matter of getting to play with RuPaul in a transvestite bar, well then I'd go out and put on my kilt and kick it up."

Still, MacIsaac can't escape matters of his personal life or his unconventional points of view from creeping into people's perception of him. He admits that some of his view points, including that being gay is more often a choice than not, are "pretty intense, pretty insane in one view," he

"But, if everything I say is completely irrelevant to lots of other homosexual people's head, then they can just look back on it and say, 'Oh well, he's 22-years old and I went through that awkward stage too as a young gay adult and we'll support him anyway.' If they didn't agree with me, I'd just assume they'd say that 'lots of people have had difficult times in figuring out their life and he's probably just one of them as well.

But he is tired of people trying to find a correlation between his sexuality and his music. "All that I assume anybody wants to know when they've asked whether or not I'm gay - or want to know by knowing whether or not any man is gay whether I suck another man's cock. People have all kinds of stereotypes and whatever, but that's what it comes down to. And if people want to know that, then yeah, come and say hi to me personally after a concert and we'll have that conversation, "he says.

"All these things are not things that clearly have much to do with me playing the fiddle, "he adds. "That's why people would assume that maybe I'm racy. When I was 17, I went on stage and played and nobody bothered to really play attention to anything else except the vibe of the music. Then I went to New York and did this play and came back with the idea that I could

sell my fiddle music by putting on an image or doing whatever it took to sell it. And now I have articles that are written in Gaelic papers at home that say the messenger is bigger than the music and that's not the way it used to be. And I guess they're right, and that is the case."

Still, given the choice of defending his off color point of view or talking about his debut opus, MacIsaac prefers to focus on the album and his tour -- the core of what he is

"At this stage of my life, I'm still trying to go out and promote this "Hi, How Are You Today?" project and talk about music and do everything that I've been doing for three or four years with this band. I still have to go out and basically put the fiddle in front, "MacIsaac says.

"However, my original goal of just having a house in Cape Breton has now changed to having a house in Cape Breton, but also to maybe having a house in France," he continues. "Maybe all of this will come to a relevance in 10 years' time and people will say, 'he was this 22-year old freaky fiddle player, but now he sings Wayne Newton songs and he's in Vegas. Or maybe I'll be

in jail writing by that point."

Doubtful. The masterful musician clearly has his sights set on the future. From wanting to pose for Playgirl and record a duet with RuPaul -- a cover of Abba's "Dancing Queen," only called "Step Dancing Queen,"-- to put forth an entire discoinfused recording, MacIsaac has no intention of slowing down or conforming to the masses.

"My next record is probably going to be a dance-orientated and a club record in a

sense, at least in beats, "he says. "I have other sort of more integrity ideas that I want to put on it as well, besides just writing nice simple songs to put a fiddle tune to. I' like to do some speaking on it as well, all about my point in life."



# Please Contribute Something So That the Holocaust May Never be Forgotten

They wore Pink Triangles on their pockets...and in the cruel hierarchy of the concentration camps, they were the lowest of the low.

They were singled out for brutality not only by the guards, but by other inmates as well. And when the long awaited liberation finally came, these victims of Nazi oppression were not released...but were forced instead to serve out the rest of their terms in prison.

Their crime?

They were homosexuals.

As I'm sure you know, the United States Holocaust Memorial Museum is one of the largest and most important museums in the world dedicated to telling the story of the Holocaust.

Though primarily a story of the Nazis' efforts to exterminate the Jews, it is also about their plans for the annihilation of "confessing clergy" German resisters, Polish intellectuals, Soviet prisoners of war, and Gays.

Since the museum opened in 1993, more than 7.8 million people have come to see first-hand what happened to those in Germany and Nazi occupied Europe who did not fit into the Nazi conformist mold

mold.

And in doing so, they have learned—
among other things—that the Holocaust
was not just "something that happened to
the Jews."

It was something that happened to humanity.

Despite the controversy (and over the objections of some), this Museum has never shied away from examining the experience of Gays in the Holocaust.

Yet, despite our efforts, the story of Gays in the Holocaust is still largely untold.

This is what we know.

The Nazis came to power in 1933, pledged to "purify" German society of anyone they considered "abnormal," "aberrant," or "weak."

They began by abolishing all Gay organizations. Storm Troopers raided Gay bars, cafes and meeting places. The Gay community that had flourished in Berlin and other cities in the 1920s, was driven underground.

In 1934, the Nazis created an anti-Gay task force of the Gestapo. And, in the following year, a provision of the German criminal code—Paragraph 175—was interpreted to allow for the arrest of anyone suspected of being Gay.

(Lesbians were largely spared from this persecution. Not out of any sense of understanding or compassion, but simply because the Nazis believed that "Lesbian wombs could breed the master race.")

According to eyewitnesses, prisoners marked with Pink Triangles or patches bearing the number "175" were among the most harshly treated in the camps. They were often the victims of cruel medical experiments—including castration

But the worst blow came at the very end. When the camps were liberated in 1945, and survivors were released to rebuild their shattered lives, those convicted of being Gay were forced to serve out the rest of their sentences meted out by Nazi judges.

No consideration was given for the time they'd already spent in the hellish camps. And no financial reparations were made by the German government. Paragraph 175 remained a part of West German law until 1969.

In the Holocaust, there were people who were victimized because of what they would or would not do. Jews and Gays were different. They were persecuted for who they were. It didn't matter if they were productive and loyal German citizens. It didn't matter if they swore allegiance to Hitler or didn't. It didn't matter what their political or religious beliefs were. The Nazis wanted them gone.

were. The Nazis wanted them gone.
It was senseless, irrational hatred. The same kind of hatred that still haunts Gays, Jews, African-Americans and anyone whom society deems to be "different."

whom society deems to be "different."

That's why the Gay experience in the Holocaust is more relevant today than ever before.

That is why the Holocaust Museum has embarked on this special campaign to remember the untold thousands of Gays who suffered in the camps.

We are asking those of you who read this article, those of you who understand the meaning of "Never Again," to make a contribution so that the work of scholarly research into the Gay experience in the Holocaust can continue.

Money is urgently needed to locate the rapidly decreasing Gay survivors, to chronicle their oral histories, to uncover missing artifacts, to produce new exhibits in the Museum so that all may understand the poisonous results of bigotry.


