State HIV Test Disclosure Up for **Public Hearing**

Madison— A bill that would allow a physician to disclose test results of someone exposed to the AIDS virus is sched-

uled for a legislative hearing.

In a modification of rules that protect a patient's confidentiality, the legislation would allow a doctor to provide the information to someone with whom the patient has had a sexual relation.

It also would let a doctor provide the information to people who share intravenous

drug use with the patient.

Assembly Bill 280 would alter state law which currently allows a doctor to disclose such information only after the person who tested for the AIDS-causing HIV virus has died.

The bill is scheduled for a public hearing Tuesday at 1 p.m. before the Assembly Health Committee in room 417 North of the State Capitol.

Of the 350 individuals who accessed the "First, we locate housing that is long-term, service, approximately 80 percent were single safe and affordable, then we can offer the family a security deposit, three months of rent assistance and utility assistance."

The Rent Assistance Program, which is funded through state and private sources, was started in 1992 to help people with AIDS avoid homelessness when they were unable to continue working, had excessive medical bills or were on unpaid medical leaves from their employment. In the program's first year, MAP provided \$75,000 in rent assistance. The \$250,000 provided in 1996 reflects an increase of more than 300 percent over a four

"In 1996," said Albrecht "we were able to offer six months of assistance. However, this year we are seeing a reduction in the government's Housing Opportunities for People with AIDS (HOPWA) funding at a time when the need has never been greater. Subsequently, we have had to reduce the amount of assistance we provide from six months to three

Despite the reduction in the number of months a consumer may receive assistance, the demand on the service is already exceed-

ing projections for 1997 "The number of people needing this type of assistance, both MAP consumers and persons receiving services from other community-based organizations, is staggering. In March alone, we provided nearly \$24,000 in assistance," Albrecht said. "It is an essential program for the HIV/AIDS community. Without it, many people would not have the necessary housing and stability in their lives to focus on their health, particularly with the new treatments that are available. For many people, this program provides them with a place to call home and an opportunity to fight the disease."

Wisconsin Congressman Mark Neumann has found himself in the middle of a hail of criticism following a report of his statements to a group of Christian Coali-tion members in La Crosse that he wouldn't hire anyone who was openly Gay or

The Congressman, who is preparing a bid against Senator Russ Feingold re-ceived scathing criticism from both the left and right.

According to published reports, the Congressman, who just last April had signed a pledge not to discriminate against Gays and Lesbians in his office hiring practices, told the group: "If somebody walks in to me and says I'm a Gay person and I want a job in our office,' I would say they wouldn't be hired because that means

they are promoting their agenda."

Neumann added, "The Gay and Lesbian lifestyle (is) unacceptable, lest there be any question about that."

While saying that he doesn't ask job applicants about their sexual orientation, Neumann said "I don't ask a whole bunch of questions. A sin is a sin in God's eyes.

The remarks by the Southeast Wisconsin Congressman brought him an unwelcome public spotlight They also brought to the forefront a little known article fea-turing Neumann in the New York Times Magazine.

The article printed on November 3rd of last year quotes Neumann as saying "If I was elected God for a day, homosexuality wouldn't be permitted.

Outraged officials contacted by The Wisconsin Light were uniformly critical of Neumann's remarks.

Extremist Religious Right Tries to Launch Anti-Gay Campaign

Washington, DC--Several major profamily groups launched an ad campaign Wednesday, May 28th, by placing an open letter to American Airlines Chief Executive Officer Robert Crandall in the Washington Times, the Allen American, the Plano Star-Courier, the Louisville Leader and several other papers.
USA Today, as well as the Dallas Morning News and the Fort Worth Star Telegram refused to carry the ad.

The ad outlines American's support of homosexuality through discount fares for homosexual partners, sponsorship of "Gay pride" events and all-night "circuit parties," designation as official carrier of a Gay schoolteachers group, and donations to partisan homosexual activist groups such as the Human Rights Campaign and Parents, Friends and Family of Lesbians and Gays (PFLAG), both of which have labeled pro-family organizations as "extremist" and "bigoted.

The letter is signed by Gary L. Bauer of the Family Research Council, D. James Kennedy of Coral Ridge Ministries. James Dobson of Focus on the Family, Donald Wildmon of the American Family Association, Beverly LaHaye of Con-cerned Women for America, and Richard Land of the Christian Life Commission of the Southern Baptist Convention. The groups collectively represent more than 20 million Americans.

"American is free to market their serv-ices in any way they see fit," said Robert Knight, FRC's Director of Cultural Stud-"They are also free to support homosexual activism. But we are free to alert the American people to their agenda and

Milwaukee Presbytery Becomes First To **Oppose Church Ban on Gay Ministers**

national group's recent ban on ordaining Gays, but one official said what the move means is anybody's guess.

The Presbyterian Church voted in March

to make its ban on the ordination of homosexuals part of church law.

The ban got the majority it needed with approvals from regional bodies in Miami and Charlotte, N.C. The Book of Order, the church's constitution, will be changed to require chastity of single ministers.

It says to the country that Presbyterians are committed to reaffirming their biblical center for faith and practice," the Rev. Jack Haberer said at the time. He was a moderator of The Presbyterian Coalition, a group favoring the amend-

But the Milwaukee Presbytery, a regional group of 51 congregations with more than 15,000 members, approved a "covenant of dissent" by a 2-1 margin on

the matter Tuesday, May 27.
The Rev. Carl Simon, parliamentarian for the Milwaukee Presbytery, said he does not know what the covenant of dissent will lead to. Although the covenant clearly went against the constitution of the church, "simply to advocate civil disobedience is not wrong.

The change to the Presbyterian Book of Order, adopted in March, said, in part: Persons refusing to repent of any selfacknowledged practice which the confessions call sin shall not be ordained and/or installed as deacons, elders or ministers of the Word and Sacrament.'

The Rev. John Gregg, a retired minister who is a member of the Milwaukee Presbytery's Advocacy Committee, among those opposing the change.

"We think that the amendment itself is

There are so many things in the historical confessions that are described as sinful, including having a picture of Jesus in your home, that the amendment opens any number of doors to challenge ordina-

But Jenkins said the national church body had warned dissenting congregations in a letter that the covenant might subject them to legal action in church courts.

The Rev. Phil Brown, Milwaukee's executive presbyter, said he had voted against the covenant and had asked that his opposition be recorded. But he declined to comment further.



Gay Officer Files Suit Against National Guard

San Francisco-AP- A class-action lawsuit accuses the California National Guard of violating state law by discharging Gay guard members. The suit claims that because the California Army National Guard is a state agency, it is bound by state law prohibiting discrimination based on sexual orientation.

First Lt. Andrew Holmes, who was discharged in 1995 after he told his commanding officer he is Gay, filed the suit in San Francisco Superior Court. The suit said it represents all guard members who are still serving but must hide their sexuality for fear of

It asks that a court order require all National Guard officers discharged because they are Gay be reinstated with back pay.

'In bringing this suit, I hope to end discrimination against Gay men and Lesbians who are serving their state and country as members of the California National Guard," Holmes said in a statement.

Man Gets Probation for Shooting at Gay Bar

Somerset, PA-AP- A Wyoming man agreed to enter a quick-plea program for firing a gun during his confrontation with protesters at a Gay bar.

Craig Marple, 37, of Green River, Wyoming, will serve two years of probation in

Prosecutors said Marple fired a shot into a hillside April 26 during an argument outside the Casa Nova in Boswell, about 40 miles southeast of Pittsburgh

The bar has attracted numerous anti-Gay protesters and the Ku Klux Klan since opening earlier this year. A preacher agreed to stop his demonstrations and began giving sermons at the Casa Nova earlier this month.

Marple had been charged with reckless endangerment and a weapons count. He agreed with prosecutors to enter Somerset County Court's quick-plea program. Once he serves his term, his record will be cleared.

Gay Activists Protest United Airlines

San Francisco-AP- Gay activists are protesting the airline's refusal to comply with a law requiring domestic partner benefits for companies doing business with the city.

Several companies from Bank of America to the San Francisco 49ers have complied with the city law, which applies to benefits for Gay or heterosexual couples who

are registered as domestic partners.

United and a coalition of 24 other airlines, through the Washington-based Air Trans-

port Association, have filed a lawsuit to protest the law.

Members of the Harvey Milk Lesbian/Gay/Bisexual Democratic Club are calling for a boycott of United. They say airline officials privately told members of San Francisco's Gay community they would offer the benefits.

United officials say they promised to review the city ordinance. In a statement issued Saturday, Chicago-based United officials said they are deciding whether to offer the benefits, separate from the San Francisco law.

Troy Perry Condemns Proposed Alabama Law

Los Angeles-A proposed law before the Alabama state legislature has kindled the ire of Rev. Troy Perry, founder and moderator of the Universal Fellowship of Metropolitan Community Churches (UFMCC). On June 1, condemned the "unconstitutional religious bigotry" of SB-1, a bill that has come before the Alabama State Senate in each of the last two sessions.

The bill provides a \$1,000 fine for any clergyperson who officiates at a wedding for a

same-sex couple.

"Let me be very clear," Perry said. "The day any such bill passes the Alabama legislature, I will be on a plane for Montgomery where I will invite all of our UFMCC pastors, as well as enlightened clergy from any other faith community, to join me on the steps of the Alabama Capitol for the largest mass wedding for the Gay community ever seen in Alabama.'

The bill is sponsored by Sen. Roger Bedford.

"I find myself amazed that an elected official who is sworn to uphold the Constitution would endorse and introduce legislation that so obviously violates the separation of church and state," Perry said. "I will serve time in jail before I will allow the government to dictate our religious practices.'

Florida's Same-Sex Marriage Ban Becomes Law

Tallahassee, FL-AP- Marriage in Florida will remain a bond between a man and a woman, even if other states should recognize Gay marriages, under a bill Gov. Lawton Chiles will let become law.

"This issue should not be decided by the action of another state--it should be addressed by Floridians," Chiles said in a statement issued by his office. "I hope that my decision is not the end of the debate, but the beginning of a dialogue.

Under the new law that takes effect Thursday, June 5, Florida will not recognize

same-sex marriages allowed in other states.

No state allows Gay marriages. But the state Supreme Court of Hawaii may approve

such unions in the future

The governor said the bill does not limit the ability of companies to give benefits to Gay partners but does protect Florida's right to make its own decision about allowing Gay marriages.

I believe that, by and large, most Floridians are tolerant and will one day come to view a broader ranger of domestic partnerships as an acceptable part of life," Chiles wrote in a public statement about his decision.

But that is not the case today.

Portsmouth Priest Comes Out to Congregation

Portsmouth, NH-AP- Rev. Robert Stiefel had become known in the community as priest of "the church of the open door," a priest who welcomed Gay men and Lesbians and battled prejudice against them.

So Stiefel said it was only right that he be open with his parishioners at Christ Episcopal Church and his colleagues about his own homosexuality.

So at services Sunday morning, May 25, the 55-year-old priest told his church community he was Gay. 'Life in the closet is profoundly debilitating. I know because I have endured it for some 50 years." Before the service, Stiefel and his wife, Jennifer, who is the church deacon, sent out a

letter to the congregation saying they had built a good marriage over 27 years. But the letter also spoke of the pain and confusion Stiefel and his wife coped with as they tried several methods offered by the church and modern psychiatry to "cure" his sexual orientation.

"Before we decided to get married, I told Jennifer I was Gay," Stiefel said. "But we were young _ what did we know? I had been trying since early childhood to be the best 'straight' little boy in the world."

Soon after he married, Stiefel enrolled in an experimental program offered by Harvard Medical School for men who hoped to be cured of their homosexuality.

For three years, he went to weekly sessions of individual and group therapy, and one winter he underwent electric shock treatments five times a week. It didn't work, and neither did anything else he tried over the next 20 years.

"The resources that the society and the church offered us were misguided and hurt-ful," Jennifer Stiefel said. "Through all of this, I came to understand and to feel, more and more deeply, how Robert was struggling, both to affirm our relationship and to find and accept his own center."

The Stiefels said they will separate soon and divorce by next year.

Gay Rights Bill Comes Back to Life in Oregon
Salem, OR-AP- Softening his opposition to a Gay-rights measure, Senate President
Brady Adams says he will allow an alternate version of the bill to proceed through the
Senate. Adams, (R-Grants Pass), had steadfastly refused to allow changes to the House

measure that would have increased its chances of passage in the Senate. The bill easily was approved in the House, but it has languished in the Senate Livability Committee. The original bill, HB3719, bans employer discrimination against workers on the basis of sexual orientation. It was introduced by Portland Rep. Chuck Carpenter, the Legislature's only openly Gay Republican, who joined Democrats to maneuver the bill through the House to a resounding 40-20 victory.

Two main concerns arose from the bill: that it didn't include a "loser pays" provision to prevent frivolous lawsuits against employers; and that it was ambiguous about which

religious organizations could be exempted by the law.

During debate on the House floor, Carpenter assured lawmakers the problems would be worked out in the Senate, but Adams said the bill had to remain in its original form. Brown's forthcoming bill contains language addressing the two main concerns, Adams said.

That would make it almost identical to the revised bill Carpenter promised. Carpenter has said his bill, with the necessary amendments, would have enough votes to pass the Republican-controlled Senate. He said all 10 Democrats and seven Republicans are lined up in support of the measure.

Court Sides With State in Gay Case

Atlanta-AP- In a key Gay rights case, a federal appeals court has ruled that the Georgia attorney general did not break the law when he withdrew a job offer to a Lesbian planning to marry another woman.

The 11th U.S. Circuit Court of Appeals said Mike Bowers had the right to reject any

employee whose conduct he believed might be at odds with his positions and under-

mine his credibility with the public.

The 8-4 decision released Friday, May 30, drew immediate criticism from the American Civil Liberties Union, which is considering an appeal to the U.S. Supreme Court.

Bowers, who has resigned to run for the Republican gubernatorial nomination, said

he was pleased. Bowers was the one who defended the state's anti-sodomy law before the U.S. Supreme Court in 1986.

Clergy Criticize Promise Keepers

Kansas City, MO-AP-- A group of Kansas City clergy on Friday, May 30 criticized organizers of the Promise Keeper rallies as right-wing political activists, with repres-

sive attitudes toward homosexuals and women.

The Rev. Susan Helm-Davis of Hillside Christian Church said the Promise Keepers view submission of women to men as honorable. Relationships are "more like an employer-employee" or "slave-master," she said.

Helm-Davis spoke at a news conference earlier Friday with three other local clergy, who said they wanted to divulge what they called the truth about the Promise Keepers.

"They are talking about keeping Gays in the closet and women in the kitchen," said

the Rev. John Swomley, pastor at United Methodist Church. The information the clergy presented in Kansas City is not true, Dave Townsend, a

Promise Keepers spokesman, said in a telephone interview. Promise Keepers urge men to honor their spouses just as women are urged to honor their husbands. Townsend said the Promise Keepers don't endorse Gay and Lesbians relationships but do not pass judgment on Gays and Lesbians.

What they discuss in these accountability groups is very alarming," Swomley said. 'They use the Bible in very dangerous ways, using only portions of the Bible that they

Mass Same-Sex Wedding Not Illegal

Bozeman, MT-AP- A wedding ceremony for Gay and Lesbian couples planned June 8 during the Pride! weekend in Bozeman does not violate the Montana law against

same-sex marriages, two lawyers say.

"Anybody can have any kind of a ceremony they want," said Holly Franz of Helena, one of two lawyers who argued before the Supreme Court to overturn Montana's deviate sexual contact law. The case is pending.

However, she noted that the state will not recognize it as a valid marriage, and those participating will not have the legal rights of married couples.

Assistant Attorney General Clay Smith of Helena said the ceremony is "probably

protected speech under the First Amendment. The mass wedding is planned for 11 a.m. June 8. The ceremony is part of the Pride! celebration June 6-8, when an estimated 500 Gays and Lesbians are expected to gather

in Bozeman. However, a local Baptist minister said the weddings are illegal and represent a bellig-erent attitude on the part of the Gay and Lesbian community. Gays and Lesbians are acting "against the laws of God," he said.

University Prexy Accused of Raping Cop

Harare, Zimbabwe-AP- Former President Canaan Banana, under investigation for alleged homosexual rape of a police aide, has been fired from his teaching post at Zimbabwe's main university, the official news agency reported Thursday.

Banana, 61, a Methodist minister, academic and professor of classical studies, theol-

ogy and philosophy, was relieved of his post at the Harare university and cleared out his desk earlier this month, the Zimbabwe Inter Arican News Agency reported.

Banana has refused to comment on allegations by former Police Inspector Jefta Dube that he was raped and forced into homosexual acts while on Banana's presidential staff.

Banana became non-executive president after independence in 1980. Robert Mugabe,

then prime minister and the nation's only black ruler, became executive president in 1987. Banana received a pension and diplomatic and tutorial assignments from the

Police have said students, soccer players from a team sponsored by Banana and soldiers have come forward with reports of homosexual abuse by the former head of state. Banana's predatory homsexuality was rumored long before Mugabe launched an outspoken campaign against Gays two years ago, describing homosexuals as "lower than dogs and pigs."

The ex-president is married with four adult children.

Maine Governor Tries to Stop Referendum

Augusta, ME-AP- Gov. Angus King will ask Gay-rights opponents to back away from their plan to challenge the civil rights bill he signed May 16.

King asked if he could meet with leaders of the Christian Civic League of Maine on June 6 at their headquarters in Augusta to make his case against the group's plan use the "people's veto" to overturn the law.

The governor will urge the civic league to drop its opposition to the law, or at least delay an attempt to reneal it for several years to see how the law works.

delay an attempt to repeal it for several years, to see how the law works.

The bill to bar discrimination based on sexual orientation in employment, housing, credit and public accommodations takes effect 90 days after the Legislature adjourns. State law already outlaws bias based on several other criteria, such as age, race, gender and physical handicaps.

"I appreciate the fact that he is talking to us," said Michael Heath, executive director of the civic league. But he said the group is unlikely to abandon its opposition to Gay rights because King asks it to do so. The league will make a final decision on whether to seek a public vote no later than

Sheriff's Chaplain Quits Over Lesbian Bigotry
San Rafael, CA-AP- A Novato minister who quit a ministers group after learning
that a member is a Lesbian has resigned his post as a Marin County sheriff's chaplain. The Rev. W. Lee Grady's resignation has been attributed to comments he made about

"My appeal to the ministers is, 'Don't let this split us up.' Satan is certainly an ace at loing that," Grady told the Marin Independent Journal last week in regard to the Novato Ministerial Association. "This lady, if she were living a clean life, my goodness, she would be welcome like all of us."

Sheriff Robert Doyle said that, if Grady had not resigned, he would have been re-

moved from the program.

Yes, I Am A Gay Teen, Damn It. Do You Have a Problem With That?

Charlotte, NC-Tamara Fry felt shut in, Coming out meant telling the world she's Lesbian.

It meant telling her father, a Baptist minister. It meant she could lose school friends, be shunned by family members and condemned by the church.

"I knew I was different from the other kids," Fry said. "I needed to tell some-

body.

In Mecklenburg County, one private agency provides emotional support for LBGT teen-agers, Time Out Youth. At their weekly meetings, Gay teen-agers are free to speak their minds, get advice and, at least for 90 minutes, be themselves.

In North Carolina, individual school systems can develop their health education curriculum, as long as it meets state requirements for heterosexual based ``family living" education.

When the county's health education curriculum was approved by school officials in 1994 95

in 1994-95, an advisory group recommended that homosexuality, masturbation and abortion be excluded from classroom discussions and counseling sessions.

It's what the community wants," said Charlotte-Mecklenburg Schools health specialist John Stoner. "Most of North Carolina has taken a conservative stance.

'If a kid asks a question about one of those three issues, we can give a simple definition and tell them to talk to a parent. If talking to a parent doesn't help, we can refer the parent and child, if they ask, to a school nurse. The parent should be the

number one resource for the child."

Time Out Youth Executive Director

Tonda Taylor has asked school officials to train guidance counselors, nurses, social workers and psychologists to work with LGBT students. She also wants informa-tion about sexual orientation included in the health education curriculum.

The omission of homosexuality from the public school curriculum just adds to the pain," Taylor said. "It's saying these

youth don't exist."

The Rev. Joe Mulligan of St. Luke Catholic Church chaired the Interfaith Advisory Committee two years ago. Mulligan said Time Out Youth is filling the void "until more work is done. But the tenor of the community is such that it will be a knock-down, drag-out fight" to bring about a measure of acceptance and understanding. Mulligan said schools and churches should take part.

We're at a crossroads in Charlotte," he said. "People need to have a better understanding. How this gets done will take a fair amount of diplomacy and wisdom."

When Fry realized at age 13 she was Lesbian, she coped by hiding behind her acerbic wit.

"In the eighth grade when girls were chasing boys, I was beating them up," said Fry, now a 22-year-old journalism student at Central Piedmont Community College. Her family dismissed her behavior as

tomboyish. Fry tried hard to conform. Once, I hung a poster of General Ulysses S. Grant on my bedroom door so I'd

have some guy to point to and say 'isn't he cute?' " She cautiously nudged open the closet

door at age 17. The first ray of light came in the form of a flier about Time Out

The first time I said it out loud, that I was a Lesbian, I was sobbing on someone's shoulder, but the feeling was won-derful," Fry said. "Sure, I've had to put up with the 'butch' and 'dyke' remarks, but I was ready to kick anybody's butt who laid

Time Out Youth members talked during a recent meeting about physical violence and mental harassment they face.

A 17-year-old said he was suspended for lashing out at a student who called him

"The teacher said my presence in the class was disruptive," he said. "I get pushed, thumped on the head and called names when I walk down the hall. Some teachers will stop it and some will just look away."

An 18-year-old has a standard reply for those who call him derogatory names. He stops, stares and proclaims "Yes, I am Gay. Do you have a problem with that?"

Coming out is always a hot topic. How one goes about it varies, Fry said. For some, it's being honest with themselves. For others, it's telling friends and family, or going out in public with a part-

What Gay teens fear most, according to Charlotte psychotherapist Jim Green, is

the isolation.

They hear it at home, at school, everywhere that being Gay is wrong," Green said. "They become depressed and withdrawn. Some turn to drugs and alcohol."

Parents suffer too, Green said. Desperate couples have gone to Green with children who said they were Gav.

"Some parents want me to change the child," Green said. "I tell them it can't be done. You can't turn a Gay person into a straight one. Some parents accept this, others will take their child to someone

People just don't realize how difficult it is to be a young, Gay person," Green said. "In time, society will learn how to

deal with its young, Gay people."

Some teens can't handle the pain and eventually commit suicide, he said. Green knows because of letters left behind or confessions to friends. And there are other painful results.

Fry has barely spoken to her parents in four years. She knows Gay teen-agers who

dropped out of high school.

Some found their way to Time Out
Youth. Founded by Taylor in 1990, the
group has about 40 members ages 13 to 23. It's a nonprofit organization funded by private donations.

The group has blended into a supportive family unit.

Many of the teen-agers plan to flee Charlotte upon graduation. They want to live in cities like New York and San Francisco where the Gay communities are more accepted.

in 14K gold, courtesy of China West Gems in Lake Geneva. Jadite is the most choice cut of the jade, and the carved pendant is valued at \$600.



At its inception, the idea behind a political recall was a good one. If a politician was a engaged in some sort of nefarious or illegal activity, concerned citizens could mount a drive to force whoever it was to face the electorate before the regularly scheduled election. As we understand the recall, it was to be used sparingly and only after the most serious consideration and debate.

Things seem to have changed, at least in Wisconsin.

Now, the recall is being used as punishment for a vote.

As to the Republican Party's support of this recall, we think there is more political

opportunism and expediency than anything else.

We have said over and over again in this paper that we come close to counting on the fingers of one hand the politicians we respect. Senator Russ Feingold is at the top of that list. We did not endorse him in the primary when first he ran. However, we have

since learned to respect him highly, very highly indeed.

Senator Feingold is, sadly, a rara avis among political leaders. He is a man of conviction, a man of great honesty, a man of integrity, who does not blow this way or that

with the popular wind.

That being said, regardless of your stand on partial birth abortion—and whether you agree or disagree with Senator Feingold's vote on the issue, to mount a recall against him on the basis of that vote is, we believe, not only silly and involving unnecessary expense, but dangerous to our country's political health and governmental stability.

Let us not get into the issue here of whether the people of a state can recall a federal

official. Let us only say that we have elections, regularly scheduled elections, during which people can raise any issue they want and vote for who pleases them. An election is the time to call any politician to account—not now.

It is our belief that Senator Feingold is one of the finest political leaders this state

has seen. Let him be judged on his whole record at the time of a regular election. In our opinion, this recall effort should be dismissed for what it is: frivolous.

On Congressman Neumann

Congressman Mark Neumann's remarks on Gays quoted in June 2nd's Milwaukee Journal Sentinel are both wrong and a mistake.

While his position on discrimination on hiring based on sexual orientation may not be clear, it is, perhaps irrelevant now. What is relevant is that he is wrong, very wrong, to demean and degrade a whole people the way he did.

It is wrong, very wrong contribute to the hatred, bigotry and violence directed against us as Congressman Neumann has done. He, and others, can deny culpability, but what he—and they—don't realize is that others, many others, unfortunately, will take Neumann's words as a license to bash.

The way the "thinking" goes is thus: A Congressman, a political leader, said in the paper that Gays were unacceptable (read "no good"), that means we can kick their teeth in. Let's go get the dykes and kill the queers.

Or another way: a teen struggles with her or his sexuality. Whoever it is reads Neumann's words. I'm a sinner, the kid thinks. Congressman Neumann said God hates me. And what happens? The suicide rate among LBTG teens is among the highest in the

The Congressman may deny his responsibility, but the fact remains it is not reality that most often determines thought and behavior, as it is the perception of reality. We would like to ask the Congressman if he has ever been called filthy names for being who he is? Has the Congressman ever feared for his safety—or his life—because of who he is? Has the Congressman ever thought that one of his children might be Gay? What then, Congressman? What then?

We would like to tell the Congressman that if we were applying for employment in

We would like to tell the Congressman that if we were applying for employment in his office, we might indeed, tell him we are Gay. Why? Because being in the closet is a hell of a life. Better to get the truth out than to live, sweat-drenched in fear that it will

"Blessed are the peacemakers," someone once said, "for they will be called the chil-

dren of God." The Congressman should reflect on that.

Finally, what the Congressman said was a mistake, perhaps a grave one. In this state, as in the U.S. as a whole, the majority vote tends to go to those who occupy the middle ground. By his remarks, Congressman Neumann has placed himself well away from the center. He has given proof that he is in the camp of the Far Right Wing. Not a good place to be, Congressman, not if you want to win elections, it isn't

Why I Am Not Proud

By Terry Boughner Remember your first time? I remember mine all too well.

It was 1969, August. I had driven to Baltimore on some matter or another and found I had an evening free. This was it, I thought. This is the time I'm going to do it. There was only one problem, I didn't know where any Gay bars were-or even if there were any in the city.

On East Baltimore Street, there was a magazine shop, the kind with sticky floors. I bought a newspaper. It wasn't Gay, but even so, I was scared out of my mind that the clerk would know exactly what I wanted the paper for. He couldn't have cared less. I gave him my money and scurried out.

In the back of the paper, I found what I was looking for, It was a bar called Mary's on Cathedral Street. I drove there, found it and parked five blocks away.

I mean, it was still daylight. Everyone who saw me would know what I was doing there, wouldn't they? Didn't I have my name and address written on my fore-

Finally, I plucked up whatever gumption I had, went up to the door and slipped inside. Down the stairs I went. To my absolute amazement, what I found was-a bar. It looked exactly like any bar I'd ever seen. There were men sitting around. They were talking, that's all, talking in low, conversational tones, chatting over beers or drinks.

I ordered a beer and found to my sur-prise (and consternation) that, far from being importuned or hustled, no one was

paying any attention to me at all. Eventually, that evening, I got to know some people, and I've been to a lot of Gay bars since, but never will I forget that first time, going to Mary's. I was scared, very

me? (I told whoever I met that I was from Cleveland, thinking that if I mentioned Pittsburgh, I'd be pinpointed exactly.)

Fast forward almost 30 years. Jerry and I were driving down Wisconsin Avenue this past week. There, on a number of the lamp posts were Rainbow Flags, beautiful Rainbow Flags, fluttering in the wind, and

I remembered going to Mary's that night. There were no Rainbow Flags flying anywhere then (at least as far as I remember). I'd have been hard put to find a Gay newspaper. Equal rights laws were only a misty dream, while domestic partnership same-sex marriage weren't thought of when I slipped into Mary's that

I remembered all that when I saw those flags flying over Milwaukee's streets. I felt-what? - Pride? No, that's not the

word for it, despite its use. After all, I was born with brown hair. I was born with other characteristics. I like those things, but I'm not "proud" of them. I didn't have anything to do with them, any more than I had anything to do with my being Gay. I was born Gay, I am Gay,

and I have always been Gay. That's it. What I am is happy, happy to see those flags, happy that there are Pride celebrations now around the world, happy that in the last nearly three decades since I went to Mary's, people who have been born like me, LGBT people, have stood up.

Yes, we have battles to fight, lots and lots more battles on our road to freedom, but, by God, we have stood in ways I could never have imagined at Mary's that

night. What those Rainbow Flags mean to me is that even with all that still lies ahead of us, we will never, ever bow our heads

The feeling I have because of that is not scared. What if I met someone who knew pride. It's happiness, confidence, pleasure,

It is so good to be free. Even partial freedom is better than none. It is so good, it feels so good, to be marching down the road to liberation instead of slipping into Mary's as I did.

The Pink Triangle

TO THE EDITOR:

The article, "The Pink Triangle" (May 22, 1997, issue) shared a compelling and horrifyof death, love and the choice that one man made at Dachau. Your writer touches on a very important issue: the grave significance of the Pink Triangle and all that it symbolizes. Although I understand the initiative of the article and respect the writer's urgency to call our attention to this symbol, I must also remind others of the large responsibility we have, not only to this symbol-but to the meaning of it.

Klaus Muller, the Holocaust Museum's appointed historian for Nazi persecution of homosexuals, reminds us that symbols have a way of losing their meaning as they are absorbed into consumer culture. I agree. Too often I see the Pink Triangle used as clip art or as an advertising tool.

Most Gay men and Lesbians in Europe, especially Germany, will not wear Pink Triangles because they often become (in part) a fashion statement that trivializes the death camp experience. Some argue that it represents the idea of "never again," while others argue it represents the continued struggle of Gays and Lesbians today. Although I respect these arguments, it concerns me that many forget (or do not know) the meaning. I believe we must be responsible in how we choose to appropriate this symbol.

It is certainly a question of debate as to whether or not we can share this symbol with our own victimization. Does the discrimination and harassment of the present equate the horror and the suffering of homosexuals during the Nazi regime?

Although we do hear rhetoric from the Far Right that has more than a hint of "uberlegenheit" to it, we should always be careful when drawing similarities to our lives today with





Thousands "Take Back The Trails" to **Commemorate Murders of Two Women**

Violets and droopy, yellow orchids poke see what Julie saw in through the brown leaves of the mountain to spread a message. ridges. Warblers are nesting in the hard-woods. With the maples and oaks not yet at full foliage and the air crisp and clean, the vistas from the mountains onto the Shenandoah Valley below are breathtak-

It was amid such splendor that Julie and almost feels like an act of defiance. Lollie pitched a tent on the eastern face of this mountain near the Appalachian Trail during the Memorial Day weekend last year. It was there that they were murdered.

The Lesbian couple were found at their campsite June 1 with their hands bound and their throats slashed. Their killer van- Take Back the Trails. ished without a trace.

Stony Man Mountain, VA-Julie Williams and Lollie Winans knew how beautiful the Shenandoah National Park is this daughter's final hike in the Shenandoah National Park to be with her in spirit, to see what Julie saw in those final days and

"I guess I want people to know that I wouldn't want this to stop anybody from going out into the woods," said Mrs. Williams, 50, of St. Cloud, Minnesota." don't want anybody to feel intimidated. Julie would not have wanted that, either. It

She had plenty of company this past weekend. More than 20,000 hikers in every state along the trail, from Georgia to Maine, also hiked to commemorate the anniversary of the slayings, said Nina Roberts, coordinator of a campaign called

"There is an escalation of fear," Roberts said. "Not for all women, but some women now hike in large groups now instead of alone or with one other person. Some women have told me they haven't been backpacking or camping in the past year, but this (campaign) has sparked a sense of confidence in them." Rosemary Mirocco lives about seven

miles from the campsite where the women were killed, and she took a group of women hiking in the area during the weekend.

"The fact that the murders are unsolved preys on everyone's mind," Mirocco said.
"Violence against women is extremely prevalent, but for it to follow you all the way into the woods, where you expect to be safe, is enraging.

The slayings had a deeper impact in the Lesbian community, said Tracy Conaty of the National Gay & Lesbian Task Force.

The group asked Attorney General Janet Reno if the FBI was investigating the slayings as a possible hate crime. Reno wrote back that the FBI was "myrating all." wrote back that the FBI was "pursuing all motives, including the possibility that the crime was motivated by the sexual orientation of the victims.

Last year's attack was not the first vio-

lence against Lesbians along the trail.

In 1988, Claudia Brenner and her lover,
Rebecca Wight, were on a weekend
camping trip along the trail in Pennsylvania when a fugitive hiding in the forest shot them with a hunting rifle. Wight died, but Brenner survived five bullet wounds. Stephen Roy Carr was convicted of the crimes and sentenced to life in prison.

Relatively speaking, the Appalachian Trail and national parks are safe. More than 3 million people a year use the 2,159-mile trail, and only nine people have been killed on or near it since 1974. Last year's slayings are the only ones that remain un-

hikers at Shenandoah National Park has not decreased, spokeswoman Lynn Rothgeb said.

All of the visitor stations in Shenandoah National Park still display the posters offering a \$25,000 reward for information leading to an arrest in the Winans-Williams slayings. But the pictures of the women, smiling as they sit together on a

mountain crest, are fading.

"We're all realistic that the trail is cold," said Tom Williams, Julie's father. "There is somebody out there who is a pretty damn cold-hearted killer. The FBI is concerned about that and so are we.

Next to the reward posters are notices to hikers describing the crime and urging them to take such safety steps as being cautious when strangers approach and pitching tents well out of sight of trails

and roads.

Jeanne Vandeweile, 40, of Eue Claire, Wis., was undeterred by the slayings. She finished a two-week vacation in the She-nandoah National Park on Monday.

"It scares our families and friends," she said. "They say, Don't you know you can get killed out there? I say that it's more dangerous on city streets. I can disappear and find my way out of here if I need to."

Vandeweile said she drew courage from the story of a woman who was raped in 1959 while attempting to hike the entire length of the Appalachian Trail, from Mame to Georgia. "She finished the hike and then did it two more times. I've had a pretty good life. If something happens, it happens."

Mrs. Williams hiked with about 10 people in the Shenandoah National Park, including several of her daughter's friends.

"When dealing with grief, you try to find a positive outlet," she said. "This not only keeps Julie and Lollie's memory alive, it keeps attention on the case. olved. Maybe it will spark someone's memory from last Memorial weekend."

Some Thoughts to Congressman Neumann An Open Letter to Congressman Mark Neumann from Scott Evertz

Dear Congressman Neumann,

I am writing in reaction to recent statements you made at a gathering of the Christian Coalition in La Crosse, Wisconsin. Let me begin by saying that I never have and still don't believe that you are a prejudiced individual. Despite your comments, I don't even believe that you necessarily favor discrimination against a particular class of individu-Americans, from a sever lack of knowledge when it comes to the diverse group of some twenty million Americans we call the Gay and Lesbian community and I am hopeful this letter will provide you with some of that knowledge.

To begin with, to assume that twenty million citizens could possibly have a singular "agenda" is ludicrous. We are white, Asian, Latino(a) and African-American. We are rich and poor, and many of us like most Americans are somewhere in the middle.

rich and poor, and many of us, like most Americans, are somewhere in the middle.

We are parents and we are childless. Some of us are in long-term relationships. Others of us choose to remain single. Most of us pay our taxes. Some do not. We are stockbrokers and farmers and unfortunately, like many Americans, some of us are

We are Democrats, Socialists, and, yes, we are Republicans. We live in large urban centers like San Francisco and New York, but many more of us live in places like Janesville, Harmony and Sturtevant, Wisconsin.

So, Congressman Neumann, just because a farmer from Sturtevant, Wisconsin ap-

plies for a job in your congressional office and happens to inform you that s'he is Lesbian or Gay, please don't assume that they would approach their position with a particular ax to grind or an interest in promoting the "Gay agenda," whatever that might be. That's downright disingenuous. You certainly wouldn't necessarily assume that members of other minority groups are applying for a job in your office so they may promote their "agenda," would you?

Take me, for instance. Would you not consider my candidacy for employment simply because I may refer to my (same-sex) partner in a job interview?

because I may refer to my (same-sex) partner in a job interview?

Would you ignore the fact that I strongly support your fervent deficit-reduction poli-

cies and your commitment to the American taxpayer? Would you ignore that my commitment to the rights of the unborn (straight and Gay) is so strong that I served as a staff member of the then Vice President of the Board of

Wisconsin Right to Life? Would you ignore the fact that I have political experience working for conservative

Republican candidates for State Assembly, State Senate, the US House of Representatives and Senate, and President? Would you really ignore my qualifications because you happen to know I'm Gay? I

certainly hope you wouldn't accuse me of seeking employment on your staff to merely promote the "Gay agenda."

I've been asked many times by many different people the past two days why I believe you would first sign a pledge indicating you would not discriminate on the basis of sexual orientation in hiring, firing, or promoting of personnel in your office, and then say what you did in front of the Christian Coalition. I've generally responded by indicating that I really don't want to attempt to determine your motives.

I do indeed know that you have received a lot of heat from individuals I would char-

acterize as being a minority within a minority (i.e. the ultra-right wing of the religious right), for signing the pledge in the first place. Congressman, I respectfully ask you to step away from the situation and consider those who have given you this heat.

You have been criticized for indicating that you would consider only an individual's

qualifications for a job, and that it mattered not to you that this individual may be Gay or Lesbian; that you were more interested in the content of their character. You now seem to be asserting that one's sexual orientation does indeed have something to do

with their character, and, on this point, you are dead wrong.

Perhaps that's why the majority of citizens (in some polls as many as 70%), in all states and from all walks of life and political persuasions, indicate that they oppose discrimination against Gays and Lesbians in the work place.

By making the pledge not to discriminate, you were accurately representing the position of the majority of your constituents. Your seeming retraction of that pledge aligns you with a very vocal, but small minority of Wisconsin citizens.

Again, I don't want to assess your motives, but if I were a political consultant advising a Congressman thinking about running for the US Senate, I'd advise him against

attempting to please such a small segment of the population.

I thank you for your time and consideration of the thoughts I have included in this letter. I look forward to any clarification you may wish to provide on this issue.

Programs Promoting Sexual Abstinence Show that Ignorance is Death

The same intense struggles between dif-fering approaches to living occur and reoccur. From decade to decade they seem to resurrect. One returning bugaboo reinvokes our nation's notorious romance with sexual suppression. And repression. Not homosexual repression, but sexual re-

Gore Vidal informed Mike Wallace in a March, 1967 CBS documentary—"The Homosexuals"-- that America is regarded with astonishment in other nations where sexuality--in its varied forms-- hasn't been

allowed such worrisome top-devil status.

There was something else Gore Vidal said in that 1967 documentary making him, in my view, one of America's fore-most Gay liberation pioneers. As David Scott Evans puts it of Vidal, the great writer might soon react as startled if he were called a Gay lib pioneer. Pity. Because that's what he is, like it or not.

Yup, he sat right there with Mike Wallace in '67-two years before the Stonewall uprising— and defended same-sex erotic responses with dignity and with passion, while Wallace slammed forward with stupid, now-discredited psychiatric gobbledygook about homosexuality-thepsychopathology, old-fashioned views which Wallace himself has since rejected. "Homosexual behavior," Vidal told him,

"is perfectly natural,"
"Say's who?" challenged the Mike
Wallace of 1967.
"I say so," Vidal replied authoritatively,

embodying individualism in action.

Vidal, regarded by many as America's foremost historical novelist, and perhaps its greatest living essayist, has a wide-ranging knowledge of world-wide sexuality. He knows that strict sex control, an aspect of the Skygod religions, has stifled

many natural sympathies.

Approximately a decade ago, the enthronement of prudishness--or, rather of abstinence, as the goal of high school sexeducation classes nationwide seemed a

possibility with a future.

Surely sex education, the sanest thinkers hoped, won't become a casualty of such church-state manipulators as Jerry Falwell, Phyliss Schrafley, James Dobson and Pat Robertson. But what, since those scary days, has transpired in sex ed class?

Lets leap across the decade, from January, 1988 to the present—June, 1997. Congress has just recently been offering millions to the states if they'll simply teach public school students that the only thing—the singular thing—they must know about sex is simply that they must abstain. No talk of condoms is to be permitted. Though teen-pregnancy is rampant, there must be absolutely no talk of birth control

Abstinence alone--saying NO to sex-will save the day, dream these fundamentalist-type-congresspersons. Just Say No

Fortunately, educators from coast to coast are, for the most part, loathe to take the citizenry's tax-payer offerings to promote this abstinence business as the only answer to the nation's longtime sexual dilemmas. It isn't an answer, they rightly seem to feel, that's practical.

Almost a decade ago, I wrote and published a piece critiquing the stupidity on a particular under-fundamentalist-control-

school board.

Beginning with an observation that the school board was behaving with hellpaved good intentions and with ignorance, I explained how it was also waltzing in wonderland as it foolishly congratulated itself on a compromise: "condom use is not planned to be discussed by teachers in the classrooms" even though class videos will give some information about these unmentionables.

"What if a student who is sexually active asks for details about condoms? Is the teacher sworn to silence? If condoms have a ten percent failure rate, must the teacher bow before the Far Right's mistake and insist that 90% protection is bad and that there should be none at all for these sexually-active youths? Is the school board unwittingly a participant in a scheme of fundamentalist retribution for sex by

I pointed to the rising AIDS toll among youth. "It will take smaller towns time to catch up but with AIDS incubation (five to ten years) we can look ahead to our present day youths dying like flies.

religious-Whether fundamentalist political activists liked it or not, this particular area's culture had always been lais-sez faire about sex. We're living, I wrote, in a climate hospitable to its (sex's) allure. Large segments are "youths much given

to premarital posturing."
"Will we send them into the arms of

AIDS followed by the non-sound of our foolish silence?" I bellowed. "Will we then think kindly of our own lack of foresight and the school board's decision: that condoms are not to be spoken about by re-

"Or could it be," I ventured with my wickedest question, "that we will see the school board's NO condoms decision as one by 20th Century primitives who compromised with witch doctory and perished

as a result?

"Because of Far Right agendas that view all sexuality as a major threat, the teaching of comprehensive self-protection is being murderously thwarted. Is this san-

I raved on: "Sad contrasts loom wherever sex and hypocrisy walk hand in hand. Our TV soaps focus for weeks on half-nude bodies in bed. Advertising pushes even the lowly toothpaste tube as the path to more passionate kissing. On the other hand, the school boards are willing to adopt this bizarre plan whereby they piously ask young people to abstain from acts of passion glorified for them daily from dawn to dusk

Very well then ,let their plan-Abstinence from Sex--reign supreme. It is a plan devised by those who have forgot-ten what it is like to feel the tantalizing flames of sexual desire coursing through

"Do they not know that youth imagines itself immortal? Are they not familiar with the 'denial factor' which sees AIDS al-

ways as 'their' infection, never 'ours?' The USA has taken too long to learn that this kind of denial is whistling in the dark.

'There is no them,' wrote the brilliant Growing Up Absurd anarchist educator, Paul Goodman, 'there is only us.

And now, a decade later, what is happening across America demonstrates the sound good sense of people in the heart-land, except, of course, in the voting booths. Their Congress-has (because of loony Religious Reich folk) set aside \$250 million, in a little-known provision of welfare "reform,", to tempt local school boards everywhere to insist that only abstinence will be taught in sex-ed classes.

In an unexpected turn-of-events-- the states have not been fast to accept such sex-hush- money, according to The New

York Times (May 8).

To be eligible for this money, local governments would have to agree to teach, among other matters, that pre-marital sex "is likely to have harmful psychological and physical effects.'

States, according to the Times, have only another month to make claims on the \$250 million, but educational officials are clearly worried about undermining more practical efforts to teach safer sex. The local people are smarter in this instance, in other words, than the Congress.
"The limits on what you can say are so

restrictive that we decided we could not use the money for classroom programs or anywhere else where there was face-to-face contact," said the director of Maine's health department. It might be wiser, she surmised, to use the abstinence money to make public service announcements.

Obviously, however, teachers sense

they'd make themselves objects of ridicule if they were to refuse to talk of facts with which students are already familiar, facts, for example, like the existence of con-

Similar reactions have come from educators and public school health specialists across the country, a sign that citizen awareness is growing slowly but surely. There's hope.



A Call For A **New Stonewall**

Barbara Notestein Editor's Note: In this month of LGBT Pride, and on the eve of Wisconsin's LGBT Pride celebration, I think it is very appropriate to print in full the text of a speech given by State Rep. Barb Notestein (D-Milwaukee) at a rally against AB104 held in Milwaukee on May 5th.

Rep. Notestein was one of the primary leaders against the forces of bigotry and hate the welled up to pass the anti-same sex marriage law (AB104). Her words at the public hearing on the bill, at the rally, and on the Assembly floor, are stirring and, I think, must be preserved so that everyone, including future generations, should read her clarion call to justice.

As evidence of her commitment to justice, Rep. Notestein will be riding in the LGBT Pride Parade on Sunday, June 8.

In 1969, Gays at the Stonewall Inn decided that the time had come for significant change in the way they were treated by the police and society. They fought back, they rebelled, and they resisted, creating momentum for real change.

And, in the years since then, much has changed, especially in states like Wisconsin where great progress has been achieved in the legal arena.

But now that progress is being threatened all over this country and in Wiscon-

Given the ascendance of the purveyors of ignorance, bigotry and hate.

Given that the leadership of the Wisconsin State Assembly has recognized and legitimized that ugly voice;

Given that the Assembly is poised to pass AB 104 on May 13

We face a backlash -not from the vast majority of citizens, but from a very aggressive, vocal and determined minority. They wish to impose their righteous and

intolerant views on the rest of society;

They will not stop until their vile hatred spreads an ugly veil over all of society; They don't care about the consequences

of their hate:

They don't care that teenage Gays and Lesbians commit suicide rather than face parental and societal disapproval;

They don't care that many Gays and Lesbians feel compelled to lead closeted lives, fearful of losing jobs, friends, and

Just this week we learned that the pilot who slammed his Air Force plane into Colorado mountains, may have committed suicide, fearing the consequences of being outed in the military.

And, in Milwaukee we see the Journal Sentinel editorial page dismiss the cul-tural significance of "Ellen" as a mere marketing gimmick when we know that a program which speaks so truly to the experiences of many Gays and Lesbians is perhaps a cultural milestone and ought to be heeded.

So where are we in this long fight for Gay and Lesbian liberation and acceptance of Gays and Lesbians?

We are at a new stage.

We are at a juncture when efforts must be redoubled.

And when this long struggle must begin

We are at a point when I say to you that it is time for another but peaceful Stone-wall. Not a violent Stonewall, but a political Stonewall. A Stonewall of such strength that politicians will never even consider legislation like AB 104, a Stonewall that sends the message in no uncertain terms that Gays and Lesbians must be, expect to be, and will be treated

I was at the public hearing on AB 104 in Wausau, the location an obvious attempt to silence the Gay and Lesbian communities across this state. But no one

I heard Gays and Lesbians open their lives and hearts to legislators, speaking eloquently, patiently, tolerantly in an at-tempt to educate.

They spoke about themselves, their families, their children and their lives.

I heard 10 year old Sol Kelly Jones talk about her 2 moms and their lives together as a family in a way that brought tears to

The speakers asked only that Wisconsin treat them fairly and with tolerance.

And so it is time again for the Lesbian and Gay communities to redouble political efforts to make a commitment to the second Stonewall.

The message must be sent forth that Gays and Lesbians will never again be the targets of hate, violence, and discrimina-

Gays and Lesbians will not be treated as second class citizens.

If there is anyone in the Gay and Lesbian community, who has not written, emailed or called his or her legislator opposing AB 104, now is the time to do it.

If there are people in rest of the community who have not sent the same message, now is the time to take a stand and demand that Wisconsin serve as a symbol of truth and fairness.

Wisconsin cannot pride itself as a great state if we allow AB 104 to become law.

The message must be sent and the lesson must be learned that Gays and Lesbians are first class citizens, that Gays and Lesbians deserve to be treated with dignity and respect, that Wisconsin rejects intolerance and hate. That Wisconsin stands above the ugliness that some would choose for us. For Wisconsin is a great state.

And above all else Wisconsin will not

Speaking From The Right LCR-WI Legislative Agenda Advances

Since this year is not an election year, Log Cabin Republicans of Wisconsin (a Republican organization made up pri-marily of Lesbian and Gay Republicans) has been able to devote its time to its legislative agenda for the '97-'98 legislative

While we were, of course outraged at the State Assembly's adoption of AB104, the anti-same sex marriage bill, we knew that the die was cast when Rep. Ben Brancel won the race for Speaker of the Assembly by the one vote which was cast by Rep. Lorraine Seratti, AB104's primary sponsor. We still hope to stop the bill in the State Senate, but that remains to be seen, considering the fact that the vast majority of Wisconsinites oppose same sex marriage and a vote against AB104 can be falsely construed by opponents as a vote in favor of same sex mar-

Despite our disappointment on AB104, several of the items on our legislative agenda have already been adopted by the Assembly, and others we expect will also soon be adopted.

Supermajority for Tax Increases The Assembly has already adopted a constitutional amendment which would require a supermajority vote in both houses in order to raise the state income or sales tax. LCR-WI strongly supports this legislation, and applauds the Assembly's first step toward recognizing that taxes constitute confiscation of property from the minority by the tyranny of the majority.

The amendment must be adopted by the Senate, and then adopted by both houses in the next legislative session before it can go before the voters for ratification.

Adoption in the State Senate is seen as unlikely at this point because the Democrats control the Senate. The Democrats seem bound and determined to remain free to raise taxes whenever they wish.

Women's Health Initiative Governor Thompson and the Assembly Republicans are proposing a Women's Health Initiative which will help address some of the inequities in the health care system concerning women's health.

As the incidence of breast cancer in younger women continues to increase, too little is being done to bring attention to this critical problem. In addition, nothing affects the health of women more than the rising tide of domestic abuse.

The Women's Health Initiative will provide funding for a mobile mammography van which will target low-income women, funding for screenings, diagnos-tic tests, referrals and follow-ups for underinsured and uninsured women, funding for a Women's Health Officer who will coordinate educational programs for women concerning health risks, prevention and treatment and greater access to health screening programs, and funding of block grants for additional domestic abuse shelters in under-served areas of Wisconsin.

LCR-WI strongly supports the Women's Health Initiative, which is expected to be adopted by the Assembly.

Truth-In-Sentencing This initiative also recently was adopted by the State Assembly. It would require criminals to serve their entire sentence, rather than being eligible for parole prior to the end of their sentence, and would end the practice of shortening a criminal's stay in prison based on "good behavior"instead, a criminal's stay in prison would be lengthened for "bad behavior". This proposal will prevent the parole of

hardened criminals who frequently commit crimes again. It will also provide certainty to the victims of crimes, who currently have no idea when the criminal who attacked them will be released by the

parole board.

LCR-WI strongly supports this bill, but, lamentably, its fate in the State Senate is uncertain because the Democrats seem to care more about the rights of criminals than the rights of victims.

Hospital Visitation
Republican State Rep. Scott Jensen has introduced a bill which would require hospitals and doctors to allow patients to designate, prior to becoming incapaci-

tated, those who can visit them if they become incapacitated.

While this will benefit more than just Lesbians and Gays, it will greatly assist those of us in committed relationships which might not be accepted by the parents of one or both of the partners. Cases in which a partner has been barred from seeing his or her incapacitated partner in the hospital by the patient's parents are

LCR-WI strongly supports this proposal, which has a good chance of passing in the Assembly. We expect that other legislation protecting the rights of Lesbian and Gay couples will be intro-

duced in the Assembly in the near future. While the idea of allowing hospital visitation is accepted even by many of the fundamentalist Christians, the hospital visitation bill is the first bill protecting Lesbian and Gay couples from discrimination to be introduced in this legislative

We find it ironic that the two most high profile bills benefiting the Lesbian/Gay community or persons with AIDS introduced in this session and the last, the hospital visitation bill and the viatical settlements bill (which regulates viatical settlement companies-companies which purchase the life insurance policies of persons with AIDS but have been known to swindle desperate individuals--and was introduced by Rep. Jensen and GOP State Senator Peggy Rosenzweig), were intro-duced by Republican legislators who led the fight for their adoption.

All of our legislative successes are the result of our hard work during last year's (and previous year's) elections, as members of LCR-WI donated their time and money to support Republican candidates in the Assembly and Senate. 



David Smith, a spokesperson for the Human Rights Campaign told The Wis-consin Light "First and foremost Congressman Neumann is saying that he would break the law in the State of Wisconsin. That law was enacted by the duly elected representatives of the people, and has been in effect since 1982. As it relates to federal issues, obviously this underscores the need to enact the Employment Non-Discrimination Act (ENDA). Anyone who doubts whether discrimination against Gay people exists, need to look only as far as Rep. Neumann.

His voice was joined with that of Mark Johnson of the National Gay Lesbian Task Force. Johnson said "When those kinds of comments get made some people think its Carte Blanche to gay bash. When a public official makes statements like this there are people who will think it's okay to

Congressman Tom Barrett, (D-5th District) sent a letter to both Light and the Milwaukee Journal Sentinel condemning Neumann for his remarks. (See Letter

to the Editor, this issue.)

Rich Tafel the Executive Director of the Log Cabin Republicans, a Gay Republican group, told The Light that Neumann doesn't want to deal with the issue of Gays and Lesbians. "What he has to realize is that it won't go away" said Taffle. Taffle also said "We see a huge contradiction. Assuming that because a person is Gay that they are bringing an agenda into his office which is going to be contrary to his agenda is a major misunderstanding about what Gay people are about. What he is implying is that to be openly Gay means that you will promote some agenda. That is not the case

According to Tafel, Neumann said he stood by his pledge not to discrimination. "He just doesn't see the contradiction between what he signed and what he said. One of the ironies of all this is that based on his statements he wouldn't hire former Congressman Steve Gunderson."

The Wisconsin Chapter of Log Cabin Republicans issued an immediate press

The statement expressed the need for Neumann to clarify his remark about not hiring and openly Gay person, and went on to give strong support for equality in

"We need to make it clear to Congress-man Neumann," said Log Cabin president Curt Lamon, "that just because someone is openly Gay does not mean that he or she promotes an agenda which would be unacceptable to him."

Lamon continued, "We will continue to pursue opportunities to educate Congressman Neumann and other Republican officials, and once we ascertain Congressman Neumann's exact position on the discrimination issue, we will then be in a position to decide whether we can continue to actively support Congressman Neumann.'

9to5, National Association of Working Women, denounced Neumann's vow that he would not hire openly Gay people.

'A Congressman or any other employer should hire based on applicants' qualifibased on t ieir sexual tion," said Carmen Murguia, a spokeswoman for 9to5.

Murguia added, "Unfortunately, the law does not prevent him from discriminating against Lesbians, Gay men and Bisexu-

"It is an issue of our lives," Murguia

said, "not lifestyles.

Others think that Neumann is aware of that contradiction. A statement issued by the radical right wing group, Wisconsin Christians United calls on Neumann to rescind his pledge to the Log Cabin group. The group's press release reads in part "The question must be asked of Congressman Neumann: Are you gong to back our your agreement or are you just another politician caught with your hand in the cookie jar."

Local Log Cabin members were clearly

angry or dismayed with the Congressman. Scott Evertz told The Light that a member of Neumann's staff privately told the group that Neumann's remarks were like "Don't ask, don't tell." That staff person said he didn't know what would happen if a Neumann found out that someone he had hired was Gay or Lesbian.



Alabama T.V. Station May Continue Ellen Black Out

New York- Following Allbritton Communications television station ABC 33/40's controversial blackout of ABC-TV's highly-rated sitcom Ellen in Birmingham, Alabama, the Gay & Lesbian Alliance Against Defamation (GLAAD) has condemned Allbritton for refusing to meet with lesbian and gay community leaders to address charges of homophobia. GLAAD also expressed outrage that Ellen's upcoming fall season remains jeopardized by its local station's bigotry and intolerance.

In a letter sent this month to Allbritton Communication's Legal Affairs Department, GLAAD and a coalition of local organizations requested a meeting with company officials to address outrage sparked by ABC 33/40's censorship of Ellen, as well as the station's continued stonewalling of community concerns.

The proposed meeting was rebuked by Vice President of Legal Affairs Jerry Fritts who, according to GLAAD, passed the buck saying that "[our television station licensees] make their own decisions."

'Allbritton's refusal to be held accountable is both cowardly and counterproductive," said Kevin Snow, vicepresident of Birmingham Pride Alabama. 'Allbritton and ABC 33/40 are attempting to take away our right to make our own decisions about what we watch on televi-

ABC-TV recently announced that it has renewed Ellen for its prime-time line-up. Allbritton's ABC 33/40 has not yet commented on whether it intends to continue to black out the sitcom when it returns to the network this fall.

In an effort to give Birmingham residents the opportunity to see the blackedout Ellen coming out episode, Birmingham Pride Alabama and GLAAD organized a satellite downlink, ironically provided by another Allbritton owned station, of the history-making show at Boutwell Municipal Auditorium on April 30th, 1997. With an audience of more that 2,500 people, the live screening was the largest Gay, Lesbian, Bisexual and Transgender event in Alabama history.

those lives that ended during the Holocaust. The fact that we can participate in a Pride Festival makes this less of a "Dachau of a world" than others have met with. Yes, we are living in a political and social climate that often raises the waters of intolerance and hatred to such a degree that we become submerged, struggling to breathe our fair share of American air. But ass the freedom flag reminds us, we have the power today to claim our presence and shape our own future.

At the risk of being perceived as "too sensitive" or "too political," I simply suggest that Gays and Lesbians explore the history of the Holocaust. As the writer from the May 22 issue knows, there is a great deal of strength to be gained from the documented stories of survivors. The Pink Triangle was worn by many who were taken from their homes and families, sent to death camps, and then forced to endure humiliating, degrading, extremely painful deaths simply because of their sexual orienta-tion. This is what the Pink Triangle represents.

It is my personal opinion that the Holocaust was one of the most horrifying displays of inhumanity this century has witnessed. We have such a great deal of responsibility to both the memory of the holocaust and to the symbols that represent it. As we come across the Pink Triangle on shirts, buttons, and banners, we should not forget the silent voices it speaks for. We should be very careful not to trivialize such an enormous volume to our history book. Sven Carlson Milwaukee

Recently a Milwaukee Bar owner and I had a conversation about our policy regarding which events we list and cover in this section of our paper. He was under the impression that his bar was not being included because he did not advertise.

On the other side of the coin, I have had conversations with bar owners and managers who didn't tell us what was going on at their bars because they felt it was wrong of them to expect us to list their events when they didn't advertise.

The fact is (as any regular reader knows) that we regularly list and cover events held at bars that don't advertise with us. Our only criterion is that the bar be located in Wisconsin and that it distribute The Wisconsin Light. As a newspaper we can and should do no less.

But that conversation made me want to restate our policy on listing and covering events. It is our policy to list events held in any bar that distributes The Light. It is also our policy to cover as many bar events as we can. Unfortunately given our small staff, it is not always possible to cover every event, especially on nights where three or four (or more) things are going on at once.

We are not psychic however, bars that do not advertise in this or other publications and who do not let us know what is going on at their establishment will not have their events listed. We simply do not have the time to call the 50 Wisconsin Gay and Lesbian bars to ask them what is going on so we can list their events.

Furthermore because of limited space, we will not list regularly scheduled events such as Sunday Night shows in our You're Invited Calendar unless they are benefits for a Gay organization or charity. We generally reserve that space for special appearances, benefits and shows. Nevertheless we do list ALL special events we

So if you are not reading about what is going on at your favorite establishment, it's probably because no one told us. But if you want to read more about what's going on at the places you frequent please ask the owner/manager to keep us informed about events coming up there. Send us a note in the mail, email us through our web site www.wilight.com or just pick up the phone and call us at (414) 372-2773

Certainly we care about getting advertisers. Without them we would not have a newspaper for you to read. But when it comes to listings and coverage, where a bar puts its ad dollars are secondary, keeping our readers well informed is our primary

goal for me is to talk about relationships and honest, unconditional love."

One of the opus' most brilliant moments can be found on the title track, which was inspired by a close friend's battle with AIDS. "He's my confidante, a very dear friend, who really encouraged me and kept telling me I was going to make it," she says. "At the time I was making the album, he was very sick. My concern was that he wouldn't have the opportunity to hear the work from the album before he passed.

When it was finally recorded, I took him a studio tape, we hadn't even pressed the album, and put the headphones on him, 'cause I wanted him to hear everything I had done. He just looked at me and said, 'I'm coming home, this isn't my last trip."

Surprisingly, her friend pulled through. And has since bounced back to good health. Nesby credits the love of friends, hearing the words, "I'm Here For You," with helping him find the strength to fight back.

""I'm Here For You,' is about educating people about AIDS. So many times when people are stricken with AIDS, friends turn their back, mostly because they are uneducated. They say a lot of people die from the disease, but I think a lot of them die of a broken heart. The people in their lives are not willing to get the education to love them back to health," she says.

"That's why I entitled project 'I'm Here For You.' It's about unconditional love. Being who you say you are. You have to be a friend to have a friend."

Born in a small Illinois town, Nesby grew up singing in the church choir. (Her father was a pastor at the local church.) Barely four-years old, she got her first taste of live performance, standing up and singing "He's Got The Whole World In His Hands" with the choir in front of the parishioners.

"I was terrified. All these people were clapping and singing. I thought they were yelling at me. I thought I had done something wrong," she recalls, remembering that she was so scared she went and sat down in a chair and stopped singing.

"But my mother told me that they were clapping for me and encouraged me to get back up and sing. She told me that I had a Broadway at the Village Gate for a sixmonth run.

A year later she met Tim Lee, who later become her manager and husband, and recorded her first demo tape. The duo entered Nesby and her self-penned song, "Long, I Need You," into a Nashville talent contest, where she placed second.

Soon she found her calling in Minneapolis where she joined the acclaimed Sounds of Blackness. In 1988, she joined the group. And like Lana Turner at Schwabb's, Nesby soon found herself being discovered.

Famed R&B producers Jimmy Jam and Terry Lewis showed up at a Sounds of Blackness concert, with friend and client Janet Jackson. They duo quickly signed the group and helped them record their first album, "The Evolution of Gospel," which went on to win a Grammy. That album also spawned the top-10 R&B and dance hits, "Optimistic," "Testify" and "The

After recording three more albums (and a second Grammy for a version of Handel's "Messiah," entitled "A Soulful Celebration") with Sounds and writing several of their songs, Nesby began to break out.

She sang backup for Janet Jackson on her "Janet" album and Patti LaBelle on her "Gems" set, as well as penned the top-10 R&B hit "The Right Kind of Lover," for LaBelle and "Home Alone," for Gladys Knight.

She also contributed several songs to soundtracks including "Batman," "Mo Money" and "Demolition Man," as well as lent her voice to tribute albums, such s those done for Curtis Mayfield, Marvin Gaye and John Lennon

Gaye and John Lennon.

With the release of "I'm Here For You," the singer is racking up more attention, both as a singer and a songwriter. (She wrote or co-wrote several of the songs on the album.)

"This is a really hard business, especially when you are over 30 and not a main-stream artist, or a teenager," she says. "This industry can be very, very hard. Adult/contemporary artists don't have a big medium for video. That type of music is usually played after hours. If you are fortunate to have a video played in prime time, then there is something to be excited about."

gift, that God had given me this beautiful voice and to use it. If my mother had not sent me back (to sing), I probably would not be singing today."

After high school, her family moved to Rockland, Illinois. But soon she would seek musically richer pastures. In the late-1970s, she joined the James Cleveland's Gospel America Worship of America, a nationally renowned church choir. There she sang on three of the group's recordings.

"The church was were I got my formidable training," she says. "So many times the first training you hear that singers get was in church - people like Whitney Houston, Aretha Franklin. 
thought this was going to be a definite contemporary adult album."





'Addicted to Love' is a Joy to All Those Who Have Loved and Lost

Glenn was already a most faithful fan of Matthew Broderick long before he dazzled our community as the deliciously adorable Alan in the big screen adaptation of Torch Song Trilogy. He was the cute kid with the easy wisecrack and the mischievous twinkle in his eye in such popular films as Wargames and Ferris Bueller's Day Off.

A far different Matthew Broderick is to be seen starring in the deadly romantic comedy, **Addicted to Love**. Glenn is most sorry to have to report that it is a fleshy, doughy Matthew Broderick.

Say it ain't so, Matthew Broderick, say it just ain't possibly so!

Pudgier but still with the same wry twinkle in his eye, Matthew Broderick plays Sam, an astronomer madly, truly, deeply and quite contentedly in love with Linda (Kelly Preston), a pretty little school teacher.

Fate (and an enterprising screenwriter) sends Linda to New York, the opportunity of a lifetime. As Sam puts the finishing touches to the perfect "welcome-home dinner", Linda sends her dear ol' dad over in her place, armed with a "Dear John-ogram" (Sounds like a possible business opportunity to the entrepreneurial Glenn).

Off to New York Sam goes, to get his gal back.

Linda has happily forgotten Sam having impetuously fallen in love with the former male model now restaurateur Anton (Tcheky Karyo). Just how impetuously her love Sam learns, as he begins to spy on her from an empty warehouse across

Enter Maggie (Meg Ryan), the self-same Anton's jilted fiancée. Absurdly dressed like a crash-test dummy wannabe, Maggie's, unlike Sam's, has love has turned. Aided by a cleverly crafted camera obscura, Sam and Maggie are able to watch Linda and Anton as if examining bacteria under a microscope as their fiendish plottings of revenge unfolds.

If Griffin Dunne's direction is often heavy-handed and Robert Gordon's predictable screenplay rather... well, predictable, Addicted to Love manages to succeed by the grace of its cast.

Meg Ryan is nothing short of terrific. As the vengeful Maggie, Ms. Ryan is smart, cynical and bitter. That she manages to keep the audiences' sympathies is nothing short of remarkable.

In the more traditionally warm and fuzzy role as the forlorn Sam, Matthew Broderick remains appealing but Glenn must admit a giggle or two during his tryst with Maggie

Both Kelly Preston and Tcheky Karyo register nicely as the put upon lovers but poor Maureen Stapleton is sadly wasted in a throw-away scene as Maggie's Nana.

Armed with his usual "biggie popcorn," Glenn considered asking the adorably dressed little girl occupying the chair next to Glenn. How foolishly Glenn felt when she began to scream out "Kramer, Kramer". How sad Glenn was when she wouldn't stop.

Glenn is similarly sad to have to report that it was all downhill from then on.

So here's another big screen venture starring a small screen personality, the same said Michael Richards who is featured in the popular comedy Seinfeld (Okay, Glenn fesses up, he doesn't watch Seinfeld).

Richards follows some extraordinarily inept flops by such high-profile television personalities as Matthew "Fools Rush In" Perry, Fran "The Beautician and the Beast" Drescher and of course who can forget (no matter how much one might try in hours and hours of therapy) the perfectly dreadful Kids in the Hall Brain Candy?

Okay, Trial and Error isn't as bad as Brain Candy. How could it be, really? All Trial and Error is improbably predictable, staggeringly unfunny and generally undeserved of a theatrical release at all.

Get it, a penny. This is as funny as it gets.



Michael Richards has a wickedly funny scene auditioning for a part but otherwise is betrayed by his material. Jeff Daniels tries to make a go of it but fares little better. Rip Tom is fun as the wily Benny Gibbs, Austin Pendleton has a few bright moments as the much amused Judge Paul Z Graff and Charlize Theron shines as Charlie's love interest, Billie.

'Love! Valour! Compassion!' is a Film You Will Want to See Again and Again

The year is 1970. This celebrated stage hit has just been filmed, much of its original cast intact. Might this just possibly be that breakthrough film, that mainstream Hollywood film that would present an honest representation Gay lifestyle? The film, of course, is **The Boys in the Band**.

Jump nearly three decades. Another celebrated New York stage hit has just been filmed, again with it's celebrated stage cast nearly intact (Curiously missing is Nathan Lane). Will this finally be that breakthrough mainstream motion picture that the Lesbian and Gay community has for so long been waiting?

This film, of course, is the much heralded Love! Valour! Compassion! which stars Seinfeld mainstay Jason Alexander.

Based upon Terrance McNally's award-winning play, Love! Valour! Compassion! (or simply L!V!C!) follows a group of Gay men over the course of three summer holiday weekends spent miles and miles from another living soul in a fabulous home in the country.

The fabulous country home belongs to Gregory (Stephen Bogardus). Gregory, an aging dancer turned acclaimed choreographer lives there with his blind, younger and quite handsome lover Bobby (Justin Kirk).

Within Gregory's intimate inner circle are Perry (Stephen Spinella) and Arthur (John Benjamin Hickey), a longtime Gay couple who will, in the course of the film, celebrate their fourteenth anniversary.

Also on the guest list are Buzz (Jason Alexander), a show queen with a musical comedy lyric for any and all occasions and John (John Glover) who no one seems to like but whom Gregory felt guilty enough to invite anyway.

Adding dramatic as well as sexual tension is the inclusion of Ramon (Randy Becker), a hot young dancer John has recently met and has invited along. The group's second weekend finds one additional guest, John's sweet, identical twin brother James (also played by John Glover).

own play, McNally succeeds in depicting not only life's big dramatic scenes but also the small, intimate, often mundane moments with grace and subtlety.

Woven throughout LIVIC! are the loves, fears and betrayals of this collection of Gay men. Gregory is facing a block while working on creating his new dance piece. John seems desperate for others to like him but doesn't know how to change. Bobby's safe existence with Gregory is upset by the arrival of hunky Ramon. And so forth.

Lurking behind the much of the film's pithy, bitchy Gay humor and showtune snippets is the specter of AIDS. Buzz is HIV-positive and James is portrayed as slowly dying from AIDS. The touching relationship they forge is one based both upon equal measures of need and love.

Love! Valour! Compassion! offers Gay audiences many joys. Rarely, for example has the love and affection between Gay men, both between lovers and between friends been filmed as naturally and as sensitively. Although containing less nudity than the stage production could boast, there remains ample eye-candy in LIVIC!, particularly as embodied by the breathtakingly beautiful Randy Becker's Ramon.

Director Joe Mantello, also LIVIC!'s director on Broadway, elicits fine performances from all principals with a few standouts. Stephen Spinella (Prior Walter in Kushner's **Angels in America**) is sensational as Perry, one half of the "Gay rolemodel" couple. John Glover is equally astonishing as both the nasty, bitter John and the sweetly saintly James.

Special mention however must go to Jason Alexander. Replacing Nathan Lane is no easy task and it is remarkable how well Jason Alexander was able to fit into this ensemble. Alexander's Buzz is touchingly warm and human. How brave too, Glenn thought, for Mr. Alexander to dare to bare his pudgy little tush.

Dinosaurs Are Awe-Inspiring in the Very Suspenseful, Entertaining 'Lost World'

There's never been a more anticipated sequel. I remember my first thought after seeing Jurassic Park in 1993 was, "I can't wait to see the sequel," long before there was any official announcement of one. I just knew there had to be some kind of "Return to Jurassic Park" in the not-toofar-distant future. Well, four years and a billion dollars in movie revenues later, the desires of us dinosaur lovers have come to fruition with Director Steven Spielberg's The Lost World.

Quite naturally, everyone going to this movie who's seen the original, comes in with a lot of questions, such as: what happened to Jurassic Park and its surviving dinos on Isla Nublar? What future plans exist for them, if any?

The first half hour or so of the film is dedicated to re-familiarizing us with the main characters of the first film and tying up the loose strings it left behind. We find out that the park's creator, John Hammond (Richard Attenborough), closed down Nublar's attractions, but now plans to move several dinosaur species to a better location: Jurassic Park-San Diego!

To accomplish this task, he first wants a group of four experts to study and photograph the dinosaurs on a small island 87 miles from Nublar, known as "Site B." The knowledge of the existence of a completely wild environment filled with dinosaurs on this island comes to Dr. lan Malcolm (Jeff Goldblum) as a great shock. Never a fan of the original Jurassic Park, Malcolm is horrified at Hammond's plans. Discovering that his paleontologist girlfriend, Susan (Julianne Moore), is already there studying the dinos, Malcolm decides

to go on this mission—if only to convince her and the others involved of the senselessness and unfeasibility of Hammond's

The four scientists are joined on this trek by a stowaway: Malcolm's young daughter (Vanessa Lee Chester), further complicating things for the ever fretting Malcolm. As expected, dinosaur-human interaction begins to take nasty turns almost immediately, especially when Site B is deluged by helicopters full of hunters and trappers in Hammond's employ-their job being to capture many of the animals and prepare nem for their trip to San Diego.

We now have an island full of vicious predators (including the horrific Tyrannosaurus Rex and cunning Velociraptor of the first film), and dozens of humans who, apart from Dr. Malcolm, have no idea how much trouble they're in. What follows is a sequence of highly entertaining, suspenseful, even frightening and aweinspiring scenes as the humans' hunting and studying mission degenerates into one of mere survival.

Almost unbelievably, the dinosaurs in The Lost World are even more wonderfully realized and awesome than before. What's more, there are many more species to see, including one of my favorites, the scale-backed Stegosaurus with his spiked tail. More people are brutally killed by the predatory dinosaurs than in the first film as well (either a plus or a minus, depending on your own taste-no pun in-

In fact, The Lost World, though rated PG-13, comes very close at times to earning an R rating. This is definitely <u>not</u> a movie about cute and cuddly Barney-saurs

for little kids to get all excited about.

The Lost World is a darker, more serious film than its predecessor. Even the lofty, noble score of the first film is replaced by one of darker hues and tension (both by John Williams).

I really have no complaints about this film. Sequels to great movies always have

a very high hurdle to jump. The Lost World clears that hurdle with room to spare. Whatever awe and wonder that may be lost is more than made up for in gritty tension, dazzling effects, convincing characters, and endless fascina There's nary a dull moment. The Lost World rates a 9 out of 10. fascination.

'Lost World' is a Mass of Cliches Trying to Hide Behind Technology

Lost World is an old fashioned "B" picture on which a great deal of money has been spent. The high tech computerized effects are more advanced than those in Jurassic Park so why grumble? If the new film eludes the sense of wonder and the carefully developed suspense sequences of the earlier film-not to mention an intriguing plot line-it's easier just to go with the flow and accept the fact that technology more than compensates for the artistic decadence, as long as you're having "fun." I wasn't. I missed a certain sense of awe.

wasn't expecting a Citizen Kane or a GWTW, but there's something depressing and prophetically disheartening to think that the talented director of ET, Schindler's List, Jaws and Jurassic Park should trade off his sparkling originality for soul-less cliches. Is this what all movies are coming to? Computerized crap. But what is really frightening is the threat of films that continually depersonalize the movie goer's psyche.

King Kong remains a classic because they ape was move loveable than the human characters.

And the repetition of cliches! The Tyran-

nosaur appears again on a rainy night and pushes the trailer to the cliff's edge (as in Jurassic); a baby Tyrannosaurus is kidnapped (as in Jaws); and-horror of horrors-a live Tyrannosaur runs amok in San Diego occasioning more car crashes!! Spare us Godzilla.

The effect of watching screaming, running crowds is like an overlay of interchangeable shots from Independence Day and Volcano (sigh) with lava, space-ships, dinosaurs penciled in.

But the real panic is the enormity of Steven Spielberg's sell-out. Jeff Goldblum's clever line that new mistakes will replace old ones might well refer to this and subsequent movies. And we mustn't forget his politically correct unexplained daughter-the penultimate cliché.

Of course, this doesn't mean you should see the film. Think of all the money spent on this one. And why be a spoil sport when asked if you liked it? But make sure you know what you're buying.

As for myself, I couldn't help secretly wishing that word of mouth might kill off this film with a voraciousness that even a Tyrannosaur might envy.



'Love! Valour! Compassion!' Cast and Crew Talk About Making the Movie and Gay Life and Love in America

In 1994, Terrence McNally's Love! Valour! Compassion! opened off-Broadway to critical praise both for its direct portrayal of contemporary relationships among the Gay middle-class and its much broader theme of how the human heart has had to find new and challenging ways to connect and stay true in this day and age.

Also singled out for praise was the clarity, passion and wit of McNally's dialogue — which carries both the ring of truth and the sting of human comedy.

The stage play drew a loyal following both with mainstream and Gay theater audiences. At award time, it was honored with more accolades and nominations than any other play of the season, including the Tony Award for Best Play.

Joe Mantello, who directed the stage version, now makes his motion picture directorial debut with the film version of love! Valour! Compassion!

Love! Valour! Compassion!.

The original New York cast, has been reunited for the film joined by Jason Alexander in the role of Buzz. Terrence McNally is the author of the screenplay and the film is produced by Doug Chapin and Barry Krost. Diane Conn is the line producer. Love! Valour! Compassion! is being distributed in North America by Fine Line Features.

In the wake of "Love! Valour! Compassion's!" theatrical debut, the idea of a motion picture began to take root. Terrence McNally's stage play already read like a screenplay — it was full of underwater scenes and gleaming moonlight and lush gardens, all of which were recreated expressionistically on the stage. The play, which spoke to the core of the human spirit, called out for an even broader audience.

Producers Doug Chapin and Barry Krost, whose credits include What's Love Got To Do With It and American Dreamer, immediately saw the potential for a special motion picture.

Says producer Doug Chapin: "When Barry and I first saw the play we were struck by how humorously, gracefully and intimately Terrence and Joe communicated such a powerful notion: we are all mortal, so spend your time loving, laughing with and caring for those closest to you. That they were able to do this with a wit and charm that touched such a vast cross-section of people in the audience, convinced us that this was a wonderful movie waiting to be made."

Chapin approached Terrence McNally and Joe Mantello, who were both intrigued by the idea. But there was a caveat.

"Once upon a time it seemed inconceivable to me that Love! Valour! Compassion! would become a movie," says Joe Mantello, who is not only a director but an actor who received a Tony nomination for his acclaimed leading role in Angels In America. "Because we all agreed that it couldn't and shouldn't be done without the original cast, which of course rarely happens. There was no way I was going to enter this new world, take these characters into this new reality, without the support and love of the people who had been there in the beginning. So Terrence and I agreed we would only do it if we all did it together."

For Chapin, the task of reassembling a cast of some of theater's finest and most sought-after actors was no small thing.

"But because we realized the importance, it was a task we happily took on," recalls Chapin "and one that Fine Line courageously encouraged us in. And in the end you can see why it was so vital, how it kept the vision of the play pure, and the humor fresh, how the fact that all these actors were so close to the material made it something that could become intimate and very real on the screen."

The only major change in the casting for the motion picture was the addition of Jason Alexander in the role of Buzz, who as his name suggests, is the witty, unstoppable energy center for the whole octet. Alexander came into a potentially volatile situation: the outsider in a group of actors who had been working together for years.

Cast and filmmakers admit there was a lot of initial trepidation.

"But the amazing thing is that Jason just folded right into the production immediately," says Mantello. "There was a great deal of anxiety about him becoming part of the dynamic these guys had worked so hard to forge, but he made it easy for them to accept him and they made it easy on


Says Alexander: "I wanted the role because I saw the movie as a story of where we are now, as human beings. It's about how we succeed, we fail, we love, we lie, and mostly we just hope to come through it together, laughing if possible."

"Also, playing Buzz was incredibly interesting to me. Doing 'Seinfeld' for so long has been a great experience for me, but after awhile it gets to be like putting on the same pair of socks every morning. It was nice to have something a little frightening

to do.

And when it came to taking on Buzz, who is not just Gay but very flamboyant, I took the whole thing very seriously. Because I get offended by portrayals of over the top Gay men by straight actors, I didn't

Jackie Calhoun, Best-Selling Naiad Author, Talks of the Joys of Writing

By Cynthia Van Vreede Wisconsin Light: You are Naiad's best-selling author. When did you start

Jackie Calhoun: I started my first book, I think, it was in the summer of 1986. I finished it in December 1987, and it was published in 1990. The first book takes awhile.

WL: Were you doing any kind of writing before that?

JC: Well, I wrote some short stories but I didn't have much to do with them. I was running a business, I had a rental business, and I was married and raising my kids.

WL: Would you have ever predicted this kind of success?

JC: Well, I wouldn't think so, no. I was surprised. I mean Naiad was the second place I had the book, and the first one went to Little & Brown, which was foolish. Without a query letter or anything. So the success of getting published is, was surprising. But I did think people would like that book.

WL: Of all the books, which was the easiest for you to write?

JC: I started Lifestyles twice. I wrote it over. But once I started writing it over, it was pretty easy. So was Friends and Lovers. I would say those two, maybe Triple Exposure.

WL: Which was the most difficult?
JC: The most difficult was probably
Changes.

WL: Yes. The woman with the accident. Did you have to do a lot of research for that one?

JC: No. I broke my neck.

WL: Really? That was you?

JC: Well, it was me and it wasn't me. I mean, the medical part is accurate...That was in '89, and that was a long time ago.

WL: Do you have a favorite book?

JC: The only book I read all the way through after it was published was Friends and Lovers. I have to say two or three I like. I like Lifestyles, Friends and Lovers, Triple Exposure.

WL: One critic called you the "chronicler of Lesbian life in the 90s." Do you see yourself that way?

JC: I don't know. I write midwestern books, so I represent maybe the midwestern realism. Lesbian realism. I think my books are pretty realistic.

WL: Your books do deal with real people, real issues, and day-to-day interactions. Do you have a lot to draw on?

JC: I think that real life — it's much more exciting than something made up. It's something people can relate to. I have to say that since I became a lesbian things have been really in turmoil until the past three years. So I do have something to draw on.

WL: For me, your books are interesting to read because they take place in Northeastern Wisconsin, where I happened to grow up.

JC: It anchors me in some way, so that I can picture it. And I need to do that, picture my characters, picture the locations

WL: When you get a chance to read, what kind of books do you like to read?

JC: Probably a lot of books. Let's see what I'm reading right now. Oh. I hate to tell you I'm reading a Jonathan Grisham book. (Laughs.) That's not what I usually read. My favorite author is Lisa Alther. My favorite book is Other Women. But I have lots of authors that I like, they're pretty down to earth....I like big books. I wish Naiad would let me write a book longer than a couple of hundred pages! Right now I'm working on a mainstream book.

Frank DeCaro's "A Boy Named Phyllis," Is the Gay World's Answer to 'the Beve'

Brought up watching such idyllic suburban families as The Cleavers (Leave it to Beaver), The Andersons (Father Knows Best) and later, naturally, The Bradys (The Brady Bunch), Glenn was often left to ponder his existence. Could these be Glenn's real parents? Might have Glenn been adopted? How come no one's mother in Glenn's neighborhood offered Glenn milk and cookies after school?

Knowing he was Gay since entering puberty, Glenn increasingly found such programs unrecognizable. Neither Wally nor the Beav seemed to have any interest in the hunky, humpy boys in their class. None of the Brady kids ever mentioned the thrill of showering with the swim team.

Still, any budding Gay man might escape adolescence in the desolate American landscape known as "the suburbs" unscathed if adequately equipped with a sense of humor, as proved by Frank De-Caro's hilarious "suburban memoir", A Boy Named Phyllis (Plume Pb \$11.95).

From the opening chapter, when DeCaro

recounts his parents discovery of the fetus soon to be called Frank, hiding behind a melonsized tumor, it becomes clear that A Boy Named Phyllis is not another angstridden coming out saga.

Unlike Glenn, Frank DeCaro actually found a television family that did resemble his real family: **The Munsters**, "To me, the goings-on at 1313 Mockingbird Lane, where this clan of Transylvanian transplants lived in a decrepit mansion with a fire-breathing dragon under the stairs were like the DeCaro home movies..."

What is striking in A Boy Named Phyllis is that behind DeCaro's wise and wry observations of growing up, there is something so gosh-darn familiar. He may not have been "every Gay boy", but DeCaro's rites of passage has a surprising ring of universal truth.

From Frank's school-boy crush on Bobby Sherman (who didn't have a crush on Bobby Sherman back then, Glenn ponders?), his first experiences crossdressing (some pretty adventurous Halloween costumes), to stories about his first boyfriend

Kenneth and finally onto coming out to his parent, Glenn imagines that many will find much in **A Boy Named Phyllis** that brings back memories, both good and some not-so good.

If occasionally DeCaro's raucous Italian-American New Jersey family does seem to resemble more closely those wacky '60's sitcom families than real, flesh and blood people, never does DeCaro's storytelling lose its warmth. DeCaro clearly loves Frank and Marian (his parents), crazy Nana Anna and all the rest.

As he read A Boy Named Phyllis, Glenn admits that he began to love the DeCaro clan just a little bit, too



"What's your last name?" I asked

"Peralta," he answered, and went on. He was born in San Jose to parents who had immigrated from Mexico. His mother had died giving him birth. His father, a truck driver, had quickly remarried. From that union came seven kids. The family was poor. Everyone had to work. He did, and to please her, he'd worked his head off, graduating from high school with academic honors and a letter in gymnastics. Afterwards, she'd sent him east, to her husband's alma mater, Georgetown. It was there bad luck struck.

"She died," Rudy said, "when I was just finishing my sophomore year. She had family, distant cousins or something. They descended and I was cut off. I cried my eyes out, not for the money. I couldn't care less, but for her. She had loved me, the only one in my entire life who ever had, the only one who wanted me. I felt so alone, so empty, like a big, dark hole had opened up inside me."

He'd dropped out of school and plunged into that hole, into the dark sloughs of pity and despond, drowning himself in booze and spacing out on drugs. There are a lot on the streets like me-like I was-but one thing, though. never sold myself. I never hustled to get money. There was just enough selfrespect left in me, I guess, to stop that. But I did everything else until I hit bottom. That was one evening I was thrown out of a bar, landing face down in the gutter. That's where Johnny Chang found me and had took me home.

Johnny had a lover, guy named Tom. They offered me a home," Rudy said, for as long as I needed it. At first I thought, you know, that they were into three-ways or something, but no way. They were totally committed to each other, really solidly in love. And that's what they taught me.'

"What's that?"

'Love. About love. That it's the strongest force in the universe; that it's the only thing worth having; that love was Mrs. Presser's legacy to me, Heaven's gold, they called it. ministration. But Johnny hasn't any proof of that and he has good reason to hate

"What?"

Bardi comes Ganymede's all the time, and every time he does, everybody breaks their neck to wait on him.'

"Uhm-hum, that. He tips with \$100 bills, but there's something else, too. See, Johnny never waited on him and he told me to stay away, too. Not because we didn't want the money. That'd been good. We could've both used it. But Johnny was convinced that the money was dirty.

"What'd he mean?"

"Drugs. See, when I was buying stuff, I'd get it from any one of several guys. One I got to know kinda well, and he told me the trade was all controlled by one man, here in DC, anyhow. Who that was, he said he didn't know, but.

"Did ever say why he thought that?"

'No. But see, Johnny hates Bardi. Like I said, Bardi comes into Ganymede's a lot, and when he does, he likes to pick the waiters who serve him, for of five of them, minimum. The one's he likes, he invites to work at his parties. He calls them his 'Sacred Band."

"Wait a minute. Sacred Band. The Theban Legion of Gay lovers?'

"Uhm-hum. 328 couples." "328?! Project 328."

"Uhm?"


"I've never said that to any other man. But Rudy?"





want to do the clichés. I just wanted to create a guy who was outrageous in his unique way, but very real. And coming into it with this group of people was like having a built-in support network and some incredible guides.

Summarizes Joe Mantello: "In the end, Jason brought a truly fresh reading to the role. He brings a kind of vulnerability and gentle nature to the character that I hadn't really even thought about before - and yet without losing any of the outrageousness and spice that make Buzz so large a

The story of Love! Valour! Compassion! falls into two distinct motion picture traditions: first, it is the latest in a growing tradition of Gay-themed theater and cinema; and second, it is one in a long line of entertaining motion pictures that explore the human condition with humor and imagination.

For Joe Mantello, both are equally important. "The story is really about how difficult and joyous making your way through this world with another person is - whether you're two men, a man and woman or two women," he says. "And as was shown by the response to the play, straight people who stay open to the material, who are willing to make that leap, find all sorts of connections to their own lives and relationships.'

After all, Mantello and others in the cast point out, infidelities, temptations, the question of the long-term, anger, tenderness, death and hope are part of all human unions.

"And yet," says Mantello, "this is also a movie that is very much about what it is like for men to be affectionate with one another -- to be friends and lovers and to be incredibly comfortable with one another physically. Not just sexually, but just hanging out and being together in a close

The movie also raises issues specific to Gay relationships - some of which have

required their own special forms of valor and compassion.

"There are certain things that make Gay relationships different, that require a certain very specific set of inter-relational skills," Mantello says. "But I wouldn't say it is more difficult to be in a Gay relationship. Just that it is somewhat different."

Exploring this difference is something that has been avoided by Hollywood for the most part up till now. Mantello hopes that eventually movies like Love! Valour! Compassion! will be seen as a steppingstone to a greater diversity of motion picture stories with Gay characters.

"I hope this movie can be another important step forward for Gay cinema, a lighter look at certain aspects of Gay life today. I look back at a movie like The Boys In The Band, which is a favorite of mine and a real influence, yet so much has changed since then. The self-loathing and fear that were so much a part of that movie aren't there with these characters. It's a different time."

Mantello cautions that Love! Valour! Compassion! is not intended to be a definitive statement on Gay life in America. He hopes audiences will see the eight characters as one particular group of individuals, and not representative crosssections of Gay men.

"I think when there are so few images in the media of Gay relationships, it is easy to give the ones that do make it through more significance," he says. "But this is just the story of eight particular men in one particular place. It doesn't purport to represent every Gay man who walks this earth, or every issue that affects Gay men. It is just a story that covers a lot of the things that concern Gay men and all human beings right now, in these times."

On Location

Although the original New York cast of Love! Valour! Compassion remained primarily intact for the motion picture, the play and the characters had to go through some major changes to transition to the

"The real advantage though is that we were all so familiar with the material, it made the changes possible without losing any of the original feeling," explains Man-

Key to bringing the play to life on the screen was the casting of what Terrence McNally refers to as "the ninth character" -Gregory's house — a place of strength, sturdiness and longevity, where all his

friends come to gather.

After much searching, the filmmakers found the perfect idyll just outside of Montreal -- a charming, vintage Victorian with a vast, wood-laden attic.

"The minute I saw the attic, I knew this was the one," says Joe Mantello. thought: this is the house Gregory would have bought. The notion of him dancing over all of his sleeping friends was just so beautiful."

The production soon took over the house for three of the most intensive weeks any single abode has probably ever witnessed.

Ramon

The story's most catalytic persona is Ramon, played by Randy Becker, who drew lots of attention among theater audiences as the character who spends a good portion of his time on-stage un-

"As an actor, Ramon really interested me and I was comfortable with him from the start," says Becker. "He comes into the story as an outsider in every way, not being part of their class, not being white, and being this young thing that everybody

wants to look at. So, he's got a bit of a swagger and he knows the effect of his body on people, but he also has this great vulnerability. I think that's why he's so attracted to Bobby -- because Bobby's blind. He's the only one who can't see him."

Becker did end up stripping nude for the film's sunbathing scenes, but he thinks it will be less shocking on the screen than it

"On the stage, I started out the second act naked and stayed that way for over twenty minutes. In a movie, the nudity is there but it's only seen when the camera pulls back, which only happens when the shot requires it. So it feels very natural, very organic, it's just a guy who's swimming naked because he wants to get

Summarizes Spinella: "What was really exciting about making this movie is that I can't think of another Gay movie in which you get so involved with the characters. This play is very much about our times and about people just dealing with each other in very amusing ways -- and every once in a while taking on the world's problems."
