America On Line **Admits Breach of**

Washington, DC- In an update to a story in our last issue, America Online (AOL) admitted breaching its policy and said Wednesday, January 21, it regrets disclosing to a Navy investigator the identity of a senior sailor now facing dismissal from the service as a homosexual.

"This was a case of human error under very unusual circumstances," AOL Inc. said in a one-page statement. While criticizing the Navy for the way it sought the

cizing the Navy for the way it sought the information, AOL said of its disclosure: "This clearly should not have happened, and we regret it."

Also Wednesday, Senior Chief Petty Of-ficer Timothy R. McVeigh moved to save his Navy career by filing a case in federal court in Washington. McVeigh charges the Navy pried into his personal affairs in violation of an electronic privacy law and the military's "don't ask, don't tell" policy on gays in the military.

The service began investigating McVeigh last fall after a Navy spouse discovered information available through AOL and apparently written by McVeigh that indicated a sexual interest in young men. McVeigh, 36, is a highly decorated senior enlisted man with 17 years in the service, three years shy of the 20 needed. service, three years shy of the 20 needed to retire with a pension. He is no relation to the convicted Oklahoma City bomber.


"I don't have any bittemess against the Navy at all," McVeigh said outside U.S. District Court. "My only regret is that the Navy is unwilling to follow regulations."

McVeigh, in dress uniform festooned with rows of awards and medals on his chest, stood at attention as U.S. District Judge Stanley Sporkin entered the court-room. Later McVeigh changed into a business suit to speak with reporters, observing a regulation against uttering public statements in uniform lic statements in uniform.

McVeigh's attorney, Christopher Wolf, said the Navy "broke the law" against wresting confidential information from online services. He also contended the Navy violated the Pentagon policy on gays in the military, which prohibits open homosexuality but bars the military from trying to discover a service member's sexual orientation.

In the contest for Seat 3, Mary Joe Rosenak is being challenged by Jo Anne Elder, the President of the Madison chapter of Madison's Parents and Friends of Gays and Lesbians. Rosenak voted against providing the benefits.

Elder said that she had decided to make the race even before the vote on the contract. "I am concerned about a wide variety of issues not just this one, she said. "I want to see quality education for everyone in Madison's schools." Nevertheless Elder was critical of Rosenak's vote on Domes-tic Partnership. "It's a matter of equal treatment," she said.

When contacted by The Wisconsin Light Rosenak said that for her the issue of domestic partnership benefits was one of cost. She said that the School Board had "given a free benefit" to the teachers union, Madison Teachers Incorporated, without getting anything in return. Ro-scnak estimated that the cost of the benefits would be \$300,000.

She said this estimate was based on 60 partners taking advantage of the plan at a cost of about \$5,000 each.

Madison—On Saturday, January 17, 1998, Sol Kelly-Jones, 11, received the ACLU's Young Civil Libertarian of the Year Special Recognition Award. The Award was presented at the ACLU's annual Bill of Rights dinner in Madison.

Below is Sol's introduction delivered by Dianne Greenley, ACLU of Wisconsin board president, as she presented Sol her award. This is followed by the 11 year-old civil rights activist's acceptance speech.

Dianne Greenley In March of 1997, a ten-year-old girl from a Lesbian family named Sol Kelley-Jones spoke out at a legislative hearing on a bill prohibiting same sex marriage—in a room filled with over 500 people, some of them openly hostile to her family. Despite the intimidating circumstances, she

clearly and articulately explained how the bill would hurt her and other kids in Gay and Lesbian families. Many legislators were impressed. And the next day her story made headline news throughout Wisconsin.

In April, she conducted a "Survey of Kids' Attitudes Toward Gay and Lesbian People" at her school. Her survey soon received the attention of local school board members and State Superintendent of Schools John Benson. And it was recently entered into the record at a Congressional briefing on homophobia-based hate crimes in Washington, DC

Gay Bashed Couple Sues Washington, DC

Washington, DC—On January 16, two victims of an anti-Gay hate crime filed a case in the U.S. District Court of Washington, D.C. charging the city with intentional discrimination in refusing emergency medical care to them. Ken Ludden and Joseph Loron Lavoie's complaint is based on a July 1, 1996 incident following an attack in which a man shouted anti-Gay epithets at them and beat the couple with a large, heavy rod. Despite urgent need and the plaintiffs' request for help, the DC Fire Department emergence and instead leaned gency technician at the scene refused to provide any assistance, and instead leaned against his truck and told them they should go to a hospital. While he claimed to have dispatched an ambulance, later investigations revealed he had not. Ludden and Lavoie were forced to walk nearly a mile to the hospital, at which time Lavoie lost consciousness due to blood loss. He later received 20 stitches. ness due to blood loss. He later received 29 stitches.

Boy Scout Campaigns for Gay Rights

Los Angeles-A Petaluma, California, 12-year-old Boy Scout has joined the ranks of many in opposition to the Boy Scouts of America around their policy excluding Gay many in opposition to the Boy Scouts of America around their policy excluding Gay scouts and troop leaders. In order to get his citizenship merit badge, one step on the way towards becoming an Eagle Scout, Steven Cozza has written to local, state and national politicians and is circulating over 100 petitions at local supermarkets calling on the BSA to rescind its discriminatory ban. "They say you're supposed to treat others the way you'd want to be treated—but they're treating [Gay people] like dirt. I thought the Boy Scouts were supposed to teach kids good stuff," Cozza said. In response to some people's religious objections, Cozza replied, "I don't think God would discriminate against anyone." He added that he is willing to have people call him Gay because of his stance, adding, "I say it really doesn't matter, but I'm not Gay. I brought it up to treat everybody the same." treat everybody the same.

Pittsburgh-AP- A northwestern Pennsylvania teen-ager said verbal abuse from his high school gym teacher and taunts that he was "Gay" and "queer" nearly drove him to suicide.

The 17-year-old boy, the son of a janitor at his high school in Punxsutawney, has ac-

cused the teacher of repeated harassment and educators of ignoring the problem.

Identified only as "John Doe" in his lawsuit filed in federal court in Pittsburgh Thursday, January 22, he now attends classes in his home and Punxsutawney teachers

The boy accused Punxsutawney High School teacher Gale Shields of harassing him so much over two years that he dropped out and ended up in a hospital, depressed and suicidal. He alleges that counselors and school officials ignored his repeated complaints and pleas for help.

Thomas Frantz, the Punxsutawney Area School District superintendent and a defendant in the lawsuit, declined to comment, saying he was unaware of the lawsuit. School

officials would not pass a message along to Shields.

AIDS Up Among Older Americans

Atlanta-AP- New AIDS cases rose more than twice as fast among those over 50 than among younger adults between 1991 and 1996, suggesting that older people aren't protecting themselves against the disease.

The Centers for Disease Control and Prevention said 6,400 AIDS cases were diagnosed in the United States among people at least 50 years old in 1996, a 22 percent in-

Cases for the 13-to-49 age group rose 9 percent in the same period, to 50,300.

The center recently reported that 12 percent to 15 percent of the AIDS cases in Arizona are people over 55. Among older women, the number of new AIDS cases linked to unprotected sex more than doubled between 1991 and 1996, from 340 to 700. In older

men, that increase was almost as sharp, from 360 to 700.

New cases among older men who inject drugs jumped 53 percent, from 850 to 1,300.

Among older women, the increase was 75 percent, from 160 to 280.

Gay Rights Club Suing School

Aurora, CO-AP- A high school Gay rights club is suing the Cherry Creek School District, demanding that it be treated like any other club.

A lawsuit was filed in U.S. District Court in Denver on Thursday on behalf of the

Homosexual-Heterosexual Alliance Reaching for Tolerance. It says administrators at Smoky Hill High School have allowed HHART to meet but refused to include it in a list of school clubs.

The lawsuit, filed by the Colorado Legal Initiatives Project, also says school officials have censored words such as "homosexual," "Lesbian" and "Gay" from the club's

The high school club includes 25 members, both Gays and heterosexuals, who meet to discuss personal and social issues.

Betty DeGeneres Makes Ad

Washington, DC-AP- Every mother likes to brag about her children. Ellen De-

Generes' mother is getting to do it on national television.

Betty DeGeneres stars in a 30-second television ad urging parents to offer loving support to their Gay children.

Hello, my name is Betty DeGeneres and my kid is the greatest. You know her. She's Ellen and she's Gay," Mrs. DeGeneres says in the public service announcement as she and a group of children build a huge American flag out of red, white and blue

'For too long, Gay Americans have suffered discrimination," she says. "As long as our sons and daughters are excluded from the basic protection of law, we must share that burden as a family.'

Ellen DeGeneres made a splash on her television show, "Ellen," in an episode in which her character declared she was Gay.

Mrs. DeGeneres, 67, made the commercial as part of her duties as a spokeswoman for the Human Rights Campaign.

Mutual Of Omaha Accused of Limiting HIV

Coverage

Chicago-AP- Mutual of Omaha Insurance Co. was sued Wednesday, January 21 for allegedly placing illegal limits on HIV-related health-care coverage.

The lawsuit contends such caps violate the Americans with Disabilities Act and the

Illinois Insurance Code. Lambda Legal Defense and Education Fund and the AIDS Legal Council of Chicago filed their suit in U.S. District Court on behalf of two HIV-positive Chicago-area men, whose names were kept secret

"Mutual of Omaha caps HIV-related care at a fraction of the amount allowed for other illnesses or conditions. This discrimination severely limits access to standard, lifesaving therapies and is illegal," said Heather C. Sawyer, an attorney for Lambda.

Mutual spokesman Jim Nolan said the company had not yet seen the suit, and had no

Chicago "Trib" Backs Down on Gay Issue

against a Gay man and his partner in obituary listings, the newspaper offered to change its policy under the condition that the couple be forbidden from mentioning the dispute

US-Thai HIV Vaccine Tests Begun

Bangkok-AP- U.S. and Thai researchers have launched the world's first trials for a potential vaccine against the strain of the AIDS virus prevalent in Southeast Asia.

The project involves Thai military, hospital and university and research institutes and the U.S.-based Chiron Biocine firm that has developed the potential vaccine.

The sub-type E strain has infected more than 1 million people in Thailand and neigh-

boring Southeast Asian countries. It is primarily sexually transmitted.

The one-year trials will involve 368 volunteers. If the tests prove successful, another

round of trials will be held involving thousands of people.

The studies are being partly financed by the Walter Reed Army Institute of Medical Research, the U.S. Army's preeminent medical research facility.

Group Protests Gay Priests Ordination

Kalamazoo-MI-AP- About 30 people attending an ordination ceremony walked out to protest the Episcopal Diocese of Western Michigan's decision to allow a man and woman involved in homosexual relationships to become priests.

the King, the group had presented a formal objection citing resolutions passed by the Episcopal Church's General Convention that sexual relations are appropriate only within marriage and that it is inappropriate to ordain those who engage in either heterosexual or homosexual relations outside of marriage.

Thomas Brown, one of the two ordained priests who is a homosexual, said it was right for those whose "faith cannot abide the way in which God has called me to live" to

speak out, and that their objection did not bother him.
"I asked God to surround this place with love, and I just kept saying that," he told the

ARCW's Research **Consortium Looking** for Applicants

Milwaukee- The AIDS Resource Center of Wisconsin's (ARCW) Wisconsin AIDS Research Consortium is set to begin a new one year study of triple and quadruple therapy combinations of antiretrovi-ral drugs. The study will consist of four arms: Rescriptor, AZT, Crixivan; Rescriptor, Crixivan, 3TC; AZT, Crixivan, 3TC; or a combination of all four.

Unlike some previous clinical drug trials, this has no placebo arm. Everyone accepted into this trial will receive one of the combinations. This is a national study being conducted by Pharmacia & Upjohn.

"This trial is an opportunity for individuals who are HIV positive, have a CD4 count of at least 50, a minimum viral load of 20,000 copies and they should not have taken previous drug therapy against HIV," said Dr. Brian Buggy, ARCW medical director, lead trial physician and chair of the Consortium's scientific committee. "Everyone accepted into this study will receive medications and proper medical attention from one of six area infectious disease doctors and will be able to follow the progress of their health all at no charge.

Prior to this new trial, the Consortium has participated in several AIDS drug studies which have since been approved by the Food and Drug Administration (FDA) and are now on the open market. These include Abbott Laboratories with Ritonavir (Norvir), Glaxo Wellcome with Lamivudine (Epivir or 3TC) and Pharmacia Upjohn with Delavirdine (Rescriptor).



Re: Abortion

After reading Tom Sena's "A Thinking Gay Man's Journey Toward an Understanding of Abortion" which appeared the Dec. 4, 1997 of Wisconsin Light, we have some questions:

What is his argument for being "pro-life?" What were/are his uncertainties about choice? Exactly what IS Mr. Sena's "understanding" of abortion?

Since he does not give us answers to these questions, we have the impression that his commentary is really an argument for thinking for oneself. Mr. Sena seems to be saying that since he has changed his views on abortion, people do, with reflection, define and redefine their politics. We do not disagree with this!

Mr. Sena accuses N.O.W. of "trumpeting abortion": this is a common semantic slip. On the contrary, feminists do not ADVOCATE abortion; rather, we argue for continuing access to safe abortion procedures for all women

who seek them. In speaking of "the life and humanity of the unborn child," the writer genders the fetus female—a move reminiscent of anti-abortion rhetoric that calls for "Equal Rights for Unborn Women." Unfortunately, Mr. Sena's concern for females fades when it comes to the rights of BORN women: the life of the fetus is only a "fact" if one has a philosophical and/or moral certainty as to when life begins.

The fact is that the fetus is "fundamentally part of the mother's body" (Mr. Sena's words) all during pregnancy. This argument is not (necessarily) for unrestricted rights to abortion, but as abortion -activists have repeatedly explained, for a women's right to choose. Once more, it seems, those of us who work for abortion rights are confronted with a patronizing male voice telling us what to believe.

Perhaps more than anyone, Gay men should



Gay Business Associations Prosper as More Companies Seek Out LGBT Market

the, until recently, largely ignored and untapped Gay and Lesbian market, estimated by some at more than half a trillion dollars. With annual household incomes of Gay men more than 40 percent and Lesbians more than 25 percent above the national average, the community is seen as a lucrative target

Many of these upscale consumers also are business owners who have banded to-gether in local chambers of commerce from Boston to San Diego and beyond. An Internet listing includes groups in Europe, Canada and New Zealand.

In at least one instance, non-Gay businesses are joining such groups to better reach the market.

"Our community is as diverse as our membership," says Nanette Miller, president of San Francisco's Golden Gate Business Association (GGBA). "Heterosexual business owners want to be a part of building up that business community. And they want to do business with us.

Major corporations such as Bank of America, Citibank, Coors, Pacific Gas & Electric and Pacific Telesis are GGBA

The 24-year-old organization, the naThe nation's businesses have seized on tion's oldest, had seen its membership dwindle because of the HIV epidemic but is now rebuilding. Last year, it launched new activities to benefit members and build bridges to the wider community: a bank loan program for members, a method to get HIV positive people back to work, and a youth outreach program.

Citibank and two other GGBA mem-

bers, a local and a national bank, now grant low-interest loans from as little as \$500 to more than \$250,000 to local Gayowned businesses

To our knowledge this is the first Gay and Lesbian micro-loan fund," says

The GGBA also has created Positive Impact, a coalition designed to assist HIV positive individuals who want to return to

the workforce.
"We have the ability to bring together the best of business to assist people who want to go back into the business world as an employer or an employee, so they have the feeling of being productive and, quite frankly, focus on something other than their disease," explains Irv Spivak, imme-diate past president and himself HIV

The coalition, which includes the Life Program and Positive Resource, two nonprofit agencies, so far has facilitated more than 500 temporary and more than 140 permanent positions.

GGBA's youth outreach program will help create and utilize the first queeroriented Junior Achievement curriculum. This national organization teaches high school students about business and eco-nomics. Slated to be launched early this year, the program initially will target local youth organizations. The GGBA also is working with the city's school district to extend the program to classrooms.

"A whole generation was decimated by the AIDS epidemic so we're trying to reach the Gay and Lesbian future entrepreneur to give them a positive role model," explains Miller. "Gay and Lesbian teenage suicides are very high. We want to show them that they are not forgotten, have positive role models and can be successful members of the community. Of course, they also will be our future members and leaders.

One of the organization's goals is to assist similar groups in other cities. "What we'd like to be able to do is show the rest of the country and the world how, when you integrate the Gay and Lesbian portion of your population with the economy and the vitality, energy and creativity of your city, the synergy is absolutely mind-boggling," Sp vak asserts.

He describes an incident in a Midwestern city where a business group had diffi-culty connecting with the local chamber of commerce and corporations:


'They weren't taken seriously and no one wanted to do business with Gays and Lesbians. Once we were able to provide them with ways of cooperation from the chamber, city government and the federal government's Small Business Administration, the situation suddenly turned around.

The GGBA is one of the founders of the Western Business Alliance, a regional group. The organization maintains the alliance's mailing list data base and invites Gay and Lesbian chambers of commerce worldwide to subscribe for free by accessing its Internet web

'What this will do is connect all the chambers around the world to allow us to exchange information," Spivak points out. Acknowledging that Gays and Lesbians represent a significant economic power, he says there may be another, tragic impact: "One of our board members is undertaking a project to identify not how much we currently have in buying power but how much we lost because of the HIV epidemic in tax dollars lost, money never saved or investments never made. I think this country is going to be startled that the number is in the billions.

Sydney Gets Gay Games in 2002

Sydney, Australia-AP- Sydney will host the 2002 Gay Games after beating four North American cities in a vote in Denver on Thursday, November 13. Sydney beat Dallas, Long Beach, Montreal and Toronto and will hold the Games in

September 2002.
The games will have more participants than the 10,000 expected at the Sydney Olympics in 2000.
Sailing, netball and touch rugby will be Sydney's addition to the list of official sports which includes ballroom dancing, tenpin bowling and golf.
Events will take place in Olympic venues and other landmarks, including the Syd-

It was the third time Sydney has bid for the Gay Games and the first time the games will be held in the southern hemisphere.

Gene Suspected of Helping HIV

New York, NY-AP- Scientists might have found one way the AIDS virus evades the body's defenses: A single HIV gene can apparently keep infected cells from declaring that they harbor the virus.

If doctors can find drugs that hamper the gene's cloaking effect, it might help control HIV infections, the test-tube study suggests.

Normally, when a virus infects a cell, the cell displays bits of viral proteins on its surface like red flags to alert the immune system. The system can then kill the cell, keep-

ing the virus from replicating. But the AIDS virus appears to interfere with that warning system by the action of a gene called 'nef." The protein resulting from that gene drastically reduces the cell's

supply of its own red-flag proteins.

The result, according to the study in today's issue of the journal Nature, is that infected cells can be overlooked by the body's immune system. Scientists are already searching for drugs to block specific effects of nef.



respect all people's rights to sexual self expression, as they themselves continue to struggle in our society.

(Heterosexual) women and their allies have a closely related struggle; without either fool-proof methods of contraception, responsible sexual partners, and/or access to safe and legal abortion, women's sexuality will remain curtailed. Rather than a "demand for conformity" regarding abortion, we see a consistent philosophy of sexual autonomy uniting these two "causes".

Hospital Visitation Bill Response

TO THE EDITOR:

In the December 18-31, 1997 issue of The Wisconsin Light, Bill Meunier made a number of serious misstatements in his discussion of AB 397, the hospital visitation bill. 1 will not comment on most of his column, because contrary to his implication, the goal of Log Cabin Republicans is not to destroy the political career of Rep. Baldwin. I do feel it important, however, to correct his misstatements about the hospital visitation bill, which has been adopted by both houses of the legislature now, because it is a vitally important bill for the Lesbian and Gay community. Here are the misstatements and my responses:

Misstatement 1: Current law already allows individuals to tell the hospital to allow your same sex partner to see you. "You simply need to draw up the papers with an attorney."

need to draw up the papers with an attorney."

WRONG! Bill cites no authority for this statement, but he is not an attorney. I am an attorney and I have researched this issue thoroughly. Under current law, there is nothing to require a hospital to recognize a patient's designation of who can visit them, even if "papers" are drawn up with an attorney. In fact, since the statutes are silent on the issue and common law governs, under common law the blood relatives of the patient would have the right to determine visitation rights for a patient who is unable to express his desires.

Rep. Baldwin has stated that she thinks it very unlikely that a hospital would refuse visitation rights to someone who has a medical power of attorney for a patient. However, the medical power of attorney statute does not address the issue of visitation at all, but only grants the patient's agent the right to make

medical decisions. Thus, a hospital is under no legal obligation to allow the patient's agent to visit the patient, and current law creates the strange situation under which a person can make medical decisions for a patient but cannot be assured of his or her right to visit the patient. In addition, AB 397's procedure is much easier and does not require legal papers to be drawn up by an attorney.

Misstatement 2: "There is not a recorded

Misstatement 2: "There is not a recorded case of a Wisconsin hospital refusing to allow a conscious patient to determine who can or

can't see him or her.'

WRONG! One of the members of Log Cabin Republicans experienced this very problem at one of Madison's supposedly progressive hospitals. A nurse tried to prevent him from being present during a procedure that was being performed on his partner, who was conscious. Even when our member told the nurse that he had been present an earlier time the procedure was performed, she said he could not be present. Our member felt certain that if he had been the patient's spouse, the nurse would never have tried to bar his presence.

<u>Misstatement 3</u>: The hospital visitation bill does not cover those situations where a patient cannot communicate with hospital personnel.

DEAD WRONG! The bill was designed specifically for such a situation. All a person need do is inform his or her physician, either orally or in writing (although it would be better to put it in writing so one's partner has proof that the doctor was so informed) of her/his visitation wishes prior to the incident which caused the patient to become unconscious or mentally incompetent. Once the doctor has been so informed, a hospital <u>must</u> permit visitation regardless of the wishes of the blood relatives of the patient or the wishes of anyone else. That is exactly what the bill says.

The only way in which the hospital visitation bill falls short is in situations where a patient is admitted unconscious or mentally incompetent and the patient has not previously informed his or her physician of the patient's visitation wishes. To deal with that situation, however, legislation would have to give the hospitals some manner of determining who is in a valid same-sex relationship, such as through registration with the state. Thus, a full-fledged domestic partnership bill would have been necessary. Bill himself recognizes that such a bill is not politically feasible at this time, regardless of which party controls the legislature, when he later defends Rep. Baldwin's decision not to introduce such a bill because it would not pass.

I find it interesting that those who have defended their lack of support for this bill on the

one hand attack the hospital visitation bill because it does not go far enough, but then defend the failure to introduce a bill which would go far enough on the grounds that it would not succeed.

In any case, Log Cabin Republicans believes that it is better to obtain half a loaf than to obtain no loaf when it is clear that the whole loaf cannot be obtained. Apparently, Bill and others who do not support this bill do not agree.

It is fine for Bill and others to hold out for only a full-fledged domestic partnership bill and thereby prevent Lesbians and Gays from taking power over their lives concerning hospital visitation. That is merely a difference in political philosophy. However, it is not acceptable for Bill and others to wage the disinformation campaign which they have waged. The facts are clear, notwithstanding Bill's de-

cision to twist them: this bill empowers Lesbians and Gays to determine who can visit them, which is a significant change from current law which does not assure Lesbians and Gays that their partners will be able to visit them when they are in the hospital.
















Giving Some Love At Kirby's Klub Helps Those With HIV

Gala Show, Heart Sale Benefit AIDS Network Emergency Service Fund

Kirby's Klub and The Wisconsin Light along with Cass Marie Domino, the Portfolio Men and many others are pitching in to help a very special charity, the Madison AIDS Network Emergency Services Fund for people with HIV. The Emergency Services fund helps those with HIV meet emergency expenses. Mary Turnquist, Executive Director of the AIDS network calls the fund "an important tool that helps the AIDS network meet the needs of its clients."

"The vast majority of our clients are on very tight budgets, even the smallest expense can mean going without food or medication, or not having enough money for a bus pass so they can keep their medical appointments or coming up short on their rent.

The Emergency Services Fund itself is stretched to the limit. Two years ago, the fund ran out of money and last year the AIDS network had to limit the amount it could provide to anyone client in order to keep the fund going all year long.

In response to the AIDS network's request for help, Kirby Sheldon, owner of Kirby's Klub and The Wisconsin Light have come up with a bang up fund raiser called "Give Some Love."

The fund raiser began on Super Bowl Sunday when special valentines went on sale at Kirby's Klub. Through Valentines Day, the hearts will be on sale. Patrons can purchase a heart with a minimum donation of \$1.00. After you decorate your heart, that cute bartender at Kirby's (they have a number of them) will put it up on the wall, so everyone can see that you have given some love.

"For the parents, it takes real courage to accept their child's difference because what terrifies them most - and terrifies just about everyone -- is the prospect of being different themselves, of being seen as different by other people. Neighbors,"

age of virility," he says.

Not unlike Tim Burton's Edward Scissorhands, the visual style of Ma Vie en Rose follows the storyline. At first everything is light, open, cheerful and colorful. Then, what used to be allowed is declared forbidden and Ludovic's world grows darker. The bright, warm colors of the first part of the film contrasts with the second half, painted in colder tints of blue and gray. The film's structure gets steadily looser as the peaceful, middle-class life of Ludovic's family breaks down.

Within their quiet suburb in Brussels, which engenders the fear of others, the utmost is done within the community to be rid of elements that appear to threaten its homogeny. The object of Ludovic's affection, Jerome, is a prisoner of his parent's authority but is attracted to Ludovic's personality. His parents, Albert and Lisette Brun, are uncompromising in their mis-guided principles and do the most to alienate and ostracize Ludovic's family with their hatred.

Berliner explains, "The adults in the film react so strongly because there are other issues lurking behind the basic question of sexual identity: Where do I belong in the world? Who am 1?

'Afterglow' Makes a Comedy of Tears of Two Relationships

In director Alan Rudolph's Afterglow, we follow the lives of four people-two married couples with nothing in commonand how they intermingle and interact under the most unusual of circumstances.

The first couple includes a something, career-obsessed corporate climber, Jeffrey Byron (Jonny Lee Miller). He's an unsympathetic character, totally self-interested and extremely insensitive to his wife Marianne's (Lara Flynn Boyle) de-

sires to have a child.

Marianne's plans for the little one-to-be proceed even without Jeffrey's support. So, when she contracts to have a room of the house converted to a child's room, she meets an aging Lothario carpenter absurdly named Lucky Mann (Nick Nolte). Lucky spends his time "servicing" lonely housewives with leaking pipes, etc., while his former B-movie actress wife, Phyllis' (Julie Christie) watches tapes of her old films in a nostalgic haze. Lucky and Phyllis' marriage is stressed by knowledge of the latter's past infidelities and the former's present ones. They scarcely know how to treat each other with passion and care anymore, but can't seem to give up completely, either.

The film follows the affair Lucky and Marianne embark upon, as well as the chance meeting and subsequently abortive affair between Jeffrey and Phyllis. Two married couples: an older one with a painful past, and a younger one with an uncertain future-confront each other and themselves in this generally well-written, well-acted film.

Afterglow has a plot reminiscent of romantic comedies, and could've easily been adapted to that genre. While there are certainly comedic elements to it, the film is at base a serious look at the trou-

bles couples have with cheating, romance, expectations and disappointments.

Nolte and Christie especially possess charm and chemistry, and when neither of them is on the screen, you can't wait for them to return.

A Gay co-worker of Jeffrey's takes him to a Gay bar and comes out to him, creating the possibility of an intriguing turn of events and perhaps an exploration of Jeffrey's sexuality. Alas, this potential is ignored and nothing happens, or is even hinted at.

Nevertheless, Afterglow boasts excellent acting and writing, and on the strengths of the four central characters, succeeds in entertaining us, if not overwhelmingly so.

'Hard Rain' is a Mildly Entertaining Film, Better Seen on the Big Screen

Most of the current mindless action flicks that dominate cinema screens owe a tremendous debt to Irwin Allen, the founding father of the genre of motion picture best described as "hackneyed disaster epics." Beginning with the delightfully bloated Poseidon Adventure in 1972, Allen perfected the formula for ideal entertainment for the masses.

Allen's tried & true, never-bettered formula involved a simple plot, lots and lots of special effects, some silly romantic shenanigans and a slew of big named stars whose recognizable names often obscured waning careers. Did Glenn mention a simple plot?

Mikael Salomon's Hard Rain is a direct

Hard Rain offers the always marvelous Morgan Freeman as Jim, a good bad guy leading a pack of redneck thieves planning a big \$3 million heist of an amour car. Driving is everyone's favorite lovable grouch Mary Tyler Moore Show's , Lou Grant (Ed Asner). Oops, Asner's character is named Charlie.

To set the stage, the overcast skies have burst resulting in a deluge of rain descending on the armored car. Next to Lou/Charlie is his young nephew Tom (a not-so young, increasingly less attractive Christian Slater, also one of the film's executive producers)

Gosh, it's raining. So much rain, in fact, nat the armored car stalls in that has formed upon on a lonely stretch o' road (Glenn ponders briefly if there is any other kind of road in a cheesy flick like Hard Rain.)

Amidst this murky downpour director Mikael Salomon throws into the "plot" a greedy Sheriff (Randy Quaid) as well as up & coming Minnie Driver as Karen, the obligatory love-interest for Tom, who inauspiciously clobbers him as he seeks refuge in a church. It's love at first thump!

Salomon offers moviegoers few surprises as Jim and his pack of redneck thieves chase Tom (and later Karen) in a variety of motored boats. Perhaps the only real surprise in Hard Rain is that despite all of the rain and all of the flooding, no character actually dies from simple drowning. This is especially surprising given how long some of the underwater stunts actually seem to take. Apparently Hard Rain takes place in a small town filled with Olympic swimmers.

Still, Salomon's classy cast does manage to keep things interesting for awhile. Freeman is given the difficult task (unnecessary?) task of making Jim into a sympathetic bad guy. Ultimately, adrift in a sea of one-dimensional characters, his motivations merely seem confusing.

More fun is Hard Rain's supporting cast. Ed Asner is properly warm and fuzzy in what amounts to a cameo appearance. Another MTM alumnus, Betty White has a few fun moments as comic relief as a shrewish wife. A bearded Richard Dysart too generates a few much needed as White's hen-pecked hubby

Gritty Crime Drama, 'Jackie Brown', is a Fine Follow Up to 'Pulp Fiction'

If Pulp Fiction put Quentin Tarantino on the film industry's map and rejuvenated the sagging career of John Travolta, then Jackie Brown will not only help make Tarantino a permanent feature on that map, but hopefully will rejuvenate Pam Grier's

Jackie Brown is set largely in and around Compton and the seamier side of L.A. Grier, as the title character, is a 44 year old flight attendant with a troubled past. Indeed, she's presently smuggling cash to the US from Mexico for a gun selling hood named Ordell (Samuel L. Jackson).

Ordell wants to bring his whole fortune in ill-gotten money to the US, half a million dollars, but his increasing paranoia leads him to mistrust everyone. His ruthlessness becomes evident when he gets a long time pal (Chris Tucker) out on bail through bail bondsman Max Cherry (Robert Forster).

Afraid Tucker will talk, Ordell springs him just to kill him. When Jackie gets caught bringing in some of his dough, she also gets out on bail thanks to Ordell. He plans the same fate for her, but she's much too smart for that!

Jackie Brown is a long movie- nearly 2 1/2 hours long. It takes its time developing the central characters, as well as the supporting cast, to the point where you know their every quirk. The latter category includes Robert DeNiro as Louis, aging petty crook and friend of Ordell (one of DeNiro's least glamorous roles, to be sure!); Ray the ATF officer (Michael Keaton), who enlists Brown's help to nail Ordell; and sexy Bridget Fonda as Ordell's pot smoking, clueless girlfriend.

Tarantino not only directs but writes Jackie Brown, and while the language is every bit as brutal as the characters depicted, it's stunningly realistic and intelligent - right on a par with Pulp Fiction. His uniquely creative directing is stamped on Jackie Brown every bit as much as a cameo appearance by Hitchcock in one of his films

There's a great scene in which bags of money are being exchanged in a department store ladies' dressing room. The scene is told and retold through the eyes of each of the participants so effectively that each person's point of view becomes familiar to you. Sure, this is a crime movie and many of the characters are awful people, but Tarantino succeeds where others might fail in making them live for you giving each a 3rd dimension. Here and there, however, scenes linger a bit too long, making you start shifting around in your seat uneasily because nothing really interesting is going on. Perhaps 20-odd minutes could've been removed from this film and its narrative wouldn't have suffered a bit.

Many will ask, "Is it as good as Pulp Fic-tion?" I actually found it to be superior to that film in at least one way: Brown is convincingly realistic throughout - unlike Pulp with its over-the-top, unbelievable characters and glowing suitcase!

Add to that, the no holds barred script, the fine directing, first-rate acting and compelling plot a foot-tapping score filled with '70s R&B and Funk, and you have one of 1997's best films (somewhere between #11 and #15 on my list).

Camp and Silliness Undercut Suspense and Thrills in 'Fallen'

Detective John Hobbes (Denzel Washington) doesn't know what to make of the fact that, despite seeing a deranged serial ller he arrested being executed, the murders continue in the killer's style. He and his partner Jonesy (John Goodman) investigate the on-going crimes, thinking they're on the trail of a copycat killer or perhaps still at large partners of the executed murderer. It's not quite so simple, however.

Eventually, Hobbes discovers there's something far more sinister at work here. A series of bizarre clues and circumstances leads him to the daughter of a cop who committed suicide years ago. This woman (Embeth Davidtz), he discovers, is obsessed by angels - her apartment is covered in angel paintings & sculptures.

When Hobbes asks her to identify the name "Azazel" which he found scrawled on a wall, she essentially tells him that he's after a fallen angel who has been moving from person to person for centuries, leaving corpses and mayhem in his

Fallen pits one man - Detective Hobbes against a supernatural killing machine named Azazel in this new take on the serial killer movie genre, directed by Gregory Hoblit and written by Nick Kazan.

It might have worked as a serious, suspenseful, thrilling mystery except for the fact that, if you've seen the TV ads and read anything about it, you already know

the whole plot. I haven't said anything here not known to someone who's heard about this film. Frankly, going into it knowing so much of the story really left very little to be surprised by. If Fallen had been kept more under wraps, I think I would've found it more interesting and suspenseful.

Fallen also borders on camp now and then - not good for a film trying to scare you. There's a scene where Azazel moves between various people around Hobbes at the precinct, each singing portions of the demon's favorite song, "Time is On My Side" by the Rolling Stones. Rather than being spooky, it comes off more like a silly sing-a-long. Indeed, the song turns up every 10 or 15 minutes throughout the film, becoming more and more annoying with each performance.

The silliness factor comes in when you discover that Azazel is just impossible to catch or subdue, and follows no physical rules whatsoever. The idea that he has survived so long via person to person physical contact is an interesting one, but Azazel also can simply leap out of a dead body and just enter anyone close by. He also can enter animals (cats, in the film's case).

The possessed serial killer shakes Hobbes' hand at the start of the film, trying to enter him, but fails. Why? It's not really explained. Indeed, for a 2 hour film, very little is ever satisfactorily explained. You're

"Wisecracker" is a Highly Fascinating **Biography Movingly Told**

Billy, his lover of nearly 50 years had just died and Jimmie was devastated. Some wealthy and influential friends insisted that he come to a New Year's Eve party and he went. He was sitting in a corner by himself, staring into space when a man and his wife approached.

"Jimmie," the man said, "you loved Billy and he was a wonderful person and it's very hard to go on. But Billy would want you to. He wouldn't want to see like this.'

The man was the then governor of California Ronald Reagan. Surprised? I was. Reagan was a homophobe. Gays in general he did not like, but individuals were a different matter. If he liked you and you happened to be Gay, so what?

The story is not made up out of whole cloth. It's verified by his wife Nancy in an interview with the author, is found in a new and fascinating book, Wisecracker: The Life and Times of William Haines by William J. Mann.

Maybe it was because I'd never heard of William Haines or perhaps it was because I had some time on my hands. Whatever it was, out of the many, many books which come into this office on a regular basis, I picked this one up. That was a mistake. Once I had started it, I could not put it

For those of you who may need a little background, the 1920's were the "Golden Age" of Hollywood and actor William Haines was one of that time's biggest

and Gay-stars, directors, writers, composers and the rest. Perhaps there is a "Gay sensibility" after all.

stars. By 1930, he was the number one box office male star in the country. His contemporaries were men like John Barrymore, Charlie Chaplin and John Gilbert. Haines was different. He was Gay, openly Gay, the first Hollywood star to be so.

The '30s brought repression. The moral zealots were on the march. A star, male or female, had to be married-or else. Haines took the "or else" route.

When MGM mogul Louis B. Mayer ordered him to give Jimmie up and marry a woman, Haines quit. He regrouped and opened up a highly successful career as a high society interior decorator.

While you learn all about Gay and Lesbian Hollywood ranging over some 50 years, you also learn about the effects of repression and high cost of living the closeted life. Cary Grant is a good example of that, but there are many others who, unlike Haines, "played the game."

In highly eloquent and readable prose, the author conveys strongly the courage it took for Haines to be out. Mann obviously admires him tremendously and so, at the end of the book, will you.

The book is painstakingly documented. Thankfully, the footnotes are all in the back. There is an extensive index and a center section of pictures.

If you have any interest in the movies and those who make them at all, this is a must-read book.

If you are a romantic, this, too, is a mustread. Not only is this book good history, it is a love story, a Gay love story.

Author Jack Nichols Talks About Religion, Gays and Fundamentalists

Interview by Dave Evans

Evans interviews Badpuppy's GayToday Editor, Jack Nichols, author of The Gay Agenda: Talking Back to the Fundamentalists, published 1996, Prometheus Books, now on sale at Afterwords and other fine bookstores.

Dave Evans: There certainly must be plenty to be said back to the fundamentalists. It appears from your book, though, while you certainly have plenty to say to fundamentalists, that you're mainly on, shall we say, the offensive rather than the defensive.

Jack Nichols: There's no reason to feel defensive. Its like Disney's Michel Eisner finally admitted in a TV interview on the Southern Baptist Convention boycott, "they're nuts!"

When I was a kid I got tuned in quick to nonsense passing for religion. Fundamentalists across the globe-they're present in every country- to tell us how to behave-- and they're always nasty meddlers in every major religion.

Evans: In the same vein as recent protests outside Disney World in Orlando, Florida, (Tuesday, December 31st) do you think that fundamentalism is being seen, nowadays, as more farcical or dangerous?

Nichols: We gotta keep monitors on them. People who think they know what the Book of Revelations is all about are scary. There are some great watchdog organizations in this country and I've recommended to gay activists and others linking arms with some of them.

Evans: Which ones? Nichols: Some are already known friends

Sol Kelly-Jones Thank you very much for this award. It is a real honor. I have great respect for the ACLU because you not only believe in a rainbow of diversity, you live out

your beliefs by securing and protecting human rights for ALL people, as well as rights for our Earth. It takes a lot of courage to go all the way with this kind of work. I want to live my life with that kind of courage - even when it's scarey

Tonight my heart feels full of the concerns of the hundreds of Gay and Lesbian families with children and Gay and Lesbian youth I have heard from in this last year. I've heard from young people, like 17 year old Casey, who said he wanted to end his life, because he couldn't imagine continuing to live in a world where people hate him because he is Gay; where he is denied the most basic of human rights, including the right to, someday, marry who he loves.

I've received letters from Gay and Lesbian parents all over the world, who are denied the basic civil rights needed to protect their children under law.

I know firsthand what this is like. I have two moms but one of my moms, Joann, is denied all legal rights of parenthood, simply because she is Gay. She cannot marry my other mom, Sunshine, her partner of 19 years. She cannot legally adopt me. I would not receive her social security benefits if she died. are denied family health insurance.

In this past year I have, also, heard Gay and Lesbian youth and Gay and Lesbian families speak out with unbelievable courage - even risking their jobs and physical safety.

I have heard our Allies speak out. The ACLU spoke out in New Jersey where they helped to win adoption rights for Gay people in that state. This gives me

lots of hope. In seventeen states it would be legal for my mom, Joann, to adopt me. With the help of the ACLU we can make second parent adoption happen in Wisconsin. Kids like me can be protected. With the help of the ACLU and each of you we can secure domestic partnership health insur-

ance benefits in Wisconsin. Families, like mine, are worthy of these rights and pro-

There's too much silence on these issues. Silence is taking a stance. We need to break the silence on these issues. One of things I've learned over the past year is that all people from the youngest to oldest can make a difference. And I learned how important it is to trust what you have to say in your heart, even when you're scared. We each have a part of the truth to speak and we need to find a way to bring that into the world. I really promise you that I will keep working for justice and I hope you will too.

Editor's Note: All of us here at Wis-

consin Light offer our heartiest congratulations to Sol Kelly-Jones for her well-deserved reward. It is our hope that this young woman's dream of equality and fairness for our people will one day become reality. With people like Sol in the fight, that day will come soon.

used it all up passing prohibition which then had to be undone. The country became a bootlegger's turf and in 1924when Clarence Darrow presided over the Scopes trial in Tennessee-the "Monkey Trial"—the one that coincided with the first fundamentalist assault on evolution.

Thing is, though, there's not that many of them. Fourteen percent, maybe. They're just well organized. We gotta be just as organized. And yeah, they're out there in

cyberspace.

Evans: The credentials of fundamentalists went way down during the eighties due to the shenanigans of Falwell, Robertson, Dobson et al. Aren't they more or less a done deal?

Nichols: I wish. They're taking over school boards, city and county commissions, hospital boards, local government across the board in every state.

Usually they're people badly wounded by life and they think they need what they mistakenly believe is a religious cause—a fight against evil- to give their boring lives meaning. They can't think their ways out of bags. They assert. They believe. But they don't think.

The price of gay and lesbian liberty is eternal vigilance. The fundies are going to keep us on guard-high alert- for a long time. If you're ever tempted to think they're harmless-just remember the want you dead

And don't forget either that the churches will seize every opportunity to wrangle support from your taxes. That's what this school-vouchers controversy is about. They want you to help them send their kids to religious schools. Parochial. These people think big money all the time.

By the way, that's one word we shouldn't let the fundies use: lifestyle. Sounds like you can take it off and put it on as a whim. We all know our emotional and sexual lives can't be reduced to "lifestyle." Life styles of the Baptist Buggerers. How does that sound?

Evans: What are your own beliefs about religion? Are you a spiritual man? Certainly not sprung from the head of Zeus... How did you arrive at your philosophy?

Nichols: I've continued throughout life wondering about my thought- roots. How did I happen to grow up thinking like I do? James T. Sears, in his new book, Lonely Hunters: An Oral History of Lesbian and Gay Southern Life (Westview Press-HarperCollins)gives me two great chapters. He followed my early development, how I got the Scottish poet Robert Burns recited to me three times daily at meals, and how I was influenced by the philosophy behind Walt Disney's film, Pinnochio. And finally, by Whitman.

But first came the Baha'i World Faith, when I was only fourteen. It was a worldunity religion-all faiths, it teaches, are evolutionary steps in a ladder of the One Religion-it was born in 19th century Iran and, among other things, Bahai's taught the equality of the sexes. Racial oneness too. I kept such beliefs as these but graduated, I think at fifteen, into philoso-

I read Tom Paine's Age of Reason. Few people know that the man who inspired the American Revolution also wrote this book to debunk the Bible. He said, "My own mind is my own church." Now, that's a

After I got that far, then, in chronological order I was influenced by Kahlil Gibran, Clarence Darrow, Robert G. Ingersoll, Bertrand Russell, Zen, Lao Tzu, and Walt Whitman. I never really was a believing Christian, though I have very much admired the character of Jesus.

If I've ever had any bibles, books to which I always return, I'd put Leaves of

Grass at the top of the list.

Youngerman told The Wisconsin Light that during the negotiations, the union seriously looked at the School Board's proposals to switch to a different insurance carrier. But in the end the problem, Youngerman said was the carriers proposed by the Board would not have offered the same benefits or did not pro-vide domestic partnership coverage. "The difference in cost was not very much, but the difference in some types of coverage was. " said Youngerman.

"Domestic partnership benefits were a high priority for us," said Youngerman. "It wasn't a matter of economics it was a matter of fairness." When asked about Rosenak's statements that the district could not afford the benefits, and gave the domestic partnership benefits away without getting anything in return, Younger-man replied "That's ludicrous. There was a lot of give and take on the part of both

Youngerman added that during the negotiations, even the School Board negotiators and several members of the Madison School board indicated that they understood the need to provide the benefits. She credited Bonnie Augusta, a Lesbian school teacher, for educating both sides about the issue. "Bonnie did a wonderful job in giving a presentation about this issue to the bargaining committees on both sides.

Youngerman added that due to Augusta's work, members of the teacher's union had put a high priority on getting Domestic partnership benefits for its membership included in the new contract

even before the bargaining got underway.

For her part, Rosenak said that she didn't see her vote against the benefits as an issue in the upcoming election, "It's done and the matter has been settled," she said. Whether, Rosenak wants her vote to be

Ray Allen, the incumbent in Seat Four is also up for re-election. Like Rosenak, Allen voted against the contract, but he told The Light that his vote was based in part on the cost of the domestic partner-ship benefits. "I am not opposed to the benefits. I supported them at first. Then I found out that they weren't costed out."

Allen said the School Board had set

aside money to pay for increased benefits to the Teachers union, but that several items including Domestic Partnership were added to the contract that brought it's cost above the amount that was set aside. He said these items when added together exceeded a million dollars.

We have to find that money somehow," said Allen who emphasized that if the benefits had been covered by what was set aside he would have had no problem with them. Allen said that the partners of 45 teachers have already signed up for receiving the coverage which is slated to begin with the 1998-99 school year. But he wonders how many will actually take advantage of the program.

"Under the law, these benefits are fully taxable," said Allen who added that for some people the increased taxes may make it cheaper for them to purchase their own coverage. Allen is opposed in the April election by Kaleem Caire. Caire is viewed as a liberal whereas Allen is seen as a conservative by most observers.

Glass argued that the 1986 law restricts online services from giving up confidential information but contains no limits on how investigators can go about seeking information.

Judge Sporkin appeared to embrace this argument, noting that police routinely collect evidence volunteered to them that they would otherwise have to obtain through search warrant. He said McVeigh may have a stronger case against AOL, and Wolf said after the hearing that he and his client "are keeping our options open with regard to (suing) AOL.

Sporkin closely questioned Glass about the don't-ask, don't-tell policy.

"You're saying once somebody in an electronic instrument says that they're gay, that that's enough for the Navy to go out and start these (discharge) proceedings," Sporkin said.

That's correct," Glass replied. He said the Navy investigator who called AOL was entirely within the bounds of the

The case may hinge on whether McVeigh's online communications, none of which contained his full name, represented an open, public statement of sexuality. McVeigh has denied he is gay and told the Navy he had once been engaged and attends social events with women.
