Christian Coalition Tries to Recruit 100,000 for War on LGBT America

A Commentary

Washington, DC-On a tense day (February 18) where—on the other side of the globe—a war-ready America again risks conflict, an openly religious war has been declared by the Christian Coalition.

The Coalition's leaders, basking in their February 10 Maine "victory" which struck down government-enacted civil rights for homosexuals at the polls, now are aiming, they say, to strike down the legitimacy of same-sex affection in all 50 states and to target and worsen the basic civil rights of people who are even suspected of defying same-sex taboos.

Boasting about Maine as "Coalition-style" evidence of a divine mission at hand, the Christian Coalition has thus declared war on Gay America, calling for 100,000 recruits to repeat the "Maine

miracle" from coast to coast. Calling its program "Families 2000" the Coalition says its strategy will be to work through local Christian Coalition chapters and churches to oppose any measures that extend anti-discrimination protections based on sexual orientation.

The group will circulate a menu which gives focus to other social "evils" including gambling, pornography, and late-term abortions with which its members may want to concern themselves.

People for the American Way Foundation charges that the Christian Coalition's aggressively declared agenda masks its real troubles-losses in both money and memberships.

"The Christian Coalition's 'new' agenda - to return to the days of Gay-bashing and assaults on constitutional liberties - is the most dramatic evidence yet that the era of former Executive Director Ralph Reed is indeed over," says People For the American Way Foundation President Carole Shields.

"Gone is the effort to persuade Ameri-cans that the Christian Coalition is a mainstream organization with a broader agenda than bashing Gays and trying to outlaw all abortions.

"Randy Tate's announcement that the Coalition will return to an emphasis on social issues is evidence that the Christian Coalition, when faced with a financial cri-Please See Recruit Page 23

Congressman Barrett Announces Milwaukee to Get Federal Funds for AIDS Housing

Milwaukee-On February 12, Congressman Tom Barrett (D-WI) announced that the City of Milwaukee received approval from the US Department of Housing and Urban Development (HUD) for its \$30 million 1998 Consolidated Plan which includes various community development activities. Included in this money is \$363,000 to be used for housing for people living with AIDS.

"For the first time," Barrett said, "HUD is sending funds for a housing program for persons with AIDS."

Milwaukee will receive the Housing

The HOPWA grant is intended to help people with HIV disease and AIDS secure

and maintain safe, affordable housing.
Since 1994, the State of Wisconsm has received HOPWA funds and granted them to local AIDS service providers through-out the state. The AIDS Resource Center of Wisconsin (ARCW) has been a leading recipient of HOPWA funds and has built a

comprehensive housing program serving 750 people with HIV and AIDS.

The \$363,000 that Milwaukee will receive is nearly equal to the amount of the HOPWA funding that the State of Wisconsin made available locally lest year.

"While this is new funding for the City of Milwaukee, it is not new funding for people with HIV and AIDS in Milwausaid ARCW Executive Director Velson, "Our clients rely on these Dong Nelson funds to help pay their rent and utilities so they can afford to stay in their homes. Milwaukee - Political activity on issues related to Gay and Lesbian relationships nas noticeably increased on both a state wide and local level as activists on both sides of the of Gay marriage and Domestic Partnership issues seek to advance their agendas. At stake is nothing less than the legal definition of Gay and Les-

bian relationships.

At first glance it may seem like the issues of Same Sex marriage and Domestic Partnership are separate and distinct, but they are in fact related to each other. Both deal with the right of Gay and Lesbian relationships to be treated equally under

Polls taken by independent researchers show that while Americans as a whole are opposed to allowing Same Sex marriages they agree with giving many of the rights and privileges of marriage such as spousal health insurance benefits, hospital visitation rights and probate rights to Gay and

Lesbian couples.

A series of bills and proposals introduced both at the State Capitol and on a local government level show that the debate on Gay relationships has come to Wisconsin in a big way.

Among the items on a growing list of recent developments on the Domestic Partnership and Same Sex Marriage issues

- The introduction and passage by the State Assembly of AB- 104. Sponsored by Lorraine Serratti, (R-Spread Eagle), this bill would prohibit the state from recognizing Same Sex marriages even if they are legally performed in other states:
- The defeat of a proposal to grant domestic partnership health insur-ance benefits to City of Milwaukee
- Approval of a contract between the Madison Unified School District and its teachers union granting do-mestic partnership health insurance benefits to Madison's teachers; The introduction of a State Senate
- bill that would amend the State of Wisconsin constitution to place a constitutional ban on recognizing same sex marriage.
- The passage and signing of a bill that requires hospitals to grant visitation rights to those who are designated by patients, thereby allowing patients to make sure their partners can see them in the hospital even if the facilities policy only allows for the immediate family to see a patient.

For 12 years Doug Upchurch struggled to become heterosexual. It didn't work.

For most of that period, he was heavily involved in ex-Gay ministries, a growing international movement of Christian groups whose purpose is to lead Gay people toward heterosexuality. While some Lesbians are involved in the groups, the movement is primarily directed at Gay

ex-Gay groups as dangerous and mis-leading. He is developing a Web site called Ex.Ex, which will tell the story of others like him-those who sought out ex-Gay ministries for heavenly intervention to make them straight, but found themselves in a living hell.

Brought up in a mainstream Methodist church, Upchurch grew tired of organized religion. He joined a small charismatic church his first year in high school. There was a contagious electricity in the church that made spiritual pursuit an exciting sensation. With a growing desire to one day become a minister, Upchurch knew that he had to put a stop to his feelingshis attraction toward other males.

He shared his struggle with close friends in high school. They prayed for him. Numerous times he was exorcised for the 'demon of homosexuality.'

In 1986, Upchurch left his home in Houston to attend Baylor University, a conservative Baptist school in Waco.

'When I got to college, I gradually would tell people I knew that I was strug-gling with this," says Upchurch. "This is really sick, but in some cases you tell them because you like the person and you want to see if they are interested in you. In other cases you tell them because you

 Approval of a contract between the Madison Police union and the City that requires the formation of a committee to look into ways of granting domestic partnership benefits to members of the City of Madison's Police Department.

These events point to a two fold approach to legally defining Gay and Lesbian relationships. First, should the state recognize Gay and Lesbian marriages and second what benefits should accrue to the partners of those who are in committed Gay relationships?

Much of the activity related to the marriage issue grew out of attempts to gain legal recognition of Gay marriages in Hawaii. A lower court in that state had ruled that prohibiting those marriages violated the Hawaii constitution.

Most legal observers seemed to feel that the ruling would almost certainly be upheld by the Hawaii State Supreme Court. This precipitated a spate of legislation to ban recognition of same sex marriages in a over 30 states.

Those opposed to those marriages pushed legislation that would ban recognition of them even if they were legally performed elsewhere. In Wisconsin that debate hit home when State Representative Lorraine Seratti (R-Spread Eagle) introduced her AB 104.

After an acrimonious hearing on the bill in Wausau where opponents clearly outnumbered those supporting Serratti, the State Assembly overwhelmingly passed her measure and sent it to the State Sen-

Unlike the Assembly which is controlled by Republicans, the State Senate is controlled by Democrats. The Democratic Leadership in the Senate has buried the bill by putting it in a committee which will not hold a hearing on it.

But Gay and Lesbian activists are worried that AB-104 may soon come up for a vote in the Senate and sent to Governor Thompson who has said he will sign it.

The Senate is now evenly split with sixteen members from each party. There is one vacant seat that was held by Democrat Lynn Adelman until his appointment to the Federal Bench. Adelman's district is largely Republican and it is expected that the Republican nominee for the seat, will win the special election set for April. This would give the GOP control of the Senate.

"If they win that race, it is probable that AB-104 will come off the table and be passed," said one Senate staffer, who added "Fitzgerald's bill could pass to."

State Senator Scott Fitzgerald (R-Juneau) has introduced a bill that would amend the State Constitution to promott same sex marriages in Wisconsin. In order for his proposal to become law it must be approved in two consecutive sessions of the legislature and then approved by the voters.

"It is not easy to amend the state constitution, but if his bill comes out of committee the best chance for stopping that from happening is to make sure the Republicans don't control the state legislature," said the staffer.

Indeed the vote on AB-104 in the State Assembly while not split along party lines certainly indicated more sympathy for Same Sex marriages among Democrats than existed among Republicans.

Nearly half of the Democrats voted against AB-104 while only one Republican vote was recorded in opposition.

But if AB-104 was a slap in the face to the Gay and Lesbian community as some have called it, it also raised the issue of how Gay and Lesbian relationships are treated under the law and led some to question public policies related to Same-Sex relationships.

The so called Hospital Visitation Rights bill sponsored by the Republican Speaker of the House, Scott Jensen (R-Waukesha) was one example of that.

One of those inequities cited during the AB-104 debate was the fact that under what was then the law, hospitals had the legal right to deny the unmarried partners

of a patient access to that patient.

Jensen's bill which is now law allows the patient and not the hospital to decide who can and can not see him.

Critics called the visitation bill meaning less. According to them there were no recorded cases of a hospital denying access and the law states that the patient must tell the hospital to allow his/her partner to visit. This means that the partner of a comatose or unconscious patient could still be denied access.

But the fact remains that the state legislature passed and the Governor signed a bill that made did make at least a small advance in equalizing the treatment of Gay and Lesbian partners under the law. The latest effort to define Gay relationships comes from State Rep. Steve Nass (R-Whitewater) with his bill, AB-759. ABA 759 has fifteen other Republican co-sponsors

co-sponsors.

AB - 759, would forbid the use of state funds to provide Domestic Partnership health insurance benefits to unmarried Gay or straight couples.

If passed the bill would have what Madison Alderman Mike Verveer called "a chilling effect" on getting local government approval of these benefits.

Verveer who has been a force in getting Domestic Partnership health insurance benefits for the City of Madison employees said "Like other cities around the state, The City of Madison has not received its fair share of state revenues. If AB-759 passes it will make it very difficult for Madison or any local government to grant Domestic Partnership benefits because no one wants to have to raise the property tax in order to do that."

Local governments granting these benefits is considered important by those advocating them. During the debate on a proposal to grant Domestic partner benefits to City of Milwaukee employees, Mark Street head of Milwaukee's Domestic Partnership Task Force told The Wisconsin Light that his group hoped the granting of such benefits would set an example for local companies to follow.

At a hearing on AB-759, held in Madison on Thursday, February, 19th Nass told the Assembly Committee on Insurance, Securities and Corporate Policies that his bill was not aimed at Same Sex couples.

According to Nass, his proposal was in response to the Madison School Teacher's contract, which he said was negotiated "behind closed doors." Nass said that parents would be upset when their children came home from school and told them that their teachers were discussing the unmarried partners health insurance benefits.

He also said that he believed there would be more heterosexual couples than Gay couples taking advantage of the Madison School contract's granting of health insurance to the partners of its unmarried teachers.

Nass claimed that the benefits would cost \$300,000 a large portion of which would be paid for with state funds. He claimed that his bill had wide support throughout the state.

That support was certainly not in evidence at the hearing where Nass was the only person to speak in favor of passing his bill.

His testimony was countered not just by Gays and Lesbians but also by representatives of unions who accused Nass of trying to interfere in the collective bargaining process and City officials who said that decisions on who to give health insurance benefits too should be considered a matter of local control.

School Board member Ruth Robarts chided Nass over his statements about the cost to Madison's School District saying that only one person had so far registered for the benefits.

When asked by Rep Sheldon Wasserman (D-Whitefish Bay) whether or not she had encountered any opposition to her position in favor of the contract, Robarts replied that she received one anonymous phone call and a fax from a man who is now running against her due to her support of granting the benefits.

Madison School Board members are elected from a city wide vote. It does seem likely that if there were substantial opposition to the School Board's stand Robarts would have received more than one phone call and one fax.

Unlike the debate on AB-104, any debate on AB-759 is likely see Gays and Lesbians enlisting two powerful allies, public employee unions and local government lobbyists. Both groups bristle at the suggestion may be able to tell them what they can and can not do.

AB-759 seems to many to be pre emptive strike to keep anyone other local government or the state itself from emulating the example set by the Madison School Board.

Indeed with Republicans in control of the State Assembly and the Governor's office, many pro-Gay activists have moved their fight from the State House to City

In Madison their efforts have struck pay dirt twice this year. First with the Madison School Board contract and then with the new Police Union contract.

Verveer told The Light that the committee the City and Union are forming will look at a variety of options including the cost of leaving the State insurance plan (which will not offer the benefits) and the possibility of the City purchasing a separate policy to cover the unmarried partners of its employees.

partners of its employees.
"Whatever is decided upon and ap-

proved will be given to all of the unions and City employees and not just to the Police," he said.

Activists in Madison are having greater success than they are in Milwaukee. Last Fall, at the request of Street's Domestic Partnership Task Force, Milwaukee Alderman, Paul Henningsen introduced a proposal to grant Domestic Partnership benefits to City of Milwaukee employees.

Henningsen's idea never got out of committee.

There are other differences between Milwaukee's effort and Madison's. In Milwaukee the proposal came from an or ganized outside group. In Madison, Gay and Lesbian union members insisted that it be given a high priority in contract negotiations and that it not be negotiated away.

Concurrent with those negotiations, a group of activists worked to educate the Madison School Board. Their efforts were so effective that in the end the School Board agreed to grant the benefits without demanding anything from the Union in return.

The problem faced by those who oppose Domestic Partners benefits is that they are losing ground. Over 30 cities and two states, Vermont and Oregon now offer them to their employees. So do a growing number of both public and private universities.

Added to that is the fact that an ever increasing number of private employers are also offering Domestic partnership benefits to their employees, making it difficult for governmental units that do not do the same to compete for top notch personnel.

The problem faced by advocates of Gay marriage and Domestic partnership benefits is that Gay marriage is not popular with the voters and that their opponents are better organized.

In Wausau the hearing on AB-104 attracted hundreds of people the majority of whom supported Same Sx marriages, but as a rule, Gay organizations with limited resources have a more difficult time in filling up the seats during debates on these issues.

While the voters may favor giving at least some marriage like benefits to Gay and Lesbian couples, there is no evidence to suggest that an enraged electorate would care enough about the issue to turn someone out of office because they voted against granting them.

Furthermore there are no Gay and Lesbian Political Action committees in Wisconsin to provide financial help and volunteers to those supporting an extension of marriage rights to Same Sex couples.

There are however, organized efforts on the other side. Sources in the State Senate say that a post card and letter campaign demanding that the Senate consider Seratti's AB-104 is underway. There has been no comparable effort on the other side.

That may change, however, as the debate continues and intensifies. Some activists believe that no matter what happens on various proposals like AB-104 and AB-759, the very fact that they are being considered is helpful, because hearings and debate on them helps to educate the general public about the nature of Gay and Lesbian relationships and the legal hurdles they face.

As one person said in the hallway during the hearing on the Nass Bill, "Every time they bring this kind of stuff up, we have a chance to educate. That's why we will win in the end."

"There are great opportunities at Pride-Fest for vendors who have never been here before. They will be pleasantly surprised to see that our visitors stay for the entire day, which means people eat more than one meal while they are on the festival grounds," Mahos added.

PrideFest organizers will restrict the number of same-type menus to prevent di-rect competition between food vendors. This will also give planners an opportunity to see what works and what doesn't.


Food building packets are being produced which will detail the building dimensions, the location of equipment, and list the user fees. Fees will vary based on the size of the building vendors use.

Speaking From the Right

Gays Should Give Credit to Newt Gingrich

In Gay American today there is a relentless and fashionable disparagement of Republican U.S. House Speaker Newt Gingrich. But let's put into perspective his great historical achievements.

If Newt Gingrich had been rum over by a

truck in 1993, it is almost certain that there would not be a Republican majority in the U.S. House today. Few other congressional politicians have made such a

difference in partisan history.
Since the Republicans won the 1994 election—with the help of almost 40 percent of national Gay vote—the Dow has doubled, the welfare rolls have been cut by 25 percent and crime has fallen by almost as much. The American people— Gay and straight—are richer, less dependent, safer than they were just a few years ago and by margins almost no one anticipated.

It can plausibly be argued that the first two would not have happened if the Republicans had not won and held Congress-and the last would not have happened if Gay-friendly Rudolph Giuliani had not been elected Mayor of New York

The Republican Congress and the Greenspan Fed gave heart to investors, including the generally affluent Gay com-munity, while the GOP Congress and Giuliani's police department withdrew the sanctions other officeholders a generation ago gave welfare dependency and criminal behavior.

The Speaker's professorial style may turn off many voters; his pugnacity may get him in needless trouble with the

straight and Gay press. Still, Gingrich reminds me of one of the leading figures in Churchill's Life of Marlborough, Wil-

Cool in his personal demeanor, William III was unloved in his country and his capital; he was an outsider who took over a great kingdom almost by accident; as King of England, he undertook responsibilities far beyond the capacity of any one man, and so her performance was often

Yet, he made a difference; in his reign began annual Parliaments, representative government and international finance as we know it today. He held the line against Catholic France and preserved the liber-ties of his sullen subjects and rebellious

Gingrich, approaching his twentieth year in Congress, is a stranger in insider Washington and a disliked figure beyond the Beltway and in Gay America; has taken on the responsibilitie. of long-term strategist and short-term tactician without either the institutional means or all the personal skills needed to fill them.

Like William III, he inspires little loyalty and many not be missed if he ever falls. William III had to wait until Macaulay wrote 150 years later to be appreciated; perhaps Gays today should give Singrich a little credit.

First, let me tell you a little about my situation. I moved to Wisconsin last April and had no idea where the GLBT community was here in Walworth County (to be honest, I still don't know where we are, but I'll be damned if I don't find out!). Getting settled, finding a job and other daily tasks of life took up much of my initial time here in Wisconsin and I have

I did go to PrideFest and saw that there definitely is a community here in Wisconsin. I just had to find it in my little town. My Gaydar had gone off a couple of times when I'd been grocery shopping, but I was just too shy to do the "Hello, I'm Gay, are you?" thing. I knew there had to be a way to meet people without taking out a personal ad or making myself (or someone else) feel terribly uncomfortable in the frozen foods section. I decided to turn to my local internet message boards for a solution.

I asked for a board for the Lakes Area GLBT community to network and share information. I typed my suggestion with the best of intentions. I had no idea what was going to follow.

The response I received was inflammatory and offensive to me.

The person who wrote me, whom I late found out is Alan Fiebig, Director of Data Network Services at State Long Distance Telephone, stated on the suggestion board: 'Considering that the common denominator of the groups you mention is sexual activity (as opposed to a board for gardners [sic] the topics posted on such a board would neither comply with Elknet's Acceptable Usage Policy nor

with the family nature of Elknet. Sorry.. I was outraged at his presumption.

I wrote him expressing my feelings and letting him know that I did not appreciate his, what I deemed to be libelous wordage. My last name was hypertextually linked to that message and anyone reading the server could have seen his statements about me and the rest of the community.

I was also very disturbed that he assumed that the GLBT community was only united by their sexual activity

I quoted the definition of libel to him, demanded his and his superior's name and told him I would go to the press, the National Gay and Lesbian Task Force and the ACLU if I had to, because I felt he had libeled me and had been discriminatory and prejudiced in his deci-

I called him that Monday and tried to iron out some sort of resolution with him before took the incident any further. Mr. Fiebig would not budge. He wanted to know the nature of the posts the boards would contain and I could not answer that. I could not speak for the entire community. That would be ridiculous.

The conversations was fruitless, which brings me here today.

I have contacted the ACLU about this incident and I have also contacted the press. I am very disappointed that the situation has come to this. I pay for this service. I deserve the right to be treated equally and not have my life and my choices implied to be immoral in public. Perhaps if it had been a protest or some other sort of free gathering, I would not have gotten so angry at these sorts of words, but my dollars pay this man's salary and I do not deserve his bigoted comments.

I hope that each of you reading this will look into your Internet Service Provider's policies and ask them if they discriminate regarding sexual affiliation or orientation. I've found out the hard way

A press release date February 4th an-

nouncing the March to be held in the spring of the year 2000 had been sent out spring of the year 2000 had been sent out across the country by the United Fellowship of Metropolitan Community Churches (UFMCC) and the Human Rights Campaign (HRC).

According to The Blade, at least six other national LGBT organizations expressed "serious problems" with the way that HRC and UFMCC announced the march plans.

In a conference call to HRC's Executive

In a conference call to HRC's Executive Director, Elizabeth Birth, heads of the organizations including the National Gay and Lesbian Task Force (NGLTF), the National Black Gay and Lesbian Leader-ship Forum, GLAAD and others agreed that the announcement "happened too

quickly for an appropriate amount of consideration and discussion with an appropriately broad group," according to Lorri Jean, a leader of a group representing Gay community centers across the country.

Therefore, Jean was quoted as saying, the March was put on "pause." Also put on "pause" was an idea that has been circulated by NGLTF: a plan to hold 50 marches on the 50 state capitals in 1999.

According to The Blade, the Gay leaders were angry over not being consulted by HRC and UFMCC. The prevailing feeling was that the two organizations had "jumped the gun" with their announcement of the March.

The controversy around what is being called "the Millennium March," is reminiscent of the heated discussions which took place in the early planning stages of the last March held in 1993. Then, too, there were heated arguments over the name, aims, goals and whether the March should be held at all.

Then, too, there was the proposal for 50 marches on the 50 state capitals, an idea that one observer said "fortunately died a merciful death."


The Blade also reported that Millennial March organizers have already scrapped plans for an actual march through the streets of Washington as was done at pre-vious marches. The Millennium March will actually be a mass gathering on the Mall much like other, recent, "marches" made by other groups.


Birch told The Blade that HRC has re-

ceived "an overwhelmingly positive response to the announcement of the 2000 March." She predicted that "dozens of groups will have endorsed the event within the next several weeks.

"It is very obvious to me that the time for the next Gay march is at the dawn of the new millennium," Birch said. "Right now, the vast majority of Gay, Lesbian, Bisexual and Transgender Americans are not connected to Gay organizations. It will be these people, the rank and file, who will com to this March, in very large numbers.

Birch added, "There has never been a scenario of a Gay march on Washington that has not resulted in some turmoil. But at the end of the day, an incredible event gets delivered to the nation.

From Small Beginnings, the Gay Games Has **Become the World's Largest Sporting Event**

Editor's Note: From August 1-8,1998, the largest athletic event in the world will take place in Amsterdam. This is the Gay Games. Thousands of athletes will participate from all over the world. Uncounted thousands of people will come to watch and enjoy the fun. The following is a short history of the Gay Games.

Gay Games I San Francisco, August 28 1982 to September 5 1982, 1350 athletes from 179 cities in 12 countries par-ticipate in 14 athletic events; 600 volunteers and a budget Of \$125,000

Doctor Tom Waddell, a decathlon competitor at the 1968 Olympic Games in Mexico City, conceived of what would become the Gay Games as an opportunity for Gay page to describe the decay of the control of for Gay people to demonstrate to the world that their skills and competitive spirits in sports parallel those of the rest of humanity and to show how "normal" Gays tend to be in comparison to the stereo-

He wanted to replace the obsession to win at all costs with the positive joys of simple participation. These games would require no minimum ability for participation. Winning would be defined as achieving one's personal best. Competition would not stress nationalism or age and men and women would compete on an equal basis.

A group called San Francisco Arts and Athletics (SFAA) was formed. Two years were spent in the planning of this event which was to be called "Gay Olympic Games." Opening ceremonies were Games." Opening ceremonies were planned for August 28, 1982 and Tina

Turner agreed to perform.

Three weeks before the opening, the United States Olympic Committee (USOC) obtained an injunction in federal court prohibiting the use of the word "Olympic". This despite the fact that the USOC had ignored the use of the ancient word by Special Olympics, Police Olympics, Nude Olympics, Dog Olympics, and many others.

This created chaos and near collapse as the organizing committee scrambled to delete every use of the sacred word in advertising, merchandising, every activity, and every printed page. Somehow, the committee completed the Herculean task and the Opening Ceremonies of the Gay Games were held at Kezar Stadium (once the home of the 49er's football team, and now no longer in existence) in San Francisco on schedule.

SFAA appealed the Federal Court's injunction and a legal battle raged for two years. It was finally settled by the United States Supreme Court in a 5-4 decision in favor of the USOC in March, 1987. The still-vindictive USOC arranged to have legal fees of \$92,000 levied against Tom Waddell's residence, despite the fact he was fighting for his life against AIDS.
"However, by 1993 the USOC had

changed its tune, waiving the legal fees against Tom Waddell's estate and inviting the Federation's Executive Committee to meet with the USOC in Colorado Springs, Colorado, to 'discuss matters of mutual interest'," said Derek Liecty of the Federation of Gay Games.

The Federation of Gay Games (FGG) is the governing body and parent organization of the Gay Games. It is headquartered

in San Francisco.

'A break through in communication was established," Liecty continued, "and a rapprochement is now in place. In 1994, USOC awarded then Olympic Championship diver Greg Lou-

ganis its highest award.

In Greg's acceptance speech he dedi-cated the award to Tom Waddell and im-plored the USOC not to have Olympic volleyball played in homophobic Cobb County, Georgia, as part of the 1996 Olympic Games. It worked. In 1994 the USOC prominently listed Gay Games IV in its annual handbook under noteworthy events. The Gay Games can and do make a difference!

Gay Games II San Francisco ,August 9th to 17th, 1986

3500 Athletes (40% women) From 258 cities in 19 countries participating In 17 sporting events with a budget of \$350,000 (\$30,000 from the city of SF)

It was never the intention of the SFAA to make the Gay Games entirely a San Francisco event. They were kept there a second time in order to refine them and clearly establish their philosophy. Having four years to plan the event, a much more diverse and entertaining set of events was scheduled by the SFAA. "Procession of the Arts", a series of cultural events complementing Gay Games II, was added.

This included concerts, exhibits, plays, conferences, films, dances, cabarets, and an old-fashioned Circus Parade! The events promoting the talents and creativity of the Lesbian/Gay community, spanned the entire month of August.

In 1982, AIDS was virtually unknown. But by 1986, it was an ominous and very scary black cloud that threatened the Gay community. Gay Games II was a psychological boost as it demonstrated our strength, spirit, and unity. Dianne Feinstein, Mayor of San Francisco, welcomed the crowd at the Opening Ceremonies.

Doctor Tom Waddell, founder of the Gay Games, died of AIDS on July 11, 1987.

Gay Games III Vancouver, BC, Canada - August 4th to 11th, 1990 7,500 athletes from 39 countries participating in 23 athletic events 2,000 cultural participants with a budget of \$2.1 Million

The Gay Games grew immensely in both size and stature in the four short years since San Francisco. Vancouver, a very beautiful and friendly city, rose to the occasion. A portion of this effort was funded by the Canadian Federal Government. Vancouver's City Government and its police department were very suppor-tive. Athletes were allowed free use of public transportation!

Gay Games IV New York City June 18th to 25th, 1994 10,864 athletes from 2000 cities in 40 countries participating In 31 athletic events 7000 volunteers and a budget of \$6.5 million.

More athletes competed in Gay Games IV than any other event including the Olympics! The games were held in June in New York City instead of August be-cause 1994 was the 25th anniversary of the Stonewall Riots in 1969.
The Stonewall "March on the United

Nations" took place the following morn-

Gay Games V Amsterdam, Netherlands - August 1st to 8th 1998 12,500 Athletic ond 2,500 Culture Participants from 5 continents are expected to gather in Amsterdam 30 sporting events

"Friendship Through Culture and Sports" is the motto of Gay Games V being held on the first eight days of August

1998 in the beautiful city of Amsterdam.
This is the first time Gay Games will be held outside of North America. It will be interesting to see how the games evolve when a European flavor is added to the blend of forces influencing their path.

From a humble beginning in a half-filled stadium in San Francisco, the games has grown in a mere sixteen years to be the

largest sporting event of all times!
Gay Games V has received enthusiastic financial support from the city of Amsterdam and the government of the Netherlands. Major corporate sponsors include KLM Royal Dutch Airlines, Speedo, and Levi Strauss Europe. A campaign by diver Greg Louganis and tennis star Martina Navaraliova has analed nearly \$500,000 in the United States for the Gay Games.

Registration for participation started in December, and over 8,000 people have already registered. Tickets for the opening and closing ceremonies and events are available through the Gay Games website and merchandise such as T-shirts can be purchased as well.

Entrance to many performances, exhibi-

Senate Censors Seek New Ways to Put Limits on the Internet

DC-Senator Washington, McCain (R.-Ariz) wants all U.S. libraries and public schools to install screening software or face the loss of federal funds for computer education.

The problematic Internet issues, he believes, are online pomography, gambling and consumer fraud. The software to be installed would block access to an esti-mated 28,000 pomographic sites.

Senator Dan Coats (R-Ind.) has introduced a bill that would slap criminal penalties upon anyone who distributes sexual material "harmful to minors" on the Inter-net for profit. Only those sites which provide their visitors free preview images need be concerned, according to authoritative reports.

People for the American Way (PFAW) a 300,000-member organization dedicated to defending civil rights; promoting the democratic values of religious freedom, free speech and respect for diversity, sees government censorship in the McCain

screening plan, however.
Carole Shields, PFAW president, criticized Senator McCain's proposal, one which would require schools and other public institutions to "filter" Internet access in order to qualify for federal discounts for Internet service.

"The Internet is becoming a vital tool for educating our children," Shields said, 'and the universal service discounts are meant to extend that opportunity to every child. These discounts should not come with federal strings of censorship attached."

People for the American Way and the ACLU are contributing assistance in a lawsuit seeking to overturn a similarly restrictive Internet filtering policy in Loudoun County, Virginia public libraries. That lawsuit, with PFAW serving as co-counsel, was filed in federal court in December.

opponents of governmentsponsored censorship include the American Library Association, the ACLU, and the computer industry, all of whom argue that both the McCain and Coats bills im-pose unfair burden on educational institu-

Last summer the U.S. Supreme Court delivered a unanimous decision striking down a previous attempt by Congressthe 1996 Communications Decency Actto crack down on so-called pornography. Currently, gamblers with modems, are

able to access sites if they have credit cards, using online slot machines, poker and blackjack games, lotteries, off track betting, and roulette wheels.

"On the Internet," complained Representative Frank LoBiondo (R.-N.J.)
"gambling is virtually a free-for-all. Gamblers have no assurance they will be paid their winnings, and, unlike Atlantic City, there is no floor supervisor to complain to if you feel you're being treated unfairly."
Two states, Missouri and Minnesota, al-

ready ban Internet gambling, while other locales are considering such legislation. Foes of such bans—the Internet gambling industry-claim that these laws infringenot on free speech- but on free com-

Software that interferes with so-called "sexual" material routinely blocks all educational information about AIDS, safe sex, and access to any Gay-friendly sites that provide avenues to self-esteem and news about civil rights and social equality. The word "Gay" is often the only in-dicator seized upon by such software to provoke access denials.

In the public libraries in Loudoun County, Virginia, for example, entire daily issues of the San Francisco Examiner are blocked whenever individual Examiner columnists discuss questions relating to Gay and Lesbian rights or to

The McCain plan, according to People for the American Way, would take away from parents and teachers the decision about what children may have access to, outting that decision in the hands of the federal government.

"While the vast majority of Internet content is appropriate for children, it should be up to parents working with their local school districts, and not the federal government, to decide how to limit their children" exposure to inappropriate con-tent," said PFAW officials.

Carol Sheilds points out that Internet filters have often proved problematic and meffective, "screening out a large amount of educationally valuable material—making their forced installation in schools

particularly onerous.' Schools, she believes, now have a variety of less intrusive means of controlling inappropriate material, such as supervising the students or teaching them about the possible dangers they face on the

his own death.

But startling advances in the treatment of AIDS have changed his perspective, so he and thousands like him are able once again to think about their futures.

We're not necessarily planning for death. We're planning for life," he told a legislative committee recently.

It is not as simple a task as it might seem. So the state is being asked to help Kletecka and thousands like him by spending an extra \$100,000.

> And there are serious concerns on the state level about whether the big surpluses can be sustained in future budgets. So lawmakers are cautiously sifting through what the state can, and in some cases must, afford.



Father of Gay Activist Militancy Isn't Discouraged by Recent Losses

Washington, D.C.--Franklin E. Kameny, Ph.D., the father of Gay activist militancy, is neither discouraged nor disillusioned by the LGBT defeat in Maine on February 10. "We should be prepared to continue to do battle, both reactively and proactively,"

In 1961, the earnest 72-year old Harvard astronomer single-handedly made himself the nation's foremost authority on how to thwart the U.S. Government's anti-Gay policies. Kameny was also the first American to attempt the elimination of anti-Gay government discrimination, taking his case to the U.S. Supreme Court.

Under the unflappable scientist's leadership, the Mattachine Society of Washington. America's first militant/activist group, introduced bold activist strategies into the After four movement persistent, dedicated Gay movement work, Kameny remains as involved as ever in the historic struggle that reflects, as it grows, much of what began in his always-controversial, carefully-reasoned statements, clearly marked roadmaps to equality for same-sex affection under the

In the wake of the February 10 defeat for Gay rights at the polls in Maine, Kameny says that the Lesbian and Gay movement's tactical responses to declarations of war by the Christian right must be waged "more competently than we have in the past.

The pioneering Gay leader predicts, however, that "full success" is ahead for Gays who request nothing less than full equality with fellow U.S. citizens.

Nevertheless, he says, "we have not done nearly as well as we should both strategically and rhetorically. They (the Christian Coalition) have come up with effective sound bites, of which their special rights has been the most devastating. We have not come up with adequate counters.

Kameny believes that such "sound bites and rhetoric are crucial!" He points at how

"the opposition raises arguments which have no relationship to relevant reality, and has no compunctions about inventing 'facts' to suit them."

The veteran Gay strategist insists it is "necessary to LISTEN to what is said, and to refute, rebut and otherwise counter it point by point." He thinks that thus far such countering of arguments has been less than effective.

There has been too much of a tendency as (apparently) in Maine, to be compla-cent. We should always approach these fights as if it were absolutely certain that we will lose unless we make an all-out effort, and then make that all-out effort. These fights are no place for timidity or

"Further," says Kameny, "our people tend to be 'nice guys'; theirs are not. They have respect neither for truth nor for civility. They fight 'hardball'; our people must learn to do likewise, as alien as that type of fighting is for many of us.

The Christian Coalition's declaration of war on Gay America, he says, is marked by a "marshalling of troops" and their "coming out in full force in shameless celebration of prejudice, bigotry, dis-crimination, and undiluted hatred, in the evident hope of extending their success.

"Ultimately," according to Kameny, "of course most, if not all of these battles will be trumped by the enactment of ENDA (the Employment Non-discrimination Act pending in Congress) and so it is there that we must continue to direct our efforts in full force and relentlessly. While ENDA deals only with employment discrimination, once it has become law, additional protections in housing and public accommodations will probably be relatively easy to enact.'

Kameny says that Gay men and Lesbians will win most of the battles ahead because "we are right, moral and American and they are wrong, immoral and unAmerican."





National LGBT Groups Move Cautiously in Call for Maine Boycott

Washington, DC-Boycott the Pain in Maine! was one of many slogans that are being considered for buttons and bumper stickers, produced by veteran Southern Gay activist Bob Kunst of The Oral Majority.

Kunst, who directs The Oral Majority (he founded it shortly after the emergence of Jerry Falwell's Moral Majority) has, in the past month, marshaled forces to en-courage tourist boycotts of the Cayman

The Associated Press (AP) has disseminated news of the boycott filed in Augusta (February 18) and headlined "Florida Gay group plans boycott of Maine.'

Finding—in the South—groundswells of support for this idea, Kunst's Miami support for this idea, Kunst's Miami Beach-based organization has suddenly added Maine to its boycott list and is presently shipping thousands of boycott buttons and bumper stickers from Miami to New Orleans where they will become a visible part of the Mardi Gras scene there,

A member of the pro-Gay rights group, Maine Won't Discriminate, Kunst said, had asked him not to announce such a boycott. This Gay and Lesbian activist group has been silent about its forthcoming strategies and is said to be reviewing its options in the week since Maine became the first U.S. state to rescind state-government-sanctioned same-sex protections in employment, housing, credit, and public accommodations.

Kunst asked the Maine Gay activist, he

said, to give reasons for his objections to a national boycott. "Because we live here," the member is reported to have replied.

None of the mainstream lesbian and gay organizations, including the National Gay and Lesbian Task Force and the Human Rights Campaign, have suggested boycotts. The HRC, in fact, issued a press release saying, in effect, that the repeal of protections did not truly reflect Maine's

more tolerant majority.

Others believe that the state's voters would have turned out to defeat the repeal had the February 10 referendum not taken place in the immediate wake of fierce ice storms. It appears, nevertheless, that Christian Coalition stalwarts did arrive in sufficient numbers at the polls.

Are there reasons for caution? Another veteran activist, Dr. Franklin Kameny of Washington, D.C., said he thought that Maine's Gay activist group needs, perhaps, more than a couple of weeks to map out its next strategic moves. Kameny also expressed reservations—as a general rule--about the efficacy of Gay and Lesbian political strategies that are hatched outside of an affected area, in this case, Maine. "It is possible to be too far from the center of

what's going on," he said.

Kunst argues that the anti-gay vote in Maine is hardly a local issue, "If the rest of the country fails to show Maine how we feel about this, its going to happen elsewhere...in other states. That's why silence isn't the right answer. Boycotting

Complacency, Lack of Education May Have Contributed to Defeat in Maine

Augusta, ME--Gay-rights activists outspent their opponents 3 to 1, put Maine's popular governor on television to stump for them, and even had a poll saying 62 percent of voters were on their side.

But they still narrowly lost the February

10th referendum that repealed the state's law protecting Gays and Lesbians from certain forms of discrimination. What happened is an instructive lesson on the power of grassroots activism and how not to run a campaign, experts say.

It was always going to be close, and it was going to go to whichever group was able to mobilize their supporters, get their people to the polls," said Oliver Woshin-sky, a political science professor at the

University of Southern Maine.

The 51-49 percent victory, he says, `is a tribute to the organizational talents" of the location of the locatio last spring by the Legislature and signed with much fanfare by Gov. Angus King.

Those forces largely consisted of ex-

tremist Christian groups that focused all their energy on convincing their sympa-thizers to turn out and vote. Although most of the low-key effort during the storm-shortened campaign was in the rural areas that carried the vote, work also was done marshalling the faithful in urban Cumberland and York counties.

Television ads against the Gay rights statute did not start appearing on televi-sion until the weekend before the vote, about a week after the other side led by Maine Won't Discriminate had hit the air-

However, despite spending more than \$150,000 on television in the month leading up to the referendum, Maine Won't Discriminate lost what should have

been a decisive edge, one expert says.
"They squandered their TV budget," said Bowdoin College professor Christian Potholm, a pollster who worked with the media firm that helped Maine Won't Discriminate during a 1995 referendum against Gay rights.

The firm was not rehired for this year's

battle.

They took their biggest advantage and they squandered it, and they have nobody to blame but themselves," said Potholm, who also advises the independent gover-

Because the Gay rights groups won in 1995, they might have been lulled into a sense of complacency this time around, said Ken Hayes, a University of Maine political scientist and former Democratic

I really think there was a belief among many of the supporters of the so-called Gay rights movement that the issue had been resolved," Hayes said, describing the repeal effort as "the stealth campaign.

Commercials featuring King telling the public how he intended to vote but not overtly urging viewers to vote the same way lacked the sense of urgency needed to convince voters to turn out for a midwinter, single-issue referendum, Potholm said.

Karen Geraghty, campaign manager for Maine Won't Discriminate, defended her group's efforts, pointing out the vote was decided by "a very, very, very small group of the electorate.

"Given the fact that this campaign was run during the holidays and during one of the worst storms we've ever had, where two-thirds of the state was without power, I think we did a really great job," Geraghty said.

Campaign spokesman Joe Cooper said the pro-repeal groups had one advantage his side could not match: a captive audi-

"In the rural areas, where does everyone come together? In the churches," Cooper 'We didn't have that option.'

Although Geraghty maintains Maine Won't Discriminate had volunteers in twothirds of the towns in the state, her organization first focused its efforts on those towns where it won 55 percent or more of the vote in 1995. Those included some of Maine's biggest cities.

Next in order of importance: towns where Gay rights supporters won 51 to 55 percent. After that, the emphasis was on areas where the vote had been about 47 to 50 percent, Geraghty said.

"We had a lot of ground to cover in a short amount of time," she said.

Paul Volle executive director of the

Paul Volle, executive director of the Christian Coalition of Maine and one of the repeal effort's principal leaders, ac-knowledged the churches were a "cornerstone," but he emphasized the campaign did not stop there.

Volle and his ``ground troops," as he

put Cumberland and York counties because those two areas had solidly rejected an anti-Gay rights referendum proposal in

We had to minimize those losses so the rest of the state could carry us through," he said.

Although the two counties voted against repeal this time, Volle believes the margin could have been much higher.

Volle said his group would continue to poll Mainers to identify friendly voters, asking them two questions: Do you favor special rights for homosexuality, and do you favor partial-birth abortions?

The Christian Coalition also will examine the lists of people who voted to look for duplicate votes and "questionable registrations," especially in southern Maine, Volle said.

Meanwhile, Gay-rights supporters are regrouping to carry on the crusade, this time with particular attention to rural ar-

Election returns identify the need to reach Mainers outside our cities and better educate the public about the need for antidiscrimination legislation," the Maine Lesbian/Gay Political Alliance said in a statement Friday.

Maine Defeat Brings Fallout, Debate and **Threat of Boycott**

By Bill Meunier Milwaukee- They had a 62% to 27% lead in pre-election polls and they outspent their opponents by a 3 to 1 margin. Yet on February 10th proponents of Maine's new Gay Civil rights law saw it overturned at the polls by a margin of 51% to 49%

With talk of a national boycott of Maine and products produced there, a threat to establish a new national network of churches to "build on the Maine victory" issued by the Christian Coalition, it is clear the repercussions of the Maine vote may be with Gay and Lesbian America for a while.

What Happened
The Maine Gay Civil Rights law passed its legislature and was enthusiastically signed by Governor Angus King in May, 1997. The ink on King's signature was hardly dry when a coalition of right wing Christian fundmentalists announced a petition campaign to exercise "a peoples

The Maine constitution allows for referendums on laws passed by the legislature provided a sufficient number of signatures are gathered within a strict time limit. In October, the Maine Secretary of State was presented with enough signatures to force a referendum on the issue.

This was the second referendum Maine had held on Gay civil rights. In November, 1995 Maine votes rejected a measure that would have prohibit local governments from passing Gay Civil rights ordinances by a vote of 53% to

Pre election polls showed that by a margin of 62% to 27% Maine's voters favored retaining the new law. But on election day only 35% of those voters turned out and a majority of them voted for repeal.

Leaders of Maine Won't Discriminate, a coalition that opposed repeal, blamed a bad storm that left the two thirds of the state without power and the captive audience their opponents had gamed through churches in rural areas.

Some Maine political observers tell a different story. They say that the storm affected everyone equally and given their past victory in 1995 and big margin in the polls backers of the law became complacent.

One pollster who worked on the 1995 campaign said that the pro Gay civil rights forces "squandered their advantage" running poor TV ads. The ads Maine's featured popular independent Governor, King. In the ads, King said he was going to vote against repeal but did not specifically urge others to join him in doing so.

Others also blame those who managed the pro-Gay civil rights campaign pointing out that they outspent the proponents of repeal by a three to one margin.

The Fall Out As a result of its victory in Maine, the Christian Coalition announced a new campaign designed to re-energize itself. The campaign calls for the recruitment of 100,000 "liaisons" in churches around the country. The liaisons would help mobilize their church memberships to lobby against Gay rights and abortion and to mobilize their congregations at elections.

The Christian Coalition was helped by its victory in Maine. The group had been losing members and contributions were down following the resignation of its Ralph Reed and announcement of an IRS investigation that could result in its tax exempt status being revoked due to political activity the

group is alleged to have engaged in.

The Human Rights Campaign was quick to denounce the Coalition plan. A statement issued by Elizabeth Birch, HRC director points out that polls show that 70% of America's Christians believe that it is wrong to discriminate against Lesbians and Gays. Boycott?

Meanwhile, a Florida group, the Oral Majority has called for a boycott of Maine. That call has not been taken up by national Gay and Lesbian groups. In fact HRC issued a press release that seemed to be discouraging boycott talk. The release said that the vote did not reflect Maine's more tolerant majority.

The Oral Majority says that has shipped thousands of stickers to New Orleans to be worn during that city's Mardi Gras celebration. The groups head, Bob Kunst said the anti-gay vote in Maine is not just a local issue. "If the rest of the country fails to show Maine how we feel about this, its going to happen elsewhere...in other states. That's why silence isn't the right answer. Boycotting is."
Others aren't so sure. Veteran activist

Dr. Frank Kameny has urged outsiders to give Maine Won't Discriminate a chance to come up with its own strategy. 'Strategies from the outside seldom work.

There may be debate about what caused the defeat and what should be done in reaction to it, but one thing is clear, the issue of state wide Gay civil rights law in Maine seems to be a dead end for the foreseeable future. Even King who has been an ardent support of the idea said the legislature should move onto to other things.

A Gay Sailor's Life Under "Don't Ask" is a **Revolving Door**

"You have to live two separate lives," says Sean (a pseudonym), a career noncommissioned officer, during an interview on what it's like to be Gay or Lesbian and live under the Pentagon's "Don't Ask, Don't Tell, Don't Pursue" policy. "They say sooner or later you're going to cave in to one or the other. You have to realize that any day they can take your whole career away from you and that's really

Sean agreed to the interview if he were

not identified.

Closets in the military have revolving oors. "We're in the closet when we are [on duty] and out of the closet on our personal time, like at a party," he explains. "But then we are back in the closet if someone from work shows up at the party, but we are out if we are on vacation far away.

Such a paranoid schizophrenic existence can be unbearable. The pressure sometimes can cause sailors to wash out. makes it tougher for the rest of us," Sean "We need to show that we are, to paraphrase the Army slogan, the best of what we can be. We always feel that we have to be better than anyone else because if you're Gay and you're a dirt bag, you're out of here, buddy. They'll kick you out in a heartbeat. If you're Gay and a stellar performer, then they'll look the other way, because it's convenient for

The policy is being applied unequally and, despite assurances to the contrary, some commanders continue to carry out illegal witch hunts.

"Commands are inconsistent. Some will bust you just because of a rumor.

He says one sailor was suspected of being Gay or wearing drag because he had women's shoes in his locker he was holding for his girlfriend.

"Others will praise you and say it's really great. I've had officers try to fix me up with other enlisted personnel because they know the guys are having the same problems. But I won't go for anything like that. You have to be very cautious and make sure there's no hidden agenda.

He acknowledges that life is somewhat easier under Don't Ask, Don't Tell because witch hunts are not as rampant. believe it is happening in some com-mands, but a lot of commanders don't want to deal with it anymore. They really don't want to know.'

Sean enlisted many years before the policy was implemented, in part to escape his homosexuality. "I joined because I thought they'd kill me. I figured why should I exist if I were Gay? Back then, I didn't know what to do. I figured there were no Gays in the Navy and they would straighten me out.'

It wasn't long before he realized he was not alone. "I was in boot camp and one of the guys propositioned me, but I blew it off because I didn't know whether he was serious. I was afraid. I didn't want to do anything wrong. I didn't want to get kicked out.'

He worried about his mannerisms and how he talked. "I even had a picture of a girl and said it was my girlfriend. People would ask me 'What's her name?' 'How come I don't see you with her?' So now I tell people I'm Gay, 'but, look, I'm not a threat so don't worry about it.' Some say, you know, I never met Gay people before', yet they've been working with them all this time

His "Gaydar" picks up signals from others. "Just the way they carry themselves, you know that they're Gay. I think what's important is you have to pretend that you're not Gay by going out of the way to pretend that you're straight. That causes a lot of people to ask questions."

Over the years he has encountered dis-crimination. He sometimes didn't receive awards and battle citations he deserved. "My superiors said, 'Well, just as long as we all keep our mouths shut, we'll let you stay in. You're lucky we don't say any-

Promotions are based on periodic per-formance evaluations, which before Don't Ask, Don't Tell were used indiscriminately against suspected Gays. "Once I was marked 'perfect' in all areas," he recalls. "It made it look like I was the model sailor. They even wrote that on the report. They were very pleased with my performance.

However, the evaluation also had a section labeled 'personal behavior'. "They marked me low on that, so I asked why. They said 'Because what you do on your personal time is against the Navy's

He credits Admiral Jeremy M. Boorda, the chief of naval operations who committed suicide in May 1996 amid allegations that he was wearing unearned combat ribbons, with making life easier for Gavs and Lesbians. Beloved by the enlisted ranks, he was called a "sailor's admiral." Sean says Boorda was Gay friendly. "He didn't like the discrimination that was being brought on single peo-ple in the Navy. It's assumed that if you were not married you're Gay. That's a bad assumption. There are a lot of single people who are not."

The admiral dropped 'personal behavior' from the performance evaluation Unfortunately, Boorda was not as popular in the officer ranks, and rumors were spread that he was homosexual.

"A lot of things he did for Gays - the enlisted people, the junior people – was really good and people up [in the chain of command] didn't like that."

Sean has thus far survived his kafkaesque life, but it has not been easy. Discrimination is always present. "I've been questioned by people whom I have not come out to and I asked, 'Why are they treating me this way?' They said, 'Well, let's just say that assumptions lead to suspicions, which lead to accusations, which lead to the truth.' What they implied was 'Okay, we can't prove it or we don't know, but if you want to further investigate it, we will.' And that's not And that's not

"We have met the enemy and he is us" is Pogo cartoonist Walt Kelly's well-known paraphrasing of War of 1812 naval commander Öliver Hazard Perry. Ironically, it suits the modern Navy,

"You have to separate the enemies among us first," Sean says. "A lot of Gay people will out other Gays. That's so wrong. It's not happening nearly as much as it did before Don't Ask, Don't Tell was adopted. Someone would say to me, 'you know, that guy's a faggot', yet he would be sleeping with the same guy off duty. Unfortunately, that was the way to get promoted, to show that they were supportive of the military's policy


Sean says the argument that openly Gay and Lesbian military personnel would hinder combat operations makes no sense. 'Straights who feel that way don't realize that they are already showering with and sleeping next to Gay people when they are

He recalls news coverage when the pol-icy was implemented. TV crews were brought aboard a submarine, where they interviewed sailors, "They asked, 'How would you feel if the guy next to you was Gay?' Now on nationwide TV with cameras in my face I would say, 'I wouldn't like it'. Only because I'm protecting myself. It's called CYA - cover your ass. I know two of the guys who were on that submarine. They were openly Gay outside the Navy.

Homosexuality is so common that combat operations surely would be impeded if all were discharged. Some jobs are held predominately by Gays and Lesbians. "Yeomen secretaries and personnel staff who take care of service records are mostly Gay," he says. "So are medical corpsmen and dental technicians.

Cracks are appearing in the wall of resistance to change. A captain who writes on a variety of topics under the pseudo-nym Buster Pittman for the Navy Times, an independent weekly, called for deep-sixing Don't Ask, Don't Tell in a November 10, 1997 column: "The ban that prevents Gays and Lesbians from serving openly in the U.S. military is an unjustifiable violation of the principles of freedom upon which this country was established." He said U.S. 9th Circuit Court of Appeals Judge William A. Norris predicted in a speech that the policy would eventually be buried in the "national cemetery of shame" along with earlier Supreme Court decisions that permitted slavery and seg-regated public facilities.

The column elicited several letters to the Navy Times editor. In one, Capt. Joseph Ragan of the medical corps at Camp Pendleton, Calif., wrote: "A service Pendleton, Calif., wrote: member's sexual orientation is not relevant either to his or her ability to serve in the military - or to the military's ability to fulfill its mission. Don't Ask, Don't Tell was a politically expedient compromise which has outlived whatever usefulness it once might have had. Let's bag it now.

April 1 Deadline for Those Seeking Asylum in U.S. Because of Sexual Orientation

sexual minorities is a tragically routine occurrence throughout the world. Consider how in Islamic fundamentalist countries, homosexuality may be punished by the death penalty; in Russia and China, homosexuals are subject to electroshock therapy to convert them into hetero-sexuals; and in several Latin American countries, death squads hunt and exterminate homosexuals as part of their "social cleansing" efforts.

This persecution goes unpunished when the government inflicts or condones the abuse or mistreatment. Without legal re-dress available, many victims flee to the United States for safety given the relatively better treatment and rule of law they can find here against such violations.

Homosexuals who have experienced or fear persecution in their homelands have been eligible for asylum in the United States as members of a particular social group since June, 1994 when Toboso-Alfonso, 2 I&N Dec. 819 (BIA 1990), the Board of Immigration Appeals case in-volving a Cuban Gay asylum-seeker, was

designated as precedent.

On April 1, 1998, an unprecedented one-year filing deadline on asylum claims will take effect, requiring that all asylum

Washington, DC-Persecution against applicants file within one year of arrival in the United States unless they can prove "exceptional circumstances" for their failure to file.

Concerned that sexual minorities will fall through the cracks without greater outreach and education to advocates and the Gay and Lesbian community, the Heartland Alliance for Human Needs & Human Rights and the Lesbian and Gay Immigration Rights Task Force have produced the innovative, practical publication entitled Preparing Sexual Orientation-Based Asylum Claims: A Handbook for Advocates and Asylum-Seekers.

Authored by Heather McClure, Christo-pher Nugent and Lavi Soloway, the 178page handbook provides an in-depth focus on preparing affirmative applications for asylum by Gays and Lesbians, and in-sightful information and resources to aid sexual minority asylum-seekers and their advocates in the preparation and repre-sentation of bona fide asylum claims.

Foregrounding the needs of sexual minority asylum-seekers, the handbook in-cludes chapters on the history of asylum based on sexual orientation; clientcentered approaches to working with the applicant; techniques to raise relevant information and facilitate the client's informed decision of whether to file; step-by-step preparation of the application and the client's affidavit; guidelines and resources for securing supporting docu-mentation for sexual orientation-based claims; considerations when preparing the client to testify; and further resources for legal, social, medical and psychological support for the asylum-seeker. The handbook also addresses legal concerns for HIV-positive asylum-seekers.

The handbook is a component of the Emergency Asylum Campaign launched by the Lesbian and Gay Immigration Rights Task Force and the International Gay & Lesbian Human Rights Commission to alert potential Gay and Lesbian

asylum-seekers to the April 1st deadline. Asylum claims by Gays or Lesbians have been rare with less than two hundred identified by the International Gay & Les-bian Human Rights Commission in San Francisco.

There are several reasons for the low numbers of these asylum claims: clients' eligibility unfamiliarity with their ply; reluctance to disclose their fears based on their sexual orientation to a lawver in this "foreign" land; and advocates' difficulties in eliciting from clients such relevant information or, once discovered, the difficulties in evaluating or developing asylum claims.

"It is our hope that the handbook will serve as an invaluable resource to get the word out to potential asylum-seekers about the April 1st filing deadline and to support practitioners' rigorous evaluation, preparation and representation of Gay and esbian asylum-seekers before Asylum Offices nationwide," said Christopher



Renowned Playwright Michael Neville, **Brings Humor to Milwaukee Stage**

By Noah Archer

Michael Neville, whose play, School Girls in Uniform, opens March 14th at the Broadway Theater Center, has the look and laugh of a grown up bad boy. Not the kind of bad boy who's chased down the back alleys in "Cops," but the mischievous older brother who sets all the clocks in the house an hour ahead. Neville confesses to spending much of his high school career in detention. "The Salvatorians used to make us kneel on our hands," he laughed. "I did it so often, my mother thought I was get-Neville brings this same puckish subver-

siveness to School Girls in Uniform, a comedy set in a girls' military boarding school in Virginia. "The play goes after what I think is a pretty obvious target, the military establishment that persecutes Gay people," Neville said. "Unfortunately, a lot of military power brokers get off on sexual McCarthyism.'

"Most of the characters in School Girls are minorities: Lesbians, people with many, many marriages, REO Speedwagon freaks. Call it the zany adventures of bent lovers in an ultra-straight society.'

Neville describes his own sexual orien-

tation as "openly Bi."

"I won't reveal the secrets of my boudoir," he said. "Let's just say my toy soldiers come to life after midnight.

Quentin Crisp, author of The Naked Civil Servant, calls School Girls in Uniform, "wickedly funny."

Neville, whose plays have been produced on and off Broadway and in regional theaters around the country, has turned a nost exclusively to comedy in re-

"I've had six plays done in Playwrights Studio Theater's "Festival of Ten-Minute Plays," and all but one of them are comedies.

"It's my response to the outlandish number of family and friends who've died in recent years. You might cal it a Celtic retort to mortality," Neville said, "After all, my people refer to the obituaries as 'the Irish sports pages.

Neville said he uses humor as a weapon against "the basic terribleness of life." "Laughter is better than Prozac," he said, "and it doesn't squash your libido.

Neville adapted three musicals, Eileen One Touch of Venus and Music in the Air for Broadway in the 1980s during the first wave of the AIDS epidemic.

"The producer died of complications

from AIDS during the run of Music in the Air," he said. "Since then, more than half the people in those casts got hit and went down from the same thing.

Neville has responded to the AIDS pandemic with more than just comedy. Since moving back to Milwaukee from New York City where he lived for fifteen years, in 1988, he has donated his time and work to the Milwaukee AIDS Project, ArtReach Milwaukee and the BestD Clinic.

Most recently, a staged reading of School Girls at the Boulevard Ensemble Studio Theater raised \$250 for BestD

Despite, or perhaps because of, Neville's black sense of humor, School Girls in Uniform is surprisingly upbeat.

"Sure, I like to see my heroes prevail over the vile bastards who oppress them," he said. "It may not always be that way in life, but it's the way it ought to be."

School Girls in Uniform opens Satur-day, March 14th at 10:30 p.m. at the Studio Theater of the Broadway Theatre Centre, 158 N. Broadway in Milwaukee's Historic

Despite Rough Spots, the Florentine's Production of "Abduction" is Grand

Mozart's "Abduction from the Seraglio" was first performed over 200 years ago in Vienna. This German comic-romantic opera or "singspiel," however, has proven timeless and the Florentine Opera Company presented it again to a delighted audience in Uhlein Hall at the Marcus Center the weekend of February 20-22.

"Abduction" is a charming way for the Florentine to celebrate 65 years of musical excellence in the field of opera and to make a notable addition to Milwaukee's International Arts Festival this year.

The plot, in brief, concerns two pairs of lovers attempting to flee from captivity in the Turkish palace of Pasha Selim. Selim has romantic designs on the leading lady, Constanza, while his palace guard, Osman, is determined to conquer the affections of Constanza's maid, Blonda.

Constanza's and Blonda's lovers, Belmonte, a young Spanish nobleman and Pedrillo, a servant, are determined that all of them shall escape, while Osman is just as determined that they shall not. That's when all the comic fun begins, interspersed with Mozart's wonderful arias of hope, love, anguish and determination. Many a musical and comic-dramatic moment intervenes before the final joyous notes are played and sung.

On stage, the depiction of a Turkish palace and garden were nicely realized by one basic set with a plaza raised several steps, 4 minarets, a great central door, two side towers with shuttered windows on the second floor that could be opened. All this was bathed in bright, Mediterranean sunlit colors that, along with the vividly colored costumes, helped to complete the picture of a Turkish palace and garden by the

Pasha Selim, played by Ronald Marx, with his imposing height and strong speaking voice, created a very striking and handsome appearance and easily dominated the stage during his appearances.

Erie Mills as Constanza continued to reinforce her international reputation by meeting with commitment and a clear coloratura soprano voice all the musical demands of the part, whether it was love, sorrow, joy, longing or defiance.

Lynette Tapia as Blonda was delightful as a willful and spirited person in her own right, but vocally she seemed small voiced and lacking the intensity to match the fire of her acting.

Jonathan Boyd who played Pedrillo, proved to have an excellent tenor voice capable of both an exciting war cry in "On to Battle" and the softness of a romantic serenade in "In Moorish Lands." However, he needs to learn to act in a more natural way than "Look at me, isn't this a cute pose or move?

Belmonte, played by Bradley D. Wil-

liams, on the other hand, moved and acted in a much more realistic manner, but though he sang all the coloratura notes of his role, his light, lyrical tenor voice lacked the passion and intensity to really move our hearts when he sang of his anguish or

The singer who reminded us that this is a romantic-comic opera was Kurt Link playing and singing the part of Osman the palace guard. His was a strong bass voice that had an excellent range and he knew how to make us laugh with his comic rages, romantic failures and drunken fool-

One reservation about this charming opera production would be that the overhead projections that conveyed the German translations into English were often poorly timed to what was being spoken or sung on stage and also at times, not very accu-

"Hedwig and the Angry Inch" Opens Off-**Broadway to Wild Applause**

New York, NY-- Hedwig Schmidt is not Hansel, now Hedwig, finds himself in a your average Transsexual.

She, er, he never quite completed the operation that would have transformed him into her. There was a little bit left over, so to speak, which is where Hedwig and the Angry Inch, a wild and wonderful "neoglam, post-punk rock musical," gets its ti-

We are talking identity crisis here, of both Hedwig, a self-styled "girlie boy," and of the American musical, stretched into a provocative evening of ditsy humor, punctuated by a terrific rock score. Both survive the transformation.

What author and star John Cameron Mitchell has done is create something that defies easy categorizing, although its vibrant theatricality is not in doubt.

Mitchell's Teutonic title character, an internationally ignored" song stylist, delivers what is essentially an 80-minute cabaret show in the faded ballroom of the real-life Hotel Riverview on the far west fringes of Greenwich Village. It's hilarious mock-confessional autobiography, chockfull of political and show business asides and a liberal dose of raunch.

Hedwig's story certainly is exotic. Born in what was then East Berlin, our hero, then called Hansel, finds fleeting happiness with an American serviceman who suggests marriage and then a sex-change operation, in that order.

The operation doesn't quite succeed, but

Hedwig finds relief with Tommy Gnosis, a young rocker on his way to superstardom. Tommy later abandons Hedwig, too; in fact, as Hedwig and the Angry Inch opens, he is performing just across the Hudson River at a major stadium concert in New Jersey's Meadowlands. Is Hedwig bitter? You bet, which leads to much lamenting, a lot of it hostile and a lot of it very, very funny.

Mitchell, looking like the offspring of Farrah Fawcett and Rum Tum Tugger from Cats, handles the pulsating, heavy-duty score written by Stephen Trask, with surprising ease. He is a strong singer and an accomplished actor.

Hedwig is accompanied by a band called the Angry Inch, in reality a gritty rock troupe called Cheater, and a sexually ambiguous backup singer named Itzhak, portrayed by Miriam Shor.

Yet it is Mitchell who must carry the show and he does. The dynamic performer turns Hedwig and the Angry Inch into a tough-talking and hard-driving tour de

'Live Flesh' is a Sensual, Sometimes Melodramatic, Spanish Thriller

Judging from his earlier writing & directing efforts, namely Women on the Verge of a Nervous Breakdown (1987), Tie Me Up, Tie Me Down! (1989), and High Heels (1991), you'd expect Pedro Al-modóvar's latest effort, Live Flesh, to be just as interesting: quirky characters, inventive plot, sexy, humorous, soap opera-romantic, and a tad violent. You'd be right, I'm glad to say, as Live Flesh certainly stands comparison to his earlier, successful efforts at breaking into global, mainstream film making.

Pedro Almodóvar is something of a Spanish visionary, a writer-director who grew up (and became a compulsive movie-goer) during the last years of the Franco dictatorship, working in Super-8mm and 16mm initially, with his first feature film release coinciding with the birth of democracy in Spain in 1980.



'Ma Vie en Rose' is an Interesting, But Ultimately a Disappointing Film

Leaving the preview screening of the sweet and charming new film, Ma Vie en Rose (My Life in Pink), Glenn was puzzled? Puzzled by the film, but also puzzled by the reaction of so very many of fans who mobbed Glenn as he left the cin-

The overwhelming response to Ma Vie en Rose was startlingly enthusiastic. Both women and men found the story of cute little Ludo (Georges du Fresne), a crossdressing seven-year-old to mirror many of

As a youngster Glenn often fantasized that he was adopted - Glenn just could not, after-all, be related by blood to the dreary working class family that fed, inadequtely clothed and gave shelter to fabulous little Glenn.

Wearing women's clothes, on the other hand never seemed to appeal to Glenn. On one distressingly horrific occasion, Glenn found himself playing "dress-up" with a cute little neighbor boy. Glenn enjoyed the all-to-brief moment of his friend's nudity but quickly found himself dressed up in the pale lavender (always a favorite color of Glenn's) cocktail dress of his friend's mother. The dress was strapless. Glenn was nine.

Years of therapy have not diminished the terror Glenn experienced looking into that full-length mirror and which Glenn continues to experience from subsequent nightmares.

Yes, it can be told, Glenn is simply not a pretty girl.

But back to Ma Vie en Rose.

Unlike little Glenn, little Ludo is absolutely adorable in female attire, catching even the eye of little Jerome, the son of his father's boss. Ludo's dressing up and Ludo's friendship with Jerome soon turn the neighborhood topsy-turvy.

The final straw occurs during a school play performance. Glenn imagines it is of Snow White". Quite ingeniously Ludo locks the little girl playing the sleeping princess in the little girl's room and takes her place, knowing that Jerome, playing the handsome prince, will kiss her awake.

be removed from school. Apparently, at all costs, innocent minds must be saved from such perversion!!!

Ma Vie en Rose disappointingly settles into the familiar "Afterschool Special" formula. Initially little Ludo's "antics" were found to be amusing. Yet all that changed when Ludo turned seven. Who doesn't know that by the time one turns seven, all such foolishness must end. Here the focus of the film turns to how Ludo's "antics" are effecting the rest of the family - Dad loses his job, Ludo's brothers made fun of at school, etc.

Much more interesting is the magical world of "Pam", the fabulous, day-glo television world to which Ludo increasingly turns when his real family (excepting hip Grandmother Elisabeth) begin to distance themselves from and ultimately disown Often imagining himself/herself as "Pam", Ludo seems certain that in such a marvelous place as "Pam-land", there would be a place for a little girl mistakenly born into a little boy's body.

First-time director Alain Berliner has obvious affection for Ludo and Georges du Fresne's performance is quite touching. Ludo's hope that a miracle might still happen and his earnest attempts to reconcile his family are portrayed with great warmth and sensitivity. Sadly, at the close of Ma Vie en Rose, Berliner ultimately does his delightfully headstrong protagonist a disservice.

Dad's gotten a new job. Ludo reluctantly returns to his parents, following their move to a new neighborhood. Mom has new friends in which to share coffee and cigarettes. And Ludo meets Chris, a prototypical tomboy.

By introducing such a marvelous counterpoint for Ludo, Glenn thought that Berliner was offering Ludo's parents a perfect opportunity to gain some new insight. Yet, against the merry background of a child's birthday party, there occurs yet another moment of violence so shocking that even Berliner's obligatory "happy ending" can't entirely dispel it.

Fabulous Salaries and Technology Make Modern Films Less than Art

American films were loathe to give up the already jeopardized star system, and whereas American film directors became increasingly more important in the 50's and 60's, the seamless expertise of studio products remained in demand by the majority of the movie-going public. Interestingly enough, even Rita Hayworth's most famous film Gilda (1946) is less renowned for its subtle manipulation of film-noire themes than for

But not only was the star system taking on a different hue, but directors themselves were given an excess of financial and artistic freedom which as long as it remained in the hands of such capable artists as Frank Capra, Billy Wilder, Zinnemann, and Alfred Hitchcock, could transduce a balance between a newly contemptuous dismissiveness toward former Hollywood romanticism, and a need to match European new-wave realism with its own American variation.

MGM continued to make Fred Astaire Musicals; attempts were made to popularize the steamier novels and plays of the day such as Peyton Place [1956], and Picnic [1955] Super spectacles such as Ben Hur [1959], Quo Vadis [1950], and Ten Commandments [1956] were meant to lure audiences away from the luridness of downbeat European morbid wool-gathering as well as the impending threat of television; but the dichotomous relationship between director and actor seemed a disadvantage to both.

Audiences in America were attracted to very few directorial names, and stars could no longer be the singular factor guaranteeing a film's success. If nothing else, the foreign influx had placed a premium on quality. The enduring popularity of Ten Commandments and Ben Hur was in no small measure attributable to De Mille and William Wyler respectively, both of long standing reputation, but paradoxically these standard audience- pleasers outlasted the esoteric products of European cinema verite, although neither film was much of an auteur classic.

However, European neo- realism influenced many fine post -war American films even if in modified form which never deviated completely from he studio -polished "Hollywood

Wilder's Sunset Boulevard and Stalag 17 took an 'honest" look at cinema personalities and prison camps respectively. William Holden's presence assured box office. Stanley Kramer's On the Beach [1959] and Judgment at Nuremberg [1961] were no less smoothly tailored, but even more pessimistically haunted by the war as were Fred Zinnemann's **The Men** [1950]- Marlon Brando's first film- and **From Here to Eternity** [1953]. The sincere earnestness of these fine films was at some small cost in ecstatic fluency and emotional momentum of Hollywood's Romantic period.

Only George Stevens attempted the unlikely union of lyricism and realism, albeit finely honed to a quiet hypnotic moodiness By slowly dissolving concluding shots into subsequent ones he created a quasi-Romantic toniness which worked well in A Place in the Sun [1951] and proved that Elizabeth Taylor could act. He transformed Shane [1953] into a poetic ode to movie Western mythology which was widely admired ,but his style was too limited to wear well.

British director David Lean took an ambivalent look at ambivalence itself in The Bridge on the River Kwai]1957]--the conflict between moral compulsivity, duty, and common sense. Too studied AND ambivalent to be understood ,the film was widely praised for its "realistic" look at conflicting and self-canceling war -time ideals. The film's

polite but hypocritical nihilism is often regarded as a dry wartime classic.

As the new wave of American directors Altman, Brooks, Bogdanovich, De Palma Schlesinger, began taking license with their artistic freedom, it was becoming apparent by the 1970's that something was being lost. Such innovative films as Day of the Jackal [1975], Nashville [1975], The Last Picture Show' [1971], Looking for Mr.Goodbar [1977]. Dressed to Kill [1980] have not stood the test of time ---only subject to a particular limited time in our cultural evolution [although I might make a small plea for Bogdanovich's Last Picture Show].

Similarly, the first wave of the "new" American film stars- Brando, Clift, and James Dean, quickly deteriorated, were short lived, or as in the case of Brando, developed a deserved contempt for their profession- a contempt even shared by such a popular ac-

tor as Harrison Ford in the 90's. While it is true that popular stars of the later50's and 60's such as Gregory Peck, Kurk Douglas, Burt Lancaster, provided a pretty good body of work, they failed to displace memories of studio directed stars such as Humphrey Bogart, Gary Cooper, Henry

Fonda, and Cary Grant. Ironically, the on screen longevity of actors such as Katharine Hepburn, Cary Grant, and James Stewart, and the aura of elan which they transferred from their work in the 40's gave them a dubious, but not undeserved reputation of 'class' which may have been more inherited than earned. But the point is that some subliminal pleasure ob-

tained from movies was gradually being lost. The aforementioned directors were becoming subsumed as contributors to a body of work too "trend -directed" to develop the unique individuality that only a Hitchkock retained. As films became more timely, they lost their claim to timelessness.

The Golden Age was dead and an appropriate and perhaps deserved ugliness was permeating the arts of the 20th century We were getting the backwash of the century's

To further complicate any analysis of current filmdom, it was becoming correspondingly apparent decades earlier that fewer and fewer "great films" would be forthcoming in the last half of the Twentieth Century despite a plethora of free- wheeling experimentation, and a very determined stable of aggressive new actors with a killer instinct to succeed. Their were exceptions of course; Hitchcock's famous trilogy, Psycho [1960], Vertigo [1958], North by Northwest ,[1959] and Coppola's Godfather 1 and 2 .[1972-

74]
Perhaps the most perplexing occurrence was the initial enthusiasm for, and later idealization of, of the comic book fantasy, the Star Wars Trilogy[1977]. It established Lucas Foss as that curious hybrid- the directing technocrat Perhaps the fun-filled Star trilogy was a reaction to an earlier dead- serious science fiction effort. The very talented Stanley Kubrick had created 2001 [1968] as an almost religious exercise in metaphysical fantasy, complete with unctuous silences and disposable actors. His mellifluous style of making violence and horror exotically beautiful as in The Shining [1980] and Clockwork Orange [1971] almost outdid the most sophisticated European efforts, but the embalmed nature of his technique exasperatingly revealed in Barry Lyndon [1975] almost undid him, despite his successful [and under appreciated] stab at satirizing the cold war in Dr. Strangelove [1964]. Ironically only 2001 remains a memorable curiosity of effete distinction and is still widely admired.

But as film directors undercut the prestige of stars, even highly paid ones, and the stars started demanding directorial control themselves, both were being subverted by a threat more dangerous to the artistic future of films that television had ever been--computerized technology.

Star Wars had been intended to create a moral allegory using technology as the core basis of man's hope for the future. Considering the mechanical aspect of his achievement, the end result was surprisingly tender and even sentimental

However, the new technocracy began to overwhelm the film industry to the same extent that the giant enclosed shopping mall were replacing open store fronts-and with the same hot house, claustrophobic effect

By the 80s. movies had became more expensive, and as the new crop of directors Figgis , Tarantino, Spike Lee, Ken Russell, Oliver Stone, Larry Clark(the creep that did Kids and came up with an unprintable follow-up film), became obsessed with ambitions beyond their talents ,and as a group of non-acting film stars -Swartzenegger, Seagal, Van Damm, along with as minimally talented stars as Cruise, Moore, Stallone, Pitt, received salaries almost equaling the film's budget, both star and director became subservient to the demands for super expensive takes which were too costly to be edited

The stars popularity depended on their kinetic prowess, very much like trained circus performers rather than for personal or histrionic attributes which they generally did not







Talking to the Stars

Martha Wash, the Diva of Gay Clubs Where "It's Raining Men"

Anyone who has been in a Gay bar in the last 25 years undoubtedly knows the soaring voice that belongs to Martha Wash. From her early beginnings with Sylvester to her diva run as part of Two Tons of Fun and the Weather Girls, Wash's powerhouse talent has become one of the most recognizable voices in clubland, belting some of the most well-known and treasured dance classics of all time, including the club anthem "It's Raining Men."

"The Gay community has been the base of my success," says the singer. "I'm one to know how supportive the Gay community can be. They started with me when I was with Sylvester, who had a large following, and have grown with me all through the years. They've been there and supported me, even when I didn't have an album."

Having endured the ups and downs of roller coaster career, Wash may finally be getting her much deserved due thanks to Logic Records, which will release a collection of her best loved songs, including a 1997 remake of her Weather Girl's signature tune, "It's Raining Men," with dragster RuPaul.

"We thought it would be totally hilarious. No one would think to put us together," she says of her pairing with America's most popular drag queen. "We were trying to bring it into the '90s, and keep it fun, by adding a different twist" she says. "It's a cult classic. It will never die. I wasn't sure how well it was going to work, but it turned out to be great."

This is Wash's first full-length album since her 1993 solo debut on RCA Records, and features hits from her nearly three-decade old career, including "It's Raining Men," with the Weather Girls, "It's True I Do," with Two Tons of Fun, "Strike It Up" with Black Box and "Sweat" with C&C Music Factory.

It also features "Taking Away Your Space," which was written for her by Slyvester, "Keep On Jumpin'," with Jocelyn Brown, and "Carry On," "Someone Who Believes In You" and "Give It To You," from her solo release. There are also three new tracks.

The idea for the project came from Logic Records, which wanted to put together a collection of songs celebrating Wash's career. While hardly one disc could capture everything she's done from the early days with Sylvester, to her '70s and '80s run with Izora Armstead, her former Two Tons of.Fun and Weather Girls partner, through her solo and collaborative work today with Todd Terry and Luther Vandross, "Martha Wash – The Collection," is a small peak into her vast catalog of tunes.

"I had never thought about releasing a greatest hits package before. I didn't realize that I had recorded as much a I had," she says of the new opus. "I'm very pleased with it. It goes all the way back to the beginning and up to new stuff."

Wash still finds it difficult to shed her Weather Girls association. It has been more than a year since she spoke with Armstead, who now lives in Germany. An still carries on the Weather Girls act with her daughter singing in Wash's place.

But she hopes to shed some of that with her upcoming U.S. club tour beginning in February. But don't expect it to be the kind of club gig that most of her fans of come to know her for — a three song set, lipsynched in the middle of a smoky dance club. Wash is assembling a band, with back-up singers and musicians, and rehearsing a live show to take on tour to small venues and R&B clubs in the U.S. It will give Wash a chance to showcase her powerhouse vocal chords.

Born and raised in San Francisco, Wash got her start at the age of two singing in her parents' church choir. In the early-'70s, she joined a local gospel group, where she met Armstead. A year later, the two answered an advertisement in a San Francisco paper seeking two large-sized Black women who could sing. Unbeknownst to them, the singer they auditioned for was the late, disco-queen, Sylvester, who died in the late-80s of complications from AIDS.

Calling themselves Two Tons of Fun, Wash and Armstead became a staple in Gay clubs and on the R&B circuit, eventually landing a recording deal, and releasing several top-selling R&B albums.

But it was their 1984 campy disco ditty, "It's Raining Men," that catapulted them to stardom, and prompted them to change their name to The Weather Girls. The fun, upbeat tune went on to top the dance and pop charts all over the world. Their debut release, "Success," was certified gold.

But after two less-than-stellar follow-up albums, and years of playing the clubs, the two women parted company in the late-1980s.

Soon after though, Wash went on to lend her voice to songs for such groups as C&C Music Factory and Black Box, singing some of their top selling hits including, "Sweat (Everybody Dance Now)" and "Strike It Up," respectively. Black Box's debut set, "Dreamland," featured four number one Billboard dance singles and three top 40 hits sung by Wash.

Those stints also landed Wash on the front pages of the national press, when the two groups replaced the singer in their respective videos with a svelte, perfectly shaped, caramel-colored woman, lipsynching to Wash's voice, and failed to credit her on their albums.

Die-hard fans recognized Wash's distinctive voice. They saw the video, with the skinny, beautiful female singer, but anyone who knew Wash, knew it wasn't the same person. "It was blatant," she recalls. "I was able to deal with it. It wasn't pleasant, but I survived it. I felt vindicated. The situation was not true. I wanted people to know that."

She also adds that her law suit was also a victory for heavy-set women. "We live in a society where everything has to be immediate – it's all about the visual and the marketing, instead of the whole picture,"

"As large as I was, I still could sing. I'm never going to be a size eight. I'd look horrible if I were," Wash adds. "I'm not going to buy into the idea that thin is the thing. I have a problem with people's idea of beauty. Everyone is not the same size. Folks have to get over it. People can be large and sexy."

Her victorious law suit earned her more than just due credit and justice, it also landed her an exclusive recording contract with RCA Records, which released her critically acclaimed, but commercially disappointing self-titled solo debut.

After several years of a quiet period, Wash took the dance world by storm once again last year, when she teamed up with former disco diva Jocelyn Brown for the Todd Terry produced "Keep On Jumpin'," which topped the dance charts all over the world.

She also covered Elton John's classic "I'm Still Standing," on the First Wives Club soundtrack, and teamed with Luther Vandross for a duet on his last album. Her newest offering, a remake of her Weather Girls' classic, "It's Raining Men," with Ru-Paul in Armstead's place, debuted in the top spot on Billboard's dance chart when it was released last December.

Off stage, Wash has been very involved in the fight against AIDS, having lost many close friends, including her close friend Slyvester. "I used to tell people that I really hated having to do this," she says of the AIDS benefits she sang at. "None of us should have to do this. AIDS shouldn't exist. All we can do though is try and support people with AIDS, raise money. But my think is not so much for research, but for people who need assistance and home care. That money is not trickling down from Washington. Those are the people who need the help. It's up to us to go out and raise the money, cause Washington isn't going to give it to us. We have to help people with food, medicines, doctor appointments."

And losing Slyvester was one of the toughest things she's had to do. "He was ready for it when it happened," she recalls.

"I went to see him six months before he passed away. I knew it was coming. I resigned myself for it. I knew it was just his time. I miss him still. He was a survivor."

Wash is trying not to think too far ahead. She is hopeful the greatest hits collection will spark a renewed interest in her to record labels and land her a deal for a recording of new material by year's end. But, regardless, the veteran songstress, says she'll just keep on doing what she does hest—survive.

"I'm still surviving. Each day I wake-up and try to maintain what I'm doing and just do my best," she says. "It's been an adventure. I've had many ups and many downs. Sometimes you have to go along for the ride," she says of her nearly three-decade old career. "It's all a part of a learning experience. It's not been good or bad all the way, it's been both. I've just learned you have to ride it out until things change. I've always just hoped for the best."

The delay in the release of the Titanic movie affords no better example of the dominance of the technician over the artist. Directors no longer have the luxury of reevaluating or rethinking their work. The 'pinpoints of light' that initiated films almost a century ago are no longer the director's handiwork, nor is he glow of "starlight' screen personas like Garbo, part of our moviegoing experience.

Instead we may be subjected to the boredom of an endless supply of computer bits ordered into being by monitor keyboards. Even serious independent films such as Ice

sis and a profound legal challenge, is returning to the red meat issues that motivate its members.

"Staring down the twin barrels of flagging contributions and an FEC lawsuit, the group is returning to a narrow Religious Right message, calculated to stir up its members and fill its bank account."

Shields noted that just before Christmas, the group announced it was laying off employees and severing ties with its socalled "Samaritan Project," which sought to convert communities of color to the Religious Right political agenda.

The Coalition's outreach to minorities obviously did not resonate with its mem-bership," Shields said.

dirty politics are very clear," Tate was told by the angered Kunst.

The National Gay and Lesbian Task Force (NGLTF) denounced the new Christian Coalition Campaign as a "shal-

"The repeal effort was the result of a campaign of lies and distortions by its promoters. This is another shallow fundraising ploy to pad their coffers at the expense of the Gay, Lesbian, Bisexual, and Transgendered community," said Lobel, executive director of NGLTF.

Lobel was also critical of Christian Coalition executive director Randy Tate, who characterized the passage of the discriminatory ballot measure in Maine as "a

clear victory for people of faith."

The NGLTF director stated, "In every community there are people of every race. gender, and religion who stand for equality and know that discrimination is wrong. Randy Tate and the Christian Coalition have no right to speak for all people of faith.

The Human Rights Campaign (HRC) charges that the Christian Coalition is seeking to promote discrimination nationwide. An HRC statement says that Pat Robertson's and Randy Tate's group has misread the results of the Maine election.

"It is unconscionable that a group purporting to speak for Christians would embark on a systematic national campaign promoting discrimination in the trappings of faith," said HRC Executive Director Elizabeth Birch. "Recent polling has found a strong majority of Christians -- 70 percent - believe that Gays and Lesbians should be protected from discrimination in the workplace."

"Poll after poll demonstrates that --when Americans learn that currently, in most of the country, there is no legal protection from discrimination based on sexual orientation, they overwhelmingly sup-port rectifying that," said HRC Communi-cations Director and Senior Strategist David M. Smith. "Americans understand that discrimination" that discrimination is wrong. The path of faith points toward fairness - not the politics of fear.'

Ten states currently include sexual orientation in their non-discrimination laws: California, Connecticut, Hawaii, Massa-chusetts, Minnesota, New Hampshire, New Jersey, Rhode Island, Vermont and Wisconsin. Of these, only two states— Massachusetts and California—have initiative or referendum procedures that may allow for a Maine-style repeal effort.

According to the February 13 edition of The Washington Blade, seven state legislatures are currently considering bills to protect their citizens from discrimination based on sexual orientation: Arizona, Illinois, Iowa, Maryland, Nebraska, New York and West Virginia.

that in Milwaukee, no one with AIDS will ever be homeless.

Nelson noted that people with HIV and AIDS across Milwaukee are facing a crisis in accessing safe, affordable housing. The 750 requests for rent and housing assistance from HOPWA funding that ARCW filled in 1997 was three times higher than 1996.

More clients are seeking assistance every day. The housing crisis for people with HIV and AIDS has worsened in recent years because welfare reform and changes in Social Security Disability have cut funds available to people with HIV and AIDS by about one-third.

The housing crisis is even more acute due to the good news of effective HIV drug therapies.

"Stable housing is a critical component to overall AIDS care to ensure people have the opportunity to maintain rigorous new treatment regimens and receive the potentially life-saving benefits of AIDS drug therapies," said Nelson.

Efficient City administration of this funding is essential to serving as many people with HIV and AIDS as possible Nelson said.

HOPWA funding has "Historically, served as a lifeline that has enabled us to get people with HIV and AIDS into housing. We need to ensure that the changeover in administering this grant from the State to the City doesn't disrupt

"While there continues to be a need for meanle living more dollars for housing for people living with HIV and AIDS, the HOPWA program has been efficient and well run," commented Brother Stephen Braddock, executive director of St. Camillus. "Our houses are filled to capacity and we have people approaching us almost daily for a place to live. It is my hope that HOPWA continues to be an effective client focused program with low administrative costs," added Braddock.

really are hurting, and you feel that if you don't get this off your chest and get it done with, you're never going to live a normal life."

During his sophomore year, he was told that he could not be a leader in his church in Waco unless his homosexual feelings were "dealt with." Upchurch's college minister suggested prayer, reading the Bible and involvement in a weekly group that met in Dallas. The group was affiliated with an organization called Exodus International, the largest of several ministries who claim a "way out" of homosexuality.

Each week Upchurch would make the 90-minute trek to Dallas. In the group were men of all ages. Some married. Some promiscuous. Some whose homosexual thoughts had not led to "acting

The leader lectured weekly on the causes of homosexuality, which was thought to be a symptom of a larger problem.

Dad Didn't Love Me

"That larger problem could have been unmet personal needs as a child," explains Upchurch, "that my father either didn't love me enough or wasn't there enough or perhaps that it was abuse. It could have been a number of things, but I vividly remember the drawing on the blackboard of the iceberg, and the tip of the iceberg was homosexuality, and everything below it was the real problem you had to get rid

The faithful students were taught that the way to overcome homosexuality was to replace the void left from a dysfunc-tional childhood with the love of God.

Upchurch began seeking the void in his family. Through group discussions as well as weekly writing and reading assignments, he started to believe that he experienced a "lack of caring" as a child. At times he would weep for the loss he felt.
After spending the summer with his par-

ents, Upchurch returned to Waco to find that the group had disbanded because the leader "fell into immorality."

Exorcism

He continued to bargain with God for a change in orientation throughout college. He dated girls and increased his involvement in church activities. His senior year, he requested an exorcism to rid himself of homosexuality. He fasted for three days before the ministers at his church surrounded him and screamed at the demons they believed were inside him.

"I basically cowered on the floor for a couple of hours wanting something to happen, and nothing happened," says Up-church. "When it was all over, I felt very awkward and very weird. I felt like a complete idiot to ask for something like this. I mean this was like self-torture

Upchurch says from that point on, he no longer viewed homosexuality as demonic-but it still was wrong, and needed to be changed.
