# Substance in Urine of **Pregnant Women** May be Crucial in **AIDS Fight**

New York, NY-Something in a preg-nant woman's urine can wipe out tumors of Kaposi's sarcoma, an AIDS-related cancer, and suppress HIV itself. But what

After a false start, scientists, including Dr. Robert Gallo of the University of Maryland's Institute of Human Virology, say they're on the trail to finding out.

It all began with a chance observation a few years ago in a study of Kaposi's, a

potentially lethal disorder that causes disfiguring skin lesions in people with AIDS.
Researchers were creating Kaposi's in mice for study, and they noticed they couldn't get the disease to develop in pregnant females.

Apparently, something related to pregnancy was quashing the disease. A hormone called human chorionic gonadotropin, or hCG, is produced early in human pregnancies, so it seemed like a good candidate. Researchers reported in 1995 that doses of commercial hCG preparations killed Karosi's cells in the laboratory. tions killed Kaposi's cells in the laboratory and shrank Kaposi's tumors in mice.

The following year, scientists reported that injecting commercial hCG preparations into tumors could often make them disappear in human patients. In addition, in studies where patients got the prepara-tions injected in their blood streams, they sometimes showed a decline in the amount of HIV in their blood.


But almost from the time of the first mouse study, researchers became suspicious about whether hCG itself was really doing all this. Commercial preparations are derived from pregnant women's urine and contain many contaminants, so one or more of these impurities might really be responsible.

Some recent studies have pointed to a contaminant, though nobody has actually identified it. The latest chapter of the story appears in the April issue of the journal Nature Medicine.

Scientists present evidence that an unidentified substance they call HAF is responsible, and that hCG is just a red herring. HAF can be found in hCG preparations and in urine from pregnant women, they reported.

Milwaukee-Whoever said that you can only depend on two things in life, death and taxes forgot to include La Cage's re-modeling projects. Over fifteen years, the bar has had several makeovers. But all of them pale when compared to the 18 month effort to restore and remodel the La Cage building located at 801 South Sec-

The latest version of La Cage is sched-uled to come fully on line by early Summer. Even before it is completed, the \$750,000 project is winning praise from local politicians, neighborhood activists preservationists and others.

The project includes an exterior restoration of the building to the appearance it had when it was constructed in 1887, the addition of a new dance club and per-formance space on the building's second floor and a major remodeling of the main floor and basement dance and bar areas. According to Co-owner George Prentice the work should be finished by late June

but then he adds the inevitable words "give or take a few weeks. It's hard to be on schedule with all the work that is being done here.

When the work is finished the neighborhood will have a fully restored [1] year old building that preservationists call "exciting architecture," the community will have a new, badly needed space for live performances and Milwaukee's Gay and Lesbian bar scene will have two new spaces including a new upscale down-stairs bar designed by nationally known

The Exterior Restoration

# Nelson Cites New Poll on Needle Exchange to Reggie White Issues Apologia as Furor Over His Assembly Speech Continues

# "Bigger Slaves Were Pretty Much Used as Studs," White Says

Milwaukee-Reggie White says he's sorry if he offended anyone in condemning homosexuality and using racial stereotypes in a speech, but a spokesman for a Gay rights group Friday remained upset with the football star.

'Mr. White chose not to temper his anti-Gay remarks in the same fashion he chose to temper what were perceived to be racist remarks," said David Smith of the Human Rights Campaign.

It is very sad that Mr. White is justifying his anti-Gay bias under the guise of religious beliefs," Smith said.

But Rabbi Abraham Cooper, associate dean of the Simon Wiesenthal Center in Los Angeles, said White's "apology was

appropriate."
Whatever he wanted to say, the way it came out had a tendency to reinforce some of the very stereotypes he has worked so hard to tear down," Cooper said. "He is a big enough man to admit

the mistake and I think he learned an important lesson.

White received the center's "tolerance award" in 1996 for his "commitment to fostering tolerance and pursuing his vision for a better America."

The defensive end of the Green Bay Packers faxed a statement to the Milwaukee Journal Sentinel late Thursday, saying he did not intend to slight anyone during a March 25 speech before the state Assem-

bly.

I must stress that I in no way intended for my comments to personally hurt anyone, and for that, I apologize," White said. But I do not apologize for standing on God's word when it comes to sin in my life and others. My attitude is to hate the sin and love the sinner.'

White used racial stereotypes in ex-plaining the "gifts" of different races and ethnic groups, saying blacks were gifted worshippers, whites were good at tapping into money and American Indians weren't enslaved because they knew the territory and "how to sneak up on people.

# To Stop the Spread of HIV

Wisconsin Light firmly disagrees with those, such as the Atlanta Centers for Disease Control (CDC), who are advocating the mandatory reporting to the government of the names of those testing positive for HIV. Mandatory reporting of names would be counter productive, causing many to avoid testing altogether. Guarantee of confidentiality would simply not be believed.

Doug Nelson, the executive director of the AIDS Resource Center of Wisconsin (ARCW) took this position in his op-ed article in the April 5<sup>th</sup> edition of the Milwaukee Journal Sentinel. We agree with Nelson on his point that more, much more gov-

ernment money should be invested in AIDS prevention.

The problem is, at least in this article, Nelson neither went far enough nor was he

1. Forget mandatory reporting of names. That will neither help in prevention nor in finding a cure. Besides, we believe mandatory reporting to be something of a red herring—either that, or perhaps there's a hidden agenda involved—i.e. find out who is infected, blame them for being infected, stigmatize them even further than society already does and isolate them. Of course, the names would never,

ever, ever be found out, now would they? Government money, city, state and on the federal level, must be invested in needle exchange programs. There are politicians who may not like needle exchange, but the program has this going for it: it works. All the studies indicate that. Since it works, use it. There are people dying out there when those deaths can be prevented. It is unconscionable, we believe, for any political leader worthy of the name, not to support needle exchange. The facts are out there. The political support is there. (Read the article in this issue.) Read all this and sold like and sold this and act! Either that, or become a contributor, a major contributor, to the

spread of the disease and all the needless suffering and death. We must put money into AIDS prevention programs in the schools. Yes, teach abstinence, but recognize that there are those who are not going to be abstinent no matter what any of us do. Since no one knows who these people are, everyone, every kid, should be taught how to protect themselves. Condoms and prevention literature should be distributed at government expense in every school in the land. Every radio and TV station should be required to carry prevention

PSAs, no exceptions, no excuses

No sex before marriage should be encouraged for both Gay people and straights. That means that same-sex marriage must become a fact under the law. This is not a religious issue. It is a legal issue and one of encouraging societal stability. It must be viewed as such. It should be kept in mind that not too long ago the same types of people who are now yammering against same-sex marriage, were hollering against African-Americans marrying each other as well as interracial marriage. They were wrong then and they're wrong now.

HIV/AIDS has been stigmatized by this society. Those who contract it have been

blamed for doing so and they continue to be blamed. This is ridiculous, irrational and absurd. AIDS is a disease, not a moral condition. It is rampant. It is growing. This business about mandatory names reporting will not help, not in the least. All it is, so far as we can see, is a palliative to assuage the sensibilities of the Religious Right and to avoid doing the things (to some, very unpleasant) that must be done if the suffering is to be stopped.

# Being Politically Correct and Reggie White

In all the furor over Reggie White's re-cent speech before the Wisconsin State Assembly, a number of things disturb me

For one thing, in his weekly commen-tary on WTMJ-4's late afternoon news on March 27, Charlie Sykes, conservative TMJ radio talkshow host, opined that White had a valid point to make. How-ever, Sykes said, White was being condemned in some circles and lampooned in others because what he said was "politi-cally incorrect." Charlie mourned the violation of free speech in all this.

No one is a greater champion of free

speech than I am, but in this Charlie is way off base. White isn't being condemned for speaking. He's being condemned because he was wrong in what he

Incidentally, there are those, I heard, who excused White's comments on the basis of the fact that he's a minister. That doesn't work. Nowhere, so far as I know, is it written that the cloth not only covers error, but turns it into truth.

For example, if the Pope says that 2+2 is six, the Pope is wrong. He's in error.

I've also heard it said that White is a good man, a decent man. Pernaps so, but good people can be ignorant. There's no angel protecting them against that and when they are in error, they can commit all sorts of havoc as Reggie White has

In his rambling speech which took over an hour to deliver, White lurched from error to error with all the vim and vigor of a man lost in the haze of his own ignorance. Perhaps, as I think, he was trying to make a valid point, but sadly, he didn't have the knowledge to make it.

For example, in any discourse, avoid generalizations. White violated this rule with wild abandon.

In another example, he said Native Americans weren't enslaved. That's wrong. One has only to study the encomienda system of New Spain or look no farther than our own American South where some Native Americans were held to involuntary servitude.

To say then that Native Americans weren't enslaved—and being called on it—is not a matter political correctness, Charlie. It's a matter of citing someone for making an error in fact such as White did—and a lot of other errors besides.

As another example, White spoke about

can-Americans are not a "race." No matter how common the usage of the term is, there is only one race; the human race. All the ethnicities and cultures are simply variations on a single theme.

It may seem a minor point, but had he been aware of the unity of the human race, he might have been able to make his point. Instead, in part, his ignorance of that unity led him squarely into the stereotyping that was so offensive. It wasn't offensive because it was politically incorrect. It was offensive because he was wrong, dead wrong, as wrong as if he'd said 2+2 is 6.

It was also offensive because he should have known better—or would have known better if he'd taken Anthropology

When it came to discussing Gays, he was so far off base it was pitiful. Had he been in the least bit acquainted with Gay people and the studies that have been made on sexuality, he would have known that sexual orientation is not a choice, not a "decision," as he said.

But even without the studies, a little common sense would have allowed him to realize how inane his comments were. What does he think happens? That a person gets up one morning and says, what the hell, I think I'll be Gay.

A little common sense should tell him (and others) that being Gay is not a choice and it is not an act. One is not Gay only when one is having sex. One is Gay, period. It is a state of being. It is a part of who I am, an integral part of my makeup.

If Reggie White (or anyone else) is going to hate homosexuality, they have to hate me, all of me, because my Gayness is inseparable from me. My sexual orientation is very much a part of who I am.

Not to put too fine a point on it, I am Gay, not because of any physical activity. I am Gay because of who I love, because of who can fulfill me emotionally. White, obviously doesn't know any of this-or chooses to remain ignorant which is a worse "sin" than most. It is my belief that willful ignorance is an obscenity before Almighty God.

Reggie White's ignorance is dangerous because of the fact that he is a role model. Uncounted numbers of young people look up to him. Sadly, very sadly, many of these young people and others as well, will take his comments about Gays as a license to bash Gays. Not only that, but he

the "Black race" and other "races." Afri-has materially contributed to the anguish of Gay kids trying to come to terms with their sexual orientation. Countless numbers of them commit suicide because of

what people like White say.

Stuart Briscoe, senior pastor of the Elmbrook Church of Brookfield is quoted by the AP in saying that White could speak again at his church. Is lack of knowledge tolerated at the Elmbrook Church, I wonder?

But there are other problems that I have with White's speech, some of which have nothing to do with him. One problem, above all, is with the members of the state

legislature.

When White made his comments on Asians, some of the legislators laughed. They seemed to find it funny. Their laughter was easily heard on the tape played on the TV news. When he made his comments on Hispanics, some of them

laughed. They seemed to find it funny. How could anyone laugh, not at White, but at his remarks, how funny they were?

I don't know.

Isn't that what leadership is all about; standing up for your convictions—sometimes in a public way, a way that is costly to yourself?

Let me tell you a story, a true story. There was a man from Kansas, a U.S. Senator, who, having listened to all the testimony, decided that President Andrew Johnson wasn't guilty of high crimes and misdemeanors. He was badgered and he was bullied, but he had integrity. He voted against convicting the President and by his one vote, the impeachment was lost.

The Senator was vilified. He lost his office and retired to obscurity. He paid the price. History, however, records that he was right. History remembers him as a man of courage.

I hope this story, recorded in John F. Kennedy's Profiles in Courage makes

Friendship is a two way street and you're the one with the problem. The problem, Reggie, is that you need education. That being the case, the only way, Reggie, the only way that you and I could have any relationship at all would be if you agreed to become my student and read every book I gave you.

Below are excerpts from Reggie White's speech to the Wisconsin State Assembly on Wednesday, March 25th.

"As America has permitted homosexuality to establish itself as an alternate lifestyle, it is also reeling from the frightening spread of sexually transmitted disease. Sin begets its own consequence, both on individuals and nations."

"Let me explain something when I'm talking about sin, and I'm talking about all sin. One of the biggest ones that has been talked about that has really become a debate in America is homosexuality.'

"Now, I believe that one of the reasons that Jesus was accused of being a homosexual is because he spent time with homosexuals. I've often had people ask me, would you allow a homosexual to be your friend. Yes, I will. And the reason I will is because I know that that person has problems, and if I can minister to those problems, I will.'

"But the Bible strictly speaks against it, and because the Bible speaks against it, we allow rampant sin including homosexuality and lying, and to me lying is just as bad as homosexuality, we've allowed this sin to run rampant in our nation, and because it has run rampant in our nation, our nation is in the condition it is today.

"Sometimes when people talk about this sin they've been accused of being racist. I'm offended that homosexuals will say that homosexuals deserve rights. Any man in America deserves rights, but homosexuals are trying to compare their plight with the plight of black men or black people."

"In the process of history, homosexuals have never been castrated, millions of them never died. Homosexuality is a decision. It's not a race. And when you look at it, people from all different ethnic backgrounds are living this lifestyle, but people from all different ethnic backgrounds are also liars and cheaters and malicious and backstabbers.'

"We're in sin, and because this nation is in sin, God will judge it if we don't get it right. I want to read something about the Roman empire that's interesting to me when I look at our nation and see that we're going in the same direction.'

Fall Out

Campbell spokeswoman Ronni Heyman said White's one-year contract to promote the company's products expires within a

week.
"His comments are not consistent with the principles of Campbell but at this time, until we speak directly with Reggie White, we're not going to go any further in talking about the future," she said.

NFL spokesman Dan Masonson said the

league had no comment.

The Packers declined comment.

Jimmy Sexton, White's agent, has no comment and all inquiries have been forwarded to White, a spokeswoman for Sexton's office, Amy Wilson, said.

Following the speech, White said he stands by his comments. He is not judging people and says only what he believes, he

CBS Sports spokeswoman Leslie Anne Wade would not say whether White had spoiled his prospects for an analyst's job for which he auditioned.

"CBS has a hard-and-fast corporate policy against bias of any kind," she said. Reggie White is not an employee of CBS so I wouldn't comment on Reggie

White specifically.' White specifically.

White told Fox News Channel that he agreed with former CBS football analyst Jimmy "The Greek" Snyder, who was fired in 1988 after he said a black athlete was better than a white one because "he's been bred to be that way because of his thigh size and big size."

Snyder also said slave owners would breed a big black with a big woman so he would have a big black child, leading to superior black athletes today.

I agree with what Jimmy 'the Greek' said when it came to, that slaves, bigger slaves were pretty much used as studs. And the comments that he made about that was true. That did happen," White told Fox.

Church colleagues said White, affiliated with a church in Knoxville, Tenn., is welcome to their pulpits anytime

"I'm not his judge. God might be say-ing, 'Good job, Reggie," said the Rev. Andrea Dudley of Capital Christian Cen-ter in Milwaukee, where White has spoken.

Stuart Briscoe, senior pastor at Elmbrook Church in Brookfield, a Milwaukee suburb, said White could speak there again, having preached there once before.
"I haven't heard him say anything that

would disqualify him from being with us,' Briscoe said.

# U.S. Supreme Court Justices Spar Over HIV As a Federal Disability

Washington, DC—In an update to a story in the last issue, Supreme Court justices who sparred over whether HIVinfected people should be considered disabled because of dangers involved in sex

and childbearing expect to rule by July.

The lawyer for Dr. Randon Bragdon, a dentist from Bangor, Maine, argued that Bragdon did not illegally discriminate against an HIV-infected woman by refus-

ing to treat her at his office.

The patient, Sidney Abbott, suffers no AIDS symptoms and therefore is not pro-

Act, said attorney John McCarthy.

But Abbott's lawyer said lower courts found that Bragdon violated the law, which bars discrimination against the disabled in jobs, housing and public accommodations.

The law, responsible for such aids as wheelchair ramps at countless public places, says people are disabled if they have a physical or mental impairment that substantially limits one or more major

life activities. HIV-infected people should always be considered disabled because the contagious and fatal nature of acquired immune deficiency syndrome severely limits their ability to have sex and bear children, said

Ms. Abbott's attorney, Bennett H. Klein. Some justices disputed whether HIV in-

fection really creates such a limit.

Justices David H. Souter and Antonin
Scalia suggested an HIV-infected person
faces a 'moral choice" rather than an actual physical limit on his ability to have

"I'm not sure that's what the statute is talking about," Souter said.
However, Justice Anthony M. Kennedy

said that if a person with highly infectious tuberculosis stays away from other people, we don't just call it a moral choice.

Someone with bubonic plague would be considered disabled, added Justice Stephen G. Breyer.

Bragdon's lawyer said the disability law aims to protect people whose disabilities affect their `day-to-day independent living and economic self-sufficiency," not HIV-infected people who suffer no

Dr. Bragdon believes that when he provides a service in the face of the risk of death he should be allowed to take additional precautions" such as insisting on filling Ms. Abbott's cavity at a hospital, McCarthy said.

However, Breyer said that 'after 15 years and hundreds of thousands of deaths" from AIDS there appeared to be no documented cases in which a dentist caught the virus from a patient.

"How can we say here that your client exercised reasonable medical judgment?" Breyer asked. McCarthy replied that there were seven possible cases of HIV transmission in dental procedures.







# 'Don't Ask, Don't Tell' Policy Facing Legal Combat From ACLU & Lambda Legal

Washington, DC-The Lambda Legal Defense and Education Fund (Lambda) and the American Civil Liberties Union (ACLU), having won a federal court ruling that the military's unequal treatment of Lesbian and Gay service members is un-constitutional, will fight the government's appeal in New York

"This case is and always has been about just one thing," said Matthew Coles, director of the ACLU's Lesbian and Gay Rights Project. Nickerson found that the special rules that the military imposes on Gay service members serve only to accommodate the anticipated anti-Gay feelings of other service members. 

# Social Workers Condemn Religious-Based "Reparative Therapy" as Dangerous

Salt Lake City- Some religious therapists contend unhappy homosexuals can abandon what they call their "lifestyle" through so-called "reparative" or conversion treatment, but a Utah social-work group says they are wrong.

In a unanimous affirmation of a 2-yearold stance by its parent group, the Utah chapter of the National Association of Social Workers has adopted a policy discouraging reparative therapy.

The group's state board found there is no

scientific data supporting the treatment.

"Social stigmatization of Lesbian, Gay and Bisexual people is widespread and is a primary motivating factor in leading some people to seek sexual orientation changes," the policy states. 'Discomfort about working with this population may lead to inappropriate, ineffective and even damaging interventions by social work-

Board president Joanne Yaffe said the action came after it received an anonymous complaint, redirected from the national committee

They told us they knew of Utah social workers who were practicing reparative

therapy and asked us what we were going to do about it," she said.

The state chapter's action was criticized by such groups as extremist religious groups like Evergreen International and atter Day Saints (Mormon) Services.

"The LDS church's licensed professional counselors take the position that there is substantial evidence that individuals can diminish their unwanted homosexual attraction and make changes in their lives," said Mormon church spokesman Don LeFevre. "The church and these professionals are supportive of a person's right to seek assistance in doing so."

The American Psychological Associa-

tion in August also passed a resolution opposing reparative therapy.

Reparative or conversion therapy attempts to change homosexuals to heterosexuals, and has existed for more than a century. Early practices incorporated electric shocks, castration, lobotomies and aversion therapy. Today, religious therapists instead use the Bible, prayer and cognitive or behavioral therapy techniques to diminish or eliminate same-sex attrac-

Critics who see homosexuality as a state of being rather than an activity, contend the therapies have a 60-70 percent failure rate, but supporters insist there is ample proof that homosexuals can change, or at least stop "acting out" (having sex).

NASW board member Shirley Cox, a Brigham Young University social-work professor and Evergreen International board member, said there is a distinction to be made between reparative therapy and what she calls "lifestyle-change"

"Reparative therapy assumes people are broken and in need of repair. I don't be-lieve that," she said. "But I will help people who want to live as heterosexuals. They have a right to choose" if they want to have sex with a member of the opposite

Evergreen Executive Director David Pruden said NASW made itself "vulnerable when, as an organization, they become the arbiters of lifestyle decisions. What happens if something goes wrong because they have affirmed a certain life-

Pruden said about 40 percent of the people served by his organization stop having sex entirely and about 30 percent lessen their sexual activity.





# Genital Herpes Rates Jump in Young Whites Since the 1970s a Study Shows

New York, NY—If, as the Far Right tion rate jumped from slightly less than 1 Religious extremists have wrongly contended, that AIDS is a "Gay disease," will the rate among whites in their 20s went they now call genital herpes the "straight disease?" The extremists may be forced into this uncomfortable position.

Despite the emphasis on safe sex to prevent AIDS, genital herpes has increased fivefold since the late 1970s among white teen-agers and doubled among whites in

In all, about one in five Americans over age 12 has the sexually transmitted infection, and most of them don't know it, the Centers for Disease and Control Prevention reported.

Dr. Michael St. Louis, who wrote the report with colleagues at the CDC, said it was surprising that herpes went up during the 1980s despite publicity about AIDS. Other sexually transmitted diseases, such

as gonorrhea, declined.

He said other studies have shown that young people increased their rates of un-protected sex, premarital sex and multiple sex partners. And condoms appear to be less effective in blocking herpes than other diseases because the virus can be transmitted from parts of the body not covered by a condom.

Gray Davis, president of the Herpes Advice Center in Durham, North Carolina, said the study shows many people ignored safe-sex warnings about AIDS in the

1980s. "What these numbers are telling us is that the young, sexually active white population didn't consider themselves at risk for HIV," she said. "So the HIV message, while it was very effective in the Gay population, where it was targeted to, didn't reach the rest of the population."

One reason for concern is that herpes sores may make a person more vulnerable to infection with the AIDS virus, the researchers said in the study, published today in the New England Journal of

Medicine.

Experts said it is time to get tougher on herpes. They said new steps could include screening for it in patients at clinics for sexually transmitted diseases and in preg-nant women, whose newborns could die if infected.

"We're screening for HIV, we're screening for hepatitis B, we aren't screening for genital herpes," said Dr. Lawrence Corey of the University of

Genital herpes is caused by the herpes simplex type 2 virus, and much less often by the type 1 virus. The study used blood samples from about 24,000 people to re-

veal the prevalence of type 2 infection. The data were gathered between 1988 and 1994 and compared with a similar study done from 1976 to 1980.

The results suggest that 45 million Americans are infected, including 18 percent of whites and 46 percent of blacks.

Among whites ages 12 to 19, the infec-

The threat, received last Thursday, April 2, by The Dallas Morn-ing News, is being investigated by the

The Rev. Mike Piazza, senior pastor of the congregation, said the church would continue to operate normally. "Our stance is that we need to release this information so our members know [and] can make their choice. We're going to have services, but people have a right to know what they are coming to," he said. Piazza also noted that last year's bomb-

ing of an Atlanta Gay bar and more recent bomb attacks on abortion clinics have forced the church to view all threats with

The threats affected attendance this past Sunday, but all services were held as scheduled.

The Internet threat contained condemnations of homosexuals and claimed, "You think Oklahoma City was bad, wait

until you see this.' The Rev. Troy D. Perry, Moderator of the Universal Fellowship of Metropolitan

Community Churches, the parent denomination of Cathedral of Hope MCC, noted: We strongly condemn these threats to our constitutional rights to worship and free assembly. Over the past 30 years, more than 20 Metropolitan Community Church congregations have been targets of the hate crimes of arson or firebombing, and many more have faced threats to

both worshipers and property.
"I call upon all people of goodwill to uphold the Rev. Mike Piazza and the congregation of Cathedral of Hope Metropolitan Community Church with their love and prayers during this time," Perry added. "I salute the church for keeping its doors open to Gay, Lesbian, Bisexual and Transgendered persons. The Scriptures declare that 'perfect love casts out fear.' Thorough their boldness and love, our members and friends in Dallas are communicating the message that we don't have to be afraid anymore.

# Duke, UNC, Teach Classes on Queer Studies **Despite Alumnae Protests**

Raleigh- Duke University is standing by its "Queer Studies" class in the face of national attention and criticism by some

Duke University \_ and the University of North Carolina at Chapel Hill \_ offer classes that explore sexual identity, sexual ambiguity and Gay history. They have joined a number of top universities, such as the University of Chicago, Stanford and Brown, that see a need to explore how homosexuality helps shape literature, his-

tory and art.
"People do these things," Duke Professor John Younger said, "which is precisely why they must be talked about.

Some Duke alumni were displeased when Younger's class recently was filmed for a '60 Minutes" segment on the grow-

ing academic trend of sexuality studies.
One cut showed Younger, a classics professor, talking with his seminar students about sexual power relationships, and describing sadomasochism and black leather costumes, chaps, whips and chains and

The disgruntled alumni called and wrote letters to President Nan Keohane's office enough that the school prepared a statement. John Burness, vice president of public affairs, said most of the criticism was that Gay and lesbian studies are unworthy of attention. "I understand the subject itself offends some people and that the report tended toward sensationalism, but everyone should know the student of human sexuality at Duke is neither flaky nor immoral," Keohane said in the release.

Keohane defended the classes.

It's an intellectually challenging examination of a very complex subject from a variety of perspectives," Keohane wrote. Duke professors "don't try to indoctrinate

Supporters say "queer studies" is a le-gitimate examination of a group of people who traditionally have been excluded from college curricula much as women and blacks were in the past.

Academics chose the word 'queer" to cover issues related to lesbians, Gays, bisexuals, transgenders and intersexuals partly because the list of individual sexual categories has grown so long, Younger

Younger and Cecil Wooten, a UNC classics professor who teaches "Sex and Gender in Antiquity," say that many professors teaching "queer studies," are like them, homosexual.

Most of the (queer studies) courses on this campus are probably not taught by Gays," Wooten said. "That's why I got interested in homosexuality in the ancient world, but I'm not trying to persuade one way or another.

Duke just this academic year began offering the equivalent of a minor in gender studies. UNC has offered a couple of classes for several years but now has about 15, including ones about homosexuality in movies, the effect of the legal system on Gays and lesbians, and their artistic contributions.

All but two of the UNC classes have been funded by a bequest from Charles Williamson, a 1968 graduate of UNC's School of Medicine. Williamson, a San Francisco physician, died of AIDS in 1992 and specified how his donation would be spent.

Students in Wooten's UNC class read authors such as Plato to learn about human relationships and models of romantic involvement. They learn how women were viewed in Greek society as stupid and inferior to men.

I'm an old-fashioned Latin grammarian," said Wooten, who has taught his class for seven years. "There's a lot of homoerotic material which has not been taught. The subject has been inherent in many disciplines, but for various reasons has not been addressed before. All we're doing is encouraging departments to right the imbalance.

Len Spicer, chairman of Duke's faculty governing group, defends homosexual studies. Peer review and time will determine whether they thrive, he said.

"Universities are full of efforts to dis-cover what's important," Spicer said. Along the way some fall by the wayside.

Time will tell whether this will be sus-

# How Dishonesty Has Become a Virtue

There once was a time when honesty was a virtue, and dishonesty was a considered a vice. Today, it seems that the tables have turned, and dishonesty has become a virtue. How else can the dishonesty which runs rampant in this society be explained?

In the Gay community, we see it everywhere. In the bars, those who are cruising often do not give their real names.

In the classifieds, the rule of thumb is that you can always add at least ten pounds to the weight cited by ad's author, you can assume that someone who describes himself as "attractive" is really "average" or "less than average", and someone who says his hair is "thinning" is actually bald on top.

(A former friend of mine who was bald

(A former friend of mine who was bald as can be actually used to describe his hair as "thinning" in classifieds.)

Now that we are in the high-tech age, the lying and deception has reached a new peak on the Internet. To begin with, Internet users adopt "handles" and e-mail addresses which are designed to prevent anyone from determining their true identities. This way, they can post comments on bulletin boards with impunity, spreading whatever lies they choose.

But what is even more appalling to me is the prevalence of false pictures used on the Internet. A friend of mine recently signed up for Internet service, and his experience has disheartened me considerably. Without failure, when he meets someone in the chat rooms and asks for his picture, he invariably receives a picture of a model-type gorgeous hunk.

Is everyone on the Internet really built like Jean Claude Van Damme and does everyone really have the looks of Brad Pitt?

Of course, he frequently receives the same picture from two, and many times even more, different people, clearly demonstrating the deception with impunity which occurs. Does this bother him? No, he merely picks the picture he likes the best and pretends it is his, sending it to all manner of people who ask for his picture.

Some might argue that this does not matter, since if my friend met with these people he would discover their true appearance. Another friend of mine just says that the Internet is "just a wild and woolly place". But that's just euphemistic: the reality is that it is a hotbed of lies and deception.

The reason it does matter is that it destroys trust. If one cannot believe that a picture which is sent over the Internet is actually the picture of the sender, how can one believe anything else which is said by that Internet user or any other? Do we really want to live in a world where we cannot trust anything anyone else says?

Lies and deceit are even more common in the political world, of course, and the disease starts from the top down. It is little wonder that people today think nothing of lying when it is obvious that our nation's leader consistently lies. But people just shake their head and say they don't care as long as he is doing a good job as President.

When President Nixon was caught in a big lie, the public was aghast, and the scandal caused voters to vote Democrat in droves, ushering in an era of liberalism from which we probably will never fully recover. Yet today, the voters merely state that they expect the President to lie just like every other politician.

Here in Wisconsin, where politics are relatively clean, we see that politicians are increasingly dishonest. What do we think of a State Representative who takes credit for the adoption of a bill which she almost single-handedly doomed to defeat due to her extreme partisanship and ego, takes credit for a county ordinance for which she was not the main sponsor, and engages in a disinformation campaign about a vitally important bill?

We lavish her with praise and campaign contributions, as if she is the savior of our community

What do we think of a candidate for Alderman who tells some people that she supports privatization of some services, but yet receives the endorsement of the city's union (which would never endorse anyone who supported privatization)? We refuse even to consider the possibility that she might be dishonest, dismissing charges against her as attacks by her enemies, attacks which do not matter.

How about a State Representative who tells the Milwaukee part of his district that he opposed the property tax relief proposal because it sent too much school aid to the suburbs and not enough to Milwau-

kee, but tells the suburban part of his district that he opposed it because not enough school aid was shifted to the suburbs? He receives the endorsement of both the teachers' union and the local taxpayers organization, and we re-elect him by a wide margin.

How similar the situation with the President is. Here is a man who is an inveterate prevaricator, and we simply shrug our shoulders and say it does not matter because he is doing a good job.

because he is doing a good job.

It is bad enough that the public believes that the President's private life is none of our business and we should simply ignore his transgressions. What people seem not to understand is that the President is a role model for all of us, but especially for our children.

No one is demanding that any elected official, let alone the President, be perfect. One or two affairs could be accepted, as everyone is human. But this is a man who has repeatedly engaged in adultery, clearly showing that he thinks there is nothing wrong with adultery. What does this teach our children?! If it is acceptable for the President to commit adultery, surely it is acceptable for them, they must think.

But as bad as the public's rejection of the facts and its ambivalence toward their significance is, worse yet is the public's acceptance of the lying and the cover-up. Even the most ardent supporter of the President must now accept that he lied to us in 1992 when he said he had not had an affair with Gennifer Flowers, since he has now admitted to that affair in a deposition.

And now, woman after woman is coming forward and alleging that she either had an affair with the President or that he tried to force himself on her, and yet we are supposed to believe that this is nothing more than a right-wing conspiracy to destroy the President.

How naive have we become?

If there was no truth to Monica Lewinsky's story, why would Vernon Jordan have gone to such lengths, with the President's full knowledge according to him (although the President's account differs), to secure her a job, just as he secured Jim McDougal significant contracts when he refused to testify in the Whitewater investigation? But we are told that it does not matter anyhow.

When President Nixon covered up the relatively minor crime of spying on the Democrats, the country howled bloody murder. But here we have a President who has engaged in an extensive cover-up operation to hide the fact that he has personally enriched himself and his family through his position as Governor of Arkansas and that he is a relentless adulterer, and no one cares.

Following the lead of the President and

other elected officials, the public has concluded that lying is acceptable, that it is even a virtue. This is the message our children our learning

children our learning.

We now live in a nation where we increasingly find it impossible to trust others, because lying has become a way of life for so many. I personally do not look forward to living in a society in which I will always have to look over my shoul-

der, unable to trust anyone, even friends and loved ones.

Yet the bridge to which the President is leading us will bring us to just such a society in the 21st century. As long as our public officials convey the message to our children that dishonesty is a virtue, how can we expect any other result? The public is clearly wrong, whether or not they can see it through their bias: it matters!

# Milwaukee LGBT Community Center Board of Directors Moves Ahead

Milwaukee - On March 24, the Milwaukee Lesbian Gay Bisexual Transgender Community Center completed the two-month process of transitioning from the Interim Board to an elected Board of Directors.

Additionally, the board elected "start up" officers to coordinate activities during the next 60 days. Board Officers include Sheila Zelenski and Neil Albrecht as Co-Presidents, Steve Markowitz as Treasurer and Naomi Guzman as Secretary.

"The election of officers for a sixty day period allows us to fully transition into our roles as board members, assess priori-

ties and issues, and then elect officer's into their full two year terms," said Sheila Zelenski, Co-President.

The Community Center's Board is continuing the process of selecting candidates for the remaining three board positions. This will complete the full compliment of 15 board members.

"We are very pleased with the current strength and expertise of the Board. We are committed to board diversity, and are actively reviewing several candidates of color to serve as directors," said Neil Albrecht, Center Co-President.

Planning for the development of a Milwaukee Community Center began two years ago when Ross Walker and Erv Uecker pledged a \$1,000/month contribution to challenge the Milwaukee LGBT community to develop a center. Numerous people emerged to accept the challenge and completed a comprehensive planning and feasibility study. This study continues to give the board direction regarding programming, site selection and community

needs.
"We are very grateful to the 'pioneers' of this project, particularly former cochairs Jim Schleif, Karen Gotzler, Leonel Marchan, ReDonna Rodgers and the entire Interim Board for building the road to a Community Center," Albrecht said.

# "Cavedweller" Author, Dorothy Allison, Looks at a Writer's Life from 'On Top'

By Debbie Fraker

Five years after her first novel, Dorothy Allison is once again on tour with her second novel, and sixth book, Cavedweller. "It's deliberately as different from Bastard as I can make it," says Allison.

Bastard Out of Carolina, Allison's first novel, brought her into the literary light with a nomination for a National Book Award, critical acclaim and a place on the bestseller lists. Before Bastard, there was Trash, a collection of short stories, and The Women Who Hate Me, a collection of poetry, from Firebrand Books, a small feminist press. Since Bastard, she has written Skin: Talking About Sex, Class and Literature (Firebrand) and Two or Three Things I Know for Sure, a compact powerhouse of a memoir (Dutton

With the publication of Cavedweller, Allison has been lauded as an established author with a new book that holds up to the reputation of her earlier work. But she's taking it all in stride. "I'm a feminist," she explains. "I've got a concept of how notoriety works in this culture. I'm trying

not to take it too seriously."

Dutton/Penguin Books, her publisher, realizes they have a viable product on their hands. They are publicizing this book heavily, and carefully, doling out appearances and interviews to the highest bidders, large volume bookstores and high circulation publications.

But Allison is maintaining perspective here as well. "One reason this book tour is so long and difficult (31 stops in 25 cities in about two months) is because I fight them," she says of her publisher.

While Dutton's publicity department set up appearances at large bookstore chains like Barnes and Noble, Borders and Davis-Kidd, Allison lobbied to add appearances at smaller stores like Charis Books and More in Atlanta. "I'm starting to figure out that I can win on some," she says. "I still find it hard to believe that I find myself in this weird position of making money."

Since she is making money now, she is also giving some back to the community that got her early career off the ground.

Through the Astraea National Lesbian

Action Foundation, she has established a new "Independent Spirit Award."

"We're gonna give money away," she says excitedly. The cash prize of \$5,000 will go to "an individual or group whose work with small presses and independent book stores has helped to sustain that enterprise," according to Astraea's publicity. Allison will give away the first award this May.

As the mother of a five-year-old son, a healthy income is all the more important to Allison. Bazaar magazine recently printed an essay that Allison wrote about her family living arrangement, which includes her partner Alix, son Wolf and Wolf's dad,

Dan.
"They asked me to write something for them, and I said, 'Do you know who I am?" she laughs. "This living together in an extended family is really working out." At the time of this interview, Alix had joined Allison on the New York City leg of the tour while Dan kept Wolf in San Francisco. "It's like getting married," she says, explaining




A number of players have also used the league to help themselves come out of the closet. Anything that helps with that process has to be ultra cool.



# **Boulevard Theater Has a Real Winner in** "Glengarry Glen Ross"

Over the last few years, the Boulevard Ensemble has presented a great variety of plays ranging from Shakespeare to Moliere to modern playwrights such as the recent successful production of Milwaukee native Michael Neville's School Girls in Uniform. Now we have the Boulevard is presenting the stunning, angst-ridden comedy, Glengarry Glen Ross by David Mamet, which opened on April 3<sup>rd</sup> for a month's run.

Glengarry Glen Ross gives us the world of small-time real estate salesmen and the story of their successes and failures, frustration and treachery, a world that fits nicely into the limited playing area of the Boulevard's storefront theater.

Dana Fralick has created a simple, but suitable design for the show. Act One is a Chinese restaurant with two tables, chairs and some Chinese décor. No distractions here as the audience concentrates on the angry confrontations and the scheming and dealing that goes on among the par-

Act Two is set in the outer office of the real estate company. There is a real and very usable door centered at the back of the scene leading into the Manager's office, some chairs and a few pieces of office equipment and that's it. But again, it's what's going on between the characters that counts and even the unseen and unheard beyond the office door (as a policeman supposedly interviews several of the salesmen concerning a robbery at the office the previous night) engages our atten-

Mark Bucher's company has consistently attracted some of the best actors in the Milwaukee area and this production is no exception. All the performers acquitted themselves well. Under the expert guidance of Timothy X. Tray, they spoke their emotionally charged lines realistically and interacted quite believably.

The play had an additional interesting twist in that the director cast three of the leading salesmen roles with women. An interesting choice and, as it turned out, a

Michelle Waide as the older and most seasoned salesperson is terrific as hardbitten and frustrated Shelly. And not to be outdone, Jacque Troy plays her younger and more successful sales competitor with great intensity, intelligence an sexual suggestiveness. And Georgie, the third salesperson of this trio, is realistically played as very troubled, unsure and self-defeating by Janet Riordan

The rest of the cast includes: Rodd Walker, Kevin M. Morrow, Rich Townsend and Michael Chmiel. They all make this comedy both entertaining and disturbing as we watch ethics and morality take a beating, while the oft abused Office Manager (Michael Chmiel) tries to make some sense and order out of this world of moral mayhem.

All in all, this comedy is well worth seeing and will be running four times a week (Thursdays, Fridays, Saturdays and Sundays) until May 3<sup>rd</sup> at Milwaukee's Boulevard Ensemble Theater, 2252 S. Kinnickinnic Avenue. Call (414) 672-6019.

# Skylight Theatre's "A Chekhov Trilogy" is a Wildly Funny Good Time

By J. R. Baker Milwaukee's Skylight Opera Theater is presenting A Chekhov Trilogy, a trio of one-act operas based on turn-of-thecentury Russian short stories by Anton Chekhov. To this reviewer, composer/librettist Richard Wargo brilliantly succeeds in the first and third acts.

The middle one, "A Visit to the Country," was a bit less successful as opera per se because it really is a short, musicalized play where the dialogue seems more dominant than the music.

Nevertheless, Wargo, with the help of a beautiful scenic and lighting design for the country estate, excellent costumes and some fine performances from the actors, succeeded in creating a summer evening in Chekhov's decaying world.

The first act, "The Seduction of a Lady." is based in part on Neil Simon's adaptation of "Boa Constrictor and a Rabbit." It proved to be delightful and entertaining theater indeed. Here were lots of comedy and laughs with the music played with grace by a trio and sung with pleasing tone and wit by the Performers. Irena (the rabbit) performed by Alicia Berneche, was a delight as the young wife about to be betrayed by her passions and the wouldbe seducer (the Boa) played by James L. Brown. Brown was a bit young to be convincing as a worldly roue. Nevertheless, he sang and acted the part well.

However, what really propelled this act to comic heights was the grand piano created by Peter Dean Beck, the set designer. This clever bit of machinery could not only be a piano, but turned vertically, became part of a ball room wall, horizontally, it becomes a pool table, then a bed where Irena and her foolishly duped husband, Nicky (played and sung with pa-tickets, call (414) 291-7800.

nache by Richard Lewis) retire for the evening.

The third act, "The Music Shop," was the best of all. It was a wonderful musical farce that has Ivan (played by Marc Molomot) coming into the shop (loaded with purchases that he has bought for his wife), with the purpose of getting a song that his opera wife must sing at the forthcoming wedding of a Russian prince. But he can't remember the title and the music shop is practically destroyed during the hectic and

zany search for the right song. Both proprietor (Michael Sokol) and his shop girl helper (Wren Harrington) grab song sheets and sing bits and pieces of everything under the sun. So we hear snatches of opera, Russian folk songs, oratorios, songs from music halls and theaters in a wild and wacky profusion while the paranoid Ivan fantasizes the angry appearance of his wife (Jennifer Clark) in a series of wildly funny confrontations if he should fail to find the right song.

When the right song is finally found, we see the roof lift up and the wife, now an angel instead of a terrifying Brunhilde, floating above the shop and playing a harp. And then the final twist of this marvelous farce is that Ivan has only enough money for his train trip home, but promises to return to pay for the sheet music the following Monday. The owner, who has been driven nearly mad by seeing his shop ("the finest music shop in all Russia") reduced to shambles and nearly destroyed, shoves Ivan out, barricades the door and, while the curtain descends and the audience laughs heartily, sinks to the floor bemoaning his fate.

# Gutzman Brings the Humor and Pathos of "The Shadow Box" to the Stage

The witty and moving play takes place in a cancer hospice and follows the stories of three patients and their loved



# Alfred Hitchcock's Films Remain Mysterious, Frightening and Intriguing

By Steve Stavron Part I

Alfred Hitchcock's reputation has proved to be more of an enigma to film historians than any of the tantalizing maneuvers in his most famous suspense films. The extreme popularity of his films within the limitations of the suspense genre has provided a source of frustration to critics who feel a need to rationalize Hithcock's placement at the very forefront of the century's great directors.

The structural simplicity and the transparent clarity of his greatest films seem almost a challenge to ferret out "hidden meanings" Not even Orson Welles or Ingmar Bergman have been subjected to the endless scrutiny afforded Hitchcock's films. It seemed imperative to justify their growing reputation in the face of adverse snobbism, which cannot conciliate his popular appeal with the demands of "art."

Hitchcock's films have been overanalyzed by historians as if they were decoding hieroglyphics. Cinemaddicts rhapsodize over Vertigo, Psycho, Rear Window, Shadwo of a Doubt, North By Northwest, as if they were writing blank

Amusingly, film historians, including a bevy of outstanding French directors [ie.Francois Tuffault who lionized the aging Hitchcock in a published series of taped interviews] even try to rationalize Hitchcock's late inferior works: Marnie, Torn Curtain, as masterpieces of a declining genius, with endless references to even subtler undertexts which they attribute to the director's concealed psyche.

Hitchcock's most detailed biographer, Donald Spoto, in his fascinating study The Dark Side of Genius, becomes an embarrassed apologetic for Hitchcock's 'darker' obsessions, which he examines in great detail, citing in particular food, heavy drinking, beautiful blond actresses, sexual frustration [Hitchcock though married and father of a daughter, was celibate for over 30 years],bathroom humor, cruel practical jokes, and sundry other insecurities stem-

ming from lifelong obesity.

However, Spoto overreaches his otherwise brilliant analysis by assigning aberrant catharsis to some of Hitchcock's famous scenes. The double roles in Vertigo and the mother-son duality in Psycho become symbols of Hitchcock's dual personality as do the good-evil characters in Strangers on a Train. Not so. They were just part of the story. Neither was Hitchcock schizophrenic or symbolically ab-

It's always dangerous to attribute personal characteristics of an artist to his work on a one to one basis. Whatever emotional baggage Hitchcock carried, it was always ameliorated by his eclectic sense of what was cinematically aesthetic, by his discrete use of the camera as an unobtrusive purveyor of mood and by a quietly wicked sense of humor which prevails all his major films. Hitchcock's films were never erratic or pathologically disjointed for extreme effect. His best films were extremely well integrated and deceptively low -keyed to underscore the strength of his "surprise" element.

Nor was Hitchcock one to self-

consciously privatize his idiosyncrasies. In the manner of the introverted neurotic. Although very aware of the outward propriexpected of a good -natured corpulent individual [at times weighing over 350lbs] he had few intimate friends ,but the macabre humor of his personal introductions added sparkle to his TV series later in the 60's. He himself designed the silhouetted profile logo which became his standard trademark.

Whatever Hitchcock's" dark side" may have contributed to his artistic conceptualization, the results on screen were always elegantly -and tastefully- original and accessible. Admittedly fascinated with murder and unsuspected danger. Hitchcock's creation of the famous shower scene in Psycho,, the crop-dusting scene in North by Northwest, the rigor mortised corpse in the sack of potatoes episode in Frenzy, the hero and heroine handcuffed together in Thirty Nine Steps, are so delicately and minutely choreographed-each shot adding minuscule significance to the previous one-that the sequences are almost erotically enjoyable-but with a guilty smile.

Hitchcock could make us laugh at murder or the threat of it by his seemingly casual sleight- of -hand style laced with humor. Every shot in the shower scene in Psycho functionally combines terror with perverse delight

But herein lies part of the Hitchcock



mystique that so tantalizes his analysts who feel it necessary to justify Hitchcock as a serious artist He uses simple narrative camera movements unobtrusively to progress his all-seeing eye into unanticipated territory with the greatest economy. His films are structurally organic. Nothing s unnecessarily sensational. Hitchcock's best films deal with suspense ,not the solution of who-dunnits. His camera work is sophisticated for its apparent effortlessness. He never "intellectualizes" the narrative beyond its content, which is why Hitchcock films are always enjoyable Their profundity lies in guiding the suspense motif into heretofore unsuspected psychological channels, most notably in Vertigo. Many distinguished directors call attention to the complexity of their cinematographic technique, but in Hitchcock there is a curious serenity and calm to the camera movements. The quiet layering of individual frames, deceptively peppered with humor, as in Rear Window deflects our sense of anticipation, but creates a subliminal psychic "unsteadiness" conjuring half - forgotten fears and irrational dreads which seem to have no logical basis in our adult psyche. Part of Hitchcock's universality is his ability to invoke the perpetual insecurity of our childhood fears.

Biographer Spoto places much emphasis on the strength of Hitchcock's Images, but no single image prevails in isolation. Hitchcock works in terms of sequences. His camera angles, seemingly routine, sneak up on you and finally gather momentum as they approach a climactic point. The apparent simplicity of his technique--- and his careful planning well in advance of shooting-transforms his films into strong unified entities which surreptitiously unravel forgotten routes to unpredictable and unfeasible fears long since reasoned away but which are somehow retrieved and disturbingly magnified for us.

In North by Northwest a man is suddenly kidnapped for no reason; a small prop plane becomes deadly; in Psycho the friendly motel keeper gradually becomes ominous; we dread our first shower after seeing the film initially; in Shadow of a Doubt, the adored uncle is a serial killer. False accusations and threats of imprisonment abound in Saboteur, The Wrong Man, Frenzy, I Confess. Even the famous Hitchcock kisses have a taste of the ominous.

The first, in Spellbound, is followed by a softly fused shot of an infinite series of opening doors-very memorable ,but disturbing. The kisses in Vertigo and Notorious are passionate but curiously desperate and joyless, circled by an ominously suspicious camera.

Unlike other directors, his films were planned on paper well in advance with scenarios so detailed that hundreds of camera angles are specified down to the lens setting. Hitchcock's films were so carefully integrated in the pre-planning stage, that Hitchcock himself often became bored with the actual shooting and felt almost superfluous on the set, being known to doze off during filming, especially after a heavy lunch. His sense of detailing included selecting every item of clothing and hair styling especially for the several actresses Ingrid Bergman, Grace Kelly Vera Miles, and Tippi Hedron with whom he became enamored. His films, therefore, are lean with very few padded transitional sequences and always unpredictably witty as in the elevator scene in North by Northwest.

Hitchcock's professional career began with surprising ease in 1920 at the age of 21. British films were regarded as plebeian pastimes for the under classes and were greatly underfinanced compared to the American and German motion picture industry. Young Alfred, with his talent for sketching and a background in art and advertising, had no difficulty getting employment designing title cards and simple scenarios for silent films. With little com petition, his talents soon led him into directing--a role for which he had no particular ambition.

His first big success was The Lodger [1926], but his early r silent and early sound films [Blackmail 1929 and Murder 1930] seems rudimentary and technically crude by today's standards, due largely to budgetary restrictions.

His better sound films- The Man Who Knew Too Much [1934] and Secret Agent [1936]--in which Peter Lorre's erratic but interesting performances were influenced by his cocaine habit-only suggest Hitchcock's later style with its unique idiosyncrasies.

These early movies include Sabotage [1936] in which the wife of the saboteur fully realizes her husband's guilt by watching a cartoon from behind a movie screen in which an arrow kills "Cock-

Much better yet was the famous Thrity Nine Steps [1935] in which Madeleine Carroll and Robert Donat are handcuffed together while pursued by foreign spies over the Scottish moors at night. Off screen, Hitchcock left them bound together for hours, claiming he had lost the key-one of his diabolical little jokes.

But The Lady Vanishes [1938] abounded with Hitchcock humor and clinched his international appeal. The story is air tight. An old lady disappears on a train and very one denies having seen her except a young woman. The tension of the intrigue is offset and compounded by two stuffy Londoners solely preoccupied by Wimpledon scores, plus a hilarious search for foreign spies among a magician's paraphernalia in the baggage car. The film remains very watchable today.

At this juncture in his career, Hitchcock was imported to Hollywood under contract to David O. Selznick.

Rebecca [1940] was Hitchcock's first American film and remains a classic, alock tended to underestimate it, probably because he and Selznick had conflicting views. The producer wanted to remain faithful to du Maurier's excellent novel and [rightly] rejected Hitchcock's first proposed treatment. But the final results on the screen are first rate. The combination of Hitchcock's cinematographic mysteriouso and Selznick's sweeping, but detailed sense of dramatic Romanticism produced a superb melodrama with production values at last worthy of Hitchcock's talents. It won an Academy Award at a time when -unlike today - that honor designated true movie making distinction. TO BE CONTINUED



# D.W. Griffith's Epic 'Intolerance' to Be Screened at Oriental Theater

D. W. Griffith's 1916 epic silent film Intolerance has been recognized as one of the most influential films in the history of cinema and one of Griffith's most powerful

The film portrays the persistence and destructiveness of intolerance throughout human history, a theme that, unfortunately, remains relevant to this day. weaves together four stories: the destruction of Babylon by the Persians in 538 BC, the crucifixion of Christ, the massacre of Huguenots in 16<sup>th</sup> century Paris, and a "modern" story set in the slum of an American mill town.

Although the events in these stories often involve massive sets and large numbers of people, the cost of intolerance in human misery is depicted by personal tragedies of individuals. The budget for the film was the largest to date.

The most famous of the enormous sets, a Babalonian city, was one mile long, three hundred feet tall, populated by thousands of extras.

Intolerance began on a modest scale in 1914 in the form of Griffith's then unreleased film The Mother and the Law, a story about the cruelty of a pious factory owner and the pain he inflicted on his employees. Griffith felt that this film did not make a strong enough statement against prejudice and cruelty, so he created Intolerance by adding the three other stories.

Each of the stories could stand on its own, but Griffith edited them so that they are told simultaneously. He intended them to, as he has said, "run gradually together until, in the end, in the last act, they mingle in one mighty river of expressed emotions." The stories are linked by the recurring image of Lillian Gish rocking a cradle, a reference to Walt Whitman's Leaves of "...endlessly rocks the cradle, Uniter of Here and Hereafter."

The most fundamental theme underlying the film is the struggle between Griffith's liberal, democratic ideals and totalitarianism. The protagonists in the stories are victims who advocate inclusiveness, individualism and pluralism. The antagonists advocate uniformity. They are dogmatic, treacherous, oppressive and violent. These two opposing world views are symbolized in the editing techniques used in

The shifts between stories are nonsequential, metaphoric and modernist, and reflect the protagonist's point of view. Editing within stories is sequential and exclusive, reflecting the antagonist philosophy. Griffith rejects the 19<sup>th</sup> century notions of

similar events through history. than evolving, growing and learning from past evils and mistakes, mankind is doomed to relive them.

Director David Wark Griffith (1875 -1948) has been described as the "Father of the Motion Picture". He originated or refined many film making techniques that have remained fundamental tools of the film maker's art. The great director Sergei Eisenstein, a contemporary of Griffith, named him a "magician of tempo and montage.'

In recognition of his great contributions to cinema, the Academy of Motion Picture Arts and Sciences gave him a special award "for his distinguished creative achievements as director and producer and his invaluable initiative and lasting contributions to the progress of the motion picture arts."

Griffith had great, almost messianic aspirations. He once said to Lillian Gish, one of his favorite stars, "We've found a universal language - a power that can make men brothers and end wars forever." He also spoke of movies acting like the "hands of God" with the ability to lift people out of their "commonplace existence."

To this end, he concluded Intolerance with images of perfect love and eternal

# The Only Reason to See 'Lost in Space' is Over-Active Nostalgia

The premiere of Lost in Space, Hollywood's latest effort to bring 60s television to the big screen 90s brought back many fond memories for Glenn.

The occasion was a rare sleepover of an older cousin of Glenn's. As an athlete and two whole years older, Glenn had long admired this handsome male cousin. On that fateful night so very long ago, Glenn would find himself initiated into two new worlds. In one lived Will, Dr. Smith and the rest of the Space Family Robinson. The other was of a more intimate nature.

But Glenn digresses... Cinematic blockbusters of small screen favorites inevitably invite comparisons. As envisioned by director Stephen Hopkins

and screenwriter Akiva Goldsman, this 90's Lost in Space substitutes the original's trademark campy dialogue and cheesy space aliens with an overload of computer-generated special effects.

Who isn't familiar with the story of the Space Family Robinson? Certainly no self-respecting baby-boomer!

The year is 2058 and Earth is dying. The Robinson Family must blaze a trail for the salvation of the human population! Blah, blah, blah...

While this is not a particularly novel premise for a sci-fi flick, little more is needed to re-introduce the characters many, like Glenn, have been watching and re-watching on television for over two dec-

Whereas post-Camelot America would never have accepted a less-than-perfectfamily in space, here in the 90s, would anyone expect or for that matter accept the Robinsons as anything but exceedingly dysfunctional?

Angela Cartwright's pretty-little Penny is little more than a faint memory in the face of Lacy Chambert's punkette Penny who is positively pissed about going on the Jupiter 2. When she isn't causing havoc at the mall, Penny is keeping a memory list of her favorite things (shades of Mary Poppins) on her video diary which seemed to Glenn to also double as a nifty wrist watch.

Older sister Judy (Heather Graham), too, has received a 90s make-over. A mere bit

o' blonde window decoration in the television original, Graham's Judy is a hip, smart 90s woman who has followed her family's scientific footsteps and manages to offer Matt LeBlanc's hot-as-a-pistol Major West more than he can handle in the romance department.

Less successful are mom and dad.

William Hurt's Professor Robinson is a much more convincing "egg-head" than poor Guy Madison ever was but is shown to be a distant, somewhat neglectful father who sends his children belated apology videos whenever he misses an important family function.

Mimi Rogers cannot possibly compare to the incomparable June Lockhart but then who could compare with such a television icon. Although she, too, is supposed to be a scientist, mom Mimi does little more than offer the occasional piece of motherly ad-

Following a few happy cameos with some of the members of the cast from the original series, Lost in Space comfortably settles forth in predictable fashion: Dr Smith (Gary Oldman) appears on the scene to complete his bit of sabotage and once again the evil Smith gets trapped on board. Before one can say, "Danger Will Robinson", the robot soon goes berserk and in a jiffy, the Jupiter 2 finds itself lost in space.

Sadly, the adventures that follow not only lack imagination but merely serve the marketing needs for the creation of cute little cuddly toys with which to entice families into buying over-priced "happy-meals"

Particularly irksome is the hokey "if only Dad played catch with young Will" ending. We saw this same nonsense in Contact last year and a slew of other films. Boring!

Although fans of the original series are sure to flock to Lost in Space, as did Glenn, other younger audiences are likely to be puzzled by this curious confection of elaborate effects, embarrassingly sophomoric dialogue, abundant violence and silly space-opera melodramatics.

Sammy (Billy Crystal) is a second-rate talent agent more devoted to his vain attempts to climb to the top of the Hollywood heap than to either his wife Serena (Kathleen Quinlan) or his young son Nick (Zane Carney). His work takes him to Romania where, during on location filming of a Braveheart-type action picture, his client unceremoniously dumps him.

By accident (literally), Sammy discovers giant of a man named Max (Gheorghe Muresan), a Shakespeare-quoting caretaker living in seclusion in a monastery. Although Max seems quite content to live out his life in his humble surroundings, Sammy discovers he has one wish - to see his long, lost teenage love Lillianna (Joanna Pacula) once more. She moved to New Mexico 22 years ago.

Max's desire leads Sammy to believe he may have found his ticket - a very tall ticket - out of mediocrity. Sammy convinces Max to travel with him back to the United States where he'll not only make him a big (no pun intended) movie star, but reunite him with Lillianna.

Together they travel from the forests of Romania to the suburbs of Chicago, the hustle of Times Square to the flashy glitz of Las Vegas. During the course of their journey, both men experience significant, unexpected transformations of the heart.

Fairy tales are like that sometimes, and if viewed as a fairy tale, My Glant succeeds most admirably.

# 'The Players Club' is Loaded with Racial Stereotypes and Can be Passed By

In the 1970s, "Blaxploitation" made its debut with such "gems" as the Shaft films, Blackula, and the pre-Jackie Brown Pam Grier. This controversial genre has received somewhat of a revival in the 1990s, owing in no small part to the Hip-Hop and Gangsta Rap music cultures. The latest entry into this unusual field is pretty much the entire effort of rap singer Ice Cube who directs, writes, stars in and produces The Players Club.

The action takes place in and around an all-black strip joint in Bryland, Georgia, where one is just as likely to find trouble as arousal (of the het variety, of course).

Breaking somewhat with current trends, this film surprisingly isn't set in the Blax-ploitation Era - the '70s, but in the here and now. The story unfolds through the eyes of a young stripper named Diamond (Lisa Raye), and involves behind-thescenes interplay between club owner Dollar Bill (Bernie Mac), the comedic side-kick in the form of an underpaid deejay, Blue (Jamie Foxx), a voluptuous villainess (Chrystale Wilson) who wants some of the "action," and a small-time hoodlum (no surprise here - Ice Cube).

Cube thinks he can swindle everyone by playing the players against each other. Not

much originality here, folks, and plenty of embarrassing racial stereotypes sure to make Reggie White feel vindicated.

The Players Club comes to us via independent film company New Line Cinema, which has shown its willingness to tackle ambitious projects, and in this case continues to show New Line's support of African-American audiences.

Rapper-actor Ice Cube had a relatively tight budget to work with (\$4.5 million), but still managed for his filmmaking debut to assemble a fairly impressive cast of familiar colleagues, many of whom appeared with Cube (or is it Mr. Cube?) in previous movies like Friday.

So, can he actually write and direct a movie? Well, that would be easier to answer if he involved himself in something other than the world of "the streets," for there's really little here to distinguish The Players Club from an average rap/hip-hop music video. It has all the elements of a sordid little sizzler - perhaps even a good noir - but unfortunately Cube isn't quite up to the task of bringing us anything new or the least bit edifying. Expect this one to move quickly to home video. This film is currently showing nationwide.

Reunited after 17 years by the necessities of an impending marriage, the older-but-not-necessarily-wiser Felix and Oscar find themselves on the open road with a common destination, but still driven to distraction by their polar-opposite per-

Still, Lemmon and Matthau possess great comedic timing and chemistry, and I was also pleased that their characters are decidedly less prone to profanity than their Grumpy Old Men counterparts.

# A Thoroughly Ludicrous Premise Makes 'Mercury Rising' Very Missable

Glenn's fondness for a "Biggie" popcorn and "Biggie" Diet Pepsi during a movie screening is certainly well-known amongst the faithful readers of the Wisconsin Light. But even Glenn met his match at a screening of Mercury Rising, the latest Bruce Willis action flick.

In the front row of the cinema was a gentleman even better prepared with reeshments than Glenn could ever hope to be. Lurking beneath his overcoat was a large-size Combos, a bag of bite-size Hersey bars, a surprisingly small bag of potato chips all which were all to be washed down with a one-liter bottle of Coke. This guy could have set up his own snack bar!

Yet even this amazing display could not seriously distract Glenn from the absolute ridiculous plotting of Mercury Rising.

The film opens as Art Jeffries (Bruce Willis), an undercover FBI agent is caught up in the middle of a robbery of a small South Dakota bank. Things goes terribly, terribly wrong. Guns a' blazing, macho FBI guys storm the bank. Fortunately Art survives the shower of bullets (the good guys always seem to, don't they?) but in the process two youthful accomplices are gunned down right before his very eyes.

Riddled with guilt and haunted this by nightmare, Art quite understandably goes right off the deep end.

After his flagrant misconduct, Art finds himself re-assigned. While working with a raw recruit on a routine wire-tap when, Art gets his reprieve. A kid is missing. The police believe the boy's parents are dead following a murder/suicide.

Those of us in the audience know differently. Nine year-old Simon (Miko Hughes) is an autistic savant with an obsession for puzzles. As a bribe to get Simon to interact with his class, his caring and sharing teacher gave him a new puzzle book.

All Glenn can say is "Big mistake!" As soon as he gets home Simon delves into the puzzle book. The camera zooms in for a close-up of a page of meaningless letters, numbers and symbols.

Is that eerie music Glenn hears?

# 'The Newton Boys' Is Proof that a Film Cannot Survive on Sex Alone

It is impossible to ignore the obvious appeal of bringing to the big screen the true story of the Newton Brothers, the most successful bank robbers that this great nation has ever seen.

Hollywood has a long and distinguished history of romanticizing hoodlums, gun-men and other assorted bad guys. And they've done so with great success, ever since those glorious gangster flicks Warner Brothers used to pump out with extraordinary frequency in the 1930s. As played by the likes of Bogart, Cagney and Robinson, these celluloid villains were the folk heroes for a generation of moviego-

Still, times have changed. Unlike the violent toughs of that earlier era, the Newtons were gentlemen, who never hurt no one, no how. How delightfully 90s.

Whatever wonderful Americana Newton's saga might well be, there is one minor hitch, at least in cinematic terms. The saga of the Newton Boys has no spectacular climatic moment. The Newtons' final caper, an uncharacteristic train robbery just outside Chicago was successful but bungled. The Boys were caught, deals were made, short prison terms served and all lived to a ripe old age. All Glenn can say, "Boring."

Yet despite their spectacular success, the Newton Boys are hardly household names. Why? Maybe the Boys were just too efficient or gentlemanly. Richard Linklater, best known for Before Sunrise (also with Eathan Hawke) and Dazed and Confused seems to want to make Butch Cassidy and the Sundance Kid but doesn't have the material, the cast or the talent!

As if to make up for what the story might lack in narrative fireworks, director Richard Linklater chose to inject into The Newton Boys a generous dose of hot, virile male sex appeal: Matthew McConaughey, Skeet Ulrich and Ethan Hawke.

As Glenn watched The Newton Boys, Glenn couldn't help but ponder whether there an actor today that can hold a candle

(pun fully intended) to the pure, naked animalistic charisma of Matthew McCo-Wasn't it he who got Jodie naughey? Foster so worked up in Contact that she immediately transformed herself from a plain Jane to looking for all the world like a high-priced hooker?

Not that Mr. Matthew is necessarily a particularly fine actor. He may well be but who cares? Glenn doesn't. Matthew McConaughey simply oozes sexual heat!

Boy, the movie theater was awfully warm that night!

syrupy-smooth talkin' Willis As the Newton, Glenn images that Mr. Matthew could simply charm the money from any bank teller, male or female, without ever having to resort to guns or nitroglycerin. Mr. Matthew could easily talk Glenn into giving him anything (absolutely anything!!).

Yet, as he left the cinema, the brisk March night air worked a minor miracle in helping to bring Glenn back to his senses: Glenn decided never to be so foolish as to let this raw hunk o' man try to sell him a used car.

Ironically, the movie's best moments come during the final credits. As the names of the cast and crew scrolled across the screen, snippets of interviews with two of the aged Newton Boys are offered. These Newton Boys must have been some characters!

These Newton Boys were the real thing, a true slice of original Americana. It is just too bad that The Newton Boys doesn't similarly succeed.

# Gay Discharges Up Sharply According to Pentagon Leaks of "Don't Ask, Don't Tell"

service members are up sharply, according to early accounts of a Department of Defense internal review of the Clinton administration's "don't ask, don't tell" policy barring openly Gay people from serving in the U.S. armed services. In response to Pentagon or chestrated leaks of sponse to Pentagon-orchestrated leaks of key aspects of the report, the Human Rights Campaign said today that the report's recommendations for fixing problems underscore why the policy is not

"Any policy that asks people to lie is bound to fail," said Winnie Stachelberg, HRC's political director. "The policy itself is not being followed down the chain of command and the core problem of anti-

Gay bias goes completely unaddressed."
Leaked accounts of the some of the contents of the report show that there was an increase of 67 percent in the number of Gay-related discharges since "don't ask, don't tell" was implemented in 1994.

Department of Defense spokespeople claimed the increase was due to servicemembers' using the policy in their first

year of service to get out early.
"The policy is not working because commanders in the field are continuing to ask and pursue, hunting down Gay service members unabated," said Stachelberg.

"The military's explanations for the dramatic increase in discharges are selfserving and disingenuous. Anti-Gay bias continues to be the core issue, and the Pentagon has done nothing to address it."

HRC pointed to a ruling by U.S. District Judge Stanley Sporkin in January, who

families she writes about. Cavedweller, however, is finally about a family with hope. The novel's main character, Delia Byrd, left her first two daughters to escape an abusive husband when the girls were very small. Just like the dream of many young girls in the rural South, she ran off to join a rock band. But the people of her tiny hometown, a fictional Cayro, Georgia, will never forget that she deserted her children when she left. Coming back to Cayro also means uprooting her third daughter, 10-year-old Cissy, from the only home she has ever known, in California.

Allison knows she has created a complex character in Delia Byrd. "She's a mother who returns and attempts to save what she's lost," says Allison. "She does something really hard. She seeks forgiveness and redemption. I was raised Southern Baptist, so I use these words." She adds, though, that she may not always use them the way most Southern Baptists do.

Forgiveness does not come easily in this small Southern town. But Delia stubbornly persists in proving herself to the people she grew up with, and some of them gradually accept her back into the fold, day by painful day. "My understanding of how things really happen is daily, deliberately, kinda like my sex life," Allison laughs. "I've never done anything in my life that was simple.

One of the things Delia does to get her daughters back is to move in with their father, who is dying of cancer. She promises to care for him until he dies in exchange for getting the girls away from their Biblethumping grandmother.

Her care for this man, who's dying a wasting death, is reminiscent of the ways one cares for a person dying of AIDS. "It's how I got my information," says Allison, turning solemn. "In my life, I've taken care of people who've died of AIDS and people who died of cancer." Allison deliberately made one of Delia's best friends afraid of the cancer, refusing to help care for him because she was afraid to be in the same room with the disease. "I needed to have somebody that you liked be that afraid," Allison explained. In this book, nothing is simply good or evil.

Delia's daughters, Amanda, Dede and Cissy, are among the last holdouts to forgive her, each feeling betrayed and abandoned in her own way and each as stubborn as their mother.

"I tried to make sure that each of the girls has their own world, their own place," says Allison. "It's what you do to survive." The place where Cissy is most comfortable is in the caves near Cayro, where she can get away from the nosy eyes and questions of her schoolmates and their parents, and relax. Exploring the caves is also how she meets the Lesbian couple who opens up a new world of possibilities for Cissy.

To go someplace where no one can see you, where you're totally in control of yourself, is just the most freeing experience," says Allison of Cissy's desire to return to the caves again and again. "It's one of the great sexual metaphors," she adds. "I love

Washington, DC-Discharges of Gay found that the Navy went on a "search and out mission" by pursuing Senior Chief Petty Officer Timothy McVeigh. The Navy pursued McVeigh after learning the word "Gay" was in his personal America Online profile.

The internal review was ordered by Defense Secretary William Cohen in response to three annual reports from Servicemembers Legal Defense Network, an advocacy group that works to assist Gay and Lesbian servicemembers and monitors the "don't ask, don't tell" policy.

The reports for the past three years have shown dramatic increases in discharges and reveal that witch hunts and unauthorized inquisitions continue to take place at U.S. military installations throughout the world.

The "don't ask, don't tell" policy was adopted by the Clinton administration and Congress in 1993 as a so-called compromise measure that would allow Gay people to serve as long as they did not admit to being Gay.

'Lying cannot be the cornerstone of any U.S. policy. We need a policy that respects performance, ability, commitment

and privacy," Stachelberg said.
The Human Rights Campaign is the largest national Lesbian and Gay political organization, with members throughout the country. It effectively lobbies Congress, provides campaign support, and educates the public to ensure that Lesbian and Gay Americans can be open, honest, and safe at home, at work, and in the community.

a good sexual metaphor."

Cavro is a fictional town near Marietta, though Allison realizes there is a real, and similarly pronounced, Cairo in south Georgia. There is no deliberate comparison here. "I had researched it and didn't find Cairo," says Allison. "It took me five years to write the book, and they came back," she adds, noting the south Georgia town's recent reincorporation. "I love watching Yankees say Cayro," she adds mischie-

There is an ironic metaphor in the book for Allison's own experiences with celebrity and publicity. At one point, Delia is trying to explain to her friends what it's like to be a rock star and be broke:

"Crazy how rich you can behave when you an't got a dime in your pocket. You learn to charge things to the company or borrow against your name.' Old clothes had to be sent out to be cleaned by hotel staff, new clothes bought on credit. 'Underwear was the hardest.' Delia pushed her hair back. 'I could get a fancy dress for a show charged to some fancy store on Wilshire, but I couldn't get panties, bras, or socks. If it couldn't be charged to some re-cord company account, it couldn't be had."

"I'm talking about when I went on tour for Bastard, for Christ's sake," says Allison, though she admits that the music industry is more brutal than publishing. "It's a strange life, and it'll eat your heart if you let

There's more to the irony of celebrity that Delia's life has in common with Allison's. "Delia loves music, but she hates the music industry," says Allison. "I don't hate publishing, but I'm deeply suspicious of it." She is still a little wary of the fact that, in the publishing industry, she has gone from being an outsider to having a modicum of control over her career. "You have to change your way of thinking, to realize you have power," she explains. "Some of this stuff is about class," she adds. Having gone from "trash" to middle class, she's not one to be fooled by the temporary lure of celebrity.



all the expense and trouble of restoring the building to its original exterior ap-pearance, Prentice says, "It is one of the few remaining examples of tin over wood and mortar architecture in the nation. It looked like hell. I wanted it to be a source of pride to our community. I have wanted to do this since buying the building 15 years ago. Now I finally had the opportunity and I took it.

Local preservationists agree that the La Cage site is an important Milwaukee landmark.

Carlen Hatala of the City of Milwaukee Historic Preservation Commission is one of those who exude enthusiasm when discussing the La Cage site. Commenting on the architectural significance of the La Cage site, she calls it "an outstanding example" of tin over wood and mortar ample" of tin over wood and mortar building. "Putting tin trim over wood and mortar was fairly common at the time this building was constructed, but this site is

manufacture, Henry Fischedick. Bahr died in 1888, but his sons kept the grocery business going until 1917. After that the building was used for a variety of purposes, including storage, retailing and since the 1940's, a bar. Prentice and his partner Corey Grubb, opened La Cage at the site in 1983.

On Mondays and Tuesdays only the Dance Dance Space will be open to customers of La Cage. On Wednesdays and Sundays, only the Main Bar space will be open and on Thursdays, Fridays and Saturdays both spaces will be open and operate as a single bar.

A new light show has been designed for the Dance, Dance Dance space. The area will also include several raised seating areas with tables and chairs. Prentice says that he expects the tables and chairs to be among the most popular seats in any bar in Milwaukee.

# A Catholic Diocese Reaches Out to GLBT Catholics Alienated from the Church

San Bernardino, CA-The San Bernardino Catholic Diocese is aggressively courting Gay people in a dramatic turnaround from years of condemning Gay love as the surest route to eternal damnation.

"We are telling them they are totally welcome," said the Rev. Howard Lincoln, spokesman for the diocese and a priest at St. Catherine of Siena Church in Rialto.

"All forms of prejudice are a fundamental act of disobedience against the Lord who creates us. ... It is profane to assume God values the souls of homosexuals less than

heterosexuals.

The diocese, which includes Riverside and San Bernardino counties, set up a special committee in February to examine the needs of Gay people and now wants to establish a permanent office of Gay and Lesbian affairs.

"We think there are Gay people sitting in our pews suffering in silence who don't feel part of the congregation," said Joan Gonzales, chairwoman of the diocese's newly formed Ad Hoc Committee on Ministry to Gays and Lesbians.

"We want to open the doors to everyone. We want support groups for Gays and Lesbians. But we are going to go slowly," she said.

A committee member, the Rev. Patrick Kirsch of Our Lady of the Snows in Phelan, said: "If we don't reach out, we are

alienating a whole population."

The change came in September when the National Conference of Catholic Bishops released a lengthy statement saying people don't generally choose their sexu-

ality but are given it by God.
"By itself, therefore, a homosexual orientation cannot be considered sinful, for morality presumes a freedom to choose," the statement said. The bishops called for compassion and love for homosexuals along with an end to stereotyping.

There was skepticism. Many priests tell homosexuals seeking counseling 'you don't belong here," said Charles Cox, executive director of Wash-ington-based Dignity USA, the nation's largest organization for Gay, Lesbian and Transgender Catholics.

For the past eight years, the Rev. Peter

Liuzzi has directed the Ministry with Gays and Lesbians for the Los Angeles Arch-diocese. He frequently counsels parents of homosexuals who ask, "Will my child go

I ask, does he feed the hungry, does he clothe the naked, does he grow in justice and compassion each day?" said Liuzzi, noting most of his work involves education about church teaching and directing homosexuals to parishes that are accepting

We have hundreds of Gays and Lesbians attending church every Sunday, but most Gay people who are Catholic are alienated," Liuzzi said. "We try to tell them that they can come back."

There is, however, a catch. Lincoln noted that biblical passages dealing with homosexuality talk strictly

God does have non-negotiable moral codes, and one of them is no sex outside of marriage," Lincoln said. Since the Catholic Church doesn't recognize same sex marriage, celibacy is demanded for

Gays.

Just because we have a sexual proclivity does not mean we are without self-control. Priests are uniquely situated to understand that," Lincoln said.

But homosexuals have trouble with that. 'I don't think we were all created to be priests. Their message is I am a sinner if I practice being a whole person," said Tony Aidukas, 32, of Palm Springs.
