For those of you who don't know about Brewers' Hill, it, along with Walker's Point, is the oldest neighborhood in the city—perhaps the oldest. Neighborhood legend has it that a fur trader had his cabin rammed into the side of the hill, facing the Milwaukee river.

True or not, Brewers' Hill is still a fas-

cinating place.

Back in the 1970's, the once magnifi-cent neighborhood had become a pale shadow of the high toned place it once was. The houses were falling apart. This one, where Jerry and I live, was doomed

to see the city's wrecking ball.

However, people, like Jerry, with a deep and abiding interest in renovating Victorian homes, began moving in here and fixing things up. Today, over 100 homes have undergone—or are undergoing—restoration and rehabilitation. (It's an eternal process, believe me.)
Walk the quiet, tree-shaded streets and

you'll see the rich variety of architecture. There's Italianate, Greek Revival, Queen Anne and Federal Style designs, among

San Francisco—The Gay and Lesbian Medical Association (GLMA) recently met with representatives of Pfizer Inc., which launched Viagra. At this meeting, GLMA and Pfizer discussed concerns about the impact of Viagra on the health of some Gay and Bisexual men.

Viagra and Protease Inhibitors Specific interaction studies with Viagra and protease inhibitors have not yet been done. Thus, HIV-positive men who are taking protease inhibitors and who are considering using Viagra should carefully review what is known about Viagra with their physician. It is not known how Viagra will interact with protease inhibit Viagra will interact with protease inhibi-tors, thus caution should be taken and pa-tients should be monitored carefully. It is believed that protease inhibitors could enhance some of the side-effects of Viagra, such as headaches and flushing.

Viagra is metabolized by the cytochrome p450 enzyme in the liver. Medications which inhibits the p450

cations which inhibit the p450 enzyme system (specifically the 3A4 isoform) may affect the metabolism of Viagra. These include medications commonly used by HIV infected persons, such as protease inhibitors and some antibiotics, such as the newer macrolides e.g. clarithromycin and azithromycin.

When Viagra and protease inhibitors and/or antibiotics are taken together, they and/or antibiotics are taken together, they could cause an elevation in Viagra plasma concentrations. Medical providers should therefore consider starting these patients at the lowest possible does of Viagra (25mg).

Viagra's approved package insert states, 'higher plasma levels may increase both the efficacy, and incidence of adverse

the efficacy and incidence of adverse

Viagra is a major advance in the man-agement of erectile dysfunction, but people with HIV and their providers should remember that there are many reasons for erectile dysfunction, ranging from low levels of testosterone to depression, and that a full medical work up is indicated prior to initiating therapy with this agent.

Viagra and Poppers

Consistent with the way Viagra produces its beneficial effects, it may potentiate the hypotensive effects of nitrates in any form (particularly inhaled forms such as amyl nitrate—poppers—and is therefore contraindicated.

Poppers act by dilating blood vessels and the concurrent use of poppers and Viagra could result in sudden and marked lowering of blood pressure, which can be potentially serious or even fatal.

Marshfield Man Survives Gay-Bashing With **Both Anger and Hope** Marshfield, WI-On Friday night, May

1998, one of the leaders of the Marshfield Gay and Lesbian Organization was victimized by a Gay-basher who struck him on the head five times. The suspected assailant is currently in police custody in the Wood County jail in Wisconsin Rapids.

The victim was Victor Pilsner, 30, who had been attending a neighbor's party, not knowing he was being set up for a Gaybash. According to those who witnessed the scene, there were five men dressed in camouflage suits with black paint on their faces. Half the group stayed at the party and, later, invited Victor to a bar.

Victor asked them if it was safe to go. They assured him that it was safe. Victor went to the bar, ordered a soda and smoked a cigarette. While he was doing this, he was hit from behind five times. Victor went to the bartender, got a phone and called 911. Six squad cars answered the call. The suspect ran through the back door and went to Cheers where he was arrested.

Victor has recovered well and will continue the struggle for Gay rights.

"Gay-bashing is a hate crime," Victor will end. said. "It is illegal here in Wisconsin. No matter where you live in the State of Wisconsin, the law exists.

"The police were very helpful and supportive. They understand the hate crime laws. They got as much evidence as they could to lock this man up. This basher deserves to be brought to justice and be put

in prison.
"I will not stop my fight against hatred.
This incident gave me the push to fight more. I am still not afraid, instead I am

Attorney Christopher Krimmer Named to Head ARCW's Expanded Legal Program

Milwaukee— The AIDS Resource Center of Wisconsin (ARCW) has announced the statewide expansion of its Legal Assistance Program that provides free legal services to people with HIV and AIDS. Effective immediately, the program will expand from a Milwaukeebased service to one that is available to all people living with HIV and AIDS throughout Wisconsin.

The Legal Assistance Program provides HIV-related legal services on issues such as discrimination, access to benefits, and estate planning.

The expansion will be led by Attorney Christopher Krimmer of Milwaukee who has been named by ARCW as the director of the Legal Assistance Program. Krimmer, a Cum Laude graduate of the University of Wisconsin Law School, brings to ARCW a powerful background in areas of family, creditor/debtor and estate plan-

ning law and civil rights advocacy.
"With over half of the people living with HIV and AIDS residing in greater Wisconsin, the need for legal assistance is

increasing in every region of the state," said ARCW Executive Director Doug Nelson. "Our commitment is to assure that everyone with HIV and AIDS in Wisconsin has access to legal services.

Nelson praised the selection of Krimmer to lead the statewide Legal Assistance Program.

"Christopher is an outstanding public interest lawyer with a deep commitment to the fight against AIDS," said Nelson. "His legal expertise, leadership and advocacy skills are a tremendous asset to ARCW and guarantee that Wisconsin's AIDS community will be well served.'

Krimmer expressed great enthusiasm for his new responsibilities. "I believe that directing the Legal Assistance Program will be a great opportunity to address the legal issues a person with HIV and AIDS may have, regardless of where that person resides in Wisconsin. I hope to make the Legal Assistance Program at ARCW a model to be followed by other AIDS

Navy to Promote "Don't Ask" Sailor

Washington, DC-Just months after losing a court decision for breaking the government's "Don't Ask, Don't Tell, Don't Pursue" policy in pushing officer Timothy R. McVeigh out of military service, the Navy has selected him to be promoted to its highest enlisted rank. In January, U.S. District Court Judge Stanley Sporkin ruled the Navy broke its own rules in investigating McVeigh, especially in seeking out his America Online (AOL) screen name identity. The judge further stated the Navy had violated the Electronic Communications Privacy Act by seeking the AOL information without a court order. McVeigh, an 18-year Navy veteran, was part of only 15 percent of those eligible for promotion to Master Chief Petty Officer. "I see this as a very positive development, and McVeigh has a stellar record," said Servicemembers Legal Defense Network (SLDN) Staff Attorney Dixon Osborne. "I'm pleased that the Navy has seen fit to promote him." fit to promote him.

Boy Scouts Ignore Own Policies

New York, NY-Despite exclusionary policies which ban Gay youth and atheists from becoming Boy Scouts, ostensibly because it goes against policy, the Boy Scouts of America (BSA) have flagrantly ignored another policy in order to honor an owner of numerous gambling casinos.

At a recent fundraiser, the Boulder Dam Area Council of the BSA awarded Las Vegas mogul E. Parry Thomas the "Good Scout Award," even though the Cub Scout Leader Book explicitly opposes gambling, and the BSA Finance Division adds that "General guidelines for money-earning projects include...no gambling." The event was held at the Treasure Island Gambling Casino.

In addition, the BSA faced a protest of concerned parents and defenders of diversity at the May 9 Orange County (California) Scout-O-Rama. On May 6, the Berkeley (California) City Council voted 8-1 to deny free marina space to the Sea Scouts, an affiliate of the BSA, because local ordinances make it illegal to discriminate on the basis of sexual orientation or religion.

Pennsylvania Moves for Civil Rights for All

Pittsburgh-On the heels of a successful May 7 Philadelphia City Council vote for domestic partnership benefits for Lesbian and Gay city workers and tax-breaks for rec-ognized same-sex couples throughout the city, fair-minded Pennsylvanians are seeking ognized same-sex couples throughout the city, fair-minded Pennsylvanians are seeking support for the Pennsylvania Civil Rights Initiative. The Initiative is focused on the introduction and adoption of twin civil rights bills to amend the Pennsylvania Human Relations Act and the Pennsylvania Fair Educational Opportunities Act to include "sexual orientation" as a category in which people would be protected from discrimination. Currently, the Initiative is supported by nearly 30 diverse state organizations, the National Black Lesbian and Gay Leadership Council, the National Lesbian and Gay Health Association and the Lambda Legal Defense and Education Fund. Organizers hope to have the Initiative introduced into the State Senate by early June.

Voters Dump "Gang of Five"

New York, NY—In a county where for the past year arts and education were held captive by a zealous radical religious group of county commissioners bent on an anti-Gay agenda, voters in Mecklenburg County, North Carolina, primaries disbanded the "Gang of 5." One member of the gang, Commissioner George Higgins (R-Dist. 5), was trounced by challenger Tom Cox. He will face openly Gay Democratic candidate Andrew Reyes in the general November election. Councilmember Hoyle Martin (R-Dist. 2) lost his seat, but is attempting to get on the November ballot as an independent candidate. The other three won, but according to local observers, Tom Bush [R], who leads the field of the at-large position, faces strong competition from both Democrats and Republicans. "Voters are tired of the direction they [the Gang of 5] were headed in," said Jerry Fox, Assistant Campaign Manager for Reyes. "But we're not finished. We need to make sure to elect those who will make real change."

Minneapolis Paper Features Transgender Person
Minneapolis—The May 5 Minneapolis Star-Tribune featured an in-depth profile of

Debra Davis, a local transgender librarian. Davis, who was born David Nielsen, is the head librarian in a Minneapolis high school and recently underwent gender reassignment surgery. The article follows Davis through her first week back at school. "Quietly, over the past six weeks, Davis and officials of the Minneapolis public schools and other advisers have been putting together a plan to help make the transition from Nielsen to Davis in the workplace. It has not been easy. Their hope is that the change will be minimally disruptive to students, faculty and parents," writes reporter Rosalind

"The topic is not an easy one for many people to understand. Davis is not a cross-dresser, which usually is defined as a person who merely enjoys dressing as the opposite sex. Nor does Davis identify as transsexual—people who decide to have their body surgically altered to correspond with the gender they identify with. Davis falls under the broader term 'transgender,' applied to people who live as the opposite gender in appearance and behavior but may or may not have their bodies surgically altered."

She continues to say that "[a]lthough Davis is not the first educator nationally or locally to come out as transgender, it appears that she is the first secondary school education."

On May 7, the station decided to begin airing the program this July at 11:00 PM.

Besides the inconsistent air times, In the Life's late time slots made building an audience of loyal viewers almost impossible. "We are very pleased that KCET has committed to a better time slot," John Catania, In the Life's Director of Communications, told GLAAD. "An airtime of 11:00 PM or earlier is consistent with stations in other

Juneau Empire Jabs Anti-Gay Judgement
Juneau, AK-On May 1, the Juneau [Alaska] Empire featured an op-ed by Janice
Gregg Levy urging state legislators to dump a proposed constitutional amendment
banning same-sex marriage. "I enjoy the privileges and responsibilities of marriage,"
Levy writes. "My husband and I are secure in knowing that we can and will take care
of each other - physically, emotionally, financially and legally." She points out a number of financial protections she and her husband share, including joint insurance and
estate planning as well as legal protections such as power of attorney and next-of-kin estate planning as well as legal protections such as power of attorney and next-of-kin authority in medical emergencies. "These effects of a government-recognized relationship have nothing to do with sex....The state neither requires sex within a marriage, nor prohibits sex outside of it," she says. Black Caucus Seeks AIDS State of Emergency

Washington, DC-AP- The Congressional Black Caucus wants Health and Human Services (HHS) Secretary Donna Shalala to declare a "state of emergency" in the black community over HIV and AIDS, which is the leading killer of blacks 25-44 years old. "This is a national crisis ... and we cannot rest until it is considered as one," Rep. Maxine Waters, D-Calif., said. She chairs the 39-member caucus.

An HHS spokeswoman said the department was reviewing its options.

Waters announced the decision to call for the HHS designation after a meeting at the Capitol involving caucus members, AIDS activists and medical professionals.

The government allocated about \$3 billion for AIDS this year; President Clinton has

proposed increasing that to \$3.8 billion in the fiscal year that begins Oct. 1.

Benny Primm, executive director of the Addiction Research and Treatment Corp. in New York, said blacks, who are 13 percent of the population, account for 36 percent of all AIDS cases.

Anglicans May Approve Same-Sex Unions

Vancouver, BC—AP-This province's Anglicans have given a cautious thumbs-up to the blessing in church of same-sex couples.

But final benediction for the move will have to await the approval of New Westmin-ster Bishop Michael Ingham, who said he won't make a decision until he has talked

with fellow bishops.

After a vigorous debate, Anglicans representing the diocese's 80 churches voted 179 to 170 in support the blessing at their annual meeting, held at Capilano College.

As passed, the motion would allow individual priests to opt out of giving the bless-

Ingham's final decision on the motion will follow a summer conference in Canterbury, England, attended by Anglican bishops from around the world.

"The issue of homosexuality will be a major issue at that worldwide conference and I intend to go and listen to the discussions before I make up my mind," said Ingham, who can veto the B.C. vote.

Ingham said the blessing is not a wedding, but rather an acknowledgement of a commitment made by two people of the same sex to each other.

The United Church of Canada has blessed same-sex couples for the past 10 years, and also supports the ordination of homosexuals.

Some European churches also recognize homosexual unions, as do some Episcopal churches in the United States.

Myrtle Beach, SC-Ever since organizers announced that South Carolina's Pride98 would be held in Myrtle Beach and subsequent controversy erupted, the Myrtle Beach Sun News has provided accurate, in-depth reports of all points of view. The week leading up to and the week of Pride98 saw a flurry of interviews, columns and features about Pride98, and about the local Lesbian, Gay, Bisexual and Transgender community

Also, during each day of the festival, the Sun News ran a schedule of that day's and week's events. In its weekend section, it featured a dance party with RuPaul along with the city's other weekend events, avoiding the temptation to partition the Pride98 events

into an exclusively Gay section, or worse, not even mention them at all.

Milwaukee-Milwaukee was host to the National Association of Gay and Lesbian Community Centers conference for the Western-Midwest Region April 24-26,

More than 31 board members, staff and volunteers from nine community centers shared stories, participated in seminars and taught each other how to build successful community centers.

Representatives from Horizons Community Services - Chicago, Illinois, Les-bian and Gay Community Services Center - New York, New York, Gay and Lesbian Community Center of the Ozarks -Springfield, Missouri, Out Front Minne-sota - Minneapolis, Minnesota, Gay Lesbian Resource Center - Des Moines, Iowa, Lesbian Gay Community Center of Greater Kansas City - Missouri, Central Minnesota Lesbian Center- St. Cloud, Minnesota, Aurora Lesbian Center - Duluth, Minnesota and Milwaukee LGBT Community Center participated.

HIV Prevention Workshop Presented "Anything Butt..."

Milwaukee-"Anything Butt..." an innovative Gay men's health workshop, was among the many examples of HIV prevention programs brought to Wisconsin during a recent statewide training.

The Gay & Lesbian Outreach Program of ARCW's Milwaukee office recently hosted a day-long workshop on HIV prevention and Gay men's health. Twenty five AIDS prevention educators from across Wisconsin attended the workshop, led by Chris Bartlett, Project Coordinator for the Safeguards Project at the AIDS Information Network in Philadelphia.

Bartlett presented his research about incorporating Gay men's health issues into an HIV prevention program in Philadelphia. He shared examples of health programs that educate and empower Gay men including a Hepatitis vaccination campaign and a service directory of Gay-friendly health care pro-

One highlight of the training was a presentation about Bartlett's unique workshop series about healthy anal sex called "Anything Butt." 





I don't believe that changing jobs would have made an improved difference for me or any other known or suspected Gay person in

Before my departure, I had some discussion about my allegations and experience with higher-up officials in the Texas GOP office including the finance officer, Jill Johnson. She got her position after state party Chairman, Tom Pauken, resigned to run for Attorney General and was replaced by long-time vice-chair, Susan Weddington while I was working there. Susan is not related to Sara Weddington who successfully argued the "Roe v. Wade" case before the Supreme Court.

Over the years, Pauken has aligned himself and the Texas GOP with the radical right. He has become a constant rabid critic of Governor George W. Bush (a moderate Republican who has progressively distanced himself from the radical right since his election). Pauken's endless feud with Bush has ended any chance of him being elected Attorney General or to any other statewide position in Texas. I am quite sure that the popular incumbent, Dan Morales (a Democrat) will easily win re-election in November.

In Space, No One Can Hear You Scream Or Why We Should Care About "Babegate"

Borrowing popular outer space metaphor: I believe Commander Billy has been launching his rocket into the wrong black holes. Frankly, I couldn't care less. But I have to.

Since I was old enough to vote, I watched with dismay as twelve years of oppressive federal administration systematically beat the spirit out of this country. I saw the effects of policies of two radically conservative, out-of-touch old men: a failing economy, a demoralized citizenry, and the subtle but insidious approval of institutionalized hatred against all that wasn't white, middle class, straight and Bible-believing.

Then, in 1992, I watched with glee as an unlikely character from the South accurately gauged this zeitgeist and somehow managed to become its voice.

His campaign was riddled with allega tions of a tendency to dabble in conjugal relations outside his marriage. Several times, it appeared the newcomer was down for the count, but he pressed on, earning the sobriquet "Comeback Kid."

In the end, he parlayed his ability to perceive and address the real needs of our nation into an unexpected upset of the prevailing regime. I was thrilled.

I didn't care if he liked women other than his wife. She didn't seem too con-cerned, either. After awhile, I developed my own theories about that relationship.

Anyway, he was speaking to issues that concerned me. And he was the first president to ever publicly utter the "L" word—and I don't mean "liberal." Things were definitely looking up.

But the demons never really went away. They just seemed to lie coccooned for a time while the country allowed him to actually lead, get us back on our collective feet, make us feel better about ourselves.

He did, by reminding us to take responsibility for our behavior, embrace our differences, learn to get along. It was a real and palpable morality—not the kind you just give lip service to-and it affected everyone.

Now, well into his second term in of-

......

fice, the demons have leapt, Alien-like, from the shadows. What roused them? It's really not hard to figure out.

In November, Congressional races will be decided, and GOP members are desperate to hang on to their majority. In a period of prosperity and general content-ment such as we haven't experienced in 30 years, the Republican party-that of mean-spirited divisiveness and exclusion—is hard-pressed to give anyone a reason to vote for them. The sting of their trickle-down hatred and fuzzy economic thinking is still felt.

In the absence of any substantial legis-lation to offer, they need political lasers to shoot. Conveniently disregarding the dalliances of their own highly visible members (anyone recall Newt Gingrich leaving his wife on her deathbed for a younger woman?), they cloud the screen with these moral" allegations.

They dredge up case after case of alleged "sexual harassment" by the President, hoping this controversy will be some ammunition, however feeble, against an administration that has clearly served the majority of the people well for nearly six

So, what does all this have to do with

the LesBiGay community?

Plenty. Generally, an incumbent party will remain in office when people are, on the whole, satisfied. Under such circumstances, the populace becomes complacent; voter turnout drops significantly. Low voter participation always bodes well for the Republican party; in fact, they count on it for much of their success.

While more liberal and progressive forces rest on their laurels—a dangerous game-the GOP can rely on its core constituency, Right-Wing fundamentalists, to be its stalwarts at the polls.

While this wealthy and politically active group is being whipped into a righteous frenzy, a president who has-however imperfectly-addressed our needs, now requires our support.

Lulled into false security, many of us won't go to the polls. Into my mind springs the image of Robot from the

1960s TV drama "Lost In Space," madly flailing his dryer-vent arms and warning loudly, "Danger, Will Robinson! Dan-

Even without the threat of impeachment of our most politically effective ally, we should realize this is a time when, with fewer votes being cast overall, each one we create or sway in service to our issues has unusual political potency. Now is the time for us to mobilize around strengthening our hand on the issues of equal civil rights for people of alternative sexual orientation. Who knows what the outcome will be of this latest Washington circus?

Conveniently forgetting that most of our most effective presidents have been avid skirt-chasers, pundits have equated Clinton's sexcapades of (what was meant to be) a private and personal nature with the very public and political transgres-sions of Nixon during Watergate. This questionable comparison only

points up the desperation of conservatives to inflate a non-issue to crisis proportions. Unfortunately, the sick hunger of the media for something to take up the slack of

sensationalism left in the wake of O.J. Simpson, JonBenet Ramsey and Princess Diana is playing right into their hands, and may actually sway opinion enough to remove the president from office.

Regardless, in recent years we truly have boldly gone where no man has gone before." In November, whether we're voting for Al Gore as sitting president, Al Gore the pretender to the presidency, or some other voice that has the possibility to carry on our struggles, we need to make sure progress continues by making our voices heard. Without continued vigilance, we may find all the gains we've experienced being threatened by a collision with the dreaded Republican asteroid.

service organizations across the nation," said Krimmer.

One way he hopes to achieve this goal is for ARCW lawyers to zealously represent people with HIV or AIDS, connect them with other ARCW resources and alleviate some of the practical and personal ramifications of a person's legal case.

"The legal process is often quite confusing and frustrating if people with HIV and AIDS are in poor health or are working hard to maintain their health. The last thing they need is the burden of fighting through this legal maze," Krimmer said. "I believe that the essence of being a lawyer is to be a strong advocate for the cli-ent, and I look forward to representing and assisting clients with HIV and AIDS in their legal endeavors.

Krimmer has been a Cooperating Attorney with the American Civil Liberties Union of Wisconsin where he assisted in representing Gay and Lesbian clients, and worked with Legal Action of Wisconsin.

Krimmer has volunteered with The United of Madison and in the Legal Department of AIDS Network in Madison. He has lectured on the dynamics of same sex domestic violence to organizations such as Dane County Advocates.



GOP Will Lose the House if it Endorses

New York, NY-One-time Nebraska front-runner Rep. Jon Christensen's lastminute attacks in the Republican gubernatorial primary backfired as Lincoln, Nebraska Mayor Mike Johanns easily won the nomination Tuesday, May 5.

Christensen, wept as he gave his con-cession speech, then looked down at a row of photographers in front of him. guys up front here taking my picture -beg...that you don't use one of me crying," he said. "This may be the last time I'm in the paper."

With 64 percent of precincts reporting, Johanns had 41 percent of the vote. State Auditor John Breslow was second with 29 percent, while Christensen trailed with 28

Christensen had been a front-runner in the race after a late entry. In the final days of the campaign, Christensen announced he would never hire a Gay or Lesbian per-

son to work in his state government. In Wisconsin, Congress Mark Neumann told a Right Wing group the same thing. Neumann is currently running for the U.S.

Christensen's anti-Gay stance won the endorsement of religious extremist leader James Dobson of the Colorado-based Focus on the Family.

Christensen also bragged to reporters that his fiancée, a former Miss America, was a virgin and unleashed a barrage of negative attacks against Johanns, who positioned himself as the centrist in the race.

Christensen, a 35-year-old fundamentalist Christian, stood by the attacks, saying they would "be a rallying cry for social conservatives." cial conservatives."

Johanns welcomed the backlash. "Thank you, Jon Christensen, for energizing my team with your shabby campaign tactics." he said. "They are motivated and going to be out there in droves."

Log Cabin Republicans had joined others in condemning Christensen's tactics. "It's the kind of extreme and hateful Gavashing that makes a substantial number f swing voters disgusted with the Re-ublican Party at a national level," said tichard Tafel, Log Cabin's executive diector.

"Jon Christensen not only endorsed disrimination, he promised to practice blaant discrimination against people in his own office by dismissing a person's merit and focusing on their sexual orientation.' Tafel said. "It's ridiculous to believe that there will not be a single Gay person working anywhere in the entire state govemment, so what he is proposing is off the deep end."

In recent weeks, Dobson has issued public threats against the GOP that unless it adopts his far right social agenda, he will lead a revolt against the party among his followers. Dobson and anti-Gay ac-

tivist Gary Bauer have funded a number of far right candidates in GOP primaries this year with the aim of defeating moderate Republican front-runners.

Dobson demanded a high-level meeting with GOP Congressional leaders last week, at which he reportedly repeated his threats of a revolt again.

It's clear that Jon Christensen is a foot soldier in the Dobson and Bauer army," Tafel said. "And if the Republican Party marches with him, it will march off a cliff we will lose the House in 1998.

AT&T and Unions Reach Accord on **Domestic Partners**

Washington, DC-The Human Rights Campaign (HRC) praised AT&T and two of its unions for reaching agreement on a contract that includes domestic partner benefits for the company's Gay and Lesbian employees.

"Every time a Fortune 100 company institutes these benefits, it demonstrates that domestic partner benefits make good business sense," said HRC Education Di-rector Kim Mills, who oversees workplace issues for the organization. "AT&T and the unions agreed to these benefits in one of the most congenial negotiating sessions ever-further evidence that these benefits are a cost-effective means of attracting and keeping good employees."

This is historic, said Linda Escalante, Co-President of Lesbian, Bisexual, Gay and Transgendered United Employees at AT&T (LEAGUE). "LEAGUE congratulates AT&T, the Communications Workers of America (CWA), and the Interna-tional Brotherhood of Electrical Workers (IBEW) on treating AT&T employees with equity and fairness in the bargaining

Founded in 1987, LEAGUE at AT&T is the oldest LGBT employee organization and serves as a model for many other em-

AT&T, CWA and IBEW announced today that they have reached a tentative agreement on a four-year contract. The settlement came nearly three weeks before the expiration of the current contract.

Once this contract is ratified, AT&T will join the growing ranks of major U.S. corporations that have realized domestic partner benefits amount to equal pay for

equal work," Mills said.

The Human Rights Campaign has documented more than 500 U.S. employers that offer such benefits to their Gay and Lesbian employees. Among them are such household names as Disney, Kodak, IBM, Hewlett Packard and Reebok.



New Study Finds HIV Patients Not Taking Medications or Take "Drug Holidays"

tients admit to not taking their medications as prescribed.

HIV-treating physicians also estimated that 54% of their patients do not properly adhere to medication requirements, there-fore dramatically reducing the effectiveness of potent new drug "cocktails" and potentially resulting in multi-drug resistant strains of HIV.

The study, "Adherence to Antiretroviral Regimens in HIV Infected Patients: Results of a Survey Among Patients and Physicians" was published this month in the Journal of the International Association of Physicians in AIDS Care and was sponsored by The Dupont Merck Pharmaceutical Company.

The study demonstrates that while new drug cocktails for the treatment of HIV offer hope to physicians and patients, sometimes these regimens may fail. Treatment failure may result from pre-existing drug-resistant strains of HIV or from resistance that develops during antiretroviral therapy

On average, six percent of anti-HIV prescriptions are never filled by patients

"Resistance to HIV medications can quickly occur because of inadequate drug combinations or inadequate adherence to therapy," said Joel E. Gallant, M.D., M.P.H., associate professor of medicine, The Johns Hopkins University School of

"Even mild degrees of non-compliance can lead to resistance," Gallant said. "Once resistant strains of HIV are present, the patient's treatment options are nar-rowed and sometimes entirely exhausted."

According to the study, nearly all patients (93%) understood that taking anti-HIV drugs properly would prolong their lives. Despite this high level of awareness, one-fourth of patients (26%) disclosed personal non-adherence in the prior day and almost half (43%) admitted to nonadherence in the prior week. Furthermore, slightly more than half (54%) professed to know others who were non-adherent because of complicated dosing regimens.

In the HIV-treating physicians segment of the study, doctors estimated that more

Wilmington, DE—A new national survey examining patients' compliance to HIV medications found that 43% of pamonth. Physicians estimated that on average, six percent of anti-HIV prescriptions are never filled by patients.

The study also identified an alarming trend among HIV patients who—because of new drug cocktails—are living longer. Non-compliance appeared to become worse in patients with prolonged use of anti-HIV drugs.

Drug holidays—periods during which a patient stopped taking the drug regimen completely—increased from an average duration of 6.2 days for patients on therapy for two to 12 months, to an average duration of 14.4 days for those on therapy for more than 25 months. Nearly onefourth (23%) of all patients reported having taken an drug holiday.

According to the study, many HIV-treating physicians may solely rely on limited indicators to identify patients who are non-compliant. Physicians typically realized patients had been non-compliant when they observed an increase in a pa-tient's viral load (62%), when a patient informed them of non-compliant behavior (42%) or when they asked their patients about non-compliance (12%). Other indi-cators included decreases in CD4 cell counts (15%) and increases in symptoms

Increases in viral load or decreases in CD4 cell counts may not necessarily be the result of patient non-compliance. Preexisting viral resistance or ineffective drug regimens may also be the cause. However, many physicians continue to rely upon viral load and CD4 count measurements as indictors of non-adherence. As a consequence, the majority of the physicians (84%) reported limiting certain drugs due to concerns about patient com-

When asked for suggestions on how to improve adherence, 74% of physicians identified simplification of the dosing regimen as the most important interven-tion and 24% of patients identified this as a potential solution. These simplifications included using medications without food restrictions, using one-daily dosing regimens or having medications with simpler regimens and fewer doses per day.

you live in the Chicago area or are visiting us, here is some important reading.

In preparation for summer and warmer weather, Horizon's Anti-Violence Project, a victim assistance and advocacy program serving the LGBT or HIV/AIDS impacted victims of violence and discrimination since 1988, wants to share information regarding prevention of violence and protection in the even violence occurs.

For Prevention, We Suggest the Following:

Hang out in groups of people instead of being alone. There's strength in numbers. Realize that no neighborhood is safe. Violence can occur all over the city and suburbs. Stay in well-lighted, higher traffic areas if possible.

Always stay aware of your surroundings and people in your surroundings. Stay sober and mentally alert if you plan to be out in public. Trust your instincts to avoid someone by crossing the street, walking away, going indoors, etc. Stay focused while on the street. Consider how headphones, drugs, alcohol,

emotional stress and discussion can distract you from keeping safe. Asking for a match or change or asking the time of day is a common means of distraction used by street criminals just before committing a crime. Carry a noise-making device to sound an alarm if there is an attack. Have your

keys available (in your hand) for quick entry into your car, home or apartment. If you choose to carry mace or pepper spray, realize it can be taken from and used against you. If you carry chemical protection, be mentally prepared to use it and be informed on its proper use.

Use caution when meeting people via the internet, e-mail or classified ads. Meet in a public space and realize that at any point you can say no to further activity. Be aware of the risks taken when you socialize (go home) with a stranger.

If you go home with a stranger, introduce that person to your friends beforehand. Let them know the time frame you plan to spend with that person and ask them to worry about you (and perhaps, call the police) in the event you are

missing too long.
Watch out for "roofies" or other drugs that can affect your mental awareness being added to your drink. Get your own drink, hold on to it at all times (even in the restroom) and stop drinking immediately if you notice odd side effects. You can also make sure to order closed-container drinks, such as beer, soda or bottled water and open yourself.


If Violence Occurs

Prioritize your personal safety first. Get away from whoever is hurting you. It's okay to run in order to protect yourself. If attacked, protect your head, eyes and midsection from too much damage. If you are hurt or suffer several blows to the head, get medical attention.

Write yourself a narrative of the incident with as much detail as possible to keep details accurate. Call the police if you want to press charges. Call the AVP Hot-line—773-871-CARE—for documentation, referrals, information and support.

Don't blame yourself for someone else's violent behavior.

Be aware of options available if you are victimized by hate crime, domestic violence, discrimination or police misconduct/abuse. Horizon's Anti-Violence Project operates a 24 hour crisis line which provides counseling, referrals and information and advocacy.

HIV Prevention Workshop Presented "Anything Butt..."

Milwaukee-"Anything Butt..." an in-novative Gay men's health workshop, was among the many examples of HIV prevention programs brought to Wisconsin during a recent statewide training.

The Gay & Lesbian Outreach Program of ARCW's Milwaukee office recently hosted a day-long workshop on HIV prevention and Gay men's health. Twenty five AIDS prevention educators from across Wisconsin attended the workshop, had by Chris Partlett. Project Coordinator. led by Chris Bartlett, Project Coordinator for the Safeguards Project at the AIDS Information Network in Philadelphia.

Bartlett presented his research about incorporating Gay men's health issues into an HIV prevention program in Philadelphia. He shared examples of health programs that educate and empower Gay men including a Hepatitis vaccination campaign and a service directory of Gay-friendly health care pro-

One highlight of the training was a

presentation about Bartlett's unique workshop series about healthy anal sex called "Anything Butt." "It was such a unique concept to have a group of Gay men get together to talk about anal sex men get together to talk about anal sex and what it meant to them. It makes a lot of sense to incorporate this kind of dialogue into an HIV prevention program," said Andy Bagnall, Manager of the Gay & Lesbian Outreach Program.

Bagnall coordinated the workshop, which was made possible through Centers for Disease Control supplemental funding

funding.

"In the late 1990's, HIV prevention programs are challenged with the task of reintegrating HIV and AIDS back into the larger health care needs of Gay and bisexual men without losing the important messages of safer sex and HIV. Chris helped us to begin to think how this might work in Wisconsin and gave us some great examples of programs that could meet the needs of men in our community," said Bagnall.

Nike Chairman Calls Reggie White "Crazy" **But Continues to Work with Him**

Corp. to explain why, if it believes Green Bay Packer Reggie White is "crazy," it continues to use him to sell their products.

"Nike's posture with regard to Reggie White makes no sense and is a clear attempt by the company to have it both ways," said Kim I. Mills, HRC's education director.

"Nike claims to disagree with White's virulently anti-Gay statements while it continues to use him to represent the company in public. Gay Americans, and our friends and families, are not fooled by this kind of phony lip service," Mills said.

"Reggie White is, in simplest terms, not evil—he's just crazy." Nike Chairman, Philip Knight

On Tuesday, May 12, Nike Chairman Philip Knight addressed a luncheon at the National Press Club at which he said, in response to a question about White's anti-Gay activity: "Reggie White is in simplest terms not evil - he's just crazy. And essentially we have, in more diplomatic language than that, said that. We don't agree with his statements, but we think that he does have the right to speak his mind. But they really go against what we stand for as a company.

In a speech delivered March 25 to the Wisconsin Assembly, White, an ordained minister, called homosexuality a sin and asserted that it was a chosen "alternative lifestyle." He equated Gay people to "liars, cheaters, [those who are] malicious and back stabbers.

He repeated those assertions several

Washington, DC--The Human Rights weeks later on ABC-TV's "20/20," and Campaign (HRC) has called on the Nike on April 30, he appeared with anti-Gay on April 30, he appeared with anti-Gay activists Alveda Celeste King and singers Angie and Debbie Winans at a rally against a non-discrimination ordinance in Ypsilanti, Mich.

This is not a question of Reggie White's private, personal opinions. He has now joined forces with some of the country's staunchest anti-Gay activists working to overturn non-discrimination laws," Mills said. "Nike's non-discrimination policy and its domestic partner program— both of which cover Lesbian and Gay workers-lose all meaning if this is what

their spokesman does in his free time."
On April 23, HRC assailed the Nike Corp. for welcoming White back to the Green Bay Packers two weeks after his speech to the Wisconsin Assembly, which was filled with racial, ethnic and anti-Gay stereotypes.

'Contrary to what Nike claims, White did not apologize 'to those who may have been offended,'" said Elizabeth Birch, HRC's executive director. "I, for one, heard no apology to the millions of Gay and Lesbian Americans, and our friends and families, who were gravely offended by White's remarks."

Birch sent a letter April 23 to Knight expressing dismay. Thomas E. Clarke, Nike's president and chief operating offi-cer, wrote back, saying the company dis-agreed with White but, "Reggie is entitled to his opinions, regardless of how misguided and insensitive we believe they are. It's on this basis that we plan to continue our relationship with Reggie."

Washington, DC-The weekend of September 17-20, is shaping up to be one of the most exciting ever for advocates of Lesbian and Gay equal rights as the Human Rights Campaign (HRC) presents OutVote '98, its second national political convention, and the Second Annual HRC National Dinner.

OutVote '98 is expected to draw 1,000 Lesbian and Gay activists to Washington for the most cutting-edge political training available. The two-day convention culminates with the Second Annual National Dinner September 19.

Among the dinner speakers will be the world-renowned poet Dr. Maya Angelou. HRC will also present its first National Family Civil Rights Award to rocker Melissa Etheridge, her partner, actress/model Julie Cypher and their daughter.

These two events are extraordinarily important for the Lesbian and Gay political community because of the caliber of trainers and speakers participating in both," said HRC Executive Director Elizabeth Birch. "Putting them together in the same weekend was a logical combination." bination.'

OutVote '98 will offer the most cuttingedge political training for HRC members and allies. More than 20 workshops will be divided into four tracks: candi-date/electoral; grassroots activism; workplace issues; and youth/campus issues.

People who complete three sessions in a track will receive a certificate of completion from HRC

"If people wish to concentrate on a particular area, the certificate recognizes that they've obtained the entire skills set," says Kim Mills, HRC's education director and OutVote program chair. "But there will be plenty of variety for everyone and attendees are free to pick and choose from a giant menu of options.'

The candidate/electoral track will consist of workshops that train people in the fundamentals of working in campaigns, from message creation to fund raising to getting out the vote, and workshops for people who plan to run for office themselves. People concentrating in this track can round out their experience with one or more of the "universal electives" such as public presentations and speech making; how, when and why to talk to the media; framing the issues; and an update on legal issues/legislation.

The workplace track will zero in on the

The activist track will offer workshops on working in coalitions; mobilizing communities of faith; lobbying; state and federal issues; and much more.



GOP Mayor Leads New York City into **Granting Domestic Partner Benefits**

New York, NY- In what is touted as an right to be buried with a partner in the important advance in Gay and Lesbian rights, New York City plans to ensure that unmarried couples are treated the same as married ones on everything from housing to parking permits to burial rights.

The legislation 'moves closer to the ideal of human rights, and treating everything right.' and Married Residual Civilians.

one fairly," said Mayor Rudolph Giuliani, a Republican whose office drafted the

proposal.
"I believe New York is setting the pace for the rest of the country," he said.
For years, the city has been recognized for accommodating policies toward Gay and Lesbian couples. A series of direc-tives, at least one of which dates to 1989, extended to domestic partners the rights once reserved for spouses and family members, such as visitation in city jails and hospitals, and succession for citysupervised housing.

Giuliani's legislation, proposed Monday, May 11, and written in cooperation with advocates for Gay rights, would make those policies permanent by writing them into law. It would apply to heterosexual and same-sex domestic partnerships registered with the City Clerk.

There are about 8,700 registered domestic partners in the city, and at least 55 percent are heterosexual couples, accord-

ing to the mayor's office.

The proposal is likely to receive quick passage in the Democratic City Council, where it has the support of Speaker Peter

Since the settlement of a lawsuit in 1993, the city has provided health and dental benefits to the domestic partners of city workers. Under the proposed legislation would be required. tion, labor negotiations would be required to extend to employees' partners the same benefits provided for employees' spouses, potentially opening the way for those benefits to be expanded.

But the legislation also would venture into new areas, like allowing domestic partners of police and other uniformed employees to be eligible for death benefits if the employee is killed in the line of

A domestic partner would also have the

city-owned Canarsie cemetery, a right now reserved for spouses. Other changes involve rights to parking permits (an in-valuable commodity in New York City) and disclosure statements filed by city

The thing that's really important in this law is it does as much as the city can do to recognize domestic partner relationships. That's not what other cities have done," said Matt Foreman, executive director of Empire State Pride Agenda that worked on the bill.

Similar issues have been debated around the country.

After a five-year fight by Gay activists, Philadelphia's City Council approved a measure to extend health and pension benefits to same-sex partners of city workers. San Francisco has faced court challenges in its attempt to force the roughly 6,000 companies doing business with the city to offer the same benefits to employees' unmarried domestic partners, Gay or straight, as they provide to


At a time when some states have been passing laws barring same-sex marriage, the New York legislation sends a powerful message, advocates said.

"We applaud Mayor Giuliani for taking this important step," said Kim I. Mills of the Human Rights Campaign.

Giuliani fulfilled a campaign pledge in proposing the bill, but the legislation is ikely to hurt him among conservatives. The mayor has been trying to raise his national profile in recent months, and aides have said he could be a candidate for national office.

The mayor 'has done a swell job cleaning up the streets, but the real prob-lem is in the culture," said Robert H. Knight of the Family Research Council, which lobbies on conservative causes. He is marginalizing himself, and will not be taken seriously as a national figure by introducing radical proposals like this.

Students and Faculty Fight Racism and Homophobia on Campus

living room of this gray house that has become a sort of mecca for Gay, Lesbian and Bisexual students at Middlebury Col-

lege.

The rented house sits off campus, separated from the college by a tall picket of the fence fence. On the other side of the fence looms Middlebury's science center; farther up the hill, preppy-looking students stride across greens and sidewalks carrying books, tennis rackets and Frisbees.

Here on this side of the fence, over the gray porch, through the cluttered kitchen, past a huge poster of Bjork, the Bisexual rock singer from Iceland, and into the living room, four Gay students are talking about a recent demonstration spurred by a racist ad in the April Fools' Day issue of the college newspaper.

The students are watching a taped news broadcast of the rally, which was organized to protest not only racism on campus but many "isms," including sexism, heterosexism, classism and campus-wide oppression of all people who are different. The students laughed a little when the broadcast showed Middlebury President John McCardell reading a prepared statement to heckling students.

We aspire to something better than the real world, and you're helping us in that aspiration," McCardell said. "Are we perfect? No. Do we engage in discussion here civilly and respectfully? Yes. And that will continue as long as I'm president."

What the broadcast didn't show was a confrontation spurred by Economics Professor Richard Comwall, a Gay man who has been at Middlebury more than 20 years and is finally quitting in frustration over what he says is a hostile campus climate around Gay issues.

Cornwall challenged McCardell at the rally for failing to respond to a letter he sent four years ago. The letter listed several homophobic incidents and suggestions for improving the atmosphere for

Gays at Middlebury.

The heart of the issue is whether Middlebury can be a productive place for Queer scholars," Cornwall wrote in the March 1994 letter. "We do not have much evidence on this, though the fact that only a small fraction of the faculty are out, and none of the Lesbians, is a severe enough indicator."

Cornwall said in an interview that he confronted McCardell because he wanted to pressure him for not responding to his concerns. "I wanted it on the public record," he said.

Back at the house, students said they were frustrated with the contradiction between McCardell's "one-big-happyfamily" language and his lack of real support for Gays and Lesbians. Students would like to see the college institute several programs, a residential gender studies house, for example, and an office of mi-nority affairs and issue a statement declaring support of Gay members of the community.

They would rather not have to go off campus to find a house in which they can gather and hold meetings. Other students live in special interest houses, they say. They mention a minority student house, foreign language houses, and even an environmental house.

"There's no proactive anything (from McCardell)," said Donald Eggert, a senior. Even when he comments, it's in a way that doesn't address the issue itself."

"We're not asking him to understand what it's like to be Gay," said Carolyn Ashby, a recent graduate who works in town. "That's not the point; the point is he

Queer Alliance

The students here are four of about 30 active members of MOQA _ Middlebury Open Queer Alliance, a group that has become increasingly vocal on campus. Those students are part of a larger Gay community at Middlebury that is harder to

MOQA members presented a list of requests to college trustees that included creating an on-campus, residential house that would serve as a center for students and faculty interested in gender studies and "queer studies," a relatively new theoretic discipline that sprang out of gender and culture studies in the late '80s and early '90s.

The field, pioneered at the University of California, Santa Cruz, and UC-Berkeley, studies gender and social construction of gender, as well as the history, literature and culture of homosexuality.

Several other colleges and universities now have gender or "Queer" studies de-partments, including small Amherst College in Massachusetts. City University of New York, Duke University, and San Francisco State University all have similar

Middlebury College, a school of about 2,300, has a women's studies program, but not a department, which means that stu-

dents cannot major in it.

There has been a recent spate of hostile events on campus that concerns Gay students and faculty. Stanley Bates, professor of philosophy, cites a lack of respect for diversity and a trend toward more destructive behavior. "We have significant and serious problems with the social life on this campus," Bates told trustees at a meeting Friday.

Last fall, for example, when MOQA members constructed a closet on campus to draw attention to the isolation Gays and Bisexuals can feel at Middlebury, the

Why the issues have come to the surface now is a question McCardell struggles with. Many students and faculty say discontent has been simmering under the surface for some time.

"It is interesting that it has come to a head over a racial incident," McCardell said, referring to the recent ad in the school newspaper, The Middlebury Campus. "I think it is a reflection of the changing times we live in, and that a population does not always move at the same speed toward greater enlighten-

The advertisement in the April Fools' issue of The Middlebury Campus carried a photo of three black men under the headline: "Drug dealers, gang members, rapists and arsonists." Below the photo in smaller type was text saying that such in-dividuals were admitted to "increase ex-citement" at "sleepy" Middlebury and counter the image of the typical students,

described as a "pansy."

A retraction in the paper's April 3 issue was deemed insufficient by many members of the community. About 40 students and some faculty walked out of a Campus-sponsored forum held April 6 in response to the incident. The Student Govemment Association, the paper's publisher, held a special session to vote on whether the paper's editor-in-chief, Lela Moore, should step down from her posi-tion. The Student Government Association failed to get a two-thirds vote; Moore retains her position.

The advertisement galvanized campus minority voices of all stripes.

It's important to stress that the rally was not just about race," said Russell Plato, a member of the SGA and MOQA who spoke at the rally.

Suzanne Minott, a black student from Jamaica, said that while race issues trig-gered the rally, "the emphasis right now is on 'queer' issues.

"People were waiting for the appropriate people to respond," Minott said. "If the administration won't say anything, we

Homophobia on Campus Several hundred people gathered on the college green to hear students complain to McCardell about what they believe is the administration's inadequate approach to problems of racism, sexism and homophobia on campus.

McCardell pointed to the reinstatement of the Human Relations Committee to evaluate minority concerns on campus, upcoming diversity training for faculty and staff and the creation of a committee to evaluate campus security.

Members of the Student Coalition for Community gave McCardell a contract asking for a diversity affairs office and a statement saying that racism and sexism were problems on campus.

McCardell said he would read the contract before commenting on whether he would sign it.

Ironically, in the early '90s, Middlebury was one of the nation's first colleges to introduce domestic partner benefits to its employee insurance policy. McCardell supported this policy when he arrived in 1991.

But very few faculty are out about being Gay, and discussion of Gay issues "is done with white gloves on," Comwall said. The environment either keeps Gay students and faculty in the closet or forces them to leave, some faculty say.

In an attempt to change that, Russian Professor Kevin Moss sent an all-faculty e-mail Feb. 26, inviting all faculty to that Sunday's MOQA meeting.

"Where are all the queer female profes-sors?" Moss wrote. "As long as any of us can remember, there has never been a visible Lesbian presence on the faculty. This situation has decidedly taken its toll on the Queer women students, who never see any faculty like them. And it is a situation mirrored neither at other institutions like ours nor in Vermont where more gender parity is the rule. Why is Middle-

bury particularly Lesbian challenged?"

who needed support.

Voters Turned Off By Vitriolic Messages of Reggie White, Alveda Celeste King

Washington, DC—The rejection by Yp-silanti, Michigan voters on May 5 of an attempt to repeal a city ordinance protecting Gays and Lesbians from discrimination shows the new trend by national right wing organizations to focus on the repeal of anti-Gay initiatives has backfired, according to the Human Rights Campaign (HRC), the largest national Gay and Lesbian political organization.

This new strategy was announced by The Christian Coalition in February after Maine's anti-discrimination law was nar-

rowly repealed.

"The recent victory in Maine lulled the right wing into grossly miscalculating where America stands on issues of Gay and Lesbian equality. The results in Ypsilanti reflect the attitude of fairness shared by most Americans. The Christian Coalition will soon realize their strategy has boomeranged," says HRC Political Director Winnie Stachelberg

Local activists in favor of keeping the ordinance formed a coalition that effectively mobilized voters despite a high profile lineup of anti-Gay stars including Reggie White, Alveda Celeste King and the Winans Sisters.

At a rally in support of repealing the anti-discrimination ordinance, Green Bay Packer's star and ordained minister

Most people were repulsed by the circus of stars who traipsed through town with their message of intolerance. They spoke of love, but it was pretty obvious that they only loved people who were exactly like themselves," said Stachelberg.

In the speech delivered last month to the Wisconsin Assembly, White, an ordained minister, called homosexuality a sin and asserted that it was a chosen "alternative lifestyle." He equated Gay people to "liars, cheaters, [those who are] malicious and back stabbers."

The Ypsilanti ordinance was upheld by a 56 to 44 percent vote in this city of 25 thousand people, about 25 miles west of Detroit. The outcome is in line with March, 1998 Human Rights Campaign poll, conducted by the firms American Viewpoint and Lake Sosin Snell Perry & Associates, which showed that 59 percent of Americans oppose repealing state laws that protect Gays and Lesbians from workplace discrimination.

Even in the Maine defeat, which inspired the new right wing strategy, pre-election polls consistently pointed out that more than 60 percent of people were in favor of voting for equality.

"U.S. News & World Report" Ignores James Dobson's Dark Side, GLAAD Says

New York, NY-The Gay and Lesbian Alliance Against Defamation (GLAAD), reports that the cover story of the May 4 U.S. News and World Report (USN&WR) is an uncritical look at radical religious leader James Dobson which completely avoids his connection to hate groups and active, aggressive fight against equal rights for Lesbians and Gay

Solely looking at his call for the G.O.P. to kow-tow to a far-right Christian party line, USN&WR paints Dobson as "not a preacher or political activist. He is a psychologist, and his authority comes from an ability to connect with people right at the level of their problems...The effect is completed by the slight drawl on a country doctor.'

It hails his view as "a traditionalism humanized by common sense and flexibility...He urges discipline for the big issues and tolerance on the smaller stuff." It discusses disagreements Dobson has had with other radical religious groups

opposing equal rights on the basis of sexual orientation.

But it side-steps views of Dobson by organizations. mainstream including those seeking to ensure basic rights for Lesbians and Gay men.

Coming away from the article, a reader could see Dobson, his non-profit group, Focus on the Family (FOF), and his \$100 million media operation as homespun Christians looking out for what they see as the moral and political needs of the

A closer look at Dobson, however, reveals a much darker side totally hidden by USN&WR. During the battle over Colorado's anti-Gay Amendment 2, which was later ruled unconstitutional by the U.S. Supreme Court, the anti-Gay group leading the charge was Colorado for Family Values (CFV).

FOF is one of five national radical

religious groups represented on their board. According to anti-Gay Christian group watcher Jean Hardisty, "it is widely agreed that the 1991 arrival in Colorado Springs of James Dobson and Focus on the Family was an important catalyst for ... CFV."

In 1992, FOF gave an \$8,000 donation to CFV. From 1988-1992, FOF was merged with the virulently anti-Gay Family Research Council. Together they published and distributed a false, Gaybaiting tract entitled The Homosexual Agenda: Changing Your Community and Nation.

In a 1990 FOF newsletter, Dobson claimed "I am familiar with the widespread effort to redefine the family. It is motivated by homosexual activists...who see the traditional family as a barrier to [their] social eminerating."

activists...who see the traditional family as a barrier to [their] social engineering."

In a 1991 article, he equated sexual orientation to bestiality, saying, "There are people in our society who find sexual satisfaction from engaging in intercourse with animals...Would anyone suggest that these groups deserve special protection?"

As Hardisty said, "The skillful manipulation of homophobia by the right

manipulation of homophobia by the right wing creates anti-Gay sentiment and actions that bolster and promote intolerance."

Would this be the "common sense" or the "flexibility" to which U.S. News & World Report refers?



The Boys in the Band takes a look at the lives of a group of Gay men celebrating one of the reveler's birthdays. But these "boys in the band" are not a vocal group. They hide their sexuality, lie to the world and loathe what they are. Liberation is near for "the boys", but it has not yet



Three Leading Lesbian and Gay Writers Discuss Gay Life in America Today

For a few hours on April 30, Philadel-phia's William Way Community Center played host to three of the brightest stars in the firmament of modern American Gay and Lesbian literature. The first of its kind, the National Gay and Lesbian Authors Panel included pioneering feminist, Lesbian rights activist and best-selling author Rita Mae Brown, whose latest offering is her Rita Will: Memoir of a Literary Rabble Rouse (Bantam); Charles Kaiser, longtime journalist and author of The Gay Metropolis: 1940-1996 (Houghton Mifflin); and provocative OUT columnist Michelangelo Signorile, currently on tour to promote his latest book, Life Outside: The Signorile Report on Gay Men — Sex, Drugs, Muscles and Passages of Life (HarperCollins).

In a lively presentation moderated by Philly's City Paper editor David Warner, the three authors responded to questions by Warner and others by members of the standing-room-only audience. What follows is a re-cap of some of the evening's highlights.

Warner: "Is the sexual orientation of public officials relevant, and should the media, particularly the Lesbian/Gay media, concern itself with asking or 'outing' those public officials who are homosexual?"

Signorile: "Yes, just as heterosexual public figures' orientations are sometimes relevant in certain stories."

Kaiser: Agreed, asserting that sexual orientation is of particular concern "especially in cases of hypocrisy," where officials with alternative sexual orientations Please See Writers Page 23



"The Horse Whisperer" is an Intimate **Epic About the Quiet Power to Heal**

Although taking place in the wide open country of Montana, one hesitates to call Robert Redford's new film, The Horse Whisperer, a Western. Westerns are not about healing, they're about killing. This magnificent, intimate epic is all about the quiet power of healing - of a 14 year-old girl named Grace (Scarlett Johansson), of her horse, Pilgrim, eventually of a family.

On the surface, the plot involves a girl who suffers a crushing accident while horse riding and overcomes it, sometimes with the help she's offered, sometimes in opposition to it. Such an intimate subject occupies just short of 3 hours of screen time, a remarkable achievement indeed.

Though a busy career woman, Grace's mother Annie (Kristin Scott Thomas) senses that the cure and comeback of her daughter after the traumatic accident is inextricably linked to the cure and comeback of Pilgrim. Annie leaves her magazine editor's job and drives her spooked daughter and spooked horse from New York to Montana after being turned down by the healer she contacts on the phone, Tom Booker (Robert Redford). If he won't come to the horse, why not bring the horse to him? Annie's obviously used to getting her way, and Booker's rebuff isn't going to stop her now.

Redford's natural reserve has never worked better for him than in his role as Tom, the Horse Whisperer, and he seems a man innately bonded with the spacious terrain of the West. He's about as far from the shoot 'em up cowboy persona as one can get, though undeniably he's a man of

Beginning the slow healing process by time - deservedly so.

first gaining the horse's trust, and then the girl's, he allows them into his space, which includes his brother Frank (Chris Cooper) and sister-in-law (Dianne Wiest). Cooper and Wiest play these characters with the same ease and naturalness that this entire film comprises.

The Horse Whisperer reminds us all that natural healing takes time, and that the natural way is the only really successful way to do the job. As to the building romance between Annie the revitalized Easterner and Tom the Western rancher, it doesn't end the way you think it's going to, although the film leaves the door wide open for whatever future developments you might wish there to be, thanks to Anunderstanding husband, Robert (Sam Neill).

When Annie and Grace arrive out West, the screen literally widens - the somewhat cramped New York scenes broaden to 70mm vistas and horizons - a brilliant de-vice employed by Redford to reinforce the vast physical and cultural differences between the starting and ending points on their journey.

Johansson's cruelly challenged teenager unfalteringly holds the screen with Scott Thomas and Redford, matching the strength and complexity of the adults. As for Redford, his acting has always impeded a proper appreciation of his directing talents, and The Horse Whisperer is his best directing yet, as well as the venue for one of his finest acting performances.

'Bulworth' is a Soulless Film That **Ultimately Wimps Out in the End**

Who amongst us continues to believe, really believe, in the honesty, the integrity and the sincerity of politicians in the 1990s? Certainly not Glenn Bishop!

Glenn can listen to all of the gilt-edged promises made every four years by presidential candidates knowing all too well that the only true allegiance these (invariably) men have is to those who have poured illgotten gains into their campaign coffers. Cynical? Glenn?

Well, apparently so does Warren Beatty. Written, directed and starring Mr. Warren Beatty (such a remarkably talented man), Bulworth finds an aging liberal white senator (Warren Beatty, of course) facing an election campaign but clearly having reached the tattered and frayed edges of his remaining sanity.

Eyes glazed over, just the merest speck of drool seeping from the corner of his chapped lips, Bulworth mindlessly stares at the over-sized television screen that plays a seemingly endless spool of "campaign spots".

Over and over again, Bulworth (as well as those of us in the audience) hears, "We stand at the doorstep of a new millennium.". Over and over and over again this is repeated, Glenn muses, so those truly gullible in the audience will eventually catch on to just what a load of bullshit this slogan truly is.

In any case, it seems that Bulworth has peeped into that doorway and clearly what he saw wasn't very pretty. After trading some political favors for some free life insurance (a mere \$10 million worth), Bulworth sets up his own assassination.

The hit is to happen sometime over the

weekend only he doesn't have a clue when. However he warns, "If I'm not dead by Monday, I'm going to stop the check." Then it is back to the campaign trail for

Only something in Bulworth finally snaps. While speaking to an all-African-American congregation, Bulworth is unregurgitate his platitude-tilled speech. Throwing caution (not to mention political correctness) to the wind, Bulworth



Dramatic Potential is Squandered in the Inconsequential "Chinese Box"

An educated concubine in feudal China (Raise the Red Lantern). A prostitute caught between two childhood friends during the 1940s (Farewell My Concubine). A wife and mother facing tragedy in the aftermath of the Cultural Revolution (To Live). A sultry temptress in the gang-lands of 1930's Shanghai (Shanghai Triad). These are some of the more prominent roles essayed by Chinese actress Gong Li over the past several years.

In a way, she's reprising these roles in a contemporary setting in Chinese Box as Vivian, a Hong Kong nightclub owner and former prostitute. She's a luminous, eyecatching, scene-stealing actress, and although she has trouble forming the English words that form much of her dialogue, her screen presence holds sway. Sadly, Chinese Box is not the best forum for a display of her talent (for that I'd much more strongly recommend any of the aforementioned films).

Instead of adopting a strong, dramatic tone that might have worked better, director Wayne Wang opted for melodrama for this examination of Hong Kong during the final months of its independence from mainland, Communist China. Given the tension and cultural upheaval generated by the events of July 1, 1997, this would seem to be capable of inspiring a great motion picture. Unfortunately, Wang chooses to plunge viewers into soap op-Wang era, a decision which robs Chinese Box of much of its potential for emotional bang.

Jeremy Irons, looking gaunt and unhappy, plays John, a British photojournalist living and working in Hong Kong, and suffering from an unrequited love - indeed, obsession - for Vivian. The bulk of the film follows him as he desperately attempts to win her over, record the "human interest" story of a disfigured street hustler named Jean (Maggie Cheung), and deal with the exceedingly bad news he's received from

this role, uninspired, even for a very ill man. I was much more interested in the film's setting and background than I was in its foreground.

The John-Vivian relationship didn't draw me in at all. It was an obvious allegory for what was going on in the larger, historical sense, but why bother with metaphors when you can do an inspiring film on the

real thing? Instead, we learn almost nothing about the historic Chinese takeover, or its effects on anyone interesting in particular, and are left watching developments on CNN along with John.


Chinese Box is not a terrible film - the performances of Li, Cheung and Ruben Blades (as John's friend, Jim) are strong, and it offers a series of semi-satisfying moments for those into sudsy romantic tragedy - but at base it is a disappointment. The real puzzle of this Chinese Box is how so much dramatic potential could result in a film of so little consequence.



From Here To Eternity: The Motion **Picture Legacy of Frank Sinatra**

Everyone's waiting for January 1, 2001 the day the 20th century comes to an end. But I'd argue that we've already experienced the end of our current century. It happened the moment that Frank Sinatra will define this century the same way that Bach, Mozart and Beethoven did theirs. But there was much more to the Sinatra Century than his extraordinary recording legacy of over 1,800 songs spanning 6 decades. There was also Sinatra - the movie actor.

next to Eternity his best dramatic film role. Unfortunately it was abruptly pulled from movie theaters when President Kennedy was assassinated the following year, largely due to its dark political message. The rest of the decade saw the series of "Rat Pack" films, none of which artistic masterpieces, but all quite watcheable and entertaining in a light, ring-a-ding-ding sorta way. He ended the decade with performances as a kind of alter ego private eye, Tony Rome, and a doomed war hero (Von Ryan's Express).

By 1970, the curtain fell on Sinatra's 30 year film career. There would be only one more - 1980's The First Deadly Sin, in which he played a hard-bitten police detective opposite Faye Dunaway.

Whether he was in light-hearted comedies or serious dramas - musical or not -Frank Sinatra put his indelible stamp upon each and every film role of his career. He seemed to bring at least one of his many

artistic gifts to each part - his coolness, sophistication, vulnerability, romantic passion, tempermentalism, his unique personification of the American Dream, whatever it may be. When you hear me say this, it may sound ridiculous. You just have died in the wee, small hours of the morn-ing of May 15, 1998. His music & artistry have his extraordinary film career readily available to prove it; a fine accompaniment to his recording legacy.

All told there were some 60 movies, from 1940's Las Vegas Nights to 1980's The First Deadly Sin, and they span the vast chasm between God-awful dreck to film classic. But despite the quality of the films themselves, Sinatra made a mark for himself - to much critical acclaim - in virtually every role, and this despite the fact that he hadn't had 1 hour of acting school. He was a natural actor - even his concert performances bear this out.

He started out simply as the band vocalist in his films of the early '40s - Las Vegas Nights, Ship Ahoy (1942) and Reveille With Beverly (1943). His feature acting debut was in the RKO film of 1943, Higher and Higher, in which he played himself. There then followed 5 musicals in 4 years, topped off by the wonderful MGM film Anchors Aweigh (1945). Movie roles streamed in, and Sinatra had made aimost a dozen films by the end of the '40s.

The first few years of the next decade brought debacle on all fronts. His marriage to Ava Gardner crumbled, two films flopped (Double Dynamite, Meet Danny Wilson, both of 1951), Columbia Records and MGM Studios both cancelled his contracts and his vocal chords hemorrhaged. Interestingly enough it was a film role -"Maggio" in 1954's From Here To Eternity - that saved him from oblivion, not a hit record. Indeed, he would win the 1955 Best Supporting Actor Oscar for that performance. Though he was only paid \$8,000 for his work on Eternity, he was so desperate at that point in his life he'd have done it for free.

With critical success once more his own, Sinatra added non-singing, dramatic roles to his musical ones in the 1950s. As "Frankie," a strung-out drug addict in 1955's The Man With The Golden Arm, Sinatra was nominated for a Best Actor


The 1960s started off with another classic Sinatra screen performance - a soldier in 1962's The Manchurian Candidate -

In Her New Album, **Dobkin Looks Back** at Her Musical Roots

Living With Lavender Jane Alix Dobkin Ladyslipper Records, Inc.

Over 20 years ago Alix Dobkin released her first album (an LP back then, of course) entitled "Lavender Jane Loves Women." Riding the cresting wave of emerging feminist spirit, women began producing, recording and engineering music by and for fellow women. This came to

be known as "women's music." Today, women's music is wellestablished and available almost everywhere, but Dobkin's new album invites listeners to take a step back and see where it all started.

"Lavender Jane Loves Women" (1973) was followed 2 years later by "Living with Lesbians," a scandalously unabashed title that left no question as to the record's in-

tended audience as well as its performers. "Living with Lavender Jane" is a compilation of both of those history-making LPs onto a single CD, and as such is a wonderful look back at the musical roots of Lesbian/feminist activism.

The songs themselves are reminiscent of protest and folk traditions. Dobkin's radical perspective is clear and obvious as she sings of love between women and social rebellion. The "love that dared not speak its name" had found voice, accompaniment, studio and publisher and Herstory was made!

This CD is an aural history lesson - in fact, in many ways the songs themselves are history. Unapologetic and uncompromising, it stands as an archive to which modern, independent female performers can look with gratitude and for inspiration.

The early and mid-70s was a fascinating and important time full of social change and evolution, and thanks to this new CD, one aspect of those turbulent times can be experienced again!








Los Angeles correspondent Bill Britt, and "fumorist" that's feminist/humorist-Kate Clinton join IN THE LIFE host Katherine Linton on "American as Apple Pie 1998," the Gay Pride Special. Story by story description:

Life, Liberty, and the Pursuit of Happiness—Seeking Inclusion

The lead story examines how over the past two decades everyday Gay and Lesbian citizens have challenged state and federal laws to fight for their civil rights. More recently they have fought for even greater inclusion with battles surrounding America's most sacred institutions - marriage, the military, parental rights, even the Boy Scouts.

To bring perspective on these intense debates, IN THE LIFE interviews: Mi-chelle Benecke of the Service Members Legal Defense Network; Kerry Lobel, Executive Director the National Gay and Lesbian Task Force; Evan Wolfson of the Lambda Legal Defense and Education Fund; and Noemi Masliah of the Immigration Rights Task Force.

This segment maps a shifting focus in the Gay civil rights movement and illustrates how far Gays and Lesbians have come in the eyes of the law-and how far there is still to go.

> A Day in the Life of Virginia Apuzzo

Few careers reflect the changes in Americaís Gay rights struggle as clearly as that of Virginia Apuzzo. In 1987 she was arrested for demonstrating in front of the White house. Now she is involved in running it. For 30 years she has been one of the Gay and Lesbian movement's most visible activists. Now, working in the White House as Assistant to the President for Management and Administration, she is the highest ranking openly Gay official ever to serve in the federal government.

"I didn't imagine myself here 25 weeks ago. I don't think you begin as an out Gay person in government thinking that someday you'll end up in the white House,' Apuzzo said.

This segment shows how Virginia Apuzzols activist ideas reach President Clinton's ear.

Fostering Small Town Values Iowa's Foster Parents of the Year

For this story IN THE LIFE travels to rural lowa to visit with Gair Bridges and Ron Travis, two Gay men who over the past decade have made their home a safe, loving environment for 18 foster children. They were lowa's 1996 Foster Parents of the Year and are further distinguished by being the first Gay couple to be honored by any state with this award.

Gary, one of their foster children tells IN THE LIFE of his first days in their care: "My world was turned right upside down. I just didn't know what to think. And then I heard about their (Ron and Gair's) lifestyle. I was kind of afraid-you know the stereotype, the images were coming to my mind-until I finally met them. After a week it was great. They were there for me. I could trust them. I consider them my dads-my two dads.

World of Wonder

The Selling of Gay America This story profiles Fenton Bailey and Randy Barbato, the dynamic Gay duo who created World of Wonder, an independent multi-media production company that produces programming for Showtime, HBO, and VH1 as well as England's Channel 4

and the BBC. Bailey and Barbato bring to an international audience a hip, cool, and often Queer vision of America in the 1990is, turning Gay fringe images such as Ru Paul into mainstream phenomena.

"We've always felt that things that peo-

ple have traditionally dismissed as marginal are in fact potentially mainstream," said Fenton Bailey. Bailey and Barbato are not only partners in business-they have been longtime companions for sixteen years.

For God and Country A Tale of Two Reverends

In this story IN THE LIFE examines the efforts of Methodist ministers Rev. Cecil Williams and Rev. Jimmy Creech, both of whom, despite stern reprisals from church hierarchy, openly and eagerly welcome Gay and Lesbian worshippers into their congregations. Rev. Cecil Williams runs the dynamic and diverse Glide Church in San Francisco.

Rev. Jimmy Creech of Omaha, Ne-braska, recently caused a storm in the Methodist Church and was recently put on trial for performing a commitment ceremony for a Lesbian couple.

Awards Gay American Style

Perhaps no other American tradition is so constant and so public as the proliferation of award ceremonies. Every year millions of viewers tune in for events like the Oscars, Tonys and Grammyis. Now the Gay community has adopted this grand American tradition and made it their own.

This story looks at three awards: the GLAAD Awards, those given to media by the Gay and Lesbian Alliance Against Defamation; GLAMA, the Gay and Lesbian Music Awards; and the Annual Easter Bonnet Competition held by Broadway Cares/Equity Fights AIDS.

This segment, hosted by political humorist-and a veteran MC of numerous award events-Kate Clinton, examines how the Gay and Lesbian community has adapted this awards tradition as a strategy to increase its visibility and to raise funds for vital projects.

Snapshots and Sounds Recording Lesbian History



Well that wraps it up for now. Hope I see you out and about soon, meanwhile stay safe and be proud.



come down against equal civil rights for others sharing their differences simply to keep themselves out of the spotlight of suspicion.

Brown: Also agreed, saying she believes media coverage of Lesbian/Gay private and public figures reflects the negative effects of "the entire anti-woman, anti-sex, anti-joy culture that beats us over the head" every day.

"I most emphatically want to know," she continued, "about (the orientation of) our public officials whose fingers aren't far from the buttons, whether they be nuclear buttons or budget buttons."

W: Asked the panelists to reflect on how they believe a neo-Puritan "sex panic" has affected both Gay culture and how it is covered by the media.

Brown asserted that, at least for Lesbians, it probably didn't resonate as much as with Gay men. She believes it's just more reactionism taking hold of mainstream culture.

"It's entwined with the oppression of women. I don't want to bitch about it," she responded with characteristic candor, "because it's just the way it is. But there's one day when (as a woman), you wake up and realize the world is tilted."

She explained that most of the world is just not in favor of women, and women are pretty used to that by the time they are making sexual choices, so the "panic" really doesn't come as any surprise or extreme difficulty to them. "I don't think any woman in this room suffers from it." (Wicked grin) "And if you do, call me later and I'll tell you how to overcome it."

S: Admitted that Gay male culture has a lot of unhealthy aspects: obsession with body image, the party life and self-hating behavior like substance abuse. He feels that, with the appearance of effective drugs for HIV-positive people, there is false confidence that soon there will be a cure for AIDS and therefore safe sex practices are no longer important.

"If things stay the same as they are now, fifty percent of today's 18-year-olds will be HIV sero-positive by the end of the century." He feels the media treatment of this behavior is rooted in fear and backlash. "To me, (the sex panic) has been people trying to deny what's happening. We're dealing with denial."

W: Confronted Signorile with an apparent dichotomy. "How do you maintain a balance between criticizing (Gay male) obsessiveness with the 'ideal' and then showing it on the cover of your book?"

S: "Being healthy, comfortable with your body and safe (in sex practices) doesn't mean giving up caring about how we look, dress, et cetera."

K: (Coming to Signorile's defense) "The purpose of the Gay movement is to celebrate every kind of diversity." He feels that to write critically about the reality of circuit parties, cruising and other less-than-laudable lifestyles in Gay culture was not to "turn" on that culture, but to expose the dangers of irresponsible behavior in an effort to prevent further spread of HIV and other sexually transmitted diseases.

"Circuit parties are one or two percent of Gay culture," he admitted, but went on to describe the other 98% as being composed of 'regular people,' upstanding and responsible men. He believes the hysteria of the "sex panic" has been promulgated by a hostile media looking for tabloid stories, which has created a false issue with the either/or question. "I don't think we have to choose between monogamy and promiscuity."

W: "How can Gay and Lesbian writers be responsible to Gay or Lesbian kids in Podunk USA?"

Podunk, USA?"

B: "In this country, children are chattel, property, effectively non-persons." She believes that material that reaches alternatively oriented teens with factual, non-threatening information can only help, and that the Gay media is primarily responsible for publishing that information so it is available. She feels the Internet is already and will become even more a great force in this effort.

Still, she laments the fact that young people, by their nature, believe they are indestructible, and that no amount of good information can change the behavior of someone who believes 'it can't happen to me.' "Try telling a sixteen-year-old his dick is gonna kill him."

K: "We in New York and L.A. live very privileged lives and forget how unprivileged those are who don't live in big cities," referring to the availability and visibility of alternative cultural resources and communities. "It's up to us to reach out" and let them know others like them exist.

S: "Cities aren't necessarily havens. GLSTN (Gay and Lesbian Student Teacher Network) has 35 chapters nationwide. PFLAG (Parents and Friends of Lesbians and Gays) has over 300 chap-

ters. MCC (Metropolitan Community Church is the largest Gay and Lesbian religious organization in small towns."

He feels that with a concentration of attention on urban Gay/Lesbian populations, the media neglects rural populations. "Groups like these don't get funded (to the extent that urban organizations do)."

extent that urban organizations do)."

K: "What about 'Ellen?' What about t
Gay male shows on mainstream television? will they ever happen?"

B: "Yes, but I'll be long past menopause when it happens!"

K & S: Concurred, and the conversation came around to "Ellen's" demise.

B: "It's as much because the writing wasn't fabulous" in the last season as it was about having an out Lesbian star. Addressing her fellow panelists and other men in the room, she said she feels Gay men take the brunt of the abuse from straight society. Women, being relatively ignored in society except as they relate to men, are usually left alone. But men are always being sized up by each other, making an out Gay man much more visible and easier to target. "Gay men are much more threatening to straight men on a very deep level."

S: (Nodding) "All men are insecure about being men." He exhibited some distaste with a remark that attempting to "pass" is one way Gay men try to avoid harassment and violence.

W: "Isn't what you're critiquing is Gay men appropriating the costume of the oppressor?"

S: (Nodding and mimicking a personal ad) " 'I'm a straight-acting Gay man.' What the hell is that?"

K: "In the Fifties, Gay men resisted being defined as 'top' or 'bottom.' (This categorization) is a very post-Stonewall attitude... not everything being a Gay male means."

W: "What would you say are the differences between (pre-Stonewall) 1968 and 1998?"

K: "No one was out of the closet (then). There were no outwardly or admittedly Gay men or women. There was a lot of sex, but it was very self-hating."

Warner opened the floor to questions from the audience. One woman observed that a majority of the panel discussion centered around issues of interest to Gay men and stated that she would like to talk about more Lesbian issues.

B: Stated that she felt this event was a microcosm of society at large, wherein women's issues are usually subjugated to those of men, and that this stemmed from the fact of most women having less money and therefore being less empowered.

S: (Agreeing) "I would like very much to see more dialogue" about Lesbian and feminist issues among Gay men, and a recognition that so much more could be achieved if Gay men would be less self-absorbed and more open to cooperation with Lesbians on a personal and political level.

Q: "What effect did your own personal coming out have, relevant to your careers as writers?"

B: Allowed that it really wasn't a factor, that her decision to be a writer was based more on the fact that "I'm just no good for anything else."

K: "I'm a much more clear and more honest writer now that I identify as a Gay man."

S: (Relating experiences from his child-hood, when his stories always revolved around aliens from outer space who didn't fit in here on Earth) "I knew I was different, and my stories were my way of dealing with it." Since his writing had always dealt with such fantastic creations, he expressed surprise at having wound up as a journalist. "I never knew I was going to go into non-fiction."

A last question was put to the panel concerning what they would write about if a spirit appeared to them telling them that the next book they wrote would be a socially important and definitive work.

K: "The family."

B: "I'd be much more open about my true passion, the belief that the world expands and contracts with the breath of all living creatures on it."

S: "I think I've been visited by that spirit before." He explained that he feels his position of being widely published and widely read always give him the feeling that what he says does, in fact, have an effect on the opinions and actions of his readers. He takes this responsibility to heart, and admits that he's at his best while working on a new title. "In between books, I'm horri-





GLBT Travelers Can Get Help on the Net, If They Have the Right Search Engine

Would you like to go hiking with other Gay men and Lesbians? The following information should be helpful: Gay sex photos free naked men xxx pictures nudes males Gay sex jeff stryker erotica stories underwear briefs.

What? You didn't find that helpful? Actually, neither did I. Yet that was the "description" of the #1 site that came up on a popular search engine, when I asked it to find websites that included the concepts "Gay" and "hike".

Experienced web surfers are accustomed to this. The problem is compounded for Gay and Lesbian users, however. That's because much of what's on the web is porn-for-pay, and those porn sites work overtime to pump up their ratings with the various search engines.

Once you type the word "Gay" or "Lesbian" to help define your search, you open the door to these hordes.

Fortunately, some search engines prove smarter than others at detecting which sites are most relevant to your inquiry. After too many frustrating hours of watching search results download, only to find a list of spam, I undertook to test them.

I took eight queries-word combinations such as "Gay hotel paris", "Gay hike", "Lesbian vacation" and "Gay cruise ship" then called up the major search engines, and looked at the first ten results provided by each engine to each of my queries. If you think I must have been bug-eyed by the end of all this, you're right.

I scored the results by asking, of each site listed, "How relevant is this likely to be for the typical user who types in the same query?"

In response to the query "Gay cruise ship", a listing for RSVP Travel received a top score. The site of a Gay travel agency that sells cruises also got points, but not as many. Porn, spam, and irrelevant sites lost points.

So did the home page of Mark, who is Gay and writes of a memorable night on a cruise ship. Good for you, Mark, but that ral wood throughout, formal dining room, C.A., gapage doesn't belong in the top ten listings.

And the winners are:

InfoSeek (97%) and Search (96%) came out on top-a surprise to me, as I had barely heard of either one. They share a database, but InfoSeek consolidates all pages from the same site into a single listing, yielding a more concise list. Both did an excellent job at filtering out spam, and getting most of the best

Alta Vista (89%) was strong all-round, but especially with hotel listings.

HotBot (84%) found more right-on-target sites than any other engine, but was weaker at filtering out the porn and spam. Lycos (78%) was generally strong, but weak at finding hotel information.

Yahoo (72%) actually hires human beings to look at each site before it gets listed. (The others use software that records frequency of word use, and attempts to determine content from those statistics.) Consequently, for most topics, Yahoo pro-

duced fewer junk sites than anyone else. Yet occasionally, your subject just doesn't fit into their scheme: I had no luck tracking down Gay cruises, for example, on Yahoo. It also has a smaller database, and missed many relevant listings. Those humans go home at night, while comput-

ers keep on analyzing. Excite (10%) and Webcrawler (4%) got rock-bottom scores. These turkeys share the same database, but apply different search algorithms, and so yield slightly different results. But "Garbage In, Garbage Out," as they say in the computer business, and both these search engines proved virtually useless at producing relevant listings.

(It was Excite, by the way, that came up with the odd response to my search for the "Gay hike" query. The porn site that got #1

rated:

GoTo is undergoing a major overhaul. Commercial sites can now pay to get a top listing; GoTo claims this will help increase relevancy. They could well be right; it's worth trying them out in a few months.

Northern Light is heavily oriented towards news and text. It's not the place to

look for Gay vacation ideas, but for current events, it's the place to start.

My conclusion: No one search engine will find everything you want. Get in the habit of using any two or three, from the top six. If you've been relying on Excite or Webcrawler, and could never understand why other people found the web so useful and you didn't—well, now you understand.

When you plan a vacation, you make a number of choices-often unconsciously. One such choice is: How big a group do you want to travel with? Your decision will greatly shape your experiences.

Anonymously Big get to know everybody by name on a week-long vacation. (If it's over 300 people, you'll see faces at week's end that you

could swear you've never seen before.) Amongst this many people, there are undoubtedly quite a few whose company you'll enjoy. But will you find them? If you're on the shy side, ask the organizer what type of opportunities will exist for breaking the ice.

Somewhat Big

In a group of 20 to 50, if you make an effort, you'll know most people by name within a few days. If you're traveling alone, you'll probably have no trouble finding others to join you for an excursion, dinner. or whatever. Small

Just below this in size, but much different in group dynamics, falls the awkward number of six to eight. Very Small







ARCW Provides Nutrition Screening and Muscle Testing

Milwaukee — The AIDS Resource Center of Wisconsin (ARCW) Milwaukee office will provide free nutrition screening and lean muscle mass testing (BIA) on Thursday, May 21, 3rd floor ARCW Health Services, from 2:00 p.m. to 6:00 p.m.

According to Joelle Lefevre, ARCW nutrition counselor, the tests are part of an ARCW study concerning muscle wasting in HIV-positive individuals.

in HIV-positive individuals.

"BIA testing can identify if a person with HIV/AIDS has wasting syndrome, and good nutrition can improve the health and delay the onset of wasting syndrome," said Lefevre.

Michael Blackwell of Serono Laboratories will conduct the 15 minute BIA test, which helps identify if muscle wasting is occurring. At the same time, a nutrition screening will be conducted by Lefevre.

Some HIV-positive individuals experience muscle wasting, or "HIV wasting syndrome," causing weight loss and a weakened immune system. During the BIA testing and nutrition screening, Lefevre will stress the importance of good nutrition, offer informational handouts, and healthy snacks after the testing.
