# Milwaukee Stripped of Gay World Series Crown

Atlanta — After 20 years of Gay World Series competition, a Milwaukee team finally won a championship. The South Water Street Docks Pride Team captured the Class C crown at the North American Gay Athletic Alliance (NAGAAA) Gay World Series.

Milwaukee came from behind in the late innings of the final game to beat a strong Boston team by a score of 14 to 5. Milwaukee, a charter member of NAGAAA, had never before won a World Series Championship. What could have been a source of pride for the City and its league, the Saturday

Softball League (SSBL), soon turned into a source of anger and frustration.

Within hours of its victory, the Pride had its title taken away as a result of a highly controversial decision made by NAGAAA officials. NAGAAA claimed the Docks team had underrated itself and should have been playing in a higher bracket. Docks' coach, players and other observers hotly dispute the ruling.

Under NAGAAA rules, every player in a NAGAAA affiliated league, including Milwaukee's SSBL, must fill out ratings forms. The forms ask specific questions about each player's ability. The more able the player, the higher his or her point total. The rating points for each team's top ten players are added up to determine in what bracket the team should play.

Based on the NAGAAA forms, Docks was rated a C Division team. The World Series has A, B and C brackets.

On Friday, the third day of the tournament, NAGAAA Secretary Jeff Chase filed a protest against Milwaukee. Chase said that the Docks team was underrated and should not have been allowed into the C Division. The protest was filed late in the game



On August 15, the campaign is concentrating on mobilizing voters in Madison. By the end of the day, Baldwin will have made contact with hundreds of people. She will have made two visits to the Farmer's Market. She will have spent time at a Senior Citizen Saturday, so it is hard to get the media to come to an event," she says. The candidate goes through the cafeteria talking and listening to the diners. They receive her warmly. As she makes her way through, the staff and volunteers prepare a birthday cake and ice cream. Baldwin serves those sitting at the tables. When this is done, it's time for the next stop, a neighborhood festival.

The festival is held in the Southdale area of the Town of Madison. Whites, Blacks and Hispanics live in the area. Baldwin is greeted by Linda Hoskins shortly after she arrives. Hoskins is the kind of volunteer every candidate loves


She guides her candidate through the event. Hoskins seems eager and proud to introduce Baldwin to everyone in attendance. Within a few minutes, dozens of people are sporting Baldwin for Congress stickers. Rick Phelps is at the event, too. There is little visual evidence of support for his campaign.

After about an hour, Baldwin gives a speech from the stage and leaves. It is time to get back to the office and on to the next stop.

August 15 is "Moving Day" in Madison. That's because new leases on student housing go into effect that day. The Baldwin campaign knows the importance of the student vote. There are over 40,000 students living in the district. After checking in at the office, Baldwin leaves with several volunteers.

The candidate and Madison Alderman Mike Verveer work one side of the street, while three volunteers work the other side. They hand out "Tammy Baldwin's Top Ten Tips For Tenants." Baldwin introduces herself to the new tenants and tells them that she hopes they will vote on September 8.

Every poll, every political observer and every analysis says the same thing: Baldwin and her two main opponents, former Dane County Executive Rick Phelps and State Senator Joe Wienecke are in a dead heat. The Democratic congressional nomination in Wisconsin's Second District is up for grabs.

If Greer's viewpoint had any adherents at Mount Zion, it was not apparent at the picnic. Pastor Terry Thomas enthusiastically puts on a Baldwin sticker. Nearly everyone else who is offered one does the same.

Dane County Supervisor Regina Rhyn comes up to Baldwin and says, "You are the best person for the job. I know those other two, and you are the best person for the job." Madison Mayor Sue Bauman's Chief of Staff, Enis Ragland tells Baldwin that he, too, has decided to support her. "I decided to back you three weeks ago," he says. "I always see you at events that are important to me."

That was good news to Verveer. He tells me, "Now we have Bauman's entire staff supporting Tammy."

I comment to Pastor Thomas that I am amazed at the warm reception that Baldwin, an openly Lesbian candidate, is getting from a Baptist church. He responds, "Tammy gets a big gold star for being here. She is more than welcome to be here. We are trying to build community here. Everyone who shares that dream is welcome here."

As we ride back to the office, I ask Baldwin if she is pleased that even though she is running as an openly Lesbian candidate, she received a warm welcome from a Baptist Church. "It isn't about that," she replies. "These are people who are concerned about social justice, health care, social security and edu-

The next stop is the Madison Blackwolves baseball game. Baldwin stands outside the box office greeting the fans. Some of them do more than

just shake Baldwin's hand. They talk about issues like health care. Several are from out of state. One man tells Baldwin, "I would vote for you, but I don't live here. Come to Nebraska and run there."

Some of the fans also mention the Drag Queen fundraiser being held at a Gay bar, Kirby's Klub, that evening. The event got some unwelcome publicity from a local gossip column. On the way back to the office, I ask Baldwin about the Drag Show. She says that some people are looking at it the wrong way. "You can only do so many cheese and cracker events," said Baldwin. "This is something different. It's going to be fun."

Back at the office, Baldwin and I part ways. She goes home to make calls, eat dinner and go over various campaign details. I go, thoroughly exhausted, to my hotel to check in and rest.

Two hours later, I am at Kirby's Klub. The place is packed. A roar goes up as Baldwin enters. It takes nearly 30 minutes for her to make her way to the show area. Every time Baldwin enters another part of the bar, another cheer goes up, and there is a rush of people who want to shake her hand and tell her how proud of her they are.

The show is delayed because someone forgot to bring some of the music. That doesn't seem to bother Baldwin. She takes the opportunity to go from table to table, seat to seat, so that she can personally thank those who are there. At the end of the show, the candidate makes a short speech thanking everyone again.

Soon she is off to her final stop, another Gay bar, Manoeuvres. This is not a campaign stop; it is a battery recharge and a chance to be with her volunteers. After a hard grueling day, most of which was spent under a hot sun, Baldwin still looks fresh as she leaves the bar. Out in the parking lot, several patrons come up and talk to her about the campaign.

Finally, 20 hours after she began her day, it is time for candidate Tammy Baldwin to go home. She gets in the car driven by her Campaign Manager, Paul Devlin, and they drive off. It is now August 16. There are only 24 more days to go.

during Milwaukee's semi-final victory over Boston. Boston was leading at the time. Boston's player ratings were not questioned.

A five-member panel composed of representatives from Portland, Fort Lauderdale, Milwaukee, Pittsburgh and New York denied the protest. Chase told Wisconsin Light that the panel did not make a judgment on his protest because not enough of the Committee members had seen Docks play. That is not what Tommy Salzsieder, who was in Atlanta to be inducted into NAGAAA's Hall of Fame, told Wisconsin Light. Salzsieder said, "I was at the meeting. The decision was clear. The protest was denied. There was a quorum, and that decision should have stood."

Docks Manager Todd Muma recounted that during the meeting Chase said, "We don't care whether you are a B or a C team. We want to see if the questions on the rating form were answered correctly."

Although Chase was denied on his first protest, he filed a second protest—on the same grounds - during Saturday's championship game between Milwaukee and Boston. Muma says that Boston was, again, leading in the contest when the protest was filed. Earlier in the day, Boston defeated third place Fort Lauderdale by a score of 27 to 4. No protests were filed in that game.

Salzsieder called the second protest "double jeopardy," saying that the team had already been cleared once and should not have had to face a second protest.

Following the game, a two-hour hearing was held. After an hour and half of presenting his case, Muma gave up and left. "I was never more humiliated and had my honesty and integrity questioned like this group did. It was devastating. It was 15 to 1 against... I could see that we didn't have a chance. After an hour and a half, I told them to make a decision. I wasn't going to subject myself to any more abuse."

Muma gave an example of the discussion at the meeting. "In one instance, they had seen one of our outfielders run about five feet and make a catch. They

claimed we mis-rated him because we didn't put down that he was able to make a running catch. My point was that running five feet to make a catch is not the same thing as running 20 or 30 feet. To me, moving over five feet and making a catch is not a running catch. I asked how many other managers viewed the forms the same way I did. They said, 'We are only talking about your forms—no one else's.'"

Those in attendance at the second protest meeting included representatives from leagues that stood to gain by Milwaukee's disqualification. For example, Washington DC's league, which would have gone home without a trophy, ended up receiving one for third place after Milwaukee was disqualified. Similarly, Fort Lauderdale moved up to second place.

Many of Milwaukee's SSBL managers found the forms — upon which the decision was based — to be confusing and subjective. The forms asked questions like: "Doés this player consistently hit with purpose to the warning track." "What is consistently?" asked one manager. "Is it once a week, once a month or every other time at bat?"

Chase, who designed the forms and was a party to both protests, was asked about the forms. He gave inconsistent answers on what the forms did and did not say as well as on other matters.

Others were disturbed that while Milwaukee's rating forms were so critically examined, those submitted by other teams were not. Milwaukee had three close games in the tournament and both protests were filed while Milwaukee was losing.

The fact that two protests were filed seemed to especially anger many of those who were in attendance at the SSBL's Saturday August 22 All Star Game. Some players went so far as to say that if the league remained part of NAGAAA they would quit playing softball in the SSBL.

A meeting to discuss an appropriate SSBL response to the games has been scheduled for August 25.

#### Time Line of a World Series Controversy

Winter of 1997 — North American Gay Athletic Alliance Secretary Jeff Chase promulgates a new player rating system. The system is to be used to determine player eligibility in NAGAAA's 1998 Gay World Series.

June, 1998 — Milwaukee's SSBL provides the rating sheets to teams and players interested in attending the World Series. The SSBL sends them to NAGAAA prior to the July 1 deadline.

August 11 — Gay World Series competition begins. South Water Street Docks, Milwaukee's representative, registers and is accredited as a C Division team. The team is composed essentially of the same players who finished fourth in the 1997 C Division World Series.

August 11 to August 14 — Milwaukee wins all of its games,

including a come-from- behind victory over San Francisco with an exciting late inning rally.

Friday, August 14 — Chase files a protest against Milwaukee during its semi-final game against Boston. Boston is leading the game at the time. Chase claims that Milwaukee has underrated its players.

Friday August 14 — At the protest meeting, Docks is ruled to be a legitimate C Division team.

Saturday August 15 — Late in the championship game against Boston, Chase files another protest on the same grounds as his earlier protest. Boston is again leading at the time of the protest, After a two hour hearing, NAGAAA rules that Docks should have been playing in the B Division and takes away its trophy.

#### **OBITUARIES**

I Remember Jerry by Eldon E. Murray

> IN MEMORIAM Gerald Earl Myers February 14, 1930 – August 17, 1998

Gerald (Jerry) Earl Myers died on August 17 at St. Luke's Hospital in Milwaukee, Wisconsin. He had been suffering from chronic heart disease for several years and had been admitted the previous day after suffering a heart attack.

Jerry was born 15 days before me, but I didn't meet him until we were in our late 30s. He was an executive at Harnischfeger, since retired, and was well known for his contributions to various charities and his financial support for cultural institutions. In the early 1970s, when I was putting together a clinic to combat sexually transmitted disease among the Gay and Lesbian community, I approached Jerry and reminded him that he was known to support the symphony, the opera, the ballet and even the Lyric Opera in Chicago.

"Jerry," I said, "I wouldn't dream of telling you how to spend your money, but our community really needs this clinic. It could even save lives. I've already got the location and worked out many of the medical details, but we need to furnish the place. We need desks, chairs for the waiting room, filing cabinets, lamps, pictures, etc. I've located some beautiful furniture at reasonable prices, but we don't have the money to buy what we need."

Jerry, being the generous pacesetter that he was, came through with the funds to furnish the GPU (Gay Peoples Union) VD Center, which has evolved into the present BESTD (Brady East STD) Clinic.

Sometime thereafter, the church in which GPU was holding its meetings burned down. Jerry, again, came dashing to the rescue by renting, painting and completely furnishing a building on Farwell Avenue that became GPU's new headquarters.

He modestly refused our offer of naming the building after him and insisted that it be called the "Farwell Center" and suggested, since it had adequate room, that we move the clinic into the building. He continued to cover the rent and expenses for about four years and signed over some of the furnishings every year until they all were owned by GPU. In order to accomplish this, and to handle his other charitable activities, he established a private foundation called the GEM Fund. Those assets were used up several years ago.

Jerry will be remembered fondly by the many individuals and organizations he helped over the years. A celebration of his life is being planned and is expected to be announced in September.

Finally, I'm proud to say that, even in death, my friend Jerry is still setting an example. His executor tells me his entire estate is being given to The Cream City Foundation. Way to go Jerry.

#### The Fannies Fire — Did She Do It?

A Wisconsin Light Investigative Report Copyright by Bill Meunier

For more than a month, Wisconsin Light has been looking at the charges and evidence surrounding the arson at Fannies, a Lesbian bar located in Milwaukee.

Did Dixon burn down her own business or has the State ignored or overlooked important evidence in its quest to find a culprit? We make no judgments one way or the other. Our purpose is to present what we know both sides are saying, and let our readers decide for themselves.

Dixon was charged with Arson with Intent to Defraud, Possession of a Controlled Substance — Morphine and Possession of Explosive Devices. The latter charge was dropped due to a lack of evidence. Dixon is currently free on a signature bond awaiting trial.

Because of the complex nature of the allegations, our report is necessarily lengthy. Therefore we have divided it into three parts.

#### Part 2 of a 3 Part Report

Milwaukee — An indicator of an owner's involvement in the burning of a business is whether or not any items were moved from the business prior to a fire. The Milwaukee Police believe that Dixon did move several items from her upstairs home and from Fannies in the days before and day of the fire to keep them from burning.

Dixon does not dispute that some items were taken from Fannies. She does, however, dispute the State's contention on why they were moved.

Some of these items were found in a rented storage locker, others were given to or moved to the homes of friends. Some were personal items and some were business related.

#### Locker #88

On February 6, 1998, the Police searched storage locker #88 at the Metro Storage Business Center, 2922 South Fifth Court. The locker had been rented just three days before the fire by Dixon's cousin, Patricia Johnson. Johnson rented the locker at Dixon's request.

The complaint lists some of the items found in the locker. The list includes: family photographs, a gun, artwork, clothing, suitcases, items from Dixon's mother's funeral, a tent and what the complaint termed "explosives."

Here is where the plot thickens. Sharon Dixon along with a partner, Bob Chomlinski, owned Mike and Anna's restaurant. Chomlinski died in April of 1996. Dixon continued to operate the restaurant before finally closing it down in August of 1997.

Dixon says that the day before the locker was rented, she and an employee, Gail Gutjahr, went to Mike and Anna's. When they arrived, Dixon had to break into the restaurant because she said her key did not work.

Once inside they discovered that the restaurant had been broken into. Dixon says they called the police.

"While we were there talking to the Police, this guy comes in through the back door," said Dixon. "He said he was hired by the Chomlinski family to change the locks and move stuff out."

Dixon said that the Police officer on the scene took the man into custody. "Later they called me and told me the Chomlinski family confirmed that he had been hired by them," she said. Dixon said the Police viewed the incident as a business dispute and released the man.

Gutjahr confirms the incident. "It was about three or four days before the fire,"

Dixon says that as a result of this incident, she asked her cousin to rent a locker. Dixon told *Wisconsin Light* that she wanted to move her mother's things out of Mike and Anna's. "I was worried that the stuff would be gone," Dixon said.

The locker was rented in Johnson's name because Metro storage asked her to provide some ID. But for some reason, Dixon's name was not put on the application as a person who would have access.

Dixon's friend, Monica Balfour, however, was listed as someone who would have access to the locker. Balfour told the Police that she didn't know that she was on the rental application.

When asked why Balfour was listed on the application and she was not, Dixon could not provide an answer. "I don't know," she said. "Maybe she (Johnson) was thinking ahead, thinking about the IRS problem. You'd have to ask her."

Wisconsin Light tried without success to reach Johnson, who lives in Michigan.

There are two items that indisputably were moved from Fannies just before the fire.

One was a carnival type booth that was moved from the bar on the night before the fire. The booth was used for the street parties held in front of the bar. Dixon enlisted the help of several Fannies customers to move the booth out of the bar.

Dixon says that it is foolish for anyone to think that she would have publicly moved the booth out of the bar to keep it from burning while leaving more valuable items left inside of it.

"Why would I move a \$200 tent out of the bar and leave a much more valuable \$2,000 tent in the bar, if I was going to burn it?" she asks.


There was a \$2,000 tent stored next to the pinball machine in the bar. "It was all folded up. It would have been easy to move out," said Dixon.

Another Fannies item found in the locker was a Karaoke machine. The criminal complaint makes much of this machine and how it arrived there.

Dixon's friend, Monica Balfour told the Police that before going to dinner with Dixon and her friends, she had used the machine.

According to the complaint, Balfour

said that after she had used the machine, Dixon dismantled it and moved to it to a car owned by another one of Dixon's friends. Dixon said the machine needed to be fixed.

Balfour also stated that CD's for the Karaoke were also taken from the bar. The complaint says that according to Balfour, who did not work at the bar, whenever the Karaoke needed repair, it was serviced on

Dixon said the machine needed repair because the sound was muffled and because the CD's didn't always show the words on the machine's screen.

According to Dixon, a repairman was called to the bar on two separate occasions after it had been used at the Block Parties. "We had someone come in and reconnect it. This is the first time it actually needed to be fixed," said Dixon.

Dixon's attorney, David Garaghty, believes that the Police reached the wrong conclusions from the locker search. "It was coincidental timing," he said. He points out that since the locker was searched months after the fire, there is no telling when the items were moved there. "There was a good a reason to put things there after the fire because she didn't have a place to put anything," he said.

#### Other Moves

The complaint alleges that Dixon moved items from her upstairs apartment to the home of Karen, a friend of Dixon's. These items include "a large wooden antique cabinet and a commercial cooler."

Dixon said the cooler was from Mike and Anna's. She used the cooler for her Breastfest and Links Block Parties. "After the block party, we didn't need it anymore, and I had no room for it. Karen agreed to take it if I would let her use it, which I did."

The wooden antique cabinet was also from Mike and Anna's. Dixon said she planned to auction it off at Breastfest. "I had no room for it and I wasn't about to put it on my patio. But no one came forward with a high enough bid, so I let Karen use that too."

Before Dixon and her friends left for dinner on the night of the fire, she put bottles of champagne in Balfour's car. Balfour said these bottles included a 1962 Don Perignon.

Fannies bartender, Kelli Mouw, says that the bar always kept a bottle of Don Perignon on hand in case someone wanted to celebrate a special occasion. Dixon said the 1962 bottle was being saved for a spe-

According to Siegel's Liquor in Milwaukee, a bottle of 1962 Don Perignon is valued at \$622.

#### The John Doe

A "John Doe" proceeding is a rarely used investigative procedure in a criminal case. It is the State's equivalent of federal Grand Jury investigation.

The proceeding is secret. Attorneys, who represent the target of the investigation, are not allowed into the courtroom. The transcripts of the proceeding are

The purpose of a John Doe investigation is to compel witnesses to testify even though they might not wish to do so. A John Doe was called to investigate the Fannies fire.

The Criminal Complaint against Sharon Dixon contains a report on some of the testimony given at the John Doe. That testimony, if accurately reported, is damaging to Dixon's case.

According to the complaint, two individuals, Balfour and Gutjahr, told the John Doe, a week before the fire, Dixon stated she would burn down Fannies to keep the IRS from getting it.

At a preliminary hearing on the charges, Balfour denied saying that Dixon had made the statement in the week before the fire. At the hearing, Balfour said that she could not remember when Dixon made the remark.

Indeed, the Criminal Complaint is confusing in its account of Balfour's statements on this matter. In one part it reads "...adult citizen Monica Balfour and adult citizen Gail Gutjahr both testified that approximately a week before the fire they heard the defendant state, 'I'll burn it down (referring to Fannies) before the IRS takes it.""

On a different page the complaint reads, "Ms. Balfour stated Ms. Dixon had told her that if the IRS came too close she would burn her bar down. Ms. Balfour further stated that she did not recall exactly when the statement by the defendant had been made ... "

Dixon admits that she did make a similar statement to both women, but denies that it was the week before the fire. "What I said was, 'I'd rather see this place burn down than see the IRS get it for 10 cents on the dollar.' But I was talking about Mike and Anna's and not about Fannies, because it was Mike and Anna's that had the tax problem," said Dixon.

William Zinthefer, a CPA contacted by Wisconsin Light, said that even though the Dixon's tax problem emanated from Mike and Anna's, it would have affected Fannies, too, "The IRS still could have and would have gone after her other assets including the bar," he said.

Dixon also challenges Gutjahr's credibility. The Criminal Complaint says that Gutjahr identified herself as "Fannies Manager." Dixon says that Gutjahr was not the manager and only did cleaning work for her and inventory work for her.

When contacted by Wisconsin Light, Gutjahr herself said that she was not the manager and denied telling the John Doe hearing that she was.

When asked if Dixon did in fact tell her that she would burn down the bar the week before the fire, Gutjahr replied, "Yes she


Dixon says that her attorney intends to issue a serious challenge to Gutjhar's credibility at the trial.

The complaint also says that during the John Doe, Balfour testified that after the fire Dixon said she wanted to put the insurance money in Balfour's name in a

Dixon denies that was the case. She says that she had been thinking out loud and only said that she wondered if the IRS could get the money if it was in someone else's bank account. "I never asked her to do that for me," said Dixon.

# **GLEEDA Merges with Positive Voice**

Appleton — Members of the Gay & Lesbian Education and Economic Development Alliance (GLEEDA) voted unanimously to merge with Positive Voice, Inc. at the group's annual meeting at the Liberty Hall Convention Center in Kimberly August 12. As part of the merger agreement, GLEEDA members will receive prorated memberships in the Green Bay based LBGT group.

Several traditional GLEEDA events will continue with Positive Voice assuming sponsorship. Former GLEEDA executive board members also will have first refusal rights in the filling of future vacancies on the recently elected Positive Voice board.

Following lengthy discussion, GLEEDA members decided to donate portions of the group's treasury to four Gay-positive entities. Receiving \$200 each were the Fox Cities chapter of PFLAG, Appleton's LBGT Partnership youth group, Action Wisconsin, and the Tammy Baldwin for Congress campaign. The balance of the treasury will be turned over to Positive Voice.

Founded in 1992 as GWEEDA (Greater Wisconsin Education and Economic Development Alliance) with a business oriented educational and political action mission, the group evolved into something completely different, according to former executive board member Marty Brown. "We really strayed from our original purpose and became much more of a social group," Brown said.

With the merger, membership in the six-year-old Positive Voice group will top 100.

#### Resignations at Madison's AIDS Network

Madison — Two of the five members of Madison's AIDS Network management team have resigned. As Wisconsin Light went to press, it was learned that the group's Management Team was preparing a management plan for the Board of Directors. The plan would lay out the agency's governance during a transition period.

Mary Turnquist, Executive Director of the AIDS Network, Madison and South Central Wisconsin's AIDS Service Agency, submitted her resignation to Board President Todd Harshbarger effective September 11. Until then, she plans to work closely with the Board and Management Team to assure that the transition "is begun in a positive and planful manner."

Also leaving is Director of Services, Tatiana Dierwechter, effective the end of the month. Dierwechter has accepted a prevention position with the State Division of Health HIV AIDS Program in the office of Dr. James Vergeront.

Turnquist and Dierwechter make up nearly half of the five member Management Team at the AIDS Network. The other three members are Kevin Baird, Director of Administration; Suzanne Gillingham, Director of Finance; and Rudi Baker-Jambretz, Asst. Director of Services. There are 14 non-management staff members, with two vacancies. The Network's annual budget is \$1.5 million.

In her resignation memo to the staff, Turnquist wrote: "It has been my privilege to serve the AIDS Network the past three years. This is the right time to make a change in top leadership for the agency and in my life personally. I have achieved what I was hired to do...and can leave confident that the agency is strong and in very capable hands. I'm ready to start a fresh page in my own life and will pursue a long-time dream, that being to do freelance writing."

According to Turnquist, the Board and Management Team were about to hold a series of meetings to decide how to replace her. Harshbarger said "We have enough time before Mary leaves for our Management Team to set up a strong plan for the transition. "Harshbarger and Turnquist said that among the possibilities are a self-directed Team, an Interim Director, or putting another person or persons in place until a new Director is hired.

"We're looking for someone to take us to the next level. We're in a better financial state than ever before, and our service programs are unsurpassed," commented Harshbarger.

Harshbarger is also the partner of Baird, Dir. of Admin. "Let me assure you that there is absolutely no possibility of a conflict of interest between myself as President of the Board, and my partner." He said guidelines were in place to assure that.

Turnquist claims the agency is in a strong position and that the potential for the future "is positively exciting." She explained, "The merging of our prevention and client services departments and the cross-training already occurring, put us ahead of the game and provide us the flexibility of moving quickly as the environment changes." She calls the AIDS Network's subcontracting of

housing and employment services as "effective collaborations."

She also comments that "Internal systems, policies and procedures are in place and provide a stable environment," and that a Management Team of "highly skilled professionals who work well together, share a common vision and are absolutely dedicated to our mission."

However, as pleasant as things seem on the surface, one source told Wisconsin Light Turnquist quit after disagreements with the Network's Board of Directors. The source also indicated there was in-fighting amongst members of the Board, and that Turnquist was caught in the middle and decided she didn't want to "be a boss anymore."


Turnquist responded, "Not at all. There is a very good mix of people with invested interest on the Board. They all have their own opinions and I consider that healthy."

Associate Director of Services, Baker-Jambretz has worked as a team with Dierwechter for over a year, helping to assure a smooth transition in Services which now covers both client services and prevention.

Board President Harshbarger commented, "It's really wonderful credit for the State to use Tatiana for prevention services. It shows the respect the state has for our programs here."

The AIDS Network "decided housing wasn't their responsibility and I was pleased when they went to generic local community housing agencies," commented Judy Wilcox, State Director of

#### **HRC Report Attacks Ex-Gay Programs**

Washington, D.C. — A new report commissioned by the Human Rights Campaign says that so-called Ex-Gay ministries and reparative therapy does not work.

HRC says that its report, entitled *Mission Impossible*, examines these techniques and finds them lacking in merit. The report also says that religious political groups have forced the recent rise to prominence of Ex-Gay groups.

"There has been no recent mad rush by Gay people to change into heterosexuals," said Kim I. Mills, HRC's education director and author of the report. "These programs have been thrust into the spotlight recently because James Dobson, head of Focus on the Family, wants the Republican Party to hew to his conservative agenda."

Mills adds that after Dobson's meeting with Senate Majority Leader Trent Lott, Lott compared homosexuality with alcoholism, Congress began to consider several pieces of anti-Gay legislation, and Ex-Gay ministries were showcased in newspaper ads. "These are not coincidences," says Mills.

The report charges that Ex Gay programs make inflated claims of success without substantiation. For example, it cites the Public Broadcasting Service documentary One Nation under God. In a 1994 documentary, Exodus, an Ex-Gay ministry, claimed a "change rate" of 71.6%, yet could not provide documents to back up this precise figure. Four years later, Exodus still could not substantiate its claims to Newsweek magazine.

#### **Trail Blazing Gay Paper Folds**

Norfolk, VA (AP) — A Gay and Lesbian newspaper that began as a few mimeographed pages with handwritten headlines and grew into a computer-designed national publication is folding after 22 years.

The last issue of Our Own Community Press was distributed on Sunday, August 16, leaving Hampton Roads with a single Gay-interest newspaper, Out & About.

Kirk Read, Editor of Our Own, said the newspaper was built by indefatigable volunteers who saw themselves on the front lines of a civil rights struggle

Current and former staffers gathered Saturday to put together the last, abbreviated edition — eight pages, much of it a retrospective of the paper's more than 250 editions.

"I'm struck by the spirit of that early newspaper, the people who put it out and their bravery," Read said. "It was their life, but many couldn't even use their last names at the time."

News of the paper's demise came as a surprise in a community that came to rely on the publication. "It's like losing a friend, and I've had that happen too many times," said Mark Powers, 43, of Virginia Beach. "It's been part of my life for so long, I just take it for granted it will always be there."

The Editor of Out & About, who goes by the penname Harry King, said he was stunned by the news. Our Own "did a lot of trail blazing," he said. "Particularly in the beginning, it filled a big need in the (Gay) community.

Out & About, with a statewide circulation of about 12,000, is more socially oriented, featuring coverage of Gay nightlife, entertainment and sports. King said he does not expect to significantly change Out & About to fill the void left by Our Own.

#### Campaign Against Anti-Gay Measure Heats Up

**Honolulu, HI** — A \$1 million campaign to defeat an anti-Gay constitutional amendment has been launched in Hawaii. Protect Our Constitution is hoping that a state-of-the-art media and grass roots effort will defeat a proposed constitutional amendment that could lead to banning same sex marriages in the Aloha State.

The referendum if passed would allow the State Legislature to ban Gay marriages. It is intended to undermine a current court case, Baehr v Miike. The case, which is before the Hawaiian Supreme Court, could lead to same sex marriages in Hawaii. The Court is expected to rule in favor of Gay marriages.

The campaign has already filed a complaint against the Hawaiian chapter of the Christian Coalition and Focus on the Family for failing to file campaign reports as required by Hawaiian law. Those two groups are backing the referendum.

Opponents of the referendum have been buoyed by a recent poll, which showed that it might not pass. Under the State Constitution, 50% of all voters in any election must approve a constitutional amendment in order for it to pass. The poll showed the measure getting a bare majority of all likely voters.

If the historical trend on Hawaiian Constitutional Amendments continues, an estimated 15% of the voters will not cast a ballot on the measure and it would fail.

#### Talk Show Suit Delayed

Pontiac, MI (AP) — Geoffrey Fieger's campaign for Governor could delay a \$50 million wrongful death suit against talk show host Jenny Jones.

Fieger is representing the family of Scott Amedure, a Gay man murdered by a fellow guest days after they appeared on Jones' show.

Gays and Lesbians have become the hot button issue they are using to build their agenda, spur organizing and raise funds.

The budgets for the Right's two largest groups total more than ten times what our largest Gay and Lesbian organization, HRC, has. They are using that money to scare and activate their followers who consistently show up at the polls and vote what they are told to vote. Meanwhile, their Republican Right puppets in Congress are spewing anti-Gay comments.


Their constituents are being told in national ad campaigns that Gays and Lesbians can change. That Gayness is a choice that can be altered through religion. It's an anti-Gay crusade that only promises to get stronger as the election season approaches. They've twisted studies to support their contentions that Gays can change "if they want to."

However, their strategy could backfire if their oft-times nasty anti-Gay assault causes mainstream American voters to turn out in force against them.

So, what can you do? Vote, first off, in the September 8th primary. But before then, COME OUT! I know you've heard it before, many times, but it is critical. If you come out to friends, family and other people who know you well, it softens their beliefs about what Gays and Lesbians are all about. Then when it's time to enter the voting booth, that anti-Gay rhetoric just might be softened by knowing someone close who is Gay or Lesbian.

To me, the annual Pride celebration has never meant being "Proud of being Gay." I am Gay. I've always been Gay. I didn't have anything to do with that any more than I picked my height or the color of my eyes. I reserve pride for things over which I have some control: a piece of writing that's well done; a pie that I've made and comes out just right, to cite two examples.

What PrideFest means to me is a sense of triumph at having come through all the closeted years. Those were the times, the '50s and '60s, when the word "Gay" didn't exist for me; when the one or two Gay bars in town were regularly subject to police raids; when something like PrideFest hadn't been thought of; when a good friend of mine in college committed suicide after the campus minister - the so-called "Director of Spiritual Activities - said in a sermon that all the "sodomites" ere going to Hell.

I know that we have a long way to go before final victory is achieved, but when I see those rainbow flags flying, a thrill goes through me. I know how far we have come.

In celebrating Pride, each and every one of us asserts the ultimate human right: to be ourselves. However, there is more.

In celebrating PrideFest, we assert what is the ultimate American right: the

right to equal treatment under the law. We assert that there is no religion, no ideology, no philosophy that is sufficient to deny us that right.

The right to equal treatment includes non-discrimination in the workplace; in housing; in accommodations; in all places and situations whatever. Some of this we have achieved. Much remains to be done. PrideFest reminds us of both.

That right includes being able to join with someone in a legal union and receive all the legal benefits given now to different-sex couples in marriage.

PrideFest is a time for all of us to get together and have a wonderful time. There is more.

The first evening of the last March on Washington, I went to Dupont Circle. There were uncounted numbers of people there, women and men, old and young, all walking about. As far as I could see, everybody was wearing the rainbow colors in some form or another.

There was such excitement in the air. The whole of the vast space that the Circle is seemed to pulse with energy.

Suddenly, a young man stood up on the rim of the fountain in the center of the Circle and began to sing "I Am Who I Am" from La Cage aux Folles. I can still hear him today, even as I write. His voice was so beautiful, so clear.

A hush fell over that great crowd. Everyone's eye was on him, because

# Pocan, Richards, Marks-Dicks for the State Assembly

On September 8, Wisconsin voters will go to the polls to select the party nominees who will compete in the November election. There will be a number of State Assembly primaries, but we have chosen to concentrate on three Assembly races that are occurring in districts containing large numbers of Gays and Lesbians.

In Madison's 78th Assembly — the downtown area and the Isthmus — we whole-heartedly endorse Marc Pocan, an openly Gay candidate. Pocan has a solid record of public service on the Dane County Board. After leaving the County Board, he continued his involvement in the community. His work on an intergovernmental task force was particularly impressive.

Pocan has won the support from a wide variety of residents and businesspersons who believe, as we do, that he is the right person for the job. Pocan's main opponent, John Hendrick, is a strong supporter of Gay civil rights and is an able candidate. Nonetheless, we prefer Pocan, not because he is Gay, but because we believe his record shows that he will do the best job of serving the people of his district and the State of Wisconsin.

In Milwaukee's 12th Assembly District — the East Side and Bay View — there are three candidates in the Democratic primary. Jon Richards should be the choice of voters in that district

Richards takes a thoughtful approach to the issues that concern the residents of his district. His opponents, Al Campos and Tim Carpenter, who is not to be confused with State Representative Tim Carpenter, simply cannot match Richards' knowledge and abilities. We urge those living in his district to vote for Richards on September 8.

In Madison's 48th Assembly District, voters are faced with a pleasant surprise — four well-qualified candidates. We believe that Helen Marks Dicks is the right choice for members of Madison's LBGT community. In choosing Dicks, they are selecting an articulate woman who has made standing up to bigotry a hallmark of her campaign. Furthermore, Dicks has made major efforts to reach out to Madison's Gays and Lesbians. Our experience indicates this is a sign, that if elected, Dicks will place great importance on the concerns of Gays and Lesbians. We urge voters in the 48th to fill the void left by retiring State Representative Rebecca Young with another fighter for equality, Helen Marks Dicks.

# Until It's Over... Keep Walking, With Chastity, Charity & Love

As a person with AIDS, infected before 1985 and testing positive in 1988, this marks the 10th year of the AIDS pandemic for me personally. AIDS Walk Wisconsin marks its 8th year as a tool in fighting AIDS with awareness and education to fight this modern-day plague that continues to devastate our planet.

AIDS Walk Wisconsin has raised \$4.8 million since its inception, including over \$800,000 last year. This year, organizers hope for 12,000 walkers representing a diverse cross section of Wisconsinites to help raise funds for 19 service organizations scattered throughout the state.

Last year's total was less than the previous year, reversing the trend of increased totals each year the Walk was held. Why? The perception that AIDS is over. False perception, to say the least.

One of every 250 people in the U.S. is infected with HIV. The rates are higher in foreign countries. The lauded "AIDS drug cocktail" works for only about one third of PWA's.

I'm one of those cocktail "failures." I'm a diligent patient. I didn't skip doses. I didn't fail the drugs... they failed me, as they have many others. The other "lucky" third may be experiencing a honeymoon — the lull before the virus reawakens.

You may see me now and think I look much better than I did three, four years ago; and I do feel better thanks to my meds. However, so-called "salvage therapy" is barely managing to keep HIV relatively in check.

The September 20th 10K walk along the shores of Lake Michigan, in Milwaukee's beautiful lake park system, will be led by Chastity Bono. Bono, the daughter of the late Sonny Bono and superstar, Cher, has come to the forefront of the fight for Gay and Lesbian issues.

This is fitting because, whether we like it or not, AIDS is still a Gay issue. Bono is a forceful touring speaker, and recent author, who has worked with several national Gay and Lesbian organizations since her public coming out.

Have you registered to walk? Have you donated money to a registrant?

Unfortunately, I personally can't walk because of neuropathy in my feet caused by the 11 AIDS drugs I've been on since I started treatment in 1989, and the course of HIV disease itself. Instead, I'll give what money I can to someone walking in my place. Even a few bucks — the cost of a bottle of beer or a Big Mac — from each of you, could help break the record for money raised.

I don't know what the future holds. None of us do. All I ask is that you support the Wisconsin AIDS Walk, because the future is in your wallet and rests upon your feet... Until It's Over, Keep Walking!

Dear Editor,

"Can homosexuals change?" But this complex issue needs more clarifying. Otherwise, the religionists and liberationists miscommunicate past each other, and worse, outsiders miscomprehend the issue itself.

- Yes, behavioral change is possible. But not for all, or even for as many as doctrinaire religionists enthusiastically claim.
- But yes, change could be good, not oppressive. That is if one's valued religious faith, or one's secular need for social conformity, requires distance from homosexuality.
- And yes, change can make religious sense. That is if one's faith states that Scripture is the truth; that homosexuality is a sin; and that salvation is possible.
- \* But yes also, change-expectations could be bad, not liberating. That is if first, only one's outer erotic behavior changes, and not one's truer inner eroticand-emotional identity. And if second, one's secular philosophy values seeking one's truest self, then living same not with self indulgence, but with responsible integrity.
- Which is worse? Religionists' mechanistically misleading uninformed folk (gay and straight) with unrealistic enthusiasms? Or liberationists' flatly ignoring conservative religion's inner logic and its appeal for the faithful? To mislead, to ignore both seem bad.
- As for "choice" and "change."
  Yes, a few people's self-perceived sexual orientations do change. Both ways (let alone bisexuality!). And at various ages in life. Infrequently, however. Further and important nobody ever really chooses that change! People don't decide they discover!
- Major misconception: that "sexual orientation" equals only sex, the physically-erotic. That is, which gender one has sex with; or can; or would prefer to. But not so! .Primarily, S.O. is about love; the physical-emotional. That is, which gender one can bond with more spiritually, intimately, responsibly, fully. Many folk misunderstand this.
- To their credit, candid religionists admit that usually, only behavioral change occurs homo-sex discarded, hetero-sex performed and not whole-person identity-change. Their doctrines can accept this "half a loaf onward." But some liberationists would judge it as dissonant self-destructiveness, maybe even a sin of sorts in their own books.

My own "religion" and "liberation" is "education." Specifically, trying to think about any subject the best one can. To be incisively accurate plus fairmindedly sensitive. Like the other religions, it's arduous but rewarding.

#### An Open Letter to Gay and Bisexual Men in Milwaukee

I was recently fortunate enough to be able to attend the 20th Anniversary National Lesbian and Gay Health Association's annual health conference in San Francisco. Besides the obvious benefits of anything happening in San Francisco, I also found the conference to be incredibly challenging as an out Gay man confronted with issues of HIV prevention and Gay men's health in 1998.

I attended a track of workshops and discussions entitled Gay Men's Sexual Cultures that dealt with tough, often controversial issues like drug use, bare-backing and leather sex. The purpose of the track was to get beyond the never ending debates and moralizations to openly discuss how these topics affect our sexual lives, as Gay and Bi men, and how we need to address them in the context of the health of our communities.

On a national level we debate circuit parties and Sex Panic!, on a local level we debate sex in parks and other public places. For the health and well being of our communities, we need to discuss these important issues with one another and how they impact our lives.

We need to ask questions such as: What are the meanings behind our sex lives? How do the kinds of sex we have define who we are as Gay and Bi men? How does sex fit into the rest of our lives and needs? And how can we respect individual choices around sex and sexuality that may be perceived as being outside of community "norms?"

If we can't discuss these issues among ourselves, then whom can we discuss them with?

I challenge all of us to get to know one another and explore who we are as Gay and Bi men. Talk with your friends and sex partners about these important issues. I also invite you to be a part of ARCW's Gay & Lesbian Outreach Program over the coming months and years as we attempt to raise the difficult questions and talk about our lives.

#### **Help AIDS** Prevention Research

Milwaukee - In addition to watching entertaining stage performances and enjoying the company of old and new friends, PrideFest attendees can help AIDS prevention research by completing a short survey for the Medical College of Wisconsin's Center for AIDS Intervention Research (CAIR).

CAIR has conducted surveys at PrideFest since 1993. This year, two questionnaires will be offered: one for individuals and one for couples. Both surveys are anonymous and ask questions regarding intimate relationships. Responses to the surveys will be used by CAIR researchers to develop and evaluate programs to improve people's relationships and sexual health. Every adult, regardless of sexual orientation, is invited to complete a survey. CAIR's booth is located in the Marketplace area

"It is important for us to hear from people at PrideFest about the ways they deal with relationship issues," says Jeffrey A. Kelly, Ph.D., professor of psychiatry and behavioral medicine and director of CAIR. "We can use the information they give us to hone our research efforts to develop better strategies to prevent future HIV infections."

#### Changing Landscapes for Lesbian/Gay Health

Washington, D.C. - The landscape for Lesbian, Gay, Bisexual, and Transgendered (LGBT) health care is

That was one of the many conclusions reached at the well-attended 20th Anniversary of the National Lesbian and Gay Health Conference and the 16th National AIDS/HIV Forum in San Francisco.

"Over the last 20 years, our health care has changed on a variety of different levels," said Beverly Saunders Biddle, executive director of the National Lesbian and Gay Health Association. "Medical issues have evolved to include HIV/AIDS and breast cancer most notably, but STDs and addictions are also becoming more present. We're beginning to understand more of the complexities involved in psycho-social issues such as the high rates of LGBT youth suicide, issues surrounding gender-identity disorder, and the horrific impact that homophobia places on both access to and the quality of medical care. And with AIDS treatment and prevention, we're examining a lot of the social factors that influence successful programming."

#### **Diverse Conference Issues**

Another change in the discussion around LGBT health care issues witnessed at the conference was the

increased recognition of the diversity of issues involved. To that end, the conference offered more than 150 panels, discussions, and workshops.

In addition to providing critical new AIDS-related information, theory and discussions, the conference educated physicians, nurses, health educators, activists, and other health care professionals about critical health issues affecting LGBT people:

- · New data on LGBT youth was unveiled by Callen-Lorde Health Center.
- · Two new ventures were announced: (1) A new Lambda Medical Center for Gays and Lesbians in LA, including a 2,400 square-foot medical facility, offering a full-spectrum of health care for Lesbians and Gay men; and (2) The Lambda Center, a joint venture of Whitman-Walker Clinic and the Psychiatric Institute of Washington, to provide behavioral health care.
- AIDS updates. Updates from the World AIDS Conference held in Geneva, Switzerland, discussed medical findings, new prevention theories, and epidemiological findings.
- A Viagra forum, co-sponsored with the San Francisco STOP

AIDS Project, attracted about 100 activists, dispelling sexual myths of Viagra, and pointing out potentially harmful interactions with poppers and AIDSrelated drugs.

- · The debut of new tracks on bisexual, transgender, and senior health at NLGHC, as well as expanded tracks on Lesbian health and youth
- Awards given to Transgender Community Task Force for their leadership on transgender issues, and Greg Merrill for his anti-violence work with the Community United Against Violence. Also recognized were Lorri L. Jean, Cornelius Baker, and Dr. Richard Isay.


#### Sights Set on Dallas for June 1999 Conference

The civil trial was set for September 14 before Oakland County Circuit Judge Gene Schnelz. Attorneys for both sides say there is a tentative agreement to postpone the case until after the November general election.

"Right now, in the middle of the campaign, I don't think it would be fair for either side," Fieger told the Detroit Free Press.

Amedure revealed that he was attracted to Jonathan Schmitz, a heterosexual, while on the talk show. Schmitz went to Chicago for the show thinking a woman was going

When the two returned to Michigan, Schmitz shot and killed Amedure at his home. He later told police he was humiliated by the surprise on-camera announcement.

Schmitz was convicted in 1996 of second-degree murder and is serving a 25 to 50-

Amedure's family says Jones helped contribute to Amedure's death by playing on Schmitz's emotions. They are suing Jones, her show, Warner Brothers and Telepictures.

#### Man Convicted of Gay Slaying

Newport News, VA (AP) - A man was convicted Friday of a Gay sex slaying similar to 11 unsolved murders. The jury recommended a life sentence.

The murder of Andrew D. Smith, 38, was similar to the others in southeastern Virginia over the past decade. Elton M. Jackson was charged only with Smith's death.

Jackson, 43, had sex with Smith at Jackson's Portsmouth home, strangled him and dumped his nude body near a dirt road in Chesapeake. The body was discovered July 22, 1996, more than 24 hours after authorities say Smith went to Jackson's home, where the two had consensual sex.


Jurors were never told of the other slayings. Jackson was convicted of first-degree murder and will be sentenced October 27. During the trial, three other men testified that Jackson tried to throttle them with a leather strap during sex. Jackson admitted to having sex with two of the men.

The bodies, all nude except for the first, began turning up in 1987. Many of the victims were Gay. Some were hustlers, and nearly all were drifters or transients last seen in or near Gay bars in Norfolk or Portsmouth. Smith's body was the last to be

discovered. There have been no other similar slayings since Jackson's arrest in May, 1997.

#### **Gay Church Elder Keeps Position**

Fort Lauderdale, FL (AP) - A Presbyterian Church (USA) court has decided that a Gay man may remain in his position as elder.

The decision Tuesday by the highest court of the 2.6 million-member Presbyterian Church (USA) ended a legal battle over Ray Whetstone's homosexuality.

Fellow church member Ronald Wier filed a complaint against Whetstone after his ordination in January, 1996. Wier cited a church law that bans Gays from ordained ministry.

The Permanent Judicial Commission ruled that while the ordination was "irregular," the panel lacked the authority to annul the position.

But the court warned that Second Presbyterian Church could not ordain another Gay elder. Whetstone also won't be allowed to serve another term under the court's agreement after his three-year term expires in December.

Housing Opportunities for PWAs (HOPWA). "We're about to initiate the new HOPWA grant cycle and ARCW will be taking over the entire state housing program. Future HOPWA grants for the entire State will be administered through ARCW using the current local representatives and subcontractors. We're quite satisfied with ARCW' s work."

In a letter to Wisconsin Light (August 13 edition) Turnquist said that instead of providing a "one-stop shopping center resource as ARCW" has done, the Network approached providing services by building a community of support to fight the AIDS pandemic. The result, she claimed, was a network of resources and service subcontractors. She concluded "The Milwaukee model [ARCW] " is not appropriate here."

In her resignation letter, Turnquist again reiterated that position. At an August 18 meeting with top officials of the Wisconsin Division of Health AIDS/HIV Program, Turnquist claims "they are absolutely supportive of the community-focused collaborative model of service provision. They emphasized this at the meeting."

#### Replete

It was Saturday afternoon at home and the phone rang. I hurdled a few chairs to arrive at the phone as the fourth ring kicked in the answering machine. I intercepted it just in time, breathlessly greeted the caller, and have remained in a breathless state ever since

The caller was a co-worker who was assigned the tedious task of pulling a Saturday shift at our facility, poor dear. She was beside herself due to an encounter she had with some man. My friend, as co-workers so often are, is straight, pencil straight, and she's looking for Mister Right.

I tried to slow her down, but that girl had met a man who attracted her. Through hell or high water she was going to tell me everything she could about every detail of their interaction. After several laudatory adjectives about him, she granted me permission to put forth some general inquiries; "So, where's the boy from?" to which she responded with a puzzled "I'm not sure".

"Does he have an accent?" I probed. "Yes, kind of, but I don't know, its different." "Is he middle-easternish?" "Can't say." "Swarthy skinned?" "Well, sort of, very athletic built - lean and chiseled."

Then she told me his name, which, as neither of us knew at that time, was grossly misspelled due to a slight intercultural communication issue. For our purposes, we'll call the man Replete.

What I could ascertain from my coworker was that Replete was not Caucasian or native-born American, but was instead from some "other place". Outside of his overall beauty, I knew nothing else.

I detected, ever so slightly in her voice, what began as a mere trickle and grew as she spoke into something resembling a flood of trepidation. I wondered

"So, what aren't you telling me?" "Well, his emergency contact on his employee card - is a man. A man living in California, San Francisco - to be exact. I have a feeling Replete is Gay."

A week or so later I was sitting at my station, working diligently, as I am often praised for doing. I suddenly found myself gazing upon a most handsome figure. This beauty could be none other than Replete. When he spoke, his mellifluous voice left me wishing dinner hadn't already been eaten.

Replete was sublime. The Count of Monte Cristo would have found cause to admire his poise and his ivory teeth - I had to glance down to blink and re-wet my eyes. "You must be Replete. I see you're new here."

I began with a thorough investigation of his past and heritage. I left no stone unturned. His coloring was as natural as genetics. His accent was a remnant of an adventurous youth spent overseas.

I figured I was off to a reasonable, if not exactly earthshaking, start. I kicked off our interactions with a familiar air and he responded with eloquence and

composure. Professionally speaking, I couldn't ask directly, "Are you Gay?"

I slipped on my Gay sleuthing gloves and began to sow the seeds from which a full disclosure could blossom. Meanwhile, my dreamy-eyed friend was demanding full-length, itemized reports on my progress.

We masterminded a flanking action. I wanted Replete to feel completely at ease with me. Like the wily chameleon, I took to dressing for work in a style remarkably similar to his dress: casual wealth with a hint of athleticism.

Having achieved a reasonable semblance, I then determined to directly target the cause of all the skepticism - the emergency contact in California. I cornered Replete and demanded he provide a local emergency contact.

His response was enigmatic at best. Evidently, his former "roommate" was the only person in the U.S. he'd trust with emergency decisions. He eventually allowed that his current "roommate", gender unspecified, would do and provided me with a number, but no name.

Next I tried the osmosis angle. I'd been reading a fabulous Gay adventure called A Ghost in the Closet. Whenever he's around I keep the book, cover up, on my desk. I toss it idly from hand to hand while Replete and I leisurely discuss the perils of daily living.

He's never once uttered an inquiry as to what I'm currently reading. A query to which I would happily reply, "A lovely Gay novella. It's really hits close to home for me."

Then, as if fortune had showered down upon me, Replete arrived one day with a man, who was unquestionably a flaming homosexual. This man's fire burned so queer that he wasn't just flaming, he was ablaze.

Replete introduced the very lovely person as his "colleague". I was thrilled. practically fell over myself serving him. I was hoping to send out subconscious signals to Replete; out Gay people get special treatment.

You can imagine my surprise when, later that week, Replete declared that he wasn't interested in taking dance classes with my charming co-worker. How could that be?

He had an expressed interest in dance. All Gay men without dance partners who love to dance are looking for a partner. Right? Well, evidently not.

The shocker came when he said, "My colleague, who you met the other day, is looking for a dance partner. It would be great for him. He's looking for (look left, look right) someone special." To which I replied with an astounded, "What, he's Gay, Gay, """ "Oh no Tina, he's looking for a wife. He's made that clear enough."

I couldn't believe we were having the long overdue talk, and Replete was not the center of discussion. In fact, he was incredulous as to how I could have thought his colleague was Gay, "not that there's anything wrong with it."

And that, as if a metaphor for life itself, is how the situation stands: replete with ambiguities.







#### Sri Lanka Gays Want Target Anti-Gay Law

Colombo, Sri Lanka (AP) — Sri Lanka's only Gay rights group Wednesday is calling for the repeal of a 19th century law which makes homosexuality a criminal offense.

"Gay people don't even dare come out in the open while this law is there, branding them as criminals," Sherman de Rose, a spokesman for the group Companions On a Journey, told reporters.

The 130-year-old law, passed when the Indian Ocean Island was a British colony, makes homosexual acts punishable by up to 12 years in prison.

No studies have been done on the number of Gays in Sri Lanka, where homosexual issues are rarely discussed in the open.

De Rose said Gays are hopeful that their attempt would succeed. A 1992 move to repeal the law was approved by the country's Cabinet, but was never presented to parliament. De Rose said the law was even hampering AIDS and safe sex education for Gay people.

Sri Lanka has detected only 267 AIDS cases among its 18 million population, but some research groups estimate that there may be up to 8,000 infected cases who have not developed full blown AIDS.

#### **Aussie Court Rules Against Lesbian**

Brisbane, Australia (AP) — Queensland's highest state court ruled that a donor sperm clinic did not discriminate against a Lesbian when it refused to inseminate her.

Last January, the Queensland Anti-Discrimination Tribunal found the 24-year-old woman had been discriminated against by the clinic on the basis of her sexuality.

The woman, who is now a mother of two, has gone on record as saying she led the crusade for Lesbian access to the clinics because stringent testing meant the clinics did not carry the same risks as private donor insemination, notably the possibility of AIDS contamination.

However, the state Supreme Court overturned the decision after the clinic appealed, saying it had the right to refuse treatment because the woman was not infertile.

The Court of Appeal upheld the Supreme Court finding, saying the woman had not been directly discriminated against on the basis of her Lesbianism.

#### Big Ben Target of Protest

**London** — Data Lounge reports that members of the Gay British activist group YouthSpeak launched an unusual protest. The group painted London's most famous landmark, Big Ben with a laser projected Pink Triangle.

Youthspeak is angry at the failure of the House of Lords to approve a change in Britain's Age of Consent law. In June, the House of Commons approved a measure to lower the age of consent for Gay sex to 16 — the age of consent for heterosexual sex in Britain.

In July, the House of Lords rejected the proposal. While the House of Lords cannot kill legislation, it can delay it for up to a year.

YouthSpeak demanded that the Home Secretary and Attorney General issue a waiver on enforcement of the law until both Houses of Parliament could pass the new law. The demand was refused.

After about 20 minutes, the Police surrounded the protesters and forced them to disband. Nevertheless, the group was pleased with the protest. YouthSpeak Chairman, Chris Morris, said, "Big Ben is one of the capital's biggest landmarks... It is the first time that a political message has been blasted onto Parliament for the whole of London to see."

#### French Protest Same Sex Couple Bill

Paris, France — The Reuters news agency reports French Prime Minister Lionel Jospin has been the target of a postcard campaign protesting a government bill that would provide benefits for same sex and unmarried heterosexual couples.

The French National Assembly will debate the idea on October 9. The bill is backed by Jospin's government and, if passed, would grant legal recognition to same sex couples.

In April more than a third of French mayors signed a petition objecting to the proposal. The government maintains that the proposal would not put same sex relationships on the same footing as marriages. The new law would forbid Gay couples from adopting children and from using artificial insemination to conceive children.

Reuters says that the proposal would give same sex couples the ability to file joint tax returns, share rights to common property, and give foreigners living with French citizens the right to claim residency after a five-year period.

The post card campaign has flooded Jospin's office with messages against the proposal. The campaign is being sponsored by The Future of Culture. The group says that the measure will "destroy the family." It claims that passage of the bill would "throw us back 20 centuries and destroy the remains of civilization that still separate us from barbarism."






#### **AIDS Walk Wisconsin Queen Crowned**



# Venturing OUT by Sasha Alyson

#### Discover Asia

Asia has long held an allure for travelers from the West. With the region now in economic recession, we have another reason to visit: The dollar buys much more than it did a year ago. Here are a few destinations to consider for a first-time visit.

#### Thailand

While planning our tenthanniversary trip, my boyfriend and I investigated Gay Thailand tours. The leading company, we learned, offers no discount for double occupancy: Everybody gets a double room to themselves, with an unspoken assumption that the other half of the bed will get filled soon enough. This didn't seem like the ideal arrangement for our tenth-anniversary vacation, but for other travelers, it will be just the ticket. (Tours to Paradise: 213-962-9169,

www.tourstoparadise.com) For many, that's the appeal of Thailand: Sex between men is legal, accepted and available. Most contact between visitors and Thais is commercialized in go-go clubs staffed with young "masseurs," who often identify themselves as straight - but flexible. Clubs with a more western-style Gay identity have opened in recent years like Bangkok's Telephone (114/11-13 Silom Rd., Soi 4, +2/234-3279) or DJ Station (8/6-8 Silom Rd., Soi 2, +2/235-1227).


The north of Thailand offers a sharp contrast to urban Bangkok. You can visit an ornate Buddhist temple one day, raft in the Himalayan foothills the next. The hill tribes provide a fascinating cultural counterpoint to the rugged scenery.

Southern Thailand is known for its exquisite beaches and islands. The best-known beach resort, Phuket, has become congested, over-built, and a prime destination for sex tourists. Instead, consider Krabi on the mainland, or the islands of Phi Phi and Samui.

#### Bali

One of Asia's most popular destinations is Bali, Beautiful beaches ring this verdant island. Some of the most luxurious resorts in the world are found along these shores.

Don't confine yourself to the beach. The striking river gorges of Bali's interior are popular with intrepid travelers. Ubud, a city in the middle of the island, is Bali's cultural capital, with shops and galleries featuring art and handicrafts. The interior also offers hiking, river rafting, a Monkey Forest and the Pura Dalem Agung temple.

#### Vietnam

The freshest travel destination in Asia is Vietnam, which fully opened itself to tourism only in the early 1990s. While lacking the sophisticated resorts of Bali, or the sexual openness of Thailand, Vietnam offers enormous natural beauty and a fascinating culture that has long been isolated from the world. Intrigued? This is the time to go, as it won't remain unchanged for long. Many hotels opened just as tourism dipped, so luxury rooms are available for under \$100 a night.

Ho Chi Minh City (formerly Saigon) in the south is the fast-paced capital. There are few venues at which you can meet Gays. One is Cafe 39 (Le Thi Rieng St., Dist. 5), outside the city center. Another is Dem Mau Hong Disco (Ham Nghi St.) in the city.

Saigon also offers enough other attractions, such as the Reunification Palace, to keep you busy. If the city crowds prove overwhelming, about 130 miles north of Ho Chi Minh City lies Da Lat, a Vietnamese honeymoon spot noted for its beautiful scenery and relaxing atmosphere.

Hanoi, in the north, plays little sister to Saigon, Its charms include the old quarter whose crooked streets and alleys contain thousands of vendors and artisans. A day trip from Hanoi, four hours southwest of the city, is the Perfume Pagoda, a Buddhist cave temple set deep in a fragrant forest.

The narrow center of Vietnam boasts two cities worth a stop. While in Hue, visit Thien Mu pagoda by riverboat. South from Hue is Da Nang and nearby China Beach.

Still undecided? Your travel schedule is a factor. October brings an end to the rainy season in Thailand and Vietnam; weather will be best from November into springtime, Bali's the opposite: The best months are May to September.

### From The Right Commentary by James McFarland

#### A Long, Hot, Uncomfortable Campaign Season

It looks like we are in for a long, hot and uncomfortable campaign season for Lesbians and Gays, especially for Lesbian and Gay Republicans. Within a week of the publishing of my last column, Rep. Frank Riggs (R-Calif.) announced he would introduce an amendment barring Federal housing funds to any municipality that required employers to provide domestic partner health insurance benefits.

While this amendment passed the House of Representatives recently, it should be noted that it passed with only a two-vote margin (214-212). More importantly, the House soundly defeated the attempt to overturn President Clinton's executive order banning discrimination on the basis of sexual orientation by a vote of 252-176. 63 Republicans joined 188 Democrats and 1 independent in opposing this measure.

This means that not only did the 30 or so moderate to liberal Republicans in the House vote against the measure, but they were joined by thirty-some mainstream conservative Republicans. In fact, notable conservative Republicans, including Rep. Dana Rohrabacher (R-Calif.) and Rep. Thomas Bliley (R-Va.), took the floor to oppose the measure.

While we are encouraged by the votes on these measures, the fact remains that the GOP leadership has and will continue to use Gay bashing to solidify its support from fundamentalist Christians. In my last column, I labeled this a dangerous gamble because it could alienate the mainstream swing voters in the suburban districts critical to Republican control. However, this may prove not to be such a dangerous gamble after all.

Why? Because voter turnout for this fall's election is expected to be at a record low. And the fact of the matter is that those mainstream swing voters are just not going to show up at the polls in any appreciable numbers. Both parties know this. Both the Democrats and the Republicans have foregone the traditional strategy of "moving to the center" during a general election to attract swing voters (after "moving to the right" for Republicans or "moving to the left" for Democrats in a primary election).

The new strategy, as outlined by an article in *The Wall Street Journal*, is to scare your party's voting base so much that they show up at the polls in larger numbers than their opponents. Thus, the Republicans, whose most reliable voters have been the fundamentalist Christians, will try to scare the bejeezus out of the fundies by charging that the Dems are promoting homosexuality and destroying family values, and by showing those voters that the GOP is willing to speak out and stop it.

The Dems, on the other hand, will try to scare the heck out of their most solid base, the senior vote, by charging that the GOP is going to destroy Social Security and Medicare by using the budget surplus from tax cuts for the rich. Of course, the truth will be sacrificed by both sides.

Thus, we can expect to continue to hear highly charged anti-Gay rhetoric from the GOP leadership all the way into November, and it will be very uncomfortable. What is the cause of this problem?

I'll be blunt. You, the readers, ask yourself this question: do you regularly vote in fall primary elections, or have you ever voted in a primary election? If the answer is no, then you have no one to blame but yourself for the fact that we increasingly see elections between farright Republicans and far-left Dems.

If you are one of the many Lesbians and Gays who tell me that they are fiscal conservatives but consider themselves Democrats, or usually vote Democrat because of GOP views on Gay issues, yet you do not vote in GOP primaries for Republicans with better views on Gay issues, you will be doomed to having to choose between a Republican who is a fiscal conservative but will make us feel like second class citizens by rhetorically attacking Lesbians and Gays, or a Dem who will do the right thing on Gay issues but will raise our taxes significantly.

We will not win all of these races. The change will not happen overnight, but the more we get involved in these campaigns, the more success we will have.

Personally, I long for the day when I will not have to worry that the candidates with common sense, when it comes to the economy and government spending, will prove themselves to be homophobic ignoramuses when it comes to Gay issues.





#### Billy's Hollywood Screen Kiss' Sean P. Hayes

If the tone of his debut feature Billy's Hollywood Screen Kiss is hard to describe, Sean P. Hayes has the synopsis down pat. "Boy meets boy. Boy wonders if boy is Gay or straight. Boy discovers boy is Gay. Boy is happy. Boy discovers boy likes another boy. Boy loses boy."

Over the phone from Los Angeles, where he has lived for many years, Hayes rattles this off without a breath, ending in a rollicking laugh. But his description eliminates a significant element of the story. Boy never really had boy. Boy's friends have been trying to tell him this. Does boy's problem sound familiar?

When Hayes's character, a photographer named Billy, first sees Gabriel (played by Brad Rowe), his slackjawed first words are, "That boy is too beautiful to be slopping coffee." From this attraction flow all of Billy's subsequent romantic dilemmas.

"It's such a simple story," says Hayes. "Billy just flips over Gabriel and not necessarily in the right direction."

Has Hayes himself ever flipped for a Gabriel? Or Brad? "It was wild passionate sex every day," Hayes says of his co-star, quickly adding, "No, no, no. None of that. Just kidding." None? "Brad and I are great friends. We had a lot of fun."

Hayes never intended to make acting his life's work but first performed at a very early age. "I went for my first commercial when I was a child," he recalls, his voice sliding from a happy shout to a gentle whisper. "I don't even remember the first one."

Hayes grew up in the Chicago suburb of Glen Ellyn. He credits his mother with teaching him to look at the lighter side. "She worked secretarial jobs, which are no glamour and lots of hard work. Still she raised all five of us alone — and with this amazing sense of humor. Sarcasm was how we dealt with everything. Then again, maybe that's being Irish and Roman Catholic."

Hayes studied piano performance at Illinois State University, where he hung out in the theater department "because music majors were so boring." After graduation he was the Music Director at a small Chicago theater, where

he directed and starred, alternately, in war-horses from Evita to West Side Story. Hayes also performed at venerated places like the Steppenwolf Theater Company and Second City.

"I think I was always an actor but couldn't acknowledge it," Hayes con-tinues. "I mean, I would find myself doing all these musicals! I would hear about people who made a living doing commercials, but it was a scary thing to let go of financial security and move to L.A."

It was no mistake. Hayes' brighteyed, all-American visage (which is winningly tweaked by its mustache and chin beard) has been featured in some highly visible TV spots. He won an industry award for a Residence Inn commercial. In a spot for Pepsi, which has burned stars far bigger and brighter than his, Hayes played a man who is unexpectedly pursued by a strutting supermodel at a cocktail party.

"Madonna!" Hayes screams when reminded of her infamous battle over aluminum cans and crosses. "I'd forgotten all about that. Wow! She couldn't pull it off, but I did! Just kidding." Go ahead, laugh. Stardom, as many a famous face can attest, has often been preceded by advertising gigs and supporting roles on TV series, the latter which Hayes recently landed as

Hayes will play Jack McFarlane, a Gay guy whose best boy friend is the title character of "Will & Grace," NBC's fall entrant in the Gay man/straight girl combo comedy sweepstakes. "I play the neurotic, bitter kind of best friend," Hayes quips. "As my reference, I use Tommy O'Haver."

Given the chance to retaliate, O'Haver said, "Believe me, Sean P. Hayes didn't need any lessons in being bitter or neurotic." But the director is also quick to sing his star's prais-

es. "Sean is a terrific actor," O'Haver

"And don't throw around compliments lightly. Just ask the rest of the cast and crew. And on top

of that, he's just the greatest human

Will Jack and Will get boyfriends on the show? "I don't know," Hayes says. "[The producers] want to stay away from shoving it down people's throats. The goal is humor, not to make a statement." Asked if he worried about having the same fate as Ellen, Hayes said, "I'm definitely not going to be a spokesperson for anybody. But as for Ellen and Anne, everybody just needs to relax. If Anne plays a murderer in a movie, is Ellen's life in danger? If Ellen loves a man in her next series, should Anne be worried?"

It's a good point, but one that assumes Ellen is allowed to have a next series. That requires - for heterosexual viewers in particular accepting openly Gay and Lesbian performers in all kinds of roles, which depends on Gay and Lesbian actors coming out. Even though he's playing two Gay roles in such close proximity, Hayes declined to talk about his personal life, including whether or not he had a romantic interest, and whether or not it was a man or woman.


Asked if he'd like to get some of the parts that major heterosexual actor like Kevin Kline and Liam Neeson have recently had, Hayes offers a qualified yes. "I don't want to get stuck in the world of Gay comedy. I'd definitely play another Gay role if the script was amazing. You're only as good as the role or the movie. I'd love to do something I haven't done, drama in particular." Although he's worried about being limited as an actor, Hayes thinks perceptions of Gay men and Lesbians are changing and that the entire question will eventually be irrelevant. "I think we're getting to a better point in society. At least I hope so."

### Billy's Hollywood Screen Kiss is Light, Amusing and Clichéd

Light as a feather and just about as emotionally and intellectually substantial, the Gay-themed Billy's Hollywood Screen Kiss is a flirty little film that has a good heart, but little staying power.

Billy (the cute-in-an-offbeat-way Sean P. Hayes) is a movie-struck photographer from the Midwest who has recently moved to L.A. looking for his "big break." The film begins with a series of Polaroid snapshots of and by the title character, as he introduces himself and amusingly "confesses" the fact he's Gay. He's also a romantic, still looking for the "man of his dreams." (Join the club, honey!)

One day, while in a trendy coffee shop with a gal pal, an adorable waiter pops over and Billy's enraptured. The new object of his attention is Gabriel (Brad Rowe), a gorgeous blonde boy blend of Brad Pitt and Rob Lowe circa 1985.

But Gabriel's sexuality remains obscure (Don't you just hate that!), and Billy becomes increasingly dismayed as Gabriel keeps bringing up his girlfriend in San Francisco and lacks, as Billy calls it, the "show tune

Still, as Billy's friend and "big sister" Perry (Madison native Richard Ganoung) remarks, "Every once in a while, you get a vibe." We follow Billy's adventures with hunky Gabriel, as the latter keeps himself tantalizingly available without ever committing himself to a specific sexual orienta-

Writer-director Tommy O'Haver calls Billy's Hollywood Screen Kiss "a trifle," and that it surely is. Little more than a Gay-themed slice-of-life, it's flyweight and, frankly, all too familiar.

We've seen Billy before in several Gay romantic comedies: the lovelorn nice guy who falls for the seemingly unattainable, enigmatic hunk. The title comes from Billy's obsession with classic Hollywood screen kisses and his photo shoots recreating them, but involving lovely lads and drag

The narrative is, however, bogged down by several intrusive, overlong and only mildly amusing moviethemed dream sequences featuring a trio of overacting, lip-syncing drag

Billy's Hollywood Screen Kiss is likeable and unthreatening, but nevertheless disposable and clichéd. And for those of us often finding ourselves in Billy's shoes, don't expect to find many nuggets of wisdom... you're on your own here, girlfriends! Billy's Hollywood Screen Kiss opens in September at the Oriental Theatre.

#### Driver Fails to Engage Us as The Governess

The only thing that's truly kosher in The Governess is its heroine, and that's just because she's a 19th-century Jew. This mixed-up movie attempts to deliver a treatise on religious intolerance and a dollop of proto-feminism within the context of a tawdry love affair. Nice try, but on the whole, it just doesn't hold together.

Minnie Driver stars as Rosina da Silva, who lives in 1840s London. When her father (Bruce Myers) is murdered, the family is plunged into debt. Rather than go through with an arranged marriage to a wealthy but elderly fishmonger, Rosina decides to take the high road — to Scotland.

In order to get a job, she must hide her true heritage. In the film's wittiest scene, she gives herself a good Christian name, "Mary Blackchurch." She then accepts a position as a governess with a wealthy family, the Cavendishes, who live on a remote

Thus the elements are in place for a fascinating fish-out-of-water story. How will this Jewish girl from the city cope with a situation that's not only foreign to her (everything from ham for dinner to Sunday church), but could have serious consequences should she be discovered?

Instead and unfortunately, Writerdirector Sandra Goldbacher chooses to explore Rosina's growing interest in Mr. Cavendish (Tom Wilkinson of The Full Monty). He is a self-absorbed pioneer in the early study of photography. At the same time, she must fend off the rampaging hormones of the gorgeous, young Cavendish boy, Henry (Jonathan Rhys Meyers).

The movie's tone lurches from deadly solemn — the Cavendishes' offhand anti-Semitism — to inadvertently humorous. Driver acts herself almost to death. She's clearly an ambitious performer, and this is her first real lead since Circle of Friends, her breakthrough film. But Driver's approach to her often unsympathetic character is ultimately off-putting due largely to her overwrought exertions. Plus, for every compelling scene, there are half a dozen that just don't work. What's left is an over-busy film with under-realized potential.

The Governess opens Friday, August 21 at the Oriental Theatre.

#### Simon Birch: A Tearjerker

As the opening credits rolled for Simon Birch, Glenn's attention was caught by the credit which rather intriguingly stated that the film about to unfold before this packed cinema was "suggested by" the novel A Prayer For Owen Meany by John

"Suggested by" the novel... Glenn pondered this concept for awhile and remains utterly clueless as to what that curious phrase actually means. Is it the same story? Will the characters from the novel appear in the film? Has Hollywood forced upon John Irving a cinematic happy ending he finds dis-

So many questions, so few answers. How like life.

So what about Simon Birch? Well... Simon Birch is just probably the most shamelessly manipulative tearjerker Glenn has even seen. More shamelessly manipulative than It's a Wonderful Life? Yep.

It comes as no surprise that the climax to Simon Birch occurs in the days following Christmas.

Simon Birch (Ian Michael Smith) is a tiny twelve-year-old. Virtually disowned by his uncaring, slovenly parents, Simon has been betriended by Joe (Joseph Mazzello) and Joe's mother Rebecca (Ashley Judd).

Simon is an obvious outsider in the rural small town in which he lives, due to his size. Joe, too, is an outsider because he is a bastard. Mom, Rebecca, remained unmarried and has refused to tell Joe who his real father is until he's ready.

The relationship between the two

boys is more like that of brothers than best friends. This situation is strengthened by the fact that Rebecca has taken Simon under her wing, acting more like a mother to the boy than Simon's own mother.

Through the course of the film, each boy is on a quest — Joe to find his real father, Simon to find that higher purpose he believes God has for him.

Like a particularly barbarous installment of Touched by an Angel, Simon Birch is a peculiar mix of faith and friendship, death and betrayal. In the course of a few short hours, Simon and Joe are subjected to such tragedies and moments of deepest despair, that only the most cold-hearted in the audience won't find themselves wiping away the odd tear.

If only writer-director Mark Steven Johnson could have been a bit less ponderous, trusting his audience to respond naturally to Joe's and Simon's story without the repeated use of cinematic emotional sledge-hammers. And if only cute little Joe didn't grow up to be Jim "I'm a Serious Actor Now" Carrey.

And yes, Glenn did wipe away the

All six cast members (Kevin Bosley, John Ferguson, Lauri Harty, Kathleen Martin, Stephanie Turner and Joe Wiener) give strong performances on Broom Street's barren, deconstructed set.




The other big event is AIDS Walk Wisconsin on September 20. Keep in mind that the AIDS crisis is not over, not by a long shot.

journalist who decides to learn about the discrimination faced by "homosexuals" after watching the evening news, begins with a child-like enthusiasm. Leaving wife, family and friends, Griffin seeks to understand the Gay world through hormones and Billy-doll costumes.

Bosley escorts Griffin through that world. He allows the struggle faced by the closet heterosexual to illustrate heterosexual privilege and its accompanying paranoia, while reflecting the agonies of repressed identity.

Two women show the extremes of Griffin's seesaw world: his wife, Mary, portrayed by Stephanie Turner, and a radical Lesbian, Silver Eagle, played by Lauri Harty. Each woman understands oppression in ways that Griffin can't. Their parallel experience brings perspective to Griffin's single-minded crusade.

Mary is an abandoned wife who struggles to find her own answers to the questions her husband has left her to find. Her quest leads her to medical "experts" and desperate religious tenets, as she tries her best to become a part of what she believes to be mainstream morality.

Turner plays Mary with an annoying whine. But her portrayal of a woman determined not to be victimized while playing into every conventional form of victimization is ultimately sympathetic, as she reveals Mary's slowly increasing desperation.

L'auri Harty's Silver Eagle angrily protests a world that has her lover performing in a strip club, even while she lives off of her lover's income. One against the world, she carries signs and a chip on her shoulder as she tries her best to bring justice to an unjust world.

Harty is gruff, with convincing emotional barriers against a world her character battles daily. When the barriers slip, she allows Silver Eagle to be momentarily vulnerable, and her fearful hope to be glimpsed. But Harty then quickly hides Silver Eagle's "weakness," remaining loyal to her character's basic distrust of other people.

For many queer Madison audience members, Gay Like Me acts as a partial catharsis of emotions raised from the past few months' anti-Gay activities in the city. Director-writer Harty based several scenes on recent local anti-Gay events and personalities.

Griffin's journey from wide-eyed PC idealism to his saddened, yet determined pursuit of justice reflects the journey that Madison has made as a community. Queer and straight together, we have recognized, exposed and denied the hate in our midst.

But in the process, we have lost our innocence. Our lives have changed. Like Griffin, we are left to pick up the pieces of an illusion of safety and equality, while trying to learn how to face a world suddenly more hostile than we had believed it to be.

Gay Like Me is currently playing at Broom Street Theater, 1119 Williamson Street, at 8pm on Fridays, Saturdays and Sundays through September 6, 1998. Tickets cost \$7. For more information, call (608) 244-8338.

What better time than as the third celebration at the Summerfest grounds approaches to reflect for a moment on just how far the LGBT community has come since those celebrated drag queens fought the police for the Stonewall Bar way back in 1969!

Many wonderful non-fiction titles have found their way onto Gay Bookstore shelves this past summer, from fascinating biographies to revealing histories and books that explore the many aspects of our diverse community.

Hot off the presses comes The Pleasure Principle by Michael Bronski (St. Martin's Press, HC \$24.95). Subtitled, Sex, Backlash and the Struggle for Gay Freedom, here controversial critic and commentator Bronski explores mainstream America's curious fascination as well as its deeprooted fear of Gay culture, resulting in the continued political struggle for the most basic of human rights!

Utilizing hundreds of personal interviews and archival sources, John Loughery has traced the impact of homosexuality on this century's turbulent times in The Other Side of Silence (Henry Holt, HC \$35.00). Exploring beyond the stereotypes of isolation and victimization, Loughery reveals Gay men as accomplished participants in some of the century's most


monumental dramas, including such figures as Harry Hay, Harvey Milk, Michael Callen and many other littleknown activists.

In Together Forever (Anchor Books HC \$23.95), Eric Marcus takes the reader on a journey across America to meet and speak to forty deeply committed, happy Gay and Lesbian couples and asks them how they've managed to accomplish what many think impossible - staying together. What he found out may or may not surprise - that Gay marriage is a messy, complex, wonderful, indescribable and very, very rewarding.


Another fascinating historical work is Improper Bostonians (Complied by the History Project Beacon HC \$30.00). Fun, often surprising and magnificently illustrated, Improper Bostonians depicts the last three centuries of Gay and Lesbian Boston the American city with the longest recognized history of Gay and Lesbian life. Improper Bostonians introduces us to men and women who flouted conventional gender rules, were unapologetic about their lifestyles, and tried to make sense of their sexuality - sometimes at great cost.

A former Mr. Universe, Bob Paris is one of the most visible and widely sought-after motivational speakers. In Generation Queer (Warner HC \$23.00), Paris breaks new ground in a revelatory look at what it means to

be young, Gay and out in the age of liberation.

Another biography of particular note is The Queen of Whale Cay by Kate Summerscale (Viking HC \$21.95). British eccentric Marion "Joe" Carstairs (1900-1993) was a world-class speedboat racer, ruler of her own Caribbean Island... and a cross-dressing Lesbian. During the permissive 1920s, Carstairs was able to flaunt her taste for women in the bohemian circles of London and Paris.

Come Pride season, many couples begin to think about commitment ceremonies. Paula Martinac's The Lesbian and Gay Book of Love and Marriage (Broadway Books Pb \$18.00) is a crossbreed of a book that offers knowing, humorous insights on love in the Gay lane. Crossing romantic advice à la "Dear Abby" ("Meeting Ms. Right") with practical tips on Gay weddings that would make Martha Stewart proud ("Right in Your Own Backyard"), Martinac has assembled a book that is both frank and funny as well as practical and political.
