

Congresswoman Baldwin: The Interview

The last time I sat alone with Tammy Baldwin in her office, she told me that she was preparing to run for Congress in Wisconsin's Second District. Nearly two years and a hard campaign later, I am again in Tammy Baldwin's office, but it is not the State Capitol office of a State Representative. It is Room 1020 of the Longworth House Office Building, the office of America's first openly Lesbian Congresswoman. It is the day after she was sworn in as the Congresswoman from Wisconsin's Second Congressional



WI Light How do you feel about the history you've made?

Tammy Baldwin It's hard to express. It's other people who demonstrate to me how important it is to them. Sometimes watching a tear well up in the corner of someone's eye or seeing outright expressions of joy. I feel thrilled, especially because I feel that it touches so many other people. I was moved by the presence of a wide range of people here. Some I hadn't seen in years. Having my partner and mother here plus college friends and high school friends was very special to me.

WI Light Did you always believe you would get here?

Tammy Baldwin I never doubted that I could win but I certainly doubted that I would win. You're trying to do everything right and not make mistakes and missteps. While you can't control all of that, you can control some of it. I think we did a very effective job. The magnificence of the campaign had a lot to do with the youth movement. The headline the day after the primary was "Youth Quake."

WI Light Some students waited in line for two hours after the polls closed so they could vote for you. How did you feel

Tammy Baldwin I felt great. I wanted to yell from the mountaintops, "Don't ever ignore the students again."

WI Light After the election was over, Governor Thompson credited you with re-electing Russ Feingold to the U.S. Senate. He said Russ should take you to lunch every week. So has he?

Tammy Baldwin We had a lovely lunch after the election. Russ and I consulted and we figured that we ought to go out to lunch with Tommy because we got about a third of his vote. We should just go to dinner and split the bill. (Laughter)

WI Light Have you found a place to

Tammy Baldwin I have a temporary place to stay. Every time I come to Washington D.C., two times since the election, I have a goal of finding a permanent place, but my time gets swallowed up. Tomorrow, I am taking most of the day to keep looking until I find something. I have a month-to-month rental


WI Light Is the workflow what you expected?

Tammy Baldwin There is so much coming. It is dramatic to see the bundle of mail come every day to this office and think about how our day-to-day workload is going to be quite intensive. Yesterday was my first day of floor sessions. It was fabulous to have that sense of history when I walk into the chamber and think about who've I read about, who's been

WI Light You are the first openly Gay person to win a first term in Congress. Are you concerned that some LGBT people are going to expect too much from you?

Tammy Baldwin No, I look at the progression of the Gay and Lesbian civil rights movement. I think we are a much more sophisticated movement by now. Certainly there will be some who would like me to use this position in a way other than the way that I plan on using it.

It's not so much a question of floor speeches as it is a question of national accessibility. As I have said a number of times since the election, I have to develop and strengthen the relationship I have with the people of the Second District. I was happy to win the election but I didn't win in a landslide victory. I have to make sure that first and foremost I represent well the people who sent me here.



Then there's the substantive impact. There will be legislation that impacts Gay and Lesbian people, hopefully ENDA and Hate Crimes legislation. There will be anti-Gay legislation that will come to the floor and I will participate in those debates.

Finally what I view as the most important impact of all is that I can touch the hearts and change the minds of mainstream America. If people can see me as a hard and effective worker on health care reform or social security reform and know that I happen to be a Lesbian; that will do more to change the hearts and minds of people. They will know that a Gay person worked really hard for them on an issue that affects their everyday life.

WI Light Wisconsin Congressman Tom Petri may be one of those whose mind you can change. Here's a conservative Republican who has said he wanted to outlaw homosexuality. Were you surprised to see him at your reception yesterday?

Tammy Baldwin I was delighted to have him stop by and greet me. I never met him before. We are going to be part of the delegation representing Wisconsin. I thought this was a marvelous gesture on his part to welcome me to this new role.

WI Light You had a six-year tenure in the State Legislature. What are you most proud of doing there?

Tammy Baldwin Several things, some are actual passing of legislation, sometimes it's fighting back against legislation successfully. In other respects, it's the relationships I was able to develop.

In the last session we passed the first piece of campaign reform legislation in four years. We did it at a time when everyone was talking about it but nothing was getting through. It was because the par-

tisan divisions on that issue are so strong. I worked with a fellow by the name of Scott Walker, a Republican, to really craft something that was an important first step on campaign finance reform and detailed elec-

for nursing

home workers passed. My Grandmother is in a nursing home. That's very important to me. Those who report elder abuse should not be fired from their jobs for making waves. They should be encour-

WI Light You have been given assignments on the Budget and the Judiciary Committees. People say that's pretty impressive for a freshman. Was this a sign of respect from the leader-

Tammy Baldwin The committee appointments are made by a 44-member committee. When I finished the campaign, and the results were in, let me tell you, I was a little shocked to learn that I had to wage another campaign to get on the committees I wanted to serve on.

WI Light Are those the committees you wanted?

Tammy Baldwin Let me explain. There are a few committees called exclusive committees such as Appropriations, Ways and Means and Commerce, that by and large, freshmen never get on. Everybody in the freshman class listed one of those committees as their first choice, as did I, because you want to be recognized as seeking them.

Baldwin at a Glance

1980 - Baldwin graduates from Madison High School, where she was elected to the Homecoming court.

1984 - Tammy Baldwin graduates from the prestigious Smith College with a double major, mathematics and politi-

April, 1986 - Baldwin rolls up 92% of the votes and is elected to the Dane County Board of Supervisors. She will be easily re-elected to three more two-

November, 1992 - Baldwin becomes the first ever openly LGBT person and the youngest woman ever to win a seat in the Wisconsin State Legislature. Baldwin fights off a strong challenge in the Democratic primary and then cruises to a landslide victory in the general election. She is re-elected to two-year terms in 1994 and 1996.

March, 1997 - Baldwin tells Wisconsin Light that she is considering a campaign for Congress. The frontpage story helps to generate excitement in Wisconsin's LGBT community. "Run Tammy Run" buttons begin appearing everywhere in Madison.

June, 1998 - Baldwin officially announces her candidacy with a call to the voters to ignore the special interests. "We are Americans," she says. "In America the people decide what is pos-

September 8, 1998 - Baldwin wins the Democratic nomination to Congress by a narrow margin. Her opponents, former Dane County Executive Rick Phelps and State Senator Joe Weinecke, immediately endorse her.

November 3, 1998 - Baldwin makes history becoming the first Wisconsin woman and the first open Lesbian ever elected to Congress. She defeats Republican Josephine Musser by a margin of 54% to 46%.

January 6, 1998 - Baldwin is sworn in as the Congresswoman from Wisconsin's Second District.

Inaugural Highlights

The Parties

Tammy Baldwin held a swearing in party at the Rayburn House Office Building, where supporters watched the ceremony. It was not her only "inaugural event." Over 200 of Washington's LGBT political elite and supporters attended the Victory Fund fundraiser, held in Baldwin's honor, at the elegant D.C. mansion of general contractor Bruce Johnson. The minimum donation was \$40. The event sold out.

On the evening of January 6th, an invitation only party was held at the Union Station Capitol City Brewery. A packed house was on hand for that as well. (For more on the Baldwin parties see Dusty After Dark.)

Surprise Guests

Two of the guests attending the Baldwin swearing in party were somewhat of a surprise. Conservative Republican Congressman Tom Petri (R-WI) came and brought Republican moderate Congressman Steve Horn (R-CA) with him. Just a few years ago, Petri told a national student group that he would like to outlaw homosexuality. In 1996, Gay activist Rick Zbur opposed Horn in his bid for re-election.

Jon Nichols, editor of Madison's Capitol Times, told Wisconsin Light he felt Petri's presence was a good sign.

He said Baldwin's election would make it more difficult for Petri to vote against pro-Gay civil rights legislation.

Privately, several moderate Republicans asked if Baldwin would be receptive to working with them. For some, their concern stemmed from the Gay Log Cabin Club's opposition to Baldwin's election. Baldwin has a reputation for working with members of the opposition party.

Home Boys and Girls

Madison Mayor Susan Baumann came to D.C. for Baldwin's inauguration. The Mayor, a former schoolteacher, taught eighth grade Algebra to the future Congresswoman. Baumann is very popular among Madison's LGBT community. Her support of Baldwin is likely to strengthen the affection that LGBTs have for her.

Dane County Executive Kathleen Falk also received

substantial LGBT support in her campaign but was Mayor Susan Baumann not in D.C. for the festivities.

When asked about this, a Dane County politician would only say, "Mayor Baumann is very attentive to her constituencies." Falk endorsed Baldwin opponent Rick Phelps in the Democratic primary.

Other politicians on hand included Wisconsin's Democratic Congressmen Tom Barrett, Gerald Kleczka, Ron Kind, David Obey and newly elected State Senator Tom Erpenbach.

Kleczka told Light that Baldwin's election was historic because she is the first woman sent to Congress by

Wisconsin. When reminded that she is also the first open Lesbian in Congressional history, he nodded and said that was important too. Kleczka also said he was impressed with Baldwin's committee assignments. "She is on two very important committees, Budget and Judiciary. A lot of people wait for years to get on the Budget committee," he said.

First Vote

Tammy Baldwin cast her first vote in the House even before she was sworn in. She voted for Richard Gephardt (D-MO), the Democratic House leader, in the election of a new Speaker of the House. The vote is taken prior to swearing in of the new

As the roll was called, the Baldwin party got quieter as those in attendance waited for her name to be called. When it was announced, Baldwin stood up and said "Gephardt" to the cheers of those at her Swearing In Party. The majority Republicans successfully elected Congressmen Dennis Hassert (R-IL) Speaker.

Bipartisanship?

Following Hassert's election as Speaker, and due to the intense rancor of the House impeachment debate, both Gephardt and Hassert appealed for bipartisanship. The good feelings were, however, short-lived. In one of its first votes, the new House considered a motion to send managers to the Senate with articles of impeachment against the President. Nearly every Republican voted yes and nearly every Democrat, including Baldwin, voted no.

Security Tight

Security is tight in Washington, especially in congressional buildings. Following the bombing of Iraq last month, a wall with paintings of trees and grass was erected alongside part of the Capitol Building. It prevents cars from getting too close.

Every entrance to the Capitol and Congressional office buildings has a metal detector staffed by Capitol Hill Police officers.






Governor Barrett?

Conventional wisdom has it that Wisconsin Governor Tommy Thompson will not run for a fifth four-year term. Speculation about who might succeed him in the 2002 election started even before the vote counting in November's election was completed.

Wisconsin will almost certainly lose a seat in Congress after the next census. Many observers think that one of Milwaukee's two Congressmen will lose their seat when this happens. Naturally enough, many politicos assume that one of them will run for Governor.

The speculation is that highly respected Fifth District Rep. Tom Barrett & Congressman Tom Barrett will run for the State House. Barrett has a 100% rating on LGBT issues from the Human



Rights Campaign. When asked about the possibility of running for Governor, Barrett didn't confirm or deny that he is considering making the race. He did say that whatever move he makes will be done after he has consulted with his family.

Ryan Says Probably Not

Before the election, Wisconsin Light tried to get Paul Ryan's campaign to tell us how he stood on LGBT issues. We never got a response. As he came out of the House chamber following his swearing in, we were there to ask him if he would support ENDA, the Employment Non-Discrimination Act. Ryan succeeds Congressman Mark Neumann, who had a 0 record of support on LGBT issues, according to the Human Rights Campaign.

At first Ryan said he wasn't sure if he would support the bill or not. When told what the bill would do he responded, "I probably won't vote for that." Some think Ryan, who has been described as a "Neumann clone without the harsh edges," will run for the U.S. Senate in six years.


Hate Crimes Lobby Day a Bust

Grass roots activists called for a "Hate Crimes Bill Lobby Day" to be held on January 6, the same day that the House of Representatives was sworn in. Several national organizations endorsed the idea but not without reluctance.

Privately some national staff people said they could have and would have offered more support had the "lobby day," been scheduled for a better time. Most of Congress was busy with swearing in ceremonies, parties, and the impeachment process.

Another problem was the organizer's insistence on calling the Hate Crimes Act the "Matthew Shepard Hate Crimes Act." The Human Rights Campaign has been hard at work lining up the support of other civil rights groups for the bill, some of whom may be offended by what could be viewed as a Gay attempt to co-opt their bill.

One staffer said that he resented the lobby day organizers "just coming in and telling us to drop everything, rearrange our schedules and plans, and help them."




He did get to talk to Baldwin and Congressman Barrett (D-WI) about the hate crimes bill during a Baldwin party. Both immediately said they would support it. When told that Schuster may be one of the few, who came for the Lobby Day, to actually get support lined up, Barrett, who is a co-sponsor the act, said "Tell them I was a tough sell," generating laughter all around.

Poor Newt?





AROUND THE STATE

HRC Issues Scorecards for 105th Congress

Milwaukee — Wisconsin's congressional delegation as a whole gets only a 50% rating from the Human Rights Campaign's 105th Congress scorecard.

Wisconsin's five Democratic representatives fared far better on the HRC rating system than its Republican ones did. Led by Milwaukee's Tom Barrett, who was rated 100% on LGBT issues, the cumulative score for Wisconsin's Democrats was 82.5%. The most highly rated Republican, Madison's Scott Klug, scored 25%. The cumulative rating for Wisconsin's four Republican Congressmen was 15%. Two Republicans, Petri and Neumann, received 0 ratings from HRC.

The Scorecard:

1. Co-sponsorship of the Employment Non-Discrimination Act

All 435 members of the House were asked to co-sponsor legislation prohibiting anti-Gay discrimination in the workplace. Introduced on June 10, 1997, H.R. 1858 has 157 cosponsors including Wisconsin's Representatives Kind, Barrett and Johnson

2. Co-sponsorship of the Hate Crimes Act

All 435 members of the House were asked to co-sponsor legislation extending federal jurisdiction over serious, violent hate crimes committed against LGBT Americans. Introduced on November 13, 1997, H.R. 3081 has 163 cosponsors including Wisconsin's Kind, Klezcka, Barrett and Johnson.

3. Non-discrimination Office Policy

Representatives were asked to voluntarily adopt a written policy for their congressional offices indicating that sexual orientation is not a factor in their employment decisions. A total of 249 representatives have adopted this policy including all of Wisconsin's Congressmen except for Petri and Neumann.

4. Funding Ban for Needle Exchange Programs

Rep. Gerald Solomon, R-N.Y., introduced a bill that would permanently ban federal funding for local needle exchange programs. On April 29, 1998, the House passed H.R. 3717 by a vote of 287 to 140. HRC opposed passage. Wisconsin Congressmen Neumann, Klug, Kind, Klezcka, Petri, Johnson and Sensenbrenner supported the ban; Barrett and Obey did not.

5. Domestic Partnership Benefits

HRC opposed the Riggs amendment to the Veterans Affairs, Housing and Urban Development appropriations bill. Riggs would have prohibited any federal housing funds from being used to implement a San Francisco ordinance requiring private companies doing business with the City to provide health care benefits to unmarried domestic partners of their workers. Riggs passed on July 29, 1998 by 214 to 212. Eight representatives did not vote. Wisconsin Congressmen Neumann, Klug, Petri and Sensenbrenner supported Riggs; Kind, Klezcka, Barrett, Johnson and Obey voted against it.

6. AIDS Housing Funds

Rep. Van Hilleary, R-Tenn., introduced an amendment to the Veterans Affairs, Housing and Urban Development appropriations bill to take \$21 million from the Housing Opportunities for People With AIDS (HOPWA) program. This amendment passed the House July 29, 1998 by a vote of 231 to 200. Three representatives did not vote. HRC opposed this amendment. Congressmen Neumann, Klug, Petri, Johnson and Sensenbrenner supported it. Congressman Kind, Klezcka, Barrett and Obey were opposed.

7. Federal Job Discrimination

Rep. Joel Hefley, R-Colo., introduced a measure to gut President Clinton's executive order prohibiting discrimination based on sexual orientation in federal employment. The amendment was defeated August 5, 1998, by a vote of 176 to 252. Six representatives did not vote. HRC opposed this amendment. Congressmen Neumann, Petri and Sensenbrenner voted in favor, while Klug, Kind, Klezcka, Barrett, Obey and Johnson were opposed.

8. Gay Adoptions in D.C.

Rep. Steve Largent, R-Okla., introduced an amendment to the District of Columbia appropriations Bill to deny couples in the District of Columbia not related

by blood or marriage from jointly adopting a child. This amendment passed August 7, 1998 by 227 to 192. Fifteen representatives did not vote. Congressmen Neumann, Klug, Petri and Sensenbrenner supported the ban; Kind, Klezcka, Barrett, Obey and Johnson opposed it.

AROUND THE NATION

Passages on Gay Holocaust Deleted from Book

Atlanta – As reported in the Atlanta Journal-Constitution, The Georgia Commission on the Holocaust deleted two paragraphs describing the Nazi persecution of Gays from the 92 page Holocaust guide it distributes to high school and middle school teachers around the state.

The Commission's decision to remove the paragraphs caused a firestorm of criticism from at least some of the businesses and individuals that fund its work. The law firm of Holland & Knight, which sponsored the publication in three states, objected so strongly that it's paying \$14,000 in plate charges so the material can be included in later press runs.

Sylvia Wygoda, Director and Chairperson of the Commission defended the decision. She said that the deleted content was not necessary to the book and that "it is not our place to put sexually graphic material into the schools."

Wygoda points out that the Nazi persecution of Gays and Lesbians was mentioned in four other places in the guide.

Others disagree. Henry Knox of the Georgia Equality Project said, "The language is horrifying but everything about the Holocaust should horrify us. Erasing persecution of Gays from the history of the Holocaust repeats the tragic silence of most Germans in the Nazi years."

The deleted paragraphs, which appeared on two different pages of the text, read as follows: "German male homosexuals were targeted and arrested because they would not breed the master race: they were an affront to the Nazi macho image."

"The doors of the third [cattle] car open and the homosexuals spill forth, males only, because as Himmler concluded, 'Lesbians can give birth.' The taunting jeers and blows of the guards stun the men. They will stay a night and then be rerouted to Sachsenhausen and Buchenwald to be with their kind. The pink triangle they will soon wear is a result of a judgment that they have broken Article 175A, by sexual act, by kissing, by embracing, by fantasy and thought. Some will be given an opportunity to recant by successfully completing sexual activity with a woman in the camp brothel. Most others will find themselves tormented from all sides as they struggle to avoid being assaulted, raped, worked, and beaten to death."

Domestic Partners Law Winning Support

Honolulu – The Honolulu Star-Bulletin reports that some proponents and opponents of same sex marriage have found they agree on Governor Ben Cayetano's proposal to give LGBT couples benefits similar to those enjoyed by legally married couples.

The plan does not include the right to adopt or parent children. Jack Hoag who helped to lead the successful effort to pass a constitutional ban on same sex marriages, after it appeared that Hawaiian courts would rule them legal, said that he supports the proposal. Hoag said the majority of Hawaiians would object to the plan if it included the right to adopt.

On the other side, civil rights attorney Dan Foley, who represents the same sex couples suing for the right to marry, also supports the Cayetano proposal. "I can't have everything I want when I want it. I'm a big boy. I know that," said Foley, who contends that there is no legal or factual basis to withhold adoption and parental rights from Gay couples.

"We're still pursuing full equal rights in the courts; you can't bet anything on what the courts would do," Foley added. "But the governor's bill would be a major step forward. If it is adopted by the Legislature, it would move the state forward in treating Gays and Lesbians equally."

Cayetano's bill would replace the reciprocal benefits law passed in 1997. That law gave unprecedented rights to same sex couples, but also included any two people who were living together even siblings, friends and blood relatives.

Not everyone is pleased with the proposal. Mike Gabbard, another foe of same sex marriage, says he sees domestic partnerships as another name for Gay marriages. "Let's get down to the main business at hand and fix the economy and get off of this stuff," said Gabbard.

Arkansas Vote to Ban Gay Foster Care

Little Rock – The Child Welfare Agency Review Board has voted to ban Gays and Lesbians from becoming foster parents. The vote makes Arkansas only the second state to take such an action.

The vote was held without allowing dozens of people who opposed the ban an opportunity to testify. Board member Robin Woodruff, who introduced the proposal in June, said hearing from the public was unnecessary because the board has held open meetings on the issue in the past few months and has received extensive written information.

In order for the new policy to become official, the agency must hold hearings and take comments from the public for at least 30 days. It will then submit the policy to the Arkansas Legislative Council, which can hold another hearing before the new rule is implemented.

New Hampshire is the only state to forbid Gay foster parents. Earlier this month, a bill to repeal that ban was introduced in the New Hampshire State Legislature.

Bishops Win Suit against Anti-Gay Group

Newark NJ – A conservative Episcopal group that was using the church's name to promote an anti-Gay agenda has agreed to stop the practice after a group of liberal bishops filed suit. The group headed by Wisconsin Bishop William C.

Wantland used the name Protestant Episcopal Church in the United States of America on its web site.

Wantland helped lead an effort to ex-communicate retired Bishop Walter Righter because he ordained an openly Gay man. Wantlands' group also opposes the ordination of women.

Shepard Suspect's Mother Dies

Laramie WY – The mother of Russell Henderson, one of the two men accused of murdering Gay University of Wyoming student Matthew Shepard, was found dead of hypothermia. Mrs. Cindy Dixon was found lying alongside a two-lane highway dressed in a shirt, jeans and windbreaker after a night when the wind chill factor dipped to 30 below.

Media reports say that Mrs. Dixon was last seen staggering from a Laramie bar. Although there were no signs of bodily injury, Laramie police say they are investigating the death as a homicide. Police believe that Dixon was driven about 12 miles out of town by an unidentified man. They say she tried to make it back to Laramie but was unable to do so.

Suspicions are focusing on Dixon's husband, Charles. He has been charged with beating his wife on three separate occasions, the most recent being November 4 of last year.

Late last year, prosecutors announced that they would seek the death penalty against Henderson and James McKinney in the Shepard murder case.

The Party's Over

New York – The Gay Men's Health Crisis, GMHC, has announced that it is pulling out of the controversial Fire Island Morning Party. The party, which last year raised nearly \$500,000 for the group, has raised concerns because of illegal drug use and unsafe sex practices by many of those in attendance.

Last year, over 5,000 men paid at least \$100 each to be at the event. Twenty-one of them, including the GMHC staff member in charge of efforts to keep the party drug free, were arrested for illegal drug use. The decision comes at a time when GMHC is facing declining revenues. Fund raising revenues dropped from \$31mil-

I chose Commerce because that is a committee where you can do a tremendous amount of work on health care reform. I am delighted with the assignments I got. I had to lobby quite a few people to get them pushing for me.

WI Light Your inauguration was an historic event but not the only one going on here. Had you been there in the last Congress, would you have supported the articles of impeachment against the President?

Tammy Baldwin I probably would have voted against the articles of impeachment. That's based on my experience as an attorney more than anything else. I look at this as a very serious matter. We have constitutional responsibilities to figure out what is the right thing to do.

I also recognize that the founders of the constitution gave Congress, not a grand jury or a judicial branch, the responsibility of passing articles of impeachment. I think Barney Frank actually talked about this right before the vote.

You know that was done for a reason because Congress is a political organization. We do represent the views and the hopes and dreams of people. There was a political aspect to that vote as well as a factual judicial process. I would have voted against the articles of impeachment. Yesterday I voted against sending the House managers to the Senate.

My time is up but I ask if there is anything Congresswoman Baldwin wants to say to Wisconsin's LGBT community. There is. "Thank you for working so hard and for your extraordinary support," she says. "Thank you for believing it was possible."



Confronting Today's Mental Health Services Problem

All my professional career has been a wonderful experience, and I had planned that with increasing experience I would live in a world where everyone could, if needed, get help at any time they felt they needed it. Well, the reverse has happened; today only the affluent and a few with really good health insurance can get what they need provided by professionals with good training, experience and a humanistic approach.

The Health Maintenance Organizations (HMOs), along with most of the other insurance companies, have gone for the bottom line to the max; profit is everything, so that getting sufficient help by the right kind of professional health care provider is less and less possible. What follows, then, is honest - but due to these difficult times, unfortunately too

Most people in this country expect at least fairly good medical care (not, of course, the 43 million or so who have no health insurance) and, as we so often hear via the media, we live in a place where medical care is the best in the world. Well, if the lack of good mental health care is included, forget the U.S. having anywhere near the best care of all. It is just not so.

As today in physical medicine, mental health coverage today is mostly: Take a number; wait in line; and all your records are computer-available. (Privacy in organized health care is a thing of the past, and sexual discussions can and are accessed by anyone who knows the right numbers to punch!)

One of the most significant problems relates to the inability of many mental health professionals to treat people with "alternative lifestyles," i.e. LesBiGay-Trans. Many professionals in this country treat straights, but with the reduction in patient referrals, lots of these same professionals now will attempt to treat individuals with problems they have never treated before and, sometimes at least, are not themselves emotionally too well suited to handle.

While all individuals seeking professional help should check into the qualifications and expertise of those they call to discuss making an appointment, if you aren't straight, the problem is more complex. I recommend shopping around on the telephone and getting a brief free face-to-face introductory session. Such a session can be very helpful in avoiding unnecessary expense and unproductive help.

Many persons seeking help with emotional problems suffer from some form of post traumatic stress disorder (PTSD) that requires very complex treatment needs. Some PTSD stems from being

raised in a dysfunctional family and/or early traumatic community interactions. But some individuals are affected by serious stress later in life.

One man I recently saw was on the verge of a break down when he came for counseling. He did not know why he often cried or felt very tense, but he was convinced he was suffering from some serious disorder, perhaps a brain tumor or the beginning of a psychotic episode. At 31, even with an excellent professional education and a very good job, he was almost at a point of no return. He was given a chance to tell his story but still took several sessions before out popped the, until then, repressed issue.

A year prior he was raped by three men who apparently were escaped convicts. (He lived within a few miles of a minimum-security prison.) He lived in an apartment complex in the far north suburbs of Chicago; it was located adjacent to a farm field, and the apartment dumpsters were located a distance from his apartment. He took out some trash one night and was pulled by these men into the field where they beat and sexually assaulted him. He went through the usual self-blame of rape victims and then, as often is the case, tried to "just forget it."

Treatment was successful and he learned and used methods for dealing with the trauma. Not all sexual issues are easy to deal with, but sex is a vital factor in our lives and associated problems can be buried, as in this man's situation, only to surface later in terms of difficult symptoms. He should have found someone to talk to about the experience immediately but was told by his boyfriend that the inflicted damage (a few cuts and anal bleeding) would go away, did not require hospital care, and to "get over it."

Of course, rape is one of the most traumatic experiences one can face, and PTSD is almost always the end result. Some people are more prone to deny the event if not physically injured too badly, but the emotional pain and suffering will just not go away. Immediate counseling is required in order to avoid serious prob-

For really significant emotional problems, good professional help is essential but, at least for many, very hard to find. Lots of things can help in dealing with emotional stress. Many people can get help from a wise and empathic friend, self-help groups, self-help books, nonprofit counseling centers or the Internet. If you feel you need help with your problems, keep trying because you will likely find it if you know more of how to find



As I watched, two boys came trudging up the hill. Guys in their late teens, I judged. One was blond, the other's hair was dark. Each was carrying a shovel on his shoulder.

Near the top of the hill, they began to dig out a car. I didn't recognize it. It had been left there, I guessed, from the night before. They worked with a will, laughing and talking and soon their job was through.

The blond picked up a handful of snow and threw it playfully at his companion. The other tossed some back. This battle lasted until the brunette went to his friend and began gently brushing the snow away from his collar. Finished, he quickly kissed him on the cheek.

The kiss was returned. Quickly, they looked around. No one was about and they didn't see me. They got into their car and drove off leaving me with a warm, good, fuzzy feeling with which to begin the new year. I needed that after Christmas Day.

One of the people who came to our house for desert on Christmas Day was a young man named Jason. 1998 had not been a good year, he said. Among other things he mentioned was the anti-Gay ravings of the Far Right religionists. Their words, we both agreed, were in large part responsible for the execution of Matthew Shepherd. There were other things as well.

For the next week, I thought about what Jason had said. He was right. It really had not been a good year for us. That's why seeing the two young men out on Palmer Street exchanging a kiss made me feel so good. All was not so bleak.

Similarly, watching Rudy Galindo skate on TV raises my morale by 1,000%. Rudy is the only male athlete to have come out, not after he's retired, but at the height of his career — and he's going strong. I watched as he performed in the Mannheim Steamroller's *Christmas Angel*, skating with such grace and beauty. I thought how much I admire him. Unlike a half a dozen people in the performing arts I could name, he had the courage to come out.

(Rudy Galindo will be coming to Milwaukee to perform on Sunday, May 2nd at 3:00 p.m. at the Bradley Center in the John Hancock Champions On Ice. We should all be there to cheer him and show him our support.)

The two young men on Palmer Street and Rudy Galindo are only two reasons for the hope I have for the millenium. Let me turn prophet for a moment, remembering that a prophet is only someone who sees what's current and extrapolates from that to construct a vision of the future.

In no particular order, I am confident that there will be found a cure and a prevention for AIDS. My wonderment is what will the post-AIDS era be like for us.

I am confident that same-sex marriage will become an actuality. I think the next generation will look back and wonder what all the fuss was about.

I think that in the "social war" now going on, we are at Gettysburg. The Far Right is marching in a Picketts' Charge. For a moment, their flag will flutter on the stone wall among the copse of trees and then they will be driven back. The battles will rage on, but in the end, they will be swept into the dustbin of history. Cal Thomas will wail that the American people are not good enough for he and his like—as he's doing now.

I think that America will become a nation. It is forming now. There's not space here to discuss its characteristics, what will be "this American, this new man," to quote the Frenchman's words, but I think the nation as it will finally be will be made up of Hispanics, African-Americans and Asians. LBGT's will be part of it without a second thought.

Human kind will go into space. That's a given. Gay people, married to each other, will go to colonize "strange new worlds" that exist now only in our imaginations.

Other beings? Aliens? I won't go anywhere near that.

Anyway, happy 1999. And Jason, I agree with you. 1998 was a hard year. But I think there's reason for optimism. Things have gotten better and will continue. In my mind's eye now, I see a snowy morning and the two young men on Palmer Street.





I met Reggie White in 1993. I shook his hand. It was large and warm. His hand-shake was sincere. I saw him in some of his quiet time, before his interview with Mike Gousha on the Sunday Night show when I worked at Channel 4. I was impressed with his size, his warmth. He is a good-looking man. He sat on the set and made some phone calls as we readied the cameras and put the props in place.

I saw Reggie White from the football field as I wielded a parabolic microphone aimed to pick up the crash of the helmets, the quarterback talk and the ambient field noise for CBS sports in the fall of 1993. A man serious about his business, welcomed in Wisconsin for what he could bring to the Green Bay Packers, Reggie White had become a symbol of hope for the inner city. He autographed a card for me, addressed to my stepbrother, and signed with his standard "Corinthians 1:13". Love is the greatest of all.

The LGBT community has been on the defensive since White and his wife Sara have taken up the cause that homosexuality is a sin. Our community, referred to as "The Sodomite Community" by Sara White, wasn't happy about White's outrageous remarks before the Wisconsin State legislature in the spring of '98 when he said the largest sin is homosexuality. Minister and Mrs. White felt the backlash promised in the Bible: "Judge not..."

The issue of the comparison between the struggle the African American has faced in this country and what homosexuals have faced over time is highly debatable. For 300 years African slaves forcibly toiled for bare subsistence while building plantations and fueling this nation. They have only the inheritance of grief for their trouble.

I, for one, am for retribution of some kind accompanied by long and loud apologies for the atrocious behavior of those who would enslave and profit from other human beings. Sadly, 100 years after slavery some still treat African Americans as separate and unequal.

Japanese Americans who were interred during four years of WWII received retribution. How does four years compare to 300 years in your mind? There is no equivalent outrage to homosexuals, not in my mind. (Women's slavery to man comes to mind, but we won't get into that.)

Yes, there is a history of repression to homosexuals, and who knows the toll incurred from the secrecy that 'in the closet' homosexuals have suffered? All that repression, all those secrets. If we look at the consequences for homosexuals who are found out, we get into some serious comparisons. Death, taunting, torture. Harvey Milk, Matthew Shephard, the Lesbians on the Appalachian trail and in Oregon, the German death camps, the mental institutions, Miriam Ben Shalom and those barred from Military service to *our country*. We too have our martyrs. The psychic anguish is there in large doses.

I am not sure it is useful to try to *compare* the suffering most of us have faced. What can we do to right the wrongs we can do something about? Let's face the racism that divides this country. Let's do something about the fear that causes "whites" to move out of neighborhoods simply because "blacks" are moving in. Let's integrate each other's neighborhoods. Let's work for prison reform. Let's notice that others have suffered as much or more than we have. And let's have the courage to change.

We all know that we can't change the fundamental person that we are or the people we fall in love with. But we can do something to make the world better for our fellow sufferers and ultimately for ourselves. I'm with Reggie White on at least this one thing: Corinthians 1:13, Love is the greatest of all. Happy New Year!

In future editions you will see more results of that trip.

As I write this, I am winding up my visit. I'm not looking forward to feeling those blasts of cold air when my plane arrives in Chicago tomorrow, especially since those of us who are from Wisconsin received a warm reception here this week. Everywhere I went people were talking about what we accomplished in electing Tammy Baldwin.

Yet I felt a sense of sadness yesterday morning as I looked at the Capitol Building. I remember my first trip to Washington. I was in the Eighth grade. Back then I was eager to see that white dome, the Washington monument, and the Jefferson memorial. I have returned here several times since then. Each time I've come back the thrill has lessened, until now it is hardly there at all.

I don't know why but somewhere along the way I lost the wide-eyed wonder I once felt. Perhaps it's the many scandals, the cheap manipulation of the voters, or the media's penchant to tear down those who rise to claim true affection among the American people. Maybe it's the knowledge that most of those in the Congress say I cannot get married, am not deserving of civil rights protection and should not be covered by the hate crimes act. Probably it's all of the above.

Still I feel a measure of pride and awe at the majesty of my surroundings. Over the years I may have lost my idealistic view of our government but I have not lost my faith in the hope and promise that it holds.

Yesterday afternoon, I walked through the Capitol Building on my way to interview a Congressman, drinking in its history as I passed by statues, paintings and the ornate, gilded walls. I waited right outside the House chamber watching as the newly sworn in representatives flooded into the anteroom.

There I stood, the middle son of a blue-collar family, as 435 of the most powerful people on earth walked by. I asked a quick question of Wisconsin Congressman Paul Ryan. I didn't like his answer but the fact is that no one could have, or wanted to, stop me from asking.

I thought about the great debates that have taken place in the room, which I now stood outside of. It took 90 years to convince the government that slavery was an evil that must be ended. It was another 100 years before the government gave some measure of dignity to the descendents of those it helped to keep in bondage. Our struggle is much more recent as it began in earnest only three decades ago.

As Tammy Baldwin's election shows, we have made great progress in that time. We don't have full equality yet but we will achieve it. That will happen because of our determination. It will happen because of the many talented people working on our behalf. Most of all it will happen because our system of government allows us to demand that it does.

We will win because, just as no one could stop me from questioning Congressman Ryan, no one can stop us from speaking out and making our case. In the end, what matters are not the individuals in government or the buildings they work in - it's what we do to make use of them.

In 1978 I came to Washington for our first national march. I left Milwaukee a homosexual. I came back Gay. Twenty years later I've returned as a Gay journalist. This time, I wasn't transformed but I was reminded of the opportunity, and responsibility, that we all have to promote change. I go back to Wisconsin; my faith a little renewed, my hope strengthened.

To my friends at the Gay and Lesbian Victory Fund, who allowed me to use their office as a temporary *Wisconsin Light* Washington Bureau I wish to express my appreciation. I would especially like to thank Kathleen DeBold and her partner, author Barbara Johnson, who shared their home and part of their lives with me. I dedicate this issue to you. I will never be able to repay your kindness, except to keep hoping and believing.

Congratulations on all the success and positive developments occurring at the *Light*. I was pleased to see that you included Ben Johnson's death as one of the newsworthy events of 1998. He would have been honored to know that his contributions to the community were considered to be of such note.

As you know, Ben and I have been tireless advocates for Persons with AIDS and HIV disease. While there is certainly no shame in one dying of complications of AIDS and HIV disease, it should be noted that Ben did in fact die of metastatic cancer of the colorectal cancer, and not complications of AIDS.

It is important that we recognize that members of our community are dying of other illnesses, such as colorectal cancer, which if detected early enough are survivable. The incidence of this type of cancer in the African American community is staggering; early detection is the key.

As with HIV disease, it is critical that members of the LGBT community obtain regular medical check ups and testing to detect illnesses as early as possible. We must continue to fight for some form of guaranteed health care for all persons of this country. On a day to day basis, we must continue to encourage those we love to take proper care of their health.

We must not forget that AIDS, cancer and other such diseases have claimed far too many of our brothers and sisters. We have proven beyond all doubt, that the LGBT community has the capacity to respond above and beyond all expectations in times of crisis. Dear Editor,

In a recent column, language guru, William Safire says that President Clinton, "in his sworn civil deposition claimed never to have touched Ms. Lewinksy intimately and before the grand jury stuck to that absurd tale of total passivity."

I searched the Internet for Mr.Clinton's deposition in the Paula Jones case, which is presumably what Mr. Safire refers to. I found a purported text, which I can't verify as being true.

In this purported deposition, I don't find "touch" used in connection with Monica Lewinsky. It is used a number of times, but in connection with Kathleen Willey and "Jane Doe 2," and specifically used in a question about touching a breast.

I don't find any other language in the text could be construed as referring to physical touching of Ms. Lewinsky. I find only a question asking Mr. Clinton if he had a "sexual affair," with Ms. Lewinksy, which was immediately clarified by the examining attorney to "sexual relations" as defined for the deposition and modified by the Judge.

It could be that Mr. Safire has a more accurate text of the President's deposition than I do. In that case perhaps he would be so kind as to include in a future column, the "touching" denial to which he refers.

Perhaps Mr. Safire is drawing an inference from the court definition of "sexual relations" in the Jones case — that denying sexual relations is also a denial of touching. I've seen (*New York Times* 9/14/98), touching would be covered by sexual relations only if with the intent of arousing or gratifying the person touched.

If the issue is restricted to Mr. Clinton's claim that he didn't have "sexual relations" with Ms. Lewinsky, it is dubious to construe this as a denial of having "touched" her. What he could have been denying indirectly is having touched her with the intent to arouse or gratify, or with the intent to arouse or gratify himself. (which seems the motive of most men in such situations) and truthfully said what he said

I would think that someone writing a weekly column on correct use of language for a national newspaper would be more precise is his own usage.

in a number of mainstream publications.

HISTORY OF GAY HOLLYWOOD

PART 1

In the closed circuit Gay world of Hollywood, more often meant less. The most prominent film celebrities were shielded according to their degree of indispensability and had less to fear, having only carefully programmed public contact. The Gay upper ech-

elon was guarded from vulnerable exposure by an insular industry sporting an elitist, talented, homosexual underground.

Studios were vigilant. Movie stars in the '30s and '40s were parahuman symbols whose erotic gambits were regarded as inevitable and unavoidable conse quences of their sublime appeal onscreen. There were limits, course.

20th Century

Fox's handsome Tyrone Power's affair with Lana Turner added extra zing to his image, but his alleged (according to Hollywood Babylon) sexual encounters with Warner's Robin Hood (Errol Flynn) provoked drastic warning signals from both studios. Power was known as a submissive. There was no real cause for alarm. No one would have believed the story. Homosexuality did not exist in the popular lexicon. Acknowledgment

men's clothes (Morocco, Queen Christina) and playfully kiss ladies on the lips, Garbo declaring onscreen, "I shall die a bachelor." But these were the exotic gambols of celluloid divinities, not to be taken seriously.

Cary Grant and Randolph Scott may have been intermittent "roommates" between wives, but stardom required exclusive "friendships" Audiences lived vicariously, preferring not to speculate about overt "sexual

perversion"

Still, the danger was minimal. The homosexual community in Hollywood was large enough to give venue to its famous members who were, in turn, shrouded in secrecy not only by the studio, but by the isolation of their celebrity. They moved largely in closed circles.

Fame afforded its own protection. Furthermore, gossip columns were not as avaricious as they are today, and the

immensely popular movie magazines of the period thrived on the good will of stars and studios. A source as reliable as David Shipman in his comprehensive survey of The Great Movie Stars (pub. 1970) mentions the homosexuality of Charles Laughton and reveals that silent star Rudolf Valentino and Errol Flynn had engaged in homosexual hustling to lighten the road to success.

Early career hustling was also true and more widely known of James Dean in a later, more cynical era, but it only added piquancy to the "Dean Myth." Major stars were to a degree exempt from standards of "normalcy" if they kept silent. The press refrained from open disclosures, surprisingly adhering to an unspoken "gentlemen's agreement" Even those dredging dragon ladies of gossip, Louella Parsons and Hedda Hopper, limited their columns to departures from niceties or romantic gossip.

Cross-dressing and casual shows of Gay affection were illegal and strictly enforced by the Los Angeles Police Dept., but newspapers depended on access to the city's most prominent industry as a positive news source. Studio public relations agents could prevent publication of explosive news, often by

substituting a lesser scandal for a major one. This method worked even for the more threatening Confidential years When that magazine threat-

Hudson's blatant cruising activities in the '50s, the studio offered them the less important Rory Calhoun's prison jaunt for robbery years earlier - which aroused sympathy for Calhoun. It was reported that MGM even had an "abortion consultant" on the payroll for a different type of emergency.


Even after the appear-

ance of more vituperative publications than Confidential, homosexuality slurs were subject to lawsuits. The now discredited disclosure that Rock Hudson had engaged in a "wedding ceremony" with TV star Jim Nabors did little to rock Rock's career, although it had long been known in Hollywood that Hudson had been broadly promiscuous since his arrival. The story was treated as a royal jest. Rock began a new TV series.

Such was the nature of the public's blind spot towards their favorites - for a time.

But there was real trouble in paradise. Charles Laughton had been arrested in London in the early '30s for soliciting a male prostitute, according to loyal wife Elsa Lanchester who tried to discourage his secret quests for young men. The great MGM director George Cukor (Camile, Philadelphia Story), usually discrete even at his all-male pool parties, was arrested in 1939 on a morals charge. Both men were far too valuable to the studio. No scandal

But there was other friction within the ranks. George Cukor was dismissed from completing Gone With the Wind due to differences with Selznik as had been



Execution of Justice

My high school never put on a play like this. But then, my high school never had Colleen Kellogg as a teacher.

Over fifty people braved snow and ice to see the Malcolm Shabazz high school production of Execution of Justice, directed by Shabazz drama teacher, Colleen Kellogg. The play depicts the trial of Dan White, the former San Francisco Supervisor convicted of assassinating fellow Supervisor Harvey Milk and San Francisco Mayor George Moscone in 1978.

Dialogue taken from the trial intertwines with fictional reflections, as the play explores how prejudice and bigotry influence justice. Harvey Milk, who was one of the first out Gay officials elected in the country, becomes the focus of a subtle game of politics surrounding White's resignation from the San Francisco Board of Supervisors.

While a Supervisor, White represented a primarily white, working class district. Later, he asked Mayor Moscone to reappoint him to his post. When Moscone refused, White shot him. White then reloaded his gun and went to Milk's office, where he shot Milk. White admitted to both murders but maintained they were not politically motivated.

Ultimately, White was convicted of manslaughter instead of first degree murder. His attorneys argued that junk food had clouded his judgement.

The play explores evidence presented at White's trial and how a working and middle class, white, Catholic jury interpreted his actions. A large cast plays multiple parts (over 40 characters), in a complex menage of opinion, speculation, forensic evidence and political intrigue. This is not a play to be

Kellogg and her Shabazz students don't take it lightly. More than twenty students not only play multiple characters but also run lights, created the promotional materials, built the set and set up a power point computer presentation that flashes images and stage directions on a large screen behind the actors.

Apart from some to-be-expected amateur production problems, like projection, pacing and self-consciousness (how well many of us remember those feelings!), the students do an outstanding job of dealing with a very complex play. Spotlights leap from one character to another, leading the audience through the maze of facts, fiction and motive. The infamous "Twinkie" defense doesn't evoke giggles but disbelief. Several characters, most notably Jody Fleury as the defense attorney, capture the emotional intensity of the trial in its manipulative, bigoted glory.

As the Sapphire Ballroom's mirrored disco ball provided a bridge from the 1970's, it was interesting to see a political trial from that time in the light of current political events. The passion behind the events portrayed in Execution of Justice seems ironic: the era that produced Watergate is seen in the light of our present impeachment-mania, with the disco ball emphasizing our country's current fascination with the political as simply, entertain-

There are no other public performances

of Execution of Justice planned at this time but the show will go on. The Shabazz students will perform the play for several schools with discussions between the cast and student audiences planned.

Ten Highlights From the Otherwise Mediocre Movies of 1998

As a movie critic in the late 1990s, coming up with an annual "top ten list" is a difficult task. Not, most assuredly, because there are just so many excellent movies each year that it's hard to winnow them down to the best ten, but rather because it's hard to come up with ten that I'm content to put on my list at all! Yet again, 1998 was not a stellar year for the big screen.

Gone were the mega-blockbusters of 1997 like *Titanic*, *As Good As It Gets* and *Good Will Hunting*. Instead, we had busts like *Godzilla* and *The Avengers*. Only one movie made more than \$200 million, the loudly hyped *Armageddon*, with *Saving Private Ryan* a close call. Americans simply didn't flock to any of last year's movies, mostly for good reasons.

Like most years, many of the best of

the 80-odd movies I saw this year were produced at small, independent studios - the so-called "art house" films.

Mainstream Hollywood come through with some good films, too. Indeed, my list this year is a combination of both. Actually, this is my top thirteen list. I threw in, for numbers free, eleven (Deep Impact). twelve: (Buffalo '66) and thirteen Horse Whisperer), respectively, just

to get a few "honorable mentions" in. So, without further ado, here were the best ten movies of 1998 according to this ever-vigilant reviewer.

1. SAVING PRIVATE RYAN

Though nothing in the remaining hours of this film quite matches up to the first half-hour — a brilliant depiction of the Allied D-Day landings — Saving Private Ryan is far and away the best film of 1998. A very strongly acted, emotionally taut, anti-war film, it belongs right next to Spielberg's other WWII epic, Schindler's List. Saving Private Ryan is only one of a handful of war movies produced in recent years. It succeeds in being one of the best of the entire genre.

2. LIFE IS BEAUTIFUL

Another powerful film, that matches Schindler's List in many ways, is the Italian Holocaust-themed film, Life is Beautiful. It superbly combines comedy and pathos into a magnificent historical drama with significant emotional impact.

3. GODS AND MONSTERS

last The months of legendary, Gay, horror film Director James Whale's life retold by the exceptionally talented. openly Shakespearean actor lan McKellan. Gods and Monsters is also blessed by Brendan Frasier's well-muscled body and lots of "inside" Gay humor.

4. HAPPINESS

Happiness is a remarkable film that centers on a small group of interconnected people who have one thing in common:

a severe lack of happiness. It's the one thing they all seek but are at a loss to find. Uncomfortable themes (pedophilia, murder, loneliness, masturbation) are examined through the blackest of comedy.

5. ELIZABETH

In Elizabeth, the first few years of Queen Elizabeth's remarkable reign are revealed to be full of plotting, deceit, lies and sex. Elizabeth succeeds because of Cate Blanchet's superb titlerole performance, a great supporting cast (Richard Attenborough, Geoffrey Rush) and a detailed and accurate period sensibility.

6. AMERICAN HISTORY X

The viciousness and perpetuation of racism are unflinchingly examined in the alternating black-and-white and color *American History X*. The film is deadly serious and quite violent, but brings home the message of racism's corrosive power like few (if any) films before.

7. THE TRUMAN SHOW

Our modern-day anxieties about the overbearing gaze of the camera lens — be they media or government operated — are brought to full boil by this serious-themed yet comic tale. The Truman Show is memorable for one thing in particular: it shows at long last that Jim Carrey can actually act, and doing so without mugging around stupidly in every scene.

8. THE BIG LEBOWSKI

Joel and Ethan Coen may not have quite matched their combined brilliance in *The Big Lebowski* which they evinced in *Fargo*, but nevertheless they succeed in providing us with the year's most outlandish comedy, filled with bizarre characters performed by a great cast (Jeff Bridges, John Goodman, Steve Buscemi and John Tuturro).

9. SHAKESPEARE IN LOVE

Shakespeare in Love superficially

has much in common with the superior Elizabeth, including gorgeous Joseph Fiennes, Geoffrey Rush and an Elizabethan setting, but that's where the similarities end. This film comically and fancifully explores the Bard's early struggles to find success as well as his "muse"; the latter performed excellently by radiant Gwyneth Paltrow.

10. A BUG'S LIFE

The Disney animated bug movie, A Bug's Life, proves to be superior on every level than its somewhat darker, more boring counterpart, Antz. But, it also withstands scrutiny on its own. A Bug's Life is a lighter-than-air, exceptionally entertaining movie that frequently shows comic brilliance, in addition to its superlative visual effects at the hands of computer graphics wizards.



On Sunday, January 24, 1999, expect a very Gay-oriented 56th Annual Golden Globe Awards. The Golden Globe is a star-studded event, third in award ratings to the Oscars and Grammys. This year there will be more than a nod toward Gays in TV

Will & Grace

Will & Grace is going strong. The new time slot on Tuesdays seems to agree with it because the show's ratings are on the rise. From 79th, it's now at 26 place.

The spring season will see a parade of guest stars on the show. By the time you read this, Rudy Galindo will have appeared, according to TV Guide. The openly Gay champion skater will have appeared on the January 12th segment.

According to the *Guide*, Rudy will be followed by Debbie Reynolds. Reynolds will be playing Grace's (Debra Messing) critical, over the top, poker-playing mama, Bobbie Adler. The show will be titled (no big surprise) *The Unsinkable Bobbie Adler*. The Gay and Lesbian Alliance Against Defamation (GLAAD) reports that at the taping of the segment in December, the studio audience was in "a down right frenzy" when Reynolds goosed Jack.

Reynolds' appearance on the show may be nearly unique. On a show where all four characters want men, you probably won't see too many female guest stars.

GLAAD reports that after the taping, there was a "lengthy" discussion by Jack (Sean Hayes), Will (Eric McCormick) and Grace about whether Star Wars robot C3-PO is Gay.

Despite the show's title, the strong performances by Hayes and Megan Mullally (Karen) show just how important a strong supporting cast is to the success of a show. In up-coming episodes look for them to play bigger, more fleshed out roles.

So what about Will's love life. As I reported early, McCormick (who is very straight) said that Will has to date. Otherwise he won't be credible. That's coming — and, *The Advocate* reports, so is "the big kiss." Look for it around Valentine's day, the magazine says. (Wouldn't it be great if Will and Rudy Galindo got together?)

In the meantime, look for scripts that are a "lot more aggressive" about Will's sexuality. Will is to be true to his Gay identity, be sure about that.

Ironically, critics say that there's more sexual tension between Jack and Karen, Grace's straight assistant.

In The Life

In The Life, the LGBT bimonthly TV news magazine has been getting some rave reviews. The Los Angeles Times crit-

ic, Howard Rosenberg, says there is "nothing else like it on the air." Rosenberg calls the show a "smart, vibrant, extremely informative hour that isn't also for heterosexuals." It's for everyone, he writes, "wanting to witness the full panorama of society."

Rosenberg says the who is "opinionated without being shrill or preachy while celebrating diversity in a way you'll not find on any other newsmagazine." Now that's praise several "straight" news shows I can think of would like to hear.

Speaking of In The Life, the show's host, Katherine Linton and Kate Davis are co-producing an hour-long TV documentary on anti-Gay violence. The program will air as part of A&E's Investigative Reports

The film, Linton says, will take a serious look into the rise of hate crimes against Gay people nationwide, a trend which is little known or understood by the general public.

Bathhouse Betty

Bette Midler

In her first new album since 1995's Bette of Roses, Bette Midler's Bathhouse Betty proves that she still has what it takes to be considered a pop music Diva. The dozen tracks span the gamut of emotions, fulfilling Midler's own self-description. "My specialty is to make people laugh, really, really hard," she says of her new album, "and then turn around and make them cry. That's what I do." This new Warner Brothers release unmistakably evokes her musical roots.



And it's what she does, in her own inimitable style, on *Bathhouse Betty*. The album is a resonant, wide-ranging, entertaining collection of songs, reflecting Midler's return to the campy, cross-cultural and enormously influential New York City music scene of the early 1970s. It has moments of great vulgarity, but also moments of great yearning and spirituality.

From the hilarious audacity of I'm Beautiful and I'm Hip to the traditional pop craftsmanship of Lullaby in Blue and My One True Friend, and from the vintage vamping of I Sold My Heart to the Junkman and One Monkey Don't Stop No Show to the eclectic charms of Boxing and Song of Bernadette, Bathhouse Betty proves that the Divine Miss M still possesses a strong voice, unique style and considerable gravidas as a pop music Diva.

Little Voice - Motion Picture Soundtrack

Little Voice, a new Miramax film which has yet to open anywhere in Wisconsin, is receiving quite positive reviews from film critics who have seen it. It has been billed as "an endearing comic drama with a big heart," telling the story of an incredibly shy young girl who expresses herself through uncanny renditions of famous songs.

Despite the film and soundtrack album's title, however, the music features anything but little voices. Indeed, some of the biggest voices — and biggest stars — to ever belt out a knock 'em dead showstopper are contained on

this 11-track Capitol Records album.


The film centers on British actress Jane Horrocks, recognizable to many from her stint as Bubbles on the sitcom Absolutely Fabulous. Despite the fact that, in the movie, Horrocks mimics the voices of famous singers, the soundtrack album only contains two songs

soundtrack album only contains two songs by her, I Wanna Be Loved By You and Get Happy. True, she has a pop singer's voice, but next to her album competition — Judy Garland, Billie Holiday, Shirley Bassey and Ethel Merman — she just doesn't quite match up.

The strength of the Little Voice album is the fine assemblage of historic singing talent that it contains. Garland fans will be especially pleased, given her three appearances (That's Entertainment, The Man That Got Away, and Come Rain Or Come Shine). The album is a nice collection of classic pop standards, but these are readily available elsewhere. For uniqueness' sake this reviewer would have actually preferred to listen to an album entirely sung by Horrocks than to these same old tracks that have been around for three or more decades.



Still, Little Voice is notable for one thing: an unlisted, bilious rendition of It's Over by British actor (and no time singer) Michael Caine. This one track is almost worth buying the whole record; Caine's over-the-top performance represents screw-you show biz at its most show-bizarre.

This review will cover two films, Line Feed and Link 2 Link, both by All Worlds Video and both directed by Chi Chi La Rue (a.k.a. Taylor Hudson). Both films are simply Gay sex films: no plot, no fancy sets, and certainly no costumes just lots of unvarnished sex. This type of film usually features well known porn actors who are known as sex pigs those who are exhibitionists, completely uninhibited and insatiable, and those who enjoy wallowing in sex and who are frequently willing to perform kinky things that the average porn star would find demeaning. 
