## CCBA Meets with Local Attorneys

Tuesday, June 22, 1982, the Board of Directors hosted cocktails at John Byron's for nine attorneys representing five different law firms located in the greater Milwaukee area. The majority of the lawyers were present as the result of a solicitation by Ralph Navarro in a May 1982 Wisconsin Civil Liberties Union mailing to its attorneys. Recognizing that our membership includes several attorneys, Ralph realized the need to offer our members a wide pool of attorneys able to cope with all our legal needs, be they civil, contractual or criminal. In addition to being sensitive while dealing with gay and lesbian persons, an attorney referred by CCBA must be knowledgeable in the specialized needs of gay persons and the law. For example, two straight persons buying property together would probably form a legal partnership between them to protect their mutual rights and interests. However two gay persons buying



property together and building a home, as well as an investment together, need much different partnership structuring. Not all attorneys are capable, or willing to provide legal counsel to gay and lesbian persons on their special requirements. Furthermore, should an attorney not be sensitive to gays and lesbians as persons, the usual attorney-client confidence may be suspect.

Several board members gave extemporaneous talks on various aspects of CCBA; among topics covered were profile of our membership, format and topics at monthly meetings, benefits of membership, and how our organization relates to the community at large. Our guests responded with questions and reactions; a common response from the attorneys was surprize at the lack of compassionate and competent legal aid available to gay and lesbian people. Our answer was that the response to Ralph's initial mailing showed several such attorneys willing to work for us, however until this time CCBA never had the opportunity to meet them.

It was concluded that both sides would benefit from a continuing relationship with the attorneys present. CCBA will now have a strong

pool of attorneys to refer to our members. attorneys sensitive to a gay lifestyle and gay relationships, knowledgeable in the special legal needs engendered by our lifestyle, and attuned to the tax, investment and estate structures available to persons in our income levels. For the attorneys, they will be expanding their practice, building a stronger client base, and gaining a very lucrative referral market of middle to upper income persons in the peak of their earning years. As a membership drive the meeting was 100% successful, and we welcome our new members. and hope our membership will call upon them as need arises.

## Gay Businesses Courted

CCBA's Board of Directors, beverages, and a gorgeous food spread greeted gay oriented business owners on June 10 at the Marc Plaza.

Discussions with Chuck Balistreri, President of the Business Association of Milwaukee (BAM) and other members led to the establishment of a date and time for all gay/ lesbian oriented business establishments to learn about CCBA first hand. Official invitations were sent out which requested RSVP if not attending. Phone calls were made two days prior to the event to remind the 25 invited

guests of this meeting.

Of those invited only Joe Brehm of THIS IS IT, Ron Geiman of ESCAPE and Wayne Bernhagen of THE WRECK ROOM, YOUR PLACE and THINKING OF YOU ON BROADWAY were present. Rosie of THE MINT called with regrets. None of the officers of BAM were present, even though the entire meeting was set up to their schedule.

Members of the Board as well as Warren Ostrus and Bob Stocki presented a program that was greeted with great interest. Discussions about some of the problems encountered by tavern owners were discussed. The Board has continued to reach out to gay business owners so that CCBA would be strengthened by the diversity of our business and professional community.



# Thoughts about... Ugliness

How do we define ugliness? Is it merely being too fat? Too skinny? Having bad breath? Being bald? Being a different color (other than white)? Being deaf or blind or deformed?

Certainly most of us educated people don't use the word ugly. We may use the term tacky or we may just express a feeling in a grunt or we may avoid eye contact with such persons. But the bottom line is, DISCRIMINATION!

Some of us seem to have an idea of what each other of us is to be like. I have heard members make nasty comments about one of those people who eat too much or come on too strong or drink more than is "normal", etc. I have heard people put others down because "that person dared to kiss me" or was "too friendly"! I have heard people referred to as "real screamers who we wish would go away"!

All of these things and more are geniunely signs that gay people as a whole are certainly going through psychological adolescence. Most want to be different by being the same.

The sad part of this scene is that gay and lesbian people have NO RIGHT at all to be prejudiced! People who have been and are being discriminated against should be more sensitive and aware of the pain of discrimination.

While some people have stated a concern about certain kinds of people in CCBA, I for one wish to make an emphatic statement, if a person is professional or business person, s/he will be a welcome member of my life and my life with CCBA. To discriminate in any way would be to make a mockery of being a truly professional person, especially one who is gay/lesbian. Not only must I be tolerant, but I must learn to truly appreciate the uniqueness of each person, for s/he has something to give me that will make me a more complete person.

So what is ugliness? For me ugliness is the attitude of any person who refuses to be sensitive and appreciate the uniqueness of another person!



### **Briefs**

-Member of CongressHenry Reuss has joined as a co-sponsor of HR 1454, the Federal Gay Civil Rights Bill. Please write to him thanking him for this step!!!

-Ralph, Paul and Tom Zander recently met with D.A. E. Michael McCann regarding raids and prosecution, the news was both good and bad. The bad news was mind boggling! Ask us about it at the meeting.

On May 1st, a new 91 day | certificate was available for \$1500, yielding interest rates tied to three month Treasury Bills. The certificates. obtainable at all financial institutions are intended to compete: with money market mutual funds. Based on the latest weekly Treasury Bill auction, the yields would be 12,55% at commercial banks, and 12.8% at S&L's and mutual savings banks. The differential of one quarter point will be suspended after one year and will not apply if the interest rate falls to 9% or less at four consecutive auctions.

Many taxpayers who maintain an office at home are taking advantage of the IRS ruling that the expense is deductible if the office is the "principal place of business" or even a secondary business. But there is a catch. When the home is sold, the portion of profit from the sale attributable to the home office is subject to tax. Thus, if 10% of any gain on the sales would be taxable. This holds true even if the taxpayer buys another home of equal or greater value within two years. From: Small Business Reports, May 1982.

-Shalom Enterprises, Inc. has won a 9 month battle with the Milwaukee Journal Co. allowing it to now advertise in the classifieds. The Journal Company had rejected this

for all that time, but the Publisher has altered the policy slightly. -All radio stations in Milwaukee rejected advertising from Shalom Enterprises, Inc. even though there is no federal regulation prohibiting advertising from gay/lesbians. What kinds of discrimination have you experienced either personally or in business? Let us know so that we can do something to change it---it can be changed, even though A.B. 70 does not protect us in this positive way.

-Gay Rights National Lobby has applied to join the Leadership Conference on Civil rights. GRNL Executive Director Steve Endean states that the Leadership Conference is the key umbrella group working on civil rights issues at Congress.

-A recent issue of <u>Us</u> magazine contained an interview with singer Johnny Mathis, in which the entertainer discussed homosexuality for the first time in his twenty-five year career. The article discussed Mathis' first love affair with a 21-year old saxophone player, when the singer was 16 years old.

Several weeks prior to publication of the interview, Mathis was asked, on the syndicated show "Entertainment Tonight", if he ever planned to marry. He replied that he hoped to be married before his fiftieth birthday.

Mathis is 46.

-The National Gay Press Association is developing a national gay wire service which will be accessible by home microcomputers. The system is expected to be in full operation by Labor Day of this year.

CCBA is anxiously awaiting to "log on" to this system as soon as it is in operation.

-The CCBA mailing list is now fully computerized. Please inform the newsletter committee, if there is an error on the mailing label which was used to send this newsletter to you. Also, notify the Board of any address changes, so that we may keep our records up to date.

-The deadline to submit materials for the August CCBA Newsletter is July 21st.

-Leon Rouse, an associate member of CCBA and the driving force behind the passage of Wisconsin's AB70, appeared on "Public Conference", a local public service program on TV6.

The show featured a panel discussion, "The Civil Rights of Gays", with panelists Rep. Dismas Becker, (D-32nd Assembly District); and Rev. Gene Pocernich, Associate Director of the Office of Human Concerns of the Catholic Archidiocese of Milwaukee.

The discussion was moderated by Donna Utke of the Milwaukee Public Library and aired Sunday June 20th at 11:30am. 
