Non-Discrimination Statement: Statement requiring written verification by those with whom CCBA does business that they support the spirit and letter of Wisconsin AB70, which added sexual orientation to the classes protected from discrimination in employment, housing & public accomodations. Such policy to be implemented as of September 1, 1984.

Special Edition: Tom Martin presented a comprehensive proposal for the transfer of Special Edition to ASA Communications as publisher. Concerns about continuing rights and involvement of CCBA and final contract language will be considered at a special board meeting June 6, 7pm.

Joint Membership: Board adopted the concept of a "joint membership" category recognizing the status and needs of those members for whom the business membership is inappropriate, and the individual membership is redundant. Draft of membership committee referred to executive committee for language & implementation.


# THE INVESTMENT CLUB IS OPENING ITS MEMBERSHIP

When I visited Warren Breitlow at his photography studio in Wauwatosa, he indicated that he is "more interested in taking advantage of the space given to business members to promote the Cream City Association Foundation than I am in talking about photography and Breitlow Studio."

He is strongly committed to the goals of the Foundation—"to provide for the well-being of the gay community"—and hopes more publicity will lead to growth in the Foundation's funds.

The Foundation is now in its second year, having been formed in mid-1982 by CCBA. In 1983 it dispersed about \$1400, but will probably give considerably more in 1984.

Gifts can be restricted or unrestricted, according to Warren. It recently received a \$2,000 contribution for A.I.D.S. projects/research and is deciding how to use it. Others have made donations for purposes such as the legal rights cards for gays. The Foundation has also made grants for Mandala's Hotline for gay counseling and for speakers and films at local gay meetings.

All contributions are tax deductible, because it is a charitable organization charted by the state and federal I.R.S.; it's the only organization for gays in Wisconsin with this status. Anyone giving to United Way can designate on the pledge card that the Foundation should receive the funds.

Warren says that the Board of Directors prefers to fund local activities whenever it can. Right now, he finds that donors are more interested in contributing funds for health services, but Warren points out that a scholarship could be another designated gift.

The Foundation is an associated organization of CCBA with members sitting on each others Board of Directors.

Warren sums up his sense of the importance of giving to the Foundation in this way: "If we don't take care of our own, who will?"

#### Thinking of You On Broadway

It can be truthfully said that we as gays have very good taste in where we choose to dine, the clothes we wear, the cars we drive and where we live. Not to mention the fact that we are great decorators. So when it comes time for a special item for our home or a present for a friend—we tend not to shop at the run of the mill type stores but to find a place with a little more originality or character.

Thinking Of You On Broadway, 147 N. Broadway, is such a store. The shop now starting its fourth year is owned by Wayne Bernhagen and it is a subsidiary of W E inc. Much of the merchandise featured in the store is gay oriented, however, Wayne has carefully chosen quality gifts in order that he can cater to the gay or straight customer.

Thinking Of You On Broadway offers the largest selection of gay oriented greeting cards in the city. Close to two isles are devoted to just this type of card. Additional gay items include gay monopoly, wrapping paper, calendars, mugs, gag gifts and poster art.

When looking for a higher quality gift the shop features fine crystal decanters and glassware, leaded glass, vases, steins, mobiles, mirrors, statues, music boxes, candles, brass items and wall hangings.

The location is out of the way for the everyday shopper, however, 80% of the clientele is gay and with the convenient hours of 3:30 PM to 10 PM, customers tend to stop in while in the area.

Wayne owns the building and by not having to pay high rent for a shopping mall space or the salaries of multiple employees—the shop has a low overhead thus his prices are noticeably lower on certain items carried by similar gift shops.

The store is stocked with an abundance of merchandise and Wayne is considering moving a wall back to allow for more space. He said that if the shop was all he owned, he wouldn't hesitate to expand and open another shop. Therefore he could buy in mass quantities and prices would be much lower. However, because he owns and operates some other businesses—it is not feasible at this time.

In coming up with a name for the shop three years ago, Wayne wanted to get across to the gay community of Milwaukee that by opening a business with merchandise geared to a particular clientele—he was "thinking of you."

#### N.O.W. sponsors national march for lesblan/gay rights

Although the San Francisco community is working hard to make this event a success, we must have input and assistance from around the country. The March may be in San Francisco, but the statement made here will be carried across America by both the media and convention delegates." commented Outreach Co-Chair Howard Wallace.

Having recently returned from the NABC midyear conference in Seattle, I'm happy to report that "the baby's doing fine." By that I mean that the infant organization which was formed as a national communication network between and among lesbian/gay business groups four years ago is beginning to speak its first words and take its first steps.

I attended the Seattle meeting as CCBA's delegate, assisted by the valuable insight and hard work of Tim McCoy, CCBA's alternate delegate.

A group of talented, accomplished and extremely dedicated individuals comprised this gathering. Issues from how to promulgate successful programming ideas to taking a stand on bathhouse closures to dealing with the special economic and power structure status of women and racial minorities filled a massive agenda. Further reports on the meetings and NABC's national agenda will be forthcoming, via monthly newsletter inserts from the NABC President (Wemer Kuhn) and other vehicles.

CCBA has played a major role in the growth and development of NABC, because we feel that only through a cohesive national voice will our concerns be addressed at the national level, and because of the tremendous storehouse of talent which exists among the NABC's affiliated groups. Our substantial involvement continues through two actions taken in Seattle: first, Ralph Navarro was elected as Central Region (stretching from North Dakota to Michigan; Minnesota to Texas) representative to the Executive Committee of NABC; second, the proposal that Cream City Special Edition become the model for a national Lesbian/Gay business magazine was unanimously endorsed by the board of delegates.

If you are reading this before June 2, be sure to plan to attend the Spring Shake Up on that day. Information is included elsewhere in this issue, but the essential idea is to create an intensive day of action planning, utilizing all of our existing resources. The excitement level already evident is indicative of the progress to follow.

For my fellow procrastinators: you will be happy to know that the mem-

bership committee's promotion of special prizes and benefits for getting new CCBA members has been extended into June. NOW IS THE TIME to make that contact with the people you think may be interested in CCBA. With the Spring Shake-Up plans, new committee activities and our progressive stance on so many issues, there are surely hundreds of women and men out there who have thought of joining CCBA. You will also be receiving shortly some information pertaining to Milwaukee's selection of a new Chief of Police. This is a matter of great concern to us all, since not only will the decision be with us for at least seven years, but the attitude of the Police Department is so crucial to all of our day-to-day business and personal lives. We will not be endorsing any candidate, but will try to make you aware of the significant concerns in the selection process, and the ways to make your views known.

I had the pleasure of being involved with GPU in the writing of the gay community's report to the Fire and Police Commission's public hearing, as delivered by Miriam Ben Shalom. CCBA members Paul DeMarco, Greg Quindel, Boyd McGranaghan and others have also participated in the process of researching the selection process.

So, please remember the Spring Shake Up at the War Memorial on June 2 (9:00am). Remember also that June is Will Writing Month, with several member attorneys offering to write a simple will for CCBA members for \$40 (see article this issue). As always, your At-Large Representative or other Board member is available whenever you need more information or wish to make a commment.
