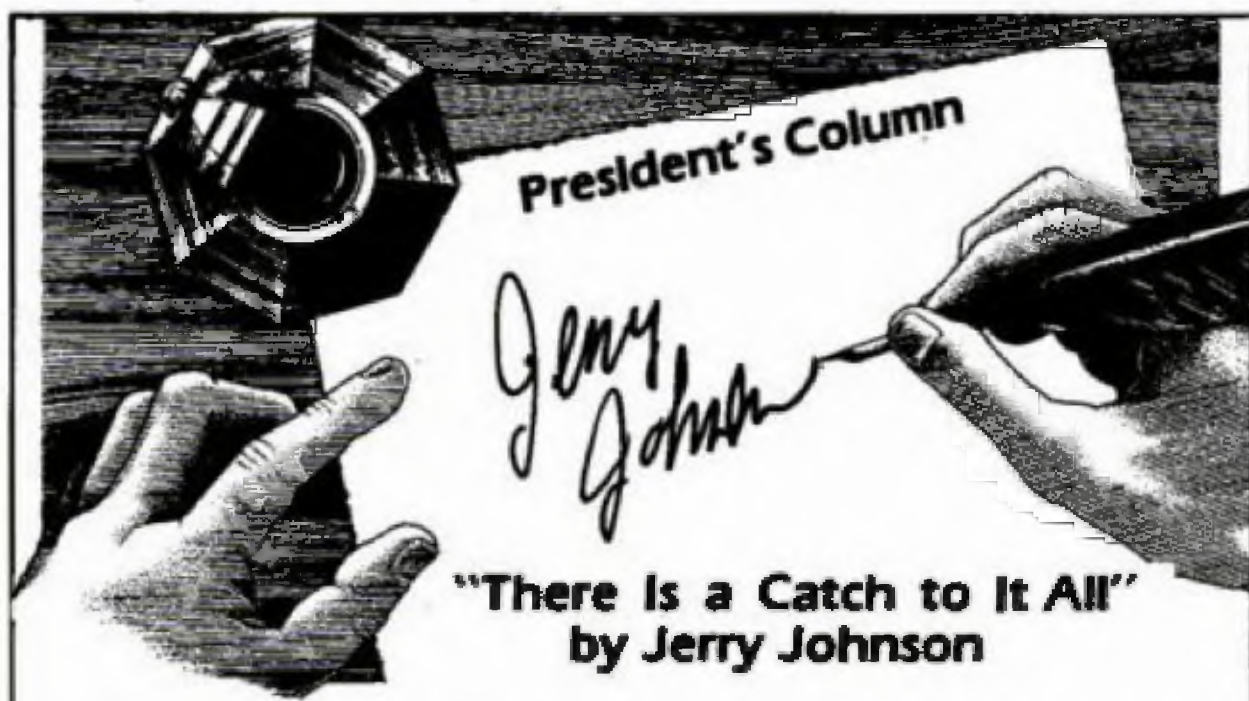

## Future Milwaukee - Training Community Leaders

Future Milwaukee, a community based leadership training organization, is accepting applications for its 1986-87 class. Now in its 9th year, Future Milwaukee has provided a training to over 350 people.

trict development, the largest single development in Wisconsin history. Bolger's talk was a wonderful blend of philosophy (Bolger holds degrees in Philosophy as well as law) and practicality. He claimed that this huge development was done "with mirrors" - that is, every piece of the gigantic puzzle was dependent on every other piece, particularly the start-up funding. After being told he was crazy by virtually every person he contacted at the start, his affiliation with the Milwaukee Redevelopment Authority gave him the credibility necessary to get the other pieces to fall into place.

"Now," Bolger said wryly, "everyone is saying that they are glad they gave their support in the early days of the project."

Bolger quoted the philosopher Kafka who said that once you are fully committed to an ideal, the power of the universe moves with you. This concept can be applied to anyone's life and any project or concern, said Bolger.

A question and answer session solicited Bolger's thoughts on the new Contemporary Arts Center to be developed in the Third Ward on Broadway Street. He said he supported the diversity of artistic forms which this new addition represents. He also recognized a person in the audience, Leonard Sobczak, a CCBA and CCIC member who serves on the Theatre X board and was instrumental in the start-up of this new project.

The meeting progressed to the presentation of the annual "Plaudits" awards for outstanding service to CCBA in the past year. Receiving Plaudits were: Cliff Heise, for his contributions to the board of CCBA and his contacts to other community organizations, notably Future Milwaukee; Jim Manders, for his service as Chairman of the Business Enhancement

Committee and developer of the new CCBA Advantage directory; Lowell Warshawsky, for his valuable help in computerizing the records of the Investment Club and his exemplary contact with members during his stint as board member; Leonard Sobczak, for his direction of the Investment Club and his community involvement; Don Schwamb, for his able direction of the Cream City Association Foundation and his service on the AIDS Resource Center of Wisconsin, Inc. board; Bob Gliniecki, in his third recognition, for his continuing contributions of typesetting and art services and his involvement on the PR Committee.

The Plaudits recipients were presented with the handsome framed certificates which have become a tradition of CCBA.

The next section of the program was recognition of those board members who have completed their terms. ing, inpatient facilities and office and meeting space for the AIDS cause.

Two separate organizations are currently asking the Foundation for grants to help fund programs directly addressing the lesbian community: 1. A lesbian sensitivity training program for counselors of the Counseling Center of Milwaukee. The Woman's Support Group Program there has been running at an annual deficit, and the costs for this training program are \$1,000 which cannot be covered by the Center's normal funding sources. 2. Lesbian History Week programming for the Women's History Program of the University of Wisconsin - Madison. This event has unmet costs of \$1,789.

challenge. All donations to CCAF are tax deductible.

Last Fall's fund drive of UNITED WAY officially closed on December 31, 1985. The book work and record keeping of United Way requires several months before funds from United Way are forwarded to CCAF. The Foundation is inaugurating a new recognition program for donors. The program will be activated as soon as United Way turns over to the Foundation its share of last fall's drive.

## APA Resolution Condemns Use of AIDS Epidemic for Prejudice, Discrimination

Washington, DC — Given current evidence that persons do not become infected with the AIDS virus through casual contact, "the American Psychological Association deplores the exclusion of persons with AIDS or those suspected of having AIDS from housing, education or necessary professional services," says a resolution adopted by the national association of psychologists.

APA "condemns use of the AIDS epidemic as a vehicle for fostering prejudice or discrimination against any group or individual," says the resolution adopted February 1 by the APA Council of Representatives, the policy-making body of the 61,000 member professional and scientific society. "Until there are empirical data linking specific tests with the eventual development of AIDS, the American Psychological Association condemns indiscriminate testing to detect exposure to AIDS."

APA says that psychosocial and mental health aspects of AIDS should be stressed in treatment, research and prevention programs, and urges that mental health services for persons with AIDS, AIDS-related conditions or an exaggerated fear about the threat of AIDS 'should be widely available.' However, while noting that identification of persons exposed to the AIDS virus is 'a major public health goal,' APA urges that the confidentiality of patient records be protected.

APA supports increased funding for public education regarding AIDS and calls on psychologists 'to combat irrational public fears' of AIDS through teaching, public lectures, counseling and therapy, consultation, and research. The resolution was developed by the APA Committee on Lesbian and Gay Concerns and the APA Board of Social and Ethical Responsibility for Psychology.

CCBA's annual Media Award will be presented to a local medium which has demonstrated exemplary service to our community. The Fest City Singers will perform selections from

their Spring concert, and a sumptuous repast of hors d'oeuvres and cocktails will be served.

The conference is being coordinated by Past President Marc Hauptert, who is soliciting assistance from any CCBA members who wish to be involved. Help is needed in providing housing, transportation, program coordination, and in identifying resource people, coordinating logistics and publicizing the events locally. ## Louisville Group Announces "Art for AIDS" Competition

The Gay & Lesbian Pride Week Committee in Louisville, Kentucky is planning an art competition and exhibition for the month of June, 1986 to select artwork for a national AIDS poster. Artists are invited to submit their work to the competition by April 15. The goal is to bring more attention to the AIDS crisis and to raise funds for groups around the country that need the money.
