BOARD MINUTES

S. Rademan has resigned as Public Relations Chair, but hopes to be able to serve on the Board again in the future. Thanks to Steve for his contribution to the Association in this capacity.

Accounts receivable and accounts payable continue to be a major concern for the Board. Please contact a Board member if you have ideas for fund raising

projects.
Treasurer S. Murray will telephone outstanding accounts in the immediate future. Membership renewal and new membership recruitment are important revenue sources. The Board will conduct a "phone bank" and contact all persons whose memberships have expired in the recent past. B. Le-Grave will be contacting an individual who may be interested in soliciting advertising for CCBA publications.

The March Dinner Meeting raffle raised \$71, and donations are being accepted [for prizes] for future raffles.

It is urgent that members contact State legislators regarding the bill which would legalize hiring discrimination on the basis of sexual orientation [for organizations with "sincerely held religious beliefs" which work with children], i.e. the Rawhide Boys Ranch [which has Bart Starr as spokesman]. Although the bill failed to pass the House, the margin was slim, and there is reason to expect that it will be brought up in the future. If passed, this bill would set a devastating precedent for those who work with children in any setting.

MAP is instituting a statewide hotline which is to be in operation for extended hours. Volunteers are needed by MAP, especially for non-victim related services.

Speakers for the National NABC convention will include Ron Najman, Nancy Langer, Chris Uszler and Ron McCrea. Celebration of CCBA's fifth anniversary will be held May 16 as part of NABC festivities. Las Vegas Night will be held May 17 from 8pm to 12; donations for prizes to be auctioned, and for food and snacks are encouraged. M. Haupert has submitted extensive proposals to the Board regarding the convention.

The Board will have an all day retreat april 19 at Holy Hill; an agenda is being developed.

Your At-large board rep will be calling you to discuss the options regarding official organization positions on these and other issues. Be thinking about them, and please respond when your rep calls!



As president I believe it is important to have as wide a member participation in CCBA as is possible. We have many very talented people among us. Those of you who have something to say are encouraged to put your thoughts and ideas on paper and send them to me for inclusion in this publication. I have encouraged the board of directors to submit material for this column. Therefore, I am pleased to give this column over to our Treasurer, Steve Murray. While the ideas presented may or may not represent the thoughs of the entire board, they should provoke thought. If you have a reaction, please let me know. We will be pleased to open this newsletter to any written reaction.

THE TREASURER SPEAKSI

In the past several weeks, numerous people have expressed concern over issues and policies of CCBA. As a new member of the executive committee and the board, I welcome any questions, comments, and concerns you may have. I will always try to answer you individually, however, some issues with a broader base will be answered in the Newsletter. Before I start, I would also like to stress that we welcome written response to any issue discussed.

One of the key issues involves the [Certificates of Compliance with Nondiscrimination Policy] letters which are sent to our dinner meeting facilities. As some of you may have heard, we recently had a request from a member of "our community" not to patronize a certain restaurant because of this member's fear of losing his job...HOMOPHOBIAI This letter is used [in part] to protect employees that may be dismissed because of their homosexuality. These letters are a matter of record and are available to these people in the event of their necessity in court. These letters simply state the basics of the antidiscrimination law of the State of Wisconsin.

The second issue brought to our attention was the awarding of a complimentary membership to the

person doing the review of the CCBA financial records. The last review was done over two years ago and we felt it necessary, as a new board of directors, to have this done. The person doing the review DID NOT request a membership in exchange for the review of our financials, but it was given as a token of our appreciation. After all, if a person were paid to do this function, it would have cost us about \$500. CCBA does not [as a matter of policy] trade memberships for services rendered.

As stated in our purposes, we are an organization to provide exposure [of gays] to the community at large. As Charlie Murphy says in his song, "Gay Spirit", "when we were born, they tried to cover our eyes. They tried to tell us what to see. We are discovering this did not work." HOMOPHOBIA within our own community is a growing. dilemma. With the onset of the AIDS health crisis, [some of us] are being forced back into our closets. It is more important now than ever that we are visible to the general public and don't put ourselves back into the closet. The concern of being recognized with a 'gay group' at the dinner meetings is unfounded. Why do we, as lesbians and gay men, fear recognition in a restaurant with this group? the straight members of our organization do not. Take the time at the next meeting to observe our organization. We are not an unprofessional organization by any means. So why do we fear "quilt by association?" This situation not only applies to our meetings, but any function within our community. Would you feel the same if you met a gay friend at a "straight" function? After all, you are gay, aren't you? HOMOPHOBIA with our community is more dangerous than from without.

Our rights are presently being threatened in our legislature. [See elsewhere in this issue.] We urge you to call your legislator to voice your opinion on this matter. This phone call could mean the differnece between the first successful challenge of the Gay Rights Law, or, as we hope, the overwhelming defeat of this amendment to our law. The bill is amendment number SB527 in the Senate. The toll free hotline available for your use is 1-800-362-9696.

CCBA Inaugurates Milwaukee Gay/Lesbian Hall of Fame

The Milwaukee Gay/Lesbian Hall of Fame was officially established on March 13 with six individuals named for the year 1986.

It has long been felt by many that a Hall of Fame should exist in order to properly recognize those persons who have contributed so greatly to the gay and lesbian community.

CCBA President Jerry Johnson anounced the 1986 award winners at the March dinner meeting. Present to receive their awards were:

Alyn Hess - Alyn has contributed with a broad range of activities to the gay/lesbian community. He was one of the early members of the Gay Peoples Union, organized Gay Pride programs through the years and is a founder of Black

and White Men Together; Roger Gremminger - Roger has been instrumental in setting a high standard for gay/lesbian health care in Milwaukee. Not only has he invested thousands of hours of time, but he has donated money towards the health clinics. Besides being involved in earlier clinics, he was one of the people who started and operates the Brady Street STD Clinic:

Eldon Murray - Eldon has contributed countless hours of time through the years in helping shape the gay/lesblan community. He is a Gay Peoples Union cofounder and for years, almost single-handedly, published the nationally acclaimed magazine called GPU News:

Miriam Ben Shalom - Miriam has been involved in a ten year running battle with the U.S. Army. Discharged from Milwaukee's 84th Division in 1976 for being a lesbian, she has won her right to return to the army. However the Army has a temporary stay allowing it not to reinstate her. She was also a president of GPU.

Unable to be present to receive their awards were:

Paul DeMarco - Paul has contributed to the gay/lesbian community for many years. He was involved with the Gay Peoples Union for years, and has been active in several gay political organizations. Paul was a founding member of CCBA, and served on its board of directors;

Wayne Bernhagen - Wayne is the owner of three gay businesses, The Wreck Room, Your Place and Thinking of You. He has been a staunch supporter of the gay and lesbian community. He founded the Wreck Room Classic softball tournament which is a national model for sporting events, and presently serves on the Board of the Cream City Association Foundation.

We wish to congratulate these six pillars of the gay and lesbian community. Their strong dedication to our community should no longer go unnoticed. Through the Hall of Fame, we can recognize their outstanding service, and present role models to others who will one day join their ranks.

After the awards were presented, Johnson announced that nominations are now being accepted for the 1987 awards. All nominations must be in writing, stating why he/she is being nominated, and be sent to the CCBA PO box.

When a permanent location has been determined, a placque bearing the growing list of awardees will be on display.

Urgent - Action requiredi

As printed elsewhere in the Newsletter, supporters of Rawhide Boys School, including Bart Starr, are successfully challenging AB70 in the Wisconsin Senate. 
NGRA News

National Gay Rights Advocates has appealed a Chicago court order requiring a gay father to take an HTLV-III antibody test in order to visit his children. In a dramatic move, NGRA attorneys have informed the court that the father will refuse to comply with the order. As a result, the judge has agreed to reconsider the order and hear further evidence from both sides.

"The judge's original decision was clearly wrong," declared Benjamin Schatz, Director of NGRA's Civil Rights Project. "The HTLV-III antibody test does not tell us whether a person has or will develop AIDS. Moreover, even if the father did have AIDS - which he does not - there would be no reason to keep him from visiting his children. AIDS cannot be casually transmitted, and it is time for the courts to recognize this fact."

NGRA Executive Director Jean O'Leary agreed: "The court room is not a legitimate place for AIDS hysteria. NGRA is determined to fight the misuse of the GTLV-III antibody test wherever it occurs."

Panelists are Dr. Dennis Maki, Head of the Infectious Disease section at the Center for Health Sciences, UW Hospital and Clinics; Chaz Pope, Support Manager of the Madison AIDS Network; and Attorney Barry Lynn, ACLU Legislative Counsel, who lobbies for ACLU on issues involving AIDS.

The ACLU is working in several states against discrimination in employment and education based on someone having or potentially having AIDS.

Other workshop sessions will discuss Pomography and Women's Rights, the Sanctuary Movement and Forbidden Writers. CORPORATE OUTREACH IN ATLANTA: Atlanta Business and Professional Guild president Ted Binkley announced at that group's awards banquet that Atlanta's major beer and liquor distributors have agreed to include sexual orientation in their nondiscrimination policy statements. That announcement came as a result of a longterm effort on the part of Guild officers and corporate executives. Atlanta's success is encouragement for other NABC affiliates that have been working with major corporations in their respective cities. Similar projects are underway in San Diego, Milwaukee and Seattle.

GSBCA TO HOST AWARDS: The Greater Santa Barbara Community Association will be the official host of the 1986 Chadbourne Humanitarian Awards. These awards are presented to members of the general Santa Barbara community for outstanding humanitarian contributions. The awards ceremony and reception will be held during the month of May.

FOUNDATIONS IN ACTION: With its Winter, 1985 grants announced, the GGBA Foundation in San Francisco has given over \$80,000 to Bay Area lesbian/gay organizations.
