July CCBA Minutes of Board Meeting.

- 1. Peter Johnson will assume the position of Organizations Chairperson. - 3. Bob Reimer, Public Relations Chair, has suggested that the names of new CCBA members be printed in The Newsletter; and that a series of ads be purchased in In Step to publicize the CCBA.

CCBA Women Meet

On July 10, about fifteen women met to duscuss how the Cream City Business Association could become more meaningful to women members.

Many women indicated a desire for regular CCBA activities that would be of specific interest to women. Areas of interest were educational, selfhelp or supportive, and (of course!) social. Specific topics mentioned included: financial planning, investments, planned parenting, coparenting, child custody, and dealing with gaynessrelated stress in the work environment. Bo Black, director of Summerfest, was suggested as a possible speaker. Several women suggested that by becoming acquainted with other women members, they would be more likely to attend other CCBA functions.

Many women spoke of valuable personal and professional contacts gained as a result of CCBA events, and the support of women's activities by men members. It was generally noted that it is desirable for lesbians and gay men to be united in our struggle for equal rights, and in our involvement in political processes.

- 5. The Cream City Association Foundation (CCAF) will meet every second Tuesday of the month at the main library. Gay/lesbian organizations are to send a representative, and to appoint an P. Johnson will be the CCBA alternate. representative, and B. Reimer the alternate. The purpose of these meetings will be to unite the



- 6. B. Reimer of the Business Enhancement Committee reports that there will be a meeting of Business Members on August 4.
- 7 Treasurer Steve Murray has met with the auditor. Some recommendations from that audit include improving cash control and billing. A letter will be sent to Progressive Prints, to not accept rush orders for CCBA publications.
- 8. At-Large representatives will contact members whose dues are 30 or more days late. A letter is being sent to all persons or businesses in accounts receivable status. Board members are encouraged to bring new members into the organization. The financial status of the organization will be a major topic at the Executive Committee and full Board meetings.
- All members are encouraged to return the surveys that were included in the July Newsletter, as soon as possible.
- 10. The review of the secretarial service will also be a major topic at the next Board meeting, and bids for this service will be solicited in the near future.
- 11. Fifteen women met recently to discuss how CCBA could become more attractive to women members. It was decided that there will be regular CCBA functions for women members. [Please see other articles elsewhere in this issue.]
- 12. It was decided that the Board needs to address many issues related to <u>The Newsletter</u>, including policies deciding who will ultimately be responsible for information printed in <u>The Newsletter</u>, etc.; to be on next month's agenda.
- The August picnic will be on August 16th!! Ron Rozman and Sue Jurgens are making arrangements.
- 14. Bo Black has been invited to speak at the September dinner meeting.
- 15. Bids received for printing and typesetting were opened and discussed. After much deliberation, it was decided that Sunrise Business Services will typeset The Newsletter, and Progressive Prints will do the printing. The printing of stationary, , etc., will be done by C. J. Printing, a new CCBA business member.

Since the inception of CCBA in 1981, there have been continued efforts made to attract women to the organization. Through the years, however, successes have been minimal. While there were often one or two women on the board, the number of women actually taking out memberships was small.

Theories have been offered that the word "business" in the organization's title scared off some women. And CCBA was perceived by others to be a "men's" organization. After all, some said, isn't the business world a man's world? In January, for the first time, CCBA had three women simultaneously on the board. This was a major accomplishment. The fact that all three are active and deeply interested in the organization is heartening. Women can and should be a vital force within CCBA. One-third of our sister business group in Minneapolis has traditionally been women. I hope that will also come to pass in Milwaukee.

Elsewhere in this newsletter there is a report on the recent women's meeting that board members Sally and Sue organized. Fifteen women attended this first meeting; and others expressed strong interest, but could not attend for various reasons. I am told that enthusiasm was high and everyone present wants to meet on a regular basis, plan regular activities and events. They are planning their own picnic for August [in addition to the August 16 picnic]. A lecture series is also being considered, with topics relevant to women's interests and concerns.

Sue and Sally are to be congratulated for the organization of this first women's meeting. I am confident that with their leadership, and the excitement and enthusiasm of the others attending the first meeting, the group will grow and prosper. The potential is tremendous. Welcome!



Jeffrey Rick, 32, has recently filed a formal complaint with the California Department of Insurance against Sentry Life Insurance of Stevens Point, Wisconsin, and Alpha Corporation, a firm based in Louisiana. National Gay Rights Advocates, which represents the AIDS victim, alleges that when Rick left his old job he was not allowed to convert from his group health plan with Sentry and Alpha to an individual policy, as is required under California law.
