Bo Black to Speak at September Meeting

Black is Elizabeth J. (Bo) CCBA's featured speaker at the monthly dinner meeting to be held at the Brown Bottle on Tuesday, September 16th. Black, the Executive Director of Milwaukee World Inc. (Summerfest), will Festivals. be speaking on "Summerfest: Its Past, Present, and Future."

During over a decade of association with the festival, Black (who, as chief executive officer of Summerfest, is responsible for all facilities and activities) has been highly instrumental in leading it to become what it is now; the third largest music festival in the nation. She has also been a leading force in creating the seven ethnic festivals which take place on the Summerfest grounds every year.

Black first became associated with Summerfest in 1974 when she took relations position as public officer. Later promoted to Administrative then-Assistant the to Director, she then served on the Directors Summerlest Board of 1978 1983) the (from to as Mayor's representative.

Since taking Executive over as Director in 1983, she has led the multi-million-dollar organization to profits, sponsorship raised net dollar amounts by 43 percent, and reorganized the staff, while overseeing the construction administration building. Her current project is the planning of, and raising of funds for, the new 12 million dollar main stage amphitheatre. Of this sum, she has raised four million, with the remaining eight million bonded privately.



speak out and be heard are easily varied. and many, accessible. For example, any CCBA member can attend any Board meeting simply by informina President the 24 hours in advance. The times and places of these monthly widely meetings dissemare inated throughout the membership; and should you wish to attend, you are always welcome

There are other ways, as well. If your concern is relevant to a particular committee, contact the chair or co-chair. She or he will be glad to hear from you. The same goes for your At-Large Representative. They too will be happy to have you express your opinion.

In considering the meaning of active membership, there is one thing, I think, that we should all keep in mind. That is, that in an organization where members themselves expressing are there inevitably publicly, going to be controversy. While some may view this as a negative thing, I don't think that it necessarily need be. As long as controversy is not secretive, and occurs without acrimony -

 certainly an ideal - with each person engaged in the debate remembering the good of the group as a whole, it is evidence constructive activity. opposite of apathy, a positive good. CCBA is doing much and has much more to do. In this, while there should be a basic underlying harmony of purpose which is to move the organization ahead, complete harmony cannot be expected and perhaps, in a vital group, is not desirable. After all, the only thing in total harmony with its environment is a corpse.

The future of CCBA looks bright; but that future can only be achieved if you help. Let us hear from you; for you as an active member are the most important asset CCBA has.

THE GENTLE ART OF VERBAL SELF-DEFENSE

Dr. Suzette Haden Elgin; Prentice-Hall, hard cover, 310pp; \$12.95 hard cover, \$6.95 trade paperback.

Do you know when you are being verbally abused? No, not just being called names or shouted at, but subtly abused: like when someone whose opinion is important to you says "Honey, if you really loved me you wouldn't go bowling" or "Even an assistant manager should be able to understand this procedure, darling" (notice where the accents are). Each of these contains non-stated presuppositions which can hurt, and make you feel guilty for hurting besides. ["I can't understand why I feel so stupid when I'm

with her/im. S/he is always so considerate. There must be something wrong with me⁻¹].

These were verbal attacks just as surely as if they had said out loud, "you don't love me because there is something you like to do without me there" or "since it doesn't take much intelligence to be an assistant manager you should feel guilty and stupid for not understanding."

From reading The Gentle Art of Verbal Self-Defense I learned that I am a verbal abuser of those people who are dearest to me. Fortunately I also learned from Dr. Elgin's book how I can learn to be less abusive in the future [besides just thinking out what I will be saying before I need to say it.] From reading this book I realized that there are productive ways of coping when my boss is being verbally manipulative: concentrate on the presupposition rather than just on what was said aloud; remain calm; and look relaxed.

Society teaches men and women to verbally attack in different manners, so there is a chapter devoted to each gender and coping with its attacks and defenses. Men are taught early in life that verbal confrontation games are just a part of their career activities. Women, on the other hand, play for keeps and tend to say what they mean with no bandying about (this is noted as one of the reasons why men don't understand women).

Throughout the book there are exercises and workbook assignments to improve your offense as well as your defense. Each lesson is brief and is fully explained for ease of comprehension.

Although Dr. Elgin states that this book is a manual to teach you verbal judo (p.3), I feel that it is more like instruction in aikido or tai chi in that the exercises make you feel good just practicing them, and you don't need an "attacker" to use them in your daily life.

So the next time someone one says to you "don't you even care about (X)?" say "no" and find out what happens. -- C.Kay Hinchliffe

Enticing Smiles: CCBA's Dentists

What do Bartley Bell, John Scaduto, Michael Bernklau, and Craig Larrabee have in common, besides being DDS's? How about the fact that they have all been graduated from Marquette's School of Dentistry!

When the average person thinks of the dentist, a smile does not come upon her/his face. Still, without our dental professionals, there would certainly be more gummy smiles apparent in CCBA. Years ago, people were "deathly afraid to come to a dentist," stated one of our oral engineers; but since then new equipment and new ways to make dental work more satisfying for everyone have been developed.

When asked, "What are some of the best things about living and being a professional in the Milwaukee area?", Bart stated, "Not only does Milwaukee have a very good selection of cultural events, but it is a city that really cares about its future." Mike and Craig, partners in life for 5 years as well as partners in practice, said, "Milwaukee is a very clean 'small town' city with relative affordability in housing and entertainment. We are especially impressed that we live in such a relatively enlightened, progressive state." John, echoing his peers, said, "The quality of life available in Milwaukee is very high, if one wishes to partake of it; and the professional standards here are generally very good." He later added, "The strides which CCBA has made to promote the growth and integrity of member businesses should engender respect in the straight and gay communities."

Asked for the most important professional advice that they could give to our members, the responses could be summarized as: 1) Learn to really care about your own total health as well as the quality of your life; 2) Come to see a dentist regularly; don't wait until it hurts, as by that time it may be too late; 3) Be responsible about the appointments you make: be there on time; 4) Pay all dental bills on time; and 5) Learn correct techniques of oral care (brushing and flossing properly) that will improve and maintain the health of the soft tissues around the teeth. Doing this will prevent the development of periodontal disease.

Our dentists are small business people. They work hard to develop a good practice, to serve their total client base. Their work is delicate and very sensitive, especially in light of the fact that so many people are still afraid of dentists. Many of them are involved in many ways in our total community. Some serve on organization boards, others volunteer to help on special activities; and all of them pitch in and help take care of our sisters and brothers who cannot handle the cost of dental work. There is no reimbursement for this volunteer labor and equipment these people share. These people know what they are doing and do it well; and we should be proud of their high calibre of professionalism.



Midwestern Gay & Lesbian Leaders Call Grassroots Planning Conference; To Be

Held in Twin Cities

Minneapolis- Lesbian and gay leaders in Minneapolis-Saint Paul have called for a national conference of grassroots lesbian & gay leadership "to organize and develop leadership at the grassroots level for dramatic and sustained actions in months and years ahead." The conference is planned to "enable joint action in areas where there is broad agreement as to priority and strategy thru identified and empowered leadership network."

The conference, called "Forward in Unity: Charting the Course," will be held October 24-26 in the Twin Cities. Organizers said the agenda would include recognized national leaders as keynoters and as "inspirational speakers" at a closing celebration brunch. The plan also calls for a process of alternating small group and plenary discussions to clarify shared priorities for action.


Co-coordinator Emma Hixson director of the Minneapolis Department of Civil Rights) described the conference as "an important resource for both emerging and experienced leadership." She said, "Without discounting the importance actions and ideas originating on the East or West Coasts, most of the gay men and lesbians in this country live somewhere between the coasts. We think this conference offers us a particular opportunity to be heard, to share ideas with one another, interact with national leaders, and to parstrengthening ticipate in movement. We see this meeting as a catalytic event in the development of our movement."



Summary of Aug. Board Meeting

- President Jerry Johnson appointed Bill LeGrave and Karen Gotzler as co-chairs of the Public Relations Committee with a shared vote on the Board of Directors; this was approved by the board.
- Treasurer Steve Murray gave his report, and summarized the accounts payable; he agreed to provide a detailed list to the Board. He also reported briefly on the formal review of the CCBA books conducted by Bill Tobias.
- 3. Cliff Heise reported that we did not have any takers on *Dreamgirls*, but our deposit can be applied to future purchases of as few as two tickets. Discussion followed on possible events for CCBA, including cross-country skiing; and groups, such as a gourmet food group, dessert club, and/or diet club.
- 4. Peter Johnson reported on his attendance at the gay and lesbian coordinating group organized by CCAF. Groups announced events and discussed ways to support each other's major events. Groups there included: BWMT, GPU, Gay Youth-Milwaukee, The Network, Grapevine, Midwest Music, St. Alerud's, Gay/Lesbian Community at UWM, CCBA, and BEST clinic.
- A letter of resignation from the Business Enhancement Committee by certain members was read, as well as a second letter stating that they

- would not be attending the Board meeting. Various officers and Board members reported on conversations with members of the resigning group, and lengthy discussion followed, Jerry Johnson appointed a committee to meet with the resignation group.
- 6. The question of CCBA policy on bids and contracts for goods and services was discussed. It was determined that no written policy exists. The Board voted unanimously to reconfirm the continuing policy that, in evaluating bids, great weight is to be given to membership in CCBA.
- 7. Newsletter Editor Mike Lowrey reminded everyone that he is looking for articles and ideas for The Newsletter. The committee established to recommend newsletter policies and directions was directed to meet, and to report at the next meeting.
- 8. Ron Rozman reported that the food for the picnic was sufficient and that equipment for the pig and chicken roast caused the budget to go over by \$25. The Board applauded his efforts on the picnic.
- 9. Steve Murray reported on his negotiations with printers regarding the printing of the fall Business Directory. It was voted to authorize a one month delay in printing the directory, in order to give careful consideration to the bids, and to allow all printers to submit amended bids, due to a change in one of the bids.
- 10. Jerry Johnson reviewed options in dealing with the secretarial service review. A lengthy discussion followed, regarding CCBA finances, cash flow, and image. A committee is to be appointed to consider how secretarial duties might possible be handled without a paid service, and to provide for an orderly transition.
- 11. It was announced that we will have a table at MAPFest on Labor Day.
- 12. The November membership meeting will be a general meeting, with the Board making a presentation and being available for questions or concerns from the membership.
