DOUBLE PROGRAM ANNOUNCED FOR OCTOBER 15 DINNER MEETING

CCBA will feature a double bill for the afterdinner segment of the October 15th dinner meeting. First, Neal Brenard, Producer of Milwaukee's Clavis Theatre, will present a "sneak preview" of Larry Kramer's *The Normal Heart*, a hit play based on Kramer's own experiences with the founding of the Gay Men's Health Crisis Center in New York City. Eight actors will present a 20-minute segment of the drama, giving those attending a chance to see something of why this play is one of the hit dramas on the New York stage. It is scheduled to open at the Clavis's Encore Theater on November 12.

For the second attraction, Dr. Terry Boughner will be discussing famous women and men in lesbian/gay history. Dr. Boughner, recently of Pittsburgh (where he was professor of history at La Roche College), is currently a reporter for *Outl*, and is a syndicated columnist on the subject of lesbian/ gay history whose articles appear in *In Step* and other papers across the United States, and in Canada and New Zealand. He is also the author of an upcoming book on the subject, entitled *Out of All Time*, which is scheduled for publication in the spring by Alyson Publications of Boston.

It deals with the lives of lesbians and gay men such as Queen Marie Antoinette, Pharaoh Tutankhamen (King Tut), and Eleanor Roosevelt, as well as more general aspects of lesbian/gay history, such as lesbianism in the ancient world and the Nazi persecution of homosexuals. The book consists of 50 chapters; and Dr. Boughner is currently working on its sequel. Terry believes that it is long since time for lesbians and gay men to discover their history, which straight historians have "bent over backward" to obscure or deny. He also notes that while some may think history dull, it is his experience that the people who made it were not.

Secretarial Service To Be Discontinued

For several years, CCBA has paid a secretarial service to handle the organization's day-to-day operations. This has included handling phone calls, membership renewals, computer listing updates, requests for information, dinner reservations, general typing and correspondence as needed, etc. However, in recent months the Board has felt that CCBA could function with these services being done on a volunteer basis, thus saving CCBA \$300 per month. A special ad hoc committee of the Board was appointed by President Jerry Johnson at the August 19 Board meeting, to recommend how the duties that had been carried out by the secretarial service

could be divided among members of the Board. The committee delivered its recommendations to the Board at a special meeting held August 28. After lengthy discussions, the Board voted to accept the report and to officially notify Shalom Enterprises that CCBA would no longer require its services, effective October 1, 1986. Board members have met with Shalom Enterprises to facilitate the transition of duties to the respective persons. One change that members should immediately notice is that dinner meeting reservations will now be made with the Treasurer. Another is that membership renewals will be sent out by the Membership Committee Chair.

The CCBA Board of Directors is working very hard to make our organization stronger, more effective, and just plain better. After considerable discussion at meetings during the past several months, you, the members, are beginning to see the results. For several years we have used a paid secretarial service (see article elsewhere in this issue); this will no longer be the case, effective October 1. The Board feels that this work could be done effectively by the Board itself, thus saving us \$300 a month or \$3600 annually. As you can see, this will be a considerable reduction in costs. Therefore, as of press time various secretarial service responsibilities have been delegated to others. For example, the Secretary will handle Board and special membership mailings, maintain mailing materials, and update mailing lists. The Membership Committee Chair will mail out membership renewals and welcoming letters to new members, as well as initiating mailings to prospective members. The Treasurer will handle ad billings for The Newsletter, accept dinner meeting reservations, operate the computer system, etc. With everyone working closely together, we expect the transition to be smooth, with any problems quickly corrected. While this gives the Board considerably more work, it does spread the work load as evenly as possible. Please do give me your reactions to this new system. If you find something that is not correct, please let me know. I assure you that the Board is here to help and is determined to make this transition with ease.

Your Board has been active in other ways as well. With the help of Board members and *Newsletter* editor Mike Lowrey, we are working hard to improve *The Newsletter*. In the months ahead, you will see the number of pages increase as advertising revenue merits. Mike Wavra is "out there" soliciting ads. If you wish to advertise and would like additional information, let Mike Wavra or myself know. It is ads that pay for this newsletter.

In addition, the Board is busy rewriting the By-Laws. There will be significant changes

proposed for your consideration and adoption at the November membership meeting. The November meeting will be informational; the Board will be present to answer your questions, solicit input on goals and priorities for CCBA from you, and generally listen to you, CCBA's members. To encourage maximum turnout, we are varying the format. There will be no dinner or door fee (it will be free!), and it will start at 7:30 PM. So please mark your calendars and plan to attend. The Board needs your input and needs you there to vote on the By-Law changes.

Of equal significance, the Board is compiling a Procedures Manual which will be distributed to all members. In the past, too much has been done with no written guidelines. This left some operations ambigous or simply without precedents. We hope that this manual will go a long way toward preventing confusion, misunderstanding, etc. on CCBA policies. The Board is working hard in other ways as well. Some Board positions are being reevaluated, and you might see some changes there. Our four women Board members are working hard with the newly formed women's group. Membership surveys are being evaluated. An audit of our finances has been completed. Our cash flow problems are showing considerable improvement. If interest is there, skiing and dinner clubs will be formed this Fall. CCBA is definitely becoming a stronger, more effective organization. Your valued support is greatly appreciated.

Insurance Agency Forced to Withdraw Anti-Gay Guidelines

Equifax, Inc., the nation's largest insurance investigative agency, has revoked guidelines which it had issued to its investigators to help screen out "high risk" insurance applicants. The \$500 million a year organization (headquartered in Georgia), which performs detective work for most insurance companies in this country, had reportedly issued instructions which would help companies spot "lifestyles" which it felt identified people at high risk for AIDS, on the basis of such factors as marital status, gender, occupation, "living arrangements", and "irregular beneficiary". Such "high risk" applications were to be brought to the attention of the companies; but when the San Franciscobased law firm National Gay **Rights Advocates threatened to** sue Equifax, Inc. for discrimination against gays, the company backed down and withdrew the "lifestyle" instructions, which they said had been issued without proper review.. They have also agreed not to focus on sexual orientation in future investigations.



LaRouche Bill Threatens California Freedoms; Are Our Rights in Wisconsin in Danger on Election Day?

The so-called "LaRouche Initiative", Proposition #64, will definitely be on the California ballot in the November general election. This bill, promulgated by a group of Lyndon LaRouche's followers and their "new right" allies, calling themselves PANIC, is widely considered the most serious threat to gay citizens since the beginnings of the modern gay rights movement.

The bill would empower law enforcement or public health officials to "guarantine" and "isolate" HTLV-III carriers and persons with AIDS. It is generally understood that such isolation/guarantine would take the form of internment camps like those in which Japanese-Americans were imprisoned during World War II. Proposition 64 will require the reporting of names to health authorities of persons who are, or are suspected of being, HTLV-III carriers, with no protection of confidentiality permitted. It forbids food handlers (waiters, airline stewards, bartenders, etc.) from working with food if the person is even suspected of being an HTLV-III carrier or person with AIDS, with no job protection rights. Students and school staff who have AIDS, test positive for HTLV-III, or just

Great Success



live with such people, would be forbidden to come to school. Finally, public authorities would be permitted to impose travel restrictions on carriers and persons with AIDS who are not in "guarantine".

While it may seem that this bill is too extreme and irrational to pass, it is being taken very seriously by our sisters and brothers in California. The AIDS hysteria in Wisconsin has not as yet reached this pitch; but we may rest assured that the new legislative session will see further efforts to take back what protections we have achieved. Tommy Thompson has announced his intention to disband all state offices and councils concerned with the lesbian/gay community; and several legislative candidates (mostly Republican) have expressed an intent to repeal or gut AB 70 (our Wisconsin state gay rights law, the first in the nation). CCBA takes no position on political candidates; but we must all pay close attention to what stands the candidates in our areas take.

ESTÉE: A Success Story Estée Lauder Ballantine Books; massmarket paperback, 286pp; \$4.95 © 1986 0-345-33746-8

If you ever wondered how someone becomes a multi-millionaire in a highly competitive field, Josephine Esty Mentzer Lauder's autobiography *ESTÉE* will teach you. (The rules and advice she gives will work for any business, not just cosmetics.)

Rose Kennedy said that good luck is something you make and bad luck is what you endure. Estée has had her share of bad luck: a divorce leaving her to be a working (single) mother in the 1940's; her sister contracting polio [after returning to N.Y.C. from Milwaukee]; a potential lawsuit when a customer served a facecream on a salad: the loss of her supportive significant-other. She has made her share of good luck too, with persistence and poise: making expensive multiple trips to England and working with fashion magazine editors to convince Harrod's of London to carry her products; applying make-up to a poor-looking chicana (after the store's manager told her not to, "that kind never has any money") who then bought and brought all of her friends and relations who also made purchases; talking with everyone; touching faces (and hearts) whereever she goes; following her "gut feelings" about what is right.

Using common sense and innate wit, she revolutionized marketing and sales techniques by offering incentives to the customer (not the sales force); using word-of-mouth as her only advertising (now it's called "networking", then it was the third form of communication-- Telephone, Telegraph, and Tell-A-Woman); and having a staff who was knowledgable about the products, what was it, as well as how to use it.

Estée tells us repeatedly that her make-up and scent products are natural and exciting. The words she uses are also exciting and natural. **ESTÉE** gave me the feeling that it was just she and I sitting in my livingroom chatting comfortably.

Estée Lauder says that she sells beauty. From this book I found that Estée Lauder sells herself: her charm, grace, wit, savvy, and style.

Sept. Board Meeting: Summary

1. At a special Board meeting on August 28, the Board voted to discontinue paid Secretarial Service, and to divide secretarial responsibilities among Board members. 30 days' notice was given to Shalom Enterprises on August 29. 2. A letter was sent to Shalom Enterprises on September 2, requesting a meeting to complete the transference of materials and information, and to answer any questions regarding the termination of the service.

3. A report was given by the Ad-Hoc Committee that met with 4 members of the Business Enhancement Committee who resigned last month. The report contained

recommendation to the Board for improvements in CCBA policies and procedures. Many have been acted upon, and each recommendation was discussed.

4. A comprehensive revision of CCBA By-Laws will be led by Peter Johnson.

6. A Report of Women's activities was given (see elsewhere in this issue). The Women's group has requested Committee status in CCBA, and a small budget for mailings.

7. Each Board Member is to submit related policies and procedures to President Johnson for compilation in CCBA Policy and Procedure Guide. 8. Pat LeSage of Forward Wisconsin is being contacted to speak at the October dinner meeting, if possible. The November meeting is to be an informal membership meeting, 9. The Public Relations Committee. co-chaired by Karen Gotzler and Bill Le Grave, presented a proposed job description, which was accepted by the Board. Duties of the PR Committee include: oversee The Newsletter, relate to the media and

related organizations, promote CCBA via articles and advertisements, develop recruitment materials, and involve CCBA in community activities. It was suggested that the Committee should formulate guidelines as to which issues CCBA should publicly respond to. The Committee proposed that the Board establish procedures to improve communications with members. It has been suggested that the PR and Membership Committees work together in this area; it is though that the At-Large system has not been working optimally. 10. The Board adopted a pricing policy for Dinner Meetings:

Pre-paid reservations: cost + 20% (gratuity&tax)+ \$2, rounding up

<u>Not Pre-paid</u>: As above, plus \$1. (Charter Members continue to receive \$1 off.)

11. There are several new CCBA members! (We hope to have details in future issues.)

12. A list of past-due membership renewals has been drawn up and is being sent to the Membership Committee.

13. MAP Fest was well attended. CCBA had a game booth; all proceeds went to MAP.

14. Vacancies in Board At-Large positions may be resolved if these positions become part of the Membership Committee. 15. Nominations for the Gay-Lesbian Hall of Fame are being solicited. Contact President Johnson by the January dinner meeting. 16. A letter was sent to Hurricane Productions, stating that CCBA would be unable to co-sponsor their Halloween Party on such short notice, but would be interested in cosponsoring a future event. 17. Anyone interested in serving on a committee for Marin Luther King,

Jr. Week should speak to President Johnson.
